## 2 Oracle Financial Services Regulatory Reporting For Bank of England

Oracle Financial Services Regulatory Reporting For Bank of England (OFS REG REP BOE) enables banks to automate risk reporting to central banks and regulators in a single integrated environment. It automates end-to-end processes from data capture through submission with industry-leading solutions, eliminating the need for further manual intervention. It is a standalone product that has pre-built integration with Vermeg's Solution for Regulatory Reporting - AgileREPORTER and has the capability to integrate with any other third-party tools for the end mile reporting forms. The solution ensures data integrity allowing banks to focus more time on analyzing and gaining new business insight from their growing stores of data instead of preparing data and reports with the sole objective of meeting submission deadlines. This is made possible by the following:

- Providing Centralized Data Storage for Risk Data through relevant subject areas of the Financial Services Data Foundation (FSDF).
- Interfacing with a Regulatory Reporting tool – Vermeg AgileREPORTER to build necessary template reports to meet the regulatory expectations.
- Managing the accuracy of risk reporting through Data Governance Studio (DGS).

OFS Regulatory Reporting For Bank of England (OFS REG REP BOE) offers regulatory reporting solutions for the Financial Institutions (FIs) in the UK. The present scope of the release in v81000 includes 11 EFS reports which have undergone regulatory updates in recent past and mandatory to be submitted by all FIs in the region.

### 2.1 Prerequisites

The following are the prerequisites to install the OFS REG REP BOE application:

- Oracle Financial Services Advanced Analytical Applications Infrastructure (OFSAAAI) v8.1.2.4.0 plus other prerequisite OFSAAAI patches (see Section 2.5 *Installation Checklist* of [OFSAAAI Installation and Configuration Guide](#)) should be installed and configured on your machine.
- Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.2.4.0 plus other prerequisite OFSDF patches (see the *section 4.1 Pre-installation Checklist* of [OFSDF Application Pack Installation and Configuration Guide Release v8.1.2.4.0](#) in the [OHC Documentation Library](#)) must be installed and configured on your machine.
- AgileREPORTER version **22.4.0-b130**.
- AgileREPORTER Stats and Regulatory Data Div Template version **3.3.0-b616**.
- AgileREPORTER ECR Template version **22.12.0-b51**.

- Ensure that you have executed the `.profile` file before you trigger the installation.
- Ensure that the FICServer is up and running before you trigger the installation. For information on restarting the services, see the [OFS Analytical Applications Infrastructure Release 8.1.2.0.0 Installation and Configuration Guide](#).

## 2.2 Installing the OFS REG REP BOE 8.1.2.0.0 Release

Perform the following instructions to copy, extract, and install this release:

1. Download the archive file from [My Oracle Support](#). Search for the Patch ID **35635018** under the **Patches & Updates** Tab.
2. Copy the downloaded archive file to your OFSAA server in **Binary** mode.
3. Shut down all the OFSAA Services. For more information, see the *Stop Infrastructure Services* section in [Oracle Financial Services Advanced Analytical Applications Infrastructure Installation and Configuration Guide](#).

**NOTE** Ensure that the **FICSERVER** is up and running.

4. Execute the `chmod -R 750 $FIC_HOME`
5. If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS-specific) `unzip_<os>.Z` from the location <https://updates.oracle.com/unzips/unzips.html> and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** path or directory in which you have copied the 8.1.2.0.0 patch.

Uncompress the unzip installer file using the command:

```
uncompress unzip_<os>.Z
```

**NOTE** If you notice an error message “*uncompress: not found [No such file or directory]*”, contact your UNIX administrator.

6. Execute the `chmod 751 35635018_81200_Generic.zip`
7. Execute the `unzip -a <name of the file to be unzipped>`  
For example: `unzip -a 35635018_81200_Generic.zip`
8. Navigate to the installer directory `appsLibConfig/conf` containing the template file `Silent.template`.
9. Create a copy of this file and rename the copy as `Silent.props`.
10. Edit the `Silent.props` file and specify the parameters as per the requirements.

The following table lists all the properties that must be specified.

11. Execute the user `.profile`
12. Navigate to the `OFS_REG_REP_BOE/bin` directory and execute `./setup.sh SILENT`
13. The installation progress can be viewed by periodically refreshing the log file under the `OFS_REG_REP_BOE/logs` directory.
14. After installation is completed, verify the log file for any Errors or Warnings. Contact [My Oracle Support](#) in case of any issues.

This patch installation has taken approximately 20 minutes to complete in Oracle Labs.
