2 Oracle Financial Services Regulatory Reporting For Bank of England

Oracle Financial Services Regulatory Reporting For Bank of England (OFS REG REP BOE) enables banks to automate risk reporting to central banks and regulators in a single integrated environment. It automates end-to-end processes from data capture through submission with industry-leading solutions, eliminating the need for further manual intervention. It is a standalone product that has pre-built integration with Vermeg's Solution for Regulatory Reporting - AgileREPORTER and has the capability to integrate with any other third-party tools for the end mile reporting forms. The solution ensures data integrity allowing banks to focus more time on analyzing and gaining new business insight from their growing stores of data instead of preparing data and reports with the sole objective of meeting submission deadlines. This is made possible by the following:

- Providing Centralized Data Storage for Risk Data through relevant subject areas of the Financial Services Data Foundation (FSDF).
- Interfacing with a Regulatory Reporting tool Vermeg AgileREPORTER to build necessary template reports to meet the regulatory expectations.
- Managing the accuracy of risk reporting through Data Governance Studio (DGS).

OFS Regulatory Reporting For Bank of England (OFS REG REP BOE) offers regulatory reporting solutions for the Financial Institutions (FIs) in the UK. The present scope of the release in v81000 includes 11 EFS reports which have undergone regulatory updates in recent past and mandatory to be submitted by all FIs in the region.

2.1 Prerequisites

The following are the prerequisites to install the OFS REG REP BOE application:

- Oracle Financial Services Regulatory Reporting For Bank of England v8.1.2.5.0 should be installed and configured on your machine.
- Oracle Financial Services Advanced Analytical Applications Infrastructure (OFSAAAI) v8.1.2.4.0
 plus other prerequisite OFSAAAI patches (see Section 2.5 Installation Checklist of OFSAAAI
 Installation and Configuration Guide) should be installed and configured on your machine.
- Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.2.5.0 plus
 other prerequisite OFSDF patches (see <u>OFSDF Application Pack Installation and Configuration
 Guide Release v8.1.2.5.0</u> in the <u>OHC</u> Documentation Library) must be installed and configured
 on your machine.
- AgileREPORTER version 23.11.0-b53.

- AgileREPORTER Stats and Regulatory Data Div Template version 3.3.0-b616.
- AgileREPORTER ECR Template version 22.12.0-b51.
- Ensure that you have executed the .profile file before you trigger the installation.
- Ensure that the FICServer is up and running before you trigger the installation. For information
 on restarting the services, see the <u>OFS Analytical Applications Infrastructure Release 8.1.2.4.0</u>
 Installation and Configuration Guide.

2.2 Installing the OFS REG REP BOE 8.1.2.5.2 Release

Perform the following instructions to copy, extract, and install this release:

- 1. Download the archive file from My Oracle Support. Search for the Patch ID **36784528** under the **Patches & Updates** Tab.
- **2.** Shut down all the OFSAA Services. For more information, see the *Stop Infrastructure Services* section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Installation and Configuration Guide</u>.

NOTE

Ensure that the **FICSERVER** is up and running.

- 3. Execute the chmod -R 750 \$FIC HOME
- **4.** If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS-specific) unzip_<os>. I from the location https://updates.oracle.com/unzips/unzips.html and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** path or directory in which you have copied the 8.1.2.5.2 patch.

Uncompress the unzip installer file using the command:

uncompress unzip <os>.Z

NOTE

If you notice an error message "uncompress: not found [No such file or directory]", contact your UNIX administrator.

- **5.** Execute the chmod 751 p36784528_81200_Generic.zip
- 6. Execute the unzip -a <name of the file to be unzipped>
 For example: unzip -a p36784528 81200 Generic.zip
- 7. Execute the user .profile
- 8. Navigate to the OFS REG REP BOE/bin directory and execute ./setup.sh SILENT
- **9.** The installation progress can be viewed by periodically refreshing the log file under the OFS REG REP BOE/logs directory.
- **10.** After installation is completed, verify the log file for any Errors or Warnings. Contact My Oracle Support in case of any issues.

2.3 Post-installation Steps

The post-installation steps required for this release are as follows:

- 1. See the log file in the <code>/OFS_REG_REP_BOE/logs</code> directory to ensure that there are no errors reported. Contact My Oracle Support in case of any issues.
- 2. In case there is an access error in log as "Object FN_RR_CONF_REG_METADATA_COLS is invalid" or "Object FN_RR_CONF_REG_CELL_LOGICAL_MAP is invalid" then execute below grant statements using a SYS user: grant select on <CONFIG USER>.DB_MASTER to <ATOMIC USER>; grant select on <CONFIG USER>.DSNMASTER to <ATOMIC USER>;
- 3. Generate the application EAR or WAR file and redeploy the application on the configured Web Application Server. For more information on generating and deploying the EAR or WAR file, see the Post Installation Configuration section in OFS Advanced Analytical Applications Infrastructure Installation and Configuration Guide.
- **4.** Restart all the OFSAA services. For more information, see the *Start Infrastructure Services* section in the OFS Advanced Analytical Applications Infrastructure Installation and Configuration Guide.
- **5.** Resave all hierarchies after executing all the SCDs and before triggering the BOE Run.

The Oracle Financial Services Regulatory Reporting For Bank of England is now ready for use.
