## 2. Interface Guide

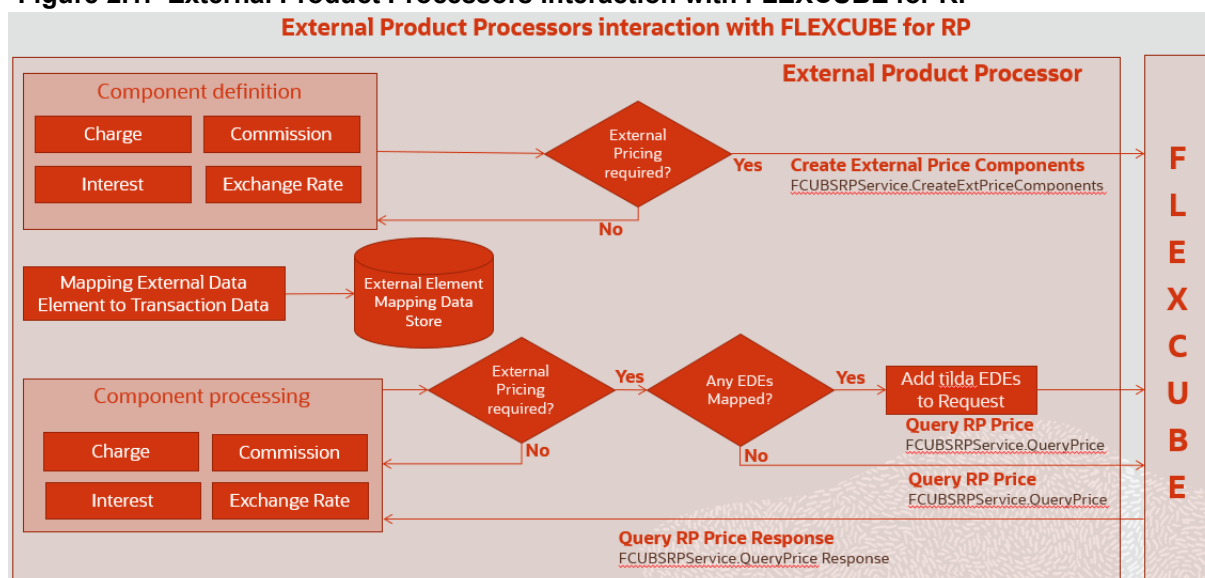
This topic explain about the functions and features of the interface guide.

### 2.1 Introduction

Customer Relationship pricing is the pricing of services offered to a customer based on the total business that the customer conducts or could potentially conduct. In this case, a set of eligible customers is offered special pricing over and above the standard product pricing. This is commonly implemented by way of discounts, rebates, or offsets against standard pricing. A combination of products wrapped as a product bundle could also be offered to customers. Pricing benefits are offered to customers based on customer relation, product bundling, or a combination of both. For e.g., for keeping a minimum daily balance of \$2,500, a bank may offer its customers a fee waive-off on credit cards, lines of credit, checking, and savings, as well as 100 free trades and bonus interest rates on savings accounts.

The following diagram displays the relation between various components involved in the calculation Of relationship pricing and integration maintenance for external product processors.

**Figure 2.1: External Product Processors interaction with FLEXCUBE for RP**



To get the Relationship pricing Price from FCUBS, maintenances are required at both FCUBS and external product processors. This document will brief about these maintenances.

### 2.2 Maintenances to be done in FCUBS

This section describes the specific maintenances, needed in Oracle FLEXCUBE Universal Banking (FCUBS) to integrate the same with External Product Processors.

#### 2.2.1 Relationship Pricing Maintenance

The various maintenances required to provide relationship pricing to customers are explained in detail in the Relationship Pricing user manual (UM). This UM contains the following Maintenances:

- User Data Elements
- System Data Elements

- External Data Elements
- External Price Component Maintenance
- Relationship Value Tag Codes
- Relationship Pricing Eligibility Plan
- Pricing Variance Rule Maintenance
- Benefit Plan Maintenance
- Relationship Pricing Scheme
- Customer Scheme Relationship Pricing Batch

## 2.2.2 Upload Source Preference Maintenance

In the Upload Source Preference Maintenance screen (CODUPLDM), please maintain the External system with Post Upload Status as “Authorized”.

## 2.2.3 External System Functions Maintenance

External Product processors invoke FCUBS for RP when

- 1) Create/Modify/Query Price Component
- 2) Create/Modify/Query Price Component

### 3) Querying Relationship Price

This maintenance is required for every product processors both for invoking Gateway or Rest service.

## 2.3 Maintenances to be done in External Product Processors (PPs)

This section describes the specific maintenances for RP needed in the External Product Processors system to integrate the same with Oracle FLEXCUBE Universal Banking (FCUBS).

### 2.3.1 Product and Component Maintenance

Enable “External Pricing” for Components for which price needs to be derived from FLEXCUBE. (If any)

### 2.3.2 EDE Maintenance

Maintain External Data Element name and value so that they can be sent to FLEXCUBE when querying the price. These EDEs are internally used in Variance Rules in FLEXCUBE to derive the price. (If any)

### 2.3.3 FCUBS - RP Processing

#### 2.3.3.1 External Price Component

API called to create external pricing component is as below -

**Service** - FCUBSCoreService

**Operation** - CreateExtPriceComp/ ModifyExtPriceComp/QueryExtPriceComp

IN → Module\_id, price\_comp\_code, price\_comp\_desc, product\_code, price\_comp\_type (I-INTEREST/C-CHARGE/F-FEE/M-COMMISSION)

OUT → Successfully created price component.

Here is the high level in and out parameters for the API

IN → Module\_id, ede\_code, ede\_desc, ede\_data\_type (S-STRING/N-NUMBER/D-DATE)

OUT → Successfully created EDE component.

#### 2.3.3.3 External Query Price Service

“CreateQueryPrice” API will be called by external product processors for the respective product components and EDE’s (as name value pair) to get the relationship Price. External PPs send transaction attributes, EDE codes, and

pricing component as input. In Response Charge/Fee/Interest/Commission/Exchange rate/amount is sent as fixed/variance value. This will take in EDEs as an array of name value pair.

Here is the high level in and out parameters for the API

IN → Transaction reference number, price component, customer, account, EDE name value pair, Currency

OUT → RP reference number, benefit type (Variance/Waive), variance type (Fixed/Variable Amount), variance value, pricing currency
