## 2.1 Create Country Preference

Oracle FLEXCUBE Investor Servicing provides the facility to associate certain attributes for countries maintained in the system. You can define the reputation risk of a country, the EUSD option associated with it and assign alpha codes in the Country Preference Maintenance screen. You can invoke the 'Create Country Preference' screen by typing 'Create Country Preference' in 'Menu Item Search' at the top left corner of the screen or alternatively you can navigate manually Menu -> Investor Servicing -> Country Preference -> Create Country Preference.

#### **Country Code**

Alphanumeric; 3 Characters; Mandatory

Select the country for which you wish to define country preferences.

#### **CRRT Risk Level**

Optional

Select the CRRT i.e., the Country Reputation Risk Table associated with the country from the drop-down list. The reputation risk level may either be 'High' or 'Low'. High implies that it is a high-risk country while Low indicates cautionary risk country. While creating a unit holder, if the unit holder domicile country is listed in the CRRT list, then system throws up an error depending on the country risk level.

### **EUSD Options**

#### Optional

You need to associate a EUSD (European Union Savings Directive) option with each country. Based upon unit holder's country of domicile, the corresponding EUSD option of that country will get defaulted during unit holder creation.

The list displays the following values:

- With Holding Tax
- Exchange of Information

By default, no option will be selected. If no option is selected the system will consider that the EUSD is not applicable, and the system will not track the average cost as required for EUSD. If any of the option is selected, then the system will consider that the EUSD is applicable. The EUSD option at transaction level will be defaulted from the unit holder's EUSD Option. You can also modify the EUSD option at transaction level. The transaction level option will be taken as the EUSD option. The following EUSD Options would be available at transaction level.

- With Holding Tax (WHT)-- EUSD tax is computed and deducted
- Exchange of Information (EOI)-- EUSD tax is computed but not deducted
- Tax Certificate (TCE)-- EUSD tax is computed but not deducted

For all the above three options, the system will calculate the EUSD tax. However, if you select With Holding Tax, the system will deduct it from the settlement amount.

### 2.2.1 Invoking the View Country Preference Screen

After you have set up the country preferences, you must have another user authorize it so that it would be effective in the system. Country preferences for an unauthorized record will not be used in the system. You can invoke the 'View Country Preference' screen by typing 'View Country Preference' in 'Menu Item Search' at the top left corner of the screen or alternatively you can navigate manually Menu -> Investor Servicing -> Country Preference -> View Country Preference.

Look and feel of View Country Preference screen may change. Now, in above screenshot, Search Filter is coming at right corner. It may change, to display at the top of the results.

## 2.2.2 <u>Retrieving Country Preference Details</u>

To retrieve a previously entered currency record:

Invoke the View Country Preference screen and specify the following:

- The authorization status of the currency record in the Authorization Status field. If you choose the "Blank Space" option, then all the records are retrieved.
- The status of the currency records in the Record Status field. If you choose the "Blank Space" option, then all the records are retrieved.
- The Country Code and
- EUSD Options
- CRRT Risk Level

After you have specified the required details, click 'Search'. All records with the specified details are retrieved and displayed in the lower portion of the screen.

You can perform Edit, Delete, Amend, Authorize, Reverse, confirm operation by selecting from the Action list.

You can also search the record by using combination of % and alphanumeric value. For example, you can search the record for country code by using the combination of % and alphanumeric value.

Search by Z%: - System will fetch all the records whose country code starts from Alphabet 'Z'.

## 2.2.3 Editing Country Preference Details

You can modify the details of a country preference that you have already entered in the system, provided it has not been subsequently authorized. You can perform this operation as follows:

- Invoke the View Country Preference screen from the Browser.
- Select the authorization status of the currency records that you want to retrieve for modification in the Authorized field. You can only modify records of currencies that are unauthorized. Accordingly, choose the unauthorized

option from the drop-down list.

- Specify any or all the search parameters of the currency for retrieving the records.
- Click 'Search'. All unauthorized currencies with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record you want to modify and Select Unlock Operation. Then, Create Country Preference screen is displayed. Modify the necessary information.
- Click Save to save the changes. The Country Preference Maintenance screen is closed and the changes made are reflected in the View Country Preference screen.

## 2.2.4 Viewing Country Preference Details

To view the currency details that you have previously entered:

- Invoke the View Country Preference Screen from the Browser.
- Select the authorization status of the currency records that you want to retrieve for viewing in the Authorized field. You can also view all currencies that are either unauthorized or authorized, by choosing the Unauthorized / Authorized option.
- Specify any or all the search parameters.
- Click 'Search'. All records with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record that you want to view and Select View operation. Then, Create Country Preference screen is displayed in view mode.

## 2.2.5 Deleting Country Preference Details

You can delete only unauthorized records which were not authorized even once. To delete a country preference record:

- Invoke the View Country Preference screen from the Browser.
- Select the status of the currency record that you want to retrieve for deletion.
- Specify any or all the search parameters of the currency record in the corresponding fields on the screen.
- Click 'Search'. All records with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record that you want to delete and Select Delete Operation. The system prompts you to confirm the deletion, and the record is deleted physically from the system database.

## 2.2.6 Authorizing Country Preference Details

An unauthorized currency must be authorized in the system for it to be processed. To authorize a currency:

- Invoke the View Country Preference Maintenance screen from the Browser.
- Select the status of the currency record that you want to retrieve for authorization. Typically, choose the unauthorized option from the drop-down list.

- Specify any or all the search parameters of the currency in the corresponding fields on the screen.
- Click 'Search'. All records with the specified details that are pending authorization are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record that you want to Authorize and Select Authorize Operation. The system prompts you to confirm the authorization, and the record is authorized physically from the system database.

When the checker authorizes a preference, details of validations, if any, that were overridden by the maker of the currency code during the Save operation, are displayed. If any of these overrides results in an error, the checker must reject the currency.

## 2.2.7 Amending Country Preference Details

After a country preference is authorized, it can be modified using the Unlock operation from Action list. To make changes to a currency after authorization, you must invoke the Unlock operation which is termed as Amend Operation.

- Invoke the View Country Preference screen from the Browser.
- Select the status of the currency record that you wish to retrieve for amendment. You can only amend records of currencies that are authorized.
- Specify any or all the search parameters of the currency in the corresponding fields on the screen.
- Click 'Search'. All currency records with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record you want to amend and Select Unlock Operation. Then, Create Country Preference screen is displayed in Amendment mode.
- Amend the necessary information. Click the Save button to save the changes.

#### Note

An amended country preference record must be authorized for the amendment to be made effective in the system. The process of authorization after amendment is same as the process of normal authorization.

If we delete the record after amendment, only the amendments made after Auth are deleted. Record will be available in the system.

## 2.2.8 Copying the attributes

If you want to create a new country preference record having the same attributes of an existing country preference record, you can copy the attributes of an existing country preference record to a new country preference record.

To copy the attributes:

- Invoke the View Country Preference screen from the Browser.
- Select the status of the currency record that you wish to retrieve for copy.
- Specify any or all the search parameters of the currency in the corresponding fields on the screen.

- Click 'Search'. All currency records with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record, which attributes you want to copy and Select Copy Operation. Then, Create Country Preference screen is displayed in Amendment mode with few/all attributes were copied except key attributes.
- Amend the necessary information. Click the Save button to save the changes.

## 3.2.2 <u>Retrieving Entity in View Entity (Summary) Screen</u>

You can retrieve a previously entered entity as follows:

- Invoke the View Entity (Summary) screen and click on search icon at the top left corner of the screen and specify the following:
  - The status of the entity in the Authorization Status field. If you choose the "Blank Space" option, then all the entities are retrieved.
  - The status of the entity in the Open field. If you choose the "Blank Space" option, then all the entities are retrieved.
  - The Entity ID
  - Entity Type
  - Entity Name
- Click 'Search' button after you have specified the required details, all entities with the specified details are retrieved and displayed in the lower portion of the screen.

You can perform Edit, Delete, Amend, authorize operation by selecting from the Action list.

You can also search the record by using combination of % and alphanumeric value.

For example, you can search the record for Entity ID by using the combination of % and alphanumeric value as follows: -

- Search by D%:- System will fetch all the records whose Entity ID starts from Alphabet 'D'. For example, Direct.
- Search by %7:- System will fetch all the records whose entity ID Type ends by numeric value' 7'. For example, AGENT7.
- Search by %17%:- System will fetch all the records whose Entity ID contains the numeric value 17. For example, AGENT17.

## 3.2.3 Editing Entity

You can modify the details of an entity that you have already entered into the system, provided it has not been subsequently authorized. You can perform this operation as follows:

- Invoke the View Entity (Summary) screen from the Browser.
- Select the status of the entity that you want to retrieve for modification in the Authorization Status field. You can only modify records of entities that are unauthorized. Accordingly, choose the unauthorized option from the drop-down list.
- Specify any or all of the details of the entity in the corresponding fields on the screen to retrieve the entity that is to be modified.
- Click 'Search' button. All unauthorized entities with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dotted icon and click on Unlock. The Entity Maintenance screen is displayed.
- Modify the necessary information.
- Click Save & Close to save the changes. The Entity Maintenance screen is closed and the changes made are reflected in the Entity Summary screen.

## 3.2.4 Viewing Entity

To view an entity that you have previously entered:

- Invoke the View Entity Summary Screen from the Browser.
- Select the status of the entity that you want to retrieve for viewing in the Authorization Status field. You can also view all entities that are either unauthorized or authorized only, by choosing the Unauthorized / Authorized option.
- Specify any or all of the details of the entity in the corresponding fields on the screen.
- Click 'Search' button. All entities with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dotted icon and click on View. The Entity Maintenance screen is displayed in view mode.

## 3.2.5 Deleting Entity

You can delete only unauthorized entities in the system. To delete an entity:

- Invoke the View Entity Summary screen from the Browser.
- Select the status of the entity that you want to retrieve for deletion.
- Specify any or all of the details of the entity in the corresponding fields on the screen.
- Click 'Search' button. All entities with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dotted icon and click on Delete and the record is deleted physically from the system database.

## 3.2.6 Authorizing Entities

An unauthorized entity must be authorized in the system for it to be processed. To authorize an entity:

- Invoke the View Entity Summary screen from the Browser.
- Select the status of the entity that you want to retrieve for authorization. Typically, choose the unauthorized option from the drop-down list.
- Specify any or all of the details of the entity in the corresponding fields on the screen.

- Click 'Search' button. All entities with the specified details that are pending authorization are retrieved and displayed in the lower portion of the screen.
- Click on 3 dotted icon and select Authorize button. New dialogue window is displayed, click on Approve button to authorize record.

- Click 'Search' button. All entities with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dotted icon and select Unlock button. The Entity Maintenance screen is displayed in Amendment mode.
- Amend the necessary information. Click the Save & Close button to save the changes.

## 3.2.8 Authorizing Amended Entities

An amended entity must be authorized for the amendment to be made effective in the system. The process of authorization is subsequently the same as that for normal process.

This screen supports New, Edit, Delete, Authorize, Copy, Amend and Close operations. A Segment can be closed unless it is mapped to any Agency Branch or Unit holder or Fund.

- Specify any or all of the details in the corresponding fields to retrieve the record that is to be modified. All unauthorized records with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on three dots menu of the record you want to modify in the list of displayed record.
- Select Unlock Operation from Action list to modify the record. Modify the necessary information.

You can delete only unauthorized records in the system. To delete a record that you have previously entered:

- Invoke the View Segment screen from the Browser.
- Select the status of the record that you want to retrieve for deletion.
- Specify any or all of the details and click 'Search' button. All records with the specified details are retrieved and displayed in the lower portion of the screen.

# 5.1 Create Source Currency Pair

All sources that will be used to derive prevailing exchange rates between any two currencies must be identified in the system, with a unique identification and a profile. You can maintain these sources through the 'Create Source Currency Pair' screen.

You can invoke the 'Create Source Currency Pair' screen by typing 'Create Source Currency Pair' in 'Menu Item Search' at the top left corner of the screen or alternatively you can navigate manually Menu -> Investor *Servicing -> Source Currency Pair -> Create* Source Currency Pair

The profile for each source will consist of the following details:

- The unique ID and the name of the source
- The reference currency associated with this source, against which exchange rates for all other currencies will be derived.
- The default fluctuation percentage that is admissible for this source. Exchange Rates derived from this source can be overridden only within this percentage range.
- Units of quotation for the source reference currency, which will be used for the direct rates.

Before you maintain an exchange rate source in this screen, it is desirable to ensure that the currencies must be set up in the system in the Currency Maintenance.

# 5.1.1 Source Information Section

#### Source ID

*Alphanumeric; 6 Characters; Mandatory* Specify a unique identification for the Source that is to be maintained.

### Source Name

Alphanumeric; 60 Characters; Mandatory Specify the name of the Source that is to be maintained.

#### Source Reference Currency

Alphanumeric; 3 Characters; Mandatory

Select the currency that is to be designated as the reference currency for this source. This is the currency in which the rates are to be maintained for the other currencies.

An In Currency can be designated as the Reference Currency for a Source only if the validity period (transition period) for the currency has not commenced. At that point when the validity period commences, exchange rates can no longer be captured for this Source. The Reference Currency is defaulted once you select the Source.

#### **Default Fluctuation Allowed (%)**

Numeric; 5 Characters; Mandatory Specify the default percentage by which the exchange rates can be overridden or within which they can be allowed to fluctuate.

### **Quotation Units for Reference Currency**

*Alphanumeric; 27 Characters; Mandatory* Specify the units of quotation that must be used for direct rates for the reference currency.

# 5.1.2 Pair Currency Details Section

Before you set up the pair currencies for a source, it is desirable to ensure that the following Information is already setup in the system:

- The source for which the currency pair setup must be maintained has already been set up in the Source Maintenance.
- The currencies have already been maintained in the Currency Maintenance

### **Pair Currency**

### Alphanumeric; 3 Characters; Mandatory

Select the currency that must be set up as a pair currency for the source, from the drop-down list. An In Currency can be designated as a Pair Currency for a particular reference currency only if the validity period (transition period) for the currency has not commenced. At that point when the validity period commences, no exchange rates can be maintained for this currency. The Pair Currency is already set up for the source; you have to only select the pair currency for which exchange rate needs to be maintained

#### **Quotation Mode**

#### Mandatory

Select the mode of quotation that will be used to derive the exchange rate for this currency pair from the drop-down list. It could be a direct or an indirect quote.

#### **Fluctuation Allowed**

### Numeric; 5 Characters; Mandatory

Specify the default percentage by which the exchange rates can be overridden or within which they can be allowed to fluctuate for this currency pair. This is defaulted to the value specified in the Source Maintenance record for this source, but it can be altered at this stage.

#### **Quotation Units**

### Numeric; 5 Characters; Mandatory

Specify the units of quotation that must be used in direct rates for this currency pair. This is defaulted to the units specified in the Source Maintenance record for this source. If the mode of quotation specified for the pair is direct, then the default value cannot be altered. If the mode is indirect, then the default value may be altered.

### **Currency Disabled?**

Mandatory

Select 'Yes' option if currency is disabled from the drop-down list. Else select 'No'.

If this is Yes, then, that Source-Pair combination will not be considered for selecting ModeOfQuotation, QuotationUnits, Fluctuation Allowed while generating Transactions, while enriching exchange rates.

# 5.2.1 Making Changes to Sources or Currency Pairs for Source

After you have set up an exchange rate source, you must have another user authorize it so that it would be effective in the system. Exchange rates for an unauthorized source will not be used in the system.

Before the exchange rate source with its associated pair currencies is authorized, you can edit its details as many times as necessary. You can also delete it before it is authorized.

After authorization, you can only make changes to any of the details of the source and currency pairs through an amendment, except in the following circumstances:

- It has been specified as the default source for the AMC in the Defaults Maintenance.
- Exchange Rates have been captured for the source
- The currency combination selected for amendment is in use as a fund base currency transaction currency combination for any one fund in the system.
- The currency combination selected for deletion is being used to arrive at a derived rate between two currencies that do not form part of a currency pair for a source.

You can invoke the 'View Source Currency Pair' screen by typing 'View Source Currency Pair' in 'Menu Item Search' at the top left corner of the screen or alternatively you can navigate manually Menu -> Investor Servicing -> Source Currency Pair -> View Source Currency Pair

You can perform Edit, Delete, Amend, authorize operation by selecting from the Action list. You can also search the record by using combination of % and alphanumeric value.

### Example

You can search the record for Source ID by using the combination of % and alphanumeric value that is, Search by R%: The system will fetch all the records whose Source ID starts from Alphabet 'R'. For example, Reuters

# 5.2.3 Editing Source Currency Pair Details

You can modify the details of a source currency pair that you have already entered in the system, provided it has not been authorized. You can perform this operation as follows:

Invoke the View Source Currency Pair screen from the Browser.

- Select the authorization status of the source currency pair records that you want to retrieve for modification in the Authorization Status field. You can only modify records of the source currency pairs that are unauthorized. Accordingly, choose the Unauthorized option from the drop-down list.
- Specify any or all of the search parameters for retrieving the records.
- Click 'Search' button. All unauthorized records with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record you want to modify and Select Unlock Operation. Then, Create Source Currency Pair screen is displayed in Unlock mode

- Invoke the View Source Currency Pair screen from the Browser.
- Select the status of the source currency pair records that you want to retrieve for authorization. Typically, choose the unauthorized option from the drop-

down list.

- Specify any or all the search parameters for retrieving the records.

- Invoke the View Source Currency Pair screen from the Browser.
- Select the status of the source currency pair record that you wish to retrieve for amendment. You can only amend records of associations that are authorized.
- Specify any or all the search parameters for retrieving the records.
- Click 'Search' button. All the records with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record you want to amend and Select Unlock Operation. Then, Create Source Currency Pair screen is displayed in Amendment mode.
- Amend the necessary information. Click the Save button to save the changes.

### Note

An amended source currency pair record must be authorized for the amendment to be made effective in the system. The process of authorization after amendment is same as the process of normal authorization. If we delete the record after amendment, only the amendments made after Auth are deleted. Record will be available in the system.

# 5.2.8 Copying Attributes of Source Currency Pair

If you want to maintain a source currency pair having the same attributes of an existing source currency pair rate, you can copy the attributes of an existing source currency pair to a new source currency pair.

To copy the attributes:

Retrieve the source currency pair record whose attributes the new currency pair should

inherit. You can retrieve the record through the View Source Currency Pair screen

 Click on 3 dots menu of the record you want to copy and Select Copy Operation. Then, Create Source Currency Pair screen is displayed with few/all details inherited except key attributes. • Indicate the new Source ID. You can however change the details if required. And, then save.

#### Description

*Date Format; Optional.* Specify the date from when the Daylight-Saving Time or Summertime ends.

#### Offset From GMT (HH24: MI: SS)

*Numeric; 24 Characters; Mandatory* Enter the time difference between the Time Zone and Greenwich Meridian Time.

#### Server Time Zone

Optional

Make the slider to ON state, to specify if the time zone code is where the server would be located.

#### Behind GMT

*Optional* Make the slider to ON state, to denote that the Time Zone being maintained is behind GMT.

# 6.2.1 Invoking the View Time Zone Screen

To perform any operation on Fund-ISIN association, you must first retrieve the record from the database in the Summary screen. You can invoke the 'View Time Zone' screen by typing 'View Time Zone' in the field at the top right corner of the Application tool bar and clicking on the adjoining arrow button.

You can perform the following operations on a Time Zone:

- View
- Edit
- Delete
- Authorize
- Amend
- Authorize an amended record
- Copy the Attributes

# 6.2.2 Retrieving Record in View Time Zone Screen

You can retrieve a previously entered record in the Summary Screen, as follows:

Invoke the summary screen and specify any or all of the following details in the corresponding fields:

- The status of the record in the Authorized field. If you choose the 'Blank Space' option, then all the records are retrieved.
- The status of the record in the Open field. If you choose the 'Blank Space' option, then all records are retrieved
- Time Zone
- Click 'Search' button to view the records. All the records with the specified details are retrieved and displayed in the lower portion of the screen.

# 6.2.3 Editing Time Zone Maintenance

You can modify the details of a Time Zone Maintenance that you have already entered into the system, provided it has not been subsequently authorized. You can perform this operation as follows:

• Invoke the View Time Zone screen from the Browser.

- Select the status of the record that you want to retrieve for modification in the Authorized field. You can only modify records that are unauthorized. Accordingly, choose the unauthorized option.
- Specify any or all of the details in the corresponding fields to retrieve the record that is to be modified.
- Click 'Search' button. All unauthorized records with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record you want to modify in the list of displayed records.
- Select Unlock Operation from the Action list to modify the record. Modify the necessary information.
- Click Save to save your changes. The Time Zone Maintenance Detail screen is closed and the changes made are reflected in the View Time Zone screen.

# 6.2.4 Viewing Time Zone Maintenance

To view a record that you have previously input, you must retrieve the same in the View Time Zone screen as follows:

- Invoke the View Time Zone screen from the Browser.
- Select the status of the record that you want to retrieve for viewing in the Authorization Status field. You can also view all records that are either unauthorized or authorized only, by choosing the Unauthorized/ Authorized option.
- Specify any or all of the details of the record in the corresponding fields on the screen.
- Click 'Search' button. All records with the specified fields are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record you want to view in the list of displayed records. The Time Zone Maintenance Detail screen is displayed in View mode.

# 6.2.5 Deleting Time Zone Maintenance

You can delete only unauthorized records in the system. To delete a record that you have previously entered:

- Invoke the View Time Zone screen from the Browser.
- Select the status of the record that you want to retrieve for deletion.
- Specify any or all of the details in the corresponding fields on the screen.
- Click 'Search' button. All records with the specified fields are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record you want to delete in the list of displayed records.
- Select Delete Operation from the Action list. The system prompts you to confirm the deletion and the record is physically deleted from the system database.

# 6.2.6 <u>Authorizing Time Zone Maintenance</u>

An unauthorized Time Zone Maintenance must be authorized in the system for it to be processed. To authorize a record:

- Invoke the View Time Zone screen from the Browser.
- Select the status of the record that you want to retrieve for authorization. Typically, choose the unauthorized option.
- Specify any or all of the details in the corresponding fields on the screen.

- Click 'Search' button. All records with the specified details that are pending authorization are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record you wish to authorize. Select Authorize operation from the Action List.

When a checker authorizes a record, details of validation, if any, that were overridden by the maker of the record, during the Save operation are displayed. If any of these overrides results in an error, the checker must reject the record.

# 6.2.7 Amending Time Zone Maintenance

After a Time Zone Maintenance is authorized, it can be modified using the Unlock operation from the Action List. To make changes to a record after authorization:

- Invoke the View Time Zone screen from the Browser.
- Select the status of the record that you want to retrieve for authorization. You can only amend authorized records.
- Specify any or all of the details in the corresponding fields on the screen.
- Click 'Search' button. All records with the specified details that are pending authorization are retrieved and displayed in the lower portion of the screen.
- Click on 3 dots menu of the record you wish to authorize Select Unlock operation from the Action List to amend the record.
- Amend the necessary information and click on Save to save the changes.

#### Note

An amended Time Zone maintenance record must be authorized for the amendment to be made effective in the system. The process of authorization after amendment is same as the process of normal authorization. If we delete the record after amendment, only the amendments made after Auth are deleted. Record will be available in the system.

# 6.2.8 Copying Attributes

If you want to create a new Time Zone Maintenance with the same attributes of an existing maintenance, you can copy the attributes of an existing Time Zone Maintenance to a new one.

To copy the attributes:

- Invoke the View Time Zone screen from the Browser.
- Click on 3 dots menu of the record you wish to Copy. Select Copy operation from the Action List to Copy the record.
- Amend the necessary information and click on Save to save the changes.

# 7.1 Create Branch Preferences

Typically, in an AMC/Distributor, installation of Oracle FLEXCUBE Investor Servicing installs the following components:

- Fund Manager
- Agency Branch

In case of a Pension house, user should create Pension Module.

In a network scenario, the following situations are also possible:

- A single AMC/Distributor with a single installation may have two or more "instances" of Agency Branch
- A multi-AMC/Distributor situation where a number of AMCs/Distributors are networked, and each AMC/Distributor has one or more Agency Branch.

Each instance of the installation, in a multi-networked situation, is referred to a Branch. At the time of installation, the installation process sets up the Fund Manager in the system.

Subsequently, the system admin User must set up the corresponding Fund Manager, Agency Branch and/or Pension as applicable.

Subsequently, if any new agency branch branches need to be created, the system admin User can create them using the 'Create Branch Preferences' screen. You can invoke this screen by typing 'Branch Preferences' in 'Menu Item Search' at the top left corner of the screen or alternatively you can navigate

manually Menu $\rightarrow$ Investor Servicing $\rightarrow$  Branch Preferences $\rightarrow$  Create Branch Preferences.

By default, user is displayed with Grid view. In order to change to List view, click on List view icon at the top right corner of the screen.

# 6.2.2 <u>Retrieving Branch in Branch Preferences (Summary)</u> Screen

You can retrieve a previously entered Branch as follows:

- Invoke the View Branch Preferences (Summary) screen and click on search icon at the top left corner of the screen and specify the following:
  - The status of the Branch Preferences in the Authorization Status field. If you choose the "Blank Space" option, then all the Branch Preferences are retrieved.

When the checker authorizes a Branch, details of validations, if any, that were overridden by the maker of the transaction during the Save operation, are displayed. If any of these overrides results in an error, the checker must reject it.

# 6.2.7 Amending Branch Preferences

After a Branch is authorized, it can be modified using the Unlock operation.

- Invoke the View Branch Preferences Summary screen from the Browser.
- Select the status of the Branch that you wish to retrieve for amendment. You can only amend records of Branches that are authorized.
- Specify any or all of the details of the branch in the corresponding fields on the screen.
- Click 'Search' button. All Branches with the specified details are retrieved and displayed in the lower portion of the screen.
- Click on 3 dotted icon and select Unlock button. The Create Branch Preferences screen is displayed in Amendment mode.
- Amend the necessary information. Click the Save & Close button to save the changes.

An amended branch must be authorized for the amendment to be made effective in the system. The process of authorization is subsequently the same as that for normal process. If we delete the record after amendment, only the amendments made after Auth are deleted. Record will be available in the system.
