The PeopleSoft Online Help is a website that enables you to view all help content for PeopleSoft applications and PeopleTools. The help provides standard navigation and full-text searching, as well as context-sensitive online help for PeopleSoft users.

Hosted PeopleSoft Online Help

You can access the hosted PeopleSoft Online Help on the [Oracle Help Center](#). The hosted PeopleSoft Online Help is updated on a regular schedule, ensuring that you have access to the most current documentation. This reduces the need to view separate documentation posts for application maintenance on My Oracle Support. The hosted PeopleSoft Online Help is available in English only.

Locally Installed PeopleSoft Online Help

If you're setting up an on-premises PeopleSoft environment, and your organization has firewall restrictions that prevent you from using the hosted PeopleSoft Online Help, you can install the online help locally. Installable PeopleSoft Online Help is made available with selected PeopleSoft Update Images and with PeopleTools releases for on-premises installations, through the [Oracle Software Delivery Cloud](#).

Your installation documentation includes a chapter with instructions for how to install the online help for your business environment, and the documentation zip file may contain a README.txt file with additional installation instructions. Common Help Documentation

Common help documentation contains information that applies to multiple applications. The two main types of common help are:

- Application Fundamentals

- Using PeopleSoft Applications

Most product families provide a set of application fundamentals help topics that discuss essential information about the setup and design of your system. This information applies to many or all applications in the PeopleSoft product family. Whether you are implementing a single application, some combination of applications within the product family, or the entire product family, you should be familiar with the contents of the appropriate application fundamentals help. They provide the starting points for fundamental implementation tasks.

In addition, the *PeopleTools: Applications User's Guide* introduces you to the various elements of the PeopleSoft Pure Internet Architecture. It also explains how to use the navigational hierarchy, components, and pages to perform basic functions as you navigate through the system. While your application or implementation may differ, the topics in this user's guide provide general information about using PeopleSoft applications.

Field and Control Definitions

PeopleSoft documentation includes definitions for most fields and controls that appear on application pages. These definitions describe how to use a field or control, where populated values come from, the effects of selecting certain values, and so on. If a field or control is not defined, then it either requires no additional explanation or is documented in a common elements section earlier in the documentation. For example, the Date field rarely requires additional explanation and may not be defined in the documentation for some pages.

Typographical Conventions

The following table describes the typographical conventions that are used in the online help.

Key+Key	Indicates a key combination action. For example, a plus sign (+) between keys means that you must hold down the first key while you press the second key. For Alt+W , hold down the Alt key while you press the W key.

{ } (curly braces)	Indicate a choice between two options in PeopleCode syntax. Options are separated by a pipe ().

ISO Country and Currency Codes

PeopleSoft Online Help topics use International Organization for Standardization (ISO) country and currency codes to identify country-specific information and monetary amounts.

ISO country codes may appear as country identifiers, and ISO currency codes may appear as currency identifiers in your PeopleSoft documentation. Reference to an ISO country code in your documentation does not imply that your application includes every ISO country code. The following example is a country-specific heading: "(FRA) Hiring an Employee."

The PeopleSoft Currency Code table (CURRENCY_CD_TBL) contains sample currency code data. The Currency Code table is based on ISO Standard 4217, "Codes for the representation of currencies," and also relies on ISO country codes in the Country table (COUNTRY_TBL). The navigation to the pages where you maintain currency code and country information depends on which PeopleSoft applications you are using. To access the pages for maintaining the Currency Code and Country tables, consult the online help for your applications for more information.

Region and Industry Identifiers

Information that applies only to a specific region or industry is preceded by a standard identifier in parentheses. This identifier typically appears at the beginning of a section heading, but it may also appear at the beginning of a note or other text.

Example of a region-specific heading: "(Latin America) Setting Up Depreciation"

Region Identifiers

Regions are identified by the region name. The following region identifiers may appear in the PeopleSoft Online Help:

- Asia Pacific
- Europe
- Latin America
- North America

Industry Identifiers

Industries are identified by the industry name or by an abbreviation for that industry. The following industry identifiers may appear in the PeopleSoft Online Help:

- USF (U.S. Federal)

- E&G (Education and Government)

Translations and Embedded Help

PeopleSoft 9.2 software applications include translated embedded help. With the 9.2 release, PeopleSoft aligns with the other Oracle applications by focusing our translation efforts on embedded help. We are not planning to translate our traditional online help and PeopleBooks documentation. Instead we offer very direct translated help at crucial spots within our application through our embedded help widgets. Additionally, we have a one-to-one mapping of application and help translations, meaning that the software and embedded help translation footprint is identical—something we were never able to accomplish in the past.

Chapter 1

Getting Started with Stock Administration

Stock Administration Overview

Stock Administration provides the tools to administer stock option and stock purchase plans for your workforce. As a fully integrated solution, the system enables you to leverage data and functionality that you already use as part of your human resources, payroll, and benefits applications.

Stock Administration Business Processes

Stock Administration discusses the following business processes:

- Stock administration.
 - Stock option plan administration.
 - Stock purchase plan administration.
-

Stock Administration Integrations

This section discusses integration with:

- PeopleSoft Human Resources (HR).
- PeopleSoft HR Base Benefits business process and PeopleSoft Benefits Administration.
- PeopleSoft Payroll for North America.

Human Resources

Stock Administration uses various types of information that you set up in HR, including employee and nonemployee data. Changes that you make to a plan participant's status in your human resources system can trigger a workflow notification to a stock administrator.

- Stock Actions

The setup tables used for HR integration are Stock Action, Stock Action Reason, and Stock Action Rules. The type of action determines the type of processing. You can process an action by receiving a worklist or by processing it manually.

- Nonemployees

The stock system handles regular employees within your company and nonemployees. Examples of non-employees are members of boards of directors, contractors, or employees of a subsidiary or foreign office who are not administered by HR.

- **Multiple Jobs**

For stock options and reports that require an employee's job title and other job information, the stock system refers to the primary job identified by HR for supporting processes. For stock purchase plans, the system refers to the job designated within the Base Benefits business process.

- **Variable Compensation**

Stock awards are given through the Variable Compensation business process. Because of this integration, stock awards are included with all other variable monetary and non-monetary awards for total variable compensation reporting and history. Stock Administration grants and administers stock awards after they are approved and received from HR as service operations. Both Stock Administration and Variable Compensation use the group build feature so that when groups are used, they are consistent between the two systems.

When splitting or repricing stock, it is important that you coordinate this action with your Variable Compensation process.

Base Benefits Business Process and Benefits Administration

Either the Base Benefits business process within HR or Benefits Administration can administer your stock purchase plan and enroll participants, including eligible employees and non-employees who are not administered by HR. A stock purchase plan is a savings plan designating the reserved plan type 4A to indicate stock purchase. After setting up your stock purchase plans, you can enroll eligible plan participants directly through the Base Benefits business process or through the automated eligibility and event-driven Benefits Administration system.

Payroll for North America

Several stock option and stock purchase transactions are integrated with Payroll for North America.

The integrated *Stock Option* transactions are:

- Exercises and releases.

Payroll for North America calculates taxes on ordinary income from exercises and releases. You invoke the calculation process and display the results in Stock Administration, then send ordinary income and taxes to the payroll system. Payroll loads these transactions using the Load/Reset Paysheet process, which updates employee balances but does not issue a check.

- Dispositions.

Stock Administration enables you to send ordinary income from dispositions to the Load/Reset Paysheet transaction record (PSHUP_TXN) in Payroll for North America.

The integrated *Stock Purchase* transactions are:

- Contributions.

Contributions are gathered from Payroll for North America during the Purchase Stock process.

- Refunds.

The Refund Contributions process in Stock Administration sends contributions to be refunded to the Load/Reset Paysheet transaction record (PSHUP_TXN) in Payroll for North America.

- Dispositions.

Stock Administration enables you to send ordinary income from dispositions to the Load/Reset Paysheet transaction record (PSHUP_TXN) in Payroll for North America.

Stock Administration Implementation

PeopleSoft Setup Manager enables you to generate a list of setup tasks for your organization based on the features that you are implementing. The setup tasks include the components that you must set up, listed in the order in which you must enter data into the component tables, and links to the corresponding documentation.

Other Sources of Information

In the planning phase of your implementation, take advantage of all PeopleSoft sources of information, including the installation guides, data models, business process maps, troubleshooting guidelines, and PeopleTools documentation such as *PeopleTools: Component Interfaces* and *PeopleTools: Setup Manager*

Understanding Stock Administration

Stock Administration Features

This section discusses:

- General stock administration features.
- Stock option features.
- Stock purchase features.
- Administrative and regulatory reports.

Stock Administration provides the tools to administer and maintain stock option and stock purchase plans for your workforce. As a fully integrated solution, the system enables you to leverage data and functionality that you already use as part of your human resources, payroll, and benefits applications.

Note: PeopleSoft Stock Administration is a US product, supporting US legislative and regulatory requirements. Although this product can support global administration requirements for determining eligibility, calculations, allocation and grant generation; securities administration and taxation requirements outside of the US must be managed and maintained by the customer.

General Stock Administration Features

You can define business rules that dictate how the system handles common elements for stock option plans, stock purchase plans, and regulatory reports. With Stock Administration you can:

- Support multiple plans.
- Track and maintain plan balances, common issued and outstanding shares, and treasury shares.
- Store transfer agent, escrow agent, and broker instructions.
- Track insider activity.
- Track daily stock prices.
- Calculate the fair market value (FMV) of stock transactions.
- Create multiple FMV methods.
- Identify individuals for proxy and Section 16 reporting.
- Value stock options and purchases in compliance with FAS 123.
- View stock option and stock purchase plan activity.

Stock Option Features

Use the system's stock option functionality to track and report on granted stock options, including Incentive Stock Options (ISOs), Non-Qualified stock options (NQs), and Restricted Stock Awards (RSAs). Stock option features enable you to perform a number of functions. For example:

- Generate grants from plans based on stock awards allocated in variable compensation and individual grants.
- Create vesting schedules that are tailored to your plans.
- Administer plans that enable exercises before shares have vested and permit the repurchase of shares that are exercised before vesting.
- Reprice grants for eligible individuals and set restrictions, including vesting and exercise restrictions, on the repriced grants.
- Exercise an ISO as an NQ option 90 days after termination.
- Track 83(b) filings and administer restricted stock awards, exercises, releases, and repurchases.
- Integrate with Payroll for North America to process ordinary income and taxes on restricted stock transactions.
- View stock option activity.
- View employee's stock option activity.

Stock Purchase Features

The stock purchase feature of Stock Administration enable you to identify participants in stock purchase plans, calculate participant contributions, and deduct the correct amount from payroll. You can define limits and rules that are specific to your company, administer stock purchases by purchase period, and capture stock sale information.

Stock purchase functionality enables you to:

- Integrate with Benefits and Benefits Administration to leverage benefits enrollment, deduction, and eligibility checking as you enroll employees in stock purchase plans.
- Integrate with Payroll for North America to administer employee-authorized stock purchase payroll deductions.
- Administer fixed and rolling offerings.
- Capture multiple grant dates in a purchase period.
- Process and track employee stock purchase participants who are not administered by human resources.
- Accept multi-currency contributions and refunds.
- Monitor the Section 423 \$25,000 stock purchase limit and other rules and limits that are defined in your stock purchase plans.

- View stock purchase activity.

Administrative and Regulatory Reports

Stock Administration provides reports that make it easier for you to comply with stock regulatory requirements and help administer your stock plans. These include:

- Individual statements, receipts, and transmittals.
- Reconciliation reports.
- Payroll and tax reports.
- Transfer agent and brokerage reports.
- Summary and detail reports on potential diluted options outstanding.
- FAS 123 and APB 25 financial disclosure reports.

Defining Stock Administration Business Rules

Understanding Business Rule Setup

Before you can use Stock Administration to administer your stock plans, you must define the fundamental business rules for your system, including the rules that are common to your stock option and stock purchase plans. This section provides an overview of the steps to follow to set up the stock administration business rules.

To define the basic stock administration business rules:

1. Set up foundation tables.

Usually set up only during system implementation, data in the foundation tables seldom changes.

- a. Specify the governing body for your stock plans and the governing body rules, including ISO Section 422 rules for stock option plans and Section 423 rules for stock purchase plans.
- b. Define the stock exchanges on which your stock trades, if applicable.
- c. Define the agencies that provide escrow or transfer agent services.
- d. Define the brokerage firms and branches that handle participants' transactions.
- e. Define the different fair market value (FMV) methods to use for stock transactions.

2. Set up stock rules.

Here, you create a profile for your stock and define various attributes, some of which you can override at the plan level or stock detail level.

- a. Define a unique stock ID for your stock and specify the currency, CUSIP number, and par value.
- b. Link the stock ID to escrow and transfer agents.
- c. Link the stock ID to brokerage branches.
- d. Link the stock ID to the stock exchanges on which it trades.

3. Define stock details, including the FMV method, rules for handling fractional shares and non-trading days, default rules for stock option and stock purchase plans, and the earnings codes to use when sending tax and income information to Payroll for North America.

4. Create agreements and legends to use on stock transaction documents.

5. Define the blackout periods for the stock and designate the groups or individuals who are blocked from buying or selling stock during blackout periods.
6. Define process groups to use for processing stock transactions and reporting.
7. Allocate shares to the treasury, stock classes, and stock plans.

Setting Up Foundation Tables

To set up foundation tables, use the Governing Body Rules (ST_GOVERN_BODY), Exchange Table (ST_EXCHANGE), Transfer/Escrow Agency (ST_AGENT), Brokerage Table (ST_BROKERAGE), Brokerage/Branch Table (ST_BRKR_BRANCH), and the FMV Method Table (ST_FMV_MTHD_TBL) components.

This topic provides an overview of the reports that you can generate for foundation tables, lists prerequisites, and discusses how to set up foundation tables.

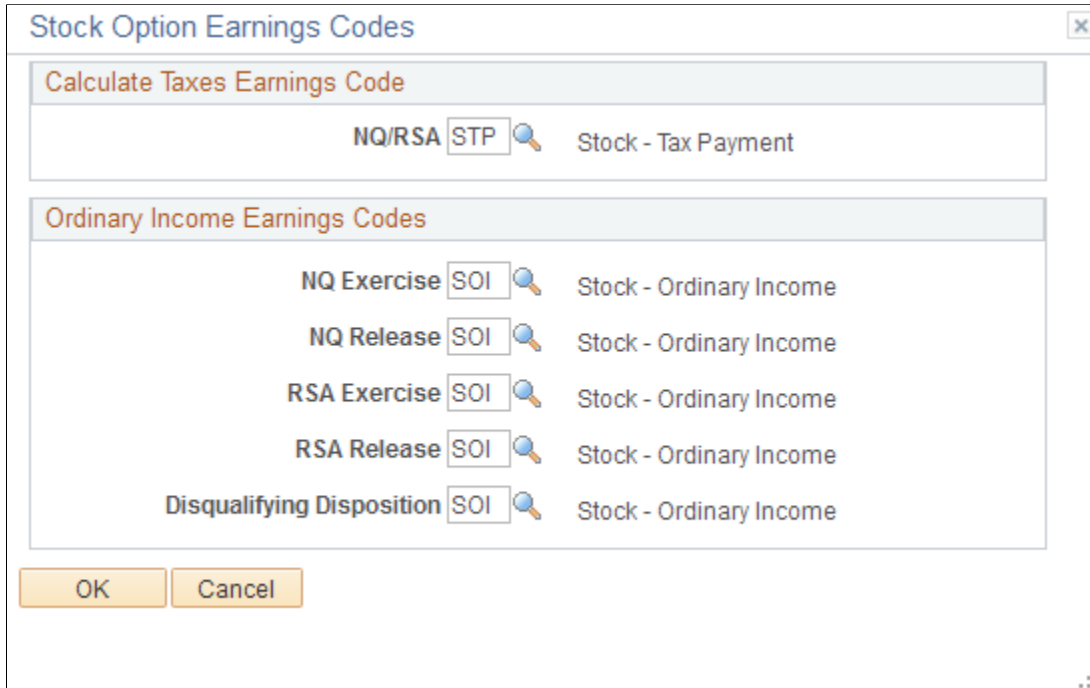

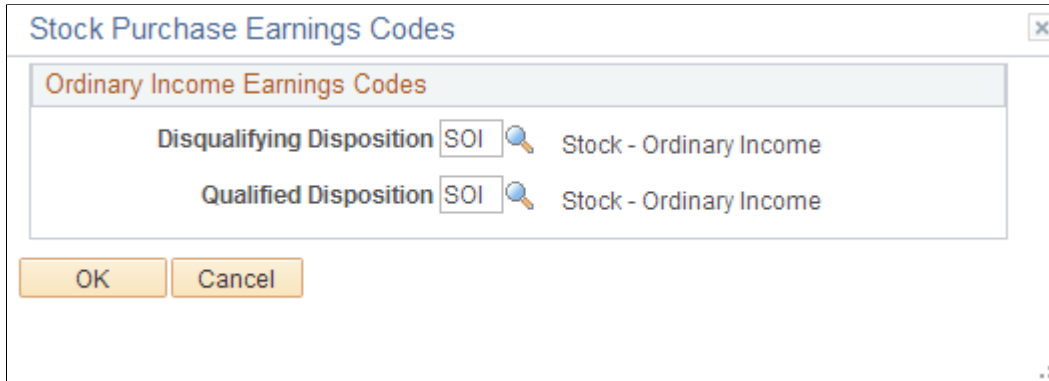

Understanding Share Allocation Procedure

After you create a stock ID and define the attributes of your stock, define the stock's treasury pools, stock classes, and stock plans and allocate shares to each.

Use the Stock Treasury Table component to set up the initial stock allocation. Later, you can change the stock allocation based on board or shareholder approved actions, stock splits, or adjustments. You can set up a treasury ID for each class of SEC approved stock: common shares, preferred shares, and warrants.

The Stock Class Table component enables you to store and track different classes of equity securities. You can set up one class of common shares, multiple classes of preferred shares, and multiple classes of warrants. Then you allocate shares from your stock treasury to your various stock classes. You establish attributes related to the class of stock and track allocations to each individual stock class.

Use the Stock Plan Table component to allocate stock from your treasury to individual stock plans. You can create multiple plans for each stock plan types: stock option, stock purchase, and stock bonus.

Chapter 4

Setting Up Stock Option Plans

Understanding Stock Option Plan Setup

This section discusses the steps for setting up stock option plans. Depending on how your organization administers its stock option plans, the majority of this setup phase is a one-time event that requires periodic maintenance on your part.

To set up stock option plans:

1. Create vesting schedules for stock options.
2. Define fiscal year calendars for stocks, if applicable.
3. Define basic stock option plan rules.

Basic rules include the option types allowed, payment and income methods, share rules, FMV rules, and other parameters.

4. Define the tax rules.
5. Define the various reasons that you grant stock options.
6. Define stock action rules.

These rules specify how certain changes in an optionee's human resources status can affect how the optionee participates in your stock plan.

Prerequisites

Before you begin to set up stock option plans, define your stock administration business rules and create common setup tables.

Creating Vesting Schedules

To create vesting schedules, use the Vesting Schedule (ST_VEST_SCHED) component.

Vesting schedules govern when and in what proportions shares become available to optionees. Vesting schedules are used when you grant options.

Example 1: Shares Vest Equally Over Three Years Beginning One Year From Hire Date

You grant an option on 04/01/99 for 1,000 shares to vest equally over 3 years, starting one year from the optionee's hire date of 03/15/99. You can define a vesting schedule that looks like this:

Vesting Schedule ID: 3at33%-Service

Description: Shares vest in three equal increments beginning one year from the Service Date.

Uneven Share Rule: Last Vest Period

Vesting Begin Code: Start/Hire Date

Sequence	Vesting Frequency	Vesting Months	Vesting Percent	Period Count
1	Annually	12	33.00	1
2	Annually	12	33.00	1
3	Annually	12	34.00	1

Or you might create one entry:

Because you specified the uneven shares load at the end of the vesting schedule, the fractional one-percent share is included in the last period. The shares vest as follows:

03/15/00 - 333 shares.

03/15/01 - 333 shares.

03/15/02 - 334 shares.

Example 2: All Shares Vest at Grant

You grant an option on 04/01/99 for 1,000 shares to vest 100% on the date of grant. You can define a vesting schedule that looks like this:

Vesting Schedule ID: 100%atGrnt

Description: All shares vest on the date they are granted.

Example 4: Quarter of the Shares Vest After One Year Then Monthly for Three Years

You grant an option on 04/01/99 for 1,000 shares to vest at 25% after one year from the date of grant and then monthly thereafter for the next year. You want to accumulate fractional shares over the vesting periods until they equal one full share, then add them to the vesting period where that occurs. You might define a vesting schedule that looks like this:

Vesting Schedule ID: 4YrCombo

Description: Shares vest 25% after 1 year and monthly thereafter for 3 years (36 months).

Defining Stock Fiscal Year Calendars

To define stock fiscal year calendars, use the Stock Fiscal Year (STOCK_FISCAL_YEAR) component. This topic discusses how to define the fiscal year calendar for a stock.

Set up fiscal year calendars if you selected Fiscal as the Year Rule on the Stock Details - Stock Options page. This rule determines how the system calculates stock option share limits.

Suppose that you have a stock option plan that limits grants to 50,000 shares per optionee in a fiscal year. At the time of a grant, the system validates that the number of shares granted does not exceed the limit for the fiscal year as defined under the Stock Details - Stock Options page and the Stock Option Plan Rules - Shares page. If the grant exceeds the share limit you receive a warning.

Share Methods

Indicate what happens to shares related to each of the events listed in the Share Methods group box. Options are:

- *Return Shares to Plan*: Shares return to the plan pool where they are available for grant. This is the default share method.

- *Retire Shares to Treasury*: Once returned to the treasury, shares are not available for grant unless allocated to a plan by the Board of Directors or the shareholders.

Field or Control	Description
Cancellations	Cancelled shares are no longer available for exercise.
Expirations	Unexercised shares cease to be exercisable at the end of the option term.
SAR Exercises	When a SAR is exercised for cash rights the individual receives the cash amount of appreciation that has occurred on the option shares rather than receiving the option shares. This field determines how the unused SAR shares are handled during an exercise.
Repurchases	A company typically repurchases shares from an individual who exercises an option before it's vested and then terminates before the vest date.
Swaps/Trades	When individuals exercise options with a stock swap, they surrender the already-owned shares of stock to pay the total required option price or taxes for the option they are purchasing.

Treasury ID	If you selected <i>Retire Shares to Treasury</i> for any share method, indicate to what treasury they are to be returned.

Optionee Share

Field or Control	Description
Optionee Limit	In this optional field, enter the maximum number of shares that can be granted to an optionee from the stock option plan. If an optionee limit is defined on the Stock Details - Stock Options page, the value defaults and this field is unavailable.

Fractional Share Rules

If you allowed fractional shares on the Stock Details - Common Rules page you can further restrict the number of decimal places here. Your selections on the Stock Details - Common Rules page determine the default values shown here; you can make the values more restrictive.

Understanding Tax Rule Setup

By setting up default tax percentages and amounts you can limit the manual tax calculations that you need to perform when participants exercise options. You can override the defaults at the time of exercise depending on an individual employee's tax situation. However, by entering default tax information you get from your payroll administrator, you can help ensure that you don't take taxes above certain limits. If you use Payroll for North America, at a minimum, the tax types must be set up to integrate with the payroll system.

Important! The tax codes and data you enter here should be directly mapped from your payroll department. Contact your Payroll Administrator to get and maintain the information stored in these pages.

Warning! You are responsible for maintaining the default tax tables.

Understanding Stock Action Rules

Changes to an employee's human resource status may affect the employee's participation in your stock option plan. You can define how various changes to an optionee's human resource status affect stock plan processing. The stock action rules you define here integrate with HR.

To define stock action rules:

1. Define a stock action and associate it with a stock action type.
2. Link an HR action/reason code combination to a stock action.
3. Define the rules by which existing grants and vesting schedules are to be modified by various stock actions.

The Stock Action Table

This table defines all unique stock actions that integrate with HR. The effective-dated table describes each stock action and the corresponding stock action type. The system recognizes three stock action types: termination, leave of absence, and return from leave. The stock action type determines the processing that is performed when a particular stock action is processed for an employee. These actions effect existing stock option grants and vesting schedules.

Examples of stock actions you can set up and their related types are:

Chapter 5

Setting Up Stock Purchase Plans

Understanding Stock Purchase Plan Setup

This section lists prerequisites and provides an overview of stock purchase plan setup.

Prerequisites

Before you begin to set up your stock purchase plans:

- Review and decide how your stock administration application integrates with other HCM applications. Specific steps you should take are:
 - Have your benefits administrator establish a stock purchase benefit plan ID. If you offer more than one stock purchase plan, for example a domestic plan and an international plan, define an individual benefit plan for each.
 - Have your benefits administrator establish a stock purchase savings plan.
 - If you use Payroll for North America, have your payroll administrator set up payroll for processing stock purchase contributions by setting up deductions.
- Define your stock administration business rules, then set up the tables that are common to, and used by, both stock purchase and stock option plans. Specific steps you should take are:
 - Establish the Section 423 rules using the Governing Body Rules - Stock Purchase Rules page.
 - Define Fair Market Values (FMV) using the FMV Method Table page.
 - Set up earning codes using the Stock Details - Stock Purchases page.
 - Set up the stock purchase plans and allocate funds using the Stock Plan Table - General page.
 - Define blackout periods using the Stock Blackout page.
 - Set up the stock exchange using the Stock Exchange Table - General page.
 - Set up the transfer agents and escrow agents using the Transfer/Escrow Agency - General page.
 - Set up the stock brokerages and stock branches using the Brokerage Table page, the Brokerage/Branch Table page, and the Stock Branch Table - General page.
 - Set up process groups to use for background processing with the Process Group page.
 - Set up issuance instructions using the Maintain Issuance Instructions page.
 - Indicate your insiders using the Insider Data page.

- Specify the daily prices using the Daily Prices Tracking page.

Stock Purchase Plan Setup

When you set up a stock purchase plan, you specify the basic building blocks that control how your plan works, including linking your stock purchase plan to an existing benefit plan, selecting fair market value methods, defining offering and purchase limits, defining purchase and contribution rules, and specifying disposition restrictions. Next, you define the rules specific to your offering and purchase periods, such as grant dates and purchase periods, and establish how contributions are deducted from payroll.

Depending on how your organization administers its stock purchase plans, the majority of this setup phase is a one-time event requiring periodic maintenance on your part.

To set up a stock purchase plan:

1. Define rules for the stock purchase plan.

In this step, you link the stock purchase plan to a benefit plan, select the fair market value methods to use, specify limits for the offering and purchase periods, and define rules for purchases, contributions, and dispositions.

2. Define the offering periods and the purchase periods for the stock purchase plan.

Here, you define the range of dates in which a stock purchase offering is valid, the grant dates for an offering period, and the purchase period range of dates.

3. Define the reasons for holding a participant's purchase.
4. Define stock purchase processing messages.
5. Define the details of the stock purchase, including the process groups, currency conversions, and other processing parameters.

Defining Stock Purchase Plan Rules

To define stock purchase plan rules, use the Stock Purchase Plan Rules (ST_ESPP_PLAN) component.

The Stock Purchase Plan Rules component defines the details of the stock purchase plan that can change over time. Use the effective-dated table to define plan level details for each stock purchase plan that you offer.

Generate the Stock Purchase Plan Rules report (STSU022) to view stock purchase plan rules information.

Note: Before you define your plan rules, you must define a stock plan ID using the Stock Plan page and a stock plan in the Stock Plan Table component. You must also have the benefits administrator define a benefit plan ID.

Purchase	Select an FMV method. This field is used to calculate the ordinary income for dispositions. Depending on your purchase plan rules, it may be used to determine the purchase price.

Non-Trading Day Rules

The system accounts for all days in a calendar year. The days that are not market trading days must be identified as such. Therefore, define a method to account for these nontrading days. The methods below supersede the holiday and weekend FMV rules defined in the Stock Details component.

Field or Control	Description
Holiday	When a FMV calculation includes a holiday, select <i>Previous Trading Day</i> to use the previous trading day's price, or <i>Next Trading Day</i> to use the next trading day's price.
Weekend	When a FMV calculation includes a weekend, select one of the following: <i>Both Previous Trading Day</i> : Uses the previous trading day's price for both weekend days. <i>Both Next Trading Day</i> : Uses the next trading day's price for both weekend days. <i>Saturday Previous - Sunday Next</i> : Uses the previous trading day's price for Saturday and the next trading day's price for Sunday. <i>Saturday Next - Sunday Previous</i> : Uses the next trading day's price for Saturday and the previous trading day's price for Sunday.

Participant Shares	Enter the maximum number of shares that a participant can purchase in an offering period.
Total Shares	Enter the total number of shares for all participants that can be issued in an offering period.

Residual Contributions

After a stock purchase is processed and confirmed, some of the participants' contributions may be left over. The balance may be less than the purchase price of the stock or the participant may have reached an offering period, or purchase period limit, which left more than the purchase price unused. Indicate a method of handling these residual contributions.

If the amount is less than the purchase price, it is carried forward to the next purchase. This is the default.</p>

Balance Threshold	If you selected a balance rule of Carry Forward Balance or Refund Balance, this field becomes available for entry. Enter the minimum amount needed to carry forward or refund.

Pay Calendar Overrides

When deductions for a pay period fall outside the range of the purchase period begin and end dates, you might need to include or exclude a pay calendar. For example, if you selected Check Date as the date type for the purchase on September 30, 1998, then processed a bonus run with a check date of July 2, 1998, the bonus run is not included in the purchase period contributions. However, the bonus is for the period ending September 30, 1998, and should be included in the contributions for the current purchase period. To include the bonus contributions in the current purchase period, you must enter a pay calendar override specifying the company, pay group, pay period end date, and on-cycle or off-cycle, and select Include. This overrides the date, and includes the deductions for the pay calendar selected in the current purchase period.

You can also specify a beginning and ending page number for the pay calendar. This enables you to select a range of employees to include or exclude in the purchase period contributions. This feature is useful for off-cycle checks because you assign the page number.

Understanding Participant Information

With Stock Administration you can quickly access the human resources information that you need to administer your stock plans. In addition to viewing participants' job, employment, and payroll data, you

can enter issuance instructions for individual participants and run the Mass Issuance Update Application Engine process (ST_RUNCTL_ISUUPD) to add issuance instructions for multiple participants. Finally, you can specify the insiders who are subject to SEC Section 16 reporting requirements and Regulation S-K proxy requirements.

Specifying Daily Stock Prices

This topic lists prerequisites and discusses how to enter and view daily stock prices.

All companies, either public or private, must establish a fair market value (FMV) for their common stock. The various prices reported daily by the stock exchanges are indications of that value. Each company decides the price, or combination of prices, to use in calculating the FMV for the various stock transactions.

Generate the Daily Prices report to view the daily prices that you have entered for a given stock.

Understanding Comprehensive Share Balance and Allocation

As a stock administrator, you must have accurate records of the number of shares that are allocated to your treasury, stock classes, and stock plans. The intricate balance tracking and share allocation functionality of Stock Administration captures online transactions and batch processes and provides reports that you can use for financial disclosure, auditing, and regulatory reporting. When you enter an "As of Date" on the share balance inquiry pages and click the calculator button, you can see the share balances as of the date that you entered.

Once you set up your balance tables, the share accounting is derived in real time off the stock options and stock purchase transaction tables. This enables you to define effective-dated rules for the return of shares to the treasury or stock plans for transactions such as cancellations, expirations, repurchases, swaps, trades, and SAR exercises.

Treasury pool and stock plan funding follow a typical allocation process with each action altering pool and plan balances. A typical allocation flow is:

1. **Fund Treasury:** A company files an initial registration statement with a regulatory agency, such as the SEC, that lists the number and type of shares allocated to the treasury. Later on, a company may increase the number of shares allocated by filing appropriate documents with the SEC to create a new treasury pool or increase the allocation levels of the current pool.
2. **Create Class Pools:** Different pools can be created for different types of shares. For example, you may create one class pool for common shares outstanding prior to implementation and another class pool for preferred shares outstanding. The common share pool for a stock ID increases and decreases depending upon stock transactions such as exercises, purchases, swaps, trades, and repurchases.
3. **Fund Stock Plans:** The Board of Directors or the shareholders approves allocating shares to a stock plan from a designated treasury pool. If you use variable compensation, you can allocate shares from your stock option plan to be used by your variable compensation plan. The variable compensation allocation doesn't affect the plan balance.
4. **Process Stock Plan Transactions:** After the stock plan allocation, daily transactions affect plan balances. Stock option plan transactions include grants, exercises, cancellations, expirations, repurchases, sales, and releases. Stock purchase plan transactions include purchases and sales.
5. **Monitor Treasury and Stock Plan Balances:** All these stock plan transactions may affect the treasury pool and stock plan balances, and may affect common shares outstanding. The system needs to accurately record the effects of these transactions and to update share balances.

Understanding Stock Split Considerations

Stock splits affect all stock shares in your stock administration system. You must split not only the outstanding stock but the outstanding stock options as well. Historic records must be split and the split must be thoroughly documented on all records.

Consider the following before you start the stock split process:

- What split ratio will you use? Companies commonly split stock in a 2 for 1 ratio. That is, for each share of stock shareholders own they receive two shares while the price for the individual shares is cut in half. Other popular ratios are 3 for 1, 3 for 2, and 5 for 4. Regardless of the ratio, the same principle holds. The stock price declines, the par value declines, and the amount of shares outstanding increases. This is not true for reverse splits.
- How are you going to handle transactions that occur between the record date and the payable date, and the record date and the process date? All FMVs and grants that occur between these dates must be adjusted to account for the stock split before you enter information into the system.

Understanding Stock Split Processing

Run the Stock Split report before and after you process a stock split. You can use these reports to reconcile your balances. You should run the Shares Granted SQR and select grants with a pending status. Then run all the SQRs for all your stock option plans and stock purchase plans. You should also run and print all balance inquiry pages just before you run the split process.

To split your stock:

1. Define the split parameters.

Define the stock split parameters, including the stock ID, the split conversion ratio for shares and stock prices, and the record date of the split, using the Define Split page.

2. Run the Stock Split Application Engine process (ST_SPLIT_PRC).

Run the Stock Split process using the Process Split page. You can run only stock splits with a split status of unprocessed.

Use the Define Split page (ST_SPLIT) to define the parameters of a stock split and the stock split ID.

Administering Stock Option Plans

Understanding Stock Option Plan Creation

This topic discusses the creation of stock option plans and the various types of stock options the system supports.

Stock Administration enables you to create and manage a variety of stock option plans. You can grant options individually or through a variable compensation program according to your organization's business rules, and track exercise, release, repurchase, and disposition transactions.

The stock option plan process starts with your management designing a stock program, frequently assisted by outside consultants and legal counsel. The organization's board of directors or a compensation committee decides on the number of shares to place in the stock option pool. Following adoption by the board, a stock option plan is often submitted to the organization's shareholders for approval at their annual meeting. State corporate law may require such approval or it may be required by the organization's charter documents, or by the stock exchange on which the organization's stock is traded.

Usually it's not necessary to obtain Securities and Exchange Commission (SEC) approval before implementing an employee stock plan. However, for publicly traded stock, the plan must be registered with the SEC before offers or sales of securities under the plan may commence. You may have to register the stock plan with the appropriate state agency before the plan can be used, unless an exemption from qualification or registration is available.

A stock option plan typically allows an organization to set the terms and conditions of its program on a company-wide basis, thereby avoiding individual negotiations with employees. Besides the plan document, an organization may have written policies and procedures concerning its stock option activities. Depending upon the provisions within the stock option plan, your organization may need several different plans. For example, an Incentive Stock Option (ISO) plan only for employees, and a Non-Qualified Stock Option (NQ) plan for employees, consultants, and outside board members. A single plan can allow for the granting of various stock option types, such as ISO, NQ, and Restricted Stock Awards (RSAs). This type of plan is commonly called an omnibus plan.

Stock Option Types

Stock Administration supports the following types of stock options:

Non-Qualified (NQ) Stock Options

NQs allow optionees to purchase stock directly from the company. The grant price may be less than the fair market value on the date the option is granted. When the option is exercised, the optionee (if a US resident) is generally taxed at the ordinary income tax rate on the difference between the option price and the fair market value at exercise. The optionee's company is entitled to a corresponding tax deduction.

Incentive Stock (ISO) Options

ISOs give individuals the right to purchase stock without incurring federal tax consequences at the time of the exercise. To maintain the preferential tax treatment the current IRS rules state the following:

- ISO options can only be granted to employees of the organization.
- The grant price must not be less than fair market value on the date of the grant. If an employee owns more than 10 percent of the organization's outstanding stock the option price must be at least 110 percent of the grant FMV.
- The number of shares first exercisable in each calendar year may not exceed an aggregate value of \$100,000.
- The option term may not exceed 10 years from the date of the grant. However, if an employee owns more than 10 percent of the organization's outstanding stock the option term may not exceed five years.

Tandem Stock Appreciation Rights

A tandem stock appreciation right (NQ/SAR or ISO/SAR) is a contractual right granted with a stock option that allows the optionee to receive the cash value equal to the appreciation on the specified number of shares exercised, or the shares of stock. If a stock distribution is made, the exercise is treated like a stock option exercise for the option type granted. The appreciation value is based on the difference between the grant price and the fair market value at exercise. When the cash appreciation is paid out, estimated income taxes are usually due on the gain.

Restricted Stock Awards (RSAs)

RSAs are generally given to key employees but can be granted to any individual. RSAs are usually granted below the current fair market value and often the grant price is set to the par value of the common stock. Optionees can exercise shares before they vest. Shares are typically held in escrow until they vest and are released. When optionees terminate before the rights to the shares are vested, organizations typically exercise their right to repurchase the shares at the option price.

Because of the risk of forfeiture, ordinary income and taxes are not calculated until the shares vest. The ordinary income equals the difference between the grant price and the fair market value on the vesting date. The optionee may elect to incur ordinary income at the time of issuance (exercise) by filing an 83(b) election.

Understanding Stock Option Grants and ISO Limits

This topic provides an overview of stock option grants and discusses the validation of ISO limits.

A stock option grant typically enables the optionee to purchase a specified number of shares of stock for a specified price over a specified period of time. Usually the right to purchase shares is detailed in the grant agreement and is contingent on the employee's continued service or other contribution to the organization for a specific period of time.

The most common types of stock options do not require a cash investment until the optionee purchases (*exercises*) the option shares.

Validation of ISO Limits

There is no limit to the number of option shares that can be granted as ISOs. However, only the first \$100,000 in aggregate fair market value of shares (determined on the grant date) covered by a stock option, which is exercisable for the first time during any calendar year, qualifies as an ISO and receives preferential tax treatment. Any amounts first exercisable in excess of \$100,000 are treated as NQs. If an individual quits and returns to the same organization within the same calendar year, the pre-termination ISO shares exercisable in that calendar year count against the limit even though they are no longer exercisable. The \$100,000 limit is defined in the governing body rules and can be changed.

The following scenarios illustrate how Stock Administration interprets the \$100,000 limit rule.

Maximum Rule Scenario

On March 6, 1995 12,500 shares are granted with an FMV of \$50 and the following vesting schedule:

The NQ shares are calculated by multiplying the corresponding percentage over the limit by the number of shares that are first exercisable in each calendar year. In our example, 60 percent of 5000 shares is 3000 shares and 20 percent of 2,500 shares is 500 shares. The number of ISO shares granted is determined by subtracting the NQ shares from the shares first exercisable each year.

In the case of stock option repricing, the double counting only needs to occur in the year of the repricing. Shares exercisable in the years prior to and after the repricing do not need to be double-counted. The reprice rules are first exercisable in all years or first exercisable as of the reprice. Many organizations choose to count all periods with which shares are first exercisable from the repriced option, although this may limit the amount of shares that can be granted as ISOs in future years. You choose which method your organization uses.

Even Rule Scenario

On March 6, 1995 12,500 shares are granted with an FMV of \$50 and the following vesting schedule:

In this example the NQ shares are calculated by multiplying the highest percentage over the limit by the number of shares first exercisable in each year. So, 60 percent of 5000 shares is 3000 shares and 60 percent of 2,500 shares is 1,500 shares. The number of ISO shares granted is determined by subtracting the NQ shares from the shares first exercisable each year.

Understanding Exercise and Release Options

This topic discusses:

- Tax calculations for exercises and releases.
- Payment methods for stock option exercise and release.

When exercising stock options, optionees must decide how to pay for the shares, the related taxes and fees; and how they want the shares to be issued. Depending on the option type, optionees may incur ordinary income and have to pay taxes at the time of exercise.

Some stock options can be exercised before they are vested. The optionee pays for the shares at the time of exercise and the shares are typically held in escrow until the vesting date. At that time, the vested shares are released and become fully tradable by the optionee. While the shares are held in escrow, the organization typically has full repurchase rights to the unvested shares.

Tax Calculations for Exercises and Releases

For vested stock options exercises, depending upon the option type, ordinary income or alternative minimum tax (AMT) income is calculated at the time of the exercise. When an option is exercised prior to vesting the income calculation generally occurs when shares are released, free of restrictions. However, an optionee may choose to file an 83(b) election to accelerate the time at which the applicable ordinary income or Tax Preference Income for AMT is recognized.

When you calculate ordinary income Stock Administration enables you to calculate taxes by integrating with PeopleSoft Payroll for North America, using Load Default taxes or by manually entering taxes

into the system for the exercise. The tax page is not available when Tax Preference Income for AMT is calculated or when ordinary income is zero. Stock Administration does not support the calculation and collection of taxes based upon Tax Preference Income for AMT pursuant to the IRS guidelines under circular E. Consult your payroll administrator or tax advisor for further information.

Tax Preference Income for AMT is calculated at exercise or release (if a restricted exercise) for ISOs and ISO/SARs exercised for shares. Ordinary income is calculated at exercise or release (if a restricted exercise) for NQs, RSAs, NQ/SARs, and ISO/SARs exercised for cash (SAR exercise). ISOs exercised after the regulatory period for termination and disability are treated as NQs and therefore ordinary income is calculated.

Stock Administration supports these exercise and release methods: cash, loan, swap, same day sale, and sell to cover, along with trade for taxes. The different share and tax payment methods affect how the system calculates the ordinary income. If an exercise method involves a sale, such as same day sale or sell to cover the system must first look to the Stock Option Plan rules for sale income methods. The methods available for each option type are FMV; sales price; or lesser of FMV or sales price. The method chosen for the option type determines what price is used when calculating the ordinary income. If only some of the shares are sold the sale income method is used only to calculate the ordinary income for the shares sold. The remaining shares (exercised but not sold) use the FMV to calculate the remaining ordinary income.

Note: Stock Administration supports only IRS tax regulations, consequently the tax calculations and discussions are based on the IRS tax code.

The following tables compare different income calculations for the various exercise and release methods.

When ordinary income is recognized at exercise or release you calculate and collect the withholding taxes for US employees. You need to define the stock tax types, percentages, and limits to enable the Load Default Tax process to calculate the appropriate withholding. When you set up the various Stock Tax Types you need to define the Country Code associated with the tax you are setting up. This enables you to set up the various taxes associated with different countries. When you click the Load Default Tax the system calculates taxes based on what is set up in the tables for the country and state code at the locality for the individual. If you use Payroll for North America you can use the Calculate Tax and Update Payroll functionality to calculate the withholding due at the exercise or the release. You need to set up stock tax types for integration with Payroll for North America in order to correlate tax class to tax type.

Payroll Integration Issues

If you use Payroll for North America you can take advantage of integrated processes to calculate taxes and send tax and ordinary income directly to payroll. Otherwise, you can generate the Options Income and Tax report to send to your payroll administrator.

Stock Option Exercise Methods and Release Methods

There are several methods optionees can use to pay for the cost of the shares and related taxes: cash, loan, stock swaps, same day sales, sell to cover, and SAR exercise.

Here's a brief discussion of each of these methods with examples illustrating how they work:

Cash

At the time of exercise, the employee is required to pay the total option price plus any withholding taxes due to the organization.

Example 1: Cash ISO Exercise

On August 22, 1998 an optionee was granted an ISO option to purchase 500 shares vesting in five annual increments beginning one year from the date of grant. The option price was \$3.40 per share. On November 1, 1999 the optionee exercised the stock option for the first 100 shares. The FMV on the date of exercise was \$12 per share. The calculation is:

Calculation Step	Example
Grant Price x Shares Exercised = Option Cost	$\$3.40 \times 100 \text{ shares} = \340
Exercise FMV x Shares Exercised = Exercise Value	$\$12 \times 100 \text{ shares} = \$1,200$
Exercise Value – Cost of Shares = Tax Preference Income for AMT	$\$1,200 - \$340 = \$860$

No withholding taxes are calculated at exercise. Thus the optionee owes the company the cost of shares (\$340.00) and receives 100 shares.

Example 2: Cash NQ Exercise

On September 22, 1998 an optionee was granted an NQ option to purchase 500 shares vesting in five annual increments, beginning one year from the date of grant. The option price was \$3.40 per share. On November 1, 1999 the optionee exercised the stock option for the first 100 option shares. The FMV on the date of exercise was \$12 per share. The optionee is a California resident for income tax purposes. The calculation is:

Calculation Step	Example
Grant Price x Shares Exercised = Option Cost	$\$3.40 \times 100 \text{ shares} = \340
Exercise FMV x Shares Exercised = Exercise Value	$\$12 \times 100 \text{ shares} = \$1,200$
Exercise Value – Cost of Shares = Ordinary Income	$\$1,200 - \$340 = \$860$

Taxes are based on your setup and whether you are integrated with Payroll for North America. For example, taxes might be calculated as follows:

Calculation Step	Example
Federal	$\$860 \times 28\% = \240.80
State	$\$860 \times 6\% = 51.60$
Social Security	$\$860 \times 6.2\% = 53.32$
Medicare	$\$860 \times 1.45\% = 12.47$
SDI	$\$860 \times .5\% = 4.30$

Calculation Step	Example
Total Taxes Due	\$362.49

Thus the optionee owes the company the sum of the cost of shares (\$340.00) and the total taxes due (\$362.49). The optionee pays the company \$702.49 and receives 100 shares.

Loan

Loans are another form of a cash exercise. They typically require a loan agreement and a promissory note. You can select Loan as a payment method at the time of exercise, but all other aspects of loan administration are handled outside of the Stock Administration system.

All aspects of processing the exercise with the payment method of Loan are the same as those involving the payment method of Cash.

Stock Swaps

When optionees elect to exercise stock options by means of a stock swap, they are exchanging shares they already own for option shares. The shares exchanged are usually valued at the fair market value of the company's stock on the date of exercise.

In the case of a stock swap, the ordinary income or Tax Preference Income for AMT is calculated in the same manner as a cash exercise. If an optionee exercises a non-qualified stock option, ordinary income is recognized on the option shares acquired and taxes may be withheld. The shares required for the swap/trade are cancelled and sent back to either the stock plan or the treasury, according to the stock option plan rules.

The formula for calculating stock swaps is:

Cost of Share = Shares Exercised x Grant Price

Shares Required for Swap = Cost of Shares/Swap FMV

Example 1: ISO Stock Swap

An optionee was granted an ISO to purchase 500 shares vesting in five annual increments beginning one year from the date of grant. The option price was \$3.40 per share. On November 1, 1999 the optionee exercised the stock option for the first 100 option shares via a stock swap. The FMV for both the exercise and swap was \$12 per share. The swap rounding rule specifies to round down. The calculation is:

Calculation Step	Example
Cost of Shares	100 x \$3.40 = \$340
Shares Required for Swap	\$340/\$12 = 28.333
Swap Value	\$12 x 28 = \$336

Calculation Step	Example
Additional Cash Required	$\$340 - \$336 = \$4$
Tax Preference Income for AMT	$(\$12 - \$3.4) \times 100 = \$860$
Total Shares Exercised	100
Shares Required for Swap	28
Net Shares Issued	72

This assumes constructive delivery of swapped shares. The optionee owes the company \$4.00 and receives 72 shares. The number of shares cancelled is 28. The cost basis for the shares issued becomes the amount due to the company divided by the net shares issued. In the above example the Cost Basis per share would be \$.055555.

Example 2: NQ Stock Swap

If an optionee exercises a non-qualified stock option, ordinary income is recognized on the option shares acquired and taxes may be withheld. The shares required for the swap/trade are cancelled and sent back to either the stock plan or the treasury, according to the stock option plan rules.

On September 22, 1998 an optionee was granted an NQ option to purchase 500 shares vesting in five annual increments beginning one year from the date of grant. The option price was \$3.40 per share. On November 1, 1999 the optionee exercised the stock option for the first 100 option shares using a stock swap and trade for taxes. The FMV for both the exercise and swap was \$12 per share. The swap rounding rule is set to round down. The optionee is resides in California and has not met the limits for Social Security or SDI. The calculation is:

Calculation Step	Example
Cost of Shares	$100 \times \$3.40 = \340
Shares Required for Swap	$\$340/\$12 = 28$
Value of Swapped Shares	$\$12 \times 28 = \336
Additional Cash Required	$\$340 - \$336 = \$4$
Ordinary Income	$(\$12 - \$3.4) \times 100 = \$860$

Taxes are calculated as follows:

Calculation Step	Example
Federal	$\$860 \times 28\% = \240.80
State	$\$860 \times 6\% = 51.60$
Social Security	$\$860 \times 6.2\% = 53.32$
Medicare	$\$860 \times 1.45\% = 12.47$
SDI	$\$860 \times .5\% = 4.30$
Total Taxes Due	\$362.49

The trade transaction is:

Calculation Step	Example
Shares Required for Trade	$\$362.49/\$12 = 30$
Value of Trade	$12 \times 30 = 360$
Additional Cash Required	$362.49 - 360 = 2.49$

Optionee owes the company	$4+2.49 = 6.49$
Total shares exercised	100 shares
Total shares Returned to Plan or Retired to Treasury	58 shares
Optionee receives	42 shares

This assumes constructive delivery of swapped shares.

For a tandem SAR, only the exercise of shares could use a stock swap. If the optionee exercises the SAR shares using a stock swap, the transaction would be handled in exactly the same manner as for the corresponding ISO or NQ example.

An option that allows unvested shares to be exercised before they are vested, such as an RSA, does not allow the use of a swap at the time of exercise. A trade is only allowed at the time the shares are released when payment is needed to cover tax liability that might be due.

Same-Day Sale

A same day sale is when the optionee finances the exercise of a stock option by immediately selling 100 percent of the shares exercised or released.

Example 1: ISO Same Day Sale

On September 22, 1998 an optionee was granted an ISO to purchase 500 shares vesting in five annual increments beginning one year from the date of grant. The option price was \$3.40 per share. On November 1, 1999 the optionee exercised the stock option for the first 100 option shares and sold all 100 shares at \$12.50 per share. The FMV on the date of exercise was \$12 per share. The sale income method for the stock plan is the lesser of the FMV or the sale price. The calculation is:

Calculation Step	Example
Grant Price x Shares Exercised = Cost of Shares	\$3.40 x 100 shares = \$340
(Lesser of FMV or Sale Price x Shares Sold) + (Shares Exercised - Shares Sold x FMV) = Exercise Value	(\$12 x 100 shares) + ((100-100) x 12) = \$1,200
Exercise Value - Option Cost = Tax Preference Income for AMT	\$1,200 - \$340 = \$860

Thus the total due the Company = \$340.00

The company instructs the transfer agent to issue 100 shares and deliver them to the stockbroker. The company also bills the stockbroker for the cost of shares (\$340.00). The optionee then receives the difference between the Total Sale Price less the Total Due Company and any brokerage fees.

Example 2: NQ Same Day Sale

On September 22, 1998 an optionee was granted an NQ to purchase 500 shares vesting in five annual increments beginning one year from the date of grant. The option price was \$3.40 per share. On November 1, 1999 the optionee exercised the stock option for the first 100 option shares. The FMV on the date of exercise was \$12 per share. The optionee resides in the state of California for income tax purposes. The calculation is:

Calculation Step	Example
Grant Price x Shares Exercised = Option Cost	\$3.40 x 100 shares = \$340

Calculation Step	Example
Exercise FMV x Shares Exercised = Exercise Value	\$12 x 100 shares = \$1,200
Exercise Value – Option Cost = Ordinary Income	\$1,200 - \$340 = \$860

Taxes are calculated as follows:

Calculation Step	Example
Federal	\$860 x 28% = \$240.80
State	\$860 x 6% = 51.60
Social Security	\$860 x 6.2% = 53.32
Medicare	\$860 x 1.45% = 12.47
SDI	\$860 x .5% = 4.30
Taxes Due at Exercise	\$362.49

The total due to the organization is = \$340.00 + \$362.49 = \$702.49

The organization instructs the transfer agent to issue 100 shares for delivery to the stockbroker and bills the stockbroker for the cost of shares and taxes (\$702.49). The optionee receives the total sales price less the total due the organization and any brokerage fees.

Sell to Cover

Sometimes the optionee only wants to sell a portion of the option shares to cover the exercise cost. Many times the optionee contacts the company to have them estimate using the current FMV, the total shares that would have to be sold to cover the cost of the exercise and applicable taxes. The following examples show how these types of transactions would be handled. Example 1: NQ Sell to Cover

On September 22, 1998 an optionee was granted an NQ to purchase 500 shares vesting in five annual increments, beginning one year from the date of grant. The option price was \$3.40 per share. On November 1, 1999 the optionee sells enough stock (60 shares at a sale price of \$12.50) to cover the exercise of 100 shares. The optionee wants to have the remaining 40 shares issued and delivered to himself. The FMV on the date of exercise was \$12 per share. The sale income method for the stock plan is set to sale price. The optionee is a California resident for income tax purposes. The calculation is:

Calculation Step	Example
Grant Price x Shares Exercised = Cost of Shares	$\$3.40 \times 100 \text{ shares} = \340
(Sale Price x Shares Sold) + ((Shares Exercised - Shares Sold) x Exercise FMV) = Exercise Value	$(60 \times \$12.50) + ((100-60) \times 12) = \$1,230.00$
Exercise Value – Cost of Shares = Ordinary Income	$\$1,230 - \$340 = \$890$

Taxes are calculated as follows:

Calculation Step	Example
Federal	$\$890 \times 28\% = \249.20
State	$\$890 \times 6\% = 53.40$
Social Security	$\$890 \times 6.2\% = 55.18$
Medicare	$\$890 \times 1.45\% = 12.91$
SDI	$\$890 \times .5\% = 4.45$
Taxes Due at Exercise	$\$375.14$

The total due the company is $\$340.00 + \$375.14 = \$715.14$

The company instructs the transfer agent to issue 60 shares and deliver them to the stockbroker, and issue 40 shares and deliver them to the optionee. The organization also bills the stockbroker for the option price and taxes (\$702.49). The optionee receives the Total Sales Price less the Total Due Company and brokerage fees.

SAR Exercise

This method is only allowed if the option type is a tandem SAR (ISO/SAR or NQ/SAR). The underlying shares of the option are valued using the SAR FMV and the optionee is paid out the cash rights on these shares by subtracting the grant price from the SAR FMV determined on the date of the exercise. Taxes are typically due on the income at the time of the exercise for both ISO/SAR and NQ/SAR option types. Only when the individual exercises the right to the ISO shares can the preferential tax treatment be taken. The underlying shares that are used to value the cash rights are then cancelled and sent back to either the stock plan or the treasury, according to the Stock Option Plan rules specified. On September 22, 1998, an optionee was granted an ISO/SAR to purchase 500 shares that vests in five annual increments, beginning one year from the date of grant. The option price was \$3.40 per share. On November 1, 1999, the optionee chose to exercise the cash right of the tandem SAR for the first 100 option shares. The SAR FMV on the date of exercise was \$12 per share. The calculation is:

Calculation Step	Example
Grant Price x Shares Exercised = SAR Cost	3.40 x 100 shares = 340
SAR FMV x Shares Exercised = Exercise Value	\$12 x 100 shares = \$1,200
Exercise Value – Cost of Shares = Ordinary Income	\$1,200 - \$340 = \$860

Withholding taxes are due on all SAR exercises. The funds paid to the optionee are treated as compensation and taxed accordingly for both ISO/SAR and NQ/SAR.

Taxes are calculated as follows:

Calculation Step	Example
Federal	\$860 x 28% = \$240.80
State	\$860 x 6% = 51.60
Social Security	\$860 x 6.2% = 53.32
Medicare	\$860 x 1.45% = 12.47
SDI	\$860 x .5% = 4.30
Total Taxes Due	\$362.49

Chapter 8

Administering Variable Compensation Grants

Understanding Variable Compensation

This topic lists prerequisites and provides overviews of Variable Compensation administration and integration.

Prerequisites

Before you begin administering your variable compensation grants you should:

- Define the rounding rules.
- Set up your stock option plans.
- Allocate stock to stock option plans.

Variable Compensation Administration

Variable compensation (VC, or variable comp) is pay that is not included in base pay. It generally varies according to performance, and can include non-monetary awards such as stock.

To administer stock through Variable Comp:

1. Set up Variable Comp tables and plans for stock awards.

Responsibility: Variable Comp (VC) Administrator.

The VC system supports five stock plan types: ISO, NQ, NSAR, RSA, and ISAR. Your VC administrator needs to set up variable comp plans that correlate to the stock option plan types you offer. Before the variable compensation plans are set up, you define in Stock Administration some of the data needed to define each plan such as stock ID, stock plans, and stock plan rules.

In setting up the VC plan, your VC administrator defines:

- VC Plan ID.
- Stock plan and Stock ID.
- Plan payout periods.
- Plan membership on an Ad Hoc, individual, or group basis.
- Valuation of a unit of stock. Stock grant valuation is based on your company's policy and business rules, and is for reporting purpose only.

- Payout formulas at the target and optional minimum and maximum level.
 - Optional weighted or matrix goals.
 - Optional eligibility proration and proration period duration.
 - Optional plan approval and identification of the approver at the plan or group level.
2. Allocate stock units from Stock Administration Stock Option Plan to the Variable Comp Stock Fund.

Responsibility: Stock Administrator.

In Stock Administration, you allocate stock units from your Stock Option stock plans to the Variable Comp stock fund. From this allocation the VC administrator can fund multiple VC stock plans that have the same stock plan and stock ID. You can anticipate a future fund allocation and allocate those stock units now because the Stock Balances are adjusted when the grants are generated, not when the stock units are allocated.

3. Allocate funds from the Variable Comp Stock Fund to the Variable Comp Stock Plan.

Responsibility: Variable Comp Administrator.

From the Stock Administrator's allocation of shares by stock plan and stock ID, the Variable Compensation administrator can fund multiple stock plans that have the same stock plan and stock ID. If the VC plan is a group plan, the funds must be allocated among the groups.

4. Allocate the stock awards.

Responsibility: Variable Comp Administrator.

An employee's manager can allocate grants on an ad hoc basis without any eligibility or award calculation processes if the plan is set up with Ad Hoc Awards as the plan member rule. Otherwise various calculation processes are required, depending upon the VC plan definition.

Managers can adjust the calculated individual awards of their direct reports. Finalized awards are automatically published to Stock Administration for grant generation.

For non- Ad Hoc plans, the VC system calculates:

- Eligibility and a proration factor according to the plan member rules and proration rules defined in the plan.
 - A performance factor if the plan uses goals.
 - Target awards, which it adjusts with the proration factor, performance factor, and specified minimums and maximums as appropriate.
 - An adjustment factor, which it applies if funding falls short of calculated payouts.
 - The award unit by applying stock rounding rules.
 - The award value by applying valuation and VC rounding rules to the award unit.
5. Generate the grants in Stock Administration.

Responsibility: Stock Administrator.

After Variable Comp publishes the stock awards, you can view them using the Generate Grants inquiry page, and run an Application Engine program to generate grants using the Generate Grants page. You can run multiple runs of the same Variable Comp stock plan, pay out period, and group, to pick up any stock award that have not been processed.

As each stock grant is generated, each Variable Comp stock award record is updated with the grant number and grant value. Each grant created during this process adds a new record to the Grant table, using values in the award record and in the run control. The Variable Comp Plan ID is stored with each grant. You can select Reject Award Data for Plan ID on the Create Grants - VC Criteria process page if you want to reject all grants within a group ID.

6. Make appropriate adjustments for cancellations due to data entry errors.

Responsibility: Stock Administrator.

Once awards are generated, you may need to change them. Changes to the grant date or grant price may affect the award value in Variable Comp and must be transmitted back to Variable Comp for constancy between the two systems. You use the Modify Grant page to modify system-generated grants generated by the Generate Grant process or manually modify the grants using the Administer Grants component.

You can modify grants created from Variable Comp awards, as you do for grants you create manually online, only you cannot change the number of shares granted. This also applies if the grant is split between an ISO and an NQ grant. The total number of shares granted cannot change. If the modification involves a change in the grant price, which in turn modifies the award value or the grant date, the modified grant information is transmitted to Variable Comp. To change the number of shares, void the grant and allocate a new award.

7. Make adjustments in Variable Comp Stock Funding, Stock Plans, and Stock Awards for stock splits and stock repricing.

Responsibility: Stock Administrator.

Some stock adjustments affect the valuation of the stock units in the Variable Comp plan, the stock price for all stock awards, or the number of shares available to allocate.

Stock splits change the number of shares available in the Variable Comp stock plan, stock funding, and awards. They also change the values in stock awards and in the valuation table. The stock split processing that occurs in the Stock Administration system, also splits the stock in any Variable Comp stock plans, stock funding, and stock awards.

When you reprice your stock, the values in stock awards and the valuation table change. You need to recalculate the value in stock awards and also in the valuation table.

8. Expire Variable Comp plans.

Responsibility: Stock Administrator.

A Variable Comp funding period expires when the period end date is reached. Run the Stock - VC Plan Expire process regularly to process the expired funding periods. Unused shares are returned to the Stock Plan from where they were originally allocated.

Variable Compensation Integration

Stock Administration uses two integration points to grant and award variable compensation grants. The system uses the following service operations to transfer award and grant data between Stock Administration and the Variable Compensation business process.

<i>Integration Point Name</i>	<i>Message Name</i>	<i>Message Definition</i>
Award Data	AWARD_GRANT_ISSUE	VC publishes award data to Stock Administration and Stock Administration subscribes to the award data.
Grant Data	GRANT_AWARD_UPDATE	Stock Administration publishes grant data to VC and VC subscribes to the grant data.

In PeopleTools Application Designer you must activate the AWARD_GRANT_ISSUE and GRANT_AWARD_UPDATE messages. Make sure that you set the status of each selected message to *Active*, and set the status of the corresponding queue to *Run*.

Third-Party Stock Administration Subscription to Integration Point Messages

Through the use of web server extension mechanisms such as Java servlets, a third-party application can accept and process an XML post from a PeopleSoft message. Third-party applications can publish data to the PeopleSoft database by means of an XML data post directly to PeopleSoft's Integration Broker Gateway.

Allocating Stock to the Variable Comp Stock Fund

To allocate stock to the variable compensation stock fund, use the Variable Comp Allocation (ST_VC_ALLOC) component.

This topic describes how to allocate stock units from your stock option plans to the variable compensation stock fund.

You can also allocate stock units for future fund allocations. Stock balances are adjusted when grants are generated, not when the stock units are allocated.

Running the Stock - VC Plan Expire Process

When the Variable Comp plans or funding periods expire, return the shares back to the stock plan. Schedule the Stock -VC Plan Expire Application Engine process (ST_VC_EXPIRE) to run periodically. The process checks the expiration of the Variable Comp plans. If any plans are expired, the system inserts a row into the Variable Comp Funding page to decrease the balance to zero.

Chapter 9

Administering Grants

Understanding Grant Administration

This section provides an overview of grant administration and lists prerequisites and common elements.

Once you establish your stock option plans and allocate funds to them, you're ready to grant stock options to your optionees.

You can grant stock options to your participants in three ways:

- Process grants awarded through your variable compensation plan.
- Award grants from an individual stock option plan through an online transaction.
- Replace an existing grant with a new grant during a reprice.

By using variable compensation, much of the process is automated. But you can still make adjustments and grant individual grants as necessary.

Prerequisites

Before you begin granting stock options, you should:

- Create the vesting schedules.
- Set up your stock option plans.
- Create your grant reasons.
- Set up agreements.
- Set up the default tax tables.
- Add insider data.
- Add issuance instructions.
- Enter daily prices.
- Allocate shares to the stock option plan and variable compensation plan.
- Receive variable compensation awards.

Common Elements Used to Administer Grants

Field or Control	Description
Agreement ID	Select a grant agreement to use for this grant. If you selected a Parameter ID its agreement ID is the default. You can select another from the available options.
Employee Information	This group box displays employee information as of the grant date.
Exercise Before Vest	If the option plan allows exercise before vesting, you can select this check box. If the option type is RSA this check box is selected.
Expire Basis	Displays the value that is associated with the option parameter ID. You can select <i>Grant Date</i> , <i>Grant Date - 1</i> , <i>Vest Date</i> , or <i>Vest Date - 1</i> to indicate the date used to calculate the start of the option life months.
Grant Date	Defaults to the payout period's end date associated with the payout period ID or the VC plan ID. You can change it, but the date must be between the payout period's begin date and the end date.
Grant FMV	Displays the Grant FMV calculated based on the Daily Prices table and defined using the Stock Option Plan Rules - FMV Rules page.
Grant Number	Displays <i>NEW</i> when you enter a grant. When you save, the system generates a sequential grant number from the last grant number stored on the Stock table.
Grant Price	<p>The system default is the Grant FMV (fair market value) calculated based on the Daily Prices table and defined in the Stock Option Plan Rules - FMV Rules page. You can change this amount.</p> <p>If the option type is <i>ISO</i>, the grant price cannot be less than the FMV on the grant date.</p> <p>If the optionee is a 10% shareholder, the grant price of an <i>ISO/ISAR</i> grant has to be at least the Grant FMV multiplied by the 10% shareholder FMV rule on the governing body rules table.</p>

Shares Granted	Number of shares to grant to an individual.

Status Date	Displays the date that the status was last changed and saved.
Grant Date	Enter the grant date. You get a warning if the individual is not active as of this date.

Shares Granted	Displays the total shares of the two grants if the ISO limit is reached and two grants, one ISO and one NQ, are created.
Option Parameter ID	Option parameter IDs are defined on the Stock Option Plan Rules - Option Parameters page. 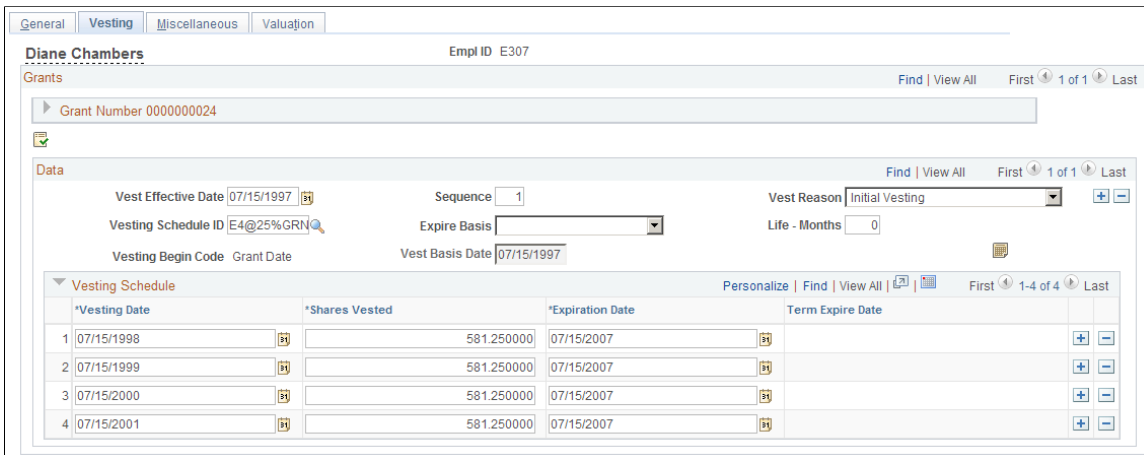

To create a vesting schedule and validate ISO limits:

2. Complete other fields applicable to the vesting schedule.
3. For ISO options, click the **Validate ISO** button to determine if the value of the shares first exercisable exceeds the 100K limit.

Field or Control	Description
Vest Effective Date	When you enter a new grant, the system default is the grant date. When you later make an adjustment, enter a new vest effective date.
Sequence	Displays a sequence number if you make a change to the vesting schedule.
Vest Reason	When you enter a new grant, the system default is the vesting reason <i>Initial Vesting</i> . To change the vesting schedule after the grant is saved, enter a new set of rows and select a different Vest Reason. Values are <i>Initial Vesting</i> , <i>Correction</i> , <i>Merger/Acquisition</i> , <i>Performance Vesting</i> , <i>Reprice</i> , <i>Return from Leave</i> , and <i>Termination</i> .

Vesting Schedule

The vesting schedule associated with the stock option plan is the default.

Create Vesting Schedule	If you entered a vesting schedule ID, you can click this button to create the vesting schedule.

Field or Control	Description
Vesting Date	Displays the vesting date for each period. You can change the date, however, the date cannot exceed the life of the option or be before the date of the grant or after the expiration date.
Shares Vested	Displays the number of shares that vest in each period. You can change the number of shares, but the total of all the shares must equal the total shares granted.
Expiration Date	Calculated from the Expire Basis and Life Months fields. You can change the date, however, if the option type is <i>ISO</i> , the date cannot exceed the option life limit set up on the Governing Body Rules - Stock Option Rules page.
Term Expire Date	Available when the option is cancelled due to termination. Enter the grant expiration date.

A grant can be cancelled automatically as a result of a reprice or the processing of a termination stock action. You can manually enter information for rescinded grants as well as repricings and terminations.

Cancel Reason	Select a reason for the cancellation. Values are <i>Reprice</i> , <i>Rescind</i> , and <i>Terminated</i> . If you select <i>Rescind</i> , the Agreement Status field must be <i>Rescind</i> also.
Shares Cancelled	Displays the number of shares cancelled.

Reprice

If this grant is the result of a stock reprice, the fields in this group box are populated. You can also enter the information manually if the grant was repriced manually. If you enter information, be sure that both the grant that is repriced and the new grant are updated correctly as would have been done by the Reprice process.

Field or Control	Description
Reprice Grant Number	The system enters the number of the grant that was repriced and replaced by this grant.

HR Integration

If the grant is changed because of a stock action, the HR Integration fields are populated. You can change the default values. If you enter the information manually ensure that the correct fields are modified and the correct validation is performed as would have been done by the Stock Action process.

<i>Field or Control</i>	<i>Description</i>
ISO as NQ Date	Applies if the stock action is termination and the grant is ISO.

Understanding Grant Modifications

The types of adjustments that you can make to grants depend on the source of the grant, the option type, and the transactions that have occurred since the grant date. Use the Maintain Mass Grants component to modify a group of grants using the Modify Grants (ST_MOD_GRANT) Application Engine process. (Use the Grants component to modify an individual grant.)

Pending grants are counted toward the ISO limit if the pending grant is the grant being generated. During the Modify Grants process, or an online process of changing the grant status from Pending to Active, the ISO validation occurs again, which may change the ISO/NQ split if an employee has more than one ISO grant in Pending status.

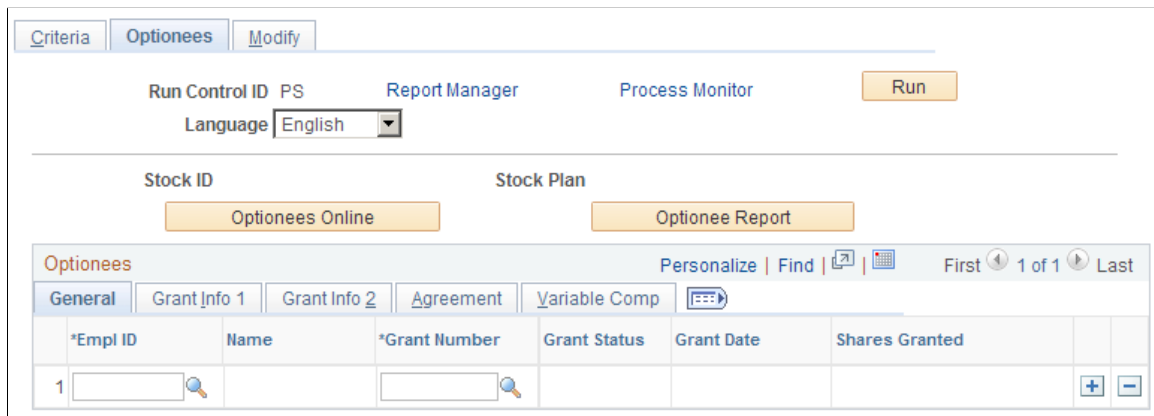

Agreement Tab

This tab displays the agreement ID, agreement status and date for the grant.

Variable Comp Tab

This tab displays the variable compensation plan ID, period ID, group ID, and employee record number for the grant.

Maintain Mass Grants - Modify page

Chapter 10

Administering Exercises

Understanding Administering Exercises

This section lists prerequisites and common elements and provides an overview of administering exercises.

Prerequisites

Before you begin administering exercise transactions, you should:

- Set up the various stock tax types and default tax rates.
- Grant options to the optionees.
- Establish issuance instructions for your optionees.
- Make sure that the grants are active and not pending.
- Make sure that daily prices are current.

Common Elements Used to Administer Exercises

<i>Field or Control</i>	<i>Description</i>
83b Election	This field is only available for a restricted exercise. Use if the optionee files an IRC 83(b) tax election.
Employee Information	This group box displays employee information as of the exercise date.
Exercise Before Vest	Selected if exercising before vesting is allowed for the option.
Exercise Number	The system displays <i>NEW</i> when you enter an exercise. When you save, the system generates a sequential exercise number from the last exercise number stored on the Stock table.
ID	Click to access the Employee Information page to view employee information.
Restricted Exercise	Selected if the exercised shares are unvested.

Exercise Administration

Optionees may exercise stock options on or after the vesting date; prior to the vesting date if exercise before vesting is allowed; or at any time during the life of the stock option, depending on the terms of your stock option plan.

When an optionee exercises a grant, you record the number of shares exercised, the funds and any applicable taxes due from the optionee, and issue the shares.

Depending on the type of option being exercised and the exercise method selected, you can issue the shares in a stock certificate, electronically deposit them with a stock broker, or hold the shares in escrow until the optionee meets restrictions, such as vesting.

Viewing Exercise Information

This topic lists the pages that you use to view exercise transactions.

Field or Control	Description

Exercise Information

Field or Control	Description
Exercise Status	Select the exercise status. Valid values are <i>Pending</i> , <i>Void</i> , and <i>Active</i> , which is the default.
Status Date	Displays the date that the status was last changed and saved.
Exercise Date	Enter the exercise date.

Field or Control	Description
Replace Exercise Number	If this is a replacement exercise, select a replacement exercise number from the available choices. You must first void the original exercise before you can create a new, replacement exercise. You associate the two exercises with the Replace Exercise Number for audit purposes.
Shares Exercised	Enter the number of shares to be exercised. If exercise before vesting is allowed all vested shares must be exercised before unvested shares are exercised. The system will not allow shares exercised to include both vested and unvested amounts.

The system populates these fields when you click any of the **Load Default Taxes**, **Copy Previous Taxes**, or **Calculate Taxes** buttons. You can change the values until you send the transaction to payroll.

Field or Control	Description
Tax Type	Select the type of tax to calculate.
Default Percentage	The system enters the default tax percentage based on the tax type. You can change the default percentage to modify the current tax amount.
Tax YTD	Enter the year to date tax amounts to have the system to use these values when calculating taxes with limits.
Current Tax	The system calculates the current tax based on the ordinary income amount displayed on the page and the default percentage. You can change the current tax amount and the default percentage changes accordingly.
Tax Override	If you override the default taxes or inserted the tax amounts the system displays <i>Manual</i> . The default is <i>None</i> , which means no tax override.
Maximum Tax	Displays the maximum tax limit if the tax type has a maximum tax limit.

Default Tax Calculation

You can load the default tax information or copy the tax information from the previous exercise. Use these methods if you don't use Payroll for North America or for exception processing.

Field or Control	Description
Load Default Taxes	Click to load the default tax rates based upon the country and state associated with the optionee's tax location and the tax rates that you entered on the tax setup pages. The taxes are calculated based upon the ordinary income from the exercise.

Field or Control	Description
Copy Previous Taxes	Click to copy the tax percentages used in the last exercise within the last calendar year. If there are no exercises for the current year, the system copies the percentages from the previous year and gives a warning message.

North American Payroll

If you use Payroll for North America, you can calculate the taxes owed and send them directly to payroll.

Field or Control	Description
Calculate Taxes	Click to have Payroll for North America calculate the taxes due on the ordinary income from the exercise. The system determines the YTD taxes paid and monitors any limit that might be met.
Update Payroll	Click to send the tax and ordinary income data to payroll. Once the transaction is saved, you receive confirmation that the transaction was sent. If you don't save the exercise, Payroll is not updated.
Sent to Payroll Date	Displays the date the payroll taxes were sent to payroll either through Update Payroll or when the payroll report is run. Click the date to access the Exercise Payroll Data page to display how the transaction was sent to the payee (through Payroll for North America or a manual report) and the paycheck number, if applicable.
Reversal Date	Displays the date, if any, that the Payroll Reversal Report was run.

Calculated Values

Field or Control	Description
Tax Preference Income	Displays the alternative minimum tax value, if any, when the option type is ISO. Otherwise, it is ordinary income, which is the difference between the option price and the fair market value of the company's stock on the exercise date.
Total Taxes	Displays the sum of all taxes displayed. These are the taxes that are due on exercise.

Field or Control	Description
Net Due Optionee	If this is a SAR exercise, the system displays the net due to the optionee. This amount is the difference between the ordinary income and the total taxes.

Reversing Taxes Sent to Payroll

To reverse taxes that you've already sent to payroll, change the Exercise Status to *Void* on the Exercises - General page and save. If the transaction has not been processed by payroll the system deletes the transaction.

If the transaction has already been processed by payroll you receive a message that the transaction wasn't found. You can print the Options Income/Taxes Reversals report to notify your payroll administrator that the transaction should be reversed.

If a payment method is Swap for Shares or Trade for Taxes, these fields become available.

Understanding Actual Tax Benefits and Deferred Tax Assets

Since the adoption of FAS 123R in December, 2004, when an option is exercised, the actual tax benefit realized at the time of exercise (typically the spread or gain realized by the participant at exercise) must be compared to the deferred tax asset originally recorded for the option (typically the fair value of the option determined at grant).

If the actual tax benefit exceeds the deferred tax asset, the excess is treated as additional paid-in capital. If the tax deduction realized on exercise is less than the expense record for the option, the shortfall reduces paid-in-capital. By comparing the values of the actual tax benefit and deferred tax benefit, you can determine whether your company has a reserve of paid-in-capital or a shortfall. A shortfall of paid-in-capital is deducted from reserve paid-in-capital. If no reserve of paid-in-capital exists then you must report the shortfall as additional tax expense.

Chapter 11

Administering Releases

Understanding the Release of Restricted Shares

This section lists prerequisites and common elements and provides an overview release administration.

Prerequisites

Before you begin releasing restricted shares:

- Grant options or awards that allow exercise before vesting, such as restricted stock awards.
- Exercise unvested shares.

Common Elements Used to Administer Releases

Field or Control	Description
83b Election	Selected if the optionee filed an IRC 83(b) tax election.
Employee Information	This group box displays employee information as of the release date.
EmpIID	Click to access the Employee Information page to view employee information.
Release Number	Displays <i>NEW</i> when you enter a release. When you save, the system generates a sequential release number from the last release number stored in the Stock Table.

Release Administration

Stock options that are exercised before they are vested are commonly called restricted shares and are typically held in escrow until they vest. As the shares vest, they are released to the optionee. You must record the number of shares released and the taxes due from the optionee, release the shares from escrow, and deliver them according to the optionee's instructions. Ordinary income and taxes are generally calculated and collected at the time of release unless the optionee filed an 83(b) election at the time of exercise.

If your stock plans include restricted stock awards, or the plans allow exercise before vesting, you periodically release restricted shares.

The process of releasing restricted shares is similar to that of exercising options. You identify the releasable shares, the release method, and the issuance instructions. Depending on the optionee's 83(b) election, you calculate ordinary income and collect taxes.

Viewing Release Information

Reversing Taxes Sent to Payroll

To reverse taxes that you've already sent to payroll, change the release status to *Void* on the Releases - General page, and save. If payroll hasn't processed the transaction, the system deletes the transaction.

If payroll has already processed the transaction, you receive a message that the transaction wasn't found. Print the Option Income/Tax Reversals report to notify your payroll administrator that the transaction should be reversed.

Understanding Stock Option Dispositions

Prerequisites

Before you begin recording stock option dispositions:

- Process optionee exercises and releases.
- Receive information about dispositions from optionees, transfer agents, or brokers.

Common Elements Used to Administer Stock Option Dispositions

<i>Field or Control</i>	<i>Description</i>
EmplID	Click the EmplID number to access the Employee Information page, where you can view employee information.
Shares Self Service	Displays the number of shares that are reported as disposed through the self-service page and that have a status of self-service.
Shares Disposed	Displays the number of disposed shares that have a status of confirmed.
Shares Available	Displays the number of shares available. This equals <i>(Shares Issued) – (Share Pending) – (Shares Self Service) – (Shares Disposed)</i> .
Disposition Number	Displays <i>NEW</i> when you enter a disposition. When you save, the system generates a sequential disposition number from the last disposition number stored in the Stock table.

Field or Control	Description
Status	<p>The default for a new record is <i>Pending</i>, unless the shares were already sold through a same day sale or a sell to cover transaction. Then, the status is <i>Confirmed</i>. Status Date	Displays the date on which the status was last changed and saved.

Sent to Payroll Source	Displays the way in which the income and taxes were sent to a payroll, either through Payroll for North America or a manual report.
Paycheck Number	Displays the paycheck number when the transaction was processed through Payroll for North America. This field is blank if a manual report was used.

Stock Option Dispositions

After shares are exercised or released, optionees can sell or transfer shares. Depending upon the option type and the holding period requirements, your company might be entitled to a tax deduction equal to the optionee's ordinary income on a disposition.

You can record and track dispositions, determine if they are disqualified, and, if you use Payroll for North America, send the ordinary income calculated on disqualifying dispositions directly to payroll for processing.

When you enter a disposition for an ISO or an ISO/SAR, the system checks the 422 plan rules defined on the Governing Body Rules - Stock Option Rules page to determine if the required holding period is met for preferential tax treatment. If the disposition does not meet the holding period requirements, the system calculates the ordinary income for the shares disposed. If the ordinary income is reported on a Form W-2, a company can take it as a tax deduction. If the disposition date meets the holding period requirements, the system does not calculate ordinary income.

Ordinary income calculated on a disqualifying disposition is based on the income method rule that is specified on the Stock Option Plan Rules - Payment/Income Methods page for ISO sales. This rule determines the price that is used to calculate the ordinary income on the disposition. The value also depends on whether the transaction is an exercise or a release, and if the optionee filed an 83b election.

Disqualifying dispositions are calculated for ISOs and ISO/SARs in these ways:

Exercise of Vested Shares

Holding Period: Calculated from the exercise date.

Ordinary Income Calculation:

$[(\text{Sale Price or Exercise FMV or lesser of the two}) \times \text{Shares Disposed}] - (\text{Grant Price} \times \text{Shares Disposed})$

Release with No 83b Election Filed

Holding Period: Calculated from the exercise date.

Ordinary Income Calculation:

$[(\text{Sale Price or Release FMV or lesser of the two}) \times \text{Shares Disposed}] - (\text{Grant Price} \times \text{Shares Disposed})$

Release with 83b Election Filed

Holding Period: Calculated from the exercise date.

Ordinary Income Calculation:

$[(\text{Sale Price or Exercise FMV or lesser of the two}) \times \text{Shares Disposed}] - (\text{Grant Price} \times \text{Shares Disposed})$

Disposition Processing

You might want to survey the transfer agents, brokerages, and the optionees to determine if a transaction represents a true disposition or a transfer from one brokerage account to another. You can enter all information received from transfer agents or brokers concerning potential dispositions into the system with a pending status.

When the individual, transfer agent, or broker confirms a disposition, change the status to confirmed. If the disposition is disqualified, you can send the ordinary income to payroll to include it on the individual's W-2.

If you use Payroll for North America, you can automatically send the income information to payroll for processing. If you do not use Payroll for North America, or the optionee is not paid through this payroll system, run the Disqualifying Disposition Payroll report and send it to your payroll administrator for processing. Stock Administration displays the date on which you transmitted the data or ran the report.

Disposition Adjustments and Cancellations

If you must adjust or cancel a disposition after you've sent the ordinary income to payroll, change the status of the transaction to void and add a new disposition to the record. If the disposition was created by a same day sale or sell to cover transaction, make the change using the Exercises or Releases components, as appropriate. If you use Payroll for North America and the transaction has not been processed by Payroll for North America, the system deletes the transaction from the table. You receive a message that the transaction was successfully deleted. If Payroll for North America processed the transaction or you ran the manual payroll report, run the Disqualifying Disposition Reversal report and give it to your payroll administrator.

Administering Repurchases

Understanding Administering Repurchases

This section lists prerequisites and common elements and provides an overview of repurchase administration.

Prerequisites

Before you begin a stock repurchase, you must have:

- Granted options to an optionee.
- Exercised unvested shares that have not been released.

Common Elements Used to Administer Repurchases

<i>Field or Control</i>	<i>Description</i>
EmplID	Click the EmplID number to access the Employee Information page, where you can view employee information.

Repurchase Administration

If your stock option plans allow the reacquisition of shares from restricted exercises, you can accurately record the repurchase transactions and send the transaction information to optionees, escrow agents, and transfer agents. Typically, repurchases occur due to a termination before vesting.

How you handle share repurchases depends on the stock option plan rules that you set up using the Stock Option Plan Rules component. Typically, you repurchase unvested shares, such as those that remain in escrow when an optionee terminates, but you can also repurchase vested shares. You can return the repurchased shares to the stock plan from where they were granted or retire the shares to the treasury.

Use the repurchase administration pages to record repurchase information, such as the repurchase date, the numbers of shares repurchased, and the repurchase price. Use this information to generate reports, statements, and transmittals. To repurchase the shares at different prices, you enter a separate repurchase transaction for each price.

Finally, you can generate the following necessary statements and transmittals:

- Repurchase Receipt: Given to the optionee stating that the company has repurchased the shares.

- **Agent Issuance Instructions:** Sent to the transfer and escrow agents so that they can process the stock transaction and record the cancellation of the shares.

Chapter 14

Processing Stock Actions

Understanding Stock Actions

This section lists prerequisites and common elements and provides an overview of stock action processing.

Prerequisites

Before you begin processing stock actions:

- Set up the Stock Action Table using the Stock Action Table page.
- Define the correlation between HR action and action reason combinations using the Stock Action Reason Table page.
- Define the rules by which existing grants and vesting schedules are modified using the Stock Action Rules page.

Common Elements Used to Administer Stock Actions

<i>Field or Control</i>	<i>Description</i>
EmplID	Click the EmplID number to access the Employee Information page, where you can view employee information.
Process	Click to process the stock action.
Check Messages	Click to access the Stock Action Message page, where you view the results of the stock action.

Stock Action Processing

When your optionees' human resources status changes, their stock plan participation is often affected. Using the stock action rules you've defined, you automatically receive notification from HR about relevant changes, such as a termination or return from leave of absence.

The Stock Action Table defines all unique stock actions that integrate with HR. The effective-dated table describes each stock action and type. The Stock Action Reason Table defines the correlation between HR action and action reason combinations and a stock action. The Stock Action Rules Table defines the rules that modify existing grants and vesting schedules for terminations, leaves of absence, or returns from leave stock action.

You receive a workflow from HR when:

- The individual is labeled Employee, Non Employee - Stock, Non Employee - Non administered HR employee.
- The action and action reason of a new action or a correction corresponds to a stock action in the Stock Action Reason table.
- The individual has at least one active or pending grant.
- The change is to the HR JOB.

After you receive the worklist notification, review the worklist to determine what must be done. You might want to check with HR to make sure the job change is still valid before you process the stock action. The system automatically changes existing grants and vesting schedules based on the rules defined in the stock action rules table. After you've processed the stock action, the worklist for the individual is marked Worked and is no longer available. If you must make adjustments, use the manual entry page. You can reverse the processing or adjust the grant information.

Understanding the Stock Action Process

Administering the stock action workflow consists of reviewing and processing the stock actions you've received from the worklist. You can reverse or adjust previously processed stock actions or enter actions manually.

Processing Stock Actions

The type of stock action and the rules defined for that stock action control how option grants are modified. The system checks to see if the stock action has not already been processed, then it processes the stock action according to the rules that you defined.

For a Termination stock action, the following occurs:

1. Adjust the vesting schedule.

If the grant allows immediate vesting upon termination, a new vesting schedule is produced with all unvested shares vested as of the employee's last active day. If the grant is an ISO (incentive stock option), run the ISO Limit report for the optionee. If the termination occurs while the optionee is on leave, the system checks to see if the vesting period should be deferred.

2. Cancel the unvested shares.
3. Set the stock option expiration date for the termination.
4. For ISO options, set the ISO exercise as NQ date.

For a Leave of Absence stock action, the following occurs:

1. Verify that the previous stock action was not a leave of absence.

If the previous stock action was a leave of absence, the system cannot process another leave of absence stock action until the individual returns from the leave. You receive a message that it could not process this stock action.

2. Suspend vesting, if the plan rules indicate to do so.
3. Suspend the exercise, if the plan rules indicate to do so.
4. Stage the grant so that vesting is deferred, if required, when the optionee returns from leave or terminates.

For a Return from Leave stock action, the following occurs:

1. Verify that the previous stock action was a leave of absence.

If the previous stock action was not a leave of absence, the system cannot process a return from leave of absence stock action. You receive a message that it could not process this stock action.

2. Adjust the vesting schedule.

If the return from leave occurs after the deferral grace period, calculate the amount of time the employee was on leave by the difference between the leave of absence stock action date and the return from leave stock action dates. The vesting schedule is deferred for the amount of time that the optionee was past the grace period. If the grant is an ISO, run the ISO Limit report for the optionee.

Processing Reversals

Sometimes you must reverse a stock action process. The system confirms that the stock action and stock action dates on the processed grant match those of the reversal. If you reverse a Return from Leave or a Termination that occurred while on leave, you are essentially reversing the Leave of Absence as well.

Note: Before you run the Stock Action process, set up your Stock Action process table and rules and grant options to optionees.

Process Stock Action-Work List Page

Use the Process Stock Action-Work List page (ST_ACTN_PRC_WL) to process stock actions received from the worklist.

Navigation:

- **Stock > Grant Transactions > Process Stock Action-Work List**
- **You can access this page directly from a worklist created by workflow notification.**

Select either an option type or grant number to process, but not both. If you leave both unselected, the system processes all grants related to the stock ID.

Chapter 15

Administering Reprice

Understanding Reprice Administration

This section lists prerequisites and provides an overview of repricing and the repricing procedure.

Prerequisites

Before you begin to reprice stock or run the Reprice Grants process, back up all of your data.

Repricing Overview

If the value of a company's stock declines such that the current fair market value of the stock is less than the option price of outstanding stock options, the option is considered to be *underwater*. The company may decide to *reprice* some or all of the options. Optionee's can choose not to participate in the repricing, and you might want to exclude individuals and groups, such as insiders or foreign offices.

When a stock is repriced, optionees surrender their higher-priced stock options in exchange for lower-priced options. Repricing affects stock options with option prices that exceed a specified break price. A repricing cancels the shares that remain outstanding on the original grant and creates a new grant for the outstanding shares at a new, lower option price on a specific date. The new stock option, granted as a result of the repricing, usually retains many of the characteristics of the old stock option.

The number of shares in the new stock option grant is equal to the number of outstanding shares in the old stock option grant as of the cancel date of the option. All transactions that occurred before the repricing remain with the repriced option.

Repricing Procedure

When a stock is repriced, optionees surrender their higher-priced stock options in exchange for lower-priced options.

To reprice your stock:

1. Set up the reprice parameters including stock ID, eligibility, and vesting, through the Stock Reprice component.
2. Run the Reprice Eligibility process to determine who can participate in the reprice using the Reprice Eligibility Process page.
3. Print Reprice Election forms and send to plan participants for their acceptance (optional).
4. Enter individuals' elections to participate in the stock repricing using the Reprice Participation page.
5. Run the Reprice Grants process using the Reprice Grants Process page.

6. If necessary, run the Reverse Reprice process using the Reverse Reprice Grants Process page.

Note: Check the Reprice Messages page after you run any of the reprice processes.

Understanding Stock Purchase Plans

The Stock Purchase Business Process

Stock Administration enables you to create and manage your company's employee stock purchase plan in compliance with several IRS and SEC rules. These rules include the Section 423 annual maximum purchase amount, share discount amount, purchase holding periods, and offering holding periods.

Employee stock purchase plans allow eligible employees to purchase company stock, often at a discounted price. Employees enroll in a company's plan during certain periods or intervals, authorizing the company to place payroll deductions in a trust to purchase company stock. If the collected funds are in a foreign currency, they must be converted into the stock currency for purchase. Most stock purchase plans are qualified IRC 423 stock purchase plans in which employees participate, including those who are not administered by HR.

The stock purchase price is determined based on your plan rules. At predetermined periods, the stock is purchased for participating employees. The value of the stock and the amount of funds collected determine the amount of stock purchased, and employees can sell or transfer these shares. When employees sell shares, any ordinary income is sent to payroll.

Section 423 (IRC) Plans

The majority of stock purchase plans in the United States are qualified IRC 423 Plans. In general, the participants do not recognize ordinary income when they purchase stock, but they do at the time of sale. The following IRS Section 423 eligibility rules are supported in the Governing Body Rules Table:

- Only employees of the company are eligible to participate in Section 423 plans. This includes employees who are not administered by HR.
- Employees who are major shareholders (those who hold 5 percent or more of the company's stock) may not participate in the plan.
- The maximum purchase discount is no more than 15 percent.
- The maximum offering length is no more than 27 months.
- An employee may not purchase more than \$25,000 of stock in any calendar year (based on the value at participation). PeopleSoft supports the two most common interpretations of the IRC 423 maximum purchase value limit: 1) a \$25,000 limit applies to purchases within a calendar year, and 2) a \$25,000 limit applies to the years that the offering is outstanding. You select one of these purchase limit rules when you define the stock purchase plan rules.

Example: Calendar Year Interpretation of \$25K Rule

The system calculates the value of purchases made by a participant in a calendar year and applies the purchase limit to any amount over the \$25,000 by adjusting the value so that it is below the limit. For example:

Offering Period: 12 months

Begin: 01/01/1999

End: 12/31/1999

Purchase Periods: 6 months

Begin: 01/01/1999

End: 06/30/1999

Begin: 07/01/1999

End: 12/31/1999

<i>Date</i>	<i>Activity</i>	<i>Value</i>	<i>Adjusted Value</i>

The second purchase exceeds the \$25,000 limit, so the purchase is adjusted.

Example: Years Offering is Outstanding Interpretation of \$25K Rule

The Years Offering is Outstanding interpretation is more complex and allows the participant to accumulate the \$25,000 value per year that the offering is outstanding. This allows a participant to purchase stock up to a \$25,000 value for each year the offering remains outstanding. If the offering extends to more than one calendar year, the unused portion of the limit is added to the next year's limit. For example:

Offering Period: 24 months

The offering period is as follows:

Antidilution Issues

A stock purchase can potentially flood the market with newly issued shares if the purchase fair market value (FMV) is much lower than the grant FMV. To protect shareholders, the IRS limits the number of shares that an individual participant can purchase. In addition to the IRS limit, corporations can implement additional rules to further limit the number of shares that participants can purchase. One of the ways that a corporation can limit the potential diluting effect of its stock purchase plan is to implement an antidilution rule, which is used when the purchase FMV is much lower than the grant FMV. There are many ways to define an antidilution rule, but all are designed to determine a price to use in calculating the maximum number of shares to purchase.

Administering Enrollment

Understanding Stock Purchase Plan Enrollment

This section provides an overview of stock purchase plan enrollment and lists prerequisites.

After you set up your stock purchase plans, the next step is to enroll your participants into the plans through the Base Benefits business process. Then, enroll your participants in offering and purchase periods using the Update Participants process. After you run the Update Participants process, you can view and adjust the enrollment records or manually add participants not administered in the Base Benefits business process.

Prerequisites

Before you enroll participants:

- Set up your stock purchase plans.
- Have the benefits administrator define the stock purchase benefit plan and deduction codes.
- Have the benefits administrator enroll stock purchase plan participants.
- If you use Payroll for North America, have the payroll administrator set up payroll for processing stock purchase contributions by setting up deductions.

Running the Update Participants Process

The Update Participants process (ESPP_PARTIC) enrolls participants into a stock offering and purchase period, and assigns a grant date. The system checks the benefit plan and participant enrollment rule defined on the Stock Purchase Plan Rules - General page to determine appropriate participants. If the enrollment rule is:

- *O* (next offering): The system finds the first offering which has not begun, with an offering begin date that is greater than or equal to the coverage begin date of the participant from the Savings Plan Table.

- *P* (next purchase period): The system finds the next purchase period which has not begun, regardless of the offering period, with a purchase begin date that is greater than or equal to the coverage begin date.
- *C* (enroll in current): The system finds the first available grant date that is greater than or equal to the coverage begin date.
- *User defined*: The system skips all processes. You must manually enter, import the participants, or modify this process.

For anyone who does not have a participation record, the system checks the employee's status at the time of processing. Participants who have terminated or elected to withdraw (waive) from the plan, are removed from the current enrollment.

To run the Update Participants process:

1. Set up stock purchase plan rules using the [Stock Purchase Plan Rules - General Page](#).
2. Have the benefits administrator enroll participants.
3. Set up the purchase ID using the [Stock Purchase - General Page](#) and the offering ID using the [Offering/Purchase Periods - Offering Period Page](#).

4. Run the Update Participants process using the [Process Stock Purchase Page](#).

Select the Update Participants check box.

5. View enrollment records and make manual adjustments using the [Review Purchase Participation Page](#).

Adjusting Enrollment Records

Administering Participant Contributions

Understanding Participant Contribution Administration

Prerequisites

Before you administer your employee contributions:

- Set up your stock purchase plans using the Stock Purchase Plan Rules - General page.
- Set up the offering ID using the Offering/Purchase Periods - Offering Period page.
- Set up the purchase ID using the Stock Purchase - General page.
- Run the Update Participants process using the Process Stock Purchase page.

The Gather Contributions Process

Participant contributions may come from different sources collected during the purchase period, manual adjustments, and contributions left over from a previous purchase.

The Gather Contributions process gathers all contributions for participants based on how you set up your stock purchase plan and the deductions taken during the purchase period. The system also checks how you set up your process groups within a purchase ID. The Gather Contributions process obtains contributions from three sources:

- Payroll for North America (USA and Canadian employees).
- Manual contributions (adjustments and non-USA or non-Canadian contributions).
- Residual contributions (unused contributions carried forward from previous stock purchase periods).

You can have contributions gathered from Payroll for North America, manually, or both. Residual contributions are always gathered in the process. Contributions outside of Payroll for North America must be manually entered for the process to gather the contributions.

The system stores the different types of contributions in the tables and changes the status as follows:

- Payroll for North America contributions are identified in payroll as *Gathered*, so as not to gather them again.
- Manual contributions are changed to *Processed* from *New*.
- Residual contributions are changed to *Processed Residual* from *New Residual*.

Payroll for North America

Payroll for North America groups employees by company and pay group for reporting, accounting, and other payroll objectives. It defines the company and pay group for each employee's job on the effective-dated job record. Company definition ranges from simple to fairly complex. Payroll for North America defines pay groups within companies and uses the division for payroll processing. You define the pay groups that typically fall into one or more of the following criteria:

- Frequency of pay.
- Currency in which they are paid.
- Country or location in which they are paid.
- Employee type (hourly, exception hourly, salaried, and so on).

In Payroll for North America, employees are paid according to a pay calendar, which defines the company, pay group, pay period begin and end dates, and check date.

If you gather contributions based on check date or pay period, it gathers only the appropriate contributions. If you selected Check Date, it gathers contributions on check dates that fall between the purchase period begin and end dates. If you selected Pay Period End Date, the process gathers contributions for pay period end dates that fall within the purchase period begin and end dates. Within the purchase ID setup, you can include or exclude specific pages or page ranges from the Gather Contributions process. Work with your payroll administrator to determine the best setup for your process.

Payroll for North America stores deduction data in the PAY_DEDUCTION Table by pay calendar and pay period. It contains all deductions for an employee by company, pay group, benefit plan, and benefit plan type. The unique combination of benefit plan type and benefit plan defined for each stock purchase plan controls the deduction gathering process.

Once a payroll is processed and the pay calendar is confirmed, the Gather Contributions process collects the payroll deduction data for employees. The Gather Contributions process collects deductions that match the benefit plan type and benefit plan defined for a participant. After it processes a deduction for a participant, it sets a flag (ESPP_PROCESS_FLAG) in the PAY_DEDUCTION Table. This flag prevents the Gather Contributions process from processing a deduction multiple times. Specify the parameters that control the Gather Contributions process for Payroll for North America in the Purchase Table.

Manual Contributions

Contributions not gathered by Payroll for North America are processed as manual contributions. Using the Manual Contributions page, you can adjust a participant's contribution or manually enter the contributions of employees who are not administered through Payroll for North America. Alternatively, if you don't use Payroll for North America, you can import all your contribution data through an import process.

Residual Contributions

Residual contributions are those left over from a purchase. The Gather Contributions process collects residual contributions with a residual type of *C* (carry forward) from the Residual Contributions Table (ST_CONTRIB_RSDL). After the residual contributions are processed, the contribution status is updated from *N* (new) to *P* (processed). The residual contribution's stock ID, stock plan type, stock plan, and process group must match those of the current offering for the residual contributions to be carried forward into the current offering.

Negative Contributions

The process doesn't gather negative contributions, other than reversals. These contributions are ignored and the system generates a warning message.

Steps for Running the Gather Contributions Process

To gather contributions:

1. Working with your payroll administrator, make sure the payroll is executed and the pay calendar is confirmed.

Payroll must be run to ensure the payroll check and deduction data is available for the Gather Contributions processing.

2. Enter manual contributions or view the results of a data import using the Create Manual Contributions page.
3. Run the Gather Contributions process using the Process Stock Purchase page.
Select the Gather Contributions check box.
4. If you want to hold a purchase for an individual, select a hold reason on the Review Contributions page.
5. View participant contributions and make manual adjustments using the Review Contributions page and the Review Residual Contributions page.

Generate the Contributions report to view contributions for audits and reconciliation.

Understanding Manual Processing of Contributions

If you don't use Payroll for North America, you must enter your contribution data manually or through an import process that you create. Manually entered contributions are gathered for use in a purchase during the Gather Contributions process.

If you import your contributions, you can use the Import Number and Import Date fields to reconcile the imported contributions and correct importing errors. Follow these guidelines when importing your data into the manual contributions table:

You can run the Calculate Prices process at any time, but you must run it before the Purchase Stock process. To correct errors in a confirmed run, you must run the Unconfirm Purchase process, make your corrections, then run the Confirm Purchase process again.

Running the Convert Currencies Process

This topic provides an overview of the currency conversion process and discusses how to convert currencies.

Understanding Currency Conversion

If your company administers its plan globally, some participants might make contributions in a currency other than the stock currency, USD. Before you run the Purchase Stock process, convert these contributions into the stock currency.

Stock Administration relies on several HR Management general option tables in the currency conversion process. Your system administrator defines these tables based on your company's business rules and enterprise-wide requirements. Work with your system administrator to understand the parameters defined for your company and to make sure that they are adequate for your stock purchase plans.

The exchange rate for each currency to the stock currency is the key component of the Convert Currencies process. You define the exchange rate used in the process on the Stock Purchase - Currency page. For each currency combination, the calculated market rate (based on the market rate index, rate type, and exchange date) and an actual exchange rate used in the process appears, providing an audit trail of the conversion process.

The Convert Currency process (ESPP_CONVERT) uses the currency conversion index and rate types that you set up for the plan. It finds all the currency codes loaded in your contribution table that must be converted. Based on the exchange currency set up at the trading exchange, the system multiplies the contribution amount by the multiplier factor set up in the currency exchange index. You see both the original contribution currency amount and the converted stock currency.

The Convert Currency process occurs in three stages.

Refresh Process

The refresh process compares, then refreshes, the existing rows of data for currency conversion to the most current data. It identifies all valid from and to currency combinations for the specified offering and purchase period end date. If it finds any new combinations, it inserts them into the currency table for the purchase definition. If there are any updates that change the data in the currency table, such as a rate change, the system updates the existing data to reflect the most current market rate data. Because you can override the actual exchange rate, this field is updated only if the previous market rate and previous actual exchange rate are identical. If the rates differ, you receive a warning message to review and verify the exchange rate data before running the Purchase Stock process.

You can run the refresh process by either of two methods:

- Click the Refresh button on the Stock Purchase - Currency page. This enables you to view the most up-to-date information for the Convert Currencies process. After you click the Refresh button, a batch process refreshes the data on the page.
- Select the Convert Currency check box on the Process Stock Purchase page. The refresh process runs each time the Convert Currencies process runs.

Conversion Process

This process runs each time the Convert Currencies process runs. The system calculates the stock contribution amount by multiplying the contribution amount by the rate multiplier and then dividing by the rate divisor for the market rate index, rate type, and exchange date specified.

Rounding of Converted Contributions

This process rounds the converted contributions to the number of decimal places specified for the currency code in the Currency Code Table.

Procedure for Converting Currencies

To convert currencies:

1. Run the Convert Contributions process.
Select the Convert Currency check box on the Process Stock Purchase page.
2. View participant contributions and make manual adjustments using the Review Contributions page and the Review Residual Contributions page.

Running the Calculate Prices Process

Understanding the Calculate Prices Process

You can run the Calculate Prices process (ESPP_PRICE) at any time; however you must run it before you run the Purchase Stock process.

The Calculate Prices process calculates the grant FMV, purchase FMV, purchase price before discount, and purchase price based on the rules defined for the plan. The process also performs various error checking, such as verifying that the trading days and holidays in the Stock Daily Price and Holiday Schedule tables are in sync and other setup features are logical before it proceeds.

Grant dates determine the beginning price for a participant's stock in an offering period and are defined on the Offering/Purchase Periods - Grant Dates page. The price rounding rules, and the number of decimals, are defined on the Stock Purchase Plan Rules - Purchase page.

The purchase period defines the length of time in which participants make contributions towards the stock purchase. The system maintains five types of prices for each grant date within a purchase period:

- Grant FMV: Fair market value of the stock on the grant date.
- Purchase FMV: Fair market value of the stock as of the purchase period end date.
- Calculated price before discount: System-calculated purchase price, before discount, based on the purchase price method defined at the stock purchase plan level.
- Calculated purchase price after discount: System-calculated purchase price based on the purchase price method and discount defined at the stock purchase plan level.
- Antidilution price: Applicable to antidilution purchases.

Steps for Running the Calculate Prices Process

To calculate prices:

1. Run the Calculate Prices process in one of the following ways:
 - Click the Calculate button on the Purchase Prices page. This enables you to view the most up-to-date information for the Calculate Prices process. After you click the Calculate button, a batch process recalculates the prices for all grant dates within the purchase period.
 - Select the Calculate Prices check box on the Process Stock Purchase page. This process runs each time the Calculate Prices process runs.
2. View purchase prices and make manual adjustments using the Purchase Prices page.

Note: If the plan's purchase price method is user defined (according to your selection on the Stock Purchase Plan Rules - Purchase page), you must enter prices manually before the purchase using the Calc Prices page.

Determine Purchase Price Page

Use the Determine Purchase Price page (ST_PURCHASE_PRC) to calculate the prices associated with a stock purchase.

You must first define the plan rules and enter daily prices for the purchase period. Enter prices if the plan's purchase price method is *User Defined*.

Understanding the Purchase Stock Process

The Purchase Stock process (ESPP_PURCHASE) is the final calculation in the stock purchase process. It calculates the number of shares that can be purchased by the participants identified in the Update Participants process for the contributions collected by the Gather Contributions process at the price identified by the Calculate Prices process for the grant date in the offering period. The purchase ID (defined in the Stock Purchases component) defines the purchase details.

The stock purchase plan defines the rules for the purchase of stock in the Stock Purchase process. The purchase period limits, offering period limits, purchase grant value limits, and residual contribution rules determine how many shares participants can purchase and the contributions that can be used towards the stock purchase.

The purchase process derives the number of shares that a participant can purchase based on the contributions gathered and the share, contribution, and value limits. If a participant will exceed a limit, the system adjusts the contribution to allow a purchase within the defined limit. Contributions over the limit are set to residual contributions and are processed according to plan definition.

The purchase remains pending until you confirm the purchase. You can rerun the purchase process repeatedly. Each time, the process recalculates and captures changes made by other processes, such as calculate prices or gather contributions.

Process Groups

The purchase process runs by process group in the order defined on the Stock Purchase - Process Groups page. You can process all groups, an individual group, or an individual participant. The processing order is important when a participant spans multiple process groups, for example, when a participant (employee) transfers from one organization to another, and has multiple sets of contributions. Although the system supports this structure, the best practice is to report the participant's contributions with the primary process group.

The processing order impacts a participant's limits. The first purchase that you process absorbs the majority of the limits. Because the purchase process enables you to run preliminary calculations for all groups and individual groups, there's a potential that the system might not calculate the limits properly unless you rerun all process groups that contain the same participant. In a subsequent processing, the system bases the calculations for a participant on the previous process group. If you recalculate the initial process group without recalculating other process groups that contain the same participant, the calculations might be incorrect if the participant reaches a defined limit.

The system generates a message for all participants who have contributions in multiple process groups. You can select those participants and process them separately by selecting the run method of Process by Participant.

Purchase Calculations

The Gather Contributions process identifies each participant's contributions that are available to the purchase process. The system performs several calculations for each participant to determine the number of shares that a participant may purchase.

By process group and stock plan for the purchase period:

Calculation	Method
Total contributions	Sum of all the participant contributions from ST_CONTRIB_PART for the process group and stock offering / purchase period and plan.
Shares purchased	Total contributions / (purchase price × proration %). For an antidilution purchase, this is total contributions / antidilution price.
Purchase value	Purchase price × shares purchased.
Residual contributions	Total contributions – purchase value.

Across all process groups and stock plans for the purchase period within the current purchase period:

Calculation	Method
Shares purchased	Sum of all shares purchased for the stock offering and plan which are outside of the current process group but within the stock offering / purchase period and plan.
Grant value	Shares purchased × grant FMV.

Across all process groups and stock plan for the purchase period outside the current purchase period but within the same offering period:

Calculation	Method
Shares purchased	Sum of all shares purchased for the stock offering and plan that are within the current stock offering and plan but outside the purchase period + shares purchased (purchase period) (see previous).

Calculation	Method
Grant value	Sum of (shares purchased for the stock offering and plan that are within the current stock offering and plan but outside the purchase period \times individual grant FMVs) + sum (shares purchased (purchase period) \times grant FMV).

Across all process groups for the same stock regardless of stock plan:

Calculation	Method
Grant value – calendar year	Sum (shares purchased for the stock \times grant FMV) when the purchase period end date is between 01/01 of the year of the purchase period end date and 12/31 of the year of the purchase period end date.
Grant value – years outstanding	Sum (shares purchased for the stock \times grant FMV) when the purchase period end date is between 01/01 of the year of the offering period begin date and 12/31 of the year of the offering period end date.

Order of Limits

Because you define multiple limits for a stock purchase plan, the order in which the system processes the limits is important. The order is:

1. Purchase period contribution limit.
2. Offering period contribution limit.
3. Purchase period participant share limit.
4. Purchase period grant value limit.
5. Offering period participant share limit.
6. Offering period grant value limit.
7. Purchase value limit (IRS section 423).

As a participant reaches these limits the system recalculates the following based on the limit:

1. Contributions available to purchase stock.
2. Shares purchased.
3. Grant value.
4. Purchase value.

5. Residual contributions.

Processing Results

The system holds all contributions gathered for participants that you've selected with a Hold Purchase flag. These contributions are carried forward or refunded, depending on the stock purchase plan setup rules.

After you calculate the final shares for a process group, you can view each participant's final shares using the Review Contributions page.

The participant issuance instructions determine whether the purchase process issues a certificate or makes a deposit to a brokerage firm. If no issuance instructions exist for a participant, the default option is to issue a certificate. If a certificate is issued, the mailing address established for the employee is used. If no mailing address is established, the home address is used.

Residual Contributions

Contributions left over from the purchase, called *residual contributions*, are refunded to the participant or carried forward to a future purchase. Contributions are typically leftover due to rounding, fractional shares, participant limits, or a Hold Purchase flag.

The stock purchase plan rules define the handling of residual contributions in the purchase process. The leftover residual contributions are converted back to the currency code of the process group. The exchange rate used is the reverse of the exchange rate used to convert from the source currency to the stock currency. The price is rounded according to the number of decimal places defined for the currency code. You can view a participant's residual contributions using the Review Residual Contributions page.

Steps for Running the Stock Purchase Process

To purchase stock:

1. Run the Purchase Stock process using the Purchase Stock page.
2. View purchase results using the Review Contributions page and the Review Residual Contributions page.

Process Stock Purchase Page

Use the Process Stock Purchase page (ST_RUNCTL_PURCH) to run the Purchase Stock process.

Specify the purchase ID definition to use and the processes to run.

Understanding the Confirm Purchase Process

You can do preliminary runs of all stock purchase processes until you run the Confirm Purchase process (ESPP_CONFIRM). When you confirm a purchase for a process group, the system confirms all calculations for the purchase, including any carry forward or refund, and marks as *Processed* the contribution status of all gathered contributions in a purchase ID. It also changes the preliminary system status to *Confirm*. You can no longer process the purchase period and you cannot make future adjustments.

If participants have residual amounts that are to be refunded through Payroll for North America, the system creates a payroll transaction for each refund.

Running the UnConfirm Purchase Process

Understanding the Unconfirm Purchase Process

To correct errors in a confirmed run, you can undo a confirmation by running the Unconfirm Purchase process, correct errors and confirm again. When you unconfirm a purchase for a process group, all confirmations for the purchase, including any carry forward or refunds, are undone.

If you undo a refund confirmation that's been sent to Payroll for North America, you must do additional processing. If Payroll for North America has not processed the transaction, it is removed from the Payroll

Transaction table (PSHUP_TXN). If the system has processed the transaction, the refund must manually be reversed. Process the reversal manually using the Payroll Reverse Refunds report. You cannot undo a purchase confirmation from which there is a disposition.

Refund Processing

There are many reasons why you might return your participants' contributions. For example, a participant is no longer enrolled in your stock purchase plan, but has made contributions; a carry forward amount from a previous purchase is too large; or your stock purchase plan rules require that you refund any funds remaining after the purchase of the shares.

You can refund contributions as long as you haven't run the Confirm Purchase process. The types of contributions you can refund are:

- Unprocessed manual contributions that haven't been gathered by the Gather Contributions process.
- Processed contributions that have been gathered by the Gather Contributions process, but have not been used to make a stock purchase.
- Unused contributions left over from a previous stock purchase.

Identifying Unprocessed Contributions that Can be Refunded

The first step is to identify a participant's unprocessed contributions available for refund.

Understanding Steps for Refunding Contributions

The Refund Contributions Application Engine process (ESPP_REFUND) refunds all the selected contributions, updates the refunded contributions status, and writes summary and detail records to the Stock Purchase Refunds Tables (ST_REFUND_ESPP and ST_REFUND_DTL). These tables provide a refund history in case you must reverse the refunds.

To refund contributions:

1. Refresh the contributions available for refund using the Select Refunds page.

2. Select the contributions to refund using the Select Refunds page.
3. Run the Refund Contributions process using the Process Refund page.
4. View refund results using the Review Refunds page.
5. If you must reverse the refund, run the Reverse Refund process using the Reverse Refunds page.

Occasionally, you must reverse a refund. For refunds processed through PeopleSoft Payroll for North America, the system stores transactions in a temporary payroll transaction file (PSHUP_TXN). When you reverse active refund transactions that haven't been processed by Payroll for North America, the system deletes them from the transaction file and populates the reversal date with the current run date.

Use the Reverse Refunds page to reverse an unprocessed refund. When you click the Reverse Refund button, the system removes the temporary payroll transaction from Payroll for North America with an AE process (ESPP_REF_REV).

Review Refunds Page

Use the Review Refunds page (ST_REFUND_ESPP) to view the results of the Refund process.

Administering Stock Purchase Dispositions

Understanding Stock Purchase Dispositions

This section lists prerequisites and provides an overview of dispositions.

Prerequisites

Before you begin processing participant dispositions:

- Establish disposition holding periods using the Governing Body Rules - Stock Purchase Rules page.
- Set up earnings codes using the Stock Details - Stock Purchases page.
- Confirm a stock purchase using the Confirm Stock Process page.

Dispositions Overview

A sale or transfer of stock purchased through a stock purchase plan, is called a *qualifying disposition* or *disqualifying disposition*, depending on the holding period requirements set up in the governing body rules.

For IRS governed plans, a disqualifying disposition is a sale or transfer of stock that has been held less than two years from the grant date and less than one year from the purchase date. A corporation is entitled to a tax deduction equal to the participant's ordinary income on the disqualifying disposition. To claim the tax deduction, a corporation must report the ordinary income on the participant's W-2 form. When the holding period is met, the sale is considered a qualifying disposition.

Because companies receive a tax break if the disqualifying disposition holding period is not met, participants are encouraged to report stock sales to their companies. If shares are held at a brokerage firm, a company might require that the brokerage firm report the dispositions. You must determine the best way to gather information about participant dispositions so that you can track the tax implications of the transactions.

Stock Administration determines if dispositions are qualified or disqualified according to your business rules. If you use PeopleSoft Payroll for North America, you can send the disposition information directly to payroll for reporting in the participant's earnings statement.

Tracking Dispositions

This topic provides an overview of tracking dispositions and discusses how to record track dispositions.

Understanding Tracking Dispositions

You record dispositions on the Stock Purchases - Dispositions page. Depending on the holding period rules you defined on the Governing Body Rules - Stock Purchase Rules page, the system determines whether the disposition is qualified or not.

If you use Payroll for North America and the participant's pay group is USA, you can send the disposition information directly to payroll. Otherwise you can send the Reconciliation report to your payroll administrator.

The country code must be USA to integrate with Payroll for North America. After the disposition is confirmed and you send the disposition to payroll, the system sends the transaction to the Payroll Transaction Table (PSHUP_TXN). When the payroll process executes, it associates the transaction with a particular pay run.

Stock Purchases - Dispositions Page

Use the Stock Purchases - Dispositions page (ST_ESPP_DISPOSN) to record a participant's stock sales.

You must first confirm a purchase.

Accounting for Stock-Based Compensation Plans

Understanding Accounting Features for Stock-Based Compensation

This section provides overviews of the system-supported standards for reporting equity-based compensation and the setup steps for complying with FAS 123.

Supported Accounting Standards

Under FAS 123, companies that offer equity-based compensation plans must report the fair value of plan-related compensation in their financial disclosure statements. Stock Administration provides the tools and reports that you need to comply with these requirements.

The system supports two standards for reporting the value of equity-based compensation:

- FAS 123, which specifies that companies must report the fair value of stock options and stock purchases as of their grant dates.
- APB 25, under which companies can report the intrinsic value of equity-based compensation.

Companies that comply with APB 25 must still make *pro forma* disclosures of net income and, if publicly traded, earnings-per-share, as though they had adopted FAS 123.

PeopleSoft Stock Administration uses the widely-accepted Black-Scholes option pricing model to calculate the fair value of stock options and stock purchases granted within the system. Black-Scholes uses six inputs in its valuation calculation. Four of these inputs are stored in the system or can be estimated by running reports that gather and calculate historical data.

Setup Steps for FAS 123 Compliance

To prepare Stock Administration to perform stock option and stock purchase valuations:

1. Select the accounting standard (FAS 123 or APB 25) by which your company discloses the equity compensation on its financial statements.
2. Select a valuation plan type (stock purchase plans only).
3. Create option groups (stock options only).

Selecting a Financial Accounting Standard

This topic lists the page where you select your company's accounting standard for reporting equity compensation on financial statements.

When you make the selection, also enter the disclosure date. If you select FAS 123, identify the year in which you adopted the standard.

Note: FAS 123 regulations state that if your company adheres to APB 25 and then adopts FAS 123, you cannot revert to APB 25 at a later time.

A valuation plan type determines how the share value is calculated for a stock purchase plan offering. Each stock purchase plan can be associated with one valuation plan type. Valuation plan types range from Plan Type A to Plan Type I, and their definitions can be found in FASB statement 123.

Understanding Option Group Setup

An option group is a group of active grants that are to be valued similarly, for example, grants with the same expected life or grants issued to members who have like exercise patterns, such as executives.

You create option groups by defining the set of criteria the system uses to select the grants to be valued. You can base your selection criteria on data contained in the following records: PERSON, PERS_DATA_EFFDT, PER_ORG_ASGN, JOB, ST_INSIDER_TBL, ST_GRANT, ST_GRANT_VEST, ST_GRANT_EXER.

Because some of these records contain sensitive data, such as compensation rates and birth dates, you can prevent users within specific permission lists from including certain records and fields in their selection criteria.

To define option groups:

1. Define security for option groups.

Identify the records and fields that are available to users when creating and viewing option groups. This step is typically performed during system implementation.

2. Define the selection criteria for including options in the same group for valuation purposes.
3. Save the selection criteria.

Note: Once you create a group ID, you cannot delete it online.

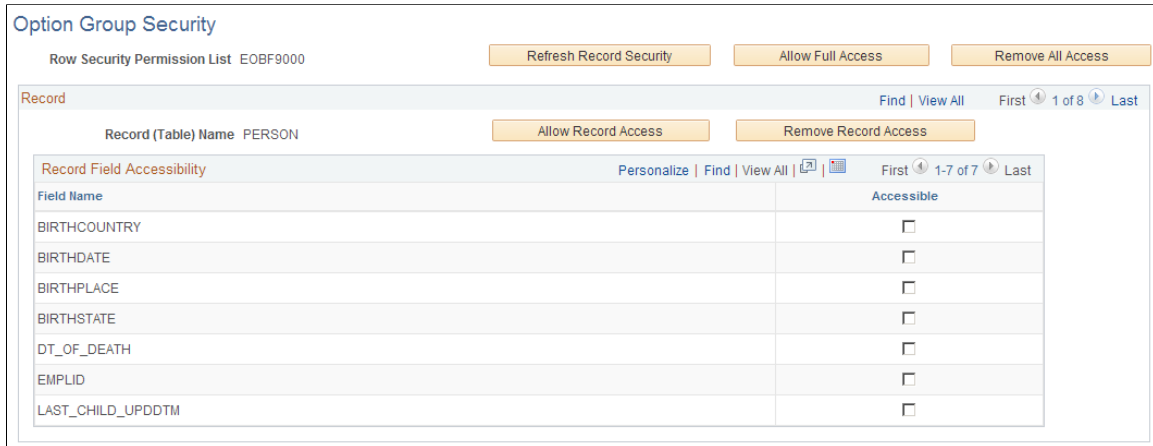

Prompts with Dependencies

In some cases, the Group Criteria Value field on the Selection Criteria page does not provide a list of valid values to choose from. This is because the field name you selected, by itself, does not give the system enough information to retrieve the appropriate set of values. That is, the values for the selected field are dependent on the values for one or more other fields.

The following table lists the fields whose values are dependent on other fields. While you can type a value for any of these fields in the Group Criteria Value field, the system may not return the results you expect, if the value you enter is not unique.

Understanding Retirement Eligibility

When you account for stock options, the valuation expense is distributed over the service period or vesting period of the option. However, if the optionee is eligible for retirement and the plan specifies that the options vest immediately upon retirement, then the service period ends as of the retirement eligibility date, and the remaining expense is due at that time. In this case, the total valuation expense is spread over the time from the grant date through the date of retirement eligibility.

The Stock – Retirement Eligibility (ST_RET_ELIG) Application Engine process determines which grants have met the retirement eligibility criteria or forecast eligibility criteria that you defined for the stock plan. The process evaluates each active grant in the system beginning on the grant date or the agreement

date (depending on how you set up the stock option plan). Grants continue to be evaluated until the option either completely vests or expires.

For each grant being evaluated, the system compares the optionee's age and length of service with the retirement eligibility requirements and forecast eligibility requirements. When an optionee meets the eligibility criteria, the process updates the Retirement Eligible check box, the Retire Eligible Dt field, and the Forecast Retirement Eligible check box on the Maintain Grants - General page. Optionees are eligible for retirement when they meet either the normal retirement or early retirement conditions.

Note: You should process retirement eligibility daily. When an optionee becomes eligible for retirement, the Stock Option Valuation Expense Report (STFS007) processing changes. Even though the optionee has not actually retired, the expense is still accelerated and expense realized from the date of grant to the date of eligibility.

Vesting schedules are not modified when optionees become eligible for retirement; vesting modifications occur only when the optionee actually retires, and is part of the integration with PeopleSoft HR.

Understanding Data Required for the Valuation Process

The Valuation process, which uses the Black-Scholes Option Pricing model, requires six variables. Two of the variables are already stored in the system, two you can derive from system-generated reports, and the remaining two you acquire from outside sources. The variables and their sources are as follows:

Variable	Source
Grant fair market value (FMV)	Stock Administration
Grant price	Stock Administration
Expected life of the option	Derived from the Expected Life report
Expected volatility of the stock price	Derived from the Expected Volatility report
Expected dividend yield	Acquired outside the system
Risk-free interest rate	Acquired outside the system

Understanding Steps for Collecting and Entering Valuation Data

To collect and enter report data for the Valuation process:

1. Run the Expected Life Years Analysis report.

This report helps you determine the expected life years for the Black-Scholes model. The expected remaining life of an option is the length of time before the optionee is expected to exercise the option in full. The report calculates the weighted average expected remaining life for the outstanding shares of the option. The system uses prior exercise information for a designated group of options plus other parameters that you enter to produce the Expected Life Years Analysis report.

2. Run the Expected Volatility report.

The Expected Volatility report helps you estimate the future volatility of a stock by calculating volatility based on historical stock prices entered through the Maintain Daily Prices page. It analyzes price movements over periods of months, weeks, days, or some other frequency that you choose and can serve as a benchmark from which you can project the expected stock volatility.

3. Enter variables on the Estimate Table page.

Use the Estimate Table page to create an Estimate ID and to record the expected volatility rates, risk-free interest rates, and expected dividend rates that you want the Black-Scholes Pricing Model to use when it values your stock options.

Expected Life Years Analysis Page

Use the Expected Life Years Analysis page (ST_RUNCTL_STFS001) to run the Expected Life Years Analysis report.

Revaluing Repriced Options

You can revalue grants *after* the initial valuation; but only if the revaluation is due to repricing, that is, the original grant has been cancelled and reissued. (A reprice grant number must appear for the new grant on the Maintain Grants - Miscellaneous page.)

You must use the same valuation method (single or multiple) to value the repriced grants; however you do not need to use the same Valuation ID.

Understanding Valuation Procedure for Stock Purchases

For stock purchases, the system estimates the fair value of the entire offering based on the fair market value of the stock on the offering begin date or the first grant date.

To value stock purchases:

1. Produce the Estimate Contributions report.

The Estimate Contributions report calculates the actual contributions for a stock offering.

For each employee associated with the stock plan and offering ID you select, the report lists the grant date, purchase date, and total actual contributions for confirmed stock purchases. It also reports the total and average contribution for all employees.

This information helps you estimate future contributions for the stock offering, which you must enter before launching the Valuation process.

2. Run the valuation process to calculate the fair value per share.

After you estimate contributions for a stock offering, you create an offering ID and launch the online process to value the offering. The system uses the Black-Scholes Model to calculate the value per share for each valuation period. Valuation periods are determined by the valuation method:

- For the single valuation method, the stock offering is valued as a whole. The valuation period runs from the offering begin date to the offering end date.
- For the multiple valuation method, the stock offering is valued for each purchase date, and can have more than one valuation period. The valuation period runs from the purchase begin date to the purchase end date.

Because there is only one valuation for each stock offering, the valuation record is not effective-dated. You cannot revalue stock purchase offerings.

The value per share is calculated based on the stock purchase plan's valuation plan type.

Estimate Contributions Report Page

Understanding Option Expense Types

In compliance with FAS 123R, PeopleSoft Stock Administration allows you to use four combinations of accounting distribution and valuation methods to expense options:

- Single valuation method with ratable distribution.
- Single valuation method with straight-line distribution.
- Multiple valuation method with ratable distribution.
- Multiple valuation method with straight-line distribution.

Note: PeopleSoft Stock Administration does not support the accelerated attribution method for expensing options.

Understanding Estimating Forfeitures

Under FAS 123R, stock option grant expenses must initially be calculated using a forfeiture estimation and the expense recorded must later be reconciled based on actual forfeiture outcomes. When a grant vests, the total of expenses taken over time must be equal to the grant's value. Similarly, if an employee terminates or otherwise forfeits an unvested grant, the total of expenses taken over time must be equal to zero. In every expense period, the expense to date for some grants will be based on a forfeiture estimate, while the expense-to-date for others will not because they reflect vesting and forfeiture events in the period.

The Estimated Annual Forfeiture Rate is used to estimate the annual percentage of currently unvested, granted shares that are expected to be forfeited prior to vesting. The rate can be changed from period to period based on experience and events in order to maintain estimation accuracy. The system assumes that the full estimated forfeiture percentage applies at the beginning of the life of a grant and then decreases towards zero as the grant's vest date approaches in order to accurately calculate the estimated rate.

Understanding Expensing Repriced Awards

Under FAS 123R, expenses for repriced shares are calculated using a fixed amount of additional expense.

The incremental cost for repriced awards is the excess, if any, of the fair value of the modified (new) award over the fair value of the original (cancelled) award immediately before its terms are modified. When re-valuing the original award at the cancellation date, the term is based on the remaining original term.

Example

To illustrate how repricing expenses are calculated under FAS 123R for both the original and replacement options, use the example of Worldwide Enterprises Corporation, which grants options having a fair market value of \$1,500,000 on January 1, 2007. The options are scheduled to 100% vest on December 31, 2009. Worldwide Enterprises' stock price subsequently declines and by December 31, 2007, the options are underwater. On that date, Worldwide Enterprises reprices the options by canceling them and granting replacement options priced at the current market value of the stock.

The repricing expense for Worldwide Enterprises under FAS 123R are determined as of the date the replacement options are granted and, except for forfeitures, are not adjusted further. Since the repricing occurs one-third of the way through the service period, assume that the company has already recorded \$500,000 in expenses to date for the underwater options. Worldwide Enterprises must continue to record the remaining \$1,000,000 expense for the underwater options. In addition, the company must determine the incremental expense for the replacement options.

The incremental expense is the difference between the fair market value of the replacement options and the underwater options at the time they are cancelled. In this example, assume that the fair market value of the replacement options is \$600,000, and that of the cancelled underwater options is \$200,000. The incremental expense is \$400,000 (\$600,000 - \$200,000). Worldwide Enterprises records a total expense of \$1,900,000 (the original option expense of \$1,500,000 plus the \$400,000 incremental expense for the replacement options). Since the company has already recorded \$500,000 of the original expense before the repricing, it records an expense of \$1,400,000 over the service period of the replacement options.

Stock Administration Self-Service Components

The Stock Administration self-service transactions interact with HR. These transactions enable employees to view and update their stock information. An additional transaction enables managers to view information about employees' grants and vesting details.

- Issuance Instructions enables employees to enter and view issuance information for each stock ID. They can view the details of issuance instructions and select broker or certificate issuance for stock options and stock purchase plans.
- View Stock Options enables employees to view a summary of active stock option grants, see the shares that are currently available for exercise, and view detailed vesting information for each active grant. They can view information as of today's date or enter a past or future date. If employees have grants in multiple stock IDs, they can switch to a different stock ID to view that summary information.
- View Stock Purchase Activity enables employees to view details of their contributions, purchases, and sales. They can view transactions as of today's date or for a date range. They can also print receipts and statements.
- Report Stock Sales enables employees to record stock dispositions (sales) and cancel pending dispositions. They can enter new dispositions, view the details of pending dispositions, and cancel pending dispositions.
- View Employees' Stock Options enables managers to view information about all active grants, along with vesting details, for a selected employee. Managers can view information as of today's date or enter a past or future date. By adding further information, managers can determine net potential gain.

Stock Administration Self-Service Roles and Security

This section discusses how to specify the information that an employee can access.

Specifying the Information That An Employee Can Access

Self-service transactions are targeted to specific roles, such as applicant, employee, faculty, manager, and optionee. These roles help determine:

- The transactions that an employee can access.
- The data that an employee can access.

User profiles determine the default access to transactions. You create user profiles on the Maintain Security page in the User Profile component. You assign a role to each user profile.

Profiles are linked to access control lists. Each access control list identifies the pages that users can access. To modify access to specific web pages for each role, you modify the access control list.

User profiles also control the data that each employee can access.
