# 1. Release Notes

## 1.1 Background

Oracle Banking Credit Facilities Process Management (OBCFPM) enable banks in managing the entire life cycle of Credit Facilities and Collateral by offering Collateral and Credit Facilities process management services to their corporate customers. OBCFPM enables bank to accelerate credit origination, customize credit lines along with tracking global business exposure and mitigating business risks. OBCFPM also streamlines the process of monitoring and managing credit lines, ensuring efficiency, compliance and enhanced customer service. In OBCFPM 14.8.0.0.0 release, the product is enhanced with additional functionality.

## 1.2 Purpose

The purpose of this Release Notes is to provide an insight about the new features in OBCFPM 14.8.0.0.0.

## **1.4 Release Highlights**

- The following enhancements are released as part of OBCFPM 14.8.0.0.0 version.

### **1.4.1 OBCC Dashboard**

- A dashboard to monitor and control overall Covenant and Conditions for a customer.
- Bank users will be able to quickly view and take action depending on the compliance history of the customer for the covenants and conditions

### **1.4.2 Deal Team & Task Assignment**

- On the basis of attributes assign tasks to particular users in the bank within a group
- Nominate expert users to pick up tasks to better align user experience to nature of the case
- Improve TAT on login to disbursement by auto assigning and ad hoc nomination complex cases

### **1.4.3 Covenants & Conditions Linkage**

- Standalone screen to link covenants and conditions to a customer or their facilities and collateral
- Can be used on an ad hoc basis and does not need a full credit facilities or collateral task to be initiated
- Provides ease of use for the monitoring and control team of the bank who generally handle large volumes of task. For them a standalone linkage screen reduces TAT significantly

### **1.4.4 Drawing Power**

- This functionality will support periodic Drawing Power calculation and update of the Facility amount for a customer based on the stock statement submitted by the customer.
- As part of the facility details users will be able to capture Drawing power attributes which should be used for the DP calculation on a periodic basis

### **1.4.5 Collateral Partial Release**

- This functionality will support partial release of Collateral and update the Charge Perfection value accordingly.

### **1.4.6 ESG Dashboard Widgets**

- Dashboard widget to show ESG related details of customers from the portfolio.

### **1.4.7 Exposure Management Flows**

- OBCFPM will support creation, review and closure of exposures
- Within the processes users will be able to define the exposure limits which get handed off to the back office
- These exposures will be available to be linked as well as is the case now with exposures created in back office

### **1.4.8 Facility UX- Ease of use**

- Quick navigation within the facility list has been provided for users to quickly go to a particular facility and edit the details

#### **1.4.9 Facility Additional Fields**

- A maintenance screen to store the information about any additional fields that need to be captured within the facility details.

#### **1.4.10 Business Process Improvement**

- Functionality provided for users to quickly export or import a specific data segment from one environment to another.

#### **1.4.11 Eligibility Checker Financial document upload**

- Users will be able to upload financial document while doing the eligibility check of the SME customers
- Keying in financial data can take time whereas this functionality will let the users upload the document and quickly fetch the ratios required to check under which program the customer is eligible for borrowing.
