
2.1 Activation of Menu

The sample reports can be activated in Menu in either of the following two ways:

- Section 2.1.1, "Front End"
- Section 2.1.2, "Back End"

2.1.1 Front End

You can process the 'Function Description Maintenance' screen by typing 'SMDFNDSC' in the field at the top right corner of the application tool bar and clicking the adjoining arrow button. The 'Function Description Maintenance' screen is displayed.



To activate the sample reports from the front end, the '**Available**' check box should be enabled by modifying the record. The user should modify and authorize the records.

2.1.2 Back End

To activate the sample reports from the back end, update the static data of SMTB_MENU Available column to '1' for all the reports.





2.2 Activation of Report Roles

All the report roles end with the word 'REPORTS'. These reports are pre-shipped as closed. You can process the '**Role Maintenance**' screen by typing '**SMDROLDF**' in the field at the top right corner of the Application tool bar and clicking the adjoining arrow button. The 'Role Maintenance' screen is displayed.



In this screen, specify the following details:

Role ID and Description

Specify the role Id of the reports. Alternatively, you can select the appropriate role Id from the option list. The system displays the role description.




Initially, all the report roles would be in closed status, the user can reopen the report roles by clicking on the '**Unlock**' button.

Click the 'Unlock' button then in the next screen click the 'save' buttonto confirm the record to unlock.



The Information Message window is displayed. Click the ' \mathbf{Ok} ' button. Now the report roles are in opened status.




2.3 Activation of EOD Reports

The Scheduler Job is used to generate Reports at EOD. The Scheduler Job can be activated by checking the **Active** checkbox from the **Job Maintenance** (STDJOBMT) screen.




2.3.2 Activation of EOD Report Batch

To activate the EOD report batches in the **Report Batch Maintenance** (RPDBATCH) screen, enable the **Available** check box by modifying the records in **Function Description Maintenance** (SMDFNDSC) screen as explained in the Section 2.1.1, "Front End". The user must modify and authorize the records.



All the batches maintained in the **Report Batch Maintenance** screen can be fetched in the **Mandatory Batch Program Maintenance** (EIDMANPE) and the reports which are part of the batches will be spooled during EOD.
