1 Overview of Product Management

Introduction to Product Management Work Area

In Oracle Fusion Cloud Applications, the Product Management work area is part of the Product Management Cloud suite, which is a modern and intuitive interface designed to streamline product life cycle processes. It's primarily used by product managers and product data stewards to manage product-related information across the life cycle—from ideation to release.

Key Features of Product Management Work Area

- Create and manage product master data.
- Define and maintain product and item structures.
- Manage item categories and attributes.
- Manage item lifecycle states
- Define item relationships and configurations
- Assign items to categories
- Track product design documents, Bill of Materials (BOMs), and changes.
- Define and manage Change Orders (COs) and Change Requests (CRs).
- Route changes for approvals using workflows.
- Use smart search that provides intelligent keyword matching, comprehensive filters, and automatic suggestions for quick information retrieval
- Configure and save personalized search views to streamline frequent tasks

Roles Required

The availability of the features in the Product Management work area depends on your role and privileges.

To access and manage the Product Management work area, you typically need roles such as:

- Product Manager
- Item Data Steward
- Product Data Hub Administrator
- Product Development Manager

Key Tabs in the Product Management Work Area

The Product Management work area has three main tabs:

- **Product Management** tab (that displays the Landing page by default)
- **Navigator** tab
- **Search** tab

Access the Product Management Landing Page

When you access the Product Management work area, the **Product Management** tab displays the Product Management landing page by default.

You can access the Product Management Landing page in any of the following ways:

- On the News Feed Home page, go to the **Product Management** tab > **APPS** section, and then click the **Product Management** icon
- On the News Feed Home page, click the **Product Management** tab. In **Quick Actions**, click **Product Management Overview**.

The Product Management Landing Page is displayed. On this page, you can:

- View the pinned items
- Use Search to find an item
- Select a view for the search
- Select a saved search
- Edit the Product Management landing page layout
- Access tasks from the Actions region

Access Key Product Management Information and Tasks Using Product Management Landing Page

Using the Product Management Landing page, you can view a summary of issues that need your attention by reviewing the Key Performance Indicators (KPIs) and the corresponding visualizations that provide details for the KPIs. For example, if you've pinned 5 items in the Clipboard that need your attention and you launch the application the next day, you can see the pinned items in the KPI and the details in the visualizations show 5 items. By default, the predefined KPIs are displayed. You can add additional KPIs. Also, you can monitor KPIs related to your work, and navigate to the relevant pages.

The Product Management Landing page displays the following panels by default:

- **Pinned items:** Shows the count of items that are pinned on the Navigator Clipboard. This panel is displayed by default.
- **Table:** Displays the visualizations related to the pinned items. In this table, you can:

- Perform a search related to the pinned items.
- Use suggested filters to filter the items based on item class and/or description.
- Export the displayed search results to an Excel file.
- View saved searches and create personalized search.
- **Actions:** Provides a list of quick links for navigating to additional pages based on your role. Your top tasks can be pinned and will display on the landing page. It contains up to 12 pinned links so that they're always available. All other tasks can be accessed using the **View all actions** link at the bottom. Clicking this link opens the Actions drawer where you can search for actions, pin actions, and click to navigate to the pages. Use the **Pin** icon to add the action to the **Actions** panel.

Edit Page Layout

You can edit the layout of the Product Management Landing page if you've the Manage Page Layout (EGP_LANDING_PAGE_LAYOUT) privilege.

To edit the page layout:

1. On the Product Management page, click **Edit Page Layout**.

The Product Management page displays in edit mode.

Hover on a panel to display a four-arrow icon. You can move and reposition a panel by clicking and dragging this icon.

Create and Manage KPIs and Visualizations

You can define OTBI-based KPIs and visualizations using the Visualization Configurations tool using the following steps:

1. Step 1: Create an analysis in OTBI and save the analysis in the Share/Custom folder.
2. Step 2: Create KPI
 - a. Access the Visualization Configurations tool using the following URL by replacing <Server> with your local server name:
<https://<Server>/fscmUI/redwood/cx-analytics/application/container/dvconfig>
 - b. Click **Add** to create a KPI or visualization.

The Create Configuration page is displayed.

 - c. Click **Create**.

The KPI is created.
3. Step 3: Create a visualization
 - a. In the same Visualization Configurations tool, click **Add**.
 - b. On the Create Configuration page, select Bar Chart, Pie Chart, Tabular Chart, and so on as the Visualization Type and then click **Create**.

The KPIs and visualizations that are created is displayed on the Visualization Configurations page.

Add KPIs and Visualizations to Landing Page

You can add KPIs and up to four visualizations for each KPI. This lets you personalize the landing page based on your requirement. OTBI report data can be mapped to visualizations provided in the graphical library.

To add KPIs and visualizations to the landing page:

1. Click **Edit Page Layout.**

The Product Management page displays in edit mode.

2. To add KPIs and visualizations, use the Library drawer that's displayed by default. The Library lists all available KPIs and visualizations.

Search for the KPIs or visualizations that you want to add. Use the suggested filters to filter the list. You can drag-and-drop the required KPI or visualizations to the appropriate areas of the landing page.

A new panel is added for the selected KPI. In case you close the Library drawer, click **Library** to open it.

3. To remove a panel, hover on the panel and click the **Remove icon.**

You can't remove the Pinned Items KPI and the Actions panels. When you edit the page layout, the changes are saved automatically.

4. Click **Exit Edit Mode.**

The Product Management Landing page displays the updated page layout and the panels.

Navigator in Product Management Work Area

You can use the Product Management Navigator to access your saved searches across Product Management objects and add, pin, and copy items, manufacturers, or workflows to and from your clipboard.

With the saved searches for each object, you can quickly navigate to the records you want without re-entering the search criteria. Also, you can refine your search further or create a new saved search.

Tagging lets you organize saved searches and clipboard items for a specific purpose. By assigning tags to relevant objects, you can effortlessly recall these collections when conducting searches, streamlining access to valuable information. You can search for tagged objects using the **Tag** filter and select a tag group.

You can also navigate to a specific detail tab from the clipboard. To access the Navigator, on the News Feed page, click the **Product Management** icon or click **Product Management Overview** in **Quick Actions**. The Product Management landing page is displayed. Click the **Navigator** tab at the bottom to view the Navigator.

You can pin the Navigator so that it persists in the left-hand panel. When you unpin, it automatically closes. Click the **Navigator** tab to access it again.

Access Saved Searches

In the Navigator's **Saved Searches** tab, you can:

- Easily find and select personal saved searches across objects using the **Filters** option. Filters limit searching saved search based on:
 - Pinned items
 - Object type
 - Tag used for an object
- Run saved searches by clicking the link for the object.
- Use the search to search for saved searches by name
- Use the **Tag** icon and tag the saved search into one of the existing tag groups. You can also create a new tag. When you click the **Tag** icon, a blank field appears. Type the tag name and press **Enter** to create the tag. When you hover or click the **Tag** icon for an object, the associated tag name is displayed.

Access Clipboard

With the Navigator's **Clipboard** tab, you can:

- Add items, manufacturers, or workflows you want to save and access at a later time. You can select the item, manufacturer, or workflow and launch the detail page.
- Items added to the clipboard will be available in the clipboard in the Product Management work area.
- Pin clipboard items so that they appear at the top (beginning) of the clipboard for quicker access.
- Use the filters to limit searching clipboard items by:
 - Pinned or not pinned objects
 - Object
- Pinned items are always displayed at the top (beginning) of the clipboard and have their checkboxes selected, followed by objects most recently copied to the clipboard.
- Click the **Tag** icon for an object to view the tagged groups.
- Click the **Actions** icon for an item and then select the tab that you want to view in the item details page.

Search in Product Management Work Area

In the Product Management work area, you can use the **Search** tab to search for many objects within Product Management. For more details, see [Use Product Management Search](#).

Identify Tasks and Objects in Product Management Work Area

You can use the visual indicators on the Product Management pages to easily identify the tasks and objects.

Use the distinct icons for items, manufacturers, and workflow objects to quickly identify the objects you're working with. Additionally, icons are displayed next to the tab names, making it easier to distinguish between them and navigate quickly and accurately to the desired open tab.

You can access the **Saved Searches**, **Clipboard**, and **Recently Visited** sections using the icons available at the top left of the Product Management landing page. When you click an icon, the panel opens. You can maximize, minimize, or close the **Saved Searches**, **Clipboard**, or **Recently Visited** sections using the icons.

You can only add items to the clipboard and spotlight if you've the view or manage permission to those items using access control list. From the clipboard, you can navigate to the various tabs of an item according to the permissions defined in the item access control list.

Similarly, view the items in the recently visited section if you've the view or manage permission on the item.

Object icons are shown beside the page title and on the tabs at the bottom (before the object name or number) that helps to identify the object type. Icons are available for the following object types:

- : Icon for the Item object
- : Icon for the Workflow object
- : Icon for the Manufacturer object

A new page title is added for the item pages accessed from the **Affected Items** tab, along with the icons to provide clarity regarding the changed object.

How You Use the Product Information Management Work Area



From the Product Information Management work area, you can scan the status of your product workflow using infolets, and also view event notifications. You can use the Tasks pane to manage items, new item requests, item batches, and import items from external data systems using import maps.

Note: If the **Product Information Management** work area is not available in the Navigator's **Product Management** menu, then navigate to the **Configuration** menu, click **Structure**, and expand **Product Management**. For **Product Information Management**, the **Navigator** and **Springboard** columns must have a green check mark. If it doesn't have the green check mark, see *Create and Edit Groups* for more information.

Product Information Management Landing Page

The Product Information Management landing page contains infolets to manage product information. For example, the Items for Definition infolet lets you view any new item requests. The Details tab in a new item request has detailed information for your analysis. After you have analyzed the request, you can decide to act on the request immediately or you can decide to come back to it later.

Apart from the infolets, you also receive notifications about events and workflow that need your attention. You can also search for items, catalogs, and so on from the Quick Search pane in Product Information Management work area. The Tasks pane has all the tasks that will help you manage your product data.

Manage Items

Use the **Manage Items** task to search for items. Open the desired item from the Search Results table and edit or view the attributes for item.

Manage New Item Request

Use the **Manage New Item Request** task to see what new items are there for you to introduce in the product workflow. Open a new item request to view the item details and its priority, and take appropriate actions.

Manage Item Batches

Use the **Manage Item Batches** task to view the batches of items imported from other data systems. The Search Results table gives you an overview of the status of the item batch. You can analyze a batch and look for any errors. For example, if the number of items available in the batch and the number of items imported don't match, it indicates that you have an error. Click the batch number to see the details of the import and analyze any error. You can also export the result of an item batch to a spreadsheet for offline analysis.

Manage Import Maps

Use the **Manage Import Maps** task to search for an import map and look at the mapping detail for the import map. Before creating a mapping of items, it's a good practice to view the source file details. To map your item entries, you can drag a column header from the source data to a corresponding attribute name in the master data. Refresh the preview table to see how the external data maps to the master data attributes.

Overview of the Product Information Management Work Area

You can use the Product Information Management work area to manage a broad range of common tasks related to product information.

This work area provides you with this specialized set of tools (in addition to the global tools such as favorites, watchlist, and notifications):

Tool	What It Does
Infolets	<p>Infolets are interactive panels on the work area page that present important data and help you take action based on it. In the Product Information Management work area, infolets summarize data from detail pages for working with your products. You can set a filter to change what's displayed in an infolet, or drill down into the corresponding detail page.</p> <p>Example: You can click a segment of the chart in the Import Batches infolet to work with the import batches from the associated source system.</p> <p>You can also move or hide infolets, to personalize the page for your own style of working.</p>

Tool	What It Does
Tasks	Use the Tasks list in the panel drawer to perform tasks specifically for the current work area. Click a task name to navigate directly to the task detail page.
Search	Use the Search in the panel drawer to search for many types of product information (such as items, catalogs, categories, trading partner items, change order requests, new item requests and item batches) directly from the work area, without needing to navigate to a specific task page. You can search using key words, names, ID numbers, or other criteria, depending on what you're searching for. Example: If you're searching for a specific item, you can enter the specific item ID, if you know it, or you can type in a few words from the description. If you enter red in the search field, the search returns items containing the word red in the item data. You can only access the data for which you have the correct permissions.
Clipboard	Use the Clipboard to speed up your work in the Product Development and the Product Information Management work areas. Copy items and documents to the clipboard and paste them onto other items, documents, and change orders. You can also do this from the Favorites and Recent Items available on the clipboard. Use the clipboard icon that appears on the Affected Objects tab and Relationships tab to copy items to the clipboard.
Reports and Analytics	Use the Reports and Analytics control in the panel drawer to run existing reports and analytics. If you need to define a new report, then navigate to the Reports and Analytics work area itself from your home page or through the navigator.

How You Use and Personalize Infolets in Oracle Fusion Cloud SCM and Procurement

Oracle Fusion Cloud Supply Chain & Manufacturing (SCM) and Oracle Fusion Cloud Procurement infolets are visual, actionable, and personalized information cards summarizing critical data about specific objects.

These infolet cards are combined in a SCM or Procurement home experience or work area home page to make key performance indicators easy to view, understand, and act upon.

You can do these with infolet cards:

- Flip or expand the card to view additional details about the object featured in the infolet card.
- Drill down to more details by navigating to relevant manage pages from the infolet view.
- Change the context of the card either at page level or at view level.
- Hide infolet cards.
- Reorder infolet cards.

Flip and Expand Card

Some infolet cards have a back view or an expanded view that provides additional information relevant to specific aspects of the object being featured in the infolet card. The back and expanded views of the infolet card display additional levels of detail and expose useful information relevant to the object. Based on how the infolets have been configured, you can then navigate to either the back view or the expanded view.

To see different views of the infolet card, do the following:

- Click the **Back View** icon present on the infolet card to see the back view with additional information about the object.
 - To return to the front view, click the **Front View** icon present on the infolet card.
- The expanded view is available from either the front view or the back view. Click the **Expanded View** icon to see useful information about the objects. Click the **Front View** or **Back View** icon to return to the view you started with.

Additional Pages

Click the number or an element like a segment on the pie chart of the infolet card to navigate to relevant manage pages with additional, in-context information. Drill down to view additional relevant information on related objects that will help you to act on the latest and critical data points. For example, suppose you've an infolet card that displays draft orders with errors. Each number or the segment of the graphical element represents the different error conditions such as pricing errors, processing constraint errors, and so on. Click the segment that represents draft orders in pricing errors to see the names and additional details of all the draft orders with pricing error.

Context Selector

To view different perspectives of the same data, use context selectors. Two types of context selectors are available: at the page level, and at the view level. Only some of the infolet cards have the view-level context selectors, while only some pages with infolet cards have page-level context selectors. Context selectors aren't present on all infolet cards and pages. If you change the context of the card on any view of the card, these changes may not necessarily reflect on the alternate views of the infolet card.

- Each view of the infolet card may have a view-level context selector located after the title of the card. Select from the list of available contexts and the view is updated based on that context. The view-level context can be different on each view of the card.

For example, you may have an infolet card that displays information about fulfilled orders for different time periods. Use the context selector to see information about orders that were fulfilled in the last three months.

- The page-level context selector is available on a tool bar of the page. The page-level context selector is similar to the view-level context selector, except that all the cards on the page will display data as per the filters set in the page-level context list. Click the **View By** icon on the tool bar of the page. Select the contexts from the two available lists in the Page Context dialog box.

Examples include updating all of the cards to show data only for the last week, or only for a particular business unit.

Hide Card

Click the **Actions** icon present on the infolet card, and select **Hide**. The selected card is hidden. You can also hide cards by clicking the **My Infolets** icon present on the page. A list of infolet cards is displayed. Deselect the check box of the infolet card that you want to hide.

Rearrange Cards

The infolet cards can be moved around and can be rearranged or re-ordered on the page in any way you want.

What You Can Do in Product Master Data Management

You perform tasks for Product Master Data Management in the Product Information Management work area.

Product Information Management Work Area Tasks

The Product Information Management work area provides these lists of tasks in the panel drawer:

- Item Management
- Data Governance
- Data Consolidation

The tasks related to these lists are described in the following tables.

Item Management Tasks

These tasks enable you to create and modify items, and the entities built with items. Items are the basic unit of product information data.

Task	What you do in this task
Define Product	Create items and apply predefined templates that provide all of the basic information to help you get started quickly.
Manage Product Specifications	Specify values for product operational attributes at a product level as well as product revision level, allowing you to control how an item is processed by downstream applications.
Manage Product Relationships and Associations	Define item relationships to relate two internal items using predefined as well as user defined relationship types. Capture attributes to further qualify the relationship as well as specify effectiveness dates to phase the relationships in or out. Define and maintain GTIN (Global Trade Identification Number) cross references to relate items using the industry standard allowing for tracking and identification of trading partner items. Assign items to multiple organizations to manage them in context of locations they're manufactured, stocked, and distributed from.

Task	What you do in this task
Manage Product Packs	Define and manage product pack information by creating homogeneous and heterogeneous packaging configurations of sellable items.
Manage Product Bundles and Structures	Define and manage product structures to represent various product hierarchies. Copy product structures from existing structures with the ability to preview the components you're copying. Associate common product structures to a master product structure to maintain a single definition across multiple organizations.
Manage Product Attachments	Associate unstructured content as attachments to a product. Categorize attachments in various predefined and user defined categories to organize and provide quick access to important documents for the product.
Manage Product Revisions	Manage item revisions to track major changes to an item in terms of its form, fit, or function. Introduce new item revisions through a formal change order framework to generate an audit trail as well as streamline implementation of new revisions.
Define Catalogs	Define and manage catalogs to categorize items in a structured hierarchy. Associate images and attachments to catalogs and categories to help you quickly build rich catalog content. Share category and item associations from a source or master catalog with multiple catalogs enabling you to reuse existing data and ease administration of catalogs.
Define Advanced Catalogs	Manage catalog mapping between two catalog hierarchies as well as attributes for the catalog and categories.
Access and Search Product Master Data	Quickly search for items using single keywords. Perform advanced searches by specifying various parameters and criteria as well as building more complex searches using search operators to quickly find products. Define saved searches enabling you to promote reuse and provide quick access to searches that need to be performed frequently.
Manage Product Mass Updates	Perform mass updates on item information including changes to item attributes, item supplier associations, item reclassification, and organization assignments.
Manage Product Security	Assign role based security at a product level to control access to items. Assign data level security at each individual attribute group level to further control access to sensitive information. Assign appropriate functions and privileges to users or groups of users to control who can create, edit, and view item data.
Obsolete Products and Services	Define and manage deletion groups to process purging and obsoleting products and services that are no longer being transacted in the enterprise. Create deletion constraints to identify and account for all transactions and entities that reference a product, thus maintaining integrity before a product can be purged.

Data Governance Tasks

These tasks enable you to govern the currency and integrity of your product information data.

Task	What You Do in This Task
Manage Product Revisions	Manage item revisions to track major changes to an item in terms of its form, fit, or function. Introduce new item revisions through a formal change order framework to generate an audit trail as well as streamline implementation of new revisions.
Manage New Product Definition and Approval	Define and manage new item requests to enable a formal definition and approval workflow. Definition steps can include product attributes, product structures, item relationships, item attachments, and organization assignment. Manage multiple item definition belonging to different item classes in a single new item request.
Manage Product Change Orders	Create product change orders to process changes to product attributes, lifecycle phases, item statuses and product structures. Submit changes through a formal review and approval workflow to ensure successful and validated implementation of change orders. Implement changes through multiple organizations by propagating change orders to organizations while still having the flexibility to adapt implementation schedule based on individual organizations. Move or split change order lines to new or existing change orders to avoid bottlenecks in processing and implementation.
Define Product Rules	Create and edit rules for products. Rules can be used to assign values to attributes, validate dependencies between attributes and require approval through change orders for certain types of attribute updates.

Data Consolidation Tasks

These tasks enable you to consolidate product information data from external sources with your internal master data.

Task	What you do in this task
Manage Imports	Manage the import of items and related entities using industry standard open interface tables allowing you to quickly import data into the production schema as well as enabling migration of data from existing applications.
Manage Import Batches	Define item batches to import sets of item data including product structures and packaging hierarchies from multiple product source systems. Specify import options for an item batch to schedule batch loads, governance and workflow policies for new item definition and approval and product changes. Specify data quality options for matching and standardization for an item batch to cleanse product data during batch import.
Manage Supplier Collaboration	Collaborate with trading partners on item data including item attributes, product structures, and packaging configurations. Secure trading partner access by assigning privileges. Communicate critical changes with suppliers through change order workflows to review, validate accuracy, and approve changes for supplier items. Associate external items such as supplier items and specify supplier item attributes to capture rich detail for the supplier items. Extend the supplier item relationships to associate supplier items to multiple organizations from which they're supplied and received.
Manage Trading Partners' Products	Define and manage trading partner items such as customer items, and associate them with an internal item. Define and manage manufacturer part numbers and associated attributes, which enables you to relate multiple manufacturer parts to an internal item. Define and manage competitor items to relate similar items that might be sold or manufactured by your competitors.
Standardize Product and Service Data	Eliminate potential duplicates by standardization of product numbers and descriptions based on user defined rules and formats.

Task	What you do in this task

Manage Worklist from the Product Information Management Work Area

Use the Manage Worklist task in the Product Information Management work area to access the BPM Worklist page.

The BPM Worklist page opens in a new tab within the Product Information Management work area. Alternatively, you can also open the BPM Worklist page by clicking the Notifications button.

Here are the statuses that you can apply to your tasks from the Worklist tab:

Status	Description
Approve	Once a task is sent for approval, the approver can use the approve action to continue the task.
Reject	Task assignee can reject the task to prevent further approval.
Request More Information	If the task assignee wants more clarification from the requester, the task can again be sent to the requester. Users can also specify who requested the information. At this stage, the task is not rejected. Once the required information is provided, the approval flow begins again.
Reassign	The task assignee can send the task to another user for approval. The new user's hierarchy is used for approval. For example, if a user thinks that the task is relevant to another department, he can reassign it.
Delegate	A user can delegate the task to another user. After approval by the delegate, the initial user's hierarchy is used for approval. The delegate can still act on the task after task expiry.
Withdraw	The task initiator can withdraw the task after the approval has been initiated.
Escalate	A user can escalate the task from the current assignee to the supervisor.
Claim	A task that is assigned to a group or multiple users must first be claimed. Claim is the only action available in the task action list for group or multi-user assignments. After the task is claimed, all applicable actions are listed. Claim is available only if auto claim is disabled and the response required from is set to One.
Dismiss	Used for a task that requires the person (acting on the task) to acknowledge the receipt. This is similar to an FYI notification, which does not involve any action.
Resume	A task that was halted by a Suspend action can be worked on again.

Status	Description
Release	Releasing a claimed task makes it available to other assignees. A task assigned to a group or multiple users can then be claimed by the other assignees.
Suspend	The expiration date remains suspended until the task is resumed. After suspension, options to update a task are disabled.

Note: The Suspend and Resume tasks are only available for application implementation management users.

2 Item Creation

Overview of Items

Items are used to represent products and services that you sell or transact and components that make up your products and services.

Each item has several standard operational attributes that determine the behavior of the item with respect to various functions, such as Purchasing and Inventory Management. In addition to these operational attributes, the item has several user-defined attributes defined by its item class. These user-defined attributes capture item specifications and other information relevant to the product definition.

You can use the new Product Management work area to create edit items. You can view item attributes, descriptive flexfields, extensible flexfields, and all other child item entities.

Note: All the actions related to create and edit items that you were able to perform in the Product Development and Product Information Management work areas can now be done in the new Product Management work area.

Create Items

Creating an item initially involves specifying a wide range of attributes that define the item's identity, behavior, and usage across various business functions.

When creating an item, you can specify whether it's an engineered item. Based on this, the attachments, structure, lifecycle phases, and so on will be validated.

When you create an item, first you must select the organization and then specify the item class. Based on the item class, templates are available. Template is a defined set of attribute values. They're available for each item class and are specific to an organization. Also, the templates are inherited down the item class hierarchy.

When you apply a template to an item, you overlay or default-in the set of attribute values to the item definition. For example, every time users in a particular organization create items, the attributes (as defined and approved by the

organization) appear in the appropriate fields. The implementation user can define both operational attributes and user defined attributes for each template.

If more than one item template is selected, they will be applied sequentially. It means that if the same attribute is defined in more than one template, the value of the attribute as set in a subsequent template in the sequence will override the previously set value for that attribute. For example, if template 1 sets the **Order Enabled** attribute to **Yes** and template 2 set the same attribute to **No**, then attribute value will be set to **No**.

Next, required attributes must be provided. If required attributes were defined in the item class, then they must be provided. Use the data level attributes to enter or view different aspects of the item, such as the base standard and operational attributes.

If you create an item using an import service, a SOAP web service, or a REST API, with the Engineering Item attribute set to **Y** (yes), that item is also considered an engineering item.

To create an item:

1. Do one of the following:
 - On the Product Management landing page, in the **Actions** panel, click **View all actions** and then click **New Item**.
 - On the Product Management Search page, click the **Add** icon, and then click **Create Item**.

The Create Item drawer is displayed.

You can create an engineering item or a commercial item.

2. Select the **Organization**, **Item Class**, and one or more **Templates**. Based on the item class, templates are available. You can select multiple templates and the template values will be applied in the order of selection.
3. Specify the **Primary Attributes** and **Mandatory Attributes** and then click **Create**.

The item is created and displays on a separate tab, where you can specify the operational attributes.

All the predefined operational attributes grouped under various attribute groups are displayed on a single page.

On this page, you can:

- Search for attributes, attribute values, and attribute groups. The data is filtered based on the search criteria and attributes are highlighted.
- Use the suggested filters to further refine the view to display only the specific attributes belonging to the page.
- Click the **Edit** icon for the attribute group, where you want to specify the values. After specifying the values, click **Apply** and the values will be visible on the user interface.

Note: For information about the attributes available in each group, see *Item Attributes Reference*.

4. After you specify the attribute values, you can optionally do the following using the various tabs within the item:

- o **Attachments** tab: Add and manage attachments
- o **Structures** tab: Define an item structure
- o **Changes** tab: Manage change orders and change requests
- o **Associations** tab: Assign the item to organizations
- o **Categories** tab: Assign the item to categories
- o **Relationships** tab: Create item relationships such as trading partner item relationship, related item relationships, link item relationships, GTIN item relationships, cross-reference item relationships, and spoke system item relationships
- o **Where Used** tab: View all instances where a specific item is used across various processes
- o **Quality** tab: Manage the item quality issues, actions, view problem reports, and perform corrective actions

Note: The tabs are displayed based on the privileges assigned for your role.

5. Click **Save** at the page-level to save the changes to the item.

If there are any errors at the time of item creation due to rules, then the item will be created in **New** status. You must resolve the errors before using the item. You can save the item or submit the item to new item request depending on the item class setup.

You can select templates either from the same organization or a different organization. After you've selected all the required templates, click **Apply**.

You can optionally specify descriptive flexfields at the Item or Item Revision levels. If you're licensed to use Oracle Product Hub, you can specify extensible flexfields to capture attributes of the item at the Item and Item Revision.

Note: While creating items based on certain attribute values, automated processes for item category assignments might be performed. If functional area catalogs aren't defined, item assignments for those functional areas are skipped. When creating items, item rules are evaluated, and appropriate messages are displayed.

Edit Items

To edit an item:

1. Do any of the following:
 - o On the Product Management page, search for the required item, and in the search results, click the item number link.
 - o On the Search page, search for the required item and click the item number link.
2. The item opens in a separate tab. All the attributes are in read only mode.
3. To edit the operational and extended flexfield attributes, click the **Edit** icon on the **Attributes** tab.
3. Edit the required information and click **Save** at the top to save the changes.

Generate AI-based Formatted Product Descriptions

In Product Information Management work area, you can automatically create detailed product descriptions based on the existing attributes, which can include various formatting elements (such as bold, italics, bullet points, and embedded images). This provides more descriptive and visually organized product information. You can generate the product description when you're creating or editing an item.

To use this feature, you must do the following:

- In the Offerings work area, enable the **Data Governance** and **Data Consolidation** features at the offering level for the **Product Management** offering.
- In the Setup and Maintenance work area, set the **ORA_SCMP_GENAI_EGI_ITEM_DESC** profile option to **Y** using the **Manage Administrator Profile Values** task.

To generate the product descriptions:

1. In the Product Information Management work area, search and open the item in edit mode for which you want to generate a product description or create an item.

2. In Formatted Description, click AI Assist.

After some time, the product description displays within the **Formatted Description** field along with the features and benefits.

If you're not satisfied, click **AI Assist** again to view a different formatted description.

If you've manually entered a description in this field, then clicking **AI Assist** will use your content to generate an improved product description and then replace the existing content with the automatically generated description.

Also, you can edit the generated description using the **Edit Formatted Description** option.

Note: The AI capabilities for creating keyword rich product descriptions uses the item description as the input parameter. Hence, providing more descriptive details in the description will help create more appropriate descriptions.

3. Click Save to save the changes for the item.

Duplicate Items

You can create a new item by copying an existing item and modifying the specific information to suit your requirements.

You can copy the attributes, structures, organizations, categories, attachments, and trading partner item relationships to the new item.

To create a new item based on an existing item:

1. In the Product Management area, open the item that you want to use to create a copy.
2. From the **More Actions** menu, click **Save As**.

Note: The **Save As** option is available only for the current revision of the item

The <item name> copy drawer is displayed.

3. Specify the following details:

- **Item:** Enter a unique name for the item
- **Description:** Provide a brief description about the item
- **Include:** Select the entities you want to copy to the new item. These entities are categorized as:
 - **Attributes**
 - **Structures**
 - **Others**

Based on the entities you select, the respective tabs are displayed.

- **Apply Templates:** Select one or more templates to apply to the new item
- Select one of the following to determine the order in which the attribute values are copied:
 - **Copy Attributes and Then Apply Templates**
 - **Apply Templates and Then Copy Attributes**
- **Attributes:** Select the attributes you want to copy to the new item.
- **Structures:** Select the structures you want to copy to the new item. You can selectively decide whether to include substitute items and reference designators for the structure. You can select the **Creation Option** as **Copy** or **Common**.
- **Others:** Select the child entities you want to copy to the new item:
 - Organizations
 - Categories
 - Item attachments
 - Item revision attachments
 - Manufacturer trading partner item relationships
 - Competitor trading partner item relationships
 - Customer trading partner item relationships
 - Supplier trading partner item relationships

4. Click **Save**.

The item is created.

Delete Items

On the Product Management page or the Search page, search and click the item number that you want to delete. The item opens in a separate tab. Click the **More Actions** icon at the top and then click **Delete** to delete the item.

Other Actions When Creating or Editing an Item

You can do the following when creating or editing an item:

- **Refresh the item:** Use the **Refresh** icon to view the latest updates that were done on the item through import maps, REST services, or SOAP web services. This refreshes the item page and shows the latest item data.
- Using the **More Actions** icon at the top of the item page, you can do the following:
 - **Add Item to Clipboard:** Click **Clipboard** to quickly add the item to the Clipboard. You can only add items to the clipboard if you've the view or manage permissions to those items using the access control list. From the clipboard, you can navigate to the various tabs of an item according to the permissions defined in the item access control list.
 - **Send Object:** Send the item to specific users based on their role along with a message.
 - **Download Attachments:** Download attachments associated with the item individually or all attachments in a single file.
 - **Assign to Change Order:** Assign the item to a new change order or to an existing change order.
 - **Assign to Change Request:** Assign the item to a new change request or to an existing change request.
 - **Change Item Class:** Change the item class for an item to one of the available item classes
 - **Apply Templates:** Select and apply additional templates for the item.
- **Spotlight:** Adds the item to the **Spotlight** tab in the Navigator. You can only add items to the spotlight if you've the view or manage permissions to those items using the access control list. From the clipboard, you can navigate to the various tabs of an item according to the permissions defined in the item access control list. The spotlight includes reference designators, substitute components, component level attributes, component level descriptive flexfields when you drag and drop (select and move) the components to the item or to a change.
- When you open an affected item in change order context, the change order number is highlighted clearly indicating the change order.

Access to Item Attachments

Access to attachments can be secured by your administrator using an access control list. To download attachments, navigate to the item page, click More Actions > Download Attachments. For more details, see [Access Control Lists for Items](#)

Item Revisions

When you create an item, a default revision is automatically created. Also, you can create item revisions based on item definition changes. Generally, if there is a change in the form, fit, and function for an item, then a new revision is automatically created.

When you create an item, a default revision is automatically created. Also, you can create item revisions based on item definition changes. Generally, if there's a change in the form, fit, and function for an item, then a new revision is automatically created.

You can capture revision level changes using revision level attributes. To use revision level attributes, you've to create a new revision.

Item revisions are specific to the organization the item is assigned to. So, the same item can have 10 revisions in Organization A and only 5 revisions in Organizations B.

In Product Management, when you create a revision, you must specify an effective date. The effective date of a new revision also signifies the end date of the prior revision. Therefore, at a given time only one revision can be effective.

Item-revision-level attributes can have different values for different revisions. However, item structures aren't revision specific. If the start and end dates of the structure components match with the start and end dates of an item revision, then item structures act as revision-effective structures. Revision-effective structures are structures that are valid from a start revision to an end revision. You can create an item revision in the context of a change order. In such cases, the new item revision becomes effective when you implement the change order.

View Item Details

To view the details of an item, on the Product Management page or the Search page, perform a search for the item.

In the displayed results, click the item number link for which you want to view the details. The item page displays the following details:

- Item name, item's revision number, and the corresponding change order from the Revision list on any item page. The current effective revision is marked with an asterisk (*) character.
- Item class name
- Status of the item
- Organization of the item
- Approval status of the item
- Use the following tabs to view the other details:
 - **Attributes:** Provides the characteristics of the item
 - **Attachments:** Shows text or graphic files, or URLs, with more information about the item; classify attachments into a category. Includes revision-specific content.
 - **Structures:** View the Bill of Materials for assemblies, products, and other collections of items. Includes revision-specific content.
 - **Changes:** Lists change orders or change requests that the item is on.
 - **Associations:** Lists the organizations assigned to the item.
 - **Categories:** Lists the categories assigned to the item.
 - **Relationships:** User-set association between any two business objects or structures. Includes revision-specific content.
 - **Where Used:** Displays those item-structures to which this item is added.
 - **Quality:** Displays those quality issues or quality actions to which this item has been added. Includes revision-specific content.

Sometimes new items aren't visible after creating multiple items or importing items. Items are generated in a sequence but a few of the items aren't visible because the sequence numbers were skipped. It's difficult to determine the cause of the failure. It might be because the process wasn't completed due to server issue, it isn't closed due to database issue, or

might be the item is still under approval (that's, it's in draft state). This results in the sequence numbers not being used and you can't reclaim those skipped numbers.

For example, when a new item is created, the new item uses the next sequence number. Let's assume the first item isn't approved and the new item request was canceled or rejected, but the subsequent item was approved. Hence, one item number is skipped. It isn't possible to identify the causes.

Restrictions When Viewing or Editing Engineering Items

For engineering items that are in the Design lifecycle phase, you can't view or edit the Structure components and MPN relationships.

For engineering items that are in any lifecycle phase other than Design, you can't add or modify the Structure components and MPN relationships.

However, you can view, edit, or add engineering items using a change order.

Update UOM Values After Creating an Item

You can update the primary unit of measure of a new item request-enabled item, in the draft status.

If the item is a part of a structure, after you update the UOM, you must check and manually update items in any impacted structures.

Note: The primary unit of measure won't be editable for approved items on new item request classes and non-new item request classes. For information about the checks performed when the primary UOM is updated, see Checks Performed for Item Attribute Changes section.

Change an Item to an Engineering Item

You can change an item to an engineering item in the following ways:

- **Import map:** In an import map, map your source data column for updating the Engineering Item attribute to the following column in the Master Data table:
 - Attribute group: **Main**
 - Attribute: **Engineered**
 - Internal Name: **ENGINEERED_ITEM_FLAG**
 - Data Type and Length: **VARCHAR2(1)**
 - Column Value: **Y** or **N**
- **File-based data import (FBDI):** In a file-based data import template, enter your upload data for updating the Engineering Item attribute in the following column:

- XLSM template: **ItemImportTemplate.xlsx**
- Worksheet: **EGP_SYSTEM_ITEMS_INTERFACE**
- Transaction Type: **UPDATE**
- Column header: **EngineeredItemFlag**
- Column value: **YorN**
- Items Version 2 REST resource: In your call to the Items Version 2 REST resource, specify the value for the EngineeredItemFlag parameter:
 - Method: **PATCH**
 - Path: **/fscmRestApi/resources/11.13.18.05/itemsV2/{itemsV2UniqID}**
 - Body parameter: **EngineeredItemFlag**
 - Parameter value: **true** or **false**

Change Lifecycle Phase on an Obsolete Item

To change the lifecycle phase on an obsolete item in the Product Management work area, assign the item to a change order. On the **Affected Objects** tab, use the **New Lifecycle Phase** column.

Add Packaging Strings to Items

If one of your items has a non-standard UOM conversion specific to that item itself, you can add a predefined packaging string when you create or edit an item, or define a new packaging string to fit your requirements.

Select Packaging Strings

If your item needs to specify a packaging string, you can select one from a list of packaging strings that have already been defined.

1. When creating or editing an item, on the **Attributes** tab > **Basic** section, select a **Primary Unit of Measure** for the item.

Tip: If you're not sure what unit of measure to select, try searching in the **UOM Class Description** field, which provides fuller naming information for the units in use.

2. Select a **Packaging String** for the item.

The packaging strings available for selection are restricted to those that include the Primary Unit of Measure that you selected. It's possible that the desired packaging string hasn't been defined yet.

Create Packaging Strings

If the list of packaging strings available for an item doesn't include the packing string you need, you can create a packaging string when creating or editing the item.

To create a packaging string:

1. When creating or editing an item, select the **Primary Unit of Measure** for the item.
2. Click the + icon next to the **Packaging String** field.

The Select UOMs drawer displays the following:

- o **UOM Class:** UOM class of the Primary Unit of Measure that you selected for the item
- o **Base UOM Name:** This is the base UOM of the UOM class of the available UOMs.
- o A list of Available UOMs for the new packaging string, including all the UOMs defined for the UOM class. You can't add UOMs directly to this list. To add UOMs to the list of available UOMs, you must use the **Manage Units of Measure** task in the Setup and Maintenance work area.

3. Select the UOMs that you want to include in the new packaging string. You must select the UOM from smaller to the largest so that they appear in the correct order. The base UOM is automatically a selected UOM, because it's always the first UOM in the packaging string. You can't define a packaging string with more than 10 UOMs.

4. Click **Continue**.

The Define Multipliers drawer displays a default Packaging String composed of the UOMs you selected, but only if the UOMs have standard conversions that divide evenly between each other. The Define Multipliers table contains a row for each UOM conversion in the packaging string, each with a default multiplier.

Note: The sequence of the UOMs in the table matches the sequence that you selected in the previous step.

5. In the **Multiplier** field for each row, enter the number that defines how many of the UOMs in the **Content UOM** field equals the UOM in the **UOM Name** field.
6. After you specify the new multiplier values or accept the defaults, click **Recalculate**.

All the displayed UOM conversions are updated.

7. Click **Create**.

The packaging string is added to the **Packaging String** field.

Example of a Packaging String

Assume that your item is a medical glove used in hospitals. You need a packaging string that tracks how the gloves are ordered and dispensed.

The units used in your customer's hospital are:

- 1 glove is dispensed as each.
- 120 gloves are stored in each room, in a box.
- 24 boxes are stored in a unit, in a carton.
- 16 cartons are stored in the supply room, in a case.

- The hospital orders gloves by the case.

The UOMs and conversion multipliers required for this example are:

Base Unit of Measure	Conversion Multiplier	Units of Measure	Unit of Measure Class
Glove	1	Each	Quantity
Each	120	Box	Quantity
Box	24	Carton	Quantity
Carton	16	Case	Quantity

To add a packaging string:

1. When creating the item, on the **Attributes** tab > **Basic** section, select the **Primary Unit of Measure** as **Each**.
2. Click the + icon next to the **Packaging String** field.

The Select UOMs drawer is displayed.

3. Select the following UOMs:

- Each
- Box
- Carton
- Case

For this example, assume that these UOMs have been defined for your organization.

4. Click **Continue**.

The Define Multipliers drawer displays the following:

- The **UOM Class** is **Quantity**
- The **Base UOM Name** is **Each**

Enter these multipliers and click **Recalculate**:

Multiplier	Content UOM	UOM Name	Base Unit Conversion
120 X	Each	= Box	120
24 X	Box	= Carton	2,880
16 X	Carton	= Case	46,080

You should see the numbers shown in the Base Unit Conversion.

The **Packaging String** field should display a packaging string similar to this:

Ea 120/BX 24/CTN 16/cs

5. Click **Create**. Your new packaging string appears in the **Packaging String** field on the **Attributes** tab > **Basic** section of the item.

Use Packaging Strings

You can use packaging strings in:

- Item definitions: When creating or editing an item, you can select an existing packaging string for the item, or create a new packaging string. See the preceding sections of this topic for details.
- Import maps and FBDI: You can import an existing packaging string for items, in the **Packaging String** attribute in an import map, or in the **Packaging String** column of the `ItemImportTemplate.xlsx` FBDI template file. You can't create a new packaging string through item import.
- Publications: Packaging strings are available in the item XML generated by the Publication process.
- Product rules: You can see packaging strings in assignment and validation rules.
- REST services: You can use the `packagingStrings` REST resource in the SCM Common group to create or get packaging strings. For details, see the REST API for Oracle Fusion Cloud SCM guide.

Autocreate Item-specific Intraclass UOM Conversions Using Packaging Strings

Earlier to define item-specific intraclass UOM conversions you had to follow a two-step process:

1. Make sure the item is created in the Product Information Management work area.
2. Populate the computed UOM conversion using the Manage UOM Intraclass Conversions page in the Setup and Maintenance work area.

Now, you can define the item-specific intraclass UOM conversions in a single step by assigning a packaging string to the item when the item is created or updated. When saving the item record, based on the item's packaging string definition, Oracle Product Hub automatically stores the item-specific UOM conversion for every UOM present in the packaging string. For example, if you assign the packaging string *Ea 12/CRD 5/PK 4/CTN* to the item *RXJY 17 mg Tablet*, then Product Hub adds the following item specific UOM conversions to the database.

Item	From UOM	To Base UOM (Each)
RXJY 17 mg Tablet	Card	12
RXJY 17 mg Tablet	Pack	60
RXJY 17 mg Tablet	Carton	240

The autocreated item-specific conversion will be available in the Manage UOM Intraclass Conversions page in read-only mode. To change the conversion factors, you must change the packaging string assignment to the item as needed.

The following table shows the conversions for the packaging string on the Manage UOM Intraclass Conversions page.

Item	Item Description	From UOM	Class Name	Conversion	Base UOM Name
------	------------------	----------	------------	------------	---------------

RXJY 17mg Tablet	RXJY 17mg Tablet	Card	Quantity	12	Each

You can view the assigned packaging string to the item when editing the item on the **Attributes** tab > **Packaging String** attribute.

To avail this feature, you must opt-in to the **Automate UOM Conversion Set Up with Packaging Strings that Specify Eligible Units for the Item** feature. After availing this feature, if you update a packaging string assignment for an item, the update must meet the data validation constraints. If you aren't availing this feature, Product Hub won't autocreate the item specific UOM conversion even if you assign a packaging string to the item.

If you've opted into the **Create Packaging Strings for Items** and the **Calculate Runtime Transaction UOM Conversions with Generated Item Data** features, (a parent feature of the **Autocreate UOM Conversions When Adding a Packaging String to an Item** feature), the LOVs for the Secondary UOM field and the Unit Of Issue field will restrict the UOMs only to the collection of UOM elements in the Packaging String assigned to the item.

Compare Items

You can compare item information such as item operational attributes, extended attributes, relationships, and categories.

To compare items:

1. On the Product Management page > **Actions** panel, click **View all actions**, and then click **Compare Items**.
The Compare items drawer is displayed.
2. Select the items that you want to compare and click **Compare**. You can select up to five items.
The results are displayed in a grid layout on a separate **Compare Items** tab and the differences are visually highlighted.

You can also do the following:

- Click the **Add** icon to add or remove items for comparison.
- Change the comparison attributes by selecting a different **View**.
- Use **Search** to narrow the displayed results.
- Click **Differences** to see the differences only. By default, **All** is selected.
- Click the **Export** icon to download the comparison results to an Excel file to the required location.

Organize Actions

You can sequence the actions that appear on the Items and Workflow pages and set the maximum number of actions that must be visible on these pages.

On the Product Management page, in the **Actions** section, click the **View all actions** link. The Actions drawer is displayed. Click **Settings**. The Settings page is displayed. This page has two tabs—Item and Workflow. You can update the following settings on both these tabs:

- Select a value from the **Maximum visible actions** drop-down list to specify the maximum number of actions that must be visible on the page.
- Set the sequence of the actions. To do this, click the row that you want to move. Hover on the first cell of the row to display the hand icon. Grab the row, and then drag and drop the row to the required position.
- Reset to the default settings using the **Reset to Default** icon.

Click **Save** to save the changes.

Sign out and sign in again for the changes to take effect. You can view the updated sequence of actions on the Item and Workflow pages.

3 Documents

Create and Edit Documents

You can create documents using the Product Management Search page for items. Here's how:

1. Click the **Create Document** button on the Product Management Search page for items.

In the Create Document drawer:

- o Select a document class.
- o Update the basic attributes.
- o Select an item template.

Note that the Create Document option will appear based on the following configurations in the Manage Configurations task (within the Product Development work area):

- o The Enable Document Management option is selected.
- o The Document Class Name field is configured to manage the root document class.

Also, you must enable the profile option Enable the Redwood page for View Document (ORA_EGP_VIEW_DOCUMENT_REDWOOD_ENABLED).

Note: You can also create a document from the New document action in Quick Actions on the Product Management landing page.

2. Click **Create**.

Here are some tabs that appear on a document:

- Attributes
- Attachments
- Structures
- Categories
- Relationships

Note: When you create a new item of type document class in Redwood, the UI displays only the Links table in the Relationships tab.

Actions on Documents

You can use the **Actions** button on the document to:

- Assign the document to changes such as change orders, change requests, problem reports, and corrective actions.
- Send notification using Send Object.

- Navigate to the Spotlight and review the document structure.

Attributes

Here's what you can do on the attributes tab:

- Edit the main and additional attributes such as extensible flexfields.
- Update the Rich Text content in the **Formatted Description** field.

Attachments

Here's what you can do on the attachments tab:

- Add or remove item attachments and item revision attachments on documents.
- Download the attachment files.
- Edit the attachment attributes such as **Title** and **Description**.

Structures

Here's what you can do on the Structures tab:

- Update the structure and component attributes.
- Add and delete items or documents as a component to the structure.
- Add, delete, and update reference designators and substitutes.
- Create structures
 - You must create a primary structure before adding components.
 - You can create structures from existing ones, copy structures, and create alternate structures. You can also use structure header descriptive flexfields, and structure header attachments on engineering items early in the design process.
 - Here's how you create a structure on a document:

Open the document and navigate to the Structures tab.

Click the ellipses (three horizontal dots) icon and click **Create Structure**.

In the New item structure drawer, enter the structure details and click **Apply**.

After you create a structure, the following actions appear when you click the ellipses (three horizontal dots) icon:

- Edit Structure (or Structure Details)
 - Click **Structure Details** to open a drawer using which you can edit the structure.
 - You can access structure header descriptive flexfields and attachments on documents.
- Add to Delete Group and Delete
 - If you've saved the structure, you can't delete it directly. You must click **Add to Delete Group**.
 - If you haven't saved the structure, you can delete it using **Delete**.

Categories

Here's what you can do on the Categories tab:

- Add new product lines to the document.
- If you have used the 'Product lines' attribute in the classic interface, the same will be visible in the 'Categories' tab in a Product Lines catalog.

Note: You can add only Product lines as Categories for a Document.

Relationships

Here's what you must know about the Relationships tab:

- The relationships you created on the document in the classic interface appear in the Links section on Relationships tab.
- From a document you can create links to other documents, items, change orders, change requests, problem reports, corrective actions, concepts, ideas, items, proposals, and quality actions.
- To create a link, select an object type. The objects corresponding to the organization in which document is created are populated in the **Name** column. On selecting the object, the other fields are populated. To save your changes click **Apply** and click **Save**.

4 Item Attributes

Overview of Item Attributes

Item attributes are named entities, whose values determine the qualities of a product item. You set these attributes when you create or update items.

Types of Item Attributes

The following types of attributes are available for an item:

- Main attributes
- Operational attributes
- User-defined attribute groups and attributes
- Additional item attributes

Main Attributes

Main attributes are common to all items. They describe essential aspects of the item. Examples of main attributes are:

- Item Number
- Description
- Long Description
- Status
- Lifecycle Phase
- User Item Type
- Approval Status
- Revision
- Pack Type
- Item Class
- Unit of Measure (a group containing eight attributes)

Operational Attributes

Operational attributes are part of the item's data. They determine the behavior of the item with respect to various applications outside Oracle Product Management, such as Oracle Purchasing or Oracle Inventory Management. You choose the control level for operational attributes on the Manage Operational Attributes Control page. For each listed operational attribute group, you select the control level for each of the group's attributes. You can control the operational attributes at the master organization level or at the organization level. You can define operational attributes as part of a new item request if you've the privileges.

User-Defined Attribute Groups and Attributes

You can define attribute groups and attributes to capture item specifications and other information relevant to a product's definition that you want to add to the item's data. Values for such user-defined attributes are defined when you create the item but can be changed over the life cycle of the item.

Oracle Fusion Cloud Applications uses the structure of extensible flexfields to support attribute groups (using flexfield contexts) and attributes (using flexfield segments).

You create attribute groups and attributes on the Manage Attribute Groups page, where you create an attribute group for a set of one or more attributes and then create the attributes in the context of the attribute group.

You select the behavior for the attribute group as multiple-row or single-row, which affects the later display and use of the attributes, as described in the later part of this topic. If the behavior you chose for the attribute group is multiple-row, then the attribute has multiple values each represented by a row in a table whose columns are context-based segments (attributes).

For each attribute, you select the data type and related validation and display options. The attribute groups are then accessed as sections listed on the **Attributes** tab of the Edit Item page. You also map the attribute to a column in a dedicated database table.

After you've created attribute groups and attributes, you associate user-defined attributes with items by adding attribute groups to item classes, on the Pages and Attribute Groups tab of the Edit Item Class page. When an item is created, it inherits the attributes from the attribute groups associated with the item class on which the item was based.

User-defined attributes are based on extensible flexfields. Create an attribute group to determine which attributes are used at runtime. Extensible flexfields or user-defined attributes aren't available to customers who only license Product Model.

User-defined attributes can have a static or dynamic list of valid values, or a range of values. You can define the values for user-defined attributes when you create the item, and the values remain the same for the life cycle of the item.

You can save user-defined attributes within attribute groups. You can associate user-defined attributes with items by adding attribute groups to item classes.

For example, items that are part of the Small Gasoline Engines item class include the following specifications:

- RPM
- Power
- Oil and fuel mixture
- Weight

You can define an attribute for each of these specifications and then group these attributes together as the Engine Performance attribute group.

You can create attribute groups on the Manage Attribute Groups page.

Note:

- Avoid creating similar names for the item class and flexfield attribute groups. Distinct names help ensure that rules run without error.
- Avoid using Item Category in the Display Name and API name fields for extensible flexfields and extensible flexfield attribute groups created on items.
- For user-defined attributes, you can optionally define validation rules to be applied when the user inputs data.
- When you create an attribute group, make sure you specify the API name.

An attribute group can be a single row, multirow, or variant.

Multirow attribute groups enable you to associate multiple sets of attribute values with the same object instance. It gives you the ability to store multiple additional attributes that are dependent on the item, organization, attribute group, and a unique value within the attribute group. For example, if your item is a book, you can create an attribute group named Chapters that contain the following attributes:

- Chapter number
- Name
- Number of pages

You can associate multiple rows of Chapters with a book, while Name and Number of pages require a single row each. The Chapter number attribute is identified as a part of the unique key.

Note: Don't add more than 20,000 rows of data to a multirow attribute group for a single item. For optimal performance, it's recommended not to add more than 1000 rows. If you've to add more rows, consider configuring additional multirow attribute groups or custom objects.

After you create the attribute group and attributes, perform these tasks to complete the extensible flexfield setup:

- Associate the attribute to the item class using the Manage Item Class task.
- Deploy the attribute using the Deploy Item Extensible Flexfields task.

Tip: Sets of user-defined attribute groups can be organized on a single page that can then be linked from the Attributes tab.

Multiple-Row Attribute Groups

Attribute groups can be either single-row or multiple-row. The selected behavior determines how the attributes will be displayed in the user interface and how they're used. When you create an attribute group on the Manage Attribute Groups page, you select its **Behavior** as being **Multiple Rows** or **Single Row**.

A single-row attribute group contains a collection of attributes that will be displayed as separate fields in region named for the attribute group. For example, a single-row attribute group named Home Address contains the attributes appropriate for a home address. Another single-row attribute group named Work Address contains similar attributes appropriate for an office address. When these attribute groups are displayed in the user interface, the attribute fields for each group are arranged compactly within a region titled with the name of the attribute group.

The following figure shows the compact user interface layout for the single-row attribute groups named Home Address and Work Address.

Home Address

In a multiple-row attribute group, the attributes are displayed as columns in a table that represents the attribute group.

Each row of the table is considered to be an attribute in the attribute group. The collective set of values contained in a row is considered the meaning of the attribute. The table is displayed in the user interface within a region titled with the attribute group name. No other fields are displayed in the table. For example, a multiple-row attribute group named Payments contains the attributes Date, Invoice No., and Amount. Each row of the table describes a payment, and is a value of the Payments attribute group.

Date	Invoice No.	Amount
3/4/11	A-1000-0346	\$1000.00
3/5/11	A-1500-2780	\$295.00
4/16/11	A-2300-0022	\$457.34

The following figure shows the tabular user interface layout for the multiple-row attribute group named Payments.

Additional Item Attributes

You can create additional information attributes, which are based on descriptive flexfields rather than extensible flexfields. Descriptive flexfields can only have one context available at a single time, while extensible flexfields can have multiple contexts available. If you only need a single category and usage, then descriptive flexfields are sufficient. You create descriptive flexfields using tasks in the Setup and Maintenance work area. For example, use the task Manage Catalog Descriptive Flexfields to define descriptive flexfields for catalogs. The Additional Information region on the

Specifications tab of the Edit Items page then displays the flexfield context segments based on the current value of the context.

Additional item attributes are based on descriptive flexfields and are used to capture detailed information about an item, such as characteristics and specifications, and business process information.

Descriptive flexfield definitions for additional attributes include the name of the attribute and attribute values.

Additional attributes are associated with items or item revisions and are listed in **Additional Attributes** on the **Attributes** tab within an item.

The Completeness Score indicates the percentage of completeness for an item and it's based on the values that are returned for specific attributes. This will appear based on the rule that your administrator configures.

Interdependent Item Attributes

Certain attribute values depend on other attribute values. For example, **Planning Method** must be **Not Planned** if **Pick Components** is set to **Yes**.

These interdependencies may be between attributes within the same specification group or between attributes in different specification groups.

Here's the table that lists the item attribute interdependencies.

5 Item Variants

Overview of Item Variants

An Item Variant is a specific version of a base item. You can manage different configurations of an item with slight differences in characteristics, such as size, color, or packaging.

When you create an item, the **Style Item** option is available for item classes that have the variant attribute group set up. Enabling this option indicates the item is a style item.

When the item has the **Style Item** option enabled, a new tab called **Variants** is available for style items. On this tab, you can create and manage the variants for the style item. You can also perform the following:

- Select Views to see additional attributes for product variants. Views defined in the Product Management work area and Product Search task flow are available for selection.
- Filter the product variants using the search and the suggested filters. Variant attribute suggested filters are available along with the suggested filters defined for the views.
- Freeze and unfreeze columns on the variant grid.
- Export the displayed results from the grid to an Excel file and save it to your system.

1. In the Product Management work area, open the style item for which you want to add a variant.
2. On the **Variants** tab, click **Add**.
The Select variants values drawer displays all the required variants attributes.
3. Each variant attribute has a multi select list. Select the required combination and click **Continue**.
4. Based on the variant values selected, two sections are available in the **Review and edit variant combinations drawer**:
 - **New variants:** Lists the new variant attribute combinations. Provide all the required information.
 - **Existing variants:** Displays variant attribute combination that already exist. Use the Views to analyze more details for these combinations.
5. Use the guided task sequence on the top and click **Select variant values** if any changes are required for the selected variant values.

6. After you provide the required information, click **Create**. The variant is created and a confirmation message is displayed.
7. Click the **Refresh** icon momentarily to view the created variants.

Delete Variant

You can delete a variant using deletion groups only.

To delete an existing variant for a style item:

1. In the Product Management work area, open the style item for which you want to delete a variant.
The Add to deletion group drawer is displayed.
2. On the **Variants** tab, select the variant, and click **Delete**.
The Select variants values drawer displays all the required variants attributes.
3. Do one of the following options:
 - o Select **Add to existing deletion group** and then select a deletion group from the drop-down list.
 - o Select **Add to new deletion group** and then specify the name and the description.
4. Click **Save and Edit**.
The variant is added to the specified deletion group.

Convert Item to Variant

To convert a standard item to a variant for a style item:

1. In the Product Management work area, open the style item for which you want to add a variant.
2. On the **Variants** tab, from the **Actions** menu, click **Convert Item to Variant**.
The Select item drawer is displayed.
3. Select a standard item from the same item class and click **Continue**.
4. Assign attribute values to the selected item (if missing) and click **Continue**.
5. If the variant combination already exists, the Change variant values message appears. Click **Change Values** to correct the variants values in the Assign attribute values drawer or click **Cancel** to stop the process.

6 Item Relationships

Overview of Item Relationships

Item relationships enable you to relate your internal item with another item or reference the item with a Global Trade Item Number (GTIN), source system item, or cross-reference.

Types of Item Relationships

The types of item relationships are:

- **Trading Partner Item Relationships:** A relationship between an item and a trading partner item such as a customer, competitor, supplier, or manufacturer.
- **Related Items:** A relationship between two items.
- **Links:**
- **Global Trade Item Number (GTIN) Relationships:** A relationship between an internal item and Global Trade Item Number.
- **Cross-Reference Relationships:** A relationship between items and entities, such as old item numbers.
- **Spoke System Item Relationships:** A relationship between an internal item and spoke system item that enables you to map and identify items that have been consolidated from multiple source systems into a single master item.

You can view, create, edit, and delete item relationships when creating or editing an item. Click the **Relationships** tab for managing item relationships for a particular item.

You can search for different relationships for an item on the **Relationships** tab using the **Search** field. Use the suggested filters to view a specific type of item relationship.

To edit an item relationship:

1. On the **Relationship** tab, click the **Edit** icon in the **Action** column for the item relationship that you want to edit. A drawer appears on the right side.
2. Modify the required fields and click **Update and Close**. You can also edit more than one relationship at a time using the navigation arrows on the drawer.

To delete an item relationship, select the item relationship that you want to delete and click the **Delete** icon. You can delete only one relationship at a time.

Trading Partner Item Relationship

You can create the following type of trading partner item relationships for trading partner items:

- Customer Item Relationships: Used to associate an internal item with one of your customer items.
- Competitor Item Relationships: Used to associate an internal item with one of your competitor items.
- Manufacturer Item Relationships: Used to associate an internal item to a manufacturer item.
- Supplier Item Relationships: Used to associate an internal item with your supplier item.

For each trading partner item relationship, you can define its status as Preferred, Alternate, or Obsolete. You can also create trading partner items on the **Relationships** tab.

Create Trading Partner Items

Trading partner items are external to the Product Management application.

To create trading partner items, you must have a data grant for the trading partner items with the View and Maintain privilege (if data security is enabled).

To add a trading partner item to Product Management:

1. On the **Relationships** tab, in the Trading Partner Items region, click **Create Trading Partner Item**. The New trading partner item drawer is displayed.
2. Provide the following details:

- **Trading Partner Type:** Select Customer, Supplier, Manufacturer, or Competitor
- **Trading Partner Name:** Trading partner for the trading partner item
- **Trading Partner Item:** Trading partner item number for the row
- **Start Date and End Date:** Provide the date range for the trading partner item
- **Status:** Select **Active**, **Inactive**, or **Pending**
- **Description**

3. On the **Additional Attributes** tab, provide the details for the descriptive flexfields.
4. On the **Attachments** tab, you can attach files, directly enter text, and provide URLs.
5. Click **Create** to create the trading partner item.

You can add the created trading partner item to the item by clicking the + icon in the Trading partner items section.

Create Trading Partner Item Relationship

To create a trading partner item relationship:

1. In the Trading Partner Items section, click the **Add** icon.

The New trading partner item relationship drawer is displayed.
2. Specify the following details:
 - **Trading Partner Item:** Select the trading partner item. Based on this selection, the **Trading Partner Type** and **Trading Partner Name** fields are populated.
 - **Relationship Status:** Select Preferred, Alternate, or Obsolete.
 - **Start Date and End Date:** Provide the date range for the trading partner item relationship.
 - **Competitor Item Type:** If you've selected competitor as the **Trading Partner Item**, then select the following:
 - Complimentary
 - Equivalent
 - **Rank:** If you've selected customer as the **Trading Partner Item**, then optionally specify the rank.
 - Relationship Description
 - Additional Attributes
3. Click **Create**.

The trading partner item relationship is created and displayed in the Trading partner items section.

Manage Links Between MPN Relationships and Supplier Item Relationships for an Item

You can create and manage links between Manufacturer Part Number (MPN) relationships and supplier item relationships for an item. The allowed linking is N:N. You can link one MPN relationship with one or more supplier item relationships and link one supplier item relationship with one or more MPN relationships. It helps to increase tracking and allows for a more robust digital thread among your product number, supplier part numbers, and manufacturing part numbers.

You can set one of the linkages of an MPN relationship or a supplier item relationship as primary. The reciprocal of the linkage will also be considered as primary.

Notes:

- The feature is available only for manufacturer and supplier relationships; customer and competitor relationships aren't applicable for this feature.
- You can link multiple supplier items belonging to the same supplier with an MPN and vice versa.
- Linkage for trading partner item relationship is currently supported only on the Edit Item page.
- You can't delete an MPN relationship or a supplier item relationship that has a linkage present. You must first delete the corresponding linkages before deleting the parent relationship.
- You can publish, audit, and report the links between the manufacturer part number relationships and supplier item relationships for an item.

To link MPN and supplier item relationships:

1. Browse to the item for which you want to create a link between the MPN relationship and supplier item relationship.
2. On the Edit Item page, click the **Relationships** tab.
3. To link a Manufacturer Part Number to a supplier trading partner item relationship:
 - a. In the Trading partner items section, in the **Links** column, click the **Link** icon for a supplier trading partner item relationship.
The Link manufacturer part numbers drawer is displayed.
 - b. In the **Manufacturer Part Number** column, from the drop-down list, select a manufacturer and click the **Apply** icon in the **Actions** column.
 - c. Edit the row and select the checkbox in the **Primary** column to mark the linkage as primary.
 - d. Click **Save and Close** to save the changes and close the drawer.
4. To link a supplier part number to a manufacturer trading partner item relationship:
 - a. In the Trading partner items section, in the **Links** column, click the **Link** icon for a manufacturer trading partner item relationship.
The Link supplier part numbers drawer is displayed.
 - b. In the **Supplier Part Number** column, from the drop-down list, select a supplier and click the **Apply** icon in the **Actions** column.
 - c. Edit the row and select the checkbox in the **Primary** column to mark the linkage as primary.
 - d. Click **Save and Close** to save the changes and close the drawer.

Related Items Relationship

When creating or editing a related item relationship for an item, you can specify whether the related item relationship must be controlled at the master organization level or at an organization level.

When you navigate to the Related Items section for the organization item, you can find any org-specific relationships and the master- controlled relationships inherited from the master organization. If a relationship is controlled at the master organization level, then it means that the relationship is applicable to all the child organizations to which both the FROM and TO items are assigned. Any changes to the item relationship will be inherited by all child organizations.

You can filter the list of related item relationships based on the following options:

- Click **Reciprocal** and select **Yes**, **No**, or **All**.

- Click the **More Actions** icon and select **Relationships** as **Forward, Derived, or All**.

There are several predefined related item relationship types available. To create your own types, an administrator can create additional types using the **Manage Related Item Subtypes** task in the Setup and Maintenance work area.

If cyclic relationship isn't allowed for a relationship type, you must use the import process to create a master-controlled relationship of this type.

Before this enhancement the audit log value for the **Controlled-At** field was **Null**. So, the records created before the enhancements shows the **Null** value in the audit. This is equal to the **Master-level** value for the **Controlled-At** field.

Optionally, you can specify the rank for the related item relationship. Rank must be unique for a combination of From item and the relationship type. For example:

- From item X to item Y, Substitute type of relationship - Rank 1
- From item X to item Z, Substitute type of relationship - Rank 2
- From item X to item Y, Cross-sell type of relationship- Rank 1

Note: Rank-uniqueness validation is enforced across the org-controlled relationships and the relationships inherited from the master organization.

Predefined relationship types are listed in the following table.

Relationship Type	Definition
Accessories	This indicates the item is an accessory of another item.
Collateral	This relationship indicates collateral, such as marketing brochures, that you've for an item.
Complimentary	This relationship indicates if a customer buys one item, the other item is received for free.
Conflict	This relationship indicates that these items might never be used together.
Cross-Sell	This relationship indicates that one item might be sold instead of another item.
Extended Warranty	Indicates if the item has an extended warranty.
Fulfillment	Indicates if the item is a fulfillment item.
Impact	This relationship is used to relate items to each other, but only under special conditions.
Mandatory Charge	This relationship indicates a mandatory charge if a customer buys both items.
Merge	This relationship enables rules based on the consolidation of contracts. You might use the earliest or latest target end date for consolidation. This enables you to choose how contracts are consolidated.
Migration	During contact renewal you're given the option of renewing contracts based on new licenses, or old licenses.
Optional Charge	This relationship indicates an optional charge if the customer buys both items.
Prerequisite	This relationship indicates that you must mark one of the items as a requirement to using the other item.
Promotional Upgrade	This relationship enables a customer to upgrade from one item to another item or equal or higher value, without an additional charge.
Regulatory	This type relates a regulatory item with the context item.

Relationship Type	Definition
Related	The items are related in a nonspecific way.
Repair To	You use the Repair To item relationship with field service operations that use spares management functionality. If a part has been superseded by another part, the Repair to item relationship determines the replacement part.
Service	This relationship establishes service items for a repairable item.
Split	This relationship enables you to split support for an item so you don't have to manually split support at contract renewal.
Substitute	<p>One item is a substitute for another.</p> <p>You can't add a dual UOM item as a substitute of a non-dual UOM item and in reverse.</p> <p>If the item has dual UOM, then make sure that the respective primary and secondary UOMs of the dual UOM item and its substitute are the same.</p> <p>Note: These validations are enforced in the respective organizations. The validations make sure that the respective primary and secondary UOMs of a dual UOM item and its substitute are the same in the respective inventory organizations.</p>
Superseded	This relationship indicates that one item has replaced another item that's no longer available.
Upsell	This relationship indicates that a newer version of the item exists, and can be sold in place of the older item.
Warranty	This relationship enables you to relate a warranty item with the item.

Note: Your system administrator can set up additional relationship types based on your business needs.

Create Related Item Relationship

To create a related item relationship:

1. In the Related Items section, click the **Add** icon.

The New related item relationship drawer is displayed.

2. Specify the following details:

- o **Related Item:** Select the item to which you want to create the relationship.
- o **Type:** Select any of the predefined relationship type.
- o **Rank:** Specify the rank
- o **Start Date and End Date:** Provide the date range for the related item relationship.
- o **Relationship Description**
- o **Additional Attributes**
- o Based on the **Type** of the related item relationship, specify the following:
 - **Reciprocal:** Indicate whether the item relationship is reciprocal.
 - **Planning Enabled:** When the item relationship type is substitute or superseded, indicate if planning is enabled for the substitute item or superseded item, respectively.

3. Click **Create**.

The related item relationship is created and displayed in the Related items section.

Cyclic Relationships

Cyclic relationships can also form in chains of relationships. For example, assume that Item A has a Substitute relationship to Item B, and Item B has a Substitute relationship to Item C. If a user tries to create a new Substitute relationship from Item C to Item A, that forms a loop.

By default, cyclic relationships are allowed. You can disallow cyclic relationships for a relationship type by using either of these methods:

- Setup: Use the Manage Related Item Types task in the Setup and Maintenance work area
- REST: Use the Related Item Types REST resource

Procedure Using Setup

To disallow cyclic relationships for a relationship type:

1. In the Setup and Maintenance work area, use the **Manage Related Item Types** task:
 - Offering:Product Management
 - Functional Area: Items
 - Task: Manage Related Item Types
2. On the Manage Related Item Types page, select the relationship type. You can enter a type name in the filter field to narrow the list of available types.
3. In the **Allow Cyclic Relationships** column for the relationship type, click the toggle control.
A message informs you whether cyclic relationships are now disallowed or allowed for the selected relationship type. You don't need to explicitly save your selections.
4. To return to the setup page for the Product Management offering, click the **Parent page** control in the page header.

Procedure Using REST

To disallow cyclic relationships for a relationship type:

- Use the Related Item Types REST resource to specify the relationship type and set the value of the property `cyclicRelationshipFlag` to `false` for that type. Example request body:

```

Example:

This example shows the effect of disallowing cyclic relationships on item maintenance:

1. Item AS54888 has an existing related relationship type of **Substitute** with item KM2584.
2. Disallow cyclic relationships for the relationship type **Substitute**.
3. User tries to create a related item relationship of type Substitute with the FROM item as KM2584 and the TO item as AS54888.

An error message informs the user that the relationship that's being created between items KM2584 and AS54888 forms a loop, and that the relationship type Substitute doesn't allow cyclic relationships.

Considerations

- Cyclic relationships for a relationship type are allowed by default until you explicitly disallow them:
 - By toggling the **AllowCyclic Relationships** control in the Manage Related Item Types task
 - By changing the **cyclicRelationshipFlag** to **false** with the REST resource
- The start date and end date of relationships (their effective range) is considered when determining whether a relationship is cyclic.
- Cyclic relationships can only be disallowed between relationships of the same relationship type. For example, if A has a Substitute relationship to C and you try to create a Cross-sell relationship of C to A, that's not considered a cyclic relationship.
- The Reciprocal setting isn't considered when checking for cyclic relationships.
- After you disallow a relationship type, you must query any existing cyclic relationships created before you disallowed and modify them to be valid. The following query example fetches all the existing relationships of type Substitute that are cyclic. You can substitute another relationship type, using the internal name of the relationship (which is '**Substitute**' in this example).

Links Item Relationship

You can create links item relationship for a document that includes links to other documents, items, change orders, change requests, problem reports, corrective actions, concepts, ideas, items, proposals, and quality actions.

To create a links item relationship:

1. In the Links section, click the **Add** icon.

The Create link drawer is displayed.

2. Select the **Object Type**:

- Change
- Concept
- Concept Component
- Corrective action
- Idea
- Item
- Problem Report
- Project Task

3. For **Name**, select the item you want to link to.

4. Select the Relationship Type:

- Fulfils
- Fulfilled by
- Impacts
- Impacted by
- Verifies
- Verified by
- Validates
- Validated by
- Tracks
- Tracked by

5. Click **Create**.

The links item relationship is created and displayed in the Links section.

Global Trade Item Number (GTIN) Relationships

You can create a relationship between an internal item and a Global Trade Item Number (GTIN).

When creating a GTIN Relationship, you must specify the Unit of Measure (UOM), and specify whether you're linking to a new GTIN or an existing GTIN.

You can associate the same GTIN with more than one item when the GTIN UOM and the item's primary UOM are the same. For example, when two or more items vary only by labels, you may want to use the same GTIN for those items. In such cases, you can create item relationships by associating the same GTIN to those items. To do this, you must enable the **Allow Multiple Item Relationships to Same GTIN** profile option in the **Manage Administrator Profile Values** task in the **Setup and Maintenance** work area.

You can use item rules to validate GTIN numbers:

- You can access the attributes of a GTIN relationship row (such as GTIN, UOM, or Party Type) by using the attribute group `[GTIN]. [GTIN Main]`. This attribute group is available to rule sets associated with an item class.
- You can define item rules using the functions `exists()` and `isNull()` to validate the presence of GTIN values.
- You can define item rules using the function `substring()` to validate the formation of GTIN values.

Create GTIN Relationship

To create a GTIN relationship:

1. In the GTIN section, click the **Add** icon.

The New GTIN relationship drawer is displayed.

2. Select one of the following:

• **New GTIN:** Lets you create a new GTIN and then link the item to this GTIN.

• **Existing GTIN:** Lets you link the item to an existing GTIN.

3. Specify the following fields:

• **GTIN:** Enter the GTIN number. If you've selected the **Existing GTIN** option, then select the GTIN to which you want to link the item.

• UOM

• Revision Code

• Party Type

• Party Name

• **Note:** If you've selected the **Existing GTIN** option, the **UOM, Revision Code, Party Type, and Party Name** fields are autopopulated.

• EPC or GTIN Serial

• Description

• Additional Attributes

4. Click **Create**.

The GTIN item relationship is created and displayed in the GTIN section.

Cross-reference Item Relationship

Cross-referencing an item with something like an old part number. While creating a cross-reference item relationship, you must first select a cross-reference type and then specify whether the relationship is applicable to all organizations or whether it specific to only a selected organization. If it's specific to one organization, select the organization.

The administrator creates cross-reference types using the **Manage Cross-reference Types** task in the Setup and Maintenance work area.

To create a cross-reference relationship:

1. In the Cross-references section, click the **Add** icon.

The New cross-reference relationship drawer is displayed.

2. Specify the following:

- Type: Select one of the following:
 - Charge Master
 - Old Item Number
 - Supplier Part Number
 - Golden Tax Adapter
- Value
- Applicable Organization
- Relationship Description
- Additional Attributes

3. Click **Create**.

The cross-reference item relationship is created and displayed in the Cross-references section.

Spoke System Item Relationship

You can create a relationship between an internal item and a spoke system item. This relationship is helpful in mapping and identifying items that have been consolidated from multiple source systems into a single master item.

To create a spoke system item relationship:

1. In the Spoke system items section, click the **Add** icon.

The New spoke system item relationship drawer is displayed.

2. Specify the following:

- Spoke System
- Item
- Description
- Start Date and End Date
- Additional Attributes

3. Click **Create.**

The spoke system item relationship is created and displayed in the Spoke system items section.

7 Item Associations

Overview of Item Associations

Organization assignments allow items created in a master organization to be used in other organizations, enabling you to control the visibility of an item in organizations.

For example, certain items might not be assembled, sold, or purchased in a specific organization.

Similarly, you can control specific attributes at organization levels. For example, an item can be sold in a specific organization (region) but not permitted to be sold in other regions. You do this by controlling this attribute at the organization level using the **Manage Operational Attributes** task. For more details, see Oracle Fusion Cloud SCM: Implementing Product Management Guide.

You can create and manage organizations associated with the item using the **Associations** tab of the item.

You can assign an item to various organizations. Also, you can apply templates and provide values for the primary attributes when assigning the item to the child organization.

When assigning an item to an organization, you can apply the required templates for the child organization item. The attribute values available in the templates are applied to the child organization item. You can apply templates associated with the selected child organization or the templates from the master organization.

Manage Item Associations

You can add, edit, and delete the assigned organizations for an item.

To manage the associated organizations for an item:

1. In the Product Management work area, search for and access the item whose associations you want to manage.
2. Click the **Associations** tab.
3. To assign an organization:
 - a. Click the **Add** icon.
The Add associations drawer is displayed.
 - b. Select the **Organization** that you want to assign to the item.
 - c. From **Apply Templates**, select the templates you want to apply to the item.
Note: You can't edit any attribute value.
 - d. Click **Add**.
The selected organization is assigned to the item and is displayed on the **Associations** tab.
4. To edit an assigned organization, click the **Edit** icon in the **Action** column.

5. To delete an assigned organization, select the organization that you want to delete and click **Delete**.
6. Click **Save** at the page level to save the changes for the item.

Manage Item Supplier Associations

Managing item supplier associations involves creating associations between items and supplier addresses for an item organization, updating these associations, and deleting the associations.

You create item supplier associations while creating or editing an item for an organization.

Note: Item supplier associations are only used for master data management. They're not used within supply chain or procurement transactions. For example, you can create an item supplier association in the Product Management work area for a supplier SUPPA123, after that supplier has been created in the Suppliers work area. But you can't use the item supplier association to provide the supplier and site information in the shipment details for a sales order from supplier SUPPA123 in the Order Management work area. You can use item supplier associations for reporting and supplier management, using the relevant Product Management subject areas within Transactional Business Intelligence.

Assign Supplier Organizations to an Item

To add a supplier association for an item:

1. In the Product Management work area, open the item for which you want to add supplier organizations.
2. On the **Associations** tab, click the **Add** icon in the **Supplier Organizations** section.

The Supplier addresses drawer is displayed.

3. Search for and select the supplier name, and then click **Add**.

The selected supplier addresses are displayed in the Supplier Organizations section.

4. Click **Save**.

The supplier organizations are saved in the item.

Temporarily Suspend Supplier Associations

Supplier associations are active, by default, but you can temporarily suspend associations. To do this:

1. On the **Associations** tab of an item, in the Supplier Organizations section, click the **Edit** icon for the supplier organization that you want to temporarily suspend.
2. In the displayed drawer, from the **Status** drop-down list, select **Inactive**, and click **Apply**.

In the Supplier Associations section, the **Status** column displays **Inactive** for the supplier organization.

Note: You can change the Supplier Organization to active status at any point by selecting the value **Active** from the **Status** drop-down list.

Specify a Primary Supplier Organization for an Item

You can choose a primary supplier for the item. There can be only one primary supplier for one item organization association.

To choose a primary supplier:

1. On the **Associations** tab of an item, in the Supplier Organizations section, click the **Edit** icon for the supplier organization that you want to set as primary.
2. In the displayed drawer, move the slider to the right for the **Primary** option and then click **Apply**.
In the Supplier Associations section, the **Primary** column displays  for the supplier organization.
3. Click **Save** to save the changes to the item.

Delete Item Supplier Associations

To remove an associated supplier organization from an item, on the **Associations** tab of an item, in the Supplier Organizations section, click **Delete** for the supplier organization that you want to remove. Click **Save** to save the changes for the item.

Difference Between Item Supplier Associations and Approved Supplier List

Item supplier associations indicate the supplier and address from where an item is supplied and the item organization to which it's supplied. You can create these associations when creating or editing an item in the Product Management work area.

The approved supplier list is where you define your approved suppliers, sites, and other information for procuring specified items. You create entries on this list using the Manage Approved Supplier List Entries task in the Purchase Orders and Purchase Agreements work areas. Suppliers are created in the Suppliers work area.

Use Workflow Approvals for Item Associations

In Product Management, you can route changes to the item organization associations or item supplier associations through a workflow approval process in two ways:

- Assign an item to a new or existing change order. The change order page is displayed. On the **Affected Objects** tab, click the item number to open the item within the context of the change order.
- Create a change order, add an item on the **Affected Objects** tab, and save the change order. Now, click the item that you added to open it.

In both the methods, the item page is displayed with a header titled **In the context of <change order name>**. Click the **Associations** tab, where you can add or update the associations. After you complete all the changes and click **Save**, the changes are saved as a redline in the change order. You can then submit the change order for approval.

8 Item Attachments

Overview of Item Attachments

An item attachment is unstructured information related to an item. Examples of item attachments include CAD drawings, test results, specification sheets, or URLs.

You can attach the following:

- Files from your desktop or a configured repository.
- Directly add text.
- URLs

Note: Executable (.exe) files aren't supported.

You can manage attachments for specific items or revisions of items, all the items for a master organization, or all the items for a specific organization.

Manage Item and Item Revision Attachments

You can add, edit, delete, and preview attachments for items and revised items on the Attachments tab of an item. You can also download the attachments.

To manage attachments for an item or item revision:

1. In the Product Management work area, search for and access the item whose attachments you want to manage.
2. Click the **Attachments** tab.

3. In **Item Attachments** or **Item Revision Attachments**, you can add attachments with the item or revision, delete attachments, or modify existing attachments.

When you add an attachment, select the file type and attachment category, and provide the description. The attachment categories listed in the **Category** drop-down list are restricted to those that are associated with the item class of the item.

Make sure that you don't inadvertently add the same attachment more than once. It's possible to add attachments with the same title, description, file, or attachment category to the same item or item revision.

Item attachments will be available for all the revisions of the item in a particular organization.

9 Structures and Structure Types

Overview of Structures

In Oracle Product Development, a Bill of Materials is called a structure.

When you add an item to a parent item, you create a simple structure. As items are added, the structure is always named and referred to by its top-level item.

A structure holds all the items and documents that make up an assembly or subassembly. Items and documents might be in the same structure; there's no restriction on the maximum or minimum number of either type of business object.

Any item on a structure might be associated with one or more manufacturer parts. On the Structure table, an icon next to an item indicates the presence of manufacturer parts. So, a structure populated with items will likely comprise associated manufacturer parts.

A document structure holds all the documents that make up a meaningful document, such as a specification for a product. When you add a document to a parent document, a simple structure is created. A structure of documents will be named and referred to by its top-level document. A document structure might be only one document.

Structure Types

Structures, also known as Bills of Material (BOM), are used to store lists of items that are associated with a parent item and information about how each item is related to its parent.

Supported structures are standard, model, option class, and planning. The type of structure that can be defined for an item depends on the value specified against the item's item structure type attribute.

Standard Structure

A standard structure is the most common type and lists the required components, the required quantity of each component, and information to control work in process, material planning, and other manufacturing functions. Examples include structures for manufacturing assemblies, pick-to-order bills, kit bills, and phantoms.

Model Structure

A model structure defines the list of options and option classes that you can select when ordering a product that can be configured. A model structure also specifies required components or included items that are required for each configuration of that model. You don't order or build the model itself; you order and build configurations of the model. A model structure can be either assemble-to-order or pick-to-order.

Option Class Structure

An option class is an item that groups optional components on a structure. An option class is an item that becomes a level in your model structure. Option classes can also have required components that apply for all of its options. For

example, when you order a computer, the monitor is an option class, and the specific type of monitor that you order is an option within that option class. An option class structure can be either assemble-to-order or pick-to-order.

Option class structures can contain standard components and options, as well as other option classes. You can structure any number of levels of option classes within option classes to create an indented hierarchy of choices. You can also specify a required component in an option class in the indented structure that would automatically be included anytime that you choose an option from that option class (or a lower-level option class).

Planning Structure

A planning structure is a structure that includes a percentage distribution for its components. The percentages associated with the components on a planning structure don't need to add to 100 percent. You can define alternate and common planning structures, where the structure that you reference as common must be another planning structure.

Planning items can be nested within one another any number of times. When you nest planning items, scheduling applications can explode forecasts level by level and apply planning percentages at each level.

Phantom Structure

A phantom assembly is a non-stocked assembly that lets you group together material needed to produce a subassembly. When you create a structure for a parent item, you can specify whether a component is a phantom. One structure can represent a phantom subassembly for one parent item, and a stocked subassembly for another parent item.

Work in Process applications explode through a phantom subassembly to the components as if the components were tied directly to the parent assembly. Work in Process applications ignore phantom assembly routings when you define a job or repetitive schedule.

You can compute manufacturing and cumulative lead times for phantom assemblies that have routings. If you don't want to offset the components of a phantom assembly in the planning process, exclude the phantom item from the lead time calculations.

In general, phantom assemblies act like normal assemblies when they represent a top-level assembly, such as when you master schedule them or manufacture them using a discrete job. As a subassembly, however, they lose their identity as distinct assemblies and instead represent a collection of their components. The components of the phantom subassembly are included on the job and on the pick list of the job, not the phantom itself.

Valid Component Attributes and Structure Types

Each structure can have many components. For each component, you specify attributes, such as operation sequence, item sequence, usage quantity, yield, supply type, supply subinventory and locator, and others.

The table lists component attributes and their validity for each type of structure.

Validation Rules for Structures and Components

Your ability to create, copy, or change structures is affected by a number of validation rules; predefined and user-configured.

How Structures and Components Are Validated

When you create, copy, or modify a structure, the following validation rules are applied:

- You can't add a component to a structure where the component item is the same as the parent.
- You can't add a component to a structure where the same component, with the same operation sequence and effectiveness, already exists on the structure.
- Lifecycle validation rules, when enabled, ensure that only components in the same lifecycle phase or higher lifecycle phase than the parent item can be added. The only exception is made for a deprecated lifecycle phase. Component items in this lifecycle phase can't be added to an effective structure.
- You can't add a component to a structure that's being referenced as a common structure from another organization, where the component doesn't exist in the other organization.
- You can't add components to common structures. Changes should be performed on the referenced structure only.
- For Assemble to Order (ATO), Pick to Order (PTO), and phantom structures where the parent item has Available to Promise (ATP) Components set to No, you receive a warning when you add a component that has either the item attributes Check ATP set to Yes or ATP Components set to Yes. The warning says "Order details for the parent item specify NO for ATP Components", but you can add the component.
- You can't add an optional component to a structure that's neither model nor option class.
- You can't add a component whose planning percentage isn't equal to 100 to a standard structure.
- You can't add a required component whose planning percentage isn't equal to 100 and that has the Forecast Control attribute set to Consume or None to a model or option class structure.
- When adding a component to a structure, Check ATP component attribute is set to No if the component quantity is less than or equal to 0.
- If the Use Placeholder attribute is enabled for the selected option class item, the item isn't loaded into the configurator model during structure import. A placeholder is created for the selected option class item in the configurator model when:
 - You select the check box for this attribute on the Edit Item Structure page.
 - You select **Yes** for this attribute on a change order.

You can replace the placeholder with the actual data during order import (when required).

Note: Routings-based validation aren't supported. The only check made is to ensure that an integer value is entered for the operation sequence.

Here is a guide to the various table values:

- Yes: You can add this component type to this structure type.
- No: You can't add this component type to this structure type.
- *: These components must be optional.
- **: These components are treated as standard subassemblies.

This table presents the validation rules used for adding components to different structure types.

Item and Operation Sequence

Item sequence indicates the sequence of an item on a structure.

Item Sequence

You can use item sequence to sort components on reports and when choosing options from a model bill in Oracle Fusion Cloud Order Management. The default item sequence value includes value of the highest existing component item sequence plus the value of the **BOM: Component Item Sequence Increment profile option**. If this profile option isn't set, the default is 10. You can override or change this number.

Operation Sequence

You can use the Routings form to assign operations to routings. Each operation must have a sequence number called the **Operation Sequence Number**.

On a structure, the operation sequence indicates the order in which you perform operations on a routing. You can configure the **Operation Sequence Numbers** to be generated automatically by using a user-defined increment factor. A profile must be created where you can indicate how much the **Operation Sequence Number** will increment every time a new operation is generated. You can change the generated value, if necessary, in the Routings form. Valid values range from 1 to 9999999.

You can assign any component to any operation on the routing, including all components to the same operation (such as the first operation). The planning process assigns material requirement dates based on the operations to which you assign each component.

You can define structures for items with or without routings. If you use routings, you can either define the structure first or the routing first.

With component-to-operation assignments, you can schedule and issue component material to the operation that requires the component on the exact requirement date. You can also assign the same component on the structure to different operations on the routing, with different usage quantities for each assignment.

If no routing exists for the item, all components default to operation sequence 1. You can't change this value until you define a routing for the item. After you define the routing, you can update your structure with routing operations, if you want specific component-to-operation assignments.

If you define the routing before you define a structure, assign components to valid routing operations or operation sequence 1 when you define the structure. If you define an alternate routing and then define the alternate structure, you can assign components to the alternate routing operations. If you define an alternate structure and no alternate routing exists, you can assign components to the primary routing operations.

10 Create Structures

How You Create Structures

A structure contains information on the parent item, components, attachments, and descriptive elements using descriptive flexfields.

Each standard component of a structure can have multiple reference designator and substitute components. Also, each component can have a different unit of measure.

A product manager or product data steward is normally responsible for defining and managing product (item) structures. Note that the terms product and item are used interchangeably.

Product structures can be created in various ways. If the new structure is similar to an existing structure, you may copy and modify this new structure. If the new structure is an exact copy of another structure and its assembly details need not be maintained separately, you can link the new structure to an existing structure by using the **Create from Common** option. Alternately, you can create a new structure by adding the required components and their information.

You can create structures from the Structure tab on the item. Use one of the following options in the **Actions** menu:

- **Create** - lets you create a new structure.
- **Create from Copy**
- **Create from Common**

Create as New Structure

Here's how you create a new structure:

1. Open the item in which you want to create the structure.
2. On the Structures tab, click **Actions > Create**.
3. In the Create New Item Structure dialog box, enter the details of the new structure:

- **Name:** Select the type of item structure.
- **Effectivity control:** Select the type of effectivity for the structure.

Date: Effective on a specified date.

Model or Unit Number: Effective based on unit number.

The options that appear in this list depend on the item for which you're creating the structure.

4. Click **Ok**.
5. In the Structure Details section, add the details of the structure and click **Save**.

Note: An item structure exists only in the organization in which it was created. To use a structure in another organization, you must either copy it or reference it as common.

Create from Copy

Here's how you create a structure by copying an existing structure:

1. Open the item in which you want to create the structure.
2. On the Structure tab of the item, click **Actions > Create from Copy**.

The Create New Item Structure from Copy dialog box appears.

3. In Existing Structures, select an item and its structure you want to copy.
4. In New Structure, enter the details of the structure you want to create.
5. Click **OK**.

The table shows whether the copy action is allowed based on the effectivity control settings in source and target structures.

Create from Common

When you create a common or referenced structure, the target structure will be created with the same effectivity as the source structure.

1. Open the item in which you want to create the structure.
2. On the Structure tab of the item, click **Actions > Create from Common**.

The Create New Item Structure from Common dialog box appears.

3. In Existing Structures, select an item and its structure you want to retain as the common structure.
4. In New Structure, enter the details of the structure you want to create.
5. Click **OK**.

Common Structures

If two or more organizations use the same item structure, you can define the structure in one organization and reference it from the other organizations, creating what's known as a common structure in those organizations.

Common structures share a component hierarchy, including the substitute components and reference designators defined for the components.

How Common Structures Work

Here are some things you must know about creating common structures.

When you create common structures, you can:

- Define a structure in one organization and reference it from other organizations, creating what's known as a common structure in those organizations, if two or more organizations use the same item structure.
- Reference another structure as a common structure only if the referenced structure has the same structure name.
- Reference structures only from organizations that have the same item master organization as the current organization.
- Create a common structure within the same organization, as well as across multiple organizations. Sharing structures across multiple organizations minimizes the maintenance of your item structures.
- Create component items in the target organization without any additional or explicit privileges. But you will require access to the root item in that organization.
- Create a common structure using FBDI only at the first level of the structure.

When you create common structures, you can't:

- Update the structure of common items in a common structure. However, you can update the fields and descriptive flexfields in the header for a structure that's common. Any maintenance, such as removing or adding components or changing component attribute values, has to be made against the source (referenced) structure.
- Reference another structure as common if that structure also references a common structure.

Substitute Components in Common Structures

Here are some things you must know about substitute components in common structures.

- When you use a structure as a common structure, the substitute components that you use for items in the source organization are automatically added to any target organizations where the component doesn't exist.
- Substitute components in the source organization are automatically added to target organizations when you:
 - Create a structure in the target organization using the Create from Common action.
 - Add a substitute to a component of a structure that's already used as a common structure.

- Once the organization is automatically assigned, you can't undo the assignment when the substitute component is deleted. You must manually delete the association.

Publish Common Structures

You can include common structures in item publications.

To publish common structures, you must select **Structures** as an entity of the item object to publish.

- If there are changes in the header details or descriptive flexfields for the common structure in an item, then any common structure is published.
- The master item and its structure are only published when changes occur to the item or structure content.
- If there are changes to the master structure, or to the header attributes of the master structure, then the item containing the master structure is published.

For example, if you add a new component to an item, the item record containing the structure for the master item is published.

- If there are changes to an item or common structure header, then the item is published.
- If there are changes to items that have common structure, or to the header attributes of the common structure, then the items that have common structure are published.

If there are no changes to the items, or to the header attributes, then the items aren't published.

- You can set the first level as common or specify the number of common levels starting from the first level.

Structure Details

This feature is available in both the classic user interface (pre-24A) and the new interface. You'll see Classic or New in the topic title for easy identification.

View Structure Details

Structure information is available as part of the item details. You can view structure details by navigating to item details and selecting the Structures tab.

All structures created for items are listed in the structure table within the **Item Structures** sub tab. Clicking the structure name enables you to drill into the structure details page to view the component information.

The Item Structure Details page shows multilevel structure components in a hierarchical table and provides you with a complete view of all the components and assemblies of the structure.

View the Item for a Particular Revision

To view the item for a particular revision, use **Actions > Open Another Revision**. The structure appears based on a reference date. The table shows how the default reference date differs based on the selected revision.

Selected Item Revision	Default Reference Date
Past effective	Revision end date
Current effective	Current date
Pending	Current date
Future effective	Future effective date

Here's some information on structures and components:

Date Filter

Enables you to see what the structure looks like at a given date.

Let's say that you enter 7/18/19 and click **Go**. Then it shows the structure as on 7/18/19.

Note:

You can't edit the component entities for a past date.

The Total Quantity in the summary table is calculated as a ratio of quantity to the yield factor.

Use Placeholder

The **Use Placeholder** column indicates whether a placeholder is set for the component. Here's what happens if the value is set to Yes:

- A placeholder is created for such items in the configurator model.
- The items aren't loaded into configurator models during structure import.

Note that:

- The Use Placeholder column is editable if **Structure Item Type** specification for an item is set to **Option Class**. You must also make **Component Order Management** fields visible from **Item Structure Details > View**.
- To change the placeholder value, on the **Actions** menu for a component select **Edit**. Select or deselect the **Use Placeholder** check box.
- You can replace the placeholder with the actual data during order import when required.
- The placeholder structure can be loaded on demand from the Configurator.
- The value for **Use Placeholder** attribute can be set from both the item context and the change order context.
- You can use SOAP and REST services to set or retrieve the **Use Placeholder** attribute.
- Import and FBDI support **Use Placeholder** attribute.

Change Control

The **Change Control** column indicates whether structure changes are allowed. Change control permission is based on the business rules written for the structure name. The change orders column presents the number of change orders pending for the structure. Structure details, including header attachments and configured attributes, are presented in the details region.

Find Number

You can differentiate duplicate components in an assembly using the Find Number attribute.

The find number identifies a specific instance of an item in a structure. When a duplicate component is added, the application will automatically increment the find number, but you can modify it before you save your changes. Once the item is saved, here's how you can change the find number:

Delete the component and add it again with the new find number.

Or

Use the **Replace** action to replace a component with the same component and provide a different find number.

Example: Consider that a server containing 4 similar processors is positioned at the same level in the structure. Each instance of the processor will have a unique find number. This will allow you to have duplicate instances at the same level in the BOM and differentiate each instance.

Here are some additional details:

- You'll be prevented from creating duplicate find numbers for Model and Option Classes. The **Find Number** column will be displayed and defaulted to 1. Also, you can't add the duplicate component row.
- You can't create overlapping effectivity dates for the combination of component and find number.
You must ensure that the date range of the duplicate component is outside the date range of the initial component. Note that the date range is calculated based on the start and end dates of the component.
- Attributes such as Quantity, Basis Type, and Supply Type can have a different value in the duplicate row. Similarly, structure entities such as substitute components and reference designators can also have a different value in the duplicate row.
- Find Numbers are automatically incremented when you add duplicate components in the user interface, but not when you update structures using REST services or import.
- In the item structure import, if the find number value isn't provided, it will be defaulted to 1. If you have a duplicate instance of the component in your structure, you must provide a unique find number value in import. In the absence of the unique find number, the import will create a single component with the find number value defaulted to 1 and the other components won't be created. This is applicable for REST APIs and SOAP Services as well.
- If you perform a **Replace** action to update the New Find Number value using import, it's recommended not to import changes to other attributes in the same import batch.

Here are the best practices and recommendations:

- All existing and new customers should use Item Sequence for sequencing the structure. It's recommended not to use Find Number for sequencing of the structure. Find number should only be used to include duplicate components in a structure.
- Agile PLM customers migrating to Oracle Fusion Cloud should map Agile PLM Find Number to Item Sequence.

- CAD integration customers should map Agile PLM Find Number to Item Sequence.
- Agile PLM MCAD customers using the find number feature must map Find Number to structure component descriptive flexfields.

Suggested Operation Sequence

You can use the **Suggested Operation Sequence** column to record a design engineer's suggestion for the operation sequence of components in a manufacturing work definition. This doesn't have a default value and isn't automatically incremented.

Note: Suggested operation sequence isn't a required value.

Example: In an assembly that includes 3 components, you can suggest an operation sequence for component A as 1, component B as 2, and component C as 3. The manufacturing team can refer to this to specify a sequence for assembly of components (in the manufacturing work definition).

Component Details

For each component in a structure, the component item and component information are provided in a component details region. To view component details, select the component. You can also view component details using the item search page available in Product Management Experience.

Click Tasks > Product Management Experience > Search Products.

Here's what you see in the Component Details region:

- **Substitutes:** Lists items that you can use in place of the component.
- **Reference Designator:** Lists the component placement during assembly.

- **Where Used:** Lists items based on the level in which this item is used in another structure.

Note that the following data security privileges are required to view the where used report: View Item Basic, Maintain Item Basic, and View Item Structure or Maintain Item Structure.

- Show Structure Levels:
 - First level: view first level of the structure in which the item is used.
 - level: view topmost level of the entire bill of material in which the item is used.
 - All levels: view all levels from the item to the topmost level in which the item is used.
- Show Items: Filter items based on their approval status in a change order.
 - Implemented: view items that are already effective.
 - All: view items that are effective and the items that are yet to go through change order approval.
- Include Substitute Components: Select Yes to identify where the item is used as a substitute component. Here are the important columns for substitutes:
 - Item: Shows the structure in which the context item is used as substitute. The number of structure levels shown in the item depends on what you select in the Show Structure Levels filter.
 - Substitute For: Shows the components for which the context item is marked as a substitute. Appears only if you select **First level** and **Include Substitute Components** filters.

Here are some extra details on substitutes:

- You can view substitute components only for first level structure in the UI and all levels in the OTBI report.
- The component number displayed in the **Substitute For** column is read-only.

When you click the information icon (orange triangle) on the item, a panel that includes links to item entities appears. Note that you'll only see items for which you're granted access.

- You can enable substitute component search by default using the profile option **Include Substitutes in Item Where Used Data**.
- When you select **Include Substitute Components**, the Where Used results are restricted to:
 - the master organization and primary structure in Product Development, and to the context item's organization in Product Information Management.
- You can perform a search on primary, alternate, or all structures based on the search filters in Product Information Management.
- The change order details report (in Product Development) includes the following substitute component attributes: Primary UOM, Enforce Integer Requirement, Priority, and Global descriptive flexfields.

- **Change Orders:** Lists pending changes for the component (item).
- **Additional Attributes:** Lists extra attributes and their values that you might have configured for the structure type and name.

Note: Only the first-level components can be managed from the Structure Details page.

Set Use-Up Date as the Effective Date

When you remove or replace a component, you can view and select a use-up date specified in a supply plan as the effective date for the affected object. The use-up date calculation helps you identify the optimal effectiveness dates for structure components that are being removed or replaced on engineering and commercialization change orders.

Here's how you set the use-up date when you remove (or replace) a component:

1. Click the Affected Objects tab on the change order.
2. Open the affected object that contains the component you want to remove (or replace).
3. Navigate to the Structure tab.
4. Select the component you want to remove and click **Actions > Remove**.
5. Click **Save and Close**.
6. Click **Actions > Calculate Use-up Date** on the Affected Objects tab.
The Select Use-Up date dialog box appears with the use-up dates defined in the referenced plans for the component (in the Supply Planning work area).
7. Select the use-up date and click **OK**.
The date you select is populated in the **Effective Date** column on the Affected Objects tab. If you manually update the effective date, any existing values for Plan Name and Use-Up Item are cleared out.
8. Save your changes.

Some additional considerations:

- The **Calculate Use-up Date** action is only visible if the **Supply Chain Planning** offering is enabled.
- If you've enabled **Supply Chain Planning** but aren't using Planning use-up dates, the **Calculate Use-up Date** action won't retrieve any use-up dates.
- The **Plan Name** and **Use-up Item** columns are hidden by default. You can use **View > Columns** to show these columns if you're using planning use-up dates.
- When you add the effective date using the **Calculate Use-up Date** action, the time is set to 00:00:00, because Use-up Date is a date-only attribute.
- The affected item's effective date automatically changes to Effective on Approval if the specified effective date is in the past by the time the final approver (for the final approval status) approves the change order. If this happens, the Plan Name and Use-up Item values are cleared out.
- If you update the affected object's lifecycle phase, you must first save the lifecycle phase change before updating the effective date using **Calculate Use-up Date**.

View Structures

You can create an item from the Product Management work area and build a structure or search for a structure and view the structure details with the component details appearing in the side drawer.

When you search for structures, you can view structure presence indicators (structure icon) that lets you access the item structure from the search results. You can create a structure by either selecting and adding existing items or creating new items. Here's how you access items.

Navigate to the Product Management work area and do one of the following:

1. Click **Items** from **Actions** on the Product Management Home Page

2. Select **Items from the Product Management Search drop-down list on the Product Management Search Page.**

When you navigate to an item and the structure tab within the Redwood page, you can create a new structure, modify the header structure, and delete an existing structure. After you create the header, you can build and modify the single-level structure by adding one or more components using the search and select icon in the toolbar.

Structure Details

Here's how you access and create a structure:

1. Open the item and navigate to the Structure tab.
2. Click the ellipses (...) button and click **Create Structure**.
3. In the New item structure drawer that appears, select any one of the options:
 - o Create new - using the Create new option, you can add Structure Name, Structure Description and the required details in Additional details field and click **Apply**.
 - o Create from existing - using the Create from existing option, you can either choose an existing structure or a new structure and fill in the required details and click **Apply**.
 - o Create from common - using the Create from common option, you can either choose an existing structure or a new structure and fill in the required details and click **Apply**.

Note: You can't add a parent component to a child component. This applies to both preliminary structures and affected item structures on engineering and commercialization change orders.

You can create items directly within the structure. When building your item structure, you can create new items or documents and add them as a component directly. It then becomes a part of the item structure, and you can edit or modify the component level attributes.

Note: Creating a new component is only supported for the single level structure.

You can drag and drop (select and move) items from the clipboard or spotlight in the navigator to create a structure. After you add the components, double-click the cell to modify the component level attributes and the component descriptive flexfields. You can use additional indicators to explore subassemblies.

When you select the component, you can:

- Refine your search using filter chips
- Multiselect the item components to add
- Search and select the components to add to a structure and perform a search for another component. You can also select a saved search.
 - o The count in the Add button shows you the number of components that you're adding. Click the **Show Selected** button to see the selected components.

Note: To save your search, you must first perform your search, apply the filters, then save your search as personal or system search.

After you add the components, you can modify the following:

- Component level attributes
- Component descriptive flexfields
- Reference designators

- Substitute components

Use **Filter** columns to narrow down the components that require review. The column filter icon appears when you hover over the column header.

Views in Structures

On navigating to the structure, you can choose to view the entire structure or focus on specific levels. The views that you can explore are:

- **Single level:** displays the single level view of all the structure components. Item structures are editable only in the single level. In this release you can create a new item or document and add it directly as a component while building a structure.
- **Multi level:** displays all the levels that are available for the structure components. You can't edit structures in the multi level view.
- **Hierarchy:** displays the details of all the structure components in a tree-format. In the hierarchy view that's available, you can view the entire tree of the structures in read-only mode with separate icons for parent subassembly, item, or document subassembly document, and document. This view is available in the change context and displays redlines for the first-level only. Filter the columns in the Hierarchy view to narrow down on components and focus on the most relevant ones.
- **Summary:** provides us with an aggregate of the components across the entire structure. The summary table contains the item attributes that you can configure for a new Task Flow view - Structure Summary. Click the View Details eye icon to see the detailed component-level attributes in the side drawer, which is the same as that visible when you select the single level, multi-level, or hierarchy views.

Edit Structures

Right-click the component row of a structure, to use the copy and paste attributes or use the keyboard shortcuts CTRL +C and CTRL+V for the same. You can only copy and paste the attributes that are edited inline and not the ones edited in the side drawer. If you copy consecutive cells that are read-only, only the editable cells will have its values pasted.

Modify single level structures with the spreadsheet-like functionality. Use the fill handle to copy values to multiple components. As in a spreadsheet, select a cell, grab the small square icon in the corner, and drag it in any direction - vertically, or horizontally to fill cells.

To perform bulk edits, select multiple cells and drag up or down (select and move in different directions). To quickly update cells, select multiple cells, right-click and select **Autofill**.

Double-click the descriptive flexfield attribute cell in a component row, which will open the side drawer and modify component descriptive flexfields. When you drag and drop (select and move) an item, remember that only the item is copied and not the structure child entities like component level attributes, reference designators, and substitute components.

Points to Consider

- If you haven't created a structure, you must first create the structure header. This enables the edit capabilities in the grid. Example: You must create a primary structure to add components.
- The primary structure is the default structure view when you navigate to the structure tab. If you've only created an alternate structure and not created a primary structure, you can see a 'No data to display' message when you navigate to the structure tab. Select the alternate structure from the drop-down list to view the components.

Where Used

You can also view the structure and where used report based on the selected context date. For structures, you can select the context date only for the current revision. Regardless of the component revision you choose, the where used report is derived based on the current revision.

- For structure, you can only select the date between the start and end revision date of the current revision.
 - If the current revision is the latest revision, then there's no end date.
- For where used, you can select past or future date.

On selecting **All** view and a specific date, the where used results will display the past, current, future effective, and future pending parent items from that date onwards.

Spotlight

You can add individual components or subassemblies to the **Spotlight** displayed in the Navigator for that transaction. After adding the components, you can (select and move) drag and drop them from the spotlight to another structure. The drag and drop feature is also supported from the clipboard. Select the items by selecting the checkboxes and drag (move) them to the structure tab. Use the **Replace** action to replace one component with another.

The spotlight includes reference designators, substitute components, component level attributes, component level descriptive flexfields when you drag and drop (select and move) the components directly to an item or to an item in change context. When you drag and drop (select and move) components from the spotlight and select the **Copy Details** toggle button, the component level attributes are copied.

You can undo the redlines of both saved and unsaved changes within an item's pending revision. This is applicable for the Structure tab in the change context. The **Undo Redlines** button is enabled when one or more redlined rows are selected.

Here are some actions you can perform from the structure grid:

- View details of the component on the header, including the lifecycle phase of the item and the revision.
- Create, modify, and delete the structure header.
- Create, modify, and delete the component and its child entities in the structure.
- Replace a component with another component.
- Select different views created by your administrator through **Configure Views**. The view can contain item operational attributes, item extensible flexfields, component level attributes, or component descriptive flexfields.
- Toggle between the single level, multilevel, and hierarchy views.
- View the levels displayed on a structure.
- View the progress indicator when the data is loading.
- Apply filters on the structure (filter supports item and item description).
- Export the selected columns and rows or all.
- Detach the table to view in full screen mode.
- Add component items to the clipboard and spotlight.
- Drag and drop from the clipboard and spotlight.
- View the total count of rows in the structure and the number of selected rows.
- Hide and unhide columns.
- Resize rows and columns.
- Sort columns in an ascending or descending order.

- Select multiple rows, columns, or cells.

Note:

- The Replace action is enabled only on a row that isn't modified, added, or deleted.
- When you initiate the Replace action, before saving, the row—including reference designators, substitute components, and descriptive flexfields—is read-only.

Reference Designators and Substitute Components

You can also add or modify reference designators and substitute components of a component which are additional attributes available in the structure grid. Use these attributes in existing views or to create new views. Select and click the data presence indicator on the reference designator and substitute component columns of a structure to view details in the side drawer. Separate tabs are available for reference designators and substitute components. Global descriptive flexfields are always visible for both reference designators and substitute components in the side drawer. You can modify the reference designator descriptive flexfields in the side drawer. Configure business rules on the standard attributes and descriptive flexfields of reference designators and substitute components.

To add reference designators, double-click the empty reference designator cell, which will open the side drawer. You can add a range, if the range indicator is configured in Manage Item Structure Type Details task, and comma separated values. For more details, see [Configure Reference Designator Options](#)

- Quantity Related: validates the component quantity against the reference designator values.
- Align Quantity: automatically calculates the quantity based on the number of reference designators and displays it in the quantity column for the component.

Search for the structure component based on the reference designator. However, remember to include the Reference Designator Search attribute in the views you create to search for components using the reference designator.

After you add the reference designators, you must click **Apply** so that they appear in the table. Modify the description by selecting the pencil icon in each row. You can navigate to the next component using the navigator icons in the side drawer and click the pencil icon to enable the edit mode. To modify an existing reference designator, double-click the cell to navigate to the side drawer and the pencil icon to switch to edit mode. You can only delete reference designators in the Details area of the side drawer for reference designators.

Note: If you've configured range indicators for reference designators before 24D, you must run the Product Management Search Ingest Job.

Use the **Enterprise Scheduler Service** job: **Product Management Search Ingest Job** to ingest the new range indicator and replace the existing range indicator:

- Ingest Object = Item Structure
- Object Type = Reference Designators
- From Date = Enter a date
- To Date = You can select the current date

After this job is completed, the **Enterprise Scheduler Service** job to run Bulk ingest to OSCS job starts automatically. When both jobs are completed, the range indicator will show the latest selected range indicator.

If the range indicator is enabled, you can see the configuration for quantity and the reference designators with the range indicator in the Reference Designator tab.

To add substitute components and descriptive flexfields, double-click the component cell which will open the side drawer. To modify and delete components, click the pencil icon next to the substitute component. You can search for the structure component based on the substitute component.

Side Panel View in a Structure

The drawer appears when you click the presence indicators on the rows of a structure and provides you more information about the structure (component details). You can quickly navigate to the next or previous component row details without closing the drawer using the navigation buttons displayed in the drawer region.

Here's the data you can view and actions you can take from the drawer:

Notes on the side drawer view:

- Has Pending Change: Displays only pending change orders and change requests, not the released changes.
- Has Quality Issue: Displays pending quality issues, quality actions, problem reports, and corrective actions.
- Has Relationships: Displays relationships added through the Product Development work area. When you click the concept component or the requirement specification that you added as a related object, the parent concept or requirement opens.
- Has Item Attachment: Displays attachments that you can download. You must select only a single row to download attachments. Selecting multiple rows will disable the Download button.

- Has Reference Designators: Displays all the details of reference designators. You can even search for specific reference designators.
- Has Substitute Components: Displays all the details of substitute components.

Compare Structures

You can compare two item structures—a baseline and another structure—using the Compare action on the Structures tab of an item.

The comparison results are shown with filters to help refine your view.

To compare structures:

- On the Structures tab of an item, click **Actions** (three ellipses button) > click **Compare**.
 - The Compare structures drawer appears.

You can select the values for the following attributes for both the baseline and the compared structure:

- Organization Name
- Item Number
- Revision Number
- Structure Type

When you click Compare in the Compare structures drawer, a single-level structure comparison is initiated across both the structures. Note that the columns in comparison results are based on the selected view.

Note:

- Only two structures and one level of the structure can be compared at a time.
- You can compare two structures and their components across different organizations, revisions, and structure types.
- You can compare components and their attributes side-by-side and scroll through the results both horizontally and vertically.

You can quickly determine the differences between the structures by using the filters such as **All**, **Differences**, **Added**, **Changes**, **Removed**, and **Unchanged** available in the comparison results.

- **All**: shows items that are similar in both structures, missing in the compared structure, highlights difference in the compared structure, and lists any items that are additionally available in the compared structure.
- **Differences**: shows items that are missing in the compared structure, highlights differences in the compared structure, and lists any items that are additionally available in the compared structure.
- **Added**: shows items that are additionally available in the compared structure.
- **Changed**: highlights the differences in the compared structure.
- **Removed**: shows items that are unavailable in the compared structure.

- **Unchanged:** shows items that are similar between both the structures.

You can search for a specific component (across both the structures) in the comparison results by entering the item number in the search box.

When you click **Detach** on the Compare structures page, the comparison results grid expands to an entire page, allowing a better view of the additional rows.

You can scroll through the results both horizontally and vertically and locate the specific cells that interest you.

The comparison results are highlighted with colored icons for better readability and understanding of the differences.

Note:

- If you have the same components on both the baseline structure and the compared structure, and if at least one of the attribute values present in the current view are different, an edit icon is displayed, and the differences are highlighted in yellow on the cell. The attributes include the Item Sequence.
- If a component exists in the baseline structure, but is missing in the compared structure, a plus icon is displayed with the row highlighted in green.

11 Manage Structures

Update Product Structures

Managing product structures involves updating the structure.

This includes adding or removing components in the structures, making changes to first-level component attributes, and maintaining substitute and reference designator information for first-level components. Managing product structures also includes deleting product structures that you no longer use.

Update Components

Structure component updates include the following actions:

- Add: Search for items and add them as first-level components to a structure.
You can't add duplicate components to a structure or a parent component to a child component using commercialization change orders.
You can add duplicate components to a structure if you opt in to the feature Add Find Number and Suggested Operation Sequence for Structure Components. This feature allows you to differentiate between multiple instances of a component within a structure using find numbers.
- Update: Select component rows and update their attributes. You can update multiple components with the same attribute changes using a single action.
- Delete: Remove the component from the structure permanently and integrate the component into a delete group. You must add the component deletion request to the delete group.
- Disable: Specify an end date to a component. You can also edit the component to specify the end date.

Update Substitutes

You can assign any number of substitute items to each structure component, and you can assign the same substitute item to more than one component. The substitute item quantity is the quantity needed to replace the full component quantity. The quantity can differ from the component usage quantity.

Planning bills and model, option class, and planning components can't have substitute components.

You can add substitute components with or without a change order. When you add the substitute component:

- in the change context - the organization is assigned only when the affected item is in the Completed status.
- through import - the organization is assigned on the completion of the job, or on the completion of the change order if the item is added to a change order.

You can't assign substitutes to inactive organizations.

Component Reference Designators

A reference designator is a sequence of comments and instructions that pertain to a component. For example, drawings that clarify the assembly process for certain components, or further instructions for the use of a large quantity of the

same component. You can specify whether to assign one reference designator for every usage of the component or assign more than one reference designator to the component.

You can indicate whether the reference designator is related to component quantity.

Planning bills and model, option class, and planning components can't include reference designator.

Component Item Usage

The Where Used tab enables you to view component item usage in other structures.

Replace a Component

You can replace a component in your item structure, copying over key data from the original component to the replacement component.

You can replace a component from:

- an item structure page in the Product Information Management work area
- a change order's Affected Objects Structure tab in the Product Development work area

How You Replace a Component

1. Depending on your work area, here's how you select the component you want to replace.

In Product Development,

- Open the change order that contains the component you want to replace.
- Click the Affected Objects tab and select the component you want to replace.

In Product Information Management,

- Open the item that contains the component you want to replace.
- Click the Structures tab and select the component you want to replace.

2. Click **Actions > Replace**. You can also use the **Replace** icon on the toolbar.

3. Search for and select the replacement component.

The original component is redlined and the replacement component appears in green (which is different from the initial color). The original component also appears in the **Replaces** column for your reference.

End date of the original component becomes the start date of the replacement component.

4. Save your changes.

In the Product Information Management work area, you can save your changes to the item or save the changes to a change order and route it for approval.

How Start and End Dates are Derived

The table lists how the start and end dates are derived upon replacement.

In Product Development	In Product Information Management
<p>Upon replacement, the end date of the original component and the start date of the replacement component will be the same as the effective date of the affected object.</p> <p>If the affected object is effective on approval, this will be the date when the change order is moved to Scheduled status.</p> <p>If the affected object has a future effective date, this will be the same as the effective date.</p>	<p>Upon replacement, the end date of the original component and the start date of the replacement component will match the date in the Date field on the toolbar of the item structure page.</p> <p>If a replacement is to be effective only in the future, select a future date in the toolbar and then perform the Replace action. The replacement is visible in the structure when the date selected is after the start date of the replacement component.</p>

What's Copied Over to the Replacement Component

When you replace a component, item sequence, structure component attributes, substitutes, and reference designators are copied over from the original component to the replacement component.

Here are the attributes that are copied over:

- Component UOM

Substitute Components

- Item
- Description
- Primary UOM

- Quantity
- Inverse Quantity
- Priority
- Enforce Integer Requirement
- Descriptive flexfields

Reference Designator

- Reference Designator
- Description
- Descriptive flexfields

Considerations for Replacing Components

The table shows considerations for replacing components based on the work area.

Perform Guided Task Flow to Mass Replace Components

You can perform a mass replacement of components across multiple structures using a guided task flow. Your administrator can configure the guided task.

You can view all the items where a component is used and replace it with a different component across one or more selected structures. Here's how:

1. On the **Tasks** panel tab click **Perform Guided Tasks**.
2. On the Explore page, search for a component replacement journey and select it or select a component replacement journey appearing on the page.
3. Click **Start This Journey**.
4. Search and select the original component you want to replace and the replacement component. Click **Done**. During the selection, the components will be filtered based on the organization selected in the configuration.
5. Select for one or more structures from the where used list that shows where the original component is used. You can refine the search within the displayed list, if the list returns too many results. Click **Done**.

Notes:

- o If the replacement component is configured to be routed through an engineering change order, the search results will only include engineering structures created in the Product Development work area.
- o If the replacement component is configured to be routed through a commercialization change order, the search results will include commercial structures created in the Product Information Management work area and engineering structures in the Prototype or Production lifecycle phases. The results will exclude Packaging Structures.
- o If the replacement component isn't configured to be routed through any change order at all, the search results will include both engineering structures and commercial structures.

6. Review the summary of the selections from your previous tasks and click **Done** to submit the mass replacement action.

Notes:

- o You can create a new engineering or a commercialization change order. You also select an existing change that's in the Draft or Open status.
- o Depending on the configuration of the guided task, the changes will be applied directly to the selected structures of the commercial items or added as affected items to the change order through the scheduled process for engineering and commercial items.
- o When the scheduled process is complete, the change order is created in the open status. If the guided task isn't configured for the change type, then there's no need to select the change type or create the change order. The replacement will be made directly on the item.
- o When the components are replaced, the reference designators will also get replaced.

7. View the change order status.

You can view the details such as batch name, change order name, job ID, and job status.

Note: To view the status of the tasks on a later date, you can click the **View Guided Tasks** link in Product Management Experience in the Tasks panel tab.

Delete Structures

You can use delete groups to delete item structures or specific components within structures.

Deleting a structure or a component from a structure removes the record without any reference to its earlier usage or existence. When you delete an entire structure, you delete all the components for the assembly, along with their reference designator and substitute item.

When you delete a structure or component, that delete action passes through several deletion constraints and statements defined for structures. Additionally, you can define your own deletion constraints and statements.

Note: You're restricted from deleting a component (or its parent) if the item is released through an engineering change order, assigned to a pending change, or part of a canceled change. However you can delete components (and items) assigned to commercialization change orders and that aren't part of a structure on an engineering item using the delete group.

Define Deletion Constraints and Statements

Along with predefined deletion constraints, you can also define your own constraints using the Service Oriented Architecture (SOA) Business Process Execution Language (BPEL).

If what you're attempting doesn't pass deletion constraints, it's not deleted. For example, you can define a constraint that prevents you from deleting a structure for an assembly that includes an item in the active status.

12 FAQs for Product Bundles and Structures

What's a structure attachment?

When creating a structure, you can attach various documents pertaining to that item structure, such as drawings and reference materials. These attachments are available to view as part of structure header details.

What are item and component attachments?

Item and component attachments are attachments that you can view at the item level as part of the structure details view.

Only those attachments whose categories have been associated with the structure name will be available.

What's a substitute component?

Substitute components are items that can be used in place of a component.

You can associate any number of substitute items to each structure component and the same substitute item can be associated to more than one component. The substitute item quantity is the quantity needed to replace the full component quantity. The quantity can differ from the component quantity. Planning bills and model, option class, and planning components can't have substitute components.

How can I reinstate a parent item in a structure that contains obsolete components?

You must first reinstate the obsolete components and then reinstate the parent item.

How can I remove an obsoleted component from an item structure?

Change the lifecycle phase to Production and remove the component from the item structure. Then change the lifecycle phase to Obsolete.

To change the lifecycle in the Product Development work area you must create a change order and release it. But in the Product Information Management work area you don't have to create the change order.

What happens to structure creation if I enable lifecycle validation?

When lifecycle validation rules are enabled, they ensure that only components in the same lifecycle phase or higher lifecycle phase than the parent item can be added.

The only exception is made for a deprecated lifecycle phase. Component items in this lifecycle phase can't be added to an effective structure. For example, the parent item has lifecycle phases of Concept, Design, Prototype, Production, and Obsolescence. It's currently in Prototype lifecycle phase. When adding a component to this item's structure, the component should have a cycle phase of Prototype (same as the parent item) or Production (higher life cycle than the parent item).

What's a reference designator?

Reference designators are sequenced comments and instructions that pertain to a component.

For example, you may have drawings that clarify the assembly process for certain components, or further instructions for the use of a large quantity of the same component. You can specify whether to assign one reference designator for every usage of the component or assign any number of reference designators to the component. Planning bills and model, option class, and planning components can't have reference designators. You can also specify a comment for each reference designator.

What's a structure loop?

Structure loops occur when a structure is assigned as a component of itself somewhere in the multilevel structure of a defined item. By default, a check for structure loops is run when creating or editing a structure.

How can I compare item structures?

Initiate a structure comparison from the structure list table by selecting two structures to compare and then selecting component attributes.

Structure comparison results are presented in a hierarchical table with the selected structure component details. You can change the attributes or structures being compared quickly using the Actions menu.

How can I create development structures for an item?

You can create development structures in the Product Development work area.

Note that you can't create, edit, or delete development structures from the Product Information Management work area.

What's the difference between common item structures and copied item structures?

If you need to create an item structure that's very similar to an existing structure, then it's easier to copy the item structure and make the necessary modifications rather than create a new one.

If you need to create an item structure that's identical to an existing structure so that it doesn't require any component changes, then make the item structure common. This helps reduce maintenance and the risk of errors.

What happens if I associate an item attachment category with the item structure type?

If you associate an item attachment category with an item structure type, you can filter your view when viewing or managing item structures to reveal only relevant item attachments.

From the attachments available at the item or component item level, only those attachments that are of the specified attachment categories appear when viewing or managing an item structure.

What happens if I enable Use Primary for Expansion validation?

If you enable Use Primary for Expansion for alternate structures for a subassembly that doesn't have an alternate structure of the same name defined, its primary structure, if available, will be used when viewing a multilevel item structure.

How can I define additional attributes?

You can define additional attributes at the item structure header or component level using descriptive flexfields. Product Managers can capture the required information for these attributes when managing item structures.

What's the significance of start and end dates on a structure name?

Start and end dates signify the usage of a structure name. You can create a structure of that name for an item during that date range, but not outside that date range.

Note: Primary structures can't have an end date.

What happens if I select Default WIP Supply Value for Components?

If you select Default WIP Supply Value, and no supply value at the component level is specified, the default item-level work in process (WIP) supply value is used for the component.

How can I control the loading of item data into the configurator?

On the item structure, select the component, and click **Actions > Edit**. In the Edit Components dialog box, select the **Use Placeholder** check box.

In a structure, how can I manage mismatches in lifecycle phase?

To manage the lifecycle phase for a structure type, use the **Enable Lifecycle Phase** option available in the **Manage Item Structure Type** task.

To access the **Manage Item Structure Type** task, navigate to the **Setup and Maintenance** work area. Select the **Product Management Offering, and Structures** functional area.

Select the **Enable Lifecycle Phase** option to manually correct any mismatches in lifecycle phase. Deselect the option to allow creation of item structures with components at a lower lifecycle phase than the parent item.

The changes you make to the **Enable Lifecycle Phase** option don't impact existing structures. For such structures you must manually correct the mismatches in lifecycle phase.

Why are the Operation Sequence and Material Control attributes unavailable in item structure?

Operation Sequence and Material Control attributes such as Sub Inventory and Locator have been removed from the **Product Information Management** work area; they're available in the work area named **Work Definition**.

But you can view similar values defined at the item level. To do so, select the item structure and view the values for the attribute group named **Work in Progress**.

13 Item Packs

Pack Types

Pack types, also known as trade item unit descriptors, are used to describe the Global Trade Item Number (GTIN) hierarchy level.

Hierarchy is used to establish relationships between different levels of an item's supply chain. For information on trade item unit descriptors, see the [GDSN Trade Item Implementation Guideline](#).

Manage the Packaging Hierarchy

You create a packaging hierarchy to define the various pack configurations in which you can package a base item.

For example, you sell flash memory sticks (the base item, VI11416) in packs of 3 at retail stores, but ship 20 of the 3-packs in a case to the store. The packaging hierarchy looks like this:

- Case: Item = Case1_VI11416
 - Pack or Inner Pack: Item = Pack1_VI11416, Quantity = 20 Each
 - Base Unit or Each: Item = VI11416, Quantity = 3 Each

A packaging hierarchy can have any number of levels. The pack type defines each level in a hierarchy. The pack types used in the above example are Case, Pack or Inner Pack, and Base Unit or Each. The pack type of any item above the base unit or each level is stored as the pack item's primary attribute Trade Item Unit Descriptor (TIUD). The base item defines the lowest level in a packaging hierarchy. A base item can belong to multiple pack hierarchies.

The following pack type validations apply.

Pack Type (TIUD)	Description	Parents	Parent Instance	Children	Child Instance

Creating a Packaging Hierarchy

You can only create and update a packaging hierarchy in the item's master organization. Once you create the packaging hierarchy in the master organization, assign it to the child organizations.

To create a packaging hierarchy:

- Select Create Pack.
- On the Create Pack pop up, select an organization and select or search for your item.
- Select OK.
- On the Create Pack: Select Pack Type pop up, select a pack type and click OK.
- On the Edit Item page, Structures tab, Packs sub tab, review your pack and save.

FAQs for Item Packs

What's managing packaging information?

Managing item packs information is key to facilitating order and inventory tracking.

You manage packaging information using a hierarchical representation of items representing the logical structure of the product packaging needs. Each packaging level is modeled as an item so you can easily track inventory and orders against them.

What attributes participate in a rollup?

Item attributes can be rolled up from base items to higher pack items. This enables you to calculate the dimensions of higher pack items from lower pack items.

The attributes for which roll-ups are performed are:

- Quantity
- Weight
- Weight UOM

How can I create item packs?

Initiate pack creation for an item from regional task pane using create pack task.

Select an item within a master organization and specify a pack type for the item, if not defined. Select the **Packs** tab on the Item Details page to specify pack items. Based on the pack type of the selected item, you can associate child or parent pack items.

Select the **Create packs** action from the search results table. The Actions menu provides the ability to create multiple packs for all the selected items of type Base Unit or Each in a single flow. It enables you to create a representative pack structure which is then replicated for all the selected items, creating individual pack structures for each of the items.

The **Create Packs** page has three main regions:

- Items: The items selected in the search results table are presented in a table. You can add additional items or remove items from this table.
- Item Class: Enables you to specify the item class for the new pack items created based on the pack template.
- Pack Template: Enables you to define a representative structure to be duplicated for all the selected items. Each level defined represents a pack item. New pack items will be created based on the levels defined and the number of selected items.

After you save your pack, click next and assign your pack to an organization. Note, all child pack items of a selected row will be assigned to the specified organizations.

14 Item Categories

Overview of Item Categories

A category is a classification that's used to group items. For example, electronics, medical devices, and so on. An item can be assigned to one or more categories in multiple catalogs to classify or organize the items for use in various processes. You can assign the current item to categories using the **Categories** tab of the item. Assigning categories helps manage items more efficiently, and in alignment with business rules and reporting needs.

Manage Item Categories

You can view, assign, edit, and delete item categories on the **Categories** tab of an item.

You can search for different categories using the **Search** field. Use the suggested filters to view a specific item category.

Assign Item Categories

To assign a category to an item:

1. On the **Categories** tab for an item, click the **Add** icon.
The Add category drawer is displayed.
2. Search and select the category that you want to assign the item to and click **Select and Next**.
The Assign effective dates drawer is displayed.
3. Specify the **Start Date** and **End Date**, and then click **Assign**.

Note: Categories assigned to a functional area catalog don't use the **Start Date** and **End Date**.

The selected item category is assigned and displayed in the table on the **Categories** tab.

Edit Assigned Item Category

To edit an assigned category to an item:

1. On the **Categories** tab, click the **Edit** icon in the **Action** column for the category that you want to edit.
The Edit item category assignment drawer is displayed.
2. You can change the category that you've assigned, start date, and end date.
3. Click **Update** and then click **Update and Close** to save the changes and close the drawer. You can also click **Update and Next** to edit the next category that you've assigned.

Delete Assigned Item Category

To delete an assigned item category, on the **Categories** tab, select the category that you want to delete and click the **Delete** icon. Deletion of categories assigned to a functional catalog may not be allowed depending on the rules for the functional area.

Download Assigned Categories

To download the assigned categories to an Excel file, select the assigned categories and click the **Download** icon.

15 Item Quality

Overview of Quality Issues and Actions

The Product Information Management and Product Development work areas integrate with the Quality Management module to help you gain insight to quality issues and actions related to items.

A quality issue is a defect, deficiency, or a significant variation in a product's expected appearance or performance.

Feature for Product Development users.

Feature for Quality Management users.

A quality action is a necessary activity required to mitigate a quality issue and prevent its further occurrences.

Note: On opening an item in the Product Development work area, the Quality tab displays a blue icon, if the item has quality-related data. And on hovering over the Quality tab, the tooltip displays Quality: Has Content.

The Quality tab displays both these tabs:

- Quality Issues and Quality Actions
- Problem Reports and Corrective Actions.

Create Problem Reports and Corrective Actions

You can create problem reports and corrective actions from the:

- **Create (+)** menu on the Overview page in the Quality management work area
- **Actions** menu of an item in the Product Development work area
- **Actions** menu of an item in the Product Information Management work area

You can see that they appear on the Quality tab of items in the Product Development, Product Information Management, and Quality Management work areas. Remember that the **Create Problem Report** and **Create Corrective Action** options appear on the **Actions** menu only after you create and save an item.

For suppliers the page reloads with the newly created object.

Note: The newly created problem reports and corrective actions automatically display organization data from the item.

The workflow of a problem report or corrective action progresses as specified by the statuses defined by the administrator. For more details, see Set Up Problem Reports and Corrective Actions.

Create 8D Corrective Action.

You can choose to create a corrective action from the following two options in the **Type** drop-down list:

- Corrective Action – action to mitigate a quality issue and prevent its further occurrence.
- 8D Corrective Actions – action that uses the 8D methodology. An investigative dive to find the cause of a problem, a solution to fix it and a method to prevent recurrence.

The 8D methodology involves a systematic investigation into the root cause of a problem to prevent recurrence. It uses a structured, preconfigured template based on 8 disciplines to define the problem, identify the root cause, and run the corrective and preventative action (CAPA) to prevent recurrence.

Here's a brief description of the eight disciplines:

1. Plan and form team: Create a plan to minimize or mitigate the problem and establish a team of skillful and knowledgeable people
2. Define Problem: define and describe the problem
3. Interim Containment: define and implement containment actions
4. Determine Root Cause: identify the root cause
5. Verify Correction: verify and choose the most effective corrective action
6. Implement Corrective Actions: implement the corrective actions
7. Prevent Recurrence: implement actions to prevent a recurrence
8. Recognize Team Effort: acknowledge and congratulate the collective effort of the team.

Note: Although the change type 8D Corrective Actions is predefined, the attribute visibility setting is read-only. The change type inherits the configuration from its parent change type, Corrective Action.

Create a Corrective Action from a Problem Report

You can also create a corrective action from the Actions menu of a problem report. The corrective action opens in a dynamic tab for editing. For suppliers the page reloads with the newly created object.

While creating a corrective action from a problem report, you can select to copy over the descriptive flexfields, attachments, relationships, and tasks for the problem report. You can also copy over the affected objects including descriptive flexfields to the new corrective action. The corrective action is automatically linked to the problem report in the Relationships tab.

View Quality Issues and Actions for Items

Quality issues and quality actions are managed in the Quality Management work area. You can view issues and actions related to an item in the Product Information Management work area.

You can view the quality issues and actions for an item in the context of its master organization or of its child organizations.

1. In the Product Information Management work area, select the **Manage Items** task and search for an item.
2. On the Edit Item page, select the Quality tab.

3. If there are any quality issues or actions for the item, you can access them by clicking their number in the **Number** column.

Quality issues and actions are only displayed if the item belongs to the same organization in which the issue was raised.

Quality issues and actions are revision-specific. Only the issues and actions corresponding to the selected revision are displayed.

4. After you work with the issue or action, you return to the Edit Item page.

Security for Accessing Quality Objects

To work with quality issues and actions, you must have a role with the following privileges:

- Review Quality Issue
- Review Quality Action

16 Search

Use Product Management Search

The Product Management Search page is used for many objects within Product Management.

You can select the object that's being searched using the selector next to the page title. The search page automatically configures based on the selected object. Item, manufacturer, proposal and change types (change orders and change requests) are the objects that are searchable through this page. You can control the attributes used in search, filters, and how search will behave in the view.

To access the Product Management Search page, in the Product Management work area, click the **Search** tab at the bottom. The Product Management Search page is displayed.

The search page has two main areas:

- *Search Region*, where you specify the search query.
- *Search Results*, where the search results are displayed based on the query run in the Search region.

Search Region

You can enter all search queries in the **Search** text box. This text box combines user entered search data as a query. When you start typing in the **Search** text box, the search provides suggestions based on the data entered. Clicking on a suggestion performs the search.

Autocomplete and Suggestions

Autocomplete provides type-ahead suggestions similar to autosuggest. Autocomplete reduces the number of clicks. The suggestions are presented as you type within the **Search** text box. By default, a set of attributes for each object is configured for autocomplete and keyword search. For example, in item search, the item number and item description attributes are configured for autocomplete and keyword search to support cases where you search for an item number or search for an item using terms within the item description.

Note: Autocomplete and suggestions are enabled by default for Item Number and Item Description attributes.

Autocomplete can provide suggestions for up to the first 20 characters you've typed. If the autocomplete or autosuggest search option provides a suggested match that might not actually be what you're searching for and it's difficult to select a different value, you can disable the autocomplete or autosuggest search option by setting the **Disable Redwood Search AutoComplete** (ORA_EGP_RW_SEARCH_DISABLE_AUTOCOMPLETE) profile option to **Yes**. To enable this option, set it to **No**.

Suggested Filters

You can refine the search by selecting filters and values based on the data in the search results. The first five to seven suggested filters are displayed beneath the **Search** text box. The other suggested filters are available by clicking on the **Filters** action. These are displayed based on the display order in the view. Suggested filters can be enabled only for date and text attributes.

Note: You can't enable suggested filters for long text attributes.

To apply a suggested filter, click it to edit the suggested filter. Click the suggested filter the second time to display a set of values for the filter that you can select. Search and select a value and click anywhere on the page. The suggested filter is applied on the search results and the table refreshes to display the result based on the applied filter.

Note: The counts show how often a specific value occurs. The values are provided through aggregation of the data in the database for the attribute.

The suggested filter might allow you to select another value, or sometimes you can select one or more values. For example, to search for items for manufacturers `Aero Tech` and `Tech Space`, you can select both and the search results are filtered based on your selection.

The following table provides the various suggested filters.

Filter Type	Filter Name	Description
Filters for Dates/Time	Rolling Period	<p>This filter allows the user to select one or more periods when the view is configured. Filter will display addition fields to support the operator. For example: if the user selects Between, the filter will display fields to enter the Minimum and Maximum values.

	Checkbox	This filter displays values and you can select one value using the checkbox.

The **Filters** action is available beneath the **Search** field at the end. Clicking this displays the **Filters** drawer, where you can select values for the suggested filter. You can apply the search criteria to multiple filters in the drawer and click **See Results** to run the search.

To remove the applied filters, click **Clear**.

Note: Applying multiple suggested filters with specific values selected will be ANDed together as part of the search.

Keyword Search

When the index is created, each attribute is assigned an analyzer, which is used to create searchable content for the attributes. Part of this process is tokenizing the characters in the attributes. Tokens are searchable terms that are part of the index record for the object. The tokenizer will create a set of tokens by reviewing the characters and applying rules to separate the characters into tokens. For example, if the description contains: 'CAP, CERAMIC, SMD, 0402, 0.22UF, Y5V, 10V, +80/-20%', the resulting tokens would be 'CAP', 'CERAMIC', 'SMD', '0402', '0.22UF', 'Y5V', '10V', '+80' and '-20'. Each token is searchable using keyword search.

By default, keyword search is enabled for primary attributes of the objects. For example, for items, keyword search is enabled for item number and item description.

Administrators can turn on the Keyword enable switch for the Item Description attribute for cases where they don't want a match on the Description field. If the Description attribute value is generated using extensible flexfields, the administrator can turn off the keyword search and use suggested filters to search for content within the Description.

All keyword searches use starts with in the searches.

Search Using Special Characters

Some characters in attribute values are considered special characters. Special characters are treated differently in the index ingest process and when searching. Special characters are categorized into two groups:

- **Operators:** These characters are used in search to provide specific operations. For the list operators, see [Search Using Operators](#).
- **Separators:** These characters are used to break up a value into searchable terms. For example, in the item number CAP-PRODA-A1, the - hyphen is a separator special character, which the index ingest analyzer uses to break up the item number to searchable terms such as CAP, PRODA, and A1. Other separator characters are space, and coma (,).

The underscore (_) character isn't a separator or an operator. It's considered as any other character in an attribute value. For example, if the item number is 1234-Alpha_LITEON and you enter LITEON, the search fails because the searchable term is Alpha_LITEON.

Search Using Operators

You can use the following operators within the search criteria to perform a keyword search. Operators are enabled by using the Simple Query String Search (ORA_EGP_SIMPLE_QUERY_STRING_SEARCH) profile option. You can set the value to **Yes** to enable operators.

Operator	Description
+	AND operator.
or space	OR operator. Space character is considered OR operator.

Operator	Description
*	When used at the end of a term, signifies a prefix query.
"	Search for a group of terms as a phrase. For example, "220 Micro Farads".
(,)	Wrap a clause for precedence (for example, wind + (capacitor cap)).
~n	When used after a term (for example, wnid~3), sets fuzziness. When used after a phrase, sets slop.

Search Content Within Item Descriptions Using Phrase Search

You can use double quotes surrounding a group of search terms to find a match closest to the term and to find one or more terms in a specific order. Use phrase search on item numbers to increase the matches when the item number includes special characters such as hyphen.

For example, if the item description is:

Item Number: CAP-0041 Description: CAP .22 Micro Farads 10mmdx17mmI 105s mp LOW Axial y5v 0.05 Ohms 10 Year 100 Celsius -35 Celsius .0017 Amperes 8 % 5 Volt

You can search for "330 Micro Farads", or any other combinations of the terms in the order they appear. When you enter "330 Micro Farads" as the search criteria, the result returns all items that have this phrase. The following screenshot shows multiple items are found that has the phrase *330 Micro Farads* and *Capacitors_DQ_MM_1* is one of the items in the search results.

Search Using Query

When you don't know the part number, you can use a combination of operators, phrase search, and suggested filters to form a query. For example, the Design Engineer needs a capacitor in the micro farads range and can use 15 volts. The Design Engineer knows that there are one or more item classes for capacitor and uses the Item Class suggested filter to select one of the item classes. Next the Design Engineer enters the following query in the search box:

Cap + "Micro Farads" + "15 Volt"

where:

- Cap is the keyword to do a keyword search for all part numbers starting with Cap
- + is the AND operator
- "Micro Farads" is in phrase search format
- + is the AND operator
- "15 Volt" is in phrase search format

The result of the query returns three parts. Next, the Design Engineer can add additional attributes using the View Selector to refine the part to use.

You can use the operators to construct complex queries by combining them with terms in the **Search** box. The formulated query can also be used with suggested filters. As example, you can select a filter value for an item class such as 'Capacitors' and combine it with terms such as 'Axial', the AND operator '+', and the term 'Micro' to search for all items within the Capacitor item class that use the Axial mounting and are in the Micro Farads capacitor value range.

Use multiple search terms with operators and suggested filters together to form a query.

Expert users can use additional operators to form complex queries.

Search Using Prefix Search

Attributes such as a part number might often use a prefix term as part of the value. The prefix term maybe followed by additional terms often separated by special characters. For example, part number SC-MAKE-IT1 is a base part and the part numbers SC-MAKE-IT1-Body represents the body of the part. You can use the prefix search to find all the part numbers with the prefix SC-MAKE_IT1 by adding a '*' asterisk.

Assume you've a set of part numbers: SC-MAKE-IT1, SC-MAKE-IT1-Body, SC-MAKE-IT1-TOP, SC-MAKE-IT1-CAP, SC-MAKE-IT1-FRAME, and SC-MAKE-IT1-BASE

You can search using SC-MAKE-IT1* to find all part numbers with prefix SC-MAKE-IT1.

Search Using Match Item Number

You can search for the exact item number or multiple item numbers (entered separated by space characters) using the **Match Item Number** filter option. This filter option is always displayed as the first filter under the **Search** field. This filter reduces multiple interactions of search and filters to find an item by matching the complete item number. It returns only the item numbers you enter.

After you enter the item number that you want to search and click the **Match Item Number** filter, the new query engine performs the search based on the Item Number attribute and ignores other attributes that have been enabled for keyword search. The query engine matches the complete item number that's part of the index data.

Item numbers that have special characters including embedded spaces, asterisks (*), or double quotes ("") must be wrapped in doubled quotes (""). For example, to search for an item number called Spark Plug, you must enter "Spark Plug" in the **Search** field because it has space as the special character between two words.

You can use other filter options with the Match Item Number search to narrow your search results. For example, if you query items and you use child organizations, a search for an item number will return a row for each organization that contains the item. You can use the **Organization** filter to filter the results based on the master organization.

If item numbers use prefix or set of characters at the beginning to indicate a type of item, the prefix search can be used to search all items that have that prefix. For example, if item number is 152-1234, then 152 is a prefix to indicate that the item is a server. You can use prefix search to search for all item numbers that start with the prefix 152 by adding an asterisk to the end of the string.

Here's a list of operators that you can use with the Match Item Number filter.

Operator	Description
Space	Acts as a separator when searching for multiple item numbers.
Asterisk (*)	When used at the end of search term, signifies a prefix query.
Double quotes ("")	Wraps the item number with special characters.

Note: The Match Item Number filter is a permanent filter and can't be removed. This filter won't appear in the **View**.

Search for Proposal Using Proposal Number

You can search for a specific proposal using the **Match Proposal Number** filter on the Product Management Search page.

Search for a Workflow Using Workflow Number

You can search for a specific workflow using the **Match Workflow Number** filter on the Product Management Search page.

Apply Operators on Filter Options

You can apply operators on filters used for attributes with list of values. This helps to quickly narrow down search results by using the operators on attributes that use list of values. To use the filter, you first select the operator, the filter will redraw and provide addition selections based on the operator.

Here's the list of operators for the filters.

Operator	Description
Is one of	Display rows that contain one or more values when filtering.
Is not one of	Exclude rows with one of more values when filtering.
Is blank	Display rows with the attribute value as blank.
Is not blank	Display rows with an existing attribute value.

Example Use Cases:

- **Is one of:** Show all rows where the Currency attribute value is USD.
- **Is not one of:** Show all rows where the Lifecycle attribute value isn't Design or Prototype to find rows that are released for commercialization.
- **Is blank:** Show all rows where the Temperature Characteristic attribute value is null, that's, filter search for attribute values that aren't populated.

- **Is not blank:** Show all rows where the Product Type attribute has a value.

Search and Filter Multirow Data

You can use filters to refine searches for attributes that have one or more values such as item category assignments or item relationships for items. These attributes are often child objects of the main object. The value selected in the filter returns only those rows with the value. For example, if you select the **Is one of Miscellaneous_1** value for the **Category Name** filter, the result displays the items with this value for the category name.

Search Results

The search results are displayed in the search results region. A table within the search results will display the results as rows. The number of rows isn't limited. The table columns and their order depend on the selected view. The Product Management Search page is optimized to display more rows in the search results, and you can easily scroll down through the results. The count shows the number of rows in the search and is dynamically updated without slowing the search.

View Data Presence Indicators

The presence indicator indicates that the objects in the row on the search page have additional content.

For example, the **Has Structures** presence indicator displays a structure icon in the column to indicate that the item in this row has a primary structure and you can view the (component) details. Other data presence indicators for components appear only if your administrator has configured them for the selected view. You can add the presence indicators to filters and as columns in the search results. Also, see the related links topic.

The supported presence indicators are:

- Is used in structures
- Has structures
- Has attachments
- Has Product Development Relationships
- Has AML
- Has quality issues
- Has pending changes
- Has GTIN relationship
- Has customer item relationships
- Has category assignments
- Has cross-reference relationships

- Has competitor item relationships
- Has supplier item relationships
- Has source system relationships
- Has related item relationships
- Has supplier associations

Note:

- Data presence indicators are accessible for structures and AMLs on both child and reference organization items, attachments, quality issues, and quality actions on reference organization items.
- To address performance problems related to data presence indicators for reference organization AMLs, create the profile option EGP_SKIP_DPI_PROPAGATION and set its value to Y. This will stop the application from generating data presence indicators for reference organization items. To update the data presence indicators on the existing reference organization items, run the Add Data Presence Indicator to Index scheduled process.
- To update the correct data presence indicator values, run the Upgrade Product Management Data scheduled process with the following parameters:
 - **Upgrade Process:** Execution
 - **Functional Area:** Item Child Entity Presence Indicator
 - **Feature:** All

You must wait till the scheduled process completed successfully and then submit the index rebuild job.

- Clicking the presence indicator icon in the workflow search results takes you to the **Affected Objects** tab, only if you have permission to access any of the affected items within the workflow.

Notes on the drawer view:

- On the **Attachments** tab, you must select only a single row to download the attachment.
- The **Pending Changes** tab display change orders and change requests that are pending; it doesn't include released changes.
- The **Product Development Relationships** tab will display the relationships you added through the Product Development work area. When you click the concept component or the requirement specification that's been added as a related object, the parent concept or requirement is opened.
- The **Quality** drawer only displays the open quality objects.

Controlling Drill Down to Other Pages

You can control the behavior of drill down when using the link for the object number in the search results or the **Has Structures** presence indicator through a profile option. The Drill Down in Place (ORA_EGP_PAGE_LAUNCH_CTRL) profile option controls if the Structure page will be launched in new browser tab or launched in same browser tab as the

Product Management Search page. The default value is to launch the new page as a drill down in the same browser tab. Use the **Manage Advanced Item Profile Options** task to update the value of the profile.

Controlling Display of Attributes with One to Many Values

You can control the display of attributes that have one to many values such as item category assignments, relationship, or multirow attributes. The Display Data in Redwood Search as One to Many Format (ORA_EGP_RW_SEARCH_ONE_TO_MANY_SPLIT_ROW) profile option controls if the attribute value is displayed by showing the one to many values in the same row in the search result table when the value is **Yes**. If the value is **No**, the one to many display shows each value on different rows.

Using Views in Product Management Search

In Product Management Search, views are grouped into two types—system views and personal views. System views are predefined and available in the application by default.

Only administrators can create and modify the system views. All other users can access the system views but can't edit them. Users can create personal views by copying a system view and modifying the columns to suit their requirements. Personal views are associated with only the user who created them. When the user logs in again, they can access the personal views they've created. You can also identify important columns and choose the order in which you want to view these columns for a specific task.

In the Product Management work area, when you click the **Search** tab at the bottom, the Product Management Search page displays based on the default system view. If you've set a personal view as default, then the Product Management Search page will initially display the default view. You can control the display of columns in your personal view. The personal view will maintain the same view settings as the system view from which it was created.

The following screenshot shows the view name that's currently being used.

Only the person who created the personal view can use the view. When necessary, the administrator can edit the personal view on the Configure View page. On this page, the administrator can create system views that the business users can use to create their personal views.

Create Personal Views

To create a personal view:

1. Click the current system view name.

A view selector appears that displays all the enabled system views and the current view name is highlighted.

2. To create a personal view based on another system view, you must first click the required system view name to make it the current view.

The Product Management Search page changes to display the column names based on the selected system

view. Click the view name and then click the  **Duplicate** icon for the highlighted the view name.

The Columns drawer slides open on the right side and displays all the attributes (column names) that are configured in the current view.

3. You can show or hide the columns by selecting or clearing the checkboxes, and you can change the order of the columns using the  icon. After you've completed the changes, click **Save As**.
The Columns drawer displays, where you can specify the details for the personal view.
4. Enter a name for the new personal view. Also, you can select the **Mark as default** checkbox to set the personal view as the default view. Click **Save and Apply** to save the view as a personal view.

Edit Personal Views

To edit a personal view, go to the view selector and click the  **Edit** icon next to the view name. The Columns drawer appears. You can show or hide columns by selecting or clearing the checkboxes and change the order of the columns using the  icon. After you've completed the changes, click **Save**.

Saving Column Spacing

If you change the column spacing in the search results, resave your personal view to save the changes. You can also manage the column spacing on the Configure View page.

Additional Features

The following additional features are available on the Product Management Search page:

- **View selection:** Select another view to change the attributes in the search and the search configuration. You can use the search in the View Selector to find a view by typing the name of the view. All views are created on the View Management page.
- **Clipboard:** Select one or more rows and click **Clipboard** to add them to the clipboard. The items will be available in the application's clipboard and can be added to pages in the work areas. The clipboard is now persisted. This allows to use the fast search on the pages.
You can add items, manufacturers, and workflows to the clipboard only if you've the required view or manage permissions using the access control list. The tabs available for navigation are based on the view or manage permissions granted to you for the selected workflow, item, or manufacturer.
To open a specific tab of a workflow in the Clipboard or Recently Visited panel, select the tab from the drop-down list.
- **Hyperlink on the name:** Click this link to view the details.
- **Sort:** Click the small arrows in each column to sort the results in ascending or descending order.

- **Revision selector:** Control the revision for which the search results are displayed. The item index contains current revision and future revision content. You can choose to display either the current or latest content for the item:
 - **Current:** Current effective revision, effective date of the revision is before the current date (system date).
 - **Latest:** Latest revision, if the effective date of the revision is greater than the effective date of the currently effective revision.

When you switch between **Current** or **Latest** options, the search information you had entered in the **Search** field is removed along with the filters.
- **Export:** Select up to 10,000 rows in the search results and export them to an Excel sheet.
- **Adjust Column Widths:** You can adjust and save column widths for both system and personal views. All users can access system views while personal views are only accessible to the user who has created it and the administrator. Previously, if column width changes were made within a view, you had to redo the same changes when re-accessing the view. From this update onward, the column widths are persisted as part of the saved view for the personal saved search. To change the column width:
 - a. Hover on the line between the two column headers. The cursor changes to .
 - b. Click and drag the cursor either to the left or the right to adjust the column width.
 - c. To save the changes made to the column widths, click the View name, then click the **Edit** icon next to the view name.

The Columns drawer is displayed on the right side.

 - d. Click **Save** to save the column width dimension changes you made on the Product Management Search page.
- **Find Keyword Enabled Attributes When Editing Columns:** You can find a column attribute using the search in the Manage columns drawer. Attributes that are enabled for Keyword Search are displayed with the  icon.
- **Filters:** Click **Filters** beneath the **Search** text box to open the Filters drawer, where you can specify the filter value.
- **Clear:** Click **Clear** beneath the **Search** text box to remove the applied filters.

Search Query Example

Here's an example that shows how to perform a search using the Search box with filters.

1. On the Product Management Search page, select **Item** using the arrow next to the page title.
2. In the **Search** text box, type **Capacitor**. As you type this word, suggestions are displayed and the suggested text for autocomplete also appears in grey color. From the displayed suggestions, select **XC1103**.

The search results are automatically refreshed to display capacitors with the item number XC1103.
3. Click the **Primary Unit of Measure** suggested filter beneath the **Search** text box and select the value **Each**. Click anywhere on the page.

The selected filter is applied and the search results are refreshed to display XC1103 items with primary UOM as Each.

Search for Workflows, Approvals, and History

You can use the Product Management Search interface to configure and run a search for workflows, workflow approvals and workflow history.

To navigate to the search page, in the Product Management work area, click the **Search** tab at the bottom. On the Product Management Search page, you can select one of the following:

- Workflow
- Workflow Approvals
- Workflow History

Search for Workflow

Workflow search can be used to configure and run a search for change orders, change requests, problem reports, and corrective actions. You can combine multiple keyword searches along with applied filters to complete the search. For example, you can search for:

- all changes created within a date range.
- all high priority changes in open status assigned to you.
- all changes based on Customer, Supplier, Manufacturer, and Source information.
- data presence indicators for tasks, attachments, and relationships.
- all changes of type New Product Introduction (NPI), and change extensible flexfields of product lines.

Search for Workflow Approvals

You can search for workflow approvals that need your attention by searching for both users and roles with participant types of Approver, Optional Approver, or Reviewer. This is supported for change orders, change requests, problem reports, and corrective actions in open, interim approval and approval workflow status types.

When you've a role as a participant and **Response Required From is One**, use this combination of filter chips to aid your search:

If the approval task hasn't been claimed by any member of the role:

Participants	Participant Role	Activity Type
Role Name	Role Name	Approval

If the approval task has been claimed by one member of the role:

Participants	Participant Role	Activity Type
User (person who has claimed it)	Role Name	Approval

Here are the example use cases for Workflow Approvals search by user role:

- Change and Quality Analyst:
 - Workflows pending approvals from a user or roles
 - High priority workflows pending approval
 - Overdue pending approvals
- Approver or Reviewer:

- My pending approvals
- Workflows that need my review
- Manager:
 - Workflows pending approvals from my group
 - High priority workflows pending approval from my group
 - Overdue pending approvals from my group

Participant Elapsed Time in Workflow Approval Search Results

The **Participant Elapsed Time** attribute in workflow approval search results represents the number of days a workflow has been awaiting approval from participants. The elapsed time is measured in days for each participant and reflects the **smaller value** of the following two durations:

- The time since the change most recently entered the workflow status.
- The time since the user was last added as a participant in that workflow status.

The elapsed timer starts when a participant becomes an approver—either when the change first enters the signoff status or when the participant is added as an approver to the signoff status.

The timer increases by one day at a time and pauses in either of the following conditions:

- The approver signs off the change for that status.
- The change exits that workflow status.

If the change enters a specific signoff status multiple times, a separate elapsed duration is recorded for each occurrence.

Search for Workflow History

You can search across change types to find all affected object redlines and updates made to the change header, workflow status, and other workflow entities.

For example:

- To find all workflow edits made by a specific user, Riley Smith, between June 23, 2024, and July 2, 2024, you can filter the search results based on workflow type, author, and date.
- To find all workflow history for a specific affected object, enter the affected object name in the search box.

Tips for Search

When you search for workflows, workflow approvals, or workflow history, you can:

- Select any configured view.
- Based on the configuration of the selected view, you can:
 - search by keywords.
 - apply one or more filters on the search results.
- Show or hide columns in the search results.
- Use the sort function to sort any column.

- Export the selected list of workflows, workflow approvals, or workflow history.
- You can apply filters or remove filters from filter drawer.

The Workflow Type (on the Product Management Search page) will be filtered to certain change types depending on the work area from where you launch the search; however, you can override the filter to display all change types.

Work Area	Change Types Filtered To
Product Development	Engineering change order, change orders without revision control, engineering change request, design change request
Product Information Management	Commercialization change order
Quality Management	Problem report, corrective and preventive action

Note:

- When you select the object, it will be opened in its respective work area, regardless of the work area from which you've launched the search.
- You can search for multiple changes by entering change numbers separated by space. For example: NPI123 ECO124 ECR156.

FAQs for Search

How many rows can be exported from the Manage Items page search results?

You can display a maximum limit of 500 rows of item search results on the Manage Items page, and you can export a default maximum limit of 10000 rows by using the Export to Excel action.

To ensure that your export includes all the items you want, perform your item search in a way that limits the search results to the export limit. A message in the exported spreadsheet tells you if the export limit was reached, and if some rows weren't exported.

To export more than 10000 rows, Oracle recommends defining a report based on the Source System Item subject area using Oracle Transactional Business Intelligence (OTBI).

You can improve the performance of the export by setting the limit on the number of item rows exported to the spreadsheet. You control the export limit by specifying the value of the profile option **Item Export Row Limit** (EGP_EXPORT_ITEM_ROWLIMIT) at site level. The default value is 500. Be aware that increasing the limit might adversely affect performance and timeouts, depending on your data. To modify the default, use the **Manage Advanced Item Profile Options** task in the Setup and Maintenance work area:

- Offering: Product Management
- Functional Area: Items
- Task: Manage Advanced Item Profile Options

Tip: To improve performance, consider limiting the number of columns in the search results table before exporting the results to a spreadsheet.

How do I search for an item using a related customer item number?

The item keyword search can use item relationship information when searching for a production item if the item relationship information is added to the item keyword index. You can add customer items to the keyword index using the **Manage Item Keyword Search Attributes** task in the Setup and Maintenance work area. For example, attributes for a manufacturer and manufacture part number can be added to the index.

When the production item is updated by adding a trading partner item type item relationship, you can use the Keyword search field in the Manage Item page to search for the trading partner item number and find the production item, where the item relationship was added.

You can use the trading partner name or the trading partner item number in the keyword search.

17 Data Security

Data Security Privileges for Accessing Items

Using the data security privileges available for items, you can authorize users to create, view, and edit item details.

A product data steward or product manager is typically responsible for managing the item data security by entering data grants for the item. Access to an item and its details is controlled at either the item class or item level.

Data Security and Function Security

Item information is controlled through function security and data security.

- Function security is a statement of what tasks and actions users can perform in pages.
- Data security is a statement of what action users can take against which data. In Oracle Product Hub, data security involves providing users with item data grants to perform operations on certain items.

For complete information on function security, data security, and their associated privileges, refer to the Oracle Fusion Cloud SCM Security Reference for Product Management guide and the Oracle Fusion Cloud Applications Security Reference for Common Features guide.

Job Roles, Duty Roles, and Security

Functional privileges are associated to different duty roles and jobs, and these privileges control the access to the tasks. If you have functional privileges, you can grant data security to other users.

- The Manage Item Classes privilege allows the user add data grants at the item class level.
- The Manage Item People privilege allows the user to add data grants at the item level.

These privileges are available for product data stewards and product managers.

For complete information on job roles, duty roles, and their associated privileges, refer to the Oracle Fusion Cloud SCM: Security Reference for Product Management guide and the Oracle Fusion Cloud Applications Security Reference for Common Features guide.

Managing Item Extensible Attributes Data Security

The IT security manager provides access to the Oracle Authorization Policy Manager application where security is managed. Using the relevant job role, you can create data security privileges on the required item EFF tables.

- The Enable Database Resource Management privilege provides you the access to:
 - Edit database resources in Authorization Policy Manager. You can create data security privileges on the required item EFF tables.
 - Manage item EFF attribute groups. You can create required attribute groups and define security conditions. The data privileges created in APM can be associated with the EFF attribute groups.

- The Manage Item Class functional privilege provides you the access to the Manage Item Classes task. This task manages the item-class level data security. The Manage Item People functional privilege provides access to the Manage Item security task. This task manages the item-level data security and you can access the task from the Actions menu in the Edit Items page.

Notes on Item Data Security Privileges

The following list contains important information on significant item data security privileges and granting privileges for items:

- The **Create Item Class Item (Data)** privilege is granted at the item class level and gives you the access to create items within the item class.
- The **View Item Basic Data** is a basic privilege that you should have in order to search for the item and access it.
- For managing item details such as relationships, attachments, or associations, you must have the **View Item Basic Data** and the **Maintain Item Basic Data** privilege in addition to the required functional privileges.
- **EFF Privilege** is user-defined and controls access to item EFF attribute groups.
- All operational attributes require specific attribute group-level privileges to edit the attributes within the group. **View Item Basic Data** privilege provides access to view all the operational attributes.

Note: To control the access to extensible attributes groups, you can create a separate and specific view and edit privileges through the Oracle Security Console.

- The **View Item Structure Data** and the **Maintain Item Structure Data** privileges are required to view and manage item structures. In addition, users must have the **View Item Basic Data** privilege in order to access the item.
- The **View Item Pack Data** and the **Maintain Item Pack Data** privileges are required to view and manage item packs. In addition users must have the **View Item Basic Data** privilege in order to access the item.
- The **Maintain Item People Data** privileges allow users to view and manage item data security at the individual item level. In addition users must have the **View Item Basic Data** privilege in order to access the item.

Note: For operational attribute groups, the **Maintain privileges** don't include view access. Corresponding view privileges needs to be granted to user explicitly so users can view and make required updates.

Managing Data Security Privileges at the Item Class Level

You can manage the item access at the item class level. You can provide access to a user or a user group for all items created within an item class at the item class level. The Public check box at the item class level indicates the state of the data security for the items created within the item class. When the item class Public check box is selected, then all users and groups can access the items created within the item class. If you want to access the extensible attribute group, then you must setup data grants for the extensible attribute groups.

When the Public check box for the item class is deselected, then you must set up data security for all users and groups that want to control access to the items created within the item class.

1. Navigate to the Security tab on the Edit Item Class page to add users and specify security privileges.
2. For each user or user group, grant specific item security privileges allowing them to gain access to only relevant information.

You must specify an organization for the item data grants. The data grant will provide users and user groups with access to the items in that organization. This allows multiple users and user groups to access the same item in different organizations.

The privileges that you grant at the parent item class are inherited by the child item classes. You can't alter the inherited privilege grants at child item-class levels. However, you can manage additional grants at the child item-class levels.

Managing Data Security Privileges at the Item Level

You can also manage the Item access at the individual item level.

1. Click Item Security from the Actions drop-down list. The Item Security dialog box opens.

Note: If the Public check box is selected, it indicates that the item is publicly accessible. You can deselect the Public check box to enable data security for the specific item. The item becomes private and the owner data grants are created for the logged in user. Only the owner can access the item at this time.

2. If the item is private, then for each user or user group, grant specific item-security privileges allowing the user or the user group to gain access to only the relevant information.
3. If the item is public, then for each user or user group, grant specific item-security privileges allowing the user or the user group to gain access to extensible attributes.

Privileges granted at the item-class level are inherited by all items and can't be edited at the item level. However, you can manage additional privilege grants at the item level.

Note: Organization stripping isn't available at the item level. This is because you're managing grants at the individual item level, which is always in the context of an organization.

Managing Security Privileges for Product Hub Portal

The product data stewards provide the required supplier product administration privileges to the supplier users to access the Product Hub Portal.

The assignment of the job role to the supplier can be done in following ways:

- From Oracle Fusion Cloud Procurement Supplier Portal, while setting up the supplier and its users. This flow is specific to Supplier Portal and not controlled by Product Hub.
- From Security Console, by searching the supplier user and assigning the relevant supplier product administration role to the user. This role is common to all Oracle Fusion Cloud Applications.

You also need to provide data security privileges at the item class level to the supplier product administrators. Refer to the preceding section, Managing Data Security Privileges at the Item Class Level, for information on how to assign data security privileges to users.

Data Security Privileges for Creating Items

When you create an item, you can enter the basic data required or add additional data to enrich item information.

The following data security privileges are required to add various item details while creating an item. If you need to enter a combination of the item details identified in the following paragraphs when creating an item, then you need the corresponding combination of data security privileges.

- The following set of data security privileges are required to create an item by entering the minimum required data:

- **Create Item Class Item Data**

Required for the item class in which the item is created.

- **View Item Basic Data:**

Required to view the item details page.

- **Maintain Item Primary Data:**

Required to author the required attributes in Main attribute group such as **Item Name**, **Description**, or **Primary Unit of Measure**.

- The following set of data security privileges are required to create items by entering additional operational attributes:

- **Create Item Class Item Data**

- **View Item Basic Data**

- **Maintain Item Primary Data**

- **Maintain Operational Attribute Group Data**

Where **Operational Attribute Group** is the operational attribute group name.

Note: Each operational attribute group has a separate maintain privilege

- The following set of data security privileges are required to create items by entering user-defined attributes:
 - **Create Item Class Item Data**
 - **View Item Basic Data**
 - **Maintain Item Primary Data**
 - **View Additional Attribute Group Data**
Where **Additional Attribute Group** is the name of the user-defined attribute group.
 - **Maintain Additional Attribute Group Data:**
Where **Additional Attribute Group** is the name of user-defined attribute group.
- **Note:** Privileges for user-defined attribute groups are created by the end user as part of the configured attributes setup and are based on end user security requirements
- **Note:** Each user-defined attribute group can have separate maintain and view data privileges
- The following set of data security privileges are required to create an item by entering item structures:
 - **Create Item Class Item Data**
 - **View Item Basic Data**

Where **Additional Attribute Group** is the name of the user-defined attribute group.

Note: Each user-defined attribute group has a separate maintain and view data privilege

- **View Item Basic Data**
- **View Item Structure Data**

- The following set of data security privileges are required to view :

- **View Item Basic Data**
- **View Item Pack Data**

Note: Supplier associations support user-defined attributes. To view these attributes, you need the corresponding view data privilege of the user-defined attribute group.

Data Security for Trading Partners

The trading partner item data security lets you control access to trading partner items data sets. The privileges for trading partner items are managed through the Manage Trading Partner and Trading Partner Item task available in the Product Information Management work area.

By default, trading partners are set to public. To enable data security, select the Private check box and enter privileges using the security section. Data security that's applied at the trading partner level applies to all trading partner items for that trading partner. The owner or administrator of the trading partner item type or person with view and manage data grants can access the content. If data security is enabled for trading partner items for a given trading partner items, all trading partner items created will inherit the data grants from the trading partner level.

A private trading partner item can only be viewed by a specific set of users or groups that have been granted the data grants to view the object. Once a trading partner item is marked private, it can't be made public again. If you mark or enable data security at the trading partner level, all existing trading partner items for the trading partner will inherit the data grant created for the person logged in as the owner.

Note: The security subsection in the Edit Trading Partners page is only displayed for trading partner items when data security is enabled for the trading partner items.

Privileges

Privileges available at the trading partner level:

- View: Users with this privilege can view trading partner items for the trading partner.
- Maintain: Users with this privilege can edit the trading partner items. Users must also have the View privilege.
- Administer: Users with this privilege can create additional data grants at the trading partner level and add additional owners.

Note: A person or group with the Administrator privilege can add another user with the Administer privilege and add a second owner. A data grant for the original owner can then be removed. There must always be one owner for the trading partner items.

Privileges available at the trading partner item level:

- View: Users with this privilege can view the trading partner item.
- Maintain: Users with this privilege can edit the trading partner item. Users must also have the View privilege.

18 Function Security

How to Define View-Only Access for Items

You can define a custom role that provides view-only access to items.

As described in more detail elsewhere, the security model requires a three-way relationship between users, roles, and data, summarized as: who can do what on which data. For the case of providing view-only access for items, this table summarizes the elements of that relationship:

Security Relationship Element	How To Implement the Element
Do What	1. Create a custom role with only those privileges that provide view access to items.
Who Can	2. Assign the custom role to the users that need view-only access.
On Which Data	3. In the item class for the items that need view-only access, assign only those actions to users that provide view access to items and certain of their components. Provide view-only data access to items in an inventory organization to users assigned the custom role.

Create a Custom Role

Create a custom role with only those privileges that provide view access to items.

To create the custom role:

1. Click **Navigator > Tools > Security Console**.

You must have the IT Security Manager role to use the Security Console.

2. Select the Roles tab, then click the **Create Role** button.
3. Enter a **Role Name**. Example: `Custom View-Only Item Viewer`.
4. Enter a **Role Code**. Example: `view_Only_Item`.
5. Select this **Role Category: SCM-Job Roles**
6. Enter a **Description**. Example: `Custom role that allows view-only access to items`.
7. Click **Next** to advance to the Function Security Policies role component.
8. On the Privileges tab, click **Add Function Security Policy**.
9. In the Add Function Security Policy dialog box, search for and select privilege names that provide view-only access to items.

To find and select privileges:

- a. Optionally, set the Search filter to **Privileges**.
- b. Enter at least 3 characters in the search field until you match the name of the desired privilege.
- c. Select the privilege in the search results, then click **Add Privilege to Role**.

Select and add these privileges:

Privilege	Purpose
Monitor Item Work Area	Allows access to the Product Management group containing the Product Information Management work area from the home page and the Navigator. View-only access to the items themselves is governed by other privileges.
Browse Item	Allows access to the Manage Items and Browse Items tasks in the Product Information Management work area, using item class and catalog hierarchies. View-only access to the items themselves is governed by other privileges.
View Item	<p>Allows view-only access to item details. The user must have rights to search and view items under your data security policies. Allows view-only access on the item detail page to the Overview, Specifications, Structures, Associations, and Quality tabs.</p> <p>The Categories tab isn't available for view-only access. You can add the Manage Item Catalog privilege to your custom role to make the Categories tab available, but that privilege makes categories editable, and defeats the view-only purpose of the role. In addition, that privilege adds the Manage Catalogs task to the task panel of the Product Information Management work area, since it makes catalogs editable.</p>
View Item Relationship	Allows access to view item relationships. Allows view-only access on the item detail page to the subtabs of the Relationships tab, with the exception of the Trading Partner Items and GTIN subtabs.
Manage Item Attachment	Allows access to view and manage item attachments.

These privileges are a starting point for defining a custom role with view-only access to items. You can add more privileges to your function security policy for this custom role, as necessary for your business needs.

10. You can click **Next** to skip through defining the other components of the new role:

- Data Security Policies
- Role Hierarchy
- Segregation of Duties
- Users

11. On the Summary page, click **Save and Close**.

Assign the Custom Role to Users

Assign the custom role to users that require view-only access to items.

To assign the custom role to a user:

1. In the Security Console, select the Users tab, then create or update a user account.

- To create a user, click the **Add User Account** button. Then, the User Information page, enter the required basic information for users, such as name, email address, user name, and password, as needed.
- To update a user, search for the user name, then click the display name in the search results.

2. Click **Add Role.**

3. In the Add Role Membership dialog box, search for and select the name of the custom role that you created. Then click **Add Role Membership. The role is added to the user account.**

Assign View Actions to Users

As you normally do when you set up data security for item classes, assign actions to users and organizations, but this time select only the actions for viewing. This assignment of actions is required for non-public item classes, but not for public item classes. (An item class is public if its **Public** check box is selected.)

Note: This section applies only if you have enabled either the Data Governance or Data Consolidation functional area within the Product Management offering in the Setup and Maintenance work area. These functional areas are available to users of Oracle Fusion Cloud Product Management.

To assign view-only actions to users for items in an item class:

- 1. In the Setup and Maintenance work area, use the **Manage Item Classes** task:**
 - Offering: Product Management
 - Functional Area: Items
 - Task: Manage Item Classes
- 2. Select the item class and click **Actions > Edit**.**
- 3. On the Edit Item Class page, click the Security tab.**
- 4. Click **Actions > Add Row**.**
- 5. In the **Principal** field, select **Group** or **Person**, depending on the requirement.**
- 6. In the **Name** field, search for and select the view-only custom role you created.**
- 7. In the **Organization** field, search for and select the organization in which the custom role's actions apply.**
- 8. In the Actions table for the custom role, click **Actions > Select and Add**.**
- 9. In the Select and Add Actions dialog box, search for and select all the actions that begin with **view**. You should select these actions:**
 - View Item Basic
 - View Item Structure
 - View Item Attribute
 - View Item Pack
- 10. Click **OK** to assign the actions to the role or user in this item class and its child item classes.**
- 11. Click **Save** to save your changes to the item class definition.**

Synchronize Users and Roles

When you make changes to users and groups in the Security Console, you must synchronize those changes with the HCM tables used by Oracle Fusion Cloud Applications.

To synchronize your custom role and the users you assigned it to with the HCM tables, in the Setup and Maintenance work area use the **Run User and Roles Synchronization Process** task:

- Offering: Product Management
- Functional Area: Initial Users
- Task: Run User and Roles Synchronization Process

Runtime Access to Items

At runtime, the affected users have only view access to the affected items.

For example, assume that you're the user account described here:

1. Sign in with the user name defined as having the custom view-only role.
2. The only tasks available in the task panel are:
 - Manage Items
 - Browse Items
 - Manage Item Relationships
3. Select the Manage Items task.
4. Set the current item class to the one that you added view actions for.
5. Add the search field **Organization**.
6. Query for items by these criteria:
 - An organization from the set for which you provided data access.
 - An item belonging to the item class that you defined view actions for.
7. Select one of the items.
8. On the item details page, all of the fields are view-only.
9. Select any of these tabs: Overview, Specifications, Structures, Associations, or Quality.

All of the fields are view-only.
10. Sign out.


Create Catalogs

How Catalogs Work Together

A catalog is a collection of categories that you use to classify items.

You can organize the categories into a hierarchy that represents a taxonomy. You create new categories only in the context of a catalog. You can add existing categories to one or more catalogs, either from another catalog or as shared categories from a source catalog. You can control the assignment of items and categories in the catalog by controlling the catalog content. For example, you can set the value of the **Catalog Content** field on the Edit Catalog page to **Items at all levels**, which allows items to be assigned to any level within the category hierarchy, not only to the leaf levels.

This figure shows the relationships of the catalog components to each other.



Catalog

A catalog is a collection of categories that are organized to define a classification of items. The top most level of a catalog is the catalog root. All categories for the first level in the category hierarchy are associated with the catalog root through the catalog category association component.

Category

A category is a component of a catalog that represents a set of items. You can associate a category to a catalog through the catalog category association. Both the shared category and the native category are associated thorough the catalog category association.

Catalog Category Association

Catalog category association represents the relationship between a catalog and a category, or a parent category and a child category. Each catalog category association represents one relationship between the catalog and a category or one relationship between a parent category and a child category.

Item Category Assignment

Item category assignment represents the assignment of the item to a category in a catalog. Each item category assignment represents the relationship between a category and an item.

Item

An item represents objects such as a product, service or template. An item is assigned through the item category assignment component.

Attachment or Image

Information is associated to the catalog or category through the attachment framework. Multiple attachments are supported but you can only associate a single attachment or attachment type image with a catalog or category for viewing in the UI.

Catalog Details

You can view and edit a catalog on the Edit Catalog page when you have the appropriate permissions.

The following parts of the Edit Catalog page provide important capabilities for managing and editing catalogs:

- Catalog header region
- Catalog details tab
- Category hierarchy tab

Catalog Header Region

The header region for the Edit Catalog page contains the catalog name and description, the selection of the default category and the start and end date for the catalog.

You can change the default category for a catalog so that the category is used for the item creation process, based on the values of attributes for the item. The choice of default category also enables other Oracle Fusion Cloud Applications to assign items to a category.

You can modify the start and end dates for a category as you update a catalog in order to control when the category is used.

You can revise or reclassify the category to reflect shifting relationships within the category hierarchy.

Catalog Details Tab

The Details tab contains:

- The configuration attributes for the catalog, which control the runtime behavior for the catalog.
- The sharing attributes for the catalog, which control the source catalog that will be used for sharing from and what content can be shared.
- The additional information for the catalog, which contains the descriptive flexfields that support the catalog metadata.

Category Hierarchy Tab

The Category Hierarchy tab contains the category hierarchy region, in which the category hierarchy can be created and maintained. In addition, items can be assigned, the usage of the category in other catalogs can be viewed, and the attributes for the category and catalog category association can be edited.

Catalog Formatting

The format of a catalog is defined at the time the catalog is created and controls the behavior of the catalog at runtime.

When you format a catalog, the layout controls three main areas and includes the following tasks:

- Catalog configuration
- Date enablement
- Category sharing

Some fields are required, and others are optional.

Catalog Configuration

You can configure the catalog, and this affects how the content behaves. The catalog configuration contains a set of attributes that define the catalog configuration. These attributes interact to define the runtime behavior of the catalog.

The configuration functions are:

- Catalog code: A unique identifier that's used.
- : Controls how items are assigned to categories and has two values. The first value is master level, which enables the automatic assignment of items to all child organizations associated with the master organization, if the current context is a master organization. The second value is organization level, which assigns the item only to the organization in the current context.
- Default category: A newly created item is automatically assigned to the default category if specific operational attribute values are entered for the new item. The automatic assignment is controlled by the functional area. Each functional area has specific rules about which operational attribute values are used to trigger the automatic assignment process. For example, an item will be assigned to the catalog assigned to the functional area called Purchasing if the Purchased specification is turned on or if the Internal Ordered Item specification is enabled.
- : Allows items to be added only to the bottom level categories in the hierarchy.
- Catalog content: Controls what content can be added to the catalog and where the content can be added.
- : When this option is selected, you can assign an item to one or more categories in the catalog. The default is deselected, which means that each item can be assigned to only one category in the catalog.
- Public Catalog: Select to mark this catalog as public. All users with access to view catalogs will have access to this catalog.
-
- Enable duplicate category names
- Enable deletion of item category assignments
- Enable hierarchy for catalog
- Enable date level control for item category assignments

Note: The catalog behavior for functional area catalogs is defined through the combination of fields within the pages and the seeded functional area rules.

Catalog Date Enablement

The date enablement function controls when the catalog is in an active state or inactive state by using the start date and end date attributes.

Category Sharing

The category sharing function enables sharing categories from a designated source catalog.

The sharing function has these attributes:

- Share by Reference: Catalog elements that are shared by reference are read-only in the target catalog. Multiple source catalogs can be used in this type of sharing.
- Copy: Content from other catalogs can be added to the current catalog by creating a copy of the content. The copied content can be edited within the current catalog.
 - Include child categories: Indicate whether to copy child categories when copying categories.
 - Copy item category assignments: Indicate whether to copy items assigned to the category into the catalog.


Manage Catalogs

How Various Catalog Hierarchies Fit Together

You use catalogs to organize and classify collections of items by associating categories with the catalog.

You organize the categories to form a taxonomy and assign items to the categories. When you associate a category with the catalog, a catalog category association is created which specifies the relationship of the association. The catalog category association may also represent the relationship between two categories, for example, a relationship between a parent category and a child category.

The following figure shows the relationships of the category hierarchy components.



Components

The components of a category hierarchy are:

- Catalog root: The topmost node in category hierarchy that represents the object called catalog.
- Category: The catalog component that is used to represent the classification structure.
- Catalog category association: The line in the diagram represents the relationship between a catalog and category or between a parent category and child category.
- Item category assignment: The dotted line in the dialog represents the relationship between a category and an item.
- Reference category: The category, C5 in this diagram, is shared as a reference category from a source catalog.
- Leaf level category: The lowest or bottom-level category in a category hierarchy. You can assign items to all levels in a category hierarchy if you configure the catalog to support this.

- **Browsing category:** The category, C2 in this diagram, is a browsing category. Browsing categories are categories that you add to the category hierarchy for the purpose of classification and do not have items assigned to them.

The category hierarchy does not have a limit on how many levels can be represented. The category hierarchy can have multiple hierarchies within a single category hierarchy.

Relationship Between Categories and Catalogs

Catalogs are used to organize and classify collections of items by associating categories to the catalog.

The categories are organized to form a taxonomy and items are assigned to the categories. When a category is associated with the catalog a catalog category association is created which specifies the relationship of the association. The catalog category association may also represent the relationship between two categories, for example a relationship between a parent category and a child category.

Catalog Category Association

The date enabled attribute value is important regarding catalog category association. The catalog category association is date enabled providing the control of when the catalog category association is active in the catalog and when the catalog category association is inactive. The catalog category association has two attributes to support enabling dates; the start date and the end date. The start date is value is the first day that the catalog category association is available or active for use and the end date is the last day the catalog category association can be used, after this date the catalog category association is inactive. The date enabled attribute values are also used to control the visibility of content and the behavior of the category in the catalog. If a category association is inactive or end dated, having the value of the end date attribute past the current date, then the items can't be assigned to the category.

A catalog category association will be set to inactive state when the category referenced by the catalog category association is set to an inactive state automatically, but the display won't be refreshed automatically.

Category Hierarchy Reports

You can use reports produced by transactional business intelligence to monitor your category hierarchy changes.

If you make changes to the catalog category hierarchy, you can use the **Product Management - Item Catalog Category Hierarchy Real Time** subject area to create reports that include multiple levels of category hierarchy data. See the Subject Areas for Transactional Business Intelligence in SCM guide for details. When you make hierarchy changes, you must run the **Refresh Product Hub Snapshots** scheduled process before creating or viewing subject area reports.

If you make changes to the catalog category hierarchy through the import process, then the **Refresh Product Hub Snapshots** scheduled process runs automatically when the import is complete. If you make changes to the hierarchy through the Item Categories REST resource or through the Manage Catalogs task in the Product Information Management work area, then the scheduled process is automatically submitted in the next scheduled time window on that day. You can also run the scheduled process yourself, to refresh the business intelligence reports immediately.

Related Topics

Catalog Category Association

The catalog category association assigns the category to the catalog or parent category. This association lets you manage when a category is assigned to a catalog, by setting the start and end dates for the association.

The catalog category association can be edited only within the Edit Catalog page, in the category hierarchy tab. The catalog category association start date and end date attributes can be edited in the details region. The association can't be deleted, only end dated.

Category Catalog Associations

You select the category in the category hierarchy table for the catalog category association that you're editing, the category details are displayed in the side panel. The association start date and association end date are the only editable fields.

After you make changes, clicking the **Save** button saves the changes to the database but doesn't close the Edit Catalog page. Clicking the **Save and Close** button saves the changes to the database and closes the Edit Catalog page.

Date Enablement for Catalogs and Categories


The catalog, categories, and catalog category association use date enablement to determine if the object specified is active or inactive based on the start date and end date. The following are date enablement definitions:

- **Active:** An object is active when the current date is later than or equal to the value of the start date, but earlier than or equal to value of the end date.
- **Inactive:** An object is inactive when the current date is later than the value of the end date.
- **Future dated:** An object is future dated when the current date is earlier than the value of the start date.

You set the date enablement attributes are used to determine when a catalog, category, or catalog category association is used or visible.

- On the Manage Catalog page, a table filter determines which catalogs appear. The default value for the choice list is **Active**, indicating that only active catalogs will be displayed. You can select the value **All** to view both active and inactive catalogs.
- On the Edit Catalog page, on the category hierarchy tab, two table filters determine what categories and catalog category associations appear. The default values for the two choice lists are **Active**, indicating that only active categories and active catalog category associations will be displayed. You can select the value **All** to view both active and inactive categories and catalog categories associations.
- Other applications also use the date enablement attributes to filter information retrieved through application programming interfaces or services for catalogs.

The following figure provides the date enablement attributes for these objects. The catalog, category, or the catalog category association has an internal state that is active or inactive.



The following aspects are important regarding date enablement for catalogs and categories:

- Start date
- End date
- Catalog and category objects
- Catalog category association
- Catalog and category rules

Start Date

The start date is defined as the first date that the object can be active. The start date can be future dated by setting the value to a date later than the current date. The start date value defaults to the system date if no date is entered during catalog or category creation.

End Date

The end date is defined as the last date that the object can be active. The object is end dated one second after the date specified by the value of **End Date**, that is the next day at 12:00:01 a.m. You cannot set the end date in the past. Also, you can change the end date from a condition when the object is ended to a new end date greater than or equal to the system date, causing the object to go from inactive to active. The end date value is optional during catalog or category creation.

Catalog and Category Objects

The start and end dates have been added for the catalog and catalog category association. The inactive date for categories has been renamed as the end date and the start date has been added.

Catalog Category Association

The catalog category association is used to specify the parent and child relationships between catalogs and categories and for category to category relationships. The catalog category association date enablement is independent of the category data enablement, except for the case where the category is end dated; the association is ended automatically as well. The catalog category association dates represents the state of the category for the catalog in which the category is associated.

Catalog and Category Rules

When a catalog is inactive the following rules apply:

- All operations for the catalog are disabled; the catalog can be edited.
- The catalog cannot be used in other processes.
- The catalog can be viewed only if you set filters on the Manage Catalog page to a value of **All**, enabling you to view active and inactive catalogs.

When a category is inactive the following rules apply:

- All operations for the category are disabled; the category is not able to be edited.
- The category cannot be added to other catalogs.
- The category can be viewed only if you set the filters on the Edit Catalog page to a value of **All**, enabling you to view active and inactive catalogs.
- The application sets the catalog category association for the inactive category to inactive.

When a catalog category association is inactive the following rules apply:

- The category may be inactive or active; if the category is active it can be edited.
- The catalog category associations and related category can be viewed only if you set the association filter on the Edit Catalog page to a value of **All**, enabling you to view active and inactive catalogs.

When a catalog is future dated the following rules apply:

- All the operations of the catalog are enabled and the catalog is can be edited.
- The catalog can be used in other processes, if allowed.
- The catalog can be viewed only if the you set the filters on the Manage Catalog page to a value of **All**.

Create Categories

You can create categories in the context of a catalog, on the Category hierarchy tab on the Edit Catalog page . When you select the Create icon in the category hierarchy table, the Create Category dialog appears.

Create Category Dialog

After you enter a name and tab out of the field, the category code will be automatically populated. You can update this value if required. Enter a meaningful description of the category. Optionally, you can add an image and an attachment to this category.

Date enablement determines if an object is active or inactive based on the start date and end date. When categories are created, the default start date value is the current date. You can move the category start date beyond the current date to a future date within the category. The end date value is optional.

Select the **Restrict category to item assignment only** check box to add only items to the category.

After you complete the required fields for the catalog, clicking **OK** creates the category in the database, adds the category to the point of selection in the category hierarchy, and closes the dialog.

Items to Categories Assignment

You can assign items to categories on the Edit Catalog page, category hierarchy tab, on the category detail item tab.

You can assign items only to active categories. In addition, you can configure catalogs to control item assignment to categories within the catalog by selecting the **Allow multiple item category assignment** check box on the Create Catalog page, which allows items to be added to all levels of the category hierarchy.

To begin, select the item class and enter search information in either the Item ID, Item description or Keyword fields and click the **Search** button. You select items from a choice list and add them to the category.

Controlling Item Assignment

You also control item assignment by selecting the value of the **Controlled at** check box on the Edit Catalog page. If you select the **Master Level** value and the organization context is a master organization, then the assigned items are automatically assigned to all child organizations that are associated with the master organization. The added items will also be assigned to any child organizations that might be created under the master organization, even after the items were assigned to the master-controlled catalog.

Select Category From a Hierarchy and Assign to an Item

You can select a category from a hierarchy and assign the category to an item. When creating or editing an item, on the **Categories** tab, add a row. In the search box, when you type the name of the catalog or category, it automatically

matches the name with the available catalog and category names and displays them as suggestions. Category suggestion also displays the catalog name to help you know the catalog for the category. The format is (category name (catalog name)).

If you select a category from the displayed suggestions, the catalog and category names are populated in the respective fields in the user interface.

If you select a catalog from the displayed suggestions, the Search and Select: Category window shows a list of categories and their paths within the hierarchy for the selected catalog. The hierarchy path allows you to identify the correct category based on the position of the category within the hierarchy. After you select a category from this list, the catalog and category names are populated in the respective fields in the user interface.

If the suggestions don't show the required category, you can use the Search icon to select or search a catalog and display the categories for the selected catalog.

When searching for categories within a catalog with a single level of hierarchy, the suggestions provide an easy way to find the category by typing all or part of the category name.

Duplicate category names will be displayed in the suggestions along with the catalog name. Duplicate category names in catalogs with a multilevel hierarchy will be displayed with their hierarchy path.

You can click the icon in the **Hierarchy** column to view the position of the category in the hierarchy.

Note: The **Hierarchy** icon is only active after you've selected a catalog and category.

What Can You Edit on the Edit Catalog Page

The Edit Catalog page is a shared page that has two modes-view and update. The view mode displays the selected catalog in a read-only file. The update mode displays the selected catalog in an editable file.

You must have edit catalog privileges to access the catalog in the update mode. You can edit only an active or future-dated catalog.

You can edit the following fields in the catalog:

- Catalog Name
- Description
- Start Date
- End Date
- Default Category
- Allow multiple item category assignment
- Addition Information
- Category Hierarchy
- Category Details
- Items assigned to category

Default Category

You can edit this field to select another category as the default category for item creation. You cannot remove the default category if the catalog is assigned to a functional area that requires a default category to be specified.

Allow Multiple Item Category Assignment

This check box is editable only until you assign an item to a category in the catalog.

Addition Information

You can edit the values of the descriptive flexfields attributes.

After you make changes, clicking the **Save** button saves the changes to the database but will does not close the Edit Catalog page. Clicking the **Save and Close** button saves the changes to the database and closes the Edit Catalog page.

Category Details

You can see category details when you select the row with the category in the category hierarchy table of the Edit Catalog page. The category details are displayed in the side pane.

You can edit the details of native categories. The category detail region contains information about the category that's associated to the catalog. It also contains the association start and end dates.

You can view and edit a catalog on the category details tab when you have rights to manage catalogs.

The following parts of the Category Hierarchy tab provide are important capabilities for managing and editing category details:

- Details subtab
- Items subtab
- Attachments subtab

Details Subtab

The details tab contains information about the category that has been associated to the catalog. This information appears in all catalogs, since a category can be associated to one or more catalogs. The details tab contains the category configuration, category date enablement, association date enablement, and the additional attributes for the category.

The details tab contains attributes that define a category. Unstructured information is added through attachments. Images are added to a category and are displayed in the category details tab.

Items Subtab

The Items subtab contains item assignments are local to the catalog that the category is associated with. You can add and delete item assignments.

Attachments Subtab

The Attachments tab contains the list of attachments that the category is associated with.

Category Edits

Categories can be edited only from within the Edit Catalog page, on the Category Hierarchy tab.

To edit a category, expand, or search in, the tree of categories associated with the catalog, then select the row for the category in the category hierarchy table and edit the category's attributes in the category's Details panel. A category can only be edited if the category is active and its associated catalog is active or future dated. If a category is directly shared, the same category can be edited in multiple catalogs, except for the item assignments that are local to the catalog you are editing.

Category information can be edited in both the Details and Items subtabs.

Details and Items Tabs

The following fields are editable in the category:

- **Category name**
- **Description**
- **Attachments**
- **Category start date**
- **Category end date**
- **Items assigned to category**

After changes are made, the **Save** button saves your changes without closing the Edit Catalog page. The **Save and Close** button saves your changes and closes the Edit Catalog page.

Catalog and Category Attachments

Catalogs and categories support attachments and use a common component for managing attachment content. You can add attachments on both the Create Catalog and Edit Catalog pages.

The attachment component displays a plus sign icon indicating that no attachments are available for the object. The Attachment dialog appears when you click the plus sign icon. You define the attachment by selecting the attachment type, file name or Uniform Resource Locator (URL), title, description, and by indicating whether the attachment can be shared with other objects. Once you define the attachments and click the **OK** button, that attachment title appears in the attachment component region of the page along with an X icon that you can click to delete the attachment.

The attachment file types are:

- File
- Repository File or Folder
- Text
- URL

File

You must provide a title for the file and create a description for the attachment. You select a file to upload from your desktop.

Ensure that you don't inadvertently add the same attachment more than once. It's possible to add attachments with the same title, description, file, or attachment category to the same catalog or category.

Repository File or Folder

You click the **Browse** button to attach a repository file or folder from the document repository to a catalog. The attachment repository contains existing attachments and is organized as a set of folders. The **Browse** button launches the Attachment Repository dialog to enable you to select an attachment. You must provide a title for the repository file or folder and create a description for the attachment.

Text

Enter the text string in the field that you want to appear as an attachment. You must provide a title for the text and create a description for the text attachment.

URL

Enter the URL address to a web page that you want to attach to the catalog. You must provide a title for the URL attachment and create a description for it.

The **Share** check box alerts users that you added an attachment and the date that you performed the task.

Category Moves

You use the move category function in the category tree table region of the Edit Catalog page. This is a table row action. The dialog is launched when you select an active or future dated category within the catalog and select this action.

Identifying the New Parent

The dialog provides the current category parent and lets you pick a new category parent. Only the legal category parents are displayed in the choice list.

The category list within the **New Parent** choice list is filtered by based on a set of rules:

- The new parent category must be an active or future dated category; the end date value of the category must be later than the current system date.
- The value of the category content for the new parent category must allow the selected category to be added; the legal values are items and categories and categories only.
- A selected category associated with the catalog at a level below the categories at the root categories can be moved to the root of the catalog.
- The new parent category catalog category association must be active; the end date value of the catalog category association must be later than the current system date.

Category Sharing

Category sharing allows the reuse of categories or a category hierarchy across catalogs. For example, if you were to create spring and fall product catalogs, many of your products would probably appear both catalogs.

The products that are in both catalogs could be assigned to one or more categories that could be shared between the catalogs. Categories can be shared across multiple catalogs, allowing catalog content to be reused and saving the work needed to maintain multiple copies of the categories. In the case of category sharing by reference, the category structure in the source catalog can be different than the structure in the native catalog.

Categories can be shared using sharing by reference.

Sharing by Reference

Sharing by reference means adding a category by reference into the catalog. Sharing by reference allows a category and the items assigned to that category to be added to one or more catalogs. If the category is a parent category, the complete hierarchy for that category is shared. The shared categories and assigned items are read-only in the catalogs where they are added. During the creation of the catalog, sharing can be enabled by specifying a source catalog that will be used for sharing by reference and setting the value of the sharing content to control what content will be shared from the source catalog. The advantage of using sharing by reference is that source catalog content can be shared to multiple catalogs and maintained in a single place, the source catalog. In addition, the referenced content can consist of more than one category. For example, a complete category hierarchy and any items assigned to categories in shared content can also be referenced within the catalog.

In the Category Hierarchy tab in a catalog, each category in the hierarchy is represented by a row in a collapsible table. The style of icon next to a category's name indicates how it is shared. Directly shared categories are marked with a folder icon; categories shared by reference are marked with the icon used for the **Share Categories** control. Categories that are shared by reference are only editable in the source catalog, and the categories and items are read-only in the target catalog where they are shared. A category or a complete category hierarchy, including items assignment, can be shared by reference.

Default Catalog Assignment

You can assign a catalog to a functional area such as Purchasing. When a catalog is assigned to a functional area, the catalog will act based on the rules you defined for that functional area.

Only one default catalog can be assigned to a functional area. During item creation, if certain operational attributes have specific values, then the item being created is assigned to the catalog assigned to the functional area, and then to the default category for the catalog.

To assign a default catalog:

1. Create a catalog based on functional area rules.
2. Create a category and assign it as the default category for this catalog.
3. Assign the catalog to the chosen functional area. Select the Manage Functional Area Catalogs task in the Setup and Maintenance work area, edit a functional area, then select a catalog name.
 - o Each functional area has specific rules that the catalog must adhere to, so the assignment process may fail if the catalog does not meet the functional area rules.
 - o Some functional areas do not allow the catalog assigned to their area to be changed.

- Some functional areas allow the catalog to be changed only if no items are assigned to the categories in the catalog.

For example, if values of the operational attributes Purchased and Internally Transferable have been set to Yes, the item being created will be assigned to the default category of the catalog assigned to the Purchasing functional area.

FAQs for Catalogs and Categories

How can I define category hierarchies?

Categories can be organized to represent classification taxonomies. The hierarchy organizations for categories have parent and child relationships that form a tree structure.

The category hierarchy is created and maintained within the Edit Catalog page, category hierarchy tab. The category hierarchy is shown in true relationship to the way it is defined.

The category hierarchy can be created using two methods: the first is manually creating the hierarchy by adding referenced categories, duplicating categories or creating category for the catalog.

The second method for creating the hierarchy is by importing the category hierarchy through the spreadsheet interface. The category hierarchy can be exported from another catalog or other sources, edited and imported into a new catalog. The hierarchy can also be added manually to the spreadsheet.

On the toolbar of the Category Hierarchy tab, you can create new categories, using the **Create Category** button. You can add categories, including shared categories, using the **Add Category** button. If a catalog has a category hierarchy, you can edit it using the **Move Category** button, which opens a dialog box.. You can also modify the hierarchy using drag and drop. The catalog category association cannot be deleted, but can be end dated to make the catalog category association inactive. The category hierarchy table provides a choice list filter that controls what catalog category associations and categories area displayed based on the date enablement.

How can I add categories?

Categories are catalog components that are associated to a catalog for purpose of classification of items.

You can add existing categories to the point of selection, which can be a category in the hierarchy or the root of the catalog. If no category is selected, the default is the root of the catalog.

You can add categories by selecting **Add Category** and selecting **Add Category**. You can then search for existing categories based on the value of the catalog structure for the catalog. You can narrow the search for existing categories by using the **Advance Search** region in the dialog. You can add each selected category by selecting the **Apply** button and the add category region remains open. The **OK** button adds a category, if a category is selected, and then closes the dialog.

How can I add shared categories?

Adding a shared category is similar to adding an existing category except the category is selected from the catalog that has been designated as a source catalog.

The sharing content attribute value determines what content is shared from the source catalog. A category within a source catalog that has been added to a native catalog is also known as a referenced category. You use the list of values from the Add Categories menu. The Shared Category option will be disabled if the catalog has not been configured for category sharing.

How can I add images to a catalog or category?

You can attach an image from your desktop or from a configured repository to a catalog or a category, or both. The image is displayed in the catalog detail and the category detail sections of the catalog page.

Only one image can be associated with a catalog or category. To attach an image, select the **Attachments** control and launch the Manage Attachment dialog. The title you provide for the image attachment will appear after the image that is displayed in the catalog. The description you provide is not displayed. Clicking the **Browse** button will allow you to select the file to be used as the image for the catalog or category. After the information is entered in to the dialog, click the **OK** button to load the image. The image will not initially be displayed until the catalog is saved. The image can be replaced with another image by selecting the X to delete the existing image and adding a new image.

How can I duplicate categories?

You can select and duplicate a category as a quick way to create a similar category configuration.

Select the **Duplicate** icon action to launch the Create Category dialog that has attribute fields populated based on the selected category attribute values. The category name is prefixed with **Copy_** followed by the name of the selected category. Fill in the required field information in the key flexfield segment values. Once the category attributes are updated and the key flexfield segments values are entered, click the **OK** button to add the newly created category into the category hierarchy of the selected category you have configured.

What is catalog mapping?

You can map categories of different catalogs to the reporting categories in other catalogs by using the Manage Catalog Mapping task in the Setup and Maintenance work area. You can map one or more categories within a catalog to category in a second catalog.

For example, suppose that you want to roll up the costs associated with all items assigned to a set of categories in catalog. Catalog mapping lets you select a category in a catalog and map all the categories in the set to that category.

20 Item Mass Changes

How You Make Item Mass Changes

You can update information for more than one item simultaneously by searching for and selecting items, and then accessing the **Manage Item Mass Changes** submenu within the **Action** menu on the Manage Items search results table.

Through the Manage Item Mass Changes submenu you can:

- Assign items to organizations.
- Assign items to supplier site organizations.
- Assign, reassign, or unassign items to catalog categories.
- Change the item class of selected items.
- Edit item attributes.
- Edit items in a spreadsheet.

You must include the fields that will be changed in the search prior to selecting the items that will be changed. For example, to change item category assignments you must include catalogs and categories as columns in the search results table and as fields in the search.

Assign Items to Organizations

Items are engineered, manufactured and distributed by physical facilities called organizations. Organizations can also be sales centers such as stores. To enable an organization to perform any of these functions on an item, you must first assign the item to that organization.

If the items selected have associated packs or structures, you can also specify these options:

- **Assign packs:** Packs available for the master organization items will be available in the selected child organizations.
- **Assign item structures:** Select one or more structures then specify to either copy or common the structures.

Commit options let you apply these assignments directly to the database or export the data to a spreadsheet for further review or modification.

Assign or Reassign Items to Catalog Categories

You can select one or more catalogs' and one or more categories within each catalog to assign to the selected items,

Rules established at the catalog level determine whether you can assign single or multiple catalog categories to the item. If a catalog has multiple assignments enabled, then the same item can be assigned to more than one category associated to the catalog.

For reassigning catalog categories, the catalog category assignments for the selected items will be removed and assignments will be made to the newly selected catalog categories.

Unassign Catalog Categories

The catalog category assignments for the selected items will be removed.

After you save your changes, they're applied immediately to the database. No commit options are available. The application will launch a dialog asking if you want to make the change, since no commit options are available for this mass change action.

Assign Items to Supplier Site Organizations

Item supplier site organizations associate an item to a supplier site and an organization. It indicates that for a given organization, the item is being supplied from the specific supplier site. This mass flow creates all combinations of the organizations and supplier sites selected. For example, if you select three organizations (org1, org2, and org3) and three supplier sites (Sup1, Sup2, and Sup3), all combinations of these selections will be used: org1Sup1, org2Sup1, org3Sup1, org1Sup2, org2Sup2, org3Sup2, org1Sup3, org2Sup3, and org3Sup3.

If the items selected have associated packs (pack items defined in the pack hierarchy of an item), then you can associate those packs to the supplier site organizations.

First the user selects the suppliers, then the organizations. Next, they select if the items selected are pack items and create the item supplier organization associations for pack hierarchy.

Commit options let you apply these assignments directly to the database or export the data to a spreadsheet for further review or modification.

Change Item Class

To change the item class for several items, search for and select items. In the **Change Item Class** dialog, select the new item class to be applied to the selected items, and the import format to be used when you import the modified items back to the product hub. Click **Download** to generate a spreadsheet, which contains the existing item class attributes and values, but mapped to the new item class. Edit the attribute values in the spreadsheet, as needed. Then import the spreadsheet using an item batch.

Edit Item Attributes

Oracle Fusion Product Hub's Mass Update functionality supports various item attributes, including predefined item attributes, operational attributes, additional attributes defined as global descriptive flexfields in spreadsheet only, attributes organized within user-defined attribute groups of type single row, supplier association, style item, GTIN, and effective date and reason for item revision.

You can edit the item attributes in the Edit Item Attribute dialog box or export them to a spreadsheet for editing. This method is useful when you need to set an item attribute to the same value across many items. For example, updating the **Orderable** attribute to **Yes** for 100 items. Using this flow, you can modify both item and item supplier site organization attributes.

Attributes that aren't editable in this flow are:

- Main:
 - Item Number
 - Image
 - Defaulting Control

- Basic:
 - Created By
 - Creation Date
 - Item Class Life cycle Phase
 - Organization Name
 - Organization Code
 - Primary Unit of Measure
 - Updated By
 - Updated Date
 - Approval Status
- Relationships:
 - Catalog/Category
 - Competitor Relationships
 - Cross References Relationships
 - Customer Relationships
 - Related Relationships
 - Spoke System Relationships
 - Manufacturer Relationships
- GTIN:
 - GDSN Enabled
 - GTIN Party Type
 - GTIN UOM
- Item Revisions:
 - Revisions
 - Revision Code
 - Effective End Date

To edit the item attributes:

1. On the Manage Items page, search and select the items for which you want to edit the attributes.

Note: Only the column attributes that are seen in the search results table are available in the Edit Item Attributes dialog box or in the spreadsheet. Use the options available on the **View** menu to add or remove column attributes in the search results table.

2. To edit the item attributes in the UI:

- a. Click **Actions > Manage Item Mass Changes > Edit Item Attributes**.

The Edit Item Attributes dialog box is displayed.

- b. If you've selected few items, then you can update the values for the attributes in the **Items** region.
- c. If the number of items is very large and you want to mass update for all items, then update the values for the attributes in the **Edit Columns** region. For example, if you want to change the status across a lot of

items, then select the status from the **Item Status** drop-down list. The selected status is applied across the items.

- d. Click **Apply** and then click **Next**.

The Process Details dialog box is displayed.

- e. Provide process details such as batch options including scheduling information. Also, specify change order details in those cases where business rules require approval for any of the changes made.
- f. Click **Submit**.

3. To edit the item attributes in a spreadsheet:

- a. Click **Actions > Manage Item Mass Changes > Edit Item Attributes in Spreadsheet**. The selected items are exported into a spreadsheet and after a few minutes the message "The spreadsheet was generated and can now be downloaded." is displayed.
- b. Click **Download** and download the file to your system. For more information, see the next section *Edit Items in a Spreadsheet*.

Edit Items in a Spreadsheet

Editing items in a spreadsheet lets you work offline on the item updates and upload them back to the application. The **Edit Items in Spreadsheet** option generates a smart spreadsheet that you can download to your system. You can review and make further changes to the items and then upload the data directly from the spreadsheet into the item batch for importing to Product Hub. You can only mass edit 100 item attributes at a time.

The columns in the smart spreadsheet is the same as the Search Results table on the Manage Items or Browse Items pages. You can add specific columns to the Search Results table for adding them in the smart spreadsheet.

Note: Item relationship attributes aren't exported to Smart Excel.

When the smart spreadsheet is generated, an Import Map is automatically created at the back end with the mappings for the attributes or columns from the Search Results table on Manage Items or Browse Items pages. This Import Map won't be visible on the Manage Import Maps page. The smart spreadsheet is created in the logged in user's language.

To edit the spreadsheet, you must have a role with the following privileges:

- Manage Item Batch (EGI_MANAGE_ITEM_BATCH)
- Generate Access Token (EGI_GENERATE_ACCESS_TOKEN_PRIV)
- Get Item Batch Rest (EGI_GET_ITEM_BATCH_REST)
- Manage Item Batch Rest (EGI_MANAGE_ITEM_BATCH_REST)
- Import Item (EGP_IMPORT_ITEM_PRIV)

Note: If your mass changes aren't imported, make sure that the **Schedule** attribute for the Product Information Management Data Hub (PIMDH) spoke system is set to **On data load**.

How You Purge Automatically Generated Import Maps

While mass editing items, a few import maps are generated automatically. These import maps are internal and not displayed on the Manage Import Maps page.

It isn't required to delete these import maps because they will be reused internally. You must delete them only if there are issues with a specific smart spreadsheet that was used for mass editing the items. You can delete these maps using the Upgrade Product Management Data scheduled process.

Note: Use the Upgrade Product Management Data scheduled process with caution because it can delete all the automatically generated import maps that were created while mass editing items.

Perform these steps to delete the automatically generated import maps:

1. From the Navigator link, go to **Tools** and click the **Scheduled Process** link.
2. Click **Schedule New Process** in the Search Result table header.
3. In the Schedule New Process dialog, select the following:
 - o **Type:** Job
 - o **Name:** Upgrade Product Management Data
4. Click **OK**.
5. In the Process Details dialog, enter the following parameters:
 - o **Upgrade Process:** Execution
 - o **Functional Area:** Import Maps
 - o **Feature:** Delete automatically generated import maps
 - o **Parameter 1:** Enter the name of the import map that must be deleted. You can get the name of the import map from the smart spreadsheet. To delete all the automatically generated import maps of all users, specify **Parameter 1 as ALL**.

If **Parameter 1** is left blank, then none of the automatically generated import maps will be deleted. If you specify the name of an import map that wasn't generated automatically, then that import map won't be deleted. The scheduled process only deletes automatically generated import maps.
6. Click **Submit** to start the process.
7. Monitor the status of this scheduled process by entering the process ID in the Search region.

Commit Options for Item Mass Changes

Commit options let you specify whether to apply changes directly to the database or export the data to a spreadsheet for further review or modification.

Data that is applied to the database is always validated prior to saving it to the database. After you select the items and specify the changes, then you select the commit operations. If you make changes to a spreadsheet, then the data is uploaded to an item batch, validated and saved to the database through a scheduled process.

Commit options are available for the following item mass change activities:

- Assign items to organizations
- Assign items to supplier site organizations
- Assign items to catalog categories
- Reassign items to catalog categories

Apply Changes to Database

Changes will be applied to the database after running the validations to ensure the integrity of the changes.

Specify item batch options including, scheduling and change order details in those cases where business rules require approval for any of the changes made.

Note: If you schedule the item batch to be processed at a later time, then it will be available as an internal item batch through **Manage Item Batches** user interface.

Manage in Spreadsheet

You can review and make further changes to the items through the downloaded spreadsheet and then apply the changes to the database by selecting **Upload** from within the spreadsheet.

When you click **Upload**, you must specify batch options including scheduling information. Also specify change order details in those cases where business rules require approval for any of the changes made.

Note: In order to use this feature you must have Microsoft Excel 2007 or later Standard Edition license.

How can I update item attributes using a spreadsheet?

Select **Edit Item Attributes in Spreadsheet** from the **Manage Item Mass Changes** submenu within the Action menu in the **Manage Items** search results table.

Edit the attributes in the spreadsheet and then apply the changes to the database using the **Upload** button in the spreadsheet.

Note: The appropriate item attributes must be included in the search results table in order to export them to a spreadsheet for modification.

Can I update the unique key attributes in multirow-extensible-flexfield groups?

No, you can't update the unique key attributes in multirow-extensible-flexfield groups. Therefore, when you provide a new value for an existing unique key attribute, the extensible flexfield group considers the updated value as a new row.

What's the difference between common item structures and copied item structures?

If you need to create an item structure that's very similar to an existing structure, then it's easier to copy the item structure and make the necessary modifications rather than create a new one.

If you need to create an item structure that's identical to an existing structure so that it doesn't require any component changes, then make the item structure common. This helps reduce maintenance and the risk of errors.

How can I update item supplier site organization attributes using a spreadsheet?

Select **Edit Item Attributes in Spreadsheet** from the Manage Item Mass Changes submenu within the Action menu in the Manage Items search results table.

Edit the attributes for supplier site organization in the spreadsheet and then apply the changes to the database.

Note: The appropriate supplier site organization attributes must be included in the search results table in order to export them to spreadsheet for modification.

21 Guided Task Flows

Perform Guided Task Flows

Administrators create and configure the guide task flow. You can perform the guided task by selecting the flow and starting it. Run each task until all the required tasks are completed. The final task allows the you to submit the changes through the mass change processes and monitor the status of the process.

You can perform the following using the guided tasks flows:

- *Mass Update Item Attributes*
- *Mass Replace Components*
- *Mass Replace Approvers or Assignees*
- *Mass Assign Items to Organizations*
- *Mass Change Item Class for Items*
- *Mass Assign Items to Catalog Categories*
- *Mass Unassign Items from Catalog Categories*
- *Create Common Structures in Bulk*

Perform Guided Task Flow to Mass Update Item Attribute Changes

You can run the configured guided task flow to mass update item attribute changes.

To run a guided task flow:

1. On the Product Management page, in the **Actions** panel, click **View all actions** and then click **Guided Tasks**.
The Perform Guided Tasks page is displayed.
2. Click the guided task flow that you want to run belonging to the **Update Item Attribute Changes** category, and then click **Start Guided Task**.
3. Click the **Select item attributes** task.
The Mass Update Summary is displayed.
4. Select the items for which you want to perform the mass update and click **Done**.
5. Click the **Review and Submit** task.
The guided task flow is automatically updated and simultaneously exports the items you selected to an Excel spreadsheet.

7. After you open the Excel spreadsheet file, you can see the items you selected in the first step of the guided task. In this file, you can edit the required item information.
8. After you've edited the information, these changes need to be uploaded back to the guided task flow. To do this, in the **Add-ins** tab, click **Validate**, then click **Upload Data**.
9. After the updated data has been uploaded back to the Guided Task, you can go back to the Guided Task and view the order status of the changes you made. To check the order status, select the batch name and click **Refresh**. When the Job Status changes to Succeeded, then you've successfully completed the Guided Task flow. If the batch fails, then you can redo the data validation through Excel.
10. To view the status of the tasks later, you can click **View Guided Tasks**.

Perform Guided Task Flow to Mass Replace Components

You can perform a mass replacement of components across multiple structures using a guided task flow. Your administrator can configure the guided task.

You can view all the items where a component is used and replace it with a different component across one or more selected structures. Here's how:

1. On the **Tasks** panel tab click **Perform Guided Tasks**.
2. On the Explore page, search for a component replacement journey and select it or select a component replacement journey appearing on the page.
3. Click **Start This Journey**.
4. Search and select the original component you want to replace and the replacement component. Click **Done**.

During the selection, the components will be filtered based on the organization selected in the configuration.

5. Select for one or more structures from the where used list that shows where the original component is used. You can refine the search within the displayed list, if the list returns too many results. Click **Done**.

Notes:

- o If the replacement component is configured to be routed through an engineering change order, the search results will only include engineering structures created in the Product Development work area.
- o If the replacement component is configured to be routed through a commercialization change order, the search results will include commercial structures created in the Product Information Management work area and engineering structures in the Prototype or Production lifecycle phases. The results will exclude Packaging Structures.
- o If the replacement component isn't configured to be routed through any change order at all, the search results will include both engineering structures and commercial structures.

6. Review the summary of the selections from your previous tasks and click **Done** to submit the mass replacement action.

Notes:

- You can create a new engineering or a commercialization change order. You also select an existing change that's in the Draft or Open status.
- Depending on the configuration of the guided task, the changes will be applied directly to the selected structures of the commercial items or added as affected items to the change order through the scheduled process for engineering and commercial items.
- When the scheduled process is complete, the change order is created in the open status.

If the guided task isn't configured for the change type, then there's no need to select the change type or create the change order. The replacement will be made directly on the item.

- When the components are replaced, the reference designators will also get replaced.

7. View the change order status.

You can view the details such as batch name, change order name, job ID, and job status.

Note: To view the status of the tasks on a later date, you can click the **View Guided Tasks** link in Product Management Experience in the Tasks panel tab.

Perform Guided Task Flow to Mass Replace Approvers or Assignees

You can use the guided task flow to perform a mass replacement of an approver or assignee. To do this, you must have the necessary permissions granted through the access control list, along with additional workflow controls.

Here's how you replace approvers and assignees:

1. Navigate to the Product Management work area.
2. In Actions click Guided Tasks.
3. Select the task configured by your administrator for replacing approvers or assignees.
4. Select replacement user.
5. Search for and select the user (approver or assignee on the workflow object) you want to replace and the replacement user.

You'll be prompted to select the user you want to replace and the user that you want to replace it with (that's the replacement user).

6. Select one or more workflow objects from the result.

You can view the list of workflow objects where the user is being added as an approver or assignee. You can choose one or more workflow objects for which you want to perform the replacement. You can further refine your search by filtering the results of the where used query. You can view the total number of workflow objects returned based on the query.

Note that only workflow participants associated with the current status are displayed, and replacements can only be made within this status. Additionally, the current status must be Open, Interim Approval, or Approval.

Replacements can't be made if the status is Draft, Scheduled, or Complete. Similarly, assignees can be replaced only when the workflow status is Open, Interim Approval, or Approval.

For example, if you're trying to replace John Doe, who's an approver in the Approval status, the replacement won't take place if the current status of the change order is Open. The replacement can only occur once the change order has reached the Approval status, and you run this guided task at that point.

7. Review and submit.
You can review and submit the task for replacement.
8. View replacement status.

Perform Guided Task Flows to Mass Assign Items to Organizations

You can use the guided task flows that belong to the guided task category called **Assign Items to Organization** available in the guided task library to assign multiple items to various organizations at once, including the item's structures. The administrator has created each task flow to be used in a specific business process context. For example, the task flow *Mass Assign - Frozen Desserts* (created by your administrator) is used to mass assign items belonging to the item class *Frozen Desserts* to a collection of target organizations. When running the task flow, you can further narrow down the data set of items (preselected by your administrator) and the list of organizations relevant for the specific business process context.

Each guided task flow in the **Assign Items to Organization** category, at the minimum, includes the following tasks:

- Select items to be assigned
- Select the target organizations
- Select structures
- Review and submit
- View item batch status

When running the task flow, you must navigate to each task in the same order it's listed. To complete a task, click **Done** for each task. However, until you complete the **Review and submit** task, you can revisit any of the prior tasks in the task flow and make any changes.

To run the guide task flow for mass assigning items to organizations:

1. On the Product Management page, in the **Actions** panel, click **View all actions** and then click **Guided Tasks**. The Perform Guided Tasks page is displayed.
2. Click the guided task flow that you want to run belonging to the **Assign Items to Organization** category, and then click **Start Guided Task**.
3. Click the **Select items to be assigned** task, select the items you want to assign, and then click **Done**.

Note: The displayed items have been already preselected by the item class (Frozen Desserts) and the master org for the items.

4. Click the **Select the target organizations** task, select the target organizations to which the items must be assigned, and click **Done**.

Note: The displayed list of organizations has already been preselected by your administrator.

5. Click the **Select structures** task.
6. Search and select the structures that you want to assign for the items and the select **Common** mode or **Copy** mode to assign the structure.

Note: The structures available for assignment has been preconfigured by your administrator. Even if you don't want to assign any structures, you must navigate to this task and click **Done**.

7. Click the **Review and Submit** task.
8. Review the selections and choices you've made. If there are no changes, click **Done**. This will submit the **Item Import** scheduled process.

Note: To change any of your selections, click the respective task and do the changes. View the updated changes in the **Review and Submit** task and click **Done**.

9. Click the **View item batch status** task.

You can use this task to view the batch name, batch ID and the status of the scheduled process. You can click **Refresh** to view the progress of the scheduled process. When the **Job Status** changes to **Succeeded**, then you've successfully completed the Guided Task flow. If the batch fails, then you can rerun the task flow after resolving the issue.

Perform Guided Task Flow to Mass Change Item Class for Items

You can use the guided task flows that belong to the guided task category called **Change Item Class** available in the guided task library to mass migrate existing items to a different item class.

Each guided task flow in the Change Item Class category, at the minimum, includes the following tasks:

1. Select items to be assigned
2. Select target item class
3. Review and submit
4. View item batch status

When running the task flow, you must navigate to each task in the same order it's listed. To complete a task, click **Done** for each task. However, until you complete the **Review and submit** task, you can revisit any of the prior tasks in the task flow and make changes.

To mass assign items to catalog categories:

1. On the Product Management page, in the **Actions** panel, click **View all actions** and then click **Guided Tasks**. The Perform Guided Tasks page is displayed.
2. Click the guided task flow that you want to run belonging to the **Change Item Class** category, and then click **Start Guided Task**.
3. Click the **Select items to be assigned** task.

4. Click the **Select the target item class** task. Select the target item class to which items must be assigned, select the target item view and click **Done**.

Note: If your administrator hasn't preselected the target item class and the target item view, you can choose one from the LOVs available.

5. Click the **Review and Submit** task. Review the selections and choices you've made. If there are no changes, click **Done**.

To change any of your selections, click the respective task and do the changes. View the updated changes in the **Review and Submit** task and click **Done**.

The selected items are exported into a smart spreadsheet with:

- Columns specified in the target item view
- One new item class name prepopulated with the target item class.

You must update the smart spreadsheet as required and submit the item import process.

6. Click the **View item batch status** task.

You can use this task to view the **Job ID**, **Job Status**, **Submitted Date**, and **Batch Name** of the Item Import scheduled process. You can click **Refresh** to view the progress of the scheduled process.

When the **Job Status** changes to **Succeeded**, then you've successfully completed the Guided Task flow. If the batch fails, then you can rerun the task flow after resolving the issue.

Perform Guided Task Flow to Mass Assign Items to Catalog Categories

You can use the guided task flows that belong to the guided task category called **Assign Items from Catalog Categories** available in the guided task library to assign multiple items to catalog categories in a single action.

Each Assign Items from Catalog Categories guided task flow, at minimum, includes the following tasks:

1. Select items to assign
2. Select catalog category to assign
3. Review and submit
4. View item batch status

When running the task flow, you must navigate to each task in the same order it's listed. To complete a task, click **Done** for each task. However, until you complete the **Review and submit** task, you can't revisit any of the prior tasks in the task flow and make changes.

To mass assign items to catalog categories:

1. On the Product Management page, in the **Actions** panel, click **View all actions** and then click **Guided Tasks**.
The Perform Guided Tasks page is displayed.
2. Click the guided task flow that you want to run belonging to the **Assign Items to Catalog Categories** category, and then click **Start Guided Task**.
3. Click the **Select items to be assigned** task. From the **Master organization** drop-down list, select the master organization from which you want to select the items. Select the items you want to assign, and then click **Save**.
4. Click the **Select the target catalog categories** task. Select all the catalog categories that are relevant to this task flow, and click **Save**.

5. Click the **Review and Submit** task. Review the selections and choices you've made. If there are no changes, click **Done**. This will submit the **Item Import** scheduled process.

Note: To change any of your selections, click the respective task and do the changes. View the updated changes in the **Review and Submit** task and click **Done**.

6. Click the **View item batch status** task.

You can use this task to view the Job ID, Job Status, Submitted Date, and Batch Name and the status of the scheduled process. You can click **Refresh** to view the progress of the scheduled process.

When the **Job Status** changes to **Succeeded**, then you've successfully completed the Guided Task flow. If the batch fails, then you can rerun the task flow after resolving the issue.

Perform Guided Task Flow to Mass Unassign Items from Catalog Categories

You can use the guided task flows that belong to the guided task category called **Unassign Items from Catalog Categories** available in the guided task library to unassign multiple items from catalog categories in a single action.

Each Unassign Items from Catalog Categories guided task flow, at minimum, includes the following tasks:

1. Select items to unassign
2. Select catalog category to unassign
3. Review and submit
4. View item batch status

When running the task flow, you must navigate to each task in the same order it's listed. To complete a task, click **Done** for each task. However, until you complete the **Review and submit** task, you can't revisit any of the prior tasks in the task flow and make changes.

To mass unassign items from catalog categories:

1. On the Product Management page, in the **Actions** panel, click **View all actions** and then click **Guided Tasks**. The Perform Guided Tasks page is displayed.
2. Click the guided task flow that you want to run belonging to the **Unassign Items to Catalog Categories** category, and then click **Start Guided Task**.
3. Click the **Select items to unassign** task, select the items you want to unassign, and then click **Done**.
4. Click the **Select catalog category to unassign** task, select the catalog categories from which items must be unassigned and click **Done**.
5. Click the **Review and Submit** task. Review the selections and choices you've made. If there are no changes, click **Done**. This will submit the **Item Import** scheduled process.

Note: To change any of your selections, click the respective task and do the changes. View the updated changes in the **Review and Submit** task and click **Done**.

6. Click the **View item batch status task.**

You can use this task to view the Job ID, Job Status, Submitted Date, and Batch Name and the status of the scheduled process. You can click **Refresh** to view the progress of the scheduled process.

When the **Job Status** changes to **Succeeded**, then you've successfully completed the Guided Task flow. If the batch fails, then you can rerun the task flow after resolving the issue.

Perform Guided Task Flows to Create Common Structures in Bulk

You can create a common item structure across multiple organizations by using guided tasks. Select and start one of the guided tasks for common structures configured by your administrator.

Depending on the configuration of the guided task, once you've made your selections, the changes will be applied directly to the selected structures of the items in selected targeted organizations, structure names, and levels or added as affected items to the change order through the scheduled process for engineering and commercial item structures.

Here's an example that shows how you can create a common structure for laptops.

1. Navigate to the Product Management work area.
2. In **Actions**, click **Guided Tasks**.
3. Search for and select one or more items you want to make common.
 - o Select one or more items belonging to the organizations configured by your administrator. Note that Items will be filtered based on the organization selected in the configuration. For example, if you have authored your structure in Product Development, you can select the master organization for the common structure.
 - o If the item has multiple item structure names such as Primary and Planning, then all those structures will be part of a common structure on target items.
4. Select target organizations, structure names, and levels you want to make common.

Select one or all organizations configured by your administrator, followed by the levels you want to make common.

The items will be filtered based on the configured target organizations, structure names, and structure levels. You can override the configured target organizations and choose other target organizations.

Your administrators can configure three levels: **All Levels**, **One Level** or **Specified Levels**.

For example, consider a scenario where you're creating a common structure for laptops across organizations. Here are the details of the laptop.

- o Laptop2050 belongs to organization V1 and includes structures Primary and EBOM_KM.
- o Laptop2051 belongs to organization V1 and has only a Primary structure.
- o Target organization is M1 and all levels must be common.

5. Review and submit the task for creating common structures.

You can view the summary of the selections from your previous tasks.

You can view the following:

- Item structure from the source organization being created as a common structure across the selected target organizations.
- Structure names in which the item structure is being created as a common structure.
- Number of structure levels being created as common: **All**, or **Single Level**, or **Specified Levels**. For example 1, 2, or 5.

When you click the **Done** button, a scheduled process will be submitted to create common item structures.

You can monitor the progress of the scheduled process.

View Guided Task Flow Status

You can monitor the status of the submitted flows and continue any guided task flow that wasn't completed in the Perform Guided Tasks action.

Monitor Guided Task Flows

To view the guided task flow status:

1. In the Product Development or Product Information Management work area, click the **Tasks** panel tab, and then click **View Guided Tasks**.
The View Guided Tasks page is displayed.
2. Use the filters or specify the search criteria in the **Search** box to display a list of guided task flows with the status **Open**, **In Process**, or **Completed**.

Continue Pending Guided Task Flow

To continue a pending guided task flow:

1. In the Product Development or Product Information Management work area, click the **Tasks** panel tab, and then click **View Guided Tasks**.
The View Guided Tasks page displays the list of guided task flows that aren't completed (status as **Open**). If it isn't displayed, use the **Status** filter chip and search for guided tasks flows with the status as **Open**.
2. Click the guided task flow that you want to complete.
3. After the guided task flow opens, go to the task that must be completed.
4. Review the task and make changes if required. Click **Done** to run the task.
5. After the guided task flow is completed, the status changes to **Completed**.

22 New Item Requests

Create New Item Requests

New item requests are created to define item information and its entities, including specifications, structures and packs, and relationships. In addition to being defined, the new item requests are also routed for approval.

Before you create a new item request, be sure to enable the item class for the new item request. Use the Manage Item Classes task to modify the item class.

Use one of the following to create the new item request.

- **Quick Submit:** To quickly create the new item request by making use of prefilled item data. Here, you can't add the new item to an existing new item request.
- **Submit:** To submit the item to an existing new item request or create a new one.
- The item import process.

Additionally, a new item request is automatically created when the item lifecycle phase changes to preproduction or production through a change order. This is only applicable for items created in the Product Development work area and when the number generation method is Sequence-Generated.

Here's how you use Quick Submit:

1. In Item Management, click **Create Item**.
2. In the Create Item dialog:
 - Select **Create New**.
 - Be sure to select an item class that's enabled for new item request.
 - Enter the item details and **OK**.
3. In the Create Item page, enter additional item details.
4. Click **Quick Submit**.

The new item request is created in the Open status.

5. Enter any additional information. Click **Save**.

Here's how you use Submit:

1. In Item Management, click **Create Item**.
2. In the Create Item dialog:
 - Select **Create New**.
 - Be sure to select an item class that's enabled for new item request.
 - Enter the item details and **OK**.
3. In the Create Item page, enter additional item details.
4. Select Create New Item Request and click **Next**.
5. Enter the details of the new item request. Click **Save and Edit**.

The new item request is created in the Draft status.

6. Enter any additional information. Click **Submit**.

Here is a description of fields appearing on the Create New Item Request page:

Additional Information

You can add Descriptive flexfields as additional attributes for the new item request.

Need-by-Date

The date by which the new item request must be approved. This is mandatory to track new item requests which fail to meet the deadline. If the new item request isn't approved by this date, the details are appended to the Items Pending Approval infolet displayed in the Product Information Management work area.

Add Attachments

You can add attachments when you create a new item request. You can also edit attachment details and remove attachments from an open new item request.

Attachments include the following file types:

- Files and folders from your desktop or a configured repository.
- Text files generated during the attachment process.
- URL links.

Note: New item requests support multiple items across different item classes. Each item can be routed to different assignees for definition, because the definition steps are defined at the item class level.

After you submit new item request, a request comment notification is normally sent to predefined assignees, but if **Skip Request Comment** is checked, request comment notifications aren't sent.

Bypass New Item Request for Configured Items

Configured items are automatically created when the end items are configured based on the model items in a sales order. These configured items should not be added to the new item request even if the item class is enabled for new item request. Such configured items aren't relevant for the new item request process. Hence, configured items created based on model items that belong to an item class and mandates new item request are skipped. You can identify configured items based on the following attribute settings:

- **Autocreated Configuration** – Set to **Yes**.
- **Structure Item Type** – Set to **Standard**.
- **Base Model** – Has a value and isn't null.

New Item Request Workflow

You can execute tasks on predefined statuses for new item requests, but you can't create or delete statuses or workflows. You can also process item approvals for master and child organizations concurrently.

Predefined Workflow Statuses

Here are the predefined statuses for new item requests:

- Open
- Definition
- Approval
- Scheduled
- Completed

Open

As an assignee, you can add items and attachments.

As an administrator, you can configure whether a request comment notification sent to the user is required. If it's required, the new item request can't move to the next status until the assignee responds to the notification.

Here's how you configure the request comment notification:

1. In the Setup and Maintenance work area, use the following:
 - Offering: Product Management
 - Functional Area: New Item Requests
 - Task: Manage New Item Request Type Details
2. In the Open status, use the **Skip Request Comment** option.

Definition

As an administrator, you can configure the definition workflow at the item class level. Based on the definition steps, a notification is sent to assignees for defining the item. Once the item is defined, it can be promoted to approval status manually or automatically approved by the BPEL process.

As a definition task assignee, you can define item information such as specifications, structures, packs and so on. But you can't add additional items in this status or create a new workflow.

Approval

Approval notifications are sent to approvers based on whether the assignment method is rules-based, or user defined. Once the approval is granted, the new item request can't be modified.

Scheduled Status

After all the necessary approval is received, the new item request is automatically promoted to the Scheduled status.

Completed

After the new item request is scheduled, a job is triggered and status is automatically changed to Completed.

Note: To view the last updated date for new item requests created before update 22D, see the **Completed On** column in the definition workflow section.

Process Child and Master Organization Item Approvals Concurrently

You can use a commercialization change order to enrich child organization items while a new item request is in progress for the master organization item. You can initiate the commercialization workflow processes without waiting for the new item request process to complete.

Here are some details on processing child and master organization items concurrently:

- When you add an unapproved child organization item to a change order, the item's **Approval Status** will be based on the completion status of the new item request for the master organization.
 - If the change is completed but the new item request isn't completed, the Approval Status of the child item is set to **Approved** when the new item request is completed.
 - If the change isn't completed before the new item request is completed, the approval status of the child item is set to **Change Order in Progress** until the change order is completed. Once the change is completed, the approval status will change to **Approved**.
- Impact on configured rules:
 - If the new item request for the master organization item is completed before the change order for the child organization item is approved, rules that are based on child organization approval status (Status = Approved) won't be triggered. It's recommended that you use change order entry and exit criteria to validate child item data. You must reconfigure entry and exit criteria to validate data on child organization items that are approved after the master organization items.
 - You can use configured rules to validate child organization item approval status (Status= 'Change Order in Progress'). Rule-related errors are recorded in the action log of the new item request.
- If you remove an unapproved child organization item from a pending change order, either by deleting or canceling the change order, then the child item must be added to a new change order to route it for approval. Once the child organization item has been added to a change order, it can't be approved through the new item request process.
- If an unapproved child organization item is on multiple change orders, the first child organization change order that becomes complete after the master organization new item request is complete will set the child organization item to Approved.
- You can't add unapproved items to a change order through import.
- If you haven't added an unapproved child organization item to a change order, then the new item request for the master organization item will approve both the master and child items.
- You can't add unapproved master organization items to a change order.

Understand New Item Request Notifications

During the new item request workflow notifications are sent out to assignees, approvers, and requester; consolidated notifications are sent out to assignees.

For a detailed list of new item request notifications, notification types, and recipients, refer to [View Product Management Notifications](#) available on the Oracle Help Center.

Note:

- If the approval notifications are delayed ensure that approvers have the following privilege: Generate Item Change Order Report (EGO_GENERATE_ITEM_CHANGE_ORDER_REPORT_PRIV)
- A line which is rejected by an approver appears as read-only in the notification.
- Here's a list of actions that aren't available for new item request notifications:
 - Skip Current Assignment
 - Suspend
 - Create Subtask
 - Request Information
 - Route Task
 - Add Comments

Claim Tasks from Notifications

For the **Claim** action to be enabled,

- Your administrator must set the value of **Response Required From** field as **One** and **Assignee Type** field as **Role**. (This is available in the Setup and Maintenance work area. Execute the Manage New Item Request Type Details task in the Product Management offering.)
- The **Auto Claim** option in BPM Worklist must be disabled. (To access this search for Manage Task Configurations for Supply Chain Management and select the New Item Requests functional area.)

When an approver or definition task assignee selects the **Claim** action on a notification, the notification is locked against changes by other approvers, unless the first approver unlocks it by using the **Release Claim** action.

New Item Request Notifications

You can review, approve and reject workflow requests in both the in-app and email notifications for new item requests.

Approval Notifications

Note: To use this feature, you must opt in to the feature Redwood: Use Redwood-Style Approval and Review Notifications.

Here are the attributes that are displayed in the new item request approval notifications:

- In the Details section:
 - New Item Request Number: Link which opens the NIR details in a new page.
 - Approval Status
 - Activity Type: It's either optional approval or approval.
 - Expiration Date: Date when this approval request will expire.
 - Response Required From: Requires response from one assignee or from all the assignees.
- The Line items section includes the new item number, item description, item class, effective date, and item status

FYI Notifications

Note: To use this feature, you must opt in to the feature Redwood: Use Redwood-Style FYI Notifications.

New Item Request FYI Notifications

Here are the attributes supported in the New Item Request FYI Notification (excludes Send Objects Notification):

- In the Details section:
 - Object Number: Link that opens the change details in a new page, depending on your profile option.
 - Object Description
 - Approval Status
 - Need-By Date
 - Priority
 - Reason
 - Comments: This is conditional. Comments provided by you're displayed only when the object is approved, deleted, rejected or canceled.
 - <Rejected/Approved/Removed/Canceled> By: User who made the action.
 - Reject Reason: The reason is shown only when object is rejected.

- The Tasks section: includes task name, description, Required, Start-by Status, Complete Before Status, Task Status, Assigned To, Need-by Date, Assigned By, Assigned On. This is shown only in Task Assigned Notifications.
- When promotion fails, the Message section displays the following message: Error in workflow, see object action log for more details.

Send Object FYI Notifications

Let's look at the attributes in the Send Object FYI Notifications.

- In Contents section:
 - Object Type
 - Sent By
 - Recipients
 - Object Number or Object Name
 - Notification Type
 - Message: Message displays the comments you've provided when you send the notifications.

Assigned Notifications

You can now view the details in Assigned Notification. Click the link in your notification to review the details, or review the details in your email notification.

Here are the details that are available in the Assigned Notification:

- In the Details section:
 - Object Number: Link that opens the change details in a new page, depending on your profile option.
 - Object Description
 - Assignee
 - Assigned Date
 - Approval Status
 - Need-By Date
 - Priority
 - Reason
 - Task Number
- The Affected objects for Item (for New Item Request) section: includes the Affected Item Number, Item Description, Item Class, Effective Date, Item Status, Status, Request Id.

Important Considerations

- After you've opted in, the application automatically uses the new predefined Oracle Analytics Publisher Template:
 - Workflow Notification Report
 - Workflow Item Send Notifications Report
 - Send Object Notification Report
 - Workflow Send Object Notification Report
- To display additional attributes in the notification, you must configure the new predefined template.

Requires Comment Notifications

You can view requires comment notifications for new item requests when the status changes from draft to open and the **Skip Request Comment** option (on the new item request type) is deselected. This is supported in both the in-app and email notifications.

Once the comment is submitted, an FYI notification with task completion details is sent to the assignee. Depending on the configuration, new item requests can be moved from open to the next status either automatically or manually.

Here are some details:

- To use this feature, you must opt in to the feature Redwood: Use Redwood-Style Comments Required Notifications.
- Once you opt in, the application will automatically use the new predefined Oracle Analytics Publisher Template: Workflow Required Comment Notification Report.

The following attributes are available in notifications:

- Organization
- Object Number: Link that opens the change details on a new page
- Description
- Assignee
- From: Only appears when an action is required
- Assigned Date
- Outcome: Only appears when a task is completed
- Approval Status
- Need-By Date
- Task Number
- Priority
- Reason

Definition Required Notifications

You can receive definition required notifications in the new format for new item requests when you're the assignee. This is supported in both the in-app and email notifications.

Here are some details:

- To use this feature, you must opt in to the feature Redwood: Use Redwood-Style Definition Required Notifications.
- After you opt in, the application automatically uses the new predefined Oracle Analytics Publisher template. You don't require any other action to enable this notification.
- You must navigate to New Item Request definition page to review task details and update the details.
- The Add comments and Add attachments are only recorded on the definition notification, they aren't recorded on the new item request object.

Let's look at the attributes that are available in notifications:

- Organization
- New Item Request Number: Link that opens the new item request definition details on a new page
- Description
- Assignee
- Assigned Date
- Approval Status
- Need-By Date
- Priority
- Reason
- Task Number
- Step Sequence Number

In addition, you'll also see the following attributes in notifications:

- Item Number
- Task Status

When the number of new items that require definition exceeds 25, you'll see a **More Items** link. Click the **More Items** link to view the complete list of items and tasks.

When the definition task is completed, you'll receive a task completed notification.

Define Items

You can define item information such as specifications, structures, packs and so on. Note that this depends on the definition task configured by your administrator.

How You Define Items

Here's how you define items from the new item request.

1. From the **Manage New Item Requests** page, search for the new item request in which you want to define the item.
2. Open the new item request, click the Details tab and select the Definition workflow status.

3. To view the definitions tasks, expand the Workflow Details section.

To filter the tasks, use the **Show** list. Here are the options in this list:

- **Current Tasks:** Tasks assigned to all users in the selected definition step.
- **My Current Tasks:** Tasks assigned to the logged-in user in the selected definition step.
- **My Tasks:** Tasks assigned to the logged-in user in all the definition steps.
- **All Tasks:** Tasks assigned to all users in all the definition steps.

Here are the key fields appearing in Workflow Details.

- **Step Sequence Number:** The number assigned to the definition step by your administrator. Note that a parallel workflow consists of multiple rows of the same step sequence number with different tasks.
- **Assigned to:** The role or the user ID of the person to whom the task is assigned.
- **Response Required From:** Whether the response is required from one or all users in the role.
- **Owner:** For tasks in progress, displays the user name of the person who claimed the task.
For tasks that are complete, displays the user name of the person who completed the task.

Note: Some of the fields and options appear only if your administrator has opted in for the feature Control Role Expansion: New Item Request Definition.

4. Click the **Go to task** icon against the task you want to define.

5. If your administrator has assigned the definition step to a role and set the value of **Response Required From** as **One**, you must claim such tasks before you define the item.

- **Claim Task:** Claim a task assigned to you in the definition step. For example, claim the current task which belongs to step sequence number 10.
- **Claim All Tasks:** Click the down arrow next to the **Claim Task** button and select **Claim All Tasks**.
Claim all the tasks assigned to you in the definition step. For example, if you open a task in step sequence number 10, then you can claim all tasks assigned to you in step 10.

6. Define the item by entering attributes or item entities configured by your administrator.

After you complete the definition task, you must set the task status as Completed and click the **Mark Complete** button. The application saves your changes and closes when you click **Mark Complete**.

You can also define the item using the definition notification. Here's how:

1. Open the definition notification.
2. Expand the item and click the **Go to Task** icon against the item you want to define.
To view the recent updates made to the task, click the **Refresh** icon.

Release Claims

If you have claimed a definition task that requires a response only from one user, you can release the claim so that it can be claimed by another user with the same role.

Click **Release Claim**, to release the claim from the task you claimed in the definition step.

Click **Release All Claims**, to release all the claims from the tasks you claimed in the definition step. For example, release all the claims you claimed in step sequence number 10.

How Control Role Expansion Impacts Definition Workflow

Here's what you need to know about the feature Control Role Expansion: New Item Request Definition:

- If only one response is required from an assignee and a role is added as the assignee, the role isn't expanded to show its members. All members of the role receive definition notifications, and you can track the task owner and task status in the workflow details section on the new item request. The **Assigned To** field in the notification isn't expanded to show all role members.
- If the definition assignee is a role and **Response Required From** is set to **All**, the role is expanded to show all its members. It's recommended to limit the number of members in a role to less than 50.
- Notifications will be sent to all the assignees added directly or inherited from the role hierarchy, whether the response is required from all or one.
- The **Owner** column isn't automatically populated for new item requests created before update 22C. To populate this column, you can run the following Enterprise Scheduler Service job: Upgrade Product Management Data. Note that this is a one-time activity. The **Owner** column is automatically populated for new item requests created after you opt in to this feature or after update 22C.

Impact on Ongoing Definition Workflows

For pending new item requests that are already in Definition status, here's what you need to know:

- If a task was assigned to a role and **Response Required From** was set to **One**, the role is expanded.
- For all the incomplete definition tasks assigned to roles, you can use the **Go to Task** icon on the notification to continue the definition tasks (on a pending new item request) or you can terminate and restart the definition workflow.

Infolets for New Item Requests

The infolets for new item requests in the Product Information Management work area help you keep track of new item requests that are assigned to you.

- **New Item Requests (Priority):** Shows open new item requests by priority (High, Medium, and Low), based on values specified in the Priority field for the items. Only new item requests that are in Open status and past the Need-By date are shown.
- **Items for Definition:** Shows the number of items that are currently in the Definition status.
- **Items Pending Approval:** Shows the number of items currently in the approval status.

Note: The count in the Items for Approval infolet and Items for Definition infolet is restricted to the new item requests that are assigned to you. You can't see the count of items assigned to anyone else.

What Happens to New Item Requests Without Approvers

If approvers aren't assigned to a user-defined workflow of a new item request, at runtime, the status of the new item request changes to Approval, but notifications aren't sent. As a result, the workflow is 'stuck' in the Approval status.

How You Manage Stuck New Item Requests

To resolve the 'stuck' new item request, you must cancel the new item lines or the entire new item request. You can cancel the new item request in any status except in the Completed state. Once you cancel an item line, it no longer appears in the new item request notifications. You can delete the new item request after:

- moving new item lines to another new item request.
- canceling all the new item lines.

Note: You can demote a new item request in the Definition, Scheduled, Scheduled (Failed) and Approval (Rejected) statuses. But you can't demote the new item request in Completed or Canceled status.

FAQs for New Item Requests

Why is the newly created new item request unavailable in the new item requests infolet on the home page?

New item requests in the Draft status aren't appended on the home page; they're appended once you promote them to the Open status.

In a new item request, what's the difference between submit and quick submit?

In Quick Submit the following fields are filled automatically: new item request name, number and description. Where as in Submit, you enter the new item request name, number, and additional details across multiple windows.

You can only append a single item when using Quick Submit. But you can append more than one item when using Submit.

The table shows which fields are automatically filled based on the number generation method.

Rule or Sequence Generated Numbers	User-Defined Numbers

How can I promote a new item request?

To promote a new item request, first review your notifications.

On the notification, go to the Manage New Item Requests tab and select the row containing your new item request. From the Actions menu, select Promote. In the Promote dialog box, you can select from the available phases to promote the new item request. You must enter a comment when promoting a new item request to the next phase.

Can new item requests be automatically promoted and demoted?

Yes. You can set up automatic promotion and demotion rules at the new item request type level.

What are the workflow phases of a new item request?

The New Item Request will go through the following workflow phases:

- Open: The new item request is created and items are added.
- Definition: Participants define item attributes and item entities, such as structures, packs, and organizations.
- Approval: Participants approve or reject the items.
- Scheduled: After approval, the request is promoted to a Scheduled status.
- Completed: When the effective date of its associated item is reached, the new item request is promoted to a Completed status.

How can I associate items with a new item request?

Items are associated with new item request in one of the following ways:

- From a new item request: Search for and select items in the Items table.
- From an item: Add the item to an existing new item request or create a new request.
- From an item import: Add the imported items to an existing new item request or create a new request.

What's an action log?

The action log provides an audit trail of all actions performed on the new item request.

The first entry indicates when the new item request was created and by whom. Subsequent actions will be listed to show the progress of the new item request. For example, submitted and promoted to definition.

From the **Action Log**, you can initiate a discussion by posting and assigning a new comment, respond to requested comments or reply to specific comments, thereby creating a threaded discussion within the context of the new item request.

Here are some additional details:

- The **Comment** column in the action log table shows additional information about an action.
- The **Author** column shows **System** when an action is performed by the application.
It shows the user name when the action is performed by a user.

Note: In OTBI, the **Author** column doesn't show System when an action is performed by the application.

The table shows some of the actions performed by the application, and the entries in the **Comment** and **Author** columns:

The table shows some of the actions performed by the user, and the entries in the **Comment** and **Author** columns:

How can I post a comment in new item request?

You post comments in the Comments section available on the contextual pane within the new item request. This section is available on all New Item Request pages.

You can also post comments from the **Action Log** by selecting the **Post Comment** link.

How can I request a comment in a new item request?

You request a comment in the Action Log by clicking the Request Comment button. A Request Comment dialog box will appear for you to assign and enter your request.

Can I approve only two out of three item lines in a new item request?

Yes. In the new item request approval notification, select the **Include in Approval** check box against items you want to approve.

Can I process a change order for a child organization item before completing the new item request for the same item in the master organization?

You can concurrently process a commercialization change order and a new item request on the same item in the child and master organization.

How can I move lines (items) from a new item request?

On the Manage New Item Request page, expand the search results and select lines from one or more new item requests within the same organization and then select **Move New Item Lines**.

You can move the selected lines to a new New Item Request or add them to an existing New Item Request.

How can I cancel a new item request?

On the Manage New Item Requests page, select the new item request you want to cancel. Click **Actions > Cancel**. The new item request status is set to canceled and any changes defined for items are discarded.

Note that you can't cancel a new item request in the **Completed** status.

How can I delete a new item request?

On the Manage New Item Request page, select the new item request to be deleted and then select the **Delete** action.

Once a new item request has been added to the delete group, the request will be unavailable and you can't reverse the delete.

How can I demote a new item request?

While reviewing your notifications, go to the Manage New Item Requests tab and select the row containing your new item request.

From the **Actions** menu, select **Demote**. In the Demote dialog box, you can select from the available phases to demote the new item request. You also must enter a comment when demoting to another phase.

When can items be added to a new item request?

Items can only be added when the New Item Request is in a draft status and an open phase.

What happens when I add a new user to a role that's assigned to an ongoing definition task?

Let's say that a new item request is in the definition phase. The definition task is assigned to a role that has multiple users, and the task isn't claimed by any user.

You add a new employee as a new user in the role (which is assigned to the task). Here are answers to questions you may have.

Does the new user receive any notification immediately?

No.

Can the new user claim the definition task immediately?

No.

How does the new user claim the definition task?

You must demote the new item request and promote it again to the definition phase. All users receive notification about the definition task. The new user can claim the task from the notification.

What happens if a user quits the organization after claiming all tasks in multiple new item requests?

This results in a stuck workflow. But you can resolve this by demoting new item requests and promoting them again to the definition phase.

Note: You can't release or reassign the definition task to another user even if the user has the claim task role.

Why did the workflow stop responding?

In change orders and new item requests, the workflow can stop responding due to one of the following reasons:

- Approval rule has an empty approval group.
- Approval rule not being associated with an approval group.
- An invalid approver. The user or role selected as an approver doesn't exist in the application.
- One or more lines don't match any rules in the approval task.
- Extensible flexfields not being generated.
- Inactive rules.
- Rules unavailable for the header stage.
- A new item request definition step assigned to a role and the role not being assigned to any user.
- An error in SOA workflow. Use Enterprise Manager to view workflow errors.
- Use of an incorrect case to specify the value of a parameter such as priority code.

Why is my approval rule not working in a new item request?


An approval rule may not work due to one of the following reasons:

- You haven't set the assignment method in the new item request type as **Rules Based**.

Open the **Manage New Item Request Type Details** task and change the **Assignment Method** in the approval workflow.


- You selected the **Ignore Participant** option for the rule. To include the participant:
 - Navigate to the BPM Worklist.
 - In the Assignees tab, select the participant. Click the Advanced tab.
 - Deselect **Ignore Participant**.

Here's the screen that shows how you include the participant:




- You selected the **Ignore Stage** option. To include the stage:
 - Navigate to the BPM Worklist.
 - In the Assignees tab, select the participant and then select the stage. In the UI, stage is the region that encloses the participant.
 - Click the Advanced tab.
 - Deselect **Ignore Stage**.

Here's the screen that shows how you include the stage:



- The **NewItemRequestHeaderRuleSet** isn't active. To activate the rule set:
 - Navigate to the BPM Worklist.
 - Select the participant. Click the diamond icon and then select **Go to rule**.
 - Click **Show Advanced Settings** (or the double down arrow icon) that appears next to the rule set.
 - Select **Active**.

Manage Item Supplier Associations

Managing item supplier associations involves creating associations between items and supplier addresses for an item organization, updating these associations, and deleting the associations.

You create item supplier associations while creating or editing an item for an organization.

Note: Item supplier associations are only used for master data management. They're not used within supply chain or procurement transactions. For example, you can create an item supplier association in the Product Information Management work area for a supplier SUPPA123, after that supplier has been created in the Suppliers work area. But you can't use the item supplier association to provide the supplier and site information in the shipment details for a sales order from supplier SUPPA123 in the Order Management work area. You can employ item supplier associations for reporting and supplier management, using the relevant Product Management subject areas within Transactional Business Intelligence.

Assign Supplier Associations to Organizations

On the Manage Items page, search for and edit an item belonging to a specific organization. From the **Edit Item** page, select the **Associations** tab and then the **Supplier Organizations** subtab. On the Supplier Organization Associations table, select **Select and Add** from the **Actions** menu, or click the **Select and Add** icon. Use the resulting **Select and Add Supplier Organization Associations** dialog to search for, select, and add suppliers.

Once the selected suppliers are added, save the associations, by saving the item.

Temporarily Suspend Supplier Associations

Supplier associations are active, by default, but you can temporarily suspend associations using the Supplier Organization Associations table. You can set a single association to being inactive by selecting the value **Inactive** in its **Status** column. You can revert it to active status at any point by selecting the value **Active**. You can change the status of multiple associations simultaneously by selecting multiple rows of the Supplier Organization Associations table, selecting their status from the **Edit Status** list of values and clicking the **Change** button.

Specify a Primary Supplier for an Item Organization

You can designate a primary supplier for the item. There can be only one primary supplier for one item organization association.

To designate a primary supplier, select the **Primary** check box for the supplier in the Supplier Organization Associations table. Then save your update.

Delete Item Supplier Associations

To remove a supplier association from an item, select the supplier from the Supplier Organization Associations table, then select **Delete** from the **Actions** menu, or click the **Delete** icon. In the Delete Item Supplier Association dialog box,

add the association to an existing delete group, or create a new delete group. Select the Manage Delete Groups task to process the delete group. The associations will be deleted completely when the delete group has been processed.

How to Manage Supplier Access

To provide supplier access to an item, navigate to the Manage Items page, select an item, and open the Edit Item page.

Select the **Item People** tab, where you can add, delete, and modify the groups and persons that can act upon the item, and the actions available to each group or person.

Item grants to supplier users can be managed at the item level. This gives you granular control in providing supplier users with access to one or more items, on an ad-hoc basis.

Grants to supplier users can also be maintained at the item class level (as instance set level grants), if supplier users need access to all items within an item class.

Note: Since the security actions defined for an item class are inherited by the items in the item class, those actions cannot be modified at the item level. Security actions defined for an item class are defined in the Setup and Maintenance work area, using the Manage Item Classes task, where you select item class people and actions on the Security tab for an item class.

FAQs for Supplier Collaboration

What's the difference between item supplier associations and the approved supplier list?

Item supplier associations indicate the supplier and address from which an item is supplied and the item organization to which it's supplied. You create these associations by editing an item in the Product Information Management work area.

The approved supplier list is where you define your approved suppliers, sites, and other information for procuring specified items. You create entries on this list with the Manage Approved Supplier List Entries task in the Purchase Orders and Purchase Agreements work areas. Suppliers themselves are created in the Suppliers work area.

24 Item Status

Overview of Item Status

Every item has an Item Status attribute. By setting the item status, you can change the default values for a subset of operational attributes referred to as status-controlled attributes of the item, according to how the status has been set up.

Set Up Item Statuses

You can use predefined item statuses, and also define your own statuses.

To create, edit or delete item statuses, use the **Manage Item Statuses** task:

- Offering: Product Management
- Functional Area: Items
- Task: Manage Item Statuses

The predefined item statuses are:

- Active
- Inactive

For each item status, the **Details** section of the Item Statuses page contains the operational attribute groups and status-controlled attributes governed by the selected item status. The same set of status-controlled attributes applies to all statuses. You define how the item status affects each attribute.

The defined status-controlled attributes are listed under the reference for the **Item Status** attribute, which is a member of the Item Main specifications. Examples of status-controlled attributes are Build In WIP, Customer Orders Enabled, and Invoice Enabled. All of the status-controlled attributes have the values Yes and No.

Whenever a defined status is applied to an item by a user, the value of each of the status-controlled attributes in this list is set to the value you choose here, subject to the usage you select. Note that the affected attribute value in the item might not be different after the item status is applied.

To set the values and usages for the status-controlled attributes, in the Details table, set the **Attribute Value** control to **Yes** or **No**, then set the **Usage**. The usage values are:

- Defaulted - Lets you override the value during the import and update of an item.
- Inherited - Sets the values of the item status-controlled attributes when the status value changes. You can't override the value.
- None - The item status attribute values won't be changed.

Any change made to an item status isn't applied automatically to existing items. The change will be applied when the item status value is next changed while editing the item.

The **Controlled at** field isn't editable and is populated from the value set on the Manage Attribute Groups page.

Apply Item Statuses

You can use an item status to change the default values for status-controlled attributes.

To set the item status of a particular item, select a value of the **Item Status** field on the Edit Item page for the item.

When you change the item status of an item, that status can change the default values of the status-controlled attributes of the item, depending on how the item status has been set up. In turn, the status-controlled attributes can change the value of certain operational attributes, which can affect the actions that you can perform on the item.

FAQs for Item Status

How can I change an item's status?

You can change an item's status by selecting the appropriate item status on the Edit Item page. Based on the status setup, either the status attributes are inherited or defaulted.

You can also change the status through a rule. For example, you could create a rule that if the attribute's lifecycle phase is production, the item status can be changed to active.

How can I make changes to item organizational assignments?

Organization assignments allow items created in a master organization to be used in other organizations, enabling you to control the visibility of an item in organizations. For example, certain items may not be assembled, sold or purchased in a specific organization.

You control the visibility of an item by assigning it to a specific organization.

Similarly you can control specific attributes at organization levels. For example, an item can be sold in a specific organization (region) but not permitted to be sold in other regions. You do this by controlling this attribute at the organization level.

Can I make changes to item organization assignment and route it for approval through a change order?

Yes. You can enable an item in a child organization through a change order. By providing an effective date for the assignment, you can ensure that the item is available for transaction in the child organization from the specified date only.

Note that this is only supported in commercialization change orders. If approval routings are enabled for the change order, you can seek approvals on the item organization assignment before enabling the item in a child organization.

25 Change Orders

Overview of Change Orders

Change orders let you process changes to user-defined item attributes, structures, packs, associations, and item revisions.

Product managers can create change orders within predefined change types, author product changes, view product changes, submit changes for review and approval, track change statuses, and implement changes on a scheduled date.

Changes are submitted through a formal review and approval workflow to ensure successful and validated completion of change orders.

Note: The Product Development work area doesn't support approval of change orders at the line level.

Changes to item structures can be implemented in other organizations by propagating change orders to multiple organizations using predefined propagation rules while still having the flexibility to adapt implementation schedules based on individual organizations.

Individual lines in change orders can be moved to existing or new change orders to avoid bottlenecks in processing and implementation.

Note: In the Product Information Management work area, change orders can be accessed through horizontal tabs or side tabs. If the navigation provided in a help topic doesn't match with navigation in the user interface, the administrator might have enabled the Simplified Change Management Interface. If you want to use a different interface, contact the administrator.

Create Change Orders

In the Product Information Management work area, you can create change orders using one of the following methods:

- From the Manage Change Orders pages, by entering the details of the change order. The change order is created in a Draft status.
- From the Item page, by quickly submitting the item to a change order in an Open status.

Create the Change Order in the Draft Status

1. In the Tasks panel tab, click **Manage Change Orders**.

2. Click the **Create** icon on the Manage Change Orders page.

Or

Select **Create** from the **Actions** menu on the Manage Change Orders page.

3. On the Create Change Order dialog, enter the details of the changes order, and click **Save and Edit**.
4. Enter the additional details of the change order, and click **Save**.

Create the Change Order and Directly Submit it to the Open Status

Here's how you create an item and directly submit it to a change order in the Open status.

1. From the tasks panel tab, click **Create Item**.
2. Enter the basic details of the item and click **Save**.
3. Enter additional item details.
4. Click the arrow next to the **Save** icon and select **Save to Change Order**.
5. In the **Save to Change Order** dialog, select **Create Change Order** and click **Next**.
6. Enter the details of the change order and click **Submit**.

The change order is submitted to the Open status.

Manage Change Orders and Change Requests

You can search for and perform actions on changes using the Manage Change Orders and Manage Change Requests pages.

You can filter changes based on type and use other criteria to narrow your search results to the most relevant results. You can also use the **Add Fields** button to add more fields to the search criteria. The fields you add can be configured to appear as columns in search results.

Note:

- To configure the fields appearing in search results, click **View > Show more columns**.
- When you search for the Change Request change type, the search results also include deviation requests.

Here are some actions you can perform from the Manage Change Orders and Manage Change Requests pages:

- Add new change orders or duplicate existing ones.
- Delete change orders by adding them to a delete group. You can delete change orders that are in the **Draft** status. You can delete change orders that are in the **Canceled** status too, but a canceled change order with even one scheduled or completed line can't be deleted.
- Manage the change order workflow by using change order actions: Promote, Demote, Hold, Release Hold, and Cancel.
- Generate change order details report.

Here are some details on the Manage Change Orders and Manage Change Requests pages:

- **Search Filter**

You can use this filter to search by a change type. The default search filter is set to **All Change Types**.

- **Saved Search**

The default saved search is titled Application Default. This is executed when you select a change type.

- **Manage Watchlist**

Use the Watchlist to track important business objects. The watchlist is categorized by the functional areas. Each item on the Watchlist page is made up of descriptive text followed by a count. Click the watchlist item to navigate to the object of interest.

You can create your own watchlist items based on saved searches. Click the **Manage Watchlist** icon on the Manage Change Orders or Manage Change Request page. In the Manage Watchlist dialog box, select the check box **Include Saved Searches** to add the saved searches to the watchlist.

You can use the Watchlist page in the Set Preferences work area (**Navigator > Tools > Set Preferences**) to determine which categories and items to show or hide in the watchlist.

You can create watchlists for corrective actions and problem reports.

Modify Assignee

If your workflow is stuck due to absence of the assignee, you can modify both assignee role and default assignee.

You can modify these fields on the following objects: change orders, change requests, problem reports, and corrective actions if they're stuck.

Before you modify the assignee role or the assignee, here's what you need to know:

- It's recommended that you always populate the **Assignee Role** field on the General Information tab so that the **Assigned To** user can add approvers during the approval workflow.
- The **Assignee Role** field can be edited in the Draft and Open statuses. If the object is in interim or approval status, you must terminate the workflow.
- To modify the **Assignee Role** and **Assigned To** fields, you must have the Manage Assignee privilege. You must also have permission to manage change header attributes as defined in the Additional Workflow Controls table in change type setup.
- If the assignee role isn't defined, the new assignee must have the BPMWorkflowAdmin privilege to terminate the workflow and reassign.
- If the assignee role isn't defined and the new assignee wants to reassign or delegate a task from BPM Worklist, the new assignee must have the BPMWorkflowSCMAdmin privilege to view all the approval tasks in Administrative Tasks.

- You can't edit the **Assignee Role** or **Assigned To** fields for objects that were added prior to the support of Additional Controls in update 20B.
- Only the **Assigned To** user can see the Terminate and Restart actions in the Actions menu. Ensure that a user name is provided in the **Assigned To** field.

Note: If you have modified the assignee's user name during a change order or new item request workflow, an error message appears. To resolve the error, terminate and restart the workflow.

Use Similar Interface for Engineering and Commercialization Changes

In the Product Information Management work area, you can use the Simplified Change Management Interface to access change orders through side tabs instead of horizontal tabs.

This interface is similar to the change order interface in the Product Development work area. You can access some of the change order features available in Product Development. For more information on change orders in Product Development, see the chapter on Change Management in the Oracle Fusion Cloud SCM Using Product Development guide.

Note: This feature is available to you only if your implementor has opted in for the following feature: Use Simplified Change Management Interface.

Here are some of the features available on all change types in the Simplified Change Management Interface:

- Redline an affected object and view the redline summary.
- Promote or demote the change order through the workflow and initiate notifications for approval.
- Add affected objects belonging to the organization from which the change order is created.
- Add affected objects created in Product Development or Product Information Management. If the item is created in Product Development, you can only add items in the following lifecycle phases: prototype or preproduction, and production.
- Edit reference designators inline on the structure tab of the affected object.
- Modify the effective date in a scheduled change order. The modified date must be within the start and end date of the updated component in the item structure.
- Cancel change lines except when the change order is complete.
- Blue tab icons on change orders indicate the presence of content in them. Note that this is applicable only if you've opted in for the feature User Interface Improvements for Items and Changes.

- Perform a comprehensive audit on commercialization change orders. To use this feature your implementor must also opt in for the feature Track Affected Object Redlines and Other Updates on Changes.

If you opt in to Use Simplified Change Management Interface after you have opted in to Track Affected Object Redlines and Other Updates on Changes for some time, you must run the Upgrade Product Management Data scheduled process to migrate change history in the Product Information Management work area.

Features Available on Commercialization Change Orders

Here are some of the features available only on commercialization change orders:

- Create a commercialization change order from master and child organizations.
- Redline and implement changes to substitute components. You can also view the redlines for substitute components.
- Edit component attribute groups in the item structure.
- Terminate and restart the workflow.
- Set up relationships with commercialization change orders, engineering change orders, and change orders without revision control.

The Relationships tab on your commercialization change order displays relationships that are set up from the Product Development and Innovation Management work areas.

- Manage change order propagation.
- View and select a use-up date specified in a supply plan as the effective date for the affected object when you remove or replace a component. You can perform this action from the Affected Objects tab on the change. For more information, see the related links.
- Perform a comprehensive audit on commercialization change orders. To use this feature your implementor must also opt in for the feature Track Affected Object Redlines and Other Updates on Changes.

Note: If you opt in to **Use Simplified Change Management Interface** after you have opted in to **Track Affected Object Redlines and Other Updates on Changes** for some time, you must run the Upgrade Product Management Data scheduled process to migrate change history in the Product Information Management work area.

Considerations for Using Simplified Change Management Interface

In the Simplified Change Management Interface:

- You can't view revision specific changes in extensible flexfields.

Difference Between Affected Object and Change Line

Simplified Change Management Interface and the Product Development work area use "affected object" to indicate an object affected by the change order, whereas the Product Information Management work area uses "change line".

What Change Orders Modify

Create change orders within predefined change types to modify item information and route that information for review and approval.

Change orders modify the following:

- Item specifications: Modify operational and user-defined item attributes.
- Item structures: Add, update, and delete structures.

Note: Components can be disabled only through change orders

- Packs: Add, update, and delete packs and pack attributes.
- Associations: Add item supplier site organization associations, remove existing associations, and modify existing item supplier attributes.
- Revisions: Create new revisions for an item while modifying item information

Changes to item structures can be propagated to other organizations through rules associated with the change type.

Where Change Orders Are Created

Access the Create Change Order process in one of three ways:

- Select the **Manage Change Orders** link on the Tasks panel tab.
- Click the **Create** icon on the Manage Change Orders page.
- Select **Create** from the **Actions** menu on the Manage Change Orders page.

The change order changes items specific to the organization that you select. However, if propagation rules are associated with the selected change type, then you can push changes made to the item structures into other organizations in which the changed item is enabled.

Change type determines how change order numbers are generated, how changes will be propagated to other organizations, and what steps in the workflow are required to complete the change order.

Change order header details include priority, reason, propagation rule, trading partner reference attributes such as customers, suppliers, manufacturers and source, and user-configured attributes.

Note: The trading partner reference attributes are applicable for only commercialization change orders in the simplified change management interface.

On the Overview tab, specify the following information:

- Tasks required to complete the change order
- Attachments providing additional information
- Propagation information

On the Lines tab, add and access individual items to modify attributes, structures, packs, and associations.

Note: Only item details that can be modified through the change order will appear. For example, because catalog assignments aren't supported through change orders, those tabs won't appear on the item details page. Also links on the Specification tabs for attributes that can't be changed through the change order won't appear.

When you submit the change order for approval, you can track approval or rejections for each line in the change order.

Manage Tasks in Change Orders and Change Requests

You can create a checklist of tasks related to the change order (or change request) and assign work to individuals.

You can make it compulsory for certain tasks to be completed by specified users before the change order can progress to a status.

Here are some more details on tasks:

- Your ability to manage tasks depends on the permissions for the Add Tasks, Remove Tasks, and Update Tasks actions in Additional Workflow Controls for the change type.
- You can mark the status of a task and assign tasks even after the change order is complete. Use this to manage post-completion tasks such as documentation or qualification of contract manufacturers. Note that only the change assignee can manage tasks in Completed status.
- The task can't be set as required if the **Complete Before Status** is one of the following: blank, first Open status, Scheduled, or Completed.

Note: Status first Open indicates the first open status in case your administrator has configured additional open statuses.

Here are some examples of tasks:

- Prepare Functional Specification document.
- Review and update cost attributes of affected objects.
- Define regulatory attributes.
- Publish information to Marketing and Sales.

The Tasks table includes the following fields that let you specify task details:

- **Sequence:** Determines the order in which the tasks are performed. By default, this increments by 10.
- **Required:** Indicates that the task is compulsory for the change order to progress. If a task is compulsory, then a **Complete-Before Status** must be specified.
- **Assigned To:** Specifies the person to whom the task is assigned.
- **Assigned By:** Specifies the user who assigned the task.
- **Assigned On:** The date and time when the task was assigned.

Note: If the same task has been assigned by different users, the **Assigned By** and **Assigned On** fields show details of the latest assignment.

- **Start-by Status:** The status at which the tasks should be initiated. Includes current and future statuses, and a blank value. Use the blank value when you want the task to begin irrespective of the change status.
- **Complete-Before Status:** The status before which the task should be completed. Includes future statuses and a blank value. Use the blank value to leave this field blank when **Start-by Status** is set to **Completed**.
- **Need-by-Date:** Indicates the date on which the tasks should be completed.
- **Task Status:** Can be updated only by the task assignee or the change analyst.

Copy Existing Tasks to New Change Orders

You can create a new change order based on an existing one, and copy over the tasks. Use the **Save As** action (in the change order). Tasks in the newly created change order are reset to the Open state.

Change Order Attachments

A change order attachment is unstructured information related to a change order. Examples of change order attachments include CAD drawings, test results, specification sheets, or URLs.

Attachments can be any type of file including:

- Files and folders from your desktop or a configured repository.
- Text files generated during the attachment process.

You can also specify URL links as attachments.

Managing Change Order Attachments

You can add attachments when you create a change order. You can also edit attachment details and remove attachments from an open change order.

Propagate Changes for Each Organization

You can use propagation in commercialization change orders to implement item structure changes automatically across multiple organizations, instead of manually creating change orders for each organization. Here's an example:

Let's say that you have different models of a mobile phone manufactured across locations. You want the microphone structure to be similar across all models. Then you can create a propagation rule so that when you create a change order on the microphone in your central R&D lab, similar change orders with redlines are automatically created across all manufacturing locations.

How changes are propagated across organizations is configured by your administrator in the change type setup.

Prerequisites and Considerations

Before you initiate propagation, here are the prerequisites and considerations:

- Make sure that the structure components you want to propagate (from source organization) are also available in target organizations. Otherwise, an error message appears.
- Propagation is applicable only for commercialization change orders, and you can only propagate item structure changes.
- Both source and target organization components must be in definition organization.

Note: To perform the procedures in this topic, it's recommended to use Simplified Change Management Interface.

How You Propagate Changes

If your administrator has configured the change type to autopropagate, you need not initiate propagation. When your change order reaches the Scheduled status, duplicate change orders in Open status are created.

If your administrator hasn't configured autopropagate, here's how you propagate changes:

1. Navigate to the Affected Objects tab on the change order and complete the item structure changes.
2. Review and approve the change order.
3. When the change order reaches Scheduled status, click Propagation Organizations tab.
4. Select the organization in which you want to initiate propagation and click **Propagate**.

You can also propagate changes from search results. Here's how:

1. On the Manage Search Results, search for commercialization change orders in the scheduled status.

2. Select change orders that are already configured for propagation.
3. Click *Actions* > **Propagate**.

View Propagation Status

When your change order reaches the Scheduled status, a batch job is created to propagate changes across target organizations. Here's how you view the propagation status:

1. Open the change order in your source organization.
2. Click Propagation Organizations tab on the change order and click the **Propagation Details** icon.

Propagation Details icon: Click this icon to view additional details in a new window. To view any error messages, use the horizontal scroll bar in the new window.

Propagation Status icon: Click this icon to view the schedule process ID and the log file.

Exclude Components from Propagation

Depending on your business needs, you can exclude items from propagation. Here are such scenarios:

- As part of localization of item structures, your organization decides to use a component which is different from the one in source organization.
- The component no longer exists in your target organization. So you decide to use a different one.

Here's how you exclude components

1. Open the change order in your source organization.
2. Click Propagation Organizations tab on the change order and click the **Propagation Details** icon.
3. In the Propagation Details window, select the item that you want to exclude and click **Exclude**.

Edit Items from Change Orders

You can add items and author item changes when you create or edit a change order.

You can create new or change existing item organization assignments. Click on the item links on the Lines tab to access the Edit Item page where you can manage item details.

Note: The effective date for the item needs to be specified and saved before the **Edit Item** page can be accessed.

On the **Edit Item** page, you can edit the following item details:

- *Specifications:* On the **Specifications** tab, you can modify predefined and user-configured attributes.
- *Structures and Packs:* On the **Structures** tab, you can add new structures, copy structures, and modify structures by adding new components, removing existing components and modifying component attributes. You can also modify packs by adding new packs and modifying pack attributes.

Note: You can't modify referenced (common) structures through a change order.

- *Associations:* Access the *Edit Change Order* page to modify change order settings and content:

- You can assign an item to a child organization or master organization through a change order. You can process the item in both child and master organizations concurrently.
- You can't add duplicate components to a structure or a parent component to a child component. This applies to both preliminary structures and affected item structures on both, engineering and commercialization change orders.

You can add duplicate components to a structure if you opt in to the feature Add Find Number and Suggested Operation Sequence for Structure Components. This feature allows you to differentiate between multiple instances of a component within a structure using find numbers.

- From a master organization, assign an item to a child organization, add the change to a change order, and route it for approval. You can then enable this item in the child organization, on a specified date.
- From a master organization, you can also create a change order, add a revised item, and make the item organization assignment in a change order context.
- By selecting the appropriate batch-level change order options, you can also make item organization assignments through batches and add them to a change order. But, if change order required rules are triggered for such assignments, they're carried through a change order even if batch options aren't specifically set.
- You can also use change services to add item organization assignments to a change order.

When managing change orders:

- You can enable an item in a child organization through a change order and have the item available for transaction on a specified date.
- If approval routings are enabled for a change order, you can seek approvals on the item organization assignment before enabling the item in a child organization.
- If **Skip Request Comment** is checked, request comment notifications aren't sent to the predefined assignees on submission of change order to Open status.
- You can access item detail through the change order details page by clicking on the item links on the **Lines** tab to access the item detail page.

Edit a Change Order

You can monitor the workflow and modify the change order using the Edit Change Order page.

You can access the Edit Change Order page in the following ways:

- When you create a new change order.
- When you select a change order from the search results on the Manage Change Order page and select **Edit** from the **Actions** menu.
- When you access a change order in view mode by clicking the change order link in the search results on the Manage Change Order page, then select **Edit** from the change order detail page.

Tasks You can Perform from the Edit Change Order page

This table lists the tasks you can perform depending on the status of the change order.

If Status is	Tasks you can perform
Draft, Open	Modify header details such as priority and reason and add or remove attachments.
Draft, Open	Modify the current status of change order tasks.
All statuses	Monitor the current status of change order tasks.
Draft, Open	Modify line details and access item pages for further change
All statuses	Monitor the current status of the change order in the workflow.
All statuses	Review the actions that have been performed on the change.

Additionally, you can perform the following:

- You can assign an item to a child organization or master organization through a change order. You can process an item in both child and master organizations concurrently.
- From a master organization, assign an item to a child organization, add the change to a change order, and route it for approval. This item can then be enabled in the child organization on a specified date.
- From a master organization you can also create a change order, add a revised item, and make the item organization assignment in a change order context.
- By selecting the appropriate batch-level change order options, you can also make item organization assignments through batches and add them to a change order. But, if change order required rules are triggered for such assignments, they're carried through a change order even if batch options aren't specifically set.
- You can also use change services to add item organization assignments to a change order.

Process Child and Master Organization Item Approvals Concurrently

You can use a commercialization change order to enrich child organization items while a new item request is in progress for the master organization item. You can initiate the commercialization workflow processes without waiting for the new item request process to complete.

Here are some details on processing child and master organization items concurrently:

- When you add an unapproved child organization item to a change order, the item's **Approval Status** will be based on the completion status of the new item request for the master organization.
 - If the change is completed but the new item request isn't completed, the Approval Status of the child item is set to **Approved** when the new item request is completed.
 - If the change isn't completed before the new item request is completed, the approval status of the child item is set to **Change Order in Progress** until the change order is completed. Once the change is completed, the approval status will change to **Approved**.
- Impact on configured rules:

- If the new item request for the master organization item is completed before the change order for the child organization item is approved, rules that are based on child organization approval status (Status = Approved) won't be triggered. It's recommended that you use change order entry and exit criteria to validate child item data. You must reconfigure entry and exit criteria to validate data on child organization items that are approved after the master organization items.
- You can use configured rules to validate child organization item approval status (Status= 'Change Order in Progress'). Rule-related errors are recorded in the action log of the new item request.
- If you remove an unapproved child organization item from a pending change order, either by deleting or canceling the change order, then the child item must be added to a new change order to route it for approval. Once the child organization item has been added to a change order, it can't be approved through the new item request process.
- If an unapproved child organization item is on multiple change orders, the first child organization change order that becomes complete after the master organization new item request is complete will set the child organization item to Approved.
- You can't add unapproved items to a change order through import.
- If you haven't added an unapproved child organization item to a change order, then the new item request for the master organization item will approve both the master and child items.
- You can't add unapproved master organization items to a change order.

Change Order Workflow

Each change order follows a process based on predefined and user-defined statuses associated with the change type. The sequence of statuses define the change order's workflow.

At each status in the change order's life cycle, specified change order tasks must be completed before a change order is promoted to the next status.

Each change order workflow definition is associated with a change type. The definition determines the sequence of statuses in the workflow.

- Change order status:
Open, Interim Approval, Approval, Scheduled, and Completed. You can configure the change type to have additional statuses including user-defined statuses.
- Sequence of status:
The sequence of final statuses must be Approval > Scheduled > Completed.
- You can cancel change lines before the change order is in the Completed status.

Rejection Reasons for Workflows

Approvers of a workflow can select one or more rejection reasons when rejecting the workflow from the workflow object, in-app notification, and the overview page.

This applies to all workflow types - change orders, change requests, problem reports, and corrective actions. The selected reasons will be displayed in the History tab and in the workflow history.

Note: You can't specify rejection reasons from your email notification.

You can add **Rejected Reason** as an attribute to your Oracle Transactional Business Intelligence (OTBI) report for approval details.

Change Order Actions

You can propagate changes, move lines between change orders, and manage the life cycle of a change order using the change order actions available on the Actions menu on the Manage Change Orders page.

Actions in the Product Information Management Work Area

Here are some of the actions available on a change order:

- **Promote** and **Demote**: Manually promote or demote a change order to the next status in the workflow for that change type.
The workflow associated with the change type may allow a change order to be automatically promoted or demoted to the next status after the completion of the workflow in a specific status.
- **Hold**: Place a change order on hold. No further action can be taken on the change order.
- **Release Hold**: Release the change order from being on hold, so that further actions can now be taken.
- **Cancel**: Set the change order status to canceled. Any changes defined for items in the change order are discarded.
- **Propagate**: Propagate the selected change order to the selected child organizations.
- **Move Change Lines**: Move the selected change lines to a new change order within the same organization.
- **Reschedule Change Line**: Modify the effective date in a Scheduled change order. The modified date must be within the start and end date of updated or disabled component in the item structure.

If you reschedule a change line which includes a new item component in item structure with start and end date specified manually, rescheduling affects the start date only; the end date is unaltered.

If you modify the effective date in a commercializaton change order and you receive a message that the effective date for the affected line must be after the effective date of the successor item, here's what you can do:

- Cancel the change line and move it to a new change order.
- Resolve revision conflicts for the old revision.
- Edit the effective date of the change line in the new change order.
- Route the new change order for approval and completion.

- **Publish:** publish engineering change orders into an XML report. A process ID is generated for each report. To view the report, click **Tasks > View Scheduled Process** and enter the process ID.

Note: You can retrieve the publication files from Oracle WebCenter Content programmatically, or by using the **File Import and Export** option in the Tools menu of the Navigator.

- **Generate Report:** Produce a detailed report on the selected change order.

How to Use the Action Log on a Change Order

The action log is available on a tab of the Edit Change Order page. The action log displays all actions (and associated comments) executed against or posted to the change order. The action log also contains messages generated by the application.

From the action log, you can initiate a discussion by posting and assigning a new comment, you can respond to requested comments, or you can reply to specific comments, thereby creating a threaded discussion within the context of the change order.

How Application Validates Change Assignee

When you promote or demote a change order (or change request) to the next status, an additional check validates whether the assignee is an active user. This check is performed for each status up to Approval status.

If the assignee isn't an active user, the promotion doesn't proceed. Demotion will proceed, and an entry is added in the action log.

During manual or automatic promotion to Open status, if the application detects that the person who initially requested the change is an inactive user, the change isn't promoted.

During demotion, if the assignee is found to be an inactive user and Skip Request Comment is disabled, the Request for Comment notification isn't sent. A corresponding entry is created in the action log. In this case, the user must choose an active user as the assignee and then promote the change manually.

Cancel Change Lines

If a change order is stuck due to an unforeseen reason, review the details in the History and Workflow tabs. Depending on the workflow, you can cancel the change order or change lines (or affected objects).

Here are some things you need to know before you cancel change orders and change lines:

Manually Cancel the Change Order

Use the Cancel Change Order action. Then the application cancels all change lines except the ones that are complete; the change order status is set to Canceled.

Note: To cancel a change order in the interim approval or approval status, you need the reschedule change order privilege.

Manually Cancel the Change Line

Use the **Cancel** action.

If you cancel change lines in a Scheduled change order which is stuck because the operation post process job is stuck, a message appears that the change line is implemented and the line will be set as Completed, not Canceled. An entry is made in the change history and an FYI notification is sent.

Auto Cancellation of the Change Line

If the application detects an error when implementing or activating the change line, the change line gets canceled automatically. If this happens you notice:

- an entry in the History tab indicating which change line is automatically canceled.
- the change line status appears as Canceled.

To proceed with the change line, you can move it to another change order.

Factors that Determine Whether you Can Cancel Change Lines

The following factors determine whether you can cancel change lines or not.

- the header status in a change order
- the progress on the header status.

Move Change Lines

Here are a few scenarios in which you can move change lines or affected objects:

- The change order is stuck. Depending on the header status, you can move the change line to a new change order and proceed with the change.
- The change order is automatically canceled. Depending on the header status, you can still move the lines to a new change order.

Here are the factors that determine whether you can move change lines:

- The header status in a change order.
- The progress on the header status.

- The configuration for the move change lines action in Additional Workflow Controls for the change type.

If you're on update 21C or later, note that this action isn't controlled by the Reschedule Item Change Order privilege.

Move Duplicate Change Lines

Here are some guidelines before you move duplicate change lines:

- If you need to move two or more duplicate change lines from one change order to another, you must select all lines and move them in a single action. You can't move such lines one at a time.
- If a change line is canceled in the target change order, then you can't move the same item again as a change line to the target change order. You must remove the canceled change line or move it to a different change order before you move the same item to the target change order.

Change Order Approval Process

A change order can be approved only through the successful completion of an approval routing.

When you create a change order, an approval routing is created automatically based on approval rules or manually by any user granted the Item Change Order Management Duty privilege.

An approval routing consists of one or more approval stages. Each approval stage specifies a workflow process and assignee. For example, you can create stages to request approval or request comments. You can also create stages having the Interim Approval status.

Skip Request Comment is available in open status. When checked, request comment notifications aren't sent to the seeded assignees.

If Skip Request Comment is enabled and autopromotion is defined for open status, on submission of the change order from draft, the change order will be pushed to the status set for autopromotion.

After changes are authored for each item, the change order is submitted for approval workflow.

When a change order is submitted, notifications are sent out to assignees. Consolidated notifications are sent to each of the appropriate assignees at each stage of the approval process. Each approver is requested to respond before the expiration date specified in the approval task in AMX. Reminder notifications can be set up so that an approver who doesn't respond by the required date can receive notifications at a specified interval.

The approval status of a change order reports the progress of the approval. A list of approvers and the action taken by each approver is captured as a part of the history displayed in the notification for approval.

The approver can approve each line in the change order or reject the change.

Note: The Product Development work area doesn't support approval of change orders at the line level.

You can set up a task so that when the change order is approved or rejected, an email notification is sent to the creator, requester, and assignee. If the approval routing workflow is stopped, then a task can be set up so an email notification is sent to all people in the approval routing who were previously notified regarding an assigned workflow process in an approval stage.

You can set up a change type so that a request is approved by a single member of a user group. From the Manage Change Order Types task of the Setup and Maintenance area, edit a change type and select an approval step on the Workflow tab. Then, for an approval activity in the step's status details, set **Response Required From** to One. When one member of a group approves the change, the notifications to other approvers in the group are withdrawn for that approval step, and notifications are sent to the approvers for the next step.

The assignment of approvers for change order lines is governed by rules. For change order headers, you can select an assignment method in the Interim Approval or Approval step's status details for the Header approval stage, either rules-based or user-defined. If you choose user-defined assignment, you then select an approver by using the **Assigned To** control.

You can assign approvers as optional. A single optional approver can reject a change order, but approvals from optional approvers are ignored. To assign an optional approver, select an approver by using the **Assigned To** control on the **Optional approval** row of the Interim Approval or Approval step's status details.

Note: For change orders in Draft or Open, their lines can be moved to a new change order or to another existing change order, if those lines are hindering the approval workflow.

If **Response Required From** has been set to One, then, when an approver selects the Claim action on a notification, the notification is locked against changes by other approvers, unless the first approver unlocks it by selecting the Unclaim action.

On interim approval and approval notifications for change orders, the Pack Type column of the Items table is hidden by default. To view the pack type associated with the items in a change order, select **Pack Type** from the View menu.

You can navigate to the items in the change order approval notification using the item link. The resulting read-only item page is rendered in a separate window. The first view on an item drill-down from a notification is the item view, to view the changes in the context of the entire item (as supported by the change order). Then you can toggle to an item view that displays changes.

Approvers can only see those aspects of the item for which they have access. They can also perform the following tasks on the change order:

- Request more information

When you request more information from a user, the user must submit the information using **Actions > Submit Information** (available on the change) so that the change can be approved.

Note: If a message appears during the approval informing you that the action is invalid or the user doesn't have the privilege, review the change history. Identify if more information was requested from a user. The change can be approved once the user submits the information.

- Reassign
- Escalate
- Suspend

Generate Change Approval Summary Using Generative AI

You can use the Generate button on workflow objects within the Redwood page to create a formatted change summary.

The generated summary is included to the workflow's formatted description field and is supported for the following workflow objects:

- Change orders
- Change requests

The **Generative AI** feature will create a common section across change orders and change requests, and provide an overview based on the object description and additional details. This will include:

- Main Attributes: Reason Code, Priority, Status
- Configured Descriptive and Extensible Flexfields
- Affected Object Number, Lifecycle Phase, Revision, and Status
- Workflow Attachment updates

Another section specific to change orders and change requests is also generated.

Change orders will include a section titled Summary of Changes and will provide Affected Object Redline information:

- Structure Component change action, Item Number Quantity, Item Sequence, Lifecycle Phase and Revision

- AML change actions, Manufacturer Part Number, Manufacturer, Manufacturer Part Number Status, AML Status
- Substitute Component change action, Item Number, Item Sequence Lifecycle Phase, and New Item Number
- Reference Designator change action
- Attachment change action
- Workflow Attachment updates

Change requests will include a section titled Affected Items and Relationships and will gather information from the following:

- List of affected items
- List of relationships detailing Name, Type, Description, Relationship Type, and Relationship Status.

Note: This feature is enabled by default and to disable the Generate button, set the predefined profile option ORA ACA WORKFLOW GENAI FORMAT DESC to No.

Points to Consider

- To get the best desirable response from AI, you can run the Generative AI feature several times, if required, for the same workflow object.
- Using sentence format in the Workflow Description field ensures an accurate summary.
- Providing descriptive and extensible flexfield attributes with appropriate names and values will result in a detailed summary.
- The response time of the prompt depends on the number of attributes, including descriptive and extensible flexfields, as well as the number of affected items, and redlines.
- When you manually enter values in the Formatted Description field while editing a workflow object, and then click Generate, your existing values will be replaced with AI-generated values. However, you can still revert to the previous values by clicking Cancel on the section edit.

Add or Remove Participants in Current Status

You can add or remove approvers in the interim approval and approval status. You can add or remove participants of type reviewers when the change is in draft, open, approval, and interim approval, scheduled, or completed statuses.

You can add roles as approvers or reviewers while approvals are in progress.

Note:

- Participants include reviewers, approvers, and optional approvers.
- This is applicable for change orders, change requests, problem reports, and corrective actions.
- Adding participants depends on the permissions assigned in the additional workflow controls table.

Here are some additional details:

- The newly added participants receive notifications. You're restricted from adding a role that has more than 40 members to the approval workflow if the **Response Required From** field is set to **All**. This happens when you promote the change. Also, automatic promotion is prevented. You'll see a new entry in the action log and a notification is sent to the analyst.
- Optional approvers can't be added when approval is in progress.
- Only the change analyst can remove approvers or reviewers in the current approval status.
- You can't add the same user as reviewer and approver.
- You can also remove a person or role from the participants list as long as there's at least one person or role remaining as an approver. Only the change analyst can remove participants.
- You can't remove approvers who have already approved or rejected the change.
- You receive an FYI notification if you're removed as an approver or reviewer in the current interim approval or approval status, and if you're removed from the approval group.
 - You can see the comments provided during the removal action in the notification.

Note:

- In BPM Worklist configuration, it's recommended that you make commenting mandatory when rejecting a change order so that rejection comments are captured.
- Comments are visible in the rejection notification for change orders, change requests, problem reports, and corrective actions.

Understand Role Expansion in Change Orders

In the change order's Approvers table, roles are expanded to show all members of the role only in certain cases.

- If the approver is a role and **Response Required From** is set to **All**, the role is expanded to show all its members.

- If the change is promoted to approval and the role has more than 40 members, it won't be expanded. You must delete the role to submit the change for approval.
- If only one response is required on a user-defined approval and roles have been added as approvers, the roles aren't expanded to show their members.

In either case, all members of the role receive notifications on completion of the change workflow, and you can track who signed off. Note that the Assignee field in the notification is also not expanded to show all role members.

Change Order Notifications

Notifications are sent to assignees throughout the lifecycle of the change order.

For a detailed list of new item request notifications, notification types, and recipients, see [View Product Management Notifications](#) available on the Oracle Help Center.

Here's when the notifications are sent:

- When a change order is submitted, notifications are sent out to assignees, approvers, and the requester.
- When you start a step, notifications are sent to each of the assignees of the step.
- When the change order is approved or rejected, a notification is sent to the creator, and approver.

Notifications are of the following types:

- Task notifications are sent out to the assignees of each task.
- FYI notifications are sent to the creator, assignee, requester, and approver of change order lines and headers when it moves to Scheduled or Completed Status.

Important Considerations about Notifications:

- FYI notification is sent if you're removed as an approver or reviewer for the change that's in the current interim approval or approval workflow status.
- FYI notifications are sent to all the removed participants of the approval groups.
- FYI notification shows who has rejected the change order approval request and the rejection comments for the same.
- Comments are visible in the rejection notification for change orders, change requests, problem reports, and corrective actions.

You can see the comments provided when you're removed as a workflow participant.

Note:

- If the approval notifications are delayed ensure that approvers have the following role: EGO_GENERATE_ITEM_CHANGE_ORDER_REPORT_PRIV_OBI
- The assignee in the notification refers to the users who are part of the approval groups. If your role is designated as the workflow status participant, the Assignee field of the FYI notifications displays your role, instead of your user name.
- Sometimes, unanticipated issues prevent the workflow from getting completed as expected, and terminating a workflow maybe inevitable. You can stop an approval routing workflow, even if it isn't completed using Terminate Workflow. Related notifications, if any, are removed from the assignees' work lists.
- In BPM worklist configuration, it's recommended that you make commenting compulsory when rejecting a change order so that the rejection comments are captured.

Note:

- Workflow participants (approvers, optional approvers, and reviewers) don't receive FYI notifications for change workflow events that aren't relevant to them.

Only participants added to the current and previous workflow statuses receive notifications when:

- The change is rejected or completed.
- Autopromotion fails.
- Participants added to future workflow statuses or skipped workflow statuses don't receive FYI notifications for these events.
- If the change moves through a status and is demoted, participants of the status through which the change moved will receive a relevant FYI notification.

Note:

- The number of affected objects displayed in an email notification depends on a threshold. If the number of objects exceeds this threshold, a link to the change order page is provided so that you can navigate to the object and view the full list.
For change order approval task notifications, the threshold is 25.
For FYI notifications, the threshold is 100.
- A predefined request comment notification is associated with the **Open** status. The change order can't move to the next status until this notification has a response. The notification is then sent automatically to the assignee and the requester.
This automatic notification can be bypassed by removing the assignees. If the notification is bypassed and the BPEL process is set to automatically promote, then the change order automatically moves to the next status. Otherwise, you need to manually move the change order to the next status.
- Change order notifications aren't sent for the following actions:
 - Skip Current Assignment
 - Suspend
 - Create Subtask
 - Request Information
 - Route Task
 - Add Comments

Note: You can view the details in a workflow notification according to the access permissions defined in the workflow access control list. The information displayed in the notification matches the content of the workflow in the Redwood interface.

Here are the notification types:

Approval and Review Notifications

The following attributes are available in all notifications:

- Organization
- Description
- Assignee
- From
- Assigned Date
- Task Number

Change Approval Notifications

Here are the attributes shown in change approval notifications:

- In the Header details section:
 - Change Number: A link that opens the details of the change order in a new page.
 - Requester Comments: Comments submitted by the requester.
 - Activity Type: An optional approval or approval notification.
 - Response Required From: Response required from either one assignee or from all the assignees.
 - Expiration Date
 - Approval Status
 - Sign Off As: The assignee is either an individual or part of a role.
- The Line details section has two parts:
 - Affected Objects that includes the affected item number, item description, the old and new revisions (if changed) of the item and the old and new lifecycle phases (if changed) of the item.
 - Impacted Products that includes the impacted item number, item description, item revision, item lifecycle phase, and the number of affected objects.

- After you've opted in, the application automatically uses the new predefined Oracle Analytics Publisher Template:

 - Workflow Item Send Notifications Report

- To display additional attributes in the notification, you must configure the new predefined template. Configuration is only available in change orders, change requests, problem reports, corrective actions, and items.

Requires Comment Notifications

You can view requires comment notifications for change orders, change requests, problem reports, and corrective actions when the status changes from draft to open and the **Skip Request Comment** option (on the change type) is deselected. This is supported in both the in-app and email notifications.

Once the comment is submitted, an FYI notification with task completion details is sent to the assignee. Depending on the configuration, change orders, change requests, problem reports, and corrective actions can be moved from open to the next status either automatically or manually.

Approve Selected Change Lines

When you receive a notification for a commercialization change order, you can choose to approve selected change lines only.

Click the **Approve or Reject Lines** option from the **Actions** menu on the notification to open it in a new browser window. Here you can select the **Include in Approval** check box to approve all change lines in the change order, or select individual change lines to approve.

Change lines that aren't selected in the **Include in Approval** column are rejected. Select individual change lines only if you're approving them. If you click Reject, the change order and all its change lines are rejected.

Note: This feature isn't supported in email notifications.

Considerations for Managing Flexfields in Items and Change Orders

Item extensible flexfields and item revision extensible flexfields are handled differently in Product Information Management and Product Development work areas.

Here's what you should keep in mind if you're managing flexfields in both work areas.

Flexfield Type	Product Information Management	Product Development
Item Extensible Flexfield	Available in items and change orders. On selecting a revision, only the current effective values appear.	Available in items and change orders. On selecting a revision, revision-specific values appear.
Item Revision Extensible Flexfield	Appears on the item page where it's configured. Appears in the change line in the classic Product Information Management work area, but not in the Simplified Change Management Interface.	Not supported. Doesn't appear in the item view or change order affected objects view.

Best Practices

Here are some best practices for managing flexfields:

- In Product Development, you can use item extensible flexfields to track different attribute values by revision when specific data isn't explicitly tracked through change control.
- In Product Information Management, you can choose not to include item attributes in change control, but still use item revision extended flexfields to track the difference in values between revisions.

Considerations for Managing Attachments in Items and Change Orders

Attachments are handled differently in Product Information Management and Product Development work areas.

Here's what you should keep in mind if you're creating and managing attachments in both Product Information Management and Product Development.

Product Information Management	Product Development
Supports item-level and item revision-level attachments.	Supports only item revision-level attachments.
Item and item revision-level attachments can be edited through the item, but not through a commercial change order.	After an item is released, item revision attachments can only be edited by redlining through a change order.
Item revision attachments don't flow to the next revision.	Item revision attachments flow automatically to the next revision, unless deleted.
Item images are stored and shared as item-level attachments.	Item images are stored and shared as item-level attachments.

Note: When you add an attachment to an item in Product Development, it will be visible on the item in Product Information Management only if the item is in a higher lifecycle status than Design. Note that the attachment appears in Product Information Management as an item revision-level attachment, not as an item-level attachment.

Best Practices

Here are some best practices for managing attachments:

- Use item-level attachments to associate unstructured content and additional details with an item. These attachments aren't revision-specific; they apply to all revisions of an item.

- Given that these item-level attachments aren't change controlled, always use the actions available on the Attachments panel from the Product Information Management work area to manage changes to these attachments.
- Always add attachments to a change order using the **+Add** button on its Attachments tab to ensure proper association and auditing. Avoid adding attachments directly from notifications.

FAQs for Change Orders

How can I create a new change order based on an existing change order?

You can use the **Save As** action to create a new change order. In the Create Change Order dialog box, you must select the change type for the new change order.

Here's what you need to know before you use the **Save As** action:

- Depending on the work area, you can choose to copy over the existing descriptive and extensible flexfields, contextual attributes, attachments, tasks, and affected objects.
- In the Product Information Management work area, you can save the change order to any type of commercialization change order.
- In the Product Development work area, you can save the change order to an engineering change order or change order without revision control.
- To copy over the descriptive and extensible flexfields select the **Additional Information** option in the **Save As** dialog box.

Why am I unable to create a change order?

Review the descriptive flexfield settings for the Item Change Management module. Be sure that the value of context segment is set to ORA_EGO_CHANGE_TYPES_VS.

Here's how you review and edit the flexfield:

- Execute the Manage Descriptive flexfield task in the Setup and Maintenance work area.
- Search for the flexfield code EGO_ENGINEERING_CHANGES and edit the flexfield.
- In Context Segments review the **Value Set** field. Be sure that the value is set to ORA_EGO_CHANGE_TYPES_VS.
- Click **Save**.

You must deploy flexfields after you save the task.

What's the difference between an affected object and a change line?

Both the terms indicate an object affected by the change order.

Affected object is used in the Product Development work area and Simplified Change Management Interface.

Change line is used in the Product Information Management work area.

How can I view the list of change orders that are on hold or canceled?

You can use OTBI to generate a report listing change orders that are on hold or canceled.

Why am I unable to view extensible flexfields on change orders in the Product Information Management work area?

You must opt in to the following features to view extensible flexfields on change orders:

- Use Extensible Flexfields on Changes, Problem Reports and Corrective Actions and
- Use Simplified Change Management Interface

What are valid objects for change order attachments?

Change order attachments can be any type of local file, repository file or folder, URL link, or text.

These objects can be attached to both the header, and to individual lines, of a change order. The attached content is not searchable.

How many objects can I add to a change order or new item request?

The default limit is 50 and the maximum is 100. Your administrator can change the default limit for:

- The number of change lines or affected objects in change orders, and
- The number of items in new item requests.

Here are some additional details:

- When you exceed the limit while adding items through the user interface, an error message appears.
- When you import a large number of items in a batch, you can choose to automatically split items and create new change orders or new item requests.

Can I set a default priority for my change order or new item request?

Yes. You must set the default priority for a change type or a new item request type. The priority is inherited when you create a new change order (based on the type) or new item request.

Use the following tasks from the Product Management Offering in the Setup and Maintenance work area:

To set the default priority, use the **Priority** field.

How can I find details about changes to an item in a change order?

You can navigate to the items in the change order approval notification using the link provided on the number of the item.

The resulting read-only item details page is rendered in a separate window. From the item details, a link on View Change Order Line enables you to view the scheduled changes to the item in redlined mode.

Click the change order link in on the Manage Change Orders page. On the Lines tab, click the **Item Changes** for an item to access the Item Changes page.

The first view on an item drill-down from a notification is the item view in the context of the change order. Then you can toggle to an item changes-only view in redlined mode.

Note: The Item Changes page displays only changes made to the item through this change order. Approvers will only see those aspects of the item for which they have access.

Click the change order link in on the Manage Change Orders page.

On the Lines tab, click the Item Changes icon for an item to access the Item Changes page then click the **Component Changes** icon in the Structure Changes table to access change information for specific item components.

How can I move change order lines?

On the Manage Change Orders page, expand the search results and select lines from one or more change orders within the same organization then select Move Change Lines.

In the Move Change Lines dialog box, you can select an existing change order to which to move the selected change lines, or you can move the change lines to a new change order by selecting Create Change Order. If you create a new change order for the change lines being moved, then you must enter header information for that change order.

Note that you can only move change lines in a commercialization change order.

What's the difference between Withdraw and Remove?

Use Withdraw, to delete a component that was added before the item was assigned to the change order.

Use Remove, to delete a component that was added after the item was assigned to the change order.

How can I secure the change order created in the Product Information Management work area?

Access the change order from the Product Development work area. Use the Security side tab to restrict access.

You can choose users who are responsible in their review and approval of the change order. You can also choose roles by which you restrict the availability of the change order. Additionally, you must provide data security privileges for the change order.

Why am I unable to assign the item to a change order?

You can't assign an item to a change order in Product Development, if the item is created in Product Information Management.

Also, you can't assign an item to a commercialization change order in Product Information Management if the item:

- Is created in Product Development, and
- Is in the design lifecycle phase.

Why does the change order display information in side tabs instead of horizontal tabs?

Your administrator has enabled the Simplified Change Management Interface for the Product Hub work area.

Why am I unable to edit the change order?

If the change order is created in Product Information Management, you can't edit that in Product Development. Conversely, the change order created in Product Development can't be edited in Product Information Management.

Can I modify the find number when the item is on a change order?

You can modify the find number when the change is in draft or open status. Here's how:

Delete a component and add it again with a different find number.

Or

Use the **Replace** action to replace a component with the same component and provide a different find number.

Can I cancel a change line in an approved change order?

Yes. When you cancel the change line, any changes defined for items in the change order are discarded.

For example, you noticed a defective item in the approved change order and the item is in scheduled state. To resolve the defect, you cancel the change line and again process the item through another change order.

What's the difference between cancel and terminate actions in a change order?

Use cancel to stop further processing of the change order. You can still move the change lines to a new change order and retain redlines.

Use terminate to temporarily pause the workflow and resume it in the same change order.

Why did the change order approval prompt for a comment and password?

Your administrator configured the comment and password fields as compulsory for the purpose of audit. Enter your sign-in password.

Why did the change order fail on approval?

Open the History tab of the change order to review the sequence of actions on that change order. Depending on the action performed, the application displays a comment.

For example, if you try to promote two change orders simultaneously and the effective dates are less than 30 minutes apart, then a comment appears advising you to maintain a time difference of more than 30 minutes. You can also see the Workflow tab to review the change order status.

How can I restart the change order workflow which is on hold when the approval is in progress?

From the **Actions** menu, click **Restart Workflow**.

Note: You can't restart the workflow using **Continue**.

Why am I unable to add or remove approvers during the change order approval?

You must be assigned with the add participants and remove participants actions in the additional workflow controls for the change type.

Additionally, the value of **Response Required From** (in the change type) must be set to **All**.

How can I remove a participant from the change workflow?

In the Change Status dialog box, select the participant and click **Delete**. You can also perform this action from the Participants section on the change Workflow tab.

Note:

- Your ability to remove a participant depends on the permissions assigned in additional workflow controls for the change type.

Can I edit multirow extensible flexfield attributes from the item page or without using a change order?

Yes. But your administrator must remove any restrictions set for editing the attribute only through the change order page.

Why did the Scheduled change order get promoted automatically?

Since the Autocomplete on Cancel option is enabled by default from update 23A, all scheduled change orders move to the Complete status on cancellation of the last change line. This is applicable to new and in-progress change orders.

Let's say that the first three change lines are complete, and the last change line is stuck in the Scheduled state. You cancel the scheduled change line, and the change order moves to the Completed status.

Why did the change order workflow restart automatically?

If the schedule processor job is stuck in the initial run and it doesn't require any user intervention, the application restarts the job. It restarts up to 5 times with increasing time gaps in between each job.

You don't need to manually search for unsuccessful change orders that weren't processed due to locked affected objects.

Note: An item can be simultaneously updated from different sources. A record can be updated through the user interface, while another update could be triggered through a web service or scheduled process. This results in locking issues, and the jobs can't be complete successfully. In such scenarios, the application restarts the subsequent job after some wait time and attempts to complete the job.

Why am I unable to update the task status in the change order?

You can only update the status for the tasks that are assigned to you. But your change analyst can update the status for all tasks.

In a change type, can I configure additional controls for the Draft status?

No. But you can configure additional controls for Open, Approval, Interim Approval, Scheduled, and Completed status.

How can I set the reason code field on a change as a required field?

You can opt in to the Simplified Change Management Interface feature and then use Page Composer to edit the Reason Code field component and set it as required.

Where are the change header attributes and change descriptive flexfield attributes displayed?

In the Product Development work area and Simplified Change Management Interface, the change header and descriptive flexfield attributes are available on the General Information tab of the change order.

Examples of change header attributes: Number, Name, Description, and Reason Code.

Why am I unable to edit the extensible flexfields on the change order?

Your ability to edit flexfields depends on the following:

- You must have the Manage Change Order privilege.
- Permission for the Manage Change Header Attributes action (in the additional workflow controls table) must be set to All or Additional Information. For example, if you are the creator of the change, the **Creator** column for this action must be set to All or Additional Information.
- You must be assigned both view and edit privileges on the Edit Context page.
- In the Security tab of the change type, your role or user ID must be assigned the same view and edit privileges (that was assigned on the Edit Context page). For more information, see the related topics.

How do I know whether my approval is required or optional for a change order?

In the approval notification, the **Activity Type** field indicates whether you're an approver or an optional approver.

How can I know whether the entire change order (or new item request) was rejected or if a few items were rejected?

The approval notification provides details of whether the entire change order (or new item request) was rejected, or if a few items in the change order (or new item request) were rejected.

How can I find out the change order used for propagating changes and the change order created by propagation?

Open the History tab of a change order to see the sequence of actions recorded for the change order. You can see which change order was used as a source for propagation and which change order was created by propagation.

Why should I claim the change order approval?

The **Claim** action enables you to review and approve the change order before another user in the role attempts the approval.

This is because your administrator assigned the change order approval to a role and set the value of **Response Required From** as **One**. So one response from a user in the role is sufficient for approval. Note that an approval notification is sent to all users in the role.

Create and Edit Workflows

You can use the Product Management Search Workflows page to search for workflows such as change orders, change requests, problem reports, and corrective actions.

The workflow header attributes on the page header persist across all the tabs, providing context for the workflow. Here are some actions you can perform on the workflow.

- Search across workflow attributes.
- Use filter chips for header attributes, additional attributes, and extensible flexfields.
- Use the spotlight to quickly navigate through the affected objects.
- Redline the item directly in the change order context.
- Drag (select and move) items from the clipboard or spotlight to the Affected Objects tab.
- Preview attachments.
- View the workflow statuses and approvals in one table.
- Manage participants for multiple statuses in the same page.
- Use filter chips on tasks and relationships.
- Click the workflow links in OTBI reports to open the workflow in Redwood.

You can also perform additional actions using the **More Actions (...)** button.

Create Workflow

You can create workflows in multiple ways:

- Click the **Add (+)** icon from the Product Management Search pages for Workflow, Workflow Approvals, and Workflow History.
- Use the links available in **Actions** on the Product Management home page.

If you're editing an item that has a needs approval rule, you can either create a new change order or add the item to an existing change order.

If you're editing an item, you can also use the **Assign to** action to assign the item to a new or existing change order, change request, problem report, or corrective action.

Identify Workflow Status Using Color Codes

You can identify the workflow status by the color codes in the workflow search results and the status shown next to the workflow title.

View and Modify the Required Descriptive and Extensible Flexfields

You can view and modify the required descriptive and extensible flexfields attributes when you create the change order from Product Management Search page, move the affected objects, or assign the item to a change order. Both global and context sensitive descriptive flexfields can be set as required.

Note: The workflow deep links in the OTBI reports open the workflow in Redwood when profile option (ORA ACA WORKFLOW REDWOOD ENABLED) is set to **Yes**.

The following header attributes are hidden by default for change orders and change requests, but you can display them using business rules:

- Supplier Site
- Reported By
- Reported Date

You can access data in the following tabs on a workflow:

- Attributes
- Affected Objects
- Attachments
- Workflow and Tasks with sub-tabs
 - Activities
 - Tasks
- Relationships
- History

Navigate to a Redwood Page Using Link in Notification

You can navigate to a Redwood page by clicking the change number link on the notification. To use this feature, set the profile option ORA ACA WORKFLOW REDWOOD ENABLED to Y.

Create a Duplicate Workflow

You can create a new workflow based on an existing one in Product Management. Use the workflow page-level action named **Duplicate**.

Click **Duplicate** to open the Duplicate <workflow name> drawer.

In the drawer, you can select a different change type. For example, you can create a change order from a change request or a change request from problem report. You can also select which entities— **Attributes**, **Affected objects**, **Affected object additional attributes**, **Attachments**, **Tasks**, **Relationships**, and **Relate to workflow**—you want to include or exclude when copying them to the new workflow. All entities are selected by default. Except for **Relate to workflow**, the others are organized into tabs within the new workflow.

If the **Relate to workflow** remains selected, then a relationship will be created between the source and the new workflow.

Attributes

You can search for attributes across sections, which can be accessed directly by selecting a filter chip. Includes filter chips for General Information, Additional Attributes and Extensible Flexfield pages:

- Additional Attributes
 - Includes global descriptive flexfields followed by context sensitive descriptive flexfields.
 - Includes the Migrated attribute (Yes/No) that indicates if a workflow was migrated using import.

- To edit context-sensitive descriptive flexfields on a change line, navigate to the context-sensitive segment, select the relevant attribute section, and create or update values in the Additional Attributes drawer.

Note:

- In the Main section of the Attributes tab, the visibility of the Source, Customer, Supplier and Manufacturer attributes depends on the workflow type.
- To view change line context sensitive descriptive flexfields in the **Additional attributes** drawer, you must change the Context Display Type to List of Values in the Descriptive flexfield setup page.

You can create extensible flexfield attribute groups as pages if you want the filter chips to appear on the Workflow Attributes tab. Here's how:

- Access the Manage Extensible Flexfields task in the Setup and Maintenance work area.
- Search for the flexfield code **EGO_CHANGE_EFF** and edit the Change Extended Attributes.
- In **Change Type Details**, select the **Add (+)** button to create a new page for the selected change type. You can edit the **Display Name** as you'd like it to appear in the filter chip.
- In the table, use the **Add (+)** button to add your extensible flexfields to the newly created page.

Affected Objects

Here are some tasks you can perform on the Affected Objects tab.

- Select affected objects using the **Select and Add Items** icon (the item picker).
- Drag and drop (select and move) items from the clipboard or spotlight to the affected objects tab.
- Search affected objects table to filter rows.
- Edit the new revision, new lifecycle phase, and effective date directly inline.
 - You can also use copy and paste to edit these attributes.
- Edit descriptive flexfields in a drawer (side panel).
- Export all the affected object lines or just the selected ones.
- Cancel lines.
- Move lines.
- Copy selected affected objects to the clipboard.

Here are some additional details on affected objects:

- If your administrator has set up an access control list, your access to affected objects will depend on the permissions specified in that list.
- When you click an affected object number link on a change order, change request, problem report, or corrective action, it appears in the workflow context, enabling you to view the affected object and easily return to the change request, problem report, or corrective action.
- You must edit the affected object lifecycle phase and effective date separately.

- When you add an affected object to an engineering change order, the new revision is automatically updated through REST APIs, and during import. However, the revision isn't automatically incremented in the following scenarios:
 - The affected item is included in another change order that is currently in Scheduled status.
 - The existing revision doesn't follow a standard or recognizable pattern, making it unclear what the next revision should be. For example, if the initial revision is set as .001 or Z.

Data Presence Indicators

Here are the presence indicator icons appearing on the tabs of an affected object.

Icon  indicates Has Content

Icon  indicates Has Redlines

The presence indicator for redlines is also visible in Spotlight if any of the change controlled entities have been redlined. Here's a list of fields for a change type on which presence indicators are available:

- Engineering change order
 - Attributes
 - Attachments
 - Structures
 - AMLs
- Change order without revision control
 - Attributes
 - AMLs
- Commercialization change order
 - Attributes
 - Structure
 - Associations

Note: To upgrade the data presence indicators introduced for change orders in update 25D, you must run the following scheduled process.

- Upgrade Product Management Data
- Functional Area: Changes
- Feature: Update data presence indicators for affected items

Fill up and fill down

You can select a cell, grab the small square in the corner, and drag it vertically or horizontally to fill adjacent cells (or select and drag cells) to modify affected objects.

To perform bulk edits, select multiple cells and drag them up or down.

To quickly update cells, right-click a cell and select **Auto Fill**.

Note: When you copy and paste objects or do a bulk update of effective dates to update the same effective date on more than 10 change lines, a scheduled process is triggered to update the dates on click of **Save**. The change order is put on Hold status until effective dates on change lines are updated.

Resolve Revision Conflicts

When there are revision conflicts on the affected objects in the change order, you can resolve them using the **Resolve Revision Conflict** action available on the **Affected Objects** tab. Additionally, the application will prompt you to address any conflicts when you attempt to change the workflow status to **Approval** or **Interim Approval**.

Note:

- If your administrator has set up an access control list for items, your access will depend on the permissions specified in that list.
- When you click an affected object number link on a change order, change request, problem report, or corrective action, it appears in the workflow context, enabling you to view the affected object and easily return to the change request, problem report, or corrective action.
- You must edit the affected object lifecycle phase and effective date separately.
- When you add an affected object to an engineering change order, the new revision is automatically updated during import. However, the revision isn't automatically incremented in the following scenarios:
 - The affected item is included in another change order that is currently in Scheduled status.
 - The existing revision doesn't follow a standard or recognizable pattern, making it unclear what the next revision should be. For example, if the initial revision is set as .001 or Z.

Permissions for Adding Affected Objects When Access Control List is Configured

On the workflow object:

- Go to Affected Objects tab and add the affected object.

You will require the Manage Permission on Affected Objects.

On the item object:

- Click Actions on an item. You will require the View or Manage permission on the item.
- Select Assign to Change Order and Save to change order.

To create a new change order, you will require the Create Permission.

To assign the item to an existing change you will require the Manage permission on the Affected Objects Tab for the specific workflow.

Open an Affected Item in Change Context

When you open an item in the context of a change order, here's what you must know:

- A hyperlink **Change order <name> Context** appears along with the page title to indicate that you're in the change order context. Clicking this link will take you to the previous page you were on, either the **Affected Objects** page or the **Pending Item Revision** page.
- You can use the drop-down list (next to the change order name) to select the other affected objects, while viewing an object in the change order context.

Configure the Send Object Action

You can use business rules (in Oracle Visual Builder Studio) to configure the following fields that appear in the Send Object action.

- Messages
- Roles
- Users

Undo Redlines

In structure and AML tabs in a change context, you can undo the redlines of both saved and unsaved changes of an item's pending revision. The **Undo Redlines** button is enabled when one or more redlined rows are selected. An **Undo** icon appears against the selected rows.

Here's how you undo redlines in a structure:

1. Open the change order and navigate to the item structure page.
2. Select the rows in which you want to undo the redline and click Undo Redlines.
3. You can cancel the undo redline. Select the row you want to cancel the undo action on, and again click Undo Redlines.

The undo action is complete only after you click **Save**. Note that the action is only displayed in the pending revision context.

Reschedule Change Lines

You can reschedule the change lines on a change order in the scheduled status, by updating the effective date and clicking **Reschedule**.

Publish Workflows

To publish workflows, on the workflow click **Actions > Change Publication Criteria**.

Here are some additional details:

- You can publish engineering and commercialization change orders, and change orders without revision control as an XML package by selecting all or one of the following entities:
 - General Information
 - Affected objects
 - Header attachments
 - Affected object redlines only
 - Affected object attachments
 - Affected object structures

- Affected object AML
- You can publish change orders in any status.
- You can't publish :
 - Structures on affected objects for change orders without revision control.
 - Attachments and approved manufacturers lists (AMLS) for commercialization change orders.

Edit Context Sensitive Descriptive flexfields

You can edit the context sensitive descriptive flexfields on change lines, navigate to the context sensitive segment of the change line, and click the specific attribute section to create or update the values in the **Additional attributes** drawer.

Add Attachments on Change Lines

You can add attachments to the change lines on workflows such as change orders, change requests, problem reports, and corrective actions.

Calculate Use-Up Date

You can calculate the use-up date and update effective dates on components.

If you've enabled the Supply Chain Planning offering, you can use the Calculate Use-Up Date action on the change order's affected objects table to view and select the use-up dates defined in the planning application. This helps you calculate the optimal effective dates for structure components that are being removed or replaced on engineering and commercialization change orders.

View Redline Information in Item Context

You can leverage the item page level action **Red Lines Only** to view item redlines quickly.

Selecting **Redlines Only** will only display tabs that have redlined data on the selected revision, and only display the redlined fields within each tab. In the **Redlines Only** mode you can select the action **Show All** to return to the standard view that displays all tabs and fields.

The Redlines Only action will still be selected when you navigate between items and item revisions in the following ways.

- Navigate between affected object revisions.
- Navigate between the items in spotlight.
- Select pending revisions on the item.

Change the Item Class on Pending Changes and Enable Needs Approval Rule

You can modify the item class in a pending change. The modification will appear as a redline and be recorded in the change history. Additionally, you can configure a needs approval rule so that an item class change automatically triggers a change order.

Note: You can't redline other fields when you redline an item class.

Attachments

Undo Redlines

Here are some tasks you can perform on this tab.

- Add attachments.
- Preview attachments in a drawer (side panel).
 - Use the arrows to scroll through multiple attachments.
- Search for and filter attachments.
- Download attachments.

Access to Download and View Attachments from Workflows

Access to download and view attachments can be secured by your administrator using an access control list. To download and view attachments, navigate to the workflow page, click More Actions > Download Attachments. For more details, see [Access Control Lists for Workflows](#)

Workflow and Tasks

Displays the workflow statuses with the following color coding:

- Green- Completed statuses
- Blue- Current status
- Gray- Future statuses

The current status is selected by default (in the workflow status diagram on the Workflow and Tasks tab), or you can click the status to see the corresponding activity for that status.

You can configure business rules to show and hide column attributes on workflows, and show or hide the Activity and Tasks subtabs.

Activity Subtab

- By default, displays the activity for the current status. You can remove the status filter chip to see all statuses for the workflow in the activity table.
- Use filter chips to refine the results.
- Use the **Manage Participants** button to open a drawer where you can add participants for current or future statuses.
 - Select current or future status.
 - Enter participant names to get a list of users or roles with matching names and use checkboxes to select users.

Use the checkbox or highlight a name to delete it.

Tasks Subtab

You can add and edit tasks using a drawer.

- By default, displays all open tasks.
- Supports filtering.
- Includes **Completed Date**.

Relationships

You can create relationships using a drawer. You can add filters on:

- Relationship Type
- Object Type
- Status
- Revision (Item relationships only)

You can create rules between workflow objects.

- Add rules in the drawer using the + icon.
- View rules in the drawer using the eye icon.

You can also configure business rules to show and hide column attributes.

History

You can add filters on:

- Audit Type
- Action Type
- Status
- Author
- Date (using Date Range)
- Action

You can also export all or selected history rows.

Workflow Actions

Here are some actions you can perform on the workflow:

Spotlight

- Click More Actions (...) and select the **Spotlight** action to copy all affected objects to the spotlight tab of the Navigator.
- Click the item number link in the **Spotlight** tab to see the item and its redlines in the change context.

For change requests, problem reports, and corrective actions, the affected items are in read-only mode, as you can't perform redlines.

Change Status

Use the **More Actions** (...) button to change the status of the workflow. You can also add participants while changing the status.

Comment character count is visible as you type your comment.

Overview of Manage Imports

You can import items and item-related information using interface tables through FBDI.

Use the file-based data import feature to import large volumes of data from third-party or other Oracle applications, or create new data in Oracle Fusion Cloud SCM. For example, product data stewards can import new items into Oracle Product Hub using the ItemImportTemplate.xlsx template. You can also import trading partner items, item associations, customer items, and customer item cross references.

The following objects are available to import:

- Items
 - Operational attributes
 - Extensible flexfield attributes
 - Attachments
- Item Associations
 - Organization assignments

Import Style and SKU Items with Import Maps

For importing Style and SKU items, users are expected to provide the correct values in the import map data file for the style item and the variant attributes.

To import style items containing a single value set for the variant attributes, users map to the style Item field in the main node and set the value to Yes in the data file column mapping to this field.

To import SKU items, map to the variant attributes displayed for SKU items and provide the style item number by mapping to the Style Item Number attribute in the main node.

Create Item Import Batches

Overview of Item Batches

A product data steward can import items and related entities such as structures, packs, category assignments and trading partner item references from multiple product source systems using an item batch.

The following options are available for item batches:

- Import options let you schedule the batch loads and specify policies for governance, new item requests, and product changes.
- Data quality options for item batches let you categorize items, standardize attribute data, and match item data to ensure clean, consistent data during batch import.

You can add and modify item data to batches using a spreadsheet, XML, CSV or any other delimited files or using industry standard open interface tables.

Item Batches

Create item batches to import sets of item data including product structure and pack hierarchies from multiple product source systems.

Item Batch Definition

When you create a new item batch definition, you specify a target organization then specify the product source system and data quality options. Based on the specified spoke system, the options that were defined during source system management are populated. You can override these options for the specific item batch. You can also modify the import batch option settings.

Data quality options determine matching and standardization rules for an item batch to cleanse product data during batch import.

Item batch options let you schedule batch loads, specify product structures and packaging hierarchies, and policies for new item requests and change orders.

Adding Items to an Item Batch

After the item batch definition has been saved, you can add items to the item batch using CSV or another delimited file format, XML, or by File-Based Data Import (FBDI).

You can import item data as follows:

- *Import Maps*: Create an item batch on the Manage Item Batch page, and select **Actions > Add Items to Batch > Upload from File**. In the **Upload from File** dialog box, specify the import map, the source data file (which is CSV or XML), and, if uploading attachments, the attachments .zip file, and select **Upload File**.
- *FBDI*: To import items, prepare the **Item Import** FBDI template.

The following objects are available for import:

- Items
- Structures and Packs
- Trading Partner Item Relationships
- Category Assignments
- GTIN Relationships
- Item cross-references
- Related Items
- Trading Partner Items

Item Batch Options

Use item batch options to set the schedule of the import, define the default structure and pack options and manage the creation of new item requests and change orders for items being imported.

Item batch options are defined and associated with product source system definitions. When you specify a source system in an item batch definition, the import options associated with the source system are included as default settings in the new item batch definition.

You can modify these settings when you create a new item batch or edit an existing definition.

Depending on the type of item being imported, you can specify item batch options in one or more of the following areas.

- Import and scheduling
- Structures and packs
- Change orders
- New item request

- Data Quality

For external batches, data quality options are determined by whether the product source system is an internal or not an internal source system. For internal batches, data quality options are determined by the product source system.

Available Options to Check Data Quality for Item Batches

You can specify data quality options when defining a source system or through an import batch definition by selecting **Check data quality on upload**.

Items being created in the Oracle Product Hub go through the data quality check automatically, while items that are updated using batches must have the data quality check initiated manually. The cleansing process classifies the item, standardizes the attributes and identifies any matches or duplicates that may exist in the product hub.

Check Data Quality Options

The options that are available when you select the **Check data quality on upload** option are determined by the data source.

- If the items are being created or updated from a third-party source system, then the following options are available:
 - **Enable data quality matching**
 - **Confirm single matches**
 - **Confirm unmatched as new item**
- If the items are being created or updated in Oracle Product Hub, then the following options are available:
 - **Enable data quality matching**
 - **Confirm unmatched as new item**

Note: In the Product Information Management work area, Oracle Product Hub is represented as a spoke system with the name **Product Information Management Data Hub**.

Enable Data Quality Matching

You can improve item data import performance and reduce the time needed for initial data load and data migration by modifying the behavior of data quality matching.

The **Enable data quality matching** option enables you to control whether the process associated with identifying potential duplicates in the import is run or not. By deselecting this option, you can improve the import performance in cases where the data is already known to be good. This can be selectively done for each batch.

- Use this option to control whether data quality matching has to run to identify potential duplicates in an import. Depending on the known state of your data, it might not be necessary to identify potential duplicates.
- Deselect this option to ignore the process associated with matching for your imports.
- Deselect this option to improve import performance when you don't want data quality checks to be performed.
- This option is especially useful for an initial data load when the data is already de-duplicated outside Product Hub.

Confirm Single Matches

The behavior of the **Confirm single matches** data quality option is determined by the data source.

- If items are being created from a third-party source system and are imported manually, the following behavior results:
 - Single matches appear in the In Progress tab and the edit match actions value is Confirm.
 - Multiple or no matches appear in the In Progress tab and the edit match actions value is Unconfirm.
 - If **Confirm Single Matches** isn't selected, then all items will appear in the In Progress tab and the edit match actions value is Unconfirm.
- If items are being created from a third-party source system and are imported during data load, the following behavior results:
 - Single matches appear on the Imported tab.
 - Multiple or no matches appear in the In Progress tab and the edit match actions value is Unconfirm.
 - If **Confirm Single Matches** isn't selected, then all items will appear in the In Progress tab and the edit match actions value is Unconfirm.
- If items are being updated from a third-party source system and are imported manually, the following behavior results:
 - If a cross-reference exists, then no data quality check is performed, and the items appear in the In Progress tab and the edit match actions value is Confirm.
 - If **Confirm Single Matches** isn't selected, a cross-reference exists, and no data quality check is performed, then the items appear in the In Progress tab and the edit match actions value is Confirm.
- If items are being updated from a third-party source system and imported during data load, the following behavior results:
 - If a cross-reference exists, then no data quality check is performed, and the items appear on the Completed tab.
 - If **Confirm Single Matches** isn't selected, a cross-reference exists, and no data quality check is performed, then the items appear on the Completed tab.

Confirm Unmatched As New Item

The behavior of the **Confirm unmatched as new item** data quality option is determined by the data source.

- If items are being created from a third-party source system and imported manually, the following behavior results:

- Items with no matches appear in the In Progress tab and the edit match actions value is Confirm.
- Items with single or multiple matches appear in the In Progress tab and the edit match actions value is Unconfirm.
- If **Confirm unmatched as new item** isn't selected then all items will appear in the In Progress tab and the edit match actions value is Unconfirm.
- If items are being created from a third-party source system and imported during data load, the following behavior results:
 - Items with no matches appear on the Completed tab
 - Items with single or multiple matches appear in the In Progress tab and the edit match actions value is Unconfirm.
 - If **Confirm unmatched as new item** isn't selected then all items will appear in the In Progress tab and the edit match actions value is Unconfirm.
- If items are being updated from a third-party source system and imported manually, the following behavior results:
 - If a cross-reference exists, then no data quality check is performed and the items appear in the In Progress tab and the edit match actions value is Confirm.
 - If **Confirm unmatched as new item** isn't selected then and a cross-reference exists, no data quality check is performed and the items appear in the In Progress tab and the edit match actions value is Confirm.
- If items are being updated from a third-party source system and imported during data load, the following behavior results:
 - If a cross-reference exists, then no data quality check is performed and the items appear on the Import tab.
 - If **Confirm unmatched as new item** isn't selected then, if a cross-reference exists, no data quality check is performed and the items appear on the Import tab.
- If items are being created or updated from the Product Data Hub and imported during data load, the following behavior results:
 - Items with no matches appear on the Import tab.
 - Items with single or multiple matches appear in the In Progress tab and the edit match actions value is Unconfirm.
 - If **Confirm unmatched as new item** isn't selected then all items will appear in the In Progress tab and the edit match actions value is Unconfirm.
- If items are being created or updated from the Product Data Hub and imported manually, the following behavior results:
 - Items with no matches, single matches, or multiple matches appear in the In Progress tab and the edit match actions value is Unconfirm.

Item Batch Import and Scheduling Options

Item batch import and scheduling options let you set the schedule of the import and specify item cross-references imports.

Cross-References Only

If you select **Cross-References Only** in the Create Item Batch dialog, then no source system data is imported. A cross-reference of the source system item is created with a matched, new, or cross-referenced item in the Oracle Product Hub.

Note: You can only select the **Cross-References Only** option when creating an item batch. If the source system specified in the item batch definition is *Product Information Management Data Hub*, then the **Cross-References Only** option isn't available for selection.

If you select **Cross-References Only**, then item batch options for new item requests and change orders aren't available. However, options can be set for structures and packs.

Schedule

Determine when the data specified in the item batch will be imported.

- **On Data Load:** Import process is run immediately at the time of data upload.
- **Manual** (default): Lets you import the data at a later time.
- **Specify Date and Time:** Lets you specify the date and time to import the confirmed items or structures in the item batch

Process Items

The Process Items option determines if the Items are to be imported individually or as a bundle. If the bundle option is chosen, then all items in the bundle will be not be imported even if one of the items fails import validations. This option is typically used when importing data from a GDSN data pool.

Item Batch New Item Request Options

Use the item batch new item request options to create new item requests or add to existing new item requests when importing items or structures.

Here are the options that appear for new item requests in the Edit Item Batch Options dialog box:

- **One per Item:** create a single new item request for each item.
- **One per Item Class:** create a single new item request for all the items in the item class. You can choose to split the items across multiple new item requests if you have many items in the same item class. For more information, see the section Limit the Number of Items in a New Item Request.
- **One per Item Batch:** create a single new item request for each item batch.

You can create a new 'new item request' or add to an existing one. You can choose to split the items across multiple new item requests if you have many items in the same item class. For more information, see the section Limit the Number of Items in a New Item Request.

- **One per Item Bundle:** create a single new item request for each item bundle.

Affected items will be added to the bundle specified in the import map. You must specify a mapping ID for the bundle in the import map. The resulting new item request will include only those items that are identified with the same bundle, which normally indicates a pack. Consequently, all items belonging to a pack will be included in a single new item request.

- **Add all items:** select this to override any approval rules defined for creating items and add items to the item batch.

For all new item request options, those items associated with rules that require approval for changes will be added to the new item request. If desired, you can specify to add all imported items to the new item request.

- **Create new:** create new item requests to include items from the import.
- **Add to existing:** add items to an existing new item request. You must enter the new item request number in the **Number** field.

If an item being imported as part of a new item request is later rejected, you can resubmit the item as part of an item batch, instead of having to create another new item request and move rejected item lines there one by one. After you resubmit the item in an import batch, its **Approval Status** field includes a link to the new item request that's created by that import.

Note: If you select the **Cross-References Only** option when creating an item batch, then new item request options are unavailable.

Limit the Number of Items in a New Item Request

If you're importing a large number of items to a single new item request, you can split the items across multiple new item requests. This feature is applicable when you select:

- **One per Item Batch** and **Create New** or
- **One per Item Class** and **Create New**.

You must then select **Split automatically**.

For example, if you set the limit to 50, and there are 70 items in total, the application automatically creates a new request and moves 20 items onto it.

If you don't split the new item request and if you exceed the maximum limit, then an error message appears.

Item Batch Change Order Options

Use the item batch change order options to create change orders or add to existing change orders when importing items or structures.

Here are the options that appear for change orders in the Edit Item Batch Options dialog box:

- **One per Item:** create a single change order for each item.

If a Needs Approval rule is configured for the item, the change type will be based on the rule. Otherwise, the change type is as based on the item class configuration.

- **One per Item Class:** create a single change order for all the items in the item class. You can choose to split the items across multiple change orders if you have many items in the same item class. For more information, see the section Limit the Number of Change Lines in a Change Order.
- **One per Item Batch:** create a single change order for each item batch.

You can create a new change order or add to an existing one. You can choose to split the items across multiple change orders if you have many items in the same item class. For more information, see the section Limit the Number of Change Lines in a Change Order.

- **One per Item Bundle:** create a single change order for each item bundle.

Affected items will be added to the bundle specified in the import map. You must specify a mapping ID for the bundle in the import map. The resulting change order will include only those items that are identified with the same bundle, which normally indicates a pack. Consequently, all items belonging to a pack will be included in a single change order.

- **Add all items:** select this to override any approval rules defined for creating items and add items to the item batch.

For example, you already have a rule for items in class Radios to go through change orders of type Region. If you select this option, the application won't execute the rule.

- **Create new:** create new change orders to include items from the import.
- **Add to existing:** add items to an existing change order. You must enter the change order number in the **Number** field.

Note:

- If you select the **Cross-References Only** option when creating an item batch, then change order options are unavailable.
- If a **Needs Approval** rule is configured, see [How You Route Item Changes Through Change Types Using Rules](#) to understand how these options are interpreted.

Limit the Number of Change Lines (or Affected Objects) in a Change Order

If you're importing a large number of items to a single change order, you can split the items across multiple change orders. This feature is applicable when you select:

- **One per Item Batch** and **Create New** or
- **One per Item Class** and **Create New**.

You must then select **Split automatically**.

For example, if you set the limit to 50, and there are 70 items in total, the application automatically creates a new change order and moves 20 items onto it.

The change orders created by this split are automatically related to each other and can be accessed from the Relationships tab on the change order (in the Product Development work area). Here, **Relationship Type** is shown as **Split by Import**.

If you select One per item class, the change orders created for each item class are related only to each other, and not to change orders of a different item class.

If you don't split the change order and if you exceed the maximum limit, then an error message appears.

Set the Change Order Line Effective Date

The **Effective Date** option lets you set the effective date for the change order:

- **Type default** - Uses the effective date from the Change Order Type setting.
- **Effective immediately** - Change order lines using this setting are effective immediately.
- **User-entered** - Use this option for special cases in the item batch that uses the import map. For details, see [Importing Item Data Using Import Maps](#).

Note: Don't use this option in **Batch Options** for **Manage Item Mass Changes > Edit Item Attributes in Spreadsheet** process.

Merge Redlines Through Import

You can incorporate redlines coming in through import into existing change orders where applicable. This helps in reducing the number of outstanding changes, stuck changes, and overall change order cycle time. This is supported for engineering change orders and change orders without revision control.

You can import redlines and merge these with existing redlines on engineering items that are assigned to a change order. You can do this as long as the change is in draft or open status. The following modifications can be merged:

- Item general information
- Item structure components

- Reference designators
- Substitute components
- AML

To merge redlines, here's what you can do in the Edit Item Batch dialog box:

- **Change Order** and **Effective Date**: Select One per Item Batch and Effective Immediately.
- **Number**: Specify the change order number in which you want to merge redlines of the existing affected item.
- **Select Add to Existing** and **Add all items**.

The table shows how the effective date specified in the existing affected items and the import file determines whether redlines are merged or not.

Effective Date in the Existing Affected Items	Effective Date in the Import File	Redlines Merged?
Effective on approval	No date. The item is considered as effective on approval.	Yes.
Effective on approval	Future effective date.	No.
Future effective	No date. The item is considered as effective on approval.	The effective date of existing affected item is applied for the newly imported changes.
Future effective	Future effective date.	If the effective dates match, then the redlines are merged. If not, redlines aren't merged.

Modify Released Engineering Items Through Import

You can modify released engineering items through import only by using a change order. This is because the application enforces change control on such items that are past the open status.

Note that this feature isn't applicable for commercial items and commercialization change orders.

Here's what you can modify:

- Item general information
- Structure components
- Reference designators
- Substitute components
- AML

To route the items through a change order, in the Edit Item Batch dialog box select the following for change order:

- **One per Item**, **One per Item Class**, or **One per Item Batch**.
- **Add to existing** or **Create new**.

Revision Updates During Import

The change order import process updates the new revision of affected items automatically on an engineering change order. The revision number isn't incremented automatically on the affected item of an engineering change order if:

- The affected item is a part of another change order that is in scheduled status.
- The revision doesn't follow a standard pattern, or it's not obvious what the next revision should be. For example, the initial revision number is .001, or Z.

Item Batch Structure Options

Item batch structure options let you specify a defined item structure, how structure effectiveness is controlled, and which structure components are updated.

You can update structures on preliminary items and change orders.

Structure Effectivity Control

The following controls determine when changes to product structure components become effective:

- **Date:** Effectivity on a specified date

- **Model Unit Number:** Effectivity based on unit number
- **Serial:** Effectivity based on the serial number assigned to each unit of an item

Update Options

You can select to update only those structure components that have changed, or you can update all. The update options are:

- Changed components only: Use the Item Structure batch option **Changed components only** to update the item structure with only the changed structure components.
- All components: Use the Item Structure batch option **All components** in the Edit Item Batch Options page to dynamically update all structure entities. The import considers the data provided in the import file as the source of truth and updates the structure of the item accordingly.

Note:

- To remove any structure data using All components batch option, exclude the details of the entity such as component, reference designator or substitute component from the import file.
- The All components batch option only supports the synchronization of structure entities like components, substitutes, and reference designators. It doesn't support the synchronization of AMLs.
- The Delete transaction type and the Replace function aren't supported for the All components batch option in structure import.
- If there are errors when using the **All components** batch option the complete transaction isn't rolled back. The changes without errors are imported and the changes that caused errors are captured in the error log.

Deleting Component Data Using Import

Use the Delete transaction type in item structure import maps and FBDI templates to delete structure components, substitutes, and reference designators you don't want in the item structure.

Here's how you can do this:

- Set the Update option to **Changed components only** in the Item Structure section of the Edit Item Batches page. This only deletes the selected components in the item structure through the import process.

Note: You can also delete structure entities using FBDI import by selecting the transaction type as **Delete**.

- Map the transaction type of each entity you wish to delete and pass the transaction type as Delete in the import file. For example, if you want to delete a reference designator, you can select the Delete transaction type for the reference designator.
- If the import file includes a **Delete** component transaction type and an **End Date** value, the application will use the end date to complete the import.
- The following existing validations will be applicable for the **All components** batch option and the **Delete** component transaction type:

- You must route the structure changes through a change order if the parent item is a released engineering item or if it's already assigned to a change order.
- If you want to merge the structure changes on to the existing affected item, the effective dates must match or they must be set to effective on approval.

Item Batch Pack Options

The item batch pack option lets you specify which pack components are updated.

Update Options: You can select to update only those pack components that have changed, or you can update all. The two options are Changed Components only and All Components.

Best Practices for Item Import Performance

You can get the best results from your item imports by observing a set of best practices.

The recommended set of best practices for item import performance is:

1. Determine the scope of data to be imported.
2. Review the data model design.
3. Create the item batches and load data.
4. Set the profile options.
5. Request a performance analysis.
6. Plan strategies for data migration.

Determine the Scope Of Data To Be Imported

There are two aspects to determining the scope of data to be imported. The first aspect is the number of items (master plus child organization) and the second aspect is the total number of records.

Each item (master or child organization) is composed of multiple child objects which may result in multiple records being imported for a single item.

The total number of records is critical in determining the appropriate profile option settings.

The total number of records is obtained by counting the following for each item (master and child organization):

- One additional record for each master controlled single row attribute group for each master item (additional records are created for translatable attribute groups)
- One additional record for each organization controlled single row attribute group for each organization item combination (additional records are created for translatable attribute groups)
- One additional record for each item category association

- One additional record for each item attachment association
- One additional record for each item relationship
- One additional record for each row of a master-controlled multirow attribute group for each master item (additional records are created for translatable attribute groups)
- One additional record for each row of an organization-controlled multirow attribute group for each master item (additional records are created for translatable attribute groups)

Review the Data Model Design

Often, a review of the data model design may offer opportunities to reduce the total number of records. The following should be considered.

Consider whether there's an opportunity to:

- Reduce the number of item organization associations
- Use reference organizations
- Reduce the number of attribute groups
- Reduce the number of rows in multirow attribute groups
- Convert organization-controlled attribute groups to master-controlled

Create the Item Batches and Load Data

The optimal number of records to load in a single run of a item batch is 100,000 items (master or child organization) and their related child entity records. However, the total number of records should not exceed 4 million records per batch.

If a large number of items are to be imported, first import the master items and the related child objects, prior to importing child organization items and their related child objects. If possible, avoid importing items assigned to different child organizations in the same batch.

Items with attribute data can be imported together in a single batch.

Attachments should be imported in a separate batch once all the other child objects have been imported.

In general, we recommend that you load the data into an item batch using a CSV file with an import map. There are some cases where it's more efficient to load items using FBDI. This is true when the ratio of attribute group records to item records is high.

Note:

- It's recommended to import trading partner items separately and then import the trading partner item relationships.
- If you're using FBDI to import data, then don't delete any sheet or tab in the FBDI Item Import template. If any sheet isn't used for the import, then leave that sheet bank. Use a batch ID that's new or doesn't exist in the interface table for item import; don't repeat batch IDs.

Purging the interface tables frequently improves performance. The tables should definitely be purged so that no more than 4 million records are in the interface tables (across all batches).

If the purge results in a large number of records being purged (greater than 1 million), then run a small batch of 5-10 items first before importing a batch with a larger number of items.

Important: Do not run multiple item batches in parallel. This can be done by setting the **Process Sequentially** spoke system option to **Yes**. The item import process already contains logic to process the workload in parallel. You gain no advantage by submitting parallel batches and may cause record locking issues. However, **Process Sequentially** should be set to **No** only when the number of records in the batches is low (in the hundreds) and when there are no large batches being imported during the same time period.

Set the Profile Options

Examine the values of profile options that affect import, and set them according to your situation.

Profile Option Code and Name	Usage
EGP_CONVERSION_MODE Item Data Conversion Mode Enabled	<p>To support data conversion and initial load, this profile option must be set to Yes. Request a Performance Analysis

If the number of records that you plan to import is greater than 1 million, or you determine the throughput to be low after following the recommendations here, file a service request for a performance analysis.

Ensure that you provide an accurate count of the total number of items (master and child organization) as well as the total number of records, broken down by the categories listed here. Also, indicate the number of days in which you would like to complete the data migration. This is very important to get the right size.

Plan Strategies for Data Migration

A common strategy for data migration is to perform the migration in stages or phases. This allows more time to migrate the data and resolve errors.

In the first stage, the items can be imported well ahead of the go-live deadline. As you get closer to the go-live date, obtain a list of legacy items which have been added or edited since the first set of data was migrated and load those changes just prior to go-live.

For initial load or large batches, it's recommended to:

1. Explicitly insert master organization rows and child organization rows in the import. You can import all master items in batches of up to 500,000 items at a time.
2. Import organization assignments to these master items in batches of ten organizations at a time. However, you can assign these 10 organizations to all the master items.

Don't use rules to assign items to child organizations during the initial data load and for batches containing a large number of rows. This helps avoid performance issues as the import automatically processes the data into parallel threads.

If there are many reference organizations, then you can assign more than 10000 reference organizations for an item in the same batch.

Best Practices for Item Structure Import Performance

You can get the best results from your item structure import by adhering to a set of best practices.

Here's the recommended set of best practices:

1. Determine the scope of data to be imported.
2. Review the data model design.
3. Set the profile options.
4. Create the item batches and load data.
5. Request a performance analysis.

6. Plan strategies for data migration.

Determine the Scope of Data to be Imported

Here are the primary aspects to determine the scope of data to be imported.

- The number of structures or BOMs (bill of materials) to be imported, and the number of components per structure header, including reference designators and substitutes.
- The number of common structures you intend to have and the number of organizations you intend to associate these structures to.

The total number of records is critical in determining the appropriate profile option settings. This number is obtained by counting the following for each item structure.

- One additional record for each structure header to be created on an item. This should include primary and alternate structures.
- One additional record for each common structure on the child organizations (reference and definition organizations.)
- One additional record for the total number of components to be added to the structure.
- One additional record for the average number of components per structure.

Review the Data Model Design

Often, a review of the data model design might offer opportunities to reduce the total number of records.

Consider whether there's an opportunity to:

- Reduce the number of common structure creation.
- Reduce the number of structures by not considering the alternate structures wherever possible.
- Reduce the number of records for reference designators and substitutes.

Also consider importing only the latest revision of the released item structures.

Set the Profile Options

Examine the values of profile options that affect the structure import and set them according to your situation.

Profile Option Code and Name	Usage
EGP_CONVERSION_MODE Item Data Conversion Mode Enabled	<p>To support data conversion and initial load, this profile option must be set to Yes. Create the Item Batches and Load Data

First import item revisions that will be part of the structure, including substitutes.

If you want to create a common structure, you must associate the items to the child organization and then create the common structures.

The components, reference designators, and substitutes must be imported in the same batch. If you have the components already imported, you must have the component details in the input file while importing reference designators and substitutes.

Note: Don't run multiple item batches in parallel. This can be done by setting the **Process Sequentially** spoke system option to **Yes**. The item import process already contains logic to process the workload in parallel. You don't gain any advantage by submitting parallel batches and this might cause record locking issues. However, **Process Sequentially** can be set to **Yes** only when the number of records in the batches is low (in the hundreds) and when there are no large batches being imported during the same time period.

Request a Performance Analysis

If you determine that the performance is still slow after following the recommendations listed here, file a service request for a performance analysis.

Ensure that you provide an exact count of the total number of structures (primary and alternate) as well as the total number of components and average number of components per structure. Also indicate the number of days in which you would like to complete the data migration. This is very important to get the correct size.

Plan Strategies for Data Migration

A common strategy for data migration is to perform the migration in stages or phases. This allows more time to migrate the data and resolve errors.

In the first stage, you must import the item structures of the older revisions well ahead of the go-live deadline. As you get closer to the go-live date, you must obtain a list of latest released structures that are current effective and load those structures just prior to go-live.

Manage Item Batch Details

Unconfirmed Items in Item Batches

Unconfirmed items are the item records within an item batch that have been created or updated and are awaiting a confirmation step. These items haven't been fully processed or finalized in the system. You can manage the results of the data quality and item matching checks performed on the items in the batch and take appropriate actions.

Data Quality Results

Data quality results for each item are:

- *Classification*: Classifies the item and also assigns it to catalog categories.
- *Standardization*: Standardizes the attribute values of the item.
- *Matching*: Checks for duplicates in Oracle Product Hub.

Matching Results

There are the three matching result types:

- **Multiple Match**: There is more than one match found for the source item in Oracle Product Hub.
- **Single Match**: There is only one match found for the source item in Oracle Product Hub.
- **No Match**: There are no matches found for the source item in Oracle Product Hub.

Matching Actions

You can review and specify a match action for each unconfirmed item:

- **Confirm**: Matches the source item with an existing item in Oracle Product Hub.
- **Exclude**: Excludes this item from this import and all subsequent imports.

The next time the same item data is uploaded within a batch, the item data appears in the In Progress tab and the match actions value changes to Excluded.

- **Ignore**: Temporarily excludes this item from import.

The next time the same item data is uploaded within a batch, the item data appears in the In Progress tab and the match actions value changes to Included.

- **New Item**: Confirms that a new item must be created during import for this source item in Oracle Product Hub.

Managing Unconfirmed Items

You can also perform the following tasks in the In Progress tab.

- You can modify the item information that appears in the In Progress tab and add more items by selecting **Manage in Spreadsheet** from the Action menu or by clicking the **Manage in Spreadsheet** icon to download an item information spreadsheet.
- If an unconfirmed item is associated with a structure or pack, you can click the icon in the **Structure or Packs** column to display structure and batch details.
You can modify structures or packs by clicking **Manage in Spreadsheet** and selecting the appropriate template to download.

Update and then upload the spreadsheet to incorporate your changes.

Click **Check Data quality** to perform additional data quality checks after making changes to unconfirmed items.

Confirmed Items in Item Batches

On the In Progress tab, you manage items that have been matched and confirmed using matching rules, along with new items in the batch.

Match Types

Match types:

- **Single Match:** There is only one match found for the source item.
- **Multiple Match:** There is more than one match found for the source item.
- **No Match:** There are no matches found for the source item.

Matching Actions

You can review and specify a new match action for each confirmed item:

- **Unconfirm:** Mark the item as Unconfirm for further update.
Note: You can also unconfirm a cross-reference. When you find a new match for the unconfirmed item, the status for that matched item becomes a single match. Upon import, the existing cross-reference is end-dated and the new cross-reference is created with a start effective date equal to the import date.
- **Confirm:** Match with an existing source item in Product Hub.

- **Exclude:** Excludes this item from this import and all subsequent imports.
The next time the same item data is uploaded within a batch, it appears in the Excluded tab for that batch.
- **Ignore:** Temporarily excludes this item from import.
The next time the same item data is uploaded within a batch, it appears in the In Progress tab, and the match actions value is Excluded for that batch.

Confirmed Item Detail

The following detailed information is displayed for a highlighted confirmed item:

- Structures
- Packs
- Category Assignments
- Relationships

Importing Confirmed Items

Select **Import** to import all items into Product Hub.

Relationships in Item Batches

On the Relationships tab, review the relationships being imported for each of the items on the In Progress tab (if applicable).

Depending on the data, confirmed item relationships can be organized in up to four areas:

- Related items
- Trading partner items
- Global Trade Identification Number cross-references
- Cross-references

Related Items

You can review confirmed relationships based on predefined and user-defined relationship types, such as superseded items, substitutes, and complimentary items. Additional item attributes further qualify the relationship and effectivity dates indicate when these relationships are phased in and out.

Trading Partner Items

You can review the relationship of the confirmed item with the trading partner items.

GTIN Cross-References

GTIN cross-references relate confirmed items using the industry standard, enabling tracking and identification of trading partner items.

Cross-References

Cross references identifies items that have been consolidated from multiple source systems into a single master item.

Excluded Items in Item Batches

Purge Imported Item Interface Tables

You can purge the data from interface tables pertaining to import process. This permanently removes all records in the batch from the import interface tables.

You must purge batches after the batch has been imported successfully, and you have ensured that the data in the interface tables is no longer required.

A high volume of records in the interface table contributes to poor performing queries, data backup, data recovery, new index creation, and so on, thus affecting the import performance. Hence, there is a limit for the number of records in the interface tables. A warning message is displayed when the number of records in any of the interface table reaches five million and will indicate that you must purge the records. If you continue to ignore this message, then after a threshold limit of six million records in any interface table, the import process displays an error message. The Purge Interface Tables scheduled process log file will have a table that provides a list of interface tables, estimated number of records in each interface table, and the warning and error limits for each table.

You can purge the interface table data using one of these methods:

- Manage Item Batch page (if you have an Oracle Product Management Cloud Service subscription)
- Purge Interface Tables scheduled process (if you don't have an Oracle Product Management Cloud Service subscription)
- `purgeBatchData` operation in the Batch Maintenance SOAP service

Purge Interface Tables from Manage Item Batch Page

To purge the interface tables from the Manage Item Batch page:

1. In the Product Information Management work area, go to the **Manage Item Batches** task.
2. Search and select the item batch that you to purge.
3. In the **Search Results**, highlight the item batches that you want to purge.
4. From the **Actions** menu, click any of the following options:

- **All Rows** - Purge all rows in the item batch including rows with the status error and completed.
- **Error Rows** - Purge rows in the interface table that were terminated due to errors.
- **Completed Rows** - Purge rows in the interface table that were completed.

The data is purged in the interface tables based on your selection.

Purge Interface Tables Using Purge Interface Tables Scheduled Process

You can purge the records from interface tables that are uploaded using FBDI and non-FBDI modes:

- FBDI Mode – Records with valid load request IDs are purged.
- Non-FBDI Mode – Records are purged only when purge predicate is defined.

To purge the interface tables using the Purge Interface Tables scheduled process:

1. In the Scheduled Processes work area, click **Schedule New Process**.
2. Search and open the **Purge Interface Tables** schedule process.
3. Specify the following parameters:
 - **Purge Process Intent** – Select one of the following modes:
 - **File-based data import** - Purge the records that were loaded using file-based data import. You can purge based on the specified load request ID or a range of load request IDs.
 - **Maintenance** – Purge the interface table entries and the extracted files in the file location that are older than 30 days or a user-defined age.
 - **Other** - Purge the records that were loaded using non-FBDI methods. You can purge based on the specified request ID or a range of request IDs.
 - **Import Process** – Select the import process for which you want to purge the interface table records.
 - If you have selected **File-based data import** as **Purge Process Intent** mode, specify one of the following:
 - **Enable load request ID ranges** – Select this option and specify the range of the load request IDs in the **Start Load Request ID** and **End Load Request ID** fields.
 - **Load Request ID** – Specify the load request ID based on which the purge must be performed.
 - **Extract Data** – If you have selected **File-based data import** as the **Purge Process Intent** mode, then select this option to indicate whether the entries to be purged must be extracted and uploaded to a file location or not.
 - **Allow context purge of data** – Select this option if **Purge Predicate** must be considered while purging the FBDI entries.
 - **Number of Days** – If you have selected **Maintenance** as the **Purge Process Intent** mode, then specify the number of days to a number greater than 30. The interface table entries and the extracted files in the file location exceeding this value for a given import process are purged.
 - If you have selected **Other** as the **Purge Process Intent** mode, specify one of the following:
 - **Enable request ID** - Select this option and specify the **Start Request ID** and **End Request ID**.
 - **Request ID** – Specify the request ID.
4. (Optional) Click **Advanced** and schedule the process to run at a later date and time. You can schedule the Purge Interface Tables job when the **Purge Process Intent** mode is **Maintenance**.
5. Submit the scheduled process.

The scheduled process deletes the interface table records for the selected import process.

Auto Schedule Purge Job

The Purge Interface Table scheduled process purges the interface and error table data (default setting is within 30 days of the initial load). Before purging the records, the interface and error data is extracted and uploaded to a file location for the individual product import process that's used.

The extracted file format is: ImportBulkData_<ImportJobName>_<LoadRequestId>.zip

The Purge Interface Table scheduled process will also purge these extracted files automatically (default setting is within 30 days of the initial file load).

You can access the extracted files using:

- File Import and Export UI
- ERP Integration Service Operations

Purge Interface Tables Using `purgeBatchData` Operation

You can purge the interface tables using the `purgeBatchData` operation in the Item Batch Maintenance SOAP Web service. For more information, see the Item Batch Maintenance SOAP Web service in the SOAP Web Services for SCM guide, available at docs.oracle.com.

Import Items Using Import Maps

Importing Item Data Using Import Maps

Retailers can upload data using spreadsheets and suppliers can send product and catalog data as comma-separated values (CSV) or Extensible Markup Language (XML) files.

Suppliers can use standard industry formats, such as BMECat or eClass, or others. Users must onboard or upload the data provided by suppliers into Oracle Product Hub.

The following is an overview of the functions that you can perform when importing items using import maps.

- Bring in data in XML format directly through an import batch without having to reformat it.
 - Upload item data in XML format directly to an import batch. The data is processed and placed in interface tables for import into Oracle Product Hub.
 - When uploading the XML file, map the elements of the XML file to the Product Hub data columns to facilitate moving the data into interface tables.
 - Preview the data from the XML file after mapping the XML elements to the Product Hub data columns.
 - Save the mapped data columns to be reused later for another data upload.
 - Optionally, link saved maps to suppliers so only relevant maps are used by suppliers.
 - The data map can be inherited from parent's item class.
 - Import maps can be used to upload data to an item batch of any source system.
 - If data errors are encountered during the XML file upload, then no data gets uploaded. The data errors are identified along with the type of errors and presented to user in a report.
 - XML file upload also preprocess all the data records so that users can navigate to the batch details and look at the data in the interface tables.

- Bring in data in the Nested XML file format directly through an import batch without having to reformat it.
 - Upload item data in Nested XML format directly to an import batch. The data is processed and placed in interface tables for import into Oracle Product Hub.
 - Nested XML files support mapping of recursive and repeating XML nodes and attributes. When uploading the Nested XML file to import packaging and structure data:
 - Map the parent node containing item information to the Item node in the Master Data region of the Import Map.
 - Map the recursive parent node with packaging and structure child item information to the **Pack** or **Structure** node in the Master Data region.
 - For example, for GDSN, Data Stewards map the `catalogueItem` XML node to the Item node in the Master Data region and the `catalogueItemChildItemLink` XML node to the Pack node in the Master Data region
 - The repeating nodes of a Nested XML data file display in the Source Data region of an import map. When a repeating node is mapped, the other corresponding repeating nodes can't be mapped.
 - Recursive nested XML refers to nested XML in which the structure or packaging hierarchy is built top-down, rather than the entire hierarchy at the same level. For example, this hierarchy:

```
Parent Item
  Child Item 1
  Child Item 1A
```

is represented by this nested XML:

```
<Item>Parent Item
  <Item>Child Item 1
  <Item>Child Item 1A</Item>
  </Item>
</Item>
```

- An XML attribute refers to an attribute on an XML element. For example, `languageCode` is an XML attribute in `<descriptionShort languageCode="en">Short Description</descriptionShort>`.

`<descriptionShort languageCode="en">Short Description</descriptionShort>`
- You can map XML attributes this way:
 - An XML attribute is displayed under its XML element in the Source Data region of the import map. Map the XML attribute in the Source Data region to the item attribute in the Master Data region of an import map.
 - Map an XML node in the Source Data region to an item attribute in the Master Data region, based on the value of the XML attribute. To do so, you can use the `decode()` function to create an expression. For example, consider an XML node that contains descriptions in various languages, such as `<descriptionShort languageCode="en">Short Description</descriptionShort>`. Based on the language specified in the XML attribute, you can map the XML node using the following `decode()` function: `Item.Main.DESCRIPTION.US=decode([languageCode], 'en', [descriptionShort], '')`, where `languageCode` is the XML attribute and `descriptionShort` is the XML node.

- Bring in product data in the CSV file format directly through an import batch without having to reformat it.
 - Upload item data in CSV format directly to an import batch. The data is processed and placed in interface tables before being imported into Oracle Product Hub.
 - When uploading the CSV file, map the metadata (columns) of the CSV file to the Product Hub data columns to facilitate pushing the data into interface tables.
 - Preview the data from the CSV file after mapping the CSV columns to the Product Hub data columns.
 - Save the mapped data columns to be reused later for another data upload.
 - Optionally, link saved maps to suppliers so only relevant maps are used by suppliers.
 - Import maps can be used to upload data to an item batch of any source system.
 - If data errors are encountered during the CSV file upload, then no data gets uploaded. The data errors are identified along with the type of errors and presented to user along with sample data rows. Using this, rectify the data errors and upload the CSV again.
 - CSV file upload also preprocess all the data records so that users can navigate to the batch details and look at the data in the interface tables.

Note: When entering item data in the data file, we strongly recommend that you group all data of an item together.

- Manage item batches.
 - Create an import map while uploading source file data to item batch from Manage Item Batches page.
 - Additionally, create an import map from the Manage Import Maps page
 - Edit and delete import maps from the Manage Import Maps page.
- Map source data for items, packs, and structures.
 - Upload a CSV, XML, or Nested XML file using the controls in the Source File region.
 - Map the CSV columns or XML elements to entities in the Master Data table.
 - Map data sources by dragging them from the Source Data table and dropping them on the corresponding entities in the Master Data table.
 - Map data sources by selecting **Map Source Columns** from the Actions menu of the Source Data table and then selecting the corresponding entities in the Master Data table in the Select Master Column dialog.
 - Expand the Pack and Structure nodes in the Master Data table to expose the attributes of packs and structures. By mapping to these attributes you can import pack and structure hierarchies.
 - Map source data to item attributes in the Master Data table so that items are imported along with packs or structures.
 - Import maps support the mapping and import of all attributes available for items, item relationships, attachments, descriptive flexfields, and trading partner items.
 - Source data columns that contain values in multiple languages can be mapped to attributes that support multiple languages. The language of a source column is identified by the value of the language code column in that row.
- Transform source data using complex expressions before importing the data through an import batch.
 - Write basic transformation expressions using functions that operate on the source data, such as the string functions `split()` and `concat()`.
 - The `split()` function:

- Takes the source data value to be split
- Takes the delimiter that indicates the points in the value at which to split the value into parts
- Takes the part number to return
- Returns the part of the split input value corresponding to the specified part number

Example:

If the value of Attribute1 is

```
AS-100#Acme Solution 100#Description
```

then:

```
split([Attribute1],#,2)
```

returns

```
Acme Solution 100
```

- The `concat()` function takes multiple source data values as input and concatenates them into a single value.
- The transformation functions are independent of the file type used for uploading the data.
- To use a transformation expression, the general procedure is:
 - i. Select a row in the Source Data table. Select **Actions > Create Expressions**. Select the Master Data Column into which the evaluated value of the expression is uploaded.
 - ii. Select the function to use. Build the expression by inserting Source Data columns and other parameters to the selected function.
 - iii. Optionally, validate the expression.
- Associate multiple suppliers with the import map.
 - Select the **External** check box to enable all suppliers to access the import map as a template in Oracle Product Hub Portal.
 - If you enable external suppliers, you can then specify which ones can access the import map. Click the **Manage Suppliers** button and use the **Manage Suppliers** dialog to add only the wanted suppliers.
- Import items to multiple organizations.
 - Map a source data column that identifies the organization for an item to the Master Data attribute `Item.Main.Organization`.
 - During import, source items are assigned to the organization identified in the source data.

- Set change order line effective dates.
 - For the source data attribute that provides the effective date for change order lines, map its source data column to the Master Data attribute `Item.Main.Change Order Line Effective Date`.
 - In the Change Orders region of the **Edit Item Batch Options** dialog box for the item batch that uses the import map, set the value of **Effective Date** to **User-entered**.
 - During data upload, the value provided for the effective date attribute in the source data file is inserted in the `VERSION_START_DATE` column in the interface table. On importing item changes, the mapped date value is set as the Effective Date for the change order line.
- Import item category assignments:
 - Map data source columns for the item categories to the **Catalog.Item Categories** set of the master data attributes.
 - Set the start and end dates of the item category assignments using the Start Date and End Date attributes available under the Item Categories node of the import map.

You can delete the end dates of the existing item category assignments through import by entering `#NULL` in the smart spreadsheet column that's mapped to the End Date attribute under Item Categories node of the import map.

- Re-assign existing item category assignments to new ones using the Old Category Code and Old Category attributes available under the Item Categories node of the import map. Make sure the Transaction Type is passed as `UPDATE` in the data file.

Note: You can't save an import map if the **External** check box in the import map is selected and any of the Old Category Code or Old Category attributes are mapped.

- Import structures with components, reference designators, and substitutes.
 - Map data source columns for the structure to the **Structure.Item Structure** set of master data attributes.
 - Map data source columns for the structure component to the **Structure.Component** set of master data attributes.
 - Optionally, import common structures.

Note: Only the first level of common structure can be created through import.

- Map the data source column containing the item number of the source item from which the common structure is to be created to the master data attribute `Structure.Item Structure.Common Structure Item`.
- Map the data source column containing the organization of the source item from which the common structure is to be created to the master data attribute `Item.Main.Common Organization`.

Note that the attribute Common Organization was previously named Pack Common Organization.

- Optionally, import reference designators and substitute components with start dates.
 - To import a reference designator for the structure, map a source column to the master data attribute `Structure.Reference Designator.Reference Designator`.
 - To import substitutes for the structure, map a source column to the master data attribute `Structure.Substitute.Substitute Item` or `Structure.Substitute.Substitute Source System Reference`.
 - If you import start dates for a structure component (by mapping to the master data attribute `Structure.Component.Start Date`), and are also importing reference designators and substitute

components, you must enter the date value in every row of the data file that contains details for the reference designator or substitute.

- You don't directly specify the effectivity start dates for reference designators and substitutes. The import process applies the effectivity start date for a component to its reference designators and substitutes.
- If you're importing multiple reference designators or substitutes for a component, then you must enter the component's effectivity start date in every row of the source data file that specifies a reference designator or substitute.

In this rough example of source data, the date 1-Oct-2020 must be entered for every row that specifies a reference designator or substitute.

Component	Component Start Date	Reference Designator	Substitute
Comp123	1-Oct-2020	RefDes001	
Comp123	1-Oct-2020	RefDes002	
Comp123	1-Oct-2020		Sub001
Comp123	1-Oct-2020		Sub002

- If you're importing the same component with different effectivity dates, then the import process applies the effectivity start date for the component to the corresponding reference designator or substitute specified in that dated component's row of the source data file.

In this rough example of source data, the reference designator RefDes001 will be imported with a start date of 1-Oct-2020, and the substitute Sub002 will be imported with a start date of 1-Nov-2020.

- Replace components on the following:
 - Item structures of commercial items
 - Preliminary item structures of engineering items
 - Affected item structures on a change order

- Share import maps between applications instances.
 - Use the Setup and Maintenance work area to export setup data associated with import maps, and import that data to another instance of Oracle Fusion Cloud Applications. After importing this data into a target instance, you will be able to view and edit the mappings there. You can export and import by specifying either:
 - The entire Product Management offering
 - The Items functional area
 - The Manage Import Maps task (which exports only the import maps)
 - The Manage Import Maps task as part of an implementation project.
 - Import map task data is exported and imported as CSV files or configuration packages.

- You can compare the setup data for import maps, as you can with other setup data, by using the **Compare Setup Data** action.
- Only the mappings in an import map are exported, not the CSV or XML data files associated with the import map, or any Smart Spreadsheets attached to the import map.
- After you have imported the import maps into the target instance, run the **Regenerate Import Map Templates** scheduled process to regenerate the Smart Spreadsheets for the imported import maps.

How You Import Item Data Using Import Maps

You can use import maps to help upload item data from a variety of external sources into Oracle Product Hub.

To use external data sources whose layout doesn't exactly correspond to the master data for Product Hub, you can map source data from comma-separated value (CSV) files and Extensible Markup Language (XML) files to the master data.

When you specify a CSV, XML, or Nested XML source data file while creating or editing import maps in the Managing Import Maps page, the file data isn't directly uploaded to Product Hub, but is first uploaded to an item batch. You can upload source data using import maps from the Manage Item Batches page.

You can create an import map or edit an existing import map using the following procedure.

Note: You can also import the setup data for an import map from another instance of Oracle Fusion Applications. For details, see the topics cited here about importing setup data using an offering or functional area.

Create or Edit an Import Map

Create or edit an import map as follows.

1. Depending on your access privileges, you can create or edit import maps in these ways:
 - In the Product Information Management work area, select the **Manage Import Maps** task from the panel drawer.
 - In the Setup and Maintenance work area, use the **Manage Import Maps** task:
 - Offering: Product Management
 - Functional Area: Items
 - Task: Manage Import Maps
2. To create an import map, click the **Create** icon on the toolbar or select **Actions > Create** from the menu.
To edit an existing map, search for and select the map, then click the **Edit** icon on the toolbar or select **Actions > Edit** from the menu.
3. On the Create Import Map or Edit Import Map page, specify the following import map information.

UI Element	Description
Import Map	Enter a name for the import map. This field is required.
Description	Enter a description of the import map.
Item Class	<p>Select an item class to associate with the import map.</p> <p>This item class is associated to items that don't have an item class specified in the data file uploaded to an item batch for import. The item class is also used to display this import map in Oracle Product Hub Portal if you select the External check box.</p>
Source Map	<p>Optionally, select an existing import map to inherit its import map details.</p> <p>If a source map is selected, the Data Map section of the current map is populated with inherited item mapping information. You can also map additional source data, but you can't edit or delete the inherited item mapping details.</p>
External	Select to specify that the mapping can be used for third-party, external suppliers.
Suppliers	<p>This option appears if you select External.</p> <p>Click the Manage Suppliers icon to open the Manage Suppliers dialog box, and select the supplier for which the import map is defined, and who can view the import map.</p> <p>You can specify multiple suppliers, by adding more in the Manage Suppliers dialog box. If no supplier is specified, the import map is visible to all suppliers.</p>
Active	Select to enable the import map for use.

Specify Source File Information

Specify information in the Source File section as specified in the following table.

UI Element	Description
File Type	Specify the source file type to be used to upload data. Options are: Text, XML, Nested XML.
Delimiter	Specify the type of delimiter used in the source data file. Options are: Comma, Tab, Colon, Semicolon, Pipe, Space, Other.
Date Format	Select a format for the date.

UI Element	Description
Time Stamp Format	Select a format for the time stamp.
Encoding Type	Select an option to specify the file encoding format. Options are: US-ASCII, ISO-8859-1, UTF-8, UTF-16BE, UTF-16LE, UTF-16.
Upload From	<p>Select Desktop, URL, or Network from which to upload source data.</p> <p>Specify the source data file location:</p> <ul style="list-style-type: none"> Desktop: Click Browse and select the source data file. URL: Enter the URL for the source data. Network: Specify whether the file is a recent file or a specific file. Enter the path of the source data file.
Templates	Displays the Microsoft Excel templates generated for the import map.

Map Source Data and Master Data Attributes

The Source Data table displays the data columns from the source file. The Master Data table displays the item attributes available in Oracle Product Hub. You can map attributes from different item classes in a single import map. You can map one source map attribute to multiple master data attributes, but not the other way around. You can create expressions on source data attributes to combine multiple source data attributes and map the expression to a master data attribute.

1. In the Master Data table, select an option in the **Item Class** field to specify the item class from which to view and map the master data attributes. The default item class is **Root Item Class**.
2. In the Master Data table, locate a master data attribute to which you want to map a source data attribute.

Expand the hierarchical attribute tree to locate an attribute. You can also search for an attribute by entering all or part of the attribute's name in the search field above the master data list. Click the **Next** and **Previous** controls to locate multiple occurrences of the attribute.

3. To map a source data attribute to a master data attribute, drag and drop an unmapped row from the Source Data Column of the Source Data table onto an attribute in the Master Data table.

Alternatively, select a data column in the Source Data table, select **Actions > Map Source Columns**, search for and select a master data attribute in the Select Master Column dialog box, and click **OK**.

4. If you're using transformation expressions to operate on source data:

- a. Select a source data column and click **Create Expressions** on the toolbar, or **Actions > Create Expressions** from the menu. The Create Expression page displays.
- b. Click **Select** to specify the master data column with which to map the expression. The Select Master Column dialog box displays.
- c. Search for and select the master data column and click **OK**.
- d. Select a function in the **Functions** tab and click **Insert**. The expression template text appears in the pane at the bottom of the Create Expression page.
- e. In the expression template, position the cursor where you want to add an attribute, select the source attribute from the **Source Columns** tab, and click **Insert**. The column is added to the expression.
- f. Insert the required columns to the expression format to create the required expression. Delete the placeholder text from the expression template.
- g. Click **OK** to create the expression and map it to the master data attribute. The Create Expression page closes, and the expression you created appears in the **Expression** column in the Source Data table of the Create Import Map page.

Note: Alternatively, to save an expression and create another expression on the same source data column, click **Apply and Create Another** on the Create Expression page.

5. In the Preview Data section, click the **Refresh** icon or select **Actions > Refresh** from the menu. The table is populated with mapped data. You can preview the result of the mapping and make changes if required.
6. Click **Generate Templates** if you want to create a Microsoft Excel template, also referred to as Smart Spreadsheet, for the import map.
7. Click **Save**.

Generate Smart Spreadsheets

Product data stewards can generate Smart Spreadsheets for import maps. These spreadsheets help users in reducing data entry errors while creating the data files that are to be used for importing data into Product Hub. These spreadsheets contain the attributes that are mapped in the import map, with their respective list of valid values and metadata information, such as data type, maximum length, and precision. The data entered in the spreadsheet is validated against the attribute metadata. Data files can then be generated from the populated spreadsheets, which can then be used to import data into Product Hub. The Smart Spreadsheets that are generated take only the attribute metadata that's available at that point in time when they're generated. So if any attribute metadata is edited after the Smart Excel is generated, then you need to regenerate the Smart Spreadsheet.

Here's how you create Smart Spreadsheets:

1. Click the **Generate Templates** button in the Source Data region of the Import Map.
2. In the Generate Templates dialog box, select the languages for which the spreadsheets are to be generated.
3. Click **Generate**. Language-specific Smart Spreadsheets are generated and attached to the import map. Use the link at the **Templates** field of the Source File region of the map to download the templates.

Keep these points in mind:

- We strongly recommend that you don't create Smart Spreadsheet templates with more than 256 columns. If more than 256 columns exist in a template, then you will be asked to save the spreadsheet as a macro-enabled workbook (**.xlsm** file) when you open it.
- A Smart Spreadsheet takes longer to open if there are several columns containing a large list of values.

You can regenerate Smart Spreadsheets in one of these ways:

- Clicking the **Generate** button on the Edit Import Map page and saving the Import Map
- Running the **Regenerate Import Map Templates** scheduled process.

When scheduling this process, select these options:

- **Item Class:** If blank, the templates are generated according to the selections in the **Import Maps** and **Languages** fields. If you select an item class, then templates are generated for the import maps for that item class and also for its child item classes. The default is no selection of item class.
- **Import Maps:** The default is **With templates**.
 - Select **With templates** to regenerate templates only for import maps that have templates.
 - Select **All** to regenerate templates for all import maps.
- **Languages:** Select the languages for which the spreadsheets are to be regenerated, or for all installed languages. If you don't make any selection, then templates are only generated for languages that exist for the import maps affected by the **Import Maps** field. The default is no selection of languages.

The selections you make for these process options are considered as a set of criteria for whether to generate templates (meaning Item Class AND Import Maps AND Languages).

If you're using Smart Spreadsheets on a Mac:

- The data file automatically generated from the Smart Spreadsheet is saved to the folder containing the spreadsheet.
- If more than 256 attributes are mapped in the import map, you need to save the Smart Spreadsheet as a macro-enabled workbook (**.x1sm** file) before using it.

Add Data, Generate Data File, or Upload Data Using Smart Spreadsheet

The smart spreadsheet contains two sheets—Instructions sheet and Data sheet. The Instructions sheet provides the information to validate data, generate a data file, and upload the data to the item batch for import. The Data sheet is where you will enter the data. It also provides the name of the item batch, spoke system, and the import map that was used to generate the spreadsheet. These attributes won't display in the smart spreadsheets generated for import maps marked as external.

If the spreadsheet was generated from the Manage Items or Browse Items pages, then:

- Item batch name is autogenerated.
- Spoke system name is the product information management data hub spoke system.

If the spreadsheet was downloaded from the Edit Import Map page, then the item batch name and spoke system name is blank.

Note:

- If you change the import map name, the specified import map won't be used for generating the data file or uploading the data to an item batch. This attribute is for information purpose only
- Item attributes with only 10000 values are displayed as drop-down lists in the smart spreadsheet
- The smart spreadsheets doesn't work with 32-bit Microsoft Office on Mac and 64-bit Microsoft Office is required
- Smart spreadsheet is certified on Microsoft Excel 365. The spreadsheet is supported only for those Excel versions that are currently supported by Microsoft Corporation.

Adding and Validating Data in the Smart Spreadsheet

To enter the data in the smart spreadsheet, refer to the bubble text on each column header for the description of the data and data type that the column requires. After adding the data, click **Validate** on the **Add-ins** tab to validate the data. If there are any errors, the respective cells are highlighted. Click the bubble text in the column header to understand and correct the error. If a value isn't entered for a mandatory attribute, warning is displayed. Resolve all the errors and warnings and then click **Validate** to confirm that there are no errors.

If the smart spreadsheet is generated from the Manage Items or Browse Items pages, then:

- Enter the date attribute in the MM/DD/YYYY format.
- Enter the timestamp attribute in the YYYY-MM-DDTHH:mm:ss.SSS-Z format. SSS indicates milliseconds and Z indicates the UTC time zone. For example, 2001-07-04T12:08:56.235-0700.
- The revision effective date is displayed in the UTC time zone.

After validating the data, you can either generate a data file or upload the data to the item batch for import.

Generating a Data File

To generate a data file, click **Generate Data File** on the **Add-ins** tab. Use this data file to import the data into Product Hub.

Set Change Order and New Item Request Options in Smart Spreadsheet

You can set the change order and new item request options in the smart spreadsheet before uploading the item data from the smart spreadsheet to the item batch. The display of these options depends on the **Item Batch Options in Smart Spreadsheets Enabled** profile option. If this profile option is enabled, then after specifying the access token during upload, the Item Batch Options dialog box is displayed, where you can specify the change order and new item request settings. In case the access token was already provided and is still valid, then the Item Batch Options dialog box dialog is displayed directly.

These change order and new item request batch options are the same as the Edit Batch Options dialog that is displayed while editing an item batch from the Manage Item Batches page.

The initial values of these options are populated from the Spoke System settings of the item batch being created or updated.

The Item Batch Options dialog box won't display if the value of the **Item Data Conversion Mode Enabled** profile option is set to Yes.

If both **Item Batch Options in Smart Spreadsheets Enabled** and **Item Data Conversion Mode Enabled** profile options are set to **Yes**, then the **Item Data Conversion Mode Enabled** profile option has higher precedence and the Item Batch Options dialog box won't display in the smart spreadsheets.

The **Item Batch Options in Smart Spreadsheets Enabled** profile option is set to **No** by default.

Uploading Data to the Item Batch for Import

The data is uploaded to the item batch based on the batch name and spoke system name in the smart spreadsheet. You can change these names based on your requirement. If the item batch name doesn't exist, it will create the batch and then upload the data into the batch.

Note: You can only upload up to 10000 rows from the smart spreadsheet to an item batch. If there are more than 10000 rows, you must generate the data file from the smart spreadsheet and upload it to an item batch from the Manage Item Batches page.

To upload data to the item batch for import:

1. On the **Add-ins** tab, click **Upload Data**.
2. In the Upload Data dialog box, click **Generate Access Token**. If you're not logged in to Product Hub, you will need to log in after clicking **Generate Access Token**.
3. In the Generate Access Token page, click **Generate and Copy Access Token**. The access token is copied to the clipboard.
4. Paste the access token in the Upload Data dialog box and click **Upload Data**.

The upload progress is displayed. After the upload process is complete, the number of rows that are uploaded and the batch number is displayed.

Note: If you're using Mac, click **Paste Access Token** in the Upload Data dialog box to paste the access token.

Important Points

- If you upload the data without validating it and if there are any errors and warnings, then the respective cells are highlighted. Resolve all the errors and warnings and then upload the data again.
- If you make any changes to the data and click **Upload Data**, the upload starts, and you don't have to provide the access token again. But, if you close the spreadsheet and open it, then you must generate the access token for uploading the data.
- If a batch with the name specified in the Item Batch Name attribute doesn't exist, then a new batch with that name is created and the data is uploaded to that batch.
- If the smart spreadsheet was generated using the Mass Update action, then the created batch is of the Mass Update type. If the smart spreadsheet was generated from the Edit Import Map page, then the created batch is of Import type.
- Smart spreadsheets of external import maps don't allow data upload directly from the smart spreadsheets to an item batch.
- When using a smart spreadsheet on Mac to upload data to an item batch, if the smart spreadsheet contains multi-byte characters, you'll be asked to grant additional permissions for generating and accessing the data file on your system before the data is uploaded. You must grant this permission for the data to get uploaded to the item batch.
- Descriptive flexfield attributes are shown as free text in the template. Valid values aren't shown for descriptive flexfield attributes.

- Dependent value sets don't show dependent values in the template. All values from the value set are shown in the drop-down of the template.
- When uploading the data:
 - Ensure the date and date time formats match with the import map setup to minimize errors during upload.
 - The numeric decimal separator and grouping separator are honored based on the user locale. The application user preferences aren't considered.

Use Transaction Type

You can control imports by using the attribute **Transaction Type** in import maps.

- For all spoke systems, you can create, update, sync, or delete an item entity when you import item data using import maps, by specifying the value for the Transaction Type attribute as CREATE, UPDATE, SYNC, or DELETE. Only those item entities that can be deleted through FBDI can be deleted through import maps as well.
- If data is uploaded directly to an item batch using import maps in Oracle Product Hub, then the valid values for the Transaction Type attribute are: CREATE, UPDATE, SYNC, and DELETE. Note that the DELETE Transaction Type is only supported for item entities that can be deleted through FBDI.
- If data is uploaded using product uploads in Product Hub Portal, then the valid values for the Transaction Type attribute are SYNC and DELETE. If the value for the Transaction Type attribute is specified as CREATE or UPDATE, then it's converted to SYNC during the data file upload process.
- If the Transaction Type attribute isn't mapped, or is mapped but has no value provided in the data file, then the SYNC transaction type will be inserted by import maps in the interface tables.
- Use the Delete transaction type in item structure import maps and FBDI templates, to delete the structure entities such as components, substitutes, and reference designators in an item structure. For details see the topic Item Batch Structure Options.
- For translatable extensible flexfields, the Transaction Type attribute is displayed for mapping in import maps once per installed language.
- You can manage attachments to items, item revisions, or trading partner items, by selecting the value for the Transaction Type attribute, as CREATE, UPDATE, SYNC, or DELETE. For details, see the topic on import of attachments.
- If you upload data using the Supplier Products REST resource in Oracle Product Hub Portal Cloud, then the Transaction Type attribute:
 - Is available only for extensible flexfields, relationships, and categories.
 - Can only have the values SYNC and DELETE. A value of CREATE or UPDATE causes an error.
 - For single-row extensible flexfield data, can only have the value SYNC. A value of CREATE, UPDATE, or DELETE causes an error.

Functions for Import Map Expressions

You can create expressions using one or more source data columns and map them to master data attributes. For example, the Long Description attribute in Master Data may include information from the Item and Description columns of the Source Data.

The functions used to create expressions can be of type String, Math, Generic, and Calendar.

String Functions

The string functions available for creating expressions are listed in the following table.

Import Item Attachments

Manage Item Attachments by Import

In addition to importing items, you can also import and upload the attachments related to the items to Product Hub. Attachments may include digital assets such as images, PDF files, and videos. You can also update and delete existing attachments by using import.

You can import item attachments by these methods:

- File-based data import (FBDI)
- Import maps

In addition to importing attachments, you can also add attachments to items using REST APIs as described here.

For the files that are to be imported as attachments, you can provide them to the import process by either:

- Compressing the files into a compressed file (recommended for ongoing incremental attachment imports)
- Uploading the files to Oracle WebCenter Content (recommended for initial migration or large volume attachments import for best performance. Note that any user with direct access to Oracle WebCenter Content and the FAFusionImportExport security group will be able to view all files in WebCenter Content.)

For the compressed file method, each compressed file must not be more than 500MB. If your compressed file size is larger than 500MB, then you should split it into multiple files. Each item batch must not have more than 5 to 10 compressed files and less than 5000 attachments should be imported per item batch. Including compressed files within compressed files is not recommended.

Identify Documents in Oracle WebCenter Content

If you have uploaded your attachment files to Oracle WebCenter Content, you need to identify the attachment documents to be imported.

To identify your attachments, use the GET_SEARCH_RESULTS search service of the Core Content Server for Oracle WebCenter Content to obtain the values of these attributes of an uploaded file:

File Attribute to obtain	Use attribute value for
dDocName This value also appears in the Content ID field of the user interface of WebCenter Content.	The value of Document ID in FBDI template spreadsheets and in import maps.
dID	The value of Document Version Number in FBDI template spreadsheets and in import maps.

Manage Attachments with File-Based Data Import

You can import, update, and delete attachments to items, item revisions, and trading partner items using file-based data import (FBDI).

1. Identify the source of your attachment files, in Oracle WebCenter Content, or in a compressed file.
2. Refer to the Oracle Fusion Cloud SCM: File-Based Data Import for SCM guide for more information about using FBDI to load data into interface tables and product tables. Use the spreadsheet template file for item import to specify your item data and item attachment data.

3. In the downloaded template file `ItemImportTemplate.xlsx`, Specify your item attachment data in the EGP_ITEM_ATTACHMENTS_INTF sheet. The template file includes formatting details and example values.

Column Name	Column Description
Transaction Type	Indicates the action (CREATE, UPDATE, SYNC or DELETE) to be performed. If you're not sure whether an attachment for an item exists, use SYNC, which updates existing attachments or creates attachments if necessary.
Batch ID	The ID of the item batch that's to be used for importing attachments.
Batch Number	The number of the item batch that's to be used for importing attachments.
Item Number	The item number of the item to which the attachment is to be attached.
Organization Code	The organization of the item.
Revision	The item revision to which the attachment is to be attached.
Source System Code	The external source system from which data is being imported.
Source System Reference	The Spoke System Reference data or the Item Name from the external source system.
Trading Partner Item Number	The item number of the trading partner item being attached.
Trading Partner Number	The number of the trading partner providing the attachment.
Entity Type	The entity for which the attachment is to be imported: Item, Item Revision, Customer Item, Competitor Item, Supplier Item or Manufacturer Part Number.
Batch Doc Name	The name of the compressed file containing the attachments to be imported.
Attachment Category	The category of the item attachment being imported. Examples: Image, Miscellaneous. If the attachment category of an existing attachment is changed to another attachment category with the Primary attribute set to Yes through import, and a primary attachment already exists for that attachment category on the item, then the attachment being imported will be set as the primary attachment after successful import. The Primary attribute of the existing attachment will be unchecked after successful import.
File Type Name	The type of attachment being imported. Values are: File, Repository File/Folder, URL, or Text.

Column Name	Column Description
File URL Text	The file name or URL of the file to be attached to an item.
Document ID	The ID in Oracle WebCenter Content of the document to be imported.
Document Version Number	The revision number in Oracle WebCenter Content of the document to be imported.
Title	The title of item attachment being imported.
Shared	Indicates whether the attachment is a shared attachment.
Primary Category Flag	Optional. Marks the attachment category as primary for the attachment. For example, if there are multiple item images attached to an item, the primary image appears first when you view that item.
New Attachment Category	The new category of the item attachment being updated by import.
New File URL Text	The name of the updated file or URL to be attached to an item.
New Title	The new title of the updated item attachment being imported.

4. If you're importing item attachment files that were uploaded to Oracle WebCenter Content:

- o Select `Repository File/Folder` in the **File Type Name** column.
- o Either do this:
 - **Batch Doc Name:** Leave the column empty.
 - **Document ID** and **Document Version Number:** Specify the values.

Or this:

- **Batch Doc Name** column: Specify the name of the compressed file.
- **Document ID** and **Document Version Number:** Omit the values.

5. Generate a `.csv` file from the template.

6. Upload the `.csv` file, and the compressed file containing attachments (if you're using one), to the account `scm/item/import`.

The size of the compressed file should be kept under 2 GB.

7. In the Scheduled Processes work area:

Schedule the process **Load Interface File for Import** to load the attachment data to the interface tables.

Schedule the process **Item Import** to import the attachments from the interface tables to the product tables.

8. During import:

- If you provided the attachment files by uploading them to Oracle WebCenter Content, then the files with the specified Document ID and Document Version Number from WebCenter Content are added to the item, item revision, or trading partner item as attachments.
- If you provided the attachment files using a compressed file, then the files from the compressed file are extracted and added to item, item revision, or trading partner items as attachments.

Manage Attachments with Import Maps

You can import, update, and delete attachments to items, item revisions, and trading partner items using an import map.

1. Identify the source of your attachment files, in Oracle WebCenter Content, or in a compressed file.
2. Create an import map and map the columns of the source data file to the attachment attributes listed in this table, in the **Attachment** node in the Master Data region of the import map.

You can't save an import map as external if any one of these attachment attributes are mapped: New Category, New File Name, or New Title.

Attachment Attribute	Attribute Description
Attachment Entity	The entity for which the attachment is to be imported: item, item revision, customer item, competitor item, supplier item or manufacturer part number.
Category	The category of the item attachment being imported. If the attachment category of an existing attachment is changed to another attachment category with the Primary attribute set to Yes through import, and a primary attachment already exists for that attachment category on the item, then the attachment being imported will be set as the primary attachment after successful import. The Primary attribute of the existing attachment will be unchecked after successful import.
Description	The description of the item attachment being imported.
Document ID	The ID in Oracle WebCenter Content of the document to be imported.
Document Version Number	The revision number in Oracle WebCenter Content of the document to be imported.
File Name	The file name or URL of the file to be attached to an item.
File Type	The type of attachment being imported. Values are: File, Repository File/Folder, URL, or Text.

Attachment Attribute	Attribute Description
New Category	The new category of the item attachment being updated by import.
New File Name	The name of the updated file or URL to be attached to an item.
New Title	The new title of the updated item attachment being imported.
Primary	Optional. Marks the attachment as the primary attachment. For example, if there are multiple item images attached to an item, the primary image appears first when you view that item.
Sequence	Optional. Marks the sequence of the attachment. For example, if there are multiple item images attached to an item, the image appears on the item in the indicated sequence when you view that item.
Shared	Indicates if the attachment is shared with another entity.
Title	Title of the item attachment being imported.
Transaction Type	<p>Indicates the action (CREATE, UPDATE, SYNC or DELETE) to be performed during import.</p> <p>To delete an existing attachment by import, select DELETE.</p> <p>To update an existing attachment by import, select UPDATE.</p> <p>If you're not sure whether an attachment for an item exists, use SYNC, which updates existing attachments or creates attachments if necessary.</p>

3. Create an item batch.

- If your attachment data is in a compressed file, select the **Upload from File** action and upload the item data file and the compressed file containing item attachments to be imported.
- If your attachment data is in Oracle WebCenter Content, map the source data columns to the master **Document ID** and **Document Version Number** attributes in the **Attachment** node of the **Attributes** table in the Master Data region. Then select **Upload from File** from the **Actions** menu and upload the item data file to be imported.

4. Submit the batch to import the item attachments.

Manage Existing Attachments

After importing new attachments, you can update or delete existing attachments using either file-based data import (FBDI) or import maps.

To update or delete existing attachments, the high-level tasks are:

- 1.** Decide whether to import by FBDI or by import map. This may have been decided by your previous imports.

2. Identify each existing attachment to be updated or deleted.
3. Set the import **Transaction Type** for the attachment to UPDATE, DELETE, or SYNC. SYNC updates an attachment if it exists, or creates a new attachment if it doesn't exist.
4. If updating the attachment, provide the new attachment's category, file name, and title.

The task details are provided in this table:

Task	FBDI	Import map
Identify the existing attachment	<p>Verify the correct values for the columns:</p> <ul style="list-style-type: none"> • Attachment Category • File URL Text • Title <p>See the identification logic in the next table.</p>	<p>Verify the correct values for the columns:</p> <ul style="list-style-type: none"> • Category • File Name • Title <p>See the identification logic in the next table.</p>

Note:

- To update an existing attachment of the File or Repository File/Folder attachment type by uploading a new file, you should use only the compressed file import method.
- To create or update a particular attachment of Repository File/Folder attachment type, you should specify the attachment title and description in only one row of the data file and not all rows.

The identification logic for updating or deleting existing attachments depends on the type of the attachment, as described in this table:

Attachment Type	Identification Logic
File	The existing attachment will be identified during import using a combination of these attributes:
Repository File/Folder	<ul style="list-style-type: none"> • The attachment category • The file name, URL, or text <p>If no attachments are found with that combination, then the import process fails.</p>
URL	<p>If multiple attachments are found with that combination, then the attachment title is also used for identification.</p> <p>If multiple attachments are still found with that expanded combination, then the import process fails.</p>

Attachment Type	Identification Logic
Text	<p>The existing attachment will be identified during import using a combination of these attributes:</p> <ul style="list-style-type: none"> • The attachment category • The attachment title <p>If no attachments are found with that combination, then the import process fails.</p> <p>If multiple attachments are found with that combination, then the import process fails.</p>

Import Shared Attachments

You can share the same attachment among multiple items

The high-level process for importing shared attachments is:

1. Designate an attachment on an existing item as shared.
2. Import attachments to other items by referencing the sharing data from the source item.

The detailed process for importing shared attachments is:

1. For the item that's the source of the attachment to be shared, create a shared attachment through either of these ways:
 - o On the Attachments tab of the item, select **Actions > Add Attachment**. In the Details pane for the attachment, select **Shared**.
 - o Perform an attachments import using the compressed file method that's described elsewhere in this topic. Be sure to select **Shared** when importing the first attachment.
2. For the other items that are sharing the attachment, create an attachment in each item, using the data listed in the following table, either through an import map or by FBDI item import.
 - o For import maps, map the attributes.
 - o For FBDI item import, pass the attribute values in the data template file (on the `EGP_ITEM_ATTACHMENTS_INTF` sheet of the `ItemImportTemplate.xlsxm` file).

Attribute	Value
Shared	Yes
File Type Name	Repository File/Folder
File URL Text	The name of the attachment file in the source item
Document ID	In WebCenter Content, the ID (dDocName) of the attachment file in the source item
Document Version Number	In WebCenter Content, the version number (dID) of the attachment file in the source item

Import Specific Entities

When importing specific entities, you need to provide specific information for certain entries.

You need to provide some specific information when importing:

- Item images
- Item revision attachments
- Trading partner item attachments
- Attachment descriptive flexfields

Attachment Entity	FBDI Template File	Import Map
Item images	Enter Image in the Attachment Category column.	Enter Image in the Category column.
Item revision	Enter the specific item revision in the Revision column, and select ITEM_REVISION in the Entity Type column.	Map the source Revision column to the master data Item Revision > Revision column. Map the source Attachment Entity column to the master Attachment > Attachment Entity column. Specify ITEM_REVISION in the source file column that maps to the Attachment > Attachment Entity attribute.
Trading partner item	Enter the trading partner item data in the Trading Partner Item Number and Trading Partner Number columns and specify CUSTOMER_ITEM , COMPETITOR_ITEM , SUPPLIER_ITEM or MANUFACTURER_PART_NUMBER in the Entity Type column.	Map the source TPI columns to the master Trading Partner Item > TPI attributes. Map the source Attachment Entity column to the master Attachment > Attachment Entity column. Specify CUSTOMER_ITEM , COMPETITOR_ITEM , SUPPLIER_ITEM , or MANUFACTURER_PART_NUMBER in the source column that maps to the master Attachment > Attachment Entity attribute.
Descriptive flexfields	Enter the Descriptive Flexfields values in the attachment Descriptive Flexfields columns.	Map the source Descriptive Flexfields columns to the master Descriptive Flexfields attributes in Attachment > Additional Attributes .

Add Attachments Using REST API

You can use REST APIs to add files in Oracle WebCenter Content as item and item revision attachments, and as product attachments.

1. Upload your attachment files to Oracle WebCenter Content.
2. Identify the source of your attachment data, in Oracle WebCenter Content, using the **GET_SEARCH_RESULTS** search service of the Core Content Server for Oracle WebCenter Content to obtain the values of **dDocName** and **dID** for an uploaded file.

3. Once the files are uploaded to Oracle WebCenter Content, you can use the dDocName and dID to:
 - o Use the POST action on the Item Attachments child-resource of the Items Version 2 REST API to add the files as item level attachments.
 - o Use the POST action on the Item Revision Attachments child-resource under the Item Revisions child-resource of the Items Version 2 REST API to add the files as item revision level attachments.
 - o Use the PROCESS action of the Product Uploads REST resource to add the files as product attachments.

The Product Uploads REST API uses import maps to upload the data from the source data file to the staging interface tables. When calling the Product Uploads REST API, you need to specify:

 - The import map to use for uploading the data to staging interface tables.
 - The Oracle WebCenter Content location of the source data file (CSV or XML) containing the item data. You can upload the source data file to the `/scm/item/import/` account.
 - Either:
 - o The Oracle WebCenter Content location of the compressed file containing attachment files. You can upload the compressed file to the `/scm/item/import/` account. Using a compressed file is recommended.
 - o An import map in which you have mapped the Document ID and Document Version Number attributes.
 - o During the POST or PROCESS action, the file with the specified dDocName and dID from Oracle WebCenter Content is added to the item as a non-shared attachment.
 - o The user who uses these REST APIs should be the same user who uploads the files to Oracle WebCenter Content.

Import Descriptive Flexfields

How You Import Descriptive Flexfields

You can import descriptive flexfields from your source file using import maps. You add your source file that has the descriptive field details to the import map and then create a mapping with the master data.

You define mappings for flexfields in the Source Data table on the Create Import Map or the Edit Import Map page. You can access this page from the Manage Import Maps task in the Product Information Management work area.

You can import descriptive flexfield data related to these entities:

- Item
- Item Revision

- Item Relationship
- Trading Partner Item
- Attachment
- Structure

Each of these entities have an attribute group named Additional Attributes that holds the descriptive flexfield data. You can map these descriptive flexfields with the source file to create an import map, and then import the data.

Here's some additional information for Item Relationship, Trading Partner Item, and Structure master attributes:

- For the Item Relationship entity, you can define descriptive fields in the Additional Attributes attribute group. Within Additional Attributes, you have the Entity attribute where you specify that the descriptive flexfields belong to which relationship type, such as Related Item, GTIN and Cross-Reference.
- For the Trading Partner Item entity, you can define the descriptive flexfields for TPI and TPI Relationship in the Additional Attributes attribute group. Within Additional Attributes, you have the Entity attribute where you specify that the descriptive flexfields belong to which TPI or TPI Relationship type, such as MPN, Supplier Item, Customer Item, and Competitor Item.

You import TPI Relationships by mapping item attributes in the Item entity, and by mapping TPI attributes in the Trading Partner Item entity. In addition to these, if you also map the descriptive flexfields in Additional Attributes, then the descriptive flexfield is imported as TPI Relationship descriptive flexfield (not as TPI descriptive flexfield).

Also, you import TPIs by mapping only the TPI attributes in the Trading Partner Item entity. In addition to these, if you map the descriptive flexfields in Additional Attributes, then the descriptive flexfield is imported as TPI descriptive flexfield (not as TPI Relationship descriptive flexfield).

- For the Structure entity, you can define the descriptive flexfields for Structure Header, Component, Substitute, and Reference Designator in the Additional Attributes attribute group. Within Additional Attributes, you have the Entity attribute where you specify that the descriptive flexfields belong to which Structure entity: Item Structure, Component, Substitute or Reference Designator.

What are the required attributes for adding items to a batch?

If the source system that you're importing from isn't Product Information Management Data Hub, then your spreadsheet for the import must include values for these attributes:

- Source System Reference
- Source System Reference Description
- Source System Code
- Transaction Type
- Organization Code
- Batch ID

You must copy the value for the batch ID from the batch's row on the Manage Item Batches page.

Can I map attributes of multiple item classes in a single import map?

Yes. While mapping the attributes on the Create Import Map or Edit Import Map page, you can select an item class from the Item Class field in the Master Data region and then map the item class-specific attributes.

You can then select another item class in the Item Class field and map its attributes.

Can I change the item class of an item during import using an import map?

Yes. You can specify the new name of the item class in the source data file column.

While creating or editing an import map, map the source column to the New Item Class Name attribute in the Main attribute group under the Item node in the Master Data region.

Can I delete a batch if it is not assigned to me?

No, you can only delete item batches that are assigned to you.

In addition, you cannot delete an item batch with a status of Active.

Can I import multibyte characters using import maps?

Yes. You can import multibyte characters using import maps by setting the Encoding Type attribute to UTF-16 on the Create Import Map page and by uploading a data file that is encoded to UTF-16.

Can I import double quotation marks using CSV files and import maps?

Yes. You can import double quotation marks using CSV files and import maps by escaping the double quotation marks. To escape the double quotation marks, enclose them within another double quotation mark.

Here are a few examples to import double quotes. If you enter the following values in a CSV file:

1. """Laptop with 15 inch display."""
2. "Laptop with ""15 inch"" display."
3. "Laptop with 15 inch"" display."
4. """Laptop with ""15 inch"" display."""
5. """Laptop with 15 inch"" display."""

Import map imports the following values:

1. "Laptop with 15 inch display."
2. Laptop with "15 inch" display.
3. Laptop with 15 inch" display.
4. "Laptop with "15 inch" display."
5. "Laptop with 15 inch" display."

How can I set existing attribute values of items to null during import?

Replace the existing attribute values with a predefined value that matches the data type (character, date, date-time, number, and so on) of the values you want to set to null. See the following table for predefined values.

Attribute Type	FBDI	Import Maps (CSV and XML)	ADFDi (Excel)	Item Version 2 SOAP Web Service
Character	#NULL	#NULL	#NULL	xsi:nil="True"
Date	#NULL	#NULL	Not Supported	xsi:nil="True"

Number	9.99E+125	#NULL	9.99E+125	xsi:nil="True"
Number, with precision X	For precision of X, enter 9, X times. Example for precision of 6: 999999	#NULL	For precision of X, enter 9, X times. Example for precision of 6: 999999	xsi:nil="True"

Note: To nullify all fields of an existing row of a multi-row attribute, you must set the Transaction Type column to DELETE in the FBDI or smart spreadsheet.

How can I import line breaks when importing items using import maps?

When you enter data for the attributes in the import map, make sure you use the Enter key to add a new line and use double quotes for the entire text so that during import, the data is imported properly.

For example, use:

```
"dddd  
ccccc"
```

Note: The double quotes are added automatically if the CSV data is prepared in Excel. Only if the data file is prepared manually, you must explicitly add the double quotes.

Why can't I change the edit item batch options for new item request or change order?

Editing of the new item request and change order options on the Item Batch page is restricted when the profile option **EGP_CONVERSION_MODE** has a profile option value of **Yes**.

The **Yes** option is used for performance reasons when initially importing items in large quantities. The Item Import scheduled process will then skip the security check for new item request and change order policies.


Use these steps to change this setting.

1. From the Setup and Maintenance work area, select the Product Management offering.
2. Select the Items functional area.
3. Select the Manage Item Profile Options task.
4. Select the **EGP_CONVERSION_MODE** profile option.

29 Supplier Products

Overview of Managing Supplier Products

Supplier product administrators can create products in Product Hub Portal that are sent to the Product Hub for review.



Users can create supplier products in the Product Hub Portal UI, using the smart spreadsheet or through a scheduled upload. The product data steward reviews the products and either requests more information, rejects, or approves the products. Products that need more information or are rejected are sent back to the supplier. The supplier can view the

product status on the Manage Products page. Products that are accepted are added to an item batch. Products that are rejected can be resubmitted by the supplier. When the item batch completes, the products are available in Product Hub with a status of Imported.

Overview of Creating Supplier Products

Suppliers can create products in these ways in Oracle Product Hub Portal:

- Through the Create Product task in the Product Hub Portal.
- By uploading a file.
- Through a scheduled product upload.

Create Supplier Products

As a supplier, you can manage your own products from Product Hub Portal.

You can create, edit, and bulk upload the products, as well as monitor the status of the products. When you upload the products, your products are stored in a staging area.

While creating and editing the products, you can provide data for the various product attributes, as well as upload product specific attachments.

To create a product:

1. In the Supplier Portal work area, select the **Manage Products** task from the task list.
2. Select **Actions > > Create**.
3. Select the category for the product that you want to create.
4. You must provide values for these required fields:
 - Category
 - Product
 - Description
 - Primary Unit of Measure

For multi-row extensible flexfield rows, you must provide a value for the unique row identifier attributes.

Other fields may be required. You can save a product without providing values for all of them, including required extensible flexfields.

Note: If you're creating products using product uploads, then you must provide values for all required extensible flexfields.

5. Optionally, attach attachments to the product.
6. Optionally, associate the supplier organizations to the product.
7. Click **Save**. The **Status** field displays the value **DRAFT**.
8. After entering the values for all the required attributes, click **Submit** to submit the product.

Consider these points when you create a product:

- A saved product remains in a Draft status until you submit it. After you submit the product, the Product Data Steward can review the submitted product before importing it into Product Hub.
- Once the Product Data Steward import the products into Product Hub, an item is automatically created in Product Hub and a Spoke Item Relationship is created for the item. The spoke system is set to Supplier's Spoke System and the spoke item number is set as the product, as uploaded by the supplier in Product Hub Portal.
- A Product Data Steward can also import the product as a Supplier Item Relationship or MPN Relationship by asking the suppliers to upload their products in Product Hub Portal using an import map. The import map must have the mappings for these Trading Partner Item Relationships.
- As a supplier, you can also specify the MPN Relationship on the Create Product page while creating a product in Product Hub Portal.

Add Supplier Organization Associations

Suppliers can associate their organization addresses to products and specify the corresponding extensible flexfield values. They can search for their addresses using Global Location Numbers if they're set up for the addresses. Product Data Stewards can then optionally review the supplier provided data before importing it in Oracle Product Hub as supplier organization associations.

To add the supplier organization associations:

1. On the Create Product or Edit Product pages, click the **Supplier Organization Associations** tab. The Supplier Organization Associations page is displayed.
2. Search and select the required address.
3. Specify the purchase price, customer price, and the margin.
4. Submit the changes.

Note: The **Supplier Organization Associations** tab is displayed only if the Product Data Steward has added the supplier-level extensible flexfield attribute groups to the **Product Hub Portal** sub-tab of the item class associated to the category of the product being created or edited.

Suppliers can delete an address only if the product is in the **Draft** status. Once the product is submitted, the delete action is disabled and suppliers can't delete the address. To delete supplier organization associations of non-draft status products, you can use Supplier Products REST.

Supplier Product Uploads

Suppliers can upload product data, using a file, through Oracle Product Hub Portal.

Upload Flow

The following table describes the basic product upload flow when your supplier uses Product Hub Portal. This flow assumes that you're responsible for managing import of data to production tables, and that you have set up a spoke system for your product data supplier.

Who (User)	Where (Location)	What (Objects)	How (Action)
You	Edit Import Map page	Import map	Select the External option and choose the suppliers who will upload data. Select a source data file and map columns of source data to master data attributes.
You	Edit Import Map page	Import map source data file	Use the Generate Templates action to generate templates that suppliers can download in product hub portal.
Your supplier	Product Uploads page in Product Hub Portal	Import map source data file	Click Download Templates and download the source data template file, which is named for the corresponding import map.
Your supplier	Downloaded Template	Smart spreadsheet	Enter the product data and generate the data file to be uploaded to product hub portal.
Your supplier	Product Uploads page	Generated data file	Click Upload File , then specify the category and data file. A default name for the upload is provided. Click Upload to start the upload of the source data file to the interface tables.
You	Review Supplier Uploads page	Product information	Review and accept or reject products uploaded by suppliers and create item batches.
You	Manage Item Batches page	Item batch containing the data upload	Review the new item batch and import options for the spoke system definition for your supplier.

Note:

- Suppliers can't import structure component substitutes or reference designators from Oracle Product Hub Portal.
- When subsequent supplier product upload is performed, the newly uploaded product data is merged with the existing product data.
- When you upload a product with an incorrect category, you can't re-upload a new file with the correct category until you delete the existing product. To delete the existing product, use the Supplier Product REST resource and then you can upload the new data file with the correct product category.

Delete Attribute Values from Production

Supplier product administrators can delete attribute values of a product in Product Hub Portal and submit the changes for import into Oracle Product Hub. On successful import, the attribute values on the production item are deleted.

- Be aware of the following scenario, and its effect on the attributes **GTIN**, **GTIN UOM**, **Manufacturer Part Number**, and **Manufacturer Name**:
 - a. You have previously imported a supplier product into production with GTIN or MPN relationships.
 - b. The supplier deletes the attribute value in Product Hub Portal.
 - c. You re-import the supplier product.
 - d. GTIN or MPN relationships aren't deleted from production items after import if values are deleted from Oracle Product Hub.

Upload Products with Smart Spreadsheets

Suppliers can download the Smart Spreadsheets that are exposed to them by the Product Data Stewards. They can use these spreadsheets to fill out their product data and generate the data files which can then be uploaded to Product Hub Portal.

The Smart Spreadsheets contain the metadata information of the item attributes that are mapped in the Import Map to which the spreadsheet belongs to. The suppliers can use this information to accurately fill in their product data. The metadata information could be valid values that can be entered for the item attributes, the maximum number of characters that can be entered for an item attribute, the data type of the item attribute, and so on.

Uploading Data Using Smart Spreadsheets

In the Product Hub Portal, supplier product administrators can download the smart spreadsheets exposed by the Product Data Stewards, enter data, and create and upload data files. The spreadsheet contains two sheets—Instructions sheet and Data sheet. The Instructions sheet provides the steps to enter and validate data, and then generate a data file. The Data sheet is where you will enter the data.

You can use smart spreadsheets to upload data to the Product Hub Portal as follows:

1. Download the smart spreadsheet template as follows:
 - a. In the Supplier Portal work area, click the **Manage Products** task.
 - b. On the Manage Products page, select the **Product Uploads** infolet.
 - c. Click **Download Templates** to download and save a smart spreadsheet template.
2. Enter data into the smart spreadsheet.
3. Validate data in the smart spreadsheet: On the **Add-Ins** tab, click **Validate** to check the data entered in the smart spreadsheet against the attribute metadata. The rows that fail the validation are highlighted in the Status column. The Status column isn't included in the generated data file.
 - o Errors indicate an invalid value or a missing value for the Item Number and Spoke Item Number required attributes.
 - o Errors also display if a value exceeds the character limit or doesn't follow the allowed format.
 - o Warnings indicate a missing value for the required attributes that are optional if you're updating data.
 - o If a row contains both an error and warning, it's highlighted with the higher severity status, that's an error.
 - o Resolve all errors and warnings, and click **Validate** to confirm.
4. Generate a delimited data file from the smart spreadsheet: On the **Add-Ins** tab, click **Generate Data File**. The data file is generated from the validated spreadsheet.
5. Upload the data file to Product Hub Portal as follows:
 - a. On the Manage Products page, select the **Product Uploads** infolet.
 - b. Click **Upload File**. The Upload File dialog box displays.
 - c. From the **Category** drop-down list, select the product category for which you want to create the products.
 - d. Select a template in the **Template** field to upload the product data. Select the same template that was downloaded to fill in the product data.
 - e. Upload the data file in the **File** field. Optionally, you can also upload a ZIP file containing product attachments, using the **Attachments** field.
 - f. Enter a name in the **Upload Name** field.
 - g. Click **Upload** to upload the data file.

The newly created or updated products are submitted to the Product Data Stewards for review. On successful import, products are created or updated in the Product Hub.

Source Data Files

The source data file contains the product data to be uploaded to the Product Hub staging tables. Before a supplier can enter data in the file, you must associate the file with an import map and map its columns to attributes in the item master data table the import map. Source data files can be in the text or XML formats. A supplier downloads the source data file template, which has the same name as the import map, from the Product Uploads page.

The following example shows product data in text format.

Review Supplier Uploads

Product data stewards can review the products submitted by all suppliers that they have access to in Product Hub.

Managing Products by Product Data Stewards

After reviewing products submitted by suppliers, product data stewards can then choose to selectively import the products into Product Hub by adding them to item batches. Once the items are added to item batches, they're copied from the supplier staging area to the item batch, from where they're imported into Product Hub. If blending rules are set up by the product data stewards then the product data of multiple suppliers is blended before it's imported into Product Hub. The data stewards can also choose to request more information from the suppliers for the submitted products, or reject the products.

Reviewing Supplier Uploads

Product data stewards can view the product uploads and products submitted by all suppliers in Product Hub from the Review Supplier Uploads page. They can then take necessary actions, such as importing the products in Product Hub, requesting more information for the submitted products and rejecting the products.

From the Review Supplier Uploads page, product data stewards can review the product uploads and products submitted by all suppliers in Product Hub.

Importing Supplier Products into Product Hub

Product data stewards can selectively import the submitted products into Product Hub by adding them to item batches.

When the products are added to item batches, they're copied from the supplier staging area to the item batch. This action keeps a copy of the product data in the supplier staging area. The products added to the item batches can then be imported into Product Hub. Changes made to the products in Product Hub aren't visible to suppliers in Product Hub Portal.

Rejecting Supplier Products

Product data stewards can reject the products that they don't want to import into Product Hub. The suppliers can then edit the rejected products in Product Hub Portal, make any needed changes, and resubmit the product for upload.

How You Can Schedule File Uploads in Product Hub Portal

Your supplier can place product data in the Oracle WebCenter Content and schedule automated uploads of that data at defined intervals. The automated upload requires a manifest file, which identifies one or more source data files and corresponding optional attachment files to be uploaded.

To schedule an automatic upload, your supplier must:

1. In Oracle WebCenter Content, place one or more source data files in Contribution Folders.
2. Provide a manifest file, in CSV format. The manifest guides the upload process to the source data files for a specified schedule. A separate product upload will run for each source data file. The manifest must contain the following columns:
 - Template: The name of the item map template associated with each data source file included in the manifest.
 - File Path: The relative path in Oracle WebCenter Content to each data source file to be uploaded.
 - Attachments File Path: The relative path in Oracle WebCenter Content to each optional references file to be uploaded.
3. In Oracle WebCenter Content, place the manifest file in Contribution Folders.
4. On the Schedules page of the Product Hub Portal, create a schedule.
5. Enter a name for the schedule, and the path to the manifest file in Oracle WebCenter Content, such as `Contribution Folders/SPManifest.csv`.
6. Specify the frequency and start date for the scheduled uploads. The frequency should accord with your supplier's upload plans.

Note: To ensure that data isn't uploaded redundantly, the manifest file is marked as processed after each run, and the schedule won't run again unless an unprocessed file is detected.

7. Since a schedule can include multiple uploads, they're each assigned a number. Specify the starting number and numbering increment. You can optionally specify a text prefix for each upload name.

Worklists and Notifications in Product Hub Portal

As you and your supplier proceed with the product upload and import process, you're both informed of its progress and status, by workflow notifications. These messages indicate what action you should take next.

- Worklist notifications are sent to both your supplier and to you.
- Notifications appear in the worklist.
- Workflow notifications contain the following information:
 - Details about the upload job, such as the assignee, originator, task number, and supplier name.
 - Recommended actions related to the status of the workflow event. The actions differ for different events.
 - Details about the product data in the upload, such as the item class, import map name, and data template file name.
 - Links to the files used by the upload, such as the data template file. The links point to Oracle WebCenter Content.
 - The name and number of any item batches created by a successful upload.

1. If a file upload fails, then you and your supplier receive a notification. The recommended action is to correct the errors and upload the file again. In Product Hub Portal, your supplier can click the **Download Errors** button in the Product Upload dialog to download the errors file.
2. If a file upload succeeds, and the schedule of the item batch is set to On Data Load, then you and your supplier receive a notification. The recommended action informs you that the scheduled import is in progress. The item batch resulting from the upload is identified.
3. If a file upload succeeds, and the schedule of the item batch is set to Manual, then you and your supplier receive a notification. The recommended action is to initiate an import of an item batch. The item batch resulting from the upload is identified. A link is provided to the Manage Item Batches page.
4. You receive a notification when a supplier submits a product by creating or updating it from the Create or Edit pages in Product Hub Portal. You also receive a notification when a supplier resubmits a product that had been rejected but was edited to fix the issue.

Your supplier receives a notification when you request more information for a submitted product, while reviewing it from Review Supplier Upload page.

Your supplier receives a notification when you raise a subscription request for supplier products from the Manage Data Pool Subscriptions page.

30 Data Quality

Check Data Quality

Data Quality

The quality of product data is enhanced with data quality, which provides classification, standardization, and matching to refine item data and to prevent duplicate items. Item data can be inconsistent, especially when imported from external sources.

Data quality involves the following:

- Data quality checking
- Data quality attributes
- Classification
- Standardization
- Matching

Data Quality Checking

When you check data quality, data quality applies classification, standardization, and matching to the items that you are creating, editing, or importing, and then presents you with the results for acceptance.

You can check the quality of your product data:

- When you are creating a single item interactively
- When you are creating multiple items interactively
- When you are editing an item interactively
- By running a periodically scheduled process that checks the items in an item class
- When you are importing a batch of items

Data Quality Attributes

Data quality depends primarily on the values of designated attributes. You define the detailed rules for the relationships between these data quality attributes, which are used for either standardization or matching. Then, you designate these attributes at the item class level.

Categorization

Categorization includes suggested assignments of items to one or more catalogs and to categories within those catalogs. For example, if the Power attribute equals 10 watts and the Capacity attribute equals 300 ohms and the Capacitance attribute equals 10 microfarads, then the item belongs to the Capacitor category. Categorization rules are defined using the Manage Item Rule Sets task.

Standardization

You can define rules that make the values of specified item attributes consistent with desired norms. For example, you might convert all Fahrenheit temperature values to Celsius, or all English measurements to metric. You can also use standardization to merge divergent forms of attribute values into a single consistent form, such as by changing the unit of measure values **in.** and **IN** to **Inches**. Standardization rules are defined using the Manage Item Rule Sets task.

Matching

You can define rules for detecting when an item that is being created or imported matches an item that already exists in the Oracle Product Hub repository. For example, suppose that if power supply items differ only in the finish style of the casing, then they are considered to match existing items. To get this result, you would not use the hypothetical Casing Style attribute as a match-rule attribute.

Check Data Quality for Items

The following scenarios illustrate the ways in which you can check data quality when working with items.

- Creating a single item
- Creating multiple items
- Editing an item
- Importing an item batch

Creating a Single Item

To check data quality when creating a single item interactively:

1. On the Create Item page, select **Actions > Check Data Quality**.
2. Examine the Check and Apply Data Quality Results window, which displays the classification, standardization, and matching values.
3. If the data quality results are satisfactory, click **Apply** to apply the new values to the Create Item page.
4. The data quality checks are also performed when you click **Save**, **Save and Close**, or **Submit**. Note that you can submit an item only when its item class is enabled for new item requests.

Creating Multiple Items

To check data quality when you're creating multiple items interactively:

1. On the Create Multiple Items page, select **Actions > Check Data Quality**.
2. Examine the Check and Apply Data Quality Results window, which displays, for each item in the set, the classification, standardization, and matching values.

3. Use the iterator control to examine different items in the set. Click **Remove item** for an item to be removed from the set.
4. If the data quality results are satisfactory, click **OK** to apply the new values to the Create Multiple Items page.
5. The data quality checks are also performed when you click **Save and Close** or **Submit**.

Note: You can submit items only when their item class is enabled for new item requests. If the data quality results contain a mixture of enabled and nonenabled items, then the **Submit** action is replaced by the following actions:

- o Add all of the items to a new item request, regardless of whether the item class is enabled.
- o Add only the enabled items to a new item request.

Editing an Item

To check data quality when you're editing an item interactively:

1. On the Edit Item page, select **Actions > Check Data Quality**.
2. Examine the Check and Apply Data Quality Results window, which displays the classification, standardization, and matching values.
3. If the data quality results are satisfactory, click **Apply** to apply the new values to the Edit Item page.
4. The data quality checks aren't performed when you click **Save**, **Save and Close**, or **Submit**.

Note: Data quality isn't automatically checked when you update an item. To ensure data quality for existing items, you can run the periodically scheduled **Semantic Key Update** process.

Importing an Item Batch

You can specify data quality options when defining a source system or through an import batch definition by selecting **Check Data Quality** in the Data Quality section of the source system or batch definition. Items being created in Oracle Product Hub go through the data quality check automatically, while items that are updated using batches must have the data quality check initiated manually.

Matching

How Items are Matched

Items that are created during import or through the application go through global trade item number (GTIN) and trading partner item (TPI) matching in addition to attribute matching as part of data quality checks.

Matching Flows

Here's a summary of when and how items are matched:

- In the Product Information Management work area, potential duplicates are shown:
 - When the item is created through the Create Item task.
 - When the item is updated through the Manage Items task and the Edit Item page.
 - For each item being created or updated, the data quality matching check runs, and:
 - Identifies any potential duplicates
 - Presents potential item duplicates to the user in the Data Quality dialog box, where the Matching region shows all the similar duplicate items that have the same values
 - Prevents possible item duplicates, based on the value of the profile option **Allow New Item Creation When a Item Match is Found** (EGI_ALLOW_ITEM_CREATE_DQ_MATCH_FOUND)
 - The duplicates are identified based on:
 - Matching attributes
 - Trading partner items associated with the item that are being updated
- During the flow of items being imported, potential duplicates are shown:
 - In the Data Quality subtab of the In-Progress tab of the Item Batches page.
This display allows the product data steward to select one of the items and allows the steward to update entity values based on import data.
 - During import, the steward selects one of the matching items to allow the import to update the attribute values of the matched item instead of changing the item provided in the import.

Tip: The essential purpose of presenting users with potential duplicates is to make them consciously decide whether or not to create a duplicate item.

Matching During Updates

Matching is only performed when one of these entities is updated, either by user action, import, or rules.

- Matching attributes that are associated with the item.
- Trading partner item (TPI) data associated with the item: Manufacturer Part Number, Supplier Part Number, Competitor Part Number, or Customer Part Number.
- Global trade item number (GTIN): By default, the same combination of GTIN and UOM can't be added to multiple items in Product Hub. If the UOM is different, then the same GTIN can't be associated with multiple items.
- Spoke system items: By default, the same spoke item can't be added to multiple items in Product Hub. This only applies to batches that are not from the Product Information Management Data Hub spoke.

Enable Matching During Updates

You enable must enable matching during updates to determine whether potential duplicates are shown to the user and what actions can be performed by the user.

To enable matching during updates:

1. Opt in to the feature Check for Item Match Upon Item Update.
2. In the Setup and Maintenance work area, use the **Manage Data Quality for Products Profile Options** task:
 - o Offering: Product Management
 - o Functional Area: Items
 - o Task: Manage Data Quality for Products Profile Options
3. Edit the profile option **Allow New Item Creation When a Item Match is Found** (EGI_ALLOW_ITEM_CREATE_DQ_MATCH_FOUND).
4. At the desired Profile Level, set the **Profile Value** to **Yes** to allow duplicate items to exist, either by creating a new item or updating an existing item.
5. Save the profile option value.

How GTIN and TPI Matching Is Processed

Items that are created during import or through the Create Item task go through global trade item number (GTIN) and trading partner item (TPI) matching in addition to attribute matching as part of data quality checks.

The data quality check first attempts to match items based on the spoke system item number, if the spoke system is not Product Information Management Data Hub. If no existing cross-references are found, data quality check then performs matching in the following sequence:

1. GTIN
2. Supplier Part Number
3. Manufacturer Part Number
4. Customer Part Number
5. Competitor Part Number

Once a match is found, the matching program stops and will not continue to the next match type. Data quality then checks for matches defined at the item class. The spoke system cross reference is created and is used in update cases.

For GTIN matching, an internal item is identified as a match if the GTIN of the incoming item exists as a GTIN cross reference on an internal item and the pack type of the incoming item is the same as that of the internal item. When creating items with a GTIN cross reference, the reference is used to match against existing items with GTIN cross references. Then you can accept the match and choose to update the existing item with the new data or ignore the match and create it as a new item.

For TPI matching, supplier, manufacturer, customer, or competitor items are considered a match only when the trading partner and trading partner item associated to the internal item are the same as the incoming item. When creating items with TPI associations, they are used to match against existing items with the TPI associations. Then you can accept the match and update the existing item with the new data or ignore the match and create it as a new item.

FAQs for Data Quality

When does data quality checking occur?

Data quality is checked automatically when you save newly created items, but you must explicitly check data quality when you save existing items that you have just updated. You can run a scheduled process to periodically check data quality.

When you are creating a new item, or multiple items, you can select **Actions > Check Data Quality**. The data quality checks are also performed automatically when you select **Save**, **Save and Close**, or **Submit**.

When you are editing an existing item, you must select **Actions > Check Data Quality**. Data quality is not checked automatically.

When you are importing a batch of items, you can check data quality either automatically or manually. To enable automatic checking during data upload, select **Check data quality** in the Data Quality Options section of the Create Item Batch page. If automatic checking is not enabled, you can select a batch on the Manage Item Batches page then select **Actions > Check Data Quality**.

How can I use attribute groups to control data quality?

While defining an item class, select the attributes that participate in data quality in the order that you want them to be applied. All selected attributes are used for classification and standardization.

You can also select attributes to be used for matching duplicate items. If an attribute isn't marked for matching, it's used for classification only and isn't used to identify duplicates.

To use attribute groups to control data quality:

1. In the Setup and Maintenance work area, use the **Manage Item Classes** task:
 - Offering: Product Management
 - Functional Area: Items
 - Task: Manage Item Classes
2. On the Manage Item Classes page, select the item class and click **Edit**.
3. On the Edit Item Class page, navigate to the Pages and Attribute Groups tab.
4. Select the Matching subtab.
5. Select **Actions > Select and Add**.
6. In the Select and Add: Data Quality Attributes window, search for one or more desired attribute groups.

7. Select an attribute from the attribute group to be used when checking data quality. Repeat for other attributes that you want to use for checking data quality.

Note: Items across item classes are used for matching if they have the same set of matching attribute values, without regard for the position of the item class in the item class taxonomy. The matching attributes are inherited down the item class hierarchy. The matching attributes present in an item class drive the identification of potential duplicates. Therefore, if any new matching attributes are added to a child item class, then any items belonging to such child item classes won't be shown as potential duplicates.

Can I bypass the data quality check while creating an item?

No. If data quality checking has been implemented, then the checks are performed automatically when you select Save, Save and Close, or Submit from the Actions menu. The Submit action applies only to new item requests.

Any items that you remove from the data quality results for multiple items are not created.

If you consider the data quality results for the item you are creating to be incorrect, then your immediate choice is to cancel the creation.

However, you should also contact the administrator responsible for the setup and discuss the issue so that the model can be altered as required.

You must either accept all of the results of classification and standardization, or choose not to create the affected items. However, if new items are affected by the checks for matching, then you can ignore the duplicates and continue with creating the items.

Why can't I see the Data Quality dialog box during item matching?

During a data quality check, if there are no matching items found, Product Hub saves the item automatically. You don't have to take any action for saving the item.

31 Item Identification

Numbers, Descriptions, and Rules

You can create rules that generate the identification numbers for several types of objects when they are created: items, change orders, and new item requests. You can also create rules that generate descriptions for items.

Generating numbers and descriptions with rules requires the following actions:

- Creating rule sets
- Creating rules
- Completing associations

Creating Rule Sets

You must associate the rule sets containing number generation rules with the item classes, change order types, or new item request types for those objects.

- You must select the **Assignment** type for the rule set, because you are assigning a new value to an object's number (or description).
- In the rule set, the association type must correspond to the object, according to the following table.

Object to Be Numbered	Association Type for the Rule Set
Item	Item class
Change order	Change type
New item request	New item request

Note: Although you can also associate a rule set with an attribute group, you cannot generate numbers for an attribute group.

You activate a rule set by adding it to an item master rule set.

Creating Rules

The rules that generate numbers or descriptions must produce appropriate values.

- The return type of the rule must correspond to the object being numbered, according to the following table.

Object to Be Numbered	Return Type for the Rule
Item (number)	Item number
Item (description)	Item description
Change order	Change order number
New item request	New item request number

- The definition of the rule must generate a number (or description) as the return value.

Completing Associations

You must associate the object with the rule set of the rule that generates the number or description.

- The rule set must already exist and contain a valid rule.
- The number generation method (or description generation method) of the object must be set to **Rule Generated**. The location for setting the generation method varies by object.
- After the number generation method is set to **Rule Generated**, the associated rule set name must be set to the rule set that contains the generation rule that you created.

Note: In an item class, you can use one rule set for item number generation, and a different rule set for item description generation.

Number Generation Methods

You can define methods to automatically generate numbers for items, new item requests, and change orders.

Number generation methods can be specified when defining the following:

- Item classes - The generated item number is applied to items when they're created from the specified item class. You specify the method in the **Item Number Generation Method** field on the **Item Management** tab of the Edit Item Class page.
- New item requests - The generated new item request number is applied to all new item requests when they're created. You specify the method in the **Number Generation Method** field on the **Number Generation** tab of the Manage New Item Request Type Details page.
- Change orders - The generated change order number is applied to change orders when they're created from the specified change type. You specify the method in the **Number Generation Method** field on the **Number Generation** tab of the Edit Change Order Type page.

Existing numbers aren't changed if you change a number generation method.

The number generation methods are:

- Inherited from Parent
- Rule-Generated
- Sequence-Generated
- User-Defined

Inherited from Parent

Select this method to generate numbers for items, using the same number generation method that's defined in the parent item class of an item class. Like other aspects of item classes, the number generation method can be inherited. This method is only available for item classes.

Rule-Generated

Select this method to use a rule set to generate numbers for items, new item requests, or change orders. The rule set that you select must be already associated with the item class, new item request type, or change type.

Sequence-Generated

Select this method to use an alphanumeric sequence to generate numbers for items, new item requests, or change orders. Enter a starting number and an increment value to determine the sequencing. You can optionally define a textual prefix or suffix for the generated number.

For item classes that define configured items, you can also define a distinct sequence number that's used by Oracle Fusion Configurator. Select **Sequence** from the **Configured Item Number Generation Method** field. Specify a starting number and an increment value. For the optional prefix or suffix, you can select **Model Item Number**, which uses the value specified for the **Base Model** attribute, or **User Defined**, which requires manually entered text. You can select an optional **Delimiter** character to separate the elements of the generated number.

User-Defined

Select this method to allow the manual entry of a number for items, new item requests, or change orders when you create them.

7. When you create a new item from this item class, the item number field initially contains a message that the number will be rule generated. When you save (or submit) the item, your rule generates a number for it.

Note: Once an item has been saved, its item number, whether generated or manually entered, can't be changed unless the **Update Item Number** (EGP_UPDATEABLE_ITEM) profile option has been set to **Yes** at the site level. If that profile option has been set to **Yes**, then when any attributes used in your number generation rules are updated, the item numbers are regenerated accordingly.

- In the Details section of the Edit Rule Set page, the differences for your rule are shown in the following table.

Determine the method to use for submitting items to the product update.

Select one of the following options:

Items Without Error

When you select this action, all the items that don't have errors will be added to the batch. When the Batch is run, rules are forcefully applied and items are updated.

Items with Error

When the impact analysis is performed, certain items may result in errors. In this case, you can add the items to an item batch and then later search and process the item batch so that the items that are updated are consistent with the rules.

Manually Update Items

If you want to correct the errors before you add the items to batch, run the batch then navigate to the respective item pages, separately, and update the necessary data so that these items don't result in an error during the update process.

Upload Items to Spreadsheet

You can update the items in a spreadsheet before adding them to the batch. You can specify any necessary preprocessing updates so that these items don't result in an error during the update process. In this case, you can add the items to an item batch, then later search and process the item batch so that the items are updated consistently with the rules.

FAQs for Item Identification

What happens if item numbers are allowed to change?

Ordinarily, item numbers cannot be changed after they are entered (or are generated by product rules) and the item is saved. This behavior is produced by the **Update Item Number** profile option (EGP_UPDATEABLE_ITEM), which has a default setting of **No**.

If you set this profile option to **Yes**, then number generation rules will regenerate item numbers when any attributes participating in those rules change.

32 Item Publication

Publish Item Objects

Publication enables you to schedule and publish item objects automatically to each spoke system.

Here are the high-level steps to publish item objects from Oracle Product Hub to a spoke system:

1. Define publication options for a spoke system.
2. Define the schedule and parameters for the scheduled process.
3. Access the payload generated by the publication scheduled process.

Now, let's discuss these steps in detail.

Define Profile Options to Publish Items

If you're publishing over 1000 items or records, you can consider changing the values of the publication profile options to optimize the publication process.

CAUTION: These profile options control all publication processes. Use care when and if you modify these settings.

You can control of the size of the publication payload to match the requirements of applications and processes. To control the payload size, use the **Manage Advanced Item Profile Options** task in the Setup and Maintenance work area to modify the values of one or more of these profile options:

1. In the Setup and Maintenance work area, use the **Manage Advanced Item Profile Options** task:
 - o Offering: Product Management
 - o Functional Area: Items
 - o Task: Manage Advanced Item Profile Options
2. Update one or more of the profile options in this table:

Profile Option Code	Profile Option Name	Purpose
EGI_PUBLICATION_ITEMS_PER_PAYLOAD	Number of Items per Payload for Publication	Number of items in each XML file. This profile option determines the number of items to be used per payload in the publication process. The predefined value is 500. If a value more than 500 is specified, then 500 is used.
EGI_PUBLICATION_NUMBER_OF_PAYLOADS	Number of Parallel Payloads for Publication	Number of publication subprocesses that are launched in the extraction process.

View Existing Spoke Systems

To view existing spoke systems, in the **Product Management** work area, click **Spoke Systems** from the **Actions** panel. The Manage Spoke Systems page displays a list of existing spoke systems with the following information:

- **Code:** Code name for the spoke system
- **Name:** Name of the spoke systems

- **Description:** Brief description of the spoke system

You can also search for a spoke system using the **Search** field and the suggested filters displayed beneath the **Search** field.

You can change the columns that are displayed using the **Columns** icon on the right side of the page. Clicking this icon displays the Columns dialog box, where you can **Show** or **Hide** the columns on the Manage Spoke Systems page.

Set Up Import Options for a Spoke System

If the spoke system is used to import items into Oracle Product Hub, you can define options such as a schedule, a default organization, and whether to process per item or per bundle.

You can also define additional options such as if the application should check data quality on upload, pack update options, new item request options, item structure name and update options, and change order options.

Setting up the import options for a spoke system allows to quickly default the parameters for the item batches when importing items.

To edit the import options for a spoke system:

1. On the Manage Spoke Systems page, click **Action** for the spoke system for which you want to edit the import options and then click **Edit Import Options**.
2. Specify the settings as per your requirement for the following:
 - Default Batch Assignee
 - Import options to import items through an item batch:
 - Data Quality settings
 - Item Structure
 - Pack
 - New Item Request
 - Change orders
3. Click **Save and Close**.

Here are the import options you can set for item batch import.

3. To delete any catalog, highlight the catalog and click **Delete**.

Publish a Spoke System

You can publish the spoke system entity data immediately or schedule it for a later time. Also, you can selectively publish entity specific data for each spoke system.

When you publish the spoke system:

- One or more XML files are created, for the objects that you selected for publication.
- Publication content includes the complete category-classification path for an item-category assignment. The category-classification path is also published in the publication payload as a part of the item-category assignment.

Publish Spoke System Immediately

To publish the spoke system data immediately:

1. On the Manage Spoke System page, select one or more spoke systems that you want to publish immediately.
2. From the **Actions** menu, click **Publish Now**.

The Publish Now dialog box is displayed.

3. Specify the following options based on your requirement:

- o **Publish Items:** Select **Yes** to publish items. Otherwise, select **No**.
- o **Publish Item Classes:** Select **Yes** to publish item classes. Otherwise, select **No**.
- o **Publish Catalogs:** Select **Yes** to publish catalogs. Otherwise, select **No**.
- o **Publish Trading Partner Items:** Select **Yes** to publish trading partner items. Otherwise, select **No**.
- o **Publish All Records:** Select **Yes** to publish all records. Otherwise, select **No**.
- o **Publish from Date:** Select the date from when the records must be included for publish.
- o **Publish to Date:** Select the date until when the records must be included for publish.
- o **Process Sequentially:** Specifies the publication jobs to run sequentially when there's more than one job. Otherwise, the jobs run in parallel with each other. Select **Yes** to process the records sequentially. Otherwise, select **No**.
- o **Generate XSD:** Indicates whether a XSD file will be created for the item publication.
- o **Purge History:** Select this option only when you've to publish the deleted item data. Otherwise, don't select this option. For more information, see [Purge Publication History Records for Spoke System](#).

Note: You can't run the Purge History operation if you've selected **Yes** for any of the other parameters in the Product Hub Publication Job scheduled process.

4. Click **Submit**.

The confirmation message is displayed with the process ID.

Publish Spoke System At a Scheduled Time

To publish the spoke system data at a scheduled time:

1. On the Manage Spoke System page, select the spoke system that you want to publish at a scheduled time.
2. From the **Actions** menu, click **Schedule Publication**.

The **Schedule Publication** tab displays in a new browser tab with the parameters that you must specify for the **Product Hub Publication Job** schedule process.

For information about the fields, see [Product Hub Publication Job](#).

3. Set the **Publish Items** parameter to **Yes** to publish your items. You need to configure a few other parameters for this scheduled process. Here are the most relevant parameters:

Schedule Process Parameters	Description
Spoke System	Name of the external spoke system where you want to publish items, item classes, or catalog information.
Publish from Date	Publishes records of objects from a start date. Specify the start date.
Publish to Date	Publishes records of objects to an end date. Specify an end date. Use this parameter with the Publish from Date parameter.
Process Sequentially	Specifies the publication jobs to run sequentially when there's more than one job. Otherwise, the jobs run in parallel with each other.

Schedule Process Parameters	Description

4. Click **Advanced** and then click the **Schedule** tab to specify the schedule when the process must run.
5. Select **Using a schedule** option and then specify the **Frequency** and the **Start Date**.
6. Click **Submit** to submit the scheduled process.

The scheduled process publishes the objects of the selected spoke system.

Publication processes can be a recurring or a one-time event. Let's say you're setting up an integration to a legacy application, where you're publishing new items that are created in Oracle Product Hub. You'd want to set up the scheduled publication job to run each night.

The scheduling frequency is based on the integration requirements and the availability of the applications that integrate with Product Hub to receive and process the data. For example, you might have a situation where Oracle Product Hub is feeding new item information to an ERP application. The application is available only for a brief period to accept the feed. So, you must plan the schedule process accordingly.

You should review the log files for additional details:

- o The log file for the **Product Hub Preprocessing Publication Job** scheduled process contains the parameters that were used to run the job, plus record counts of what's published.
- o The log file for the **Product Hub Publication Job** scheduled process contains the identifier dDocName (which corresponds to the **Content ID** in Oracle WebCenter Content) and the name of the compressed file containing the publication files.

You can view the errors identified during publication from the log files of the scheduled process.

- o If an item record in the publication fails, the publication process doesn't publish the failed record but it does publish the remaining item records.
- o The publication process updates the log file with additional information about the publication failure including the item number, rule name, and any error message that you've configured for the rule definition. Using this information, you can trace any publication errors and fix them.
- o The publication log file also:
 - Contains additional information to clarify publication exceptions.
 - Displays rule exception messages that you've created during the rule definition.
 - Displays exception messages based on the exception type during publications.
 - Includes publication subjob exceptions.

Export and Download Spoke System Information

You can export and download the spoke system information to an Excel file.

To do this:

1. On the Manage Spoke Systems page, select or highlight the spoke system that you want to export.
2. Click **Export**.

A pop-up dialog box appears where you must specify the location to save the Excel file. The selected spoke systems are exported to the Excel file and saved in the specified location.

Access Payload Generated by the Publication Scheduled Process

You can access the XML payload of the publication scheduled process from Oracle WebCenter Content.

The log file for the **Product Hub Publication Job** scheduled process contains an entry that identifies the output file for the publication. The identifier dDocName in the log file corresponds to the **Content ID** field of the user interface of Oracle WebCenter Content.

You can use File Import and Export tool to retrieve the published file. You can also locate your publication file using the GET_SEARCH_RESULTS search service of the Core Content Server for Oracle WebCenter Content, using these criteria:

- The value of dDocName from the log file
- The FAFusionImportExport Security Group

Here's an example of a search criteria expression for GET_SEARCH_RESULTS that uses information from the scheduled process log file:

Extended Item Data

You can use the Request ID and Object Version Number attributes to improve integration capabilities. The values are provided in the object headers of the published XML.

- The value of **Object Version Number** is used by integrated solutions to indicate whether the object is newly created or is updated. A value of 1 indicates that the object was newly created. Each time the object is updated, the value is incremented by 1.

The XML attribute name is: `objectVersionNumber`

- The value of **Request ID** is generated when content is imported through the item batch infrastructure, and is published as part of the publication payload. You can use the ID to filter the published items.

The XML attribute name is: `requestId`

Common Structure

The `CommonStructure` record represents common structure among items.

The publication structure record contains a record named `CommonStructure`. This record shows details of each item that the master structure was copied from or created from, enabling integration logic to add a copy of the master structure to each item.

The `CommonStructure` record enables integration to update the referencing common items from the changes in the referenced master common item, for scenarios where the target system for the integration requires a copy of the master item structure at each of the items that reference the master item structure.

Here's an example of a publication payload, edited to focus on `CommonStructure` records, which are highlighted here by doubled asterisks (**):

Publish Deleted Item Data

You can publish deleted content for items, item category assignments, and item suppliers to support integration with external systems.

You can use the publication functionality to publish either updated or deleted item data.

To configure the publication system to publish the deleted item data, select the **Include deleted items** option on the **Publication Options** tab for the spoke system. The Publication Transaction Type attribute in the publication payload will indicate if the item data is updated or deleted. Integration logic can use this attribute to support deleting the item content in external systems.

Deleted data that is published involves the following:

- Parent item record including all child objects associations to the item record are deleted. For example, if the item has an item category assignment to Catalog=Purchasing and to Category=Misc. and if the item is deleted, the item category assignment will be deleted, but the catalog and category won't be deleted. In this case, the transaction type displays Deleted and the child objects that are in scope (extensible flexfields, item category assignments, and item supplier associations).

- Child object or association is deleted, the parent object isn't deleted. For example, the item category assignment for Catalog=Electronics, to Category=Computer is deleted from the item, then this assignment content is deleted but the item isn't deleted. In this case, the item record will have transaction type as Updated and the child object will have transaction type as Deleted.

The content supported for the deleted data is:

- Items
- Item extensible flexfields: Extensible flexfields that are used to extend an item object and the translated extensible flexfields data.
- Item category assignments: Child object of the item which contains the catalog and categories assigned to the item.
- Associations: Supplier Organizations, the supplier associated with the item.

Purge Publication History Records for Spoke System

You can purge the publication history records for a spoke system using the Product Hub Publication Job scheduled process. This improves performance by systematically purging publication records on a scheduled basis.

To purge the publication history records using scheduled process:

1. In the Scheduled Processes work area, click **Schedule New Process**.
2. Search and open the Product Hub Publication Job schedule process.
3. Specify the following parameters:
 - **Spoke System** - Select the spoke system for which you want to delete the publication history records.
 - **Purge History**: Select one of the following options:
 - **All Rows**: Purge all rows in the publication history including rows from publication jobs with the status error and completed.
 - **Error Rows**: Purge rows corresponding to publication jobs that were terminated due to errors.
 - **Completed Rows**: Purge rows corresponding to publication jobs that completed successfully.
4. (Optional) Click **Advanced** and schedule the process to run later.
5. Submit the scheduled process.

The scheduled process deletes the publication history records for the selected spoke system.

Note: You can't run the Publication Purge History operation if you've selected **Yes** for any of the other parameters in the Product Hub Publication Job scheduled process.

Manage Publication Maps

You can specify a mapping between the Oracle Product Hub attributes and a target spoke system (to which the data will be published) using publication maps. Use the **Manage Publication Maps** task in the Product Information Management work area to search, create, edit, delete, or duplicate publication maps.

You can publish your data in a more streamlined and efficient manner because you can prune the data that's sent to your spoke systems. Therefore, the ingesting systems can now receive a subset of the deltas based on the previous publication.

Create Publication Map and Specify Mapping Attributes

To create a new publication map:

1. In the Product Information Management work area, click the **Tasks** panel tab and then click **Manage Publication Maps**.

The Publication Maps page is displayed.

2. Click the **Add** icon.

The New publication map drawer appears on the right side.

3. Provide the following information:

- o **Name:** Name of the publication map
- o **Description:** Description of the publication map
- o **Output File Type:** Type of file being uploaded.
- o **Delimiter:** If you've selected **Text** as the **Output File Type**, select **Comma** or **Pipe**.
- o **Active:** Indicate if the publication map is in active or inactive state.
- o Upload CSV data file that contains the spoke system attributes in the first row. The file size should not exceed 25 MB.

4. Click **Create** to create the publication map and open it in edit mode. Clicking **Cancel** will close the drawer and publication map won't be created.

If you've uploaded a CSV file, the contents of the CSV are extracted and the Map details page is displayed, where you can specify the mapping between the spoke system attribute and the attribute mapping.

If you haven't uploaded a CSV file, the mapping table will be empty when you try to edit the publication map. In this case, you can manually add spoke columns and their corresponding mapping rows to the table.

5. In the mapping table, add the following mapping details for each attribute that you want to map.

For existing rows that were extracted from the input CSV file, **Sequence** number and **Spoke Attribute** are available, and **Master Attribute** must be mapped.

To add new rows to the mapping table, use the first inline edit row present in the table. In this row, you must specify the **Sequence** number, **Spoke Attribute**, and **Master Attribute**.

- o **Sequence:** Enter a unique sequence number for each row in the mapping table.
- o **Spoke Attribute:** Name of the target spoke attribute that you want to map.
- o **Master Attribute:** Click the drop-down list and select the master attribute that you want to map to the target spoke system attribute. Entity and Attribute Group columns are automatically populated when a master attribute is selected.

Note: You can map one master data attribute to multiple spoke system columns.

In **Actions**, click the **Apply** icon to add the mapped attribute as a row.

6. To edit the attribute mapping, click the **Edit** icon for the respective row.
7. To clear the attribute mapping, select the required rows and click **Clear Mappings**.
8. To delete one or more attribute mapping, select the required rows and click **Delete**.

9. To export the attribute mappings to an Excel file, select all or the required rows and click the **Export** icon.
10. Click **Save** or **Save and Close** to save the changes.

Edit Publication Map

To edit a publication map:

1. On the Publication Maps page, search for the publication map.
2. From the search results, click the required publication map to open it in edit mode.
3. Specify the attribute mapping between the spoke system attributes and the master data attributes. You can also modify the **Description**, **Output File Type**, **Delimiter**, and the status. For details, see [Create Publication Map and Specify Mapping Attributes](#).
4. Click **Save** or **Save and Close** to save the changes.

Duplicate Publication Map

To duplicate a publication map:

1. On the Publication Maps page, search for the publication map that you want to use to create another publication map.
2. From the search results, for the publication map that you want to duplicate, click **Duplicate**.

The <Publication Name> (Copy) drawer appears on the right side.

3. Change the details such as **Name**, **Description**, **Output File Type**, **Delimiter**, and click **Create**.

Note: When you duplicate an existing map, you can't upload a CSV file.

The Map details page is displayed.

4. Update the attribute mapping between the spoke system attributes and the master data attributes. For details, see [Create Publication Map and Specify Mapping Attributes](#).
5. Click **Save** or **Save and Close** to save the changes.

Delete Publication Map

On the Publication Maps page, search for the publication map that you want to delete and click the **Delete** icon. A message appears asking for confirmation. Click **Delete** to confirm the deletion.

Business Rules and Guided Journeys for Publication Maps

The New publication map drawer and Map details page support extensibility through business rules and page properties.

The predefined business rules are:

- Default
- Delimiter Required and Default Value Localization Rule

You can also define any extension business rules for the New publication map drawer and the Map details pages.

You can control the visibility of the description and active badge on the page header and configure the Guided Journeys for the Map details page using the Page Properties section.

Transform Data Using Functions in Publication Maps

You can use transformation functions in publication maps to transform the data before publishing it to a target spoke system.

You can apply the transformation functions for TEXT output file types.

To transform data using functions in publication maps:

1. On the Publication Map page, select a mapping and click **Transform**.

The Transform master attributes drawer is displayed, where you can add and validate transformation expressions using functions and attributes.

2. On the **Functions** and **Attributes** tabs, drag and drop the required functions and attributes into the **Add expression** field.

You can click each function and view the syntax and the description in the **Function Description** section. For details, see [Functions for Transform Expressions](#).

You can search for attributes on the **Attributes** tab.

3. After adding the expression, click **Validate** to validate the expression. When the expression is successfully validated, the **Expression validated** message appears with the green tick mark beneath the **Add expression** field.
4. Click **Transform**. The validated expression is displayed in the **Expression** column for the corresponding mapping on the Publication Maps page.

Note: You can only transform one spoke to master attribute mapping at a time.

Functions for Transform Expressions

FAQs for Item Publication

What happens if I don't select any objects on the spoke system to publish?

If you don't select any objects on the spoke system, you will not be able to define the publication options and no data will be published to the spoke system.

Will all items in Product Hub be published?

Only items that have been updated since the last publication or criteria date and that meet the publication criteria for the spoke system will be published. This includes newly created items meeting the publication criteria.

Which items will be published?

The items published are based on what has changed since the last publication date and filtered by the selection rules in the configuration information on the publication options tab of the Manage Spoke Systems task.

Selection rules can be based on organizations, organization hierarchy, catalog or item class.

Can I select items from specific child organizations to publish?

No, you cannot publish by specific child organizations. You can only publish at the master organization level. All child organizations within the master organization will publish.

Which item entities are supported for publication?

The supported item entities are:

- Attributes
- Attachments
- Supplier Site Associations
- Item Category Assignments
- Packs
- Item Relationships
- Structures

How can I chunk the data of the publication process?

Use the profile options provided for the publication process:

Profile option	Purpose
EGI_PUBLICATION_ITEMS_PER_PAYLOAD	Use this to define the number of items per payload in the publication scheduled process. The predefined value is 500. If a value more than 500 is specified, then 500 is used.

Profile option	Purpose
EGI_PUBLICATION_NUMBER_OF_PAYLOADS	<p>Use this to define the number of publication sub processes.</p> <p>This profile option determines the number of parallel payloads to be used in the publication process. The predefined value is 10.</p>
EGI_PUBLICATION_SIZE_OF_ZIP_FILE	Use this to control the overall size of the publication .zip file, in megabytes. The recommended value is 500 MB or lower.

When deciding the values for these profile options, keep the following in mind:

- The capacity of the application you're publishing to.
- The equipment specifications for where the publication is running and in the applications you're publishing to.
- How often the publication job is run.

How can I modify the values of the item publication profile options?

Profile option values for items are defined using the Manage Advanced Item Profile Options task in the Setup and Maintenance work area.

33 Item Deletion

Obsolete Products and Services Using Deletion Groups

Product managers can obsolete products and services by defining and maintaining deletion groups that identify products and services that are at the end of their life cycle and should be purged.

Constraints maintain data integrity so that pending transactions aren't affected while purging.

CAUTION: You can supersede existing items using item relationships. In those cases, the superseded items must continue to exist in the application. If the superseded item is deleted from the application, then all the cross references, item relationships, and so on will be lost.

Deleting items, structures, new item requests, and change orders is managed through the Deletion Groups task. You can create and maintain deletion groups using the **Deletion Groups** link in the Product Management work area. The Deletion Groups page is launched. You can add objects directly to a deletion group through this task.

On the Deletion Groups page, you can create deletion groups, search and access the existing deletion groups, run a constraint check, and submit the deletion groups for processing. You can also delete those deletion groups that were successfully submitted and completed.

You can also add different objects to deletion groups from their respective Manage pages. The following objects can be added to a deletion group:

- Items
- Change orders
- New item requests
- Item structures

Note: You can't add components and supplier associations to a deletion group. You can add components using the Edit Item Structure page and view or delete it from the deletion group using the Deletion Groups page.

Once an item is deleted, it's removed from the application, all the cross-references and item relationships such as item organizations, item supplier site organizations, structures, and components are lost.

Note: When you delete an object such as items, new item requests, and change orders from the appropriate manage page, you're prompted to add the object to an existing deletion group or create a new one.

- Search and select the items you want to add and click **Add**.

The items are added to the **Items** tab.

4. To add structures:

- Click the **Structures** tab.

- Click the **Add** icon to open the Select and add structures drawer panel.

- Search and select the structures you want to add and click **Add**.

The structures are added to the **Structures** tab.

5. To add components:

- Click the **Components** tab.

- Click the **Add** icon to open the Select and add components drawer panel.

- Search and select the components you want to add and click **Add**.

The components are added to the **Components** tab.

6. To add change orders:

- Click the **Change Orders** tab.

You can't delete an existing deletion group with status **In Progress**.

To delete one or more deletion groups:

A warning message is displayed.
3. Click **Delete**. The selected deletion groups are deleted.

Check Constraints for Deletion Group

Constraints maintain data integrity so that pending transactions that involve objects in deletion groups aren't affected during purges.

Before submitting a deletion group for processing, you must check constraints to make sure that it's safe to submit the objects for deletion. The products that are checked for constraints are:

- Product Hub
- Procurement
- Inventory
- Shipping
- Receiving
- Manufacturing
- Sales Forecast
- Sales Catalog
- Opportunity Management
- Order Capture
- Lead Management
- Configurator
- Supply chain Collaboration

When an item is in a deletion group, the constraint check determines whether there are any open transactions involving the item.

To check constraints:

1. On the Deletion Group page, select one or more deletion groups for which you want to check constraints.
2. From the **Actions** menu, click **Check Constraints**.

When the **Status** shows **Completed** and the **Last Activity** is **Constraints Check**, then the **Last Activity Status** indicates whether there were errors.

If **Last Activity Status** for a deletion group shows **Errors**, click the group's name to open it.

3. On the <Deletion Group name> page, objects with errors shows the **Status as Errors** in the **Deletion Status** column.
4. Click the **Errors** link to open the Error Details drawer panel, which displays a list of messages about the errors that prevent the object from being deleted.

Submit Deletion Groups for Processing

To submit one or more deletion groups for processing:

1. On the Deletion Groups page, select or highlight the deletion groups you want to submit for processing.
2. From the **Actions** menu, click **Submit Delete**.

Export Deletion Groups

To export the list of deletion groups:

1. On the Deletion Groups page, select or highlight the deletion groups you want to export.
2. Click the **Export** icon on the right side of the page.

A dialog box appears where you must specify the location to save the Excel file. The selected deletion groups are exported to the Excel file.

Delete Items in Bulk

You can add a maximum of 20000 items to a deletion group using the **Deletion Groups** task in the **Product Management** work area.

You can also use a REST service to add items to a deletion group.

You can't delete an item that has open transactions. Sometimes, you can't delete an item that has a completed or canceled transaction involving the item. Hence, it depends on the product and the type of constraint checks performed.

To delete items in bulk:

1. Create a deletion group that doesn't contain any items:
 - a. On the Product Management landing page, in the **Actions** panel, click **View all actions**.
The Actions drawer is displayed.
 - b. Click the **Deletion Groups** link.
 - c. Click **Create**.
The Deletion Groups page is displayed.
 - d. Enter the **Name** and optional **Description** for the deletion group. For example, Item_Delete01.
 - e. Click **Save and Close**.
2. Run a REST service to populate the deletion group with items in bulk.
Run the **deleteGroups** REST service using the **Add items to the delete group** operation to add items to a deletion group. For more information, see the REST API for Oracle Fusion Cloud SCM guide.
3. Submit the populated deletion group for processing:
 - a. On the Deletion Groups page, search for the deletion group that you created, and click its name to open it.
The deletion group now contains the list of items to be deleted.
 - b. From the **Actions** menu, click **Check Constraints**.
 - c. Examine the constraint check status for whether there are errors or pending transactions for an item.
 - d. After errors or pending transactions are resolved, click **Submit Delete** from the **Actions** menu to process the deletion of the items.

Identify Deleted Entities Using Deletion Business Events

Items in Product Information Management contains core entities and child entities.

The core entities include master organization item, item revision, item organization assignment, item supplier association, and non-translatable or translatable single row extensible flexfields at all levels. The child entities include item category assignments, all types of relationships, trading partner items, non-translatable or translatable multi-row extensible flexfields at all levels. When a core entity is deleted, the child entities are also deleted. However, you can delete the child entities independently.

Note: Structure and related entities aren't applicable.

The core entity is always deleted through delete group along with constraint checks. The child entities can be deleted through import or individually. Constraint checks that are a part of the delete group aren't performed for child entities.

Business events are raised every time an item or its related entity is deleted. The types of delete events are:

- Bulk Delete Event: When a core entity is deleted through delete group or child entity is deleted through import, then the Bulk Delete Event is generated.
- Entity Delete Event: When a child entity is deleted individually, then the Entity Deleted Event is raised.


You can use the Deleted Item Entities REST resource to fetch the details of the deleted items from the Bulk Delete Events. The details include the primary identifier of the object and other secondary identifiers of the deleted entity. If the parent object is deleted, the child objects are also deleted, and thus the primary and alternate identifiers of the child objects must be stored.

Integration with external systems can be done by listening to the delete business event with the payload or by using a combination of business events and fetching the details using the Deleted Item Entities REST resource.

When you delete an item or its related entity in Product Information Management work area, the business events are seen in Oracle Integration Cloud. You can subscribe to these events through Oracle Integration Cloud and orchestrate real-time integrations with other systems.

You can create user-defined Business Intelligence reports based on the deleted entity tables to get the complete item details and send them to downstream products for integrations on a scheduled basis. The reports can be used to maintain external systems in sync, near real time when an item or its related entities are deleted. For information about the delete entity tables, see the *EGP_DELETE_ENTITIES* section in the *Oracle Fusion Cloud SCM: Tables and Views for SCM* guide.

After a basic item is created in Oracle Product Hub, you can enrich your supply chain item master with the following from an external healthcare catalog provider using a predefined integration:

- Trading partner information
- Standardized codes
- GUDID information
- Product classifications
- Product operational information
- Item sizes
- Sterilization methods
- Storage conditions

Using this feature, you can:

- Publish the item master items to the External Healthcare Catalog seamlessly.
- Eliminate duplicate items with automated cleansing and deduplication capabilities from the External Healthcare catalog.
- Enrich item attributes and classify items quickly and accurately.
- Quickly find and identify items with well-structured descriptions.
- Speed up the ability to transact with the item for your supply chain and clinical processes.
- Reduce errors due to manual maintenance thereby accelerating the item add and introduction processes.

Prerequisites

Before enriching the item master, make sure you've done the following:

- A license agreement with an external healthcare catalog provider.
- Deploy existing healthcare library. The standard integration with external healthcare catalog provider works with the predefined healthcare library. For more details about healthcare library, see [Use Predefined Extensible Flexfield Attributes for Maintaining Healthcare Product Data](#).
- Create an integration user for the External Healthcare Catalog provider with the following security privileges to process the enrichment:
 - Create Trading Partner (EGP_CREATE_TRADING_PARTNER)
 - Manage Item Manufacturer (EGP_MANAGE_ITEM_MANUFACTURER)
 - Modify Trading Partners (EGP_MODIFY_TRADING_PARTNER)
 - Import Item (EGP_IMPORT_ITEM)

- Manage Item (EGP_MANAGE_ITEM)
- Manage Item Attachment (EGP_MANAGE_ITEM_ATTACHMENT)
- Manage Item Batch (EGI_MANAGE_ITEM_BATCH)
- Manage Product Upload (EGS_MANAGE_PRODUCT_UPLOAD)

Item Enrichment - Initial Setup

Here's the initial setup you must do before you enrich the items master:

1. Associate the **Healthcare External Enrichment** attribute group to the relevant item classes and item pages. For details, see [Associate Healthcare Attributes With Items](#).
2. Deploy the **Register with External Healthcare Catalog** attribute for the appropriate item classes.
3. Create a validation rule set:
 - a. In the **Product Information Management** work area, go to the **Tasks** panel tab, click **Manage Rule Sets**.
 - b. Create a validation rule set to filter items with the **Register with External Healthcare Catalog** attribute value set as **Yes**. For details, see [Define Rule Sets and Item Rules](#).

Note: When defining the rules, specify the **Attribute Group** as **External Healthcare Enrichment** and the **Attribute** as **Register with External Healthcare Catalog** with **Value** as **Yes** and **Suspend**.
 - c. Click **Save**.
4. Associate the validation rule set to the predefined spoke system called **External Healthcare Catalog**:
 - a. In the **Product Information Management** work area, go to the **Tasks** panel tab, click **Manage Spoke Systems**.
 - b. Search for the **External Healthcare Catalog** spoke system.
 - c. Under **Item**:
 - In **Selection Criteria**, add the item selection rules to specify the selection criteria. The item selection rule includes the business entity, operator, and entity name. Select the following values:
 - **Business Entity**: Organization
 - **Operator**: Equals
 - **Entity name**: Name of your master organization
 - From the **Validation Rule Set** drop-down list, select validation rule set you created in step 3.
 - d. Click **Save**.
5. Schedule the **Product Hub Publication Job** scheduled process with the External Healthcare Catalog spoke system to publish the list of items that need enrichment to Oracle WebCenter Content for every four hours. For details, see [Publish Spoke System At a Scheduled Time](#). You must specify the following parameters:
 - **Spoke System**: External Healthcare Catalog
 - **Publish Items**: Yes
 - Select **No** for the other parameters.

Enrich Your Item Master

To enrich your item master:

1. Go to the **Product Information Management** work area.
2. From the **Tasks** panel tab and click **Manage Items**.
3. Search for the item.
4. From the search results, click the item for which you want to enrich the healthcare attributes.
The Edit Item page is displayed.
5. Click the **Specifications** tab and go to relevant item page for healthcare attributes. The predefined attributes are displayed without any values.
6. Set the **Register with External Healthcare Catalog** option to **Yes** and click **Save**. The external healthcare provider matches the information based on the supplier part number and supplier name and shares the updated record with Product Hub.
7. After the Product Hub Publication Job scheduled process job is successfully completed, the external healthcare catalog provider generates an enrichment file and uses the predefined import map called **Item Enrichment with External Healthcare Catalog** to automatically load the data back to Product Hub. The frequency of the enrichment updates can be discussed with the external healthcare catalog provider.
8. After the item enrichment is processed, open the same item again and you can see that the healthcare attributes have values. These values are added from the external healthcare provider during enrichment.
9. Go to the **Relationships** tab and then click **Trading Partner Items**.

You can see that the manufacturer part number and name has been updated from the external healthcare provider. Also, the GTIN information must be available.

This completes the item master enrichment process.

Sync Item Information With Oracle Health

You can sync your item master including substitute and replacement items, item location, and item cost information from Oracle Cloud ERP to Oracle Health.

You can also sync the on hand quantities between Oracle Health and Oracle Fusion Cloud Inventory Management based on item usage and create bill-only requisitions in Oracle Cloud Procurement for nonstock items.

You can publish items from their item master thereby eliminating duplicate items that might be created in the Oracle Health EHR item master. You can access critical attributes directly in Oracle ERP Cloud and it isn't required to maintain this information in Oracle Health. This reduces errors that might occur due to manual maintenance thereby speeding up release the item for clinical purposes.

Before you sync items with Oracle Health, do the following:

1. Deploy the existing healthcare library. The standard integration works with the predefined healthcare library. For more details about healthcare library, see [Use Predefined Extensible Flexfield Attributes for Maintaining Healthcare Product Data](#).
2. Deploy and setup the Oracle Fusion Cloud SCM — Oracle Health EHR | Sync Items accelerator in Oracle Integration. For details, see the Sync Items from Oracle Fusion Cloud SCM to Oracle Health EHR guide available at docs.oracle.com.
3. Opt in to the **Synchronize Item Information With Oracle Health** feature and then perform the following:
 - a. Create filters for items using the **Oracle Health** spoke system to publish the item.
 - i. In the Product Information Management work area, go to the **Tasks** panel tab, and click **Manage Spoke Systems**.
 - ii. Search for the name **Oracle Health**.
 - iii. In the search results, click the **Oracle Health** link in the **Name** column or select the row and click the **Edit** icon.

 - **Y** = enables the feature
 - **N** = disables the feature
 - d. Click **Save and Close**. Changes in the profile value will affect users the next time they sign in.

 - b. Do the following to integrate transactions and bill-only requisitions:


- i. In the Setup and Maintenance work area, go to the **Manage Special Handling Types** task.
- ii. In **Special Handling Type**, enter **Bill Only** and click **Search**.
- iii. In **Search Results**, clear the **Requires Single Supplier** checkbox.
- iv. Click **Save and Close**.

Oracle Health Item Integration Process

When the Synchronize Items with Oracle Health scheduled process starts, the Oracle Fusion Cloud SCM — Oracle Health EHR | Sync Items accelerator performs the following to integrate items, item location, and item cost:

1. Downloads the ZIP files from Oracle WebCenter Content.
2. Transforms data and creates files for Oracle Health EHR.
3. Passes the data into interface tables.
4. Communicates with administrator for resolution if data transfer fails.


The following image shows the integration process with Oracle Health EHR.



To integrate transactions:

1. Clinician completes case picking or documentation, or both in Oracle Health.
2. Oracle Fusion Cloud SCM—Oracle Health EHR | Synchronize Items accelerator performs the following:
 - a. Fetches the transactions from Oracle Health using a schedule process.
 - b. Transforms data.
 - c. Adjusts On Hand Quantity in Oracle Fusion Cloud Inventory Management if the item is stocked.
 - d. Creates Bill-only Requisitions in Oracle Fusion Cloud Procurement if the item isn't stocked.
 - e. Communicates with administrator for resolution if data transfer fails.

Sync Item Information With Epic

You can sync your item master, item inventory location, and item cost information with Epic.

You can publish items from your item master thereby eliminating duplicate items that might be created in the Epic item master. You can access critical attributes directly in Oracle ERP Cloud and it isn't required to maintain this information in Epic. This minimizes errors that might occur due to manual maintenance, thus accelerating the release of the item for clinical purposes.

Before you sync items with Epic, do the following:

1. Deploy the existing healthcare library. The standard integration works with the predefined healthcare library. For additional details about healthcare library, see [Use Predefined Extensible Flexfield Attributes for Maintaining Healthcare Product Data](#).
2. Deploy and setup the Oracle Fusion Cloud SCM — Epic | Sync Items recipe in Oracle Integration. For details, see the Sync Items from Oracle Fusion Cloud SCM to Epic guide available at docs.oracle.com.
3. Opt in to the Synchronize Item Information With Oracle Health feature.
4. Create a spoke system called **Epic**.
5. In Setup and Maintenance work area, go to the **Manage Trading Community Source Systems** task.
 - a. Click **Create**.
 - b. Add a new source system for Epic.
6. Create filters for items using the **Epic** spoke system to publish the item.
 - a. In the Product Information Management work area, go to the **Tasks** panel tab, and click **Manage Spoke Systems**.
 - b. Search for the name **Epic**.
 - c. In the search results, click the **Epic** link in the **Name** column or select the row and click the **Edit** icon.

Epic Integration Process

When the Synchronize Items with Oracle Health scheduled process is initiated, the Oracle Fusion Cloud SCM — Epic | Sync Items recipe performs the following:

1. Downloads the ZIP files from Oracle WebCenter Content.
2. Transforms data and creates files for Epic in HL7 format.
3. Loads the file in the file server for Epic to process.

4. Communicates with Product Data Steward and administrator for resolution if data transfer fails.
