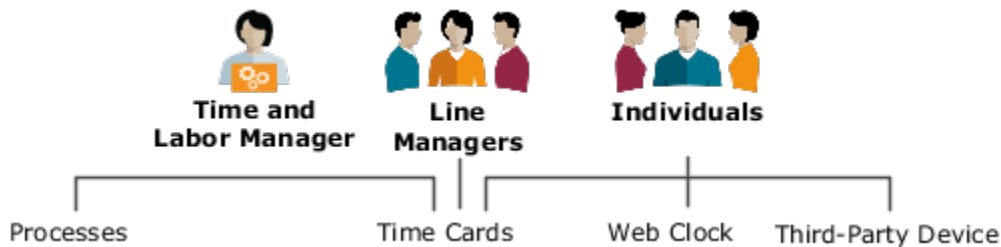

1 Overview

Overview of Implementing Time and Labor

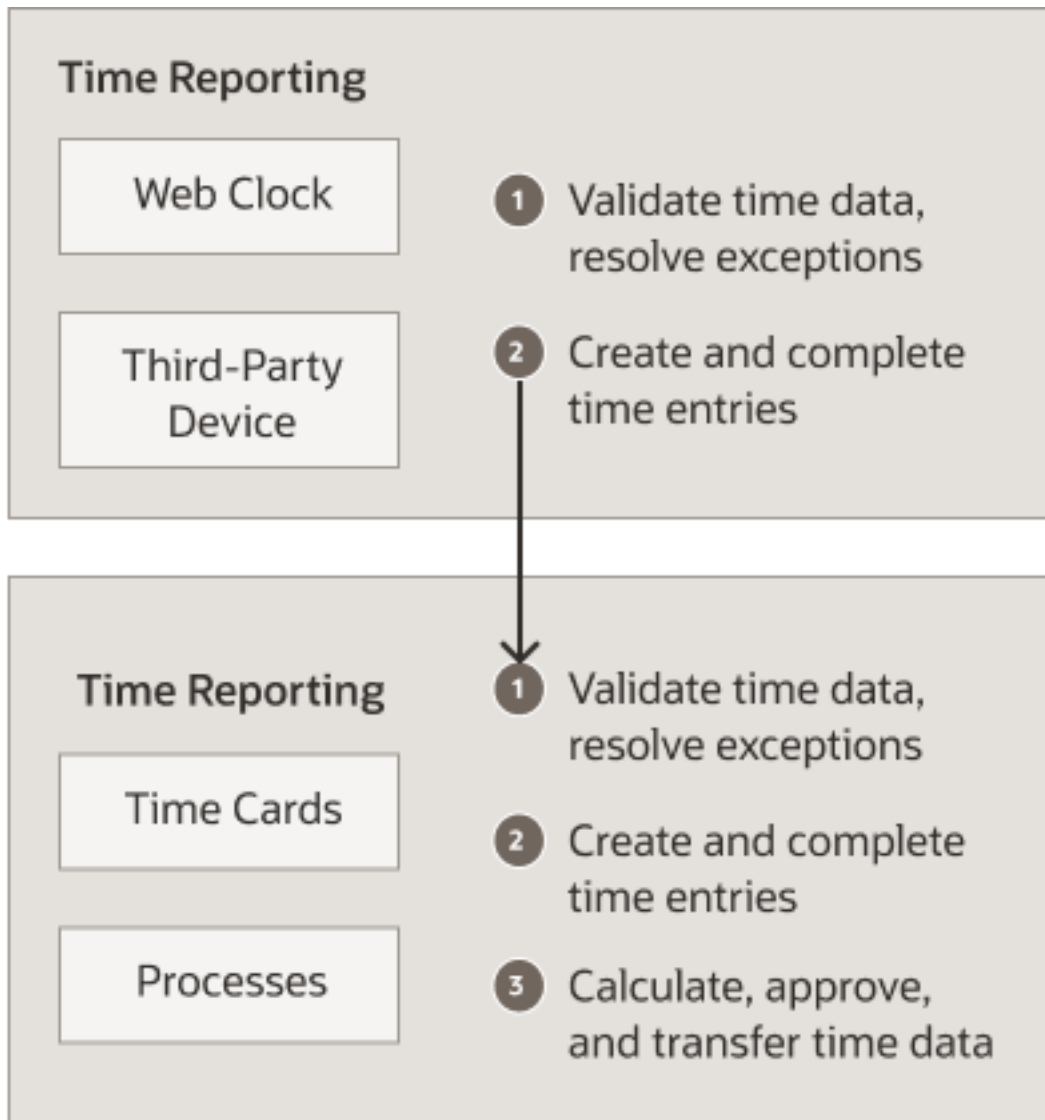
You can address simple to complex time reporting for permanent and contingent employees using this rule-based time management application.

- Individuals can report time using time cards, calendar, and web clock. They can also use third-party time collection devices, such as badge and biometric readers.
- Line managers can report, review, and submit time cards for their people, including delegates.
- Time and labor managers can report, review, and submit time for their people using time cards and processes that generate mass time.



For web clock and third-party devices, the import process validates event-related time data and creates or completes time entries. Time and labor managers resolve any badge and time entry exceptions identified during this validation.

When anyone saves or submits a time card, time entry rules run to validate reported time. Managers resolve any time entry exceptions identified during this validation. Next, calculation rules run using the time data validated by the time entry rules. Then, time consumer validation runs for the relevant calculated time data. Finally, time consumer administrators transfer time data for further processing, such as payroll and project costing. Here's a summary of this flow.



Time and Labor Task Lists

You access Time and Labor setup tasks in the Setup and Maintenance work area. The tasks are part of the Workforce Deployment offering, Time, and Labor functional area.

If you already implemented Oracle Global Human Resources Cloud, required for Time and Labor processing, you've completed many prerequisite tasks. If you pay worked time according to time card entries, you need to complete tasks in the Elements and Formulas functional area too. The Implementing Global Human Resources guide explains these tasks.

You need to show all Time and Labor setup tasks to complete these configurations:

- Time entry
- Time processing
- File processing for time collection devices

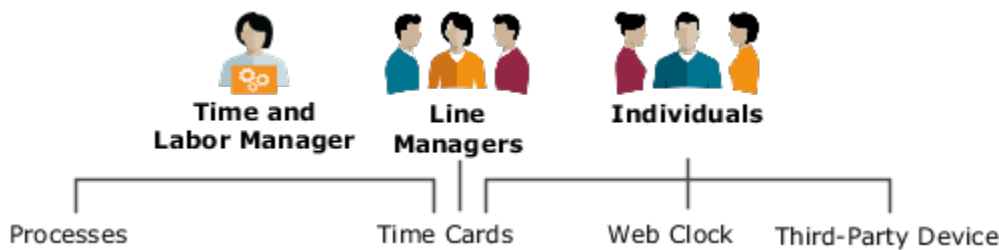

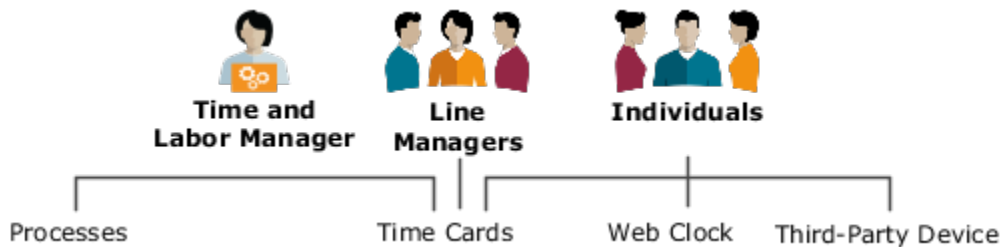

Time Processing Setup and Maintenance Tasks

Individuals can report time using time cards, third-party time collection devices, and Web Clock. Line managers manage time cards and changes requests, as do time and labor managers. Time and labor managers can also generate time using various processes.



Here's the high-level processing that happens for time reported with Web Clock and third-party devices:

1. The import process validates event-related time data and creates or completes time entries.
2. Time and labor managers resolve any badge and time entry exceptions identified during this validation.

Here's the high-level processing that happens for all time reporting and management methods:

1. Time entry rules that validate reported time run when people save time cards and submit them.
2. Managers resolve any time entry exceptions identified during this validation.
3. Calculation rules run using the time data validated by the time entry rules.
4. Time consumer validation runs for the relevant calculated time data.
5. Time consumer administrators transfer time data for further processing, such as payroll and project costing.

Retroactive changes to people's data can require recalculation and transfer of time card data. Examples of retroactive changes are changes to the payroll relationship or overtime period.

Configure time processing that supports your policies by completing these configuration tasks, in the order listed. All these tasks are in the Setup and Maintenance work area, Workforce Deployment offering, Time and Labor functional area.

3 Redwood User Experience Setup

Enable Redwood Experiences for Time and Labor

Here are the setup tasks that you need to complete for individuals, line managers, and time and labor managers to use Redwood pages.

1. Enable the enhanced time card search for managers to access enhanced time cards. Individuals access the enhanced time card using the Current Time Card task on the Me > Time and Absences page.
 - a. Run the **Initial Data Ingestion** process using the **Tools > Scheduled Processes** task.
 - **Process name:** ESS process to create index definition and perform initial ingest to OSCS
 - **Parameter name:** Index Name to Reingest
 - **Parameter value:** fa-hcm-timecard

Tip: You need to run this process after every release upgrade and production-to-test process.
 - b. Set up the data security for Oracle Search. Oracle Search data security relies on dynamically computed access control lists that reflect Oracle HCM Cloud data security setup. You should run the access control list processes with certain minimal logging features turned on.
 - c. Create the ACL index using the **Tools > Scheduled Processes** task.
 - **Process name:** ESS process to create index definition and perform initial ingest to OSCS
 - **Parameter name:** Index Name to Reingest
 - **Parameter value:** fa-hcm-acl
 - d. Run the **Compute Users ACL** process once with a User Population parameter of **All Users**.
 - e. Schedule the **Compute Users ACL by Event** process to run every 15 minutes.
 - f. Schedule the **Compute Users ACL** process to run with a User Population parameter of **Logged in users** and a frequency of every 30 minutes.

After the access control list processes complete, the related lists are generated, including the list of excluded users to be resolved.
 - g. Make sure that the HXT data security policy is correctly defined so that time and labor managers and line managers access time cards for only the workers that they're responsible for.

2. Configure the time entry layout of the time layout set.

5 Workforce Management Lookups

Overview of Workforce Management Lookups

Delivered lookups make up drop-down list values for various time and labor fields, including fields for change audit, rule classification, and time collection devices.

You can review and change these lookups according to your needs using the Workforce Management Lookups task in the Setup and Maintenance work area. It's part of the Workforce Deployment offering, Time and Labor functional area.

You can also review all the workforce management lookups and change the extensible lookups using these steps, as appropriate for your policies:

1. In the Setup and Maintenance work area, on the Tasks panel tab, click **Search**.
2. Search for and click **Manage Common Lookups**.
3. On the Manage Common Lookups page in the Lookup Type field, enter **ORA_HWM%**.
4. Click **Search**.

Change Audit Reason Lookup

When you enable change auditing for time cards, you can also have people give reasons for their changes. These reasons show as read-only information in the change audit history of affected time cards.

To ensure consistency with your policies, people select their reasons from a drop-down list with values that come from the ORA_HWM_CA_REASONS lookup type. The lookup type includes reasons for absences created and deleted in Oracle Fusion Absence Management. The Evaluate Absences process applies these reasons to affected time cards during reprocessing.

You need to add your suppliers to this lookup before you change the lookup for the supplier device event. You do this because the lookup codes for device events need to start with the supplier lookup code.

Supplier Device Events

The values that makes up the Supplier Device Event drop-down list on these pages come from the ORA_HWM_TCD_SUPPLIER_EVENTS lookup:

- Create Time Device Event Mappings
- Generate Time Events

You need to start these lookup codes with the supplier lookup code. For example, if you've a supplier with the lookup code ABC, start the lookup code for that supplier's device events with ABC_.

Time Rule Classification Lookup

You can identify the purpose of each time rule template using the Rule Classification drop-down list. Here are some example purposes:

- Threshold
- Shift premium
- Meal or break

You can add classifications that support your time policies using the HWM_RULE_CLASSIFICATION lookup type. The tag for each lookup code identify which template drop-down list includes the classification.

Tag	Template with the Classification
TAR	Time audit rule
TCR	Time calculation rule
TDR	Time device rule
TER	Time entry rule
TSR	Time submission rule
WCR	Workforce compliance rule

You can't edit the rule-level classification, because it's inherited from the template.

Web Clock Properties Lookup

You can identify more properties for web clock or time device events using the `ORA_HWM_CLOCK_PROPERTIES` lookup. For example, you can use delivered properties to identify when an event is the start or end of a shift or meal.

This lookup makes up the drop-down lists for the Start Property and End Property time attributes. You can add these time attributes and select appropriate values as part of these tasks:

- Create web clock buttons
- Create time device event mappings

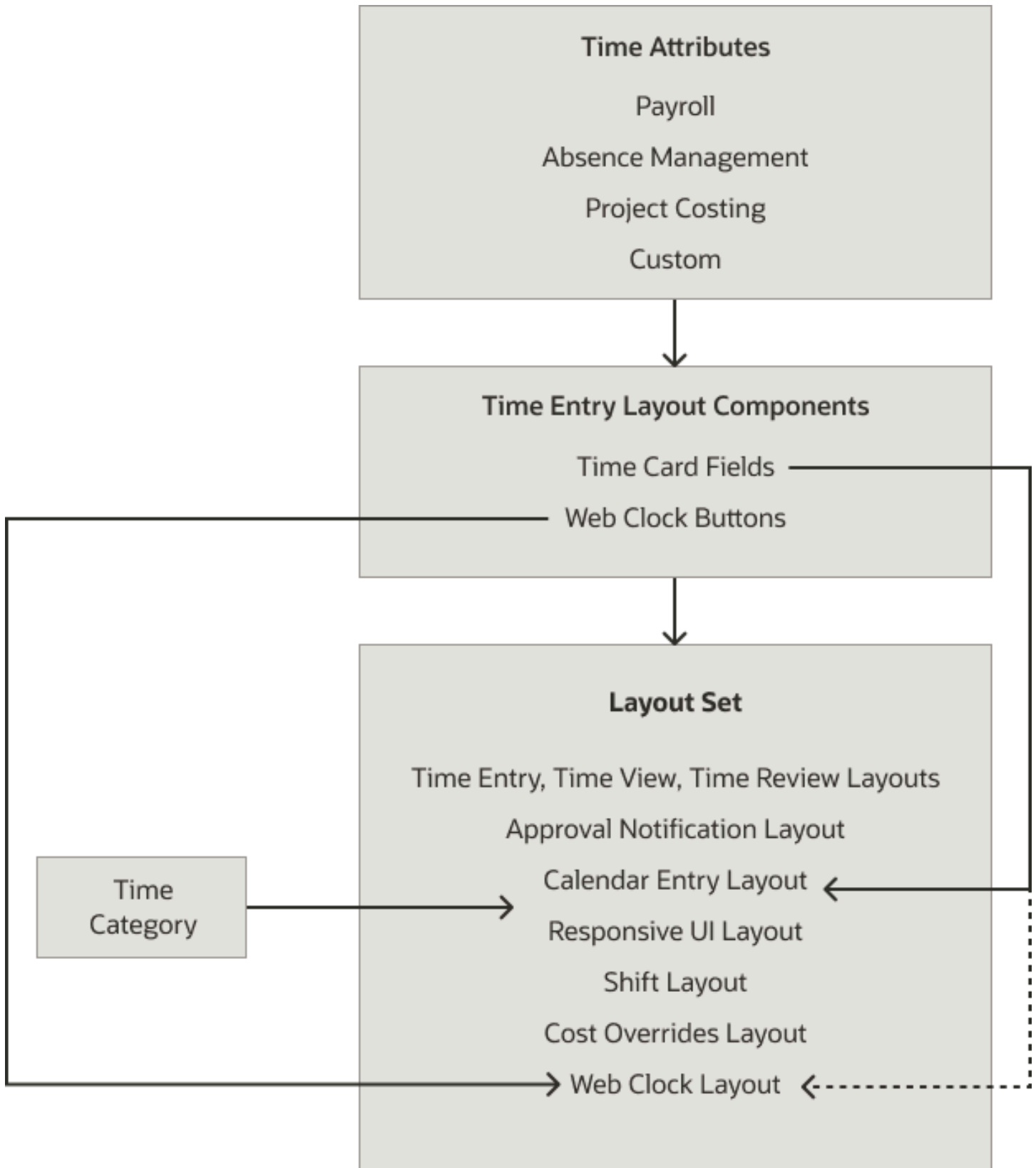
6 Time Entry Configurations

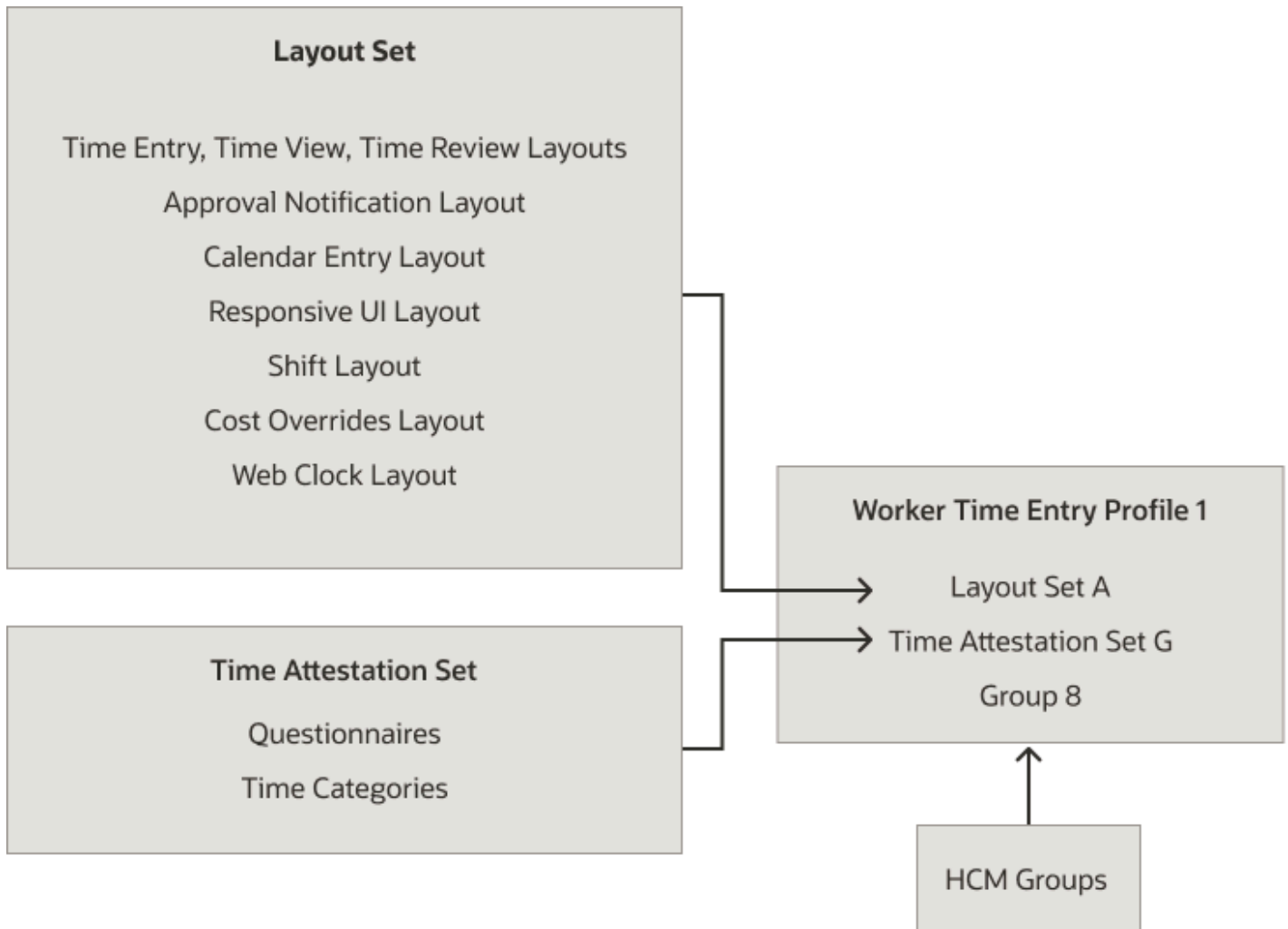
Best Practices for Creating Time Entry Objects

You need to create separate time entry profiles for each unique combination of time entry objects, as shown in these diagrams.

The more objects you create, the greater the ongoing maintenance effort. You want to find a balance between optimizing the time entry experience for your time reporters and the effort required to maintain that experience.

Here's how the time entry components and time categories of layout sets work together. And how the layout and time attestation sets of the time entry profile work together. The following sections provide some combination of guidelines, considerations, questions, and examples to help you decide how many time entry objects to create.





Custom Time Attributes

Create as many custom time attributes as you need for people to record company-specific time information outside of payroll, absences, and project costing. For example, you want people to record the type of break they take, such as Breakfast or Tea.

Time Entry Layout Components, Time Categories, and Layout Sets

You've many considerations to factor when deciding how many time entry layout components, time categories, and layout sets to create. For example, when you create layout components, you set a default field or button name. You can elect to let people override those names when they configure layouts. This approach minimizes the number of layout components you need to create because you can reuse them in different layouts. You create as many layouts as you need to provide meaningful time entry, review, and approval pages for the people using them. Another topic has questions, examples, and comments to help you assess how many of these objects you need.

Time Categories and Time Attestation Sets

Create as many time attestations sets as you need for the different groups of policy and regulations you need groups of people to attest to. Also create as many time categories as you need to identify the web clock events and time entries that cause the attestation questionnaires to appear.

Time Card Access Settings on Time Entry Profiles

Create one profile for each group of people when the different groups have these conditions:

- Different settings configurations for time card access
- The same settings configurations for time card access for different date ranges

If individuals and their managers have the same settings configuration for time card access, with the same date ranges, create one profile per layout set. If subsets of managers have different configurations or use different date ranges, then create one profile for each subset of managers and their people.

Schedule, Worker Attestation, and Cost Override Options on Time Entry Profiles

Create one profile for each group of people with the same schedule, worker attestation, and cost override options.

HCM Groups

You link one or more HCM groups with each profile. Define separate groups wherever the characteristics are unique across profiles or groups of profiles. For example, you group people into separate groups for these reasons:

- One group reports only payroll and absence time.
- Another group reports project costing, payroll, and absence time.

How Many Time Entry Layout Components, Categories, and Layout Sets to Create

Use these questions to help you figure out how many layout components, time categories, and layout sets you need to create.

Question	Examples and Comments
What type of time do you want people to report?	Examples: Project costing, payroll, absence, a combination, company-specific information
What layout components do people use to report time?	<p>Examples:</p> <ul style="list-style-type: none"> • Expenditure type, project ID or name, payroll time type, absence type, and cost center fields • Start shift, end shift, and break web clock buttons
How often do people report time with the fields? Regularly, infrequently, or does frequency vary among different groups?	<p>Example: You've a group of people who regularly reports payroll costing and another group who does so infrequently. These configurations support both groups with a single field and two layout sets:</p> <ul style="list-style-type: none"> • Time card field: You add a payroll cost segment as a dependent field of the Payroll Time Type field. You configure the dependent field to appear regardless of the selected value for the payroll time type. • Layout sets: <ul style="list-style-type: none"> ○ In one set, you configure the time entry layout so that the cost field shows as part of the main table. ○ In another set, you configure the time entry layout so that the cost field appears in the entry-level dialog box. <p>You edit the display name in each layout set to show the name most expected by that group of people.</p>
Should everyone see the same drop-down list values for the time attribute or only those values that apply to their time entries? If you plan to differentiate drop-down list values, how do you want to do that?	<p>Examples of how you can differentiate the drop-down lists:</p> <ul style="list-style-type: none"> • Based on assignment • Based on exemptions, such as overtime in the US
Can you filter the drop-down list values by creating a value set or using private view objects delivered by Oracle Global Payroll Cloud? Do you need to create different fields?	<p>If you create value sets, you need to create time card fields to use those value sets. You can limit the number of required value sets by creating table-defined value sets. Use the logic of the filter variable to constrain the values available for each person according to values selected for the independent time attribute.</p> <p>You can filter values using values specified for related independent layout components that appear on the time card or Web Clock. You can also use values from these places:</p> <ul style="list-style-type: none"> • The time card itself, such as time period start and end dates • Hidden fields, such as Assignment <p>Values for hidden fields automatically populate based on these values:</p> <ul style="list-style-type: none"> • The person's primary assignment • Values provided for related independent layout components

Question	Examples and Comments
Should everyone see the same name for the layout component?	<p>Example: You use the delivered Payroll Time Type time card field. You want certain people to see the field name Type of Hours Worked and other people to see Time Type.</p> <p>You can change the default display name of appropriately configured layout components when you edit the layouts in a layout set.</p> <p>Create different layout sets for different groups of people who use the same layout component but with different names.</p>
Should everyone see the same time totals?	<p>Example: You've reservists and you want their reservist time to show in their time totals. You want to exclude reservist time totals for people who aren't reservists.</p> <p>Create different layout sets for people with time totals from different time categories.</p>
Do you want to automatically allocate time entries to payroll cost segments? If yes, do you want people to see these allocations?	<p>Example: Allocate the person's daily hours evenly to the 1111 and 2222 departments.</p> <p>You can create time allocations using just the dependent Payroll Time Type cost attributes and no time entry fields. To view the allocations, you must create the dependent fields and add them to time card layouts.</p>

7 Absence, Payroll, and Project Costing Time Attributes

Time Attributes

A time attribute reflects how time is paid, costed, billed, or recorded as an information entry. It also qualifies the linked time event or time entry. Here's how you can use time attributes:

- In the layout components that make up time card, calendar, and Web Clock layouts
- In time calculation rules, categories, and approval rules

Here are examples of time attributes and values delivered by Oracle Global Payroll Cloud, Oracle Project Costing Cloud, and Oracle Absence Management Cloud.

Integrating Application	Time Attribute	Attribute Description	Example Values
Global Payroll	Payroll Time Type	Identifies time for payroll processing according to the value selected	Regular US, Overtime CAN, Vacation US, Public Holiday US, and Public Holiday CAN
Project Costing	Expenditure Type	Identifies time for costing and billing according to the value selected	Billable and Nonbillable
Absence Management	Absence Management Type	Identifies time for absence processing according to the value selected.	Paid Maternity and Vacation

Start and End Property Time Attributes

You can identify if a time event is the start or end of a shift or meal. Depending on your policies, you can also identify other start and end properties.

You can add your own values to the time attribute drop-down lists using the ORA_HWM_CLOCK_PROPERTIES lookup. You can add Start Property and End Property time attributes and select the appropriate values as part of these tasks:

- Create web clock buttons
- Create time device event mappings

Data Dictionary of Time Attributes

The data dictionary is the place with all possible attributes regardless of the source, such as Oracle Absence Management Cloud or Oracle Global Payroll Cloud.

- It includes the primary time attributes for projects, payroll, and absence time. You can load more payroll and absence time attributes, and your own custom attributes.
- It contains metadata that data sources and time consumers use to present time data in a meaningful way. Time consumers also use it to process time data appropriately. Here are examples of the metadata:
 - What attributes to store, such as storing the configured display names of time attributes and attribute values as alternate names
 - Where the repository physically keeps the attributes
 - How to verify valid values

Generate Data Dictionary Time Attributes

After you complete the payroll and absence setup tasks, you need to run the **Generate Data Dictionary Time Attributes** process to create these attributes:

- Payroll-dependent attributes for all element input values, such as rate, rate code, state, city, and public holidays
- Payroll costing attributes

The process also updates the HWM_GENERATE_TIME_ATTR_DFF descriptive flexfield with the new and revised attributes. Here's how you also make these attributes available in Oracle Transactional Business Intelligence (OTBI):

- Confirm that this flexfield has **Deployment Status** selected.
- Run the Import Oracle Fusion Data Extensions for Transactional Business Intelligence process.

You also need to run the Generate Data Dictionary Time Attributes process after changing any time elements. Changes include adding or deleting elements, editing input values, or editing element eligibility records. If you don't run the process, you might negatively affect these actions:

- Setup of time card fields
- Validation of payroll time types
- Transfer of time to payroll

Currently, this process doesn't create any attributes for project costing time.

Time and Labor Units of Measure

You can create payroll and custom time attributes to store and display quantities as hours, days, or units.

- Use hours-based time entries to reflect how to pay, cost, and bill worked and calculated time. For example:
 - 8 hours of regular time per work day
 - 8 hours of public holiday time for what would otherwise be a regular work day
 - 10 hours of regular time per work day that calculation rules converted into 8 hours of regular time and 2 hours of overtime
 - 7 hours of regular time per work day spent on project A, and 1 hour of regular time spent on miscellaneous administration
 - 8 hours of regular time per work day for 2 days, and 8 hours of absence for 3 days
- Use days-based time entries to measure absences, for example, 4 days of personal time off.
- Use units-based time entries to assign people a flat payment amount. For example:
 - Pay people 25 USD for each meal taken, up to three meals per day.
 - Pay people an extra 100 USD for each worked shift where they were in charge and handled related duties.

Here are the units of measure that you can include on various time layouts:

- You can include both hours-based and units-based time card fields on these layouts: time entry, review, view, approval notification, calendar entry, and responsive UI.
- You can use only hours-based time attributes to create the web clock buttons on the web clock layout. You can optionally include hours-based and units-based fields on the web clock layout.
- You can include only hours-based fields for the shift layout.

8 Custom Time Attributes

Overview of Custom Time Attributes

You can create custom time attributes that store company-specific information in the time repository and add them on people's time cards. You can also link dependent attributes to these independent custom attributes. Then use this information in rules and reports.

For example, you want to record the type of break people take when they report time for the Break payroll time type. You start by creating a value set with these values to link to your custom attribute:

- Standard 10-minute break
- Special 15-minute break
- 2 combined 10-minute breaks
- Lunch break
- Combined lunch break and 10-minute break
- Combined lunch with 10-minute breaks to leave early

You then create your custom time attribute, which you can use with the Break time card field or web clock button.

Note: You can't delete custom time attributes after you create them. And, the attribute values don't transfer to payroll or project costing.

Value Sets

Before you create your custom time attributes, create at least one value set for each independent and dependent time attribute.

- If your list of values is the same for both the setup tasks and time entry, you can create just one value set. Use that value set with both the unfiltered data source and the filtered data source.
- To limit the drop-down lists for time entry to valid values for each individual, create both an unfiltered and a filtered value set.

CAUTION: Updating an existing value set for a custom time attribute linked to time entry layout components already used on time card layouts causes errors. You need to create a new value set, new custom time attribute, and new layout component instead. Then, replace the existing layout component with the new component in the appropriate layouts.

Attribute Categories

You can use attribute categories to group multiple custom time attributes together, to help when people add time attributes as part of setup tasks. For example, you can use the delivered Custom category to identify time attributes not delivered as part of the application. You can also use these categories in reports.

Create Value Sets for Time and Labor

You create unfiltered value sets for your administrators to use during setup tasks, such as creating time categories or rules. And you can create separate, filtered value sets for individuals to use when they report time.

Use the Time and Labor Value Sets task in the Setup and Maintenance work area. It's part of the Workforce Deployment offering, Time and Labor functional area.

CAUTION: You'll get errors if you update an existing value set for a custom time attribute used on time card layouts. You need to create a new value set, new custom time attribute, and new layout component instead. Then, replace the existing layout component with the new component in the appropriate layouts.

1. On the Time and Labor Value Sets page, click the **Create** icon.
2. On the Create Value Set page, complete these steps:
 - a. In the Module field, select **Time and Labor Web Entry Configurations**.
 - b. Select one of these validation types: **Format Only**, **Independent**, or **Table**. Typically, you want to use a table-validated set as the filtered data source for a time card field.
 - c. Select the appropriate data type for the values in the set.
 - d. For a table-validated value set, use the SQL WHERE clause to add filter variables that limit the valid values to a subset of values. When you create time card fields, you map these filter variables to time attributes that limit drop-down lists to valid values for each individual.
 - e. Save and close your configuration. The task maintains the values that you want to use in an application table.
3. Add values. How you add them to the value set depends on the validation type.
 - o Independent validation: On the Create Value Sets page, click **Manage Values** to add values.
 - o Table-validated: You don't have to define or maintain values because the reference view or table manages them.

Attribute Categories for Custom Time Attributes

An attribute category can include a limited number of time attributes. This limit depends on the data type of the time attribute, as shown here.

Data Type	Maximum Number of Time Attributes Supported
Text	40
Number	40
Date	20

If you've more than the specified number of attributes, you need to create another category. To retain the relationship between the categories for reports, you might want to use the same category name with an appended number.

You create attribute categories for the ORA_HWM_ATTR_CATEGORY lookup type using the Manage Common Lookups task in the Setup and Maintenance work area. The attribute categories are available for use when you create time attributes.

Create Custom Time Attributes

To create a custom time attribute, you use the Custom Time Attributes task in the Setup and Maintenance work area. It's part of the Workforce Deployment offering, Time and Labor functional area.

1. On the Custom Time Attributes page, click the **Create** icon.
2. On the Create Time Attribute page, complete these steps:
 - a. Enter a name and description.
 - b. Select the classification type, which indicates if the attribute has dependent attributes.
 - c. Select the data type of the attribute. It need to match the data type of the linked value set.
 - d. Optionally, select the unit of measure used for payroll and reporting purposes.
 - e. Select the data source value sets that appear first in the data source drop-down lists when your administrators configure time card fields with these attributes.
 - f. Select an attribute category value to group time attributes for reporting purposes. You create your own attribute categories as lookup type values.

When you select an attribute category, the data dictionary location that stores the custom time attribute appears. The location value also indicates the number of times this attribute category was used to group time attributes.

- g. To add dependent time attributes, go to the next section. Otherwise, save your changes and close the page. Saving your time attribute adds it to the data dictionary.

3. If you're using the nonunified time entry experience and you selected the classification type With dependent attributes, you need to add the dependent time attributes. Here's how to do that:
 - a. On the Create Custom Attributes page, in the Dependent Time Attributes section, click **Create**.
 - b. Select the data type. It needs to match the data type of the selected data sources.
 - c. Select the data source value sets that need to appear first in the data source drop-down lists when your administrators configure the dependent fields.
 - d. Save your changes and close the page. Saving your time attribute and any dependent attributes adds them to the data dictionary.

If you're using the unified time entry experience, you can create the related single-attribute time card fields instead of dependent fields. Then add the custom attribute and related single-attributes fields to the appropriate layouts in the layout sets, in the display sequence that makes the appropriate drop-down list values available.

Overview of Layout Components for Time Entry

You specify how a time attribute appears on classic calendar pages, classic and responsive time card and web clock pages, and Redwood enhanced time card pages. Also specify how the attributes transfer to the time consumer with these layout components.

To manage time entry layout components, use the Time Entry Layout Components task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

Single-Attribute Time Field

A single-attribute time field has only one time attribute linked to it. For example, Task is a single-attribute field with the TaskID time attribute.

You use single-attribute fields most often with lists of values that are dynamic and update automatically as new values are added for the attribute. Because the list is dynamic, some values might not be relevant to the people reporting time.

If you've the unified time entry experience enabled, you create single-attribute fields with dependent time attributes from payroll element values. Examples of element values are rate override, location override, and costing segments. The people who can see the field, and where they see it depends on how you configure the field and the layouts that include it.

If you've the nonunified time entry experience, you configure dependent attributes as part of the create single-attribute field guided process.

Multiple-Attribute Time Field

A multiattribute field has one or more time attributes linked to it. It stores multiple values internally, but people see only one value. For example, when someone selects the Hours Type value Regular, the save action stores the Regular payroll time type and Billable expenditure type.

Multiattribute fields also let you identify HCM groups whose members can see the value. And you can specify whether workers, line managers, and time and labor managers can edit or only read the value.

You use multiattribute fields most often with payroll time attributes because they're relatively static. And you can change the name of the attribute value that people see. For example, a payroll time type value might be US Reg Hrly and you set the display name to Regular Pay.

The unified time entry experience uses layout-level maximums for time card field data types, including multiattribute fields. The nonunified time entry experience uses a site-level maximum of 20 multiattribute fields across all layouts. So if you've the nonunified experience, plan carefully the fields to create and the layouts to add them to.

1. Use the allowed actions and HCM groups in each row to create one multipurpose field.
2. Use the field in various layout sets across many groups of workers, managers, and time and labor managers.

Web Clock Buttons

Each web clock buttons layout component typically contains multiple web clock buttons. Each button has one or more attributes linked to it.

The button stores the multiple values internally, but people see only one value. For example, when someone clicks **Clock Out**, it stores the Out application event and Regular payroll time type.

The create buttons page automatically includes the Clock Event time attribute in the button definition table. The attribute values are In, In and Out, Out and In, and Out.

Dependent Time Field

Optionally define dependent time card fields as part of the guided processes to create single-attribute and multiattribute time card fields, and web clock buttons. A dependent field is always a single-attribute field that's related to an independent field or button.

Generally, you identify dependent time attributes from payroll element values, such as rate override, location override, and costing segments. For example, you configure a field so that people need to select a Payroll Time Type value before they can select the dependent State value.

When and where the dependent field appears on the time card or Web Clock depends on the related independent field or button. It also depends on the availability setting. The availability setting specifies whether the field always appears with the independent field or only after people select specific values.

If you've the unified time entry experience enabled, you create single-attribute fields. Instead of just independent time attributes, the Time Attributes drop-down list includes both independent and dependent attributes. The people who can see the field, and where they see it depends on how you configure the field and the layouts that include it. It doesn't depend on any value selected for the corresponding independent time attribute because the unified experience doesn't let you do this configuration.

Note: If you need fields to appear only after workers select specific attribute values, then continue to use the nonunified environment. You can also post your requirement in Idea Lab.

Delivered Time Card Fields

Time and Labor include delivered single-attribute absence, payroll, and project fields, many of them used in the delivered layout sets.

Delivered project fields include fields to track grant-related information, such as funding sources and expenditure organizations for sponsored projects. You need to finish configuring the delivered multiattribute Time Type field before you can use it.

To quickly find these fields, search for Delivered in the Description field. If you need to create your own fields, you can search for and duplicate the delivered field that most closely matches the field you need. Then, edit the duplicate field to support your time reporting policies.

CAUTION: For the delivered fields to work properly, you need to complete Absence Management, Global Payroll, and Project Costing setup and integration task. Then, you need to generate the time attributes in the data dictionary.

Basic Time Entry Layout Component Configuration Process

You use time entry layout components on classic calendars, classic and responsive time cards shift dialog boxes, and Web Clock, and enhanced time cards.

The basic process for creating single-attribute and multiattribute time cards fields has four main steps and uses the Time Entry Layout Components task in the Setup and Maintenance work area. It's part of the Workforce Deployment offering, Time and Labor functional area.

Before you start

Make sure that the payroll and absence time attributes exist in the data dictionary, and any custom time attributes.

Here's what to do

1. From the Time Entry Layout component page, create the time card field.
2. Complete the Field Definition page. If you've the unified time entry experience enabled, this is the only page available.
 - a. Enter the general properties.
 - b. Configure the time attributes, data sources, and filters for the filtered data source, as appropriate. For multiattribute fields, you do this when you add a time attribute to the attributes definition table.
 - c. Configure the reported time options for workers, line managers, and time and labor managers. This section is available only if you've the unified time entry experience enabled.
 - All options apply only where the field is used to report time. They're ignored where the field is used to show calculated time and on other, nonreported time pages.
 - Any Filtered Data Source for Time Entry selection that you make for line managers and time and labor managers overrides the selection in the Time Attribute and Data Source section. You only need to do this when managers need a less granular filter than workers.
 - d. Add and configure each row in the attributes definition table. This step doesn't apply to single-attribute fields.
 - e. Optionally, configure a value to default for the field when it appears on classic and responsive time cards. The enhanced time card ignores the default value.
 - f. Configure the field-level display properties.

If you've the nonunified time entry experience enabled, continue to the next step.

3. Optionally complete the Dependent Field Definition page. This step is available only if the independent time attribute you selected on the previous page has dependent attributes defined in the data dictionary.
 - a. Create the dependent field. Each dependent field that you create appears as a row in the table on the Dependent Field Definition page.
 - b. Optionally, edit the dependent field properties, as appropriate.
 - c. Select the data sources for the dependent time attribute and add filters for the filtered data source, as appropriate.
 - d. Optionally, configure a default value for the dependent field.
 - e. Configure the field-level display properties for the dependent field.

You can also create all dependent fields first, step 1, then select a field in the table and complete steps 2 through 5. You keep selecting a field and completing steps 2 through 5 until you completely configure all the dependent fields.

4. Complete the Review page.

On this page of the guided process, you review and save your definition details. If any details aren't right, you can go back and fix them before you save the component.

10 Data Sources

Data Sources for Layout Components

When you define single-attribute, multiattribute, and dependent fields, you select a filtered data source and an unfiltered data source for the specified time attribute. When you define web clock buttons, you select the unfiltered data source for each time attribute.

Typically, the most appropriate filtered and unfiltered data source is the first value in the drop-down list.

Data Source Filters for Time Entry

Oracle Absence Management Cloud, Oracle Global Payroll Cloud, and Oracle Project Costing Cloud provide filtered data sources for many of their independent time attributes. They don't provide filtered data sources for many of their dependent time attributes.

When the filtered data sources include filter variables, you need to select the filter input attribute for each filter variable. A filter input attribute supplies the value that filters the field data source. For example, the person's assignment ID identifies their choices for the Payroll Time Type attribute. Drop-down lists for the filter variable and input attribute values of multiattribute fields contain all the values from all the filtered data sources, for all the time attributes.

Data Source Filter Examples

Both a single-attribute field and multiattribute field use the Payroll Time Type time attribute. The multiattribute field also uses the Expenditure Type time attribute. Here are the filter variables provided by the filtered data source for each time entry field.

Single-Attribute Filter Variables	Multiattribute Filter Variables
<ul style="list-style-type: none"> • pAssignmentID • pEffectiveDate 	<ul style="list-style-type: none"> • pProjectUnitId • pEffectiveDate • pAssignmentID

Single-Attribute Filter Variables	Multiattribute Filter Variables
	<ul style="list-style-type: none"> • pStartTime • pStopTime <p>The Filter Variables drop-down list includes pEffective Date only once, even though it's provided by the filtered data sources for both time attributes.</p>

Data Source Types

Data sources are either private view objects or value sets.

- A private view object is an Oracle component that simplifies querying and working with business object rows. Values for private view objects appear on the time card, in the drop-down lists of the time attributes. Global Payroll provides separate private view objects for the filtered and unfiltered data sources.
- A value set is a collection of values that appear in the drop-down lists of the time attributes. Project Costing provides the same value set for both the filtered and unfiltered data sources. You can create value sets to use as drop-down lists for any custom time attributes that you create.

For unified single-attribute time card fields, the filtered data sources for line managers and time and labor managers must store the same data type and data as the worker filtered data source. When the worker delivered data source is a private view object, the corresponding manager value sets that you create must include the same values as the private view object.

11 Common Configuration Properties for Time Card Fields and Web Clock Buttons

Best Practices for Configuring General Properties of Time Entry Layout Components

When you create any time entry layout component, configure the name and description according to these best practices.

Name

Enter a unique short name, possibly using agreed on abbreviations, such as **PTT** for payroll time type. This name appears in the Name drop-down list on the Edit Layout dialog box, Time Card Matrix page. That drop-down list shows only the first 15 characters.

Description

Provide a concise but complete description of the purpose of the time card field or web clock buttons. It really helps people who are configuring time layouts to know which components to add or delete. Here's an example description for a multiattribute time card field with dependent fields: **Absence and payroll values with dependent meals, department, and US location fields.**

Options to Configure Default Values for Time Card Fields

When you create time card fields, you can optionally specify values to default for new time entries on classic, responsive, and enhanced time cards. You can also specify values to default for dependent fields that appear on Web Clock.

Note: You don't configure default values for web clock buttons.

People add fields to a time card when they open the time card, add an attribute row, or add an entry. You don't configure default values for web clock buttons.

Select the population method for new field entries from these options:

- **No default value:** Don't automatically populate the new field with an entry.
- **Specific value:** Automatically populate the new field with the specified value. These sources populate the **Specific Display Value** drop-down list:
 - For single-attribute fields, the unfiltered data source that you selected earlier
 - For multiattribute fields, the display names in the Display Name and Multiple Attribute Definition section

Optionally, populate new entries based on another time card field. For example, if you select the **Expenditure Type** time attribute, you can specify to populate new entries based on the Expenditure Type Name attribute value.

Note: This option works only with classic time cards. Responsive and enhanced time cards ignore this population method.

- **Function:** Automatically populate the new field with the value derived by the selected function, such as **Based on primary assignment**. The function uses the filtered data source. This option is available only if the time attribute has delivered functions.

Note: Any default value that you specify is ignored by the Generate Time Cards process accessed from the **My Client Groups > Team Time Cards** page. It uses the attribute values specified on that page instead. Enhanced time cards also ignore default values.

Configure Field-Level Display Properties for Time Entry Layout Components

The actual combination of field-level display properties that you can configure varies by the type of time entry layout component. For example, you can't configure the Display Type property for web clock buttons.

1. Select the display type, such as **Text box**, **Smart choice list**, or **Hidden field**. Hidden fields never appear on the time card. If you've the unified time entry experience, the drop-down list doesn't include Read Only option. You handle this instead in the Reported Time section, with the Read only option.
2. Edit the display name, as appropriate. This name is the default column header of the tables on classic time card entry, review, view, and approval notification pages. It's the default column header of the tables on the enhanced

time card pages. It's also the default field name on responsive time card pages, Web Clock, and time card and calendar dialog boxes.

Note: To fully render the display name on time card, calendar, and web clock pages and dialog boxes, limit the name to 70 characters or less.

3. Enable or disable override on layouts. Enabling the override lets people set different, meaningful display names in various layout sets that use the same layout component.
4. Specify whether the time card field is required. Required fields always appear on the page or dialog box and people need to provide a value.

Tip: To keep people from submitting time cards with no entries, make sure that at least one time card field on the time layout is required.

The validation that checks for values in the required fields runs when people save or submit classic and Redwood time cards. It also runs when people click **OK** after editing an entry on a responsive time card. It doesn't run when people save or submit responsive time cards. If people don't edit responsive time card entries that include required fields, they can submit time cards that are missing required values.

12 Single-Attribute Time Card Fields

Configure the Single-Attribute Time Card Field Properties

Here's how you configure the time attribute, data sources, and filters for single-attribute time card fields. The process applies for both nonunified and unified time entry experiences.

1. On the Create Time Card Field: Field Definition page, select the time attribute, such as **Payroll Time Type**.
2. Select the filtered data source and unfiltered data source for the specified time attribute. Typically, the most appropriate source for the selected attribute is the first value in the drop-down list.
3. Add any filters for the filtered data source by selecting the filter variable and corresponding input attributes. For example, here are the filter variables and filter input attributes provided by the Payroll Time Type attribute data source.

Filter Variables	Filter Input Attributes
pAssignmentID	Assignment
pEffectiveDate	Start Time

Not all filtered data sources have filters.

Configure US Location Override Fields in the Unified Time Entry Experience

Let people enter location override information when they report time worked somewhere other than their normal work location. You can set up only a single location level, such as State, or multiple location levels, such as State, County, and City.

Set up each location level as a single-attribute time card field using the Time Entry Layout Components task in the Setup and Maintenance work area. The task is in the Workforce Deployment offering, Time and Labor functional area.

Before you start

Prepare the location time attributes. You can use the location time attributes we provide. They've data sources and drop-down list filters, and transfer to payroll after final approval. Or you can prepare your own location attributes using this basic process:

1. Create payroll elements using the Time Card category, with the necessary input values for location by legislative data group. Use the Elements task in the Elements and Formula functional area.
2. Generate the location time attributes using the Generate Data Dictionary Time Attributes task in the Time and Labor functional area.

Here's what to do

1. Create the single-attribute time card field, such as State, County, or City.
2. Complete the general properties.
3. In the Time Attribute field, search for and select the appropriate location attribute, such as **State**, **County**, or **City**.
4. Select the unfiltered data source and filtered data source for the time attribute.

Time Attribute	Data Source

City	Filtered, one of these options: <ul style="list-style-type: none"> ○ ORA_HRX_US_EARN_CITY ○ List of values for payroll US county field for Geocode Unfiltered: List of values for payroll US city field for administrator

5. Add the filter variables and input attributes for the filtered data source. If you use multiple location levels, you configure the data source filters as shown in this US example.

Time Attribute	Filter Variable	Variable Input Attribute	Available Values
State	NA	NA	All values in the State data source
County	pCodeLevel1	State	All counties in the selected State
City (step 1)	pCodeLevel1	State	None
City (step 2)	pCodeLevel2	County	All cities in the selected County in the selected State

6. Add the location fields to the appropriate layouts in the layout sets, in the display sequence that makes the appropriate drop-down list values available. For example, when city values depend on the selected state and county values, you display the State field first, followed by County, and then City. If you display the City field first, the drop-down list is empty.

Configure Labor Costing Override Fields in the Unified Time Entry Experience

Let people enter payroll costing information by creating the appropriate single-attribute fields using the Time Entry Layout Components task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

Before you start

Prepare cost segment time attributes for use in time card fields using this basic process:

1. Create payroll value sets using the Payroll Value Sets task.
2. Set up the cost allocation key flexfield using the Cost Allocation Key Flexfield task.
3. Set up the cost allocation key flexfield usage to be available at the element entry level.
4. Generate the costing time attributes using the Generate Data Dictionary Time Attributes task.

Here's what to do

1. Create the single-attribute time card field.
2. Complete the general properties.
3. In the Time Attribute field, search for and select the appropriate general or common payroll cost segment.
4. Add the data sources and filters.
 - a. Select the unfiltered data source and filtered data source for the cost attribute. Typically, the most appropriate source is the first value in the list.
 - b. Add the filter variables and input attributes for the filtered data source.

What to do next

Add the costing field to the appropriate unified time entry layout.

13 Dependent Time Card Fields in the Nonunified Time Entry Experience

Configure the Dependent Field Properties

You can define dependent fields in the nonunified time entry experience. You do this in the optional second step of the guided processes for creating time entry layout components.

If you've the unified experience, you create dependent fields as single-attribute time card fields. Then you add the fields to the appropriate time layouts in the appropriate order for filters and processing. For example, the State field needs to come before the County field. This way the County drop-down list has only the counties for the selected state and not all counties for all 50 states.

Dependent time card fields that you created before the unified experience was enabled continue to work in unified layouts that include the corresponding independent layout component.

You can create and configure dependent fields in the nonunified experience using either of these methods:

- Create all your dependent fields and then select each field in turn to add the data sources and filters.
- Create a dependent field, add the data sources and filters, and then repeat for the remaining dependent fields.

Note: To add dependent fields to a single-attribute payroll field, duplicate and edit the delivered Payroll Time Type field. Don't directly edit the delivered field to avoid possible issues with future upgrades.

Before you start

Before you add dependent fields to multiattribute fields and web clock buttons, configure the entire attribute definition table on the Field Definition page. You do this because the attribute values that you select in that table make up the Independent Attribute Value drop-down list.

Here's what to do

1. On the Dependent Field Definition page, click the **Create** button.
2. On the Create Dependent Time Card Field dialog box, complete the general properties:
 - a. In the Name field, enter a unique short name, possibly using agreed on abbreviations, such as **PTT** for payroll time type. Also, you can select a dependent time attribute from either the general or detailed level. For example, at the general level you can select **Rate Amount**. At the detailed level, you can select **Rate Amount for US Regular** or **Shift Premium**. To help with accurate layout configurations, we recommend that you include an appropriate suffix, such as **D** or **G**, for example, **RateG** or **DeptOTD**.

This name appears in the Name drop-down list on the Edit Layout dialog box, Time Card Matrix page. That drop-down list shows only the first 15 characters.

- b. In the Description field, document the purpose of the dependent field. Here are some examples:
 - Override rate amount to provide as the payroll input value
 - Override rate amount to provide as the payroll input value for the US Regular time attribute
 - Department for the reported time
 - Department for the worked overtime
 - County for the reported time, provided as the payroll input value
 - County code for the reported time, provide for the US Hourly costing segment
 - c. Select the dependent time attribute for the specified independent time attribute, such as **Overtime_City** for location or **Department** for payroll costing.
 - d. Configure the availability of the dependent time attribute:
 - i. Select the availability of the dependent time attribute. See the Availability Options for Dependent Time Card Fields topic for key considerations about these options.
 - ii. If you select **For specific independent time attribute values**, add the specific values.
 - e. Click **OK**.
3. Select the filtered data source and unfiltered data source for the specified time attribute. Typically, the most appropriate source is the first value in the drop-down list.
 4. Add any filters for the filtered data source. Many filtered data sources for dependent absence management, payroll, and project costing attributes don't have filters.

Availability Options for Dependent Time Card Fields

When you define dependent time fields, you specify the availability of the dependent field in relation to the independent time attribute. You indicate whether it's available with all values of the independent time attribute or just specific values.

Considerations

Your availability selection affects where you can configure the dependent field on layouts. The selection also affects when people see the dependent field on time cards and Web Clock. Here are some key considerations for when you're deciding which availability option to select for the dependent field.

Consideration	Available for All Independent Values	Available for Selected Independent Values
Can I use the dependent field on the calendar?	Yes	No.
When does the dependent field appear?	It always appears, as configured in the time card matrix or a dialog box, when the layout configuration includes the independent attribute.	It appears only after the person selects one of the specified values.

Consideration	Available for All Independent Values	Available for Selected Independent Values
Where can I display the dependent field on the time card layout?	<ul style="list-style-type: none"> In the matrix In the dialog box for row-level or entry-level details On the calendar dialog box 	Only on the dialog box for row-level or entry-level details. You need to add the independent time attribute in the matrix of the layout before you can add the dependent field.
In what scenarios is each availability option recommended?	<p>When people use the dependent field often:</p> <p>When you want it to appear in the time card matrix, on the calendar, on Web Clock, or a combination</p>	<p>When people use the dependent field infrequently</p> <p>When you don't want it to ever appear in the time card matrix or on the calendar</p>
What are the drawbacks of each availability option?	<p>The drop-down list values for the dependent field might be inappropriate or missing</p> <p>The dependent field could be available but there isn't a corresponding input value on the payroll element for some independent attribute values</p>	The time card matrix and calendar can't display the dependent field
When can I use dependent fields on Web Clock?	When the dependent field applies to all defined web clock buttons	When the dependent field applies to only one or a subset of web clock buttons

When you create single-attribute fields in the unified time entry experience that depend on other fields, it's the same as selecting **Available for all independent values**.

Example of a Dependent Field That's Available After the Person Clicks a Specific Button

You want people to select a department on Web Clock after they click **Transfer**.

Setup

You specify that the dependent Department field is available for only the Transfer button. You then add the Department field on the web clock layout.

Results

The Department field appears when people click **Transfer** on Web Clock.

Example of a Dependent Field That's Available After Specific Selections

You want people to select a department after they select **Overtime** in the Payroll Type field. They use this dependent field infrequently so you want it to appear only in the dialog box with row-level details.

Setup

You specify that the dependent Department field is available only when people select **Overtime** for the independent Payroll Time Type attribute.

Results

If the people select **Overtime**, the Department field appears in the dialog box with row-level details and they can select a department. If people select **Regular**, the Department field doesn't appear anywhere on the page, including dialog boxes, and they can't select a department.

Example of a Dependent Field That's Always Available

You want people to always select the department after they select a payroll time type. They should easily find the dependent field in the time card matrix or on the calendar.

Setup

You specify that the dependent Department field is available for all independent Payroll Time Type attribute values.

Results

The Department field always appears in the time card matrix and on the calendar, regardless of the selected payroll time type. People can always select a department.

You can capture only a single location level, such as State, or multiple location levels, such as State, County, and City. Set up each location level as a dependent time card field of the independent Payroll Time Type attribute. Use the Time Entry Layout Components task in the Time and Labor functional area.

Before you start

Prepare the location time attributes. You can use the location time attributes we provide. They've data sources and drop-down list filters, and transfer to payroll after final approval. Or you can prepare your own location attributes using this basic process:

1. Create payroll elements using the Time Card category, with the necessary input values for location by legislative data group. Use the Elements task in the Elements and Formula functional area.
2. Generate the location time attributes using the Generate Data Dictionary Time Attributes task in the Time and Labor functional area.

Here's what to do

1. Create or edit an independent time card field or web clock buttons definition that has the Payroll Time Type time attribute.

You can let people enter payroll cost information by creating dependent fields for the independent Payroll Time Type time attribute.

Set up cost fields as dependent time card fields of the related independent Payroll Time Type time attribute. Use the Time Entry Layout Components task in the Time and Labor functional area.

Before you start

Prepare cost segment time attributes for use in time card fields using this basic process:

1. Create payroll value sets using the Payroll Value Sets task.
2. Set up the cost allocation key flexfield using the Cost Allocation Key Flexfield task.
3. Set up the cost allocation key flexfield usage to be available at the element entry level.

4. Generate the costing time attributes using the Generate Data Dictionary Time Attributes task.

Here's what to do

1. Create or edit an independent time card field that has the Payroll Time Type time attribute.
2. Create the dependent field.
 - o Be sure to set the independent attribute to **Payroll Time Type**.
 - o Remember, your availability selection decides what display options people have when they configure time layouts. Here's the appropriate availability selection for legislative data groups that do and don't share costing structures.

Shared by LDGs	Availability Setting
Yes	You can make the costing structure available to all independent attribute values.
No	You must create multiple dependent fields and specify the independent attribute values for each dependent field.

3. Add the data sources and filters to the field selected in the General Properties section.
 - a. Select the unfiltered data source and filtered data source for the cost attribute. Typically, the most appropriate source is the first value in the list.
 - b. Add the filter variables and input attributes for the filtered data source.
4. Add the dependent costing fields to the appropriate layouts in the layout set. The availability setting that you selected when you create the dependent field decides your display options in time card layouts.

14 Dependent Time Card Field Configuration Examples

Create the Dependent Meal Override Rate and Rate Periodicity Fields

You want to let managers override the meal allowance as appropriate, so you create two dependent fields for the independent Payroll Time Type attribute.

The Meal Override Rate field lets them override the person's default rate. The Meal Rate Periodicity field ensures proper processing after the overridden rate transfers to Global Payroll.

Before you start

Create the Meals Taken element.

Certain people regularly travel among regional locations, even crossing state lines. You want them to identify where they worked their reported time. So you create the dependent State, County, and City location fields for the independent Payroll Time Type attribute.

 - i. In the Name field, enter the name of the current location field that you're creating, either **State**, **County**, or **City**.

 - iii. In the Dependent Time Attribute field, click **Search**.
 - a. On the Search and Select: Time Attributes dialog box, in the Name field, enter the current attribute name, either **State**, **County**, or **City**. The default search results level is General, which is what you want for these attributes.
 - b. In the search results section, select the dependent time attribute for the current field, either **State**, **County**, or **City**, that's in the InputValue collection.
 - c. Click **OK**.
 - iv. On the Create Dependent Time Card Field dialog box, enter the description.

Configure the Time Attributes for the Multiple-Attribute Time Card Field

You create a multiple-attribute time card field by adding, for example, a combination of absence, payroll, and project costing time attributes as table columns.

1. On the Create Time Card Field: Field Definition page, click **Add Time Attribute**.
2. On the Add Time Attribute dialog box, complete these steps:
 - a. Set the attribute display sequence to specify where the column appears in the table.
 - b. Select the time attribute, such as **Payroll Time Type**.
 - c. Select the unfiltered data source and filtered data source for the specified time attribute. Typically, the appropriate source is the first value in the drop-down list.
 - d. Specify whether the structure definition requires the time attribute.
 - e. Click **OK**.
3. Repeat steps 1 and 2 until you add all the time attributes for this field definition. Be sure to include the Identifier time attribute so that you can uniquely identify rows that otherwise have the same attribute values.
4. Add up to five of the filters provided by the filtered data sources, for the time attributes in the attribute definition table. For example, these are the filter variables and input attributes provided by the Expenditure Type and Payroll Time Type attribute data sources.

Add and Configure Values for the Multiple-Attribute Time Card Field

After you create the attribute definition structure, you define the field values by completing these steps for each row that you add to the table:

1. Enter the display value that people see in the field drop-down list, such as **Paid holiday US, Nonproject work, or Regular professional**.
2. Select the time attribute values that the time repository stores, such as the **Public Holiday US** or **Regular US** payroll time type. Or select attribute value combinations. For example, select the **Professional Straight Time US** expenditure type name and the **Regular US** payroll time type.
Expenditure types are derived from the project unit. The selected project identifies the expenditure type values that people see in this field drop-down list. Changing the project won't affect the payroll or absence values that people see in the drop-down list.
CAUTION: If you use Absence Management and Global Payroll or Project Costing attributes, or all three, in the absences rows, select values for only the absence management attributes. This way payroll and project time data routes to the appropriate approvers and transfers to the appropriate time consumers. If you extract time data to use with external applications, you can combine absence data with payroll or project data, or both.
3. Optionally specify that people can override the cost segment linked to the specified payroll time type. For example, the default cost segment for the Regular US payroll time type is Standard. This default is fine for your help center staff. But, your field technicians often need to override the cost segment according to the type of work they do.
If you enable cost override, be sure to include and configure the Cost overrides layout in the appropriate payroll or payroll and project layout sets.
4. Specify the worker and manager actions allowed for reported time entries. The default action for both is Edit.
 - o When a time attribute value is read-only for everyone, the value appears in only the calculated time. The value doesn't show up in any reported time entries.
 - o Calculated results are always read only for both workers and managers.
 - o Managers with the Time Attribute Full Access privilege can edit reported time values, even if the manager allowed action is Read only.
5. Optionally filter the values that people see by assigning one or more HCM groups. Click the **Show All Groups** icon to do this row by row. You can also select multiple rows, and on the Actions menu, select **Assign to HCM Group**.
 - o If you assign groups to specific values, group membership identifies if workers and managers can even see the value in their drop-down list.
 - o If you don't assign groups to specific values, everyone can see all the values in their drop-down list.

 - b. Configure the fields for each row, as shown here. Note that the absence rows have values for only absence management attributes. This way payroll and project time data routes to the appropriate approvers and

transfers to the appropriate time consumers. If you extract time data to use with external applications, you can combine absence data with payroll or project data, or both.

1. Create attribute definition table structure, which automatically includes the Clock Event attribute.
 - a. On the Create Web Clock Buttons: Button Definition page, click **Add Time Attribute**.
 - b. In the Add Time Attribute dialog box, complete these steps:
 - i. Set the attribute display sequence to specify where the column appears in the table.
 - ii. Select the time attribute, such as **Payroll Time Type** or **Start Property**.
 - iii. Select the unfiltered data source for the specified time attribute. Typically, the correct value for the selected attribute is the first value in the drop-down list.
 - iv. Specify whether the definition structure requires the time attribute.
 - v. Click **OK**.
 - c. Repeat steps a and b until you add all the time attributes for the definition of these buttons.
2. After you finish the attribute definition structure, add and configure each row of the attribute definition table.
 - a. Enter the button label that people see on Web Clock. For example, **Start Shift**, **Take Break**, **Back from Break**, or **Take Meal**.
 - b. Select the time attribute values, which the time repository stores.

You can reuse the short break buttons, so you only create them once. Use the Time Entry Layout Components task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

1. Create the web clock buttons.
 - a. On the Layout Components page, click the **Create** button.
 - b. On the Create Layout Component dialog box, select **Web clock buttons**.
 - c. Click **OK**.
2. Enter the general properties.
 - a. On the Create Web Clock Buttons: Buttons Definition page, in the Name field, enter **8-Hr Shift Clock Events**.
 - b. In the Description field, enter **Uses the independent Payroll Time Type, Start Property, and End Property attributes, and the dependent Department time attribute**.
3. Add the time attributes, data sources, and filters.
 - a. On the toolbar, click **Add Time Attribute**.
 - b. On the Add Time Attribute dialog box, complete the fields for the Payroll Time Type time attribute, as shown here. Use default values unless otherwise specified.

17 Time Attestations

Time Attestations

You can identify if people are complying with time policies and various regulations. You do this by having people attest to more information when they report time using Web Clock or responsive time cards.

You can configure these attestations to appear for the time card. For example, you've an attestation that prompts workers to attest they took their meal break if they worked more than 5 hours. Or you can configure attestations to appear when specified events or actions occur. For example, show a meal attestation when someone clocks out at the end of their shift, or when they save their time card. You can also have attestations appear when certain conditions get met. For example, show an attestation after a specific elapsed Web Clock duration, for a specified time entry duration, or for specific time attributes.

Time-card level attestations appear every time the worker submits their time card for approval and the attestation display conditions are met. Detail-level and day-level attestations appear only once. Submitted attestations are viewable only in attestation history opened from the time card.

Configure Time Attestations

Here are the setup tasks that you need to complete in the Setup and Maintenance work area to configure time attestations: The tasks in steps 2 through 4 are part of the Workforce Deployment Offering, Time and Labor functional area.

1. Create your attestations using the Question Library, Questionnaire Templates, and Questionnaires tasks.
2. Create time categories using the Time Categories task. For more complex logic, you can create an advanced time category rule and link it to the time category. Use the Time Rule Templates and Time Rules tasks.
3. Create groups of related attestations using the Time Attestation Sets task.
4. Link the time attestation set to people on their time entry profiles using the Worker Time Entry Profiles task.

Time Attestation Sets

Identify if people are complying with time policies and various regulations using time attestations sets. You can link an attestation set to a time entry profile so that people with shared compliance characteristics for time entry can make appropriate attestations.

Questionnaires

Link existing questionnaires to a time attestation set for people with similar attestation requirements. For example, teenagers need to attest that when they work unscheduled time, their managers authorized the work beforehand. And, they need to attest to whether they took meal breaks. If they didn't take a meal break, they need to specify why for regulatory compliance.

Initiating Events

Specify when to check whether to show the questionnaire. For example, you can check only when someone clocks in or out, saves or submits their time card, or some combination of events and actions.

Time Category

Identify what conditions the web clock events or time card entries need to meet for the questionnaire to actually appear. For example, when someone has a web clock event or time card entry with unscheduled time, show the overtime attestation questionnaire.

Display Level

Specify when to show the questionnaire. For example, show it when an entry that meets the time category conditions added to the time card. Or, show it when the person submits their time card.

18 Entries to Use in Time Totals and Processing

Time Categories

A time category has conditions that the time entry must meet to be included. A category can include only hours-based, days-based, units-based time entries, or a combination.

For example, the delivered All Payroll Entries time category includes all time entries with Payroll Time Type attribute values, regardless of their units of measure. You create categories using the Time Categories task in the Setup and Maintenance work area. It's part of the Workforce Deployment Offering, Time and Labor functional area.

Tip: To create a category with a combination of measures, leave the Unit of Measure field blank.

You can configure a single condition, compound conditions, or both. Here are some examples:

- A units-based category includes any time entry with the Payroll Time Type attribute value Meals Taken.
- An hours-based category includes any time entry with these specific Payroll Time Type attribute values: Regular US or Training US or Travel US.
- A days-based category includes any time entry with the Absence Management Type attribute values measured in days, such as Vacation Days, and not those measured in hours.

You can include other time categories in a category as long as they've the same unit of measure. Here's an example:

- The hours-based Statutory Time for OT category identifies entries with these specific Payroll Time Type attribute values: Regular US or Training US or Travel US.
- The hours-based Union Time for OT category includes the Statutory Time for OT category. It also has another OR condition that identifies entries with the Payroll Time Type attribute value Jury Duty US.

All Payroll Entries	Identifies all the reported time entries with payroll time type attributes
All Project Entries	Identifies all the reported time entries with the Project, Task, or Expenditure Type project time attributes Ignores project entries with only grant-related attributes for sponsored projects

To quickly find these categories, in the Description field, search for **Delivered**. To include other conditions to support how you identify and group time entries, you need to create more categories.

Condition Components in Time Categories

A time category condition has a time attribute, value type, and operator.

- The time attribute identifies the type of time, such as Payroll Time Type, Task, and Expenditure Type. The unit of measure that you select filters the available time attributes.
- The value type is the classification of the time category value. You can use these value types to define time categories.

Value Type	Description
Any value	Include the time entries that have any value for the time attribute in the category.
Blank value	Include the time entries that have no value for the time attribute in the time category.
Specific value	Include the time entries that have the specified value for the time attribute in the time category.
Value set	Include the time entries that have an attribute value that's in the specified value set, in the time category.

To see only attribute values that you can save and use in balance definitions and reports, select **Track Usage**.

- The operator lets you combine multiple conditions to further filtered the time entries to include in the category. Use an AND operator to include entries only if they meet both conditions. Use an OR operator to include entries if they meet either condition.

Compound and Grouped Conditions in Time Categories

You can use parentheses and operators to create compound and grouped conditions in time categories.

- Connect two or more conditions using the logical AND or OR operations to create a compound condition.
- Group two or more conditions inside parentheses to form a separate statement, or group, within a compound condition.
- Group a condition within another grouped condition.

For example, you create a time category that includes a compound condition with these components and values:

Component	Value
Single condition	(Payroll Time Type = Regular)
Logical operator	AND
Grouped condition	(Expenditure Type = Overtime OR Expenditure Type = Billable)

The time category includes all the time entries that match the first condition and either of the two grouped conditions.

How You Ungroup a Time Category Condition

Select any one of the conditions in that group and click the **Remove Parentheses** icon to ungroup all the conditions. You can then regroup conditions as appropriate.

How You Embed an Existing Time Category in a New Category

Use the **Embed Time Category** icon to insert the condition of an existing time category. The embedded category appears in read-only format, along with its time attributes and attribute values.

Create a Units-Based Time Category for Meals Taken

You plan to use meal-related time entries in rules that calculate meal allowances and in reports. So you create this time category to identify the Payroll Time Type time attribute value Meals Taken US.

You use the Time Categories task in the Setup and Maintenance work area. The task is part of the Workforce Deployment Offering, Time and Labor functional area.

2. On the Create Time Category page, complete the fields, as shown here:

Create Time Categories for Overtime Calculations

You need to include certain payroll time in overtime calculation rules to be compliant with statutory rules. You need to use these same entries, plus another entry in overtime calculation rules to be compliant with a union contract.

You create two time categories that identify the appropriate entries. Use the Time Categories task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

1. Create the Statutory Time for US OT category to identify time entries with these payroll values: Regular US, Training US, and Travel US.
 - a. On the Time Categories page, click the **Create** icon.
 - b. On the Create Time Category page, complete the fields, as shown here:

 - g. On the Confirmation dialog box, click **OK**.
2. Create the Union Time for OT category to identify time entries with those same payroll values, and Jury Duty US. This category embeds and builds on the Statutory Time for US OT category.

How Time Categories Work in Time Layouts

Provide relevant hours-based and units-based totals on time entry, review, view, approval notification, and responsive UI layouts. Do this by adding time categories on the Time Totals tabs. On the responsive UI layout, you add them on the initial section.

For example, you've a group of people who want to see these totals on each of their time cards:

- Reported Regular hours
- Calculated Overtime hours, if any
- Reported On Call Allowance units

You can change the name that people see for each category on the layout to names that are meaningful to them. For example, on one layout, calculated overtime is Overtime. On another layout, it's Premium Time.

How Time Categories Work in a Time Attestation Set

You need to select a time category for each questionnaire you add to a time attestation set. The category identifies the web clock events or time card entries that the questionnaire applies to.

Example

You create an advanced time category rule to identify when people have payroll time events or entries when they're not scheduled to work. You then create the Entry When Not Scheduled time category and link the advanced time category rule to it. In a time attestation set, you've a questionnaire about overtime attestation. You link the Entry When Not Scheduled time category to that questionnaire. Depending on the display level you select in the set, the questionnaire appears when someone reports time that matches the time category conditions.

How Time Categories Work in a Time Consumer Set

You need to select a time category for each time consumer that you select in a time consumer set. Here's what the time category identifies:

- Which time entries the validation rules of the time consumer apply to

- Which time entries make up the time data transferred to the time consumer.

Typically, you use the delivered All Project Entries and All Payroll Entries time categories with these respect time consumers: Project Costing and Payroll. The All Payroll Entries time category includes both hours-based and units-based time data.

How Time Categories Work in a Time Allocation

You need to select a time category for every source that you include in a time allocation. The time category identifies which time entries the time calculation rule with the allocation uses to calculate the corresponding allocation outputs.

For example, allocate all time entries with a payroll attribute value of Regular as follows:

- 25 percent to department 1001
- 35 percent to department 1002
- 40 percent to department 1003

You can use only hours-based time categories in time allocations.

How Time Categories Work in a Time Rules

When you create time rules, you select the time category that identifies which time entries to use in validations, calculations, and submissions. Here are examples of what the time category identifies:

- The end and start entries to compare with the defined rest period
- The entries to compare with the person's total scheduled hours
- The entries to allocate across the specified cost segments
- The entries to use when dividing reported daily or period time by the specified threshold value to calculate regular and overtime hours
- The entries that cause the rule that automatically saves or submits the time card to run

How Time Categories Work in a Time Rule Set

When you create a time rule set, you can optionally select a time category for one, multiple, or all time rule set members. You want to add time categories at this level only when the category criteria apply to the entire time card.

For example, you set the Statutory Time for OT time category on the rule set member.

- Time cards that contain entries for only Regular US, Training US, and Travel US cause this rule set member to run.
- Time cards with different, or more entries don't cause this rule set member to run.

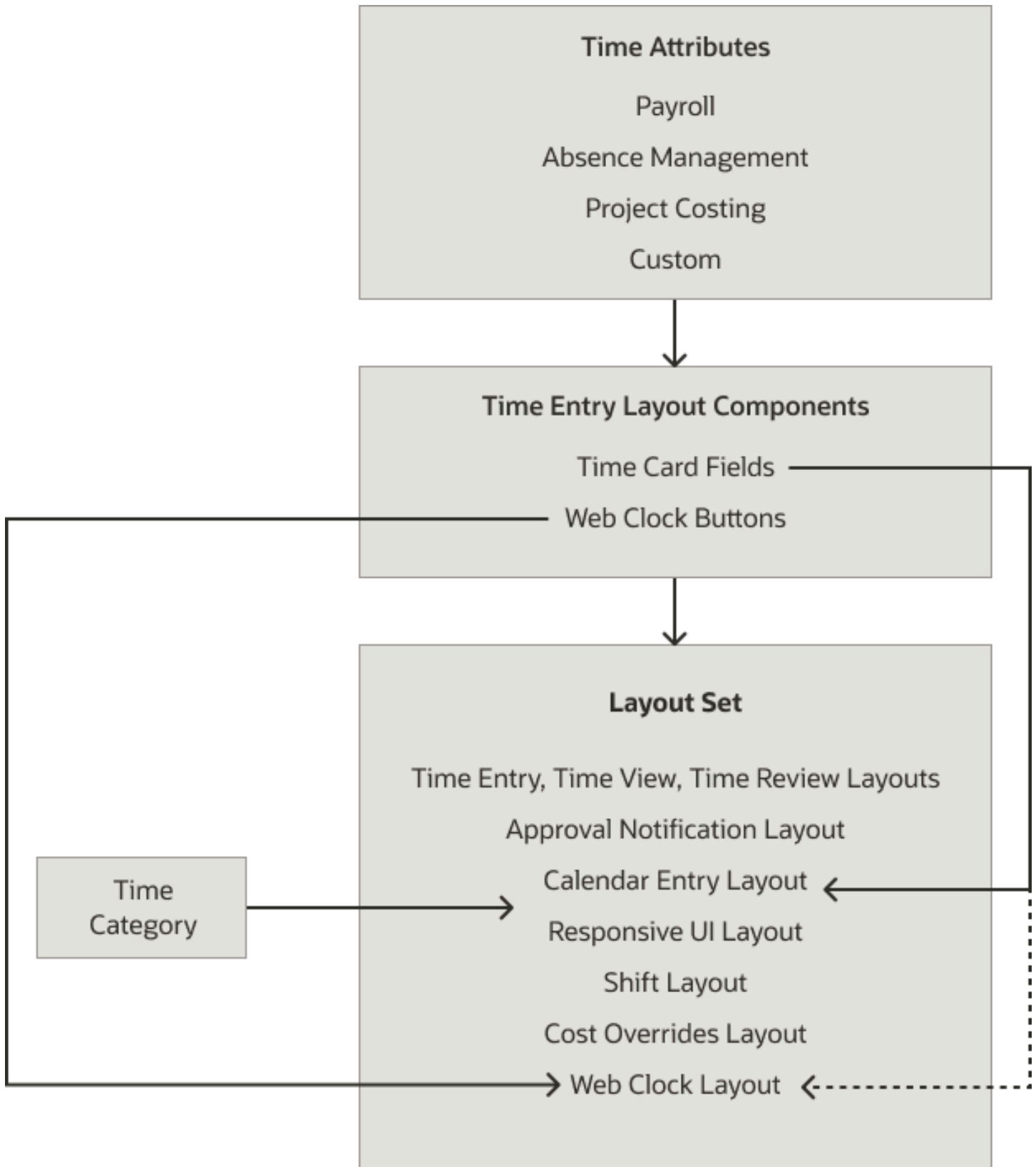

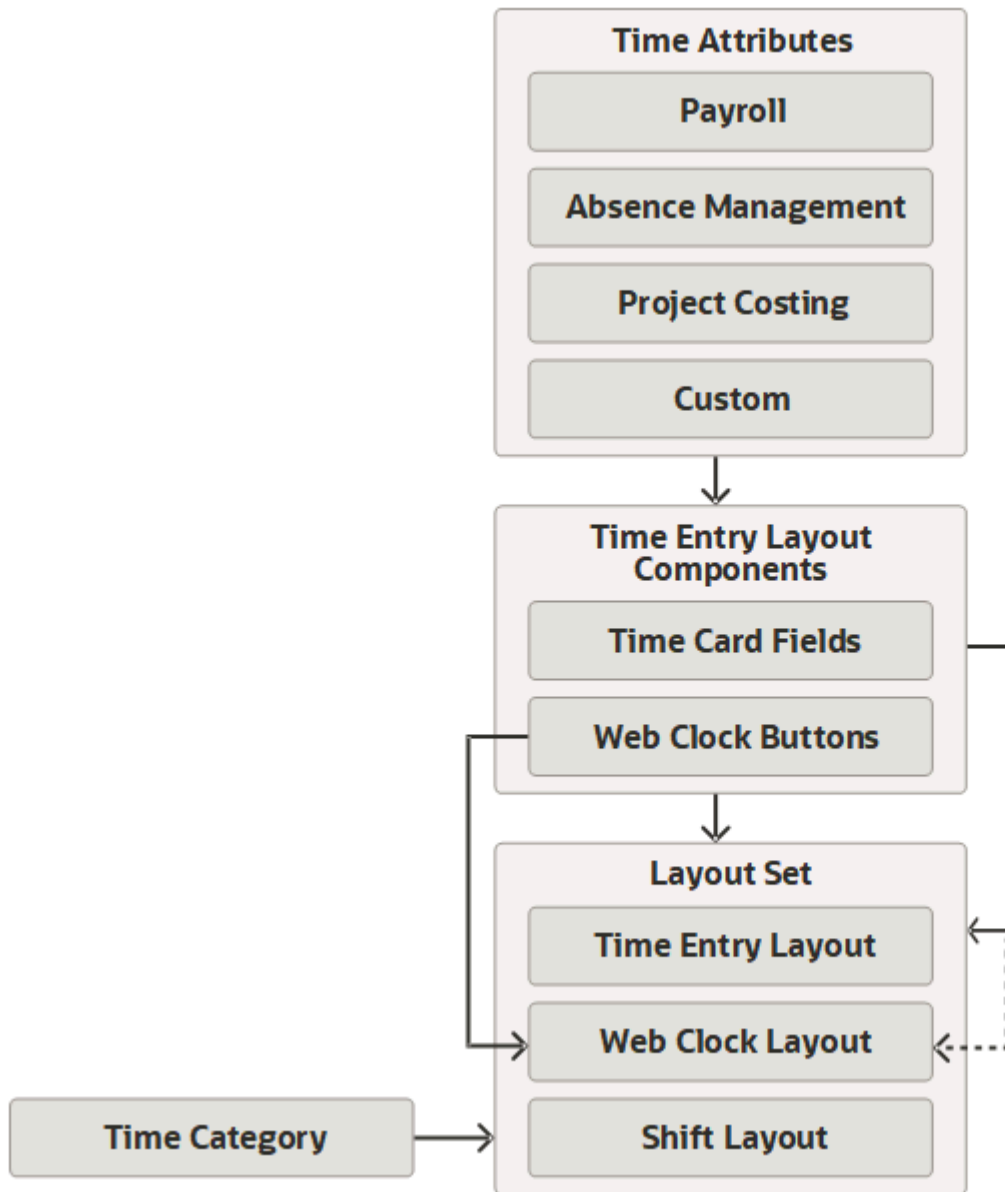

The Projects and Payroll Layout Set includes absence fields to record and store absence data for transfer to the Project Execution Management time consumer.

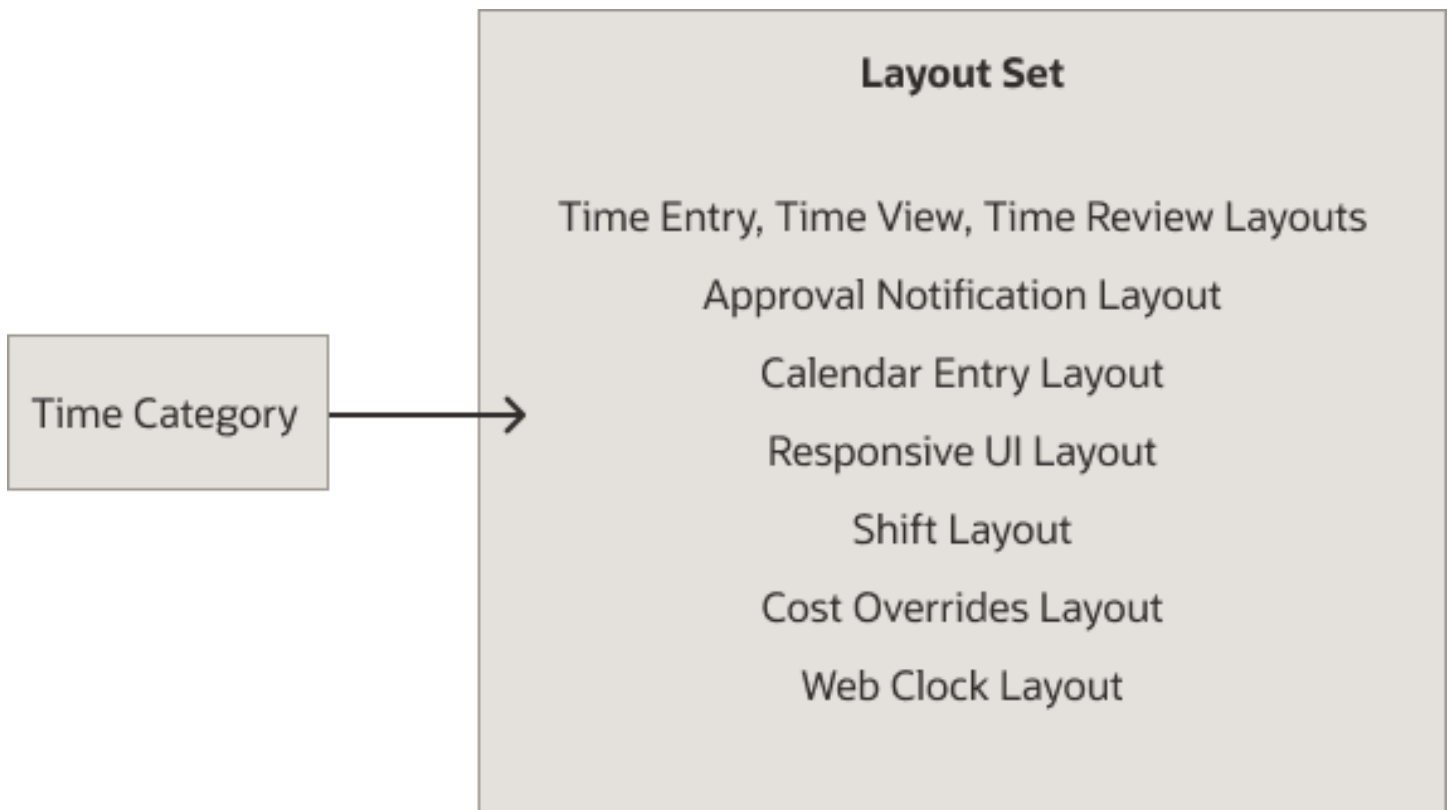

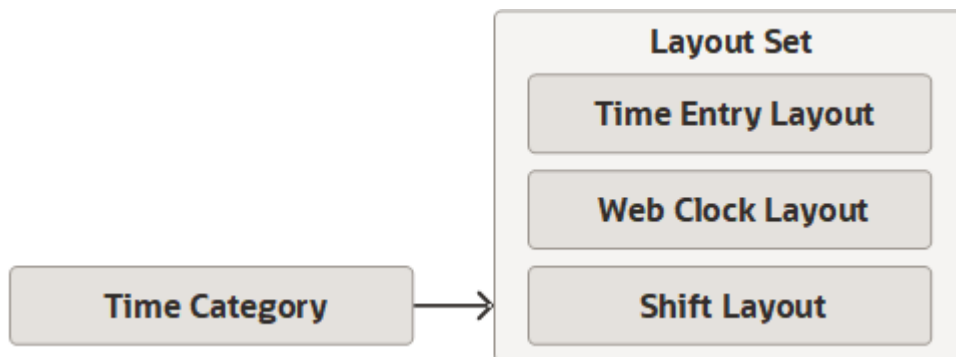

Time Entry, View, Review, Approval Notification, and Calendar Entry Layouts

The worker versions of these classic, nonunified layouts are essential layouts and all layout sets automatically include them unless the HWM_WORKER_RESPONSIVE_PAGES_ENABLED profile option is enabled. If it's enabled, here's what happens:

- Only time and labor managers can see the time entry, review, view, and approval notification layouts. Individuals see the responsive UI layout.
- The generated layout set doesn't include the calendar entry layout.

Both nonunified classic and responsive layouts can include unified time card fields.

When you save your configurations to the time entry layout, you've the opportunity to apply your edits to all related layouts. You can then edit the other layouts to refine their configurations as appropriate for your policies.

Note: People can't submit monthly time cards created with these layouts. Managers can generate monthly time cards with these layouts and the generate time cards process. And, they can approve these monthly time cards. But, they can't open these monthly time cards to see the details.

Manager Time Layouts

Manager versions are available for all classic and responsive nonunified time layouts except the calendar entry and web clock layouts. The manager versions are optional and included in layout sets only when you select the **Manager layout**.

When you don't select the **Manager layout** option, managers get the worker layout configurations. When you do include the manager versions of the layouts, they automatically inherit your worker configurations. You can optionally make more edits to manager versions that individuals don't see, or see as read-only.

Responsive UI Layout for Time Cards

The nonunified responsive UI layout merges time entry, review, and view layouts. It's an optional layout that's included in layout sets only when you select the **Responsive UI** layout.

- Individuals see responsive time cards only after the HWM_WORKER_RESPONSIVE_PAGES_ENABLED profile option is enabled.
- Line managers see the responsive time cards for their teams only after the HWM_MANAGER_RESPONSIVE_PAGES_ENABLED profile option is enabled.
- Time and Labor managers see the responsive time cards for their client groups only after the HWM_TIME_AND_LABOR_MANAGER_RESPONSIVE_PAGES_ENABLED profile option is enabled.

This layout can include unified time card fields.

Note: People can create and submit monthly time cards with this layout. And, managers can open the monthly time cards to review details.

Cost Overrides Layout for Time Cards

The nonunified cost overrides layout lets people override the cost segment for any time card field with a payroll value with cost override enabled. For example, let people override the cost for Regular payroll entries but not Sick absence entries.

Shift Layout for WFM Schedules

The time entry, review, view, and approval notification layouts are essential layouts and all classic and Redwood nonunified layout sets automatically include them. They include the calendar entry layout only when you don't select the **Responsive UI** layout.

Configure these layouts using the Layout Sets task in the Time Management work area.

Time Card Fields

You can replace the default fields and add more nonunified and unified fields that you want to appear on the time card. Also change display names. If you want the complete names to appear, limit them to 70 characters or less. The display names appear here:

- On existing time card pages in the Time work area
- On the Report Time dialog box opened from the Time work area calendar
- On team time card pages in the Time Management work area
- As column headers in the time entry and calculated time tables

The sequence of the fields is important for data filter dependencies. For example, your layout includes location fields. You need to select a state before you can select a county. And, you need to select the county before you select a city. To set field sequence for classic layouts, you need to use Personalization. Otherwise, classic time card pages ignore field positions in the time card matrix table. To set field sequence for Redwood layouts, you need to enable the unified time entry experience.

You can select the fields that together uniquely identify time entries on dialog boxes for change audit. People open these dialog boxes from classic time cards and see these fields and their values for each changed time entry.

On the time review layout, you can also whether to display the owner and entry source as column headers on time review pages.

Time Entry Properties

Here are the time entry properties that you can configure. The specific properties vary by the layout that you're editing and apply to the pages and dialog boxes that the layout defines.

- Enable the entry of negative time and time spanning midnight.
- Display the unit of measure column and the option to highlight overtime periods.
- Specify the time entry and date formats, and the precision of time display using decimal places.

Here are more edits that you can make to the classic, nonunified time entry, review, view, and approval notification layouts. On the Edit Layout dialog box, click **Next** to move from one page of the guided process to the next.

Row-Level Details

You can add nonunified and unified fields that you want people to see in a separate, row-level dialog box. They open this dialog box from the time entry, review, view, and approval notification pages. For example, you configure the Additional Attributes dialog box to include the dependent Department field whenever someone selects **Premium** in the Time Entries table.

You can change the display names so that they're meaningful to the people who use the layout. If you want people to see the whole name, limit each name to 70 characters or less.

Comments

Specify whether the time card pages should include the Comments column. Further specify if the column should be in the Time Entry and Calculated Time tables or on the entry-level details dialog box.

Entry-Level Details

Add nonunified and unified fields that you want people to see in a separate, entry-level dialog box. They open this dialog box from the time entry, review, view, and approval notification pages. You can change the display names so that they're meaningful to the people who use the layout. If you want people to see the whole name, limit each name to 70 characters or less.

On the time review layout, you can also specify whether to display the owner and source columns. This information can be useful to who report time with multiple methods, such as badge reader, Web Clock, and time card. It can also be useful to managers who review time cards with time entries from various owners and sources.

- Examples of time entry owners are WFM or Web Clock.
- Examples of internal sources are Manager entry, Absence entry, or Calculated entry.

On both Hours and Units pages, you can also make the category display names more meaningful to the people who use the time cards. And, you can configure time entry properties.

Unified Time Entry Layout Configuration

The unified time entry layout is essential and all unified layout sets automatically includes it. You configure this layout using a three-step guided process and the Layout Sets task in the Time Management work area.

Layout Properties

Here are the layout properties that you can configure. They apply to the pages and dialog boxes that the layout defines.

- Specify the time entry and date formats, and the precision of time display using decimal places.
- Specify the default view for responsive time cards
- Enable the entry of negative time and time spanning midnight.
- Display the unit of measure column.
- Enable editing of time and durations with time change requests, and enable comments.

Time Card Fields

You can replace the default fields and add more nonunified and unified fields that you want to appear on the time card. By default any fields that you add apply to both reported and calculated time. Also change display names. And dependent time card fields continue to work in unified layouts that include the corresponding independent layout component.

If you want the complete names to appear, limit them to 70 characters or less. The display names appear here:

- On existing time card pages in the Time work area
- On the Report Time dialog box opened from the Time work area calendar
- On team time card pages in the Time Management work area
- As column headers in the time entry and calculated time tables

The display sequence of the fields is important for data filter dependencies and processing. For example, your layout includes location fields. You need to select a state before you can select a county. And, you need to select the county before you select a city.

You can select the fields that together uniquely identify time entries on responsive time cards and on dialog boxes for change audit. People open these dialog boxes from classic time cards and see these fields and their values for each changed time entry. Or you can include them in the Addition Attributes of responsive and enhanced time cards. You can also specify where the time card fields appear on classic time cards, such as the main time card matrix, or row-level or entry-level details.

The Users column shows you the roles that can see the field on time cards. The Exclude option is set as part of the time card field configuration. You can't override it while configuring the layout.

You can use the **Actions > View By > Users** or **Locations** options to filter the fields that you see while configuring the time entry layout. The filter doesn't affect the actual time cards.

Time Totals

You can add time categories measured in hours and units and specify where they appear on classic, responsive, and enhanced time cards. You can also make the category display names more meaningful to the people who use the time cards.

The delivered hourly totals will always appear before all other time categories that you add. All unit totals will appear in the order that you specify.

Considerations for Selecting the Time Entry Format

Specify whether people enter time as number of hours, start and stop times, or both when you configure time layouts. You need to include the correct formats in the layouts to ensure the accuracy of reported and calculated time.

You configure the layouts using the Layout Sets task in the Time Management work area. You specify the time entry format on the Edit Layout dialog box, in the Time Entry Properties section.

Time Entry Formats

Here are the available time entry formats.

Time Entry Format	Appearance on Time Card for Each Day	Time Entry by Time Reporters
Display hours only	One column, labeled Hours	Enter the number of hours.
Display start and stop time	Two columns, labeled Start and Stop	Enter clock times.
Display hours and times	Three columns, labeled Start, Stop, and Hours	Enter either the number of hours or clock times for each time card row. Entering both times and hours in a single time card row results in an error message.

Time Entry Format for Calculated Time

For the classic, nonunified time review, view, and approval notification layouts, you need to configure two sections:

- Reported Time
- Calculated Time

If your time entry layout includes Start and Stop columns, your Calculated Time sections need to use the time entry format Display hours and times. Calculated time always displays totals as a number measured in hours, in the summary row.

Absence and Payroll Time Entry Format

Absence entries resolve according to the person's schedule. Select the time entry format supported for the schedule type applicable to people who use the layout set. Here are the different schedule types with the correct formats for each.

Schedule Type	Time Entry on the Time Card	Time Entry Format to Select on the Layout
Work Schedule	Absence start and end times	Either Display start and end time or Display hours and times
Elapsed or Duration Schedule	Number of absence hours	Either Display hours only or Display hours and time

How You Let People Submit Time Cards Containing 0 Hours Entries

Make sure that the time entry format is Display hours and time.

- To edit the time entry format, use the Layout Set task.
- To link the layout set to relevant profiles, use the Worker Time Entry Profiles task.

Both tasks are in the Time Management work area.

Create a Nonunified Payroll Layout Set That Includes Absence and Override Fields

You want to configure how people report, change, submit, and approve payroll and absence time. You also want to let managers include time attributes as part of shift details.

Before you start

Before you create the layout set, you need to complete these tasks:

1. Create the Meals Taken element and calculation components. Use the Elements task in the Elements and Formula functional area.
2. Generate the absence management and payroll time attributes in the data dictionary. Use the Generate Data Dictionary Time Attributes task.
3. Create the AbsencePayrollTime multiattribute field with the dependent meal, department, state, county, and city fields. Use the Time Entry Layout Components task.
4. Create the Statutory Time for OT, Overtime, and Meals Taken US time categories. Use the Time Categories task.

The tasks are in the Setup and Maintenance work area, Workforce Deployment offering. They're part of Time and Labor functional area unless otherwise specified. The examples in the Related Links section at the end of this topic tell you how to create the element and dependent fields.

Here's what to do

1. Create the Absence and Payroll layout set.
 - a. In the Time Management work area, on the Tasks panel tab, click **Layout Sets**.

- b. On the Layout Sets page toolbar, click the **Create** icon.
- c. On the Generate Layout Set page, select **Responsive UI, Manager, Shift, and Payroll**.
- d. Make sure that **Project Costing** isn't selected.
- e. Click **Generate Layout Set**.
- f. On the Define Layout Set page, in the Name field, enter **Payroll and Absences**.
- g. In the Description field, enter **Includes the row-level department field for the time entry, review, view, and approval layouts. Includes entry-level location fields for the time entry, review, view, and approval layouts and meals rates on the manager layouts. Includes time and hours sliders on the calendar layout and location fields for the shift layout.**
- h. Click **Save**.

2. Configure the time entry layout for workers.

- a. On the Define Layout Set page, in the Time Entry Layout row, click **Configure Layout**.
- b. On the Configure Time Entry Layout page, click the Worker tab.

Tip: Edit the worker layout first so that the manager layout inherits the edits, which you can then revise as required. The worker layout doesn't inherit any manager layout edits.

- c. In the Time Entry section, click **Edit Layout**.
- d. On the Edit Layout dialog box, Time Card Matrix page, make these edits:
 - i. Replace the Payroll Time Type field with AbsencePayrollTime.
 - ii. In the Time Entry Properties section, select these options: **Enable time to span midnight** and **Display unit of measure**.
 - iii. Make sure that the time entry format is **Display hours and time** because it best supports the reporting of both absence and payroll time.
 - iv. In the Date Format field, select **Mon,Jan 01**.
 - v. Click **Next**.
- e. On the Row Level Details page, make these edits:
 - i. Add the Department field.
 - ii. Change the Label on the Time Card value to **Department Details**.
 - iii. Click **Next**.
- f. On the Comments page, make these edits:
 - i. Make sure that **Comments column in the time card** is selected.
 - ii. Change the Label on the Time Card value to **Row-Level Comments**.
 - iii. Click **Next**.
- g. On the Entry Level Details page, make these edits:
 - i. Add these fields in the order listed: Default Payroll Rate, State, County, and City. The location fields need to go from broadest geographic area to narrowest for time attribute filters to work.
 - ii. Change the Label on the Time Card value to **Daily Pay Details**.
 - iii. In the Date Format field, select **Mon,Jan 01**.
 - iv. Click **Save and Close**.
 - v. On the Warning message asking if you want to copy your edits to the other layouts in the set, click **Yes**.

Tip: Only edits to the fields in the time card matrix and time entry properties copy to the calendar entry and shift layouts. Edits on the row-level and entry-level pages don't copy. To include these edits on the time review, view, and approval notification layouts, repeat the edits on the relevant Reported Time and Calculated Time sections.

 - vi. On the Confirmation message, click **OK**.
- h. On the Configure Time Entry Layout page, click the Time Totals tab.
 - i. In the Time Totals section, click **Edit Layout**.
- j. On the Edit Layout dialog box, make these edits:
 - i. On the Hours page, add these time categories: Statutory Time for OT and Overtime.
 - ii. In the Date Format field, select **Mon,Jan 01**.
 - iii. On the Units page, add the Meals Taken US time category.

- iv. In the Date Format field, select **Mon,Jan 01**.
 - v. Click **Save and Close**.
 - vi. On the Warning message asking if you want to copy your edits to the other layouts in the set, click **Yes**.
 - vii. On the Confirmation message, click **OK**.
3. Configure the time entry layout for managers.
 - a. On the Configure Time Entry Layout page, click the Manager tab.
 - b. In the Time Entry section, click **Edit Layout**.
 - c. On the Edit Layout dialog box, Entry Level Details page, make these edits.
 - i. Add the Meal Override Rate field.
 - ii. Select the **Worker layout read only** display option.
 - iii. Add the hidden Meal Rate Periodicity field.
 - iv. Click **Save and Close**.
 - v. On the Warning message asking if you want to copy your edits to the other layouts in the set, click **Yes**.
 - vi. On the Confirmation message, click **OK**.
4. Configure the calendar entry layout for workers.
 - a. On the Configure Time Review Layout page header, in the layout drop-down list, select **Calendar Entry Layout**.
 - b. On the Configure Calendar Entry Layout page, Worker tab, click **Edit Layout**.
 - c. On the Edit Layout dialog box, select these options: **Display hours slider** and **Display time slider**.
 - d. Click **Save and Close**.
5. Configure the shift layout.
 - a. On the Configure Calendar Entry Layout page header, in the layout drop-down list, select **Shift Layout**.
 - b. On the Configure Shift Layout page, Worker tab, click **Edit Layout**.
 - c. On the Edit Layout dialog box, add these time card fields, in the order listed: State, County, and City. The location fields need to go from broadest geographic area to narrowest for time attribute filters to work.
 - d. Click **Save and Close**.
 - e. On the Configure Shift Layout page, click **Save and Close**.
 - f. On the Edit Layout Set: Absence and Payroll page, click **Save and Close**.
 - g. On the Confirmation message, click **OK**.
 - h. On the Layout Sets page, click **Done**.

23 Responsive UI, Cost Overrides, Web Clock, and Shift Layouts

Top Section Configuration of the Responsive UI Layout

You can affect what people see when they show details at the top of the nonunified responsive time card page. Make these changes when you edit the top section of the responsive UI layout.

- Specify whether to show the person's start time from their assigned work day definition, if they've a definition.
 - Show only the delivered time totals that are appropriate for the people using this layout. And add more time categories to provide relevant totals for reported and calculated time.
- Tip:** The Scheduled Hours total comes from the individual's current schedule or work hours.
- Optionally change the display name and time entry properties. You can include the unit of measure in display names, as appropriate.

Entries Section Configuration of the Responsive UI Layout

You can configure the default view, time card fields, and time entry properties for individuals and managers. Do this by editing the Entries section of the nonunified responsive UI layout.

Default View

When individuals open a responsive time card page, by default they see the Reported Time detailed view by entry date. When managers open a responsive time card, by default they see the Reported Time summary view by entry date. In the Entries section, you can change these default views, for example, so managers start by seeing the calculated times.

Tip: The Add button appears on only the Reported Time view.

Time Card Fields

On the Reported Time and Calculated Time tabs of the layout, you can replace the default fields on the responsive time card. You can add more nonunified and unified fields that you want to appear. And you can change display names. If you want the complete names to appear, limit them to 70 characters or less.

You can also identify which fields to use to uniquely identify time entries tracked as part of change audits. You can identify the fields to show in the additional attributes area of completed entries, instead of in the main area. And, you can identify the fields that people can edit when they create change requests.

Note: People need to edit absences using the Existing Absences task instead of the Request Change task. So, the Edit with Change Request option is unavailable for fields with absence time attributes.

If the layout set also includes the Cost overrides layout, be sure to include the multiattribute fields with cost override enabled for appropriate payroll values. Include the fields on the Reported Time tab so that you can configure the dependent cost segments on the Cost overrides layout. Include the fields on the Calculated Time tab so that people can see how calculations applied the cost overrides to calculated time entries. You can't add the cost segments themselves to the Reported Time tab. You can add them on Calculated Time tab of the same layout or in the Cost overrides layout.

Optionally, display the entry owner and internal source. This information can be useful to people who report time with multiple methods, such as badge reader, Web Clock, and time card. It can also be useful to managers who review time cards with time entries from various owners and sources. Examples of time entry owners are WFM or Web Clock. Examples of internal sources are Manager entry, Absence entry, or Calculated entry. You can also change display names. If you want the complete names to appear, limit them to 70 characters or less.

Effect on the Responsive Time Card Page

Here's what the fields and properties you configured do:

- Form the entries on the Reported Time and Calculated Time tabs
- Group time entries in summary views
- Identify the owner and source of individual or grouped time entries
- Appear in the expandable Additional Attributes entry area
- Comments appear as part of responsive Time Card page entries and expanded Additional Attributes area.

Cost Overrides Layout Configuration

You can configure the dependent cost override fields that appear on the nonunified cost override page that opens from a responsive time card entry. You can also configure time entry properties.

Add the dependent cost override fields that are linked to payroll values for the multiattribute fields you added to the responsive UI layout. Optionally, you can change the display names. If you want the complete names to appear, limit them to 70 characters or less.

The sequence of the fields is important for data filter dependencies. For example, your layout includes department and fund fields. And people need to select the department to see the corresponding funds.

Optionally, you can set the time entry format, decimal precision, and date format.

Web Clock Layout Configuration

You can optionally let individuals report time and view daily time events using Web Clock. You configure the nonunified and unified web clock layout using the **Layout Sets** task in the Time Management work area.

Web Clock Layout Configuration

You can edit the layout to make these configuration changes.

Configuration Options	Usage Description
Hide or show seconds on the clock	The digital clock appears on the web clock page with or without seconds showing.
Enable the button logic rule	Individuals either can or can't click earlier buttons after they click a button later in the sequence.
Restart sequence after last button	Either make all the buttons available again after the person clicks the last button in the sequence, or keep the buttons unavailable.
Allow manual entry of missing In event	Individuals either have or don't have the option to manually enter the missing In event when they're clocking out.
Enable viewing of daily time events	Individuals either can or can't see the corresponding time events in the Daily Time Events section after they click a button. When enabled, they can see the events for the current day and day-by-day for up to 7 previous days.
Specify whether to use device or server time	When individuals' layouts configurations use device time, validate whether the device time is within the allowable difference with server time. If it isn't, then the time event uses server time and saves the device time as additional event information.
Enable editing of clock time with change request	Instead of letting individuals edit their time cards directly, let them request changes to their time and corresponding attributes.

Buttons

You add the buttons that you want to include on the Web Clock page and optionally select an icon for each button. You can also change the display label. If you want all the label text to show, limit the labels to 70 characters or less.

Individuals see these button labels and icons on their Web Clock. The device that they use to open Web Clock dynamically identifies how many buttons they see per row. For example, if they open Web Clock on their smartphones, they probably see one button per row in portrait mode. If they use a tablet in landscape mode, they might see three or four buttons.

Time Card Fields

Optionally, you can add any nonunified and unified time card fields that individuals need to complete. And again, you can change the display names. If you want all the names to show, limit them to 70 characters or less.

CAUTION: When the selected web clock buttons and fields have the same time attributes, the time repository stores the field value and ignores the button value.

The sequence of the fields is important for data filter dependencies. For example, your layout includes location fields. You need to select a state before you can select a county. And, you need to select the county before you select a city.

Individuals see these fields on their Web Clock, in addition to the buttons. They and their managers also see these fields on the corresponding pages of the time cards generated from the clock events.

If individuals submit change requests instead of directly editing the corresponding time card, you also identify the fields where they can change the values. Individuals can edit their time data for the enabled fields when they open the Request Change page from Web Clock.

Shift Layout Configuration

Optionally include time attributes on people's shifts by adding nonunified and unified time card fields to the shift layout. For example, include the Department and Payroll Time Type attribute values for the shifts that use this layout.

You can also change the display labels. If you want all the names to show, limit them to 70 characters or less. Use the Layout Sets task in the Time Management work area.

The sequence of the fields is important for data filter dependencies. For example, your layout includes location fields. Managers need to select a state before they can select a county. And, they need to select the county before they select a city.

Managers can enter values for these fields when they create shifts in the Time Management work area. Individuals see the values that their managers entered when they view shift details for their team schedule in the Time work area.

 - ii. In the Assignment Number and AbsencePayrollTime rows, select **Time Entry Identifier**.
 - iii. Add the Meal Rate Department field and select **Show in Additional Attribute**.
 - iv. Add these location fields in the order listed: Default Payroll Rate, State, County, and City. The location fields need to go from broadest geographic area to narrowest for time attribute filters to work.
 - v. In all the location rows, select **Show in Additional Attribute**.
 - d. In the Time Entry Properties section, make these edits:
 - i. Select these options: **Enable time to span midnight** and **Display unit of measure**.
 - ii. Ensure that the time entry format is **Display hours and time** because it best supports the reporting of both absence and payroll time.
 - e. In the Other fields section, make these edits:
 - i. In the Owner and Internal Source rows, select **Display** and **Show in Additional Attribute**.
 - ii. In the Comments row, select **Display** and **Show In Detail List View**.
 - f. Click **Save and Close**.
 - g. On the Warning message asking if you want to copy your edits to the calculated time tab, click **Yes**.
 - 4. Configure the responsive UI layout for managers.
 - a. On the Configure Responsive UI Layout page, click the Manager tab.
 - b. In the top section, click **Edit Layout**.
 - i. In the Overtime Day Start Time section, select **Show**.
 - ii. Click **Save and Close**.
 - c. In the Entries section, click **Edit Layout**.
 - d. On the Edit Layout dialog box, in the Default View section, select **Calculated summary by entry date**.
 - e. In the Time Card Fields section, make these edits:
 - i. Add the Meal Override Rate field.
 - ii. On the Configure Time Card Field Display Option dialog box, select **Worker layout read only**.
 - iii. Click **OK**.
 - iv. On the Edit Layout dialog box, add the hidden Meal Rate Periodicity field.
 - v. On the Configure Time Card Field Display Option dialog box, click **Cancel**.
 - vi. Click **Save and Close**.
 - vii. On the Warning message asking if you want to copy your edits to the calculated time tab, click **Yes**.

5. Configure the shift layout.

- a. On the Configure Responsive UI Layout page header, in the layout drop-down list, select **Shift Layout**.
- b. On the Configure Shift Layout page, Worker tab, click **Edit Layout**.
- c. On the Edit Layout dialog box, add these time card fields, in the order listed: State, County, and City. The location fields need to go from broadest geographic area to narrowest for time attribute filters to work.
- d. Click **Save and Close**.
- e. On the Edit Layout Set: Responsive Absence and Payroll page, click **Save and Close**.
- f. On the Confirmation message, click **OK**.
- g. On the Layout Sets page, click **Done**.

24 Offline Web Clock Configuration

Overview of Configuring Web Clock for Offline Use

You can optionally configure Web Clock to also work offline after you configure it to work online. For example, you've people who work remotely, so you set them up to report their time using Web Clock on their mobile devices.

They aren't always able to connect to the server when it's time for them to clock in or out. So you also let them use Web Clock when they're offline. Their devices store their time data locally until they connect to the internet again. Then, the local data gets synced to the time repository and processed accordingly.

Configure Web Clock for Offline Use

Here's how you can extend your online Web Clock configuration so people can also use it offline.

1. Add these 2 privileges to the Employee role or your corresponding custom role for the relevant people:
 - HXT_REST_SERVICE_ACCESS_TIME_LAYOUT_SETS_RO_PRIV
 - HXT_REST_SERVICE_ACCESS_WEB_CLOCK_EVENTS_PRIV
2. Make sure that the HCM_MOBILE_ENABLE_OFFLINE_WEB_CLOCK profile option code has all its profile values set to Yes. The delivered profile value is **Site**.
3. Have people install the Oracle HCM Cloud app on their mobile device from either the Goggle Play Store or the Apple Apps Store.
4. Make sure that everyone who will use Web Clock offline use it first on their device while they're online and connected to the server. Starting online makes sure that each device successfully completes the initial data sync and can complete future syncs.

People see appropriate notifications on their online Web Clocks when the sync finishes. They can then use Web Clock online and offline to report their time. When they're online, any stored offline time data automatically syncs to the time repository for time processing.

Functionality Differences Between Online and Offline Web Clock

Some functionality acts differently depending on whether Web Clock is online or offline.

Elapsed Time Counter

The counter for time elapsed since the most recent button tap is accurate when Web Clock is online. The counter isn't accurate when offline. People who are offline can't use the elapsed time to make sure they're complying with regulations. For example, they can't tell if they rested for the required periods between work periods.

Button Logic

Enabled button logic applies only when Web Clock is online. This means that when people are online the earlier buttons they tapped are now unavailable. When they're offline, the buttons are still available. People can inadvertently tap the same button multiple times during a day, which can cause time entry errors. People need to fix these errors before submitting the corresponding time card. You can use time entry profiles to identify if individuals, their managers, or both can correct the errors.

Time to Use for Clock Events

If the layout has server time enabled, it applies to only online clock events. When Web Clock is offline, the clock events always use device time. This difference in the time used might lead to time entry errors that people need to fix before they submit the corresponding time card.

More Fields

If the layout includes more fields for specific buttons, when Web Clock is online, people can see the fields. When Web Clock is offline, they can't. The corresponding time card might be incomplete or in error if people don't complete these more fields.

Data Sync Time

The time it takes to sync data between the device and the time repository is completely dependent on the device, network bandwidth, and connection stability. To keep time events on Web Clock current, people need to let the data sync completely when they're back online. Then they use Web Clock to report their latest time.

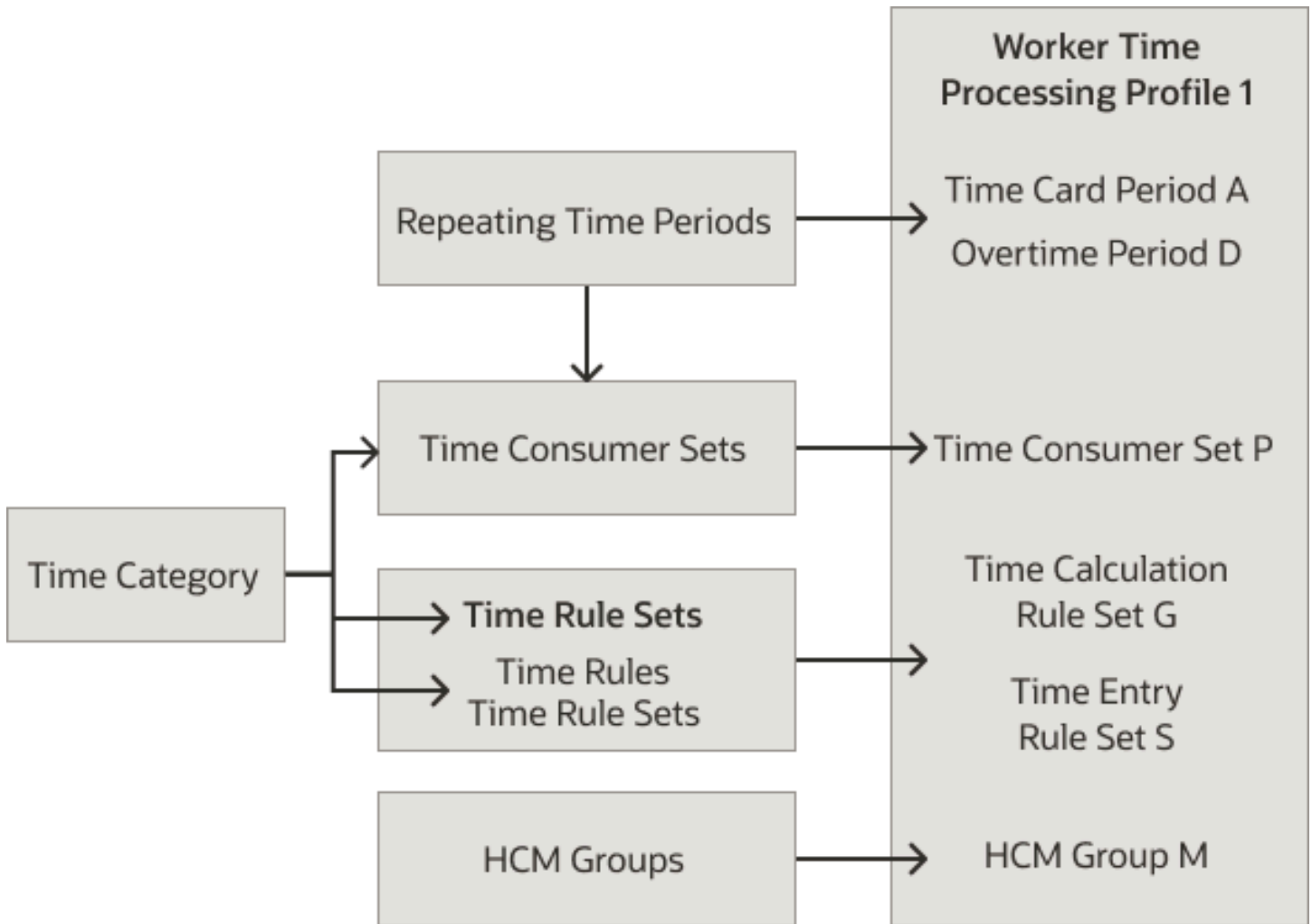
25 Time Processing Configurations

Best Practices for Creating Time Processing Objects

You need to create separate time processing profiles for each unique combination of the time processing objects, as shown in this diagram. To automatically add public holiday entries to time cards, you also need separate profiles for each LDG.

The more processing objects that you create, the greater the ongoing maintenance effort. You want to find a balance between optimizing the time processing experience for your employees and the effort required to maintain that experience.

Here's how the components of the time processing profile work together. The following sections provide some guidelines and considerations to help you decide how many time processing objects to create.



The number of time consumer sets that you need depends on the time consumers needed and the unique configurations of these options for each consumer:

- Validate on time card actions
- Time category
- Approval period

Time Consumer Sets and Time Card, Approval, and Overtime Periods

You need a separate time consumer set for each unique combination of time card, approval, and overtime periods. The approval periods of the time consumer set need to match the time card period of the time processing profile. Each time consumer requires a separate time processing profile.

Time Consumer Sets and Time Categories

What type of time--such as project costing, payroll, absence, or a combination--do your people report and how often? The type of time and the reporting frequency affect how you configure time categories and time consumer sets. Since

you can link only one time category to a time consumer, we recommend that you use these delivered categories: All Project Entries and All Payroll Entries. The delivered category All Payroll Entries includes both hours-based and units-based time entries.

The more time categories and time consumer sets that you create, the greater the maintenance effort. Another topic has scenarios and suggested configurations to help you assess how many of these objects you need.

Time Consumer Sets and Validate on Time Card Actions

Create one consumer set for each group of people with different settings for the time card actions that run validation for the same time consumer. Here are examples of how you might create different Payroll time consumers depending on the Validate on Time Card Action selection.

- **Save and Submit:** For people who report time every day of a time card period, or whose entries you want to report on during the week.
- **Submit only:** For people who create and submit time cards at the end of their week and for time and labor managers who correct time exceptions.

Time Categories and Time Allocations

Create as many time categories as you need to identify the time entries that you want to allocate to various cost segments.

Time Entry and Time Calculation Rule Sets

You can link only one time entry and one time calculation rule set to a time processing profile. But, you can add as many rules and rule sets to a rule set as appropriate for the people linked to the rule set. Use rule sets to link rules to groups of people who have similar requirements for vacation, time validation, and time processing.

The number of rule sets you need depends on the different ways that you validate reported time and calculate time. Here are some examples:

- You generate validation exceptions for a group of people when their total reported time exceeds 42 hours for the week. You generate validation exceptions for another group when their total reported time exceeds 10 hours a day.
- You pay people an overtime rate of 1.5 times their regular pay. For people working in California, the overtime rate applies every worked hour over 8 hours in a 24-hour period. For people working in Florida, the overtime rate applies for every hour worked over 40 hours in a 7-day period.

Change Audit and Public Holiday Settings

Create one profile for each group of people with different change audit settings. Also create one profile for each group of people who use the same payroll element to automatically create their public holiday entries. Typically, this means creating at least one profile for each LDG. For example, create one profile for people who use the Public Holiday US element. Create another profile for people who use the Public Holiday CAN element. You can have more than one profile per LDG, depending on how many unique settings you've for the other profile options.

HCM Groups

You link one or more HCM groups to each profile. Define separate groups wherever the characteristics are unique across profiles or groups of profiles. For example, you group people into separate groups for these reasons:

- One group has people who work in states that calculate overtime daily.
- Another group has people who work in states that calculate overtime weekly.

26 Repeating Time Periods

Repeating Time Periods

Many organizational tasks need continually generated time periods, such as a weekly period that starts every Sunday. You can't edit delivered periods. After saving your own periods, you can edit only the name and description.

You configure these periods using the Repeating Time Periods task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area. Saving the configuration generates periods for 10 years before and after the current date.

Period Usages

Here are descriptions of the repeating period usages. It also identifies the pages where the usage decides which configured repeating periods the period drop-down lists include.

Usage	Description	Page Where the Usage Filters Period Choices
Time cards	<p>How often people need to submit their time card.</p> <p>When you configure a time processing profile, you select a repeating time period as the time card period. All time card layouts support weekly and 2-week repeating periods. The responsive layout also supports a monthly repeating period.</p>	Worker Time Processing Profiles
Approvals	<p>The date range when approvers can approve a submitted time card, including monthly.</p> <p>When you configure a time consumer set, you select a repeating time period as the approval period.</p>	Time Consumer Sets
Accrual Processing	<p>The interval when people accrue time, such as every 2 weeks within an annual accrual term.</p> <p>Use these periods when you create absence plans.</p>	Manage Absence Plans

Examples of Generated Repeating Time Periods

You use repeating time periods with time cards, approvals, accrual processing, overtime, and balances. The combination of period usage, type and length, and sample start date decide the generated periods.

Create these periods using the Repeating Time Periods task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

These examples show you how the sample start date works with the period type and length to generate repeating periods within the preview period dates. The preview start dates let you review your repeating period configuration without generating the actual repeating time periods. The first preview period generated might or might match the sample start date. It depends on how you configured the preview period.

Weekly Period with a Biweekly Length

The sample start date is 05/01/12 and the preview period start and end dates are 01/01/12 and 05/31/12. The period generation logic generates periods every 14 days from the sample start date. All periods start on the same day of the week, for example:

- 01/10/12 to 01/23/12
- 01/24/12 to 02/06/12
- 02/07/12 to 02/20/12
- 02/21/12 to 03/05/12
- 03/06/12 to 03/19/12
- 03/20/12 to 04/02/12
- 04/03/12 to 04/16/12
- 04/17/12 to 04/30/12
- 05/01/12 to 05/14/12
- 05/15/12 to 05/28/12

Monthly Period with a Calendar Month Length

The sample start date is 05/04/12 and the preview period start and end dates are 01/01/12 and 07/31/12. The period generation logic generates periods from a specified day in 1 month up to that day in the following month, for example:

- 01/04/12 to 02/03/12
- 02/04/12 to 03/03/12
- 03/04/12 to 04/03/12
- 04/04/12 to 05/03/12
- 05/04/12 to 06/03/12
- 06/04/12 to 07/03/12

Semimonthly Period

The sample start date is 05/04/12 and the preview period start and end dates are 05/01/12 and 07/31/12. The period generation logic generates periods using a pattern:

- The first of the semimonthly periods starts on the numeric day of the pattern starting date and lasts for 15 days.
- The second period starts the day after the first period ends. It lasts through the day before the numeric day of the pattern starting date in the next month.

Here are examples:

- 05/05/12 to 05/18/12
- 05/19/12 to 06/03/12
- 06/04/12 to 06/18/12
- 06/19/12 to 07/03/12
- 07/04/12 to 07/18/12

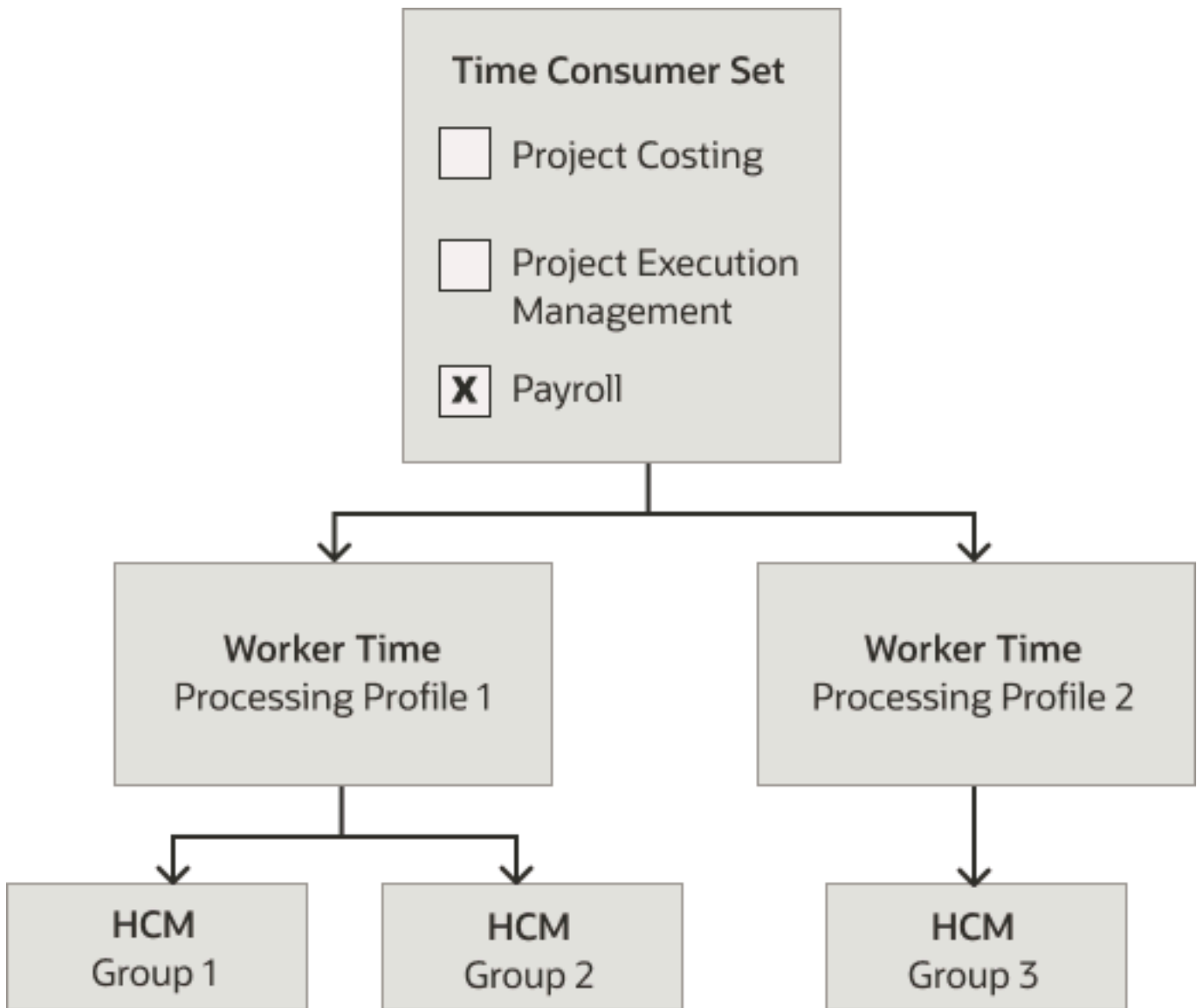
27 Time Consumer Validation, Approval, and Transfer

Time Consumer Sets

Typically, other applications use, or consume, your time data in their processes. These are the other Oracle Cloud products and offering that consume time data from Time and Labor:

- Global Payroll, to pay people
- Project Costing, to bill customers for time worked on projects
- Project Execution Management offering of Project Portfolio Management, to figure out staffing for projects

You identify the consumers that consume time data for specific groups of people using a time consumer set. The set is also how you configure the consumer validation rules, approval periods, and transfer rules that apply for the linked groups. Link a time consumer set with groups using time processing profiles, as shown here.



Tip: You can't edit any time consumer sets associated with a worker time processing profile. Also, after you save a new time consumer set, you can't include new time consumers in the set. And you can't exclude existing time consumers from it.

Considerations for Creating Time Consumer Sets

You create time consumer sets using the Time Consumer Set task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

Time Consumer

Start by selecting the relevant time data consumers.

- Global Payroll, to pay people
- Project Costing, to bill customers for time worked on projects
- Project Execution Management offering of Project Portfolio Management, to figure out staffing for projects

Enable Informational Workflow for Bulk Time Card Submission

Specify whether to notify everyone affected across the selected time consumers when managers generate or submit and approve bunches of time data at one time. You might want to select **No** if you regularly submit and approve many time cards at one time.

Time Category

Select the time category that identifies the time data to transfer to the time consumer. For example, payroll doesn't want time data with project attributes, so you select a time category that identifies only payroll-related data. Project execution management automatically uses the All Absence Entries category.

Validate on Time Card Actions

You specify the time card actions that start consumer validations for the time data identified by the selected time category.

- **Submit Only:** This default selection validates relevant time data when someone clicks Next on classic time cards or Submit on responsive time cards. Validation doesn't run when they click **Save**.
- **Submit and Save:** This selection validates relevant time data when someone clicks and of these actions on a time card: **Save**, **Save and Close**, **Next**, or **Submit**.

For Project Costing, we recommend that you select this option. That way people working on time cards know immediately if they're saving time entries to closed projects.

Required Time Card Status

This option is for reporting purposes.

- Select **Yes** to report on missing time cards for the people linked to this consumer set, and who regularly submit them.
- Select **No** if the consumer set is for groups of people who submit time cards sporadically, such as to report absences, training, and other exceptions.

Approval Options in Time Consumer Sets

Here are the various approval options you configure when you create time consumer sets.



Enable Informational Approval Workflow for Workers

You can send people approval notifications that let them approve or reject their time card. Their approval or reject is acceptance or repudiation of the time card data. This worker approval workflow is separate from the manager approval task and doesn't affect the time card status or processing.

Absence Approval Routing

Specify how you want to handle approvals for absence entries on time cards. The setting applies to all selected time consumers.

- **Absence approval rules:** The approval process uses the absence approval task to approve absence entries. It uses the time card approval task to approve worked time entries. The process approves the time card after both approval tasks complete.
- **Time approval rules:** The approval process uses the time card approval tasks to approve all time card entries, including absences. To include absences from time cards with only project and absence attributes, you also need to select the **Payroll** and **Project Execution Management** time consumers. The time card approval workflow for payroll handles absence approvals. And, all absence data transfers only to project execution management. No absence data transfers to project costing.

Approval Period

To define the approval period for the time consumer, select a repeating time period. For example, you want approvers to approve the time card once every week, so you select a repeating period with a weekly definition.

CAUTION: The approval period that you select for each consumer must match the time card period set in the time processing profile containing the consumer set. Otherwise, you might get errors when you try to link groups to the profile.

Entry-Level Approval

If you want approvers to see only the time card entries that they need to approve, select this option. If you want approvers to see all time card entries, even those that they can't approve, don't select this option.

Time Data for Approval Rules to Evaluate

Specify the time card data that approval rules should evaluate, either reported time or calculated time with reported absences. If you select entry-level approval for the time consumer, then approval rules can only evaluate reported time.

Required Approval Configuration

Specify whether other time consumers in the set must approve the time card before the time data can transfer to this time consumer. For example, the payroll department wants only the payroll time data approved by both project costing and payroll time approvers.

How Default Time Card and Time Entry Approvals Work

When you submit a time card that has project, payroll, or project and payroll data, you initiate approval workflows. These workflows are for either the time card or the time card entries, depending on the corresponding time processing configuration.

Time Card Level Approvals

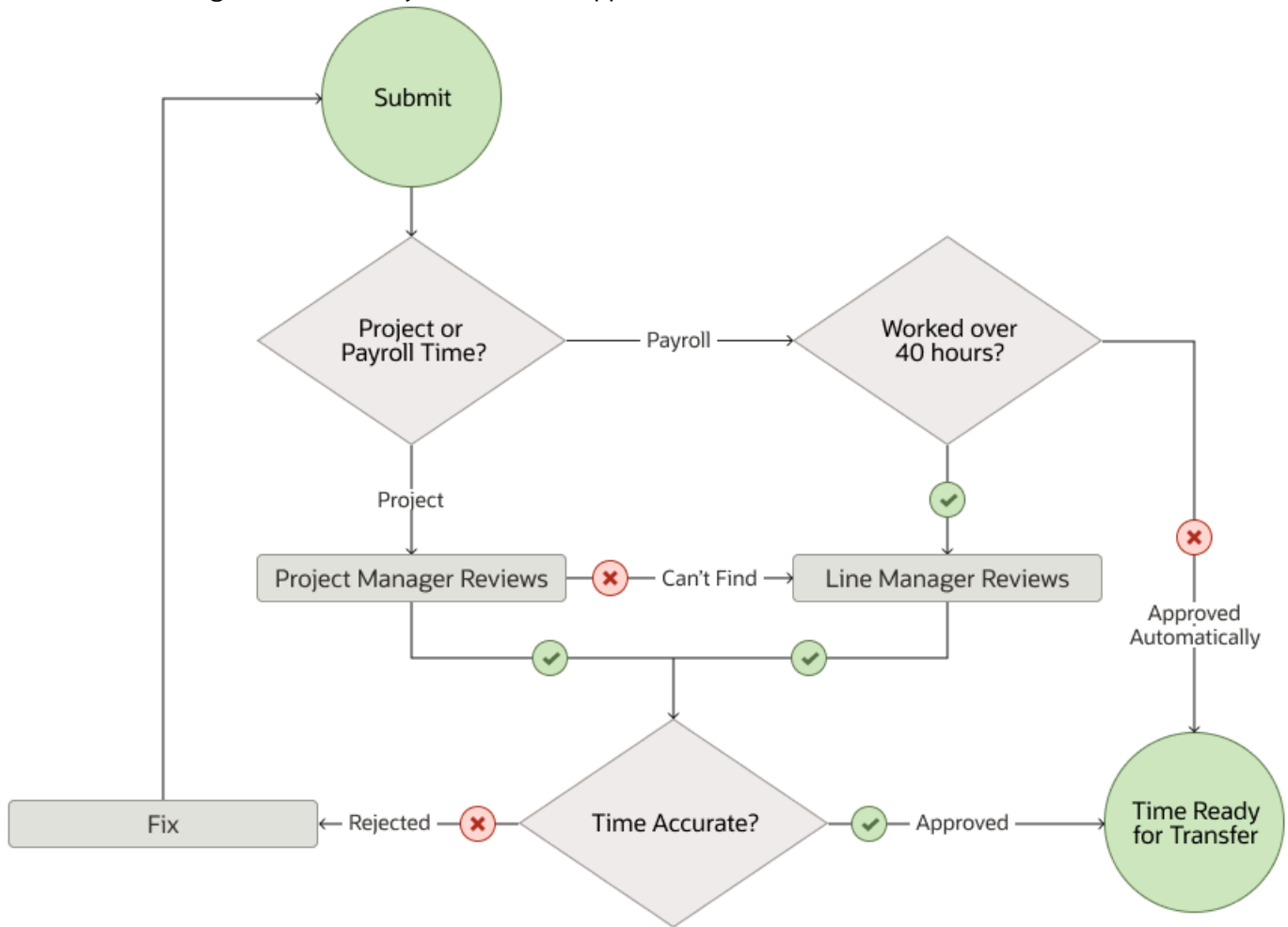
Here's what happens with the default approval workflows for time cards:

- For project time data, the workflow tries to figure out the appropriate project manager. If it can figure out who that person is, it routes the data to them to review and approve or reject. If it can't figure who that person is, it routes the data to the individual's line manager to review and approve or reject.
- For payroll time data, the workflow checks the total payroll time. If it's 40 hours or less, it automatically approves the data. If it's more than 40 hours, it routes the data to the individual's line manager to review and approve or reject.

Here's how the default workflow handles approvals, rejections, and notifications:

- It changes the time card status to Approved after all approvers approve the time card. The relevant time card data is ready for transfer to Project Costing or Payroll.
- It changes the time card status to Rejected if at least one of the approvers rejects the time card.
- It lets the individual know whether the approver approved or rejected their time card.

Here's a workflow diagram that shows you the default approval behavior for time cards.



Time Entry Level Approvals

These default approval workflows for time card entries are similar, but not identical to the time-card-level workflows. The big difference is when the time data is ready for transfer to project costing and payroll.

- For project time data, the workflow tries to figure out the appropriate project manager. If it can figure out who that person is, it routes the data to them to review and approve or reject. If it can't figure who that person is, it routes the data to the individual's line manager to review and approve or reject.
Approved data is ready for transfer to Project Costing.
- For payroll time data, the workflow routes the data to the individual's line manager to review and approve or reject. The applicable approvers need to approve all entries for the time card period before the data is ready for transfer to Payroll.

Validation and Processing Rules by Time Card Action

Time consumers, such as absence management, payroll, and project costing, deliver validation rules that apply to time card data. For example, absence validations make sure that absence entries are for only those absence types that the person is eligible for.

Here's the validation and processing associated with the main time card buttons.

Button	Validation and Processing Description
Next	<ul style="list-style-type: none"> • Validates absence, payroll, and project time entries • Applies time entry rules, as specified by rule configuration • Applies time calculation rules, including any allocation rules, as specified by rule configuration • Generates calculated time entries
Save Save and Close	<ul style="list-style-type: none"> • Always starts the delivered absence validations • By default, doesn't start the delivered project and payroll validations <p>You configure validation on the save buttons using the Time Consumer Sets task. In the Validate on Time Card Actions field, select Submit and save. Validations on the save buttons are then identical to those described for the Next button.</p> <p>For Project Costing, we recommend that you select Submit and save. That way people working on time cards know immediately if they're saving time entries to closed projects.</p>
Submit	Sets the time card status to Submitted and starts the approval workflow

28 Time Card and Entry Approval Workflows

Overview of Time Approval Workflows Configuration

Send time card data for project costing or payroll to the appropriate approvers using approval workflow tasks. Configure the workflows to support your approval policies using these tasks in the Define Approval Management for Human Capital Management task list:

- **Manage Task Configurations for Human Capital Management:** You configure the associated rules and rule sets on the Assignees tab. On the Configuration tab, the Once per stage task aggregation ensures that the approval process sends only one notification per approver.
- **Manage Approval Groups:** By default, the actionable time card approval workflow tasks route time cards using the dynamically decided supervisor hierarchy. You can identify specific approvers to route to instead using this task. The informational workflow task sends the notification to the individual on the time card.

To search for the task list, on the Setup and Maintenance work area, Tasks panel tab, click **Search**.

Stages and Layers

Workflow tasks for time approval have two stages and the payloads have two layers. These stages and layers link to header-level and line-level approvals, respectively.

- **Header-level approvals** have the ApprovalTimeRecordHeader payload layer and the Serial participant type. The approvals include the total number of hours.
- **Line-level approvals** have the ApprovalTimeRecordGroup payload layer and the Parallel participant type. So, the line-level rules always run in parallel for each line. The approvals include individual hours and time-card-related attributes, such as Expenditure Type or Payroll Time Type. ApprovalTimeRecordGroup attribute values vary by implementation. To figure out your value mapping, create your own data model report in the Reports and Analytics work area using this query:

```
select * from FUSION.hxt_tm_col_attr_map where LOCATION like 'Approval' and ENTERPRISE_ID = <ent_id>;
```

Related Time Object Configurations

These time objects include settings that affect approval workflow:

- **Worker Time Entry Profile:** You specify when people can change time cards during approval processing.
- **Repeating Time Periods:** You also configure time periods that continually generate, such as weekly periods that start on Sunday. You can use these periods with time data approvals.
- **Time Consumer Sets:** You can specify whether to notify everyone affected across the selected time consumers when managers submit and approve bunches of time data at one time. Also specify which time card actions start checks and rules. For example, specify which time category, approval period, and transfer rules to use. And specify whether to handle approvals at the time card or time entry level.

Here's what the actionable tasks do:

Supports header-level and line-level approval configurations that use payroll data on the time card, for the specified individual and time card period.	Supports line-level approval configurations that use payroll data on the time card, for the specified individual and time card period.
Notifies the configured approvers to approve or reject the time entries that they're responsible for. The approvers see all payroll time data, even the data that they don't approve.	Notifies the configured approvers to approve or reject only the time entries that they're responsible for. Approvers see only the payroll time data that they approve. Payroll data for the time card isn't ready for transfer until all time card entries are approved.
Notifies specified recipients based on time card status, for example, notifies individuals when approvers approve or reject their time cards.	Notifies specified recipients based on time entry status, for example, let's individuals whether approvers approved or rejected their time entry.

By default, the TimeCardApproval task evaluates payroll time entries only when the entire time card is ready for approval.

CAUTION: To avoid issues with approval routing for the TimeCardApproval task, TimeEntryApprovalRuleSet and TimecardApprovalRules must each have either an active rule or call IgnoreParticipant.

The TimeCardApprovalFYI task notifies individuals when approvers approve or reject their time entries for the specified time card period. You can disable this task so that individuals don't get notified about approved or rejected time cards. Because this task isn't rule based, you can't configure it to disable only one notification. For example, you can't disable the notification about approved time cards while keeping enabled the notification about rejected time cards.

How to Set Ignore Participant

Here's how you set Ignore Participant:

1. On the Assignees tab, click the appropriate participant.
2. In the participant configuration pane at the bottom, click **Advanced**.

3. Select **Ignore Participant**.
4. On the Tasks to be configured header, click **Save**.

By default, the ProjectTimeCardApproval task evaluates project time entries only when the entire time card is ready for approval.

CAUTION: To avoid issues with approval routing for the ProjectTimeCardApproval task, TimecardApprovalRuleSet, ProjectTimecardApprovalRules, and ProjectTimeCardLineManagerRuleset must each have either an active rule or the call IgnoreParticipant.

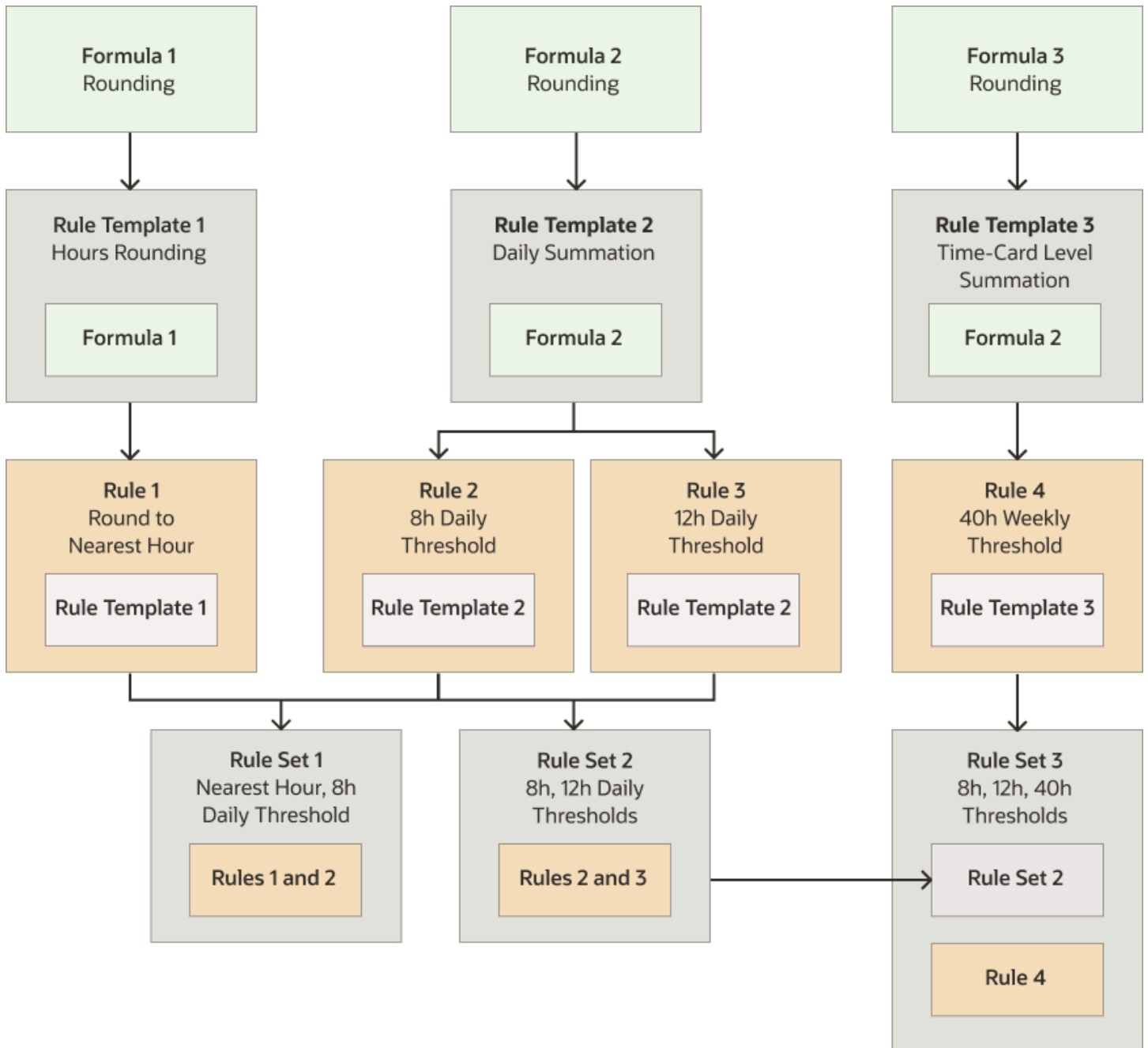

29 Time Formulas and Rule Components

How Formulas and Time Rule Components Work Together

One way that you can configure time validation, processing, and compliance is with fast formulas. You create rules based on formulas using rule templates. Then, you group rules of the same type into rule sets.

Here's what this relationship among formulas, rule templates, rules, and rule sets look like.



Formula

Formulas contain the logic for processing time. You can associate a formula with more than one rule template. For example, in the diagram the Hours Rounding rule template uses the Rounding formula. And, the Daily Summation and Time-Card Level Summation rule templates use the Threshold formula.

Rule Templates

Rule templates are tools that simplify the adaptation of formulas into rules. A template exposes the exact parameters that the associated formula requires and the outputs that the formula uses to return results. For example, a time calculation rule template can have an overtime threshold parameter. And, it can return Payroll Time Type attributes, such as Regular and Overtime, as outputs.

You can use one formula with multiple rule templates by varying the template configuration. For example, the diagram shows how the Daily Summation rule template uses the Threshold formula to calculate daily totals. The Time-Card Level Summation template uses the same formula to calculate totals for the time card period.

Rules

When you create a rule, you select a template to use rather than a formula. For example, in the diagram, the Round To Nearest Hour rule was created with the Hours Rounding template. The template automatically populates the description of all outputs and helps you enter correct parameter values.

You can create multiple rules from a single template, varying the parameter and output values of each rule. For example, the diagram has two rules, 8h Daily Threshold and 12h Daily Threshold, that were created with the Daily Summation template.

Rule Sets

You create a collection of rules and rule sets of the same type. You then assign these rule sets to groups of people with similar requirements for vacation, time validation, and time processing. For example, in the diagram the Nearest Hour, 8h Daily Threshold rule set has the Round To Nearest Hour and 8h Daily Threshold rules. The 8h, 12h, Daily Thresholds rule set has the 8h and 12h daily threshold rules. And, the 8h, 12h, 40h Thresholds rule set has the 2 daily and 1 weekly threshold rules.

You assign rule sets to an individual or group of people using worker time entry, processing, and device processing profiles.

You configure time validations, processing, and compliance using these types of formula, rule templates, rules, and rule sets.

Formula and Template Type	Description	Example Rule Usages
Advanced time category	Defines advanced conditions that you then associate with a time category.	Create rules to find time events or time entries that don't match published schedule times.
Time calculation	Creates or updates time card entries and uses the data to create calculated results based on formula logic.	Handle overtime or premium pay by updating reported time or creating more calculated time.
Time device	Evaluates time events imported from time collection devices and creates time entry exceptions.	Create exceptions for time entries with start time, or stop time, or both outside the specified grace periods.
Time entry	Validates time card entries and generates a message with a defined severity.	When reported time exceeds a specified weekly maximum, display the specified message.
Time submission	Identifies when to automatically save and submit time card entries created with time events imported from time collection devices.	Automatically save a time card after each Out event. Automatically submit a time card after receiving the Out event for the last scheduled shift of the week.
Workforce compliance	Identifies upcoming compliance exceptions by reviewing time card data and unprocessed time events to help you prevent or quickly fix any exceptions.	Notify managers when young people are approaching mandated worked time limits.

Time Entry Owner and Internal Source in Calculation Rules

When you create time calculation rules, you can specify whether the calculated time should keep the owner and internal source from the reported time.

For example, a person badges in at the start of the work day. Then they badge out 2 hours later than their schedule has them stopping for the day. Here's what the associated calculation rules do:

- A rule reduces the regular time to account for the standard 1 hour, unpaid meal break. Another rule converts the remaining 2 hours of regular time to overtime. Both rule configurations keep the original source, even though the rules are calculating the entries from the reported time.
- Yet another rule adds 1 hour of premium time. This rule configuration overwrites the original source to show that the entry is a calculation result.

Type of Time	Start Time	End Time	Quantity	Payroll Time Type	Internal Source
Reported	8:00a	7:00p	11h	Regular	TCD
Calculated	8:00a	5:00p	8h	Regular	TCD
	5:00p	7:00p	2h	Overtime	TCD
	NA		1h	Premium	Calculated entry

To keep or change the owner and internal source, the selected calculation rule template needs these attributes configured in the relevant output groups. You can't add these attributes to calculation rule templates already in use, but here's what you can do:

1. Check your existing rule to see what template it was created with.
2. Duplicate the original template.
3. On the Outputs page of the new template, add the Owner, Internal Source, or both attributes as user-defined rows in the relevant output groups.
4. Create the rule again, this time using the new template and specifying whether to change or keep the appropriate output.

30 Rule Template Options

Options to Configure Time Rule Templates

You configure various options when you create time rule templates using the Rule Templates task in the Time Management work area. Here are the options that you can configure for each template type.

Option	Template Type with the Option
Rule Classification	All except advanced time category
Default Allocation	Time calculation after you select a time allocation formula
Rule Type Execution	Time calculation if the selected formula references it
Summation Level	Time calculation, device, entry, and submission if the selected formula references it
Reporting Level	Time device, time entry, and workforce compliance if the selected formula references it
Suppress Duplicate Messages Display	Time device, time entry, and workforce compliance if the selected formula references it
Process Empty Time Card	Time entry if the selected formula references it
Time Card Events That Trigger	Time calculation and entry

Rule Classification Option for Time Rule Templates

The optional rule classification is the subtype within the template type. The drop-down list values vary among the template types. Examples include Business message, Comparison validation, Variance, Supplier event, and Hours entered.

You can set the rule classification for all template types except Advanced time category.

For time calculation rules, you can optionally select a default time allocation created using the Time Allocations task in the Time Management work area. Here's what you can do when creating allocation rules from calculation rule templates:

- Select an allocation, if the parent rule template doesn't have a default allocation.
- Leave the default allocation, if already selected in the template.
- Override the default allocation selected in the template.

Rule Execution Type Option for Time Calculation Rule Templates

To specify whether rules created with time calculation templates either create additional hours or update existing hours, select a Rule Execution Type option.

Example

Scenario: Threshold 8 Overtime is a time calculation rule that compares reported time to a defined daily threshold of 8 hours. Time worked over the scheduled 8 hours pays at 1.5 times the regular rate of 10 USD per hour.

Results: Here are the calculation details for both rule execution types when reported time is 10 hours.

Rule Execution Type	Calculation Description	Calculation Example
Create	<p>Rule processing calculates total time of 12 hours, which is 2 hours more than the reported time.</p> <ul style="list-style-type: none"> • It keeps the 10 hours of regular time at the regular hourly rate. • It creates 2 hours of premium time at .5 times the regular hourly rate. 	$(10 \text{ hours} * 10 \text{ USD}) + (2 \text{ hours} * 5 \text{ USD}) = 110 \text{ USD}$
Update	<p>Rule processing calculates total time of 10 hours, which matches the reported time. Processing adjusts the pay rate for 2 of the 10 reported hours.</p> <ul style="list-style-type: none"> • 8 hours of regular time at the regular hourly rate. 	$(8 \text{ hours} * 10 \text{ USD}) + (2 \text{ hours} * 15 \text{ USD}) = 110 \text{ USD}$

Rule Execution Type	Calculation Description	Calculation Example
	<ul style="list-style-type: none"> 2 hours of overtime at 1.5 times the regular hourly rate.

Summation Level Option for Time Rule Templates

Time calculation, device, entry, and submission rule templates might reference the Summation Level option. When they do, you can specify the level to apply the rule.

Here's the rule logic for each option:

Summation Level	Rule Logic
Details	Apply the rule to all time entries that match the time category conditions.
Day	Apply the rule to all the hours for the entire day that match the time category conditions.
Time Card	Apply the rule to all the hours for the entire period that match the time category conditions.

Time device, time entry, and workforce compliance rules might reference the Reporting Level option. When they do, you can specify the level to display the rule message results.

Here's the rule logic for each option:

Reporting Level	Rule Logic
Details	Display rule results for all time entries that match the time category conditions.
Day	Display rule results for all the hours for the entire day that match the time category conditions.
Time Card	Display rule results for all the hours for the entire period that match the time category conditions.

Suppress Duplicate Messages Display Option for Time Rule Templates

Time entry and device rules might generate repeated messages for the same condition. It depends on the time card action settings in the rule template. Workforce compliance rules might also generate repeated messages for the same condition.

- To display the message just once, in the Suppress Duplicate Messages Display field, select **Yes**.
- To display the message every time an entry or rule meets the condition, select **No**.

This option works with the **Reporting Level** option.

Example

A time entry rule produces a warning message when people report more than 20 worked hours for a week. When they save, submit, and resubmit their time cards, they apply the rule.

Someone reports working for 10 hours per day for 5 days and saves the time card each day. Here's how often messages would appear according to the reporting level and whether you suppress duplicate messages.

Reporting Level	Suppress Duplicate Messages Display	Message Display Frequency
Time Card	Either Yes or No	Once
Day	No	3 successive days after reported time exceeds the 20-hour maximum
Day	Yes	Once, on the third day when the reported time for the week exceeds the 20-hour maximum

For only time entry rule templates, you can specify whether the rule applies to time cards that contain days with no time entry values. If you select **Yes**, then the rule applies to all entries, not just those with hours.

Formula Parameters in Time Rule Templates and Rules

Formulas contain parameters that time repository rules use to provide actual values to the formulas. You configure formula parameters when you create rule templates. Your settings affect the values people select or enter when creating rules with the rule template.

Display Sequence

You can specify the order that the parameters appear when people create rules with the template. The lower the number, the higher the parameter appears in the list. The actual values set in the template don't show when people create rules.

Formula Parameter Name

The name of the formula parameter that you see in the rule template comes from the formula. You can't change the parameter name because it uniquely identifies the parameter in the formula.

Parameter Type

The parameter type specifies the expected format of the value set in rules created with the template. You type selections include value set; fixed text, number, and date; time category; exclude; and message. If you don't want the parameter to appear in rules created with the template, select **Exclude**.

Required

You specify whether rules created with the template need to use the parameter. You select **Yes** or **No** when you create the rule template. People creating rules with the template see your selection as a read-only value.

Value Set

You can see the Value Set parameter setting only if Parameter Type is Value set. The value set that you select decides the values that people can select from when they create rules with the template. They see the values that make up the parameter drop-down list, but they don't see the name of the value set. For example, the available value set HRC_YES_NO includes the values Yes and No. People creating rules see those values in the parameter drop-down list. They don't see HRC_YES_NO anywhere in the Rule Parameters section.

Display Name

The display name is the read-only name for the parameter in rules created with the template. By default, the display name is the formula parameter name. For example, many time formulas have a parameter named WORKED_TIME_CONDITION of type Time category. This parameter identifies which time entries the formula should consider as part of the validation or processing. People creating rules with the template select a time category from a

drop-down list. It might make more sense for them to see the display name Time Category or Time to Consider instead of the actual parameter name WORKED_TIME_CONDITION.

Value

People creating rules with the template select or enter the actual value that parameter passes to the formula depending on your parameter settings. For example, if a parameter uses the HRC_YES_NO value set, one rule created with the template could have the parameter pass the value Yes. Another rule created with the same template could have the parameter pass the value No.

Formula Outputs in Time Rule Templates and Rules

Formulas contain outputs that they use to return results to the time repository rule. You configure outputs when creating rule templates. Your settings affect the values that people select or enter when they create rules with the rule template.

Display Sequence

You can specify the order that the outputs appear when people create rules with the template. The lower the number, the higher the output appears in the list. The actual values set in the template don't show when people create rules.

Output Name

The name of the formula output that you see in the rule template comes from the formula. You can't change the output name because it uniquely identifies the output in the formula.

Message Severity

You can specify the default exception type for time entry and time card exceptions by setting the message severity to Information, Warning, or Error. For example, you want to identify anyone who starts or stops outside their specified grace period, but during their start and end early and late periods. So, you set a default severity of Warning. People creating rules with the template can change this default severity as appropriate.

Display Name

The display name is the read-only name for the output in rules created with the template. By default, the display name's the formula output name. For example, many time formulas have the OUT_MSG output, which returns the selected message severity. It might make more sense for people creating rules to see the display name Message Severity instead of the actual output name.

Formula Outputs Unique to Time Calculation Rule Templates and Rules

Formulas contain outputs used to return results to the time repository rule. You configure these outputs when creating time calculation rule templates. Your settings affect the values that people select or enter when creating time calculation rules with the template.

Output Group

You use output groups to link outputs from the formula to specific time attributes for calculation processing. For example, you add the PayrollTimeType attribute once to Output Group 1 and once to Output Group 2. Here's what you've after you finish:

- Output Group 1 has the OUT_MEASURE_UNDER output from the formula and your added PayrollTimeType attribute.
- Output Group 2 has the OUT_MEASURE_OVER output from the formula and your added PayrollTimeType attribute.

Even though both groups have the same payroll time attribute, the values that people set when they create rules with the template will be different. For example, the payroll value for hours below the measure is typically a regular pay rate. The payroll value for hours over the measure is typically an overtime or premium pay rate.

You select the output group when you create the calculation template. People can see, but not change your selection when they create calculation rules with the template.

Time Attribute

You need to specify the type of time attribute for each output. For all measure outputs, such as OUT_MEASURE_UNDER and OUT_MEASURE_OVER, select the **Measure** time attribute. As with output groups, people can see, but not change, your selection when they create calculation rules with the template.

Value Type

You specify whether the people creating rules with the template enter or select the time attribute value. For example, people enter a value for Measure attributes, such as **8** for a daily threshold or **40** for a weekly threshold. If you select **Data source** or **Value set**, people select a value from the corresponding drop-down list. If you select fixed number, text, or date, then people enter the value.

Value Set

You can see the Value Set output setting only if Value Type is Value set. The value set that you select decides the values that people can select from when they create rules with the template. They see the values that make up the output drop-down list, but they don't see the name of the value set. For example, the available value set HRC_YES_NO includes the values Yes and No. People creating rules see those values in the output drop-down list. They don't see HRC_YES_NO anywhere in the Rule Outputs section.

Output Source

The output source identifies whether the output came from the formula linked to the template or a person added it. You see this setting when you create calculation rule templates. People who create rules with the template don't see it.

Value

People creating rules with the template select or enter the actual time attribute value for the output results. For example, you create a calculation template with the Under Pay Rate and Over Pay Rate payroll attributes. A rule created with the template calculates daily overtime. Another rule created with the same template calculates daily premium time. Both rules have Under Pay Rate set to Regular. The first rule has Over Pay Rate set to Overtime and the second rule has it set to Premium.

How You Group Outputs in Calculation Rule Templates and Rules

When creating time calculation rule templates, use output groups to identify the time attributes that store outputs. The associated formula provides the outputs and groups, one group for each output.

You select the output values for the time attributes as you create rules using the rule template. In the Time Management work area, create templates using the Rule Templates task and rules using the Rules task.

Scenario

You create a rule template that calculates time data weekly based on the WFM_THRESHOLD_TIME_CALCULATION_RULE formula, which has these 2 outputs:

- OUT_MEASURE_UNDER
- OUT_MEASURE_OVER

The Output Group drop-down list contains these values:

- Output Group 1
- Output Group 2

Grouping Structure

On the Outputs page, you complete these actions:

- For OUT_MEASURE_OVER, change the output group to Output Group 2.
- For the time attribute of each measure outputs, select **Measure**.
- Add one time attribute output to each output group, as shown in this table:

Output Name	Time Attribute	Output Group	Display Name
PAY_TYPE_UNDER	Payroll Time Type	Output Group 1	Pay for Under Threshold
PAY_TYPE_OVER	Payroll Time Type	Output Group 2	Pay for Over Threshold

On the Outputs section toolbar:

- Use Grouping Structure to review your output groups in a hierarchy format.
- Use Reorder to edit the display sequence.

Time Attribute Values in the Rule

You create a rule using this template. For the PAY_TYPE_UNDER and PAY_TYPE_OVER payroll time types, select **Regular** and **Overtime**, respectively. The rule sets calculated hours below the threshold value to regular time. And it sets the hours over the threshold value to overtime.

How You Configure Explanation Text in Time Rule Templates and Rules

You describe the business purpose of the time rule template and any rules created with the template on the Create Rule Template Explanation page.

You can include message tokens as placeholders for parameter and output values. When people create rules with the template, the specific values they set replace these message tokens in the rule explanation text.

By default, the values in the Message Tokens drop-down list are the parameter and output names from the linked formula. If you configure display names for the parameters and outputs in the rule template, then the drop-down list values are the display names.

Example

You create a time calculation rule template. It evaluates all reported time that meets the specified conditions. And, it identifies the appropriate Payroll Time Type attribute to store the calculated hours depending on a defined limit. You then use the template to create a rule that evaluates total reported time for all payroll time entries against a 40-hour threshold. It stores time below the threshold with the Regular time attribute. And it stores time over the threshold with Overtime.

Here's an example of how explanation text that includes tokens changes from the rule template to a rule created with the template.

- Template: Compare the total reported hours in the {WORKED_TIME_CONDITION} time category to the threshold of {DEFINED_LIMIT} hours. Store the calculated hours below the threshold with

the {OUT_PAY_TYPE_UNDER} pay attribute. Store any calculated hours over the threshold with {OUT_PAY_TYPE_OVER}.

- Rule: Compare the total reported hours in the All Payroll Entries time category to the threshold of 40 hours. Store the calculated hours below the threshold with the Regular pay attribute. Store any calculated hours over the threshold with Overtime.

Best Practices for Explanation Text That Includes Tokens

Here are some best practices to keep in mind when you write text that includes tokens:

- Include abbreviations in tokens that are easy to recognize.
- Qualify tokenized text by inserting a word or phrase just before or after the token that describes what the token is.
- Ensure that the qualifier text and the token name make sense together, as shown here.

Example of Incorrect Pairing	Examples of Correct Pairings
The time card was approved by the approver {STATUS}.	The approver {APPROVER_NAME} approved the time card. The invoice was approved and now has a {STATUS} status.

- Read your explanation text without the token to check if the explanation makes sense.
- Use tokens for numbers carefully. Qualify tokens for numbers that are objects, such as number of hours or time type. If a token represents an amount that could be singular or plural, the text needs to support both scenarios.

You use a different attribute value to store any calculated overtime hours. So, you add the Payroll Time Type attribute to the output group for outputs over the threshold.

For example, if the period is weekly, the total hours should equal or exceed 168. A final hourly value of 999 safely covers any overflow for all summation levels, since a blank value isn't valid.

Time Allocation Assignment

After you create a time allocation, you can assign it to people directly or with rules.

Direct Assignment

You can directly assign time allocations using the Allocation Assignments task in the Time Management work area. Set a specific date range for the assignment or leave the end open by specifying only a start date.

Rule and Time Processing Profile Assignment

You can assign time allocations to all members of one or more HCM groups using rules. Here's what you need to do. The tasks are in the Time Management work area.

1. To specify a default allocation, create one or more time calculation rule templates using the Rule Templates task. Use the bundled OFA_WFM_TCR_ALLOCATION_TIME_AP formula or create your own.
2. Create time calculation rules using the Rules task. You can use the bundled template Time Allocation Template or your rule templates. When you create the rule, you can optionally associate a time allocation with the rule. Or, you can override a default allocation set in the selected rule template.
3. Create a time calculation rule set that includes the relevant allocation rule or rules using the Rule Sets task.

4. Associate the time calculation rule set with time processing profiles using the Worker Time Processing Profiles task.

Assignments from Both Methods

When you assign time allocations to people with both methods, the direct allocation assignment takes priority over assignments derived from the time processing profile. We recommend that you create a default time allocation and assign it to the appropriate people through time processing profiles. Then, assign more specialized allocations for specific people and HCM groups using the Allocation Assignments task.

Time Allocation

For the assigned time allocation to actually allocate time, here's what you need to do:

1. Create a time allocation rule even if you don't specify an allocation name.
2. Include the allocation rule in the time calculation rule set associated with the time processing profile.

Add the fields to the time card matrixes of these layouts: time view, review, and approval notification. To let only managers view allocation outputs, edit the Manager tab, in the Calculate Time section. Add the fields to the time card matrixes of these layouts: time view, review, and approval notification.

You want to automatically allocate time entries linked to regular payroll time attributes, to different cost centers, programs, and funds.

These allocations use hours-based, daily thresholds. The allocation also automatically allocates 100 percent of time entries linked to on-call payroll time attributes, to a specific cost center.

Before you start

You need to create the Cost Center, Program, and Fund cost segments and the RN in CA on Primary Assign HCM group.

Create Time Rules Sets and HCM Groups for Workforce Compliance Alerts

You can prevent time exceptions by checking compliance outside of the time management process using workforce compliance time rule sets and HCM groups.

These tasks are in the Setup and Maintenance work area unless otherwise specified. They're part of the Workforce Deployment offering, Time and Labor functional area.

1. If the delivered fast formulas don't meet your requirements, create your own formulas using the Fast Formulas task. The delivered fast formulas identify missing time attestations, card, and entries, and dangling In and Out events. There's also a reminder escalation formula.
2. Review the bundled lookup values for time collection device exceptions using the Workforce Management Lookups task. Add more lookup codes to the `ORA_HWM_TCD_EXCEPTION_TYPE` lookup type, as needed.
3. Create and edit workforce compliance rule templates using the Time Rule Templates task. Use time categories in the templates to summarize time and compare different categories of time.
4. Create and edit workforce compliance rules with your compliance rule templates using the Time Rules task.
5. Create and edit collections of workforce compliance rules and rule sets using the Time Rule Sets task.
6. Create and edit groups to identify the people you want to link to workforce compliance rules using the HCM Groups task. You use these groups when you prepare the Generate Time Exceptions from Compliance Rules process. You can reuse the existing HCM groups that are part of your Worker Time Entry Profiles. Or you can create as many HCM groups to identify time exceptions as makes sense for your organization. For example, you could create separate groups for each department, legislative data group (LDG), or business unit. You can also create a list of specific individuals.

What to do next

Schedule the *Generate Time Exceptions from Compliance Rules* process to run either once or regularly. You use this process to send managers and workers notices of noncompliance.

Alerts for Change Requests with an In Error Status

You can notify individuals and their managers about errors that occurred when the manager approved a change request. For example, the change request included a stop time before the start time, or there was an issue with the environment.

You notify them using the Alerts Composer tool and the delivered HWM Time Change Request In Error alert. The alert includes two alert templates, that are both enabled by default:

- Notify Individuals of In Error Change Request
- Notify Managers of a Subordinate's In Error Change Request

36 Time Card Approval Reminders and Escalations

Overview of Time Card Approval Reminders and Escalations

You can send approval reminders for submitted time cards to an individual and their manager. You can also send approval escalations to other managers in the manager's supervisor hierarchy.

You can configure parameters, such as these:

- The approval type, such as Worker Approval and Time Card Approval
- The maximum management level to escalate the approval to
- If delegates receive reminders and escalations
- When reminders should start
- When escalations should start

Automated notifications pause for people who are part of the manually maintained exclusion group.

Basic Process to Configure Time Card Approval Reminders and Escalations

Here's the basic process to configure approval reminders and escalations for submitted time cards.

1. Create a workforce compliance rule template. Use the Rule Templates task and the delivered `ORA_WFM_WCR_APPR_REMIND_ESCALATE_AP` formula.
2. Create a rule with the new compliance rule template using the Rules task.
3. Create a compliance rule set with your new rule using the Rule Sets task.
4. Review the delivered notifications for the HWM Time Approval Reminders and Escalations alert and adjust them as needed using the Alerts Composer tool.
5. Configure the Generate Time Exceptions from Compliance Rules process to automatically run at appropriate intervals. Use the Scheduled Processes task.
Click the **Advanced** button to set up the recurring schedule. Make sure that you select the **Send alert immediately** option so that the alerts start correctly.

37 Time Entries That Span Midnight and Overtime Start

Setup to Handle Midnight-Spanning Time and Overtime Day Start

Here are the setup tasks that you need to complete to derive and use the earned date for time entries that span midnight. It's also how you specify and use the overtime day in overtime calculations.

1. Configure work day definitions that support your policies for earned dates and the day start for overtime. Use the Work Day Definitions task in the Setup and Maintenance work area. It's part of the Workforce Deployment offering, Time and Labor functional area.
2. Assign a work day definition to each person whose time entries can span midnight or who has a nonstandard overtime day. On the Employment Info page for your team or client groups, use the Assignment Hours Details icon. The icon is next to the Working Hours field.
3. Create time rules to calculate overtime using time entry earned dates. Use the Rule Templates, Rules, and Rule Sets tasks. To link these rules to the appropriate groups of people, use the Worker Time Processing Profiles task. Both tasks are in the Time Management work area.

Day Start for Overtime Calculations

To support your overtime policies, you can specify the day start time for overtime, including whether the time is for the current or next day.

By default, the day start time for overtime is 12:00a of the current day. Overtime calculations split single time entries that span the day start time into two entries. The first entry ends at the day start time and the second entry starts then.

Start Day Rule

You can configure work day definitions to use the Start day spanning days rule on classic, responsive, and enhanced time card entries that span midnight.

With this rule, the earned and reference dates for the entry are the start date of the entry. For grouped time entries, it's the start date of the oldest time entry in the group.

Entry Spans 2 Periods

It's possible that an entry group includes the last entry of a time card period and the first entry on the next period. These entries both appear on the first time card because the earned and reference dates are in that time card period. The entry from the next period appears as another day on the first time card.

Here's an example with a time card period of April 5 to 11. The person has a grouping threshold of 90 minutes because you want to keep entries before and after a break together as a single shift. The person works a shift that starts on April 11 and ends on April 12.

Time Card Period	Date	Start Time	Stop Time	Complete Time Entry
April 5 to 11	April 11	6:30p	11:30p	6:30p to 11:30p
	April 12	NA	NA	12:30a to 5:30a
April 12 to 18	April 12	12:30a	5:30a	NA

Their two time entries are from 6:30p to 11:30p on April 11 and from 12:30a to 5:30a on April 12. Normally, the time card wouldn't show the April 12 time entry because it's part of the next time card period. But because the entries are grouped, the rule adds the April 12 entry to the April 5 to 11 time card.

Also, the entries get processed together as part of the April 5 to 11 time card period. If time card, absence accrual, and pay periods are the same, then the entries also accrue and get paid in that period.

You configure the person's work day definition with the Start day spanning days rule and a 90-minute grouping threshold.

Hours Paid and Absences Accrued

Here's how the time on a classic, responsive, or enhanced time card gets paid and accrued for the 2 periods April 5 to 11 and 12 to 18.

The final entry for the Saturday shift is reported on Sunday, April 12, which is part of the second period. But because of the grouping threshold, it appears on the April 5 to 11 time card. The hours also get paid and accrue as part of that first period.

Stop Day Rule

You can configure work day definitions to use the Stop day spanning days rule on classic, responsive, and enhanced time card entries that span midnight.

With this rule, the earned and reference dates for the entry are the stop date of the entry. For grouped time entries, it's the stop date of the newest time entry in the group.

Entry Spans 2 Periods

An entry can start on the last day of a time card period, and end on the first day of the next period. When this happens, the entry appears on the time card with the time card period that includes the entry start date. The entry also gets processed as part of that time card period.

Here's an example with the time card periods April 5 to 11 and 12 to 18.

Time Card Period	Date	Reported Time	After Applying Work Day Definition
April 5 to 11	April 11	10:30p	10:30p to 6:30a
April 12 to 18	April 12	6:30a	NA

The entry starts on April 11 at 10:30p and stops on April 12 at 6:30a. So, it appears on the April 5 to 11 time card and gets processed as part of that time card period.

When the time card, absence accrual, and pay periods are the same, the entry accrues and gets paid in the period that includes the entry stop date. So in this example, the entry accrues and gets paid as part of the April 12 to 18 period.

Tip: To ensure that all time card entries get paid in the same pay period, start your time card period 1 day before your pay period. Using the preceding example, if your time card period is April 5 to 11, your pay period is April 6 to 12.

Split at Day Start Time Rule

You can configure work day definitions to use the spanning days rule Split at day start time, on time entries that span midnight. The time entries can be on classic, responsive, or enhanced time cards.

This rule splits the entry into two entries, an entry that stops at midnight and an entry that starts at midnight. The earned and reference dates for each of the two entries match the entry start dates.

Entry Spans 2 Periods

In this example, the reported entry that starts on April 11 at 10:30p and ends on April 12 at 6:30a becomes two reported entries:

Time Card Period	Date	Start Time	Stop Time	Complete Time Entry
April 5 to 11	April 11	10:30p	NA	10:30p to 12:00a
April 12 to 18	April 12	NA	6:30a	12:00a to 6:30a

The earned and reference dates for these entries are April 11 and April 12, respectively. When the time card, absence accrual, and pay periods are the same, the entries get processed, accrue, and get paid in the same period.

Spanning Days Rules and Grouping Threshold

For certain rules, such as Start day, you can also set a grouping threshold. The grouping threshold, measured in minutes, lets you link time entries together to identify the earned or reference date.

For example, you want to treat the entries just before and after a meal break as one shift. So, you set a grouping threshold of 90 in the person's work day definition.

- They start work at 6:30p on April 11 and break for lunch at 11:30p.
- They return from lunch at 12:30a on April 12 and stop for the day at 5:30a.

The earned and reference dates for both entries are April 11 because less than 90 minutes separates the stop and start times.

38 Database Items and Time Balances

Overview of How You Configure Database Items to Summarize Time

You can include relevant time data in fast formulas that include people's balances, such as absence accruals, by creating your own database items.

Database items are formula language variables with values resulting from database queries. They make formulas simpler to write and maintain because you avoid writing and updating complex queries to access the database. To create your own database items, you create balance dimensions and then time balance definitions.

Time Balance Dimensions

To specify the level and time period to use when summarizing time for people's balances, you create time balance dimensions.

Use the Balance Dimensions task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area. You can also use this task to view bundled balance dimensions.

Summary Levels

- Assignment summarizes them by the person's assignment.
- Person summarizes them across all the person's assignments.

Period Types

- Absence accrual time period: The time period set in the absence accrual calculation.
- Profile overtime period: The repeating period with the Overtime usage associated with the person's assignment. Otherwise, the overtime repeating period selected on the person's worker time processing profile. The profile selection is optional, so there's no guarantee that the profile provides this period.
- Repeating time period: The repeating time period with the Balances usage selected.

Dimension Level and Period Type Working Together

Here are examples of how the dimension level and period type work together:

- A balance dimension summarizes time for people across all their assignments using the overtime period set in time processing profiles.
- Another balance dimension summarizes time for people by each of their assignments using a specified repeating time period with the Balances usage.

Dimension Suffix

Saving the newly created dimension automatically generates a dimension suffix based on the dimension name, grouping, and time period values. This dimension suffix forms part of the automatically generated definition name of the balance definition. For example, you create a time balance dimension with this configuration:

Field	Example Configuration Value
Name	Reg Hrs by Person
Dimension Level	Person
Period Type	Repeating Period
Time Period	Biweekly Starting Sunday

The application-generated suffix, which forms part of the database item name, is `_REG_HRS_BY_PERSON_PER_RP`.

Time Balance Definitions

Time balance definitions consist of one balance dimension and one or more time categories. The time categories identify the time data to add or subtract from the time balance.

When you create balance definitions, you must select a unit of measure, either **Hours** or **Units**. This selection constrains the time categories that you can select.

Create balance definitions using the Time Balance Definitions task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

Definition Name

After you enter a name for the balance definition and select the balance dimension, the application automatically generates the definition name. This automatically generated definition name, which includes the automatically

generated dimension suffix, is the database item name. You can use the database item name in your fast formulas that include time balances. For example, you create a time balance dimension with this configuration:

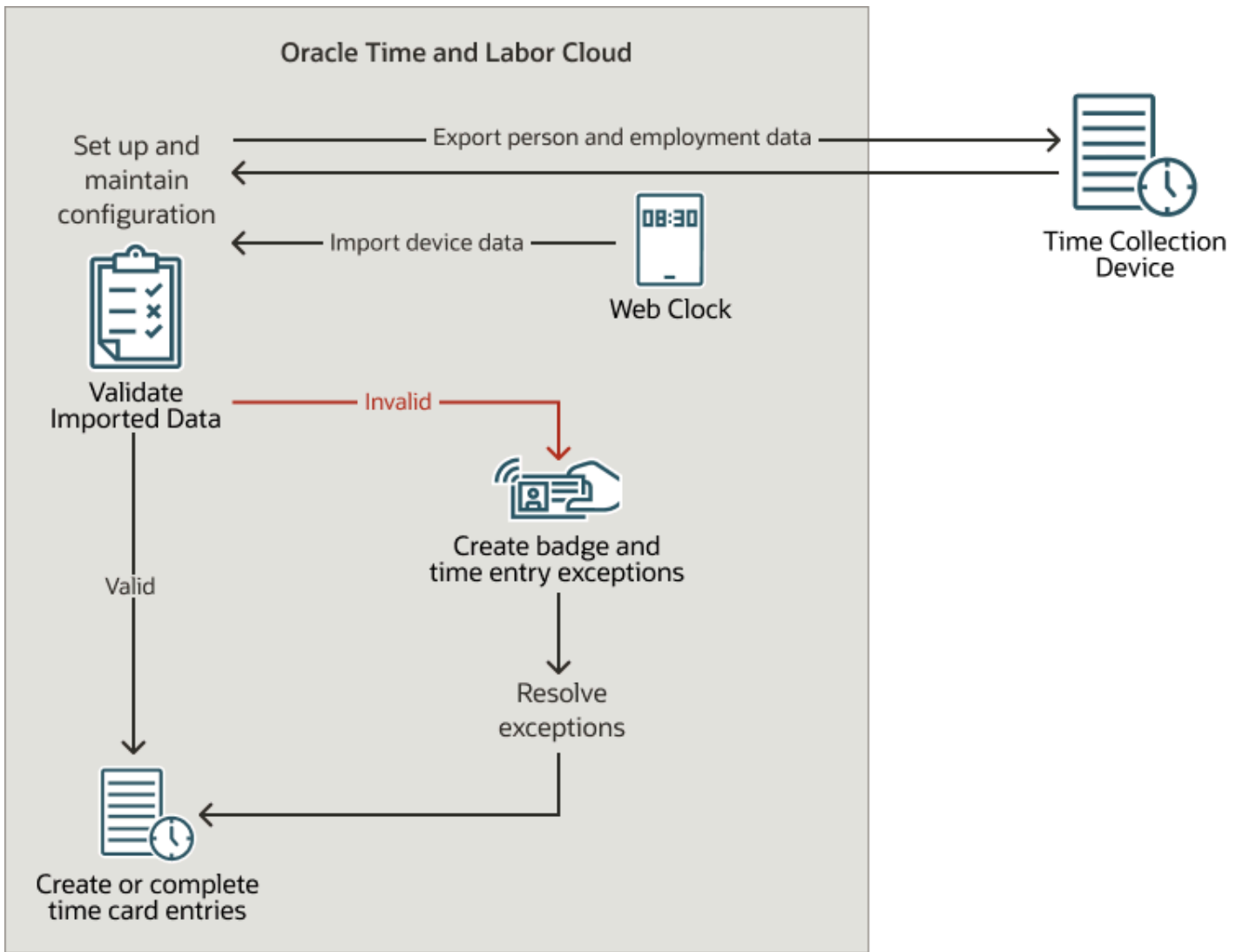

Overview of Time Collection Device and Web Clock Event Processing

You can process time reported with time collection devices, such as badge or biometric readers. Or process time reported with Web Clock. Here's the basic ongoing process of collecting events through to creation or completion of time entries.

1. You regularly export person and employment data to third-party time devices and import time device and web clock events.
2. The import process runs validations of the imported time data and identifies any badge and time entry exceptions for resolution by time and labor managers.

3. The import process uses valid events to create or complete time entries.

How You Import Data from Time Collection Devices

You transfer time data from a third-party time device using the Time Event REST service. Typically, the time collection device performs time event transfers in regularly scheduled batches.

The process handles imported time events using one of these methods, depending on the verification results:

- Returns inaccurately formed resources in an error status
- Saves accurately formed resources to the time repository for further functional validations

Supplier-Related Choice Lists for Time Device Event Mappings

When you create time device event mappings, you identify the supplier and supplier device event using drop-down lists generated from these lookups.

- ORA_HWM_TCD_SUPPLIERS: the companies supplying the time collection devices
- ORA_HWM_TCD_SUPPLIER_EVENTS: the time events recognized by the time collection device supplier, such as Clock In or Meal Out

These event lookup codes need to start with the supplier lookup code. For example, if you've a supplier lookup code ABC, start the lookup codes for those supplier device events with ABC_.

To create values for these lookup types and edit existing values, use the Workforce Management Lookups task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

Time Device Event Mappings

To process events imported from time collection devices, map the supplier device events to time and labor application events. Also identify the time attributes and default attribute values for each device event, such as Payroll Time Type and Regular.

Use the Time Device Event Mappings task in the Setup and Maintenance work area. It's part of the Workforce Deployment offering, Time and Labor functional area.

Here are descriptions of the four application event values.

Application Event	Description	Example
In	Used with the specified time attributes to create the start time event for an activity.	Start shift
In and Out	Used with the specified time attributes to create the start time event for one activity and the stop time event for another activity.	Start break and stop shift
Out and In	Used with the specified time attributes to create the stop time event for one activity and the start time event for another activity.	Stop shift and start break
Out	Used with the specified time attributes to create the stop time event for an activity.	Stop shift

Time Device Event Mapping Sets

To group time device event mappings for a specific supplier device and the people who use the device, create mapping sets.

Use the Time Device Event Mapping Sets task in the Setup and Maintenance work area. It's part of the Workforce Deployment offering, Time and Labor functional area.

You can get unpredictable processing results if you include multiple mappings for the same supplier device event in a single mapping set. For example, you map the same device event to these combinations of pay type and costing time attributes: Regular and Administration, and Regular and Engineering. You include both mappings in the same mapping set. The import process has no logic that decides which mapping the process uses for each imported time device event. For best results, name and describe your device event mappings so that you include only one mapping per supplier device event in each mapping set.

Examples of Mappings for Time Device Events

You want to create mappings between PPR Mint Company supplier device events and time and labor application events. You also want to include Payroll Time Type attribute values in the mappings.

Event Mapping Scenario

You've hourly workers who use badge readers from PPR Mint Company to record when they start and stop shifts, breaks, and meals. You pay shifts and breaks at regular rates, while meals are unpaid.

Event Mapping Set

Here are the individual mappings you plan to add to a mapping set for PPR Mint Company.

Event Mapping Name	Supplier Device Event	Application Event	Time Attribute	Default Values
PPRMint Start Shift	Start Shift	In	Payroll Time Type	Regular
PPRMint Stop Shift, Start Break	Start Break	Out and In	Payroll Time Type	Out: Regular In: Paid Break

Analysis

To make sure that there aren't any gaps when people take breaks and meals during a shift, select the **Out and In** application event. Although there's one application event in this instance, the Generate Time Cards from Time Collection Device import process creates two time events. The first time event is an Out event that's immediately followed by an In event. For example, in the PPRMint Stop Shift, Start Break mapping, the Out event corresponds to stopping the shift. The In event corresponds to starting the break.

Payroll elements created for use with time cards provide the default values for the **Payroll Time Type** time attribute.

Resulting Time Card Entries

Here are the time entries that the Generate Time Cards from Time Collection Device import process creates as someone badges in and out.

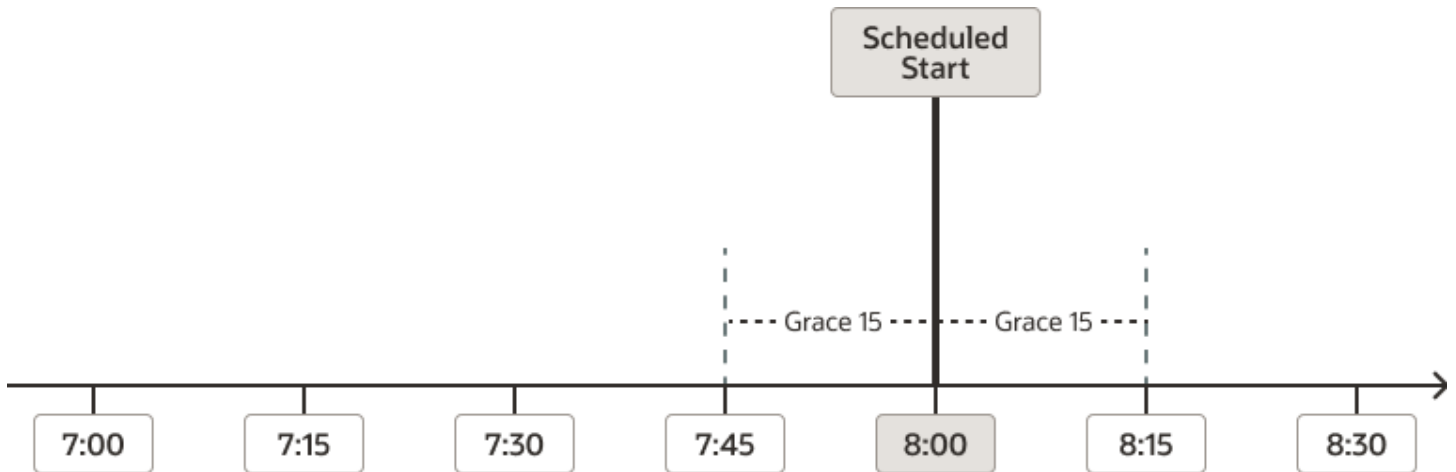

Shift Limits in Time Processing

Shift limits identify acceptable deviations from scheduled shift starts and stops. And they help time device rules identify the shift to use when evaluating time device or web clock events. Set shift limits using the Manage Shift Properties task.

Grace Period

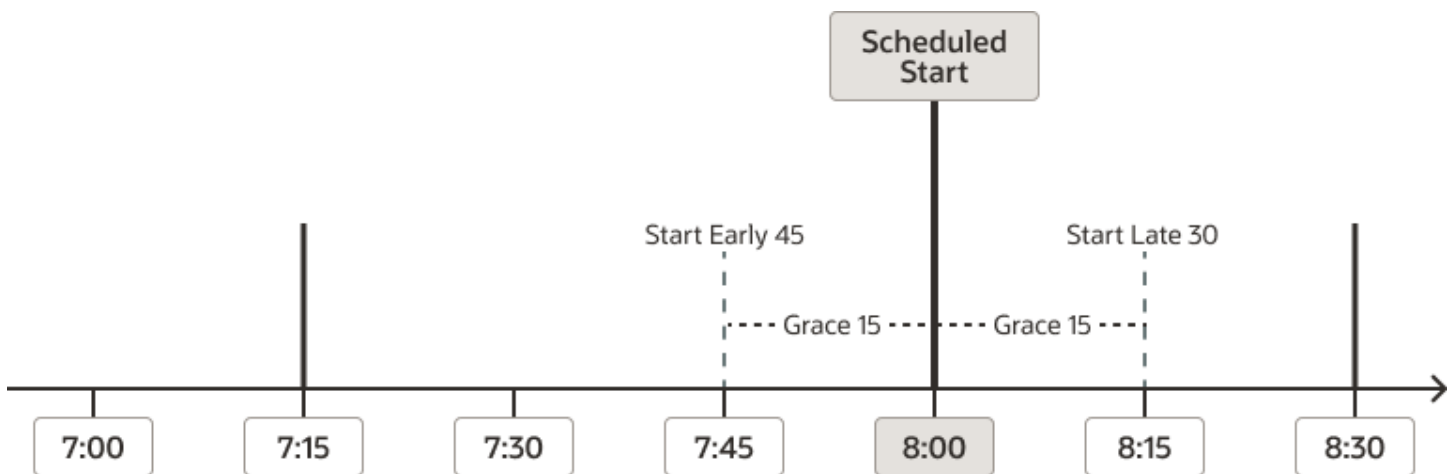
A grace period is the number of minutes that individuals can deviate from their published scheduled start and stop times without getting attendance violations. This deviation applies both before and after the scheduled time. For example, when a shift with a 15-minute grace period starts at 8:00, the valid start period is 7:45 to 8:15.



Start and End Early and Late Periods

Early and late periods are ranges of time in minutes, before and after scheduled start and end times. These periods help time device rules evaluate time device and web clock events using identified shift start or stop times. For example, a scheduled shift starts at 8:00. It has a 15-minute grace period, a 45-minute start early period, and a 30-minute start late period.

- The 45-minute start early period includes the 15-minute grace period. So, the start early period is 7:15 to 8:00.
- The 30-minute start late period includes the 15-minute grace period. So, the start late period is 8:00 to 8:30.



Violation Types

Time device rules create time entry exceptions for time device or web clock events in the specified start and end early or late periods. They can also create exceptions for events outside of the grace period, depending on how you set up the shift limits.

Time entry exceptions include an exception type of Information, Warning, or Error, which specifies what message the time and labor manager reviewing the exception sees. A device rule uses the violation type that you set for the shift limits as the exception type for the time entry. If you don't set a violation type, it uses the message severity set in the rule. For example, the violation type for the start early period is Warning. The message severity in the device rule is Error. When the rule generates an exception, it sets the type as Warning. If there wasn't any violation type for the start early period, the rule would generate an Error exception.

Time event processing also uses the rule message severity for time events outside of any specified start and end early and late periods. For example, the rule generates Error exceptions for time before start and end early periods, and after start and end late periods.

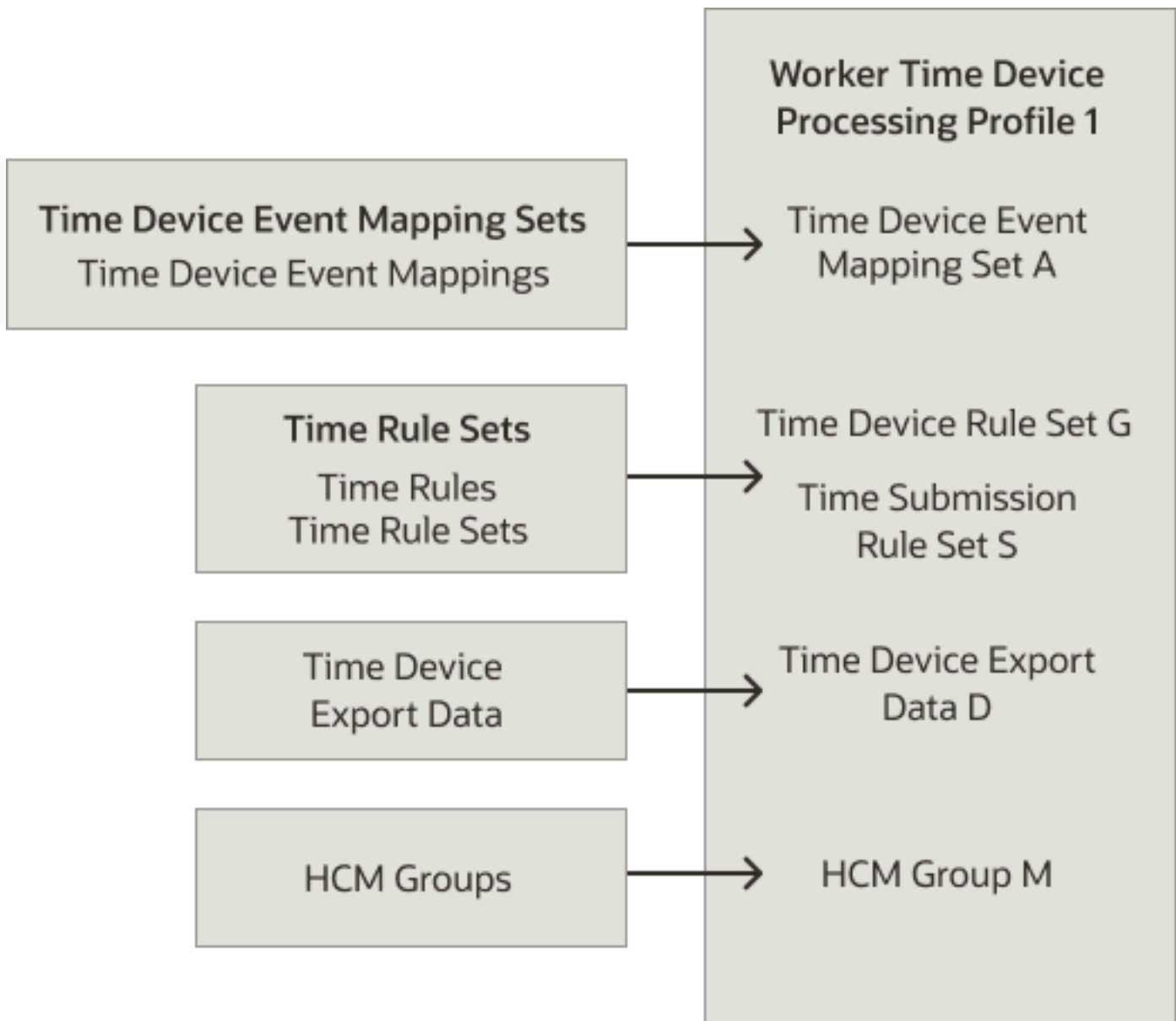

Best Practices for Creating Time Device Processing Objects

You need to create separate time device processing profiles for each unique combination of device processing components, as shown here. You link these profile people who share similar time entry and processing requirements for third-party time devices and web clock.

The more device processing objects that you create, the greater the ongoing maintenance effort. You want to find a balance between optimizing the device processing experience for people and the effort required to maintain that experience.

How Many Time Device Event Mappings and Web Clock Button Definitions to Create

Use these questions to help you decide how many time device event mappings or web clock button definitions you need to create.

Question	Examples and Comments
<p>What events do you record with your time collection devices or web clock, for example shift start, break, meal, and shift end?</p>	<p>To ensure accurate time event validation and processing, there can't be any ambiguity about the time events that each device provides. They must clearly and consistently map to an In, Out, In and Out, or Out and In application event. For example:</p> <ul style="list-style-type: none"> You identify when employees start their work using the Start Shift time device event, which maps to the In application event. You identify when employees take a break using either of these methods. Map one time device event, Break, to the Out and In application event. Or, map two time device events, Shift End and Break In, to the Out and In application events, respectively.
<p>What are the time attributes and attribute values that correspond to the time device or web clock events?</p>	<p>For example, the Start Shift, Break, and Meal time device events all map to the Payroll Time Type time attribute. But, the events each have different attribute values.</p> <ul style="list-style-type: none"> Shift Start: Regular Break: Paid Break Meal: Unpaid Meal <p>Using discrete time attributes enables you to report in greater detail, but might require more event mappings and mapping sets or web clock buttons. For example, since you pay breaks and shifts at the same rate, you could use the same Payroll Time Type attribute value for both. Since you don't pay for meals, you could decide not to associate any time attribute. Time device rules could still validate the event but time calculation rules would ignore it.</p>

How Many Time Device Event Mapping Sets and Web Clock Buttons to Create

When you create a layout component for Web Clock, you can define as many buttons as you want. If your people use Web Clock, you can optionally, link web clock events with a time device processing profile, as needed:

1. Link a web clock layout with groups of people using time entry profiles.
2. Assign the same groups of people to a time device processing profile that doesn't include an event mapping set or time device export data.

You can link only one time device event mapping set to a time device processing profile. But, you can link as many mappings to a mapping set as you want.

Use these questions to help you decide how many event mapping sets or web clock buttons and button definitions you need to create.

- Are there unique events for time collection devices or web clocks in different areas, buildings, or regions?
- Are there events that are relevant only in certain years, for example, some time attributes relate to a location that you closed?
- Do you group certain events from time devices or web clock together for payroll eligibility? For example, some payroll-related time attributes are effective for only certain date ranges.

How Many Time Device Export Data Configurations to Create

You can link only one time device export data configuration to each device processing profile. Create a separate export data configuration for each unique combination of data that you regularly send to the time collection device.

Examples of export data are:

- Person identification data, such as first and last name and badge ID
- Other data, such as payroll time types and published WFM schedules

Use these questions to help you decide how many export data configurations you need to create:

- What data does the time device require to provide complete time event records?
- What data, if any, do people require when they report time using the device? For example, you require people to select their location when they report time.

Because Web Clock is part of the standard Time and Labor solution, you don't have to create and send export data to provide relevant information.

How Many Time Device and Submission Rule Sets to Create

You can link only one time device and one time submission rule set to a device processing profile.

Use rule sets to link rules to people with similar validation and submission requirements for events from third-party time devices or Web Clock. You can link as many time device rules to a rule set as you want. When you create a time submission rule, you also automatically create the corresponding rule set because each submission rule set can contain only one rule.

Use these questions to help you decide the rules that you require:

- Do you want to validate time device or web clock events against published employee schedules and designated shift limits? Or do you want to accept all time entries automatically? Shift limits consist of a grace period, start and end early and late periods, and start and end early and late violation types.
- Do you want to validate that certain employee groups satisfy a specified minimum rest period between shifts?
- Do you want to automatically save time card entries created with the time device or web clock events and submit the time cards? What conditions, such as the type or number of events cause an automatic save? What conditions, such as number of events, duration, or schedule, cause an automatic submission? For example, automatically submit time cards after the eighth time event on the last day of the time card period.

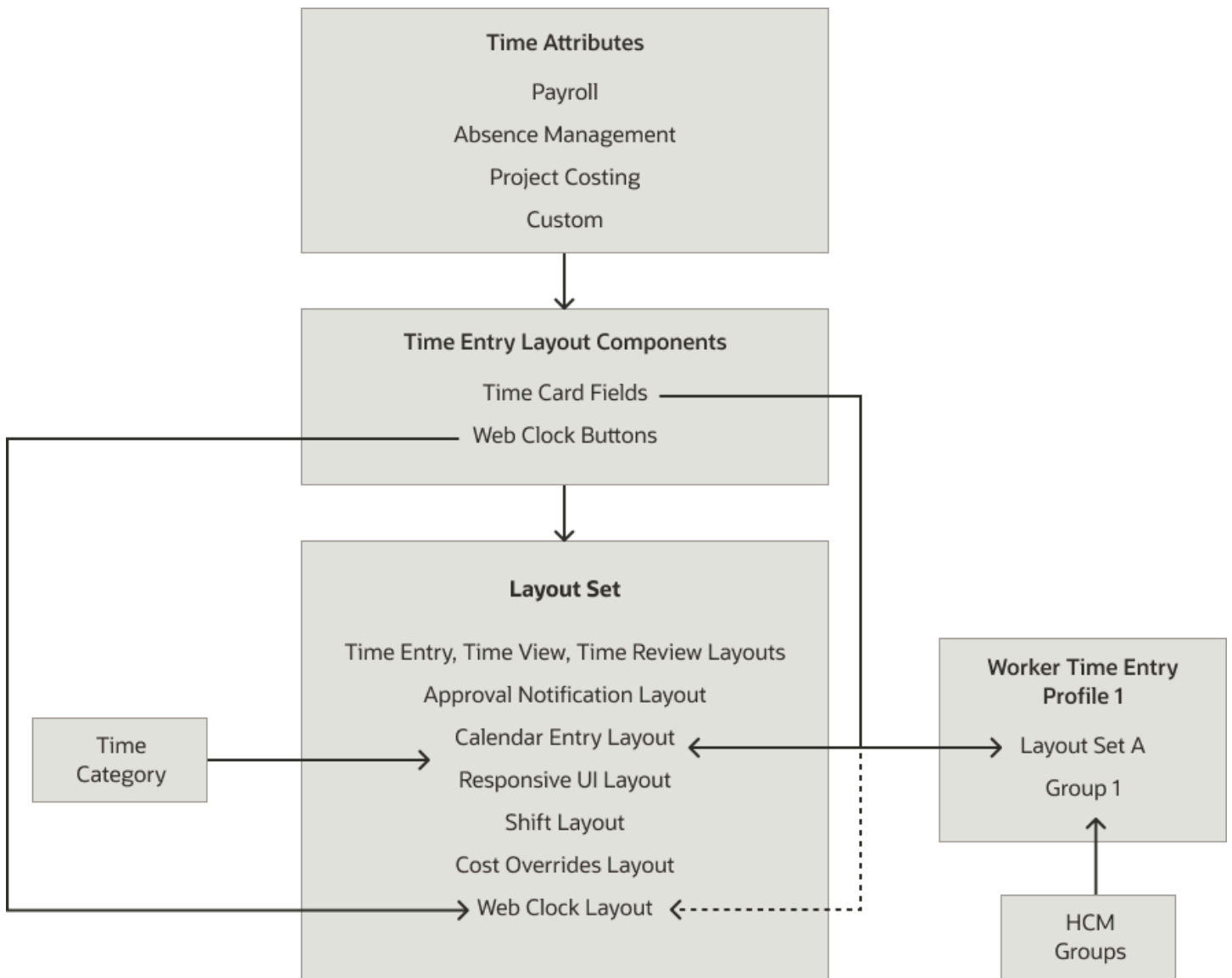

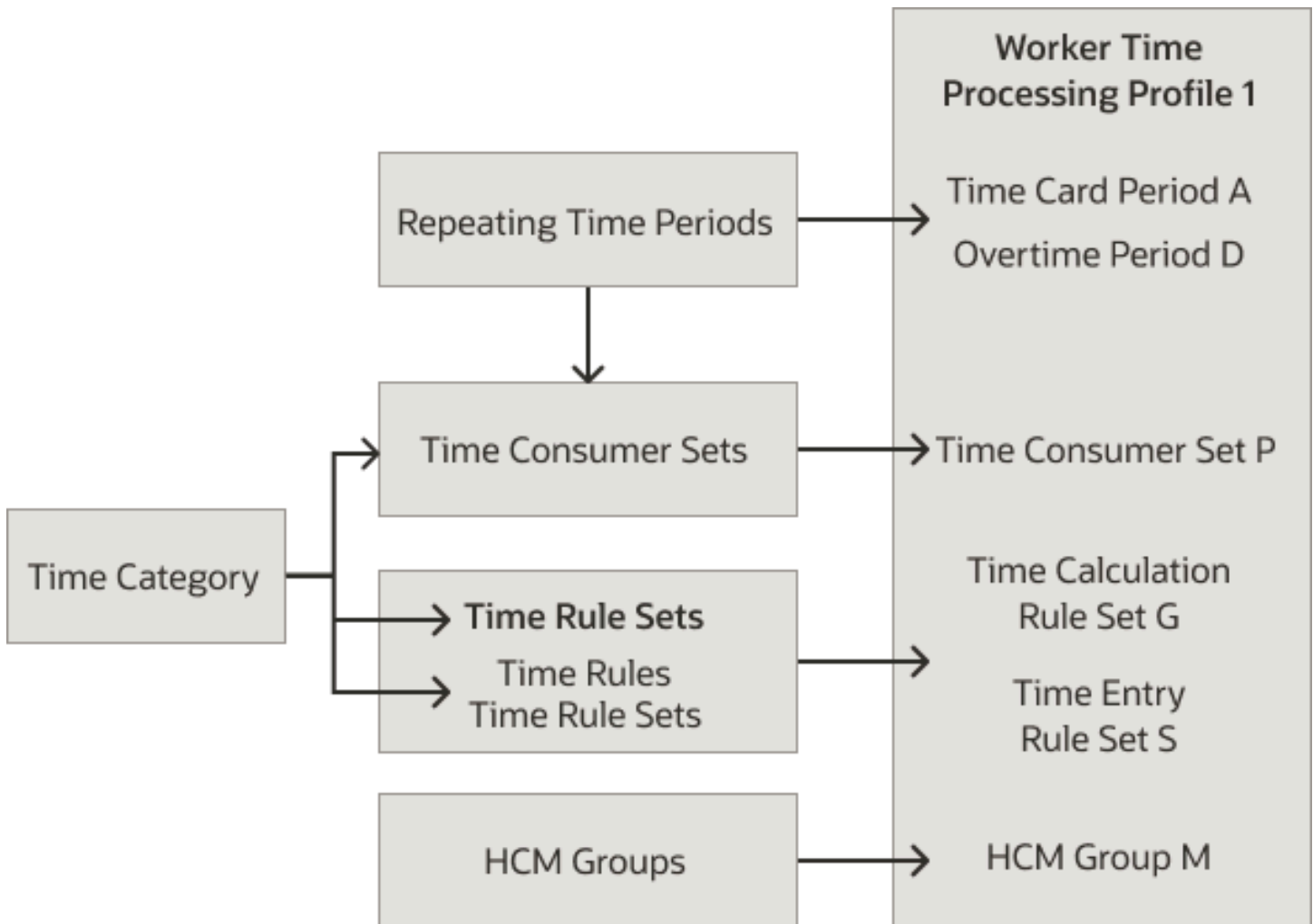

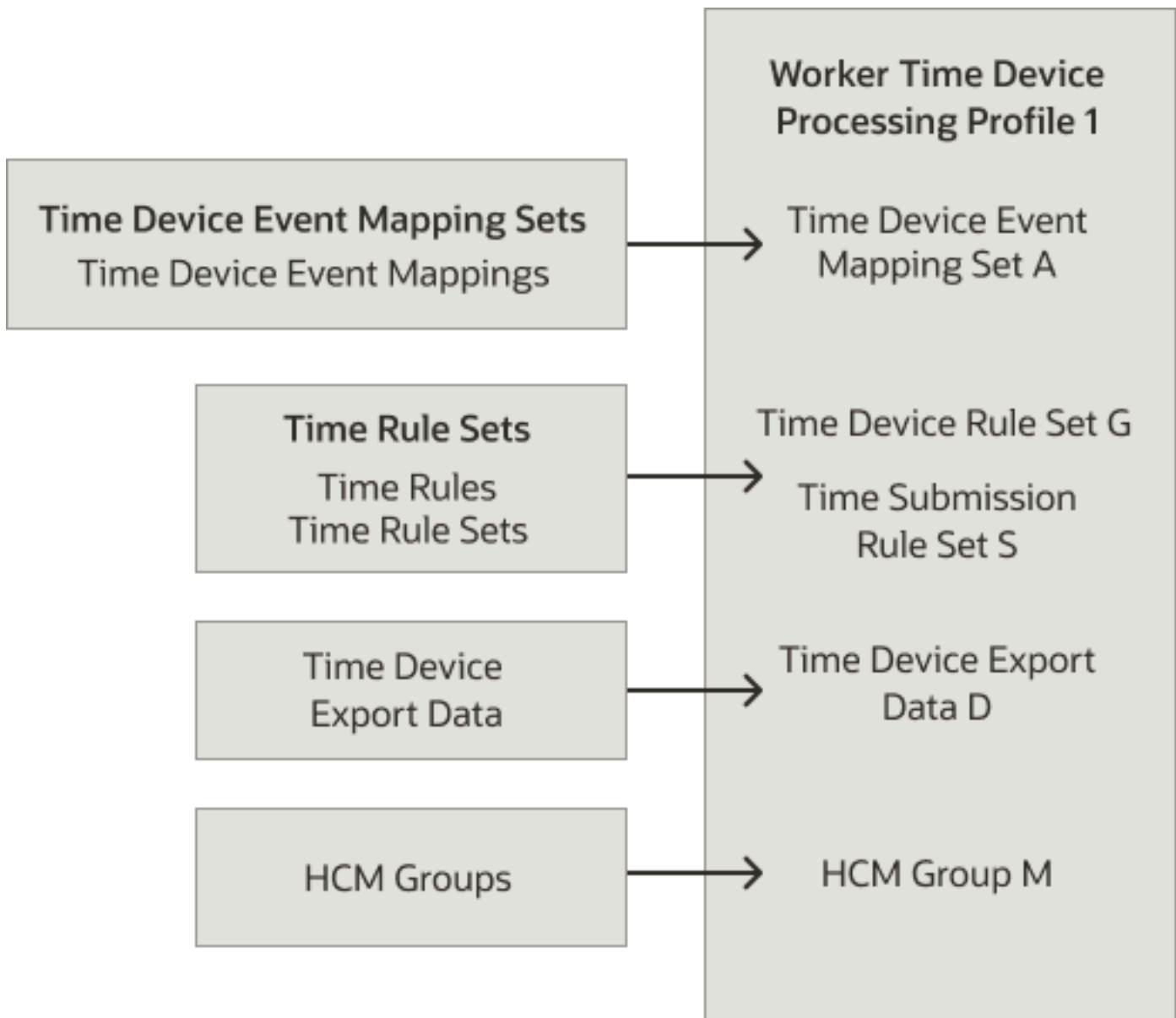

You link individuals and their managers with these sets and export data objects using time device processing profiles and HCM group assignments.

Individuals, Value Sets, or Other Groups Included or Excluded in HCM Groups

Decide group membership by adding individuals, value sets, and other groups with either Include or Exclude membership statuses. For example, to create a larger group that includes the Hourly Marketing group, add Hourly Marketing with the Include membership status.

To create a group that includes members using a value set, first create the value set. You can include any individual assignment or payroll attributes in your value set queries and filters.

Example

You create the All Part-Time Employees with an Annual Salary Basis value set that contains this query:

In this example query, 'PR' identifies the Part-Time Regular employment category. Depending on the status that you use when adding the value set, the group includes or excludes individuals that match the query.

How You Lock HCM Group Membership

So that you can always use the same set of individuals in time processing, prevent group membership refreshes. Do this by setting Locked to Yes. For example, you lock the Senior Managers group membership as of June 12, 2022.

Note: Locking group membership is a permanent action and you can't reverse it.

Embedded Group Priority in HCM Groups

When you embed groups within another group, an individual can exist in more than one group. In such a case, the priority numbers assigned to the embedded groups decide the group membership. The lowest number has the highest priority.

Example

Joe Smith is a member of these two groups. The Marketing group has them embedded with these statuses:

Priority	Group Name	Status
1	Promotions	Exclude
2	Advertising	Include

The Marketing group excluded Joe Smith because the Promotions group, his top priority embedded group, has the Exclude status.

How You Refresh and Evaluate HCM Group Membership

After you create an HCM group, you can refresh and evaluate the group membership and update the list of members. To configure and submit the Evaluate Group Membership process, on the HCM Groups page, click **Refresh Group Membership**.

You can schedule regular refreshes for the HCM group using advanced options. You can also regularly refresh the membership of all HCM groups that meet both of these conditions:

- The group definition has the Include in Refresh All Groups Process option selected.
- At least one time entry, processing, or device processing profile configuration includes the group.

To include active and suspended assignments, select the Include assignments with an HR status of active or suspended option. To include only active assignments, unselect the option.

Tip: To refresh all groups that meet both conditions, when you configure the process, be sure to leave the HCM Group and Person fields blank.

How Membership Is Evaluated

Here's how the Evaluate Group Membership process decides the final membership status of each individual as of the specified evaluation date.

Membership Evaluation	Membership Status When True
1. Is the individual directly included in or excluded from the group?	Include or exclude the individual accordingly.
2. Is the individual part of multiple child groups or value sets with different membership statuses?	Use the child group or value set that the individual is part of with the lowest priority to include or exclude the individual accordingly.
3. Is the individual part of only one child group or value set that's included in or excluded from the parent group?	Include or exclude the individual accordingly.
4. Does the individual match evaluation criteria that has attributes, relational operators, and logical operators?	<p>Include the individual.</p> <p>By default, these delivered groups include everyone:</p> <ul style="list-style-type: none"> • Payroll Usage • Projects and Payroll Usage • Project Execution Management Usage • Projects Usage

How You View HCM Group Membership

After you create an HCM group, view the membership by clicking **View Group Membership** on the HCM Groups page. Enter a membership evaluation date to get a list of the individuals who are group members as of that date.

The listed members can change as you change the evaluation date, depending on whether they meet membership conditions on the specified date.

Manually Maintained Audit and Excluded HCM Groups

You can identify people who must not get worker approval reminders for a certain period. And, you can identify people to include in Oracle Transactional Business Intelligence (OTBI) audit reports.

Use these tasks in the Time Management work area:

- Manually Maintained Excluded Members
- Manually Maintained Audit Members

You can also use the corresponding quick actions in My Client Groups.

The Actions menu has templates that you can use to merge and delete members if you prefer to maintain member using spreadsheets.

How You Can Maintain Group Membership for Large Populations and Frequent Hiring

Schedule the Evaluate Group Membership process using the As of run date parameter and a daily frequency.

The process automatically increments the Evaluation Date parameter using the first run date. Because we aren't sure at what time on what day the Wait runs, we change the Evaluation Date only when the process runs. For example, server loads can delay when the process actually runs. Also, using the original time during the Wait status helps you identify the original process, since you can have multiple processes scheduled.

 - c. In the Description field, enter **Uses a value set to find all part-time equivalent employees with an annual salary basis**.
 - d. In the Include or Exclude Groups section, click the **Add Value Set** icon to insert a value set table row.
 - e. Select the **All Part-Time Individuals with an Annual Salary Basis** value set.
 - f. Click **Save and Close**.
 - g. On the Confirmation dialog box, click **OK**.
2. Refresh the group membership.
 - a. On the HCM Groups page, click **Refresh Group Membership**.
 - b. On the Refresh Group Membership page, in the Group field, select **All PTE with Annual**.

1. Create the HCM group. Use the HCM Groups task in the Setup and Maintenance work area. It's part of the Workforce Deployment offering, Time and Labor functional area.

 - b. On the Create Group page, in the Name field, enter **RN in CA on Primary Assign and All PTE with Annual**.
 - c. In the Description field, enter **Individuals with the Registered Nurses collective agreement, in a labor union, in California. And all part-time equivalent individuals with an annual salary basis**.

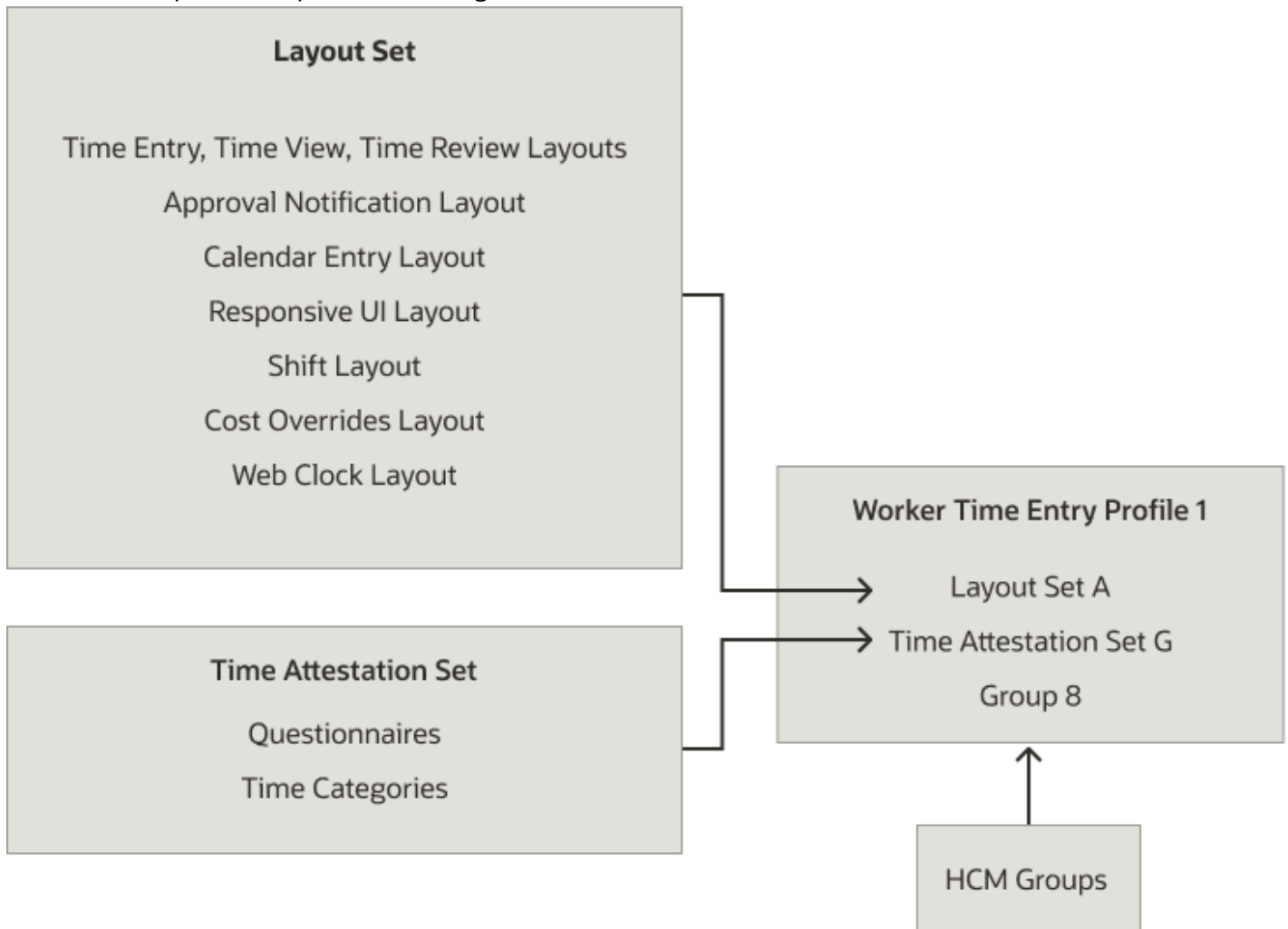

How Time Entry Profile Components Work Together

A time entry profile specifies how linked individuals report, review, and submit time using time cards, calendar, and Web Clock. It also specifies how their managers report, review, and submit time cards on behalf of individuals.

You create these profiles using the Worker Time Entry Profiles task in the Setup and Maintenance work area. It's part of the Workforce Deployment offering, Time and Labor functional area.

Here's how the profile components work together.



Layout Sets

A layout set is a collection of layouts that decide the appearance of time card, calendar, Web Clock, and shift pages. It also decides the time entry identifies used in change audits. For example, one layout set has layouts for people who have the same payroll characteristics. Another layout set has layouts for people who have the same project

costing characteristics. And a third layout set has layouts for people who have the same payroll and project costing characteristics.

Time Attestation Sets

A time attestation set is a collection of questionnaires and their initiating events and time categories. The attestation set lets you gather more information about reported time to make sure that people are complying with time policies and various regulations. For example, you can have people who work when they aren't scheduled attest that they obtained authorization beforehand.

Groups

An HCM group identifies people who share the same characteristics. All group members and their managers inherit the layouts in the layout set of their assigned time entry profile. They also inherit the time attestation set, if selected. You can assign each HCM group to only one time entry profile at a time.

Delivered Time Entry and Processing Profiles

By default, all employees in an organization are members of delivered HCM groups linked to delivered time entry and processing profiles. These delivered profiles apply to all employees.

The delivered time entry profiles use delivered time card fields, layout sets, and HCM groups. The delivered time processing profiles use delivered repeating periods, time categories, time consumer sets, and HCM groups.

Delivered Time Entry Profiles	Delivered Time Processing Profiles	Description
Payroll Time Entry Profile	Payroll Time Processing Profile	For only the payroll time consumer
Projects and Payroll Time Entry Profile	Projects and Payroll Time Processing Profile	For the project costing, project execution management, and payroll time consumers
	Project Execution Management Time Processing Profile	For only the project execution management time consumer
Projects Time Entry Profile	Projects Time Processing Profile	For only the project costing time consumer

These delivered profiles don't include any time rules because the time repository includes only delivered time rule templates. You use these delivered templates to create any rules and rules sets that you want to link to your own profiles.

To save time when creating your own profiles, you can duplicate the delivered profile that most closely matches the profile you need. Then, edit the duplicate profile, including the effective date, to support your time reporting policies.

For example, to create a profile that uses the delivered Projects Layout Set Filtered by Project Team Members layout set, duplicate Projects Time Entry Profile.

How You Set Allowable Actions for Time Entry

You can specify the actions that individuals, lines managers, and time and labor managers can do by time card status. You can also set the number of days into the past and future they can do the enabled actions.

You make these configurations using the Worker Time Entry Profiles task.

Actions by Status

Enable individuals, line managers, and time and labor managers to create, view, edit, and delete time cards according to your time card policies. For example, you've individuals who report time using Web Clock and correct any time exceptions and issues by submitting change requests. So, you let them only view their Entered, Saved, Submitted, Rejected, and Approved time cards. You've other individuals who report time with time collection devices and you want them to fix any incomplete or in error issues. So, you enable them to edit only incomplete entries on classic and responsive time cards with an Incomplete or In error status. If they're using enhanced time cards and you enable these edits, individuals can also edit or add entries.

To let individuals edit time entries generated from device events, be sure to also select the **Allow edits to times generated from device events** option.

Days Before and After

You can optionally set the number of days before and after today that people can do the action for the enabled status. For example, your policy is to let individuals edit submitted time cards up to **5** days before the current date. If that day falls in a prior time card period, they can edit the current and previous time cards if the status is still Submitted.

If you don't set any number of days, people can always do the entry action on their time cards with the enabled statuses. For example, you let individuals edit entered and saved time cards but don't set any number of days before or after. They can edit their entered and saved time cards, regardless of how many time card periods the time cards are in the past or future. But, as soon as the time card status changes to Submitted, they can't edit the time card.

Manager Days Before and After Settings

Consider prior period ranges for allowable adjustments to time data when setting days before values for allowable time entry actions on the Line Manager and Time and Labor Manager tabs.

For example, to limit adjustments for all actions and statuses to the last quarter and next month, enter **90** days before and **30** days after. The configuration on the manager tabs apply to all managers of individuals associated with the profile. We recommend that you configure the managers tabs to support your typical adjustment policies for time cards.

Here's how you can handle exceptions that fall outside the typical adjustment periods:

1. Edit the relevant profile to remove the relevant days before or after values.
2. Make your time card adjustments.
3. Edit the relevant profile to re-enter the relevant days before or after values.

Time Collection Device Integration Options on Time Entry Profiles

You can specify whether people can edit the time entries generated for them from their time collection devices, including Web Clock. You can also enable geolocation for Web Clock.

The collected geolocation information includes the Web Clock device used to report the time, such as Desktop, Mobile Offline, or Mobile Online. It also includes the latitude and longitude accuracy in meters, and any exceptions, such as rejected location requests.

Note: You can record geolocation information and generate geolocation addresses for most, but not all countries. We recommend that you test the countries where you work with geolocation information to make sure you can generate the correct addresses from the geolocation coordinates.

GPS is a country-specific service. A time reporter's location, device, and other factors decide the accuracy and availability of their geolocation information. For most accurate information, we recommend that you enable this functionality for people who use Web Clock on mobile devices because they've dedicated GPS sensors. Because desktop devices don't have GPS sensors, their location is derived from the network, and it's likely to be less accurate. Desktops that use VPN connections are most likely to provide incorrect location information. Oracle HCM Cloud app versions that support geolocation are 11.13.23.01.01 or later.

Note: People with these time entry profiles are prompted to grant Location access when they use Web Clock on mobile devices or in browsers on any supported device.

Schedule Option on Time Entry Profiles

You can specify whether schedulers can create shifts and edit shift properties for individuals linked to the scheduler profile or only view existing shift details. By default, schedulers can edit shift properties.

You set this option using the Worker Time Entry Profiles task.

Note: The configuration of this option on imported schedule events overrides the configuration on the time entry profile. For example, you configure a profile to allow edits and import schedule events configured to not allow edits. Schedulers can't edit those imported schedule events.

Worker Attestation Options

To identify if people are complying with time policies and various regulations, link a time attestation set to the time entry profile. For example, have people who work when they aren't scheduled attest that they obtained authorization beforehand.

You can optionally set the number of days before and after today that people can edit their attestations. For example, your policy is to let people edit their attestations up to 5 days before the current date. If that day falls in a prior time card period, they can edit the attestations for the current and previous time cards. If you don't set any number of days, people can always edit their attestations. It doesn't matter how many time card periods the time cards are in the past or future.

Cost Overrides Option on Time Entry Profiles

If the layout set that you link to the time entry profile includes the Cost overrides layout, you need to enable the cost overrides option.

Doing this turns on the Override Costs option of the time entry level Actions menu on responsive time cards. The people linked to the profile use the action to open the Cost Overrides page.

44 Time Measures and Time Processing Profiles

Time Measure to Show Option

You can specify for classic and responsive time pages whether to show time measures in hours and minutes or set a decimal place.

For example, enter and show quantities on time card pages in the format Hours, Minutes (HH:MM). On certain pages, read-only quantities and durations in this format can appear in the format `hh mm`, for example, 15h 30m.

Redwood time pages use only decimal place options.

Hours decimal options specify the number of places to show to the right of the decimal. Your selection applies to pages where time layouts don't control the appearance. For example, your selection applies to time measures on the Existing Time Cards and Team Time Cards pages. It doesn't apply to the Create Time Card or Add Time Card pages.

By default, time card layouts, such as time entry, review, view, approval notification, and responsive UI, have Decimal Places set to 2. You can edit the layouts to change this default, as appropriate. We recommend that you review all the pages that correspond to any layouts in a layout set where you changed the default value. Make sure that the number of decimal places that you see on each page is what you expect.

Time Entry Rules

Time entry rules can specify output messages that include the number of hours. Unchanged formulas and rule templates delivered before 2020 use the decimal format. To create your own formulas that use the Hours format, delivered reference the delivered formula `ORA_TER_PERIOD_MAX_WITH_MSG_FORMAT_OPTION_AP`.

Basic Process for Defining Time Measures

1. On the Worker Time Processing Profile page, Actions menu, select **Define Time Measures**.
2. On the Time Measure Properties page, select the measure to show.

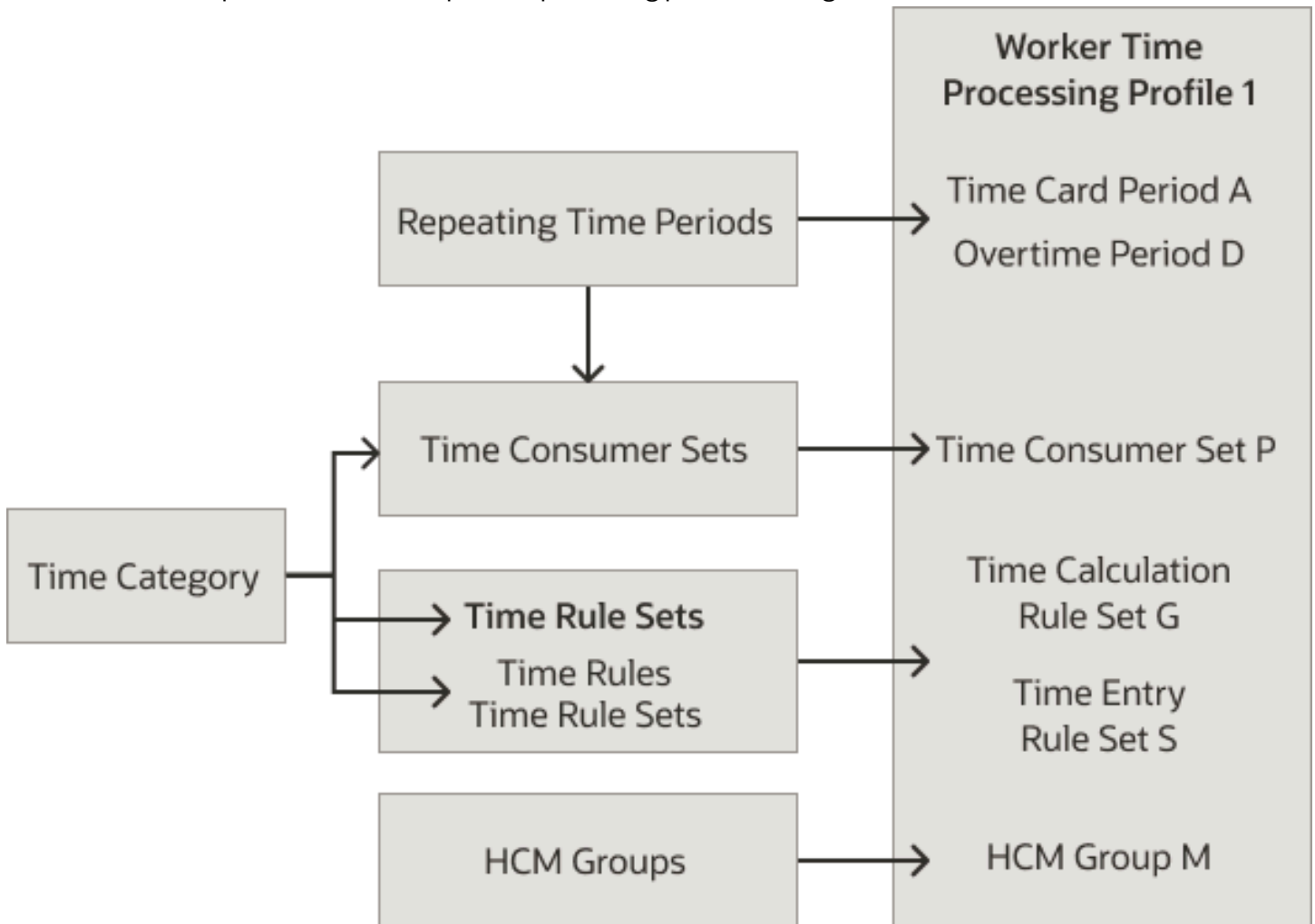
Note: Your selection applies across the entire Oracle Fusion Cloud Time and Labor environment. It isn't specific to the individuals linked to a specific time processing profile, nor the managers acting on their behalf.

How Time Processing Profile Components Work Together

A time processing profile identifies the time card period and time entries to use in linked validation, calculation, approval, and transfer rules. It also identifies whether to audit time changes and when to start the audit.

Create these profiles using the Worker Time Processing Profiles task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

Here's how the components that make up a time processing profile work together.



Repeating Time Periods

Repeating time periods, such as weekly, biweekly, or monthly periods, make up the choices for the time card period and optional overtime period. They're also selected as approval periods in time consumer sets. The approval period needs to match the selected time card period. Otherwise, you might get errors when you try to link groups to the profile.

Time Category

A time category identifies the time entries to use in time rules, summaries, analytics, and transfers. For example, use all payroll and absence entries or only all payroll entries.

Time Consumer Set

A time consumer set identifies the time data to validate for linked individuals. It also identifies the approval period that applies to the linked individuals, and what data approval rules should use. And, it specifies when to transfer the validated time data. For example, for the Payroll consumer validates all payroll time entries whenever linked individuals or their managers save or submit their time cards. Transfer the validated payroll time data whenever someone runs the Load Time Card Batches or Transfer Time Cards from Time and Labor process. The linked individuals have a weekly approval period and approval rules evaluation calculated and absence time data. And, payroll approval is required before the time data can transfer.

Time Calculation Rule Set

A time calculation rule set collects related calculation rules and rule sets that support time processing policies. For example, automatically allocate time across cost segments or grants and calculate daily and weekly overtime for the linked individuals. The rules in the selected rule set also apply to time entries created using web clock events and third-party device events.

Time Entry Rule Set

An entry rule set contains time entry rules and rule sets that support time validation policies. For example, enforce minimum and maximum worked hours and generate exceptions when linked individuals start or stop their shifts too early or late. The rules in the selected rule set also apply to time entries created using web clock events and third-party device events.

HCM Group

An HCM group identifies people who share common characteristics. All group members and their managers inherit the repeating periods, the consumer set, and the rule sets in their assigned processing profile. You can assign each HCM group to only one time processing profile at a time.

Enable Resubmission of Future Time Cards Option

A person's information, such as the payroll relationship or assignment status, can change retroactively. These information changes can also change the person's associated layout set, time card period, or both. And, the person can add absences to and change absences on existing time cards.

To include future time cards for linked individuals when the Resubmit Time Cards process runs, select the **Enable Resubmission of Future Time Cards** option. This option is on time processing profiles.

Submit Time Cards for Scheduled Processing Option

By default, when people click **Submit** on time cards, the applicable time consumer validation and time entry and calculation rules run immediately.

If your company has complex calculation rules or people with monthly time cards, we encourage you to submit time cards for scheduled processing. This way, the time consumer validation, time entry, and time calculation rules for the linked individuals run in the background. These individuals and their managers can review any issues and calculated time data results later, after the process completes.

You set this option on time processing profiles.

- When you select this option and linked individuals click **Submit** on their time cards, their Existing Time Cards page opens. The page has a submission pending message over the submitted time card. When managers click **Submit** on a time card, their Team Time Cards page opens with the same message. After time entry and calculation processing completes, other messages replace the submission pending message. The messages could be about exceptions that need fixing. Or, if there aren't any exceptions, the new message indicates that approval is pending for the time card.
- When you don't select this option, the linked time entry and calculation rules run immediately. Messages about any exceptions appear on the time card, which is still open. If the rules don't generate any exceptions, the Existing Time Cards or Team Time Cards page opens. The time card shows with the message that approval is pending.

Change Audit Options

You can track who did what classic, responsive, or enhanced time card action--such as save, submit, and approve--and when. You can also track who changed time entries, including absences, and when and why.

Use the Worker Time Processing Profile task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

Note: As soon as you enable change audit, you can't delete audited time cards. But, you can delete time entries on audited time cards. After you enable change audit, changes get tracked automatically from the specified starting point. For example, you can set change auditing to automatically start after the first time a time card gets submitted or approved. Or, you can automatically audit any manual changes to the time card.

Before Enabled Change Audit Can Work

For enabled change audit of time cards to work properly, you need to complete these tasks in the Setup and Maintenance work area.

- **Workforce Management Lookups:** Support your time policies by adding change audit reasons to the ORA_HWM_CA_REASONS lookup type. This lookup makes up the change audit reason drop-down list that appears after people save or submit edited time cards.
- **Time Layout Sets:** Select the time card fields that, when combined, enable people to identify a time entry that changed. For example, on one set of layouts, the Job and Pay Type fields together uniquely identify time entries.

Public Holidays on Time Cards Option

When you're configuring time cards to automatically add public holiday entries, you can set the default value for the payroll time type attribute.

For example, you created payroll elements for different countries using names like US Public Holidays, UK Public Holidays, and Bangalore Public Holidays. For people in the US, you want to set US Public Holidays as the default value for their public holiday entries. Use the Worker Time Processing Profile task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

You might have profiles for people who work across multiple legislative data groups (LDGs), such as the US and Canada. The time attribute value of the holiday entry gets set automatically only for people in the same LDG as the public holiday element. For example, you select the **US Public Holiday** payroll element. The element gets used for people in the US LDG. It doesn't get used for people in the Canada LDG. To automatically add holiday entries for everyone, you need to create separate profiles for the two LDGs. The fastest way to do this is to duplicate the existing profile and then update the configurations accordingly, including HCM group assignments.

Tip: You can stop the automatic creation of public holiday entries at any time. Just clear the value from the Payroll Element to Automatically Add Entries field on the time processing profile.

Before Enabled Change Audit Can Work

To automatically add public holiday entries to time cards, you need to complete these tasks in the Setup and Maintenance work area.

- Create a payroll element for public holidays, for each LDG using the Elements task. These elements get used in time card drop-down lists and to set the time attribute value when creating public holiday entries on time cards.
- Run the Generate Data Dictionary Time Attributes process after creating your public holiday payroll elements.
- Set the payroll element as one of the payroll time type attribute values to include in the drop-down list of the multiattribute time card field. If your field definition contains attributes for multiple LDGs, you can add another row for each public holiday payroll element you created for those LDGs. Use the Time Entry Layout Components task.
- Make sure that you defined all observed public holidays for the appropriate geography or organization trees. Use the Manage Calendar Events task. Be sure to set the Category to **Public holiday**. Also, define full-day public holidays as 12:00a to 12:00a.

- Make sure that your people have one of these types of schedules defined: Work Week, Work Schedule, or Standard Working Hours. For Work Schedule, make sure that the Public holiday event category is added as an exception.

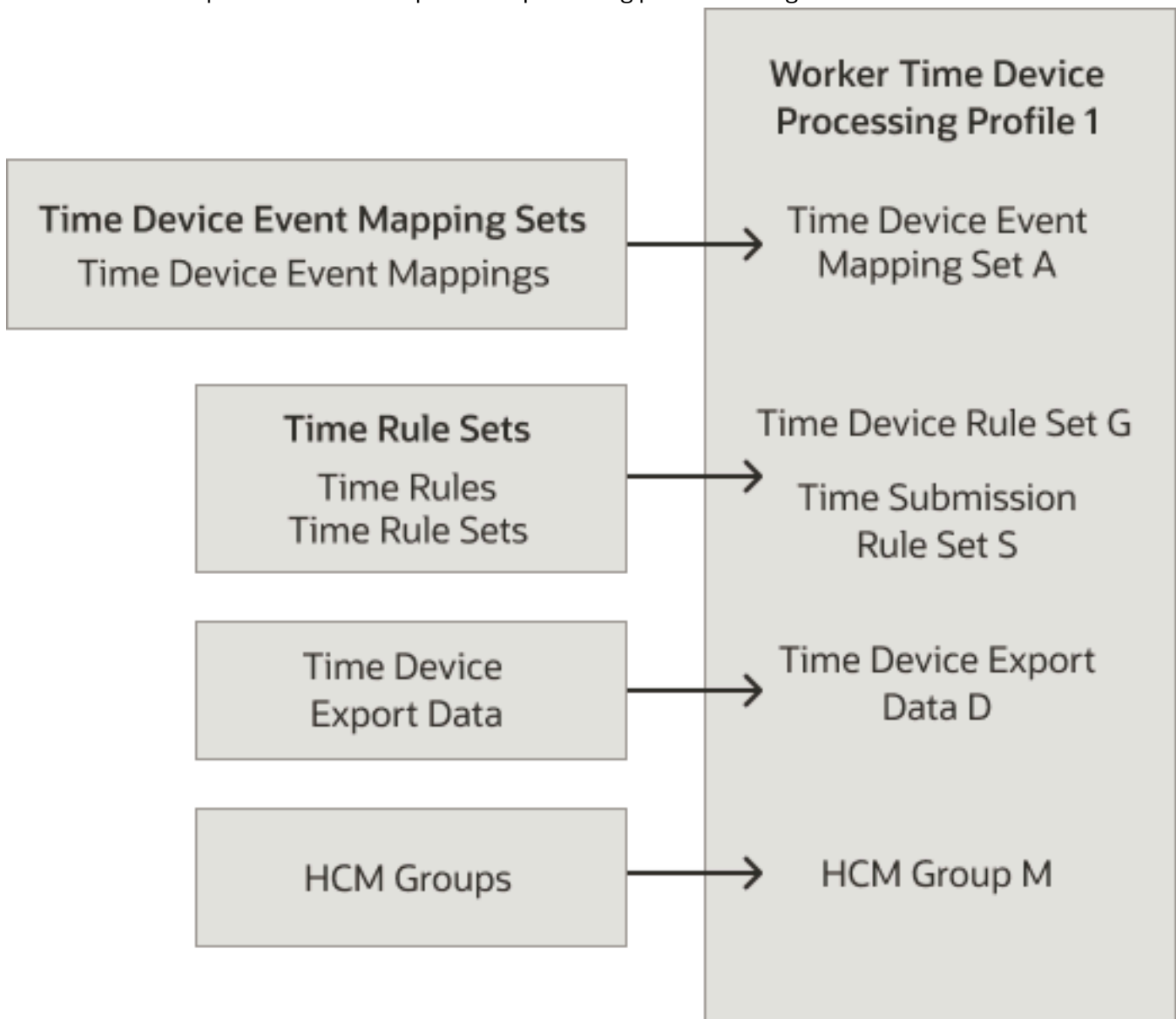
45 Time Device Processing Profiles

How Time Device Processing Profile Components Work Together

A time device processing profile identifies the application events and time attributes that form the time card entries for linked individuals. It also specifies how to validate the time entries and when to automatically save and submit the time cards.

You create these profiles using the Time Device Processing Profiles task in the Setup and Maintenance work area. The task is part of the Workforce Deployment offering, Time and Labor functional area.

Here's how the components that make up a device processing profile work together.



Time Device Event Mapping Set

A time device event mapping set identifies the time card entries generated for the linked individuals, from time collection device events.

A mapping set doesn't apply to Web Clock events because the application event and time attributes are part of the button configurations. To run device and submission rules for clock events, you can create a profile that leaves this option blank.

Time Device Rule Set

A time device rule set collects related validation rules and rule sets that support time device processing policies. For example, automatically generate an information message if an In or Out event is outside the grace period for the

individual's scheduled shift. Generate warning messages if the event is inside the start early or late periods or stop early or late periods. And, generate error messages if the event is outside the early or late periods.

Time Submission Rule Set

A time submission rule set identifies when to automatically save and submit the time card generated for the device or clock event. For example, individuals linked to this profile badge or clock in at the start of their shifts, Monday through Friday. And they badge or clock out at the end of their shifts. They don't badge or clock in or out for breaks and meals. The rule in their set automatically saves their time cards after every Out application or clock event--at the end of their work day. The same rule also submits their time cards after the fifth Out application or clock event, which is at the end of their work week.

Time Device Export Data

A time device export data configuration sends relevant person, payroll, and schedule data to the time collection device used by the linked individuals. The time device uses this export data to complete each time event transaction created by the linked individuals.

Web Clock doesn't require export data because it gets person and schedule data directly from the time repository. And, relevant payroll time data]s part of each button definition. To run device and submission rules for clock events, you can create a profile that leaves this option blank.

HCM Group

An HCM group identifies people who share common characteristics. All group members and their managers inherit the event mapping set, device and submission rule sets, and export data in their assigned device processing profile. Group members who use Web Clock, and their managers, inherit the device and submission rule sets in their assigned device processing profile. You can assign each HCM group to only one device processing profile at a time.

Time Attributes for In and Out Event Matching

You can select one or more time attributes to use to match In and Out device events, to create time entries.

An In event makes up the first part of a time entry. The incomplete entry becomes a complete entry when an Out event matches to it. Time card processing matches an Out event to the nearest In event before it, accounting for any matching time attribute option.

In Has Attribute and Out Doesn't

Here are the two most recent device events received:

- In event with a Payroll Time Type of Regular

- Out event without a payroll time type

These two events make up a time entry with the Regular payroll time type attribute.

In Doesn't Have Attribute and Out Does

Here are the two most recent device events received:

- In event without a payroll time type
- Out event with a Payroll Time Type of Meal

These two events make up a time entry with the Meal payroll time type attribute.

In and Out Have Different Attribute Values

Here are the two most recent device events received:

- In event with a Payroll Time Type of Regular
- Out event with a Payroll Time Type of Meal

While both events have a Payroll Time Type value, the values are different and thus the events don't match. These events make up two incomplete time entries:

- An entry with the start time and an In event with the Regular payroll time type that's missing the stop time of the Out event
- An entry with the stop time and an Out event with the Meal payroll time type that's missing the start time of an In event

Someone needs to fix these incomplete entries before the time card can be submitted.

In and Out Have Same Attribute Values

Here are the two most recent device events received:

- In event with a Payroll Time Type of Regular
- Out event with a Payroll Time Type of Regular

These two events make up a time entry with the Regular payroll time type attribute.

Group Assignments on Time Profiles

You use start and end dates to assign time entry, processing, and device processing profiles to groups of individuals for these reasons:

- You can assign more than one group to a single profile. For example, you assign the USA_Individs profile to the FullTime_USA_Individs and PartTime_USA_Individs groups.
- You can't assign a single group to more than one profile of the same type at the same time. For example, the FullTime_USA_Individs group can't have active assignments for both the USA_Individs and UK_Individs time entry profiles.

Priority of Time Profiles

You assign each time entry, processing, and device processing profile a unique priority number relative to other profiles of the same type.

The priority decides an individual's profile if they're eligible for multiple profiles of the same type. The highest priority is 1. For example, an individual is linked to these two time entry profiles:

- US_Western, which has a priority of 5
- US_CA, which has a priority of 3

Because US_CA has a higher priority, that time entry configuration applies.

How Time Profiles Get Derived

Through HCM group membership, an individual can be eligible for multiple time entry, processing, and device processing profiles. The assignment type for each of an individual's eligible profiles decides the single profile of each type that applies.

Priority	Assignment Type	Derivation Description
1	Individual Assignment	The profile with this assignment has the highest priority and overrides all group profile assignments.
2	Group Assignment	The profile with the lowest priority applies when multiple group memberships qualify an individual for multiple profiles of the same type.
3	Default Group Assignment	The profile with this group assignment applies to all individuals who don't have any profile assignments. This way, they can report time and that time can get processed and transferred to the appropriate time consumers.

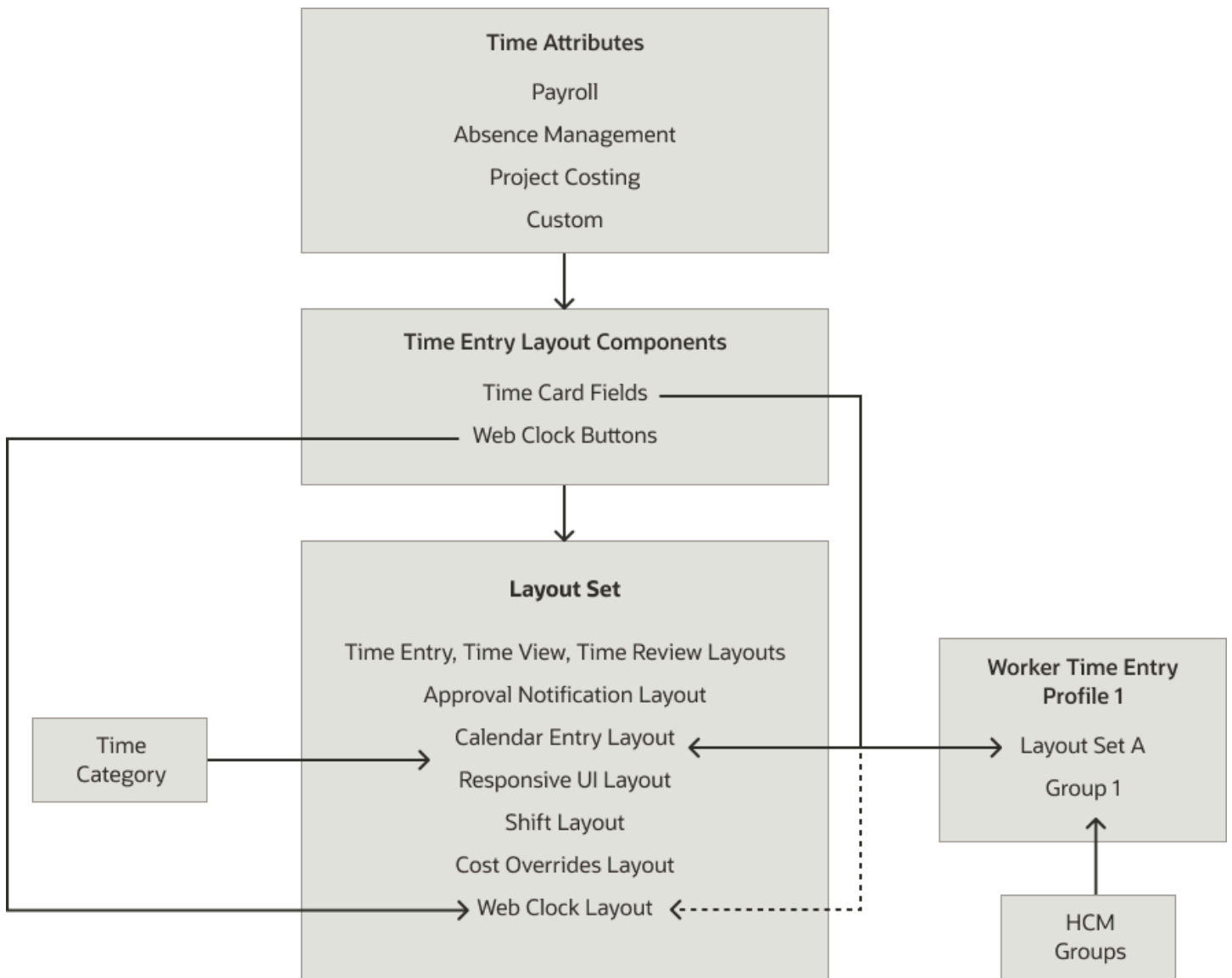

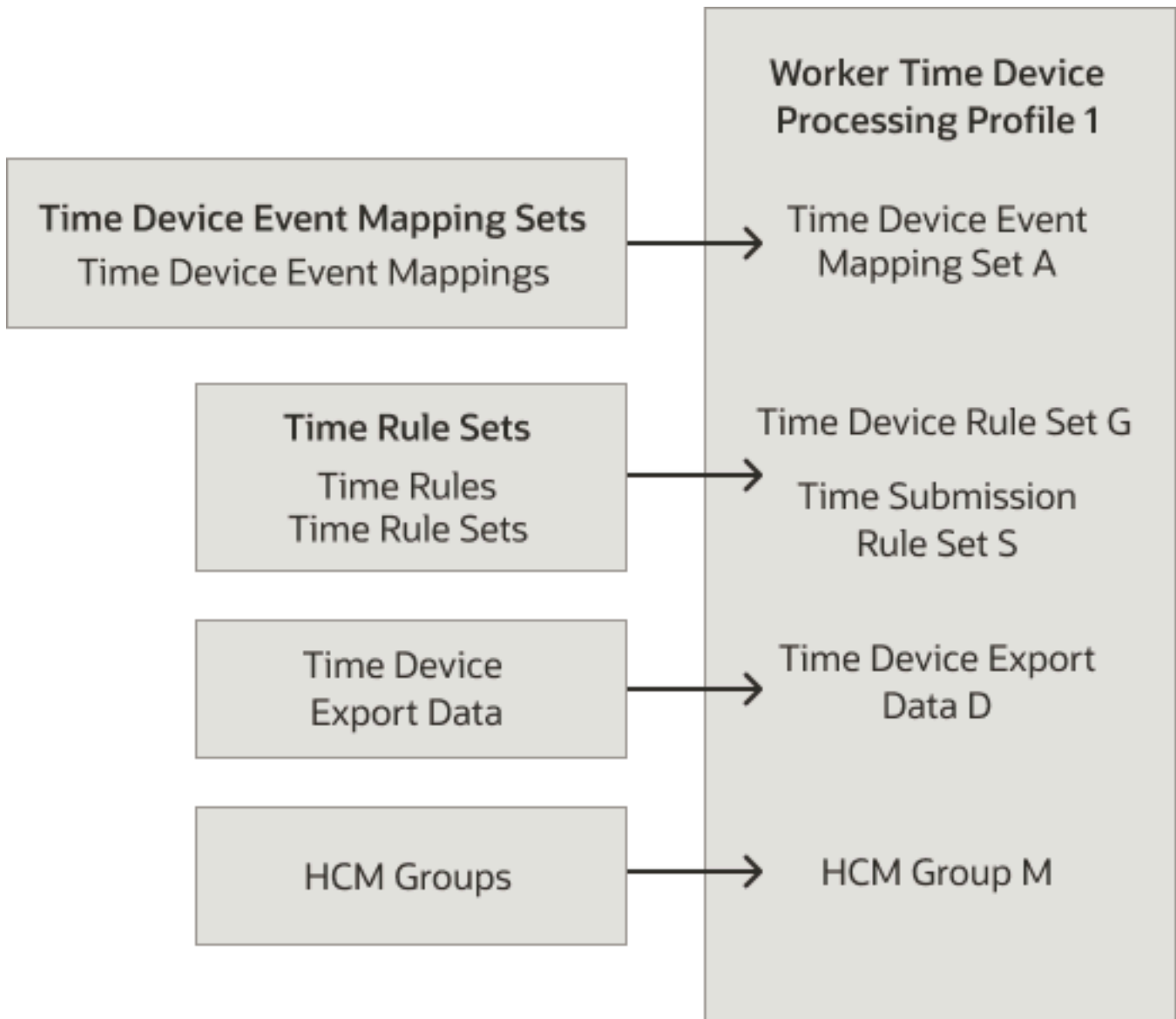

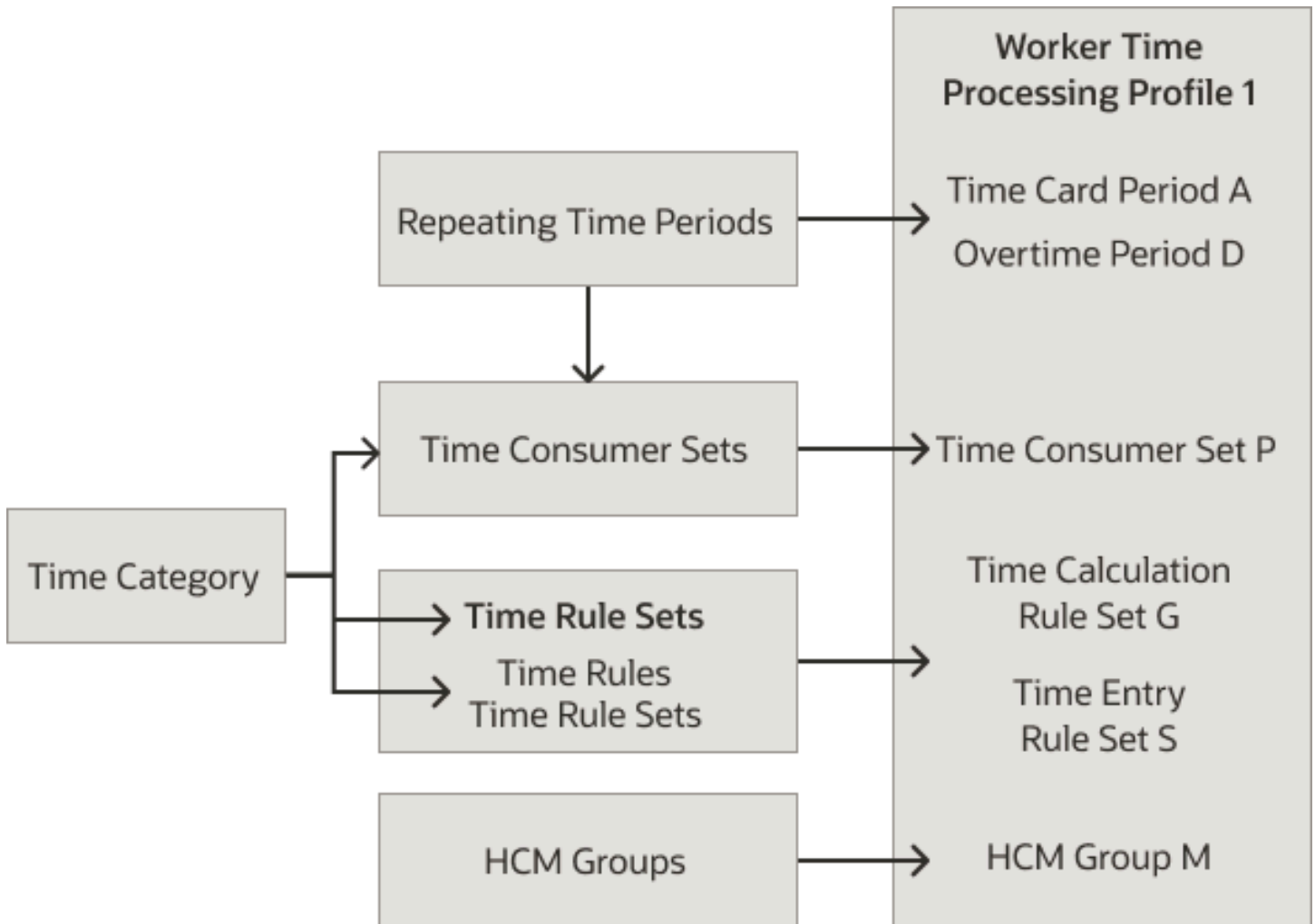

Compensatory Time and Time Cards

You can need people to work excess hours outside of their regular work schedule, such as overtime hours or hours worked on a holiday.

You can convert these excess hours to earned compensatory time off, also known as time off in lieu (TOIL), instead of monetary compensation. People can then record absences against the defined compensatory plan specific to your policies when they take time off in the future.

Here's how people earn and use compensatory time:

1. They report earned time on the same Oracle Time and Labor Cloud time cards that they use to report regular worked hours. This earned time transfers to Oracle Absence Management Cloud and updates the corresponding plan balance.
2. They apply for paid time off using the corresponding compensatory absence plan.

To provide seamless integration between Time and Labor and Absence Management, you need to complete some setup tasks. When you finish, compensatory time reported on time cards will automatically transfer to the corresponding absence plans.

How You Override the Work Location for Accurate Absence Accrual Calculations

For people in the US to accurately accrue time off, the time entry process reads and stores the work location set in their assignments. You can let these people override the assignment work location on their time cards.

Use these delivered time attributes: Work Location Overrides and Work Location with US Hierarchy Overrides. The data sources for the work location override time attributes use a delivered value set of valid HR work locations. You can create your own value set using the delivered set as a template.

You can also define time balances for people in the US using delivered time balance dimensions that include these location attributes:

- State (area1)
- County (area2)
- City (area3)

Then, you can use the time balances and generated database items in absence accrual formula to include time card hours in absence calculations. Here are descriptions of the supported actions for each time attribute.

Delivered Time Attribute	Actions
Work Location Override	Overrides the work location of time balances used by absence accruals
Work Location with US Hierarchy Overrides	Overrides the work location of time balances used by absence accruals Transfers the state, county, and city values to payroll for processing

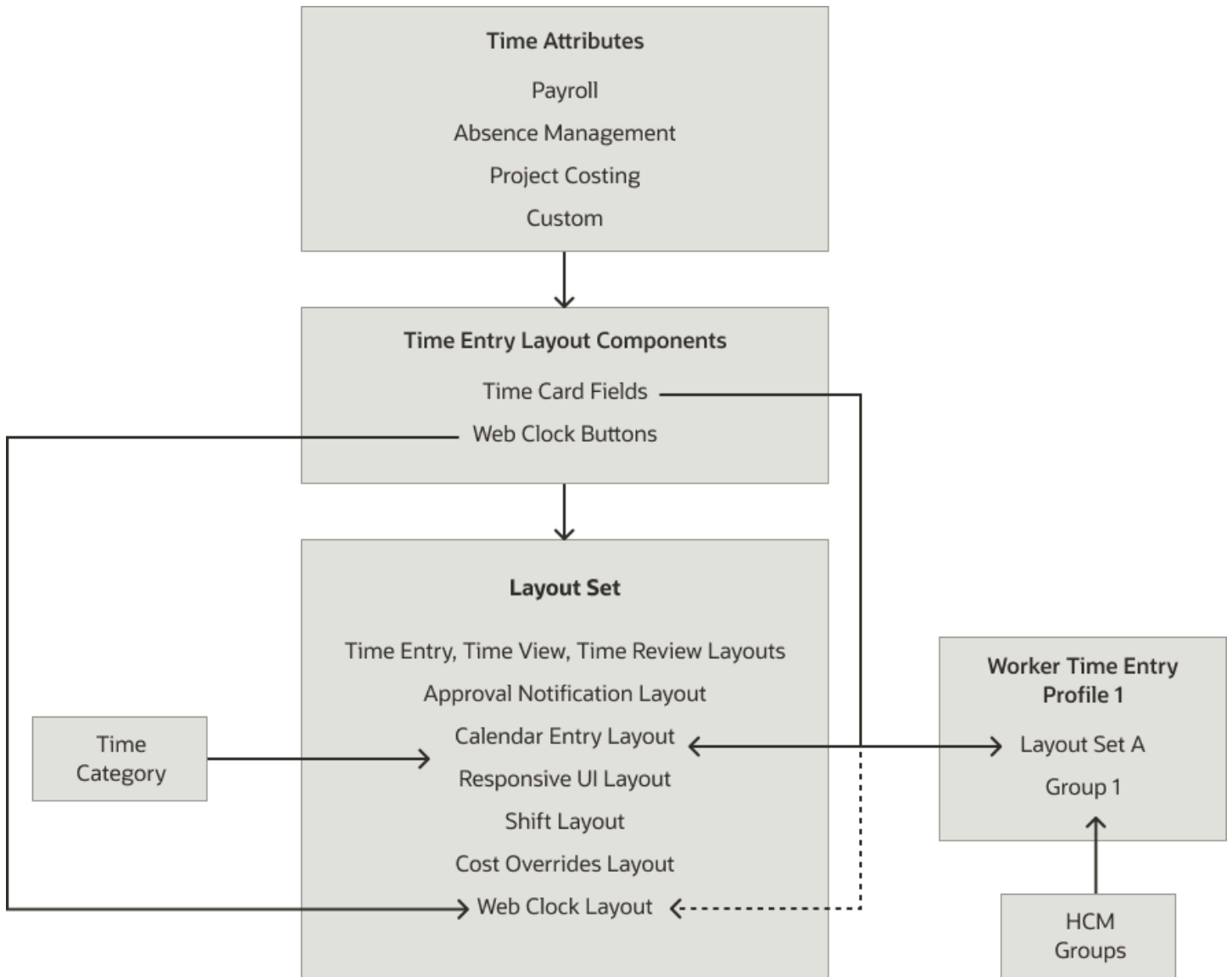

2. Create elements to store payroll time types from the time card and to transfer time to payroll or a third-party application for processing.
3. Create rate definitions to show default and payroll calculated rates on time cards and get overrides from time card entries.
4. Create the relevant calculation value definitions to link elements and rate definitions.
5. Confirm that the Employment page has the Time Card Required option selected for each person who reports time.

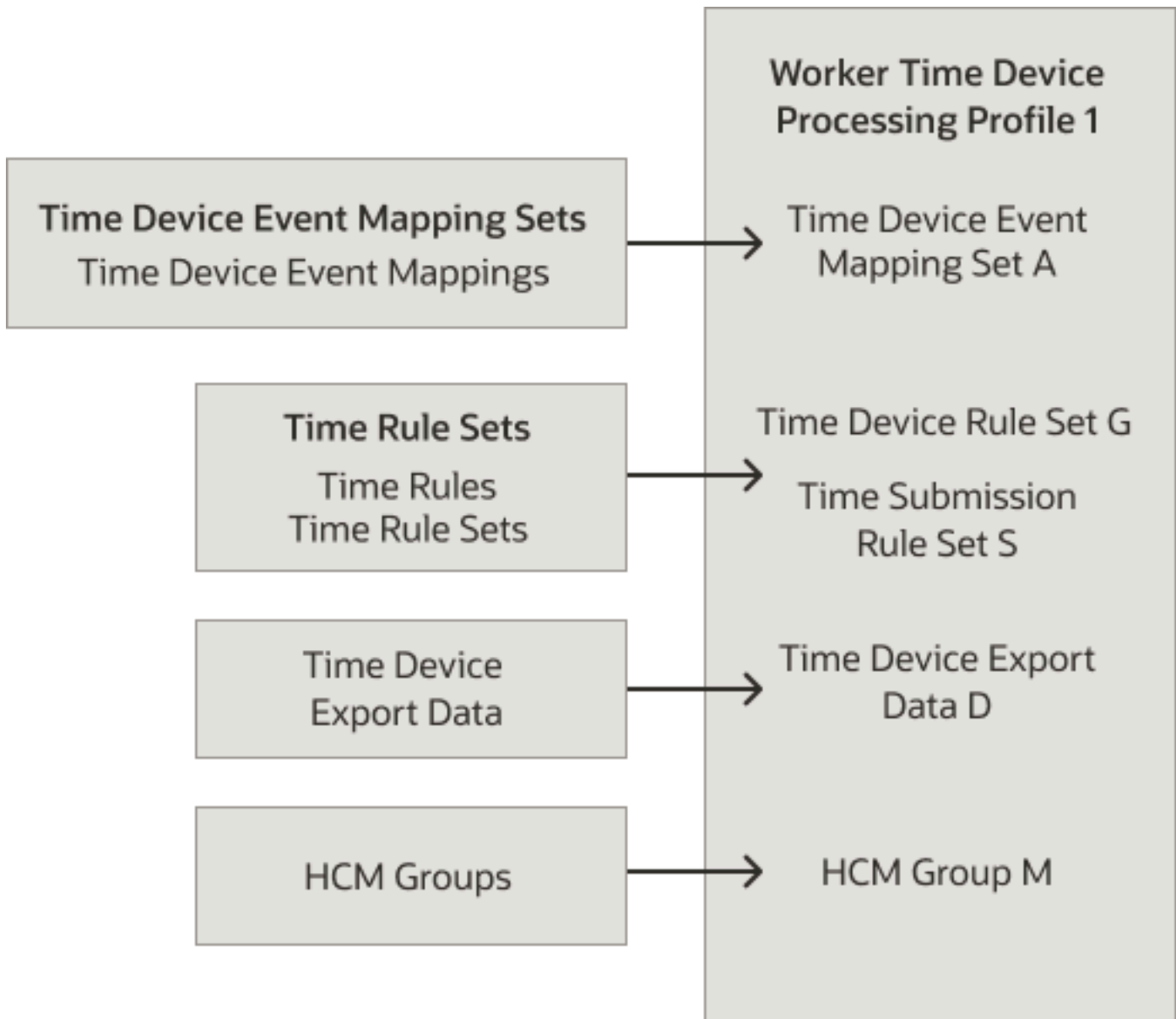

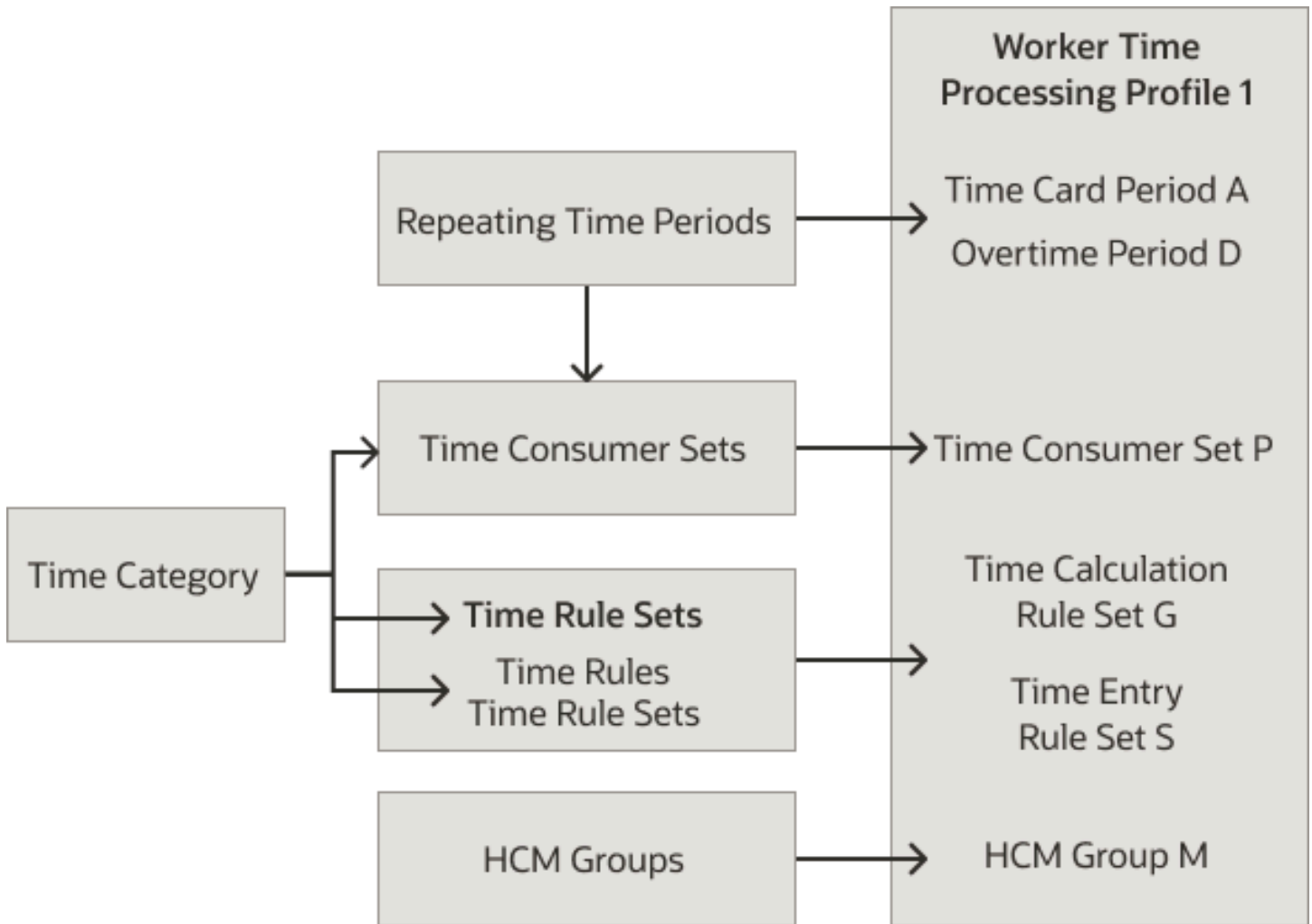

Create Time Card Elements for Time Entries

Time card elements support hours-based and units-based quantities. You use the hours-based quantities to assign people a flat payment amount through associated rates. For example, you pay people a meal allowance according to the number of meals they take daily.

When you create a time card element, you also create the related payroll elements, balances, formulas, and calculation components.

Tip: If people report regular and straight time portions of overtime separately, create two elements, such as Overtime and Overtime Premium. If they report the portions together, you might use straight time instead of regular time, and create a separate element for the overtime premium.

1. Create the payroll element.
 - a. In the Setup and Maintenance work area, click the **Elements** task.
 - Offering: Workforce Deployment
 - Functional Area: Elements and Formulas
 - b. On the Elements page, click the **Create** icon.
 - c. On the Create Element dialog box, complete these steps:
 - i. Select the legislative data group, such as **FR LDG**, **Hong Kong LDG**, or **US LDG**.
 - ii. Select the primary classification, such as **Regular Earnings** or **Earnings**.
 - iii. When available, select the secondary classification.
 - iv. Select the **Time Card** category.
 - v. Click **Continue**.
2. On the Create Element: Basic Information page, complete these steps:
 - a. Enter a descriptive name, such as **Regular**, **Stright Time**, **Overtime**, or **Shift Pay**.
 - b. Enter the name that you want to display on reports containing this payroll element.
 - c. Select the effective date **January 1, 1951**. The early date ensures that the element attributes are immediately available to use with shifts, time cards, web clock, and time collection devices.
 - d. Click **Next** to accept the remaining default values.
3. On the Create Element: Additional Details page, complete these steps:
 - a. Select **Days**, **Hours**, or **Other Units** as the calculation units for reporting.
 - b. Select the Work Units conversion rule. For the calculation used by each conversion rule, see *Conversion Rule Options for Configuring Additional Details of Payroll Elements*.
 - c. Click **Next** to accept the remaining default values.
4. On the Create Element: Review page, complete these steps:
 - a. Review the element configuration to ensure that everything is correct.
 - b. Click **Submit** to create the element and automatically generate all the related elements, balances, formulas, and calculation components.

By default, the Time Card category elements already have the appropriate value definition configurations required to support location overrides. You don't have to make any edits.
5. On the Element Summary page, configure element eligibility by completing these steps:
 - a. In the Elements Overview section, select **Element Eligibility**.
 - b. On the Actions menu, select **Create Element Eligibility**.
 - c. In the Information section, enter an element eligibility name with a suffix that identifies the criteria. For example, for the regular element with open eligibility--no selected criteria--the name would be **Regular Open**.
 - d. Select the eligibility criteria. To leave eligibility open on the element and control it with HCM groups and time processing profiles, skip this step.
 - e. Click **Done**.

6. Configure element eligibility for each of the related elements, which share the same name as this element and have suffixes. Suffixes include Earnings Calculator, Earnings Distributor, Earnings Results, Retro, and Retro Results.
 - a. On the Manage Elements page, search for the element that you just created.
 - b. Click the related element name.
 - c. On the element summary page, complete these steps:
 - i. In the Elements Overview section, select **Element Eligibility**.
 - ii. On the Actions menu, select **Create Element Eligibility**.
 - iii. In the Information section, configure the same eligibility criteria as the original element.
 - iv. Click **Submit**.
 - v. Click **Done**.

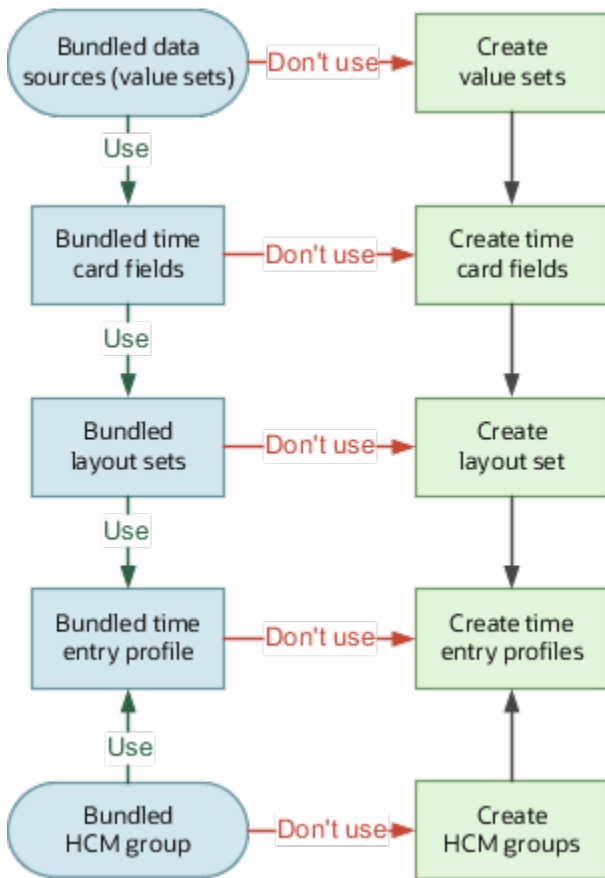

Overview of Time Entry Configuration for Only Project Costing and Project Costing and Payroll Combined

You can let people report only project costing time on time cards or project costing, payroll, and absence time. You can use delivered data sources, time card fields, layouts, HCM groups, and time entry profiles.

These layout configurations support time reporting for only project costing or project costing according to team membership. There's also a layout that supports reporting time for project costing, payroll, and absences combined. Or you can create your own configurations, as shown here.



If you create your own value sets and time card fields, then you need to create your own layout sets and time entry profiles. You also need to create layout sets and profiles if you use delivered fields that the delivered layout sets don't include. For example, you want to track funding sources and expenditure organizations for sponsored projects using delivered fields. To do this, you need to create layout sets that include these fields and profiles that link to the new layout sets.

To use the delivered time entry configurations with your own HCM groups, you only need to create time entry profiles. You can link the delivered value sets, time card fields, and layout sets to your HCM groups using your profiles.

Tip: To save time if you create your own objects, search for and duplicate the closest delivered project costing or project costing and payroll object.

Choice List Filters for Project Costing Time Cards

Time cards derive values for certain project-specific drop-down lists.

Projects That Are Correct for the Person

To find the appropriate projects for the person, the time card uses their business unit. If the time card also filters by team membership, the project names and numbers are for projects where the person is a team member.

Tasks That Are Correct for the Person

To find the appropriate tasks for the person, the time card uses the selected project name or number. If the time card also filters by team membership, the tasks are for projects where the person is a team member.

Expenditure Types That Are Correct for the Project

To find the appropriate project unit, the time card uses the selected project. It then uses the derived project unit to find the appropriate expenditure types.

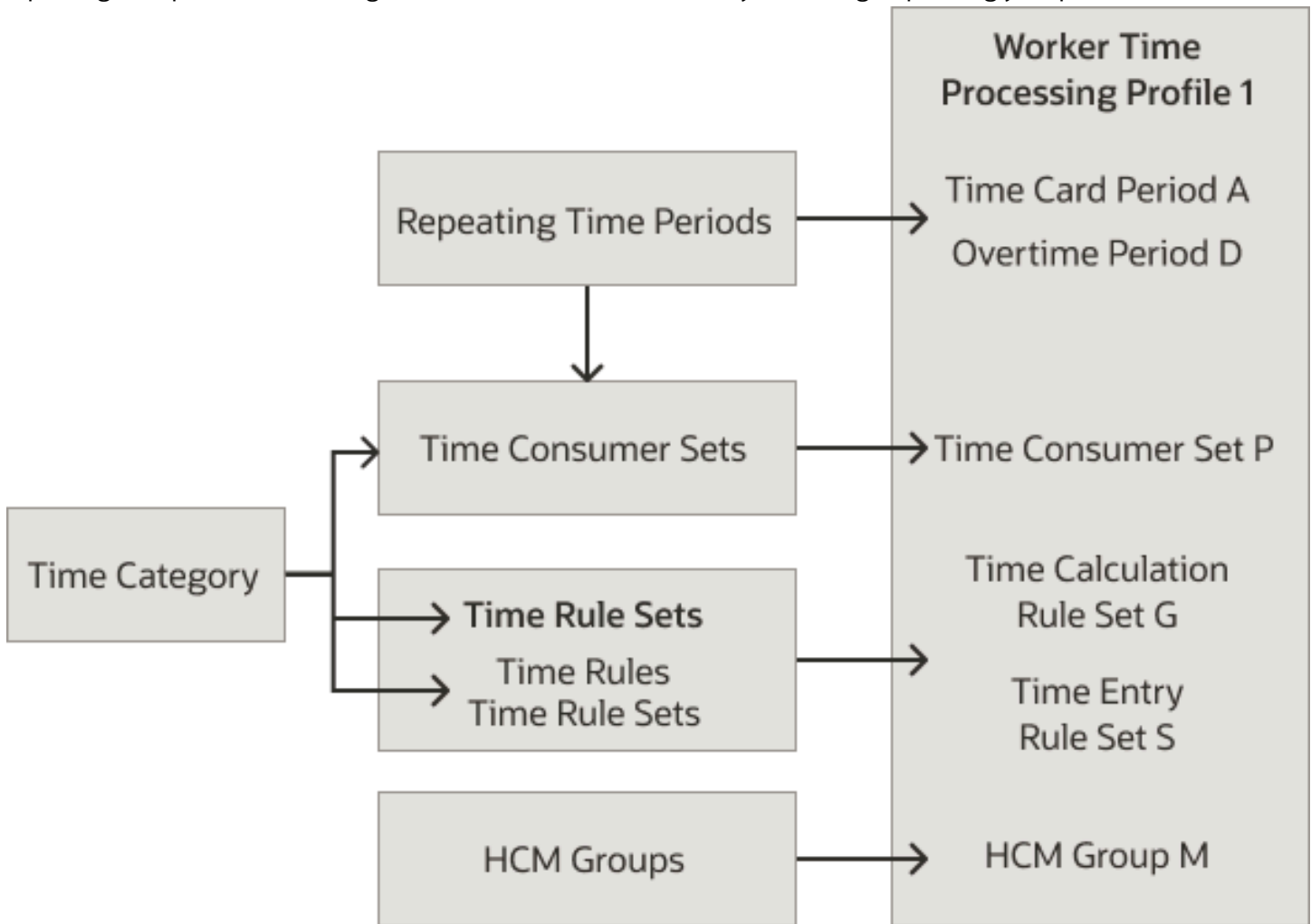

To process time data for only project costing or project and payroll combined, you can use delivered time processing profiles. These profiles use delivered repeating time periods, time categories, time consumer sets, and HCM groups.

The profile configurations support project-specific time processing. Or you can create your own configurations, as shown here.

If you create any of your own repeating time periods, time categories, and time consumer sets, then you need to create your own processing profiles. To use the delivered time processing configurations with your own HCM groups, then you only need to create time processing profiles. You can link the delivered

repeating time periods, time categories, and time consumer sets to your HCM groups using your profiles.

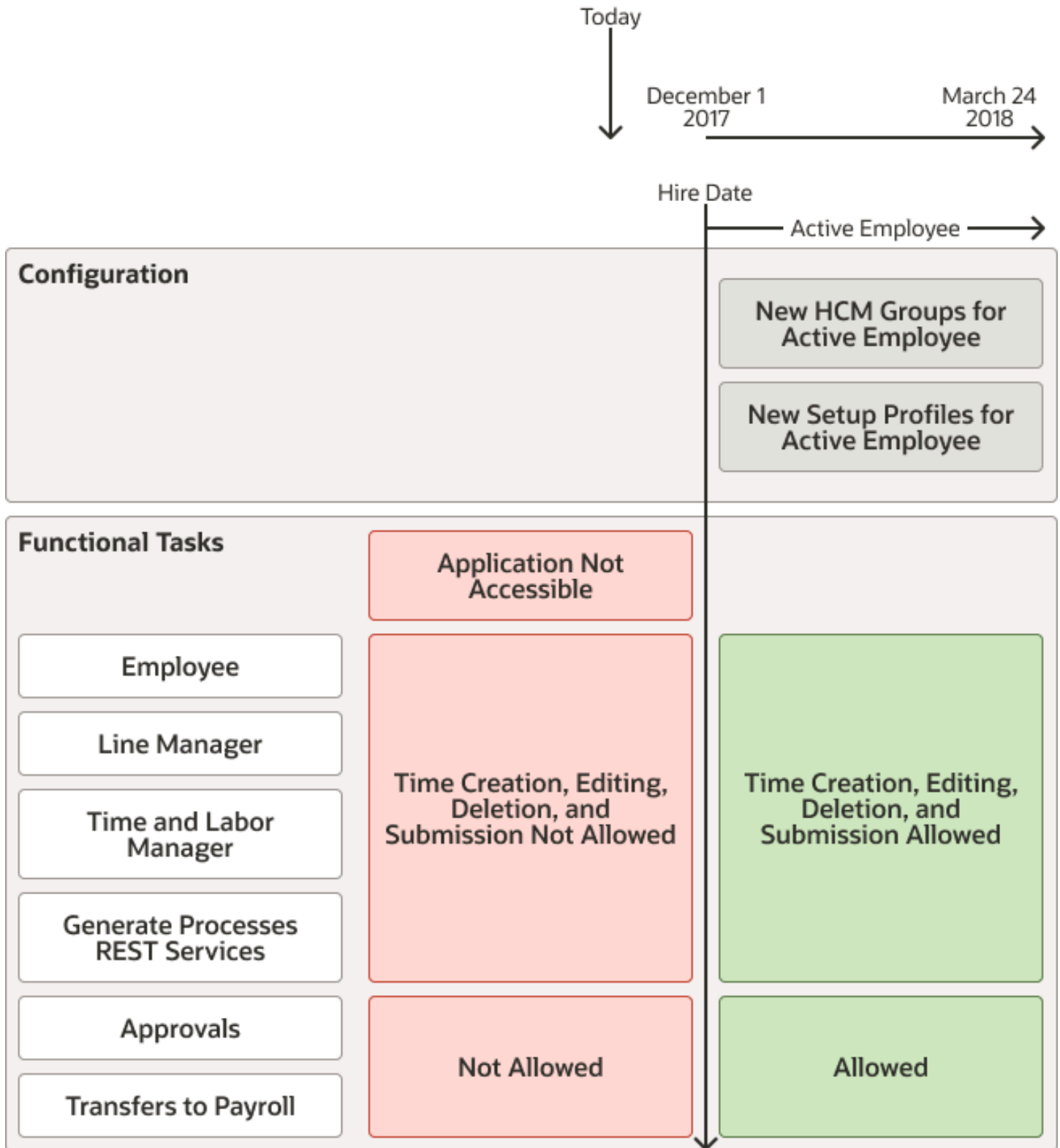

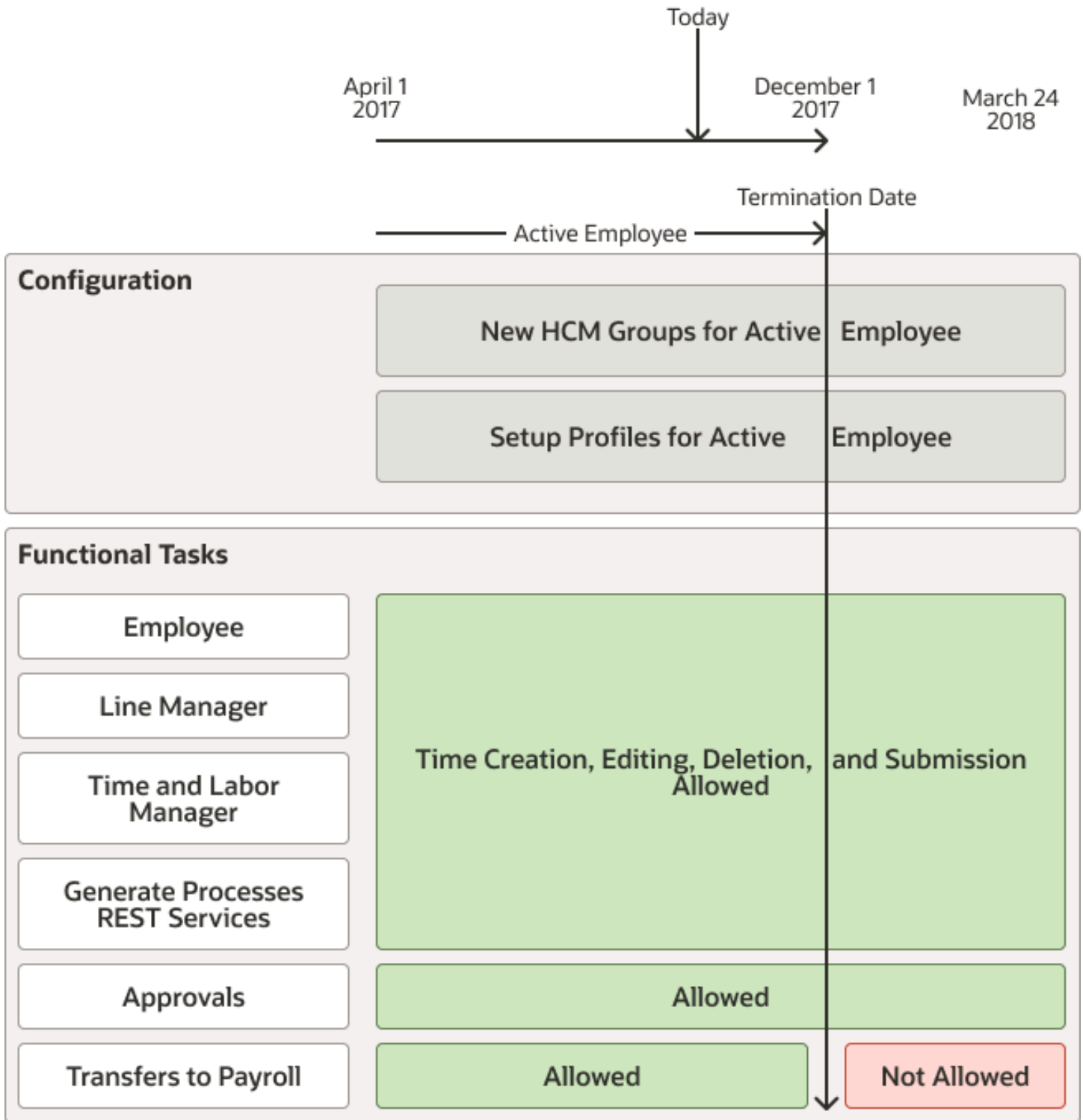

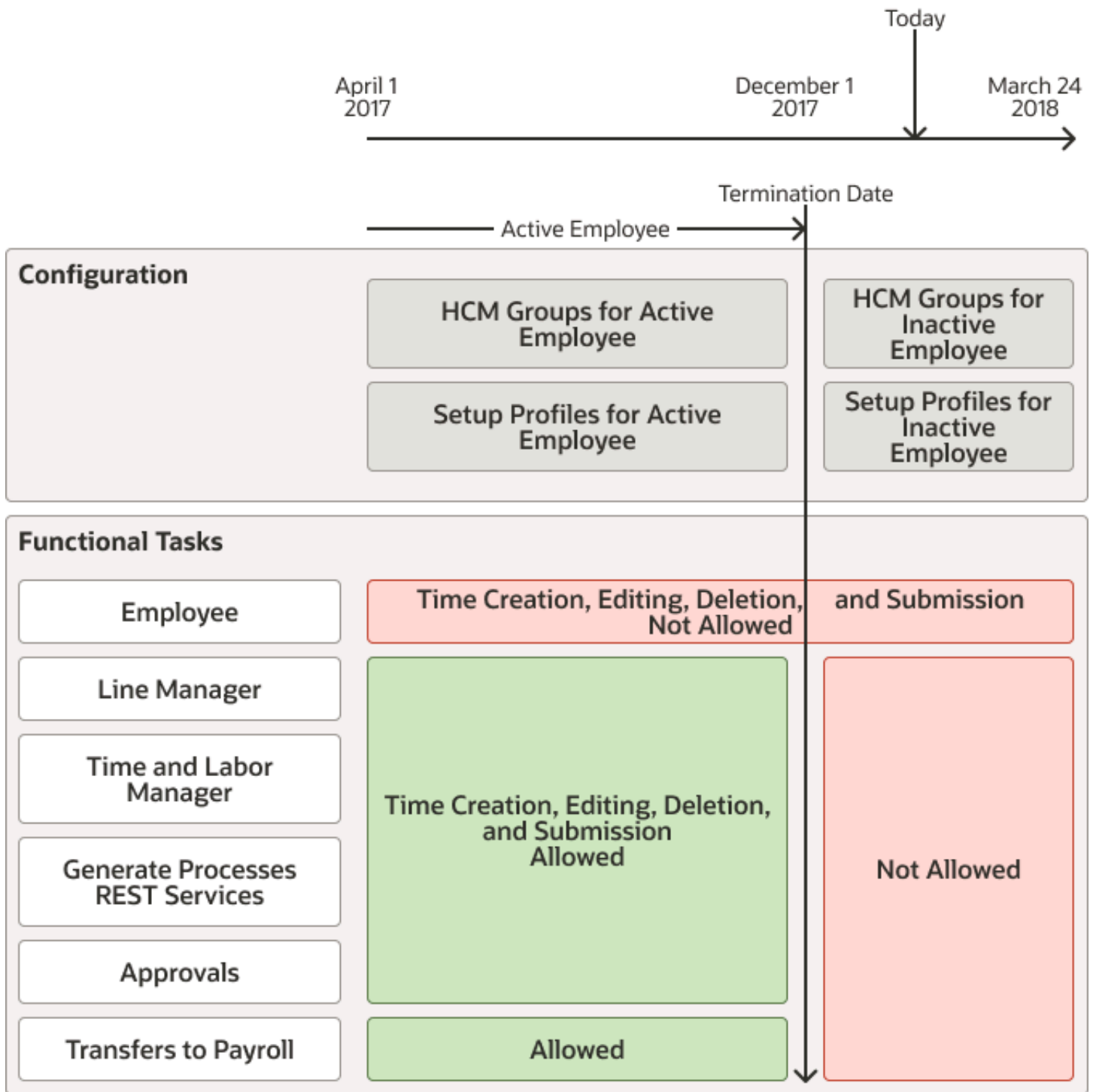

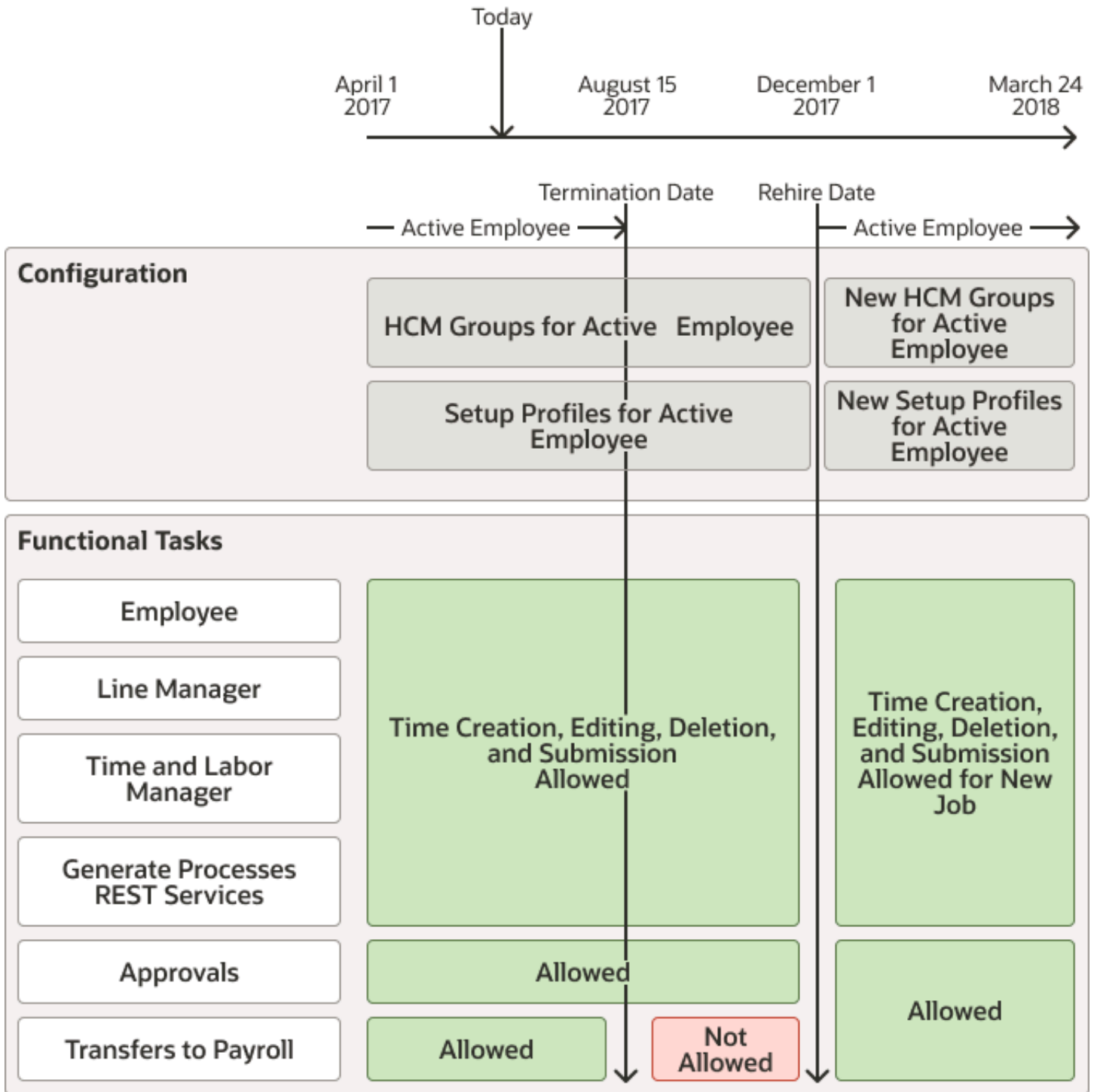

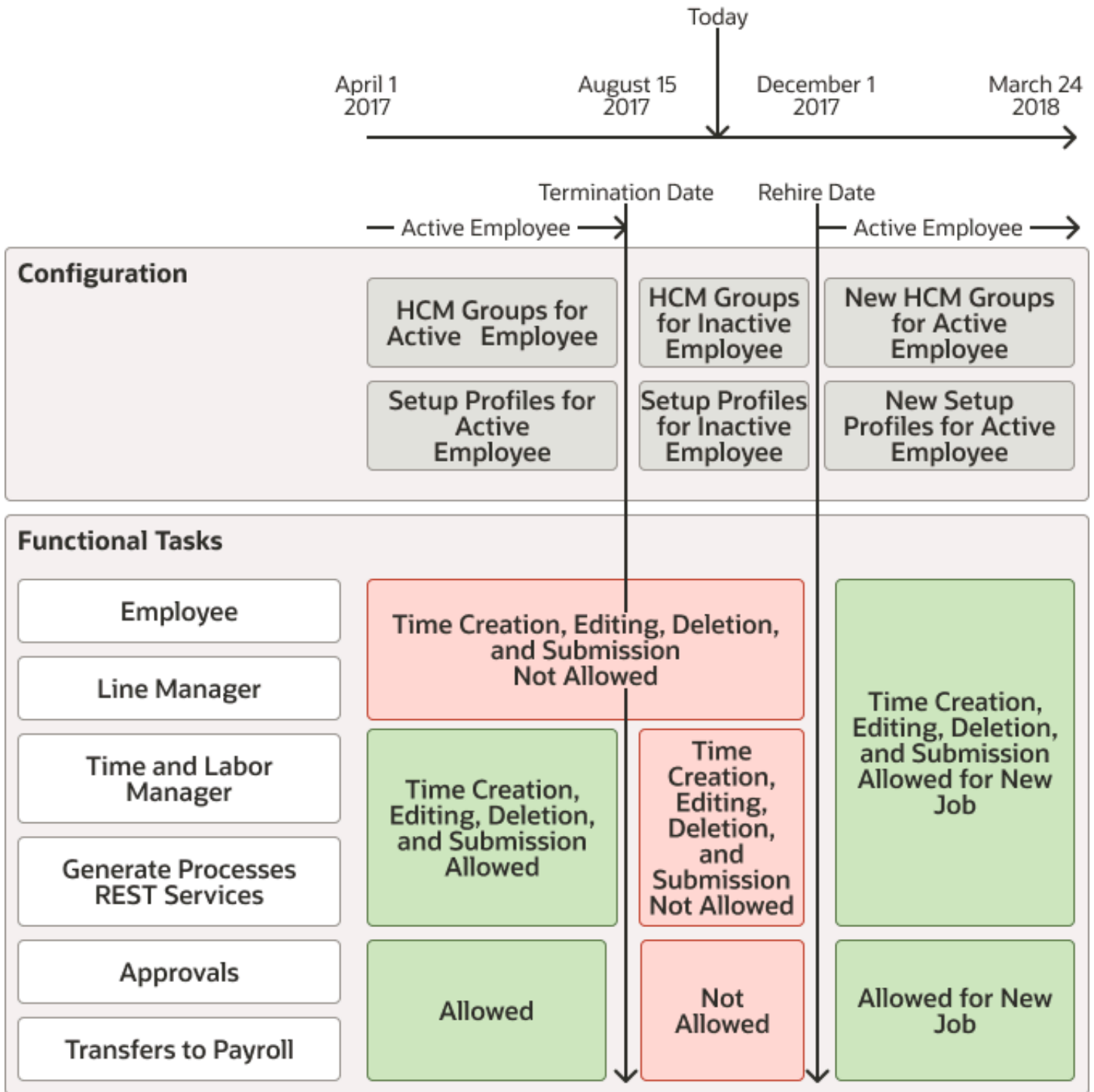

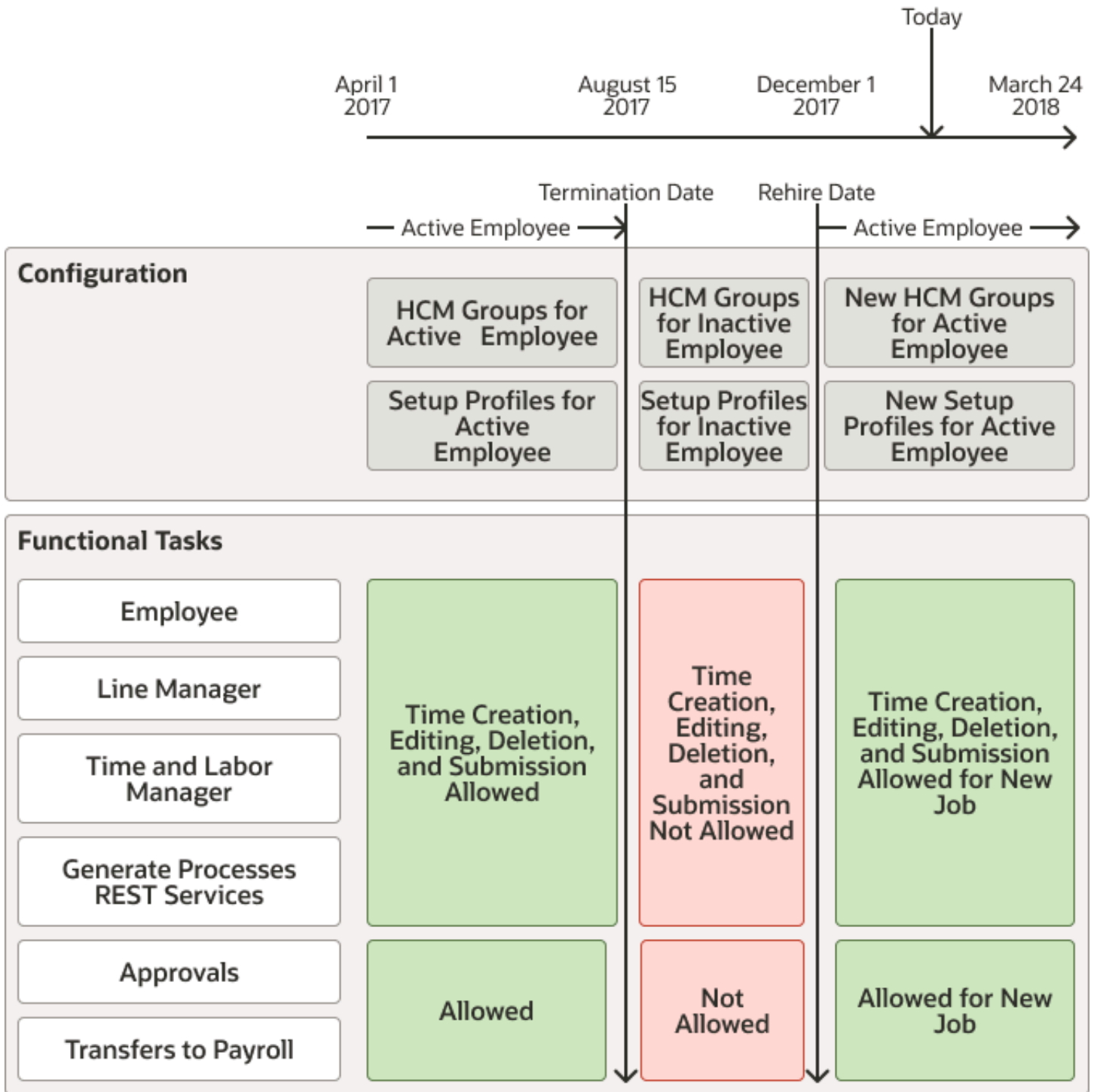
