# 1 Introduction

## Introduction to EOY Guide

This document is intended to provide the general requirements for end-of-year processing for Canada.

End-of-Year processing consists of multiple steps, which you must complete in the correct order. Specific information regarding the steps involved can be found in relevant sections of this guide as mentioned in this table.

## End-of-Year Processing for Canada

At the end of every tax year, as a Canadian employer, comply with these statutory requirements:

- Submit to Canada Revenue Agency (CRA) the following federal year-end slips, if applicable:
  - T4: Statement of Remuneration Paid
  - T4A: Statement of Pension, Retirement, Annuity, and Other Income
- If you operate in the province of Quebec, submit to Revenu Québec these year-end slips, if applicable:
  - RL-1: Employment and Other Income
  - RL-2: Retirement and Annuity Income

Submit these year-end slips to your employees for tax filing purposes.

**Note:** During a reporting year, if you haven't paid any earnings reported on any of the year-end slips, then you need not submit that particular year-end slip.

The tax reporting year is January, 01 through December, 31. All payrolls or balance adjustments with a payment date during that time frame are included in the year-end slip for that year.

The end-of-year processing for Canada consists of multiple steps, which you must complete in the correct order.

End-of-year processing includes these activities:

1. Configuring end-of-year reporting

Before beginning your end-of-year reporting, complete these operations:

- o Configuration for Quebec
- o Tax reporting unit (TRU) setup
- o Element setup
- o Year-end balance feeds

2. Archive end-of-year payroll results

Use the Archive End-of-Year Payroll Results process to retrieve employee and employer information, including employee balances in a given year for a payroll statutory unit (PSU) and TRU. The Archive End-of-Year Payroll Results process archives the data for year-end reporting.

3. Validate the year-end slips data

Before you generate the year-end slips, ensure that the slips don't contain any errors or missing information. Generate the End-of-Year Exception Report for each slip to review and correct any errors or discrepancies in transmitter, employer and employee data. If data corrections are required, correct the data and run the exception report to check if the exceptions reported earlier are resolved. Continue repeating the process of rollback and rerun of the archive process until all errors are resolved.

4. Perform year-end payroll reconciliation

Before you use the archived payroll results data to generate the year-end slips, review and validate the results data for each slip.

Generate the end-of-year register report to review and validate the results data for each slip. Compare this data against the archived data to assist in reconciling your periodic payrolls and year-end balances. If changes are required, perform balance adjustments and if required, modify employee and employer data.

5. Resolve any balance errors detected

## 2 End-of-Year Configuration

### Overview of End-of-Year Configuration Tasks

Before beginning your end-of-year reporting, perform these tasks:

- Configuration for Quebec
- Tax reporting unit (TRU) setup (to configure the transmitters)
- Element setup
- Year-end balance feeds
- Year-End Reporting Information Card Component
- Document delivery preference setup (to allow employees to view their year-end documents in self-service)
- Year-End Documents Publish Date

### Set the Scope

Before you perform any operation on the legal entity, first set the scope for the tasks. It can be a legal entity or a payroll statutory unit (PSU), if designated as such in payroll, or the legal reporting unit (or TRU in payroll). This sets the PSU and TRU to the appropriate entity for the task itself so you can perform any operations for them. For example, before you update the interface rules or add registrations, set the scope to the PSU or TRU you're working with.

**Note:** If the scope is already set for the task, the Scope column displays the TRU or PSU name.

To set the scope for the PSU:

1. Navigate to the following:
  - Work Area: Setup and Maintenance
  - Offering: Workforce Deployment
  - Task: Define Legal Entities for Human Capital Management
2. Click **Define Legal Entities for Human Capital Management** task to expand the entry and display a list of related tasks.
3. Click the **Select Scope** link for the Manage Legal Entities task or any other task for the legal entity.
4. In the Select Scope window, select **Manage Legal Entity**.
5. In the Legal Entity field, select **Select and Add** and click **Apply and Go to Task**.
6. In the Select and Add: Manage Legal Entity page, search for and select the appropriate PSU.
7. Click **Save and Close** twice.

The Scope column on the tasks list page displays the name of the PSU you selected as the scope for the tasks related to the legal entity.

To set the scope for the TRU:

1. Navigate to the following:

- Work Area: Setup and Maintenance
  - Offering: Workforce Deployment
  - Task: Define Legal Entities for Human Capital Management
2. In the search area, enter **Define Legal Entities** and click **Search**.
  3. Click **Define Legal Entities for Human Capital Management** task to expand the entry and display a list of related tasks.
  4. Click the **Select Scope** link for the Manage Legal Reporting Units task or any other task for the legal reporting unit.
  5. In the Select Scope window, select **Manage Legal Reporting Unit**.

The Legal Entity window displays the PSU you selected in the previous task, or the name of the PSU that the scope is currently set to.

6. In the Legal Reporting Unit field, select **Select and Add** and click **Apply and Go to Task**.
7. In the Select and Add: Manage Legal Reporting Unit page, search for and select the appropriate TRU.
8. Click **Save and Close** twice.

The Scope column on the tasks list page displays the name of the TRU you have selected as the scope for the tasks related to the legal reporting unit.

## Quebec Enterprise Number Setup

The Quebec Enterprise Number is a ten-digit numeric identifier assigned to businesses operating in Quebec. If you have a Quebec Enterprise Number, configure it at the legal entity level (or PSU, if designated as such in payroll). If configured, it's used in reporting to Revenu Québec, to identify the enterprise at a level higher than the Quebec Identification Number.

To set up the Quebec Enterprise Number at the PSU:

1. Navigate to the following:
  - Work Area: Setup and Maintenance
  - Offering: Workforce Deployment
  - Task: Manage Legal Entity
2. In the search area enter **Manage Legal Entity** and click **Search**.
3. Click **Manage Legal Entity HCM Information** task.
4. Enter the Legal Entity Name. This is also referred to as the PSU.
5. Click **Search** and select the Legal Entity in the search results window.
6. Select the **Payroll Statutory Unit** tab.
7. Click **Edit** and **Update**, or **Edit** and **Correct**.
8. Click **Quebec** and enter the **Quebec Enterprise Number**.
9. Click **Submit**, **Yes**, and **OK**.

## Quebec Provincial Tax Setup

If you operate in the province of Quebec, complete these additional setup tasks.

You typically set up the Quebec Provincial Tax information when you define your organization structures, and not necessarily during the time of processing the payroll or at year-end. However, confirm this configuration before you perform any year-end processing so that your RL-1 and RL-2 processing is successful.

- *Quebec Provincial Tax Jurisdiction Registration Code*

The Quebec Provincial Tax jurisdiction must have the Quebec Identification Number (QIN) set up as the Legal Reporting Unit Registration Code.

**Note:** The Quebec Provincial Tax jurisdiction is predefined by Oracle. You must first use the **Maintain Canadian Geography** task to load the requisite provinces for which you need to create the jurisdictions.

To set up the Legal Reporting Unit Registration Code for QIN:

- Navigate to **Setup and Maintenance**.
- Search for and select **Manage Legal Jurisdictions** task.
- In the Manage Legal Jurisdictions page, enter **QC** (for Quebec) in the Territory field and click **Search**.
- Select **Quebec Provincial Tax** in the Search Results to display the Edit Legal Jurisdiction page.
- In the **Legal Entity Registration Code** field, select **Legal Entity Registration Number**.
- In the Legal Reporting Unit Registration Code field, select **Quebec Identification Number**.
- Click **Save and Close**.

- *Quebec Provincial Tax Registration*

Additionally, set up the Quebec Provincial Tax Registration information for each PSU or TRU that has employees in Quebec. Set up this information at either the PSU or the TRU level.

If you set up the Quebec Provincial Tax Registration at the PSU level, it's applicable for all the TRUs attached to the PSU, unless you override it on the TRU. Only enter this information at the TRU level, if it's different from that defined for the PSU. The Quebec Provincial Tax Registration associates the Quebec Identification Number (QIN) with the PSU or TRU.

- *Quebec Provincial Tax Registration at the PSU Level*

To set up the Quebec Provincial Tax Registration at the PSU level:

**Note:** You must first set the scope. If the scope isn't already set for the tasks, set the scope as given in the Set the Scope section.

- Navigate to **Setup and Maintenance**.
- Search for and select **Define Legal Entities for Human Capital Management** task.
- Select the **Manage Legal Entity Registrations** task.
- In the **Manage Registrations** page do either of the following:
  - If Quebec Provincial Tax doesn't already exist, click **Create**.
  - If Quebec Provincial Tax already exists, click **Edit**.

Enter or confirm the information in this table.

To set up the Quebec Provincial Tax Registration at the TRU level:

- i. Navigate to **Setup and Maintenance**.
- ii. Search for and select **Define Legal Entities for Human Capital Management** task.
- iii. Select the **Manage Legal Reporting Unit Registrations** task.
- iv. In the **Manage Registrations** page do either of the following:
  - o If Quebec Provincial Tax doesn't already exist, click **Create**.
  - o If Quebec Provincial Tax already exists, click **Edit**.

Enter or confirm the information in this table.

## Transmitter TRU Setup

To facilitate electronic submission of year-end reports, the government assigns a transmitter number to an employer. The Canada Revenue Agency issues an employer account number and Revenu Québec issues a Quebec identification number.

As an employer, you can designate an employer account number or Quebec identification number as the transmitter. The TRUs file their slips electronically through this transmitter.

A transmitter can file slips for itself or on behalf of other TRUs. Capture the transmitter information at the TRU level. If you designate a TRU as a transmitter, the information you enter for the TRU is used for year-end reporting to the government. Multiple TRUs with different account numbers can use the same transmitter to submit year-end information to the government.

## Configure the TRUs

Set up the transmitter information for each TRU prior to processing the end-of-year archive. Configure the transmitter information at the federal and provincial levels, as well as for each form type (T4, T4A, RL-1, RL-2). The application uses this data to generate the electronic files that you submit to the government.

As an employer you can designate multiple transmitter TRUs, but you must configure each transmitter with a unique transmitter number. This means that you register the TRU as a transmitter with the Canada Revenue Agency (for T4 and T4A) or Revenu Québec (for RL-1 and RL-2). Other TRUs are related to the transmitter TRU by attaching the Transmitter Name and Number in the transmitter information for this TRU.

The steps given here outline how you can configure the TRU as a transmitter or as a non-transmitter.

## Transmitter TRU for the T4 and T4A

To configure the TRU as the transmitter for the T4 and T4A:

1. Navigate to the following:
  - o Work Area: Setup and Maintenance
  - o Offering: Workforce Deployment
  - o Task: Define Legal Reporting Units for Human Capital Management
2. In the search area, enter **Define Legal Reporting Units for Human Capital Management** and click **Search**.
3. Click **Define Legal Reporting Units for Human Capital Management** to expand the entry and display a list of related tasks.
 

**Note:** If the scope isn't already set for the Manage Legal Reporting Unit Registrations task, set the scope as given in the Set the Scope section.
4. Click **Go to Task** for the Manage Legal Reporting Unit HCM Information task.
5. Enter search criteria and select the record.
6. On the Manage Legal Reporting Unit page, select the **Tax Reporting Unit** tab.
7. Click **Federal Tax Reporting Unit Information**.
8. Click **Edit-Update**.
9. On the Update Legal Reporting Unit form, select an **Action Reason**. Click **OK**.
10. In the T4 Interface Rules and T4A Interface Rules sections, enter these transmitter details for both the T4 and T4A rules.

Field Name	Field Value
Transmitter TRU	Select <b>Yes</b> to designate the TRU as a transmitter. This indicates the Employer Account Number is registered as a transmitter with the Canada Revenue Agency (CRA).  <b>Note:</b> You can designate multiple transmitter TRUs, but each transmitter must be configured with a unique transmitter number.
Transmitter Name	Search and select the name registered with the CRA.

Field Name	Field Value
	<p><b>Note:</b> This list of values contain only transmitters that already exist. If the required Transmitter Name isn't yet available for selection, you must first create the transmitter TRU. Save the record, go back into the record, then select the Transmitter Name, and save the record.</p>
Transmitter Number	Enter the number assigned by the CRA to report the year-end slip data electronically. The format is MMXXXXXX, where X is a number.
Transmitter Type	Select the associated transmitter type from the list.
Transmitter Contact Name	Enter the contact name of the transmitter.
Transmitter Contact Area Code	Enter the contact area code of the transmitter.
Transmitter Contact Phone Number	Enter the contact phone number of the transmitter. Enter only the numbers, without spaces or dashes.
Transmitter Contact Extension Number	Enter the contact extension number of the transmitter.
Transmitter Contact Email	Enter the contact email of the transmitter.
Transmitter Secondary Contact Email	Enter the email for a secondary contact of the transmitter.
Language of Communication	Enter the language of communication of the transmitter.
Transmitter Country	Enter the country of the transmitter.
Transmitter Province	Enter the province of the transmitter.
Transmitter City	Enter the city of the transmitter.
Transmitter Address Line 1	Enter the address line 1 details of the transmitter.
Transmitter Address Line 2	Enter the address line 2 details of the transmitter.
Transmitter Postal Code	Enter the postal code of the transmitter.

Field Name	Field Value
Contact Name for this Return	Enter the contact name of the employer.
Contact Area Code	Enter the contact area code of the employer.
Contact Phone Number	Enter the contact phone number of the employer. Enter only the numbers, without spaces or dashes.
Contact Extension	Enter the contact extension number of the employer.
Proprietor 1 Social Insurance Number	Enter the Social Insurance Number of the proprietor of the business.
Proprietor 2 Social Insurance Number	Enter the Social Insurance Number of the second proprietor, if applicable.

## Non-Transmitter TRUs for the T4 and T4A

To configure the non-transmitter TRUs for the T4 and T4A:

1. Navigate to the following:
  - o Work Area: Setup and Maintenance
  - o Offering: Workforce Deployment
  - o Task: Define Legal Reporting Units for Human Capital Management
2. In the search area, enter **Define Legal Reporting Units for Human Capital Management** and click **Search**.
3. Click **Define Legal Reporting Units for Human Capital Management** to expand the entry and display a list of related tasks.

**Note:** If the scope isn't already set for the Manage Legal Reporting Unit Registrations task, set the scope as given in the Set the Scope section.

4. Click **Go to Task** for the Manage Legal Reporting Unit HCM Information task.
5. Enter search criteria and select the record.
6. On the Manage Legal Reporting Unit page, select the **Tax Reporting Unit** tab.
7. Click **Federal Tax Reporting Unit Information**.
8. Click **Edit-Update**.
9. On the Update Legal Reporting Unit form, select an **Action Reason**. Click **OK**.
10. In the T4 Interface Rules and T4A Interface Rules sections, enter the following non-transmitter information for both the T4 and T4A rules.

**Note:** Only the fields listed in this table are required. The other fields are optional and you should only populate them if the information is different from that of the Transmitter TRU.

Field Name	Field Value
Transmitter TRU	Select <b>No</b> to designate this as a non-transmitter TRU.
Transmitter Name	Search and select the name registered with the CRA.  <b>Note:</b> This list of values contain only transmitters that already exist. If the required Transmitter Name isn't yet available for selection, you must first create the transmitter TRU. Save the record, go back into the record, select the Transmitter Name, and save the record.
Transmitter Number	The transmitter number of the TRU defined as the transmitter. This is derived from the TRU selected in the Transmitter Name field.  <b>Note:</b> Don't enter this value for a non-transmitter TRU, as it must be derived from the transmitter TRU. The value is derived when the record is saved and can be viewed in the UI after the record is saved.
Contact Name of this Return	Enter the contact name of the employer.
Contact Area Code	Enter the contact area code of the employer.
Contact Phone Number	Enter the contact phone number of the employer. Enter only the numbers, without spaces or dashes.
Contact Extension	Enter the contact extension number of the employer.
Proprietor 1 Social Insurance Number	Enter the Social Insurance Number of the proprietor of the business.
Proprietor 2 Social Insurance Number	Enter the Social Insurance Number of the second proprietor, if applicable.

## Transmitter TRU for the RL-1 and RL-2

To configure the TRU as the transmitter for the RL-1 and RL-2:

**Note:** If the scope isn't already set for the Manage Legal Reporting Unit Registrations task, set the scope as given in the Set the Scope section.

4. Click **Go to Task** for the Manage Legal Reporting Unit HCM Information task.
5. Enter search criteria and select the record.
6. On the Manage Legal Reporting Unit page, select the **Tax Reporting Unit** tab.
7. Click **Provincial Tax Reporting Unit Information**. This data is used to generate the electronic file that's submitted to the Quebec government.
8. Click **Edit-Update**.
9. On the Update Legal Reporting Unit form, select an **Action Reason**. Click **OK**.
10. In the RL-1 Interface Rules and RL-2 Interface Rules sections, enter the following non-transmitter information for both the RL-1 and RL-2 rules.

**Note:** Only the fields listed in this table are required. The other fields are optional and you should only populate them if the information is different from that of the Transmitter TRU. The only exception to this are the Starting and Ending Slip Numbers, which you must populate on the Transmitter TRU.

## Element Setup

When you create a deduction element belonging to the primary classification of Pretax and Voluntary Deductions, provide the seven-digit number as the default value for either of these:

- Deferred Profit Sharing Plan (DPSP)
- Registered Pension Plan (RPP) number

This registration number appears on the year-end forms.

If you report pension adjustments, create an Employer Liability or Information element to report the amount on the slips. Use the **Elements** task under **Payroll** in **My Client Groups** on the Home page, to create the required element.

While creating these elements, enter a value to report the registration number for T4 Box 50 and T4A Box 036 reporting.

**Note:** The registration number must be set up prior to year-end processing, otherwise the registration number will not appear on the year-end forms.

## Dynamic Payroll Relationship Group for Reports

Use payroll relationship groups to define a set of people for payroll processing, data entry, or reporting. For example, you can create a group to process the report for terminated employees.

**Note:** Use the **Objects Group** task under Payroll in **My Client Groups** on the Home page to define the payroll relationship group before you can select it in reports and processes.

While defining the payroll relationship group, select any of these options:

- Include: To only include the payroll relationship numbers defined in the object group.
- Exclude: To exclude the payroll relationship numbers defined in the object group.

You can make the payroll relationship group dynamic by configuring a formula that dynamically builds the list of employees, based on defined criteria. For example, you may configure a formula to build a group of terminated employees, union employees, or employees that are on leave. You may then attach those employees to a payroll relationship group.

## Year-End Balance Feeds

Before you start the end-of-year processing, review the balances required for year-end reporting. Many of the year-end balances are predefined for you, but if required, manually configure additional year-end balance feeds.

Use the **Balance Definitions** task under Payroll in **My Client Groups** on the Home page to manually configure the year-end feeds for balances that are reported on the year-end slips.

**Note:** Generally, the best practice is to create the year-end feeds using the same date that the balance is created. If you don't create it using the same date and it's the first year that you're configuring the feeds, set up the year-end balance feeds with an effective date prior to December, 31 of the calendar year you're reporting. Once this is configured, you need not make changes in the subsequent years.

The element that you should feed to the year-end balances is the 'Results' element and not the 'Base' element. However, for elements with a primary classification of Information, you must use the 'Base' element for balance feeds. A Results element isn't created for Information elements.

## Year-End Reporting Information Card Component

Use the Reporting Information calculation card to capture year-end data required for reporting. Use the component Year-End Data to capture this information.

### RL-2 Additional Information Code C-10

If the amount entered in Box C includes a single payment made under a registered pension plan (RPP) or a deferred profit-sharing plan (DPSP), report **C-10** followed by the date of the payment. Use the Reporting Information calculation card's **Year-End Data** component to capture this date.

If required, add the Reporting Information card within the reporting year. Then add the card component, component detail, and populate the **RL-2 RPP or DPSP Single Payment Date** field with the date of the payment.

To create the Reporting Information card:

1. In the Person Management area, select **Calculation Cards**.
  2. Complete the fields in the Search section.
  3. Click **Search** to display a list of matching records.
  4. Select person.
  5. Search and select the **Calculation Cards** task under **Payroll** in **My Client Groups** on the Home page.
  6. Click **Create** to open the Create Calculation Card window.
  7. In the Name field, select **Reporting Information**.
  8. Click **Continue** to display the Calculation Cards page.
  9. To create the **Year-End Data** calculation component and component details, click **Create** in the Calculation Components section.
  10. In the Create Calculation Component window, select **Year-End Data**.
  11. Click **OK**.
- Note:** The calculation component details are created by default for the related calculation component.
12. On the new Year-End Data calculation component details row, click **Edit > Correct**.
  13. Enter the date of payment in the **RL-2 RPP or DPSP Single Payment Date** field.
  14. Click **Save**.

### RL-2 Type of Income and Plan

Use the Reporting Information card's **Year-End Data** component to capture the fields below. These fields are available to override the source of income for an employee. Enter the RL-2 Type of Income. If none of the options apply, select 'Other plan or fund' and enter the RL-2 Type of Plan field. This will report 'AUTRE' in the Provenance box along with Other Info code 201.

- RL-2 Type of Income
- RL-2 Type of Plan

## Document Delivery Preferences Setup

Define delivery preferences for documents that are delivered periodically from employers to workers, for example, the end-of-year slips. You can select the default delivery methods of either paper or online delivery and specify the other delivery related preferences.

Set these preferences using the Manage Document Types task in the Setup and Maintenance work area.

When you process the end-of-year slips in the Final reporting mode, the application automatically creates the PDF versions and publishes them to the Document Records. For employees who have opted for paper delivery, the tasks create separate PDF files containing their slips. You can print and distribute these files as needed.

Let's look at steps required to set up the document delivery preferences.

### How to Configure the Default Delivery Options

To configure the default print options for your organization:

1. In the Setup and Maintenance work area, go to the following:

Offering: Workforce Deployment

Task: Manage Document Types

2. Search for Canada documents. These document types are available for end-of-year slips:
  - o T4\_ORIGINAL
  - o T4\_AMENDED
  - o T4\_CANCELLED
  - o T4A\_ORIGINAL
  - o T4A\_AMENDED
  - o T4A\_CANCELLED
  - o RL1\_ORIGINAL
  - o RL1\_AMENDED
  - o RL1\_CANCELLED
  - o RL2\_ORIGINAL
  - o RL2\_AMENDED
  - o RL2\_CANCELLED
3. Select a document type to edit.
4. In the Document Type Information section, set the Enable Document Delivery Preferences field to **Yes**.
5. Use the Override Hierarchy field to define the level where your document overrides are applied. The default is Payroll. See the Overriding Default Preferences section for additional information.

**Note:** This field is available only if Enable Document Delivery Preferences is set to **Yes**.

6. In the Document Delivery Preferences section, check the settings and make changes as given here:
  - o The default delivery method is Paper. Select **Online** for employees to access their slips online using employee self-service.

**Note:** If you don't select Online, the document isn't published to the Document Record and the employees won't be able to view it. If you change the Delivery Method after running the End-of-Year process in Final mode, you must roll back that process and re-run the End-of-Year process in Final mode.
  - o To receive digital versions of their slips, employees must provide explicit consent using Document Delivery Preferences. You can also grant initial consent at the document type level.
  - o If you're outsourcing the printing of your employee slips to a third-party provider, change these settings as necessary to satisfy their requirements.
7. Use the fields in the Document Delivery Default Overrides for any areas that require overrides to the current default settings.
8. Click **Submit**.

**Note:** Repeat this process for each year-end document type.

## Default Preference Overrides

You can set default delivery preferences on the document type and override the preferences on associated work structures. You can override default delivery preferences at various levels for a payroll statutory unit (for payroll documents) or legal employer (for other document categories).

The delivery preference levels exist in a hierarchy. For example, delivery preferences set for a location override those set for a department. Delivery preferences set for a department override those set for a legal employer. The document type is at the highest level in the hierarchy. The default delivery preferences you specify for a document type apply to all documents, if you don't override them at lower levels.

## Person Level Overrides

You can enable persons to override the delivery preferences for their documents, on the Document Delivery Preferences page in the Personal Information area. The delivery preferences that workers specify on this page override delivery preferences specified elsewhere for the document type.

## How to View Overrides

You can view all overrides for delivery preferences for a given document type. The View Document Delivery Preferences Report page provides information about all overrides set at the organization and person levels by document type.

To view all overrides made to delivery settings:

1. In the Setup and Maintenance work area, go to the following:
  - Offering: Workforce Deployment
  - Task: Manage Document Types
2. Search for the document type you want to view overrides.
3. In the Document Delivery Preferences section, click the **View Document Delivery Preference Report** button.
4. To export the details, select **Actions-Export to Excel**.
5. To remove overrides, select **Remove Overrides** button.

6. Click **Done**.

## Employee Print Elections

If you allow your employees to specify their own preferences for year-end slips, they can do so through their **Me** page.

1. On the **Me** page, select **Pay**.
2. Select **Document Delivery Preferences**.
3. For the appropriate form, click **Edit** and make the necessary changes.
4. Click **Save**.

**Note:** If the employee selects the **Online** delivery method, and grants online delivery consent, they can view their forms online. If they don't grant consent, the forms are generated and stored in Document Records, but the employee won't be able to view them. Online access to documents can reduce the cost of printing and provides employees ease of access.

## Document Record and Attachment Preferences

By default, the preferences for document records and attachments are restricted, employees or payroll professionals can't add, update, or delete completed year-end documents and attachments. This disables updates and removal of the slips after they're created and posted. This applies to all year-end document types, as well as original, cancelled, and amended slips. Here's a list of preconfigured restrictions.

- Restrict Create = Yes
- Restrict Update = Yes
- Restrict Delete = Yes
- Restrict Add Attachment = Yes
- Restrict Update Attachment = Yes
- Restrict Delete Attachment = Yes

The restrictions are preconfigured for these year-end document types.

- T4\_ORIGINAL
- T4\_AMENDED
- T4\_CANCELLED
- T4A\_ORIGINAL
- T4A\_AMENDED
- T4A\_CANCELLED
- RL1\_ORIGINAL
- RL1\_AMENDED
- RL1\_CANCELLED
- RL2\_ORIGINAL
- RL2\_AMENDED
- RL2\_CANCELLED

If required, you can remove the restrictions by updating the record and attachment preferences for a document type.



To access the document record and attachment preferences, use the Manage Document Types task in the Setup and Maintenance area.

**Note:** These restrictions aren't preconfigured for existing customers. This is only applicable for new customers implementing Release 19A, or later. Existing customers prior to Release 19A can manually configure the restrictions as noted.

## HCM Data Loader

Oracle Cloud provides a data loader for performing mass-uploads of employee print preferences into the application. For further information, see HCM Data Loader: Loading Document Record Delivery Preferences (2021205.1) on My Oracle Support.

## Year-End Documents Publish Date

Specify the day and month when employees can view their year-end documents in employee self-service for the following document types:

- T4
- T4A
- RL-1
- RL-2

The configuration addresses original, amended, and cancelled form types.

The publish day and month determines the date the documents are published to Document Records. In order to publish these documents to Document Records, complete these conditions:

- Submit the Run End-of-Year Reports task in final mode.
- Set the publish date on or before the system date, so that the PDF Final option generates a final version of the individual year-end slips and publishes them to the Document Records.

Once these two conditions are met, the employee can view their document in employee self-service and the professional user will be able to access the final document in the Document Records.

You can configure the publish day and month for the payroll statutory unit (PSU) or tax reporting unit (TRU), or for both. If you configure the publish date at the PSU level, all TRUs belonging to that PSU will adhere to the same date. You may override the configuration at the TRU level, if needed.

To configure the publish date for the PSU, use the Manage Legal Entity HCM Information task. To configure the publish date for a TRU, use the Manage Legal Reporting Unit HCM Information task. The fields are located in the Year-End Reporting Rules section. Once you configure the publish day and month, this controls both the federal and provincial form types.

If the publish dates are left blank, the documents are available once final mode is processed.

Here's what you must ensure to display the documents in employee self-service:

- Publish Day and Month on or before today's date (PSU or TRU level, or PSU and TRU level)
- Run End-of-Year Reports task in PDF Final mode

- Set Document Type Delivery Method to Online
- Set Document Type Publish Required to Yes

## Year-End Balance Adjustments

Perform balance adjustments to report balances not processed through the payroll, or to reduce balances, for example, those of T4 Box 14 or RL-1 Box A.

Perform balance adjustments for a single employee or for multiple employees in batch mode.

**Note:** When processing balance adjustments, use the 'Results' element and populate all the required input values of the element, for example, province and reporting type.

- When processing balance adjustments for elements that have an input value of 'Registration Number', add the registration number to the 'Results' element as a default value to avoid entering the value manually.
- If you're performing a balance adjustment to amend a slip, the electronic interface process must be complete prior to processing the adjustment. For more information, see the Troubleshooting section.

Refer to the Adjusting an Individual Balance section for detailed steps to adjust balances.

Refer to the appendix at the end of this document for additional information on the predefined balances that map to the individual boxes on the year-end slips.

## Create Balance Feeds and Adjustments for End-of-Year Reporting

Review the balances required for year-end reporting and if required, perform balance adjustments and create balance feeds before you begin the end-of-year processing. This example demonstrates how to adjust the balance and create balance feeds for year-end reporting.

### How to Adjust an Individual Balance

Process an individual year-to-date balance adjustment for an employee to report balances not processed through the payroll.

Complete these steps to adjust an individual balance for an employee.

1. Search and select the **Adjust Individual Balances** task under **Payroll** in **My Client Groups** on the Home page.
2. Enter the search criteria and click **Search**.
3. Select the employee name in the Search Results section to open the Adjust Individual Balances page.
4. On the Person Details page in the Adjust Individual Balances Element Details section, complete the fields as shown in this table. Use the default values except as indicated in this table.

3. Select a Canadian **Legislative Data Group**.
4. Click **Search**.
5. Select the balance to navigate to the Balance Definitions page.
6. Select **Balance Feeds** folder in the left pane.
7. In the Balance Feeds by Elements section, select **Actions-Create**.
8. Select the **Element Name**. This element feeds the year-end balance.
9. Select the **Input Value** of the Pay Value.
10. Select **Add**.
11. Click **Submit**, then **Done**.

## T4 Box 29 Employment Code Reporting

Capture and report the Employment Code on the employee's T4 slip in Box 29, using an Information element.

To report the Employment Code on the T4, use the Information element to feed the new T4 Employment Code balance in element entries.

The following employment codes are supported. Enter one of the values below when creating the default value for the Employment Code input value, or in the element entry if no default was provided.

Additionally, populating the Employment Code also affects reporting on Box 14 and Box 56 (for Quebec employees only), whether it is to be blanked out or not. See the table below that outlines employment codes and the behavior for Box 14 and 56 for each employment code.

The End-of-Year Exception Report generates an informational exception, if the Employment Code archived is invalid or not supported for the employee. It states, 'The Employment Code configured for Box 29 is not valid.'

Complete the following prior to running the End-of-Year Reports process to generate the T4:

- Create an Information element for the T4 Employment Code
- Create the input values to capture the Pay Value and the Employment Code.
- Create the eligibility record for the base element.
- Create the balance feed to the T4 Employment Code balance.

- Create the element entry and process in payroll.
- Run the End-of-Year Reports to generate the T4 register, slip, and interface.

10. Select **Pay Value** for Input Value.
11. Select **Add**.

**Note:** If you entered a default employment code when you created the Information element, it is displayed in the Employment Code input value field.

## Employer Offered Dental Benefit Code Reporting

Capture the code associated with the Employer Offered Dental Benefit, and report it on the employee's T4 (Box 45) and T4A (Box 015) slips.

You can configure a default code at the Payroll Statutory Unit (PSU) (if applicable) or the Tax Reporting Unit (TRU). If required, you can override the default for a specific employee using an information element and process it in the payroll, or alternatively a balance adjustment.

Use the Dental Access or Coverage field in the Year-End Reporting Rules section of the PSU or TRU to capture the default code. The following codes are supported. Select one of the values when creating the default value, or in the element entry if the value must be overridden for the employee.

Dental Access or Coverage Code	Meaning
Code 1	No access or coverage
Code 2	Payee only
Code 3	Payee, spouse and dependents
Code 4	Payee and spouse
Code 5	Payee and dependents

The balances used to hold the values of the codes are:

T4	T4 Employer Offered Dental Benefits	T4 Box 45 - Employer Offered Dental Benefits
T4A	T4A Employer Offered Dental Benefits	T4A Box 015 - Employer Offered Dental Benefits

The **End-of-Year Exception Report** generates an error exception, if the code archived is invalid or missing for the employee. Depending on the form, this is the error exception reported:

- T4
  - The Dental Access or Coverage Code value of <CODE> for Box 45 is not valid.
  - The Dental Access or Coverage Code for Box 45 is missing.
- T4A
  - The Dental Access or Coverage Code value of <CODE> for Box 015 is not valid.
  - The Dental Access or Coverage Code for Box 015 is missing.

**Note:** This message is only displayed when there is an amount reported in T4A Box 016.

## Capturing and Reporting the Employer Offered Dental Benefit Code

To capture and report the Employer Offered Dental Benefit on the T4 or the T4A, perform the following steps. Complete these steps prior to running the Archive End-of-Year Payroll Results and the End-of-Year Reports.

- Capture the default code at the payroll statutory unit (PSU) level (if applicable) or at the tax reporting unit (TRU) level.
- If you require an override for the employee, create an information element for the code and process in a payroll or a balance adjustment.
  - Create the input values to capture the Pay Value and the Employer Offered Dental Benefit code.
  - Create the eligibility record for the base element.
  - Create the feeds to the balances.
  - Create the element entry and process in payroll (or alternatively in a balance adjustment).
- Run the Archive End-of-Year Payroll Results and the End-of-Year Reports to generate the registers, slips, and interfaces.

## How to capture the Default Code at the PSU or TRU level

Use the **Dental Access or Coverage** field in the **Year-End Reporting Rules** section of the PSU or TRU to capture the default code. The default value is reported on both the T4 and T4A

To configure a default Employer Offered Dental Benefit code for the PSU, use the **Manage Legal Entity HCM Information** task.

To configure a default Employer Offered Dental Benefit code for a TRU, use the **Manage Legal Reporting Unit HCM Information** task.

### Create the Balance Feeds

To create the balance feeds for this element:

1. Search and select the **Balance Definitions** task under **Payroll** in **My Client Groups** on the Home page.
2. In the Balance Definitions search section, enter the balance name (**T4 Employer Offered Dental Benefits**) in the **Name** field.
3. Select a Canadian **Legislative Data Group**.

4. Click **Search**.
5. Select the balance to navigate to the Balance Definitions page.
6. In the Effective As-of Date, enter an early date so that the feed is available for use immediately. For example, 1/1/10.
7. Select the **Balance Feeds** folder in the left pane.
8. In the Balance Feeds by Elements section, select **Actions-Create**.
9. Select the **Element Name** (the element previously created, for example, Employer Offered Dental Benefit Code). This element feeds the balance.e
10. Select **Pay Value** for Input Value
11. Select **Add**.
12. Click **Submit**, then **Done**.
13. Repeat the process for the balance, **T4A Employer Offered Dental Benefits**.

## Override the default code set at the PSU or TRU level

You can override the default code set at the PSU or TRU, for an employee by creating an element entry and processing it in the payroll, or by creating a balance adjustment.

**Note:** Once you process a payroll for 2024, you will not be able to process the Information element in 2023 as part of a payroll run. In this case, you must create a balance adjustment. If you want to use the Information element to create the element entry, this must be done prior to processing any payrolls in 2024.

### Create Element Entry

To create the element entry to override of the default code for the employee:

1. Search and select the **Element Entries** task under **Payroll** in My Client Groups on the Home page.
2. Create the element entry for the employee using the new element name (the element previously created, for example, **Employer Offered Dental Benefit Code**).
3. Enter the **Dental Code**, **Province**, and **Pay Value**.

**Note:** If you entered a default code when you created the Information element, it is displayed in the **Dental Code** input value field.

4. Click **Submit**.
5. Process the element entry in a payroll run.

### Create Balance Adjustment:

Alternatively, you can create a balance adjustment to override of the default code for the employee. Process a date-effective balance adjustment within the reporting year (for example, 12/31/2023), where you must populate the following for the adjustment:

1. **Adjustment Element:** Select the newly created Information element.
2. **Dental Code:** Enter a Dental Code. Enter one of the supported codes (for example, 1-5), if no default code is present when performing the balance adjustment.
3. **Pay Value:** Enter an amount.

**Note:** The Pay Value is used to identify the dental code to report. The value does not appear on any report. The code associated with the highest Pay Value is reported. You can also perform the balance adjustments for all employees at once using the HCM Data Loader.

## Tips and Considerations

- On the T4A, Box 015 is mandatory for slips that report an amount in Box 16. If no amount is reported in Box 016, it is optional.
- If an error exception is reported as “missing”, that means the dental code is not available at the employee level and a default is not configured at the PSU/TRU level.
- The Employer Offered Dental Benefit code is reported in the T4 Box 45 column, on the End-of-Year Register for the T4.
- The Employer Offered Dental Benefit code is reported in the T4A Box 015 column, on the End-of-Year Register for the T4A.
- This feature includes reporting for the original, amended, and cancelled T4 and T4A.
- You can process a balance adjustment using the information element to populate T4 Box 45, or T4A Box 015, with the Employer Offered Dental Benefit code, if you need to override the default code for a specific employee.
- Updating the default code at the PSU or TRU does not trigger an amendment. You must process a balance adjustment to report the corrected code.
- If processing an amendment, process a balance adjustment using a Pay Value that is higher than the original. For example, if the Pay Value associated with the original code is 100, enter a Pay Value of 200 in the balance adjustment. The Pay Value is used to identify the code to report and the code associated with the highest Pay Value is reported.
- The default code in the new **Dental Access or Coverage** field configured on the PSU or TRU is reported on both the T4 and T4A.
- If an employee has transferred from one tax reporting unit (TRU) to another within the calendar year, and you need to perform a balance adjustment for either TRU, then you must perform a separate adjustment for each, using a process date as of when the transfer took place.

# 3 End-of-Year Archive

## Overview of End-of-Year Archive

Oracle Fusion Human Capital Management for Canada provides the Archive End-of-Year Payroll Results process to archive employee and employer information for end-of-year reporting.

The Archive End-of-Year Payroll Results process retrieves employee and employer information, including employee balances in a given year. It retrieves information for a payroll statutory unit and tax reporting unit, and archives them for year-end reporting.

After you run the process, navigate to **Regulatory and Tax Reporting** under **Payroll** on the Home page, and click **Submit a Process or Report** task. Use the **Archive End-of-Year Payroll Results** process to view the archived results.

The process archives these details included on the T4, T4A, RL-1, and RL-2 slips:

- Transmitter information used in electronic reporting to the government
- Employer information, such as:
  - Name (registered or alternate name)
  - Address
  - Employer Account Number
  - Quebec Identification Number
- Employee information, such as:
  - Name
  - Address
  - Social Insurance Number
  - Province of employment
  - Exemptions
  - Balances

Before you use this archived data to generate the year-end slips, you must review and validate the results data. Validating the results data involves reconciling the data by running the registers, exception reports, and balancing the data.

## Archive End-of-Year Payroll Results Report

Oracle Fusion Human Capital Management for Canada delivers the Archive End-of-Year Payroll Results report to retrieve and archive employee and employer information for year-end reporting. The year-end reports also include employee balances in a given year.

Payroll managers or payroll administrators can use the **Archive End-of-Year Payroll Results** task from the **Regulatory and Tax Reporting** area under **Payroll** on the Home page to generate the Archive End-of-Year Payroll Results output. You can also run this report using the **Submit a Flow** task under **Payroll** in **My Client Groups** on the Home page.

## Parameters

### Flow Pattern

Select **Archive End-of-Year Payroll Results**.

### Payroll Flow

Enter a payroll flow name.

**Note:** It's best practice to name the flow so that you can easily identify the process later. This is helpful while searching so you can determine what you have already run or if you must roll back any process.

### Year

Specify the 4-digit tax year.

### Payroll Statutory Unit

Select the PSU. The process archives the year-end data of employees belonging to this PSU only.

### Tax Reporting Unit

Select the TRU. If a value is selected, the process archives the year-end data of employees belonging to this TRU only. If left blank, all TRUs belonging to the selected PSU are processed.

### Payroll Relationship Group

Select the payroll relationship group name, if you have defined one. For example, you can create a group to process all employees within a specific province.

**Note:** Use the **Objects Group** task under **Payroll** in **My Client Groups** on the Home page to define the payroll relationship group before you can select it here.

### Process Configuration Group

Select the process configuration group name, if you have defined one. This is an optional parameter. It is used for logging and reporting purposes.

**Note:** Use the **Payroll Process Configuration** task under **Payroll** in **My Client Groups** on the Home page to define the process configuration group before you can select it here.

### Reason for Amendment

Enter the amendment reason, if you're amending the T4 or T4A. This is an optional parameter and applies only to the amended T4 and T4A report types. It's reported in the electronic interface files.

## Results

### Viewing the Report Output

Use the View Person Process Results task to open and view the archived data for each payroll relationship in the selected PSU or TRU. The archived results include T4, T4A, RL-1, and RL-2 data.

## Post-Archive Tasks

**You can view the archived data for each payroll relationship in the selected PSU or TRU. Use the following processes to roll back and rerun the archive process.**

### Process Rerun

There may be cases when employees are excluded from an original archive run, such as a missed vacation payout. The last payroll run for the tax year is also successfully completed. You must rerun the process to include the excluded employees.

**Note:** You can rerun the process for an individual employee or a group of employees. Create a configuration group for the individual employee or group of employees and use the object group to rerun the process.

You can identify these employees and rerun the archive again. The rerun archive process captures data for the employees excluded in the previous archive process. This process doesn't archive data that was already archived by a previous run.

To archive all data once again, you must first roll back the archive.

### Process Retry

Use the retry process to archive changed, new, or otherwise not archived data for selected employees.

### Roll Back Process

Use the Roll Back process to remove the archived data. Sometimes rerun or retry isn't possible. For example, if you ran the Archive End-of-Year Payroll Results process before completion of all the payroll processes. In this case, the data in the archive is not valid. To resolve this you must roll back the archive process.

When you roll back the Archive End-of-Year Payroll Results, the process removes the archived data from the Oracle Fusion database. Rolling back and rerunning the Archive End-of-Year Payroll Results process reruns the process and recreates the archive completely.

Use the Roll Back Process from the Checklists page.

### Data Locks

After you archive the payroll run results and run any subsequent process, such as the T4, T4A, RL-1, or RL-2 Electronic Interfaces or PDFs, the archived data gets locked. Once locked, you can't change the data through either retry or roll back of the archive. You must first roll back the Electronic Interfaces or PDF process, to try the retry or roll back archive process.

**Note:** Take care when rolling back the locking processes. If you have distributed the tax forms to the employee or submitted the electronic files to the government authorities, additional steps are required to resubmit the files.

### Special Characters

If special characters (< > ' " &) exist in any of the year-end electronic interface files, the government may reject the files. Therefore, all special characters entered in the application are removed during the archive process, before they're submitted to the government. This includes the interface files for the T4, T4A, RL-1, RL-2. This change is reflected in all year-end reports (End-of-Year Exception Report, End-of-Year Register, employee slips, and electronic interface

files). The fields given here are scrubbed for special characters. All special characters are replaced with a space, with an exception of '&', which is replaced with the word 'and'.

- Employee first name
- Employee last name
- Employee address line 1 and 2
- Transmitter name
- Transmitter contact name
- Contact name for this return
- Transmitter address line 1 and 2
- Transmitter computer resource person name
- Transmitter accounting resource person name

## View the Archive End-of-Year Payroll Results Output

Upon successful completion of the archive process, you can open and view the archived process results. Here are some examples of from where you can view the output results.

### From the Regulatory and Tax Reporting Area

To view the Archive End-of-Year Payroll Results output from the Regulatory and Tax Reporting area:

# 4 Payroll Reconciliation

## End-of-Year Exception Report

### Overview of End-of-Year Exception Report

Before you generate the year-end slips, ensure that the slips don't contain any errors or missing information. Generate the End-of-Year Exception Report to review and correct any errors or discrepancies in transmitter, employer and employee data. This report facilitates year-end reconciliation.

Use the report to respond to government reports identifying discrepancies in Canada Pension Plan, Quebec Pension Plan, Employment Insurance, Quebec Parental Insurance Plan amounts reported in the year-end slips or other government reports.

**Note:** Not all exceptions displayed on the reports are errors. Some exceptions are informational only.

Run this report after you process the Archive End-of-Year process. All of the data displayed on the report comes from the archived data, with the exception of the name and address of the employee and the employer. The End-of-Year Exception Report automatically produces both a PDF and an Excel spreadsheet version of the report for all slip types.

These sections list the exception messages reported in the End-of-Year Exception Report for transmitter, employer and employee information.

Generate the End-of-Year Exception Report to review the output and correct any discrepancies in transmitter, employer and employee data. The End-of-Year Exception Report automatically produces both a PDF and an Excel spreadsheet version of the report for all slip types.

Payroll managers and administrators can use the **Run End-of-Year Reports** task from the **Regulatory and Tax Reporting** area under **Payroll** on the Home page to generate the report. You can also run this report using the **Submit a Flow** task under **Payroll** in **My Client Groups** on the Home page.

### Prerequisites

Before you run this report, run the Archive End-of-Year Payroll Results process. The information reported in the exception report comes from the end-of-year archive process, with the exception of the employee and employer name and address.

## Results

### View the Report Output

Use the View Results icon to view the report output. The End-of-Year Exception Report automatically produces both a PDF and an Excel spreadsheet version of the report for all slip types. If there are exceptions met, the report displays those exception messages. Exceptions are reported for transmitter, employer, and employee data. Before proceeding with the end-of-year processing, you must correct the data as required.

### Process Rerun

To archive all data once again, you must first roll back and then rerun the archive. The rerun archive process captures data for the employees excluded in the previous archive process.

Run the exception report to check if the exceptions reported earlier are resolved. If you notice any exceptions, fix them and repeat the process of rollback and rerun of the archive process.

# End-of-Year Register

## Overview of End-of-Year Register

Oracle Fusion Human Capital Management for Canada provides the Run End-of-Year Reports process for generating and verifying the end-of-year information prior to distribution of the statutory year-end slips.

The End-of-Year Register uses the archived payroll run results and generates employee details required for each year-end slip. The report is created in a spreadsheet format and includes employee information as well as the information or amounts reported in each box on each of the year-end slips.

You must run the Archive End-of-Year Payroll Results process prior to running the End-of-Year Register.

Use this report to:

- Review employee information included in each year-end slip
- Verify the box balances

This process doesn't lock the end-of-year archive process. You can run this process multiple times for the same employee or group of employees, without rolling back the process.

The end-of-year registers you can generate are:

- T4
- T4A
- RL-1
- RL-2

Select the Register report format so that you can generate the year-end slip register and review and verify the generated information. Once you confirm your forms are accurate, you can select the PDF or Interface format.

## Report Type

You can generate the register for an original, amended or cancelled report type.

## Transmitters and Tax Reporting Units

You must select a transmitter name. The report includes information for all TRUs that transmit their data using this transmitter TRU.

If you select a TRU, the process generates the report for employees belonging to this TRU only.

The report output is a spreadsheet. It displays information or amounts reported in each box of the year-end slip for all employees in a specified transmitter or TRU in a reporting year.

## Overview of Employee Active Payroll Balance Report

Use the Employee Active Payroll Balance report to reconcile your balances prior to year-end reporting. The Employee Active Payroll Balance Report displays the current and year-to-date values for employee balances without the need to process the payroll archive.

This report assists in determining any tax balances that are over the statutory limits and any of the tax liability balances that are improperly calculated. To assist with reconciliation and balancing of your data, run this report prior to generating the employee slip and interface files.

The report is a pipe delimited text file of live payroll balances for an employee filtered by various parameters. You can easily convert the output text file into an Excel spreadsheet for further totaling and manipulation to meet your specific requirements. You can also get the report in excel format. You can select a dimension of run or year, and a balance group usage displays all balances defined for that group.

You can configure this report to return balances for these components:

- Individual employees
- Members of a payroll relationship group

- All employees in a tax reporting unit (TRU)
- Employees associated with a specific payroll run
- Year-end employee balances
- Pay-period employee balances

## Run the Employee Active Payroll Balance Report

Generate the Employee Active Payroll Balance report to review the output and correct any balance discrepancies prior to year-end reporting.

Payroll Managers and administrators can use the **Run Employee Active Payroll Balance Report** task from the **Regulatory and Tax Reporting** area under **Payroll** on the Home page to generate the report. You can also run this report using the **Submit a Flow** task under **Payroll** in **My Client Groups** on the Home page.

### Prerequisites

The only prerequisite to running this report is that a valid payroll action must exist, like a payroll run, QuickPay, or balance initialization. Processing the payroll archive isn't required prior to running this report.

### Parameters

**Enter these parameters to run the Employee Active Payroll Balance Report.**

#### Flow Pattern

Select **Run Employee Active Payroll Balance Report**.

#### Payroll Flow

Enter a payroll flow name.

**Note:** It's best practice to name the flow so that you can easily identify the process later. This is helpful while searching so you can determine what you have already run or if you must rollback any process.

#### Start Date

Enter a start date to retrieve balances. This is a required parameter.

#### End Date

Enter an end date to retrieve balances. This is a required parameter.

#### Payroll

Select a payroll, to run the report for a specific payroll.

#### Consolidation Group

Select the consolidation group name, if you have defined one.

**Note:** Use the **Consolidation Groups** task under **Payroll** in **My Client Groups** on the Home page to define the consolidation group before you can select it here.

### Tax Reporting Unit

Select a tax reporting unit (TRU), to run the report for a specific TRU.

### Payroll Relationship Group

Select the payroll relationship group name, if you have defined one. For example, you can create a group to process all employees within a specific province.

**Note:** Use the **Objects Group** task under **Payroll** in **My Client Groups** on the Home page to define the payroll relationship group before you can select it here.

### Employee Name

Select the name of an employee, to run this report for a specific employee.

### Balance Dimension

Select the balance dimension used to report balances. This is a required parameter.

Valid Values are:

- Run
- Month
- Quarter
- Year
- Quarter and Year
- Inception to Date

If you select **Quarter** or **Quarter and Year** in the **Balance Dimension** parameter, the values presented to you in the Quarter parameter is dependent on the Start Date and End Date parameters. The Quarter Number you can select is within the date range you select. For example, if the Start Date is 1/1/21 and the End Date is 12/31/21, you will be presented with all four quarters to select. You can select any of the quarters or select All to include all the quarters.

The amounts are displayed on the report for each quarter selected. If Quarter and Year was selected, the balances are also reported for the year, which is a sum of the quarters reported, as given here.

- Balance Dimension = Quarter and Year
- Quarter = Quarter 1,2
- Balance Group Usage = Canadian Employer Liabilities Quarter and Year Balance Group Usage

### Balance Group Usage

Select the balance group usage to report balances. The balance group usage displays all balances defined for that group. The list of values is dynamically determined based on the Balance Dimension parameter value selected. This is a required parameter.



The Balance Group Usage parameter is a defined group of balances used for reporting. Six groups of balances are predefined in the application:

- Canadian T4 Balance Group
- Canadian T4A Balance Group
- Canadian RL-1 Balance Group
- Canadian RL-2 Balance Group
- Canadian Tax Remittance Balance Group
- Canadian Employer Liabilities Balance Group
- Canadian Employer Liabilities Quarter and Year Balance Group

If you select Quarter or Quarter and Year in the Balance Dimension parameter, only the applicable quarter-to-date dimension values are presented for selection in the Balance Group Usages parameter.

If these balance groups don't meet your specific requirements, create additional balance group usages to use for reporting. For additional details, refer to the Appendix III: Creating User-Defined Balance Group Usages.

For a list of the individual balances included within each predefined balance group, refer to the Appendix II: Balances Defined for Predefined Balance Groups.

### Display Person National Identifier

Select the display option for the person's Social Insurance Number. Valid values are:

- Do not display ID – the column is not present in the report (this is the default value)
- Display masked ID – displays the Social Insurance Number, partially masked, as XXX-XXX-### (for example XXX-XXX-555)
- Display full ID – displays the full Social Insurance Number (for example, 555-555-555)

**Note:** Out-of-the-box, the **National Identifier** column is not displayed on the report, and this parameter is not visible in the **Run Employee Active Payroll Balance Report** flow. To enable and use the new parameter in the flow, you must copy the seeded flow and create a copy, then enable the **Display Person National Identifier** parameter for that flow. This feature offers the ability to configure various versions of the report, offering flexibility to display the national identifier or not, and in what format. This feature can make it easier to reconcile balances with third-party tax providers that may require the employee's Social Insurance Number.

### Process Configuration Group

Select the process configuration group name, if you have defined any. This parameter is used for logging and reporting purposes.

**Note:** Use the **Payroll Process Configuration** task under **Payroll** in **My Client Groups** on the Home page to define the process configuration group before you can select it here.

## Results

### Report Output

Generate the **Employee Active Payroll Balance Report** in Excel using the **Report Category** parameter. These values are displayed using the new parameter during report submission:

- Employee Payroll Balance Report in Text
- Employee Payroll Balance Report in Excel

You can convert the text output file into an Excel spreadsheet for further totaling and manipulation to meet your specific requirements. For additional details, refer to the link given in the Related Links section and search for the Text Import Wizard on the portal.

Typically the report will contain one line for each employee. However, for Canada, there are certain contexts associated with some Canadian balances that may report multiple lines for a single employee balance, if there is a change in context value. Some Canadian balances may have province, statutory reporting type, or reference code contexts associated with them that result in reporting multiple lines for one employee. Not all balances have contexts.

The statutory reporting type context is the year-end form that the balances are associated with. The statutory reporting type is associated with an element's secondary classification. It determines how the element is used in the payroll calculation, and how the element is reported at the end of the year.

The reference code context is for Workers' Compensation and Provincial Medical balances and contain the relevant account information.

The output of this report is purely a balance-based record of an employee's live balances. If an employee has any of the balances defined in the balance group usage selected as a parameter, within the date range specified, they're included in this report. These balances are defined in the balance group usage and as noted, certain balances require certain contexts, (province, statutory report type, reference code), and are stored that way in the application. As a consequence of this, the report may display multiple lines for each balance for each dimension and context for that employee. A row with a blank context value may also appear as a total. Restrict the output of the data by selecting specific report parameters so as to generate the report for relevant employees for each balance group usage. For example, to restrict the output for employees who receive an RL-2, create a group that contains only those RL-2 employees and select that group while generating the report.

If the predefined balance groups don't meet your specific reporting needs, you can create additional balance group usages to use for reporting. For additional details, refer to the Appendix III: Creating User-Defined Balance Group Usages. For a list of the individual balances included within each predefined balance group, refer to the Appendix II: Balances Defined in the Predefined Balance Groups.

### Displaying the Social Insurance Number on the Employee Active Payroll Balance Report

You have the option to display the person's national identifier (Social Insurance Number) on the **Employee Active Payroll Balance Report**. This feature offers various display options, using a hidden parameter. The valid values for the **Display Person National Identifier** parameter are:

- Do not display ID – the column is not present in the report (this is the default value)
- Display masked ID – displays the Social Insurance Number, partially masked, as XXX-XXX-### (for example XXX-XXX-555)e
- Display full ID – displays the full Social Insurance Number (for example, 555-555-555)

This feature supports the ability to configure various versions of the report, offering flexibility to display the national identifier or not, and in what format. This feature can make it easier to reconcile balances with third-party tax providers that may require the employee's Social Insurance Number.

Note these important considerations for this feature:

- You do not have to use the new feature if you do not want to display the national identifier. You can simply use the seeded flow as is, or if you create a custom flow, do not enable the parameter.
- The employee's designated primary national identifier is displayed. This is held in the National Identifiers section for the person. If you only added one identifier, it is automatically set as the primary identifier.
- You can create different versions of the flow pattern with different parameter settings for different users, depending on their security requirements. For example, one user could use the existing seeded report with no changes so the new parameter hidden and the National Identifier column is not displayed at all. Another user could use a version of the report where the parameter is set to display the full identifier, and the National Identifier column is displayed with the person's primary identifier that is fully displayed.

### Enabling the Display Person National Identifier Parameter

Out-of-the-box, the **National Identifier** column is not displayed on the report, and the parameter is not visible in the **Run Employee Active Payroll Balance Report** flow. If you choose to use this feature and enable the **Display Person National Identifier** parameter, you must copy the seeded **Run Employee Active Payroll Balance Report** flow. This will create a custom flow and allow you to enable the new parameter. Use the **Payroll Flow Patterns** task to copy the existing flow, then enable the **Display Person National Identifier** parameter by changing **Display** to **Yes**. Once the changes are submitted, the **Display Person National Identifier** parameter is enabled for the custom flow.

# 5 Federal End-of-Year Slips

## Overview of Federal End-of-Year Slips

Use the Run End-of-Year Reports task from the Regulatory and Tax Reporting area under Payroll on the Home page to generate the statutory T4 and T4A federal year-end slips,

The tax reporting year is January, 01 through December 31. The deadline to provide employees and the governments with year-end slips is the last day of February of the following year.

### Copyright Message

Every year, Oracle obtains a copyright clearance to use the CRA issued T4 and T4A slips. This read-only message that appears in the Copyright Message field indicates that Oracle has Canada Revenue Agency (CRA) clearance. It also gives credit to the CRA for the format of the T4 and T4A slips generated from the application.

### Locking

When the slips are generated, the end-of-year archive is locked. You can't generate the slips multiple times. You must first perform a rollback process of the slip generation process, then you can rerun the process.

The XML process also creates a lock on the records, and therefore, generate the slips prior to the interface files.

### Reporting Mode

Process the year-end slips in draft or final mode. The Format parameter is available within the Run End-of-Year Report process and applies to the year-end T4 and T4A slips. It is available for the Original, Amended, and Canceled Report Type options.

The Format parameter has these two options:

- PDF Draft
- PDF Final

The PDF Draft option generates a draft version of the year-end slips as they would appear in final format. Perform data verification prior to distributing the final versions to the employees. Additionally, it ensures you're satisfied with the results. This version of the slip isn't published to the Document Record, and hence isn't visible to the employee. The draft version is a single PDF that contains the slips of all the employees included in the process. You can run the year-end slips in the draft mode multiple times without rolling back the process. Additionally, you can roll back the end-of-year archive without rolling back the draft PDF process.

The PDF Final option generates a final version of the individual year-end slips to distribute to the employees and publish them to the Document Record. It creates a single PDF that contains the slips of all the employees included in the process. After you have run the process in PDF Final mode, you must roll back the process if you require changes.

## Generate the T4 Slip

The T4 slip is a federal year-end form issued primarily for reporting employment income, statutory deductions and other information required by CRA.

Payments reported on the T4 are elements with a secondary classification reporting type of T4/RL1.

Use the **Run End-of-Year Reports** task from the **Regulatory and Tax Reporting** area under **Payroll** on the Home page to generate the T4 slip.

### Prerequisites

Before you run this process, complete these tasks:

- The Archive End-of-Year Payroll Results process. The information reported on the T4 slip comes from the end-of-year archive.
- The Run End-of-Year Reports task to generate the T4 register. Review and validate the information. Make balance adjustments or adjust employee information before you generate the T4 slip.

**Note:** Although the register isn't mandatory, it's strongly recommended to run the register to identify and correct discrepancies.

### Parameters

#### Flow Pattern

Select **Run End-of-Year Reports**.

#### Payroll Flow

Enter a payroll flow name.

**Note:** It's best practice to name the flow so that you can easily identify the process later. This is helpful while searching so you can determine what you have already run or if you need to roll back any process.

#### Tax Report Year

Select the 4-digit tax year.

#### Year End Report

Select **T4**. Valid values are T4, T4A, RL-1, and RL-2.

#### Report Type

Select **Original**. The values you can select include Original, Amended, and Cancelled.

#### Format

Select **PDF Draft** or **PDF Final** format.

### Transmitter

Select a transmitter to generate the slip by a transmitter. If you have selected a transmitter, the list displays only those TRUs that transmit data using this transmitter TRU. The list includes only those TRUs for which the data is archived. However, if you haven't selected a transmitter, data is processed for all TRUs for which the data is archived.

### Tax Reporting Unit

Select a TRU, to generate the slip by a TRU. The list includes only those TRUs for which the data is archived. However, if you haven't selected a TRU, report is processed for all TRUs for which the data is archived.

### Payroll Relationship Group

Select the payroll relationship group name, if you have defined one. For example, you can create a group to process the report for terminated employees.

**Note:** Use the **Object Groups** task under **Payroll** in **My Client Groups** on the Home page to define the payroll relationship group before you can select it here.

### Province

Select a province, if you want to run the report for a specific province. For RL-1 and RL-2, the field displays only Québec. Also, it is blank for T4A.

### Print Employer Address

Select **Yes** to display the employer address on the T4 slip. The default value for this field is **No**.

### Print Instructions

Select **Yes** to print the instructions for the T4 slip. The default value for this field is No. If the paper stock that the slips are printed on has instructions, printing the instructions isn't necessary.

### Sort Option One

Select Location, Payroll, or Province.

### Sort Option Two

Select Location, Payroll, or Province. The options presented to you for selection is dynamically changed depending on your selection in the previous Sort Option One parameter.

### Sort Option Three

Select Location, Payroll, or Province. The options presented to you for selection is dynamically changed depending on your selection in the previous Sort Option parameter.

### Process Configuration Group

Select the process configuration group name, if you have defined any. This field is used for logging and reporting purposes.

**Note:** Use the **Payroll Process Configuration** task under **Payroll** in **My Client Groups** on the Home page to define the process configuration group before you can select it here.

### Copyright Message

This field is used to hold a copyright message for the PDF Draft or PDF Final format of the T4 and T4A slips. It isn't reported on the actual slips.

## Results

### Report Output

The application generates the T4 PDF in the format provided by the Canada Revenue Agency for all employees in a specified transmitter or TRU and for a particular reporting year.

## Generate the T4A Slip

The T4A slip is a federal year-end form that's issued primarily for reporting retirement income, annuity income, and federal income tax withheld.

Payments reported on the T4A are those elements with a secondary classification reporting type of T4A/RL1 and T4A/RL2.

Use the **Run End-of-Year Reports** task from the **Regulatory and Tax Reporting** area under **Payroll** on the Home page to generate the T4A slip.

## Prerequisites

Before you run this process, complete these tasks:

- The Archive End-of-Year Payroll Results process. The information reported on the T4A slip comes from the end-of-year archive.
- The Run End-of-Year Reports task to generate the T4A register. Review and validate the information. Make balance adjustments or adjust employee information before you generate the T4A slip.

**Note:** Although the register isn't mandatory, it's strongly recommended to run the register to identify and correct discrepancies.

## Parameters

### Flow Pattern

Select **Run End-of-Year Reports**.

### Payroll Flow

Enter a payroll flow name.

**Note:** It's best practice to name the flow so that you can easily identify the process later. This is helpful while searching so you can determine what you have already run or if you need to roll back any process.

### Tax Report Year



Select the 4-digit tax year.

### Year End Report

Select **T4A**. Valid values are T4, T4A, RL-1, and RL-2.

### Report Type

Select **Original**. The values you can select are Original, Amended, and Cancelled.

### Format

Select **PDF Draft** or **PDF Final** format.

### Transmitter

Select a transmitter to generate the slip by a transmitter. If you have selected a transmitter, the list displays only those TRUs that transmit data using this transmitter TRU. ### Tax Reporting Unit

Select **Yes** to print the instructions for the T4A slip. The default value for this field is *No*. If the paper stock that the slips are printed on has instructions, printing the instructions isn't necessary.

### Sort Option One

Select Location, Payroll, or Province.

### Sort Option Two

Select Location, Payroll, or Province. The options presented to you for selection is dynamically changed depending on your selection in the previous Sort Option One parameter.

### Sort Option Three

Select Location, Payroll, or Province. The options presented to you for selection is dynamically changed depending on your selection in the previous Sort Option parameter.

### Process Configuration Group

Select the process configuration group name, if you have defined any. This field is used for logging and reporting purposes.

**Note:** Use the **Payroll Process Configuration** task under **Payroll** in **My Client Groups** on the Home page to define the process configuration group before you can select it here.

### Copyright Message

This field is used to hold a copyright message for the PDF Draft or PDF Final format of the T4 and T4A slips. It isn't printed on the actual slips.

## Results

### Report Output

The application generates the T4A PDF in the format provided by the Canada Revenue Agency for all employees in the specified transmitter or TRU and for a particular reporting year.

# 6 Quebec End-of-Year Slips

## Overview of Provincial End-of-Year Slips

Use the Run End-of-Year Reports task from the Regulatory and Tax Reporting area under Payroll on the Home page to generate the statutory provincial RL-1 and RL-2 year-end slips.

The tax reporting year is January, 01 through December, 31. The deadline to provide employees and the governments with year-end slips is the last day of February of the following year.

### Locking

When the slips are generated, the end-of-year archive is locked. You can't generate the slips multiple times. You must first perform a rollback process of the slip generation process, then you can rerun the process.

The XML process also creates a lock on the records, and therefore, generate the slips prior to the interface files.

### Reporting Mode

Process the year-end slips in draft or final mode. The Format parameter is available within the Run End-of-Year Report process and applies to the year-end RL-1 and RL-2 slips. It's available for the Original, Amended, and Canceled Report Type options.

The Format parameter has these options:

- PDF Draft
- PDF Final

The PDF Draft option generates a draft version of the year-end slips as they would appear in final format. Use this mode to perform data verification prior to generating and distributing the final versions to the employees. Additionally, it ensures you're satisfied with the results. This version of the slip isn't published to the Document Record, and hence isn't visible to the employee. The draft version is a single PDF that contains the slips of all the employees included in the process. You can run the year-end slips in the draft mode multiple times without rolling back the process. Additionally, you can roll back the end-of-year archive without rolling back the draft PDF process.

The PDF Final option generates a final version of the individual year-end slips to distribute to the employees and publish them to the DOR. It creates a single PDF that contains the slips of all the employees included in the process. After you have run the process in PDF Final mode, you must roll back the process if you require to make any further changes.

## Generate the RL-1 Slip

The RL-1 slip is a provincial year-end form that's issued primarily for reporting employment income as well as statutory and other deductions. The information is reported on an annual basis to Revenu Québec.

Payments reported on the RL-1 slip are elements with a secondary classification reporting type of T4/RL1 or T4A/RL1.

Use the **Run End-of-Year Reports** task from the **Regulatory and Tax Reporting** area under **Payroll** on the Home page to generate the RL-1 slip.

## Prerequisites

Before you run this process, complete these tasks:

- The Archive End-of-Year Payroll Results process. The information reported on the RL-1 slip comes from the end-of-year archive.
- The Run End-of-Year Reports task to generate the RL-1 register. Review and validate the information. Make balance adjustments or adjust employee information before you generate the RL-1 slip.

**Note:** Although the register isn't mandatory, Oracle strongly recommends to run the register to identify and correct discrepancies.

## Parameters

### Flow Pattern

Select **Run End-of-Year Reports**.

### Payroll Flow

Enter a payroll flow name.

**Note:** It's best practice to name the flow so that you can easily identify the process later. This is helpful while searching so you can determine what you have already run or if you must roll back any process.

### Tax Report Year

Select the 4-digit tax year.

### Year End Report

Select **RL-1**. Valid values are T4, T4A, RL-1, and RL-2.

### Report Type

### Print Employer Address

This only applies to the T4 and T4A PDF Draft or PDF Final formats. The RL-1 automatically displays the employer address.

### Print Instructions

This applies only to T4 and T4A.

### Sort Option One

Select **Location** or **Payroll**.

### Sort Option Two

Select **Location** or **Payroll**. The options presented to you for selection is dynamically changed depending on your selection in the previous Sort Option parameter.

### Sort Option Three

This applies only to T4 and T4A. RL-1 and RL-2 only have Location and Payroll as sort options.

### Process Configuration Group

Select the process configuration group name, if you have defined any. This field is used for logging and reporting purposes.

**Note:** Use the **Payroll Process Configuration** task under **Payroll** in **My Client Groups** on the Home page to define the process configuration group before you can select it here.

### Copyright Message

This applies only to T4 and T4A.

## Results

### Report Output

The application generates the RL-1 slip in the format provided by Revenu Québec for all employees in the specified transmitter or TRU and for a particular reporting year.

## Generate the RL-2 Slip

The RL-2 slip is a provincial year-end form that's issued primarily for reporting retirement income, annuity income, and Quebec income tax withheld from those payments.

Payments reported on the RL-2 are those elements with a secondary classification reporting type of T4A/RL2.

Use the **Run End-of-Year Reports** task from the **Regulatory and Tax Reporting** area under **Payroll** on the Home page to generate the RL-2 slip.

### Prerequisites

Before you run this process, run these reports:

- The Archive End-of-Year Payroll Results process. The information reported on the RL-1 slip comes from the end-of-year archive.
- The Run End-of-Year Reports task to generate the RL-1 register. Review and validate the information. Make balance adjustments or adjust employee information before you generate the RL-1 slip.

**Note:** Although the register isn't mandatory, Oracle strongly recommends to run the register to identify and correct discrepancies.

### Parameters

#### Flow Pattern

Select **Run End-of-Year Reports**.

#### Payroll Flow

Enter a payroll flow name.

**Note:** It's best practice to name the flow so that you can easily identify the process later. This is helpful while searching so you can determine what you have already run or if you must roll back any process.

#### Tax Report Year

### Transmitter

Select a transmitter, to generate the slip by a transmitter. If you have selected a transmitter, the list displays only those TRUs that transmit data using this transmitter TRU. The list includes only those TRUs for which the data is archived. However, if you haven't selected a transmitter, data is processed for all TRUs for which the data is archived.

### Tax Reporting Unit

Select a TRU, to generate the slip by a TRU. The list includes only those TRUs for which the data is archived. However, if you haven't selected a TRU, report is processed for all TRUs for which the data is archived.

### Payroll Relationship Group

Select the payroll relationship group name, if you have defined one. For example, you can create a group to process the report for terminated employees.

**Note:** Use the **Object Groups** task under **Payroll** in **My Client Groups** on the Home page to define the payroll relationship group before you can select it here.

### Print Employer Address

This only applies to the T4 and T4A PDF Draft or PDF Final formats. The RL-2 automatically displays the employer address.

### Print Instructions

This applies only to T4 and T4A.

### Sort Option One

Select **Location** or **Payroll**.

### Sort Option Two

Select **Location** or **Payroll**. The options presented to you for selection is dynamically changed depending on your selection in the previous Sort Option parameter.

### Sort Option Three

This applies only to T4 and T4A. RL-1 and RL-2 only have Location and Payroll as sort options.

### Process Configuration Group

Select the process configuration group name, if you have defined any. This field is used for logging and reporting purposes.

**Note:** Use the **Payroll Process Configuration** task under **Payroll** in **My Client Groups** on the Home page to define the process configuration group before you can select it here.

### Copyright Message

This applies only to T4 and T4A.

## Results

### Report Output

The application generates the RL-2 slip in the format provided by Revenu Québec for all employees in the specified transmitter or TRU and for a particular reporting year.



# 7 Electronic Interfaces

## Generate Electronic Interfaces

The electronic interfaces are files that contain employee information and balances and are in the XML format. Use the Run End-of-Year Reports task from the Regulatory and Tax Reporting area under Payroll on the Home page to generate the files.

These files are generated by the employer and submitted to the government. It has the same information provided to the employees in their year-end slips. You can generate the electronic interface files for the original, amended, or canceled report types.

### Locking

When you generate the electronic interface files, the end-of-year archive is locked. You can't generate the interface files multiple times. You must first perform a rollback process of the file generation process, then you can rerun the process.

The XML process also creates a lock on the records, and therefore, generate the slips prior to the interface files.



# 8 View Employee End-of-Year Slips

## Employee Self-Service

Enable the Employee Self-Service so that your employees can access their year-end documents online. Configure employee access using any of these methods:

- Document Records
- Responsive Pages in the Redesigned User Experience product

Using either method, employees can access their T4, T4A, RL-1, and RL-2 slips for the original, amended and canceled form types.

**Note:** Configure the Document Delivery Preferences in Manage Document Types for employees to view their year-end documents in employee self-service. See the Document Delivery Preferences Setup section for more details.

### Access using Document Records

Employees can access their year-end documents by navigating to the Document Records.

To access the Year-End Documents in employee self-service using the Document Records:

1. On the employee dashboard, click **Me**.
2. Click **Personal Information**.
3. Click **My Documents**.

### Access using the Responsive Pages

Enable the Employee Self-Service and the responsive pages, so that your employees can use the enhanced user interface to access their year-end documents. It provides the employee easy, direct access to their year-end documents, and they need not navigate to the Document Records.

Access the documents using either **Quick Actions** or the **Pay app**, both of which are located on the employee dashboard under the **Me** tab. Employees can use the default search of the last 3 years, or choose to enter a specific date range.

To access the Year-End Documents in employee self-service using the Pay app:

1. On the employee dashboard, under the **Me** tab, click **Pay**.
2. Select **Year-End Documents**.

### Enable Year-End Documents

To enable the Year-End Documents, enable these profile options:

1. HCM\_RESPONSIVE\_PAGES\_ENABLED
2. PAY\_PAYROLL\_RESPONSIVE\_ENABLED

**Note:** To enable the HCM\_RESPONSIVE\_PAGES\_ENABLED profile option, refer these documents on My Oracle Support: HCM Responsive User Experience Setup Information- Profile Options and Displayed Fields (Document ID: 2399671.1).

To enable the PAY\_PAYROLL\_RESPONSIVE\_ENABLED profile option:

1. In the Setup and Maintenance work area, go to the following:

Offering: Workforce Deployment

Functional Area: Maintain Common Reference Objects

Task: Manage Administrator Profile Values

2. Search for and select the profile option.
3. Click **Add** to add a new Profile Value.
4. Select **Level** in the **Site** field.
5. Enter **Y** in the **Profile Value** field.
6. Click **Save and Close**.

**Note:** By enabling the PAY\_PAYROLL\_RESPONSIVE\_ENABLED profile option, you're also enabling all the payroll responsive pages that are available.

# 9 Corrections

## Update End-of-Year Data

While preparing and processing your year-end tax data for reporting, if required, you can make changes or corrections as needed. However, how you uptake those changes into your year-end reports depends on where you're in the process:

- After year-end archive
- After year-end register
- After generation of the year-end slips
- After the year-end slips are distributed to employees

### After Year-End Archive

To make any corrections subsequent to running the year-end archive:

1. Make corrections.
2. Roll back and rerun the Archive End-of-Year Payroll Results process to capture your changes.
3. Run the End-of-Year Register report to review the corrected year-end data.
4. Run the End-of-Year Exception report to review exceptions.
5. Run the individual year-end slips.

### After Year-End Register

Follow the procedures mentioned in the previous section, to make changes to your employee data subsequent to running the year-end register. You can run the End-of-Year Register as many times as needed and no roll back is necessary.

### After Generation of Year-End Slips

If you haven't yet distributed the year-end slips to your employees or submitted them to the government, and you want to make changes to your employee data:

1. Make corrections.
2. Roll back the individual year-end report processes.
3. Roll back and rerun the Archive End-of-Year Payroll Results process to capture your changes.
4. Run the End-of-Year Register report to review your corrected year-end data.
5. Run the End-of-Year Exception report to review exceptions.
6. Run the individual year-end slips.

### After Distribution of Year-End Slips to Employees

If you have already distributed the year-end slips to your employees and submitted the electronic interface files to the government, and you want to cancel or amend the slips, complete these tasks as required.

## Scenario

### Cancellations

**Note:** As a prerequisite, you must configure a Payroll Relationship Group to include the employees whose slips you want to cancel.

To cancel slips:

1. Run the End-of-Year Reports process to generate the cancelled year-end PDF.

**Note:** Populate the Payroll Relationship Group parameter in the Run End-of-Year process. If the Payroll Relationship Group is blank, all slips are cancelled.

2. Run the End-of-Year Register report to review the cancelled slips. Set the Report Type parameter to **Cancelled**.
3. Run the End-of-Year Reports process to generate the cancelled year-end interface.

## Scenario

### Amendments

To amend slips:

1. Make changes to the tax data already reported to the government, for example, balance adjustments to the data displayed on the slips.
2. Run the Archive End-of-Year Payroll Results process to capture the changes.

**Note:** You may optionally populate the Reason for Amendment to report the reason in the interface files for the T4 or T4A.

3. Run the End-of-Year Register report to review year-end data for the amendment. Set the Report Type parameter to Amended.
4. Run the End-of-Year Exception report to review exceptions for the amendment. Set the Report Type parameter to Amended.
5. Run the End-of-Year Reports process to generate the amended year-end PDF.
6. Run the End-of-Year Reports process to generate the amended year-end interface.

When performing amendments for the employee, note the following tips:

- If you perform a YTD adjustment to amend a year-end slip after the original PDF and interface is processed, the date of the YTD adjustments for the prior year must be "12/31/XX", where XX denotes the affected year. The balance adjustment is processed using the results element that feeds the year-end balance. Ensure that the eligibility exist for the results element.
- The file name of the T4, T4A, RL-1, and RL-2 registers and PDFs distinguish if it's an original or amended version.
- The header of the register indicates if it's an original or amended version.
- The PDFs follow government guidelines to distinguish if it's an original or amended version.
- The RL-1 includes the original slip number from the original archive and reports it on the amended version of the PDF and interface file.

The amended slip is provided to the employee, as well as reported to the government.

# 10 Troubleshoot End-of-Year Reporting

## Common Issues with End-of-Year Reporting

# 11 Year-Begin

## Begin-of-Year Processing

Complete year-begin activities after you complete your last payrolls of the year, but before you run the first payrolls of the new year. Year-Begin processing involves the following:

- Report/Remove Employee Tax Overrides
- Load Basic Personal Amounts for all Provinces and Territories
- Payroll Definition Updates

### Report/Remove Employee Tax Overrides

The Tax Overrides Report provides the ability to either report, or report and remove, federal and provincial tax overrides for employees. This is especially useful for employers who, as part of their year-end and year-begin activities, want to reset the Total Claim Amount to the Basic Amount.

The federal and provincial overrides to report are:

- Total Claim Amount (Federal and Provincial)
- Annual Deduction (Federal and Quebec)
- Other Tax Credits (Federal and Provincial)
- Additional Tax (Federal and Quebec)
- Annual Income Including Commission (Federal)
- Annual Commission Income (Quebec)
- Commission Expenses (Federal and Quebec)
- Labour Fund Contributions (Federal and Provincial)
- Tax Rate (Federal and Quebec)
- Tax Amount (Federal and Quebec)
- Prescribed Zone Deduction (Federal and Quebec)
- Federal Lump Sum Rate (Federal and Provincial)
- Provincial Lump Sum Rate (Quebec only)

### Payroll Definition Updates

Use the Manage Payroll Definitions task to verify the payroll calendar dates for the coming calendar year.

## Tax Overrides Report

When you run the Tax Overrides Report, these two tasks are executed sequentially:

1. Report Tax Overrides
2. Remove Tax Overrides

The Report Tax Overrides task reports the overrides for the selected employees. The Remove Tax Overrides task removes the override values, for the selected data type, if overrides exist.

**Note:** Roll back isn't supported for the Tax Overrides Report.

Use the **Run Tax Overrides Report** task from the **Regulatory and Tax Reporting** area under **Payroll** on your Home page to run the report..

## Parameters

### Flow Pattern

Select **Run Tax Overrides Report**.

### Payroll Flow

Enter a payroll flow name.

### Effective Date

Enter an effective date. This is required. The report removes or reports records as of the effective date you enter.

**Note:** If future-dated records exist, the overrides aren't removed.

### Payroll Statutory Unit

Select a payroll statutory unit (PSU), if you want to run the report by a PSU.

### Tax Reporting Unit

Select a tax reporting unit (TRU), if you want to run the report by a TRU.

### Payroll

Select a payroll, if you want to run the report by a payroll.

### Payroll Relationship Group

Select the payroll relationship group name, if you have defined one. For example, you can create a group to process all employees within a specific province.

**Note:** Use the **Objects Group** task under **Payroll** in **My Client Groups** on the Home page to define the payroll relationship group before you can select it here.

### Data Type

Select the data type. This is required. Valid values are:

- Total claim amount
- Annual deduction
- Other tax credits

- RRSP limit
- Lump sum rate
- All

**Note:** It's important to note that report doesn't remove all the overrides when you select All as the Data Type parameter. It removes only the Total Claim Amount, Annual Deduction, Other Tax Credit, RRSP Limit, and Lump Sum Rate overrides. Also, if you select All as the Data Type parameter, the report displays all value definitions regardless of the parameters selected. For example, there's no province filtering.

## Reporting Mode

Select the reporting mode. This is mandatory. Valid values are:

- Report Overrides (default)
- Report and Remove Overrides

## Process Configuration Group

Select the process configuration group name, if you have defined any. This field is used for logging and reporting purposes.

**Note:** Use the **Payroll Process Configuration** task under **Payroll** in **My Client Groups** on the Home page to define the process configuration group before you can select it here.

## Report Results

The Report Tax Overrides task reports the overrides for the selected employees in an Excel format. The data isn't sorted, but you can sort easily in the spreadsheet according to your needs.

The Remove Tax Overrides task removes the override values, for the selected data type, if overrides exist.

The Data Type and Mode parameter work together. This table displays the relationship for each parameter selection and the override that's reported, or reported and removed.

## Create User-Defined Balance Usage Groups

Create additional balance group usages, if the predefined balance groups don't meet your specific reporting needs for the Employee Active Payroll Balance Report. You can then use the newly created balance group as a parameter while running the report.

Use the **Balance Definitions** task under **Payroll** in **My Client Groups** on the Home page to create a balance.

This topic explains how you can create a:

1. Balance
2. Balance Group
3. Balance Group Usage

To create a balance:

1. Search and select the **Balance Definitions** task.
2. Click **Create** on the Balance Definitions page.
3. Select the **Legislative Data Group** and click **Continue**.
4. Add the Payroll Balance details, and click **Next**.
5. On the Balance Dimensions page, click **Select and Add**.
6. Search for and select the **Dimension Name**, for example, Relationship Tax Unit Run or Relationship Tax Unit Year to Date.
7. Click **Apply**, and then **Done**.
8. Click **Next, Submit**, and then **OK**.

**Note:** Use this procedure only if you don't want to use the predefined balances.

To create a balance group:

1. Search and select the **Balance Groups** task under **Payroll** in **My Client Groups** on the Home page.
2. Click **Create** on the Balance Groups page.
3. Select the **Legislative Data Group**, enter a **Name**, and click **Continue**.
4. Click **Submit**.
5. In the Balance Group Overview pane, click **Balance Definitions**, and then click **Select and Add**.
6. Search for and select the required **Balance Definition**.
7. Click **Apply** to add each balance definition you require, and then click **OK**. You can select the predefined balances or a new balance.

**Note:** If the context level balance values are required for Reference Code and Year End Forms (Statutory Report Type), add the balances with dimensions that include that context. For example Relationship Tax Unit, Province, Reference Code Year to Date or Relationship Tax Unit, Statutory Report Type Run.

8. Click **Submit**.

To create a balance group usage:

1. Select the **Balance Group Usages** task under **Payroll** in **My Client Groups** on the Home page.
2. Click **Create** on the Balance Group Usages page.
3. Select the **Legislative Data Group**, and enter a name.
4. Select the newly added Balance Group, and select **Matrix**.
5. Click **Continue**.
6. In the Balance Group Usages pane, select **Matrix Items**.
7. In Matrix Items page, click **Create**.
8. Search for and select the required **Balance Dimension Name** and enter a Position value. Continue this step until you have created all the required usages. Create multiple usages for each combination of contexts required.

**Note:** Each Balance Group Usage should only contain one period type of balance dimensions, for example, all Run, or all Year to Date, or all Month to Date.

9. To sort the balances in the group, select **Sorting** to define the sequencing.
10. Click **Submit**.

You can now select the newly added Balance Group Usage as a parameter of the report.
