1 Introduction

End-of-Year Processing for the US

US end-of-year processing consists of multiple steps, which you must complete in the correct order. You should perform these steps first in a test environment.

Before your fourth quarter starts, run a trial year-end process to validate your results.

End-of-year processing entails the following activities. Amend them as required to suit your specific organization needs. Best practice is to document any changes thoroughly to ensure proper processing in the future.

1. Configure for end-of-year.

Before beginning your end-of-year reporting, make sure you've performed the following operations.

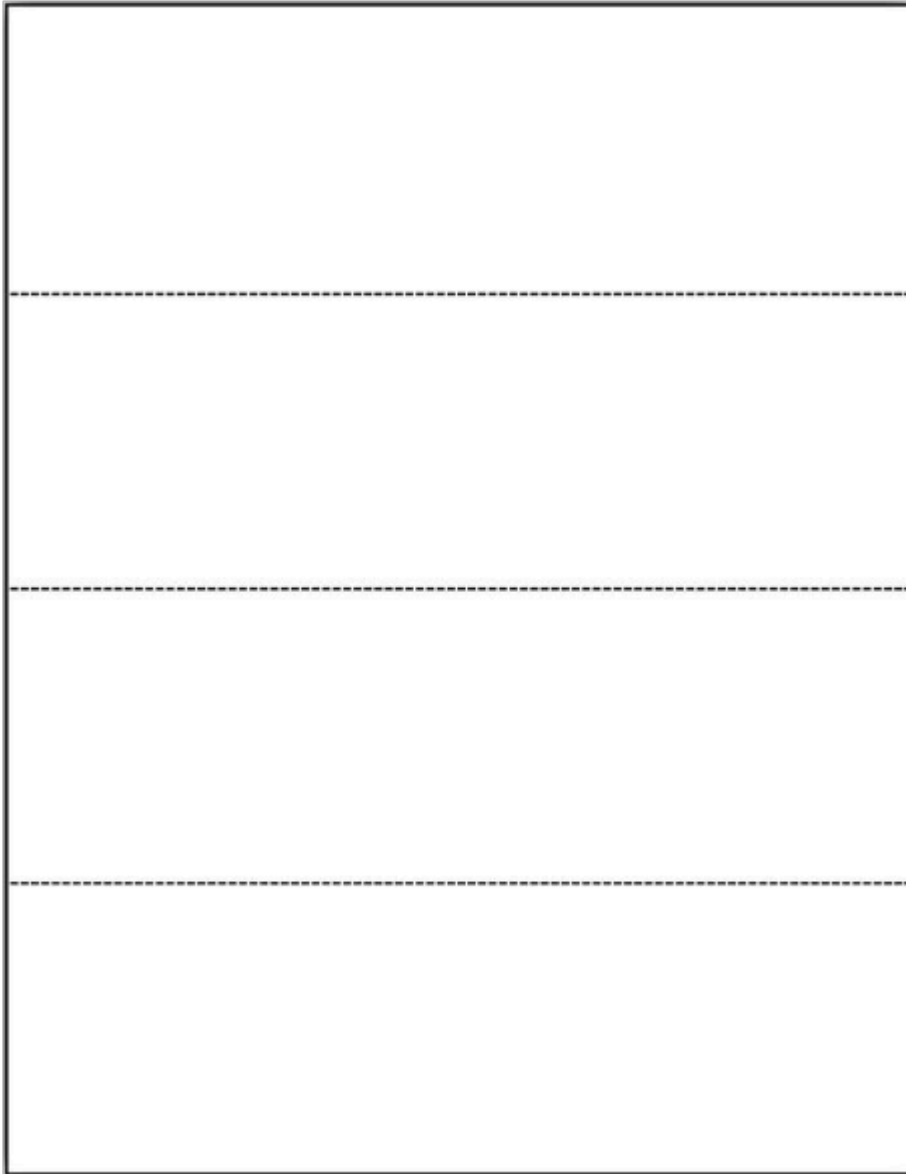

2. Order year-end tax form paper stock.

For employees opting to receive paper delivery of their year-end tax forms, you print these forms on 4up



perforated paper.

You have the option of using paper stock with the employee instructions preprinted on the backside. However, you can elect to print the instructions yourself.

The US Form W-2 printing format supports form #5208 and window envelope #4444-1. You can buy these forms from any supplier you choose, such as Evergreen, Greatland, and Complyright.

No specific paper stock is needed for Form W-2PR, W-2c, W-2cGU, or W-2cPR.

3. Complete all payroll processing for the year.

4. Perform your prearchival processing.

5. Fix any balance problems detected by the prearchival reports.

6. Perform your quarter-end processing for the fourth quarter, and resolve any errors detected.

7. Use the Assign Control Number for Puerto Rico Employee flow to assign W-2PR control numbers to your Puerto Rico employees.

8. Archive your end-of-year payroll results.

9. Perform year-end balance reconciliation, and resolve any errors detected.

10. Use the W-2 Register Report to validate your archived data, resolve any balance issues detected, and repeat the year-end data archive.

11. Generate the year-end tax and wage reports.

- Use the Third-Party Quarterly Tax Filing Extract flow to submit your end-of-year data to your third-party tax filing provider. You submit this data to your third-party provider, which generates the appropriate electronic files and submits them. These files include EFW2, EFW2c, MMW2PR-1, and Form 940.

Note: The Third-Party Quarterly Tax Filing Extract isn't dependent on the year-end or quarter-end archives.

- Use the W-2 Employee Report flow in Draft reporting mode to create year-end forms for report verification purposes.
- Use the W-2 Employee Report in Final reporting mode to create your employees' year-end forms. This flow creates the electronic forms published on the employees' Me page. It also generates the printed forms for those employees who have opted for paper distribution.

12. Distribute the employee forms as indicated by employee election.

For 1099-R recipients, you must contract with a third-party provider to print and distribute their year-end forms. Use the Third-Party Tax Filing Extract for Retirees to generate an output file of your retiree year-end data. See their documentation for instructions on how to pass this file to their print services.

13. Lock the W-2 and W-2c document types in Document Records to prevent them from being changed.

14. Run the year-begin flow.

Run any necessary year-begin flows between running the last payroll of the year and the first payroll of the next year.

Configure Number of Rows for W-2 Box 14

By default, the Form W-2 and W-2c PDF templates support up to four rows for Box 14.

You can set the maximum number of rows at the payroll statutory unit (PSU) and tax reporting unit (TRU) levels. A setting on the TRU overrides the setting on the PSU.

To set this value:

1. Start the Manage Legal Entity HCM Information task to set it at the PSU level.
Use the Manage Legal Reporting Unit HCM Information to set it at the TRU level.
2. Click **Federal** in either **Payroll Statutory Unit** or **Tax Reporting Unit**.
3. In **Federal Year-End Reporting Rules**, set the maximum rows.
You can select a value between 2 and 9.

Note: If you specify more than four, you must manually configure the W-2 and W-2c PDF templates to support the additional rows.

4. Save your work.

Configure Organizations for Year End for the US

Before you attempt to generate your year-end forms, make sure you've correctly configured your organizations.

This involves:

- Configuring federal and state registrations
- Configuring tax reporting units (TRUs)

How you configure federal and state registrations

Use the Legal Reporting Unit Registrations task to make sure you populated the following fields for each TRU.

This jurisdiction	Uses this field name	This is how it's used
United States Federal Tax	EIN or TIN	Your federal employer identification number (EIN)
United States Federal Tax	Registered Name	Your employer name
United States Federal Tax	Address	Your employer address
<state> Income Tax	Registration Number	Your employer state EIN

How you configure tax reporting units

To set W-2 info for your TRUs:

1. From **My Client Groups**, click **Workforce Structures**.
2. Click **Manage Legal Reporting Unit HCM Information**.
3. In **Tax Reporting Unit**, select **Federal**.
4. In **Federal Year-End Reporting Rules**, enter the following.

For this field	Enter this
W-2 Publish Month	Specify the month when the employee can view their W-2.
W-2 Publish Day	Specify the day when the employee can view their W-2.
W-2c Publish Month	Specify the month when the employee can view their W-2c.
W-2c Publish Day	Specify the day when the employee can view their W-2c.
Maximum W-2 Box 14 Rows	Specify the maximum number of entries allowed in Box 14. Note: If you are using Cloud to generate forms W-2 and W-2c, their predefined templates support up to four entries. If you select more than four in this field, you must update the templates to accommodate them. These form templates are often updated by Oracle, so this would be a recurring obligation.
1099-C Publish Month	Specify the month when the employee can view their 1099-C.
1099-C Publish Day	Specify the day when the employee can view their 1099-C.

5. If necessary, set regional values.

For this field	Enter this
NJ Disability Insurance	Identify your plan type and, if a private plan, the plan number.
NJ Family Leave Insurance	Identify your plan type and, if a private plan, the plan number.

Configure Employees for Year End for the US

Before you attempt to generate your year-end forms, make sure you've properly configured your employees.

Employee type	What you need to do
US employee	When you create employee roles, be sure to add the View US End of Year Tax Form privilege. This privilege is attached to the US Employee Portrait Gallery duty role, which lets employees use the View US End-of-Year Tax Form task. Without it, they won't be able to view their W-2s online. US territorial employees	1. When you create employee roles, be sure to add the View US End of Year Tax Form privilege. This privilege is attached to the US Employee Portrait Gallery duty role, which lets employees use the View US End-of-Year Tax Form task. Without it, they won't be able to view their Forms W-2GU and W-2PR online. 2. Any Puerto Rico employee must provide their birth date when reporting Code E in Box 16 of their Form W-2PR. Use Date of Birth in either the Person task or through the new hire process. 3. Employees in Guam have the same requirements as US employees. Document Delivery Preferences for Year End for the US

You can generate these employee year-end forms suitable for either paper or online delivery.

- W-2
- W-2c
- W-2cPR
- W-2GU
- W-2PR

When you process the end-of-year forms in the Final reporting mode, the task automatically creates the PDF versions and publishes them to the Document Records. For employees who have opted for paper delivery, the tasks create separate PDF files containing their forms. You can print and distribute these files as needed.

Before you attempt to generate your year-end forms, make sure you've set your employees' document delivery methods and other delivery-related preferences. You set these preferences using the Document Types task.

This document type is available for viewing.

This type	Is used for this
W_2	Employee Form W-2
W_2c	Employee Form W-2c

Here's your configuration steps.

1. Access the document types.
2. Set your default print options.
3. Set the document delivery overrides.
4. Restrict access to documents and attachments.
5. Set the print elections.

How you access the document types

To access a document type for viewing or editing:

1. Start the Document Types task.
2. Search for all United States document types.
3. Select the W-2 document type in the search results.

From here, you can set:

- Print option defaults
- Document delivery overrides
- Restrictions on the changes you can make to documents stored in Document Records

You can also use the Document Delivery Preferences task to set print elections of these documents for individual employees and as mass updates.

How you set the print option defaults

To change the employer default print options:

1. Open the appropriate document type in the Document Types task.
2. In the edit page, in **Document Type Information**, ensure the **Enable Document Delivery Preferences** field is set to **Yes**.
3. Use **Override Hierarchy** to define the level where your document overrides are applied. You can choose between the **Document Type** and **Person** levels. For further info, see How You Set Preferences for Document Delivery in the Help Center.

Note: This field is available only if you set **Enable Document Delivery Preferences** to **Yes**.

4. In **Document Delivery Preferences**, check the settings and make changes as needed.

For this field	Enter this
Delivery Method	Default delivery methods for your employees' forms. By default, Online isn't selected and Paper is selected. If you're outsourcing the printing of your employee forms to a third-party provider, change this setting as necessary to satisfy their requirements.

Regardless of what delivery preference you set, the process always publishes a PDF version of the form to Document Records.

5. Click **Submit**.

How you set document delivery overrides

After you set the default delivery preferences, you can set any needed overrides at the Person level. Use the Document Delivery Preferences task. and query a specific person.

Use the Document Types task to enable **Allow Person Level Overrides** for your people. If you do, workers can use the Document Delivery Preferences task to specify their own delivery preferences.

To view all overrides made to the form delivery settings:

1. Start the Document Types task.
2. Search for and select the **W_2** document type.
3. Click **Document Delivery Preferences**.
4. Click **View Document Delivery Preference Report**.

View Document Delivery Preferences Report provides info about all overrides set at the organization and person levels.

To export the details in Microsoft Excel format, click **Export to Microsoft Excel**.

To remove overrides, click **Remove Overrides**.

5. Click **Done**.
6. Repeat these steps for the **W_2c** document type.

How you restrict access to documents

You might want to restrict employee access to the documents stored in Document Records. These settings control access to documents by people using the Employee role.

For example, after you have generated and distributed the employee year-end forms, you would lock those documents to prevent an employee from changing or deleting them.

To lock your year-end documents:

1. Open the appropriate document type in the Document Types task.

2. Select **Document Record Preferences** and then **Restrict Settings**.
3. Set the appropriate create, update, and delete restrictions for the document.

How you set print elections for individual people

If you allow your employees to specify their own print options for the year-end tax forms, they can do so through their **Me** page.

1. On the **Me** page, select **Pay**.
2. Select **Personal and Employment** and then **Document Delivery Preferences**. This table provides options for online and paper preferences.
3. For the W_2 or W_2c document type, click **Edit** and make the changes.

Mask Employee Social Security Numbers for the US and Guam

You have the option to mask your employees' Social Security numbers on their year-end forms. If you choose to do this, you must perform this configuration before you attempt to generate the forms.

You can mask employee Social Security Numbers (SSNs) on the employee W-2 4-up form.

- B - To be filed with the employee's federal tax return
- C – For the employee's records
- 1 – To be filed with the employee's state, city, or local income tax return
- 2 – To be filed with employee's state, city, or local income tax return

Note: Before modifying copy 1 or 2, confirm with your state, city, and local governments if they allow masking or truncation of Social Security numbers.

You can configure the masking to appear as either XXX-XX-1234 or ***-**-1234.

Note: The EmployeeW2 template changes every year, so you must perform this configuration yearly.

To mask the SSNs:

1. Open the appropriate predefined EmployeeW2 template in the `custom` folder.

2. Edit the template to mask the SSN.

- a. Navigate to **Copy B: Employee's social security number (SSN)**.
- b. Right-click **SSN**, and select **BI-Publisher** and then **Properties**.
- c. Replace:

```
<?../EMPLOYEE_INFO_REC/PRIMARY_NID?>
```

with:

```
<?concat('XXX-XX-', substring(EMPLOYEE_INFO_REC/PRIMARY_NID,string-length(EMPLOYEE_INFO_REC/  
PRIMARY_NID)-4))?>
```

Note: You can use X or * as the masking character.

- d. Click **OK**.
3. Repeat this step for Copy C and other copies as appropriate.
 4. Upload the template.

If you have performed this configuration in previous years, you must first remove the old template from the `custom` folder.

Define Balance Feeds for Year-End Forms

Before you attempt to generate your year-end forms, make sure you've established the necessary balance feeds.

This makes sure the balances appear correctly in the appropriate boxes on your on your US and territory W-2 forms.

To do this:

1. Use the Balance Definitions task to establish balance feeds for all W-2 balances applicable to your business. Every box has one or more balances that must be fed.
Box balances that begin with "W2" aren't automatically fed. You must create the feeds using the appropriate user-defined elements you've defined.

Special step for Form W-2

You must define balance feeds for any W-2 box 14 and box 12 balance you want to use.

For example, use the W2 BOX 14B balance with the Box 14 lookup code.

Special steps for Form W-2PR

You must identify your user-defined deductions as belonging to Puerto Rico. This involves configuring these balances and the results elements that feed them.

- W2 Territory 401k
- W2 Territory Charitable Contributions
- W2 Territory Government Employee Savings Plan
- W2 Territory Government Retirement Fund

To do this:

1. Use the Elements task to edit the results elements of the user-defined deductions that feed these balances.
2. In **Element Summary**, create an input value with the following.

For this input value	Enter this
Name	State
Displayed	Selected
Allow User Entry	Selected

For this input value	Enter this
Create a Database Item	Selected
Unit of Measure	Integer
Display Sequence	1

Note: Do this before you use this element for any payroll calculations. If you don't, the Form W-2PR or Employee Active Payroll Balance Report won't include the balances.

3. In **Default Entry Values and Validation**, set **Reference** to **State**.
4. In **Default Value**, set the following.

For this field	Enter this
Default	PR
Apply Default at Run Time	No

5. Click **Save**.
6. Use the Fast Formula task to modify the element's formula, such as "401k_Calculator_Formula" for Puerto Rico 401 (k).
7. Insert this line at the beginning of the formula.

state=72

This makes sure the element output is correctly configured for Puerto Rico.

2. Use the Common Lookups task to update the meaning of the corresponding lookup code of the ORA_HRX_US_W2_BOX_14_USER_DFND lookup type.

The text you type becomes the label text appearing on the W-2 Box 14.

Note: This box has a 15-character limit. If you're exporting your payroll data to ADP, they enforce a 10-character limit.

3. If multiple states share the balance you're using, some additional configuration is required, such as for Family Leave Insurance. This makes sure you capture info only for the correct state.

2. Add an input value for this element called **DC FLI ER Liability Calculated**.

3. Create element eligibility for the information element.

- Don't feed the predefined Family Leave Insurance Employer element to this W-2 balance.
- If you have fed a predefined tax element used by multiple states to a W-2 balance, you must end-date or delete the feed.
- If you already configured this W-2 balance feed for prior years, you would need to end-date the feed instead of deleting it.

If you don't do this, and an employee has the family leave insurance employer liability for more than one state, their totals will be overstated in Box 14.

5. Update the meaning of the corresponding lookup code of the ORA_HRX_US_W2_BOX_14_USER_DFND lookup type. For this example, this is lookup code C.

The meaning you enter becomes the label text appearing on the W-2 Box 14.

Note: This box has a 15-character limit. If you're exporting your payroll data to ADP, they enforce a 10-character limit.

6. Complete your payroll runs for the year.

7. Use the Employee Active Payroll Balance report to identify all DC employees with a Family Leave Insurance Employer Liability YTD balance.
8. For any employee identified, create a balance adjustment for the year-to-date tax liability, using your Information element.

End-of-Year Tax and Wage Reports for the US

Processing for year-end involves generating and submitting several federal and state end-of-year reports.

Form name	How you use it
1099-R	These are the tax forms you distribute to your retirees at year end. They include details of the earnings and taxes paid by the person for a given year. To capture this data and submit it to the IRS, use the Oracle Fusion Third-Party Quarterly Tax Filing Extract. This extract generates and submits the tax info to a third-party reporting provider, such as ADP, and they forward it to the proper tax authorities.
Employers Annual Federal Unemployment Tax Return	This is a tax form you issue to the IRS at year end. It reports the employer's contribution to the Federal Unemployment Tax Act (FUTA). Also known as Form 940. To capture this data and submit it to the IRS, use the Oracle Fusion Third-Party Quarterly Tax Filing Extract. This extract generates and submits the tax info to a third-party reporting provider, such as ADP, and they forward it to the proper tax authorities.
EFW2 and EFW2PR files	These are the files you submit electronically to the Social Security Administration (SSA), state, territory, county, and city authorities. To report the year-end info to the SSA and appropriate regional authorities, use the Oracle Fusion Third-Party Quarterly Tax Filing Extract. This extract generates and submits the tax info to a third-party reporting provider, such as ADP, and they forward it to the proper tax authorities.
EFW2c and EFW2cPR files	These are the files you create if changes are required after you have submitted the employee tax info to the SSA or third-party tax filing provider. They include details on the changes made to a previously reported year-end form. To report the W-2c info to the SSA and appropriate regional authorities, use the Oracle Fusion Third-Party Quarterly Tax Filing Extract. This extract generates an updated tax info file suitable for submission to a third-party reporting provider. Based on the content of the file and the date submitted, the provider determines what changes were made and files the proper amended tax returns. Note: Not all third parties support EFW2c submission. Refer to their documentation for details.
W-2 Employee Report W-2GU Employee Report W-2PR Employee Report	These are the tax forms you distribute to the employees at year end. They include details of the earnings and taxes paid by the employee for a given year. The W-2 Employee Report flow creates a PDF document based on archived data and stores it in the Document Records. Employees can view their Forms W-2, W-2GU, and W-2PR through their Me page. They can also elect to receive a printed copy. Managers and professional users can access employee forms through the Document Records task.

Form name	How you use it
	You can outsource the printing of these forms to a third-party, such as ADP or MasterTax. These providers use the data you provide in the fourth quarter tax file. Refer to their documentation for details.
W-2c Employee Report W-2cGU Employee Report W-2cPR Employee Report	These are the corrected tax forms you distribute to employees if changes or corrections were made after submitting their tax info to the SSA or third-party tax filing provider. They include details on the changes made to the previously reported W-2 or W-2c. Employees can view their Forms W-2c, W-2cGU, and W-2cPR through their Me page. They can also elect to receive a printed copy. Managers and professional users can access these forms through the Document Records task.

Correct Your Year-End Form Data

When changes to tax data are necessary, you have options on how to report them, depending on the timing of the changes.

Update the year-end forms	After fixing the data, rerun the report process.
Generate Form W-2c	After fixing the data, use the W-2c Employee Report process.
Update your fourth quarter tax file	If you're the Third-Party Quarterly Tax Filing Extract to process your tax data, you must send an updated fourth quarter tax file to your supplier.

Update Your Employee Year-End Forms

You can update and regenerate your employee W-2 or W-2GU if:

- You haven't yet issued the form to your employees
- The deadline for submitting your year-end tax file to your third-party tax-filing supplier hasn't yet passed

5. Run the Run W-2 Employee Report process.

To perform additional checks before distribution, run it in Draft mode. Run it in Final mode if you're ready for employee distribution.

6. Use the Third-Party Quarterly Tax Filing Extract to process your tax data and submit the fourth quarter tax file to your supplier.

If you have already submitted the file, you must resolve the tax data changes with your supplier. Depending on the data changed and the scope of the change, your options include:

- In most cases, you can regenerate a fourth quarter tax file and submit to your provider. The supplier determines what changes were made and submit file EFW2 to the appropriate agencies.
- For corrections to data that's not passed in the tax file, such as registration IDs, contact the supplier to determine the best action.

Generate Form W-2c

Sometimes you need to make changes or corrections to your year-end tax data after sending the electronic data files to the Social Security Administration (SSA) or a third-party tax filing provider. When this happens, you must create and issue Form W-2c to report the new data.

Form W-2c reports changes to:

- Form W-2
- Form W-2GU
- Previous Form W-2c

To create Form W-2c:

1. Make the necessary data changes in Oracle Fusion.

This might require balance adjustments. For further info, see the following on My Oracle Support.

2. Run the W-2c Archive Process to archive the data changes.
3. Run the W-2c Employee Report to generate Form W-2c suitable for issuing to the employee electronically or by print.

Use the Draft mode to create an output file suitable for review.

When you're certain the Form W-2c is ready for employee distribution, run the process in Final mode.

Note: This process performs locking actions on the data regardless of the setting you choose. If you find errors in your draft report, roll back the Run W-2c Employee Report process before correcting the data and regenerating the report.

4. Use the Third-Party Quarterly Tax Filing Extract to create an updated fourth quarter data file, and submit it to your third-party tax filing supplier.

Update Your Fourth Quarter Tax File

If you're using the Third-Party Quarterly Tax Filing Extract to process your tax data, you must send an updated fourth quarter tax file to your supplier.

The supplier determines what changes you made. Depending on whether their deadline for accepting updated tax files has passed, they submit either the EFW2 or EFW2c files to the appropriate agencies.

In the course of preparing and processing your year-end tax data for reporting, you may determine that changes or corrections are needed.

How you uptake those changes into your year-end reports depends on where you're in the process.

- After you have run the year-end archive
- After you have generated your employee Form W-2s Draft mode
- After you have generated your employee Form W-2s in Final mode
- After you have distributed the employee Form W-2s
- After the third-party tax-filing supplier's submission deadline

After You Have Run the Year-End Archive

If you make changes to your employee data after you ran the year-end archive, you can still update the archive, assuming:

- You haven't generated the Form W-2 by running the W-2 Employee Report flow in Final mode.
- Your third-party tax-filing supplier's deadline for accepting 4th quarter tax files hasn't yet passed.

To do this:

1. Make your changes to the tax data.

4. Use the W-2 Employee Report flow to create your employee W-2s.

5. If you haven't already done so, use the Third-Party Quarterly Tax Filing Extract to process your tax data and submit the 4th quarter tax file to your supplier.

If you have already submitted the file, you must resolve the tax data changes with your supplier. Depending on the data changed and the scope of the change, you can:

- In most cases, regenerate a 4th quarter tax file and submit it to your supplier.
- For corrections to data that's not passed in the tax file, such as registration IDs, contact your supplier to determine the best action.

After You Have Generated Your Employee Form W-2s Draft Mode

The W-2 Employee Report flow provides a Draft mode so you can create sample Form W-2s for testing and verification purposes.

In this case, if you need to make updates, it's assumed:

- You have successfully run this flow in Draft mode.
- You haven't run this flow in Final mode or distributed the forms to your employees.
- Your third-party tax-filing supplier's deadline for accepting 4th quarter tax files hasn't yet passed.

After reviewing these reports, if you determine that changes are necessary:

1. Make your changes to the tax data.

You may have to perform a balance adjustment. For further info, see the following on My Oracle Support.

3. Rerun the archive to capture your updated data.
4. Run the W-2 Register flow to review your year-end data.
5. Run the W-2 Employee Report flow.
 - If you feel additional checks may be necessary, run this flow in Draft mode again and repeat your review.
 - If you're certain the Form W-2 is ready for employee distribution, run this flow in Final mode and distribute the forms to your employees.
6. If you haven't already done so, use the Third-Party Quarterly Tax Filing Extract to process your tax data and submit the 4th quarter tax file to your supplier.

For corrections to data that's not passed in the tax file, such as registration IDs, contact your supplier to determine the best action.

After You Have Generated Your Employee Form W-2s in Final Mode

Changes to your year-end tax data may be necessary after you have run the W-2 Employee Report flow in Final mode. In these cases, you can update the forms with the changes, assuming:

- You haven't issued the Form W-2s to your employees.
- Your third-party tax-filing supplier's deadline for accepting 4th quarter tax files hasn't yet passed.

Note: Because you ran this flow in Final mode, it applied data locks on the archived data. You must roll back this flow before you can retry or roll back the archive.

To do this:

1. Make your changes to the tax data.

You may have to perform a balance adjustment. For further info, see the following on My Oracle Support.

Note: If you made changes made to the following values, you don't have to rerun the archive.

- Employer address
- Employee mailing address
- Employee document delivery preferences
- Employee birth date (Puerto Rico)
- TRU confirmation number (Puerto Rico)

For these values, the W-2 Employee Report flow derives them from live data.

4. Rerun the archive to capture your updated data.

5. Run the W-2 Register flow to review your year-end data.

6. Run the W-2 Employee Report flow.

- If you feel additional checks may be necessary, run this flow in Draft mode and repeat your review.
- If you're certain the Form W-2 is ready for employee distribution, run this flow in Final mode and distribute the forms to your employees.

7. If you haven't already done so, use the Third-Party Quarterly Tax Filing Extract to process your tax data and submit the 4th quarter tax file to your supplier.

If you have already submitted the file, you must resolve the tax data changes with the supplier. Depending on the data changed and the scope of the change, you can:

- In most cases, regenerate a 4th quarter tax file and submit to your supplier. The supplier determines what changes were made and submits file EFW2 to the appropriate agencies.
- For corrections to data that's not passed in the tax file, such as registration IDs, contact the supplier to determine the best action.

After You Have Distributed the Employee Form W-2s

Changes to your year-end tax data may be necessary after you have generated and issued the employee W-2s. In these cases, you must create Form W-2c to report the new tax data.

To do this:

1. Make your changes to the tax data.

You may have to perform a balance adjustment. For further info, see the following on My Oracle Support.

5. If you're using the Third-Party Quarterly Tax Filing Extract to process your tax data through a third party, you must resolve the data error with your supplier. Depending on the data changed and the scope of the change, you can:

- In most cases, rerun the 4th quarter tax file and submit to the third-party supplier. The supplier determines what changes were made and submits file EFW2c to the appropriate agencies.

Note: Not all third-party providers support the submission of the EFW2c file or the automatic generation of Form W-2c from your extract. Consult with your supplier for more info.

- In cases where fewer than 250 employees are impacted, you have multiple submission options.

- For corrections to data that's not passed in the tax file, such as registration IDs, contact the supplier to determine the best action.

After the Third-Party Tax-Filing Supplier's Submission Deadline

After generating your employee W-2s and submitting the EFW2 file, you find changes are necessary. If the deadline for submitting tax files to your supplier has passed, you can't update the EFW2 file or employee Form W-2s with new info. Instead, you must create Form W-2c to report the changes.

To do this:

1. Make your changes to the tax data.

After You Have Distributed Employee Form W-2PR

Changes to your year-end tax data may be necessary after you have generated and issued the employee W-2PRs. In these cases, you must create Form W-2cPR to report the new tax data.

After the Third-Party Tax-Filing Supplier's Submission Deadline

If the deadline for submitting tax files to your supplier has passed, they can't update the EFW2PR file with new info. Instead, you need to work with them to report the changes in an EFW2CPR file.

Note: Not all third-party providers support the submission of the EFW2CPR file or the generation of Form W-2cPR.

To do this:

1. Make your changes to the tax data.

Examples of Troubleshooting Year-End Tax Data for the US

When archiving your year-end data and generating the files and forms, you may encounter the following conditions.

Changed Payroll Relationship Data Missing in Archive

If the payroll relationship was archived in a previous run, this data isn't archived again. To retrieve newly changed data for the payroll relationship, you have two options.

- Retry the archive for the impacted payroll relationship.
- Roll back the archive for the impacted payroll relationship, and run it again.

Year-End Form Content Is Incomplete

If the W-2 Employee Report flow is generating incomplete employee Forms W-2, W-2GU, or W-2PR, use the Legal Reporting Unit Registrations page to verify your federal and state registration info. For each tax reporting unit (TRU), check to see if you have captured the correct registration numbers for the United States Federal Tax and state Income Tax registrations.

Year-End Forms Display Employee Name or Social Security Number as Blanks

If you have issued forms to the Social Security Administration (SSA) where one or more employee names or Social Security Numbers are blank or missing, you must contact the SSA for instructions on resolution. Do not use Form W-2c for this kind of correction.

Year-End Forms Display Incorrect Employee Address

In cases where the forms were submitted to the SSA with incorrect employee addresses, you must reissue the forms with the incorrect address to the employee in an envelope showing the correct address or otherwise deliver it to the employee.

There's no requirement to submit an EFW2c file to the SSA.

Note: For employers using the Third-Party Quarterly Tax Filing Extract to manage their year-end reporting through ADP, ADP sends any corrected info to the SSA electronically.

Incorrect Employer Identification Number on the Forms

If the incorrect employer identification number (EIN) was reported on your employee year-end forms, proceed with the normal W-2c flow. When you do so, the W-2c Employee Report flow creates two Form W-2cs for distribution to the employee.

First Form W-2c	Box b	Your federal EIN as it was reported in the original Form W-2 or W-2c.
	Previously Reported	Money amounts as they were reported in the original Form W-2 or W-2c.
	Correct Information	All values filled with 0.
Second Form W-2c	Box b	Your correct federal EIN.
	Previously Reported	All values filled with 0.
	Correct Information	Money amounts as they were reported in the original Form W-2 or W-2c.

6 Year-Begin Preparation

Overview of Begin-of-Year Processing for the US

There are several begin-of-year activities you must perform before you run the first payrolls of the new year.

Some of these preparations involve updates to the employees' tax card, and you can perform them on the individual cards.

Note: You can perform your year-begin processing before you have completed your year-end processing of the previous year.

What you want to do	How you do it
Clear last year's deferred compensation deductions limit overrides	For employees who required limit overrides during the previous year, you must remove these overrides before your first payroll run of the year.
Clear or update last year's federal or state tax exemptions and allowances	Employees use the Tax Withholding task from their Me page to enter their W-4 exemptions and allowances. As federal and some state tax exemption statuses expire after a year, the employee must submit new withholding forms by the deadlines identified by the IRS and states tax agencies to renew them. If they allow an exemption to expire, you must end date it as of the expiration date. Use the Start-of-Year Process to identify and end date these exemptions. Or you can update the individual cards manually. Refer to your state tax authority for info on what exemptions expire.
Verify Indiana county of residence or employment	For employees working or living in Indiana, you must ensure their Tax Withholding cards record their resident and work counties as of January 1. Use the Start-of-Year Process to complete this verification before the first payroll run of the year.
Validate legislative limits	Use the Calculation Value Definitions task to view these predefined legislative limits. • 401 (k) Limit • 403 (b) and 457 (b) Limits • Social Security Limit • State FUTA Credit Reduction Limit • State Unemployment Wage Limit This data is predefined. You don't need to modify it.
Apply annual occupational or Local Service tax exemptions	Employees working in states with annual occupational or Local Services Taxes (LSTs) may seek exemption, such as the Pennsylvania LST. Use the Calculation Cards task to grant or revoke these exemptions.
Enable New York Paid Family Leave for eligible employees	The payroll process doesn't automatically withhold deductions for the New York Paid Family Leave program. You must impose this tax on eligible employees.

What you want to do	How you do it
Update your payroll definitions	Use the Payroll Definitions task to verify the payroll calendar dates for the coming calendar year.
Update your state unemployment insurance rates	The unemployment insurance divisions of the states where you employ workers may change their state unemployment insurance (SUI) rates for the new year. You must make these changes on your organization calculation card as soon as you have received the new rates.
Update your state unemployment insurance wage limit	These states have multiple SUI wage limits. - Michigan - Nebraska - Rhode Island If one of a state's wage limits changes for the new year, you must make the appropriate changes on your organization calculation card.
Opt-out individual employees from contributing to pretax age catch-up contribution	To opt-out an employee, do the following prior to processing the first payroll of the calendar year. 1. Start the Calculation Cards task. 2. Search for and select the person. 3. Open their Reporting Information card for editing. 4. Add the Reporting Information calculation component under the Federal component group. 5. Set Eligible for Pretax Age Catch-Up Contributions to No under the calculation component details. 6. Click Save and Close. You can do this for multiple employees through HCM Data Loader. For further info, see Payroll Configuration for SECURE 2.0 Act (ID 2971058.1) on My Oracle Support.

Clear last year's deferred compensation deductions limit overrides

For employees who required a deferred compensation deductions limit override during the previous year, you must remove the overrides before your first payroll run of the year.

Deduction types	Where you set the override
401 (k)	For employees with 401 (k) plans, you may have set the override values for these employees in a couple places. - For all employees enrolled in 401 (k) and 401 (k) catch-up, reset these input values on the Deferred Compensation 401k and Deferred Compensation 401k Catch-Up elements - For specific employees, reset them on the element entries For further info, see Set Up 401 (k) and Roth 401 (k) Deferred Compensation Plans in the Help Center.
403 (b) and 457 (b)	For employees requiring the same override for their 403 (b) and 457 (b) plans, you would have set it on their Benefits and Pensions calculation card. 403 (b)

	• Override IRS Annual Compensation Limit • Override IRS Annual Limit Catch-Up • Override IRS Employer Annual Compensation Limit • Override IRS Employer Catch-Up Annual Compensation Limit • Override IRS Limit 457 (b) • Override IRS Annual Limit Catch-Up • Override IRS Limit For further info, see Considerations When Setting Up 403 (b) and 457 (b) Deferred Compensation Plans in the Help Center.
457 (b) Special Catch-up	The Start-of-Year Process flow end-dates the Accumulated Under-Utilized Contributions for Special 457 (b) Catch-Up value definition for the previous year. You must define a new value definition for the current year. This is part of the 457 (b) limit update. For further info, see Special 457 (b) Catch-Up Contributions on the Help Center.

Use the Start-of-Year Process flow to identify the employees with an override amount for their 401 (k), 403 (b), and 457 (b) plans. If the employee has one of these overrides, this flow end-dates it.

- Accumulated Under-Utilized Contributions for 457 (b) Catch-Up
- Override IRS Annual Compensation Limit
- Override IRS Annual Limit Catch-Up
- Override IRS Employer Annual Compensation Limit
- Override IRS Employer Catch-Up Annual Compensation Limit
- Override IRS Limit

Clear or update last year's tax exemptions

Employees use the Tax Withholding task from their **Me** page to specify their W-4 exemptions and other federal fields that affect the calculation of taxes. Because the exemption statuses for federal and some state taxes expire after a year, the employee must submit new Form W-4s by the IRS deadline to renew them.

Consider issuing reminders to your employees to renew these exemptions.

Use the Start-of-Year Process flow in Draft mode to generate a report that identifies the employees with Exempt status. Use this flow as verification prior running in final mode. When you run it in Final mode, it removes the exemptions and date stamps them with the effective date you select in the parameters.

For further info, see Start-of-Year Process in the Help Center.

For those employees who want to renew their exemptions, you must apply them based on each person's W-4.

1. From **My Client Groups**, click **Payroll**.
2. Click **Calculation Cards**.
3. Search for the person, and open their Tax Withholding card for editing.
4. Specify the proper effective date.
5. In **Withholding Details**, select **Federal**.
6. Click **Edit**, and select **Update**.
7. In **Withholding Exemption**, specify the appropriate exemptions.
8. Save and submit your changes.

Verify Indiana county of residence or employment

For employees working or living in Indiana, you must ensure their Tax Withholding cards record their resident and work counties as of January 1. These cards must reflect any changes to their addresses before you run the first payrolls of the calendar year.

Note: Because the period between year-end and the deadline is so brief, you have limited time to update this data. Consider performing them early with a future effective date.

Use the Start-of-Year Process flow to:

1. Compare the employees' resident and work counties against the values in their tax cards.
2. Update the tax cards appropriately.

Apply annual occupational or local service tax exemptions

Employees working in states with annual occupational or LSTs may seek exemption, such as the Pennsylvania LST. If granted, they must provide you with their paperwork at the beginning of the calendar year.

Before processing the first payrolls of the year, you must capture these exemptions for your employees. For employees who have let their exemptions lapse, you must likewise update the tax card accordingly.

To specify these exemptions for multiple employees, use the HCM Data Loader.

Here's how you can specify these exemptions for individual employees.

1. From **My Client Groups**, click **Payroll**.
2. Click **Calculation Cards**.
3. Search for the person, and open their Tax Withholding card for editing.
4. Enter an effective as-of date.
5. Click **Regional**.
6. Review the following for each locality requiring exemption.
 - Exempt from LST
 - Exempt from City Tax
 - Exempt from School District Tax
7. If you need to make changes, click **Edit**.
8. Make the required changes.
Select **Yes** to apply the exemption.

Select **No** to revoke the exemption.

9. Save and submit your changes.

Enable New York family leave insurance for eligible employees

The payroll process doesn't automatically withhold deductions for the New York Paid Family Leave program. To impose this tax on eligible employees, enable it at one of these levels.

- Payroll statutory unit (PSU)
- Tax reporting unit (TRU)

Settings at the TRU level override those at the PSU level. Settings on the tax card override both.

Update your state unemployment insurance rates

The unemployment insurance divisions of the states where you employ workers may change their SUI rates for the new year. You must make these changes on your organization calculation cards as soon as you have received them.

Here's how you do it.

1. Search for and start the appropriate task from your implementation project.
 - Legal Entity Calculation Cards
 - Legal Reporting Unit Calculation Cards
2. Open the Calculation Rules for Tax Reporting and Payroll Statutory Unit card for editing.
Create it if it doesn't already exist.
3. Set the effective as-of date for the new rate.
4. Select the appropriate state node under the **Regional** component group.
Create it if it doesn't already exist.
5. Select the **State Unemployment** calculation component.
6. Select **Enterable Calculation Values on Calculation Cards** in **State Unemployment: Details**.
7. Select **SUI Employer Rate**, and click **Edit>Update**.
Add it if it doesn't already exist.
8. Enter the new rate, and click **OK**.
9. Click **Save and Close**.

Update your state unemployment insurance wage limit

The states where you employ workers may change their SUI wage limits for the new year. If you have made changes to state wage limits the previous year, review those changes on your organization calculation cards and update as appropriate.

For states with multiple wage limits, the tax calculations automatically use the lower limit. If you need the other limit, make the change on your organization calculation cards.

Here's how you do it.

1. Search for and start the appropriate task from your implementation project.

- For the PSU card, use Legal Entity Calculation Cards.
- For the TRU card, use Legal Reporting Unit Calculation Cards.
- 2. Open the card for editing.
Create it if it doesn't already exist.
- 3. Set the effective as-of date for the new wage limit as January 1.
- 4. Select the appropriate state node under **Regional**.
Create it if it doesn't already exist.
- 5. Select **State Unemployment**.
- 6. In **State Unemployment: Details**, select **Enterable Calculation Values on Calculation Cards**.
- 7. Select **SUI Wage Limit for Employer**.
Add it if it doesn't already exist.
- 8. Click **Edit**, and select **Update**.
- 9. Enter the new limit, and click **OK**.
- 10. Click **Save and Close**.

7 Appendix A: Year-End Reference Info

How the Payroll Process Calculates Indiana County Taxes

Employees working or living in Indiana, might be subject to Indiana county taxation. Use the Calculation Cards task to specify the employee's Indiana county of residence or employment as of January 1.

These values must be up-to-date before you run the first payrolls of the calendar year.

How the County Tax Is Determined

To determine Indiana county tax eligibility, the payroll process uses this hierarchy based on the employee's residence or work county.

1. As of January 1, if the employee is living in an Indiana county that has county income tax, the person is subject to that county's resident tax rate until:
 - End of the year
 - They're no longer an Indiana resident
2. If the county where the employee lived hasn't adopted a county income tax, they're subject to the nonresident tax rate of the county in which they were employed on January 1 of the current tax year.
3. If the employee moves to, or works in, another Indiana county after January 1, their county status doesn't change until the next calendar tax year.
4. If the employee moves to, or works in, a state other than Indiana, they're no longer subject to Indiana taxes.

New Jersey Disability Insurance

New Jersey Disability Insurance (SDI) is a tax for most workers whose employment is covered by New Jersey unemployment compensation law.

For employees enrolled in a private disability plan (DIPP) in New Jersey, the DI PP # appears in Box 14 of their W-2 reports.

Use the Legal Reporting Unit HCM Information task to identify your plan type and plan number.

8 Appendix B: Quarter-End Processing

Quarter-End Processing for the US

Quarter-end processing consists of the archival of data and the generation and submission of statutory reports. When you do this during the fourth quarter, you can include them as part of your end-of-year processing.

Performing quarter-end processing involves the interactions of these components.

- Quarter-to-Date Archive
- Quarterly Tax Reports
- Oracle Fusion Third-Party Tax Filing Interface
- Payroll Balancing
- Other Quarterly Reports

Quarter-to-Date Archive

The Quarter-to-Date Archive is a payroll flow that archives employee, employer, and tax data for a quarterly tax period. Based on the payroll statutory unit (PSU) or tax reporting unit (TRU) you select, it captures data for these payroll actions.

- R (Run)
- Q (QuickPay)
- B (Balance adjustment)
- I (Balance initialization)
- V (Reversal)

The Quarter-to-Date Archive uses the US State Quarter-to-Date Archive extract definition to gather this info. When completed, you can generate your reports.

Use either the Quarter-to-Date Archive flow or the Oracle Fusion Third-Party Tax Filing Interface to generate the following tax reports.

9 Appendix C: Reports and Processes

Archive End-of-Year Payroll Results for the US

For the purposes of reporting taxes and wages to the federal, state, and local governments, use the Archive End-of-Year Payroll Results flow before generating the reports.

This flow captures all employee balances for a given year and tax reporting unit (TRU) and archives them for year-end reporting.

You must run this process against every payroll statutory unit (PSU) that includes TRUs.

Running this flow is a prerequisite to generating end-of-year tax forms, such as the US Form W-2.

To run this flow:

1. From **My Client Groups**, click **Payroll**.
2. Click **Submit a Flow**.
3. Select your US legislative data group.
4. Search for and select **Archive End-of-Year Payroll Results**.

Before You Start

Use the Legal Reporting Unit Registrations task to ensure you have properly configured the federal and state registrations. Use **Search** to find the task if needed.

Use the Legal Reporting Unit HCM Information task to ensure you have properly configured the W-2 info for each of your TRUs. Use **Search** to find the task if needed.

Use the Balance Definitions task to ensure you have configured the balance feeds for your W-2 boxes. Use **Search** to find the task if needed.

Use the Calculation Cards task to ensure you have properly configured your employees' Tax Withholding and Reporting Information cards.

Run the prearchival flows as needed, and address any issues they detect. For further info, see Prearchival Reports for the US in the Help Center.

Payroll Flow

Provide a meaningful name for the payroll flow.

Specify the first day of the reporting year, January 1.

Process End Date

Specify the last day of the reporting year, December 31.

Payroll Statutory Unit

Select the PSU for archiving. The flow archives the year-end data of employees belonging to this PSU only.

Tax Reporting Unit

Select the TRU for archiving. The flow archives the year-end data of employees belonging to this TRU only. Leave blank to archive all TRUs in the PSU.

Reporting Reference Code

This field isn't used.

Payroll Relationship Group

Select a payroll relationship group.

Process Configuration Group

Select a process configuration group for logging and performance purposes.

Archive Results

This flow archives data for each payroll relationship in the selected PSU or TRU.

View Archive Results

To view the archived flow results:

1. From **My Client Groups**, click **Payroll**.
2. Click **Process Results Summary**.
3. Perform a search for an **Archive End-of-Year Payroll Results** flow pattern against the appropriate PSU or TRU.
4. Select **Output and Log Files**.
5. Select the log file to view.

To view an individual's results:

1. From **My Client Groups**, click **Payroll**.
2. Click **Process Results Summary**.
3. In the search criteria, specify the employee, process of **Archive Write**, and other relevant info and perform the search.
4. Select **Process Results**.
5. Select the archive results.
6. Select the record name to view the context.

Balance Reconciliation

Flow Rerun

Captures data for employees that were excluded from a previous archive. This flow doesn't archive data that was already archived by a previous run.

Flow Retry

Archives changed, new, or otherwise not archived data for the selected employees.

Flow Roll Back

There are instances where rerun or retry isn't possible, such as if you ran the Archive End-of-Year Payroll Results flow before all payroll processes had completed. In these cases, the data in the archive isn't valid. To resolve, you must perform a roll back operation.

When you roll back the Archive End-of-Year Payroll Results flow, all archived data is removed from the database. Rolling back and rerunning the Archive End-of-Year Payroll Results flow reruns the flow and recreates the archive completely.

Data Locks

The archived data is locked by flows you run subsequently, such as running the W-2 Employee Report flow. When locked, that data can't be changed through either retry or roll back of the archive. In this case, you have two options:

- Roll back the locking flow and then performing the archive.
- Mark the selected employees for retry in the locking process. By doing this, you can retry the archive for the impacted employees.

Note: Take care when rolling back the locking processes. If the W-2 has already been distributed to the employee or the electronic files submitted to the government authorities, additional steps are required.
