# 1 How do I configure payroll to set up absence donation pools?

## Define Payroll Elements for Absence Accrual Plans that Enable Donating to a Pool

This example shows how to define an absence element for a vacation accrual absence plan that's enabled for donating to a donation pool.

Based on your setup decisions, this procedure configures these additional elements:

- · Accrual element to process absence liability amounts
- Entitlement element to process payments for absence during vacation
- Discretionary disbursement element to process disbursement of partial time accruals
- Final disbursement element to process accrual disbursement when the absence plan enrollment ends
- Donation pool element to process donations from an employee to a donation pool

The name of the element is prefixed to each additional element.

**Note:** Each absence accrual plan will have its own, specific accrual element defined. The element you define for an accrual plan shouldn't be used across multiple plans. You can't map one element to multiple accrual plans.

This table summarizes key decisions for this scenario.

#### Define an Absence Element

Ensure that you've configured a rate definition to determine the monetary value of a unit of absence.

Depending on your enterprise, you should have also configured separate rates to calculate liability, discretionary disbursement, and final disbursement payments. You configure a rate definition using the Rate Definitions task.

Here's how you create absence accrual elements for donating to a donation pool:

- 1. Click My Client Groups > Show More > Payroll > Elements.
- 2. In the Create Element dialog box, select your Legislative Data Group.
- **3.** From the **Primary Classification** drop-down list, select **Absences**.
- 4. From the **Secondary Classification** drop-down list, select an appropriate value for your legislation, such as Vacation.

**Note:** Only accrual type absence plans can donate leave to a donation pool.

- 5. Click Continue.
- 6. On the Create Element: Basic Information page, enter Vacation Payment in the Name and Reporting Name fields.

### **Define Element Eligibility**

Here's how you define the eligibility for each element:

- 1. In the **Element Overview** section of the Element Summary page, click the **Element Eligibility** node.
- 2. From the Actions menu, click Create Element Eligibility.
- 3. In the Element Eligibility section, enter Vacation Payment Open in the Element Eligibility Name field.

Leave the rest of the fields on the page blank.

- 4. Click Submit.
- 5. Click Done.
- 6. On the Elements page, search for the other elements prefixed with your absence element name.
- 7. Select each element in turn and repeat the steps on the Element Summary page to define eligibility for each element.



## Define Payroll Elements for Donation Pool Plans

This example shows how to define an absence element for a donation pool plan.

Based on your setup decisions, this procedure might configure these additional elements:

- Accrual element to process absence liability amounts
- Entitlement element to process payments for absence during vacation
- Discretionary disbursement element to process disbursement of partial time accruals
- Final disbursement element to process accrual disbursement when the absence plan enrollment ends
- Donation pool element to process claims from a donation pool and maintain the donation pool total

The name of the element is prefixed to each additional element.

**Note:** Each donation pool plan will have its own, specific donation pool element defined. For example, the Emergency Donation Pool Plan will have an Emergency Donation Pool element; the Earthquake Donation Pool Plan will have an Earthquake Donation Pool element. The element you define for a donation pool plan shouldn't be used across multiple plans. You can't map one donation pool element to multiple donation pool plans.

- 6. On the Create Element: Basic Information page, enter Emergency Donation Pool in the Name and Reporting Name fields.
