# 1 How Do I Load Payroll Tax Info for the US

Oracle provides the tax info necessary for you to perform calculations and process payroll. Oracle Cloud Operations installs all required info as part of the regular patching.

Once the files are installed, you must run the Load Payroll Tax Information for US flow.

- Run it as part of the initial setup for your implementation project.
- Run it monthly for the Federal and State categories to ensure you receive the latest changes.
- Running it for the local categories can be resource intensive, so you may consider running it for them less frequently.

This flow updates the appropriate predefined calculation value definitions.

Depending on what category you select, this is what the flow does.

Tax category	What it does
Federal	<p>Oracle Fusion Human Capital Management for the US provides predefined federal-level calculation value definitions, and new definitions can be added with each release. Every time you run this process, it may update them.</p> <p>There are multiple federal-level calculation value definitions, such as Social Security wage limits and Federal unemployment tax (FUTA) credit reduction rates.</p>
State	<p>State-level calculation value definitions are predefined, and new ones can be added with each release. Every time you run this process, it can update them.</p> <p>There are multiple state-level calculation value definitions, such as state unemployment insurance (SUI) and state disability insurance (SDI) wage limits.</p>
City, tax district	<p>The first time you run this process, it delivers all local-level calculation value definitions.</p>
County	<p>When you implement payroll from your legacy system, run this process for these levels before you convert any local W-4 data.</p>
School District	

You can run tasks from the following locations.

## 2 Payroll Tax Info

### How Do I Install Payroll Tax Data Files

Oracle Cloud Operations installs these files for you. You automatically receive a notification when the file is available for installation.

Once the files are installed, run the Load Payroll Tax Information for US flow to update your tax data. Run it as part of your initial setup for the implementation project as well as monthly.

### How Do I Upload Payroll Tax Info

After the geography data files are installed, use the Load Geographies for US flow to load data into your installation after an update.

1. In **My Client Groups**, click **Payroll**.
2. Click **Submit a Flow**.
3. Search for your US legislative data group (LDG).
4. Search for and select **Load Payroll Tax Information for US**.
5. Specify the following values.

Field name	What you enter
Data Location	Location of the file to be used only if it's different from the default location.
Allow Upload of Older Version	Allow an older version of the data file to be uploaded, replacing newer data.
Geographic Category	Run for Federal and State each month. Run for City, County, and School District as needed.  <b>Note:</b> Federal and state runs can take a couple hours to process. Lower-level runs can take longer.

6. Click **Submit**.

## How Do I Upload Payroll Tax Info for a Specific Region

After the geography data files are installed, use the Load Geographies for US flow to load a specific region's data into your installation.

1. Run the Load Payroll Tax Information for US flow.
2. Select the appropriate value in **Geographic Category**.

## How Do I Resolve Payroll Tax Info Upload Problems

If you receive errors when you run the task, run the US Payroll JIT Validation test from the Diagnostic Dashboard. For further info, see Diagnostic Tests for the US in the Help Center.

If you're unable to resolve the issue, log a service request with Oracle Support.

If you're an On-Premise customer, contact your DBA or third-party provider for assistance.

## How Do I Review the Load Payroll Tax Info Log File

To view the log:

1. From the Navigator, select **Tools** and then **Scheduled Processes**.
2. Search for and select these processes.
  - Load US Postal Code Geographies
  - Load US Geography Identifiers
  - Load US Master Geographies
3. Click **View Log** for each, and check them for useful info.

## How Do I View My Payroll Tax Info

Use the Calculation Value Definition task to view the following tax info.

- Federal tax info
- State tax info
- Pretax info

### View Federal Tax Info

1. Start the Calculation Value Definitions task.

2. Select a US legislative data group (LDG).
3. In **Value Definition Group**, enter `Federal Tax Information`, and click **Search**.

This displays all federal-level value definition groups, such as the Medicare employer tax rate, Social Security employee wage limit, and Federal Unemployment Tax Act (FUTA) employer rate.

4. Click a group's link to view its detailed info.

## View State Tax Info

1. Start the Calculation Value Definitions task.
2. Select a US LDG.
3. In **Value Definition Group**, enter `State Tax Information`.
4. In **Name**, type the state you want to query and click **Search**.

This displays all value definition groups for that state, such as the state unemployment insurance (SUI) wage limit.

5. Click a group's link to view its detailed info.

## View Pretax Info

1. Start the Calculation Value Definitions task.
2. Select a US LDG.
3. In **Value Definition Group**, enter `Pretax` and click **Search**.

This displays all deferred compensation value definition groups.

This info isn't loaded as a result of the Load US Payroll Tax Information flow. The US localization provides a set of predefined calculation value definitions for deferred compensation.

4. Click a group's link to view its detailed info.

## How Do I Revert to an Older Payroll Tax Code Version

To revert to an older version:

1. Run the Load Payroll Tax Information for US flow.
2. Select **Yes** in **Allow Upload of Older Version**.
