are necessarily infringed by the use or sale of its Contribution alone

or when combined with the Program.

"Program" means the Contributions Distributed in accordance with this

Agreement.

"Recipient" means anyone who receives the Program under this Agreement

or any Secondary License (as applicable), including Contributors.

"Derivative Works" shall mean any work, whether in Source Code or other

form, that is based on (or derived from) the Program and for which the editorial revisions, annotations, elaborations, or other modifications represent, as a whole, an original work of authorship.

"Modified Works" shall mean any work in Source Code or other form that

results from an addition to, deletion from, or modification of the contents of the Program, including, for purposes of clarity any new file

in Source Code form that contains any contents of the Program. Modified

Works shall not include works that contain only declarations, interfaces, types, classes, structures, or files of the Program solely

in each case in order to link to, bind by name, or subclass the Program

or Modified Works thereof.

"Distribute" means the acts of a) distributing or b) making available

in any manner that enables the transfer of a copy.

"Source Code" means the form of a Program preferred for making modifications, including but not limited to software source code, documentation source, and configuration files.

"Secondary License" means either the GNU General Public License, Version 2.0, or any later versions of that license, including any exceptions or additional permissions as identified by the initial Contributor.

## 2. GRANT OF RIGHTS

Each Contributor disclaims any liability to Recipient for claims brought by any other entity based on infringement of intellectual property rights or otherwise. For example, if a third party patent license is required to allow Recipient to Distribute the Program, it is Recipient's responsibility to acquire that license before distributing the Program.

Commercial Contributor would have to defend claims against the other  
Contributors related to those performance claims and warranties, and if  
a court  
requires any other Contributor to pay any damages as a result, the

Contributor must pay those damages.
