Overview of the Integration

Oracle Utilities Work and Asset Cloud Service Integration to Oracle Fusion Procurement Cloud helps to facilitate a hybrid model for the Procurement module. Different business functions that are part of the integration initiate either in Oracle Utilities Work and Asset Cloud Service or Oracle Fusion Procurement Cloud, completing the Procure to Pay end-to-end cycle.

About Oracle Fusion Procurement Cloud

Oracle Fusion Procurement Cloud modernizes procurement by standardizing, streamlining and automating the source-to-settle process through automation and social collaboration, while controlling costs and achieving higher margins.

Oracle Purchasing Cloud

A key component of Oracle Fusion Procurement Cloud, Oracle Purchasing Cloud enables business to streamline and automate the procure-to-pay process while enforcing negotiated pricing and terms and ensuring policy compliance.

- It allows users to automate purchasing transactions and provides buying
 professionals insight into exceptions, status, and actions required. Users
 streamline routine tasks, such as creating purchase orders from approved
 requisitions without intervention, increasing productivity while enforcing
 compliance at every step. Users can utilize electronic communications with the
 suppliers to improve the timeliness and accuracy of purchase orders and changes.
- It provides the change management capabilities to help adapt to dynamic business needs. It allows changes to be initiated from requesters and suppliers reducing off-line communication and the chance of miscommunication. The supplier work area provides a summary of activity and transactions that require attention. Suppliers can access agreements, purchase orders, advance shipment notifications, invoices, and negotiations allowing suppliers to respond to your business needs.

Oracle Fusion Supplier Portal makes it easy to expand self-service to almost any supplier by providing an intuitive, browser-based solution. It also increases the variety of self-service transactions by providing a solution that is integrated across the entire source-to-settle lifecycle.

Oracle Utilities Work and Asset Cloud Service provides functionality to manage the receipt, installation, maintenance, tracking and removal of assets. The application also manages approval processing, tracks purchasing transactions, manages inventory and resources, and tracks costs, accounting and financial transactions.

About Oracle Integration Cloud

Oracle Integration Cloud is a unified platform to integrate the applications, automate processes, and create applications.

Using the Process Builder the business processes can be rapidly designed, automated, and managed in the cloud. Using integrations connect the applications into a continuous business flow. The integrations can be quickly developed and activated between both the applications that live in the cloud; and the applications still live on premises. The lookups help to match application specific codes between the two applications.

Integration Insights and Stream Analytics helps to simplify and extract business metrics and create custom dashboards.


Prerequisites

All participating applications must be installed, set up, and working properly. It is also required to do all the mandatory setup described in the *Oracle Fusion Procurement Cloud Configurations for Oracle Utilities Work and Asset Cloud Service Integration to Oracle Fusion Procurement Cloud Setup Guide* to run this integration.

Supported Business Processes

This integration supports the following key functionalities:

- Supplier and Supplier Site information created and updated in Oracle Fusion Procurement Cloud is sent to Oracle Utilities Work and Asset Cloud Service. This process creates Work and Asset Vendor and Vendor Location.
- Blanket Purchasing Agreements and Contract Purchase Agreements with the Vendor from within Oracle Fusion Procurement Cloud are sent to Oracle Utilities Work and Asset Cloud Service. This process creates Work and Asset Blanket Contracts that can be referenced when creating Purchase Requests in Oracle Utilities Work and Asset Cloud Service.
- Purchase Request created in Oracle Utilities Work and Asset Cloud Service is synchronized with Oracle Fusion Procurement Cloud to further process the request into a Purchase Order.
- Purchase Order created for the Purchase Request within Oracle Fusion
 Procurement Cloud is sent to Oracle Utilities Work and Asset Cloud Service
 using a business event and Oracle Integration Cloud.
- Receipt for Purchase Order created in Oracle Utilities Work and Asset Cloud Service for materials received within Oracle Utilities Work and Asset Cloud Service) is sent to Oracle Fusion Procurement Cloud.
- Returns created in Oracle Utilities Work and Asset Cloud Service as a part of any
 purchase order received is sent to Oracle Fusion Procurement Cloud to match
 the purchase order with the received vs returned in the system.
- Accounts Payable related integration synchronize invoice and invoice payment information from Oracle Fusion Procurement Cloud to Oracle Utilities Work and Asset Cloud Service. Oracle Financial Cloud is the master for invoice and invoice payment in this integration hybrid model.



The following diagrams provide a high-level representation of the integration.


Business Processes

This section describes the business processes included in this integration:

- Vendor/ Vendor Location Process
- Blanket Contract Process

Vendor/ Vendor Location Process

The Vendor/Vendor Location process synchronizes Supplier and Supplier Site information maintained in Oracle Fusion Procurement Cloud to Oracle Utilities Work and Asset Cloud Service.



The following diagram shows the end-to-end synchronization process:

Maintenance of Supplier and Supplier Site

Oracle Fusion Procurement Cloud is the master for Supplier and Supplier Site information.

Supplier and Supplier Site Data Extract

Oracle Fusion Procurement Cloud uses Business Intelligence Cloud Connector (BICC) to extract the supplier and supplier site data for the integration.

Oracle Business Intelligence Cloud Connector extracts the supplier and supplier site business intelligence data from the Fusion Applications Cloud data source, generates a report and store it into an Oracle Storage Service or UCM server. The extract file generated is in csv and zip format.

The integration follows two modes of extraction:

Bulk Sync

Filters control the selection of the Supplier/Supplier Site in the Procurement module. The business may choose to import all records from Oracle Fusion Procurement Cloud or based on an organization (Operating Units).

For bulk sync, it will only extract active suppliers. This is usually the initial sync done at the beginning of implementation.

The FILTER used for Bulk Sync extract are:

- Supplier Status = "Active"
- Supplier should be enabled for either Purchasing or Pay or could be both.
- Organization/Legal Entity site assignment

Incremental Sync

Incremental sync gets the new or modified data since the last extract datetime. It will extract both active and inactive suppliers.

The FILTERS used for Incremental Sync extract are:

• Filter criteria for incremental is similar to bulk except for Supplier Status that now includes both "Active" and "Inactive" suppliers.

Note: Additional columns are added to the extract in case a customized value is used for this integration. Mapping value and Oracle Integration Cloud will need to change to allow the additional value to synchronize with Oracle Utilities Work and Asset Cloud Service.

Vendor and Vendor Location Synchronization

Oracle Integration Cloud gets the extract file from an Oracle Storage Service or UCM server and transforms the data and invoke the Vendor Location Synchronization REST service to create or update the vendor and vendor location information in Oracle Utilities Work and Asset Cloud Service.

Running the Vendor and Vendor Location Sync integration process is a prerequisite before using all the integration flows for Procurement. The vendor details passed into Oracle Utilities Work and Asset Cloud Service are used to raise a purchase request within Oracle Utilities Work and Asset Cloud Service, and the Purchase Order received from Oracle Fusion Procurement Cloud will also create a Purchase Order for the vendor mentioned.

Inactive Vendor and Vendor Location

If the Inactive Date on Supplier or Supplier Site is populated in Oracle Fusion Procurement Cloud, the integration passes an Inactive status to Oracle Utilities Work and Asset Cloud Service. Even if a future inactive date is provided, the vendor and vendor location will be inactive on the date of extraction. This is because BICC incremental extract is not triggered on the date of inactivation but on the date of the update, when the inactive date is populated.

Limitations

• Do not support future inactive date functionality since the BICC extract report does not support future dated incremental reporting of inactive date.

Blanket Contract Process

Blanket Contracts define the purchasing agreement between the customer and the vendors.


Oracle Fusion Procurement Cloud supports Blanket Purchasing Agreements (BPA) and Contract Purchase Agreements (CPA).

 Blanket Purchase Agreements contain the pre-determined pricing and purchasing terms for materials, miscellaneous items, and services listed on Purchase Requisitions and Purchase Orders. These agreements are used when

- the details of the goods and services planned to buy from a supplier in a period of time is known but specific delivery details are unknown.
- Contract Purchase Agreements contain specific terms and conditions without indicating the goods and services to be purchased.

The Blanket Contract Process synchronizes Blanket Purchasing Agreements and Contract Purchase Agreements that are approved, revised, suspended or finally closed in Oracle Fusion Procurement Cloud to Oracle Utilities Work and Asset Cloud. These agreements are synchronized as Blanket Contracts in Oracle Utilities Work and Asset Cloud.

The following diagram shows the end-to-end synchronization process:



Maintenance of Blanket Purchasing Agreement or Contract Purchase Agreement

Oracle Fusion Procurement Cloud is the master for Blanket Purchasing Agreements and Contract Purchase Agreements information.

Once a Blanket Purchasing Agreement or Contract Purchase Agreement is created and approved in Oracle Fusion Procurement Cloud by a buyer, the status changes to "Open".

Blanket Purchasing Agreement or Contract Purchase Agreement Update

Any revision to the agreement in Oracle Fusion Procurement Cloud goes as an update to the existing Blanket Contract in Oracle Utilities Work and Asset Cloud Service.

Blanket and Contract Purchasing Agreement Data Extract

Oracle Fusion Procurement Cloud uses Business Intelligence Report to extract the purchase agreements data for the integration.

Oracle Business Intelligence report extracts the agreement data from a Fusion Applications Cloud data source, generates a report and store it into an Oracle Storage Service or UCM server. The extract file generated is in xml and zip format.

The integration follows two modes of extraction:

• Bulk Sync

Filters control the selection of the purchasing agreements in the Procurement module. The business may choose to import all records from Oracle Fusion Procurement Cloud or based on an organization (Business Unit).

For bulk sync, it will only extract purchasing agreements in 'Open' status. This is usually the initial sync done at the beginning of implementation.

The FILTERS used for Bulk Sync extract are:

- Blanket Contract Status = "Open"
- Organization/Business Unit

Incremental Sync

Incremental sync gets the new or modified data since the last extract datetime.

The FILTERS used for Incremental Sync extract are:

 Filter criteria for incremental is similar to bulk except for blanket contract Status that now includes "Open", "On Hold", "Cancelled" and "Finally Closed" statuses.

Blanket Contract Synchronization


Oracle Integration Cloud gets the extract file from an Oracle Storage Service or UCM server and transforms the data and invoke the Blanket Contract Synchronization REST service to create or update the blanket contract information in Oracle Utilities Work and Asset Cloud Service.

Additional points for this integration process:

- Purchase order lines with different blanket agreement can be clubbed in one Purchase order
- In case the END date of the agreement is missing, end date is picked from the Oracle Integration Cloud configuration. Similarly, limit amount if left blank it is picked from the Oracle Integration Cloud configuration.
- PI ratio is calculated using Unit of Measure on blanket to the Unit of Issue on the Item definition.

Purchase Requisition Integration

The Purchase Requisition process synchronizes approved purchase requisitions in Oracle Utilities Work and Asset Cloud Service to Oracle Fusion Procurement Cloud.



The diagram shows the end-to-end synchronization process:

Creation of Purchase Requisition

Purchase requisitions are created in Oracle Utilities Work and Asset Cloud Service and this application is always the owner of the requisition portal.

Purchase Requisition Synchronization

Only approved purchase requisitions are synchronized from Oracle Utilities Work and Asset Cloud Service to Oracle Fusion Procurement Cloud.

Oracle Integration Cloud receives the purchase requisition information from Oracle Utilities Work and Asset Cloud Service, transforms the data and invoke the Create Purchase Requisition REST service to create the requisition in Oracle Fusion Procurement Cloud. Then, another Oracle Integration Cloud process is called to invoke the Submit Purchase Requisition for Approval REST service to submit the purchase requisition created for approval in Oracle Fusion Procurement Cloud.

The purchase requisition created in Oracle Fusion Procurement Cloud has "Externally Managed Flag" = true to indicate the requisition is coming from an external system.

Based on the purchase requisition's category/buyer, it will be available on the **Process Requisition** page of the buyer.

Purchase Requisition Update

Once the purchase requisition is sent to the external system, no updates to the purchase requisition is allowed in Oracle Utilities Work and Asset Cloud Service.

Blanket Contract Reference

When the referenced blanket contract is:

- A Contract Purchase Agreement (Initiating Blanket Category is "CPA"), the Blanket Contract Header External ID is passed back to Oracle Fusion Procurement Cloud.
- A Blanket Purchase Agreement (Initiating Blanket Category is "BPA"), the Blanket Contract Header and Line External IDs are passed back to Oracle Fusion Procurement Cloud only if the PR Line is linked to a Blanket Contract Line External ID.


Limitations

- Only Expense Type Purchase Requisition is created in Oracle Fusion Procurement Cloud.
- Cancellation of Purchase Requisition is not supported by the integration. This is manually done in both applications.
- Update to Purchase Requisition is not supported by the integration.

Purchase Order Process

Purchase Order Integration is the next step to the procurement process. As purchase requests are received from Oracle Utilities Work and Asset Cloud Service in the above flow, these requests are converted to purchase orders in Oracle Fusion Procurement Cloud to make a seamless integration between Oracle ERP Procurement and Oracle Utilities Work and Asset Cloud Service.

The Purchase Order process synchronizes purchase orders that are approved, updated, canceled or finally closed in Oracle Fusion Procurement Cloud to Oracle Utilities Work and Asset Cloud.



The diagram shows the end-to-end synchronization process:

Creation of Purchase Order

Oracle Fusion Procurement Cloud is the master for Purchase Order information.

Once a Purchase Order is created and approved in Oracle Fusion Procurement Cloud by a buyer, the status changes to "Open".

Purchase Order Synchronization

Once a Purchase Order is in "Open" status in Oracle Fusion Procurement Cloud, it triggers a business event that sends out the approved purchase order to the integration.

Oracle Integration Cloud receives the purchase order information from Oracle Fusion Procurement Cloud, transforms the data and invoke the Purchase Order Synchronization REST service to create or update the purchase order information in Oracle Utilities Work and Asset Cloud Service.

Only purchase orders based on an approved Oracle Utilities Work and Asset Cloud Service purchase requisitions are synchronized over to Oracle Utilities Work and Asset Cloud Service. This means the purchase order's Interface Source Code field must have the value 'WACS'.

Purchase Order Update

Any change order/revision of purchase order goes as an update to the existing purchase order in Oracle Utilities Work and Asset Cloud Service.

When the purchase order is "Canceled" or "Finally Closed" in Oracle Fusion Procurement Cloud, it also triggers an event to the integration and sends an update to the existing purchase order in Oracle Utilities Work and Asset Cloud Service.


Limitations

- Users cannot combine different purchase requisitions to one Purchase Order in Oracle Fusion Procurement Cloud. However, multiple Purchase Orders can be created from one Purchase Requisition.
- Taxes on the purchase order are not synchronized from Oracle Fusion Procurement Cloud to Oracle Utilities Work and Asset Cloud Service.

Receipt Process

The Receipt Process synchronizes all completed receipts created in Oracle Utilities Work and Asset Cloud Service to Oracle Fusion Procurement Cloud as Purchase Order Receipts.

The following diagram shows the end-to-end synchronization process:



Creation of Receipts

Receipts are created in Oracle Utilities Work and Asset Cloud Service since the inventory module is owned by Oracle Utilities Work and Asset Cloud Service. To close the purchase order and further create the invoice and invoice payment, the receipt information needs to be synchronized to Oracle Fusion Procurement Cloud.

In Oracle Utilities Work and Asset Cloud Service, the receipt function is disabled to receive quantity more than ordered for a Purchase Order. Due to tolerance setup on receiving parameters as per business practice in Oracle Fusion Procurement Cloud, the quantity received cannot exceed the Purchase Order quantity on Oracle Utilities Work and Asset Cloud Service.

Receipt Synchronization

Only completed receipts are synchronized from Oracle Utilities Work and Asset Cloud Service to Oracle Fusion Procurement Cloud.

Oracle Integration Cloud receives the receipt information from Oracle Utilities Work and Asset Cloud Service, transforms the data and invoke the Receiving Receipt Request REST service to create the receipt in Oracle Fusion Procurement Cloud.

If Oracle Utilities Work and Asset Cloud Service pass Force Complete field = "Yes", then the corresponding Purchase Order Line will be Closed.

In the current phase of integration, only 3-way match is supported. Hence all Purchase Orders require receipt in Oracle Utilities Work and Asset Cloud Service.

Errors encountered in the integration needs to be fix in Oracle Fusion Procurement Cloud. All the error in the staging interface table needs to be reviewed and manually resolved in the Oracle Fusion Procurement Cloud as Oracle Utilities Work and Asset Cloud Service has already completed the receipt processing.

The implementation user/consultant needs to fetch the error records and correct records manually to reprocess them in Oracle Fusion Procurement Cloud.

Receipt Update

Once the receipt is sent to the external system, no updates to the receipt is allowed in Oracle Utilities Work and Asset Cloud Service.


Limitations

- Only Expense Type Receipt is created in Oracle Fusion Procurement Cloud.
- Update to Receipt is not supported by the integration.
- When all quantities for a Purchase Order Line have been received, the ERP external system will close the Purchase Order Line. If the "Force Complete" flag was also included in the receipt, the ERP external system will error as it tries to close the Purchase Order for receiving all quantities and again for the "Force Complete" flag. The "Force Complete" flag is sent when the checkbox option is selected in the Work and Asset Cloud Service Accept dialog box.

Return Process

The Return Process synchronizes all completed returns on receipt created in Oracle Utilities Work and Asset Cloud Service to Oracle Fusion Procurement Cloud to create return for inventory within Oracle Fusion Procurement Cloud.

Returning received lines is the process of moving the material received in the warehouse back to the supplier, customer, or receiver. There should be a valid receipt to process the returns.



The following diagram shows the end-to-end synchronization process:

Creation of Returns for Receipts

Returns are created in Oracle Utilities Work and Asset Cloud Service since the inventory module is owned by Oracle Utilities Work and Asset Cloud Service.

Returns Synchronization

Only completed returns are synchronized from Oracle Utilities Work and Asset Cloud Service to Oracle Fusion Procurement Cloud.

Oracle Integration Cloud receives the returns information from Oracle Utilities Work and Asset Cloud Service, gets the Parent Transaction Id of the receipt to return from in Oracle Fusion Procurement Cloud, transforms the data and invokes the Receiving Receipt Transaction Request REST service to process the returns in Oracle Fusion Procurement Cloud.

Returns Update

Once the return is sent to the external system, no updates to the return is allowed in Oracle Utilities Work and Asset Cloud Service.


Limitations

• Update to Returns is not supported by the integration.

Account Payable - Invoice Process

For all the purchase orders synchronized to Oracle Utilities Work and Asset Cloud Service, receipts are synchronized back to Oracle Fusion Procurement Cloud to close the purchase order for invoicing. Once the purchase order is closed for invoicing and the invoice is created and validated within Oracle Financial Cloud, these invoices are synchronized to Oracle Utilities Work and Asset Cloud Service.

The following diagram shows the end-to-end synchronization process:



Creation of Invoice

Oracle Fusion Procurement Cloud is the master for the procurement module and is the owner of the Invoice information.

Invoice Validated Synchronization

Once an Invoice is validated in Oracle Fusion Procurement Cloud by a buyer, the invoice status changes to "Validated" and triggers a business event that sends out the validated invoice to the integration.

For more information on when Oracle Payments Cloud business events - Invoice Validated is initiated, refer to the *Oracle Financials Cloud - Implementing Payables Invoice to Pay* documentation at https://docs.oracle.com/en/cloud/saas/financials/21d/faipp/index.html.

Only invoices from a purchase order based on an Oracle Utilities Work and Asset Cloud Service purchase requisitions are synchronized over to Oracle Utilities Work and Asset Cloud Service.

Invoices are filtered based on a descriptive flexfield used to differentiate invoice created for Oracle Utilities Work and Asset Cloud Service. Invoice Distribution DFF is created to store value that is used as a filter when subscribing invoice out of the business event.

Invoice Update

Only a limited number of fields can be updated from Invoice in Oracle Fusion Procurement Cloud. Any update that is validated triggers a business event that sends out the updated invoice to the integration.

Integration sends the whole invoice information to Oracle Utilities Work and Asset Cloud Service and this can cause an error in Oracle Utilities Work and Asset Cloud Service since Oracle Utilities Work and Asset Cloud Service only allow invoice header information updates and new invoice lines added to an invoice. It does not allow updates to existing invoice lines.

Invoice Canceled

- When a validated invoice is canceled in Oracle Fusion Procurement Cloud, the
 invoice status changes to "Canceled" and triggers a business event that sends out
 the canceled invoice to the integration.
 - For more information on when Oracle Payments Cloud business events Invoice Canceled is initiated, refer to the ERP documentation.
 - The Integration sends an email out to a Oracle Utilities Work and Asset Cloud Service User to reverse the invoice created in "Posted" status in Oracle Utilities Work and Asset Cloud Service. This is a manual step that a user has to do in Oracle Utilities Work and Asset Cloud Service.
- When an invoice is created and canceled, without validation, in Oracle Fusion
 Procurement Cloud, it triggers both the Invoice Validated and Invoice Canceled
 business events and send out the canceled invoice information to the integration.

The integration will disregard the message received in the Invoice Validated OIC Process and not send the canceled invoice information to Oracle Utilities Work and Asset Cloud Service. But, it will still process the message received in the Invoice Canceled OIC Process and sends an email out to a Oracle Utilities Work and Asset Cloud Service User to reverse the invoice created in Oracle Utilities Work and Asset Cloud Service. In this case, the Oracle Utilities Work and Asset Cloud Service user should just ignore this email.

Invoice Lines

Oracle Fusion Procurement Cloud can pass the following invoice lines: Item, Freight, Miscellaneous and Taxes.

- When passing an Item invoice line, it should always reference a Purchase Order (PO) Number/PO Line Number combination or else it will error in Oracle Utilities Work and Asset Cloud Service.
- When passing Freight or Miscellaneous invoice lines, reference to a Purchase Order Line can be optional.

 When passing the Tax invoice lines, integration is passing the detailed transaction tax lines to Oracle Utilities Work and Asset Cloud Service. The tax line can reference a PO Number/PO Line Number combination.


Limitation

Invoice Cancellation in Oracle Utilities Work and Asset Cloud Service should be done manually.

Account Payable - Invoice Payment Process

When an invoice payment is created or voided in Oracle Financial Cloud, the invoice payment details are synchronized to Oracle Utilities Work and Asset Cloud Service.

The following diagram shows the end-to-end synchronization process:



Invoice Payment/Voided Synchronization

Once an Invoice payment is created or voided in Oracle Fusion Procurement Cloud, this triggers the payables payment created or payables payment voided business event that sends out the invoice payment or voided information to the integration.

For more information on when Oracle Payments Cloud business events - Payables Payment Created or Payables Payment Voided are initiated, refer to the **Enable the Payments Business Events Profile Option** section in the *Oracle Financials Cloud - Implementing Payables Invoice to Pay* documentation at https://docs.oracle.com/en/cloud/saas/financials/21d/faipp/index.html.

Only invoice payments or voided related to an invoice base on an Oracle Utilities Work and Asset Cloud Service purchase requisitions are synchronized over to Oracle Utilities Work and Asset Cloud Service.

Invoice Payment Details

Once an invoice payment is created, whether full payment or partial payment, the payment date, payment number, payment type and payment amount are synchronized to Oracle Utilities Work and Asset Cloud Service. In Oracle Utilities Work and Asset Cloud Service, this stores the payment information as part of the invoice header.

When partial payments are synchronized to Oracle Utilities Work and Asset Cloud Service, Oracle Utilities Work and Asset Cloud Service only stores the latest payment information. To see the complete history of the payments, navigate to the purchase order in Oracle Fusion Procurement Cloud.

Invoice Discounts

When a discount is applied during an invoice payment, the discount amount is passed to Oracle Utilities Work and Asset Cloud Service as part of the Invoice Payment Process. Aside from updating the invoice header with the payment information, this will also create a new discount invoice line with the discount amount in Oracle Utilities Work and Asset Cloud Service.

Voided Invoice Payment

When an invoice payment is voided, the payment amount and discount amount, if any, are reversed.

Solution Overview

The technical aspects involved in the integration between Oracle Fusion Procurement Cloud and Oracle Utilities Work and Asset Cloud Service are:

- The integration layer consists of integration processes deployed on Oracle Integration Cloud.
- The integration processes interact with other applications using the following adapters:
 - Oracle ERP Cloud Adapter to subscribe to business events raised by various modules in Oracle ERP Cloud. This integration subscribes to the Purchase Order and Invoice Events.
 - It also invokes the Business (REST) Resource for procurement service application to create, update or query the purchase requisition and receive the receipt request and returns.
 - SOAP Adapter to interact with Oracle UCM Generic Web Service to search, get and rename files in Oracle UCM.
 - Oracle Utilities Adapter interacts with the WACS REST APIs.
- The integration pattern used for the solution is:
 - One-way asynchronous for all flows.
- Email notification is optional in most cases. Configure the property name email.flag in the OUTL-BRT-WACS_FPRC_ConfigProps lookup to 'true' to receive email notification when errors are encountered. By default, this is set to 'true'.
- The recipient(s) of the email notification is configured in the OUTL-BRT-WACS_FPRC_Email_ID lookup.

The Vendor Location Bulk or Incremental BICC report should be run first to create the vendor and vendor location sync extract file in UCM. The file is needed before running this integration process.

- Bulk synchronization is done as a first step to synchronize all the active vendor and vendor locations.
- Any updates to the vendor or vendor location, including changing the status from active to inactive and vice versa, are extracted by the Vendor Location Incremental Sync BICC report periodically.

Note: Define the integration schedule for this process and make sure it coordinates with the BICC report generation in Oracle Fusion Procurement Cloud.

Blanket Contract Synchronization Process (Oracle Fusion Procurement Cloud Initiated)

This integration process synchronizes the purchase agreement information from Oracle Fusion Procurement Cloud to Oracle Utilities Work and Asset Cloud Service as blanket contract information for both Bulk sync and Incremental sync.

Two types of purchase agreements are synced from Oracle Fusion Procurement Cloud: Blanket Purchase Agreements and Contract Purchase Agreements.


The Blanket Contract Bulk or Incremental BIP report should be run first to create the Blanket Contract sync extract file in a UCM. The file is need before running this integration process.

• Bulk synchronization is done as a first step to synchronize all the purchase agreements whose status is "Open".

 Any updates to the purchase agreements, including changing the status at the header and line level, are extracted by the Blanket Contract Incremental BIP report periodically.

Note: Define the integration schedule for this process and make sure it coordinates with the BIP report generation in Oracle Fusion Procurement Cloud.

 - Each "Row" element under the ResultSet has all file information for the matched blanket contract file. Iterate over each "Row" field to process each blanket contract file.
- 5. For each Blanket Contract file, invoke the UCM Generic SOAP service to get the file from UCM as a MTOM attachment in the response.
- 6. Use Stage File operation "Unzip file" to unzip the file. The file is unzipped in a temporary directory named with string "TempUnzippedFiles concatenated with docId".

- 7. Use Stage File operation "ReadFileinSegments" to read the file in segments of 200 records. After all the 200 records are processed, the next segment of the records is read.
- 8. For each Blanket Contract record in the segment, do the following:

Determine PIRatio

- If Blanket Contract lines exists in the Blanket Contract record, iterate over each of the Blanket Contract line. For each line, check:
 - If the line is a Stock Item and the Blanket Contract UOM is the same as the Stock Item Unit of Issue then assign "1" as the PIRatio for that line. Add it to the UOMConversionCollection.
 - If the line is a Stock Item and the Blanket Contract UOM is different from the Stock Item Unit of Issue, invoke UnitOfMeasureConversions REST API from FPRC to get the UOM Conversion for Blanket Contract UOM to Stock Item Unit of Issue. This will be the PIRatio for that line. Add it to the UOM Conversion Collection.
 - If the line is not a Stock Item, PIRatio is passed empty.

Note: In Stock Item, if the Unit of Issue is blank, it used the Primary UOM value as the Unit of Issue.

- Use Stage File Operations to convert the UOM Conversion Collection into XML format with record for PIRatio for each Blanket Contract Stock Item line.
- Transform the payload from the XML extract file to the Oracle Utilities Work and Asset Cloud Service payload passing the PIRatio for the matched Item from the XML transformed UOM Conversion collection.
 - The field mapping details for Blanket Contract Integration are available in the Oracle Utilities Work and Asset Cloud Service Integration to Oracle Fusion Procurement Cloud Data Mapping Guide included in this release.
- Invoke the Oracle Utilities Work and Asset Cloud Service Blanket Contract Sync REST API to pass the Blanket contract information to Oracle Utilities Work and Asset Cloud Service.

Refer to the Error Handling section in Configuring Lookups, Error Handling, and Email Notifications for information on error scenarios and retry options.

- 9. When all Blanket Contract records in the file are processed, invoke the UCM Generic SOAP service to rename the file.
 - If no record is in error, prefix the filename with 'PROCESSED-'.
 - Else, prefix the filename with 'ERROR-'.
- 10. The next unprocessed blanket contract file is picked up from UCM and the processing continues.
- 11. After all files are processed, a process completed email notification is sent.

This integration process deployed on Oracle Integration Cloud is exposed as a REST endpoint. It does the following activities:

- This process is triggered when Oracle Utilities Work and Asset Cloud Service invokes the REST endpoint to send an approved purchase requisition to Oracle Fusion Procurement Cloud.
- 2. Transforms the Purchase Requisition information received from Oracle Utilities Work and Asset Cloud Service into the Oracle Fusion Procurement Cloud format.
- 3. Invokes the Create Purchase Requisition REST endpoint using ERP Cloud Adapter.
- 4. If the REST service returns:
 - Status 200 (OK), invokes Purchase Requisition Approve OIC REST endpoint.
 - Error Status, such as 400 or 500, throws a fault back to Oracle Utilities Work and Asset Cloud Service and send an email notification with the error details to the users configured in the OUTL-BRT-WACS_FPRC_Email_ID lookup.

To retry, resend the purchase requisition from Oracle Utilities Work and Asset Cloud Service by rerunning the F1-SYNRQ batch.





Purchase Order Synchronization Process (Oracle Fusion Procurement Cloud Initiated)

Processing Details

This integration process deployed on Oracle Integration Cloud does the following activities:

1. Subscribes to Purchase Order Event. Oracle Fusion Procurement Cloud publishes an event with a purchase order payload when a purchase order is approved, changed, canceled or finally closed in the application. The integration process only accepts purchase order whose Interface Source Code = 'WACS'.

Note: The filtering criteria for Interface Source Code is hardcoded to 'WACS'. This value is passed to Oracle Fusion Procurement Cloud during Purchase Requisition Sync to indicate the purchase requisition came from Oracle Utilities Work and Asset Cloud Service. If a Purchase Order is associated with an Oracle Fusion Procurement Cloud Contract Purchase Agreements, this relationship will not be visible on the synchronized Purchase Order within Oracle Utilities Work and Asset Cloud Service. There is no element on the Purchase Order to indicate it was created against a Contract Purchase Agreement.

- 2. Transforms the Purchase Order payload from Oracle Fusion Procurement Cloud to Oracle Utilities Work and Asset Cloud Service format.
- 3. Invokes the Oracle Utilities Work and Asset Cloud Service REST endpoint for Purchase Order Sync to pass the Purchase Order information to Oracle Utilities Work and Asset Cloud Service.
- 4. Error Handling for this process.

If any error occurs in the integration process, an optional email notification is sent with error details to the users configured in the OUTL-BRT-WACS_FPRC_Email_ID lookup.

Retry Option: Re-run from Oracle Integration Cloud

Note: When the Purchase Order Sync Request record is successfully created in Oracle Utilities Work and Asset Cloud Service, it means the integration process ended successfully. If the fix is in Oracle Fusion Procurement Cloud or in the integration DVM, the Purchase Order has to be updated from Oracle Fusion Procurement Cloud to trigger a Purchase Order event.

Processing Details

This is an application driven orchestration process deployed on Oracle Integration Cloud. The Oracle Integration Cloud flow is exposed as a REST service for Oracle Utilities Work and Asset Cloud Service to invoke when sending the completed receipts. This is a synchronous flow which returns a response. But, the response is not used by Oracle Utilities Work and Asset Cloud Service in any way.

The process handles the following:

- 1. Oracle Utilities Adapter is used as a Rest trigger to receive the Receipts message from Oracle Utilities Work and Asset Cloud Service.
- 2. The payload from Oracle Utilities Work and Asset Cloud Service is transformed into the FPRC ReceivingReceiptRequests Rest API payload format.

 - b. Invoke FPRC ProcessingErrors Rest API through Oracle ERP Cloud Adapter.
 - c. "HeaderInterfaceId" and "InterfaceTransactionId" are passed as parameters, by mapping to Template Parameter 0 and 1 respectively.
 - d. The response contains error information. Concatenate the information under "InterfaceErrorId", "InterfaceHeaderId", "InterfaceLineId", "BatchId", "ErrorMessage", "ErrorMessageName", "ErrorType", "ColumnName", "TableName" elements into an Error collection.
 - e. Send an email with the error information.
 - f. Invoke a fault Return action with error code as 400. The outbound message sent by Oracle Utilities Work and Asset Cloud Service is rolled back and can be resent from Oracle Utilities Work and Asset Cloud Service.
- If the ReturnStatus element in the response is not "ERROR" or if the ProcessingStatusCode element is 'ERROR', iterate through Oracle Utilities Work and Asset Cloud Service response 'lines'.

Execute the following steps for each line.

- a. If ReturnStatus is ERROR and ProcessingStatus is not ERROR, it would mean that the partial receipt was created. As as a first step, collect the error on the errored lines. Execute steps b through f.
- b. Iterate through Lines from Oracle Utilities Work and Asset Cloud Service Receipt payload.
- c. Get the HeaderInterfaceId and InterfaceTransactionId of last errored line in the "lines" list.
- d. Invoke FPRC ProcessingErrors Rest API through Oracle ERP Cloud Adapter.



The process is executed as follows:

- 1. The trigger is a Rest Trigger using Oracle Utilities Adapter to receive the Returns message from Oracle Utilities Work and Asset Cloud Service.
- 2. Invoke FPRC LinesToReturn Rest API through Oracle ERP Cloud Adapter, passing the Organization Code, Source Document Code, PO Line ID, PO Header ID and Document Number as query parameters to 'findLines'.
- 3. The response contains all receipt transactions matching the query parameters.
- 4. Iterate over all the receipt transaction items to add the quantity to the total Available Quantity.
- 5. If the totalAvailableQuantity is less than the quantity required to return, a fault return is invoked to return a fault to Oracle Utilities Work and Asset Cloud Service with a 400 status and the outbound message is rolled back.

- 6. If the totalAvailableQuantity is greater than or equal to the return quantity, iterate over each of the receipt transaction items.
- 7. For each receipt transaction item, transform the payload to FPRC ReceivingReceiptTransactionRequests Rest API format.
- 8. Invoke ReceivingReceiptTransactionRequests Rest API through Oracle ERP Cloud Adapter.
- The quantity is returned from each receipt transaction until the processed quantity is greater than or equal to the return quantity specified in the Oracle Utilities Work and Asset Cloud Service payload.
- 10. If the "Return Status" in the response of any of the return transactions is 'ERROR', the corresponding processing Errors of Receiving Receipt Transaction Requests Rest API is invoked through Oracle ERP Cloud Adapter to get the processing errors.

This integration process deployed on Oracle Integration Cloud performs the following activities:

- 1. Subscribes to the Payables Invoice Validated Event. Oracle Fusion Procurement Cloud publishes an event with a subset of invoice information in the payload when an invoice is validated in the application.
- Only standard, credit memo and debit memo invoices created from a related Oracle Utilities Work and Asset Cloud Service Purchase Requisition will be processed by the integration. This means the Purchase Order is based on a requisition coming from Oracle Utilities Work and Asset Cloud Service.

Note: Interface Source Code with value 'WACS' is passed to Oracle Fusion Procurement Cloud during Purchase Requisition Sync to indicate the purchase requisition came from Oracle Utilities Work and Asset Cloud Service. This name value pair is passed on to PO then to Invoice.

3. Do an enrichment call by invoking the Get an Invoice REST API to get the other invoice information not provided by the business event message.

- 4. Check if the invoice to be synchronized is related to a Oracle Utilities Work and Asset Cloud Service Purchase Requisition.
 - If yes, proceed to the next step.
 - Else, stop the process. The invoice is not synchronized with Oracle Utilities Work and Asset Cloud Service.
- 5. Transforms the Invoice payload from Oracle Fusion Procurement Cloud to Oracle Utilities Work and Asset Cloud Service format.
 - In this transformation, it is only passing the item, freight and miscellaneous invoice lines.
 - The summarize invoice tax lines are not passed to Oracle Utilities Work and Asset Cloud Service.



- 3. For each invoice related to the payment, do the following:
 - Invoking the Get an Invoice REST API to get the invoice information.
 - Check if the invoice is related to a Oracle Utilities Work and Asset Cloud Service Purchase Requisition.

- If yes, proceed to the next step.
- Else, go to the next related invoice, if any.

Note: Only voided payments created for invoices related to Oracle Utilities Work and Asset Cloud Service Purchase Requisition will be processed by the integration. This means the Purchase Order is based on a requisition coming from Oracle Utilities Work and Asset Cloud Service. - Transforms the voided invoice payment information from Oracle Fusion Procurement Cloud to the Oracle Utilities Work and Asset Cloud Service format.
- Invoke the Oracle Utilities Work and Asset Cloud Service REST endpoint for Invoice Sync to pass the invoice payment information to Oracle Utilities Work and Asset Cloud Service.
- 4. Error Handling for this process is taken care.

If an error occurs in the integration process, an optional email notification is sent (with error details) to the user(s) configured in the OUTL-BRT-WACS_FPRC_Email_ID lookup.

Retry Option: Re-run from Oracle Integration Cloud

Note: When the Invoice Sync Request record is successfully created in Oracle Utilities Work and Asset Cloud Service, it means that the integration process ended successfully. Running the Oracle Utilities Work and Asset Cloud Service batch process W1-SIOPE processes the sync request records and creates/updates the invoice records, or it might encounter a business validation error. If an error occurs, the Sync Request Record transitions to error and a To Do is created in Oracle Utilities Work and Asset Cloud Service.

This chapter provides details about the configuration settings needed in Oracle Utilities Work and Asset Cloud Service for this integration. It includes the following sections:

One-Time Configuration Setup

Certain one-time configuration settings must be coordinated manually to make sure proper flow of data between the two applications.

Configuring Admin Data

This section describes the admin data setup in Oracle Utilities Work and Asset Cloud Service related to the integration. The **Admin** menus can be configured to be grouped alphabetically or by functional groups. The descriptions that follow will include both groupings.

- Message Senders
- External System
- Inbound Web Service (IWS)
- Master Configuration
- Business Object
- ERP Integration
- Buyer
- Stock Item

Message Senders

Create a new or update an existing real-time message sender for each Oracle Utilities Work and Asset Management Outbound Message.

To create a message sender:

- 1. In the Admin menu navigate to [M or Integration] > Message Sender > Add.
- 2. Enter a unique message sender and its description.
- 3. Populate the following values:
 - Message Sender: Sender name in Oracle Utilities Work and Asset Management
 - **Description**: Sender's description
 - Invocation Type: Real-time
 - Message Class: RTJSONSNDR (Sender for real-time HTTP / JSON messages)
 - **Active**: Select the check box
 - MSG Encoding: UTF-8 message encoding
- 4. Select the **Context** tab and set values for the following context types:
 - HTTP Header: application/json
 - HTTP Login User: User ID to access OIC
 - HTTP Login Password: Password to access OIC
 - HTTP Method (POST/GET): POST

- HTTP Timeout: 300
- **HTTP Transport Method**: SendReceive
- **HTTP URL 1**: Set the URL to the OIC REST service endpoint. If the URL value is too long, use the additional HTTP URL types to set the complete URL.

External System

Create a new or update an existing external system to support the Enterprise Resource Planning Cloud.

To create an external system:

- In the Admin menu navigate to [M or Integration] > External System > Add.
- 2. Enter a unique External System and its Description.
- 3. Associate the outbound message types created to the external system. For each outbound message type, set the following:
 - Outbound Message Type
 - Purchase Request: Use the W1-PREQIMSG (Purchase Request Outbound) outbound message type
 - Receipt: Use the W1-RCPTOUTMS (Receipt Outbound) outbound message type
 - **Return Line**: Use the W1-RTNOUTMS (Return Line Outbound) outbound message type
 - Processing Method: Real-time
 - Message Sender: Set the corresponding message sender for the outbound message
 - Date/Time Format: XSD
 - **JSON Conversion Method**: Base JSON conversion

Inbound Web Service (IWS)

The following REST inbound web services are delivered for this integration:

- W1-PurchaseOrderSynchronization
- W1-VendorLocationSynchronization
- W1-InvoiceSynchronization
- W1-BlanketContractSynchronization

The full URI component for the REST inbound web service is configurable.

Seeder Sync Request Master Configuration

The Seeder Sync master configuration identifies the ongoing sync request business object and key reference view for the maintenance object specified in the synchronization request.

This is used by the Vendor Location and Purchase Order sync integration.

To create a Seeder Sync Request master configuration:

- Create a row for the Oracle Enterprise Resource Planning External System and Cost Center Maintenance Object (MO): W1- COSTCTR for Cost Center Sync Integration.
 - Define the Ongoing Sync Request Business Object that will process the integration record and the Ongoing Sync Key Reference View and Identifier Type to find existing integration records.
- 2. Create a row for the Oracle Enterprise Resource Planning External System and Employee Maintenance Object (MO): W1-EMP for Employee Sync Integration.
 - Define the Ongoing Sync Request Business Object that will process the integration record and the Ongoing Sync Key Reference View and Identifier Type to find existing integration records.
- Create a row for the Oracle Enterprise Resource Planning External System and Resource Type Maintenance Object (MO): W1- RESRCTYPE for Stock Item Sync Integration.
 - Define the Ongoing Sync Request Business Object that will process the integration record and the Ongoing Sync Key Reference View and Identifier Type to find existing integration records.
- Create a row for the Oracle Enterprise Resource Planning External System and Vendor Location Maintenance Object (MO): W1-VENDORLOC for Vendor Location Sync Integration.

 Cost Center segment and another the Expense Code segment defined. The
 "Include in Cost Center" flag defines the segments that make up the Cost Center
 string. The Delimiter will define the separation character sent in the REST Web
 Service request.

Purchasing Master Configuration

The parameters set in this Master Configuration are used in the Receiving and Invoice process.

- 1. To allow users to receive purchase orders created for services, set the **Require Receipt for Services** parameter to **Yes**.
- 2. In the **Invoicing Parameters** section:
 - a. Set the values for Discount Cost Allocation, Freight Cost Allocation and Extra Cost Allocation and Taxes Cost Allocation.
 - a. Set the values to **Line** to prorate the financial transactions across all normal and credit memo invoice line items. In addition, the cost center from the line item incurs the cost instead of the default cost centers indicated this master configuration.

- b. Set the values to **General** so that the financial transaction is written against the header and the default cost centers from this master configuration are used.
- b. Set the cost center and expense codes for the Discount, Freight, Extra Cost, Taxes and Invoice Write-Off.

Inventory Master Configuration

In the **Receiving Parameters** section, set the following:

- Add Tax to Cost of Inventory: This indicates whether taxes are to be included as part of the cost of inventory.
- Receive More Than Ordered Allowed parameter to 'No'

Financial Master Configuration

The parameters set in this Master Configuration are used in the Receiving and Invoice process.

In the **Financial Transaction Parameters** section, set the cost center and expense code for Received Awaiting Invoice and Payables.

Set the distribution codes in the **Distribution Codes** section.

Business Object

SOA-based ERP integrations required positive/negative acknowledgment messages to be returned to the ERP system. These are not needed for the Oracle Application Cloud - Fusion Procurement integrations.

Vendor Location Ongoing Sync Request BO (W1-OngoingSyncRequestVendorLoc)

Make the following lifecycle algorithms inactive:

- Synchronized (SYNCHRONIZED) Status: Create Positive Acknowledgment for ERP (W1-CPOSAERP)
- Negative Acknowledgment Sent (NEG-ACK-SENT) Status: Create Negative Acknowledgment (W1-CRENEGACK)

To make the algorithms inactive, add an option within the **Status** with an **Inactive Algorithm Option Type** and the name of the algorithm within the **Value** field.

Purchase Order Inbound Integration BO (W1-PurchaseOrderIntegInbound)

Make the following lifecycle algorithms inactive:

- Complete (COMPLETE) Status: Send Positive Acknowledgment (W1-SNDPOSACK)
- Complete with Error (COMPLETE-ER) Status: Send Positive Acknowledgment (W1- SNDPOSACK)

Error (ERROR) Status: Send Negative Acknowledgment (W1- SNDNEGACK)

To make the algorithm inactive, add an option within the **Status** with an **Inactive Algorithm Option Type** and the name of the algorithm within the **Value** field.

Invoice Inbound Integration BO (W1- InvoiceIntegInbound)

Make the following lifecycle algorithms inactive:

- Complete (COMPLETE) Status: Send Positive Acknowledgment (W1-SNDPOSACK)

Asynchronous/Synchronous Flow Error Handling

Technical Fault

This fault occurs when there is a data mismatch or any Xpath related error.

Remote Fault

This fault occurs when the target system is down or not accessible.

Business Fault

These faults are application-specific faults that occur when there is a problem with the information being processed in the target application due to invalid data or business error validations.

Vendor/Vendor Location Sync and Blanket Contracts Sync: For processing records in a file

When Oracle Utilities Work and Asset Cloud Service returns HTTP status codes 400 or 500, these are considered business faults by the integration. When these errors occur, the flow will not stop but continue to process the next record and the errors will be stored in a temporary error collection. Optional emails are sent when error count reaches the value specified for maxerrorcount.per.email.notification, email with error details is sent.

When the file completes processing, an optional email is sent with the list of remaining errors to the respective user.

- 2. Drag the slider for that integration. When prompted to enable tracing, click **Yes** to view the instances.
- 3. Click Activate.

The integration takes time to get activated. The activated integration appears at the top of the integrations list.

- 1. Login to Oracle Integration Cloud.
- 2. On the **Home** page, click **Monitoring**.
- 3. Select any of the following as required:
 - Dashboards To monitor the complete dashboard of integration.
 - Integrations To monitor each integration.
 - Tracking To monitor instance and flow trace/activity stream of the integration.
 - **Error** To monitor the integrations in 'error' state. Re-submit the asynchronous integration flows.

To monitor the integration flows using Oracle Integration Cloud logs:

- 1. Login to Oracle Integration Cloud.
- On the Home page, click Monitoring.
- 3. On the navigation pane, click **Dashboards** to view the overall success/failure rate of the integration.
- 4. Navigate to the **Logs** menu.
- 5. In the right pane, click the link to show options for downloading the Oracle Integration Cloud logs or diagnostics logs.
- 6. In case of any issues, attach the diagnostic logs to a service request for help.

Troubleshooting

If an activation fails, the Integrations page displays an error message.

To troubleshoot the activation error:

1. Click **Download Diagnostic Logs** to download the logs for diagnosing the issue.

2. Select **Enable Tracing**.

TRACE ENABLED is displayed next to ACTIVE.

Some of the sample cases are as follows:

• For any connectivity errors while activating the integration, make sure the trigger connection is successful. Test the connection, refresh the metadata and activate the integration.
