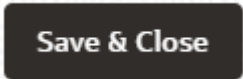

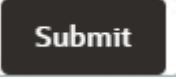

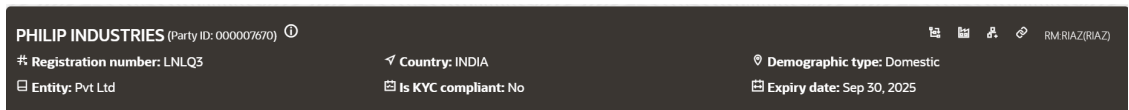

Figure 3-1 Customer Information




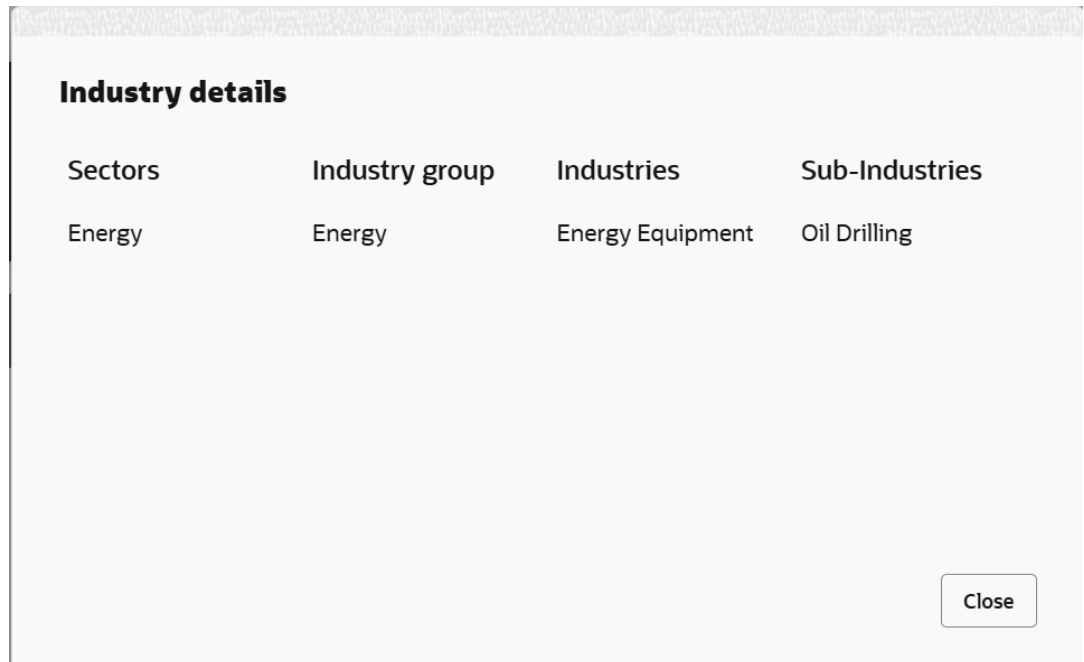
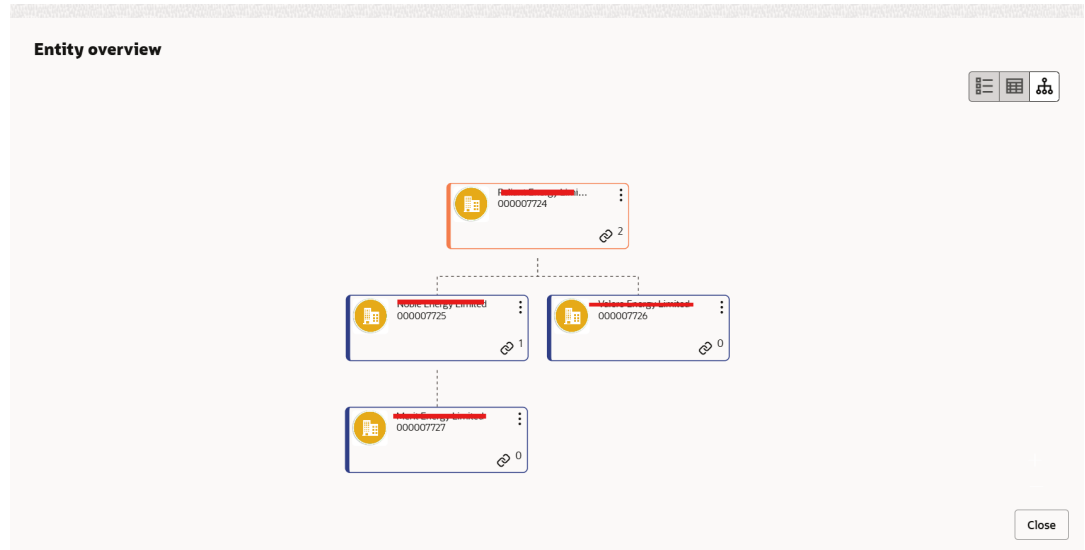

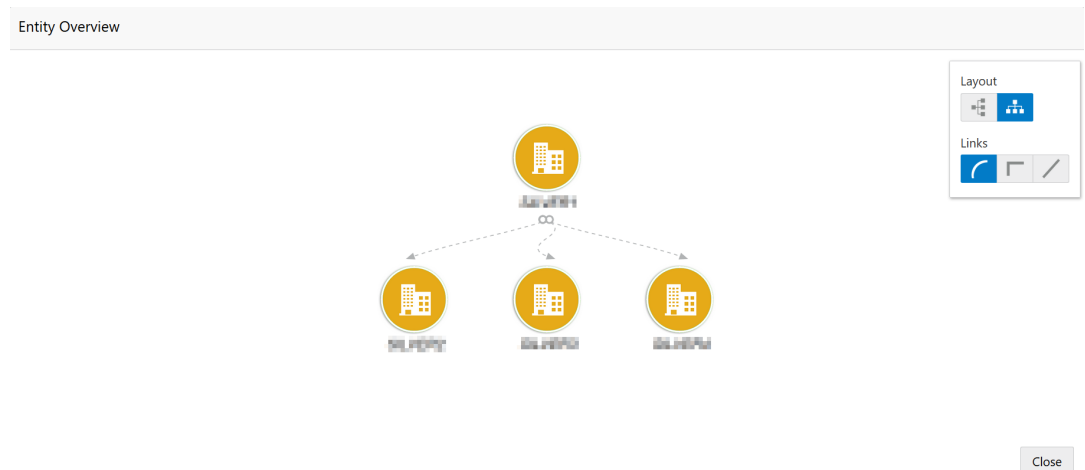
Figure 3-2 Industry Details

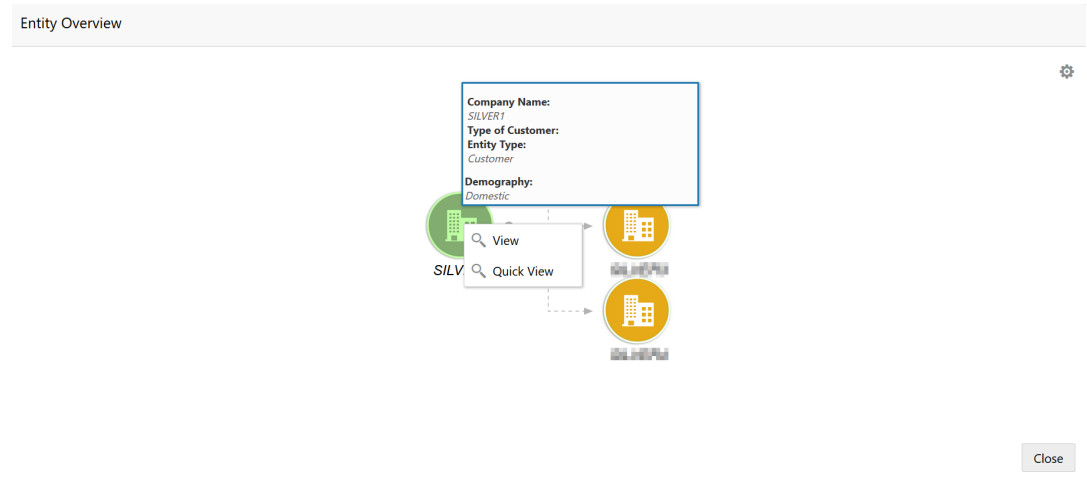
Figure 3-3 Entity Overview

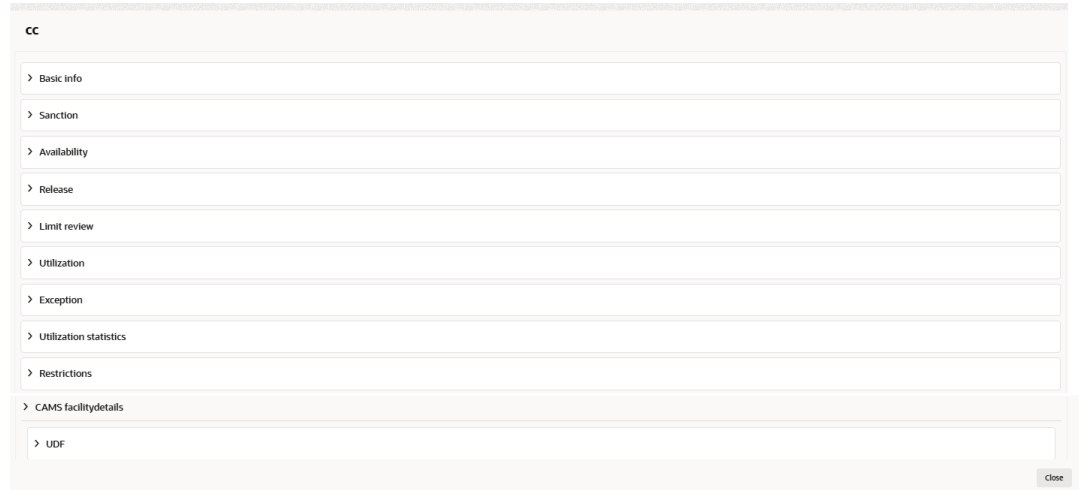


Figure 3-10 Liability Details

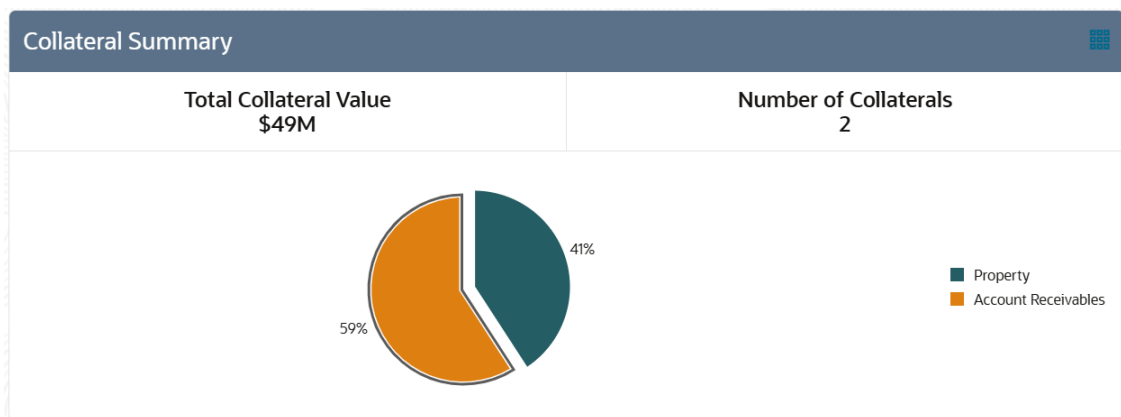

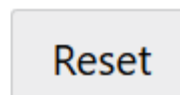

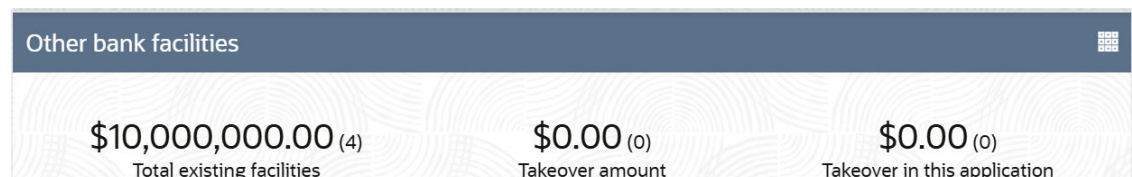

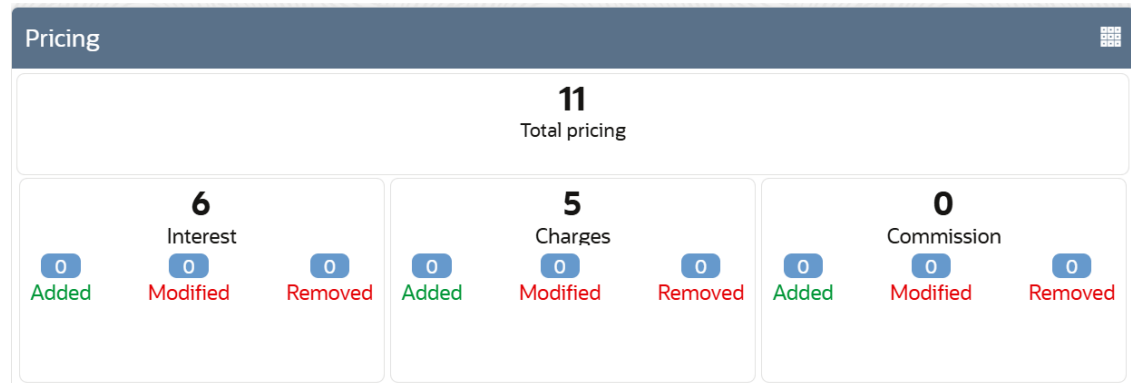

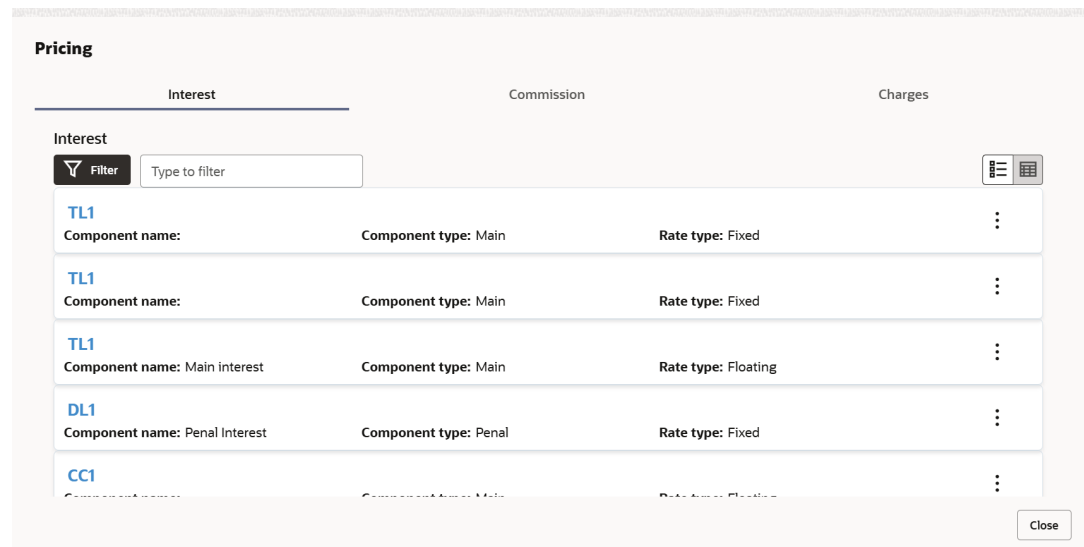

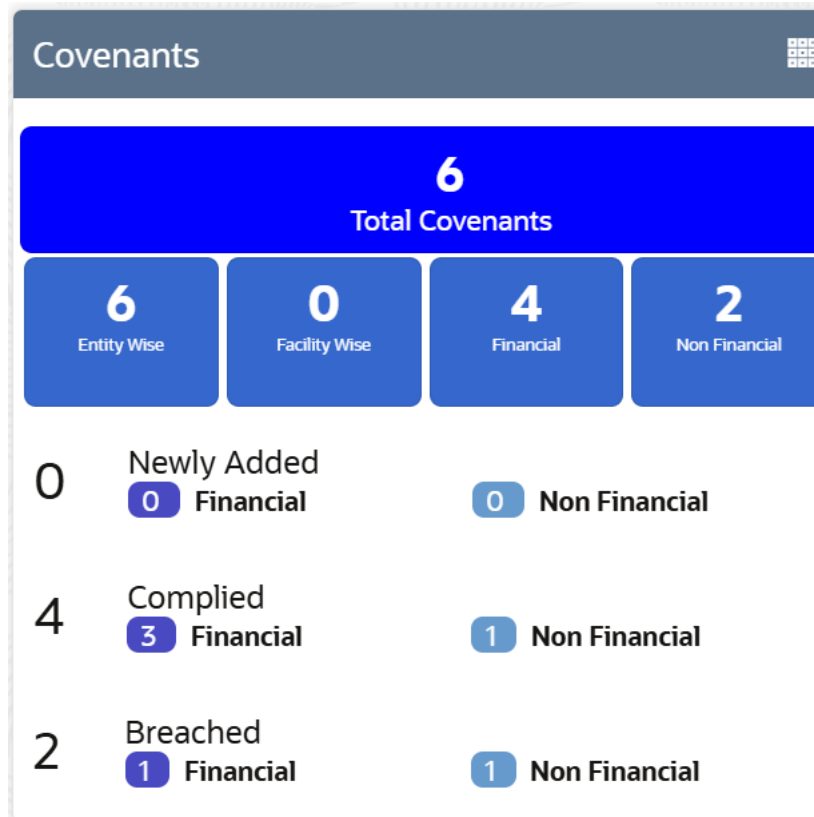

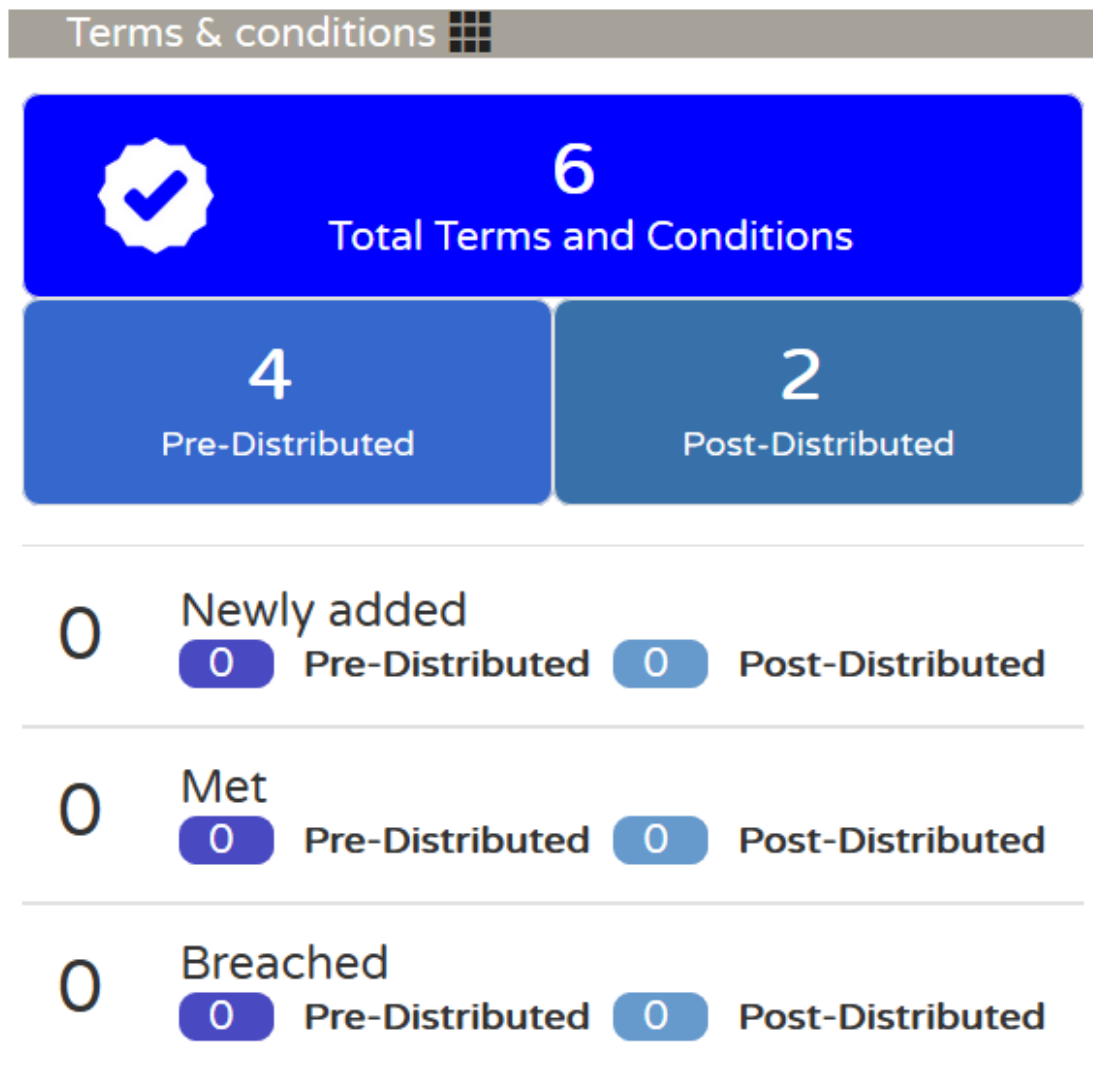

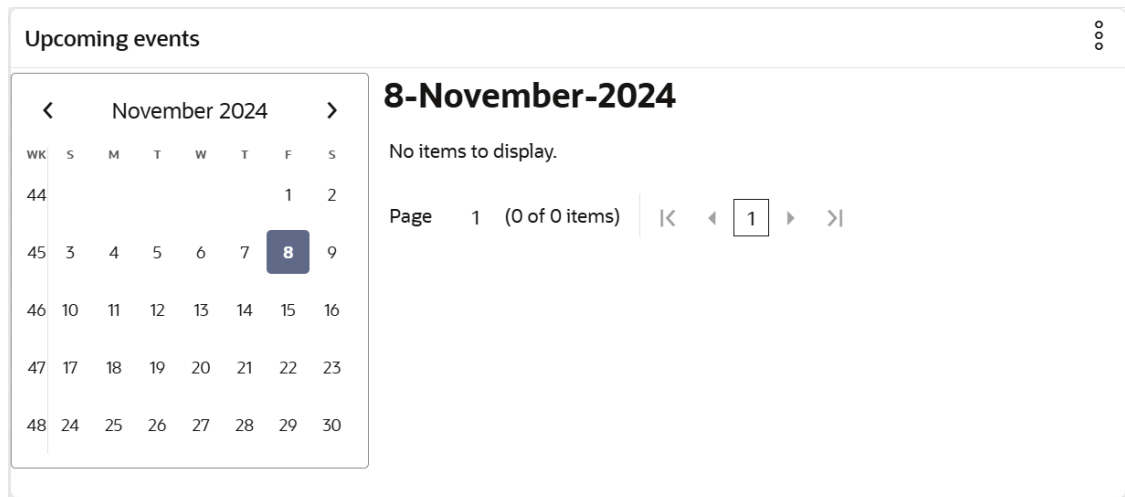

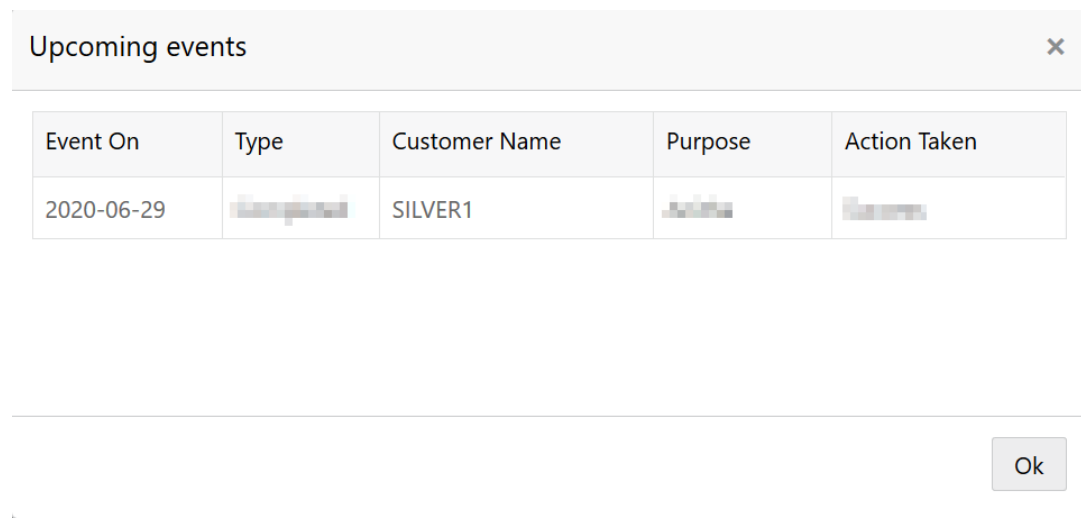

Figure 3-32 Upcoming Events - View All



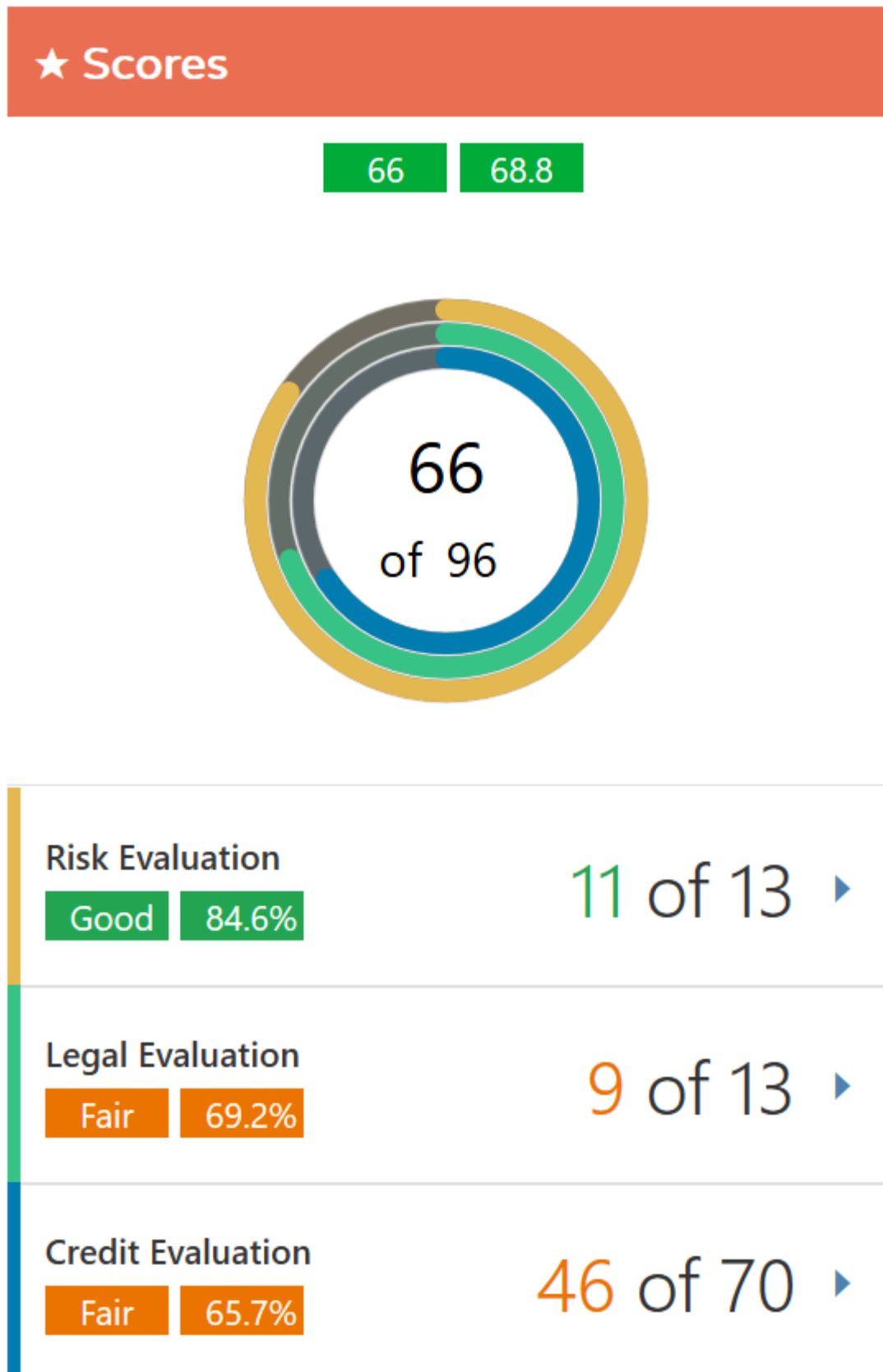

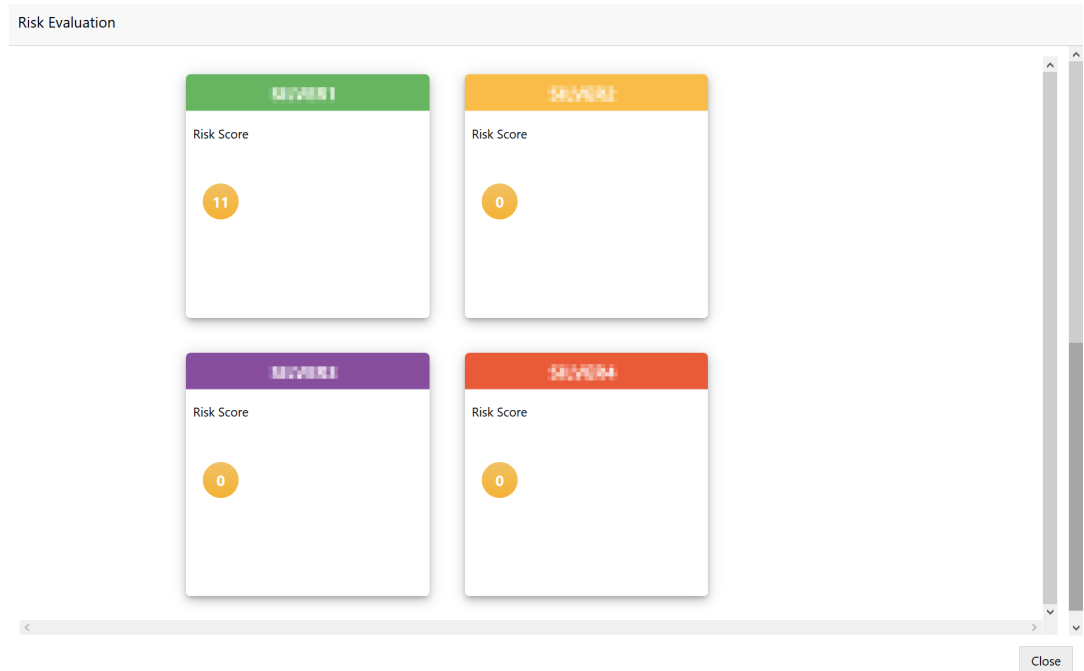
Figure 3-33 Scores

Figure 3-34 Risk Evaluation



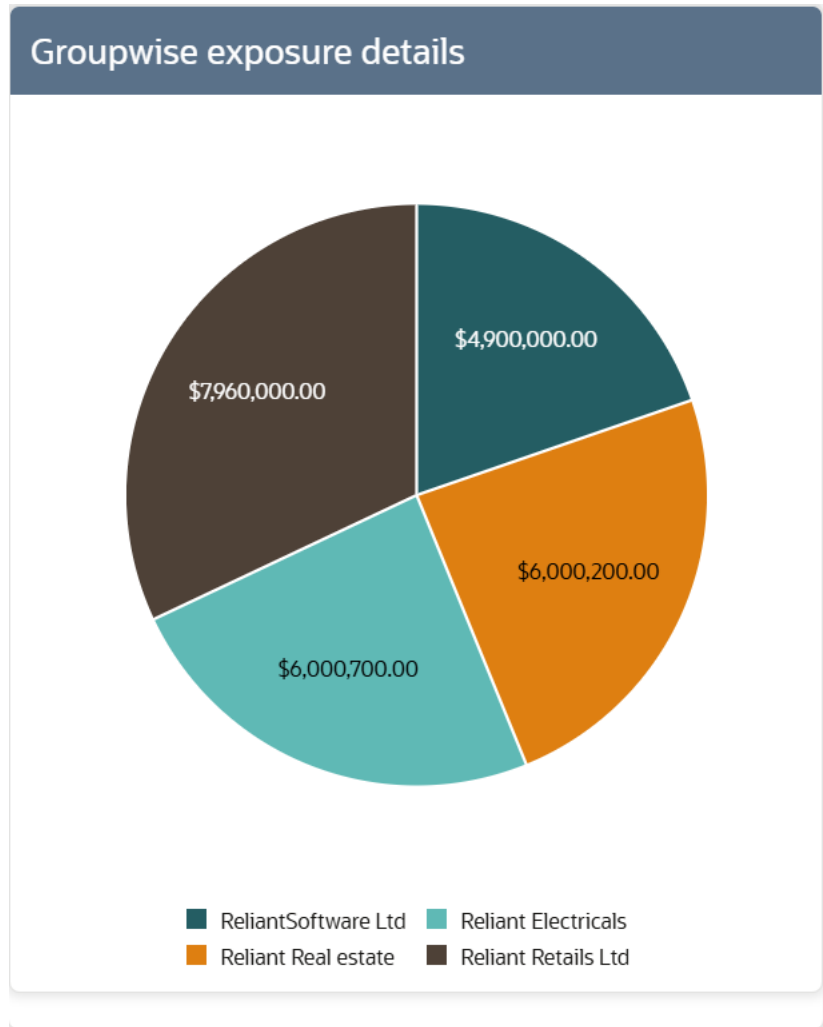

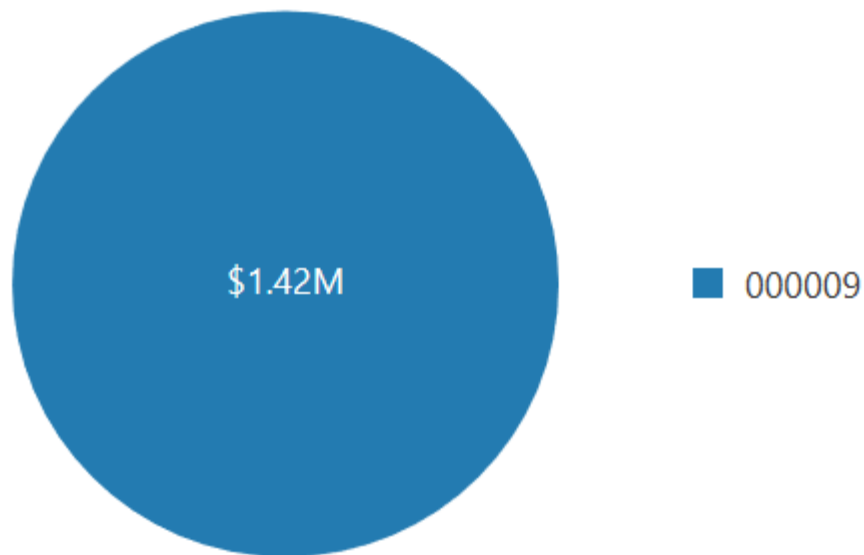

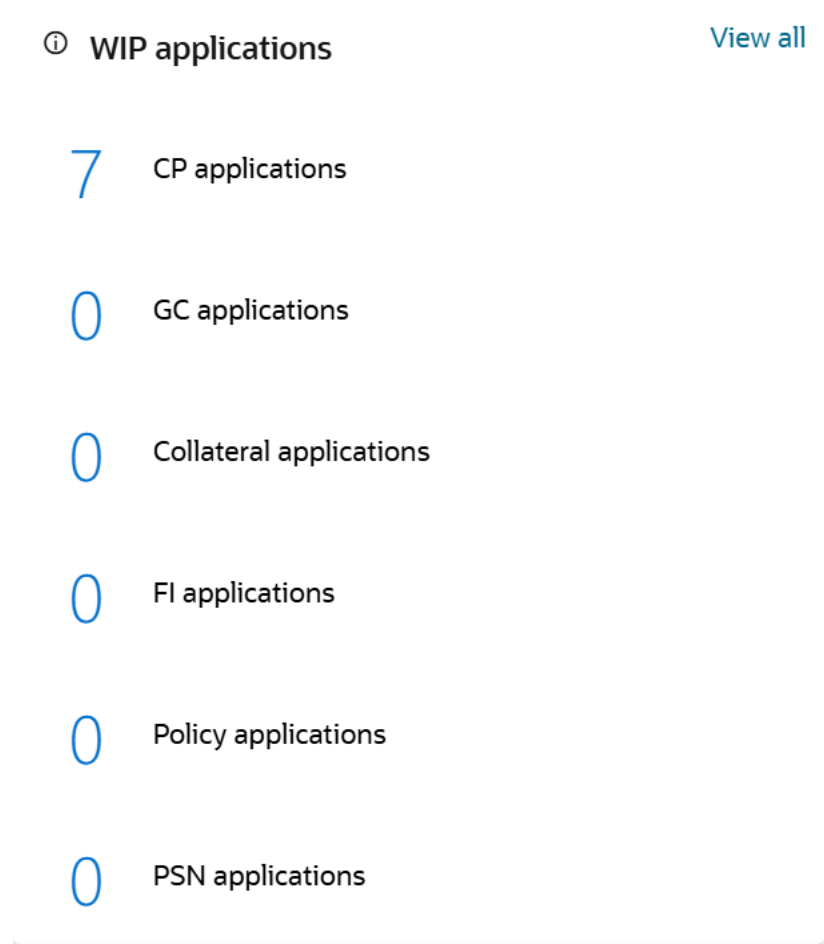
