Overview of Risk Weighted Asset (RWA) Eligibility

This topic describes the information about Overview of Risk Weighted Asset (RWA) Eligibility.

According to Basel III regulations, banks must evaluate and categorize collateral as either Risk Weighted Asset (RWA) eligible or ineligible using clear criteria and rules. This classification is essential for managing internal risks and is also used for regular reporting to both internal governance teams and external regulatory authorities.

RWA eligibility assessment relies on key data points such as customer information, collateral, facility details, liabilities, and other factors collected during the credit application process. In the past, the Oracle Banking Credit Facilities Process Management (OBCFPM) solution lacked the ability to consistently assess or track the RWA eligibility status of collaterals.

To meet this regulatory and operational need, the Collateral RWA Eligibility Checker has been created. This tool allows banks to:

- Keep and set up parameterized lists of data points and questions related to eligibility assessments, including their dependencies and hierarchies.
- Gather and verify relevant data from both facility and collateral applications, ensuring it is complete and accurate.
- Enable bankers to add extra information to system-extracted data as necessary during the eligibility checking process.
- Use advanced, predefined rule sets on the compiled data—automatically determining RWA eligibility results according to Basel III standards.
- Offer end users a structured interface for checking eligibility status, comprehending the decision logic, and aiding compliance and audit needs.

This solution helps banks maintain strong governance over collateral eligibility, ensure consistency in regulatory reporting, and fully align with changing global banking standards.

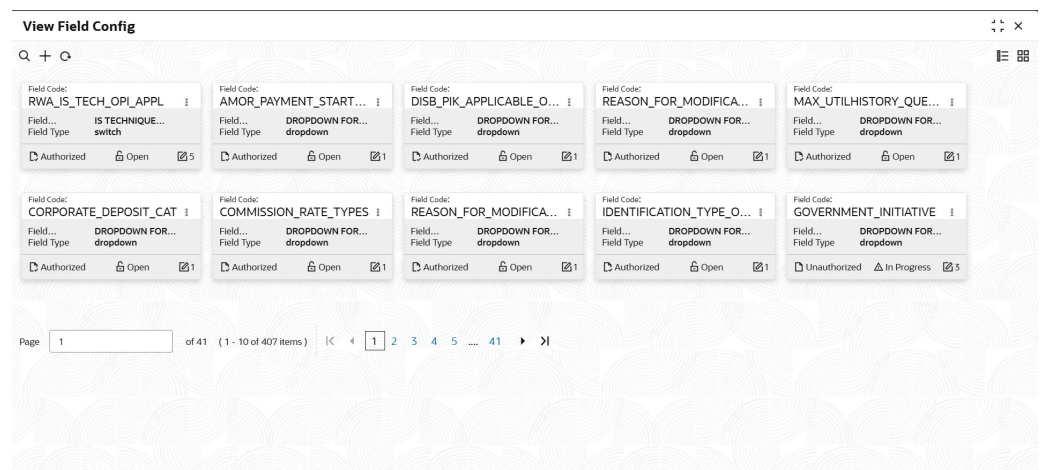

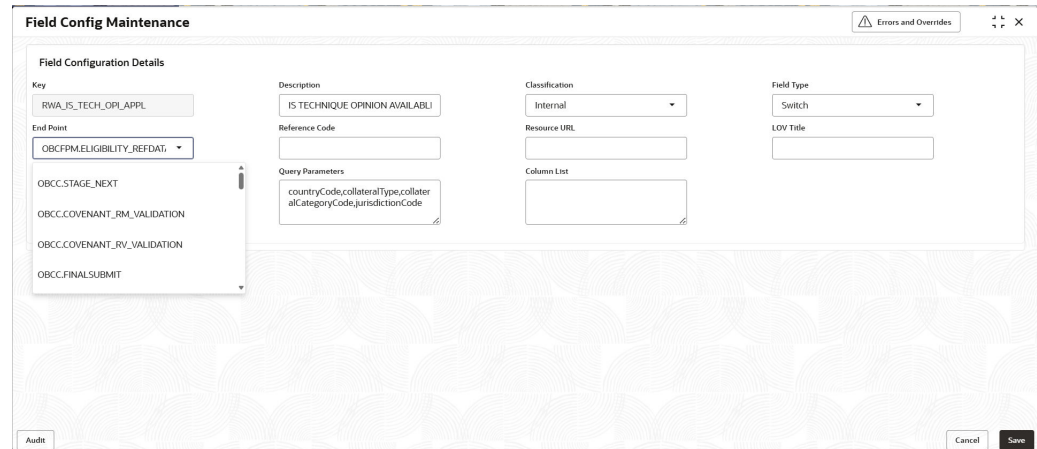

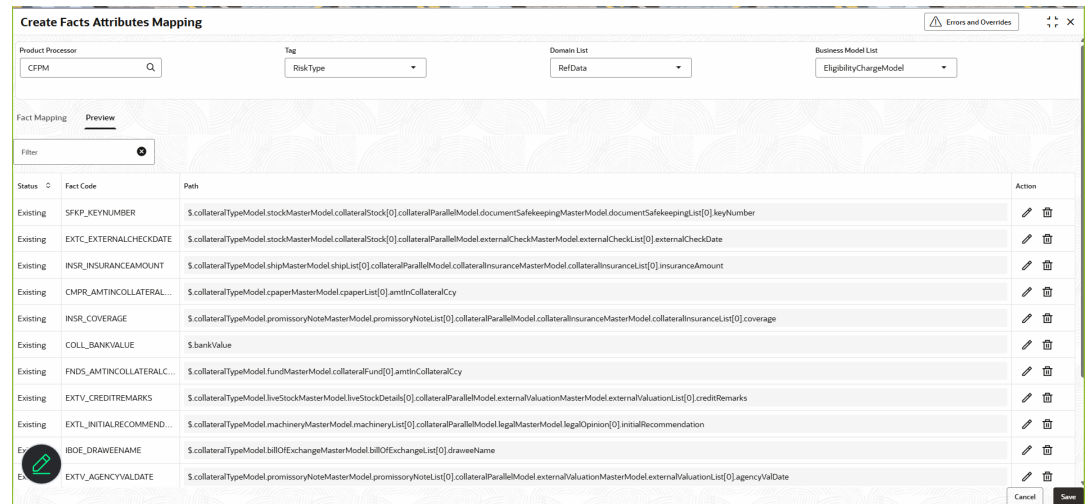



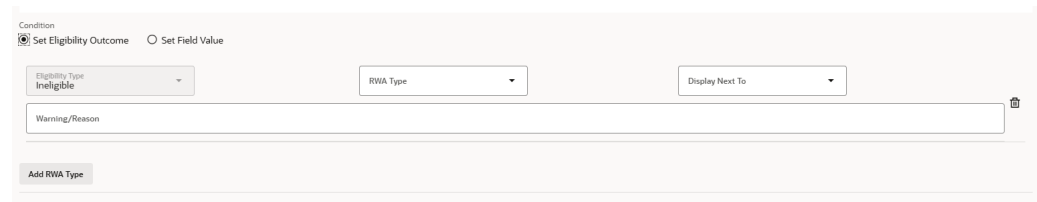

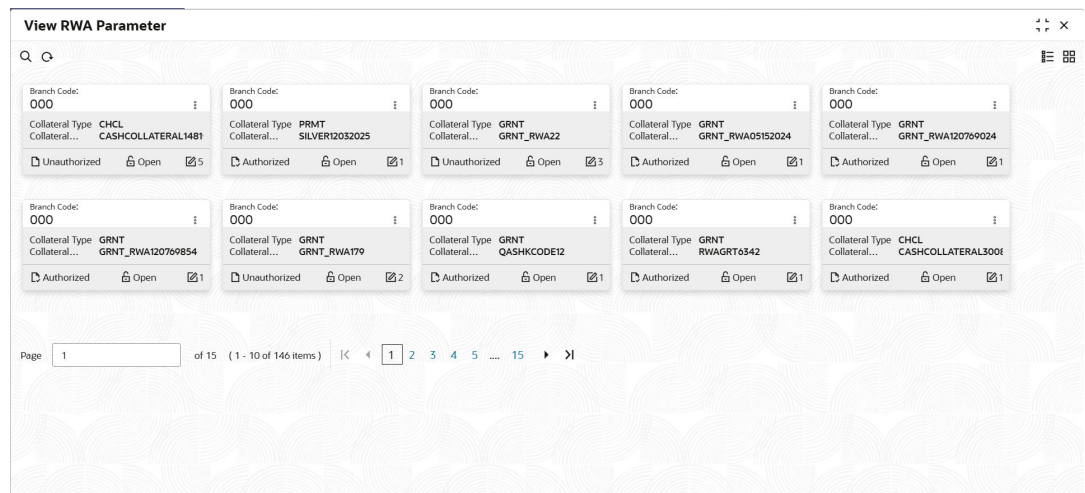



Figure 3-3 Edit RWA Parameter - Modify

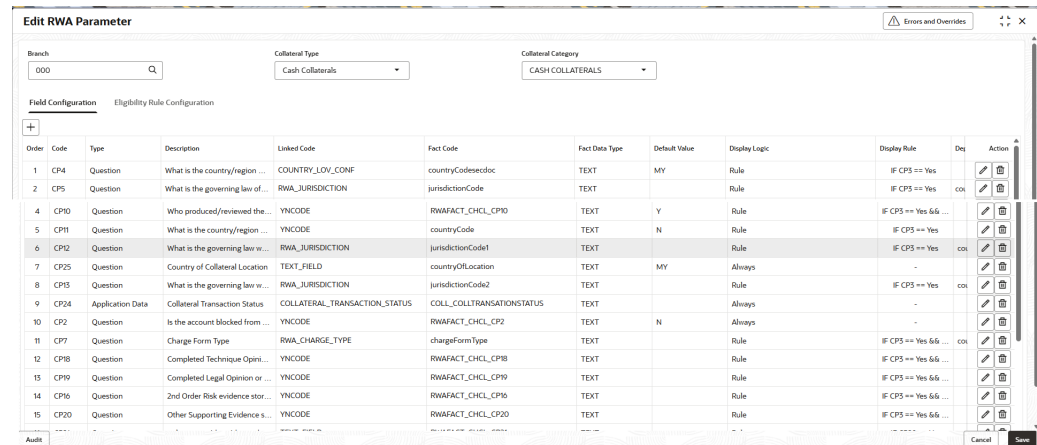



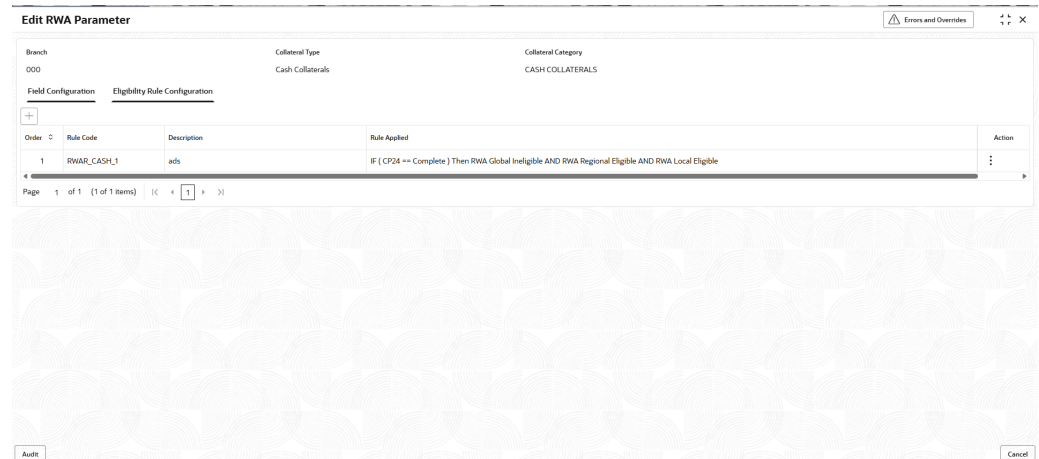

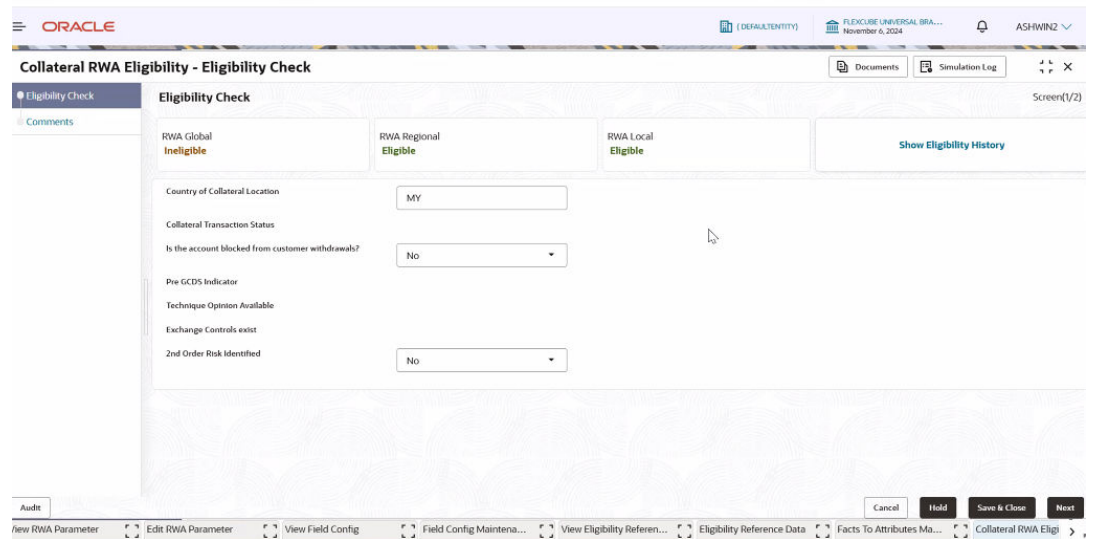
