Most of the screens contain icons to perform all or a few of the basic actions. The actions which are called here are generic, and it varies based on the usage and the applicability. The table below gives a snapshot of them:

Table 2 Basic Actions and Descriptions

Action	Description
Back	In case you missed to specify or need to modify the details in the previous segment, click Back to navigate to the previous segment.
Cancel	Click Cancel to cancel the operation input midway without saving any data. You will be alerted that the input data would be lost before confirming the cancellation.
Next	On completion of input of all parameters, click Next to navigate to the next segment.
Save	On completion of input of all parameters, click Save to save the details.
Save & Close	Click Save & Close to save the data captured. The saved data will be available in View Business Product with <i>In Progress</i> status. You can work on it later by picking it from the View Business Product .
Submit	On completing the input of all parameters, click Submit to proceed with executing the transaction.
Reset	Click Reset to clear the data entered.
Refresh	Click Refresh to update the transaction with the recently entered data.
Download	Click Download to download the records in PDF or XLS format.

Quick Snapshot

This topic provides the systematic instructions for using the Quick Snapshot feature to view balances and transactions for current and savings accounts.

Quick Snapshot feature is available on the login page of Futura bank mobile application. Using this option retail user can view the account summary from mobile application and get important account information in a single view without going on the dashboard.

Pre-requisites

- The User must download Futura bank Application and have a valid account with bank with online banking enabled.

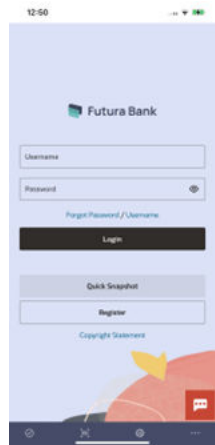
To view accounts summary:

Option 1: From the pre-login page, enable the Quick Snapshot

1. Launch the **Futura bank** application Page.

The **Futura bank** login page appears.

2. Click on the **Quick Snapshot**.

The **Quick Snapshot** screen appears.

3. Click on the **Login to Enable** to enable quick snapshot feature from **Futura bank** application for the first time.

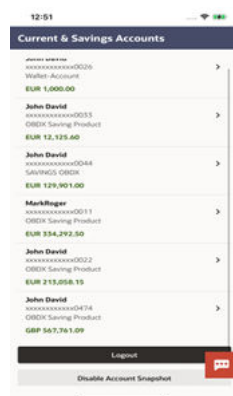
The **Future bank** login page appears to authenticate the user before enabling.

4. Login to **Futura Bank** app.

After authentication is successful, user is redirected to account snapshot screen. Application displays the recent transactions of Current and Savings accounts with account details.

Note

This is one time activity for enabling the quick snapshot. From next time user will directly be taken to account snapshot after clicking on **Quick Snapshot** button on the main login page of the mobile application.

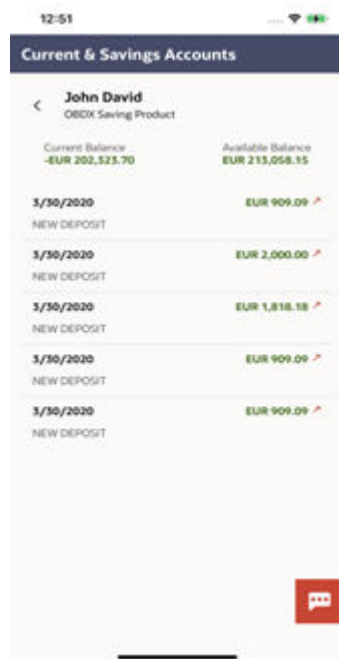

Figure 1-4 Account Details Page

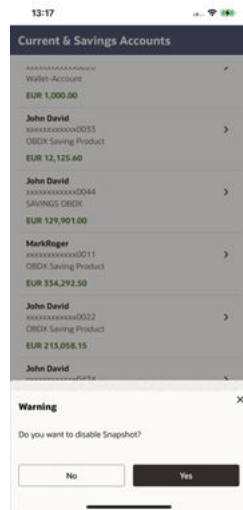
5. Click **Disable Account Snapshot** to disable the quick account snapshot facility for the account.

Figure 1-5 Disable Account Snapshot**Logout from Snapshot**

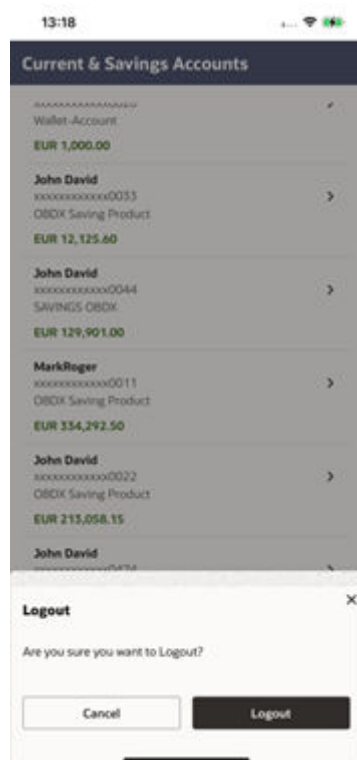
This option will logs out the user from Snapshot view. User will have to login again when he clicks on Quick Snapshot button on login page.

User can add OBDX widgets from the device like other widgets like weather, notes etc. There are three widgets which shows account details and summary.

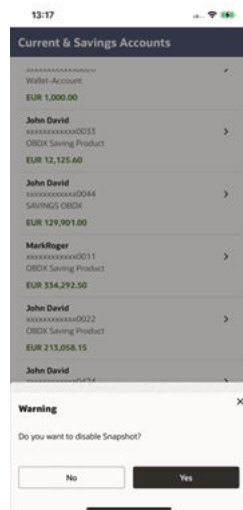
Note

1.1 Recent Activity widget

This topic provides the systematic instructions for viewing the activities and functions displayed in the Recent Activity widget.

The **Recent Activity** widget on the home page displays the summary of the primary account. The widget displays the account available balance of Current and Savings account and last 3 transactions on those accounts along with the date of transaction.

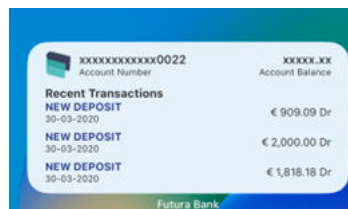
Note

- a. The criteria to view multiple CASA account summary is the retail user who should have at least one CASA bank account, has downloaded the mobile application, and activated the screenshot function.
- b. In case of joint CASA accounts if the primary account number is not setup, then shows the summary of the first account from the CASA accounts list.

1. Login to the **Futura bank** application.

The **Recent Activity** widget on the **Futura bank** home page displays the all the debit and credit entries along with each transaction amount.

**Note**

In case of Joint CASA account if the primary account number is not setup then shows the summary of the first account from the CASA accounts list;

To set primary account, navigate from **Account Settings**, click **Preferences**, and then click **Primary Account Number**, and then select an account **Please setup a primary account** to use futura Bank's widget.

2. Toggle to mask the account balance.

App displays the **Account Balance** in masked format.

In IOS, long press on the **widget**, and then click **Edit Widget**, and then select **Toggle Mask** option.

Note

By default, App displays the account balance in unmasked format.

1.2 View the multiple account summary

This topic provides the systematic instructions for viewing their account summary from the Snapshot widget.

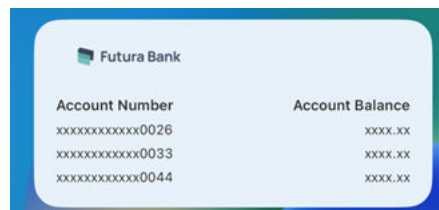
On the home screen, the widget is provided to view their account summary if the user has more than one bank account. The widget on the home page displays the multiple account summary of the registered retail user.

Note

- a. The criteria to view multiple CASA account summary is the retail user who should have at least one CASA bank account, has downloaded the mobile app, and activated the screenshot function.
- b. The widget displays the top three accounts.

To view multiple accounts summary:

1. Click on the **Snapshot** widget icon.
It redirects to accounts snapshot page.

Note

In case of Joint CASA account if the primary account number is not setup then shows the summary of the first account from the CASA accounts list;

To set primary account, navigate from **Account Settings**, click **Preferences**, and then click **Primary Account Number**, and then select an account **Please setup a primary account** to use futura bank's widget.

2. Perform one of the following actions:
 - Long press on widget, and click **Edit Widget** and toggle to mask and unmask the accounts for iOS users of the accounts.
 - Click the  icon to mask, and unmask the accounts for Android users of the accounts.

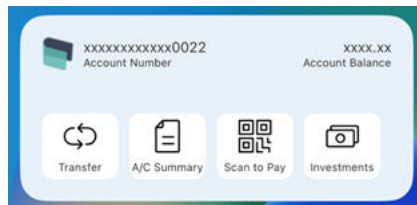
Note

By default App displays the accounts' balances in unmasked format.

1.3 Multi-functional Account Snapshot widget

This topic describes the details features and function of the Multiple Account Snapshot widget.

This widget provides details of the primary account if configured or the first account from the list. It displays the account balance in masked format. To unmask, follow steps mentioned in above section. In addition to the details, it also provides user with multiple options like Scan to pay, View Credit Card Account/summary, view investment dashboard and transfer money.

FAQ

1. What is the benefit of using Quick Snapshot feature?

Quick Snapshot is a quick & convenient way to access your accounts summary, without any need to login to application.

2. Who can use Quick Snapshot feature?

Any futura bank customer who has downloaded mobile application can use this feature

3. Is this feature available for all type of accounts (Current, Savings, Loan, Deposits and Credit Cards)?

No, this feature is only available for Current and Savings accounts.

4. How can the user disable Quick Snapshot?

User can anytime disable this feature by clicking on Disable Quick Snapshot button on the Quick Snapshot screen.

5. Do I need to authenticate myself with my credentials/ alternate login every time I access quick snapshot?

You will need to authenticate only when you are enabling quick snapshot, subsequently clicking on quick snapshot will display the account summary and recent transactions without any authentication.

6. What is Operating system requirements for Augmented Reality (AR) use case?

For iOS minimum support version is iOS 13 and for Android it's Android 6.
