




This topic describes the systematic instruction to **Creating Data Model and ER diagram** option. This document describes the steps to create data model and ER diagram.

1. Open the Oracle SQL Developer Data modeler.












2. Click on File → Import → Data dictionary.









Click Add.




4. Provide the schema details, and **Test** the connection.













5. If connection is successful click **Connect**.




6. Select the newly created connection and click **Next**.






7. Select the required schema and click **Next**. All the schema objects will be listed.




8. Select the entities(tables) that are to be used in ER diagram.







