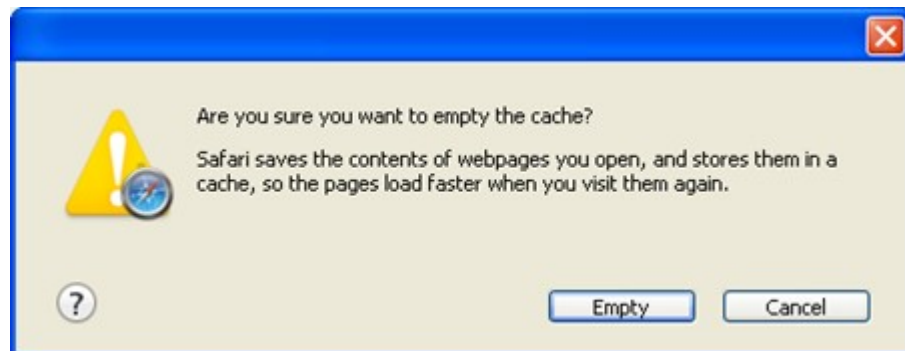

**Figure 2-1 Empty the Cache Message**

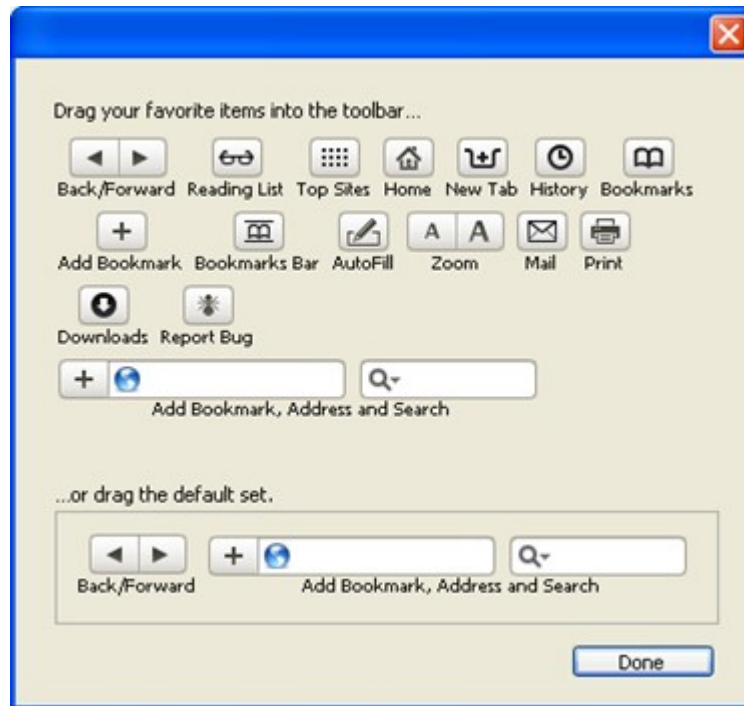


3. Click on the **Empty** button.

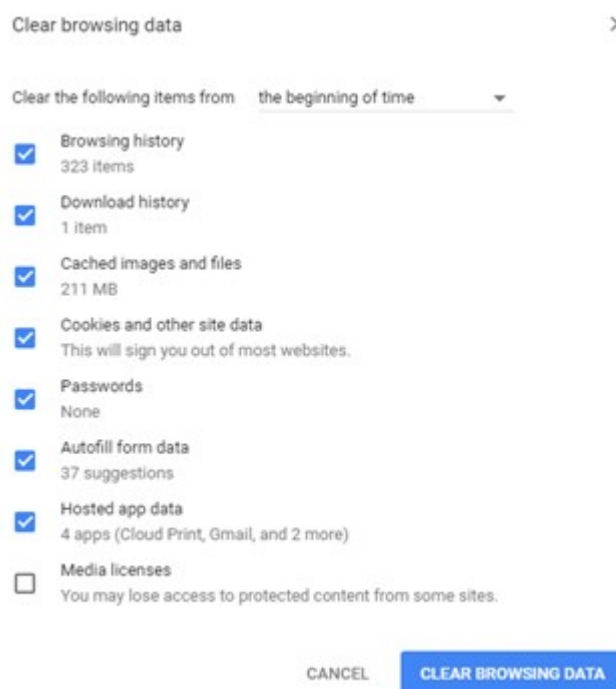
To clear cache, follow the steps given below:

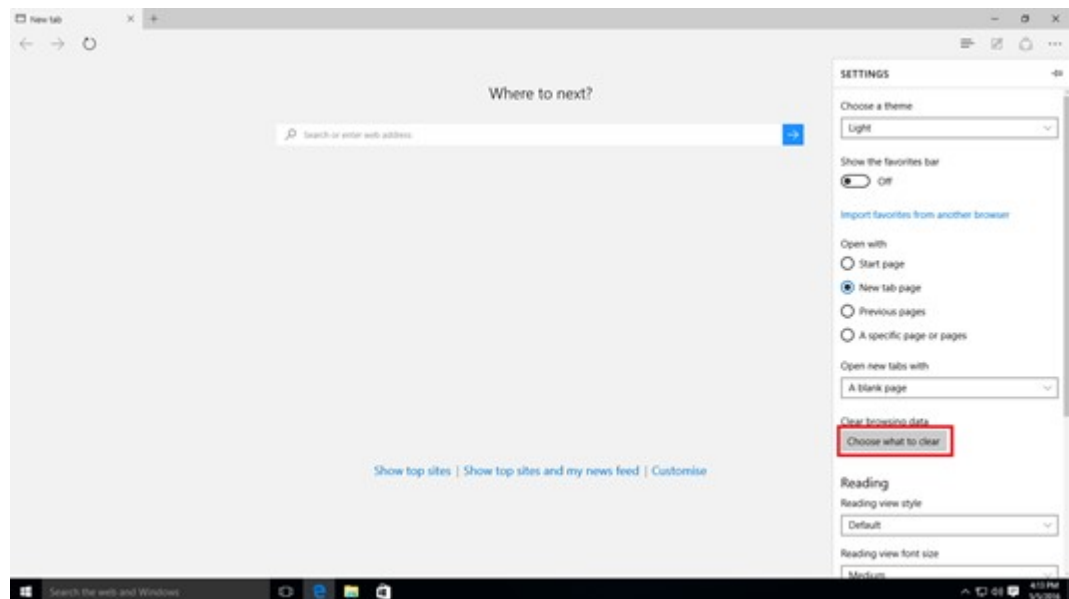

### 4.1 Clearing Cache

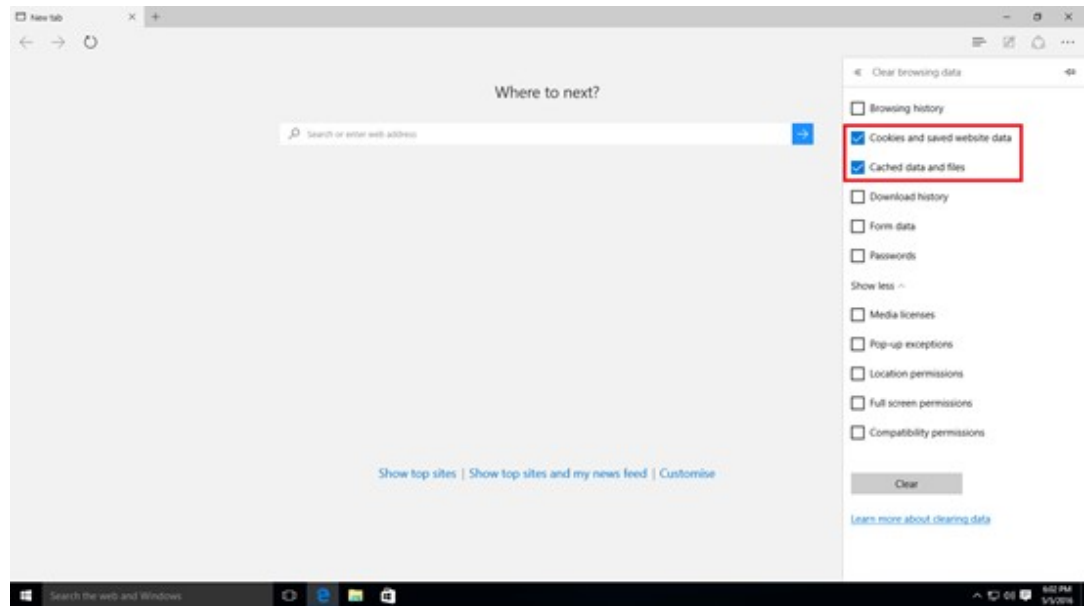
To clear cache, follow the steps given below:

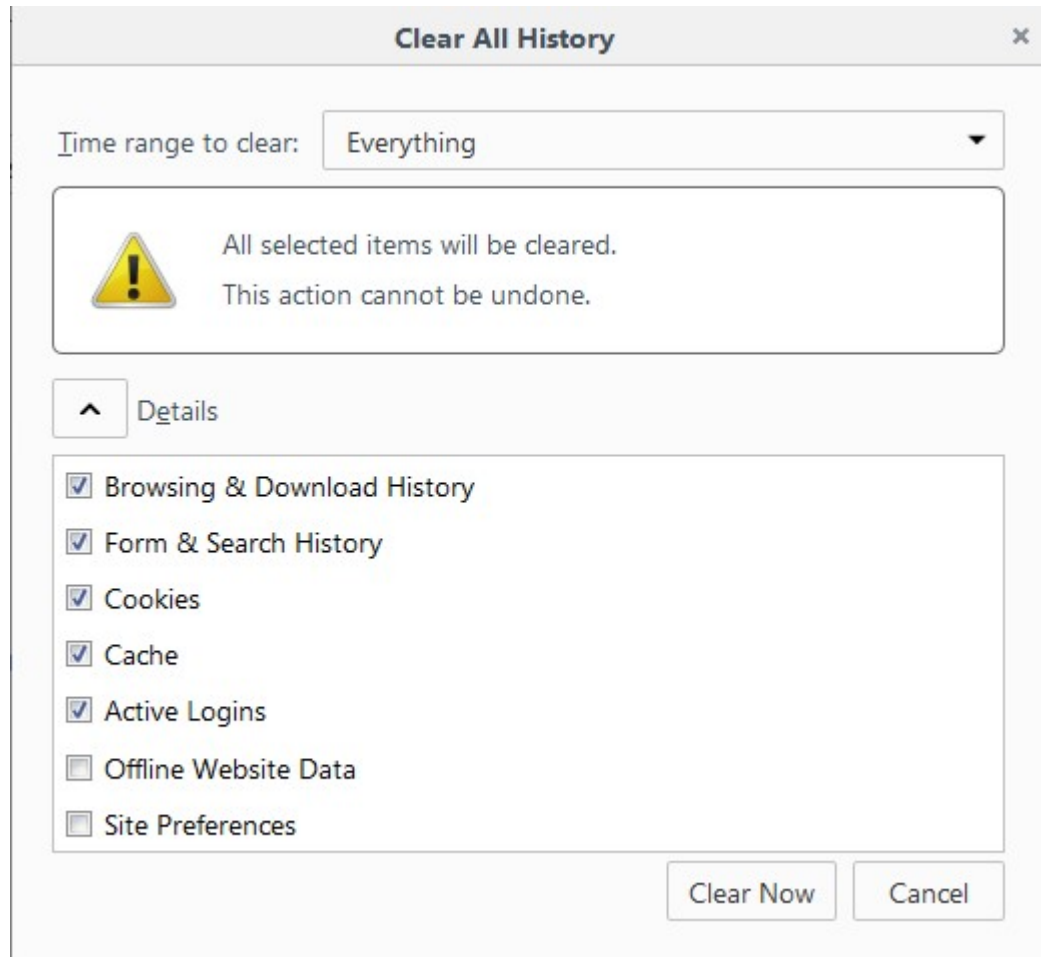

**Clear All History** window displayed.

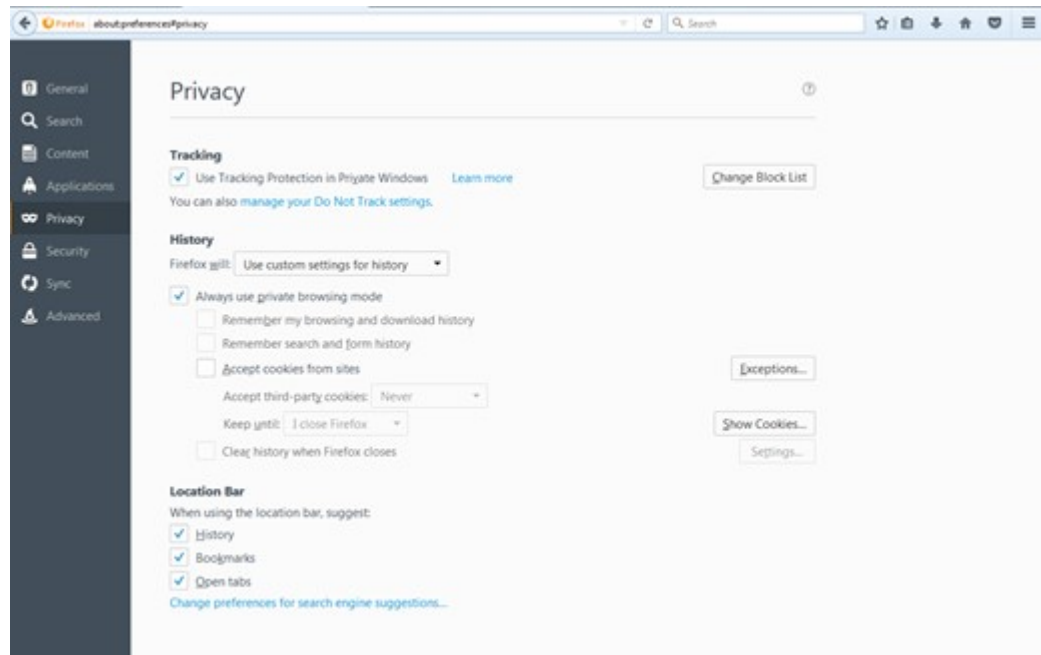
Figure 5-1 Clear All History
