<b>Refer</b>	<p>Select a Refer Reason from the values displayed by the system.</p> <p>Refer Codes are:</p> <ul style="list-style-type: none"> <li>• R1- Documents missing</li> <li>• R2- Signature Missing</li> <li>• R3- Input Error</li> <li>• R4- Insufficient Balance/Limits</li> <li>• R5 - Others</li> </ul>
<b>Hold</b>	<p>The details provided will be saved and status will be on hold. User must update the remarks on the reason for holding the task.</p> <p>This option is used, if there are any pending information yet to be received from applicant.</p>
<b>Cancel</b>	Click <b>Cancel</b> to cancel the transaction input midway without saving any data.
<b>Save &amp; Close</b>	Click <b>Save &amp; Close</b> to save the details provided and holds the task in 'My Task' queue for further update. This option will not submit the request.
<b>Next</b>	Click <b>Next</b> , system validates if all the mandatory fields have been captured. Necessary error and override messages to be displayed. On successful validation, system moves the task to the next data segment.
<b>Submit</b>	Click <b>Submit</b> to complete the transaction after you specify all the input parameters for a particular process. The task will get moved to next logical stage of the process. If mandatory fields have not been captured, system will display an error message until the mandatory fields data are provided.

### Overview

Oracle Banking Trade Finance Process Management Cloud Service is a Trade Finance middle office platform, which enables bank to streamline the Trade Finance operations. Oracle Banking Trade Finance Process Management Cloud Service enables the customers to send request for new Trade Finance transaction either by visiting the branch (offline channels) or through SWIFT/Trade Portal/other external systems (online channels).

### Benefits

Oracle Banking Trade Finance Process Management Cloud Service helps banks to manage Trade Finance operations across the globe in different currencies. OBTFPMCS allows you to:

- Handle all Trade Finance transactions in a single platform.
- Provides support for limit verification and limit earmarking.

- Enables the user to upload related documents during transaction.
- Enables to Integrate with back end applications for tracking limits, creating limit earmarks, amount blocks, checking KYC, AML and Sanction checks status.

## Import Documentary Collection Booking Update - Islamic

Import Documentary Collection Booking Update - Islamic process involves update of an existing documentary collection.

Details of Import Documentary Collection can be updated before liquidation, changes can be for Collection amount, Maturity Date, etc. The update can be requested through Online/Offline channels.

The various stages involved for Import Doc Collection update are:

- Receive and verify documents (Non Online Channel)- Registration stage
- Input application details
- Upload of related mandatory and non-mandatory documents received from the presenting bank
- Verify documents and capture details (Online/Non Online Channels)- Data Enrichment stage
- Input/Modify details of update Collection - Data Enrichment stage
- Check for limit availability if applicable
- Check balance availability for amount block if applicable
- Check for sanctions & KYC status
- Earmark limits/Create amount block for cash margin/charges if applicable
- Capture remarks for other users to check and act
- Hand off request to back office

The Islamic Import Doc Collection Update process flow is similar to that of conventional Import Doc Collection Update process flow.

## 2.1 Common Initiation Stage

This topic provides the systematic instructions to initiate the import documentary collection booking update - Islamic request.

Specify **User ID** and **Password**, and login to **Home** screen.

1. On **Home** screen, click **Trade Finance**. Under **Trade Finance**, click **Initiate Task**.  
The **Initiate Task** screen appears.


## 2.2 Registration

This topic provides the systematic instructions to initiate the Registration stage of import documentary collection booking update - Islamic request.

In Registration stage, user captures the basic details of the transaction and upload related documents. On submit, the request will be available for an collection expert to handle the request in the next stage.

Specify **User ID** and **Password**, and login to **Home** screen.

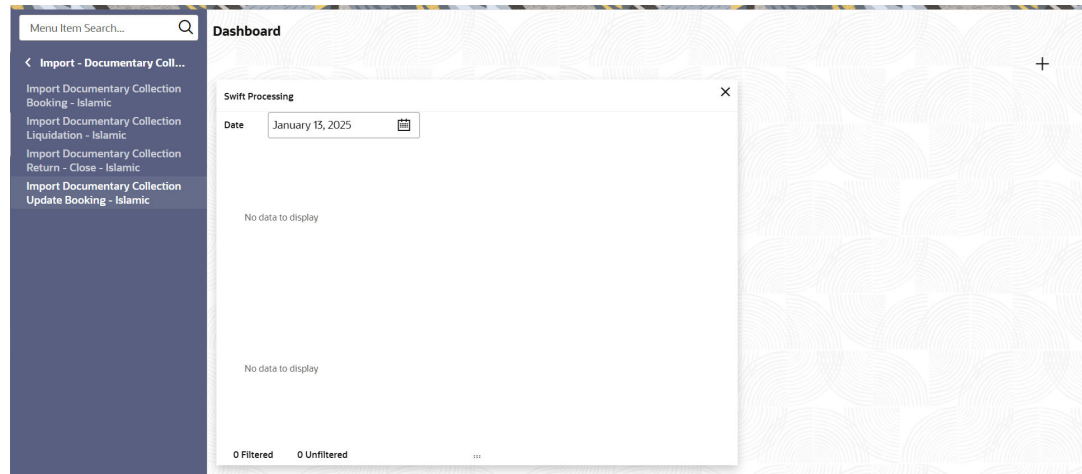
Figure 2-2 Login Screen

Field	Description
<b>Documentary Collection Number</b>	Specify the documentary collection reference.  Alternatively, click <b>Search</b> to search and select the documentary collection reference number. In the lookup, you can search giving any combination details of Documentary Collection Number, Drawer, Currency, Amount, Product Code and Booking Date to fetch the collection details. Based on the search result, select the applicable documentary collection to update the details.
<b>Drawee</b>	Read only field.  This field displays the Drawee ID and name based on the selected Documentary Collection Number. The user can change the parties in Update Collection Processes. Update summary should show both old and new parties.  <div> <b>Note</b>            If the values are allowed to change and the selected drawee/ party is blacklisted the system displays a warning message.         </div>
<b>Branch</b>	Read only field.  Branch details is auto-populated based on the selected Documentary Collection Reference.
<b>Priority</b>	System populates the priority of the customer based on priority maintenance. If priority is not maintained for the customer, system will populate 'Medium' as the default priority. User can change the priority populated any time before submit of task in Registration stage.
<b>Submission Mode</b>	Select the submission mode of Import Documentary Collection Booking Update - Islamic request from the drop-down list.  By default the submission mode will have the value as 'Desk'. <ul style="list-style-type: none"> <li>Desk - Request received through Desk</li> <li>Courier - Request received through Courier</li> </ul>
<b>Update Date</b>	System displays the update date of the application.  By default, the application displays branch's current date.

Field	Description
<b>Remitting Bank/Remitter</b>	Read only field. Remitting Bank/Remitter is auto-populated based on the selected Documentary Collection Number. The user can change the parties in Update Collection Processes. Update summary should show both old and new parties.  <div> <i>Note</i>  In case the selected Bank is not RMA Compliant, the system displays error message “RMA arrangement not available, Only MT999 messages can be sent to the bank”. </div>
<b>Remitting Bank/Remitter Reference</b>	Read only field. Remitting Bank/Remitting Bank Reference is auto-populated based on the selected Documentary Collection Number.
<b>Process Reference Number</b>	Read only field. Unique OBTFPMCS task reference number for the transaction.  This is auto generated by the system based on process name and branch code.
<b>Remitting Bank Date/Remitting Date</b>	Read only field. Remitting Bank Date/Remitting Date is auto-populated based on the selected Documentary Collection Number.
<b>Version Number</b>	Read only field. Version number is auto-generated.

Registration user can provide collection details in this section. Alternately, details can be provided by Data Enrichment user.

- On **Import Documentary CollectionBooking Update - Islamic - Registration - Collection Details** screen, specify the fields.

Field	Description
<b>Documents Received</b>	Documents Received is auto-populated based on the selected Documentary Collection Number. User can change the documents received value. The options are: <ul style="list-style-type: none"> <li>• First</li> <li>• Second</li> <li>• Both</li> </ul>
<b>Duplicate</b>	If a Duplicate (second set) of Import document is received, the user has to initiate Import Collection update process. User has to select the option as 'Second' in "Document Received" and has to set the "Duplicate" toggle to Yes.
<b>Tenor Type</b>	Read only field.  Tenor type is auto-populated based on the selected Documentary Collection Number.  If Tenor type is <b>Both</b> , system disables user input in Liquidation and Unlinked FX rate field. On Submit user will get an error message.
<b>Product Code</b>	Read only field.  Product Code is auto-populated from the Documentary Collection Number.
<b>Product Description</b>	Read only field.  This field displays the description of the product as per the product code.
<b>User Reference Number</b>	User reference number is defaulted based on the description of the product as per the product code. User can change the value.

Field	Description
<b>Operation Type</b>	<p>Operation type is auto-populated from the collection booking. User can update the operation code, if required.</p> <p>The options are:</p> <ul style="list-style-type: none"> <li>• ACC</li> <li>• NEG</li> <li>• COL</li> <li>• PUR</li> <li>• DIS</li> <li>• PAY</li> <li>• FOP - Free of Payment for bills booked with operation Collection or Acceptance</li> <li>• CAC</li> </ul> <div> <p><b>Note</b></p> <ul style="list-style-type: none"> <li>a. Change of Operation from Collection or Acceptance to Free of Payment should be enabled only for Documentary Bills not under LC.</li> <li>b. <b>Stage</b>	<p>Stage is auto-populated from the collection booking. User cannot change the stage value from Final to initial.</li> <li>b. For Operation Type, FOP the Stage to be defaulted to Final as Free of Payment is not applicable for Bills in Initial stage.</li> </ul> </div>
<b>Contract Reference Number</b>	<p>Read only field.</p> <p>System populates the contract reference number from the back end system once the Documentary Collection Number is selected.</p>
<b>Bill Amount</b>	<p>Read only field.</p> <p>This field displays the bill currency and the Bill Amount based on the selected Documentary Collection Reference.</p>
<b>Amount In Local Currency</b>	<p>Read only field.</p> <p>System fetches the local currency equivalent value for the LC amount from back office (with decimal places).</p>

Field	Description
<b>Bill Outstanding Amount</b>	<p>Read only field. Bill outstanding amount is auto-populated from the collection booking.</p> <div> <p><b>Note</b></p> <p>This field is enabled, if Stage is <b>Initial</b>.</p> </div>
<b>Finance Amount</b>	<p>Read only field. Finance amount is auto-populated based on the selected Documentary Collection Number. User can update the Finance Amount, if the <b>Operation Type</b> is set to <b>DIS</b>.</p>
<b>Acceptance Date</b>	Specify the acceptance date.
<b>Non Acceptance Date</b>	Non acceptance date is auto-populated based on the selected Documentary Collection Number.
<b>Non Payment Date</b>	<p>Non payment date is auto-populated based on the selected Documentary Collection Number. This field can be read only or editable depending on the Documentary Collection Number.</p>
<b>Drawer</b>	<p>Drawee ID will be auto-populated from the collection booking. The user can change the parties in Update Collection Processes. Update summary should show both old and new parties.</p> <div> <p><b>Note</b></p> <ul style="list-style-type: none"> <li>a. If the values are allowed to change and the selected drawee/ party is blacklisted the system displays a warning message.</li> <li>b. This field is read only , if the <b>Operation Type</b> is set to <b>DIS</b> and <b>PUR</b>.</li> </ul> </div>
<b>Limit verification required</b>	<p>Move the slider On to enables for limit verification.</p> <p>If the toggle is disabled and <b>Finance Amount</b> has been provided, the system prompts an override message on Submit.</p>
<b>Rebate Amount</b>	Specify the value for rebate to the bill outstanding amount.
<b>Transferee Bank</b>	<p>Read only field. Displays the name of the transferee bank.</p>

Table 2-4 (Cont.) Collection Details - Field Description

Field	Description
<b>Avalization/Co-Acceptance Requested</b>	<p>Enable this option, if the bill is to be avalized.</p> <p>User can enable this option either during the Bill Booking or Amendment. During bill booking, the option can be enabled both INTIAL/FINAL stage and Operation is COL/ACC /DIS. During the Amendment, stage should be Final.</p> <p>By default this option is disabled.</p> <p>Once the option is enabled, it can not be unchecked during any further actions or operations.</p> <div style="border: 1px solid #ccc; padding: 10px; margin-top: 10px;"> <p><b>Note</b></p> <p>Option is not applicable for Sight bills, Multi-tenor and Bills Under LC.</p> </div>

5. Click **Submit**.

The task will move to next logical stage of Import Documentary Collection Booking Update - Islamic.

Field	Description
<b>Documents</b>	Upload the documents received under the Documentary Collection.
<b>Remarks</b>	Specify any additional information regarding the collection. This information can be viewed by other users handling the request.
<b>Overrides</b>	Click to view the overrides accepted by the user.
<b>Customer Instruction</b>	<p>Click to view/ input the following.</p> <ul style="list-style-type: none"> <li><b>Standard Instructions</b> – In this section, the system will populate the details of Standard Instructions maintained for the customer. User will not be able to edit this.</li> <li><b>Transaction Level Instructions</b> – In this section, OBTFPMCS user can input any Customer Instructions received as part of transaction processing. This section will be enabled only for customer initiated transactions.</li> </ul>
<b>Common Group Message</b>	Click to send MT799 and MT999 messages from within the task.
<b>Incoming Message</b>	Clicking this button allows the user to view the incoming SWIFT message MT730.



### Exception - Amount Block

As part of amount block validation, application will check if sufficient balance is available in the account to create an amount block. On hand-off, system will debit the blocked account to the extent earmark and credit charges/ commission account in case of charges block or credit the amount in suspense account for earmarks created for collateral.

The transactions that have failed amount block due to non-availability of amount in respective account will reach the amount block exception stage.

Log in into OBTFPMCS application, amount block exception queue. Amount block validation failed tasks for trade transactions will be listed in the queue. Open the task to view summary of updated available fields with values.

Exception is created when sufficient balance is not available for blocking the settlement account and the same can be addressed by the approver in the following ways:

Approve:

- Settlement amount will be funded (outside of this process)
- Allow account to be overdrawn during hand-off

Refer:

- Refer back to DE providing alternate settlement account to be used for block.
- Different collateral to be mapped or utilize lines in place of collateral.

Reject:

Reject the transaction due to non-availability of sufficient balance in settlement account
