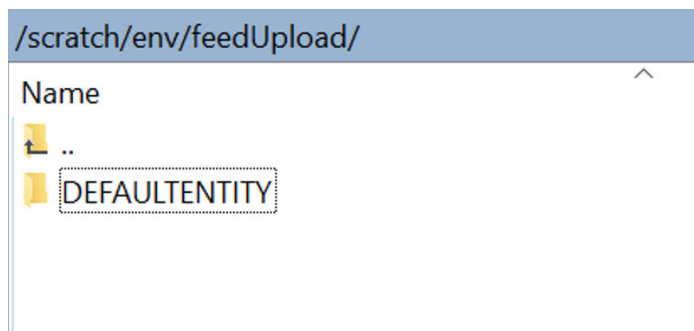
Prerequisites

1. Create the below Folder Structure for inbound data processing.
Path should be `{FeedUploadDirectory}/{EntityId}`. For example, if Feed Path is `/scratch/env/feedUpload` and Entity Id is `DEFAULTENTITY`, then directory structure like below and upload inbound file in that folder.
