For the purposes of Oracle FLEXCUBE Investor Servicing Adapter for Block chain Mutual Funds Transactions, 1K Transactions is defined as one thousand unique mutual fund transactions that are processed through the Program. Each query, endorsement or commit of subscription, redemption, switch or transfer irrespective of success or failure of the same is counted as a transaction.
- ⁴1K Investment Accounts are defined as financial institution's one thousand investor accounts that are opened, maintained, and stored in the Program. All dormant investor accounts shall be considered to be investment accounts as long as they are in the production database of the applicable Program. Closed investor accounts shall not be considered to be investment accounts for the purposes of licensing requirements.
