Download Specifications

Download Specification is an excel file that allows you to manage the sourcing of data to the IPA Staging Area. The Download Specification maps the Staging Data Model to use cases. This is done by mapping the Staging Model at a column level to use cases. This mapping information is embedded in ERwin at a column level using metadata called User Defined Properties (UDPs).

The Download specifications are extracted by using pre-built templates similar to the Data Dictionary. Due to confidentiality reasons, the Download Specifications are only available on My Oracle Support. For more information, see [Other Documents](#).

Run Chart

Run Chart allows the consultant to understand the sequence of tasks to be performed to ensure valid Data Flow in the product. It contains the details about Data Loading for all mandatory tables for the product and the sequence of execution of Seeded Tasks or Batches.

OFS PA provides Run Charts that lists the tasks required for the population of data for OFS PA Reports. The following tasks are covered in the OFS PA Run Charts:

- Stage Dimension Load
- Common Data Population (for example Exchange Rate)
- Set up Table Population
- Dimensions
- Facts
- Profitability Tables Population
- Model Execution
- Derived Entity Refresh
- Cubes Build

Direct Loads

Direct Load enables you to Fast Load the tables into the Oracle Database.

The following tables must be loaded using the Direct Load Method before the Run Charts are executed:

Table 4-1 Direct Load Tables

Table Name	Description
FSI_M_USER	Stores all the users who are not Relationship Managers but are Business Users who have access to data at different levels. The User ID in this table should match the User's Login ID of OBIEE.
FSI_M_USER_MANAGER_MAP	Stores all the users who are Relationship Managers. V_User_name should hold the Obiee Login ID of the user who is a Relationship Manager. The Manager Code Column should match with the entry in dim_management.
DIM_REGION	A geographical region to which the customer belongs.
FCT_REG_CAP_ACCOUNT_SUMMARY	Stores the regulatory capital related information from the BASEL Applications. This table must be loaded after loading the DIM Tables.

4.1 Verification of Exchange Rates T2T

You must verify that a join in the T2T FSI EXCHANGE RATES is correct as part of the Installer in a pack-on-pack scenario. If the join is not correct, you must change it.

To change the ANSIJOIN, perform the following steps:

1. Navigate to **Financial Services Performance Analytics**, select **Data Management Framework**, select **Data Management Tools**, and then select **Data Mapping**. The Data Mappings window is displayed.
2. Select the row of the T2T definition and then select **Edit**. The Data Mapping window to edit the T2T Definition is displayed.
3. Select Map to modify the ANSIJOIN parameter.
4. Enter the following condition in the **ANSI Join** field of the **Join/Filter** pane:
VW_FSI_RATE_TRIANGULATION INNER JOIN DIM_RUN ON DIM_RUN.N_RUN_SKEY = -1
5. Click **OK**.
6. Click **Save**. The ANSIJOIN is modified.

Run Chart Execution

The execution of Run Chart starts by running the Data Foundation Processes.

Due to confidentiality reasons, the Run Charts are only available on My Oracle Support. For more information, see [Other Documents](#).

In case of an integrated environment, if the DIM_DATES table has intermittent records, then the user should clean up the DIM_DATES table by temporarily disabling the FKs (Foreign Keys) and then execute the OOTB Seeded Run: RN_DATES for the entire range.

To get the correct LTV Values, the Customer needs to execute the Run Chart from earliest Start Date across all accounts.

- The Data Foundation Processes
 - **Reference Data Load (Dimensions):** The Reference Data Load is needed to load all the Dimensions.
 - **Currency Conversion Load:** This loads the Exchange Rate Data.
 - **Party Load:** This loads all the Dimensions related to Party like DIM_PARTY, DIM_CUSTOMER along with MLS Tables and Derived Entities.
 - **Account Load (Dimension + Facts):** This loads all the relevant Dimensions and Fact Data for the Instrument Tables.
 - **Party Facts Load:** This Loads Facts at the granularity of Party like FCT_COMMON_CUSTOMER_SUMMARY, FCT_CRM_CUSTOMER_SUMMARY, and so on.
 - **Transaction Data Load (Dimension + Facts):** This loads detailed Account Transaction Data and the Summaries.
 - **Application Data Load:** This loads data that is part of the information provided by Customers while applying for a particular Product.
 - **Opportunity Data Load:** This loads data corresponding to potential Business Opportunities and leads that are available to the Bank along with the conversion stages.
 - **Management Data Load:** This loads data corresponding to the Banks Client Relationship Managers and their corresponding Professional Hierarchies.
- PFT Integration
- FTP Integration
- Profitability Load
- Projections (ARIMA Model)
- Reporting Line Correlation (Regression Model)
- Segmentation

This ends the Base Run Chart Execution.
