New Features in this Release

Oracle Insurance Accounting Analyzer Extension Pack bundles the following new features in version 8.1.2.7.0. For detailed information about the usage of the listed features, see the respective product User Guides on [OHC Documentation Library](#).

- Reserve Converter now has a user interface that allows users to choose basis, assign weights, and make necessary modifications.
- STG_CLAIM_TXNS table is being referred to for capturing claims transactions and STG_CLAIM_DETAILS is being referred to for other claim related details including claim outstanding as of FIC_MIS_DATE.
- Subledger definition creation is allowed based on only unique definition names, meaning two subledger definitions can have the same dimensions but different names.
 - If the subledger definitions share same dimensions but have unique definition names, then these unique names (i.e., exact matching criteria) should only be entered in the Accounting Rules page for searching and importing accounting rules. Searching based on dimensions will not fetch any results in this scenario.
 - Importing of accounting rules is enabled for also the subledger definitions which are in draft status.
- On the LDTI EP reports dashboard, a new tab called **Reinsurance Held** has been added under **Liability Analysis** page and a new report called **EP Roll Forward Reinsurance Premiums and Recoveries** has been added there.

Known Issues or Limitations

The following are the Limitations in Release 8.1.2.7.0:

- Only the English Language is supported on OFS IAA EP. Ensure that only the OFS IAA Application Pack in the English Language is first installed for the OFS IAA EP Application to load the English Language correctly.
- The projections do not work when the data given for Direct Insurance and Reinsurance Held are of different frequencies.
- If the 1/24th or any other method (except for the 1/365th method) is used for *Earned Premium* computation, then the reserve converter will not support the apportionment on the basis of *Policy Years Exposed*. Other basis such as *Paid Claim*, *Earned Premium*, and *Incurred claim* etc will be supported.
