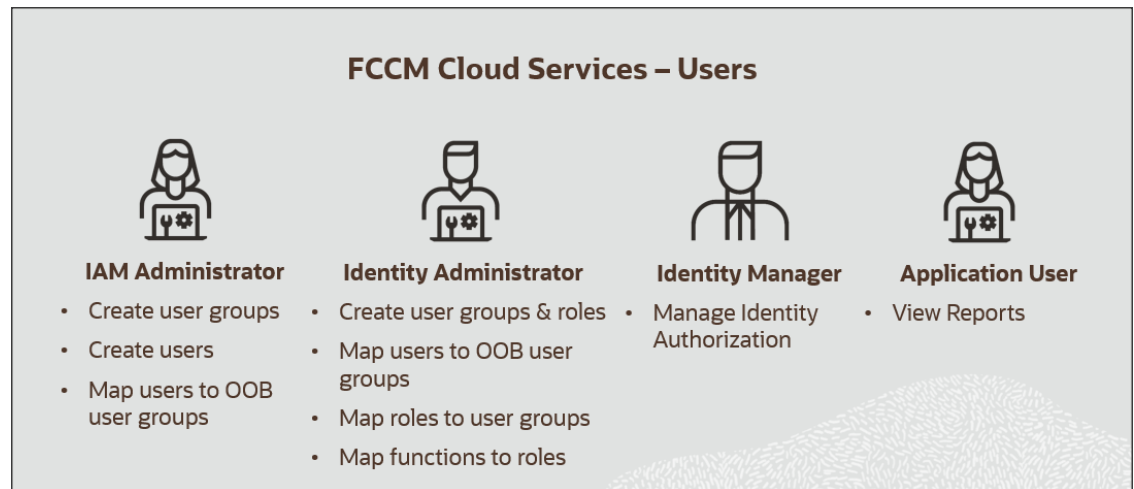

Role-Based Access Control

Role-based security in Oracle Financial Services Compliance Monitor Cloud Service controls who can do what on which data.

1	Subscribe	Activating Subscription
2	User Authentication	- Create users - Add User to Group
3	Application Security Mapping	Application Security Administration helps Administrators classify users and the data that they are permitted to access.
4	Loading Data	Data that is present in the application layer is processed and loaded into the reporting layer.
5	Replication Utility	Replication Utility - a tool to ensure data consistency across multiple databases enabling efficient data replication and synchronization.
6	Getting Started	Explains the steps to log in to the FCCM Monitor cloud service and provides a brief overview of the users and their roles
7	Case Management Reports	To view Case Management reports.
