# Oracle Argus Mart data and Argus signal management installation overview

#### • About the installation and upgrade process

The Oracle Empirica Signal application supports data from the Oracle Argus Mart application. Users access the data in Oracle Empirica Signal by using the Oracle Argus Mart data configurations. For example, users can reference the Oracle Argus Mart data configurations when creating data mining runs, queries, case series, and reports for ad hoc analyses.

• Before you begin

You need access to the Oracle Empirica Signal 9.1 distribution media and required user names and passwords.

### About the installation and upgrade process

The Oracle Empirica Signal application supports data from the Oracle Argus Mart application. Users access the data in Oracle Empirica Signal by using the Oracle Argus Mart data configurations. For example, users can reference the Oracle Argus Mart data configurations when creating data mining runs, queries, case series, and reports for ad hoc analyses.

If your organization is licensed for Signal Management, users can employ the signal management feature in Oracle Empirica Signal on the data. The feature facilitates the ongoing monitoring of safety signals by enabling users to perform statistical analysis on successive updates of safety data. Users employ the feature by using the Argus Mart signal configuration to populate the Signal Review page. For more information, see the *User Guide and Online Help*.

The installation process for the Oracle Argus Mart data configurations includes:

- Updating Oracle Argus Mart 8.0 (and later) for use with Oracle Empirica Signal 9.1.
- Setting up the Argus data configurations on the Oracle Empirica Signal application server.

The installation process for the Oracle Argus Mart signal configurations includes:

- Installing the Oracle Argus Mart signal configuration on the Oracle Empirica Signal application server.
- Configuring the PL/SQL custom procedure to run from the Argus ETL hook.
- Configuring the Oracle Empirica Signal application to enable the signal management feature.

The upgrade process for Oracle Argus Mart signal configuration from 8.1.x to 9.1 is covered in Upgrading Argus signal configuration from 8.1.x to 9.1.



### Before you begin

You need access to the Oracle Empirica Signal 9.1 distribution media and required user names and passwords.

To install the Argus Mart data configuration, you need:

- An Oracle Argus Mart in which ETL has been run.
- Access to the Oracle Argus Mart 8.0 update for Oracle Empirica Signal 9.1 distribution media, which contains:
  - Update\_AM\_8\_0\_for\_Signal\_9\_1\_0\_0\_xxx.zip
  - Empirica\_Signal\_Argus\_Installation.pdf
  - Oracle Argus Mart Release Notes 9.1.pdf.
  - Argus\_Prep.zip —A Zip archive file. Optional for Argus Signal Management.
- The user name, password, and TNS name of the system, AM\_MART\_USER, and webvdme database user accounts.
- The user name and password associated with a non-privileged user account on the Oracle Empirica Signal application server.
- The MedDRA version used for each time period in the data.
- The user name and password associated with an administrator account on the Oracle WebLogic Server Administration console.

# Set up the Oracle Argus Mart data configurations in Oracle Empirica Signal

#### • About the Oracle Argus Mart data configurations

The data configurations provide access to the cases in the database tables that you can analyze using Oracle Empirica Signal. For example, the Argus Spontaneous (S+C) data configuration includes only spontaneous reports from Oracle Argus Mart, but both suspect and concomitant drug records for those cases.

• Make the Release Notes accessible to users from the Oracle Empirica Signal application

You must make the Release Notes accessible for users to install Argus Mart data and Argus Signal Management.

Install MedDRA accounts on the Oracle Empirica Signal database

Data from the Oracle Argus Mart application is timestamped. Therefore, you must create a MedDRA user account for each version of MedDRA used to code the data.

- Update Oracle Argus Mart 8.2 (and later) for use with Oracle Empirica Signal 9.1 To update Oracle Argus Mart 8.2 and later to Oracle Empirica Signal 9.1, perform these steps using the non-privileged user account on the application server.
- Load the Oracle Argus Mart data configurations into the Oracle Empirica Signal application

You load the data configurations into Oracle Empirica Signal to enable users to work with data from the Oracle Argus Mart application.

• Specify the MedDRA version for each time period in an Oracle Argus Mart data configuration

You must specify the MedDRA version used for each time period in the data. A time period is a range of dates during which only one MedDRA version was used to code the data.

- Validate the Oracle Argus Mart data configurations Validate the Oracle Argus Mart data configurations before you attempt to publish the configurations. For more information about the validation process, see the User Guide and Online Help.
- Publish the Oracle Argus Mart data configurations Publish the Oracle Argus Mart data configurations to the login groups and users that require access to the configurations.
- Attach the PL/SQL custom procedure to the Argus ETL hook Oracle Argus Mart provides ETL Hooks for custom procedures that can be used to extend the existing behavior of the Argus Mart ETL.

## Make the Release Notes accessible to users from the Oracle Empirica Signal application

You must make the Release Notes accessible for users to install Argus Mart data and Argus Signal Management.

- 1. Obtain the most recent version of the Oracle Argus Mart Data and Argus Signal Management for Use with Oracle Empirica Signal Release Notes.pdf file.
  - a. Go to the Oracle Help Center.
  - b. Select the latest release version of Oracle Empirica Signal and Topics.
  - c. On the Books page under Release Notes, select Oracle Argus Mart Data and Argus Signal Management for Use with Oracle Empirica Signal Release Notes.

The file downloads.

2. As a non-privileged user on the application server, copy the .pdf file to the <INSTALL\_DIR>/relnotes directory, for example:

/u01/stage/Signal\_Install/Signal/relnotes

- 3. Redeploy the Oracle Empirica Signal WebLogic Server instance:
  - a. In a Web browser, navigate to the Oracle WebLogic Server Administration Console:

https://<servername>:<port>/console

- **b.** Log in using the administrator credentials provided to you by the system administrator.
- c. In the Domain Structure pane, click **Deployments**.
- d. In the Change Center pane, click Lock & Edit.
- e. In the Deployments table, select Signal.
- f. Click Update.
- g. Click Next, then click Finish.
- h. In the Change Center pane, click Activate Changes.

The deployment is updated.

After logging in to Oracle Empirica Signal, users can access the Oracle Argus Signal Management for Use with Oracle Empirica Signal Release Notes by



selecting **Settings** from the left navigation pane and then **About**. On the About page, click the **here** link.

## Install MedDRA accounts on the Oracle Empirica Signal database

Data from the Oracle Argus Mart application is timestamped. Therefore, you must create a MedDRA user account for each version of MedDRA used to code the data.

You create the user accounts using the MedDRAxxx.zip files provided by Oracle. xxx indicates the version of MedDRA. For example, a MedDRA191.zip file is for MedDRA version 19.1.

If a user account already exists on the database server for a given version of MedDRA, do not recreate the account.

The application server is assumed to be Linux. If installing from a Windows server, please contact Oracle support.

For each MedDRA account that you need to create, perform these steps using the non-privileged user account on the application server.

• For MedDRA 19.0 and prior

Data from the Oracle Argus Mart application is timestamped. Therefore, you must create a MedDRA user account for MedDRA 19.0 and prior to code the data.

For MedDRA 19.1 and later
 Date from the Oracle Arrive Mart emplication

Data from the Oracle Argus Mart application is timestamped. Therefore, you must create a MedDRA user account for MedDRA 19.1 and later to code the data.

### For MedDRA 19.0 and prior

Data from the Oracle Argus Mart application is timestamped. Therefore, you must create a MedDRA user account for MedDRA 19.0 and prior to code the data.

- 1. Copy the MedDRAxxx.zip file from the distribution media to a temporary directory on the server.
- 2. Unpack the MedDRAxxx.zip file into a temporary directory, for example:

\$ unzip MedDRAxxx.zip -d /u01/stage/ The MedDRAxxx subdirectory is created.

3. Navigate to the /MedDRAxxx directory, for example:

\$ cd /u01/stage/MedDRAxxx

- 4. Using a text editor, open the Create\_MedDRA.sql file.
  - a. Locate the DEFINE ORACLE\_DBF\_FILE statement.
  - **b.** Edit the path portion in the DEFINE ORACLE\_DBF\_FILE statement to point to the desired location for the Oracle tablespace data files.

Keep the single quotes and use &SCHEMA.a.dbf as the last part of the string.

The path can point to any existing location on the database server. However, the Oracle tablespace data files are usually located in the oradata subdirectory of the Oracle Database installation directory.



**c.** Optionally, change the default password. Be sure to abide by your site's password policies.

The default password has the same value as the username.

Locate the DEFINE PASSWORD='&SCHEMA' line near the top, and replace &SCHEMA with the desired password.

- d. Save and close the file.
- 5. Execute the Create\_MedDRA.sql script as the system user to create the MEDDRAxxx tablespace and user account, for example:

```
$ sqlplus system@<TNS_name> @Create_MedDRA.sql
A password prompt appears.
```

- 6. Enter the system database account password, and press Enter.
- Execute the imp command to populate the MedDRA tablespace you created in a previous step, for example:

```
$ imp userid=MEDDRAxxx@<TNS_name> file=MEDDRAxxx.dmp full=Y
Log=Imp_MEDDRAxxx.log
```

A password prompt appears.

8. Enter a password for the MEDDRAxxx database account, and press Enter.

Installation produces log files in the MedDRAxxx directory, including counts of imported records for each table:

imp\_MEDDRAxxx.log

Create\_MedDRA.log

 To verify that the import has completed successfully, compare the record counts in imp\_MEDDRAxxx.log to the counts of exported records in exp\_MEDDRAxxx.log.

### For MedDRA 19.1 and later

Data from the Oracle Argus Mart application is timestamped. Therefore, you must create a MedDRA user account for MedDRA 19.1 and later to code the data.

- 1. Copy the MedDRAxxx.zip file from the distribution media to a temporary directory on the server.
- 2. Unpack the MedDRAxxx.zip file into a temporary directory, for example:

```
$ unzip MedDRAxxx.zip -d /u01/stage/
The MedDRAxxx subdirectory is created.
```

3. Navigate to the MedDRAxxx/Linux directory, for example:

\$ cd /u01/stage/MedDRAxxx/Linux

4. Give execute permissions on the shell script files:

\$ chmod +x \*.sh

5. Execute the installer:

\$ ./install.sh

6. Follow the on-screen prompts to install MedDRA xx.x.



The following is a sample transcript of the prompts and information that the installer generates.

#### **Pre-installation checks**

The installer performs a series of checks to ensure that the required software components are available.

Empirica Signal Data Release Installation Program Version <version> Pre-installation checks:

sqlplus	INSTALLED
imp	INSTALLED
tnsping	INSTALLED
builtin echo	AVAIL.
builtin printf	AVAIL.

### **Oracle TNS name**

The installer prompts for the target TNS name, which will be used in the rest of the steps.

Enter the TNS name and press Enter.

Please enter your database's TNS name: The installer attempts to verify the TNS name provided. After three failed attempts, the installer will terminate with an error. If verified, the installer indicates success.

TNS name <TNS NAME> verified successfully.

#### Password for privileged Oracle user

Creating and dropping schemas requires elevated privileges. The installer prompts for a privileged Oracle user account name. The default privileged Oracle user account name is **SYSTEM**.

Please enter Privileged user's Oracle user name [SYSTEM]:

Enter the password for this account and then press Enter.

Your response will not be echoed to the screen but will be masked by a series of asterisks.

Please enter SYSTEM's password:

The installer attempts to verify the password provided. After three failed attempts, the installer will terminate with an error. If verified, the installer indicates success.

SYSTEM password verified successfully. Oracle Empirica Signal or Oracle Empirica Study application user name (not applicable for MedDRA 19.1)

If Oracle Empirica Signal or Oracle Empirica Study is installed, press Enter.

Is an Empirica application installed in the target database <TNS NAME> [Y] N]?

Enter the Oracle user name (for example, **WEBVDME** or **STUDY**) and password for the application when prompted.

Please enter Empirica application's Oracle user name [WEBVDME]:
Please enter WEBVDME's password:



If verified, the installer indicates success.

WEBVDME password verified successfully.

#### Installation

The installer presents the option to install the MedDRA xx.x data account. If the data account already exists, drop and re-install the account. Press **Enter** or enter **Y** to install MedDRA xx.x, or enter **N** to skip.

Install MEDDRA xxx [Y|N]?

Enter a secure password for the **MEDDRAxxx** Oracle user, subject to any site-specific policies or restrictions.

#### Note:

Your site's database may have specific password policies or restrictions. For example, your database may not allow the password to be the same as the account name. Take this into account when choosing the password for this account.

Your response will not be echoed to screen but will be masked by a series of asterisks.

Please enter a new password for MEDDRAXXX:

Enter the same password for verification. Your response will once again be masked by a series of asterisks. After three failed attempts, the installer will terminate with an error. If verified, the installer continues.

Please re-enter the same password for verification: Enter the full directory path for datafiles on your database server or press **Enter** to accept the default.

### Note:

The installer does not have the ability to verify remote system paths. Please make sure that the path you are entering is correct. Linux file and directory paths are case sensitive and use forward slashes to separate path components.

Please enter the absolute datafiles directory path [/u01/app/oradata/ ORCL]:

The installer presents all of the information it has collected. Passwords are masked by a series asterisks. Inspect the list carefully before proceeding. If necessary, press **Ctrl+C** to abort the installation and retry with the corrected information. If the information is correct, press any key to proceed with the installation.

#### Installation progress and summary

Updates are printed to the screen as installation progresses. Any errors encountered also display. For an error-free installation, the installer will report success before exiting.

## Update Oracle Argus Mart 8.2 (and later) for use with Oracle Empirica Signal 9.1

To update Oracle Argus Mart 8.2 and later to Oracle Empirica Signal 9.1, perform these steps using the non-privileged user account on the application server.

- 1. Copy the Update\_AM\_8\_0\_for\_Signal\_9\_1\_0\_0\_xxx.zip file from the distribution media to a temporary directory on the server.
- 2. Unpack the Update\_AM\_8\_0\_for\_Signal\_9\_1\_0\_0\_xxx.zip file into a temporary directory, for example:
  - \$ unzip Update\_AM\_8\_0\_for\_SIGNAL\_9\_0\_0\_0\_xxx.zip -d /u01/stage/



The /UPDATE\_AM\_8\_0\_FOR\_SIGNAL\_9\_1 subdirectory is created.

- 3. Navigate to the /UPDATE\_AM\_8\_0\_FOR\_SIGNAL\_9\_1 directory, for example: \$ cd /u01/stage/UPDATE\_AM\_8\_0\_FOR\_SIGNAL\_9\_1
- 4. Using a text editor, open the create\_argus\_spontaneous\_configurations.sql file.
- 5. Locate the following WHERE clause:

WHERE UPPER (report\_type\_ve) IN (''SPONTANEOUS'',''LITERATURE'')

The WHERE clause describes the spontaneous reports from the Oracle Argus Mart database user account.

- 6. Modify the WHERE clause as needed.
- 7. Save and close the file.
- 8. Execute the UPDATE\_AM\_8\_0\_FOR\_SIGNAL\_8\_1.sql script as the am\_mart\_user, for example:

\$ sqlplus am\_mart\_user@<TNS\_name> @UPDATE\_AM\_8\_0\_FOR\_SIGNAL\_8\_1.sql
A password prompt appears.

- 9. Enter the am\_mart\_user database account password, and then press Enter.
- **10.** Execute the UPDATE\_AM\_8\_2\_FOR\_SIGNAL\_9\_1.sql script as the **am\_mart\_user**. For example:

\$ sqlplus am\_mart\_user@<TNS\_name> @UPDATE\_AM\_8\_2\_FOR\_SIGNAL\_9\_1.sql
A password prompt appears.

11. Enter the am\_mart\_user database account password, and then press Enter.

## Load the Oracle Argus Mart data configurations into the Oracle Empirica Signal application

You load the data configurations into Oracle Empirica Signal to enable users to work with data from the Oracle Argus Mart application.

- ARGUS (S)
- ARGUS (S+C)
- Argus Spontaneous (S)
- Argus Spontaneous (S+C)

Perform these steps using the non-privileged user account on the application server.

 Navigate to the /u01/stage/UPDATE\_AM\_8\_0\_FOR\_SIGNAL\_9\_1 directory, for example:

\$ cd /u01/stage/UPDATE\_AM\_8\_0\_FOR\_SIGNAL\_9\_1

2. Execute the @init\_configuration\_account.sql script as the **system** user and provide the Oracle Empirica Signal and Oracle Argus Mart database user accounts on the command line:

\$ sqlplus system@<TNS\_name> @init\_configuration\_account.sql webvdme
AM\_MART\_USER



The script enables Oracle Empirica Signal to import the Oracle Argus Mart data configurations from the **am\_mart\_user** database user account without requiring Oracle Empirica Signal users to enter the database user account password.

A password prompt appears.

- 3. Enter the system account password, and then press Enter.
- 4. Log in to the Oracle Empirica Signal application as a user with the Manage Configurations user permission.

## Specify the MedDRA version for each time period in an Oracle Argus Mart data configuration

You must specify the MedDRA version used for each time period in the data. A time period is a range of dates during which only one MedDRA version was used to code the data.

For example, suppose that the Oracle Argus Mart data includes the following rows:

Case ID	Start	Stop	
100	01-01-2004	06-01-2004	
200	06-01-2004	01-01-2005	
300	01-01-2005	-	

Additionally, suppose that different versions of MedDRA were used to code the Oracle Argus Mart data:

- MedDRA version 6.1 was used until June 1, 2004.
- MedDRA version 7.0 was used between June 1, 2004 and January 1, 2005.
- MedDRA version 7.1 was used starting January 1, 2005.

You would specify the version of MedDRA used for each time period as described in this procedure.

- 3. From the Configure System section, click Manage Configurations.



Each date includes a time stamp of 12:00:00 a.m. unless you specify a time stamp. For example, if you specify that MedDRA version 6.1 was used until (<=) 06/01/2004 and MedDRA version 7.0 was used thereafter, then MedDRA 7.0 is applied to source data coded at 12:00:01 a.m. on June 1, 2004.

- **b.** In the first row of the **Hierarchy Account** column, enter the MedDRA account name.
- c. Fill in one row for each time period in the Oracle Argus Mart data, for example:





#### Define Effective Dates for the Event Hierarchy Accounts

If you need additional rows, you can select **Add additional empty rows upon saving**, and click **Save**.

For the last time period, enter only the Oracle database account name for the MedDRA version.

## About the Oracle Argus Mart signal configuration

For example, the signal configuration specifies the variables the application uses for data mining runs. For more information, see the *User Guide and Online Help*.

When you install the Oracle Argus Mart signal configuration, queries are created in the **Argus Signal Mgmt** project. Each query is a specification for retrieving a subset of cases from a data configuration in data mining runs.



### Install the Oracle Argus Mart signal configuration

You must install the Oracle Argus Mart signal configuration.

Perform these steps using the non-privileged user account on the application server.

**1.** If it does not already exist on the Oracle Empirica Signal application server, create the following directory:

```
/u01/stage/projects
```

2. Copy the Argus\_Prep\_3\_0\_0\_1\_xxx.zip file from the distribution media to:

/u01/stage/projects

3. Unpack the Argus\_Prep\_3\_0\_0\_1\_xxx.zip file into a temporary directory, for example:

\$ unzip Argus\_Prep\_3\_0\_0\_1\_xxx.zip -d /u01/stage/projects/ The /argus\_prep subdirectory is created.

4. Navigate to the /argus\_prep directory, for example:

\$ cd /u01/stage/projects/argus\_prep

5. Execute the following command to give execute permissions to all .sh files:

\$ chmod u+x common/\*.sh sigdet/\*.sh site/\*.sh

6. Navigate to the /argus\_prep/sigdet directory, for example:

\$ cd /u01/stage/projects/argus\_prep/sigdet

7. Execute the following command to give write permissions to the db directory:

\$ chmod u+w db

8. Execute the main\_install\_sigmgt.sh script to initiate the installation:

\$ ./main\_install\_sigmgt.sh < signal database account name >@<TNS\_name> where < signal database account name > is the Oracle Empirica Signal database user account name, for example, webvdme. <TNS\_name> is the TNS name that the application server uses to access the database server.

A password prompt appears.

 Enter <password>, where <password> is the Oracle Empirica Signal database user account password.

A second password prompt appears.

10. Reenter <password>.

The database tables for the Oracle Argus Mart signal configuration are populated. The install\_sigmgmt.log file is created in the sigdet/sigmgt/install/log subdirectory.



Note:

If you enter the password incorrectly, an error such as this appears in the install\_sigmgmt.log file: Error returned from execution of "sqlplus /NOLOG @db/connect webvdme @db/ fetch\_next\_config\_id".

If the following error message appears, the Argus Signal Mgmt project already exists:

ERROR at line 1:

ORA-00001: unique constraint (WEBVDME.UC\_PROJECTS1) violated You can disregard the error.
