#### Download the patch

Oracle distributes the release patch set as a zip file.

To locate and download the patch set:

- 1. Log in to My Oracle Support at support.oracle.com/signin.
- Click the Patches & Updates tab. The Patches and Updates page opens and displays the Patch Search region.
- 3. In the **Patch Name** or **Number** field, enter the primary bug number fixed in this patch (38715783).
- 4. Select **Search** to execute your query. The Patch Search page opens.
- Select the patch number. The system displays details about the patch. In addition, you can view the Readme file before downloading the patch.
- Select **Download**. The File Download dialog box opens.
- 7. Browse to a temporary directory where you want to download the file. Select **Continue**.
- 8. Select Save.
- Transfer the patch .zip file to the necessary servers.

When you unzip the downloaded OHMPI 5.0.9.5 patch archive to a temporary directory, the following files are extracted:

- readme\_ohmpi5\_0\_9\_5.htm.
- ohmpi-patch.zip.
- runPatch.bat (Windows script that installs ohmpi-patch.zip).
- runPatch.sh (UNIX script that installs ohmpi-patch.zip).

You must have JDK version 1.8 or above. This is a prerequisite for installing OHMPI patches.

Before installing the patch, perform the following steps.

- Start NetBeans.
- 2. Shut down NetBeans.
- 3. Back up the ohmpi directory from the OHMPI 5.0 NetBeans installation directory (for example <ohmpi5.0.9.4 install dir>/netbeans/ohmpi).
- 4. Back up the **Samples** folder and all of its contents.

#### Run the patch script

Before installing the patch, perform the following steps.

- Unzip the downloaded OHMPI 5.0.9.5 patch archive (p38715783\_50950\_Generic.zip) to a temporary directory.
- Edit runPatch.bat (Windows) or runPatch.sh (Unix) and set NETBEANS\_DIR to the OHMPI 5.0 NetBeans installation directory (for example <ohmpi5.0.9.4 install dir>/netbeans).
- Run the edited runPatch.bat or the runPatch.sh script. The script uses ohmpi-patch.zip to complete the installation.

#### Post-installation steps

After installing the patch, perform the following steps.

- Start NetBeans.
- Perform one of the following:
  - a. For Master Person Index (MPI): Backup the existing MPI project, Open the project, Clean, Re-generate the Master Index File, and build the project.
  - b. For IHE Profiles: Backup the existing IHE project, Open the project, Clean IHE and the corresponding MPI project, Re-generate the Master Index File for MPI Project and build the IHE project. Then use the generated hl7v2.zip file to configure the HL7v2 Server.
  - c. For HPD Profiles: Backup the existing HPD Project, Open and Clean HPD, IndProvider and OrgProvider Projects, Re- generate Master Index File for IndProvider and OrgProvider Projects and then build the Projects.
- 3. Redeploy the Master Person Index, IHE Profile, or HPD projects.
