What can I do with Oracle Healthcare Translational Research?

Oracle Healthcare Translational Research enables integrating, controlling, and analyzing the clinical and genomic data required to support the complete biomarker life cycle. This includes data acquisition, discovery, and research as well as clinical use of patient and specimen information and cohort maintenance in clinical trials.

Use Oracle Healthcare Translational Research (OHTR) to:

- Select cohorts of patients or subjects using 10 clinical dimensions and 4 types of genomic data type criteria.
- Save cohort queries and lists and share them with colleagues.
- View complete clinical and genomic information for a single patient or subject.
- Use the built-in Visquick genome browser to view different types of genomic results in a circular plot.
- Search genomic data based on different genomic features like genes, genomic location, gene components, variants and so on.
- View information on patient or subject specimens linked to genes and variants.
- View and export specific clinical information for a selected cohort.
- View clinical activities on a visual timeline.
- View built-in cohort-driven reports on:
 - Demographic statistics
 - Clinical statistics
 - Genomic variants, copy number variation, gene expression, and structural variants
 - Genes compared to a sample matrix
 - Variants compared to a sample matrix
- Export various types of genomic data in VCF, SEG, GCT, and RES formats in synchronous and asynchronous mode.
- Schedule jobs for genomic data export.
- Drill in from one screen to another to further drill down and generate various reports.

The standard Oracle ADF logger is applied for logging, and by default, it is written in WebLogic diagnostic logs. Logging focuses on the following areas:

- SQL queries to retrieve cohort count or list and event data - These are constructed dynamically based on user input and may need to be tracked for debugging and diagnostic purposes.
- DML operation of saved queries - Unlike other parts of the UI that handle read-only data, saving queries writes data into database tables, and the operations are logged.

Before you begin building your query

Before you start creating your query, let's go through these tips. Keep this section in mind, you will probably come back to it from time to time.

- Prepare or plan the query definition in a structured format (line-by-line) before creating it in Oracle Healthcare Translational Research.
- When you want to search for a criterion, but can't exactly remember the name or the code, just click **Search** without selecting any conditions, or adding a keyword. The entire list of codes and names appears.
- Every criterion you want to add in your query can be included as an inclusion or exclusion. When you select either option, it applies to all of the elements in that criterion.
- By default, most dialog boxes for choosing criteria use the **Equals** operator and list the first 100 types only. If there are more than 100 types for one criterion that you want to include in your query, you can search for them using other operators such as **Starts with**, **Contains**, and so on.

Patient Information

Demographics

1. On the Home page, on the left, click the **Cohort Query** icon().
2. In the **Cohort Query** screen, on the left, click the **Patient Information** category, then click **Demographics**.

3. Either enter the Patient ID or click the search icon ().

To search for a **Patient ID**:

- a. Select a condition and enter part of a patient ID.
- b. Click **Search**.
- c. Select the patient ID that you want to use from the left side and move it to the right side using the arrow ().

Alternatively, multiple patient IDs can be specified by:

- Pasting comma or new line separated values in the designated input box.
- Uploading a text file containing multiple comma or new line separated values.

After pasting the values or uploading the file, when you click the Search button the patient IDs found in the system are listed in the left side list and the remaining patient IDs are listed below the left side list.

- d. Click **Submit**.
4. Either enter the Patient Universally Unique Identifier (Patient UUID) or click the search icon (). To search for a Patient UUID:
 - a. Select a condition and enter part of a Patient UUID.
 - b. Click **Search**.
 - c. Select the Patient UUID that you want to use from the left side and move it to the right side using the arrow ().

- d. Click **Submit**.

Alternatively, multiple Patient UUIDs can be specified by:

- Pasting comma or new line separated values in the designated input box.
- Uploading a text file containing multiple comma or new line separated values.

After pasting the values or uploading the file when the Search button is clicked, the Patient UUIDs found in the system are listed in the left side list and the remaining Patient UUIDs are listed below the left side list.

5. Set any other criteria that you want to use in your query:
 - **Gender**: Select the gender from the drop-down list.
 - **Marital Status**: Select the status from the drop-down list.

- **Age:** Select a condition, and then add the age in years, as a single value or a range.

 Note:

Queries that use age: To optimize performance of queries that use age in years, the application uses pre-calculated age in years based on Date of Birth and current date, rounded to the nearest value.

Age calculation is automatically performed when Patients or Subjects are created in Cohort Data Mart and the calculated age is stored in the **AGE_IN_YEARS** columns in Patient and Subject dimensions.

Age calculation can also be scheduled to run at an specified interval, for example daily, weekly, monthly. Default schedule is Weekly (Sundays, 1 AM).

Details on scheduling of this calculation are provided in *Oracle Healthcare Foundation Administrator's Guide*, section *Age_in_years attribute*.

If the calculated age of Patients or Subjects is above 90 years then it is rounded to 90 years to comply with HIPAA security rule. To search for Patients or Subjects above 90 years of age, use the search criteria **Age = 90 Years**.

- **Date of Birth:** Select condition, and then enter the date.
- **Deceased:** Select this check box, if needed.
- **Last Contact Date:** Select a condition, and then add the date as a single value or a range.
- **Ethnicity:** Select the appropriate ethnicity.
- If in the **Subject** context, specify Age at Study Start.
Select a condition, then add the Age as a single value or a range and select the unit of measure of the age, that is, Year(s), Month(s), Week(s), or Day(s). To match the Subjects based on this criteria, Cohort Query uses the Cohort Data Mart's database column **Age At Study Start in Days** (W_EHA_SUBJECT_D.AGE_AT_STUDY_START_DAYS or AGE_AT_STUDY_START_DAYS_OBF, depending on the data access privileges of the logged in user). The value in the database column **Age At Study Start in Days** is automatically populated based on the values populated in the columns **Age at Study Start** (AGE_AT_STUDY_START) and **Age at Study Start Unit Of Measure** (AGE_AT_STUDY_START_UOM_WID) using the following calculations and the same calculations are also used for parsing the search criteria defined for **Age at Study Start**.

If value of the database column Age at Study Start Unit Of Measure matches the parameterized value for:

Value of the database column Age At Study Start in Days:

Day	= Age at Study Start
Week	= Age at Study Start X 7
Month	= Age at Study Start X 365/12
Year	= Age at Study Start X 365
Any other value	=Null

Refer to the Oracle Healthcare Foundation Administrator's Guide for information on the Cohort Data Mart ETL's configurable parameters related to automatic population of the database column Age at Study Start in Days.

- **Race:** Select the appropriate race.
 - **Location:** Enter either a city, state, zip code, county, or country.
 - **Data Source:** Enter or search for a Data Source.
6. Under **Insert as** select either:
 - **Inclusion** to include the criteria in the query.
 - **Exclusion** to exclude the criteria from the query.
 7. Click **Submit**.

Consent

1. On the left, click the **Patient Information** category, then click **Consent**.

2. Enter a **Consent Type** or click the search icon (🔍).

To search for a **Consent Type**:

Note:

Follow the same steps for the Consent Code and Consent Status.

- a. In the **Select Consent Type** window, select a condition for **Consent Type Name** or **Consent Type Code** and enter part of the consent name or type.
 - b. Click **Search**.
 - c. Select the consent type or code that you want to use from the left side and move it to the right side using the arrow (➡).
 - d. Click **Submit**.
3. Set any other criteria that you want to use in your query:
 - **Consent Code:** Enter or search for a Consent Code.
 - **Consent Status:** Enter a consent status, or follow steps from 2a to 2d, to search for a consent status.
 - **Consent Start Date:** Select a condition, and then add the date.
 - **Consent End Date:** Select a condition, and then add the date.
 - **Data Source:** Enter or search for a Data Source.

Note:

The double asterisks next to the input label of an attribute indicate that at least one of such attributes is required for defining search criteria for the selected data (in this case, Consent). The same convention is used in all other search dialogs as well.

4. Under **Insert As** select either:
 - **Inclusion** to include the criteria in the query.
 - **Exclusion** to exclude the criteria from the query.
5. Click **Submit**.

**Note:**

To define search criteria for Consent, the criteria must include at least one of the following attributes: Consent Type, Consent Code or Consent Status.

Patient Group

1. In the Patient Context, on the left, click the **Patient Information** category, then click **Patient Group**.
2. Enter a Group Name or click the search icon ().

To search for a Group Name:

**Note:**

Follow the same steps for the Responsible Party Number and Responsible Party Name.

- a. In the Select Group Name window, select a condition for Group Name and enter part of the Group Name.
 - b. Click **Search**.
 - c. Select the Group Name that you want to use from the left side and move it to the right side using the arrow ().
 - d. Click **Submit**.
3. Set any other criteria that you want to use in your query:
 - a. Enter a Group Type or click the search icon.
 - i. In the Select Group Type window, select a condition for Group Type Name or Group Type Code or Code System ID or Code System Name and enter part of the Type Name or Type Code or Code System ID or Code System Name.
 - ii. Click **Search**.
 - iii. Select the group type that you want to use from the left side and move it to the right side using the arrow.
 - iv. Click **Submit**.

- b. **Group Start Date:** Select a condition, and then add the date. This is the date when the Group was started or became active.
 - c. **Group End Date:** Select a condition, and then add the date. This is the date when the Group was ended or became inactive.
 - d. **Participation Start Date:** Select a condition, and then add the date. This is the date when a Patient became part of the Group.
 - e. **Participation End Date:** Select a condition, and then add the date. This is the date when the participation of a Patient in the Group ended.
 - f. **Responsible Party Number:** Enter or search for a Responsible Party Number (Identifier of the Party). Responsible Party for a Group can be an individual or organization party who is managing the Patient Group, such as an institutional review board (IRB).
 - g. **Responsible Party Name:** Enter or search for a Responsible Party Name.
 - h. **Data Source:** Enter or search for a Data Source.
4. Under Insert As, select:
- **Inclusion** to include the criteria in the query.
 - **Exclusion** to exclude the criteria from the query.
5. Click **Submit**.

Diagnosis

1. On the left, click the **Clinical Data** category, then click **Diagnosis**.
 2. Either enter the diagnosis or click the search icon ().
- To search for a **Diagnosis**:
- a. Select one of the **Search Modes**:
 - **Classic Search.** Select it to use more search conditions for Diagnosis Name, Code, and Code System.

- **Hierarchy Drill-in Search.** Select it to search all of the codes in a hierarchy that are associated with a single Code System, and have only one parent code.

 Note:

This feature does not support mixed hierarchy, meaning different levels of codes belonging to different Code Systems or multi-parent hierarchy, meaning one code having multiple parent codes.

- b. Select a condition for one or all: **Diagnosis Name, Diagnosis Code, Code System ID** or Code System Name.
 - c. Click **Search**.
 - d. Select the diagnosis codes that you want to use from the left side and move them to the right side using the arrow ().
 - e. Click **Submit**.
3. Set any other criteria that you want to use in your query:
 - **Concern Subtype:** Enter or search for a Concern Subtype.
 - **Diagnosis Status:** Enter or search for a Diagnosis Status.
 - **Diagnosis Severity:** Enter or search for a Diagnosis Severity.
 - **Onset Date:** Select a condition, and enter a date.
 - **Reported Date:** Select a condition, and enter a date.
 - **End Date:** Select a condition, and enter a date.
 - **Age At First Onset:** Select a condition, and then add the age in years, as a single value or a range.
 - **Anatomical Site:** Enter or search for an anatomical site.
See [Sequence Variants](#) for more details.
 - **Hospital Acquired Concern:** Select one or more values for Hospital Acquired status of the Concern/Diagnosis.
 - **Cancer Grade:** Enter or search for a Grade of diagnosis.
 - **Cancer Stage:** Enter or search for a Stage of diagnosis.
 - **Staging System:** Enter or search for a Staging System of the Stage.
 - **Primary Tumor:** Enter or search for a Primary Tumor value.
 - **Node Extension:** Enter or search for a Node Extension value.
 - **Metastasis:** Enter or search for a Metastasis value.
 - **Clinical Encounter:** In the section Clinical Encounter, search for clinical encounter by specifying search criteria for:
 - **Visit ID:** Enter or search for a Visit ID (Encounter Number). In the Select Visit ID dialog, select a condition for Visit ID to search for Visit IDs.
 - **Encounter Type:** Enter or search for an Encounter Type. In the Select Encounter Type dialog, select a condition for Encounter Type Name, Encounter Type Code, Code System ID or Code System Name to search for Encounter Types.
 - **Data Source:** Enter or search for a source of data.

 Note:

To define search criteria for Diagnosis, the criteria must include at least one of the following attributes: Concern Subtype, Diagnosis, Diagnosis Severity, Diagnosis Status, Anatomical Site, or Hospital Acquired Concern.

4. Under **Insert as** select either:
 - **Inclusion** to include the criteria in the query
 - **Exclusion** to exclude the criteria from the query
5. Click **Submit**.
Back to "[Build a cohort query](#)".
6. A Diagnosis search criteria can be linked to search criteria for Test or Observation, Procedure, Medication and Specimen to define advanced search criteria like "Diagnosis D1 with Test or Observation T1, with Procedure P1, with Medication M1, with Specimen S1" which allows searching for Patients who have:
 - Diagnosis D1 and Test or Observation T1 in association/linked to Diagnosis D1 and
 - Diagnosis D1 and Procedure P1 in association/linked to Diagnosis D1 and
 - Diagnosis D1 and Medication M1 in association/linked to Diagnosis D1 and
 - Diagnosis D1 and Specimen P1 in association/linked to Diagnosis D1

In the above example the criteria D1, T1, P1 and M1 can be defined using multiple values of the selected data (for example: Diagnosis DA1 or DA2 or DA2...; Procedure PR1 or PR2 or PR3... and so on) and the criteria can include all of the attributes available for defining the search on a particular data (for example: Diagnosis, Diagnosis Status, Onset Date, Cancer Grade and so on)

To define a criteria linked to Diagnosis search criteria:

- a. Define a criteria on Diagnosis via Clinical Data category Diagnosis dialog and Submit.
- b. On the query builder page, where the query criteria is displayed under the



sections Inclusions and Exclusion, click the **Link** icon () displayed next to the Diagnosis search criteria. This action brings up the popup menu for selecting the clinical data for which search criteria is to be defined and linked to the Diagnosis search criteria. The menu has options to select the following clinical data: Procedure, Medication, Test or Observation, and Specimen.

- c. Click on the popup menu to select a clinical data. This action brings up the search dialog for the clinical data, which is similar to the search dialog invoked via Clinical Data menu on the left side of the screen. To indicate that this search dialog when submitted would create a linked criteria, a label 'Add Linked <clinical event>', for example 'Add Linked Procedure' is displayed in the search dialog.
- d. Define the search criteria for the selected clinical data and submit the search dialog for the clinical data. This action adds the search criteria for the linked clinical data to the query builder screen where the newly added criteria is

displayed below the diagnosis search criteria and linked to it via the label 'WITH'.

For information on defining search criteria for a clinical data see section Clinical Data under Build a Cohort Query in this document.

- e. Similarly linked search criteria can be defined for the other clinical events.

A criteria defined using the Diagnosis dialog can be linked to criteria for Procedure, Medication, Test or Observation and Specimen to create a single set of linked criteria. Such linked set can be ANDed to any other criteria including another Diagnosis based linked set(s) or standalone criteria defined using any of the clinical or genomic data, for example:

Diagnosis (DA1 or DA2 or DA3...) OR (DB1 or DB2 or DB3...)

- WITH Procedure P1 or P2 or P3...
- WITH Medication M1 or M2 or M3...
- WITH Test or Observation T1 or T2 or T3...
- WITH Specimen S1 or S2 or S3...

AND

Diagnosis (DA2 or DA3 or DA4...) OR (DB2 or DB3 or DB4...)

- WITH Procedure P3 or P4 or P5...
- WITH Medication M3 or M4 or M5...
- WITH Test or Observation T3 or T4 or T5...
- WITH Specimen S1 or S2 or S3...

AND

Diagnosis D7 or D8 or D9...

AND

To define a criteria linked to Specimen search criteria:

 9. Under **Insert as** select either:
 - **Inclusion** to include the criteria in the query.
 - **Exclusion** to exclude the criteria from the query.

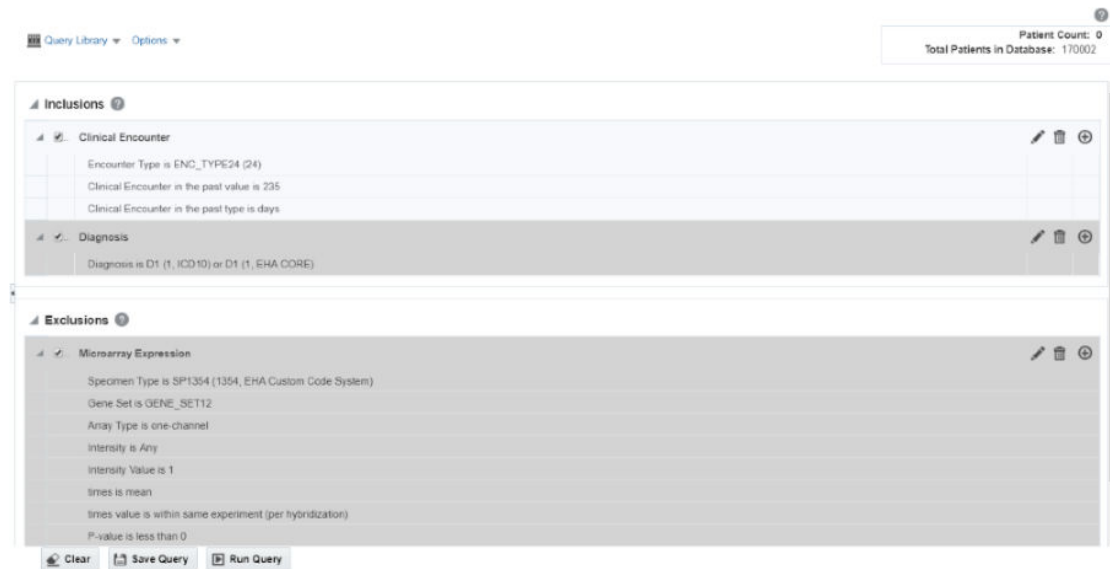

View Specimen Count

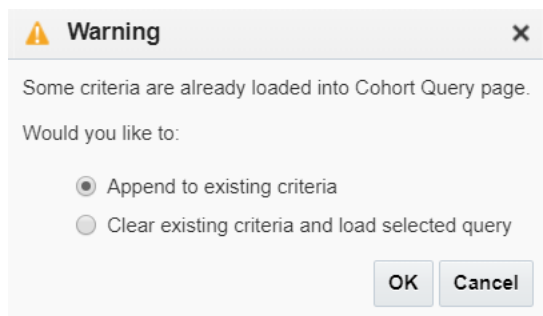

View cohort lists

1. On the Home page, on the left, click the **Cohort Viewer** icon (.
2. On the left side, in the **Patients** section, choose your option:
 - **active query**: to view the cohort list for a patient or subject query that is currently running
 - **library query**: to view the cohort list for a patient or subject query from the library
 - **list**: to view the cohort list for a saved patient or subject list
 - **ad-hoc query**: to view lists for specific patients or subjects you want to examine
3. Click **Submit**.

Use the Data pane on the left to select and filter the data you want to view for the cohort list. For details on filtering data, see [Filter data in cohort lists](#).

After running the query, the patient or subject count is displayed above the table, and you can review the data of those patients or subjects.



Note:

Filter data in cohort lists

1. On the left, below the **Patients** section, click **Data**.
2. Select or deselect any of the information that you want included in the cohort lists.
3. Either click the radio button for **Include criteria used in a query** or set your custom criteria.

 Note:

The **Include criteria used in a query** can only be used for active queries.

This option filters clinical records in cohort lists and cohort timelines on the basis of a specific set of attributes from the Cohort Query screen as listed below.

- **Diagnosis:** Concern Subtype, Diagnosis Code, Anatomical Site
- **Consent:** Consent Type
- **Procedure:** Procedure Type, Procedure Code, Procedure Outcome, Anatomical Site
- **Appointment:** Appointment Number, Facility, Service Provider
- **Medication:** Medication Code, Medication Outcome
- **Patient History:** History Code
- **Test or Observation:** Test or Observation Subtype, Test or Observation Code, Anatomical Site, Medication
- **Specimen:** Specimen Type, Specimen Number, Specimen Vendor Number, Anatomical Site

If the inclusion criteria of the active query is not based on any data topics supported in the cohort lists, a message is displayed to select at least one of the supported data elements.

In the Cohort Viewer, criteria defined on any particular data (such as Diagnosis, Procedure etc.) using the OR option should be sufficient for filtering the clinical records in Cohort List. For example, if the Cohort Query criteria is "Diagnosis Code = D1 OR Diagnosis Anatomical Site Code = A1", then the Cohort Query will correctly fetch all the patients who have Diagnosis Code = D1 or any diagnosis associated with the anatomical site A1. However, selecting the Include Criteria Used in the Query checkbox will filter clinical records on the Cohort List such that only the Diagnosis records having Diagnosis Code = D1 AND Anatomical Site = A1 are displayed.

To set custom criteria:

- Select the criteria.
 - Enter the criteria or click the search icon ().
 - In the new window, enter all required details and click **Search**.
 - Select the elements that you want to use from the left side and move them to the right side using the arrow ().
 - Click **Submit**.
4. Click **Submit**.

To remove data, clear the appropriate boxes and click **Submit** again.

To export the list to a Microsoft Excel sheet, click **Export** ( **Export**), along the top of the table. Keep in mind that additional information, such as address and email are only visible in the exported XLS file.

To save a cohort list, click the **Save** button ( **Save Cohort List**). You can rename the list, or save it under an existing name. All cohort lists are saved as **Private**.

To switch between Demographic and Events data, use these buttons above the table:

Display procedure associated with medication

In the Cohort Viewer screen, Events tab, for the Medication records the column Relevant Data displays the Procedure in context of which the Medication was prescribed.

Display anatomical site details

In the Cohort Viewer screen, Events tab the column Anatomical Site displays the Anatomical Site associated with Diagnosis, Test or Observation, Procedure and Specimen records.

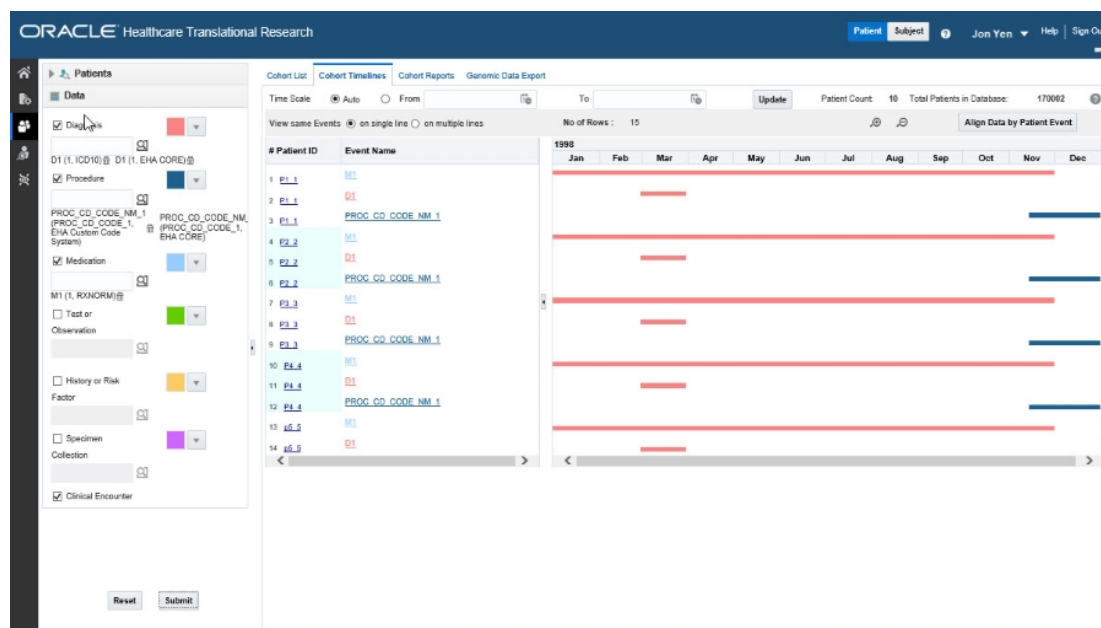
Display specimen details

In the Cohort Viewer screen, Events tab:

- For the Test or Observation records, the column Specimen Details displays the details of the Specimen associated with the Test or Observation.
- For the Specimen records, the column Specimen Details displays the identifier attributes associated with the specimen.

Select patients or subjects

This step is similar to how you select patients or subjects for the **Cohort List**.

1. Along the top, click the **Cohort Timelines** tab.
2. On the left, expand **Patients** or **Subjects** to select the source of your patients' or subjects' IDs from an active query, library query, list or ad-hoc query.
3. Click **Make initial pool**.

All patients or subjects from the selected query are added to the initial pool.

4. Select up to 20 patients or subjects and click the arrow () to move them from the initial pool to the display list.

The data displayed in the cohort timeline is of these 20 patients or subjects.

**WARNING:**

Don't click Submit yet! Wait until the next section.

Filter data in cohort timelines

1. On the left, click the **Data** section.
2. Change the colors of the data criteria, if needed.
3. Either click the radio button for **Include criteria used in a query** or set your custom criteria.

**Note:**

The **Include criteria used in a query** can only be used for active queries.

This option filters clinical records in cohort lists and cohort timelines only on the basis of the primary coded attributes from the Cohort Query screen. For example, it only uses Diagnosis Codes, Procedure Codes or Medication codes.

If the inclusion criteria of the active query is not based on any data topics supported in the cohort lists, a message is displayed to select at least one supported data element.

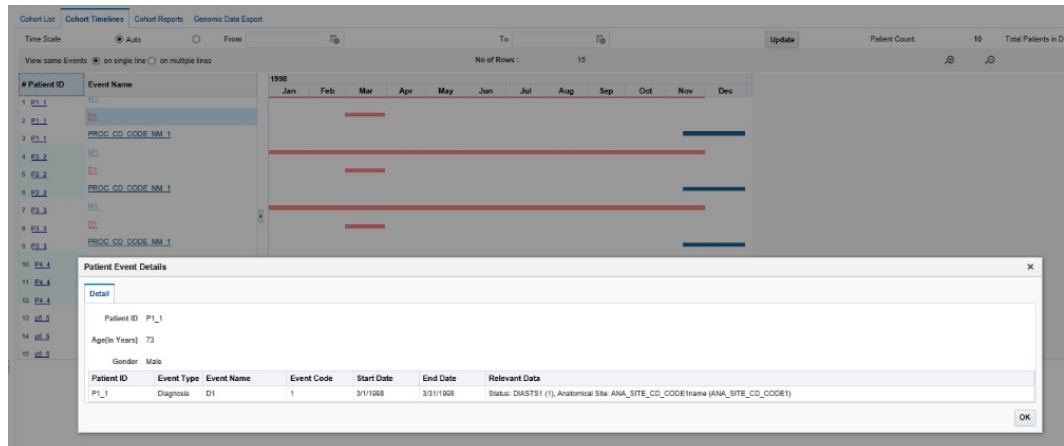
To set custom criteria:

- a. Select the criteria.
 - b. Click the search icon (.
 - c. In the newly opened window, enter all required details and click **Search**.

Display patient or subject data

The subject and patient data display is divided into two sections.

- The left side has attributes about the selected patients/ subjects: **Patient/ Subject ID** and **Event Name**.
- To see demographic data for a Patient or Subject, hover over their ID.
- The right side shows the colored layers of the selected clinical data, in a timeline view.
- To see more details of a patient or subject and their medical records, click on an **Event** link from the left side table. A pop-up appears with more data on the event.

- To navigate to the Single Patient Viewer, and see details of a specific subject or patient, click the Subject or Patient ID.
- To view data for a specific date range, along the top, use the **Time Scale** options:
 - To view data for certain date range, enter the **From** and **To** dates and click **Update**.
 - To view data without a specific time reference, select the **Auto** option.
- For plotting the Observation events, Observation Effective Start Date and Observation Effective End Date are used as the preferred dates. If these dates are not available then Observation Date is used. The following decision table is used for determining the Start Date and End Date for plotting the Observation event on the chart:

Select the Timeline Mode

To view events in different ways, go to **View same Events** along the top and select one of the radio buttons:

On single line

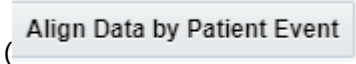
This is the default mode of displaying data in a timeline.

In this mode, all instances of a repeating event are displayed on the same line and separate events are displayed on separate lines.

On multiple lines

In this mode, all of instances of events are displayed on different lines, even if the events are repeating.

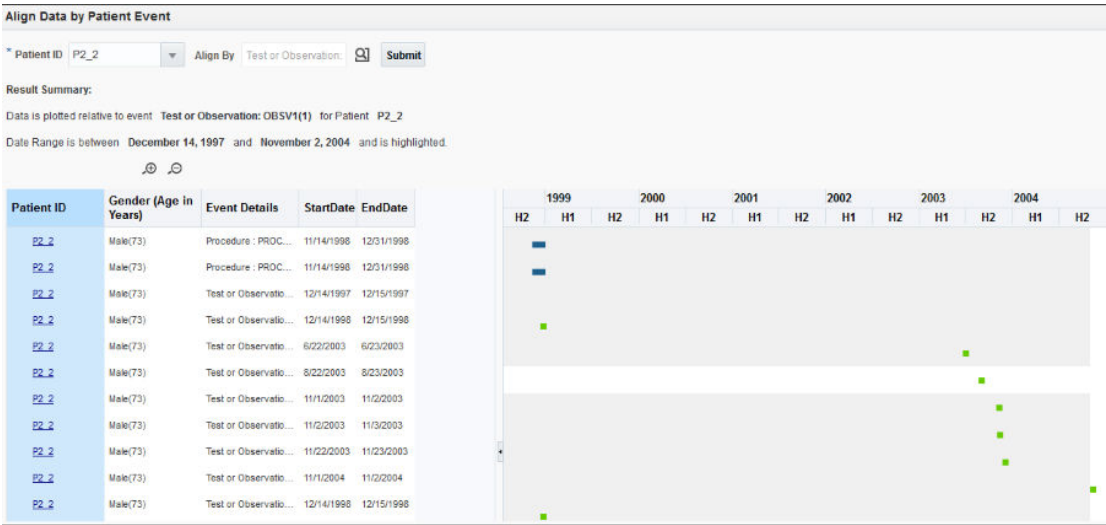

View cohort reports

The **Cohort Reports** tab lets you view various cohort reports.

 Note:

In the Active Query mode, if no filters have been selected in Cohort Query, then the reports display data for only the first 10,000 patients or subjects. This limit is configurable and can be changed using the `DEFAULT_ACTIVE_QUERY_LIMIT` property in the `TRC.properties` file.

However, irrespective of the patient or subject selection option, if the count exceeds the value specified in `GENOMIC.REPORTS_MAX_PATIENT_COUNT` of `TRC.properties` file, a warning message is displayed. You can either continue to plot with a large number of patients or subjects (might impact performance) or change the selected cohort to a smaller number.

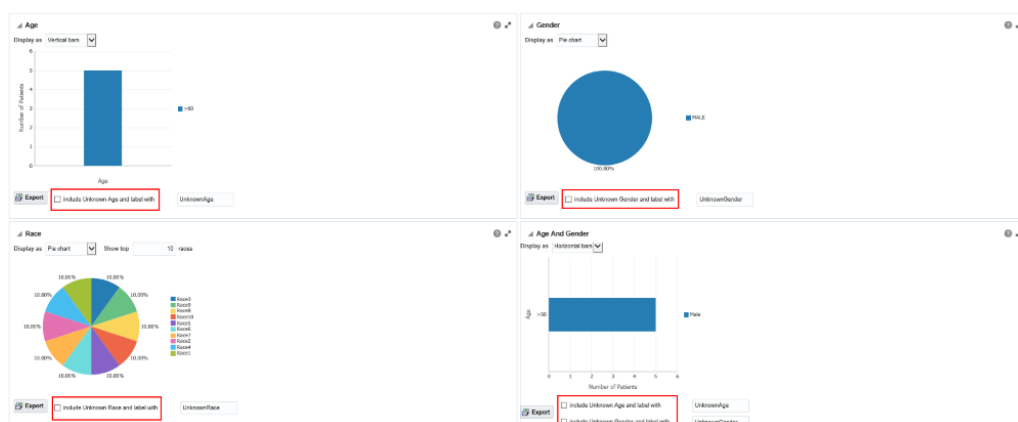

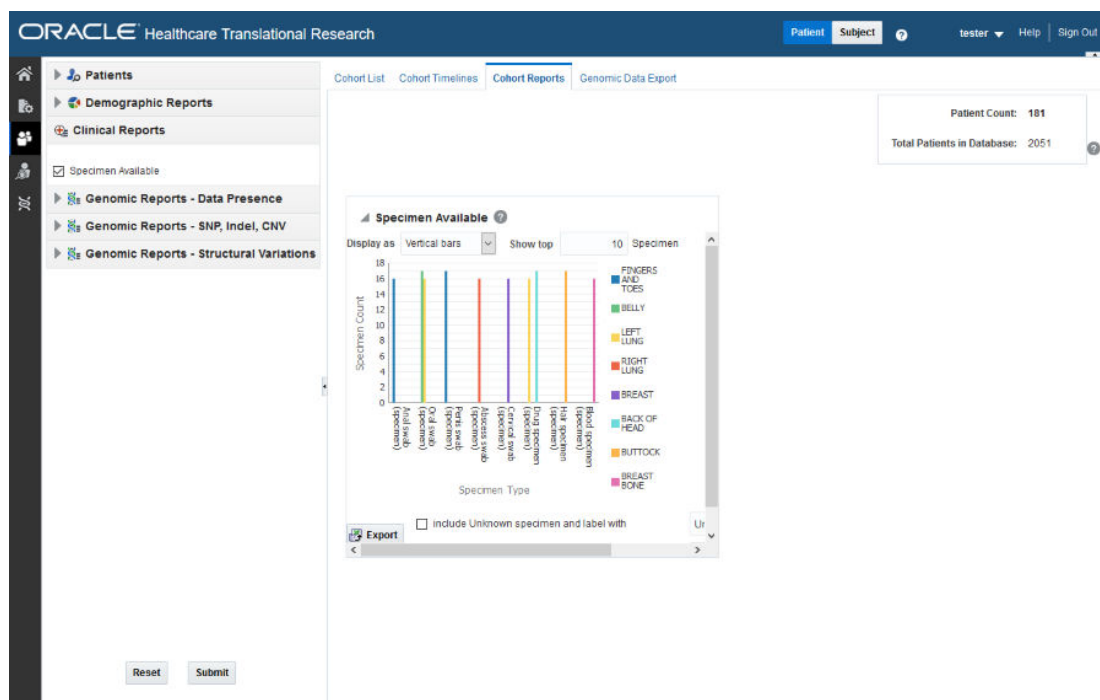

1. Along the top, click the **Cohort Reports** tab.
2. On the left, click the **Patients** or **Subjects** section, and select a source for your reports, if needed.

Note:

There is no upper limit on the number of patients or subjects to be selected, however the performance slows down as more and more patients are selected.

3. Click **Genomic Reports - Data Presence**.
4. Select the **Genomic Data Presence** check box.

An optional **Specimen Type** input field appears to allow for filtering the initial cohort on specimen type.

5. Click **Submit**.

Tip:

To change the display type after generating the report, select the display option from the **Display as drop-down** list.

To view a breakup of present genomic data by data type, click **View distribution of genomic data**.

Figure 3-8 A Genomic Data Presence report in Oracle Healthcare Translational Research

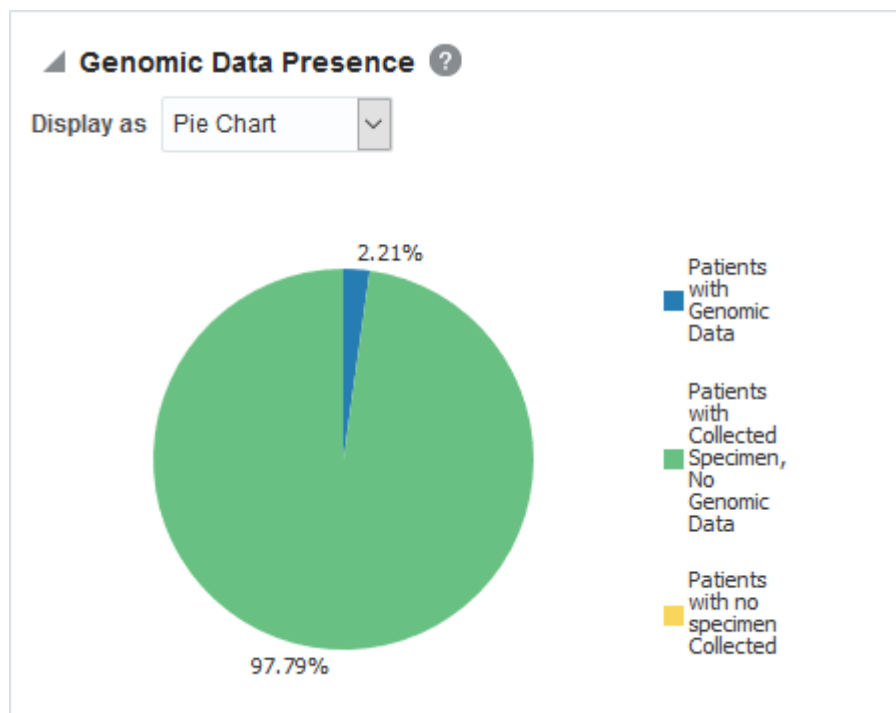
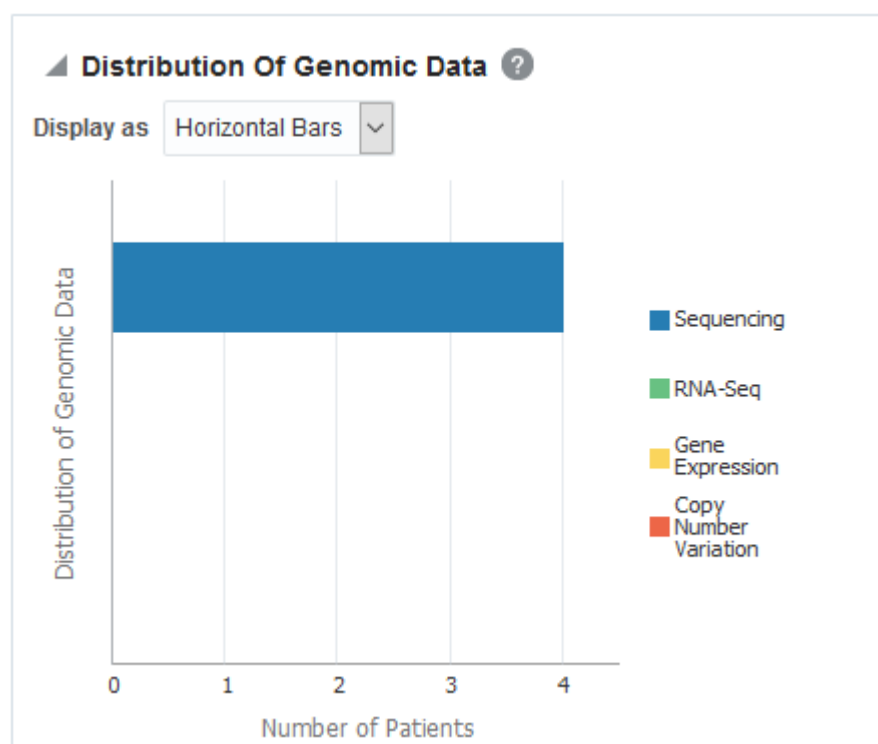


Figure 3-9 Distribution of Genomic Data in Oracle Healthcare Translational Research

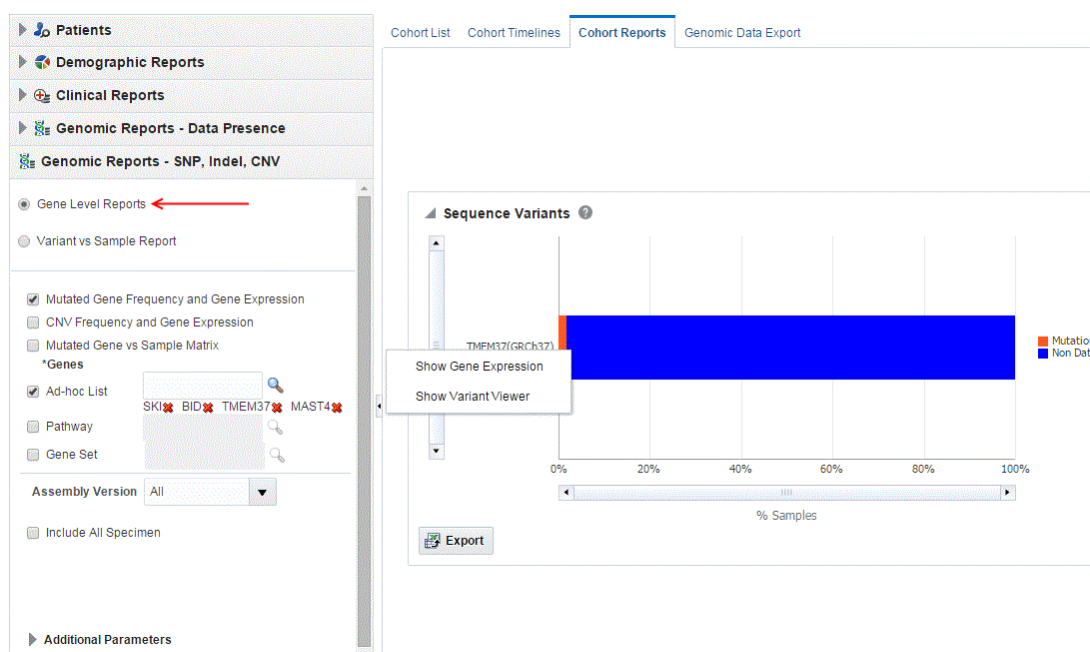

5. Select **Mutated Gene Frequency and Gene Expression**.
Selecting **Include All Specimens** includes specimens without genomic data. Not selecting this option generates results with genomic data only.
6. Enter or search for at least one gene using one of the three search fields: Ad-hoc List, Pathway or Gene Set.
7. Expand the **Additional Parameters** section to add a Specimen Type or an Anatomical Site.
8. Click **Submit**.

You can display the results as horizontal bars, vertical bars, or as a table. To export the bar results into PDF or the table results into Excel, click the Export button

( **Export**).

Each bar represents a specimen, which is grouped patient-wise and in the order of the specimen collection date. The Sequence Variants and CNV information for each specimen is displayed. The percentage of specimens with mutation on the gene is also mentioned. Export functionality is provided at each specimen level.

There is a limit to the number of specimens that can be seen in the gene matrix plot. The default value of this parameter is 1000. If the number of specimens in the cohort used for this analysis is greater than the specified value, then the following warning message is displayed:

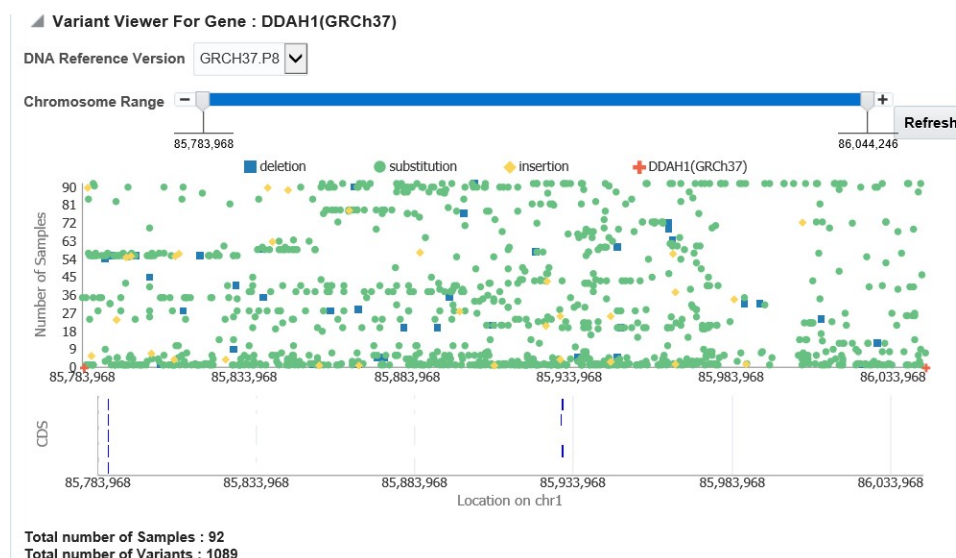
Figure 3-11 Warning message for reaching a limit on specimens

If you continue from this warning message, the report displays the summary statistics instead of the matrix plot. You may have to decrease the cohort size based on some criteria like specimen type or anatomical site or otherwise use cohort query to view the matrix plot. Alternatively, you can also change the default value of MAX_SPEC_REPORT parameter to a desired value and rebuild the plot. However, rebuilding maybe affect the performance of the plot generation.

You can further drill down to the sequencing results by clicking "Show Variant Viewer" in [Figure 3-10](#). This will show data in the form of scatter plot depicting variants on the

chromosome (Figure 3-12). This drilldown also shows all the variants in tabular format with reference information below the plot.

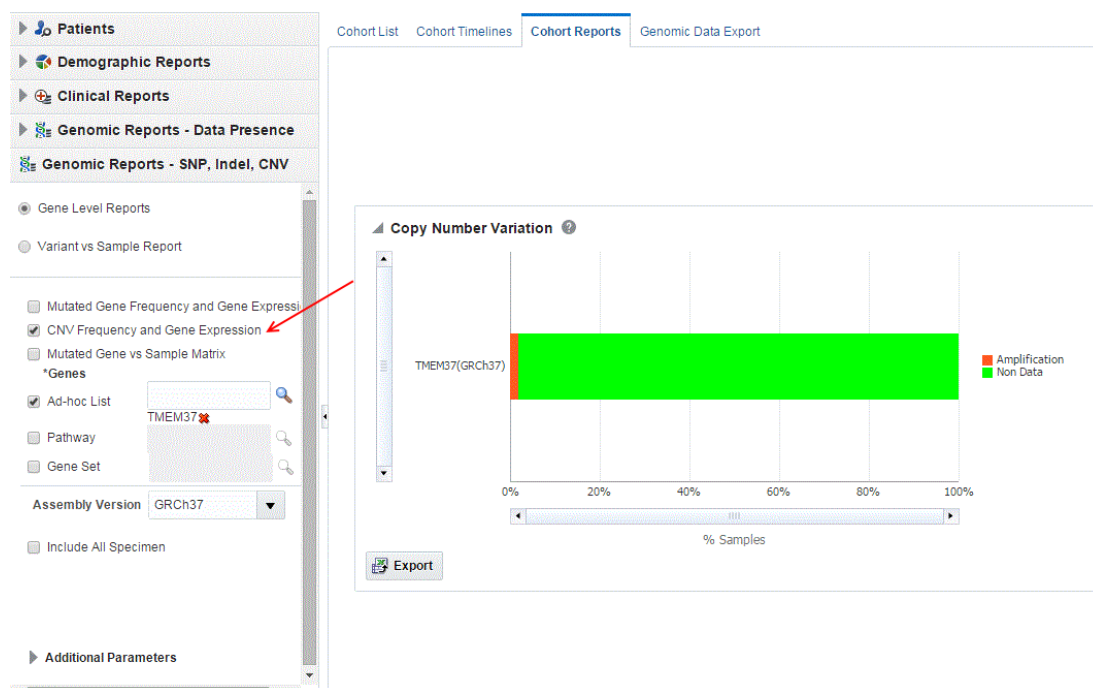

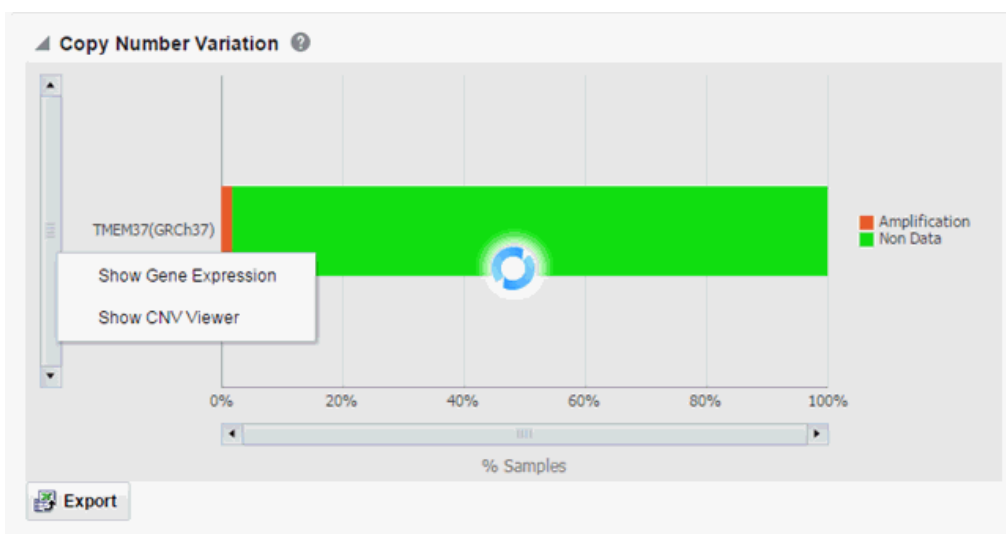

To export the bar results into or table results into Excel by clicking **Export** ( **Export**). Select **Show Gene Expression** to display the Gene Expression details for **Single Channel** or **Dual Channel**. In the **Single Channel Expression**, you must provide hybridization details. Click **Show CNV Viewer** to display necessary information about all CNV variants that are present in that gene in the samples belonging to the selected cohort of subjects or patients.

Figure 3-16 A Mutated Gene Vs. Sample Matrix Report in OHTR

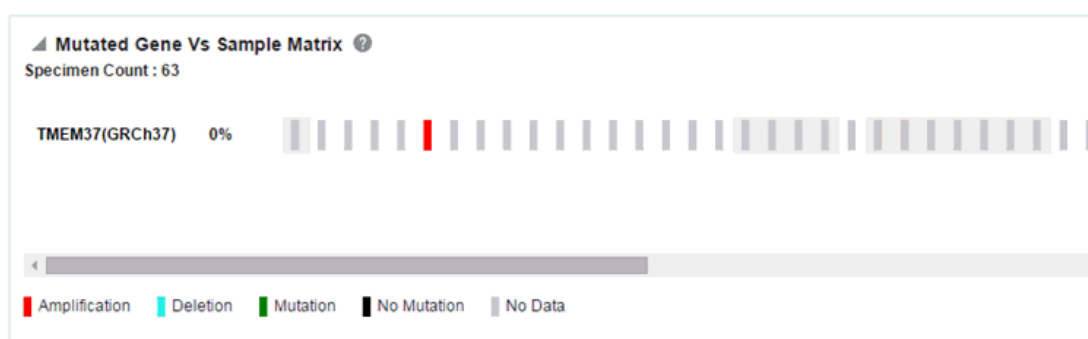


Figure 3-17 A Mutated Gene Vs. Sample Matrix Report ready to be exported

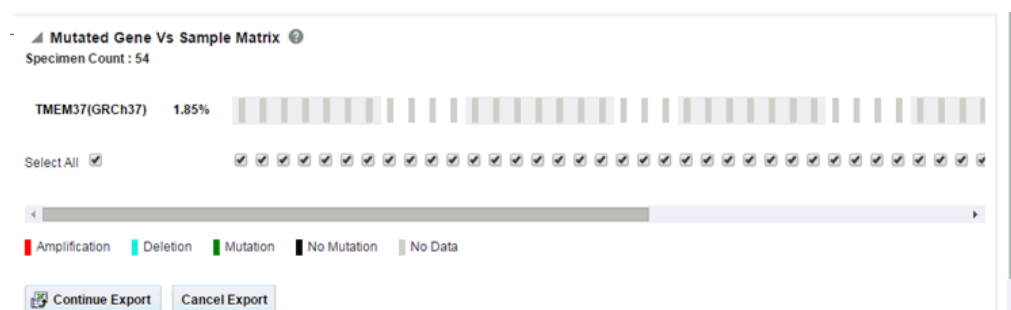
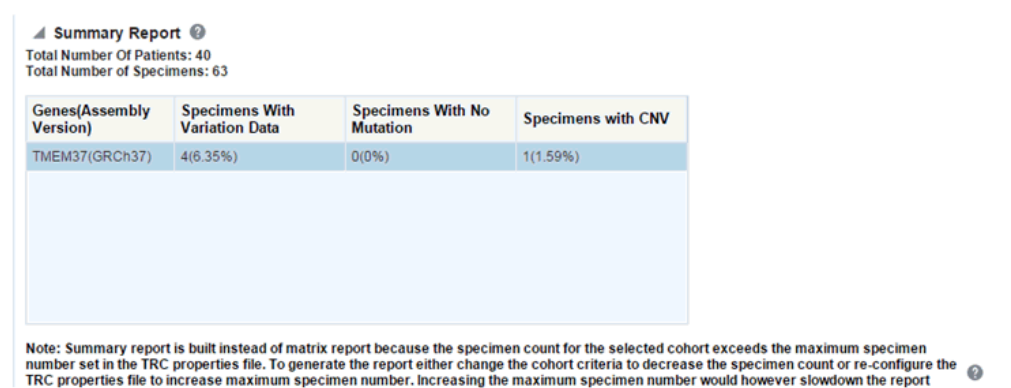


Figure 3-18 A Summary Report for Mutated Gene Vs Sample Matrix Reports

Figure 3-19 A Genomic Variant Vs Sample Report in Oracle Healthcare Translational Research

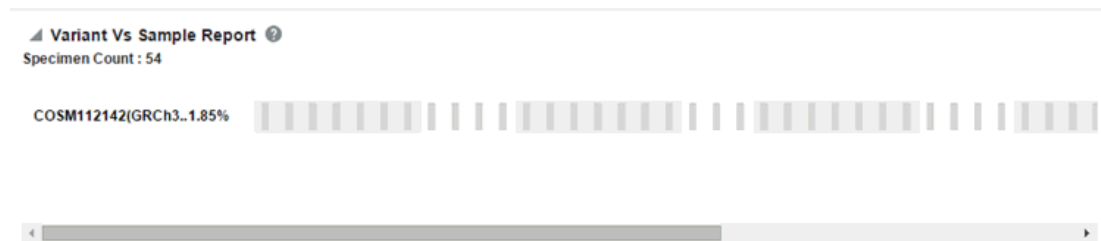
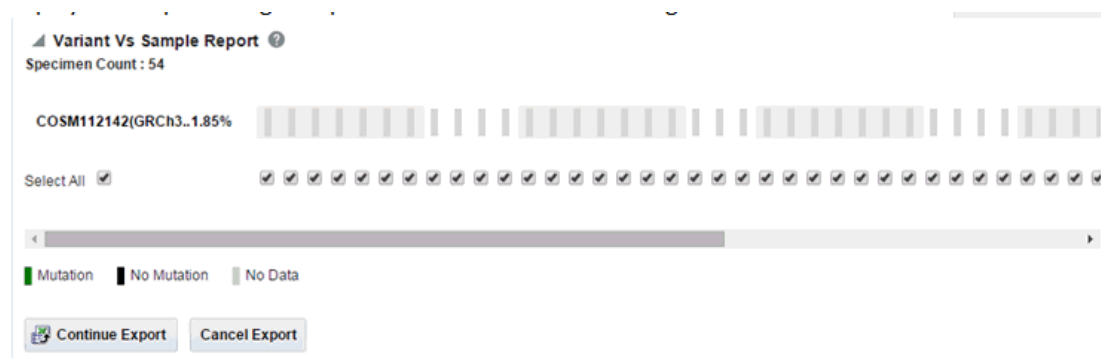


Figure 3-20 A Genomic Variant Vs Sample Report ready to be exported

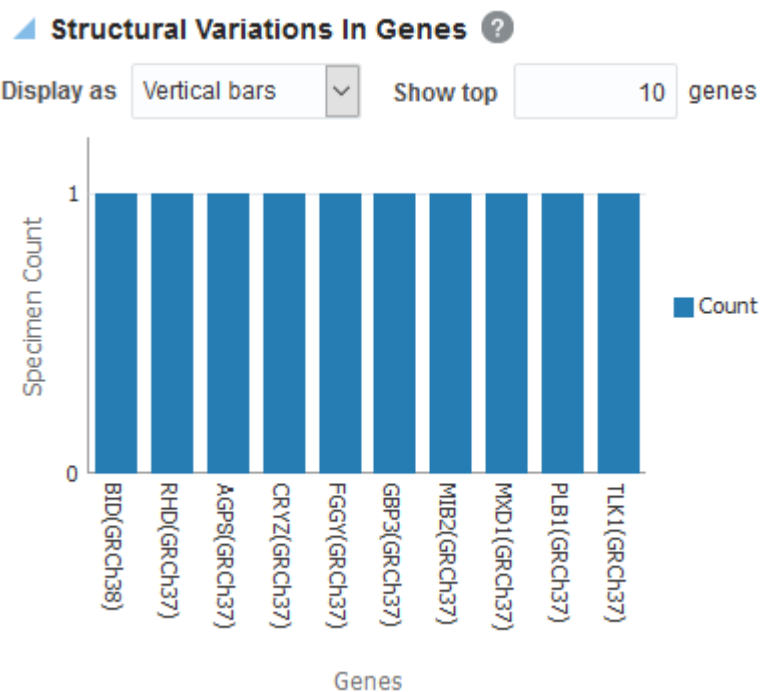

Currently only one version of data can be exported at a time.

To select results:

Set the location

Mutation - VCF

This option exports the sequencing variation data for the selected patients or subjects for either the selected genes, pathway, gene set or for a given chromosome region as selected in the previous option. VCF supports multiple specimens' data in a single file.

1000 Genomes VCF 4.1 conventions are followed while exporting variation data, however certain data types, which are non-standard, like BQ and MQ, may differ in convention for some customers since there is no standard way to represent them.

Handle Non-variant and No-call Data

If NON_VARIANT and (or) NOCALL records exist for any given position, the zygosity is checked to determine if the information format from these tables is used.



Note:

For *het-ref* or *half* zygosity values, these other format fields are compared with the existing SEQUENCING information. This information is then used with zygosity to create the format string.

The NON_VARIANT data allows for GQ, GQX, MQ, BQ and the first reference read count of AD. The NOCALL data allows for all format fields to be compared. Both NON_VARIANT and NOCALL do not support exporting flex fields. The GT value of the format string reflects the stored zygosity as follows:

Zygosity	FORMAT string GT:GQ:GQX:BQ:MQ:AD:DP
het-ref	1/0:99:98:38:45:20:10,10
Half	1/.:99:98:34,34:45,45:20:10,5

If there are no result records for any specimen, the export displays "." with no other information for the format.

Handle Duplicate Genetic Information Exports

There could be cases where users reload genetic information multiple times for the same specimen. This may create ambiguous values for the different fields that exist in the VCF export file. The export code deals with such ambiguous numerical values that represent the quality (that is, GQ, GQX, AD, BQ, MQ). This code now computes minimum values and ensure that the value of least confidence is reported. There could be more complex cases, for instance, if there are 2 different alleles for the same position belonging to the same specimen, or variants with same position for same specimen with different zygosity. The export code uses MIN functions on all values including all the text fields. This allows for VCF export to create a valid file that can be loaded into genome browsers.

Alternatively, you can choose not to consider data from a specific specimen or a specific file using following methods:

- Using DELETE_FLG - A user may load results for a specimen more than once that can completely contradict previous results. Users can set the DELETE_FLG as 'Y' on W_EHA_RSLT_SPECIMEN and (or) W_EHA_SPEC_PATIENT or W_EHA_SPEC_SUBJECT to have previous loads excluded, and then reload the correct result files. When the user now exports the data, only the latest loaded specimen data is considered for export.
- Using FILE_URI - Oracle recommends using this method since you need not reload the data again as opposed to the above method. When there are multiple files loaded with contradicting data for the same specimen, user can set some files as obsolete by changing the W_EHA_FILE_LOAD.FILE_WID column. For example, if you have loaded the same specimen data 3 times and would like to consider the latest file loaded for export, then you must first identify the latest FILE_WID from W_EHA_FILE_LOAD table. Then change the FILE_WID of two old files in W_EHA_FILE_LOAD table to the latest FILE_WID. Now, all the three records belonging to the three file loads contain same FILE_WID, which represents the latest file load and only the latest file export data is exported.

Represent AD Values

Allele depth values represented under the AD data type are in the order of the alleles represented in the GT. Refer to the following table with examples:

ALT	FORMAT	SAMPLE1	--

Copy Number Variation - SEG

The copy number variation data is exported in SEG format. Currently, CNV data from any array based system like Affymetrix Genome Wide SNP 6 array whose data is in SEG format while loading in OHO is supported. The main requirement for exporting CNV data is to have the SEG_MEAN value in the CNV table of OHO.

For exporting data that is not loaded from SEG files, for example, data from CGI CNV files or any other source of CNV data, users have to create their own loader. The loader is expected to calculate the SEG_MEAN value since this value is most important for export.

1. ID: specimen ID of the reported CNV segment
2. chrom: chromosome name
3. loc.start: start position of the CNV segment
4. loc.end: end position of the CNV segment
5. num.mark: for array based CNV data, this stores the number of probes details
6. seg.mean: this stores the segment mean value from SEG_MEAN column in CNV table.

Gene Expression - RES

RES is one of the gene expression formats supported by IGV browser. Currently, only microarray gene expression data is exported to this format. Following data types are imported to RES format:

1. Description: hugo name of a specific probe
2. Accession: probe ID
3. Intensity: intensity value of the associated probe
4. Call: call of the associated probe

Gene Expression Dual Channel - GCT

GCT is one of the gene expression formats supported by IGV browser. Currently, only AgilentG4502A platform microarray gene expression data is exported to this format. Following data types are imported to GCT format:

1. Description: Gene symbol of a specific probe
2. Accession: probe ID
3. Intensity: intensity value of the associated probe
4. Call: call of the associated probe

**Note:**

The GCT file takes its gene symbol for the probe from the 2-channel composite element of ADF file. This is input into the ADF composite table in OHO. This value may not match with HUGO name in certain cases as OHTR associates 2-channel records in the result table that has partial (which includes a flanking region set by the user) genomic coordinate. The coordinate overlaps between composite elements and gene segments in the reference. This may also result in some cases in more than one unique gene in the reference mapping to a gene composite element.

Specify the export options

Export data in three ways:

- **Select the option to download last loaded file(s)**
- **Immediately**, which is the default option
- **Schedule**

After selecting the **Export** option, click **Submit** to finalize the genomic data export. The data is generated and a separate link is provided in the bottom panel for each result type.

About Export Options

The **Immediately** option gives you the file link on the same screen and you can click to download it immediately. The link provided has a specific naming convention: *file_type_OHO_date:MM-DD-YYYY_time:HH24*-MI-SS.file_type_extension*. For example, RES_OHO_09-14-2014_04-26.res. A short description of the file stating data type and advice on the expected count of features is displayed below the created link.

The **Schedule** option runs the process as a job. You can track the status of the job from the **Home, Jobs** tab. This option is best suited for exporting large data sets like **All Data** or whole chromosome variants. For the scheduling option, you must provide a job name and description.

There is a possibility of replicate and duplicate data in the database. This could be due to loading multiple files belonging to the same specimen_number. This can happen if the same library is sequenced multiple times or the data is reanalyzed. For example, the reads were realigned using the new reference version, so new VCF or gVCF files are created for the same sample. In this scenario, you can use the option to export VCF data only from last loaded files. For example, if variation data has been loaded for a specimen in Jan 2015, Mar 2015 and July 2015, then using this option you can export data from the file loaded in July 2015 and it would not consider variants from the file loaded in Jan and Mar 2015.

 Note:

The **Schedule Jobs** option uses an asynchronous approach to store the file in DBFS. As an alternative to downloading the file using the link in the Oracle Healthcare Translational Research page, there are other ways to access DBFS. From a Linux OS, you can mount DBFS using *dbfs_client* application and then browse the directories. Windows OS does not support the FUSE interface and cannot mount DBFS directly. However, there is a *dbfs_client* application for Windows that can execute commands to access DBFS. The Windows version of *dbfs_client* lets you use the command line to execute normal directory commands. You can list the DBFS directories as well as copy data from DBFS to the local drive. The *dbfs_client* application is part of the standard Oracle client software.

View records

To view a patient record:

1. On the Home page, on the left, click the **Single Patient Viewer** icon ().
2. Enter the patient ID.
3. Select the **Source**:
 - **All records** is the default option. This allows you to search through all available patients in the CDM database.
 - **Cohort**
4. Select the clinical and genomic data you want to view for the patient.
5. Click **Submit**.

To sort patient or subject data, either click the phenotype column to reorder them, or enter a value in the blank field, at the top of any column, then hit **Enter**.

In the Diagnosis table, the column Additional Diagnosis Details displays hyperlinked text for coded values of Grade, Stage, Staging System, Primary Tumor, Node Extension and Metastasis associated with the Diagnosis. The tool tip on the text displays the corresponding code names. To see detailed values of these attributes click the hyperlink to display the Diagnosis Details window.

In the Procedure, Test or Observation, Medication and Specimen tables the column Diagnosis Details displays the Diagnosis that is associated with these records.

In the Medications Taken table the column Procedure Data displays the Procedure in context of which the Medication was prescribed.

In the Test or Observation table, use the drop down list 'Additional data to be displayed' to select the columns that should be displayed in the table. Irrespective of the columns selected for display, data from all of the Test or Observation columns is included in the exported data.

In the Diagnosis, Procedure, Medication and Test or Observation tables, the columns Visit ID, Encounter Type Name and Encounter Type Code display the information about the Encounter with which the above clinical events are associated.

To save patient or subject data in an Excel file, click the **Export button** ([Export](#)) next to the category title. You can export either all data or just the selected criteria.

Variants can only be exported separately. To do so, follow these steps below:

1. In the Single Patient Viewer screen, on the left, select the **Variants** checkbox.

2. Click **Submit**. The Variants hierarchy graph is displayed on the right side of the screen.
3. Click on any nodes in the graph to display the tables with Variants data and select it. These tables show 500 records only.
4. Along the top, click **Export** to export the variants. Variants are exported in an XLS file for the selected node.

Display Variant Found

When the user clicks on one of the top 2 level nodes (Variants, Coding, Non-Coding , Unknown)

- If the count of variants is less than a threshold value, then the variant table is displayed.
- If the count is greater, then a message is displayed to select any lower-level node.

Click on the text on the individual nodes to display the table with the variants for the node.



Note:

If there are child nodes, clicking on the + sign will expand the node and display child nodes. However, if there are no child nodes, the graphs will disappear. The user must refresh the page to display the graphs again.

Export Variant Found

While exporting the variants found, if the count of variants is higher than threshold value, user will be to choose a chromosome from drop down list to narrow down the variants.



Note:

If the number of variants that you want to export exceeds the limit of 50000, contact your database administrator. The limit can be modified within the database. For more details, see the *Oracle Healthcare Translational Research Administrator's Guide* on the Oracle Help Center.

Navigate through selected patients or subjects

To navigate through patients' or subjects' data in the **Single Patient Viewer**, keep in mind three things:

1. If the selected patient ID generates a patient or subject count larger than 1, you can navigate through patients' or subjects' history using the **Previous** and **Next** buttons found next to the **Patient ID** field, on the left. This is also available for patient or subject counts generated in the Cohort Query or Cohort Viewer screens.
2. Every patient has an ordinal number (his position within the selection) listed under the **Patient** field. If the selected source is a cohort, then the total number of available patients or subjects from that cohort is also displayed.
3. If you went from the Cohort Timeline screen to the Single Patient Viewer screen, then the total number of available patients or subjects in the cohort is the count of patients or subjects selected in the initial pool, in the cohort timeline.

Selecting this option displays different variants available for a patient. These variants are grouped and displayed in a hierarchical structure with the count of the variants displayed for each type of variants.

Variants can only be exported after they've been submitted.

Select the Assembly Version

By default, the last loaded assembly is displayed but this selection can be modified. The Genomic data is filtered out with this assembly version instead of the DNA reference version. One Assembly version can belong to multiple DNA reference versions.

View circular genomic data

1. On the left, click the **Circular Genomic Viewer** tab. Select a **Patient ID** or **Subject ID**. If an ID is selected in the **View Record** tab, it's inherited in the **Circular Genomic Viewer** tab.

2. To filter your view, you can select a **Specimen Type** or an **Anatomical Site**. The DNA Reference Version selected is used to filter out the results and determine the cytoband to be used while rendering the circular genomic plot for any of the five data types.
3. Select an **Assembly Version**.
4. Click **Submit**.
5. Select only one specimen of different result types to plot the graph. By default, the cytoband of chromosomes is also plotted which is the outer most ring of the circular plot.
6. Click **Plot Graph**.

 Note:

For the circular viewer to run properly in IE9, turn off compatibility mode.

About the Circular Genomic Viewer

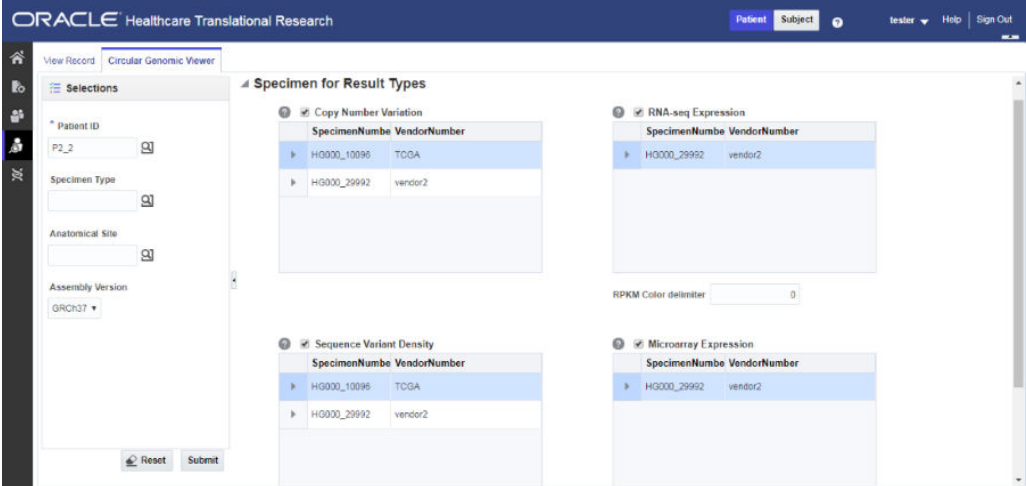
Circular genomic data viewer provides an interface for you to visualize the genomic data which includes variation, micro array expression, copy number variation, dual channel expression and RNA sequencing. The system uses the VisQuick tool, which is a Javascript library built specifically for genomic data visualization.

Microarray Expression

The microarray expression panel displays all the specimens of the result type expression. You can select only one specimen at a time.

For the selected specimen from the panel, you can view the list of hybridizations available for that specimen. You can select a maximum of two hybridizations from the multiple choice box, for which the plot is rendered.

The color delimiter value is used to render color to the data points in the plot based on the intensity value. If the intensity value is above the value defined in color delimiter then the data points have green color. Otherwise, the points have red color.

Sequencing-Variant Density

This option enables you to plot the density of variants for every 100-kb region for a specimen. The sequence variant density panel displays all the specimens of the result type sequence variants. You can select only one specimen at a time.

RNA-Seq Expression

This panel displays all the specimens of result type RNA Sequencing. Each level of normalization like Gene, Exon and Transcript appears as separate panel. You can select one specimen from each normalization level to view the plot. You also need to select a normalization metrics as RPKM, TPM, FPKM, or FPKM_UQ.

The color delimiter value is used to render color to the data points in the plot based on the normalization metrics value. For example, if the RPKM value is above the value defined in color delimiter then the data points have green color. Otherwise, the points have red color.

You can use the check boxes provided next to each of the result types to determine if the specimen selected is plotted or not. You can select one or all of the result types for plotting of the graph. Once the specimens are selected, the circular genomic plot is displayed. The outermost circle in the plot is the Cytoband. The supported Cytoband versions are: hg-18 and hg-19.



Note:

To display the cytoband in the Circular Genomic plot we need an entry mapping each DNA Reference Version to the Cytoband in the TRC_LOOKUP_CODE table in the APP_schema.

For each reference version we must insert a row with the following values:

- CODE_TYPE: TRC_REFVERSION_CYTOBAND
- CODE: cytobandHG19 (for HG19), cytobandHG18 (for HG18), or cytobandHG38 (for HG38)

- **CODE_NAME:** Name of the loaded DNA reference version (for example, V69)

You can hover over the plot to get details such as:

- **Microarray Expression:** Chromosome, Start Position, End Position, Value and Gene
- **Copy Number Variation:** Chromosome, Start Position, End Position and Value
- **Sequence Variants:** Chromosome, start position, end position, and value. The density value is calculated by: Total number of variants for 100kb region / 100000
- **Dual Channel Microarray Expression:** Chromosome, Start Position, End Position, Value and Gene
- **Rna Seq Expression:** Chromosome, Start Position, End Position, Value and Gene

Copy Number Variation

The panel displays all the specimens of the result type copy number variation. You can select only one specimen at a time.

The value for copy number variation depends on the CNV result type selected. If the selected specimen contains data from Genome_Wide_SNP_6 array, then the value for CNV is taken from segment mean stored in the database. If the selected specimen has data from complete genomics, then the value is calculated based on the called Ploidy value stored in the database. The value to be plotted is calculated using the following formula for CNV data from complete genomics:

$$\log_2(\text{called_ploidy}/\text{expected_ploidy})$$

where,

expected_ploidy is 2 for chr1-22

expected_ploidy is 2 for chrX for females.

expected_ploidy is 1 for chrX outside the pseudo-autosomal region in males

expected_ploidy is 2 for chrX inside pseudo-autosomal region in males

The pseudo autosomal regions on chrX for 'NCBI build 37' as reported by Complete Genomic are 60000 - 2,699,519 and 154,931,043 - 155,260,559.

The pseudo autosomal regions on chrX for 'NCBI build 36' as reported by Complete Genomic are 0 - 2,709,519 and 154,584,237 - 154,913,753.

For called_ploidy zero, the log2 should be infinity, in which cases the final value is taken as -2.

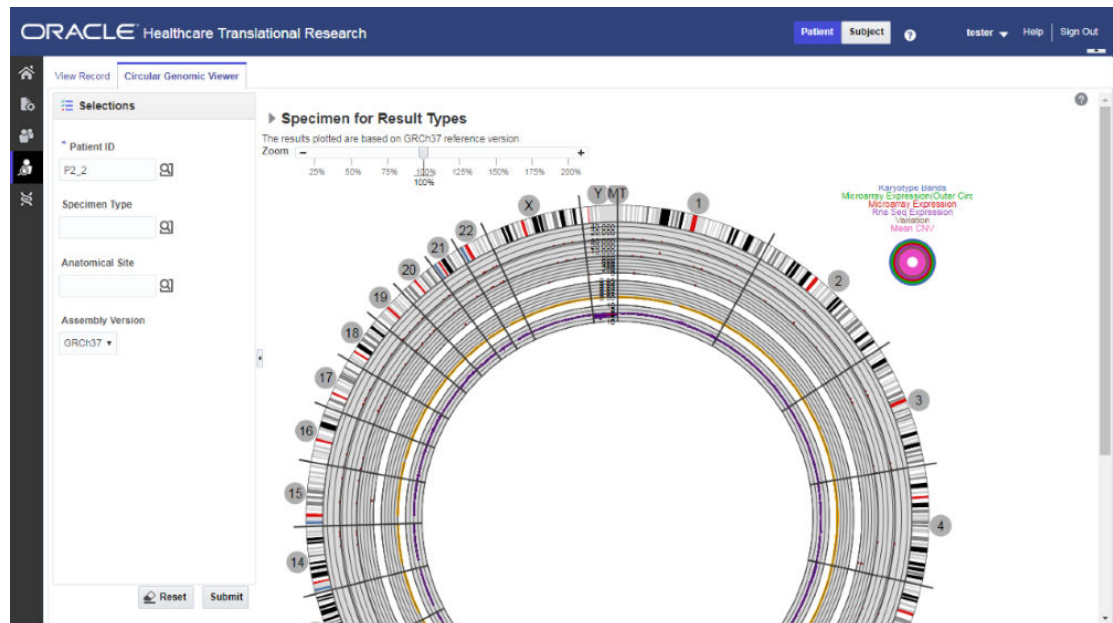
Dual Channel Microarray Expression

This panel displays all the specimens of result type Dual Channel Microarray expression. You can select only one specimen at a time.

The color delimiter value is used to render color to the data points in the plot based on the Log2Ratio value. If the Log2Ratio value is above the value defined in color delimiter, then the data points have green color. Otherwise, the points have red color.

The results are displayed on the right. You can see the following:

- **Result Summary:** displays how many genes were searched for, how many have results found and how many do not have any results present in OHO for the criteria selected, what types of results are found.
- **Result Details:** tabular list of metadata for each gene that is found to have genomic results in OHO.

To print the results, click **Print**.

To export the resulting table to a spreadsheet, click **Export**.

Click the **Number of Patients** column to navigate to different screens such as:

- View Record
- Circular Genomic Viewer
- Cohort List
- Cohort Timelines
- Cohort Reports
- Genomic Data Export

**Note:**

If the pathway, gene set or genes are selected from the ad-hoc genes selection, the result details table is paginated based on gene selection. Each page displays the result for a 25 genes selection.

Search for variants

You can specify one or more variant identifiers to be searched across results in Oracle Healthcare Omics (OHO).

1. In the upper left corner, click the **Variant Search** tab.
2. Either load a recently used query by clicking **Load Recent Query** or search for the variant by:
 - a. Variant ID
 - b. Variant Attributes:
 - **Variant status:** select one or all options (**All**, **Novel** and **Known**)
 - **Variant type:** select one or all options (**All**, **Complex**, **Indel**, **Substitution**, **Insertion**, and **Deletion**).

3. Enter the **Species** and **Assembly Version**.

4. Click **Submit**.

The results are displayed on the right. You can see the following:

- **Result Summary:** displays how many variants were searched for, how many have results found and, if applicable, how many do not have any results present in Oracle Healthcare Genomics for the selected criteria, what types of result files are found for the variants, if any.

- **Result Details:** displays a tabular list of metadata for each variant that is found to have genomic results in Oracle Healthcare Genomics. The columns list includes options such as:

Perform a search by Variant ID

1. Either use a recent query by clicking **Load Recent Query** or search for a variant **by Variant ID**.

Tip:

You can specify Genomic Position by typing in chr#:from-to location.

Example: to find variants in base pair region 1-200 on chromosome 7, you would need to type in the chr7:1-200. If you want to search for any variants on chromosome 7, you can enter chr7.

Additional options that can be specified include known or novel status on the variant, variant type such as insertion, deletion, substitutions, indel, complex. The strand is the directionality of the variant and it can be either plus (+) or minus (-).

2. Select the **Species**.
3. If in **Subject** context, enter a **Study** or search for one.
4. Select the **Assembly Version**.
5. Click **Submit**.

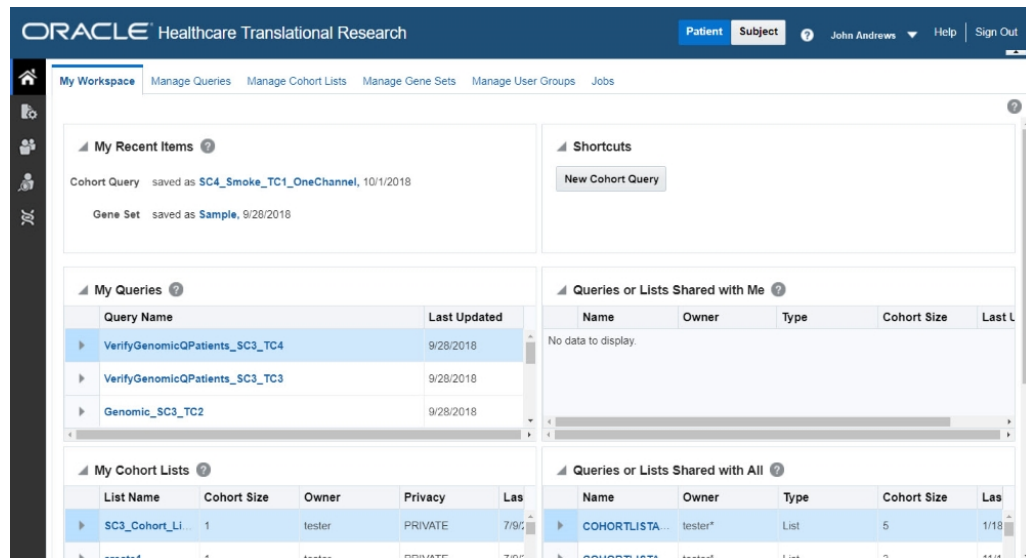

Search and view your cohort lists

You can only search for cohort lists that you have access to.

1. On the **Home page**, click the **Manage Cohort Lists** tab.

Modify cohort lists

Manage gene sets

What are gene sets and what can I do in here? Gene set refers to groups or lists of genes. This set can consist of a couple of genes or hundreds of genes. This allows you to group genes into convenient *collections* for reuse. You can group a few genes for quick search retrieval or for use in a cohort query. In this tab, you can create, edit, and manage gene sets.

A few things to keep in mind about gene sets in Oracle Healthcare Translational Research:

- There are no restrictions on genes that can be included in a gene set. You can mix genes from multiple species or assembly versions.
- The same gene can be part of many different gene sets.
- Gene sets are private and cannot be shared among users.
- Gene set names are not case-sensitive.
- When genes are compared using the **Contains** or **Starts With** option, the limit is 512 characters.

Create a new gene set

1. Along the top, click **Manage Gene Sets** and go to the **Create New or Edit** section.
2. Specify the genes you want to include in the gene set. This can be done in three ways:
 - **Type in Gene Names** - Search for genes using their Ensembl or HUGO names. You can enter multiple gene names separated by space, comma or semicolon.
 - **Add from existing gene set** - Search for genes based on an existing gene set.
 - **Upload from a file** - Select a text file (CSV, TSV, TXT) from your computer where the genes are delimited by comma, space or tab. Click **Choose File** to browse for the file.

 Note:

The file size limit is less than 5MB when genes are matched using Equals.

3. Select a value for **Species**.
4. Select an **Assembly Version**.
5. Click **Submit**. The matching genes appear in the Available Genes pane.

6. Use the arrow () to move available genes to the Final Gene Set panel.

Use the double arrow () to move all available genes to the Final Gene Set panel.

To remove genes from the Final Gene Set panel, use the **Remove** or **Remove All** buttons.
7. In the **Save Gene Set** section, enter the name and description of the gene set.
8. Click **Submit**.

Edit a gene set

To edit a gene set:

1. Along the top, click the **Manage Gene Sets** tab, and go to the **Create New or Edit** section.
2. Search for the gene set you want to edit using the **Add from existing Gene Set** option.
3. Select a value for **Species**.
4. Select an **Assembly Version**.
5. Click **Submit**. The gene set appears in the Available Genes pane.
6. Use the arrow() to move available genes to the Final Gene Set panel.

Use the double arrow () to move all available genes to the Final Gene Set panel.

To remove genes, use the **Remove** or **Remove All** buttons.
7. Click **Submit**.



Note:

When you search genes using the **Contains** or **Starts With** option, the limit is **512** characters

Manage a gene set

To manage a gene set:

1. Click the **Manage Gene Sets** tab and go to the **Manage** section.
2. Enter the gene set you want to modify.
3. Click **Submit**.

To print the data, click **Print** on the top right.

To export the data in an.xls file, click **Export**.

To remove a gene set, click **Delete Gene Set** at the bottom.

 Note:

When you delete a gene set, its record is still available in the database but it can only be restored by a system administrator.

Administrate user groups

Administering user groups can be done directly from the Oracle Healthcare Translational Research UI.

To simplify sharing, create user groups and assign users to them. Instead of sharing queries or lists with each user individually, set up a list of users to share multiple items to multiple users at the same time.

 Note:

Only the user that is the owner of a list can modify its members. However, any user can share any given lists with other groups and see members in other lists.

5. Select the user you want to remove.
6. Click **Remove**.

Manage user groups

You can edit, duplicate or delete a user group using the buttons at the top of the **User Groups** section.

1. Go to **Manage User Groups, Search User Groups**.
2. Enter the details of the group you want to find.
3. Click **Search**.
4. Follow one of these steps:
 - Click **Edit** to change the name and description of the user group.
 - Click **Duplicate** to create a copy of a user group.
5. Click **Submit**.

Schedule and monitor genomic data export jobs

Currently, jobs are scheduled only for **Genomic Data Export**. To schedule a job, navigate to the **Genomic Data Export** screen in the **Cohort Viewer** tab.

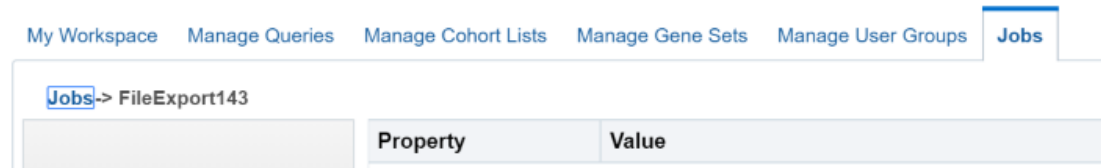

Switch between Patient and Subject context

Oracle Healthcare Translational Research can be run in either Patient or Study Subject context. In Patient context, all queries are directed at patient tables in the Cohort Data Model (CDM) schema, while in the Subject context, all queries are routed to the subject tables in the Cohort Data Model (CDM).



- To change context, click either one of the buttons (Patient or Subject), in the upper-right corner of the screen. By default, the context is set to **Patient**.
- The new context is available until the next time you change it.
- Switching context clears the data loaded in the Cohort Viewer tabs, but not the criteria of an active query in the Cohort Query screen. Only applicable criteria for the selected context is displayed.

Example

Encounter criteria is not supported in the Subject context and will be disabled. When you switch back to the Patient context, it is enabled again.

- For a subject or a patient to be considered deleted and not visible for selection, a given subject or patient's delete flag in CDM should be set to Y.

Overview

Oracle Healthcare Translational Research Next Gen (OHTR NG) is an updated User Experience (UI) that is built on the same databases as of Oracle Healthcare Translational Research (OHTR). Oracle Healthcare Translational Research NG has been developed using modern technologies as Oracle JET and REST APIs and provides a fresh visual design that complements the modern layout approach.

The phase 1 of Oracle Healthcare Translational Research NG presented the Single Patient View in a more intuitive format retaining the ability to explore data associated with the patient using the same instances of the underlying data models of Oracle Healthcare Translational Research. Phase 2 introduces features to build cohort query criteria and view cohorts along with details of the patients in the cohorts.

Login

Oracle Healthcare Translational Research NG is available using the context path of `/ohtr-nextgen/LoginScreen.html`

Users of Oracle Healthcare Translational Research (OHTR) can access and login to Oracle Healthcare Translational Research NG using the same user name and password. The login user must be granted the `ohf_cg_api_group` role to use the application. The user has access to the same set of patients as in Oracle Healthcare Translational Research.

To login:

1. On the Login screen, provide your user name and password.
2. Click **Sign In**.
After successful login, you are directed to the Cohort List screen.

Navigation

The navigation bar on the left side of the screen provides links to:

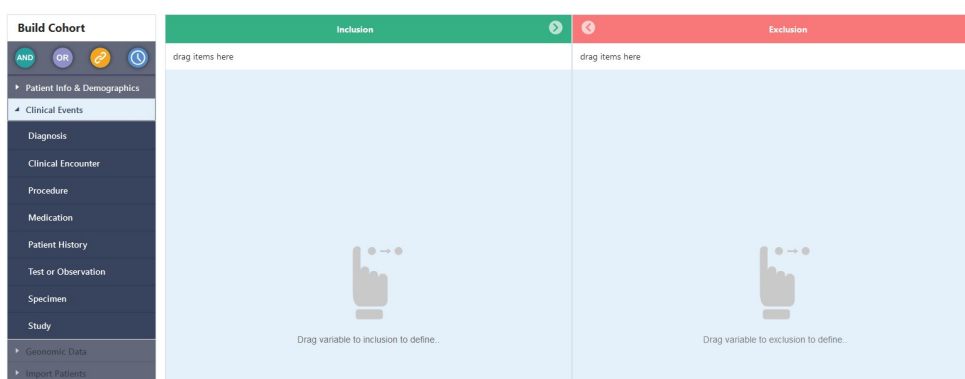

Build Cohorts

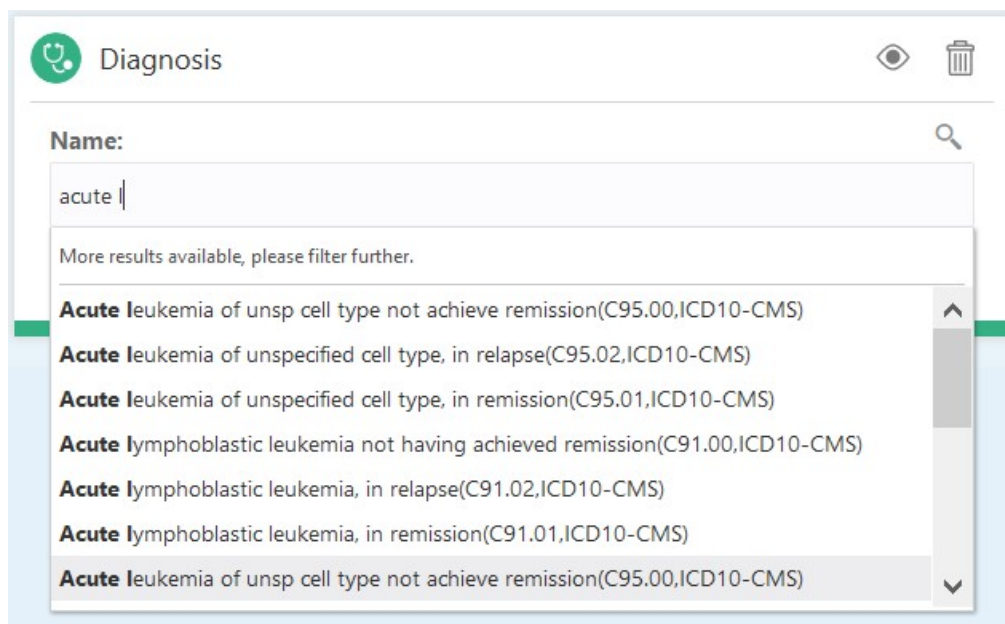
To build cohorts of patients, the Cohort Builder screen provides features to define cohort query which specifies the selection criteria for building cohorts of patients. Cohort query can be based on inclusion and exclusion criteria, each of which can be defined using a combination of demographic and clinical attributes.

To create inclusion or exclusion criteria for a cohort query:

1. Select the data category under the section Patient Info & Demographics or Clinical Events.



2. Click on the menu item for the data category (such as Demographics, Consent, Diagnosis, Procedure etc.) and drag it to the label 'drag items here' under the Inclusion or Exclusion section.
3. The above action results in placement of the criteria tile in the Inclusion/Exclusion section.
 - a. In the criteria tile, the primary attribute of the data category (such as Patient ID, Diagnosis Code, Procedure Code, Medication Code, and so forth) can be searched by typing a text string which is likely match with the starting characters of Code Name of the primary attribute. As the text string is typed, the input box displays a list of items in which the typed text string matches with the initial characters of Code Name of the data attribute. For example, in the Diagnosis criteria tile, the text string 'acute I' lists all of the diagnoses in which the Code Name starts with the letters 'acute I'.



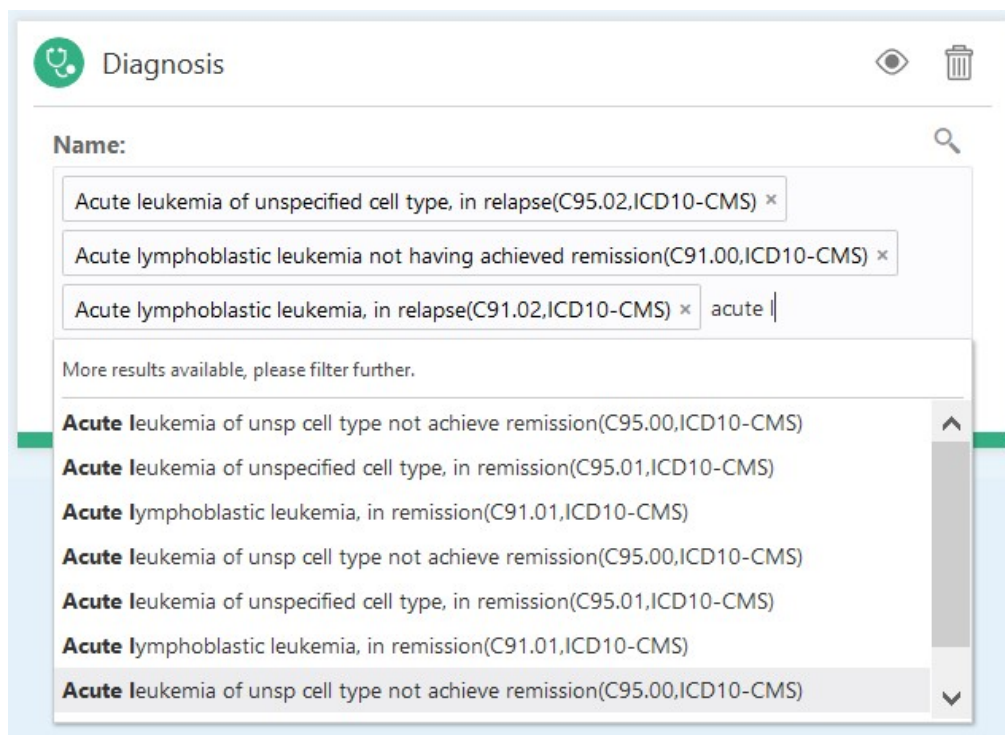

- b. From the displayed list, select the desired items, one at a time, to add them to the selection criteria. The selected items are added in the input box one by one. Depending on the number of selected items scroll bar automatically appears in the input box. Note that an item from the drop down has to be selected. Keying in an item that is not selected (adding an item not in the list) would not work.

- e. In the above illustrated advanced search screen (for example, the Select Diagnosis screen) the attribute values can be searched using a combination of Code Name, Code and Code System. For all these three attributes the search string can be provided in the respective input boxes and a matching operator (such as, Starts With, Contains, Equals, or Not Equals) can be selected from the corresponding drop down list. After specifying the search criteria, click the **Next** button, which displays a list of matching results.

- f. In the selection list screen, use the checkboxes corresponding to the list items to select one or more items from the list. In this screen:
The label '**Search:**' at the top provides information about the current search criteria.

To change the criteria use the hyperlink '**Change**' to navigate back to advanced search screen.

The '**Back**' button navigates back to the advanced search screen.

The '**Next**' button navigates back to the criteria tile, which includes all of the items selected on this screen.

The '**x**' icon at the top right section of the screen can be used to close this screen without applying the selected items in the selection criteria tile.

- g. All of the codes selected in a criteria tile are used in Patient search based on the OR condition. For example, in the Diagnosis criteria tile, if a Patient has any one of the selected Diagnosis Codes then the patient is considered a match for the selection criteria.
- h. More Details search screen: In the criteria tile, the More Details ([More Details](#)) link invokes the criteria definition screen where additional attributes of the selected data category are available for definition of criteria. For example, for Diagnosis criteria definition, the dates associated with diagnosis, anatomical sites, and the Grade and Stage attributes are available. The input fields in this screen allow search by either Code Name or Code, wherever applicable. The search is done using the operator Starts With. Thus, for example, for the Diagnosis Grade and Stage field, the input value is searched against both (either) Code Name and Code of the diagnosis grade and stage.

The More Details screen includes all of the attributes that can be used to define search criteria. The attributes are organized into different sections that can be expanded and collapsed by clicking on the respective section headers.

 Note:

In any date fields, all dates before 1950 should be manually entered in the mm/dd/yyyy format to ensure correct retrieval of patient count.

- i. All of the criteria a criteria tile can be enabled or disabled using the 'Eye?' () icon. This action does not remove the criteria tile from Inclusion or Exclusion section but the criteria defined in the tile is not used in the cohort query while searching for the matching patients.
- j. A criteria tile can be deleted using the 'Delete' () icon. This results in removal of the criteria tile from the Inclusion or Exclusion pan so use this icon with caution.
4. Similarly, criteria tiles for other data categories (such as Medication, Procedure, Test, or Observation and so forth) can be placed in the Inclusion or Exclusion sections to create complex criteria consisting of different categories of data.
5. The Inclusion and Exclusion pans can be expanded and collapsed using the '>' () and '<' () icons to view details of the criteria on the screen.

8. A cohort of patients thus created can be saved by providing a unique Cohort Name, Privacy (Public/Private) and optionally Description. After a cohort is saved, the user who

owns the Cohort (that is the logged in user who created the cohort) can update and save it with the same name. Users who have access to shared Cohorts created by other users cannot modify the cohort, but can save the Cohort with a different name. Cohorts created in Oracle Healthcare Translational Research Next Gen can be accessed and updated in Oracle Healthcare Translational Research and vice versa. In this release, Cohort Queries built and saved in Oracle Healthcare Translational Research cannot be imported into Oracle Healthcare Translational Research NG and vice versa.

9. List of all of the available Cohorts is available in the Cohort List screen.

 Note:

If the Code/Name column in the underlying terminology data in Cohort Data Mart (CDM) contains braces, that is (,) , or both, then the search may result incorrect number of matching Patients. 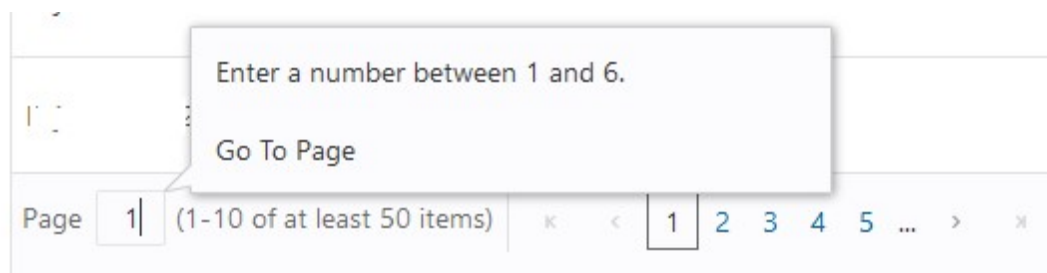
Upon modifying the criteria of an existing cohort and while saving the cohort may sometimes result in an error. If the error logs show an error occurring due to 'timeout or end-of-fetch during message dequeue', the possible cause could be an issue in the version of the Oracle database. This issue has been reported on the Oracle database.

View Cohorts

To view and manage cohorts, the Cohort List screen is accessible using the application's navigation bar. The Cohort List screen provides information about the cohorts that are previously saved and available in the system. A user can only see the cohorts created by self, shared with the user or the public cohorts.

1. The upper section of the screen displays the total number of cohorts and number of cohorts shared with other users.
2. The tabular cohort list includes the following attributes of the cohorts:
 - a. Name of the Cohort, displayed as hyperlink, double-clicking on which displays the Events List screen with details of the selected cohort.
 - b. Size: Total number of Patients in the Cohort.
 - c. Owner: The application User who created the Cohort.
 - d. Last Created Date
 - e. Last Updated Date
3. The **Create Cohort** button navigates to the Cohort Builder screen.

4. The menu Manage Cohorts subcategory Delete Cohort can be used to delete the cohort(s) selected in Select column of the Cohort List. When the Delete Cohort menu is clicked then:
 - If all of the selected cohort(s) are owned by the logged in user then the application displays a confirmation dialog with a list of selected cohort(s) along with **OK** and **Cancel** buttons. **OK** deletes the selected cohort(s) along with the cached clinical data associated with the cohort(s) from the Application (App) schema. The data in Cohort Data Mart (CDM) remains absolutely unaffected. **Cancel** closes the confirmation dialog without any other action.
 - If any of the selected cohorts is not owned by the logged in user then the application displays a notification that the user does not have permission to delete the cohorts. The notification includes the list of cohort(s) which are not owned by the user. The user cannot delete any cohort from the cohort list if any one of the unowned cohorts is selected for deletion. After deselecting the specified un-owned cohort(s) from the Cohort List, cohort deletion can be re-initiated.
5. The drop down list with value 'All Cohorts' can be used to selectively display all, Private or Shared cohorts.
6. The input box next to the above drop down supports filtering of Cohorts by Cohort Name. Search is based on the operator "Starts With" to match the Cohort Name with the input string. After providing the input string press **Enter** on the keyboard or click the magnifying glass icon () to refresh the tabular list.
7. Pagination available at the bottom of this screen allows navigation across multiple pages of the list. To directly navigate to a particular page, type the page number in the input box next to the Page label and press **Enter**. This is, however, limited to the pages that are already loaded and mentioned in the hover over of the input box. For example, the number between 1 and 6 in the image below.

- a. In Show Event Type, checkboxes are available for each type of clinical event, which can be used to select the clinical events that should be displayed in the event list table. The All Events checkbox can be used to display all types of clinical events. When this checkbox is selected, all other checkboxes are automatically selected and vice versa. If any of the event-specific checkboxes are deselected then All Events is automatically deselected. By default, all of the checkboxes are selected.
- b. In Time Scale section, the Auto option (selected by default) displays all of the selected event types without applying any filter on their Start Date or End Date attributes. The From option and To, along with the Select Date Type drop down list (with values Start Date and End Date) allow filtering and display of only those events that match with the specified time range, for example the events with Start Date between 01-January-2020 and 31-March-2020.
- c. The Show Patients With section allows filtering of Events that match with the filter criteria provided in the input box. Filter criteria can be defined based on Patient Identifier or the combination of Event Type (such as Diagnosis, Procedure, and so forth) and Event Name value(s). Multiple values can be provided in the above input box. Type ahead is provided in this text field. Only one filter type can be provided at a time for this filter.
- d. Click **Apply** to apply changes in the Show Event Type, Time Scale, and Show Patients With sections, refresh the information in the events list table, and close the above sections.

By default, the Latest Events Only toggle () is set to display only the latest date's events that are selected for display, wherein an event is defined by the combination of Event Type and Event Code. If a particular event has multiple instances on the same date (for example, Observation of Blood Pressure is performed multiple times in a day) then all of such instances are displayed. The toggle can be used to change the above filter and display all of the instances of the selected events.
- 5. Upon clicking a particular event record in the event list table, the collapsible/expandable sections located at the right side of the events list table display the details of the patient and the selected event. Depending on the type of clinical event (such as Diagnosis, Medication, Specimen Collection, and so forth) the sections display the relevant details of the event using a unique background color for each section to provide visual cues about different types of events.
 - a. The Patient Details section displays the demographic and contact details of the selected patient, along with information on the Patient Group(s) associated with the patient.

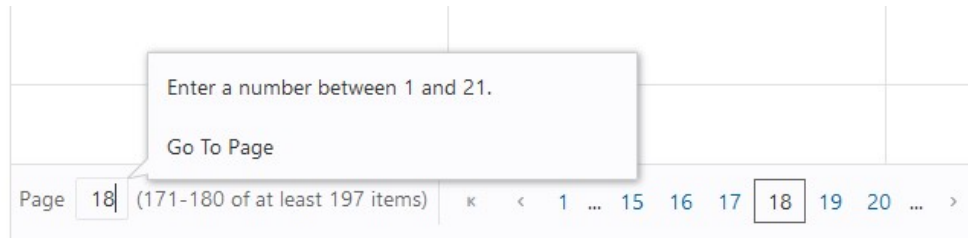

1. Click on the triangular icon () adjacent to the Patient ID label.

The demographics section expands to display the demographic attributes for the patient.

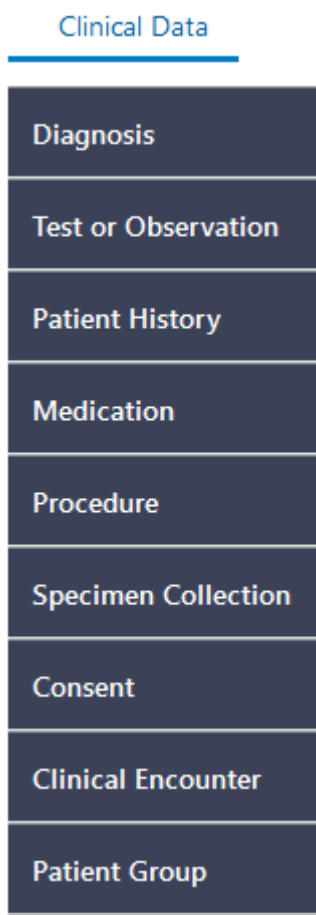
2. Click the same icon to collapse this section.

View Clinical Data

Below the demographics section, the application displays clinical data of the patient in a tabular format in the center of the screen. By default, Diagnosis data is displayed.

To display other type of clinical data in the table, such as Test or Observation, Patient History, and so on:

1. Click the clinical data selection menu available on the left side of the screen.



Filter Clinical Data

By default the tabular display lists the latest 100 records pertaining to the selected clinical event, sorted by the most recent events displayed first. You can further search or filter for any

records for the patient in the system based on the values of specific attributes (columns in the table) and date range of clinical events.

To search and filter the records based on the value of attributes of clinical data:

1. Select the column on which search is required. For example, in the Medication data, to search for the records with a specific medication, select Code or Name from the drop down list.

2. In the search input box next to the column selection provide the search string.
3. Click the search icon () or press Enter key on the keyboard.

**Note:**

In the tabular display, search is performed using the operator 'Starts With' and is case sensitive. For example, if the search string "Met" is provided for Code Name, then the tabular data is filtered to display only those records where Medication Name starts with the word "Met". A Medication Name starting with "met" would not be returned.

To filter the records based on dates of clinical events:

1. By default, the table display records without any filter on dates of clinical events, that is, the Time Scale is set to Auto. To filter the records based on the dates of

clinical events, for example Medication Start Date or Medication End date, click on the

Time Scale **Auto**

link Auto ().

2. In the time range selection dialog, select the desired date range and the clinical event's date column (such as Start Date or End Date) on which the filter is required.

For example, the filter on Medication can be specified to display only those records where Medication End Date is From 01-Jan-2018 To 31-Jan-2019. If only the From date is specified then the filter selects the records where the event date starts at the specified date, for example all records where Medication End Date is equal to or later than 01-Jan-2018.

If only the End date is specified then the filter selects the records where the event date ends at the specified date, for example all records where Medication End Date is equal to or earlier than 31-Jan-2019.

View Details

For all types of clinical data (for example, Diagnosis, Procedure, Specimen Collection and so on) the application displays all of the clinical attributes available in Cohort Data Mart in the Details and Additional Details section.

To see the additional attributes available for any selected record in the tabular display:

1. Select the record in the tabular display.
2. On the right side, click Details to expand it (if not already expanded).

3. The Details displays a vertical scroll bar depending on the number of attributes available in this section.
4. Similarly, below the Details section, click Additional Details to display the additional attributes available for the selected record.

The Additional Details section also displays details of all of the events that are linked to the event selected from the events list table. If a Diagnosis event is selected in the events list table then this section displays details of the Specimen Collection event(s) that are linked to the selected Diagnosis event. For Medication, Procedure, and Observation events, the linked Diagnosis event is displayed. For Medication events, the linked Procedure event is also displayed. For Test or Observation events, the linked Specimen Collection event is also displayed. For Specimen Collection events, this section displays information about all of the Specimen Aliases and Specimen Metadata associated with the selected Specimen Collection record.

Logout

To log out from the application:

1. Click on the login user name at the top right corner of the screen.
2. Click on the **Logout** menu item.
3. To access online documentation, use the Help menu.
