**LARGER SCALE:** These UI or process-based features have more complex designs. Therefore, the potential impact to users is higher.



The following template reports are generically available in Reporting and Analytics, but should be reviewed by properties in Spain. They are located in the Fiscal/Spain subfolder.

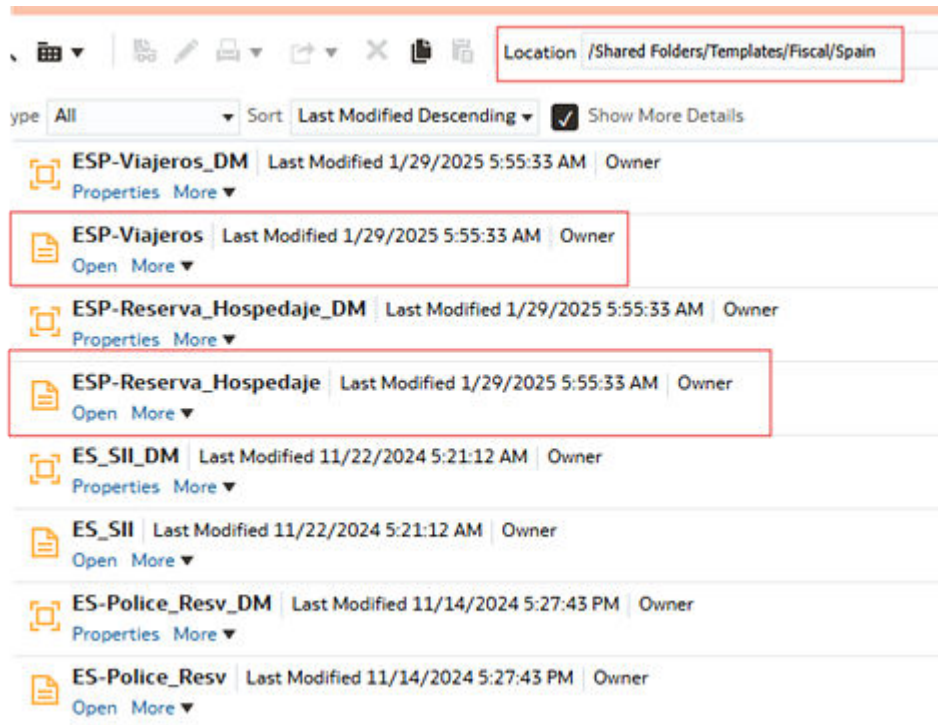
- ESP\_Viajeros - The report displays Travellers bookings for police report purposes.

A new finjrnbytrans report is added to the Shared Folders/Templates/Financial folder.

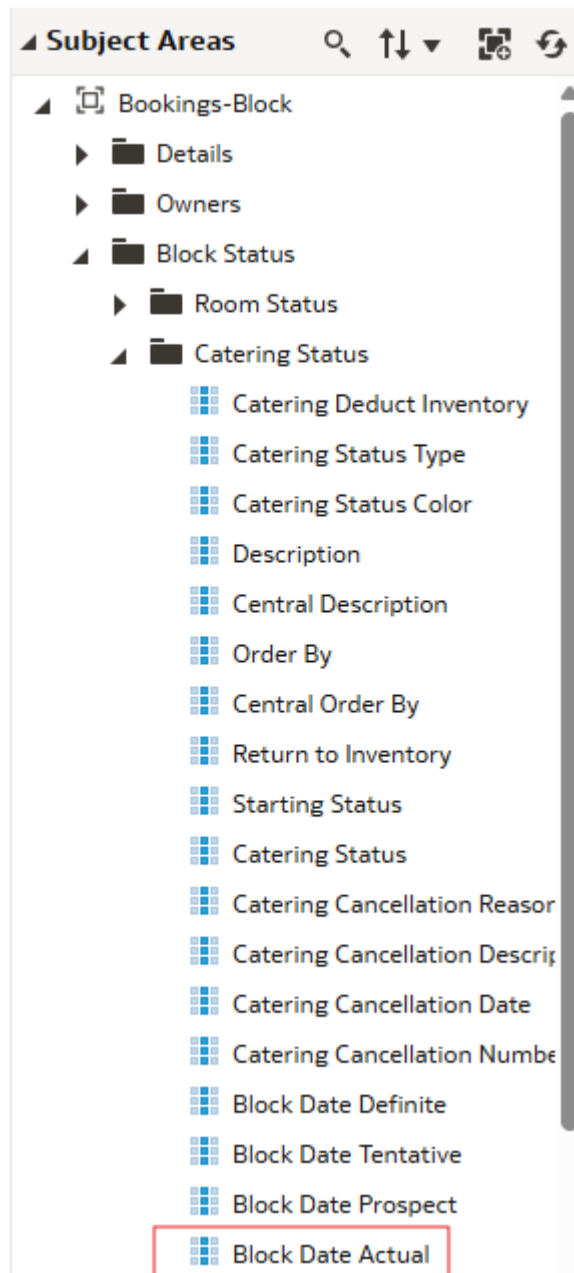
The Journal By Cashier and Transaction Codes report displays each posted transaction code and its corresponding amount for a particular date. The ability to filter on a Transaction Code is available. Each transaction code shows the cashier that posted the transaction, any taxes that apply, and if any package credits exist for that particular code.

37727727	Issue with job that was cleaning invalid users automatically from configuration is resolved.
37613785	When selecting multiple properties as criteria, the data is appearing correctly in the reports.
37588190	PoliceReport1 and PoliceReport2 in the Shared Templates\Fiscal folder are updated with a report parameter. You'll need to select a property and other criteria before generating these reports. If you're already using these reports, you'll need to reselect and customize them if required. The report should be reconfigured if set as a scheduled report.
37576660	The fields for Package Forecast, Expected, Guaranteed, Actual and Billed Revenue are updated to calculate revenue for packages priced per person.
37564884	Promotion coupon codes generated at the template level are available in the Reports and Analytics for report creation.
