Issue fixed in release 24.2

Description: After 20 minutes of inactivity in an open Oracle InForm study session, Oracle InForm provides a pop-up window to prompt users to re-authenticate their credentials. When users enter their credentials, they are instead redirected to a new pop-up window with an error message and are not logged in.

Affected feature: Access Management

Solution: The provided pop-up window prompting users to re-authenticate their credentials now work as expected, and users are taken back to their previous Oracle InForm study session.

Description: In some cases, a user creation request coming in from Oracle InForm User Management Tool or the SCIM API placed the newly created user under the Oracle organization instead of the tenant's.

Affected feature: Oracle InForm User Management Tool, Oracle Life Sciences IAMS inbound SCIM

Solution: Oracle Life Sciences IAMS inbound SCIM and the interface to Oracle InForm User Management Tool have been updated to now properly place each created user under their corresponding organization.



Description: In some cases, user creation in Oracle Life Sciences IAMS could result in the following error message: *IAM-3051103: The create operation on user entity failed in action stage.*

Affected feature: Oracle Life Sciences IAMS inbound SCIM

Solution: Oracle Life Sciences IAMS inbound SCIM has been updated and user creation no longer results in this error message.

Issue fixed in release 23.4

Description: A legacy database user name attribute caused performance issues with the creation of users through the Oracle Life Sciences IAMS Create User APIs, resulting in intermittent failures.

Affected feature: Create User APIs and Oracle InForm User Management Tool

Solution: The conflicting legacy attribute is now removed, resolving its associated failures.

Issue fixed in release 23.2

This release addressed the following issues:

Description: In some cases Oracle Clinical One Platform bulk user uploads failed to synchronize with Oracle Life Sciences IAMS, requiring users to apply a manual workaround.

Affected feature: Bulk Upload

Solution: Oracle Life Sciences IAMS has been updated and now synchronizes correctly with Oracle Clinical One Platform when uploading users in bulk.

35454799

Description: The newly released Oracle InForm audit trail API was blocked due to an incorrect policy configuration, preventing the flow of SSO study audit trail data from Oracle InForm to Oracle DMW.

Affected feature: Access Management

Solution: The software has been updated and the Oracle InForm audit trail API now works as intended, granting Oracle DMW the ability to attain SSO study audit trail data from Oracle InForm.

35547281

Description: When identity administrators tried to access My Oracle Bookmarks through the IAMS identity console, the Home link in the top left corner of the menu directed them to a 504 error message instead.

Affected feature: Access Management



Solution: The Home link in IAMS identity console now correctly directs users to My Oracle Bookmarks.

35537605

Description: When users attempted to reset their password, they received the error "The requested URL /oam/server/dap/cred_submit was not found on this server", even though the password reset was successful.

Affected feature: Access management

Solution: After a successful password reset, users are now directed to the correct page.

35654059

Description: Oracle Clinical One Platform user accounts created through Oracle IDCS received Oracle Life Sciences IAMS new account and password expiration notification emails causing confusion among federated users.

Affected feature: Federation

Solution: Oracle Clinical One Platform administrators can now work with their Oracle Services lead to disable Oracle Life Sciences IAMS notification emails for federated users created through Oracle IDCS. To ensure continued access, please be sure to communicate the appropriate login process to existing users before disabling Oracle Life Sciences IAMS notification emails.

35741905

Description: Study URLs in MyApps were rendering incorrectly due to a new API not adding the correct *https://* prefix to them, causing 404 errors when clicked.

Affected feature: MyApps

Solution: The affected API now provides the correct *https://* prefix to the URL, allowing study links to render correctly in MyApps.

35741846

Description: If a user's username contained a mix of upper and lower case values, MyApps did not render their study links, resulting in a blank page.

Affected feature: MyApps

Solution: MyApps now renders study links correctly for users who have usernames with any combination of upper and lower case values.

Oracle Support and Services login support for forthcoming IDCS-protected Health Sciences Cloud Services

Oracle user logins have been consolidated for Health Sciences Cloud Services moving to IDCS, as part of a strategy to centralize Oracle user authentication and account management. This affects Trial Monitoring and Management Cloud Services and Study Startup Cloud Services starting with their January 2022 releases.

Issue fixed in release 21.3.0.1

The following issue was addressed in this release:



Description: Clinical One user was navigated to an inoperable Oracle Life Sciences IAMS login screen when the following steps were performed:

- 1. Logged into Clinical One with the Data Visualization access.
- 2. Clicked Analytics. The Analytics opened in a new tab.
- 3. Closed Analytics tab.
- Logged out of Clinical One.
- Logged into Clinical One again.
- Clicked Analytics.

Affected feature: Integration

Solution: The software has been updated so that when the Clinical One user performs the steps mentioned above, the analytics application opens in a new tab and it works as expected. The fix to the bug is isolated to the analytics application.

Enhancements in release 21.3

Define your federated service provider

You can now group your federated applications together to work with a specific identity provider, such as grouping the test applications to work with a test identity provider, and grouping the production applications to work with a production identity provider. This also enables you to separate your clinical applications from the safety application. To activate this feature, raise a request to Health Sciences Support.

Improved performance for Oracle InForm 7.0

The technology stack of Oracle Life Sciences IAMS has been updated to replace the library components that were nearing the end of life with the new components. It will also improve the performance for Oracle InForm 7.0.

Issues fixed in release 21.2

The following issues were addressed in this release:

New Custom Role Membership report is available upon request

A new report is available which provides information about when each user had access to a role in Oracle Life Sciences IAMS. For Oracle InForm, a study is a role. For other applications like Oracle Clinical One Platform, Oracle Central Coding, or Oracle Empirica Signal, each application instance is a role. You can request for this report through <u>Support Cloud</u>.

Enhancements in release 20.3

Release 20.3 introduced the following enhancements in Oracle Life Sciences Identity and Access Management Service.

Link your Exostar and Oracle Life Sciences IAMS accounts using a confirmation code

You can link your Exostar and Oracle Life Sciences IAMS accounts using a confirmation code (valid only for one hour) that is sent to the email address associated with your Oracle Life Sciences IAMS account. This is a new feature that can be configured for tenants who have opted-in to access federation-enabled applications. Prior to this release, you could link accounts by entering your Oracle Life Sciences IAMS single sign-on credentials.

Security update for a technology component.

Issue fixed in release 20.3

The following issue was addressed in this release:

Description: If a tenant is enabled for the Email Link flow to reset the account password, resetting the password through an inbound SCIM still triggered an email to reset the password.



An email with the password reset link is generated either when a user clicks Trouble Signing In on the Sign In page or when a delegated administrator creates a user. The email with reset link should not be generated when an inbound SCIM API is called to reset a user's account password.

Affected feature: Identity Management

Solution: The software has been updated so that when an inbound SCIM API is called to reset a user's account password, an email to reset the password is not sent to the user.

After an Exostar account is linked with multiple Oracle Life Sciences IAMS tenants, you can log in to trials across multiple tenants using your Exostar credentials.

The business service onboarding process is now automated

With this release of Oracle Life Sciences IAMS, the following tasks to provision a business service are automated. Prior to this release, these tasks were manually performed by a CDA, once for each role (ClinicalOne_Production, IntegrationHub_UI_Production, and ClinicalOne_Production_AssignGlobalRoles).

- Enable Self-service Authorization Request To enable a self-service request access to Oracle Clinical One Platform.
- Activate Approvals To activate an approval workflow so that you can approve user requests to access Oracle Clinical One Platform.
- Publish to Oracle Org Publish to the Oracle organization so that Oracle users can be granted access to Oracle Clinical One Platform.

Issue fixed in release 20.1

Description: While resetting the password in the Email Link flow, the customized email template was not sent to the user. Instead, the default email template was sent to the user with a link to reset the password.

Affected feature: Identity Management

Solution: The software has been updated so that the user receives the customized email template while resetting the password in the Email Link flow.

Description: When a user had successfully reset the password in the Email Link flow, the customized password reset successful email template was not sent to the user. Instead, the default password reset successful email template was sent to the user.

Affected feature: Identity Management

Solution: The software has been updated so that the user receives the customized password reset successful email template when the password is reset successfully.

Issue fixed in release 1.5.0.2

The following issue was addressed in this release.

Description: With the password reset flow set to Email Link, when a CDA attempts to reset password for a UAT user, OHSIAMS allows the CDA to enter the new password manually instead of an option to send an email to user with a link to reset the password.

Affected feature: Access Management



Solution: The software has been updated so that when a CDA resets the password for a UAT user, an email is sent to the user with a link to reset the password.

Reset account password and retrieve user login

If you opted to use the new way of resetting the account password, when a user clicks on Trouble Signing In on the Sign In page, the user receives an email containing a link to reset the password. Previously, a system-generated clear text password was sent to the user in an email. There is no limit for the user to trigger the password email containing a link to reset the password.



(i) Note

The email templates will change if you are using the new process to reset your account password.

To reset the password using the security questions, users have to remember the answers for the security questions set by them. But with the introduction of the new process, users can set a password by clicking the link in the email. This eliminates the overhead task of remembering answers for the security questions.

For users who forget their user login, there is a way to retrieve the user login. When the user clicks on Trouble Signing In on the Sign In page and enters an email address, an email is sent to the user containing the user login.

Scroll through all business services on the Oracle Health Sciences Cloud landing page

If a user has access to multiple business services spanning more than 25 rows, user can scroll on the Oracle Health Sciences Cloud (OHSC) landing page to view all business services. Earlier, only the first 25 rows were displayed on the OHSC landing page.



Navigate from OIM console to Oracle Health Sciences My Oracle Bookmarks or OHSC landing page

Users can now navigate from the Oracle Identity Manager (OIM) console to Oracle Health Bookmarks or OHSC landing page using the **Home** link on the OIM console.

Email notification is sent to the approver for a business service request

When an access request is raised for a business service by the user or by a CDA on behalf of the user, Oracle Life Sciences IAMS sends an email to the approver(s) detailing a request is pending for their action to be taken, provided the approval workflow is active for the business service.

eSignature to support federation

Currently, Oracle Life Sciences IAMS provides an ASDK for products to collect the credentials from end-users within their application and validate those credentials directly with Oracle Life Sciences IAMS through this ASDK. With federation, the user identities will no longer be residing within Oracle Life Sciences IAMS, but at the customer site. To support federation, Oracle Life Sciences IAMS offers the new eSignature REST Service so that the products can migrate away from ASDK for signing end-users.

New business service validation API

During onboarding of the Oracle Clinical One Platform, Oracle Life Sciences Empirica Signal, Oracle Life Sciences Empirica Study, or Oracle Central Coding business services, Oracle Life Sciences IAMS does not have a way to validate the business service is working end-to-end until the CDA creates a user and the user logs in.

Oracle Life Sciences IAMS provides a new service validation API, which product teams can invoke to smoke test Oracle Life Sciences IAMS and the product application integration.

Enable self-service registration for a business service with multiple products

Oracle Clinical One Platform is a multi-tenant application having a business service associated with multiple products. This means that there are two or more URLs registered during the Oracle Clinical One Platform product registration. Now, the CDA has an option to select a URL from a list of registered URLs and set it as the application landing page for users.

Description: In Oracle Health Sciences My Oracle Bookmarks, when the user selected an SSO study and clicked **Edit Study**, the port number was being displayed in the trial URL.

Affected feature: Oracle Health Bookmarks

Solution: The software has been updated so that the trial URL does not display the port number.

Description: In Oracle Health Bookmarks, it took considerably long time (more than 10 seconds) to process when a user was added, edited, or deleted from a study.

Affected feature: Oracle Health Bookmarks

Oracle Health Sciences My Oracle Bookmarks

This release introduces Oracle Health Bookmarks, a single dashboard to access all applications and studies that are secured using Oracle Life Sciences IAMS. If you decide to use Oracle Health Bookmarks, it will be available to all your users from the same URL and will replace the landing page.

About the interface

The main page of Oracle Health Bookmarks displays links to access applications and studies:

- Application tiles: The top of the page displays a tile for each of your company's
 applications that has been defined and added by your Sponsor Administrator. Clicking a
 tile opens the application.
- Study list: The remainder of the main page lists all SSO-enabled studies to which the logged in user has access. You can sort and filter the study list. The following details are available for each study:
 - Study name
 - Therapeutic area
 - Program

Clicking the row for a study opens the study details page. You may see one or more buttons to access the study on this page, for Oracle InForm or Oracle InForm Testing. The buttons you see depend on the types that exist for the particular study and your privileges to access them.

Roles in Oracle Health Bookmarks

Users can have three types of roles for Oracle Health Bookmarks, with specific privileges:

- Basic role: This is the main user role for Oracle Health Bookmarks and, if you want to use
 Oracle Health Bookmarks, you should assign it to all users in your organization. Users with
 this role can:
 - Access Oracle Health Bookmarks
 - View the application tiles for those applications where Site Access is turned on
 - View the study list
 - View the study details page for a study.
- Sponsor User: This user can view all application tiles, regardless of their Site Access setting. Assign this role when you want the user to see all application tiles, including reporting applications or other tools that are not broadly used within your organization. To grant this additional privilege in Oracle Health Bookmarks to a user, assign the FNTD_BIZ_SERVICE_FD_SP_USER role to the user from Oracle Life Sciences IAMS Identity Self Service console.



- Sponsor Administrator: This role is for users of sponsor organizations who manage the
 applications used to conduct clinical trials. Users with this role can perform high-level
 maintenance in Oracle Health Bookmarks:
 - Add and edit the company name
 - View all application tiles
 - Add, edit, or delete applications
 - Turn on or turn off Site Access for applications; this controls its availability to Site Users
 - Add or edit the description (visible on the study details page), therapeutic area, and program for existing studies
 - View the study details page.

To grant these privileges to a user, assign the FNTD_BIZ_SERVICE_FD_SP_ADMIN role to the user from Oracle Life Sciences IAMS Identity Self Service console.

Getting started with Oracle Health Bookmarks

Oracle Health Bookmarks is open to any customer who uses Oracle Life Sciences IAMS for user provisioning. To start using it, perform the initial setup and then assign Oracle Health Bookmarks roles within your organization.

Initial setup:

- Ask your delegated administrator to create a Sponsor Administrator user for Oracle Health Bookmarks. The sponsor administrator can be the same user as the delegated administrator or a different user.
 - To create a Sponsor Administrator, assign the basic role FNTD_BIZ_SERVICE and the application role FNTD_BIZ_SERVICE_FD_SP_ADMIN from Oracle Life Sciences IAMS Identity Self Service console. For instructions, see Assign one or more roles to the same user in the Oracle Life Sciences Identity and Access Management Service Administrator Guide.
- Log in to Oracle Health Bookmarks as the Sponsor Administrator by following the Oracle Life Sciences IAMS link provided in the email message you received when your account was created.
 - If you no longer have the message, contact Oracle Support to request the Oracle Health Bookmarks link for your company.
 - Because the basic role FNTD_BIZ_SERVICE is assigned to your account, you are now redirected to Oracle Health Bookmarks instead of the landing page.
- 3. Set your company name. For instructions, click **Help** and watch the video *Configure My Oracle Bookmarks*.
- 4. Add application tiles for your applications that use Oracle Life Sciences IAMS. You can also add application tiles for any other URLs that your users might need to access. For instructions, click Help and watch the video Configure My Oracle Bookmarks. If the application or URL should be available for all your users, turn Site Access on. If only Sponsor Users need the application, leave Site Access turned off.
- 5. Your SSO studies will be available in the study list, if any. Edit each study to add a description, set a therapeutic area, and a program name. The therapeutic area and program name are used to filter the study list. For instructions, click **Help** and watch the video *Configure My Oracle Bookmarks*.



Assign Oracle Health Bookmarks roles

Your delegated administrator should assign the following roles so that users can access Oracle Health Bookmarks:

- 1. Assign the basic role FNTD_BIZ_SERVICE to all users in your organization.
- Assign the sponsor user application role FNTD_BIZ_SERVICE_FD_SP_USER to those
 users who should see application tiles for which Site Access is turned off.

Enhancements related to Oracle Enterprise User Security

When you create an Oracle Life Sciences IAMS account, the system automatically generates an Oracle Enterprise User Security (EUS) user name that is linked to the main account. The EUS user name works together with the password for the main account.

The EUS user name appears in the **DB User Login** field, shown on the Attributes tab of the User Details page in Oracle Life Sciences IAMS Identity Self Service console. Next to this field, you can click **Email DB User Login to user** to send an email notification to the target user, which includes this DB user name.

Option to hide the Remove Roles button

You can choose to hide the **Remove Roles** button from Oracle Life Sciences IAMS Identity Self Service console for non-administrator users. To hide this button for users in your organization, submit a request to Oracle Support.

Default redirection on logout

It is no longer mandatory to specify a target page where users should be redirected after logout. If you do not provide a target redirection page, users are redirected to a default page which confirms that logout was successful.

If you want to change the page to which users are redirected after logout, submit a request to Oracle Support.

Accessible interfaces

The Oracle Life Sciences IAMS Identity Self Service console and the new Oracle Health Bookmarks are now accessible for the main types of users for these interfaces. However, Oracle Health Bookmarks is not fully accessible for users who have the Sponsor Administrator role.

In this release, a number of accessibility issues have been addressed in the Oracle Life Sciences IAMS Identity Self Service console related to items such as tab navigation, missing alt text for images and links, missing table headers or labels.

- The Publish Role to External Organization dialog box now displays assistive text and a list of available external organizations instead of a drop-down list. To publish the role to an organization, you now select its check box and click Submit. Organizations to which the role is already published appear graved out and cannot be deselected.
- The Set Approval Options dialog box now displays radio buttons to activate or deactivate the approval workflow. A check box for the Activate Approval option allows you to choose whether to notify the user of the request status. The current settings are selected when the dialog box opens.

Conditions for answers to challenge questions added to interface

The conditions for answers to challenge questions were not displayed, making it difficult for users to define acceptable answers.

The software has been updated so that the challenge question conditions are displayed on the My Information, Forgot Password, and Password Management pages where users define or edit answers.

Current release number shown on Login page

The Oracle Health Sciences Single Sign-on (SSO) login page has been updated to show the current Oracle Life Sciences IAMS release number.

New text for error page

If users bookmark a login URL instead of the URL of the application they are trying to access, they now see a message directing them to use the correct URL.

Improved text in email templates

The wording in the subject and in the message for default email templates has been simplified and updated for consistency.

Text updates for consistency

The Oracle Health Sciences Single Sign-on (SSO) login page, My Information page, Forgot Password page, and the default email templates were updated to use the term User Login to refer to the account user name.

Other enhancements: Improved support for Oracle Enterprise User Security

User management operations can be performed in bulk

A new option, **Bulk Import**, has been added to the Administration menu in the Oracle Life Sciences IAMS Identity Self Service console. This option allows delegated administrators to perform multiple operations on multiple user accounts at the same time. To use this feature, you describe user management operations of the types create, authorize, deauthorize, and disable in a CSV file that you upload in the Oracle Life Sciences IAMS Identity Self Service console. The system validates and executes all operations for the specified user details.

A bulk import template file is available for download in the console. The file contains information on the required details for each type of operation. You can specify up to 10,000 operations in a bulk import file. The file can be a maximum of 2 MB.

Users can request access to company resources using self-service registration

Self-service registration

Delegated administrators can now set up an Oracle Life Sciences IAMS role so that when an unauthorized user attempts to access the resource associated with the role, the user is redirected to an authorization request page. On this page, the user can enter a justification and submit a request for access. This feature, called **self-service registration**, is inactive by default.

To manage self-service registration, a new button has been added to the top of the role page in the Oracle Life Sciences IAMS Identity Self Service console: **Select Authz Error Page**. The button opens a dialog box where you can select the option **Authz Request Page** to show the authorization request page to unauthorized users.

Approval workflow

Delegated administrators can opt to enable an approval workflow for those roles where self-service registration is active. When activated, access requests submitted by users must be approved to grant the role to the user. This feature is inactive by default.

If approval is inactive but self-service registration is active, when a user submits an access request, it is automatically approved and the user can access the resource.



When activating the approval workflow, you can choose whether Oracle Life Sciences IAMS should send email notifications to the requesting user on the status of their access request.

To manage the approval workflow, a new button is added to the top of the role page in the Oracle Life Sciences IAMS Identity Self Service console: Enable/Disable Approval. The button opens a dialog box where you can select to enable the approval workflow with or without target user notification. When the approval workflow is active, this dialog box shows a link to deactivate the approval workflow.

Approver role

A new role, Approver, is required if you activate the approval workflow. This role allows users to process access requests received through self-service registration. Users with this role can view, approve, or reject access requests by accessing Pending Approvals under the Requests menu in the Oracle Life Sciences IAMS Identity Self Service console.

To create this role for your organization, submit a request to Oracle Support. When the role is available, assign it to a user who will be responsible for approving or rejecting access requests.



(i) Note

User accounts that have the Approver role cannot process their own access requests.

Choose the page that appears to unauthorized users

Delegated administrators can now choose the type of page that appears to unauthorized users when they attempt to access a company resource.

The Select Authz Error Page button has been added at the top of the role page in the Oracle Life Sciences IAMS Identity Self Service console. The button opens a dialog box where you can select one of the following options:

- Authz Error Page: Display an error page indicating that the resource is not accessible with the current credentials. This option is selected by default.
- Authz Request Page: Enable self-service registration.
- Resource Not Found Page: Display an error page indicating that the resource does not exist.

Grant access to Oracle employees to your resources

A new option, Publish Role to Organization, has been added to the role page in the Oracle Life Sciences IAMS Identity Self Service console. Your roles, and therefore your resources, are only visible within your organization. This option allows you to make a role available to the Oracle organization.

After you publish a role to the Oracle organization, an Oracle administrator can assign the role to the account of an Oracle employee, such as a representative from Oracle Support or an Oracle administrator. That Oracle employee can then access your resource and provide assistance.

Work with Oracle Support to coordinate your request for assistance and to identify the need to publish a role to the Oracle organization.



View and revoke access to a resource for individual Oracle accounts

After publishing a role to the Oracle organization, Oracle administrators have access to the role and can assign it to Oracle employees as appropriate so that they can provide assistance. These user accounts are known as **external members** of the role because they are external to your organization.

To see external members for a role, access the role page in the Oracle Life Sciences IAMS Identity Self Service console, select the Members tab, and click **External Members**. You can view and revoke access for external members using this option.

Users can remove their own roles

Users can now revoke a role that is assigned to their user account from the My Information page in the Oracle Life Sciences IAMS Identity Self Service console.

Help for delegated administrators is available in the user interface

A new option is available in the Oracle Life Sciences IAMS Identity Self Service console under the Administration menu: **Admin Help**. This option opens a new browser window where administrators can view the *Administrator Guide*.

In Oracle Life Sciences IAMS release 1.1, you can handle your access and identity needs for services integrated with Oracle Life Sciences IAMS through self-service operations. These operations can target a single user or a group. You can also perform many operations at the same time using a bulk action.

User management actions include:

- Creating, replacing, and deleting users
- Changing user attributes
- Changing user passwords
- Enabling and disabling user accounts
- Searching for users and retrieving user accounts

Group management actions include:

- Listing groups
- Retrieving groups
- Modifying group membership
- Removing some or all users from a group

You can use bulk actions to perform multiple operations in a single request (for example, creating and adding users to a group).

Your remote applications can also interact with the Oracle Life Sciences IAMS application through LDAP, if enabled, to authenticate users' credentials through search and compare.



Support for Oracle Internet Directory added

Oracle Life Sciences IAMS release 1.1 includes support for Oracle Internet Directory, 11g Patch Set 6 (11.1.1.7.0) for Linux x86-64.

Support for database EUS integration with Oracle Life Sciences IAMS added

Oracle Enterprise User Security (EUS) is a mechanism to leverage LDAP authentication when accessing the database. This feature is available for Oracle databases 10g and higher. When an EUS application is integrated with the Oracle Life Sciences IAMS application, you can use your Oracle Life Sciences IAMS credentials to log into approved databases.

Support for E-Business Suite application integration with Oracle Life Sciences IAMS added

The Oracle Life Sciences IAMS 1.1 release includes Oracle Internet Directory, which allows integration with Oracle E-Business Suite applications such as Oracle Life Sciences Data Hub and Oracle Life Sciences Data Management Workbench.

About the Product Verification Pack (PVP)

The Product Verification Pack (PVP) is a collection of product release artifacts that are aimed at helping with your validation efforts.

The documents in the PVP are used by Oracle for product testing and verification purposes. Oracle makes the documents available to you at no charge at product release. You can use the PVP to gain insight into product requirements and testing and to use this information to determine the appropriate amount of testing needed on your end.

You'll find the following documents in the Oracle Life Sciences IAMS PVP:

- Product requirements
- Master traceability matrix
- Objective evidence
- readme.txt

A new PVP is made available for every release.

Step 1. Get an account for My Oracle Support (MOS)

Do I have to do this? Yes, unless you already have a My Oracle Support (MOS) account. Getting an account takes just a couple minutes.

How many times do I have to do this task? Just one time.

1. If you think you might have an MOS account but aren't sure of your user name or password, follow these steps to retrieve your sign-in details.

You already have an MOS account if...

 You were identified as the primary contact from your organization for the deployment of Oracle Life Sciences IAMS when the environment was first provisioned.

If you were the primary contact, you received the Welcome letter from Oracle and were provisioned with a My Oracle Support (MOS) account during the onboarding process.

Step 2. Associate your MOS account with your organization's customer support identifier (CSI)

Do I have to do this? Yes. Even if you have an MOS account, you won't be able to download the Product Verification Pack (PVP) or see useful information until you associate your account with your organization's customer support identifier (CSI).

How many times do I have to do this task? Just one time.

- 1. Obtain your organization's CSI using one of the following methods:
 - Find the CSI in the Welcome letter, if you received it.
 If you were identified as the primary contact from your organization for the deployment of Oracle Life Sciences IAMS when the environment was first provisioned, you received the Welcome letter from Oracle.
 - Consult the documents you received during the onboarding process.
 - Reach out to your Sales contact.
- 2. Sign in to My Oracle Support.
- In the upper right, click the drop-down arrow to the right of your name, and select My Account.
- Below Support Identifiers, click Request Access.
- 5. Fill in the fields:
 - Note to Approver: Include an optional note about why you need to be associated with the organization's CSI.
 - **Support Identifier**: Enter the numerical CSI for your organization.
- Click Request Access.



- 7. Review these important guidelines so you understand how your request is approved, next steps, and future responsibilities:
 - If you are the first person from your organization to request to be associated with the CSI:
 - You can expect to hear back from Oracle within a couple business days, letting you know that the association has been set up.
 - As the first user at your organization to be associated with the CSI, you automatically become the Customer User Administrator (CUA) for your organization.
 - * As the CUA, you'll be responsible for approving all future requests for associations to your organization's CSI.
 - * You'll typically receive requests only when another person at your organization needs to download the PVP. After someone requests access, you'll receive an email, and all you have to do is return to MOS to approve their access.
 - You also have the ability to identify other users as CUAs. We highly recommend setting up more than one CUA for your organization. That way, if the current CUA is on vacation or leaves the company, your organization will still be able to approve requests. If your last CUA leaves your organization, reach out to Oracle Support for help in manually updating the CUA.
 - If you aren't the first person from your organization to request to be associated with the CSI, the request for approval is emailed to the Customer User Administrators (CUAs) at your organization.
 - One of them needs to sign in to My Oracle Support and approve your request, and then you'll be able to see the PVP. They can also make you a CUA so that you'll have approval rights for future requests.

Step 3. Enter a ticket to obtain the password for the Product Verification Pack (PVP)

Do I have to do this? Yes. Due to security considerations, the PVP can be downloaded only if you have the current password. But if you are responsible for validating, we think you'll find that the contents of the PVP are worth the extra step of getting the password.

How many times do I have to do this task? The password changes every 90 days, so you'll have to request a new password about four times per year.

1. Open Support Cloud.



Your Support Cloud account is the same as your My Oracle Support (MOS) account.

- 2. Select the **Support Request** tab.
- 3. Enter a ticket and ask for the password for the product PVP. Complete the following fields:
 - Select Customer: Choose the name of your organization.
 - Select Product: Choose UMT.



- Select Business Service: Choose the business for your organization, such as UMT -<your organization>.
- Oracle Internal: Choose No.
- Environment: Choose Other.
- Severity: Choose the severity.
- Issue Category: Choose General Inquiry.
- Summary: Enter Please provide password for the InForm Product Verification Pack (PVP).
- Description: Enter Please provide password for the InForm Product Verification Pack (PVP).

Step 4. Download the Product Verification Pack (PVP)

- 1. Sign in to My Oracle Support.
- 2. Paste **Patch 31090473** into the search box in the upper right on any page in My Oracle Support, and press **Enter**.
- On the right, from the Release drop-down, choose the product release for which you need the PVP.
- Below the drop-down, click **Download**.
- 5. In the File Download pop-up, perform the following tasks:
 - a. Check the download time for the PVP, and make sure you'll be able to leave your computer on for the duration of the download.
 - **b.** Enter the password you obtained from Support, and click **Unlock**.

The PVP downloads.

Did a Password is invalid error appear? If so, the password has expired since you last obtained it. Enter a ticket to get the current password.

You're finished! Now all you have to do is save the PVP locally and unzip the file so you can view its contents.
