These updates are intended to improve case-processing efficiency, strengthen data integrity, and reduce manual effort during intake review and merge operations.

Unlock a case during merge follow-up processing without navigating separately to Argus Safety.

You can unlock an Argus case directly in Safety One Intake when opening the Merge Viewer window from either the Duplicate Search, Intake Worklist, or Intake Monitor windows.

This enhancement eliminates the need to separately navigate to Argus Safety to unlock a case during merge follow-up processing.

Follow-up awaiting acceptance notification displayed in a case even after follow-up was marked as invalid in Safety One Argus

Before

After upgrading to Safety One Argus, auto-rejected ICSR follow-up reports from the Consolidated Intake Worklist could still generate Follow-up Awaiting Acceptance case notifications in the corresponding Argus case. (39156260)

After

Auto-rejected ICSR follow-up reports no longer generate case notifications in Argus. Case notifications are created only for reports that are pending acceptance. If notifications were previously created for rejected reports, you can remove them by raising a Support ticket.

E2B files that contained company study failed to import and were not displayed in Intake Worklist

Before

E2B files that contained Company Study data were not imported and thus were not displayed in the Intake Worklist. (39396623)

After

E2B files that contain Company Study data are imported successfully and are displayed in the Intake Worklist. Both the Study ID and Study Name values are correctly displayed.

MedDRA loading failed at Dictionary terms loading is in progress step

Before

When you loaded a MedDRA dictionary, the process could fail during the **Dictionary terms loading is in progress** step. This issue occurred because the required permissions were not granted for certain MedDRA dictionary tables. (39457143)

After

When you load a MedDRA dictionary, the required permissions for the affected MedDRA dictionary tables are granted automatically, eliminating the need for manual intervention.

Product Verification Pack (PVP)

The Product Verification Pack (PVP) is a collection of product release documents designed to help with your validation efforts.

The PVP is used by Oracle for certification purposes, and Oracle makes a new pack available to customers with every release (except patches). You can use the PVP as a blueprint for acceptance testing.

The latest PVP for Oracle Safety One Argus is made available on [My Oracle Support](#). The patch containing the PVP for Oracle Safety One Argus is **37708659**.

To complete the steps below, you need the following:

- A My Oracle Support account. If you don't have one, please ask your Oracle contact for assistance.
 - The current password for the PVP patch, which you can obtain from My Oracle Support by creating a service request. Patch passwords expire periodically.
1. Log in to your account at [My Oracle Support](#).
 2. Select **Patches**.
 3. Select **Patch Name or Number**.
 4. Enter the PVP patch number, 37708659, and press **Return**.
 5. Select **Apply**.
 6. Select the patch from the list of results.
 7. Select **Download**.
 8. Enter the password for this patch. Passwords are case sensitive.
 9. Select **Unlock**.
 10. Select the ZIP file to start the download.
