About Oracle Site Select LITE

Oracle Site Select LITE is the web-based tool that provides anytime, anywhere access to your site feasibility to-do list and status.

Getting started

Check your email for an invitation. There are two ways to access Oracle Site Select LITE:

1. **No login required** – No need to remember a password, just click the encrypted link for secure access. This link expires after 60 days.
2. **Log in required** – Provides access to all studies you have been invited to participate in along with a document library with all the documents exchanged with the CRO/sponsor. Click the Log in required link to set a password for your account. If you forget your password, use the reset password link to receive a reset password email.



Note:

We have documented issues where email servers add tracking links to the Log in button. This may result in you having to re-authenticate after setting your password.

Home page

On the home page, you'll see completed and future activities/tasks and milestones listed vertically on the left side of the page. Complete a task by taking the **Task action** on the right side of the page. Status for each task is color coded for at-a-glance view:

- Green – complete
- Orange – pending review (in progress)
- Red – discontinued
- Gray – not started

Your CRO/sponsor can optionally include:

- additional study information that displays above the tasks
- additional information for each individual task that displays under the Task name on the right



Note:

You may be working on more than one study with your CRO/sponsor. Make sure to review the study name in the "Study" drop-down menu, at the upper left, and adjust it as necessary using the down arrow before you begin your work.

The study CRO/Sponsor may include a brief study description on the home page as well. If provided, the descriptive text displays above the task list and may include a document download icon for additional information (). Not all studies require this descriptive text or document download, so it is not of concern if it does not display above the task list. To get back to this home page at any time, click the "select LITE" logo at the upper left of any page.

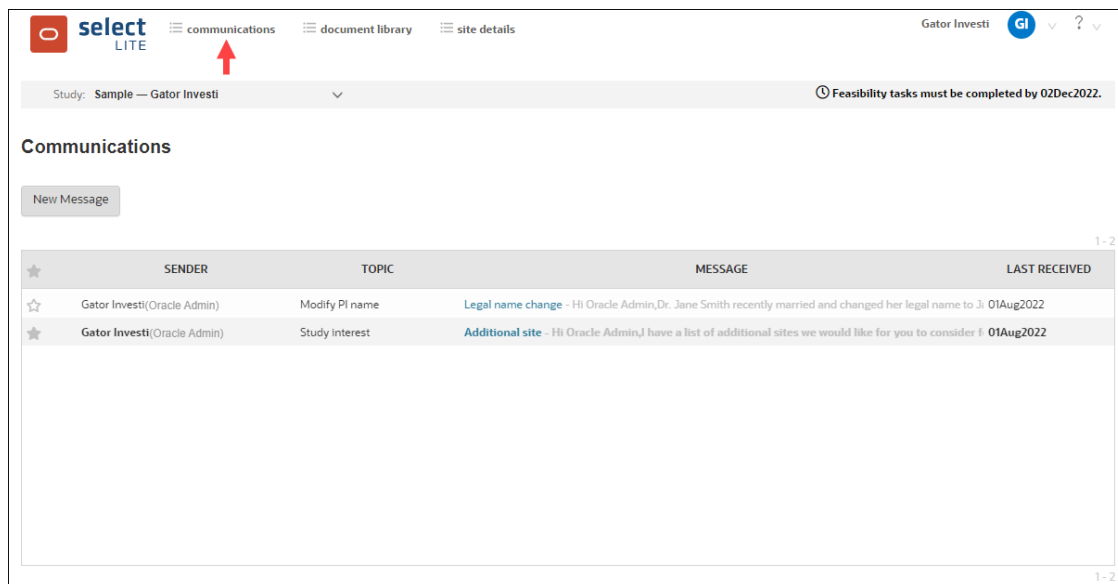
Your CRO/sponsor determines the required tasks, the task materials provided to you, and the order in which each task is available to you for action. Examples of tasks that might be assigned to you include:

- Sign and return CDA
- Review and/or return a document
- Enter date available for site visit

Viewing communications with your sponsor or CRO

On the **communications** tab, you can send messages, and you'll see the complete history of communications with your sponsor or CRO.

Managing documents and updating the site profile

Under the **document library** section, you can manage all the documents that are exchanged within a study in the “Study Documents” subtab (e.g., all CDA versions, protocol and other study documents exchanged with the CRO/sponsor, feasibility survey questionnaire PDF, as well as your completed survey). If your CRO/Sponsor has activated the optional Site document library feature to store investigator- and institution-scoped documents at the account level, you'll also see a "Site document library" subtab in the document library. This tab will include documents that can be re-used across studies (e.g., privacy consents, data use consents, master CDA, etc.).

Each CRO/sponsor within Oracle Site Select maintains a profile for the site. To view and manage your site's profile, click the **site details** tab (you'll see a bell icon if someone from your organization or the CRO/sponsor has updated the profile). If you have created an Oracle Site Select LITE account, then the study picker will allow you to switch between CRO/sponsor based on who is managing the study. Make sure to review and update all the tabs that have been made available to you by the CRO/Sponsor managing the study (tabs like Contacts, Study contacts, etc.). If you want someone on your team to work with the CRO/sponsor in Oracle Site Select LITE, add their information and email address in the “Site” sub-tab within profile's Contact tab in the applicable section. The new contact will receive an email with a link to login.

If the site record has been associated with a network, a read-only Network subtab also displays in the site profile. The subtab displays network details like name, ID, Affiliation scope and type, and Network delegate contact information, if available.
