NetSuite for Government Utility Billing Version 25.9.1 – Release Date September 15, 2025

Customer cloud services(CCS):

- Introduced a change to the PDF bill. If a bill is identified as a closing bill (i.e., a final bill), a note will be displayed on the bill indicating 'FINAL BILL'.
- Updated CCS program logic to handle move-in/move-out requests from Iowa American Water file, applying specific rules to determine customer type.
- Added Accounts Payable extract to interface with NetSuite for processing customer refunds.
- Updated County Parcel file upload process to handle missing values in the incoming file.

Citizen Portal:

- Resolved issue where Login button was disabled when using a password manager, ensuring button remains functional.

Employee Portal:

- Employee Portal now includes email notification telemetry statistics.
- Introduced email monitoring for Bill and Letter notifications sent from CCS, including sent, bounced, and delivered emails.
- Enhanced user experience with updated UI and navigation for In-app Navigation, Agency Detail, and associated feature and template pages.
- New Employee Portal page to store merged PDF files for bulk bills: one for 2-page bills and one for 3+ page bills, streamlining printing for bill vendors.
