Overview

This document will cover the aspects of security that were mentioned in the Merchandising Security Guide Volume 1 and describe them in a bit more detail as well as outline how they are used in Merchandising specifically.

Application Functional Security

Merchandising functional security supports a role-based, declarative model where resources are protected by roles that are assigned to users. Roles are associated to one or more duties, which are logical groupings of privileges, which provide different access rights. In this manner, an application role becomes the container that grants permissions to its members to access the application tasks, screens and the functionalities within.

Roles

Roles, also referred to as Job Roles, align with titles or jobs within a retailer's organization, such as a Buyer or Inventory Control Manager. Roles are used to classify users based on job responsibilities and actions to be performed in the application. One or more duties as well as individual privileges, if desired, can be assigned to roles. When a user logs into the application, based on the roles assigned to the user, the system determines which privileges have been granted to the user and the system features are enabled accordingly.

Duties

Duties are tasks one must perform in the context of their job. Duties in Merchandising are logical groupings of privileges or other duties that grant users access to a set of functionally related tasks within the application.

Privileges

Privileges are used to grant permission to access links into workflows, screens, actions and in some cases specific fields within the application. Privileges that grant access to related functionality are grouped together into duties that permit a user to perform a complete task to fulfill responsibilities within the context of their job.

Data Filtering

Oracle Retail Merchandising suite offers an optional layer of data filtering in the application user interface, which limits the data end users see based on levels in the merchandise and organizational hierarchies. Whether or not this is used in your environment, is controlled by a system option in Merchandising, which is also where all the configuration for this functionality is managed.

This data level filtering is configured by assigning users to a data security group. The group then is assigned to levels of the merchandise and organizational hierarchy. All users within a

group will have similar access to a particular section of the merchandise or organizational hierarchy. For example, a group may be defined for a particular division, giving users across application job roles, access to the departments, classes, subclasses, and items in that division.

Within Merchandising, there is not any additional configuration that is needed. However, all Merchandising users will need to be included in the user/group relationships configured in Merchandising so that they are able to access the data needed to perform their jobs. With data filtering enabled, users will only be able to work with items that are part of the merchandise hierarchy to which they have been given data filtering access. Likewise, users will only be able to work with locations (or zones containing locations) that are part of the organizational hierarchy to which they have been given data filtering access.

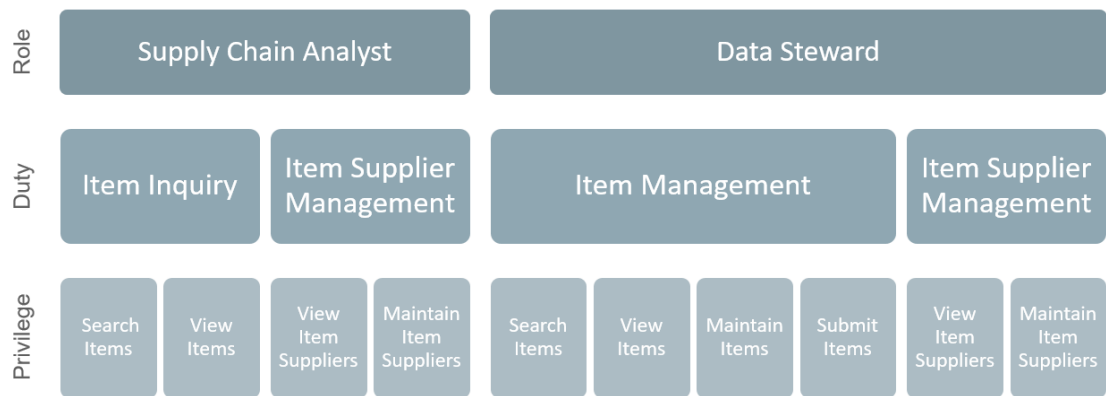

2 Roles

Roles are used to classify users based on job responsibilities and actions to be performed in the application. Using roles, a user's access can be restricted to specific areas or functions within the system. Users must be associated with at least one job role in order to access the application and may be associated with several roles if desired.

For example, within Merchandising, a Supply Chain Analyst may only have the ability to maintain item sourcing related information but not the ability to modify any other details on an item's definition. This role would be given view only access to the item workflow with the exception of item supplier screens where the role will be granted management access. Whereas a user in the Data Steward role might have ability to manage the general item definition, including item sourcing information.

Roles Provided at Initial Setup

A default security configuration is provided with each application during installation and is intended to be used as a starting point as you define the roles that align for your business and users. The provided roles can be modified by adding or removing duties and/or individual privileges to adjust the access granted to the role, or the roles can be deleted completely. Additional roles can be created as well and can be mapped to the desired duties or privileges. Administrator users can change the mappings of roles, duties and privileges in the Merchandising's User Interface.

Details about how to manage these application security policies are available in Chapter 2, Manage Security Policies in the *Oracle Retail Merchandising Administration Guide*.

Application Administrator

The Application Administrator is a part of a retailer's IT department responsible for maintaining and configuring the Pricing application. Primary responsibilities include:

- Maintaining daily operations, such as daily batch processes of the application.
- Supporting end-users and providing the first level of support for the application.
- Applying patches and upgrades to the application on a regular basis.
- Troubleshooting and resolving product issues.
- Setting up users and security privileges for the application.

Data Steward

The Data Steward is responsible for the management of foundational data elements for Merchandising, which includes ensuring the completeness and accuracy of the data, as well as development and enforcement of standard processes.

Buyer

Develops business strategies and seasonal assortment plans to maximize the development of the brand, as well as sales and profits for a department or assigned area. Their primary responsibilities are:

- Performing market and competitive analysis and analyze sales trends to keep abreast of current trends.
- Developing business strategies outlining strengths, weaknesses, new opportunities and threats.
- Analyzing and approving new product or concepts for their department.
- Maintaining relationships, resolving issues and conducting negotiations with significant suppliers and agents.
- Managing sales and margin dollar performance against plan.
- Recommending adjustments to the plan to maximize sales, profits, and to protect the brand.

Inventory Analyst

The Inventory Analyst works with the buyer to ensure product distribution aligns to strategy. The Inventory Analyst is responsible for managing and allocating inventory at the store level. This includes:

- Working with the buyer to develop and manage buy plans.
- Ensuring stores maintain appropriate in stock service levels and weeks on hand.
- Modifying store replenishment settings to achieve sales and inventory plans.
- Communicating regularly with stores concerning inventory levels and assortments.
- Communicating with production team to ensure on time delivery of product developing action plans for delayed product.
- Partnering with distribution center to ensure accurate and on-time delivery to stores of allocated merchandise.
- Supporting promotions with appropriate inventory.
- Developing exit strategies for managing disposition of discontinuing products.

Inventory Manager

Responsible for working with the buying teams to execute the inventory strategy for a retailer. Primary responsibilities include:

- Coordinating with their team of inventory analysts to execute to the inventory strategies for their division.
- Partnering with the buying team in assessing and determining assortment and financial goals.
- Communicating regularly with stores concerning inventory levels and assortments.
- Communicating with production team to ensure on time delivery of product developing action plans for delayed product.

Corporate Inventory Control Analyst

Inventory control analysts at corporate collaborate with their warehouse and store counterparts to ensure accurate levels of inventory through the retailer's supply chain. This includes.

- Scheduling, coordinating, and reviewing cycle counts performed in stores and warehouses.
- Monitoring and resolving inventory discrepancies, problem orders, and transfer issues.
- Making recommendations to minimize supplier invoice discrepancies.
- Analyzing inventory-related procedures to suggest process improvements.

Inventory Control Manager

Inventory control managers develop and implement inventory control procedures for a retailer and direct the work of inventory control analysts at corporate, in stores, and in warehouse to ensure accurate levels of inventory through the retailer's supply chain. This includes:

- Developing procedures for cycle counting in stores and warehouses.
- Assisting in the resolution of inventory discrepancies.
- Analyzing inventory-related procedures and implementing process improvements.
- Auditing operational processes and compliance procedures.

Sourcing Analyst

Manages the sourcing for a retailer, including importing processes, to ensure efficient and ethical procurement of merchandise. This includes:

- Ensuring product is sourced from the best supplier or factory so that a quality product is produced ethically, on-time, and at the right price- Processing product claims with vendors, supporting quality.
- Researching problems, develop resolutions, lead negotiations.
- Reviewing and maintaining import details related to items and purchase orders, such as expenses, assessments, duties, discharge lading ports, and partner information.
- Monitoring for and resolving any issues related to importing of merchandise, including troubleshooting disruptions to the calendar and communication with all partners connected with the calendar.
- Communicating with merchandising, import operations and overseas offices agents to resolve issues with deliveries.

Supply Chain Analyst

Responsible for planning, coordinating and controlling all aspects of supply chain management, including demand and capacity planning, product sourcing, and distribution, using the most efficient and cost effective means available. Usually focused on a group of suppliers and or locations within a category. Key responsibilities include:

- Analyzing supplier compliance performance to use in supplier negotiations and to optimize lead times settings to provide more accurate view of inbound inventory.
- Analyzing cost and performance of shipping inside the retailer's supply chain to optimize the shipping schedules and sourcing locations for the retailer's stores.
- Conducting root cause analysis on problem areas.
- Recommending and implementing supply chain improvement programs.

Financial Analyst

Responsible for analyzing financial information of an area within the enterprise to assist in decision making and assist with planning for the brand. This includes:

- Supporting the finance team with scheduled reports and budgets.
- Monitoring performance indicator trends and analyze causes of unexpected variances.
- Assisting with financial report generation, budget and trend preparation, business plans.
- Assisting with cost control and conduct budget meetings with department managers.
- Developing, analyzing, and preparing data for use in negotiations with suppliers.
- Managing and approving the corporate view of vendor trade funds.

Financial Manager

Responsible for the financial accounting of a retailer's business, which includes making sure that all financial operations are running smoothly, bills are paid on time, figures are reported timely and accurately, period end books are closed properly. This includes:

- Ensuring period end reporting is completed in a timely manner.
- Ensuring the timely resolution of auditing issues.
- Ensuring in the timely resolution of vendor payment issues, including the resolving cost and other invoicing discrepancies.
- Identifying risks and opportunity areas to the operations.
- Providing performance reporting highlighting trends and opportunities to assist in improving profits, margins and reducing costs.

Duties and Privileges

Privileges grant access to specific tasks, links, and actions within the application. The access controlled by a particular privilege is fixed and can only be changed by an enhancement to the application. You can control the functions and features to which a user has access by grouping the desired privileges into duties, and assigning the duties to job roles which can then be associated to one or more users

Duties Provided at Initial Setup

As part of this default security configuration, the system privileges have been logically grouped into duties and the duties have been assigned to an initial set of job roles. The provided duties can be modified or deleted and new duties created. Administrator users can change the mappings of roles, duties and privileges in Merchandising's User Interface.

Details about how to manage these application security policies are available in Chapter 2, Manage Security Policies in the *Oracle Retail Merchandising Administration Guide*.

Duty Types

Duties provided in the default security configuration follow a general naming convention to indicate the type of privileges grouped within and the level of access provided. In Merchandising, the provided duties are one of the following duty types:

- Inquiry

An inquiry duty will provide the user the ability to search for and view the associated entity. The provided inquiry duties are used when it is desirable for a user to have visibility to an area, but no option to create or update any information. Inquiry duties are assigned to viewers of an area.

- Management

A management duty provides the user the ability to maintain the associated entity. The provided management duties are used when it is desirable for a user to have the ability create, update, delete, and, typically, submit information. Management duties always contain the inquiry duty for the same entity. For example, the Purchase Order Management Duty contains the Purchase Order Inquiry Duty along with the additional Maintain Purchase Orders Privilege and Submit Purchase Orders Privilege, because in order for a user to maintain an entity they must also have the ability to search for and view the entity. Management duties are assigned to contributors of an area.

- Approval

An approval duty is meant for users with the authority to review and approve or reject submissions. Approval duties should always be granted along with the management duty for the same entity. Typically this is supported by nesting the management duty within the approval duty, as is the case with the Purchase Order Approval Duty which contains the Purchase Order Management Duty, therefore only the Purchase Order Approval Duty needs to be mapped to a user because due to the nested duties the Purchase Order Approval Duty will grant search, view, maintain, submit and approval access. However, there are some exceptions to this nested structure, in which case you should ensure both

the management and approval duty are assigned to the role to which you wish to grant approval level access. Approval duties are assigned to reviewers of an area.

Duties with no Hierarchical Relationships

There are a number of privileges used within Merchandising that do not have a hierarchical set of duties with increasing levels of access, as described by the duty types above. Rather these duties simply grant access to a single area, such as a dashboard, or they grant access to particular information across several functional areas. Therefore access is either granted or not, there are no access levels. These duties may be classified as management or inquiry duties, depending on if the user can maintain the related data or if it's view only. For example:

- **Blank Template Inquiry Duty**
Grants access to the Download Blank Templates screen in order to download empty spreadsheet templates.
- **Dashboard Inquiry Duties**
Grants access to view a given dashboard. Access to each report within the dashboard is controlled separate privileges based on the functional area of the report. For example, the Finance Analyst Dashboard contains five reports, the Stock Count Value Variance, the WAC Variance, the Cumulative Markon Variance, the Shrinkage Variance, and the Late Posted Transactions reports. A user must have the View Stock Count Values Privilege to access the Stock Count Value Variance report and likewise must have the View Item Locations Privilege to access the WAC Variance report. However, in order to see these reports the user must also have the Finance Analyst Dashboard Inquiry Duty and its single View Finance Analyst Dashboard Privilege in order to have access to the Finance Analyst Dashboard.
- **Grocery Attributes Management Duty**
Grants access to grocery related item attributes for users with the ability to view or maintain grocery items.
- **Differentiator Display Duty**
Grants access to view differentiator information throughout the various application workflows and the ability to manage parent/diff level price events in each of those areas. The Differentiator Display Duty should only be assigned to users that work with items that use differentiators in their definitions, such as fashion merchandise.
- **Settings Menu Duty**
Grants access to the Settings menu except for the Security folder. The default security configuration has this duty assigned to the Application Administrator role. This is a limited use duty which cannot be assigned to any other roles aside from the provided application administrator role.
- **Administrator Console Duty**
Grants access to the Security folder on the Settings menu where security roles, duties and privileges are managed. The default security configuration has this duty assigned to the Application Administrator role. This is a limited use duty which cannot be assigned to any other roles aside from the provided application administrator role.
- **Data via Application Express Inquiry Duty**
Grants access to view data via the Application Express module.

- **Service Access Duty**
Grants access to execute Merchandising ReST services.
- **Average Cost Management Duty**
Grants access to maintain average cost values.
- **GL Drill Back Inquiry Duty**
Grants access to view general ledger drill back information.
- **Transaction Data Inquiry Duty**
Grants view only access to transaction data.
- **Inventory Adjustment Management Duty**
Grants access to make inventory adjustments.
- **Inventory and Sales Inquiry Duty**
Grants access to item related inventory and sales information.
- **Ticket Management Duty**
Grants access to maintain ticket requests.
- **Price Change History Inquiry Duty**
Grants access to view price change history.
- **DSD Management Duty**
Grants access to maintain DSD purchase orders.
- **Pre-issued Order Numbers Management Duty**
Grants access to generate pre-issue order numbers and creating orders using pre-issued numbers.
- **Receipt Adjustments by Cost Management Duty**
Grants access to create receipt adjustments by cost.

Limited Use Duties

There are limited use duties which provide access, but only to the application administrator role provided in the default security configuration. These duties cannot be mapped to any other roles.

- **Settings Menu Duty**
Grants access to the Settings menu except for the Security folder. The default security configuration has this duty assigned to the Application Administrator role.
- **Administrator Console Duty**
Grants access to the Security folder on the Settings menu where security roles, duties and privileges are managed. The default security configuration has this duty assigned to the Application Administrator role.

Determining Access for your Organization

When determining access for a given role in your organization, start by categorizing each role with a duty type for each functional area in the application. For example, a Sourcing Analyst may be a viewer of cost changes and a contributor of cost zone and purchase order

definitions. They may have no access to system options and may have approval privileges over customs entries and obligations.

Duty Definitions

For ease of mapping privileges to roles, privileges are logically grouped into duties. Duties may contain one or more privileges as well as other duties.

[Table 3-1](#) lists the privileges and nested duties contained in each of the predefined duties provided in the default security configuration:
