#### Overview

Oracle Retail Xstore Suite 21.0.3 includes the products below.

#### Oracle Retail Xstore Point of Service

Oracle Retail Xstore Point of Service is a point-of-sale application that provides the capabilities to carry out day-to-day transactions and conduct daily store activities. Tasks such as scanning items, applying price adjustments, tendering, and printing receipts as well as processing returns and web orders can be performed. Store operations including opening the store, managing registers and tills, and closing the store can be handled through Oracle Retail Xstore Point of Service. As part of Oracle Retail Xstore Point of Service, these release notes include information about Xstore Point of Service Mobile and Xenvironment.

#### Oracle Retail Xstore Office

Oracle Retail Xstore Office is a central web-based management console that provides for the effortless management of the data and configurations that empower your associates. The user interface within Oracle Retail Xstore Office provides streamlined functionality that guides users through configuration changes, data changes, and deployments. Granular security access can create a custom experience for users of all access levels. Multiple support tools and alerts enable IT leaders to take a proactive approach to managing multiple installations.

# **Functional Enhancements**

#### SIOCS REST Service Integration

In addition to SOAP web services, Xstore POS supports REST versions of the web services when Xstore uses Store Inventory Cloud Service (SIOCS) for inventory.



The SIOCS reason code mapping no longer supports code 97. The SIOCS reason code mapping in services-sim.xml has been updated to use SIOCS reason code 93 for Xstore return reason codes RET1, RET2, RET3,RET5,RET6,RET41 and RET43.

# Italy Country Accelerator

The following functional enhancements have been implemented for the Country Pack Italy.

#### **Instant Lottery**

Enhancements have been implemented for the Instant Lottery functionality to comply with the legal requirements.

Country Accelerator France/Register Open and Close	35476959	A signature issue that occurred when using taxed vouchers has been fixed.
Customer Options	35544575	Line breaks are now considered in the fiielddevinitionconfig.xml file.
Country Accelerator Mexico/Global Invoice	35157246	Fixed performance issues when creating Global invoices.
Deals	35196048	Fixed an issue where deals with the field item_field = USE in the prc_deal_field_test table were not applied.
Customer Search	35184949	Fixed an issue where a customer search would return duplicate customer entries if Customer Engagement was not enabled.
RTLog	35701420	The RTLog file displays all items now.
Xstore Certificates	35898658	A user-facing prompt has been added when a certificate is expired or going to expire.
Quick Items	35759485	Fixed an issue where it was not possible to change the items pages on the Quick Items tab.
Layaway	35191225	Fixed an issue with deposits that occurred when items were modified after setting up a layaway.

Order Transactions	35073489	Fixed an issue where Xstore was allowing a pickup in store order when Order Orchestration was configured to not allow that order type in the store.
Xcenter	35767786	Fixed an issue where the product import failed in Order Broker if the file contained a large number of records and was created in Xcenter.
Xservices	35798118	Fixed an issue where the Xservice replication settings in the xservice.properties file did not work.
Country Accelerator Italy/Invoice	35949345	In New Desktop, the Invoice Identification Code is uppercase only.
Order Transactions	35993596	Fixed an issue where an item was not returned to stock when the Order was canceled when it was in Reserved status.
