This chapter provides a functional introduction to Store Operations Cloud Service (SOCS).

Overview

SOCS is a cloud service mobile UI which requires Enterprise Inventory Cloud Service (EICS) as a pre-requisite. It executes operational inventory transactions related to a store.

The application uses Oracle's Mobile Application Platform (MAF), a browser based Oracle JET desktop and for quick execution processes, JET Mobile.

The MAF UI is intended to be deployed on iOS, Android, and Windows 10 mobile units, be it a handheld scanner or a tablet. SOCS supports the following functions:

- Scanning of barcodes (GS1, VPN, item, UIN, container ID) or waving an RFID wand to identify a SKU or container
- Container, item, and supplier lookup
- Inventory adjustment with appropriate reason codes
- Direct Store Deliveries with Purchase order (PO), without PO and against an ASN
- Store Ordering
- Creating, accepting, picking, and rejecting transfer requests
- Accepting Return to Vendor (RTV) request, creating RTVs and shipping to a vendor
- Shipping to another warehouse, store, or external finisher
- Receiving from warehouse, store, or external finisher
- In Store Replenishment from backroom to shop floor
- Management of inventory on delivery bay, shop floor and backroom
- Adhoc, unit, problem line and unit and amount Stock counts
- Customer order pick, pack, and ship
- Item Basket
- Serialized inventory tracking
- Capturing customer extended attributes at serial, item, and transaction levels
- Ticket printing

The JET Mobile UI is focused on fast and simplified execution of several transactions and faster navigation. This app will only run on Android O/S devices and can also be accessed as a web browser application. It supports the following processes:

- Inventory Adjustments with appropriate reason codes, and quick adjustments
- Stock Counts (Ad Hoc, unit count, problem line and unit and amount)
- Transfer request, transfer document and transfer shipment

- Scanning of barcodes (GS1, VPN, SKU) to identify an item
- Extended Item Lookup with simplified inventory adjustments and ticket print
- Supplier Lookup
- Quick Customer Orders: Accept/reject, pick, delivery and curbside pickup
- Native scanning is possible with supported Honeywell or Zebra device using the Android specific application.
- Item Maintenance
- Quick Store Order
- Quick Stock Count
- Quick Container Receiving
- Transfer ASN receiving

The JET Mobile, EICS and MAF applications can be run together. This allows the retailer to decide if they want to use the quick and simplified processes on the JET Mobile application in conjunction with the full functions and administrative capacities of the MAF client, or just deploy the MAF client.

Business Value

This section describes the business values of using SOCS.

Improved Customer Satisfaction

SOCS allows a user to execute store inventory transactions and provide inventory positions to a customer across multiple stores. This means that no time is required to walk over to a fixed station since anyone with a mobile unit can answer inventory and location positions of an item in the store. It is even possible to look up inventory in other stores within the same workflow.

Real-Time Inventory

SOCS sources its data from a centralized point which is continuously updated with sales, receipt, shipping, and adjustment data. This allows for a real-time cross enterprise inventory view.

Streamlined Inventory Processes

All the processes in the SOCS UI follow a similar pattern which means that learning to operate a single workflow allows a user to intuitively and quickly learn how to operate other workflows.

Assisted Inventory Ordering

Some items require real time ordering review with up to date inventory positions to ensure a sufficient supply of inventory is available for customers. This is especially important for highly volatile selling items like fresh. SOCS supports this process through importing replenishment pre-generated orders and the creation of ad hoc orders based on accurate store inventory.

To make ordering easier, SOCS provides inventory information about last ordered quantity, inventory positions in the backroom and shop floor, days of supply, but also allows the user to review forecasted sales data from the planning applications.

Improved Corporate Control

SOCS can be configured using over 400 permissions and configurations. It is for example possible to restrict the UI from manual entering quantities or receiving processes can be configured to require a secondary person to approve the receipt.

Additional tracking features have been built out to help corporate or store managers to validate compliancy through several dashboards:

- When leveraging GS1 databar functionality (manual or automatic through the databar), expiration dates and lot numbers can be tracked and through EICS we can evaluate which items have an expiration date.
- When printing tickets a log is created for all tickets that have been printed.
- A dashboard exists to enable a user to see which stock counts need to be authorized across a region.
- A store shipping network function allows retailers to control which store locations a store can ship to or request inventory from beyond generic transfer zones that can be setup at corporate.

Full Transaction Views

The SOCS UI does not only serve as a mechanism to scan items and record them against transactions, but it also serves as a management application by allowing managers to look up transactions, view item lists and even edit or change (within a time frame) receipts.

Enhanced Inventory Tracking

Two features inside of SOCS allow the user improved inventory tracking.

Serialization tracks each individual item instance, and SOCS allows the user to track each item instance in any physical transaction flow like shipping and receiving, inventory adjustments, stock counts. This improved tracking increases security on high value items as each time a user touches the item a record is made of the transaction.

RFID real time streaming integration allows for accurate location level inventory. This allows a sales associate to quickly look up where an item is located and have confidence that the RFID tracked information is accurate and up to date when serving a customer. In addition to the real time streaming from a third party system, SOCS also has the ability to execute stock counts with RFID items.

Custom Flexible Attributes

SOCS allows the retailer to capture custom defined attributes at three levels:

- **Transactional**
The retailer can define by transaction type what can be captured and if the new custom information is required to be captured or not.
- **Item**

By leveraging the GS1 databar, retailers can define by subclass up to 10 attributes that can be captured automatically or manual at the item level. This for example can be leveraged to capture lot numbers, expiration dates.

- **UIN**

The Item scan number feature allows the user to capture additional attributes for each UIN. This function is reserved for the Jet client at this point, but it does allow in SOCS to identify a single item instance with more than 1 scannable barcode. This is ideal for composite items with multiple unique identifiers for the same item as a computer with a hard drive, or a cellphone.



Welcome / Login


Figure 2-1 Welcome Screen



Upon launching the mobile UI application, the login screen is displayed. The first time a user logs into the system, if logon is successful, the system will log in to the user's first assigned store. The system will remember the store the user was last logged into and log in to that store until the store is changed. Upon successful login, the system will navigate you to the [Open Transactions](#) dialog.

Menu/Drawer


Figure 2-2 Menu/Drawer



The mobile drawer is displayed as the menu panel on the left side of the screen upon tapping the drawer (hamburger stack which looks like three horizontal lines in the upper left-hand corner of the application). From the menu/drawer, you have access to various functionality of the application.

Store List

The change stores function is available from the drawer/menu by tapping the store option. You are directed to the store list screen with an option to change stores.

The store list displays all the stores that the user is authorized for. If needed, the user can search for a store by either the store ID or store name. The store list is narrowed down based upon the search. Selecting a store will display the new store in the store field of the drawer/menu as well as in the footer on **Open Transactions**. The user is then officially logged in to the new store. All data and transactions will be for the newly selected store. Every time the user logs in to the system, it will be for the store selected until a new store is selected. The system remembers/saves the store for the user.

Language

The **Language** screen is displayed by selecting the **Language** menu option within **Configurations** from the drawer/menu. Initially when a user is logging into the mobile for the first time ever, it will use the language of the device. The **Language** screen will display with a list of the available languages supported in the system. User selects a language, and the language will change in the application to the language selected and user will navigate to the **Open Transactions**. That language will remain for the user (saved on the user) until the user change languages. The locale of the device (date format, currency format, and so on) will remain that of the device.

Scan Type

The **Scan Type** is a found in the mode bar. It is used whenever an item can be entered or scanned within a Scan Bar. The scan type allows you to tell the system what type of item or barcode is being entered.

The values for this include **Auto** which is represented by a lightning bolt, **Bulk** represented by a cube (user must have proper permissions), and **UIN** which is a barcode.

Auto is the default value when logging into the system. **Auto** assumes that you can enter or scan any of the supported barcode types such as SKU, type 2, UPC E, GS1, and so on, and the system will parse through the various algorithms to derive the item.

Bulk allows the user to bulk scan or enter one to many items within a bulk dialog and then apply them to the transaction and validate them all at once. An example would be doing a wave of multiple RFID items.

The final option of **UIN**, assumes that the user will enter in a serial number or AGSN and therefore the system will only run the algorithm to search for UINs. Scanning a UIN as part of the UIN option will be much faster and potentially be more accurate in case of overlapping UIN numbers.

Scan Mode

Figure 2-6 Select Scan Mode





Figure 2-7 Scan Mode



The **Scan** mode is a found in the mode bar. It is used whenever an item can be entered or scanned, and the quantity is captured. The scan mode defines if the quantity from the barcode should be:

- Added to the existing item quantity, indicated by Increase with a plus icon.
- Removed from the exiting quantity indicated by reduce with a minus sign.
- No change to the quantity, which is review mode represented by a barcode.

The default scan mode is set to **Increase**.

Unit of Measure

Figure 2-9 Unit of Measure




The **Unit of Measure** selection is found in the mode bar. It is used whenever a quantity is captured. The unit of measure defines if the quantity displayed is going to be represented in the item's standard unit of measure, cases, or transaction unit of measure.

When switching the Unit of Measure, the quantity on the screen will convert to that unit of measure. When first logging in, the default unit of measure will be set based upon the system configuration **Default Unit of Measure**. The Unit of Measure selected by the user will be displayed in the mode bar, and the selected UOM will remain as the UOM until the user logs out of the application.

Transaction Unit of Measure will only be used where applicable which is in Customer Orders as well as Shipping and Receiving for a Customer Order. If Transaction UOM is selected in dialogs where it is not applicable, the system will use the Standard Unit of Measure even though the Transaction UOM may be selected.

Numeric Entry

Figure 2-10 Numeric Entry




The **Numeric Entry** popup is used whenever there is an editable numeric field such as an item quantity field. The quantity that gets entered into the **Numeric Entry** popup will increase, reduce, or override the existing quantity on the screen. The mode on the **Numeric Entry** will be defaulted the system setting, **Manual Quantity Entry Default Mode**. When set to **Scan Mode**, the **Numeric Entry** popup defaults based upon what the **Scan Mode** is set to. When set to **Override** the default will be **Override**. In all cases, these are only defaults, and the user can always change mode of the **Numeric Entry**.

Examples:

- Qty = 15, enter in 3 increase, Qty = 18
There is a quantity of 15 on the UI. In the popup, the user enters a quantity of three, selects the increase option, and apply. The new quantity is 18.
- Qty = 15, enter in 3 reduce, Qty = 12
There is a quantity of 15. In the popup, the user enters a quantity of three, selects the reduce option, and apply. The new quantity is 12.
- Qty = 15, enter in 3 override, Qty = 3
There is a quantity of 15. In the popup, the user enters a quantity of three, selects override, and apply. The new quantity is three.

Filter Bar

The **Filter** bar is used to narrow down a list of things such as items, containers, child stock counts, and so on.

You can tap and type into the filter bar or tap and scan into a filter bar. By default, the **Filter** bar will be displayed on the top of the list. When scrolling down in the list, the filter bar disappears, and it reappears when scrolling back up in the list. The criteria that a user can filter on will be unique per functional area. For example, inventory adjustments the user can filter on Item ID, Item Description, reason code, and UOM. The search is not case sensitive. The filter can be cleared out to return the full list. The filter will retain the entered criteria until leaving the screen in which it will be cleared out.

Scan Bar

Figure 2-12 Scan Bar





Figure 2-13 Scan Bar Camera



The scan bar is at the top of the transaction lists, Item Lists, other lists such as Child Count and Container Lists, and Item Detail screens. It will be anywhere an item, or some other attribute can be entered or scanned to be viewed or edited on a transaction.

This bar allows for one defined attribute to be scanned and that attribute will be stated in the text of the bar. For example: Item, Container or Customer Order ID.


In the Transaction List screens, the scan bar will further filter or funnel down the list of transactions when doing a scan. The scanned attribute will be added in addition to the existing search criteria. It will appear in the search criteria, eye glasses field.

In other areas such as lists, item lists, container lists, as well as Item Detail, and soon, the scan bar will go to the details for what was scanned. Quantity may be updated, and the item may be added to the transaction depending on functionality.

If the system configuration **Enable Device Camera Barcode Scan** is set to **Yes**, then if a camera is detected on the device, the camera icon will be available. The camera icon will allow for scanning in the barcode via the camera on the device. The barcode will be parsed and processed the same as if the scanner was utilized.

Search Criteria

Figure 2-14 Search Criteria




The **Search Criteria** field is represented by an eye glasses icon in the header of the screen. Search criteria will be found on all transaction list screens, such as Inv Adjust List shown in this figure. Criteria will be listed. If there is more than one criteria, they will be separated by a pipe symbol. Initially when entering the dialog, the default search criteria for the functional area will be displayed. For example: in inventory adjustments it would show: Status = In Progress. If there are no default search criteria, the eye glasses will be displayed and the words **Search Criteria** will be listed.

Tapping the **Search Criteria** field, eye glasses, will navigate to the **Search Criteria** screen to select and or change criteria to search with. The search criteria field gets updated with the newly selected search criteria fields from the **Search Criteria** screen. When leaving the dialog, the search criteria will be reset back to the default search criteria.

Item Image and Item Description

Figure 2-15 Item Detail Item Image




The item image is displayed throughout the application wherever an item is displayed. The item image will be displayed next to the Item ID and Item Description in all applicable screens. Each functional area has a parameter called Display Item Image. If it is set to **Yes**, the image will be displayed in that functional dialog. If it is set to **No**, the image will not be displayed.

The Item Description will display with the first line displaying the short or long description based upon as system configuration. The second line will display the diffs, diff1, diff2, diff3, diff4. If there are no diffs for the item, the second line will be blank. The second line is also displayed per a system configuration.

Print

The **Print** dialog is accessed when selecting print within the application. It is available when selecting **Print** from the footer menu within a transaction.

The transaction format type or types that are applicable to the functional area will be available for selection. For example, in Customer Order Deliveries, there may be format types of Customer Order Delivery and BOL. If there is only one applicable format type for the functional area it will be defaulted.

Once a format type is selected, the system will list all the reports that are available to print for that format type. The report will default based upon the default format type. The user can choose to select a different report format to print if other report formats exist for this format type transaction. Once print has been selected for the report, the PDF is retrieved based upon the report format.

Print Tickets

The **Print Tickets** dialog is accessed by the user to print the tickets for the container items. This dialog can be accessed by selecting the **Print Tickets** option from the footer menu.

The Print Tickets dialog is available on the following transactions container items screen both via transaction and lookup.

- Direct Store Delivery
- Transfer Receiving
- Transfer Shipment

The system displays the following attributes for the user to select.

Format Type: This allows the user to select the format type. Item Ticket or Shelf Label. Default -Item Ticket.

Format: This will show the list of formats available for the selected format type for the user to select to which format the tickets should be assigned. Default format assigned for the selected format type will be shown as selected by default.

Quantity: This field indicates the quantity populated depending on the transaction and status. This is a read only field.

Values: Shipped, Received or Expected.


In case of Shelf Label, the quantity is 'Label Quantity or 1'.

Print Date: This field indicates the print date. This is a read only field.

When the user selects to print, the system displays the **Select Printer** screen for the user to select the printer to which the tickets need to be submitted to print.

Select Printer

On this screen the user can select the printer to set for the ticket printing.

On the top of the lists the system displays the paired Bluetooth printers.

The Bluetooth printers are indicated with the Bluetooth symbol and prefix 'BT' and these printers cannot be scanned.

This screen is for the user to select or scan the barcode of the printer and submit the tickets for printing.


This screen is accessed from the **Select Printer** option on the Auto Print Item, Manual Print Item screens and Print Tickets popup that appears when printing tickets from the container items screen.

This screen lists all the printers that are available in the system for the item tickets and label type.

The selected printer is displayed on the Auto Print Item and Manual Print Item screens for the user to know to which printer the tickets/labels are submitted for printing.

Notes

The Notes function is used to capture one or more notes about the transaction. It also allows you to view history or a trail of notes for a transaction. It is an optional process. The notes feature will be accessed from the footer menu within a transaction using the **Notes** menu option. Notes is available from within all transactions.

To add a note, select the **Add Note** button. The **Add Note** popup displays. Enter the note and then select **Post**. The note will be posted to the top of the list of notes in the Notes dialog. All notes will be listed in read-only mode with the user who created them and the creation date. Notes will always be available, and the user will always be able to add notes regardless of the transaction status. The user must have **Create Notes** permission to add notes.

Reset, Remove, and Restore Item

Within the footer menu (ellipsis) on most Item Detail screens will be options for **Reset**, **Remove**, and **Restore**. **Remove** and **Restore** are also displayed on most list of items screens, that is, Inv Adjust Items.

Reset will take all changes that have been made during the session and "undo" them back to the way the item was prior to entering the session. This option is only available


for items that were added before the current session and only applicable to items where updates can be made to the item.

Remove will allow for the removal of the item from the transaction. After selecting **Remove** the item will remain on the transaction, however it will be grayed out/disabled and changes cannot be made to the item. The item will remain on the transaction until it is saved/completed, which at that time the item will be deleted from the transaction.

Once an item has been marked for removal a **Restore** option will be available. **Restore** item allows for an item that is marked for removal to be unmarked. It will no longer be grayed out and the user will be able to edit the item where applicable.

Item Detail - UIN

The UIN tab will be accessible from Item Detail screen from within a transaction. The system must be configured for UINs and the item must be a UIN item.

UINs can be added to the adjustment for UIN items via the scan enter item bar in the header. A UIN can be removed by tapping the trash can which will flag the UIN for removal and it will be deleted from the transaction upon saving or confirming the transaction. Lastly those UINs that have been flagged for removal can be added back to the transaction by selecting the **Restore** option.



Item Detail - Attributes

Figure 2-21 Item Detail - Attributes




The Attributes screen is accessible from the Item Detail screen by selecting the **Attributes** icon. The store must be configured and the user must have Access <functional area> Attribute permission to Access the Attributes screen. In order to add and remove attributes the user must have Edit <functional area>Attribute permission. In addition, the item must be configured to be an item that has extended attributes. This screen will display attributes that may have been captured automatically from a GS1 barcode, or they may have been manually captured in this screen.

Sets of attributes can be captured manually by selecting the **Add Extended Attribute Set** button. The attributes to be captured depend on the attribute configuration for the item. A popup will be displayed to enter the attributes. Sets can be removed and then they will be flagged for deletion. Upon saving or confirming the transaction the flagged sets will be removed. The **Restore** feature will be available to bring back the attributes if necessary.

Item Detail - Scan Details

Figure 2-22 Item Detail - Scan Details




The last scan details are displayed on the bottom of all of the Item Detail screens in transactions of the mobile application. It includes the details from the barcode for the last item entered/scanned. This field is refreshed for each scan, so if an item has a quantity of 10, the Last Scan could have displayed different content for all ten barcodes/instances scanned.

- GS1 barcode - the system will display the barcode, GTIN, and the contents of the barcode (that is, price, UIN, and so on).
- Type 2, barcode, and Price.
- All other types of barcodes will display the actual barcode (UPC, UIN, and so on).



Figure 2-24 Scanner Config




- This screen on the mobile application is to configure the external scanners.
- The **Scanner Config** screen is displayed by selecting the **Scanner Config** menu option within **Configurations** from the drawer/menu.
- This screen will list all the paired/connected scanners to the device.
- Selecting the paired device will connect to the mobile device for the user in the application.
- If the device does not find any scanners paired/connected, it displays a message to indicate no scanners found.
- **Identify** - Upon selecting this button, the system makes the scanner you are connected to beep, so the user knows which one is used. Note: This button is displayed only in IOS.

For the scanner to find the external device, the location permission should be assigned to the client.

This screen is accessed on the mobile application by selecting the **Configure** option from the external **Scanner List** screen after an external scanner has been connected.

- **Scanner Name:** <Scanner Name> - the name of the connected scanners whose settings are displayed on the screen.
- **Battery Info Bar:** Visual progress bar showing the amount of battery remaining in the scanner:
 - The progress bar will be green if the battery remaining is greater than 30%.
 - The progress bar will be yellow if the battery remaining is between 15% and 30%.
 - The progress bar will be red if the battery remaining is less than 15%.
- **Battery %:** Shows the amount of battery life remaining as a numeric value (0-100%).

- **Battery State:** Will display either Charging or Discharging depending on if the battery is charging or discharging.
- **Scan Power Slider Bar:** Displays the amount of power each scan takes on a slider bar. The slider bar can be dragged to a new value. The values are between 0 and 300 dBm.
- **Scan Power Input Field:** Displays the amount of power each scan takes as a numeric value. A user can enter a new numeric value in this field. Any value less than 0 will be set to 0, and any value greater than 300 is set to 300. This value updates if the slider bar value is changed.
- **Scan Volume:** Displays the current beep volume during a scan and presents values in a drop down to change. Values are: Quiet, Low, Medium, and High.

Buttons

- **Apply:** Will apply the settings to the connected external scanner.
- **Identify:** Upon selecting this button, the system makes the scanner you are connected to beep, so the user knows which one is used. Note: This button is displayed only in IOS.


Figure 2-26 Welcome Screen



Figure 2-27 Menu/Drawer





The menu consists of the user's store to change stores, Favorites, Tasks, and Item Lookup.

From the menu/drawer the user can select Tasks to access various functionality of the application such as Lookups, Inventory Management, etc. The functional areas are displayed based upon the user's access permissions. Tasks can also be searched on.

Figure 2-29 Favorites




A favorite is a way of creating a shortcut for a task/menu that the user frequents often. A user's favorites are accessed by selecting the Favorites (star) option. The system will list all the favorites. Selecting a favorite will navigate into that dialog. The user can also search for a favorite and select the searched favorite and navigate into the dialog.


Figure 2-30 Quick Actions

Quick actions will include the same functionalities as the drawer menu such as Item Lookup, Quick Receiving, etc. User must have proper permission for the menu to display. Quick Actions will also be where User Preferences are accessed and an option for user to update UOM from here. The menu items on Quick Actions can be moved and rearranged by dragging and dropping allowing the user to put the more used / important menus at the top.

Figure 2-31 Select Store




The select store function is available from the drawer/menu by tapping the Store. It is also in the Additional Options menu (...) in the upper right hand corner on the Open Transactions by tapping the User and then selecting Change Store the user is directed to the Select Store screen with an option to change stores.

The Select Store displays all the stores that the user is authorized for. If needed, the user can search for a store by either the store ID or store name. The store list is narrowed down based upon the search. Selecting a store will display the new store in the store field of the drawer/menu. The user is then officially logged in to the new store. All data and transactions will be for the newly selected store. Every time the user logs in to the system, it will be for the store selected until a new store is selected. The system remembers/saves the store for the user.


Figure 2-32 Select Language



The **Select Language** screen is displayed by selecting the **Change Language** menu option within the Additional Options menu (...) in the upper right hand corner on the Open Transactions. Initially when a user is logging into the mobile for the first time ever, it will use the language of the device. The **Language** screen will display with a list of the available languages supported in the system. User selects a language, and the language will change in the application to the language selected and user will navigate to the **Open Transactions**. That language will remain for the user (saved on the user) until the user change languages. The locale of the device (date format, currency format, and so on) will remain that of the device


Figure 2-33 Preferences



The Preferences dialog is accessed by selecting Preferences from the Quick Actions menu or by selecting Preferences from the Additional Options (...) menu in the upper right hand corner. Preferences are for the user on the JET Mobile application. Preferences include: displaying images, scan navigation preference, Scan Type, Scan Mode, and UOM. The Display Images preference will be available if the system setting, Display Images is set to 'Yes'.

Scan Type

The **Scan Type** is found in preferences. It is used whenever an item can be entered or scanned within a Scan Bar. The scan type allows you to tell the system what type of item or barcode is being entered.

The only value for this is **Auto**.

Auto assumes that you can enter or scan any of the supported barcode types such as SKU, type 2, UPC E, GS1, UIN, and so on, and the system will parse through the various algorithms to derive the item.

Figure 2-35 Select Scan Mode




Figure 2-36 Select Scan Mode on Scan Bar



The **Scan** mode is found in preferences. It is used whenever an item can be entered or scanned, and the quantity is captured. The scan mode in preferences will be used to default in the scan mode on the scan bar. The default scan mode in preferences when logging into the system initially will be 'Increase'.

The scan mode will update the quantity as follows:

- Increase: Adds to the existing item quantity. The Scan Bar will show a '+' sign
- Decrease: Removes from the existing quantity. The Scan Bar will show a '-' sign
- Review: No change to the quantity. The Scan Bar will show an 'Eye' icon

The user can change the scan mode in the scan bar, and that will be the scan mode used upon entering / scanning an item, it trumps that of the preferences. The system will retain the scan bar defined scan mode until the user logs out of the session. Upon relogging in, the system will default the mode in the scan bar to the scan mode defined in the preferences.

Figure 2-37 Select Unit of Measure





Figure 2-38 Unit of Measure




The **Unit of Measure** selection is found on the Quick Actions menu as well as in Preferences. It is used whenever a quantity is captured. The unit of measure defines if the quantity displayed is going to be represented in the item's standard unit of measure, cases, or transaction unit of measure.

When switching the Unit of Measure, the quantity on the screen will convert to that unit of measure. When first logging in, the default unit of measure will be set based upon the system configuration **Default Unit of Measure**. The Unit of Measure selected by the user will remain as the UOM until the user changes it or Resets Application.

Transaction Unit of Measure will only be used where applicable which is in Customer Orders as well as Shipping and Receiving for a Customer Order. If Transaction UOM is selected in dialogs where it is not applicable, the system will use the Standard Unit of Measure even though the Transaction UOM may be selected.

Edit Quantity


The **Edit Item Quantity** popup is used whenever there is an editable numeric field such as an item quantity field. The quantity that gets entered into the **Edit Item Quantity** popup will increase, Decrease, or override the existing quantity on the screen. The mode on the **Edit Item Quantity** will be defaulted per the system setting, **Manual Quantity Entry Default Mode**. When set to **Scan Mode**, the **Edit Item Quantity** popup defaults based upon what the Scan Mode is set to in Preferences. When set to **Override** the default will be **Override**. In all cases, these are only defaults, and the user can always change mode of the **Edit Item Quantity**.

Examples:

- Qty = 15, enter in 3 increase, Qty = 18
There is a quantity of 15 on the UI. In the popup, the user enters a quantity of three, selects the increase option, and apply. The new quantity is 18.
- Qty = 15, enter in 3 reduce, Qty = 12
There is a quantity of 15. In the popup, the user enters a quantity of three, selects the decrease option, and apply. The new quantity is 12.
- Qty = 15, enter in 3 override, Qty = 3
There is a quantity of 15. In the popup, the user enters a quantity of three, selects override, and apply. The new quantity is three.

Filter Bar

Figure 2-40 Filter Bar




The **Filter** bar is used to narrow down a list of things such as items, containers, stores, and so on.

You can tap and type into the filter bar or tap and scan into a filter bar. By default, the **Filter** bar will be displayed on the top of the list. When scrolling down in the list, the filter bar disappears, and it reappears when scrolling back up in the list. The criteria that a user can filter on will be unique per functional area. The search is not case sensitive. The filter can be cleared out to return the full list. The filter will retain the entered criteria until leaving the screen in which it will be cleared out.

Scan Bar

The scan bar is at the bottom of the transaction lists, Item Lists, other lists such as Child Count and Container Lists, and Item Detail screens. It will be anywhere an item, or some other attribute can be entered or scanned to be viewed or edited on a transaction.

This bar allows for one defined attribute to be scanned and that attribute will be stated in the text of the bar. For example: Item, Container or Customer Order ID.

In the Transaction List screens, the scan bar will further filter or funnel down the list of transactions when doing a scan. The scanned attribute will be added in addition to the existing search criteria. It will appear in the search criteria field.

When scanning /entering items from Item Lists, if the Scan Navigation user preference is set to 'Yes' (meaning navigate), the user will navigate to the item detail screen for that item. The quantity will be updated per the scanned/entered item barcode.

If the Scan Navigation user preference is set to 'No' (meaning do not navigate), the user will stay on the Item List and focus will be brought to the that item in the list. The quantities for the item will be updated on the list per the scan/entry of the barcode. This is only applicable in the case where a quantity is editable on the list screen. If the list does not have an editable quantity, then the system will always navigate to the Item Detail on scan.

Figure 2-42 Search Criteria 1




Figure 2-43 Search Criteria 2

Item image is displayed based upon a user Preference, Display Images. If it is set to Yes, the image will be displayed in the application for the user. If it is set to No, the image will not be displayed.

The Item Description will display one or two lines depending on the system configuration, Display Item Description Diffs. If it is set to Yes, line one will display either the short or long description per the system configuration Display Item Description. The second line will display the diffs for the item if they exist otherwise it will be blank. If the Display Item Description Diffs. If it is set to No, only one line for the item description will be used and it will be the short or long description per the system configuration.

Print

The **Print** dialog is accessed when selecting print within the application. It is available when selecting Print from the footer menu within a transaction.

The list of applicable format types and report combinations will be given. The user can choose to select a different report format to print if other report formats exist for this format type transaction. Once print has been selected for the report, the PDF is retrieved based upon the report format.



The **Notes** function is used to capture one or more notes about the transaction. It also allows you to view history or a trail of notes for a transaction. It is an optional process. The notes feature will be accessed from the footer menu within a transaction using the Notes menu option. Notes is available from within all transactions.

To add a note, enter the desired text and select the Add Note button. The note will be posted to the top of the list of notes in the Notes dialog. All notes will be listed in read-only mode with the user who created them and the creation date. Notes will always be available, and the user will always be able to add notes regardless of the transaction status. The user must have Create Notes permission to add notes.

Item Detail Scan Details

The last scan details are displayed on the top of all of the Item Detail screens in transactions of the mobile application. It includes the details from the barcode for the last item entered/scanned. This field is refreshed for each scan, so if an item has a quantity of 10, the scan details could have displayed different content for all ten barcodes/instances scanned.

- GS1 barcode - the system will display the barcode, GTIN, and the contents of the barcode (that is, price, UIN, and so on).
- Type 2, barcode, and Price.
- All other types of barcodes will display the actual barcode (UPC, UIN, and so on).

Figure 2-48 Item Detail — UIN





Figure 2-49 Item Detail — UIN — Serial Number



- If the store is configured to process UIN Items and if the item is an UIN item, the system will allow to capture the UINs/Serial Numbers for the transaction.
- The user can access the UIN/Serial Number popup by selecting the Quantity Field on the item detail screen within a transaction.
- On the item detail screens for the UIN items, (AGSN and non AGSN), the quantity field is disabled and the selecting the edit quantity will take the user to the UIN/Serial Number popup screen.
- The Edit Quantity icon will be a <pen>+, + to show that UINs are needed.
- Quantity gets updated per UINs being added / removed on the UIN panel .
- The system does not look for the Edit Quantity permission for the UIN items to see if a quantity is editable or not. With UINs, the quantity field is always disabled with a few exceptions like receiving.
- On the Serial Number screen, the user can add or delete the serial numbers and it will be updated upon confirming the transaction.
- The user can select the Remove All option from the footer menu to remove all the Serial Numbers/UINs.

Figure 2-50 Item Detail




Figure 2-51 Extended Attributes





Figure 2-52 Add Attribute



Extended Attributes are added at the item level on transactions. They can be accessed on the transaction item list screen by selecting the line level overflow menu and then the Extended Attributes option. The Extended Attributes screen is also accessible from the Item Detail screen by selecting the < x> Extended Attribute Sets link.

The Use Extended Attributes config must be set to 'Yes' to use extended attributes for the store and the user must have permission for that functional area, Access functional area Attribute. In order to add and remove attributes, a user must have Edit <functional area> Attribute permission.

This screen will display attributes that may have been captured automatically from a GS1 barcode, or they may have been manually captured in this screen. Sets of attributes can be captured manually by selecting the Add Attributes button. The attributes to be captured depend on the attribute configuration for the item (setup on desktop). A popup will be displayed to enter the attributes. Sets can be removed by selecting the 'x' icon for the set. The quantity field will increment each time the GS1 Databar is scanned.



Figure 3-1 Open Transactions Screen Flow






The Open Transactions screen is accessed upon logon as well as by selecting **Open Transactions** from the menu drawer. The Open Transactions screen lists all the open transactions for the store you have permission to access. Selecting one of these transactions navigates you to the details for that transaction. The transaction can be viewed, edited, deleted, and so on, just as it would be had you navigated directly into that specific functional area. Once leaving the transaction you navigate back to Open Transactions.

Each transaction has a transaction ID and transaction type such as inventory adjustment, stock counts, and so on, for identification. The status, last update date, user, SKUs and not after date for the transactions will be displayed.

Open transactions are sorted based upon the **Sort** button. The sort defaults to oldest first and tapping on Sort allows you to change the sort to newest first.

The search eye glasses icon opens up a search criteria screen that can be used to further narrow down the list of open transactions. All applied search criteria will be displayed in this field. The Open Transactions list screen does not have any default search criteria initially when entering the screen.

The Select Users popup is displayed by swiping a transaction on [Open Transactions](#) and selecting the **Notify** button. The select users popup is initially an empty list and you must enter in either a full or partial (at least two characters) first or last name to search on. The system will return a list of valid user names (Last Name, First Name, and Middle Initial) for the store you are logged in to.



Note:

This popup is used to find user names and not roles.

Select a name from the list of results and the system will create an ad hoc notification for the open transaction to that user. The manually created ad hoc notification appears in the notification list screen of the selected user that was notified, upon logging in to that store. Open transactions can have more than one notification sent.

From the [Open Transactions](#) screen, selecting the search criteria button, which looks like a pair of eye glasses, takes you to the Search Criteria screen. This screen is used to narrow down the open transactions further and search for open transactions with specific criteria.



The user allows for searching on the User ID, this may be the last updated user ID or the create user ID depending on

the transaction. The search limit field is defaulted per the system admin setting and is used to determine the maximum number of records returned in the search.

Once search criteria have been selected and applied, you will navigate back to the Open Transactions screen with the list narrowed down per the entered criteria. The **Reset** button will clear out all entered search criteria and reset it back to the default criteria. Search criteria will be retained until being either reset or leaving the Open Transactions dialog.

Notification List

The Notification List screen is accessed by tapping the notification (bell) icon, in the Drawer Menu. The Notification List defaults to display all unread notifications for the user at the user's store. The notification may be system generated or manually created (ad hoc).

By default, the screen will display the notifications with the unread notifications first. The sort can be changed to newest first or oldest first. Notifications can be in a read or unread state with unread being denoted with a dot in front. The notification names, transaction ID, transaction type, create date, and user will be displayed for the notifications in the list. The notification name is displayed in user's preferred language.


Swiping a read notification will display a **Mark As Unread** button. Selecting **Mark As Unread** will set the status of the notification from read back to unread. The **Mark As Unread** button

will only be available for notifications that have been flagged. Selecting a notification will navigate the user to the details for that notification.

The search eye glass icon will open up a search criteria screen for the notifications which can be used to further narrow down the list of notifications. All applied search criteria will be displayed in this field. The default search criteria for the notifications will be for the unread status of notifications.

Figure 3-6 Search Criteria (Notification)





Criteria include Create From and Create To Date, status, notification ID and type, transaction ID and type, user, and search limit. The search limit is defaulted per the system admin setting and is used to determine the maximum number of records returned in the search.

Notification Detail

The Notification detail screen is accessed when selecting a notification from the [Notification List](#) screen. This screen displays the details of the notification.


The notification ID is a system-generated ID. The notification name is either 'Forward' with the transaction type for ad hoc notifications, or the subject line of the system-generated notifications. The transaction ID and transaction type are from the transaction of the notification. The create date is the date the notification was generated. The user is the user who created the notification; for system-generated notifications, the user is the user who triggered the notification such as the system or batch user. The status will either be read or unread. The notification name and description are displayed in user's preferred language.

When entering the notification, the status of the notification will automatically be marked to Read and the **Mark As Unread** option will be available within the footer menu. Selecting **Mark as Unread** will set the status back to Unread. Once the notification is in Unread status, the footer menu option will change to **Mark As Read**. The user can set the status back to Read by selecting this option.

Also within the footer will be a Notes option which navigates to the standard notes dialog for entering in notes about the notification. Lastly, in the footer is a **Go to Transaction** option which allows the user to jump into the transaction associated with the notification for the user's store. This option is only available to users that have access permission for the functional area. Once in the truncation transaction the user will be able to view, edit, delete, and so on, the transaction as they would had they entered it directly assuming the user has proper permissions. Once leaving the transaction the user will return back to the Notification Detail screen.

Notification Warning Display

A notification warning bar is displayed at the top of the application on every screen within the mobile application whenever a new notification comes into the system and is saved. The system checks every 'x' seconds for a new notification, where 'x' is a system configured amount of time. If a new notification exists for the user logged into the system, and if the user has the permission to display the notification warning, then the notification will be displayed. The user can access the details for the notification from the notification warning. The notification warning bar will be displayed until the user views or dismisses the notification or the user logs into a new session.




Figure 3-9 Open Transactions Screen Flow

From the Open Transactions screen, selecting the search criteria icon, takes you to the Search Criteria screen. The search criteria screen allows the user to search on additional fields to narrow down and find an open transaction. There is no default set for search criteria.

Criteria include a date range (for example, Last 3 days) and From and To Date, which look at the last updated date on the transaction if one exists, otherwise the create date. The transaction type is the type of the transaction such as stock count, customer order, and so on. The transaction ID will be the actual ID associated with the transaction, thus multiple transaction types may have the same transaction ID. The user allows for searching on the User ID, this may be the last updated user ID or the create user ID depending on the transaction. The search limit field is defaulted per the system admin setting and is used to determine the maximum number of records returned in the search.

Open status is represented by a group of statuses, and they can be different depending on the transaction. Open status will represent any status which is not completed, canceled or closed. In other words actions can still be taken.

Once search criteria have been selected and applied, you will navigate back to the Open Transactions screen with the list narrowed down per the entered criteria. The Reset button will clear out all entered search criteria and reset it back to the default criteria. Search criteria in Open Transactions will be retained forever until reset or changed by the user. This is different than other areas where criteria is reset upon leaving the area.


Notifications JET Mobile

The Notifications dialog lists all the notifications for the user at the user's store.



This is the screen flow for Notifications. Notifications can be accessed by selecting the **Bell** icon in the application panel footer menu. Notifications can be viewed (read), notes can be associated to a notification and a user can navigate into the details of the transaction associated with the notification. Lastly, an ad hoc notification can be sent from an open transaction.

Notifications

The Notifications screen is accessed by tapping the notification (bell) icon, in the Application Panel footer menu. The Notifications list defaults to display all unread notifications for the user at the user's store. The notification may be system generated or manually created (ad hoc).

By default, the screen will display the notifications with the unread notifications first. The sort can be changed to newest first or oldest first, or to story by transaction ID or type. Notifications can be in a read or unread state with unread being denoted with a dot in front. The notification names, transaction ID, transaction type, create date, and user will be displayed for the notifications in the list. The notification name is displayed in user's preferred language.

Swiping a notification gives a list of options to the user: Notes, Mark as Unread, Mark as Read, and Go to Transaction, Notes can be added using the standard noted dialog. If a transaction has not been read, the Mark as Read option will set the notification to 'Read'. If a notification has been 'read', then the Mark As Unread will set the status of the notification from read back to unread. Lastly, Go to Transaction will jump the user into the details of the transaction affiliated with that notification.

Selecting a notification will navigate the user to the details for that notification.


Selecting the search criteria button (eye glasses) from the Notifications screen, will take you to the Notification Search Criteria screen. This screen is used to search for notifications for the user's store with specific criteria. The header will show the number of criteria that have been applied. The Notifications search criteria will default to the status of unread.

Criteria include Date Range, Create From and Create To Date, status, transaction type, notification ID, transaction ID, user, and search limit. The search limit is defaulted per the system admin setting and is used to determine the maximum number of records returned in the search.

Once search criteria have been selected and applied, you will navigate back to the Notifications screen with the notifications narrowed down per the entered criteria. The search criteria will be retained until they are reset or when leaving the notifications dialog.

Notification Detail

The Notification Detail screen is accessed by selecting a notification from the list on Notifications. This screen is a read only screen that shows the contents of the notification.

The notification ID is a system-generated ID. The notification name is either 'Forward' with the transaction type for ad hoc notifications, or the subject line of the system-generated notifications. The transaction ID and transaction type are from the transaction of the notification. The create date is the date the notification was generated. The user is the user who created the notification; for system-generated notifications, the user is the user who triggered the notification such as the system or batch user. The status will either be read or unread. The notification name and description are displayed in user's preferred language.


When entering the notification, the status of the notification will automatically be marked to Read and the **Mark As Unread** option will be available within the footer menu. Selecting **Mark as Unread** will set the status back to Unread. Once the notification is in Unread status, the footer menu option will change to **Mark As Read**. The user can set the status back to Read by selecting this option.

Also within the footer will be a Notes option which navigates to the standard notes dialog for entering in notes about the notification. Lastly, in the footer is a **Go to Transaction** option which allows the user to jump into the transaction associated with the notification for the user's store. This option is only available to users that have access permission for the functional area. Once in the truncation transaction the user will be able to view, edit, delete, and so on, the transaction as they would had they entered it directly assuming the user has

proper permissions. Once leaving the transaction the user will return back to the Notification Detail screen.

Notification Warning Display


Figure 3-16 Notification Display



A notification warning bar is displayed at the top of the application on every screen within the mobile application whenever a new notification comes into the system and is saved. The system checks every 'x' seconds for a new notification, where 'x' is a system configured amount of time. If a new notification exists for the user logged into the system, and if the user has the permission to display the notification warning, then the notification will be displayed. The user can access the details for the notification from the notification warning.

Notify User

The Notify User screen is displayed by swiping a transaction on Open Transaction and selecting the **Bell** icon. To find a user to notify (not roles), click on the Search for User field. The common Select User screen is displayed to find a user. See Common Chapter.

A note can be added by the user to associate with the notification. The system will create an ad hoc notification for the open transaction to that user. The manually created ad hoc notification appears in the notification list screen of the selected user that was notified, upon logging in to that store. Open transactions can have more than one notification sent.

Ad Hoc Notifications

Ad hoc notifications are notifications that are created in an ad hoc basis by notifying one or more users about an open transaction from the [Open Transactions](#) screen.

They are sent on one user at a time and each message is treated individually.

The notification will get updated to 'read' and 'unread' on an individual user/message basis as they are read or marked to 'unread'.

Ad hoc notifications can be created for each of the transaction types from the Open Transactions.

- The notification ID will be system generated.

- The notification name will be set to 'Fwd: < transaction type>'.
- The transaction type will be set based upon the transaction that the notification was created from.
- Status will be 'Unread' for all users. Status will be updated for individual users as they get read.
- Create Date will be defaulted to the date/time the notification was generated.
- Description: 'Please look at this open transaction'.
- User: The user that generated the notification clicked the 'Notify' button on the open transaction.

System Notifications


For notifications that are created via the system, they are associated to a group (role) and as one user for that notification's role/store reads the notification (or unreads) it, it will update it for the entire group. The idea is that if you send out a notification to all store clerks you do not want to make them all read it.

The details of the notification will be populated as follows:

- The notification ID will be system generated.
- The notification name will be the Subject Line from the actual notification.
- The transaction type will be based on transaction that is associated with the notification.
- Transaction ID will be the actual transaction ID for the transaction.
- Status will be 'Unread' for all users of the role. Status will be updated for all of the role users as they get read (or Unread).
- Create Date will be defaulted to the date/time the notification was generated.
- Description: Body per the notification. Note this is restricted to 2000 characters, so it may get truncated.
- User: The user that generated the notification, since these are system generated it may be a user who triggered it, a batch user, or a system user, and so on.

Recently Edited JET Mobile

Recently Edited is accessed by selecting the Recently Edited icon (looks like a clock) from the Application Panel footer menu.

Recently Edited will display the last ten transactions that have been edited by a user at the user's store. It displays unique transactions, so if the user edited the same transaction more than once it will only display the last instance.



Item Lookup MAF Mobile

The Item Lookup functionality provides the business user with the ability to view information related to an item. In addition, the Item lookup can also be used in conjunction with other screens to assign items to a transaction. The system provides real-time information on inventory positions and other item detail information.

Figure 4-1 Item Lookup Screen Flow



- Non-Sellable

When navigating to Item Lookup, you are taken to a blank list screen where no item results are displayed.

Use the search criteria, eye glasses, to navigate to the Item Lookup Search Criteria screen to enter search criteria for items to find. After applying the search criteria, the results are listed on the screen and the criteria applied is shown next to the eye glasses.

The details of the item such as Item ID, Item Description, Available SOH, Price, Price Type, and Item image (if configured) are displayed in this screen in order to provide certain basic information about the items. The pricing related information (Price and Price Type) are displayed only when the system configuration parameter 'Display Price in Search Result - Execution' is set to 'Yes'.

If the system setting, 'Filter Merchandise Hierarchy' is set to 'Yes', the list of items returned will be restricted to those departments that the user has department data permissions for. If it is set to 'No', the system will return the list of items based upon all departments without restriction.

Selecting an item from the results list navigates to the item detail for that item.

When scanning or entering an item in the scan bar, the system ignores all entered search criteria and searches for the item entered. If it results in a single item, the system takes the user automatically to the item details. If more than one item is found, it provides an item selection to select the proper item.

The system will validate the 'Allow Item Lookup for Non-Ranged Items' system setting. If it is set to 'Yes', and if the user scans/enters a non-ranged item, the item will be returned. If the setting is set to 'No', and if the user scans/enters in a non-ranged item, the system will not return the item. Note: the system setting 'Allow Non-ranged Items' is not validated here, the setting described above takes precedence.

If it results in a single item, the system takes the user automatically to the item details. If more than one item is found, it provides an item selection to select the proper item.

Item Lookup Search Criteria

From Item Lookup, selecting the search criteria button, which looks like a pair of eye glasses, takes you to the Item Lookup Search Criteria screen. This screen is used to search for items using specific search criteria.

The Item Lookup Search Criteria screen will be different and contain different search criteria depending on the Search Mode. The user can choose to find items by item number, supplier, warehouse, finisher, UDA, Inventory Status, or style. Depending on which search mode is selected, the search criteria fields change. All search modes, except for searching by style, have common search criteria consisting of item description, brand, non-ranged indicator, search limit, department, class, and sub-class.

Item Description: This field holds an item description, which you enter to search. You can search on partial description as well, meaning that if the Item Description contains what is entered in this field, results are returned. This search criterion can be used for any other search type except when searching by Style.

Brand: This field holds the brand, where you enter to search. Enter a brand for the item. The system returns all items for the brand specified. This search criterion can be used for any other search type except when searching by Style.

Dept: This field allows you to select from a list of available Departments for the selected group. This search criterion can be used for any other search type except when searching by Style.


Class: This field allows you to select from a list of available classes for the selected department. This field is only enabled if a department has been selected. This search criterion can be used for any other search type except when searching by Style.

Sub-Class: This field allows you to select from a list of available sub-classes for the selected department/class. This field is only enabled if a department and class has been selected. This search criterion can be used for any other search type except when searching by Style.

Include Non-Ranged: When the Include Non-Ranged check box is checked, the system returns items that exist but may not have been ranged to your store, in other words, the item record does not exist for your store. When it is not checked, only those items that are for your store are returned. If searching for an item by item number, the system ignores this indicator and navigates to the details regardless if the item is ranged or non-ranged. The Include Non-Ranged check box will be displayed on the screen as a search option if the system setting, “Allow Item Lookup for Non-Ranged Items” is set to ‘Yes’. If the setting is ‘No’, then the check box will not be displayed on the screen and non-ranged items will not be included.

Searching by Item

Item

This field holds an item number, which you enter to search. Partial searches are not permitted on the item number. You can enter an item number, TUC, UPC/EAN, Type 2, GS1 Databar, VPN, or SEL (shelf edge label) into this field. The system can locate the specified item.

Entering an item ID to search on ignores all other criteria entered. The system will validate the ‘Allow Item Lookup for Non-Ranged Items’ system setting. If it is set to ‘Yes’, and if the user keys in a non-ranged item, the item will be returned. If the setting is set to ‘No’, and if the user keys in a non-ranged item, the system will not return the item. Note: the system setting ‘Allow Non-ranged Items’ is not validated here, the setting described above takes precedence.

Searching by Supplier

Supplier

This field holds a supplier number, which you enter to search. The user can search for items by primary and non-primary suppliers.

Primary Supplier (Check Box)


The Primary Supplier Check Box determines whether to display all items supplied by the entered supplier (based on the Supplier or Supplier Name search fields) or only display items where the entered supplier is the primary supplier for that item:

If the indicator is checked, the system only displays items where the entered supplier is the primary supplier of the item. This is the default.

If the indicator is not checked, it displays all items supplied by the supplier ID that was entered in the search criteria field, regardless of whether the entered supplier is the primary supplier. In this case, you may see items in the search results that have a different supplier ID and name than what was entered in the search criteria. This means the item is supplied by the entered supplier but has a different primary supplier.

Searching by Style

Style (Item ID)

You can search on a style item ID. The Item Description, Brand, Department, Class, and Sub-Class search options do not display when the Style Search option is selected. Enter in a style item (style is where the item level is above the transaction level), and the system returns all the transaction level children that are related to the style parent/grandparent.





This field allows you to pick a specific User Defined Attribute (UDA) and enter the corresponding search criteria. For an item to be returned, it must match all criteria entered.

Text

This field allows you to enter any part of the UDA text. Wild card searches are also allowed.

Date Range

Inventory Status


This field allows you to search by available or unavailable inventory status. The system returns all items that match the status selected by you. If Available is selected, the system returns the items that have available inventory. If unavailable is selected, the system returns the items that have non-sellable unavailable inventory. This search feature gives you a way to search for items that have unavailable inventory which might need further action. It can be especially useful when looking up items when creating inventory adjustments.

Sub-Bucket

This field allows you to continue to filter down by sub-bucket. Sub-buckets are only an option if the system is configured to use sub-buckets. The Inventory Status must be selected as Unavailable for the Sub-bucket filter to be enabled. The system returns all items that match the selected Inventory Status and Sub-bucket.

Item Detail

Selecting an item on the [Item Lookup](#) screen brings you to the **Item Detail** screen. The header shows the item number, description, unit of measure, and item image if configured to show images. 

The item basket will be 'static' and available in the Item Basket dialog of both the desktop and mobile.

Stock On Hand

This screen shows all the various stock on hand buckets including total SOH, available SOH, shopfloor, backroom, delivery bay, unavailable SOH, transfer reserved, RTV reserved, customer order, and nonsellable.



Note:

The shopfloor and backroom buckets are only displayed when the parameter Display Shopfloor/Backroom quantity= Yes.

The delivery bay bucket is only displayed when the parameter called Replenishment - Delivery bay inventory is set to **Yes**.



Pricing is accessed by selecting the **Pricing** option on [Item Detail](#). The Pricing screen displays the Pricing Details for the item and your store. The user will be able to select the time drop down option to state if they want to show the prices that are current /


past or those that are future events. Future events can only be seen by users that have the Access Future Price Events permission.

Current / Past price changes will show all price histories for the item at the user's store. If all price events are regular price changes, then only regular price events will be displayed. If there is at least one clearance, then the system will display the clearance and the regular price changes, however many exist. Each price event is represented in as a set. The sets of price events are ordered by Effective Date/Time with most recent on the top (descending). The pricing screen will display the end date of the price event, be it a promotion, clearance, or regular price change.

Additional information may also be helpful to view about an item. The following are some additional item attributes available on this screen.

UPC: UPC for the item.

Pack Size: This field holds the pack size (number of items in a supplier case) of this item:

The pack size is populated from the item/supplier/country record for the primary supplier.

For non-ranged items, this value is pulled from the master item data, for the default supplier.

Ticket Type: Merchandising suggested ticket type code/format.

Orderable: Yes/No; indicates if the item can be ordered.

Sellable: Yes/No; indicates if the item is sellable.

Pack Item: Yes/No; indicates if the item is a pack item.





Figure 4-18 Non-Sellable Screen







Figure 4-21 Item Locations Screen




Figure 4-22 UDAs Screen

Figure 4-23 RFID Locations Screen






Figure 4-24 Item CFAs Screen




Figure 4-26 Customer Orders Screen

Figure 4-27 UINs Screen








Figure 4-30 Inv Adjust list

Figure 4-31 Item Lookup Screen Flow







Item Lookup Screens





When navigating to Item Lookup, you are taken to a blank list screen where no item results are displayed.

Use the search criteria, magnifying glass, to navigate to the Item Lookup Search Criteria screen to enter search criteria for items to find. After applying the search criteria, the results are listed on the screen and the criteria applied is shown.

The details of the item such as Item ID, Item Description, Available SOH, Price, Price Type, and Item image (if configured) are displayed in this screen in order to provide certain basic information about the items. The pricing related information (Price and Price Type) are displayed only when the system configuration parameter 'Display Price in Search Result - Execution' is set to 'Yes'.

If the system setting, 'Filter Merchandise Hierarchy' is set to 'Yes', the list of items returned will be restricted to those departments that the user has department data permissions for. If it is set to 'No', the system will return the list of items based upon all departments without restriction. Selecting an item from the results list navigates to the item detail for that item.

When scanning or entering an item in the scan bar, the system ignores all entered search criteria and searches for the item entered. If it results in a single item, the system takes the user automatically to the item details. If more than one item is found, it provides an item selection to select the proper item.

The system will validate the 'Allow Item Lookup for Non-Ranged Items' system setting. If it is set to 'Yes', and if the user scans/enters a non-ranged item, the item will be returned. If the setting is set to 'No', and if the user scans/enters in a non-ranged item, the system will not return the item. Note: the system setting 'Allow Non-ranged Items' is not validated here, the setting described above takes precedence.

If it results in a single item, the system takes the user automatically to the item details. If more than one item is found, it provides an item selection to select the proper item.

Item Lookup Search Criteria

From Item Lookup, selecting the search criteria button, magnifying glass, takes you to the Item Lookup Search Criteria screen. This screen is used to search for items using specific search criteria.

The Item Lookup Search Criteria screen will be different and contain different search criteria depending on the Search Mode. The user can choose to find items by item number, supplier, warehouse, finisher, UDA, Inventory Status, or style. Depending on which search mode is selected, the search criteria fields change. All search modes, except for searching by style, have common search criteria consisting of item description, brand, non-ranged indicator, search limit, department, class, and sub-class.

Item Description: This field holds an item description, which you enter to search. You can search on partial description as well, meaning that if the Item Description contains what is entered in this field, results are returned. This search criterion can be used for any other search type except when searching by Style.

Brand: This field holds the brand, where you enter to search. Enter a brand for the item. The system returns all items for the brand specified. This search criterion can be used for any other search type except when searching by Style.

Dept: This field allows you to select from a list of available Departments for the selected group. This search criterion can be used for any other search type except when searching by Style. If the system setting, "Filter Merchandise Hierarchy" is set to 'Yes', then the system will only list those departments that the user has data permissions for. If it is set to 'No', then all departments will be listed.

Class: This field allows you to select from a list of available classes for the selected department. This field is only enabled if a department has been selected. This search criterion can be used for any other search type except when searching by Style.

Sub-Class: This field allows you to select from a list of available sub-classes for the selected department/class. This field is only enabled if a department and class has been selected. This search criterion can be used for any other search type except when searching by Style.

Item Status: This field is a drop down listing all the various statuses of an item and enables you to lookup for items in a particular status. List of values include 'Ranged', 'Active', 'Discontinued', 'Deleted', 'Inactive', 'Temporary' (Ranged in the Inventory system and not yet approved in the Merchandising system), 'All Items'.

Selecting Ranged, the system will return items in the 'store' in statuses Active, Discontinued, Deleted, Inactive, Temporary.

Selecting Active, the system will return items in the store in status 'Active'. Same case with Discontinued, Deleted, Inactive, Temporary statuses as well.

Selecting All Items, it returns items in all statuses from Item master table. This can be used if you want to include 'Non-ranged' items. Note: the system does not validate the system setting 'Allow Non-Ranged Items'.

System will validate the 'Allow Item Lookup for Non-Ranged Items' system setting. If it is set to 'Yes', all statuses of items, including non-ranged, will be returned when selecting 'All Items' from the list. If this setting is set to 'No' then non-ranged items will not be returned in the list of items.











Pack Size: This field holds the pack size (number of items in a supplier case) of this item. The pack size is populated from the item/supplier/country record for the primary supplier. For non-ranged items, this value is pulled from the master item data, for the default supplier.

Pack Item: Yes/No; indicates if the item is a pack item

Pack Type: the type of pack item: item, simple, complex, simple breakable pack, complex breakable pack

Store Pack Inventory: Yes/No; indicates tells the system when an item will only be sold and tracked as a pack

Ticket Type: Merchandising suggested ticket type code/format

Non-inventory: Yes/No; indicates if the item is flagged as non-inventory.




Figure 4-44 Order Attributes Screen





Figure 4-47 Pack Contents Screen







Figure 4-51 RFID Locations Screen









Figure 4-53 Suppliers Screen


Figure 4-54 Select Printer Screen

Figure 4-55 Adjust Inventory Screen









Figure 4-63 Supplier Lookup Screen Flow








Figure 4-67 Address Type




Figure 4-68 Additional Details







Figure 4-71 Container Lookup Details






Figure 4-74 Container Lookup Item Detail Screen (Transfer Receiving)






Figure 5-1 Inventory Adjustment Mobile Screen Flow


Figure 5-3 Search Criteria Screen (Inventory Adjustments)

The **Inv Adjust Items** screen is where a new adjustment is created. Initially, this screen will not have any items. The items screen is also displayed when selecting an existing adjustment. The items are listed for the adjustment. The item image for the line items is displayed per configuration.

Line items appear in a list and selecting a line item navigates to the item details of that item. If the item scanned is a UIN item, the user will directly navigate to the UIN tab in the Item Detail screen.

If an item has been changed in the current session, it is indicated by a bar on the left of the item. Scrolling in the list of items displays a filter. The filter can be used to narrow down the list of items. Filtering can occur by item ID, description, reason, and unit of measure.

A reason code must be selected before being able to add or edit an item on the adjustment. The reason code selected is at the header level and is applied to all newly added items until it is changed to a different reason in which the newly changed reason is added to the items. The reason codes have a disposition associated to them which determines stock movement of the item. See [Inventory Adjustments Process](#).

Scanning or entering an item in the scan bar navigates you to the [Item Detail](#) screen for that item. The quantity may be updated depending on the scan mode.

The item must be unique on the adjustment.

The ellipsis in the lower right hand corner accesses the footer menu which contains all of the functions that can be performed on an inventory adjustment.

Footer Menu

The footer menu is accessed from the ellipsis footer menu on the Inv Adjust Items screen. The menu functions include the following:


- **Info:** Accesses the Info popup.
- **Notes:** Accesses the notes dialog to capture notes.
- **Edit CFAs:** Lets the user enter values for the CFAs that are set up for inventory adjustments.
- **Confirm:** Confirms and completes the adjustment. All stock on hand updates are made and the adjustment is published out.
- **Save:** Saves the adjustment in 'In Progress' status to be completed later.

Saving an adjustment does not publish the adjustment nor does it reserve any inventory; it simply saves it. The Save button can be used to implement a Save and Approval process. After saving, user will be taken to the Inv Adj List screen.

- **Save and Continue:** This will perform the same function as 'Save' option however the user remains in the same screen after save.
- **Delete:** Marks the inventory adjustment to 'Canceled' status.
- **Cancel:** Exits the adjustment; changes made in that session are not saved.
- **Print:** Displays the common print dialog to print the inventory adjustment report.
- **Copy:** The copy function is only available for those adjustments in a 'Completed' status. It takes the current adjustment, copies the items, reasons, and quantities, and creates a new editable adjustment with a new ID. It references the copied adjustment's ID.

Item Detail

The **Item Detail** screen is used for selecting or scanning an item from the [Inv Adjust Items](#) screen. Scanning or entering an item on this screen in the scan bar, updates the quantity per the scan mode and refreshes the Item Detail screen for the item and quantity scanned.

The quantity can be edited and updated manually if permissions allow. The system validates the inventory bucket based upon the disposition associated to the reason code. A reduction adjustment in inventory may exceed available inventory, bringing total available as a negative value. However, an unavailable inventory adjustment can never make the non-sellable unavailable bucket go negative. The same is true for sub-buckets, when sub-buckets are used, the reduction of a sub-bucket must be less than or equal to total quantity of such a sub-bucket. Increases for available, or non-sellable unavailable have no restriction.

The item information including the image (which is system configured) displays in the header. The bottom portion of the screen contains information fields for reason code, disposition, sub-bucket (if system configured), and the stock on hand pertaining to the bucket in which the

stock is coming from. At the bottom of the screen the details of the last scanned barcode will be displayed.

The footer menu, ellipsis button, contains a reset function as well as remove and restore functions. You can page through existing items on the adjustment using the arrows on the bottom.

The **Item Detail** screen has a UIN tab to take user to the UIN screen to add/remove UINs for UIN items (if system is configured to use UINs and if the item is a UIN item). If the user scans a UIN item, the user will directly navigate to the UIN tab in the Item Detail screen for that item.

- All non-AGSN (Auto Generated Serial Numbers) UINs require UINs to be captured, regardless of the disposition of stock movement. The quantity field cannot be entered for non AGSN UIN items. It gets updated as the UINs get added and removed from the adjustment.
- For AGSN items, if a reason code has a disposition of anything except Out of Stock to In Stock (+Stock on Hand), a UIN is required to be captured. This is because the UIN already exists in the system and the system needs to know which AGSN UIN is being adjusted. In this case, the quantity field cannot be entered; it is updated as the AGSN is added/removed.
- For AGSNs being adjusted from Out of Stock to In Stock (+ Stock on Hand), the system auto generates the AGSN number and print upon completion of the adjustment. This means that capturing of the AGSN is not required and the quantity can be entered. However, you may still capture the serial number if one exists. In this case, the system auto-generates the serial numbers and print for those where the quantity entered exceeds the UINs captured.

The Extended Attributes tab enables the user to view/capture Extended Attributes for the item. If the item is not configured to capture extended attributes or there are no extended attributes captured, the list will be empty.

Figure 5-6 Edit CFAs Screen



The value captured for the CFAs will also be displayed. If value has not been captured, it will display blank.



Figure 5-8 Inventory Adjustment Mobile Screen Flow




Inventory Adjustments are accessed through the Inventory Adjustment menu within the drawer or from Quick Actions. Selecting the menu option takes you to the

Inventory Adjustments screen. On this screen you can search for adjustment records that will be returned in this list. The user can create an inventory adjustment by selecting the Create New option or select an existing adjustment from the list will take the user to the Inventory Adjustment Items screen where the user can edit, copy, or view items on the adjustment. The user can add, view, and edit the details of the items on the Item Detail screen. CFAs (Custom Flexible Attributes) can be set up for inventory adjustments via the Information screen where additional details about the adjustment can also be viewed.

When navigating to Inventory Adjustments, the Inventory Adjustments screen displays by default the 'In Progress' adjustments as the default list. The list can be sorted by select the sort icon.

A search can be done by selecting the search option (magnifying glass) to navigate to the Search Criteria (Inventory Adjustment) screen to enter search criteria for the inventory adjustments. The user will return to this list with the results updated.

When scanning/ entering an item in the scan bar, the system adds the item to the entered search criteria and narrows down the current list of adjustments.

Creating a new adjustment directs you to the Inventory Adjustment Items screen with no details (items) to build a new inventory adjustment. Selecting an adjustment from the list navigates you to the details for that adjustment.



The **Inventory Adjustment Items** screen is where a new adjustment is created. Initially, when creating a new adjustment, this screen will not have any items. This screen is also displayed when selecting an existing adjustment from Inventory Adjustments. When viewing or editing an existing adjustment, the items are listed for the adjustment. User must have edit permissions as well as data permissions for all reason codes in order to edit an adjustment. There is a Filter bar to filter on items by: Item ID, Item Description, Reason Code and UOM. The user can also sort the list of items by Item ID or Item Description. The header will contain the ID, create date, and status of the adjustment.

A reason code must be selected before being able to add or edit an item on the adjustment. The Active Reason Code that is selected at the header level is applied to all newly added items until it is changed to a different reason. Once changed, the new reason is added to the items added from that point, it will not impact already added items. If an item is added/ scanned and a reason code has not yet been selected, the user will be directed to select a reason code first. Reason Codes can be edited for a specific item on the Item Detail screen. See Inventory Adjustments Process for more detail on Reason Codes and Dispositions.

Items will appear in the list. The item image for the items is displayed per user preference. Item description, ID, and Reason Code will also be displayed. The quantity to be adjusted will be editable if the user has, 'Edit Quantity' permission. The UOM for the quantity will be shown

per UOM selected in user preferences and the quantity will be converted per the UOM. The Pack Size will be displayed if the UOM is in cases.

Quantity Validations: The system validates the inventory bucket based upon the disposition associated to the reason code. A reduction adjustment in inventory may exceed available inventory, bringing total available as a negative value. However, an unavailable inventory adjustment can never make the non-sellable unavailable bucket go negative. The same is true for sub-buckets, when sub-buckets are used, the reduction of a sub-bucket must be less than or equal to total quantity of such a sub-bucket. Increases for available, or non-sellable unavailable have no restriction.

Selecting a line item navigates to the item details of that item. Scanning or entering an item in the scan bar will navigate the user per the User Preference, Scan Navigate. The user will either go to the Item Detail for the item or stay on the Inventory Adjustment Items screen. The quantity may be updated depending on the scan mode. Items can only appear once on an adjustment transaction.

If the store is configured for UINs: If the item is a UIN item there will be a UIN icon denoted. Scanning an item that is a UIN item, the user will directly navigate to the UIN screen to capture UINs. Selecting the quantity for a UIN item will also navigate to the UIN screen to capture UINS.

Each item will have an ellipsis line item menu. The user can choose to delete an item, which will remove the item from the transaction. Also the user can view/capture Extended Attributes for the item. Once extended attributes are captured, there will be an icon for the attributes on the item.

Footer Menu

- **Confirm:** Confirms and completes the adjustment. All stock on hand updates are made and the adjustment is published out. User must have permission to confirm as well as data permissions for all reason codes.


The footer menu is accessed from the ellipsis footer menu on the Inventory Adjustment Items screen. The menu functions include the following:

- **Notes:** Accesses the notes dialog to capture notes.
- **Print:** Displays the common print dialog to print the inventory adjustment report.
- **Info:** Accesses the Information screen to view transaction level info as well as enter values for the CFAs that are set up for inventory adjustments.
- **Back:** only for view only adjustments. Will exit the user back to where they came from.
- **Cancel:** Exits the adjustment; changes made in that session are not saved.
- **Delete:** Marks the inventory adjustment to 'Canceled' status. User must have permission to Delete as well as data permissions for all reason codes.
- **Copy:** The copy function is only available for those adjustments in a 'Completed' status. It takes the current adjustment, copies the items, reasons, and quantities, and creates a new editable adjustment with a new ID. It references the copied adjustment's ID.
- **Save and Exit:** Saves the adjustment in 'In Progress' status to be completed later. Save and Exit: Saves the adjustment in 'In Progress' status to be completed later.


Figure 5-12 Reason Code Screen



The Reason Code screen is navigated to when selecting the Active/Header level reason code on the adjustment as well as on the line item of the adjustment. The Reason Code screen is used for selecting a Reason Code on the Inventory Adjustment. The current active reason code is displayed at the top, if there is one. Those reason codes defined on the desktop with a 'Use in UI' flag of 'yes' will be displayed here. The user will only see those reason codes in the list that the user has data permissions for. The reason codes will be listed along with the associated disposition. The list can be filtered down.

The **Item Detail** screen is navigated to by selecting an item from Inventory Adjustment Items or by entering/scanning an item based upon Scan Navigate user preferences. Scanning or entering an item on this screen, updates the quantity per the scan mode and refreshes the Item Detail screen for the item and quantity scanned.

The header includes the active reason code. This is the reason code that is applied to newly added items as a default reason code. The details of the last scan are displayed as well as paging to allow to page through the items on the adjustment. Item information includes the image (per user preference), ID, description, and the primary location. Selecting the primary location will display the Item Locations for the item.

The line level reason is defaulted per the Active/Header level reason code. It can be updated for this specific item at the line level, if needed. The corresponding disposition will be displayed as well as the sub-bucket if there is one and if the store is configured for sub-buckets.

The quantity can be edited and updated manually if permissions allow. If the UOM is in cases, the pack size will be displayed and allow for editing per the system admin setting. If the item is a UIN item, selecting the quantity will navigate to the UIN screen to capture UINs. Same quantity validations as on Inventory Adjustment Items.


The Extended Attributes link navigates to the Extended Attributes screen. The user can view/capture Extended Attributes for the item. If the item is not configured to capture extended attributes or there are no extended attributes captured, the list will be empty.

The bottom portion of the screen contains read only information regarding inventory. Available Inventory is always displayed. Unavailable will display if disposition is to / from unavailable. Customer Order Reserved will show if the disposition is to or from the customer order reserved bucket. Lastly, the sub-bucket will show if store is configured for sub-buckets and disposition is to / from an unavailable sub-bucket.

Lastly, in the footer menu the user has the option to delete an item. Delete will remove the item from the adjustment.

UIN

The UIN screen allows a user to add/remove UINs for UIN items (if store is configured to use UINs and if the item is a UIN item). If the user scans a UIN item, the user will directly navigate to the UIN screen for that item.

- All non-AGSN (Auto Generated Serial Numbers) UINs require UINs to be captured, regardless of the disposition of stock movement. The quantity field cannot be entered for non AGSN UIN items. It gets updated as the UINs get added and removed from the adjustment.
- For AGSN items, if a reason code has a disposition of anything except Out of Stock to In Stock (+Stock on Hand), a UIN is required to be captured. The Item Maintenance screen can be accessed in the following ways:

- Clicking on **Item Maintenance** from the drawer menu in the main screen.
- Clicking on **Item Maintenance** from the Quick Actions menu.

Note:

The user must have Access Item Maintenance security permission to access this screen.

The user can perform multiple actions from this screen: adjust Shop floor/Backroom inventory, request items (store order), add/remove the item from item basket and print ticket.

Sections

Inventory

The Inventory section allows for a direct update to the Shop Floor and Backroom inventory buckets if the 'Display Shop floor / Backroom quantity' store parameter is set to 'Yes'. If it is set to 'No', then the Available Inventory bucket can be adjusted. The shop floor / backroom adjustment will be controlled via security permissions existing for inventory adjustment.

Order

The Order section is displayed and editable if Access Store Orders permission is set to Yes. This section allows the user to create a store order for the item scanned. Item must be 'Active' status. Store Order Allowed is 'Yes.' This is a store re-orderable indicator that is sent on from merchandising (ItemLocVirt). If the item is an 'SO' item, the reject indicator must be 'No'. If any of these conditions are not met, then the order section will not be editable.

Sales History and Sales Forecast

Sales History will display if the user has 'Display Sales History' permission. This data is populated from Transaction History. Sales Forecast will display if the user has 'Display Sales Forecast' permission. For forecast information, EICS must also be configured to call the Sales Forecast web service. Both of these will be displayed in graphs with the system displaying up to four weeks of data, if the data exists. Only full weeks will be displayed.

Fields

The header contains the item ID, description and image (per user preference). Additional informational fields on this screen include:

Last Received - how many were last received on allocation, DSD, transfer.

Next Delivery - the quantity on the next delivery. It is the in transit (In bound qty) for the ASN (Transfer,DSD, allocation).

Warehouse – sum of inventory for the item at all warehouse.

On Order - This field will display the total quantity remaining on the order; Transfers + Allocations + Purchase Orders.

Available - This field holds the available stock on hand.

Unavailable - This field holds the unavailable stock on hand.

Total SOH - This field displays the total stock on hand at the store for the item.

Regular Price - This field displays the regular price of the item.

Promotional Price – This field will be displayed if there is a promotion running for the item.

Clearance Price - This field will be displayed if there is a clearance running for the item

Footer Options

Confirm – On clicking the Confirm button, the following will happen:

- A Store Order will be created with the quantity added and it will get approved automatically.
- If adjustments were made to the inventory buckets, inventory adjustment will be written with reason codes of Quick Adjustment In and Quick Adjustment Out. The adjustments are published. Transaction history is written.

Add to Item Basket - This option enables the user to add the item to the 'Investigate' Item basket if the user has 'Investigate Item Basket' security permission. This option will not exist if the item exists on an open "investigate" item basket. The item can be removed from the item basket using 'Remove From Item Basket' option which appears once the item gets added to the item basket.

Print Ticket -Allows the user to print a ticket if the user has Print Ticket security permission.

Configure Screen Layout - Clicking on this option brings up a popup where the user can configure the list of sections he wants to see in the screen and also the order in which the sections are to be displayed. The list of sections include Inventory, Order, Sales History, Sales Forecast.



All manually created inventory adjustments as well as those created by an external system, such as through the web service, appear in the list screen. The inventory adjustments are listed in the form of a grid. The screen displays the 'In Progress' adjustments as the default list. This list will be updated when a search is performed. The list is sortable and filterable.


Use the **Search** button to navigate to the [Inventory Adjustment Search Criteria](#) dialogue where you can enter search criteria to lookup inventory adjustments.

Clicking on **Create** button directs you to the [Inventory Adjustment Detail](#) screen with no details (items) to build a new inventory adjustment. You must have proper security permission for this button. Selecting an adjustment from the list navigates you to the details for that adjustment.

The **Delete** button enables you to delete an 'In progress' inventory adjustment. Appropriate security permission is needed.

The **Inventory Adjustment Detail** screen is where a new adjustment is created. Initially, this screen will not have any items.

The screen is also displayed when selecting an existing adjustment. The items displayed in this screen are for the adjustment. Line items appear in a grid and selecting a line item displays the item details of that item in the **Detail Block** which is on the right side of the screen. You can edit 'In progress' inventory adjustments. 'Completed' and 'Cancelled' adjustments will be View Only.

A reason code must be selected before being able to add or edit an item on the adjustment. The reason code selected is at the header level and is applied to all newly added items until it is changed to a different reason in which the newly changed reason is added to the items. The reason codes have a disposition associated to them which determines stock movement of the item.

Grid

The line items are displayed in the grid with information like item id, description, reason code, UOM, quantity and so on. Item ID is a hyperlink. Clicking on the link opens the Item Detail screen for that item in a new tab in the browser.

The grid is filterable and sortable.

To add a new item to the adjustment, click on '+' button and it enables the **Detail Block** to enter the item and the necessary details.

To delete an item from the adjustment, select the item and click on **X** button. Upon deletion of an item, UJNs (if any) are deleted.

Detail Block

All the details of a line item are displayed in this block. When a new item is added, this block will be empty. Enter the item id in the Item field. Press **Enter** or press the arrow button, and the item's detail get displayed. Enter quantity as required. The item must be unique on the adjustment.

Clicking on an existing line item enables the detail block and the details of the item such as item id, description, reason code, disposition, sub-bucket, UOM, quantity, and so on, will be displayed.

Click **Edit** in this block to edit the details of an item. Reason code and quantity/UIN are editable.

The quantity can be updated manually if permissions allow. The system validates the inventory bucket based upon the disposition associated to the reason code. See [Inventory Adjustments Process](#). A reduction adjustment in inventory may exceed available inventory, bringing total available as a negative value. However, an unavailable inventory adjustment can never make the non-sellable unavailable bucket go negative. The same is true for sub-buckets, when sub-buckets are used, the reduction of a sub-bucket must be less than or equal to total quantity of such a sub-bucket. Increases for available, or non-sellable unavailable have no restriction.

The item information including the image (which is system configured) displays in the detail block.

Click **Apply** to apply the changes to the adjustment and the grid will be refreshed to display the new details of the item.

Header Buttons

There are several buttons on the header of this screen which enables you to perform various actions on the adjustment:

- **Info:** Accesses the Info popup which will display the details of the adjustment. View only.
- **Notes:** Accesses the notes dialog to capture notes.
- **Edit Info:** Accesses the Edit Info popup and lets you enter values for the CFAs (Custom Flexible Attributes) that are set up for inventory adjustments and any other editable fields of the adjustment like Adjustment Date.
- **Confirm:** Confirms and completes the adjustment. All stock on hand updates are made and the adjustment is published out.
- **Save:** Saves the adjustment in 'In Progress' status to be completed later.

Saving an adjustment does not publish the adjustment nor does it reserve any inventory; it simply saves it. The Save button can be used to implement a Save and Approval process.

- **Delete:** Marks the inventory adjustment to 'Canceled' status.
- **Back:** Exits the adjustment; changes made in that session are not saved. If a new adjustment is being created, the adjustment (header) will remain saved in the database (as it was committed upon initial creation), however any items, modifications, and so on, will not be saved.
- **Download Report:** Will download the Inventory Adjustment operational report for the current inventory adjustment.
- **Copy:** The copy function is only available for those adjustments in a 'Completed' status. It takes the current adjustment, copies the items, reasons, and quantities, and creates a new editable adjustment with a new ID. It references the copied adjustment's ID.



Clicking on the **UIN** icon on the [Detail Block](#) brings up the UIN tab to add/remove UINs for UIN items (if system is configured to use UINs and if the item is a UIN item).

- All non-AGSN (Auto Generated Serial Numbers) UIN items require UINs to be captured, regardless of the disposition of stock movement. The quantity field cannot be entered for non AGSN UIN items. It gets updated as the UINs get added and removed from the adjustment.



- For AGSN items, if a reason code has a disposition of anything except Out of Stock to In Stock (+Stock on Hand), a UIN is required to be captured. This is because the UIN already exists in the system and the system needs to know which AGSN UIN is being adjusted. In this case, the quantity field cannot be entered; it is updated as the AGSN is added/removed.
- For AGSNs being adjusted from Out of Stock to In Stock (+ Stock on Hand), the system auto generates the AGSN number and print upon completion of the adjustment. This means that capturing of the AGSN is not required and the quantity can be entered. However, you may still capture the serial number if one exists. In this case, the system auto-generates the serial numbers and print for those where the quantity entered exceeds the UINs captured.


Figure 5-23 Inventory Adjustment - UIN - Relocation


Figure 5-24 Inventory Adjustment - Extended Attributes



The user will navigate to the **Inventory Adjustment Extended Attributes** screen upon clicking on the **Extended Attributes** icon on the [Inventory Adjustment Detail](#) screen. This screen is only available for items that are part of merchandise hierarchies that are configured/setup for extended attributes. Also, the store must be configured to capture **Extended Attributes**. This screen will display all extended attributes that get auto captured from a GS1 barcode (per system configuration). The user is also able to enter extended attributes manually for the item here.

Edit Info Popup

The **Edit Info** popup is accessed from [Inventory Adjustment Detail](#) screen by selecting **Edit Info** and can be accessed for editable Inventory Adjustments. Appropriate security permission is needed to access the popup.

You will be able to edit the Adjustment date as well via this popup. The adjustment date is an alternative date that allows you to identify when the inventory transaction happened if different from the time the transaction is created. The date has no impact on when the transaction is applied, the transaction will always be applied immediately when approved, regardless of this date. This is the date communicated to external systems.

The popup displays the list of CFAs (custom flexible attributes) that have been set up for Inventory Adjustments, in the desktop application and lets you enter values for them. The CFAs that are set up as 'Required' must have a value entered for it before confirming the inventory adjustment. The value can be one of the following: Date, Text, Decimal, Long depending on the 'data type' set up for the CFAs, while creating them in the desktop application. Appropriate security permission is needed for entering CFA values.

This popup can be accessed by clicking on **Download Report** from the [Inventory Adjustment Detail](#) screen. Selecting a format and clicking on **Download** will download the Inventory Adjustment operational report for the current inventory adjustment.

Inventory Adjustments Process

Reason codes are defined on the desktop. When creating a reason code, a disposition is assigned to the reason code and it defines how the stock will be moved. So, adjustments are made to different buckets depending on the reason code's disposition. For example: a reason code of **Stock - In** has a disposition of + Stock on Hand which moves inventory from Out of the store to **Available** inventory where as, a **Reason if Damaged - Hold** has a disposition of + Unavailable that moves inventory from **Available** to **Unavailable**.

The system will display the inventory value for the bucket in which inventory is being removed from.

Direct Store Delivery

Overview

A direct store delivery is a delivery in which the supplier drops off merchandise directly at the store. These deliveries, received directly at the store, can be against a planned delivery, an existing purchase order (PO) raised by the corporate or by the store, or a purchase order on the fly. The delivery supports containers coming in directly with Advance Shipment Notice (ASN) or the system will create a container when the ASN is loaded in the system. Even for receipts without ASN the system will allow you to create containers.

The store can receive partial shipments, resulting in multiple deliveries against a single purchase order.

Features

- Direct deliveries against a Purchase Order (PO) and with Advance Shipment Notice (ASN) from the supplier. This feature also supports containers coming directly from the source and allows you to create additional containers.
- Receive on shop floor directly or back room/delivery bay.
- Direct deliveries against a PO and without ASN from the supplier. You can receive the delivery by creating one or more containers.
- Direct deliveries without a PO.
- **Direct EXchange (DEX)/Nex** type deliveries.
- Capture values for Custom Flexible Attributes (CFA) at the direct store delivery and containers level.

Business Cases

Four business case examples are shown below:

DSD Receiving Process for PO Based Delivery with ASN

1. Corporate office places a purchase order to the vendor and instructs the vendor to supply the goods directly to the store.
2. Supplier ships the goods with the ASN to the store and the store receives the goods against the ASN.

DSD Receiving Process for PO Based Delivery without ASN

1. Corporate office places a purchase order to the vendor and instructs the vendor to supply the goods directly to the store.
2. Supplier ships the goods, but no ASN is sent to the store and the store receives the goods against the PO.

DSD Receiving Process without PO

Stores that are allowed receiving the goods without purchase order can verbally place the order to the vendor and create those receipts on the fly.

DSD Receiving Process via DEX/Nex

Direct **EX**change (**DEX**) is the electronic exchange of information between a vendor's hand-held computer and a store's direct store delivery (DSD) system.


DEX transmits data to a store's DSD system using the EDI transaction set 894 (Delivery/Return Base Record). The standard for this transaction set is UCS 004010 894 and is maintained by the UCC.

The system supports to create the DEX/Nex type deliveries using the web services. The functionality of DEX/Nex type deliveries within the DSD receiving module would be same as on the fly delivery created by you with the exception of originating type which is DEX/Nex.

The external system that is responsible to generate the DEX/Nex delivery would leverage the service exposed by the system to integrate and upload the DEX/Nex type deliveries in to the database.

Screen Flow

You can access DSD Receiving and Purchase Order options from the Shipping and Receiving menu. The [DSD Receiving List](#) screen that appears after selecting **DSD Receiving**, lists all the active deliveries that are available and allows you to create or modify a receipt. You can also create a new receipt on the fly without any purchase order by selecting **Create Receipt**.

After selecting the ASN, active delivery, or supplier for creating an on the fly delivery, the [DSD Receiving Containers](#) screen appears and allows you to proceed with detailed receiving using the [Container Items](#) screen.

You can access various footer menu options such as Info, [Edit Receipt](#), [Edit CFAs](#), [Customer Orders](#), [External Receiver Adjustments](#), Notes, and so on from the [DSD Receiving Containers](#) screen to perform various individual functions.

Similarly, you can access various footer menu options such as Default Qty, [Edit CFAs](#), Document option to select the PO for the PO based deliveries, Notes, and so on from the [Container Items](#) screen to perform various individual functions.

The [Purchase Order List](#) screen that appears after selecting **Purchase Order** allows you to view the purchase order detail and create a receipt against a PO.


When creating a receipt, the system takes you to the [Receiving Item Detail](#) screen and follows the same flow as described above.

Functionality

This section describes the available screens in Direct Store Delivery.

DSD Receiving List

The DSD Receiving List screen is accessed when you click on **DSD Receiving** from the Shipping and Receiving menu.

The DSD Receiving List by default shows all the active deliveries that are In-Progress and New for you to do the detailed receiving. It includes all types of deliveries. If the supplier has sent an ASN, it is uploaded and listed here with New status. You can select a delivery and do the detailed receiving. If the store has received a delivery via DEX/Nex service, it will be listed here and you can select to do the detailed receiving. If you have started the delivery process, it shows the delivery with the In-Progress status. You can select the In-Progress deliveries to continue the receiving. You can also select the completed deliveries to do the adjustment.

The deliveries created in the mobile application are shown with the type On the Fly.

The deliveries that have ASN from the source are shown with the type ASN.

The deliveries that are PO based and no ASN are shown with the type PO.

The deliveries that are of DEX/Nex based are shown with the type DEX/Nex.

DSD Receipts that are affiliated with a customer order will be indicated with the text 'CO' at the receipt level on this screen.

From the DSD Receiving List window, you can do the following:

- Select the search criteria option which is shown with the pair of eye glasses to filter the list based on the given criteria. Selecting the search criteria option takes you to the Search Criteria screen which is described below.
- Select **Create Receipt** from the footer menu to create a delivery without any PO (on the fly). Upon selecting this option, you go to the [DSD Receiving Containers](#) screen.
- Select the delivery from the list and perform detailed receiving or edit the delivery. Upon selecting the delivery record from the list, takes you to the [DSD Receiving Containers](#) screen to access the existing delivery.


Select the **Include Item Packs** check box which is enabled only if the item is entered, to search for deliveries that include the pack item of the entered item.

Use the **Reset** button on this screen to reset all the filtering criteria to default values.

Creating a New DSD Receipt

You can create a new direct delivery on the fly without any ASN or PO by selecting **Create Receipt** from the [DSD Receiving List](#) screen. The system displays the Supplier Lookup screen to search the supplier. Select to create the delivery.

This Supplier Lookup screen appears when **Create Receipt** is selected on the DSD Receiving List screen to create an on the fly receipt that does not have a PO in the system.

You can identify the supplier by entering or scanning the item id or select the search criteria option to filter the supplier based on the entered criteria.


Based on the item id or on the values entered in the search criteria, the supplier(s) are listed and allowed to select a supplier who delivered.

After selecting the supplier, the system takes you to the [DSD Receiving Containers](#) screen to create new containers and to perform detailed item level receiving.

The selected supplier must be allowed to Create New Purchase Orders or the Ignore the Supplier DSD indicator to create a PO on the fly parameter has to be set to **Yes** to receive a delivery without a PO from that supplier.

DSD Receiving Containers

You can see the DSD Receiving Containers (DSD Rcv Containers) screen for all type of deliveries. It appears under the following conditions:

- When you select the delivery from the [DSD Receiving List](#) screen
- When you select **Create Receipt** from the [Purchase Order Items](#) screen
- After selecting the supplier, when you select **Create Receipt** from the [DSD Receiving List](#) to create an on the fly delivery

If you are receiving a delivery with an ASN type of delivery, it shows the containers. Select the container to go to the [Container Items](#) screen to do the detailed item level receiving. You can also create a new container using **Create Container** which takes you to the [Container Items](#) screen to receive unexpected containers or when adding a container for a delivery without ASN.

The **Create** option is only available if you have permission for the New and In-progress deliveries.

You can also optionally scan or enter the container id to do the detailed item level receiving for that container.

Tap on the filter field and perform text based searches on the containers to refine the search on what is listed.

The list will be empty with zero containers initially, in case you are creating a new receipt without a PO or with a PO and no ASN. Select **Create Container** in that case to start the receiving process.

On this screen, you can also perform other operations by selecting the respective option from the footer menu which can be accessed by selecting the ellipsis (...) from the lower right hand corner of the screen.

Footer Menu

Create: This menu is same as Create button to create a new container.

Info: Select the info option to view the invoice particulars and delivery related information. See [DSD Receiving Container Info](#).

Edit Receipt: This menu option allows you to enter the receipt information such as carrier and invoice details. When selected navigates to the [Edit Receipt](#) screen. This menu option is available only for the deliveries in New or In-Progress status.

Edit CFAs: This menu option allows you to capture values for the CFAs that are set up based on the type of delivery such as On the Fly, PO and PO and ASN. See [Edit CFAs](#).

Default Qty: The default quantity option will help you to default the remaining expected quantity to the received quantity in the containers. The system will not default the quantities for the items that are processed earlier and contains a value including zero. This button is not enabled for the On the Fly delivery. You can perform this process from this menu for all the containers in the current delivery with the New and In-Progress status. For specific containers, go into the detail, that is, [Container Items](#) screen.

- If the delivery is flagged for quality control, you cannot default the quantity and would be prompted with a message.
- Default Qty sets the status of the integrated UINs to In Receiving for the delivery.
- In addition, a validation check is performed to ensure the expected quantity matches the serial numbers for items, if that is not the case, you will not be

allowed to receive all. If there are no UINs available for a UIN required item, the quantity is set to zero.

Confirm: Upon selecting this option, the system will confirm the delivery. The status of the container is moved to Received or Damaged or Missing or Submitted.

- If all the items in the container are zero received, the status of the container is updated to Missing.

See [Delivery Rejections and Supplier Discrepancy Check](#) section for more details.

Print: Upon selecting this menu, the system opens the print dialog to print the report.

Reject: Select the Reject menu if the delivery has to be rejected. This will reject the delivery and move all the containers to canceled status and move the status of the delivery to Rejected. Rejection of a delivery is possible only for the deliveries that are in In-Progress or New status and it will not allow rejecting if there are any received or damaged containers in the delivery. This will also remove any UINs present in the delivery.

Delete: Select the Delete menu if the delivery has to be deleted. This will cancel the delivery and all the containers inside the delivery.

Customer Orders: Select this menu to view the customer orders associated to the delivery. See [Customer Orders](#).

Ext. Adjustments: Select this menu to view any adjustments done by the external system for the delivery. See [External Receiver Adjustments](#).

Notes: Use this option to access the Notes dialog to enter any notes for the delivery.

Back: Acts similar to the back button which returns you to the previous screen.

List header fields on this screen are as follows:

Delivery Rejections and Supplier Discrepancy Check

The system performs the discrepancy check based on the supplier level Supplier Delivery Exception Attribute. The attribute can indicate to:

- Allow Any Discrepancy
- Do Not Allow Any Discrepancies
- Allow Overages But Not Short Receipts

Discrepancy checking only happens for those deliveries that have an expected quantity; this includes DSD deliveries for PO deliveries with or without ASN. Deliveries on the fly do not check for any discrepancies.

Discrepancy checking is done at the container level against the expected quantity. For an ASN, this would be the expected quantity of the container, while for a delivery on the fly against an existing PO, it is the remaining quantity of the PO.

You can override the discrepancy check at the container level based on the Override supplier discrepancies security permission. Once a container is moved to Submitted or Received, no additional validation is performed.

Depending on the type of DSD, some containers will move to Submitted and require the whole delivery to be confirmed, while others will move to a Received status. The reason for this is transactional integrity.

With an ASN, the received container can move to a Received status, which indicates that the Stock on Hand is updated and the merchandising system is notified that the container is received. The transaction will automatically move to Confirmed status when all containers are received.

PO on the fly and DEX/Nex do not update inventory until the delivery is confirmed, hence the containers move to a Submitted state. At that time, the delivery transaction is confirmed, the merchandizing system is notified of the whole delivery, inventory is updated and the submitted containers move to Received status.

PO deliveries without an ASN fall into a unique case. If there is a discrepancy check performed, the container will move to Submitted and require the delivery to be completed for any updates and integration. If on the other hand, the supplier does not require a discrepancy check or the supplier allows overage and it is a short receipt that is overridden, the container will be moved to a Received state, the Stock on Hand will be updated, and the merchandizing system will be notified when it is confirmed. Manual closure of the delivery transaction is required in all cases because additional containers may need to be added.



Figure 6-6 Receiving Info Screen




This screen is accessed from the [DSD Receiving Containers](#) screen when you select the **Info** option from the footer menu.

This screen provides the read only information such as ID which is internally created in the system, ASN, supplier, number of containers, status, create date, expected date, invoice particulars, carrier particulars, user details, custom flexible attributes if any, and so on. It may also include a field called 'Fiscal Doc ID'. This field would be a placeholder for the government reference ID/E-way Bill ID for the delivery, if available.

Customer Orders

This screen appears when you select the **Customer Orders** footer menu option from the [DSD Receiving Containers](#) screen. It will display the customer order and fulfillment order IDs, along with the container ID, status, total number of orders and total SKUs. If there are no customer orders associated, it will display an error upon selecting the option. This menu option is available only for ASN and PO based deliveries regardless of delivery status and not for on the fly deliveries.

Figure 6-9 Edit CFAs



The Edit CFAs screen displays the list of CFAs (custom flexible attributes) that have been set up for the DSD -On the Fly, DSD -PO, DSD PO & ASN and DSD Container in the system and allows you enter values for them.

The CFAs need to be configured for the each type of delivery and the container for the container items. The system displays the fields based on the setup for the type of delivery. 
Figure 6-10 External Rcv Adjustments Screen



You can access this screen from the [DSD Receiving Containers](#) screen by selecting the **Ext. Adjustments** footer menu option. This read-only screen displays the ASN and supplier information at the header level and at detail level it displays Purchase Order Number, Date, Item, Description, adjusted quantity and its UOM for the external receiver adjustments that exists for the delivery. You can only access this screen when there are any adjustments created for the delivery from the external system. Store users internally adjusted deliveries in the system are not shown here.

Container Items

This screen is accessed when you select **Create Container** or selecting an existing container on the [DSD Receiving Containers](#) screen. This is the screen for detailed item level receiving irrespective of the type of deliveries.

You must have proper permissions assigned to access this screen for both creating a new container and editing an existing container.

This screen displays the list of items that are in the container and details for a container on an ASN, or on the fly delivery. All this information is initially from the supplier ASN with the exception of the received and damaged cases. For a new based delivery, the items from the container are pre-loaded on the container items screen from the source. You can add items to the container if permissions are granted for over receiving and adding items. The user will navigate to the **Item Detail** screen for the item scanned. If the item scanned is a UIN item, the user will navigate to the UIN tab within the **Item Detail** screen.

For ASN based deliveries, if the item added exists in more than one purchase order and if you have not set any PO for receiving, the system prompts you to select the PO to assign to the item. Use the **Select Purchase Order** screen by tapping the info bar or **Select PO** footer menu option to select the PO and add items from that PO.

For a new container created for the on the fly delivery/DEX/Nex, enter/scan the items to receive.

If the user scans a VPN, a validation is done to verify that the VPN scanned belongs to the supplier associated to the delivery.

For a new container created for a PO based but no ASN, use the **Select Purchase Order** screen by tapping the info bar or **Select PO** from the footer menu and add the items and also populate the remaining quantity optionally.

On this screen, you can also perform other operations by selecting the respective option from the footer menu which can be accessed by selecting the ellipsis (...) from the lower right hand corner of the screen.

Footer Menu

Info: Select this option to access the [DSD Receiving Info](#) screen to capture the container information.

Notes: Use this option to enter any notes for the delivery.

Default Regular Qty: Default the expected quantity to the received quantity field. This menu option is only available when the container is in New or In-Progress status and you have the proper permissions.

- If the expected quantity is zero (in the case of adding an unexpected item), the received quantity is updated to zero.
- If the delivery is flagged for quality control, you cannot default the quantity.

Select PO: Select the Purchase Order for an ASN based delivery.

Clear Qty: Clears the received quantity and damaged quantity fields for all items. This menu option is only available when the container is in New or In-Progress status.

Damage Mode: Scan/enter items and update the Damage Qty field. Once selected, the list header bar is updated to 'Damages' and any item entered or scanned will update the damages quantity. This menu option is only available when all of the following conditions are met:

1. The Container status is New or In-Progress.
2. This menu option will display when you are in Regular Mode.
3. You have the proper permissions.

Regular Mode: This menu option will allow you to switch to scan/enter items and update the Received Qty field. Once selected, the list header bar is updated to 'Receiving' and any item entered or scanned will update the receiving quantity. This menu option will only display when all of the following conditions are met:

1. The Container status is New or In-Progress.
2. When the screen is set to Receiving Damages.

Edit Container: Used to enter container information.

Adjust: This option on the **DSD Receiving Container Items** screen allows the received container to be reopened for receiving. The system allows you to add items, delete items, modify the quantity, save, or confirm the delivery. All options are available as if the container was never received.

- The period at which you are allowed to adjust the deliveries from the time the receipt is confirmed is based on the parameter and also you should also have security permissions to adjust the container. Once the container is moved back to In-Progress, you can work on it as if it was never received.
- It is not allowed to move a container back to In-Progress if UINs that were in the container have been processed in another transaction.

Edit CFAs: This menu option allows you to capture values for the CFAs that are set up for the DSD container.

Damage Remaining Qty: This menu option will allow you to update the Damaged Qty for all items in the container where Expected - Received Qty is greater than zero.

- If you have not received any items in the container, all items in the container are marked as damaged.
- If you have received some items and the Expected - Received Qty is greater than zero, the Damaged Qty field is updated with the remaining quantity.
- This menu option is only available when the container status is in New or In-Progress.

Display Only Discrepancies: This menu option will allow you to display only items with a Received + Damaged Qty which does not equal the expected quantity.

- This menu option is only available when the screen is in a 'Display All Items' mode.
- The discrepancy check will apply to all items, even those with an expected quantity of zero. When an item is added to a container the Expected Qty will be zero. The unexpected items will always be discrepant.

Display All Items: This menu option will allow you to reset to display all items after selecting to **Display Only Discrepancies**. This menu option is not available for on the fly deliveries.

Confirm: Used to confirm the container. See [Delivery Rejections and Supplier Discrepancy Check](#) for additional information.

Save: Saves the container with current changes.

Delete: Deletes the container.

Back: Used to return to the previous screen.


Cancel: Used to cancel any changes and go back to the **Containers** screen.

Print: Opens the print dialog to print the report.

Print Tickets: Opens the Print Tickets dialog to print the tickets or labels for the current container items. This is described in common usage document with more details.

Receiving Item Detail

The **Item Detail** screen is accessed from the [Container Items](#) screen when scanning an item that is already in the container or adding a new item to the container.

Scanning or entering an item on this screen in the scan bar updates the quantity per the scan mode and refreshes the **Item Detail** screen for the item and quantity scanned. If the item scanned is a UIN item, the user will directly navigate to the UIN tab within the Item Detail screen.

If the user scans a VPN, a validation is done to verify that the VPN scanned belongs to the supplier associated to the delivery.

You can edit the received or damaged quantity if it is in edit mode and if you have permissions.

The item header portion displays the item information including the image if configured to show. The bottom portion which is detail allows you to edit the quantities if the state of the container allows and you have permissions. The system displays the following fields on the bottom portion.

Field	Description
Received	This field shows the UOM based on the UOM mode. The value on this field is the received quantity. When this is editable, you can enter the quantity via a popup. User needs permissions to edit the quantity
Damaged	This field shows the UOM based on the UOM mode. The value on this field is the damaged quantity. When this is editable, you can enter the quantity via a popup. User needs permissions to edit the quantity.
Pack Size	This is the pack size of the item. This field is editable.
New Cost	This field is populated with the item supplier cost in case of on the fly deliveries. This field is displayed and editable for on the fly. You can enter the cost of the item at which the item is received from the supplier. This field is displayed only if it is configured to show. In general, if a PO was created by the merchandizing system, the system does not allow the store user to edit the cost as it was defined by the external system. It will also not communicate any cost information to the merchandising system. If the delivery is on the fly, the system will use the cost based on item supplier country information. It is possible with the right permissions to edit this cost and the cost can be communicated to the external system
Original Cost	This field is a read only field and only for PO and ASN based deliveries
Purchase Order	PO assigned to the current item.
Expected	Expected quantity to be delivered from the ASN/PO.
Remaining	Balance quantity to be delivered in the order.
Last Scan	The details of the last scanned barcode.

You can navigate through the existing items on the container using the two arrows on the bottom. In between the arrows the system displays the current item number position out of the total number of items.

Perform further operations by selecting the respective footer menu options.

1. **Damage Mode** - This menu option will allow you to scan/enter items and update the Damage Qty.
 - The value selected will update any item entered or scanned after changing.
 - The receiving mode will stay the same until it is changed by selecting the footer menu again.
 - When you navigate to this screen from the [Container Items](#) screen, the receiving mode will be the same on this screen.
 - If the user changes the Receiving mode from this screen and navigates to the [Container Items](#) screen, the receiving mode will also be changed on the [Container Items](#) screen.
 - The user will remain on this screen.

2. **Regular Mode** - This menu option will allow the user to scan/enter items and update the Received Qty.
 - The value selected will update any item entered, scanned or tapped after changing.
 - The receiving mode will stay the same until it is changed by selecting the footer menu again.
 - When the user navigates to this screen from the Container Items screen, the receiving mode will be the same on this screen.
 - If the user changes the Receiving mode from this screen and navigates to the Container Items screen, the receiving mode will also be changed on the Container Items screen.
 - The user will remain on this screen.

The UIN tab on this screen is to take the user to the UIN screen to add/remove UINs for UIN items (if UIN processing is enabled and if the item is a UIN item).

When you enter the screen for the first time, the Status will display the following:

1. The UINs included on an incoming ASN will be displayed with a status of **Shipped to Store**.
2. The UINs manually added will be displayed with a status of **Unconfirmed**, if they do not previously exist.
3. The UINs manually added may have another status, if they already exist in the system.
 - When you re-enters this tab, the status will be updated to **In Receiving**.
 - When the transaction is no longer editable, the screen will be in view only mode.
4. You will not have the ability to change the Receiving Mode for the UIN.
 - For the ASN based delivery, any UINs present in the ASN will be ignored if the UIN type for the item is AGSN.
 - The Extended Attributes tab enables the user to view/capture Extended Attributes for the item. If the item is not configured to capture extended attributes or there are no extended attributes captured, the list will be empty.

Over Receiving Validations

When receiving a direct delivery, the user must have the proper permission to be able to over receive. The validation occurs as the item is scanned and the quantity is updated or when the quantity is manually updated. The permissions are:

1. **Allow ASN Over Receiving** - when receiving against an ASN, the system will check if the received quantity is greater than the expected quantity (ASN quantity).
 - a. If the user does not have this permission, the user will be given an error and must update the quantity.
 - b. If the user does have this permission, then there will be no error and it is permitted to have a received quantity greater than the ASN.
2. **Allow PO Over Receiving** - when receiving against a Purchase Order with OR without an ASN, the system will check if the received quantity is greater than the expected quantity (PO remaining quantity).
 - a. If the user does not have this permission, the user will be given an error and must update the quantity.

- b. If the user does have this permission, then there will be no error and it is permitted to have a received quantity greater than the PO remaining quantity.

Assuming the user has proper permission to over receive (as stated above). When receiving the user will be able to receive more than the expected quantity (ASN quantity / PO Remaining quantity) during the receiving process. Once confirming the container, the system will remove the over received quantities. There are two store configurations that are used:

1. **Direct Delivery Auto Remove Over Received Quantity** - at confirmation of the container any quantity received over the expected quantity will result in a prompt to the user and the overages will be removed by the system.
2. **Direct Delivery Auto Remove Damaged Quantity** - at confirmation of the container any damaged quantity received will result in a prompt to the user and all damaged quantities will be removed by the system.



You have to complete the following fields that are enabled and then **Save** to return to the [Container Items](#) screen:

Reference Container: This field is to capture a reference to a container that was not intended for the current location.

Receive on Shop Floor: The default will be based on the store parameter **Direct Delivery Default to Shop floor Receiving**. If set to **Yes**, the check box will default to marked.

You are required to have **Receive Direct Delivery on Shop floor** permissions to change the value.

This indicates whether the delivery will default to receive inventory into the shop floor instead of automatically receiving into the back room or delivery bay.

If this is set to receive on shop floor, the system increments the shop floor inventory bucket instead of the backroom or delivery bay bucket. If a capacity is defined for the item and **Direct Delivery Receive Item Capacity** is set to **Yes**, the maximum shop floor quantity will equal the capacity; otherwise, the shop floor will be updated to the entire receipt amount. If the capacity is used and if the receiving quantity is excess, the balance is incremented to delivery bay or back room depending on the Replenishment - Delivery Bay Inventory parameter.

If receive on shop floor is not set on the delivery, the system increments the back room or delivery bay bucket depending on the Replenishment - Delivery Bay Inventory parameter. If this parameter is on, the system will increment the delivery bay bucket instead of back room. This will increase Stock On Hand as well.


Damage Reason: Identifies the reason for damage on the container, when items in the container have been damaged during transport. This field is optional.

SSCC: This field allows you to identify a GS1 bar code used with the container. There is no validation on this field and it is optional. This is the full 18 digit number.

Tracking ID: This field allows you to type in a tracking id from the delivery service. This is a text field and is not validated. This is an optional field used to track information only.

Figure 6-15 Select Purchase Order Screen




This screen can be reached through the [Container Items](#) screen by tapping the document bar or by selecting **Select PO** in the footer menu. This screen will show the purchase orders and, when you select the purchase order, you are prompted with a popup with the following options.

- **Use Purchase Order:** This menu option will set the PO document referenced in the container to the user selection. Any items added will be updated to the selected document.
 1. There will be validation to see if the item exists on the PO document, but the items are not automatically added to the container.
 2. This will be the option by default selected.
- **Apply Item(s):** This menu option will add all items from the selected PO document to the container without applying the remaining quantity to the received quantity and the system will default the received quantity to zero.
- **Add Item(s) & Remaining Qty:** This menu option will add all items along with their corresponding remaining quantity to the received quantity in the container.

The Purchase Order List is a screen that allows you to view purchase orders placed to the suppliers to supply goods for your store. The default is to display the list of all active status that is, Approved and In-Progress purchase orders. Use the search criteria screen to filter out the records.

This screen provides the following header level information about the Purchase Order including the ID which is system internally generated, External ID, Supplier, Not Before Date if available, Create date of the PO, current status of the PO, total number of SKUs, and customer order id and fulfillment order id if customer order is associated with the PO.



Figure 6-17 Purchase Order List Search Criteria Screen



The header contains the header information including: Supplier, system created unique Id, External Purchase Order ID, Customer Order (if applicable), Fulfillment Order (if applicable), current status of the PO, Create Date, Not before date, Not after Date, and UOM. You can select the UOM from the drop-down to view the items based on the selected UOM.

The ordered quantity is the total quantity remaining in the order for all the items, the expected quantity is the total ordered quantity in the order for all items and the received quantity is the total of how many quantities quantity received.

The detail level has the item, description, Pack Size, as well as the On Order, Expected and Received.

You can create a receipt from the Purchase Order Items screen by selecting **Create Receipt** which will navigate to the [DSD Receiving Containers](#) screen with the existing purchase order

applied to the delivery. You can create container and start the receiving process as previously described.

On this screen, you can perform other operations by selecting the respective option from the footer menu which can be accessed by selecting the ellipsis (...) from the lower right hand corner of the screen.

Footer Menu

Info: Views the PO details which includes the CFAs if available.

Print: Opens the print dialog to print the report.

Customer Order Reserve On Receipt / Auto Pick

DSD Receiving can be configured to reserve inventory for customer orders upon receiving and also to auto pick the inventory. For additional details on this process, see [Customer Orders](#).

Transfers

Transfer Functionality

Transfers and allocations define the movement of goods between internal entities or trading partners. Requests from corporate or other stores for shipping inventory out can be auto approved without human interaction and it is possible to transfer unavailable inventory between all entities with a store as a starting or ending point of the transaction.

Transfer functionality in the mobile application is split up into three dialogs: Transfers (Documents), Transfer Shipping, and Transfer Receiving:

- **Transfer Documents** define the logical movement of goods and are often created at corporate. They define the intent of what needs to be shipped.
- **Transfer Shipping** is the physical task of shipping out goods to a store, warehouse, or external finisher.
- **Transfer Receiving** is the physical task of receiving in goods from a store, warehouse, or external finisher.

Transferring features:

- Transfer zone restrictions are enforced
- Initially limit store selection to buddy stores
- Transfers are restricted to store's shipping network
- Auto receiving store to store transfers
- Item with Non-Inventory Indicator set as **Yes** can also be included in a transfer

Business Case

Scenario 1: Warehouse Shipment

1. The store manager is notified that a request for transfer has been created by the merchandising system for a shipment back to warehouse 1.

2. The store manager goes into the transfer document dialog, looks up the request, and determines the request is for shipping back unavailable damaged items.
3. The store manager makes a decision to honor all the items needing shipment and accepts the entire request.
4. The store manager asks the shipping clerk to create a new shipment for warehouse.
5. The shipping clerk goes into the transfer shipment dialog and creates a new shipment and new container for warehouse.
6. The shipping clerk selects the transfer for unavailable damaged items and adds the entire transfer document into the container.
7. The shipping clerk updates the quantity to ship, confirms the container, and subsequently dispatches the shipment. The shipment is ready to go on the truck back to warehouse 1.

Scenario 2: Store to Store Transfer Receipt

1. A user in the convenience Petrol Store creates a transfer request for the main store located on same premises (for example, Fleet Farm and gas station \ can also be used for offsite backroom concept).
2. The user walks to the main store and fills the transfer from the backroom inventory. The shipment is dispatched.
3. The user in the Petrol Store goes into the Transfer Receiving dialog and locates the delivery.
4. The user updates the quantity received and confirms the entire delivery. The transfer document is updated with the received quantity (all items shipped) and closed.

Figure 7-1 Transfer Solution Flow




Figure 7-2 Transfer > Shipment > Receipt Status Flow





Figure 7-3 Supported Entity Flow




Transfer Document

The transfer document dialog allows you to create, accept, and reject transfer documents for the warehouse, store, and external finisher in a single dialog.

Transfer Document features:

- Transfer documents allow the movement of goods between store, warehouse, and external finisher.
- Transfer documents can only be created externally, through the creation of a shipment or are being made as part of a request from another store.
- Transfer requests created externally can be approved or rejected.
- A flow exists to pick items for the transfer document.
- Transfers using unavailable inventory.
- Visibility of shipment and receipt values after transfer approval.
- This will also be a placeholder for Stock Order messages from external system for Store, Warehouse and Finisher deliveries.

The transfer document you create explains what to ship from one location to another. This includes transfers to a warehouse, store, or external finisher. The following functions are included in the Transfer dialog:

- View Transfer Documents and Requests for Transfer
- Create, Accept, or Reject a Request
- Look up Shipping and Receiving Details
- Close a Transfer
- Capture values for CFAs (Custom Flexible Attributes)
- Print Reports

Destination Types

- Transfer Shipment to Store (Store to Store):
To create a Store Transfer Shipment, the destination type of 'Store' must first be identified for the shipment. The system provides a list of valid store locations.
- Transfer Shipment to Warehouse (RTW) and to Finisher (RTF):
To return items to a warehouse, the destination type of 'Warehouse' must first be identified for the shipment. The system provides a list of valid warehouses. For a Return to Finisher, select a destination type of 'Finisher' and select the destination for the shipment, or search for it using the lookup widget. Finishers are restricted to those which are for the same operating unit as the store.

Customer Orders


Transfer documents can come from the merchandising system to request goods from one store to another store that are for a customer order. These transfer documents will appear in the **Transfer** dialog.

There will be a customer order indicator on the transfer to denote that the transfer has a customer order affiliated with it. When searching for a transfer using the filter, you can search for those transfers that are for customer orders, or search for a transfer that contains a specific customer order and fulfillment order ID.

The details of the transfer will denote if the transfer is for a customer order and the Transfer Info screen will display the specific customer order and fulfillment order ID for that transfer if there is one. **Allow Partial Delivery** is populated based upon the customer order or the system can be configured to not allow partial customer order transfer shipments. If the box is not checked then, when accepting a transfer request, you must accept the full amount being requested. If system parameter **Customer Order Fulfillment Restriction** is set to **Line Controlled**, for transfer requests associated with a customer order, any item getting approved should get approved completely.

Transfer List

When navigating to Transfers, you go to the Transfer List screen which lists the inbound and outbound transfer requests and documents for your store. This screen displays 'Active' transfers by default. The Transfer List screen is accessed by selecting **Transfers** from the Shipping / Receiving menu drawer.

Search Criteria (Transfers)


Figure 7-6 Transfer Search Criteria Screen

Create Request

A request is created from the [Transfer List](#) screen when a store wants to receive items from another store. A request can be generated from an external system or be created in the mobile application. If the request has been created in the mobile application, then **Source Type** can only be a Store. The request can only be created if the store creating the request is not an excluded store for the Source store, that is, the requesting store must be in the shipping network of the source store in order to request items from a store. A store's shipping network is setup through the 'Store Shipping Network' screen in the desktop application. A store cannot create a transfer requesting for items from a warehouse or a finisher.


From the Transfer Create Request popup, if the **Buddy Store** field is checked, the stores field will automatically list only the buddy stores set up for the store you are logged into, however, any other store can also be searched and selected from the Source field as long as they are within the same transfer zone by unchecking the **Buddy Store** field.

If the store requesting items wants the items before a certain date, a date can be selected or typed into the **Not After Date** field. The request will automatically cancel if not accepted by this date. There are notifications in place to ensure the transaction is fulfilled in time, if configured.

The request needs to be accepted by the other store before a transfer can be shipped. Once accepted, the transfer document can be used to restrict or default items in a shipment/ container.

Request Items

Figure 7-8 Request Items Screen



The Request Items screen is used when creating a new request. Initially this screen will not have any items. The items screen is also displayed when selecting a saved request from the [Transfer List](#) screen. The items are listed for the transfer request. The item image for the line items is displayed per configuration.

Line items appear in a list and selecting a line item navigates to the item details of that item. If an item has been changed in the current session, it is indicated by a bar on the left of the item. This screen also displays a filter. The filter can be used to narrow down the list of items. Filtering can occur by item ID and description. The filter disappears when you scroll down through the list of items.

Items with **Non-Inventory** set as **Yes** is also allowed to be added to the request.

Scanning or entering an item in the scan bar navigates to the Item Detail screen for that item. Quantity may be updated depending on the scan mode. All of those items are grouped together under a single Transfer ID having one header transaction. The item must be unique on the transfer.

The ellipsis in the lower right hand corner accesses the footer menu which contains all of the functions that can be performed on a transfer request.

Footer Menu

The footer menu is accessed from the ellipsis footer menu on the Request Items screen. The menu functions include the following:


- **Info:** Accesses the Info popup.
- **Notes:** The Notes option accesses the notes common dialog to capture notes.
- **Edit Transfer:** This menu takes you to the [Edit Transfer](#) screen and will allow you to enter Context Type, Context Value, Not After Date, and so on.
- **Edit CFAs:** Lets you enter values for the CFAs that are set up for Transfer documents.
- **Request:** Allows you to request the transfer. The Transfer status is updated to Requested and it will appear in the source store. A notification is sent to the source store if configured. If the store parameter 'Context Type/Value required for Transfer' is set to 'Yes', a validation is done at this point to check if the Context Type/Value has been entered for the transfer.
- **Save:** Saves changes without requesting the transfer.
- **Delete:** Deletes the transfer before it is requested.
- **Cancel:** Leave the screen without saving any changes.
- **Back:** Return to previous screen.
- **Print:** Opens the print dialog and allows you to print reports. This option will always be available regardless of the transfer status.

Transfer Items

Accepting/Picking Request

Once the requested transfer is created by the receiving store or in the merchandising system, the user on the shipping side of the transfer can enter approved quantities or pick items and set them aside for eventual shipment. Once the quantities are entered or picking is completed, the transfer moves to an Approved status.

The Transfer Items screen is displayed when opening a transfer request from the [Transfer List](#) screen in the requested store (source store). This screen enables you to pick and approve the quantities to ship, for the requested items. This screen will display the items that have been requested. The item image for the line items is displayed per configuration.

Line items appear in a list and selecting a line item navigates to the item details of that item. If an item has been changed in the current session, it is indicated by a bar on the left of the item. This screen also displays a filter. The filter can be used to narrow down the list of items. Filtering can occur by item ID and description. The filter disappears when you scroll down through the list of items.

Scanning or entering an item in the scan bar navigates to the Item Detail screen for that item. Quantity may be updated depending on the scan mode.

Items with **Non-Inventory** as **Yes** are also allowed to be in the transaction and you can enter approved quantity for these items.

You can add (unexpected items) to ship along with the requested items if you have the necessary security permission.

The ellipsis in the lower right hand corner accesses the footer menu which contains all of the functions that can be performed in this screen.

Footer Menu

The footer menu is accessed from the ellipsis footer menu on the Transfer Items screen. The menu functions include the following:


- **Info:** Accesses the Info popup.
- **Notes:** The Notes option accesses the notes common dialog to capture notes.
- **Default Quantities:** Allows you to default the requested quantity to the Approved quantity field for all the items in the transfer.
- **Edit CFAs:** Lets you enter values for the CFAs that are set up for transfer documents.
- **Accept:** Accept to ship the items requested by the requesting store. Before accepting the transfer, the system should validate to ensure that the destination store is not an excluded store for the source store however if the user has **Override Exclude Closed Stores**, the system allows the user to proceed if he wants to.

If system parameter **Customer Order Fulfillment Restriction** is set to **Line Controlled**, for transfer requests associated with a customer order, any item that is getting approved should get approved in its entirety. Having zero Approved Qty for an item is allowed.

- **Reject:** Rejects the transfer request.
- **Save:** Saves the changes made to the transfer.
- **Close Transfer:** Closes the transfer.
- **Cancel:** Leaves the screen without saving any changes.
- **Back:** Returns to the previous screen.
- **Print:** Opens the print dialog and allows you to print reports. This option will always be available regardless of the transfer status.

Item Detail (Create/Edit/View Request)

The Item Detail screen is used when selecting or scanning an item from the [Request Items](#) screen. Scanning or entering an item on this screen in the scan bar updates the quantity per the scan mode and refreshes the Item Detail screen for the item and quantity scanned. This is the screen where you can enter the required quantity for the items that have been requested by the store.

The quantity can be edited and updated manually if permissions allow. The system validates whether the item that is getting requested has enough available inventory at the sending store. If the sending store doesn't have enough available inventory for the item, a soft warning is displayed. A transfer request created in the mobile application should request the item from the available inventory only. However, if the transfer request has been created in an external system, then it can be requested from unavailable inventory also.


Items with **Non-Inventory** set as **Yes** are also allowed to be added to the request.

The item information including the image (which is system configured) display in the header. The bottom portion of the screen contains fields for entering the quantity being requested, pack size of the item if the **UOM** mode is Cases and a field that displays the available quantity of the item in the sending store. Lastly, the details of the last scanned barcode will be displayed at the very bottom.

The footer menu, ellipsis button, contains a **Reset** function as well as **Remove** and **Restore** functions. Page through existing items on the adjustment using the arrows on the bottom.

Item Detail (Accept/Reject Request)

The Item Detail screen is used when selecting or scanning an item from the [Transfer Items](#) screen. Scanning or entering an item on this screen in the scan bar updates the quantity per the scan mode and refreshes the Item Detail screen for the item and quantity scanned. You can enter the approved quantity for the items that have been requested by another store.

The quantity can be edited and updated manually if permissions allow. Items with **Non-Inventory** set as **Yes** are also allowed to be in the transaction and you can enter approved quantity for these items.


The item information including the image (which is system configured) display in the header. The bottom portion of the screen contains fields for entering the quantity being approved, pack size of the item if the UOM mode is Cases, Primary Location where the item is present if sequencing has been done for the item, field that displays the requested quantity of the item, a field that displays the available/unavailable quantity depending on the inventory bucket from where the item has to be picked. This screen also displays certain fields depending on the status of the transfer request. For example, In Shipping field is displayed if the transfer is in 'In Shipping' status,

Received and Damaged quantity fields are displayed if the transfer is getting received at the requesting store. You can view the list of locations where the item is available (if sequenced) to help you to pick the items faster. Lastly, the details of the last scanned barcode will be displayed at the very bottom.

The footer menu, ellipsis button, contains a reset function as well as remove and restore functions. Page through existing items on the adjustment using the arrows on the bottom.

Edit CFAs Screen

Figure 7-12 Edit CFAs





The Edit CFAs screen displays the list of CFAs (flexible attributes) that have been set up for Transfer Documents, in the desktop application and lets you enter values for them. The CFAs captured during request create will be available in the Edit CFAs screen of request approve along with the values captured and the values can be overridden.

Info Screen (Transfer Items)

The Info screen is an informational popup that contains read-only information about the header level of the transfer. Details include Transfer Document ID, External Transfer Document ID, Source/Destination Type, Source/Destination ID, Status, Context Type and value, Inventory bucket information (Available or Unavailable), Customer Order/Fulfilment Order info, Request Date/User, Create Date/User, Approve Date and Approval User, Close/Reject Date/User and the CFAs.

Edit Transfer

This screen allows you to edit certain information of the transfer request like Context Type/ Value, Not After Date, Allow Partial Delivery (Y/N). You need appropriate permission to edit these fields and this screen is available only when the transfer request is in 'New request' status.

A context type and value can be entered if necessary. The context type is used to give a reason or purpose for the request. For context types of 'PROM', the Context Value field will be displayed and a promo ID will need to be entered or selected from the list of promotions in the lookup. If the promo ID exists, the description for the promotion will be displayed. If the promotion ID does not exist in the system the description displays as 'Unknown'. If the promotion ID is a transfer request from the external system, the context type is disabled.

Transfer Shipping

The Transfer Shipping dialog is focused on shipping out containers. Each container can be associated to one or more complete or partial transfer documents. Containers can also be restricted to specific merchandise hierarchies to prevent mixing of items.


Transfer Shipment features:

- Supports shipping to the store, warehouse, or external finisher
- Multiple transfer documents allowed in a single container
- Create container without referencing a transfer document (on the fly)
- Limit store selection by buddy store and transfer zone
- Multiple containers allowed in a single shipment
- Manifest system integration and package tracking ID processing
- Two step approval process to warn of pending shipments
- Restrict merchandise packaged together by merchandise hierarchy

- Submit, cancel submit, or dispatch a shipment

Transfer Shipments are accessed on mobile through the Shipping / Receiving menu within the drawer. Selecting the menu option will take you to the [Tsf Ship List](#) screen. On this screen, you can search for shipment records. You can create a shipment, edit

or view a shipment. When creating, editing, or viewing a shipment, you are directed to the list of containers within the shipment on the [Tsf Ship Containers](#) screen. Here, you can create a container, edit or view a container. When creating, editing, or viewing a container, you are directed to the list of items in the container on the [Transfer Container Items](#) screen. You can add, view, and edit the details of the items on the Item Detail screen.

On the Item Detail screen, there will be tabs for UINs if the item is a UIN required item and the store is configured for the UIN processing.

You can specify values for CFAs (Custom Flexible Attributes) set up for shipments and containers via the Edit CFAs screen.

Tsf Ship List

Figure 7-16 Tsf Ship List Screen





Figure 7-17 Create Shipment Screen



When navigating to Transfer Shipping, you go to the Tsf Ship List screen with the default list being defined for 'Active' shipments. This screen gives a quick view of the list of shipments

along with the details such as shipment's status, destination type/name, status of the Fiscal Doc/E-way bill request(if the system is configured to use Fiscal Doc ID/E-way Bill ID), etc.

You can use the search criteria eye' glasses to navigate to the transfer shipment search criteria screen to enter search criteria for transfer shipments. When scanning/entering a container ID in the scan bar, the system adds the container ID to the entered search criteria and narrows down the current list of shipments by the item scanned. Scan or enter the internal or external container IDs or the tracking ID to find the matching shipments. If there are multiple containers found with the same scanned or entered number, you are prompted to select the shipment/container to return.

The **Create** button prompts you to create a new shipment. You can create a shipment for store, warehouse, or finisher. The destination types for which a user can create a shipment is controlled by the data permission **Transfer Destination Type**.

In the case of a shipment to a store, the shipment is allowed to be created only if the destination store is not an excluded store for the source store. That is, the destination store has to be in the shipping network of the source store in order to ship items. However, if the user has **Override Exclude Closed Stores** permission, the system allows the user to proceed with creating the shipment if needed. The user can setup the shipping network for a store using **Store Shipping Network** screen in the desktop application.

Buddy stores are available to allow for searching for a location to ship to that are close in proximity. Creating a new shipment will direct you to the [Tsf Ship Containers](#) screen with no containers. If you select an existing shipment, the same screen displays a list of created containers.

Search Criteria (Transfer Shipment)

The Transfer Shipment Search Criteria screen is accessed by the eye glasses on the [Tsf Ship List](#) screen. After applying the search criteria, the results will be listed on the [Tsf Ship List](#) screen and the criteria applied will show. The following fields can be searched on from this screen: Last Updated, Destination Type, Destination ID, Destination, Document ID, ASN, Item, Container ID, Customer Order ID, Fulfillment Order ID, Customer Orders Exist, Shipment Status, Context Type, and Context Value. If the retailer has set up the system to use Fiscal Document/E-way bill for the shipments, there will be additional criteria provided in the screen such as Fiscal Request ID, Fiscal Doc ID and Fiscal Request Status.

Tsf Ship Containers

The containers within a single shipment will display on this screen. If the shipment has just been created, the list will be blank. Several functions may be performed on this screen to include the following:

- Viewing additional details
- Updating authorization number
- Creating a new container
- Viewing existing customer orders
- Set up the carrier shipment details

Submit

The shipment can be saved in 'In Progress' status to continue edits later or it may be submitted or dispatched. Submitting is possible when the store setting Dispatch Validate is configured for 'Ship Submit'. Submitting will set the shipment to a 'Submitted' status and not allow for edits, there are no updates to inventory at this point. The only step possible will be to Cancel Submit or Dispatch. If the system is enabled to obtain Fiscal Doc ID/E-way bill ID for the shipment, the process to request for the same starts once the shipment is submitted.

Dispatch

When the shipment is dispatched, the transfer reserved quantity for the outbound location will decrease in addition to the stock on hand. If no shipping quantities are identified the transaction should be cancelled. Inbound is increased at the receiving store for what has been shipped. If the system is enabled to incorporate Fiscal Doc ID/E-way bill ID as part of the shipping process, the shipment cannot be dispatched until the Fiscal Doc ID/E-way bill ID is available. The exception is when the user has 'Allow dispatch without Fiscal Document ID' security permission.


Customer Orders

The [Tsf Ship Containers](#) screen has a footer menu option called **Customer Orders**, which when clicked lists the customer orders associated with the containers if any. It will display the Customer Order and Fulfillment Order IDs, along with the Container ID, Status, Total SKUs, and Comments for the customer order.

When dispatching a transfer shipment, if the transfer associated to the shipment has **Allow Partial** set to **No**, then you must ship the full amount which is requested.

If any of the containers on the shipment references a transfer with a customer order with **Allow Partial Delivery** indicator is **Yes** and the system parameter **Customer Order Restriction** is set to **Line Controlled**, the items getting delivered has to be delivered in its entirety. Partial delivery of an item is not allowed. This validation is done on both Submit and Dispatch of a customer order.

Upon selecting a container on the [Tsf Ship Containers](#) screen, you go to the details of that container on the Transfer Container Items screen.

When creating or selecting an existing shipment from the [Tsf Ship List](#) screen, you go to the [Tsf Ship Containers](#) screen with the list being defaulted to **Active** containers. When scanning/entering a container ID in the scan bar, the system will navigate you to the **Container Items** screen and display the items currently in the selected container. Scan or enter the internal or external container IDs or the tracking ID to find the matching containers in the shipment.

The create button will create a new container for the shipment. Creating a new container will direct you to the **Container Items** screen with no details (items) in order to build a new container. Lastly, selecting a container from the list will navigate to the details for that container.

Footer Menu

Info: The Info option will access the Info (Shipment) popup.

BOL Info: The BOL Info option will access the BOL Info screen.

Note: The Notes option accesses the notes common dialog to capture notes.

Customer Orders: The Customer Orders option will access the [Customer Order List](#) screen.

Create: Create will create a new container in the shipment.

Edit Shipment: Edit Shipment will access the [Edit Shipment](#) screen.

Edit CFAs: Enter values for the CFAs that are set up for Transfer Shipments.

Submit: Submit will perform validations for 'In Progress' shipments including excluded store validation and lock the shipment for additional edits. The shipment will be ready for dispatch. This menu option will only be available when the store parameter 'Transfer Shipment Dispatch Validate' is set equal to Ship Submit.

Cancel Submit: Cancel Submit will reverse the Submit and move the shipment back to 'In Progress'.

Dispatch: Dispatch will perform validations including excluded store validation and post transactions to finalize the shipment and no further changes are allowed.

Delete: Delete will mark the shipment to 'Canceled' status.


Back: Back will exit the shipment.

External Printing: External Printing will display the External Printing popup to select a printer for the pre-shipment notice and manifest documents.





The Edit CFAs screen displays the list of CFAs (flexible attributes) that have been set up for Transfer shipments, in the desktop application and lets you enter values for them. The CFAs that are set up as 'Required' must have a value entered for it before confirming the container. The value can be one of the following: Date, Text, Decimal, Long depending on the 'data type' set up for the CFAs, while creating them in the desktop application. Appropriate security permission is needed and the shipment must be in editable state for entering CFA values.

Figure 7-24 Cust Order List




The Cust Ord List is an informational screen that contains read-only information about the customer orders within the shipment. The customer order information will be on the transfer documents selected for the shipment. Details include: Customer Order/ Fulfillment Order, Status, Cnt ID, and Container ID.

Scrolling in the list of customer order/fulfillment orders on the left will display a filter. The filter can be used to narrow down the list of items. Filtering can occur by Customer Order ID, Fulfillment Order ID, Container ID, and Customer Order Status.

Transfer Container Items

The Container Items screen is used when creating a container or a new container.

There are several functions you can perform on this screen. Some of the features include:

- Create, edit, delete, or confirm a container
- Select transfer items or add loose items
- Manage carrier shipping information

The container can be created with or without referencing a transfer document. When it is created without a transfer document, it can only be created to ship available inventory. With a transfer document, it can be for Available or Unavailable inventory.

When a container is created but not yet completed, the container will display a status of 'In Progress'. The transfer reserved bucket will update the moment the container is saved. When the shipment is dispatched, the saved quantity in the transfer reserved bucket will be removed. This will keep the available quantity accurate.

The items on the list are for the container.

The item image for the line items is displayed per configuration. Line items appear in a list and selecting a line item will navigate to the item details of the item. If an item has been

changed in the current session, it will be indicated by a bar on the left of the item. Scrolling in the list of items on the left will display a filter. The filter can be used to narrow down the list of items. Filtering can occur by Item ID, Description, Document ID and Reason Code.

If the **Non-Inventory** indicator of the item is set as **No**, the SOH of the item is updated at the completion of the transaction.

If the **Non-Inventory** indicator of the item is set as **Yes**, the item can be added to the transaction however the SOH will not be updated on confirmation/completion of the transaction. That is, the item can be scanned/added to the transaction, and you will be able to enter/update quantity just like a normal (inventory enabled) item. All the processing rules and validations that apply to inventory enabled items would apply for non-inventoried items too except that the validations done on quantity against SOH will be ignored. On dispatch, the SOH of the item will not be updated since the application doesn't preserve the inventory details of the items with **Non-Inventory** indicator set as **Yes**. Publishing of non-inventory items can be restricted depending on administration integration settings.

Inventory Type of items (Available or Unavailable) in the container is held at a container header level. This means that all items in the container must be for the same inventory type, there cannot be a mixture. Once items from a transfer have been added to the container, the inventory type is set for the container and can no longer be changed. However, a shipment may have both unavailable and available containers.

If inventory is from unavailable inventory, the shipped quantity cannot exceed the unavailable stock. If the system is configured to use sub-buckets, then the sub-bucket associated to the reason codes which are for unavailable inventory will be displayed. The sub-bucket will be updated as the unavailable inventory is updated.

When a container is setup to use unavailable inventory, a reason code must first be selected before being able to add or edit an item in the container. The reason code is selected on the [Edit Container](#) screen. Containers that are setup to use available inventory will not use reason codes. The reason code selected is at the header level for the container and it will be applied to all newly added items until it is changed to a different reason, in which the newly changed reason will be added to the newly added items.

Scanning or entering an item in the scan bar will navigate you to the Item Detail screen for the item. Quantity may be updated, depending on the scan mode. If the user scans the Item ID of a UIN item or if he scans a UIN, he will be taken to the UIN tab of the Item Detail screen.

Directly below the scan bar, the currently selected transfer document will display. When first entering the container, 'No Document' will be displayed. You will need special permissions to add items without selecting a document. Access the active documents by tapping on this bar which will take you to the Select Document screen.

Next to each item, the UIN icon will display if the UINs have been associated to the item.

The ellipsis in the lower right hand corner will access the footer menu which will contain all the functions that can be performed on a container.

Footer Menu

Info: Info will access the Info (Container) popup.

Notes: Accesses the notes common dialog to capture notes.

Edit Container: Accesses the Edit Container screen.

Edit CFAs: Enter values for the CFAs that are set up for Transfer Shipment Containers.

Adjust: Reopens a container in Completed status and moves it back to In Progress.

Confirm: Moves the container in an In Progress status to Completed.

Save: Saves the container in 'In Progress' status to be completed later. This option is only available when the screen is in edit mode.

Print: Opens the print dialog and allows you to select formats and print various reports and container labels. The Transfer Shipment Container report will be available on this screen.

Print Tickets: Opens the Print Tickets dialog to print the tickets or labels for the current container items. This is described in common usage chapter with more details.


Delete: Marks the container to 'Canceled' status. This option will only be available for containers that are in a New or In Progress status.

Cancel: Exits the container and changes made in that session will not be saved. This screen is only available when the screen is in edit mode.

Back: Returns to the previous screen. This option is only available when the container is view only.

Item Detail (Quantity)

The Item Detail screen is the screen is used when selecting or scanning an item from the Container Items screen. Scanning or entering an item on this screen in the scan bar will update the quantity per the scan mode and refresh the item detail screen for the item and quantity scanned. The quantity can be edited and updated manually if permissions allow.

Items with Non-Inventory Indicator set as **Yes** are also allowed to be in the transaction and you can enter ship quantity for these items.

If the user scans the Item ID of a UIN item or if he scans a UIN, he will be taken to the UIN tab of the Item Detail screen.

The item information including the image which is system configured to display in the header. The bottom portion of the screen contains information fields of inventory qty, remaining qty, document qty and reason code (for unavailable inventory only) pertaining to the bucket stock is coming from. Lastly, the details of the last scanned barcode will be displayed at the very bottom.


The footer menu (ellipsis button), contains a reset function as well as remove and restore functions. Page through existing item in the container view the arrows on the bottom.

There is also a UIN tab to take you to the UIN screen to add and remove UINs for UIN items.

There is also an **Extended Attributes** tab that enables the user to view/capture Extended Attributes for the item. If the item is not configured to capture extended attributes or there are no extended attributes captured, the list will be empty.

Select Document

The Select Document screen is used for adding items to ship into the container. Access this screen by tapping the Document ID in the header bar of the Container Items screen. If there are no approved documents to display, the list will be empty. The

list is sorted by documents with a remaining quantity on top, then by not after date, and then by document ID.

A list of documents for Inventory Type of 'Available' or 'Unavailable' will display based on the selected option on the Edit Container screen. The default will be to display documents with inventory type set to available.

Additionally, if you have placed a hierarchy restriction on the container using the Limit Item To drop-downs on the Edit Container screen, only those documents with items matching the criteria will display. This will happen once the restriction is set by adding the first item to the container. If the container is empty, all documents will be displayed for the appropriate inventory type.

Scanning or entering a document ID on this screen in the scan bar will display the Document Options popup if any are found. Scrolling in the list of documents on the left will display a filter. The filter can be used to narrow down the list of documents. Filtering can occur by Document ID, External ID, Customer Order ID, Fulfillment Order ID, Context type, and Context value.

The following icons will be displayed to indicate the status:

- Green circle with check indicates the document has remaining quantities.
- Orange triangle with exclamation point indicates the document has no remaining quantities.

Options to Add to Container

You can select an approved transfer document and have different options to apply the items. When you are working in the container screen, any items added manually, will be added to the selected transfer document. If you do not want to add the items to the transfer, select **No Document** from this screen, to clear out the selection. Items added manually will be added to the Ad Hoc transfer if no document is selected, otherwise they are added to the transfer doc selected. Adding loose items to a container is only allowed for Containers setup for Available inventory.

- Apply Item(s): The items are pre-filled in the container without quantities.
- Apply Item(s) & Quantity: The items with their remaining quantity are added into the container.
- Use Document: Manually add the items to the container validating against the selected document. You are prompted when an item does not exist on the document. If not, you may or may not have the ability to add to the container or to the selected document.

Once the document and items are selected, the document ID is populated in the header of the container detail screen as well as next to each item added to the container. There are various permissions that will control which options you can perform.

The **No Document** button is used to clear the selected document. You need special permissions to use this button. Any items added to the container when No Document is selected, will be added to an ad hoc transfer created for the entire shipment for any unexpected items not associated with an existing transfer. The button will not be available when the container has been setup to pull items from unavailable inventory buckets since a pre-created transfer document is required.

The Edit Container screen is used to enter details for the container including transportation details. You navigate to this screen from the footer menu on the Container items screen. Details will include: ID, Inventory Status, Container ID, Package Type, Weight, Tracking ID, and Container Restriction by Hierarchy. If the inventory status is Unavailable, the Reason Code and Sub-buckets (if configured to use sub-buckets) will also be available.

The inventory status and the container restriction by hierarchy will be locked down once the first item has been added to the container.

Limit Items to (Hierarchy Restriction)

If you want to set up the container to restrict the container to hold the same type of items, set up the container to restrict by department, class, and subclass. You do not select the actual department, but set the hierarchy level to restrict by. When the first item is added to the container, the department, class, and/or subclass is set for the container based on the hierarchy the item is part of. The container detail screen will display the hierarchy that is locked in. Any items added subsequently must match the hierarchy of the first item. For example, if the restriction was set up to limit items to the same department and the first item added was for the Women's Department, only


items that match the Women's Department can be added to the container, but it will not matter which class and subclass the item is in since the hierarchy level is set at Department.

The hierarchy level is auto defaulted depending on the permission you have been given.

If manifesting has been configured, the package type and weight may be required by the carrier selected for the shipment before you can confirm the container.





Transfer Receiving is accessed on mobile through the Shipping / Receiving menu within the drawer. Selecting the menu option will take you to the Tsf Rcv List screen. On this screen, you can search for delivery/receipt records which will be presented on the Tsf Rcv List screen. You can edit or view a delivery/receipt.


When editing or viewing a delivery/receipt, you will first be directed to the list of containers within the delivery/receipt on the Tsf Rcv Containers screen. You can create a container, edit or view a container, capture values for CFAs.

When creating, editing, or viewing a container, you are directed to the list of items in the container on the Container Items screen. You can add, view and edit the details of the items

on the Item Detail screen. The Item Detail screen has tab for UINs if the system and/or item is configured. You can also capture values for CFAs that are setup for the containers.

When navigating to Transfer Receiving, you go to the Tsf Rcv List screen with the default list being defined for 'Active' receipts meaning 'New' or 'In Progress' status.

These deliveries are all populated through the system from an internal or external source. The ASN corresponds to the Shipment ASN for a store to store transfer.

Use the search criteria eye glasses to navigate to the transfer receipt search criteria screen to enter search criteria for transfer receipts. When scanning/entering a container ID in the scan bar, the system adds the scanned container ID to the entered search criteria and narrows down the current list of receipts by the container ID scanned. Scan or enter the internal or external container IDs to find the matching containers in the receipt.

Selecting a receipt will direct you to the Tsf Rcv Containers screen and will display a list of containers.

An estimated expected date will be populated if one exists in the ASN. When the delivery has been received, the receive date field will be updated. You can identify any container marked as missing or holding customer orders.

This screen allows you to identify if the transfer being received is for a customer order.

If an unexpected container arrives, search for the container using the misdirected container screen. Receiving notes may also be captured at the receipt and container level.


Figure 7-33 Search Criteria (Transfer Receiving) Screen

When scanning/entering a container ID in the scan bar, the system navigates you to the [Container Items](#) screen and display the items currently in the selected container.

You can scan or enter the internal or external container IDs to find the matching containers in the receipt. The filter can be used to narrow down the list of containers. Filtering can occur by internal ID, container ID, and container status. The following icons will be displayed to indicate the status of the container: green circle with check indicates the container is received, orange triangle with exclamation indicates the container is damaged, and the red circle with exclamation indicates the container is missing. If the container is in a 'New' or 'In Progress' status an icon will not display.

For containers in statuses 'Received' or 'Damaged', if they are 'discrepant', a label called 'Discrepant' will be displayed in red color.

Containers can be received individually by selecting the container. Click **Default Qty** and, all items received quantity for each container is set to the expected quantity. Containers can only be received at a container level if they have not been received at the item level.

If the delivery has already been received and if the receipt date is within the system configured number of days allowed to adjust a receipt, it is possible to reopen the specific container on a receipt by clicking the container. Adjust the container from within the container dialog. The receipt can be saved as 'In Progress' to complete receiving at a later time. Saving the receipt will not make any updates to the stock on hand.

Confirming the receipt will mark all containers, with received quantities, to Received. Stock on hand is updated when the status of the container changes to Received, either from within the receipt details or from within the Container. Any containers with no received quantities will be marked as Missing.

When confirming the transfer receipt, if there are containers that are in 'New' status (the items will not have any quantities):

- If the user has the **Allow Default Zero at Confirmation** permission, the system will prompt the user if they would like to set the quantities to 0. If the user chooses **Yes** to the prompt all items that have a blank quantity value will be set to 0. If the user chooses **No**, the user will return to the screen and nothing is updated.
- If the user does not have the **Allow Default Zero at Confirmation** permission, the user will not be able to confirm the delivery and will return to the screen. At this point the user will have to either save it for someone else with proper permission to confirm, or receive the items that are blank.

When confirming the transfer receipt, if there are containers that are in 'In Progress' status with discrepant quantities (Received is not equal to Expected), the user will be prompted that there are discrepant items:

- If the user has the **Allow Default Zero at Confirmation** permission, the system will prompt the user to set the quantities to 0. (Same as above)
- If the user does not have the **Allow Default Zero at Confirmation** permission, the user will not be able to confirm the delivery and will return to the screen. (same as above)

Customer Orders

The screen has a footer menu option to go to the [Customer Order List](#) screen. This enables you to identify the list of customer orders associated with this delivery, if any.

Selecting a container from the list takes you to the [Container Items](#) screen.


Figure 7-35 Edit Receipt Screen


Figure 7-36 Edit CFAs

Appropriate security permission is needed and the delivery must be in editable state for entering CFA values.


Figure 7-37 Info (Receipt) Popup



The Info (Receipt) is an informational popup that contains read-only information about the header level of the receipt. Details include: Source Type, Source, ID, ASN, Status, Expected Date, Create Date, Create User, Updated, Update User, Received, Received User, Carrier Entity, Carrier Type, Carrier Code, License Plate, From Address, Freight ID, Bill of Lading, and the CFAs. The License Plate and Freight ID fields may be used for other purposes, such as a Weigh Bill ID or BOL ID. The field names can be customized by the client.

Figure 7-38 Misdirected Container Screen




When selecting Misdirected Container from the [Tsf Rcv Containers](#) screen, you go to the Misdirected Container screen with the screen showing an empty list. When scanning/entering a container ID in the scan bar, the system will display matching containers available in the entire enterprise. Scan or enter the internal or external container IDs or Tracking ID to find the matching containers in the receipt.

When selecting a container within the list, you are taken to the [Misdirected Items](#) screen.

The Misdirected Items screen used when selecting a container from the [Misdirected Container](#) screen. Details about the intended destination are displayed at the top of the screen. The details include: ID, Container Status, Source Type, Source, Destination Type, Destination, and Container ID. When scanning/entering an item in the scan bar, the system will update the filter bar and display the resulting item.

The filter can be used to narrow down the list of items. Filtering can occur by item ID and description.

The **Copy** button will copy all items from the container to a new container. A notification is sent to the original destination store to inform them the container intended for their location has been received in another location. The old container ID will be written into the reference container field for the newly created container and the old container will be moved to a 'Missing' status.



The Cust Ord List is an informational screen that contains read-only information about the customer orders within the receipt. Details include: Customer Order/Fulfillment Order, Status, Internal and External container ID.

Scrolling in the list of customer order/fulfillment orders on the left will display a filter. The filter can be used to narrow down the list of items. Filtering can occur by Customer Order ID, Fulfillment Order ID, Container ID, and Customer Order Status.

Container Items

The Container Items screen is used when selecting a container to receive from the [Tsf Rcv Containers](#) screen.

This screen is used to work with the contents and details within the container. Information is populated from an Advanced Shipment Notice (ASN) and you mark the items as received or damaged. The items on the list are for the container. The item image for the line items is displayed per configuration.

If the **Non-Inventory** indicator of the item is **No**, the SOH of the item is updated at the completion of the transaction.

If the **Non-Inventory** indicator of the item is **Yes**, the item can be added to the transaction however, the SOH will not be updated on confirmation of the receipt. Item can be scanned/ added to the transaction, you can enter/update quantity just like a normal (inventory enabled) item. All the processing rules and validations that apply to inventory enabled items would apply for non-inventoried items too except that the validations done on quantity against SOH will be ignored. On confirmation of the receipt, the SOH of the item will not be updated since the application doesn't preserve the inventory details of the items with **Non-Inventory** set as **Yes**.

When the screen is set to regular receiving mode, the header bar will display the number of SKUs, 'Receiving', and total expected quantity. Scanning/entering an item will update the

received quantity. When the screen is set to damage receiving mode, the header bar will display the number of SKUs, 'Damages', and total expected quantity. Scanning/entering an item will update the damaged quantity. Finally, when the screen is set to display only discrepancies, the number of discrepancies is displayed on the left.

Line items appear in a list and selecting a line item will navigate to the item details of the item. If an item has been changed in the current session, it will be indicated by a bar on the left of the item. The filter can be used to narrow down the list of items. Filtering can occur by Item ID, Description, Expected Qty, Received Qty, and Damaged Qty.

Scanning or entering an item in the scan bar will navigate you to the Item Detail screen for the item. If the user scans the Item ID of a UIN item or if he scans a UIN, he will be taken to the UIN tab of the Item Detail screen.

Quantity may be updated, depending on the scan mode.

The following icons will be displayed next to the item: green circle with check indicates the item is not discrepant and the blue circle with an 'i' indicates the item is discrepant. A discrepant item is when the received quantity plus the damaged quantity does not equal the expected quantity. If configured, unexpected items may be added to the container. A new transfer will be created for the unexpected items. There will only be one transfer created for the entire receipt.

The entire container may be marked as damaged and a reason for the damage from the Container Info screen. Additionally, the container can be marked to receive on the shopfloor directly.

Receive Transfer Delivery

When the delivery is being received, the status of the delivery/receipt will move to 'In Progress' status at the receiving store. Press the **Cancel** button and the delivery/receipt will remain as 'New'. If configured for blind receiving, the expected inbound quantities will not display.

You may select to use **Default Regular Qty** option or change the quantity received and mark items as damaged if necessary.

When confirming a delivery, the status is updated to Received and inventory is updated. The merchandising system is also notified at the container level for the receipt. This provides an up to date view.

When damaged items are received the inventory for those items will be put into a Non-sellable Unavailable bucket. The total received is the sum of the received and the damaged quantities.

Receive Entire Delivery

If the system parameter **Receive Entire Transfer** is set equal to **Yes**, you cannot add or remove items from a delivery.

Managing Discrepancies

Deliveries can be received for over, short or the exact quantity dispatched. Discrepancies are easily managed with the **Display Only Discrepancies** footer menu option. When selected, the expected qty will be compared with the received plus damaged qty and only the items with a discrepancy will display. Unexpected items added during the session will not show up on the discrepancy list since there is no expected quantity.

Store to Store transfer receipt overages will adjust the difference out of the sending store's stock on hand. There is not an inventory adjustment created for this overage but an e-mail notification will be generated and sent to the sending store.

Adjust Container

After the delivery has been received, it is possible for a user to adjust each container on the receipt. This will depend on the **Number of Days** received transfers can be adjusted system parameter. Select the **Adjust** button and the container moves back to 'In Progress'. The entire container is reversed out and you will need to reconfirm. The full reversal will display in Transaction History.

Adjusting can only be done at the container level. The entire receipt cannot be adjusted at once. Once the original receipt has been confirmed, the inbound bucket will no longer see a change. In some cases, the container may be restricted from adjustments, such as when customer order reservations exist. If the container has been adjusted, a check box will be marked in the Container Info screen. The received quantity and damage quantity fields will be populated with the same value as when the container had been confirmed.

The ellipsis in the lower right hand corner will access the footer menu which will contain the functions that can be performed on a container.

Footer Menu

Info: Info will access the Info (Container) popup.

Notes: The Notes option accesses the notes common dialog to capture notes.

Default Regular Qty: Copies the expected quantity to the received quantity field.

Clear Qty: Clears the received quantity and damaged quantity fields for ALL items in order for you to start over.

Damage Mode: Scan/enter items and update the damage quantity field.

Regular Mode: Scan/enter items and update the received quantity field. This is the default mode.

Edit Container: Accesses the [Edit Container](#) screen.

Edit CFAs: Enter values for the CFAs that are set up for transfer deliveries - containers.

Adjust: Reopens a container in Completed status and moves it back to In Progress.

Damage Remaining Qty: Updates the remaining quantity not yet received to be applied to the damaged quantity field.

Display Only Discrepancies: Shows only the items with a received quantity plus damaged quantity that do not match the expected quantity.

Display All Items: Revert back after displaying only discrepancies. This is the default display.

Confirm: Moves the container in an 'In Progress' status to 'Received'.

Save: Saves the container in 'In Progress' status to be completed later. This option is only available when the screen is in edit mode.

When the container is saved, the UINs flagged as Received or Damaged and are not flagged to remove, the UIN status is updated to 'In Receiving'.

- If a UIN is flagged for removal, the UIN will be deleted if the UIN has a status of 'Unconfirmed' (this identifies the UIN as manually added).
- If a UIN is flagged for removal, the UIN receiving mode is removed if the UIN has any status other than 'Unconfirmed' (this identifies the UIN as pre-existing from an ASN).
- If an item is flagged for removal, when you save the container and returns, the item will no longer exist in the container. Note: Only unexpected items added can be removed.
- If a UIN was relocated from another store:
 1. The UIN status is updated from In Stock to In Receiving.
 2. A notification is generated and sent to the store the UIN was relocated from.

Delete: Marks the container to 'Canceled' or 'Missing' status. If the container is from an external system, the container will be marked as 'Missing', otherwise, it will be marked as 'Canceled'. This option will only be available for containers that are in a 'New' or 'In Progress' status.

Cancel: Exits the container and changes made in that session will not be saved. This screen is only available when the screen is in edit mode.


Back: Returns to the previous screen. This option is only available when the container is view only.

Print: Opens the print dialog and allows you to select formats and print various reports and container labels. The Transfer Receiving Container report will be available on this screen. This option will always be available regardless of the receipt or container status.

Print Tickets: Opens the Print Tickets dialog to print the tickets or labels for the current container items. This is described in common usage document with more details.

Item Detail

The Item Detail screen is used when selecting or scanning an item from the [Container Items](#) screen. Scanning or entering an item on this screen in the scan bar will update the quantity per the scan mode and refresh the item detail screen for the item and quantity scanned. The quantity can be edited and updated manually if permissions allow. You can enter quantity for items with **Non Inventory** indicator as **Yes**.

The item information including the image which is system configured to display in the header. The bottom portion of the screen contains information fields of inventory qty, remaining qty, document qty, and reason code (for unavailable inventory only) pertaining to the bucket stock is coming from. Lastly, the details of the last scanned barcode will be displayed.

The footer menu (ellipsis button), contains a **Reset** function as well as **Remove** and **Restore** functions. Page through existing item in the container view the arrows on the bottom. If the container is displaying only discrepancies, you will page through only the discrepant items.

If the user scans the Item ID of a UIN item or if he scans a UIN, he will be taken to the UIN tab within the Item Detail screen, for that item.

In the UIN tab the system displays all the UINs for the selected item, if the UINs were part of the ASN. Otherwise, the screen will remain blank until UINs are scanned/entered for the item.

When entering the screen for the first time, the status will display the following:

1. The UINs included on an incoming ASN will be displayed with a status of "Shipped to Store".
2. The UINs manually added will be displayed with a status of "Unconfirmed", if they do not previously exist.

- The UINs manually added may have another status, if they already exist in the system.

When re-entering this tab, the status will be updated to "In Receiving".


When the transaction is no longer editable, the screen will be in view only mode.

You will not have the ability to change the Receiving Mode for the UIN.

There is also an **Extended Attributes** tab that enables the user to view/capture Extended Attributes for the item. If the item is not configured to capture extended attributes or there are no extended attributes captured, the list will be empty.



Receive on Shop Floor: The default will be based on the store parameter **Direct Delivery Default to Shop floor Receiving**. If set to **Yes**, the check box will default to

marked. You are required to have **Receive Direct Delivery on Shop floor** permissions to change the value. This indicates whether the delivery will default to receive inventory into the shop floor instead of automatically receiving into the back room or delivery bay. If this is set to receive on shop floor, the system increments the shop floor inventory bucket instead of the backroom or delivery bay bucket. If a capacity is defined for the item and **Direct Delivery Receive Item Capacity** is set to **Yes**, the maximum shop floor quantity will equal the capacity; otherwise, the shop floor will be updated to the entire receipt amount. If the capacity is used and if the receiving quantity is excess, the balance is incremented to delivery bay or back room depending on the Replenishment - Delivery Bay Inventory parameter. If **Receive on Shopfloor** is not set on the delivery, the system increments the back room or delivery bay bucket depending on the Replenishment - Delivery Bay Inventory parameter. If this parameter is on, the system will increment the delivery bay bucket instead of back room. Regardless the stock on hand will be updated. 
Figure 7-44 Info (Container) Popup

In JET Mobile, the Receive Transfer screen is accessed by scanning/entering a Transfer Receiving record from the Open Transactions Screen with the status of 'New' or 'In Progress'. The Open transactions screen itself lists only the open transactions. The Transfer Receiving record can be a transfer from a store, finisher or warehouse to the user's store. The Receive Transfer screen will only allow for receiving the entire transfer, there will be no container or item level receiving.

This screen provides the following information about the transfer delivery:

ASN <X> — The ASN ID for the delivery/receipt.

<X> Containers - the number of containers on the ASN, where 'X' is the number.

<X> SKUs - the number of SKUs / line items on the ASN in all containers, where 'X' is the number.

<X> Expected Qty - the total expected quantity for all line items on the ASN, where 'X' is the total. This will be the sum in SUOM across all the items.

List of containers:

- Container <X>- This field holds the identifier (external id) for the container printed on the container label.
- <CO/CO Mix> - This field will indicate whether customer order is associated for this container.
 1. CO-If all the items in the transfer are associated with a customer order.
 2. Blank- If there is no any item associated with a customer order.
 3. CO Mix- If the transfer contains items both with and without customer order associated with it.
- **Tracking ID** - This field displays the tracking id assigned to the container (if there is one).
- **<Status>** - This will display the status for the container. Values: New (Blue), In Progress (Blue), Missing (Red), Damaged (Red) and Received (Green)
- **<X> SKUs** - This field holds the number of unique SKU's in the container.

Footer Menu

Print - will download the Transfer Receiving report information.

Information - the Information screen for the Transfer ASN will be displayed

Receive All - Receives all the containers in the delivery

- The items will be received on shopfloor depending on the setting '<Source Type> to Shop floor Receive' setting. If the '<Source Type> Receive Item Capacity' is = Yes, and the container is being received on the shop floor, the capacity for the item will be considered and quantity above the capacity will update the backroom. Inventory buckets are updated. If there are CFAs set up which are mandatory, there will be no validation on whether a value has been entered or not, for mandatory CFAs.
- If any of the item in the delivery is an item with UINs associated to it, if the UINs were identified on the ASN (PRE-POPULATED) and the number of UINs in the ASN match the expected quantity, all the UINs that came on the ASN will be received and the status will be updated to 'In stock'. Otherwise, the item will not be received. If the item is an AGSN item, the UINs are auto generated post receiving.
- If the delivery is for a customer order and 'Reserve Customer Order Inventory on Receipt' store config is set to 'Yes', the system will update the customer reserved inventory bucket for the items on receipt. When the reservation happens on receipt, if 'Auto Pick on Receipt indicator' is set to 'Yes', the pick quantity is also updated automatically with the original requested quantity or the received quantity, whichever is less.

The Information screen can be accessed by clicking on the 'Information' option from the footer menu in the Receive Transfer screen. This screen enables the user to view information regarding the delivery and also lets the user to enter/edit information.

The details present in the screen include: Source Type, Source ID, ASN number, Delivery ID, Status, Expected Date, Create Date, Create User, Updated, Update User, Received, Received User, Carrier Name, Carrier Type, Carrier Code, License Plate, From Address, Freight ID, Bill of Lading, and the CFAs. The License Plate and Freight ID fields may be used for other purposes, such as a Weigh Bill ID or BOL ID. It may also include a field called 'Fiscal Doc ID'. This field would be a placeholder for the government reference ID for the delivery, if available.

CFAs can be entered values or edited through this screen if the user has Edit Delivery-CFA security permission.

The fields such as Carrier Name, Carrier Type, Carrier Code, License Plate, From Address, Freight ID, Bill of Lading, Receive on Shopfloor are editable if the user has 'Edit Receipt' security permission.

Quick Receiving

The Quick Receiving dialog allows users to receive store, warehouse, and external finisher deliveries by scanning a container and marking the container as received immediately without scanning all the items within the container.




Figure 7-47 Quick Receiving Screens

Scan or enter the internal or external container IDs or the Tracking ID to find the matching shipments. The list will display anything that is scanned or entered including invalid scans.

The header of the screen lists the number of containers that have been scanned/entered and their receiving status.

- **Total Scan:** Total number of containers scanned during the session.
- **Rcvd Containers:** Total number of containers that have been successfully received during the session.
- **Rejected Containers:** Total number of container rejected (previously received containers) during the session.
- **Invalid Scans:** Total number of container scanned which are invalid during the session.
- **Not Received:** Total number of valid containers not received during the session. For example, when a misdirected container is scanned and not allowed to be received.

The following icons will be displayed to identify which scans are valid and which are in error:

- Green circle with check indicates the container is received.
- Orange triangle with exclamation point indicates the container was previously received.
- Red circle with exclamation point indicates the container ID scanned or entered is invalid or not received.
- Blue circle with up arrow indicates that the container scanned is pending processing.

Available Versus Unavailable Inventory

When a transfer is saved, the system will move the items from either available or unavailable (non sellable) inventory, based on the inventory status, and move it to the reserved bucket within unavailable inventory. For warehouse and finisher returns, the Transfer Reserved bucket is updated. Upon dispatching of the transfer, the reserved buckets will be relieved and the stock on hand will be decremented. If sub-buckets are turned on, the appropriate sub-bucket associated with the shipment reason will be updated when transferring from unavailable inventory.


Transfer Document (JET Mobile)

The Transfer Document dialog allows you to create transfer requests requesting items from a store, accept and reject transfer requests from a store as well as create and approve transfer documents to ship items to warehouse, store and external finisher in a single dialog.

Transfer Document features:

- Creation of transfer documents to allow the movement of goods between stores or from a store to a warehouse or external finisher.
- Creation of transfer requests from a store to another store requesting for movement of goods. The sending store will have the ability to either accept the request or reject it.
- Transfer requests created externally can be accepted or rejected.
- A flow exists to pick items for the transfer document.
- Transfers can be done from both available and unavailable inventory.
- Visibility of shipment and receipt values after transfer approval.
- View Transfer Documents and Requests for Transfer
- Look up Shipping and Receiving Details
- Close a Transfer
- Capture values for CFAs (Custom Flexible Attributes)
- Print Reports
- This will also be a placeholder for Stock Order messages from external system for Store, Warehouse and Finisher deliveries.

Destination Types

Transfer Shipment to Store (Store to Store):

To create a Store Transfer Shipment, the destination type of 'Store' must first be identified for the shipment. The system provides a list of valid store locations. User can do a lookup as well.

Transfer Shipment to Warehouse and to Finisher:

To transfer items to a warehouse, the destination type of 'Warehouse' must first be chosen for the shipment. The system provides a list of valid warehouses. For a transfer to Finisher, select a destination type of 'Finisher' and select the destination for the shipment, or search for it using the lookup widget. Finishers are restricted to those which are for the same organization unit as the store.

Customer Orders


Transfer requests can come from the merchandising system to request goods from one store to another store that are for a customer order. These transfer requests will appear in the Transfer dialog.

There will be a customer order indicator on the transfer to denote that the transfer has a customer order affiliated with it. When searching for a transfer using the filter, you can search for those transfers that are for customer orders, or search for a transfer that contains a specific customer order ID and fulfillment order ID.

The Info screen will display the specific customer order and fulfillment order ID for that transfer if there is one. Allow Partial Delivery is populated based upon the customer order or the system can be configured to not allow partial customer order transfer shipments. If Allow Partial Delivery is not on, then, when accepting a transfer request, you must accept the full amount being requested. If system parameter Customer Order Fulfillment Restriction is set to Line Controlled, for transfer requests associated with a customer order, any item getting approved should get approved completely.

Transfers

When navigating to Transfers from drawer menu->Shipping & Receiving or from Quick Actions, you go to the Transfers screen, which lists the inbound and outbound transfer requests and documents for your store.

The user must have 'Access Transfer' security permission to access this screen. This screen displays 'Active' transfers by default. User can click on a Transfer record and the system will take the user to the Transfer Items screen.

The records in the Transfer List screen are sorted in the following manner by default when the user enters the screen:

- The Outbound records are listed first, and within the outbound records, the records are sorted by Not After Date, lowest Not After Date to highest.
- The Inbound records are listed after the Outbound records and within the inbound records, the records are sorted by Not After Date, lowest Not After Date to highest.

In addition, the user has been provided with different options to sort - by Transfer ID, Newest or Oldest based on Create Date of transfer.

Figure 7-51 Search Criteria Screen 1




Figure 7-52 Search Criteria Screen 2

The Transfer Search Criteria Screen is accessed by clicking on the magnifying glasses on the [Transfers](#) screen. After applying the search criteria, the results are listed on the Transfers screen and the criteria applied is also shown. Create Request

A request is created from the Transfers screen by clicking on 'Create New' button and selecting 'Create Request' option, when a store wants to receive items from another store. The user must have 'Create Request' security permission to create a new request.

A request can be generated from an external system or be created in the mobile application. If the request has been created in the mobile application, then Source Type can only be a Store. A store cannot create a transfer requesting for items from a warehouse or a finisher.

The request can only be created if the store creating the request is in the same transfer zone as the source store or from a null transfer zone. Also the requesting store should not be an excluded store for the Source store, that is, the requesting store must be in the shipping network of the source store in order to request items from a store. However, if the user has 'Override Exclude Shipping Network' security permission, they can proceed with creating the request. A store's shipping network is setup through the 'Store Shipping Network' screen in the desktop application.

The user can select the source store either through the Buddy Stores tab or All Stores tab. In the Buddy Stores tab, system will automatically list only the buddy stores set up for the store you are logged into. However, any other store can also be searched and selected from the All Stores tab.

If the store requesting items wants the items before a certain date, a date can be selected or typed into the Not After Date field. The request will automatically cancel if not accepted by this date. There are notifications in place to ensure the transaction is fulfilled in time, if configured.

The request needs to be accepted by the other store before a transfer can be shipped. Once accepted, the transfer document can be used to restrict or default items in a shipment/ container.

Create Transfer



Transfer Items (Request)

The Transfer Items screen is used when creating a new request which allows the requesting store to ask for items from another store. Initially this screen will not have any items. The user can add items to the request by scanning/entering the Item ID in the scan bar. This screen is also displayed when selecting a saved request from the [Transfers](#) screen. The items that have been added to the transfer request are listed in this screen. The item image for the line items is displayed per configuration done in the User Preferences.

Line items appear in a list and the user can update the request quantity for the items in the list or navigate to the item detail of that item by selecting the item. The user can also add new items to the list. This screen also displays a filter. The filter can be used to narrow down the list of items. Filtering can occur by item ID and description. The filter disappears when you scroll down through the list of items.

Items with Non-Inventory set as Yes are also allowed to be added to the request.

On scanning or entering an item in the scan bar, the user will either stay on the screen or go to the Item Detail based upon the Scan Navigation user preference. Quantity may be updated depending on the scan mode. The item must be unique on the transfer.

The ellipsis in the lower right-hand corner accesses the footer menu which contains all of the functions that can be performed on a transfer request.

Footer Menu

The footer menu is accessed from the ellipsis footer menu on the Request Items screen. The menu functions include the following:


- **Info:** Accesses the Info popup. Lets you enter values for the CFAs that are set up for Transfer documents. Also, the screen will allow you to enter Context Type, Context Value, Not After Date, and so on.
- **Notes:** The Notes option accesses the notes common dialog to capture notes.

Item Detail (Create/Edit/View Request)

The Item Detail screen is used when selecting or scanning (when set by User preference) an item from the Transfer Items screen of a request in the requesting store. Scanning or entering an item on this screen in the scan bar updates the quantity per the scan mode and refreshes the Item Detail screen for the item and quantity scanned. You can enter the quantity to be requested for the items.

The quantity can be edited and updated manually if permissions allow. The system validates whether the item that is getting requested has enough inventory at the sending store. If the sending store doesn't have enough available inventory for the item, a soft warning is displayed. If the sending store doesn't have enough unavailable inventory for the item, an error is displayed. A transfer request created in the mobile

application can request the item from both the available and unavailable inventor similar to a transfer request created in an external system.

Items with **Non-Inventory** set as **Yes** are also allowed to be added to the request.

The item information including the image (which is system configured) display in the header. The screen contains fields for entering the quantity being requested, pack size of the item if the **UOM** mode is Cases and a field that displays the SOH of the item in the sending store. The details of the last scanned barcode will be displayed at the top. You can page through existing items on the request using the arrows on the header.



Accepting/Picking Request

Once the requested transfer is created by the receiving store or in the merchandising system, the user on the shipping side of the transfer can enter approved quantities or pick items and set them aside for eventual shipment. Once the quantities are entered or picking is completed, the transfer moves to an Approved status.

This screen enables you to pick and approve the quantities to ship, for the requested items. This screen will display the items that have been requested. The item image for the line items is displayed per configuration.

Line items appear in a list and selecting a line item navigates to the item details of that item. This screen also displays a filter. The filter can be used to narrow down the list of items. Filtering can occur by item ID and description. The filter disappears when you scroll down through the list of items.

Default Quantities: Allows you to default the requested quantity to the Approved quantity field for all the items in the transfer.

Clear Quantities: Clicking this option makes the Approved qty to NULL for all items on the transfer.

On scanning or entering an item in the scan bar, the user will either stay on the screen or go to the Item Detail based upon the Scan Navigation user preference. Quantity may be updated depending on the scan mode.

Items with Non-Inventory as Yes are also allowed to be in the transaction and you can enter approved quantity for these items.

You can add (unexpected items) to ship along with the requested items if you have the necessary security permission.

The ellipsis in the lower right hand corner accesses the footer menu which contains all of the functions that can be performed in this screen.

Footer Menu


The footer menu is accessed from the ellipsis footer menu on the Transfer Items screen. The menu functions include the following:

- **Info:** Accesses the Info popup. Lets you enter values for the CFAs that are set up for Transfer documents. Also, the screen will allow you to enter Context Type, Context Value, Not After Date, Allow Partial Delivery indicator and so on.

If system parameter **Customer Order Fulfillment Restriction** is set to **Line Controlled**, for transfer requests associated with a customer order, any item that is getting approved should get approved in its entirety. The validation on mandatory CFAs is also done here. The user can also choose to create a shipment immediately on accept if he wants to, provided if he has security permission to do so.

Item Detail (Accept/Reject Request)

The Item Detail screen is displayed when selecting or scanning an item from the [Transfer Items](#) screen of a transfer request in the sending store. Scanning or entering an item on this screen in the scan bar updates the quantity per the scan mode and refreshes the Item Detail screen for the item and quantity scanned. You can enter the approved quantity for the items that have been requested by another store.

The quantity can be edited and updated manually if permissions allow. Items with **Non-Inventory** set as **Yes** are also allowed to be in the transaction and you can enter approved quantity for these items.

The item information including the image (which is system configured) display in the header. The screen contains fields for entering the quantity being approved, pack size of the item if the UOM mode is Cases, Primary Location where the item is present if sequencing has been done for the item, field that displays the requested quantity of the item, a field that displays the available/unavailable quantity depending on the inventory bucket from where the item has to be picked. This screen also displays certain fields depending on the status of the transfer. For example, In Shipping field is displayed if the transfer is in 'In Shipping' status.

Received and Damaged quantity fields are displayed if the transfer is getting received at the requesting store. You can view the list of locations where the item is available (if sequenced) to help you to pick the items faster. The details of the last scanned barcode will be displayed at the top.

The footer menu, ellipsis button, contains a Delete function to enable the user to remove an item. You can also page through existing items on the transfer using the arrows on the header.


Transfer Items

Creating/Approving a Transfer

The user will go to the Transfer Items Screen after the user has created the transfer, by selecting the Create New button from the Transfers screen and selecting to create a transfer or selecting a transfer from the Transfers screen that is in 'Transfer In Progress' status. The

user can add items and the corresponding ship quantity that he wants to ship to another store and approve the transfer which will be eventually shipped .



This is of a transfer that the sending store has directly created in order to ship items to another store. Scanning or entering an item on this screen in the scan bar updates the quantity per the scan mode and refreshes the Item Detail screen for the item and quantity scanned. You can enter the quantity that is approved to be shipped for the items.

The quantity can be edited and updated manually if permissions allow. The system validates whether the item has enough inventory at the sending store. If the sending store doesn't have enough available inventory for the item, a soft warning is displayed. If the sending store doesn't have enough unavailable inventory for the item, an error is displayed.



Info Screen

The Info screen is an informational popup that contains a few read-only and editable information about the header level of the transfer. The screen is accessed by clicking on Info footer menu option from the Transfer Items screen. The list of fields is dependent on the status of the transfer. Details include Transfer Document ID, External Transfer Document ID, Source/Destination Type, Source/Destination ID, Status, Context Type and value, Inventory bucket information (Available or Unavailable), Allow Partial Delivery indicator, Customer Order/Fulfilment Order info, Request Date/User, Create Date/User, Approve Date and Approval User, Close/Reject Date/User and the CFAs.

 **Note:**

A transfer document can only contain available or unavailable inventory. The selection of this has to be completed before adding the first item. After the first item is added, the available/unavailable option will be locked down.

The Info screen displays the list of CFAs (flexible attributes) that have been set up for Transfer Documents, in the desktop application and lets you enter values for them. The CFAs that are set up as 'Required' must have a value entered for it before

creating/accepting the transfer. Appropriate security permission is needed and the transaction must be in editable status for entering CFA values. For Transfers, the CFAs can be captured for the same transfer in both destination and source stores while creating and approving request respectively. In this case, same set of CFAs will be available at both the stores. The CFAs captured during request create will be available in the screen of request approve along with the values captured and the values can be overridden.

This screen allows you to edit certain information of the transfer request like Context Type/ Value, Not After Date, Allow Partial Delivery (Y/N). You need appropriate permission to edit these fields and this screen is available only when the transfer request is in 'New request' status.

A context type and value can be entered if necessary. The context type is used to give a reason or purpose for the request. For context types of 'PROM(Promotion)', the Context Value field will be displayed and a promo ID will need to be entered. If the promo ID exists, the description for the promotion will be displayed. If the promotion ID does not exist in the system the description displays as 'Unknown'.

Transfer Shipping (JET Mobile)

The Transfer Shipping dialog is focused on shipping out items using a container or not using a container, depending on the retailer's business process. Each shipment can be associated to one or more complete or partial transfer documents. The shipment/Containers(if applicable) can also be restricted to specific merchandise hierarchies to prevent mixing of items.

Transfer Shipment features:

- Supports shipping to the store, warehouse, or external finisher
- Creating shipments without containers, with/without referencing transfer documents (on the fly)
- Multiple transfer documents allowed in a single shipment (without container)
- Create container without referencing a transfer document (on the fly)
- Limit store selection by buddy store and transfer zone
- Multiple containers allowed in a single shipment
- Manifest system integration and package tracking ID processing
- Two step approval process to warn of pending shipments
- Restrict merchandise packaged together by merchandise hierarchy

Features

- Search for transfer shipments
- Create a new shipment (with or without container)
- Create a new container, for shipments with container
- View or edit an existing shipment or containers
- Delete or cancel 'In Progress' containers or shipments
- Submit, cancel submit, or dispatch a shipment

- Capture values for CFAs (Custom Flexible Attributes)
- Print pre-shipment and manifest

Figure 7-62 Transfer Shipment without Container Screen Flow





Figure 7-63 Transfer Shipment with Container Screen Flow



When creating, editing, or viewing a shipment with containers, you are directed to the list of containers within the shipment on the [Containers](#) screen. Here, you can create a container, edit or view a container. When creating, editing, or viewing a container, you are directed to the list of items in the container on the [Container Items](#) screen. You can add, view, and edit the details of the items on this screen as well as on the Item Detail screen.

When creating, editing, or viewing a shipment without containers, you are directed to the Transfer Shipment Items screen where the items to be shipped and their details can be added.

Submit

The shipment can be saved in 'In Progress' status to continue edits later or it may be submitted or dispatched. Submitting is possible when the store setting Dispatch Validate is configured for 'Ship Submit'. Submitting will set the shipment to a 'Submitted' status and not allow for edits, there are no updates to inventory at this point. The only step possible will be to Cancel Submit or Dispatch. If the system is enabled to obtain Fiscal Doc ID/E-way bill ID for the shipment, the process to request for the same starts once the shipment is submitted.

Dispatch

When the shipment is dispatched, the transfer reserved quantity for the outbound location will decrease in addition to the stock on hand. If no shipping quantities are identified the

transaction should be cancelled. Inbound is increased at the receiving store for what has been shipped. If the system is enabled to incorporate Fiscal Doc ID/E-way bill ID as part of the shipping process, the shipment cannot be dispatched until the Fiscal Doc ID/E-way bill ID is available. The exception is when the user has 'Allow dispatch without Fiscal Document ID' security permission.

Customer Orders

The Shipment Info screen has a field called Customer Orders, which is set to Yes when there are customer orders associated with transfer documents and a link has been provided to view the details of customer orders associated. It will display the Customer Order and Fulfillment Order IDs, along with the Container ID where the items are in, Status, Total SKUs in the customer order.

When dispatching a transfer shipment, if the transfer associated to the shipment has **Allow Partial** set to **No**, then you must ship the full amount which is requested.

If there is a transfer in the shipment with a customer order with **Allow Partial Delivery** indicator is **Yes** and the system parameter **Customer Order Restriction** is set to **Line Controlled**, the items being delivered must be delivered in their entirety. Partial delivery of an item is not allowed. This validation is done on both Submit and Dispatch of a customer order.

Containers

The containers within a single shipment will display on this screen if the shipment has been created with containers. If the shipment has just been created, the list will be blank. Several functions may be performed on this screen to include the following:

- One or multiple containers can be created, which is controlled by security permission
- Add items from transfer documents and ship them
- Add additional items to the shipment
- View additional details
- Update authorization number, Context Type
- View customer orders associated with transfer documents added to the shipment
- Set up the carrier shipment details
- Submit/Dispatch the shipment

Shipment without Containers

Shipments can also be created without the containers. When a shipment is created, the user is taken to the Transfer Shipment Items screen which will be blank initially. The user can then start adding items directly to the shipment. The user can do the following within the shipment:


- Add items from transfer documents and ship them
- Add additional items to the shipment
- View additional details

- Update authorization number, Context Type
- View customer orders associated with transfer documents added to the shipment
- Set up the carrier shipment details
- Submit/Dispatch the shipment

Transfer Shipments

Transfer Shipments are accessed on mobile through the Shipping / Receiving menu within the drawer. Selecting the menu option will take you to the Transfer Shipments screen. On this screen, you can create a new shipment or search for shipment records.

When navigating to Transfer Shipping, you go to the Transfer Shipments screen with the default list being defined for 'Active' shipments. This screen gives a quick view of the list of shipments along with the details such as shipment's status, destination type/name, status of the Fiscal Doc/E-way bill request(if the system is configured to use Fiscal Doc ID/E-way Bill ID), etc.

You can use the search criteria magnifying glasses to navigate to the transfer shipment search criteria screen to enter search criteria to search for transfer shipments. User can scan/ enter Shipment ID/Container ID(internal/external ID)/Tracking ID/Fiscal Doc ID to fetch the shipment needed. When scanning/ entering these IDs in the scan bar, the system adds the ID scanned to the respective search criteria field and narrows down the current list of shipments

by the ID scanned. If there are multiple containers found with the same scanned or entered number, you are prompted to select the shipment/container to return.

The **Create New** button prompts you to create a new shipment. You can create a shipment for store, warehouse, or finisher. The destination types for which a user can create a shipment is controlled by the data permission **Transfer Destination Type**.

In the case of a shipment to a store, the shipment is allowed to be created only if the destination store is not an excluded store for the source store. That is, the destination store has to be in the shipping network of the source store in order to ship items. However, if the user has **Override Exclude Closed Stores** permission, the system allows the user to proceed with creating the shipment if needed. The user can setup the shipping network for a store using **Store Shipping Network** screen in the desktop application.

The user can select the destination store either through the Buddy Stores tab or All Stores tab. In the Buddy Stores tab, system will automatically list only the buddy stores set up for the store you are logged into. However, any other store can also be searched and selected from the All Stores tab.

If the destination is a warehouse, the user can choose the warehouse using the drop-down which lists all the warehouses available. If the destination is a finisher, the user can type in the finisher ID if known or can use the lookup available to search for the finisher.

The user can specify the Authorization code for transfers to warehouse and finisher. If the user has permission to enter Context type, it can be entered as well. Context Type can be made mandatory using a Store configuration

The User can choose to create the shipment with or without containers. Creating a new shipment with containers will direct you to the [Containers](#) screen with no containers listed initially. If you select an existing shipment, the same screen displays a list of created containers

Creating a new shipment without containers or opening a shipment without containers will direct you to the [Transfer Shipment Items](#) screen.

Search Criteria (Transfer Shipment)

The Search Criteria screen is accessed by the magnifying glasses on the [Transfer Shipments](#) screen. After applying the search criteria, the results will be listed on the Transfer Shipments screen and the criteria applied will show. The following fields can be searched on from this screen: Last Updated, Destination Type, Destination ID, Destination, Document ID, ASN, Item, Container ID, Customer Order ID, Fulfillment Order ID, Customer Orders Exist, Shipment Status, Context Type, and Context Value. If the retailer has set up the system to use Fiscal Document/E-way bill for the shipments, there will be additional criteria provided in the screen such as Fiscal Request ID, Fiscal Doc ID and Fiscal Request Status.

Containers Screen

When creating or selecting an existing shipment with containers from the [Transfer Shipments](#) screen, you go to the [Containers](#) screen with the list defaulted to Active containers. When scanning/ entering a container ID(internal or SSCC)/Tracking ID/ Item ID in the scan bar, the system will navigate you to the **Container Items** screen and display the items currently in the selected container.

The **Create** button will create a new container for the shipment. Creating a new container will direct you to the **Container Items** screen with no details (items) in order to build a new container. Lastly, selecting a container from the list will navigate to the details for that container. The button will not be available after the first container was created if the user doesn't have 'Allow Create Multiple Containers' security permission. This is to restrict users to ship with only one container

Footer Menu

Shipment Info: Enables the user to access the Shipment Info screen.

Bill of Lading: Enables the user to access the Bill of Lading screen.

Note: The Notes option accesses the notes common dialog to capture notes.

Cancel Submit: Cancel Submit will reverse the Submit and move the shipment back to 'In Progress'.

Delete: Delete will mark the shipment to 'Canceled' status.

Back: Back will exit the shipment. Available in view only mode.

Cancel: This option is used to exit the shipment without saving any changes. This is available only when the shipment is in edit mode.

External Printing: External Printing will display the External Printing popup to select a printer for the pre-shipment notice and manifest documents.

Print: Opens the print dialog and allows you to print various reports and container labels. The Transfer Shipment Container report and the BOL Detail report will be available on this screen.

Footer Buttons

Create: Create will create a new container in the shipment.

Submit: Submit will perform validations for 'In Progress' shipments including excluded store validation and lock the shipment for additional edits. The shipment will be ready for dispatch. This menu option will only be available when the store parameter 'Transfer Shipment Dispatch Validate' is set equal to Ship Submit. Validations to check if the destination is a closed store for the sending store, mandatory check on CFAs, Context Type etc., will happen here. The process to start obtaining Fiscal Document ID also happens at this point, if configured.

Dispatch: Dispatch will perform validations including excluded store validation and post transactions to finalize the shipment and no further changes are allowed. Validations to check if the destination is a closed store for the sending store, mandatory check on CFAs, Context Type, Fiscal Document ID etc., will happen here.



Customer Orders

The **Customer Orders** screen is an informational screen that contains read-only information about the customer orders within the shipment.


The user will go to the Customer Orders screen in either of two ways: Upon clicking 'View Details' link in the Shipment Info screen and upon clicking 'View Details' link in the Info(Container) screen. The screen will list the customer orders present in the selected shipment if the user opened the screen from Shipment Info screen. The screen will list the customer orders present in the selected container if the user opened the screen from Info(Containers) screen.

The customer order information displayed in the screen includes: Customer Order/ Fulfillment Order ID, Status, the internal/external Container ID where the items on the customer order has been kept, the Transfer Document ID associated with the Customer Order.

The filter can be used to narrow down the list of items. Filtering can occur by Customer Order ID, Fulfillment Order ID, Container ID, and Customer Order Status.

Container Items

The Container Items screen is used when creating a container within a shipment.

There are several functions you can perform on this screen. Some of the features include:

- Create, edit, delete, or confirm a container
- Add items from transfer documents or add loose items
- Adjust(re-open) a container after it has been confirmed

The container can be created with or without referencing a transfer document. The items within a container must be shipped either from available inventory or from unavailable inventory.

When a container is created but not yet completed, the container will display a status of 'In Progress'. The transfer reserved bucket will update the moment the container is saved for on-the-fly shipments. If the item is from a request, reservation must have happened at the time of approval of the request. Any new additions or deletions of items and quantities are updated to the approved document. It will also update the In Shipping quantity in the document. When the shipment is dispatched, the saved quantity in the transfer reserved bucket is removed. This will keep the inventory accurate.

The items on the list are for the container.

The item image for the line items is displayed per configuration. Line items appear in a list and selecting a line item will navigate to the item details of the item. Scrolling in the list of items on the left will display a filter. The filter can be used to narrow down the list of items. Filtering can occur by Item ID, Description, Document ID and Reason Code.

If the **Non-Inventory** indicator of the item is set as **No**, the SOH of the item is updated at the completion of the transaction.

If the **Non-Inventory** indicator of the item is set as **Yes**, the item can be added to the transaction however the SOH will not be updated on confirmation/completion of the

transaction. That is, the item can be scanned/added to the transaction, and you will be able to enter/update quantity just like a normal (inventory enabled) item. All the processing rules and validations that apply to inventory enabled items would apply for non-inventoried items too except that the validations done on quantity against SOH will be ignored. On dispatch, the SOH of the item will not be updated since the application doesn't preserve the inventory details of the items with **Non-Inventory** indicator set as **Yes**. Publishing of non-inventory items can be restricted depending on administration integration settings.

Inventory Type of items (Available or Unavailable) in the container is held at a container header level. This means that all items in the container must be for the same inventory type, there cannot be a mixture. Once items from a transfer have been added to the container, the inventory type is set for the container and can no longer be changed. However, a shipment may have both unavailable and available containers.

If inventory is from unavailable inventory, the shipped quantity cannot exceed the unavailable stock. If the system is configured to use sub-buckets, then the sub-bucket associated to the reason codes which are for unavailable inventory will be displayed. The sub-bucket will be updated as the unavailable inventory is updated.

When a container is set up to use unavailable inventory, a reason code must first be selected before you can add or edit an item in the container. The reason code is selected on the header part of the screen. Containers that are set up to use available inventory will not use reason codes. The reason code selected will be applied to all newly added items until it is changed to a different reason, in which the newly changed reason will be added to the subsequent newly added items.

For containers with available inventory type, scanning or entering an item in the scan bar will navigate you to the Item Detail screen for the item or remain in the same screen (depending on the User preference set). Quantity may be updated, depending on the scan mode. If the user scans the Item ID of a UIN item or if he scans a UIN, he will be taken to the UIN tab of the Item Detail screen. You can also edit/update the ship quantity from this screen.

For containers with unavailable inventory type, scanning or entering an item in the scan bar will always navigate you to the Item Detail screen for the item irrespective of the User preference set. The quantity can be updated from the Item detail screen unlike containers with available inventory type.

In the header of the screen, the currently selected transfer document will display. When first entering the container, 'Adhoc Document' will be displayed. You will need special permissions to add items without selecting a document. Access the active documents by tapping on this link which will take you to the Select Document screen.

Next to each item, the UIN icon will display if the UINs have been associated to the item.

The ellipsis in the lower right hand corner will access the footer menu which will contain all the functions that can be performed on a container.

Save: Saves the container in 'In Progress' status to be completed later. This option is only available when the screen is in edit mode.

Print: Opens the print dialog and allows you to select formats and print various reports and container labels. The Transfer Shipment Container report will be available on this screen.

Print Tickets: Opens the Print Tickets dialog to print the tickets or labels for the current container items. This is described in common usage chapter with more details.

Delete: Marks the container to 'Canceled' status. This option will only be available for containers that are in a New or In Progress status.

Cancel: Exits the container and changes made in that session will not be saved. This screen is only available when the screen is in edit mode.

Back: Returns to the previous screen. This option is only available when the container is view only.



Figure 7-75 Item Detail (Quantity) Screen




Figure 7-76 Item Detail (UIN) Screen




Figure 7-77 Item Detail (Extended Attributes) Screen

The Item Detail screen is the screen used when selecting or scanning an item from the Container Items screen or from the Transfer Shipment Items screen when not using a container. This screen allows the user to add ship quantity for an item. Scanning or entering an item on this screen in the scan bar will update the ship quantity per the scan mode and refresh the item detail screen for the item and quantity scanned. The quantity can be edited and updated manually if permissions allow.

Items with **Non-Inventory** Indicator set as **Yes** are also allowed to be in the transaction and you can enter ship quantity for these items.

If the user scans the Item ID of a UIN item or if he scans a UIN, he will be taken to the UIN tab of the Item Detail screen.

The item information including the image which is system configured to display in the header. The screen contains information fields of inventory qty, remaining qty, document qty and reason code (for unavailable inventory only) pertaining to the bucket stock is coming from. Lastly, the details of the last scanned barcode will be displayed at the top.

For containers with inventory type of 'Unavailable,' if the same item must be shipped using multiple reason codes/sub-buckets, you can do this from the same Item Detail screen.

Pack size can be edited from this screen.

The footer menu (ellipsis button), contains a options to Edit pack size, View Locations and Delete. Page through existing item in the container view the arrows on the top.


There is also a UIN tab to take you to the UIN screen to add and remove UINs for UIN items.

In order to add UIN details for UIN items, the UIN screen is accessed by selecting the ship quantity field for the item from the Item Detail screen.

There is also an Extended Attributes link that enables the user to view/capture Extended Attributes for the item, if the item is not configured to capture extended attributes.

Select Document

The Select Document screen is used for adding items to ship into the container or shipment without containers. Access this screen by tapping the Document ID in the header bar of the Container Items screen for shipments with containers or from the Transfer Shipment Items screen for shipments without containers. If there are no approved documents to display, the list will be empty.

The documents displayed in the screen are based on the Transfer Type (Available or Unavailable) selected in this screen (header) or in the Info screen. The default will be to display documents with inventory type set to available.

Additionally, if you have placed a hierarchy restriction using the Limit Item To drop-downs on the Info screen, only those documents with items matching the criteria will display. This happens once the restriction is set by adding the first item. If no items have been added yet, all documents will be displayed for the appropriate transfer type.

Scanning or entering a document ID on this screen in the scan bar will display the Document Options popup if any are found. The filter can be used to narrow down the list of documents.

Filtering can occur by Document ID, External ID, Customer Order ID, Fulfillment Order ID, Context type, and Context value.

The documents are grouped by documents with remaining quantity and documents with no remaining quantity. The documents are sorted by Not After Date and then Doc ID based on the group they fall into (remaining vs no remaining). If the Not After Date is blank, the document displays on the bottom of each of the groups they belong to.

The following icons will be displayed to indicate the status:

- Green circle with check indicates the document has remaining quantities.
- Orange triangle with exclamation point indicates the document has no remaining quantities.

Options to Add to Container

You can select an approved transfer document and have different options to apply the items. In the Container Items screen or Transfer Shipment Items screen, any items added manually, will be added to the adhoc transfer document. If you do not want to add the items from a transfer, select **Adhoc Document** from this screen to clear out the document selection. Items added manually will be added to the Ad Hoc transfer if adhoc document is selected. Adding loose items to a container is only allowed for Containers setup for Available inventory.

- Apply Item(s): The items are pre-filled in the container/shipment without quantities.
- Apply Item(s) & Quantity: The items with their remaining quantity are added into the container/shipment.
- Use Document: Manually add the items to the container/shipment validating against the selected document. You are prompted when an item does not exist on the document. If not, you may or may not have the ability to add to the container or to the selected document.

Once the document and items are selected, the document ID is populated in the header of the Container Items screen or Transfer Shipment Items screen as well as next to each item added to the container/shipment. There are various permissions that will control which options you can perform.

The **Adhoc Document** button is used to clear the selected document. You need special permissions to use this button. Any items added when Adhoc Document is selected, will be added to an ad hoc transfer created for the entire shipment for any unexpected items not associated with an existing transfer. The button will not be available when the container has been set up to pull items from unavailable inventory buckets since a pre-created transfer document is required.

Info (Container)

The Info screen is used to enter details for the container including transportation details. You navigate to this screen from the footer menu on the Container items screen or from the Transfer Shipment Items screen. Details will include: ID, Transfer Type, Container ID, Package Type, Weight, Tracking ID, and Container Restriction by Hierarchy.

The inventory status and the container restriction by hierarchy will be locked down once the first item has been added to the container.

Limit Items to (Hierarchy Restriction)

If you want to set up the container/shipment(without container) to hold the same type of items, you can restrict by department, class, and subclass. You do not select the actual department, but set the hierarchy level to restrict by. When the first item is added to the container/shipment(without container), the department, class, and/or subclass is set for the container/shipment(without container) based on the hierarchy the item is part of.

Any items added subsequently must match the hierarchy of the first item. For example, if the restriction was set up to limit items to the same department and the first item added was for the Women's Department, only items that match the Women's Department can be added to the container, but it will not matter which class and subclass the item is in since the hierarchy level is set at Department.

The hierarchy level is auto defaulted depending on the permission you have been given.

If manifesting has been configured, the package type and weight may be required by the carrier selected for the shipment before you can confirm the container/dispatching the shipment(without container).

The screen also displays the list of CFAs (flexible attributes) that have been set up for Transfer shipment containers in the desktop application, and lets you enter values for them. The CFAs that are set up as 'Required' must have a value entered before confirming the container. The value can be one of the following: Date, Text, Decimal, Long, depending on the 'data type' set up for the CFAs while creating them in the desktop application. Appropriate security permission is needed, and the container/shipment must be in editable state for entering CFA values.

The user can enter Label Location, which holds the location of manifesting document to print it for later use.

The Info screen also displays read-only information such as ID, Container ID, Shipment ID, Status, Destination Type and Destination, list of transfer documents that have been added, Create Date, Create User, Update, Update User, Approve Date, Approve User.

For transfer shipments without container, the ID, Status, Container ID, Create Date, Create User, Update, Update User, Approve Date, Approve User fields are not displayed.

RTV and RTV Shipment

The return's process in the mobile application supports the retailer with the reverse logistics flow. A reverse logistic flow means that inventory is shipped out of the store to a supplier or warehouse for redistribution or disposal. This particular workflow only supports shipping inventory back to the supplier.

Some examples around reverse logistics:

- Regulatory when product has to be destroyed because of recalls.
- Return of inventory to the vendor of items that are nearing their expiration date.
- Return inventory back to the supplier because of malfunctions or poor quality.

RTV Request and Shipment

Return to Vendor (RTV) can be a request or a shipment.

RTV Request

A Return Request is a return to vendor that comes into the Store Inventory system from an external system. A Return Request is a request for items to be returned. You access the return request from the external system on the mobile application. The items, quantities requested to be returned and reasons (for RTV) will be listed. Enter in the return quantity approved for the items. You can also reject the request if needed. The system can be configured to allow you to add items to the return request. The system allows for items to be removed on a return request that were not initially added during the session. After the session has been saved, the quantity for the item is set to zero, similar to original requested items. Once the request has been accepted, the items are shipped to the supplier.

RTV Shipment

If the store plans to return items to the vendor, it can be done by creating an RTV shipment to the vendor. The items, quantities to be returned and reasons (for RTV) will be added to the shipment and it can be dispatched.

To create an RTV shipment, a supplier must be identified for the return; this can be done by entering in the Supplier ID or using the widget to look up a supplier.


The Supplier must allow for returns. This is an indicator that is defined at the supplier level. The next validation will be to check the system setting **DSD Delivery Supplier for RTV**. This

configuration (if set to Yes) requires that the supplier must also be a **DSD Supplier** (indicator on the supplier) in order to create the RTV. Lastly, if the system is configured to use **Multiple Sets of Books**, then the supplier is limited to the same operating unit as that of the store.

Items along with reasons can be added to the return. For Return to Vendors, the system allows a mix of available and unavailable inventory status items on the return; therefore, all reasons for the Return to Vendor type will be listed. All items on the return must be sourced by the supplier designated on the RTV. Authorization Number, which is required for certain suppliers, would need to be entered before dispatching.

Features:

- RTV Request and RTV shipment support shipping to the supplier.
- User can initiate a return from the mobile application by creating a shipment to the supplier.
- A single RTV shipment supports multiple containers.
- An RTV shipment can be tracked at the Container and Shipment levels.
- Container hierarchy limitations.
- BOL includes container details.
- Support for multiple users working on different containers within the same shipment.
- Each item has one or more reason codes explaining the reason it is shipped back.
- BOL captures shipment purpose, tracking ID, shipment method, destination information, and container information.
- Approval or rejection of externally-generated RTV requests.
- Authorization Return ID.
- Not after date facilitates you to ship the shipment before the shipment is expired.
- Supplier-level RTV restrictions when creating an RTV.
- Printing reports and labels.
- Capturing values for CFAs (Custom flexible Attributes) for RTV Requests, Shipments and Containers.

Business Cases

Two business case examples are shown below:

Damage Item Process

Two customers return DVD players that are not working. The POS transaction identifies them as damaged. This automatically associates the items to an unavailable bucket in the Store Inventory system.

The retailer creates a return to vendor for two DVD players which were damaged. They will be sent back to the vendor with a reason of Damaged using unavailable inventory.


Recall Process

The Store Inventory system receives communication from the vendor requesting 100 units of chicken to be returned back to the supplier.

The store user will create the RTV shipment on the mobile application and enters the quantity to be returned; in this case, the store returns 99 units, packs the goods in a container, confirms the container and dispatches the shipment.


Screen Flow

Figure 8-3 RTV and RTV Shipment Status Flow





The RTV List screen displays a list of externally generated RTV requests and RTV Shipments for the store the user has logged into. The RTV List screen is accessible by clicking RTV from within the Shipping and Receiving menu. The system defaults to all RTV requests and Shipments which are in 'Active' status. The Active statuses for an RTV request are any of the following statuses:

- Request In Progress

- Approved
- Requested

The Active statuses for an RTV Shipment are any of the following statuses:

- New
- In Progress
- Submitted

This screen gives a quick view of the list of requests/shipments along with the details such as request/shipment's status, destination(supplier), Not After Date, status of the Fiscal Doc/E-way bill request (if the system is configured to use Fiscal Doc ID/E-way Bill ID), etc.

A Filter option is also available to further filter on the return and shipment records.

You can get into the details of a request or a shipment by tapping on it. You can also create a new shipment and filter records from the RTV List screen.

RTV Search Criteria

The Search Criteria screen is used to narrow down the list of RTV Requests and Shipments displayed on the RTV List screen. You can access this dialog by tapping on the eye glasses on the RTV list screen. This screen has three sections:

In this scenario, the Request specific criteria would not be visible to you. If you want to search for both shipments and requests together, select 'All' from 'Search for' drop-down and the search criteria applied would be ('Common search criteria' AND 'Shipment specific search criteria') OR ('Common search criteria' AND 'Request specific search criteria').


If the retailer has set up the system to use Fiscal Document/E-way bill for the RTV shipments, there will be additional criteria provided in the screen under Shipment Filters such as Fiscal Request ID, Fiscal Doc ID and Fiscal Request Status.

The result of the search is displayed in the RTV List screen.

There are pre-defined searches available as well: Active Request, Active Shipment, Active Request and Shipment.

RTV Request Items

The Store Inventory system subscribes to RTV Requests from external systems that requests the store to send items back to vendor. You access the Request Items screen by selecting a request from the [RTV List](#) screen. This screen displays the list of items

present in the RTV request and gives a summary of the various quantities of each item such as:

- Requested quantity
- Approved quantity
- In Shipping quantity
- Shipped quantity
- Available quantity of the item at the source store (if the inventory to be returned has to come from Available inventory)
- Unavailable quantity of the item at the source store (if the inventory of the item has to come from Unavailable inventory)
- Items with **Non-Inventory** indicator as **Yes** are also allowed to be in the request

If sub-buckets is turned on, then the Unavailable field displays the stock for the item that is associated with the specific sub-bucket for the shipment reason code selected for the item.

Whether the screen is editable or not depends on your security permission, status of the request, Not after date. You must also have return reason code data permissions for all items on the request. You can also add items (belonging to the same supplier in the request) to be returned depending on the permissions set. Inactive/delete/discontinued status items can be added to the RTV.

The item image for the line items is displayed per configuration.

Line items appear in a list and selecting a line item navigates to the item details of that item. If an item has been changed in the current session, it is indicated by a bar on the left of the item. Scrolling in the list of items displays a filter. The filter can be used to narrow down the list of items. Filtering can occur by Item ID, Description and Reason.

Scanning or entering an item in the scan bar navigates you to the **Item Detail** screen for that item. Approved Quantity may be updated depending on the scan mode. If the user scans a VPN, a validation is done to ensure that the VPN scanned belongs to the supplier associated to the delivery.

Footer Menu

The Footer menu is accessed from the ellipsis footer menu on the Request Items screen. The menu functions include the following:

- **Info:** Accesses the Info popup.
- **Notes:** Accesses the notes dialog to capture notes.
- **Edit RTV:** To enter Auth number, and so on.
- **Default Qty:** Defaults the requested quantity to the Approved quantity field for all the items in the request.
- **Accept:** Accepts and approves the quantities to be returned. The request moves to 'Approved' status and the system will reserve inventory for the items to be returned.
- **Save:** Saves the request in 'Request In Progress' status to be completed later.


Saving a request does not publish any message nor does it reserve any inventory; it simply saves it.

- **Reject:** This option allows you to reject the request and move the request to 'Rejected' status.

- **Edit CFAs:** Lets you enter values for the CFAs that are set up for RTV Requests.
- **Shipment:** This menu option will allow you to ship the items in the approved request or view the shipment and container details if they exist. Security exists to create, view and edit the shipment.
- **Close RTV:** This menu option will allow you to close the RTV request. After closing an 'Approved' RTV, for the items on return, reservation would be removed and will be moved to available or unavailable depending on where it was reserved from. A message is published to the merchandising system on the inventory reversal.
- **Back:** This menu option will allow you to leave the screen. This is available when the screen is in view only mode.
- **Cancel:** Exits the screen; changes made in that session are not saved.
- **Print:** This option allows you to select formats and print various reports and container labels. The RTV report will be available on this screen. This option will always be available regardless of the return status.

RTV Request Item Detail

The **Item Detail** screen is used when selecting or scanning an item from the **Request Items** screen. Scanning or entering an item on this screen in the scan bar updates the approved quantity per the scan mode and refreshes the Item Detail screen for the item and quantity scanned. If the user doesn't have 'Allow Over Accepting' security permission, approved Quantity cannot be greater than the requested Quantity.

If the user scans a VPN, a validation is done to ensure that the VPN scanned belongs to the supplier associated to the delivery.

The approved quantity can be edited and updated manually if permissions allow. Items with **Non-Inventory** indicator as **Yes** are also allowed to be in the transaction and you can enter approved quantity for these items.

Whether the screen is editable or not depends on your security permission, Status of the request, Not After Date. User must also have return reason code data permissions for all items on the request.


You can add items (belonging to the same supplier in the request) to be returned depending on the permissions set for him.

The item information, including the image (which is system configured), displays in the header. The bottom portion of the screen contains information fields for reason code, disposition, sub-bucket (if system configured), and the stock on hand pertaining to the bucket in which the stock is coming from, Requested quantity, In shipping and Shipped quantity. The list of locations where the item is present is also displayed in this screen, if the item is sequenced. Lastly, the Last Scan will display the details of the last scanned barcode at the bottom of the screen.






The Auth Number can be entered while creating the shipment. If not, it can be entered later while dispatching the shipment.

Select a Return Type, that is, the reason for the return. This can be configured to the business needs; some examples could be damaged goods, Invalid delivery, Seasonal.

When done, select Apply to create the RTV shipment for the supplier.

RTV Ship Containers

The RTV Ship Containers screen displays the list of containers for a shipment or displays an empty list of containers if the shipment is new. The screen is accessed by opening a shipment from the RTV List screen or by tapping on the 'Create Shipment' button from the RTV List screen. This is the first screen displayed in a shipment flow.

The details of a container such as Tracking ID, Total SKUs and Status are available in this screen. You can identify a container by entering or scanning Internal Container ID, SSCC ID, Tracking ID or GS1 data bar. If the system finds the container, you will be navigated to the Container Items screen where the list of items inside the container are shown.

The filter present in this screen can be used to narrow down the list of containers. Filtering can occur by Container ID (Internal ID, SSCC ID), Tracking ID and Status.

The ellipsis in the lower right hand corner accesses the Footer menu which contains all of the functions that can be performed on a shipment.

Submit

The shipment can be saved to 'In Progress' status to continue edits later or it may be set to Submitted or Dispatched. Submitting is possible when the store setting Dispatch Validate is configured for 'Ship Submit'.

Submitting sets the shipment to a Submitted status and does not allow for edits; there are no updates to inventory at this point. You can only Cancel Submit or Dispatch.

If the system is enabled to obtain Fiscal Doc ID/E-way bill ID for the shipment, the process to request for the fiscal document, starts once the shipment is submitted.

Dispatch

When the shipment is dispatched, the RTV reserved quantity for the source location will decrease in addition to the stock on hand. If no shipping quantities are identified the transaction should be cancelled.

If the system is enabled to obtain Fiscal Doc ID/E-way bill ID as part of the shipping process, the shipment cannot be dispatched until the Fiscal Doc ID/E-way bill ID is available. The exception is when the user has 'Allow dispatch without Fiscal Document ID' security permission.


Footer Menu

The menu functions include the following:

- **Info:** Accesses the Info popup.
- **Notes:** Accesses the notes dialog to capture notes.
- **Create:** Creates a new container in the shipment.
- **Edit Shipment:** Accesses the Edit Shipment screen where details can be added/updated.
- **Submit:** Submit performs validation for 'In Progress' shipments and locks the shipment for additional edits. The shipment will be ready for dispatch. This menu option is only available when the store parameter 'RTV Shipment Dispatch Validate' is set equal to Ship Submit.
- **Cancel Submit:** Reverses the Submit and moves the shipment back to 'In Progress'.
- **Dispatch:** Performs validation and dispatches the shipment. No further changes are allowed. The shipment is now ready to be physically shipped out of the store.
- **Edit CFAs:** Lets you enter values for the CFAs that are set up for RTV Shipments.
- **Close Shipment:** Allows you to close the rtv shipment. If there are items within these containers, reservation would be removed and will be moved to available or unavailable depending on where it was reserved from. A message is published to the merchandising system on the inventory reversal.
- **Delete:** Marks the shipment to 'Canceled' status.
- **Back:** Exits the shipment.
- **External Printing:** Displays the External Printing popup to select a printer for the pre-shipment notice and manifest documents.
- **Print:** This option allows you to select formats and print various reports and container labels. The RTV Shipment report and the BOL Detail report will be available on this screen. This option will always be available regardless of the shipment or container status.

The Shipment Info screen is accessed by clicking the Info menu option in the RTV Ship Container screen footer menu. This screen is a view only screen and lists details about the return shipment such as:

- Supplier

- Auth Number



The Carrier information is locked down once the container has been confirmed. At that time, the Adjust Carrier button will be available to move the containers back to 'In Progress' to make changes to the carrier and other shipment details.

The screen also enables the user to specify details such as vehicle number and country, driver name and License number, if the retailer has been using Fiscal Document ID/E-way bill ID in the shipment process.

RTV Ship Container Items

The **RTV Shipment Container Items** screen can be reached once you tap on a container from **RTV Ship Container** screen. Many functions can be performed through this screen:

- Add items to a container with reason codes for each item. If the user scans a VPN, a validation is done to ensure that the VPN scanned belongs to the supplier associated to the delivery.
- The user will navigate to the Item Detail screen for the item scanned. If the item scanned is a UIN item, the user will navigate to the UIN tab within the Item Detail screen.
- Items and quantities can be defaulted from an approved RTV document.
- Items with **Non-Inventory Indicator** as **Yes** are also allowed to be in the transaction and you can enter ship quantity for these items.
- Item can be added to the container manually which are not on the original RTV document. UOM is selected at the Mode bar of the screen and hence applies to all the items on the container. Toggling the UOM at the Mode bar will change the UOM and convert the quantity at the line item level.
- You may choose to add notes to the container.
- You can save, confirm, and delete a container from this screen.
- Hierarchy limitation for the container can be defined from this screen.
- UIN icon is displayed if the item is a UIN required item with Serial number or AGSN type.

Footer Menu

The menu functions include the following:


- **Info:** Accesses the Info popup.
- **Notes:** Accesses the notes dialog to capture notes.
- **Edit Container:** Allows you to enter Container ID, weight, package size, tracking id, and so on. See [Edit Container](#) story for additional details.
- **Edit CFAs:** Lets you enter values for the CFAs that are set up for RTV Shipment Containers.
- **Default Item:** Allows you to pull approved items from approved RTV documents to the shipment. This option is only available for shipments created for a return request.
- **Adjust:** Allows you to move the container back to an editable state after it has been confirmed. User needs the necessary permission to adjust a container.
- **Confirm:** Allows you to complete the container with no further edits. Appropriate security permission is necessary to confirm a container. The status of the container moves to 'Completed' status.
- **Save:** This menu option will be available on the menu when the screen is in edit mode.
- **Cancel:** Exits the screen without saving the changes made, if any. This option will be available when the screen is in edit mode.
- **Back:** This allows you to exit the screen. This menu option will be available on the menu when the screen is view only.
- **Delete:** This option will allow you to cancel the container. Reserved inventory is relieved appropriately and any RTV documents associated will set back the remaining quantities. Appropriate security permission is necessary to delete a container.

If the container contains UIN items, the UIN state should be set back to their previous state.

- **Print:** This option allows you to select formats and print various reports and container labels. The RTV Shipment Container report will be available on this screen. This option will always be available regardless of the shipment or container status.

Item Detail (Container)

The **Item Detail** screen is used when selecting or scanning an item from the **Container Items** screen. Scanning or entering an item on this screen in the scan bar updates the quantity per the scan mode and refreshes the item detail screen for the item and quantity scanned. The quantity can be edited and updated manually if permissions allow. If the user scans a VPN, a validation is done to ensure that the VPN scanned belongs to the supplier associated to the delivery. The user will navigate to the Item Detail screen for the item scanned. If the item scanned is a UIN item, the user will navigate to the UIN tab of the Item Detail screen.

Items with **Non-Inventory** indicator as **Yes** are also allowed to be in the transaction and you can enter ship quantity for these items.

The item information includes the image that is system configured to display in the header. The bottom portion of the screen contains information fields showing:



This screen allows you to pull approved items from approved RTV requests to the shipment. This screen is accessed from the RTV Ship Container Items screen of an approved request and this is only available for shipments created for a request.


The screen defaults items into the RTV Ship Container Items screen through the 'Apply Item' and 'Apply Item and Quantity' options. Apply item will default selected items to the container, while Apply Quantity will default the selected items and the corresponding remaining quantities.

Items that fall under the frozen container hierarchy will only be applied to the container. Also, only the items that has reason codes for which you have data permissions would be applied. The container hierarchy is frozen using the 'Limit Items To' feature in the Edit Container screen.

The remaining quantity column informs you about the quantity on the document that is not shipped yet, and can be used. The remaining quantity is not reduced until a container is confirmed for shipping.



The Edit Container screen is used to enter details for the container including transportation details. Access to this screen is from the Footer menu on the Container Items screen. Details include: ID, Container ID, Package Type, Weight, Tracking ID, and container restriction by

Limit Items to (Hierarchy Restriction)


If you want to set up the container to restrict the container to hold the same type of items, they can set up the container to restrict by department, class, and subclass. You do not select the actual department, but rather set the hierarchy level you want to restrict by. When the first item is added to the container, the department, class, and/or subclass is set for the container based on the hierarchy the item is part of. The container detail screen will display the hierarchy that is locked in. Any items added subsequently must match the hierarchy of the first item. For example, if the restriction was set up to limit items to the same department and the first item added was for the Women's Department, only items that match the Women's Department can be added to the container, but it will not matter which class and subclass the item is in since the hierarchy level is set at Department.

The hierarchy level is auto defaulted depending on the permission you have been given.

If manifesting has been configured, the package type and weight may be required by the carrier selected for the shipment before you can confirm the container.

Select Item

An Item may exist more than once in the request/shipment when the same item has been added with different reason codes.

For example, Item A is added to the request/shipment with reason codes 'Overstock' and as well as 'Externally Initiated'.

The Select Item popup is used when you scan/enter an item that exists on the transaction more than once. The list will display all instances of the scanned item along with all the different reason codes for which the item has been added. You will be able to select any item-reason code combination for the item scanned. If you wish to select a new reason code which is not used already, he can do so too.

Processing

When a return document is saved or updated from the RTV shipment, the system moves the items from either Available or Unavailable (non-sellable) inventory, based on the inventory status, and moves it to the Reserved bucket within unavailable inventory. The Return to Vendors uses the RTV Reserved bucket. Upon dispatching of the return, the Reserved buckets will be relieved and the stock on hand will be decremented. If sub-buckets are turned on, the appropriate sub-bucket associated with the return reason will be updated when returning from unavailable inventory.

Example 1: Return to Vendor using Available Inventory

Shipping and Receiving Common Components

Overview

The shipping and receiving functions in the mobile application have several common components. The following functional areas are included: Customer Order Deliveries, Return to Vendor Shipments, and Transfer Shipping/Receiving for store, warehouse, and external finisher. They include tasks usually performed by shipping or receiving associates. This also includes integrating to a third-party manifesting system for rate shopping to find the least expensive delivery method.

The feature of shipping and receiving available in mobile is:

- Manifest web services for rate shopping

Manifesting


Manifesting systems help retailers create manifest documents, Bill of Lading (BOL), shipping container labels for shipments, and reduce cost through rate shopping by finding the least expensive delivery method for the given shipping criteria.

For larger shipments, multiple containers may exist and each container requires a separate tracking ID. For RTV Shipment and Transfer Shipment, the manifesting service will be called when confirming each container. The carrier and service are required to be the same for all containers within the same shipment. The container and shipment are all inclusive for Customer Order Deliveries.

Business Case

A user creates a shipment (store, warehouse, finisher, customer order delivery, or return to vendor) and enters in the package type of "Small" and Weight of 2.3 lbs. The Manifesting system will do the rate shopping for the carrier and service and automatically print out a label for the package.

Figure 9-1 Integration - Flow-Ship Container



The above flow shows the confirmation of a container and how a call is made to the manifest system. The flow is highlighted in different colors to help identify different integration points.

When you confirm each container for an RTV or Transfer shipment, the system can invoke the web service to provide the required shipment details to the manifesting system and subsequently return a tracking ID for each container.

After all containers have received their tracking ID, you can ship the shipment, or an external system indicates to the Store Inventory system that the shipment is dispatched.

 **Note:**


Customer Order Deliveries only use the web service at submit or dispatch since the shipment will always be a single container.

If the Store Inventory system is configured to publish a pre-shipment, it sends the pre-shipment notice to the pre-shipment system.

If the carrier must be changed for the shipment with transfer shipment or RTV shipment, you adjust the carrier, which will cause all containers to move back to 'In

Progress'. Once the shipment has been dispatched, you will no longer be able to adjust the carrier.

Mobile

Features:

- Enter Carrier BOL Information

You have the ability to enter the carrier details for Transfer Shipments, RTV Shipments and Customer Order Deliveries. You can access the **Edit Shipment** screen by navigating to the Shipment and selecting **Edit Shipment** from the Footer menu.

For Transfer Shipments, if the shipment is for sending items to a warehouse or finisher, you have the option to enter an Authorization Number. This is not applicable to Transfer to Store or Customer Order Deliveries. Security permissions exist to enter an Authorization Number.

In order to prepare the shipment for manifesting, you are required to enter the carrier information on this screen. When the carrier Type is Third Party and the Carrier Service is a (P) parcel service, the manifesting service is called when you confirm the container. Security permissions exist for you to edit the Carrier BOL information.

Motive

The motive for the shipment is based on the functional area and sequence number. The code with the sequence of 1 will be displayed by default. You can create and manage Motives through the desktop application.

Carrier and Service Selection

The carrier type is defaulted based on the store parameter 'Carrier Default' set up for each type of transaction (store, finisher, warehouse, and RTV).

Delivery Type	Default Carrier
Customer Order Delivery	Third Party if the customer has identified a carrier to use on the customer order. If no carrier is identified on the customer order the Sender.

If the carrier type is Third Party, the Carrier is available for selection. This field may be overwritten by the manifesting system when used. You may select **Other** from the list of carriers. If **Other** carrier is selected, the Carrier Name and Address will be enabled.

When a carrier is selected, a list of services available for the carrier will be selectable. This field may be overwritten by the manifesting system when used in addition to the Carrier. The manifesting service call made can include checking for the best rate and will override what was selected by you.

Shipment Carriers, Shipment Carrier Services, Shipment Weight UOM, and Shipment Package Sizes are setup and maintained in the desktop application.

Each Carrier will have one of three manifest types: (P) Parcel, (H) Home Fleet, and (O) Other. Only carriers with a manifest type of (P) Parcel will be used with the manifesting integration service. Depending on the carrier service, weight and package size may be required. The system will alert you when the information is missing.

Adjust Carrier (Transfer Shipment and RTV Shipment Only)

The BOL Details for a shipment gets frozen once the first container is confirmed and cannot be changed without moving all the containers for the shipment back to an 'In Progress' state. This is done by using the **Adjust Carrier** feature. The BOL Details can be adjusted until the shipment is dispatched if you have the appropriate permissions. Once you select **Adjust Carrier**, a new carrier may be selected and each container will need to be reconfirmed to manifest again.

The Edit Container screen is only applicable to Transfer Shipments and RTV Shipments, since Customer Order Deliveries shipment and container is all inclusive. You will enter the package type, weight, and other container details from this screen. Security permissions exist for you to edit this screen. If manifesting is used, the manifesting service will return the tracking ID. The Edit Container screen is accessed from the Footer menu of Transfer/RTV Ship Container screen, RTV Ship Container Screen, and Transfer Receiving Container screens. Since the Edit Shipment screen defines the entire shipment, the Edit Container screen is used to identify the package type, weight, and tracking ID for each individual container. The customer order feature does not use this screen. For customer order deliveries, the package type weight and tracking ID are entered directly on the Edit Shipment screen. The Transfer Receiving feature also uses this screen to enter Reference Container ID, Damage Reason. The tracking ID may also be captured on this screen. The validations listed below apply to Transfer Shipments, RTV Shipments, and Customer Order Deliveries. The validations for Transfer Shipments and RTV Shipments are performed at the time of confirming the container, while Customer Order Deliveries performs the validations upon submit or dispatch of the shipment.

Weight and Package Validation

The weight field is used to enter in the weight of the package. The weight will be entered in the unit of measure based on the store admin Manifest weight UOM.

The package type is used to define the dimensions of package such as Large Envelope, Small Box, Medium Box, and so on. The package type will be selected from a defined list of packaged types in the Carton Dimension table.

Depending on the carrier/service selected for the shipment, the package type and weight may be required (this is only validated when the manifesting system is called). The Shipment Carrier Service table identifies when the weight and package type is required. This table is populated from a data script.


Note that when creating a transfer shipment container or RTV shipment container on the mobile, the carrier is defaulted based upon a store setting, Carrier Default. When the setting is Third Party, the carrier is Other and the service is blank. Therefore, you are not prompted for the weight and/or package type unless the carrier /service had been set as something different.

Tracking ID

The Tracking ID will contain a single ID for tracking the package; it can be entered by you, come from the manifesting system or come from the shipping ASN. It may get overwritten/ updated by an external manifesting system. The tracking ID entered within the Transfer Receiving dialog can be leveraged to find a container.

External Printing


Figure 9-5 External Printing Screen



This screen can be accessed within the Shipments by selecting **External Printing** from the Footer menu of Transfer/RTV Ship Containers screen. The external printer can be defined for the pre-shipment and manifest documents. These settings will remain until you log out of the application. This setting is applicable across all functional areas within the mobile application that use the Pre-Shipment and Manifest documents. If the printer is selected for Transfer Shipment, the same printers will be set for Customer Order Deliveries dialog and RTV Shipment and vice versa.

Print

The Print dialog is accessed when selecting print within the mobile application. It is available when selecting print from the footer menu within a transaction.

The transaction format type or types that are applicable to the functional area will be available for selection. For example in Customer Order Deliveries, there may be format types of Customer Order Delivery and BOL. If there is only one applicable format type for the functional area it will be defaulted.

Once a format type is selected, the system will list all of the reports that are available to print for that format type. The report will default based upon the default format type. You can choose to select a different report format to print if other report formats exist for this format type transaction. Once print has been selected for the report, the PDF is retrieved based upon the report format.

EWay Bill (Fiscal Document)

E-Way Bill(Electronic Way bill) is a document that is required for transporting goods in certain countries. It is be generated through the government portal for the shipment. The E-way bill is required to ship all the goods except those exempted under the notifications or rules pertaining to the country. The retailers can configure SIOCS using store configurations to incorporate obtaining the E-way bill document in the shipment process if E-way bill is mandatory in the country where they are operating. SIOCS uses a generic term called 'Fiscal Document' to refer to 'E-Way bill' document and 'Fiscal Doc ID' to refer to 'E-way bill ID'. The areas where E-Way bill ID is used are Transfer Shipment, RTV Shipment and Customer Order Deliveries.

The basic workflow is as follows:

- When the shipment is submitted in SIOCS, the Fiscal Document Generator(FDG) system picks up the shipment submitted and sends the shipment details along with tax-related information to a 3rd party system, which in turn sends the details to the government system.
- The government system validates the details submitted and sends the Fiscal Document ID back if the shipment has been approved. Once this ID reaches SIOCS, the shipment is ready to be dispatched.

Fiscal Document for Shipments Workflows

The following is the detailed process for obtaining Fiscal Documents for shipments (Transfer, RTV and Customer Order Deliveries) :

Capturing Vehicle/Driver Details

- The vehicle number, vehicle country of the vehicle used for the shipment, driver name and driver license number should be captured before submitting, if configured. The retailers have the flexibility to configure which one of these details need to be captured, depending on the rules and regulations applicable in the country where the store is operating in. These configurations are done at store level.
- These details are captured in the Edit Shipment screen of the respective transactions.

On Submit of the shipment

The process of requesting a Fiscal Doc ID for the shipment starts when the user submits the shipment. Once the submit is done:

- The Fiscal Doc ID request gets a unique 'Request ID'.
- Once the request is made, there should be NO change in the shipment details (items, quantities, etc.).
- The status of the shipment will be 'Submitted', the status of the Fiscal Doc request will be 'Waiting for Fiscal Doc ID'.
- The request ID and status of the request can be viewed from the Info screens of the respective transactions.
- SIOCS should not be able to move shipments from submit to dispatch unless the Fiscal Doc ID has been received.
- However, if the user has 'Allow dispatch without Fiscal Doc ID' security permission, the shipment can be shipped without the Fiscal Doc ID

Once the Fiscal Doc ID is Received

- Once the 'Fiscal Doc ID' is available for the shipment, The status of the request is updated to 'Fiscal Doc Approved' and the shipment can be dispatched.
- The Fiscal Doc ID will be associated with the shipment only if the shipment is in 'Submitted' status or in 'Dispatched' status(if the user had override permission to dispatch before the Fiscal Doc ID arrived).
- A notification will be created informing the user that the shipment is now ready for dispatch, if the shipment has not been dispatched already.
- **Fiscal Doc Link** — When the Fiscal Doc ID is communicated to SIOCS, there is a possibility that an external link(URL) will also be sent. This URL enables the retailer to print the Fiscal Document, whenever needed. Any user with 'Access Fiscal Doc URL' security permission can access this URL.

Canceling the Request

If the User does a 'Cancel Submit' of the shipment, the Fiscal Doc ID will become invalid if there is already one. In case the Fiscal Doc ID is received post 'Cancel Submit', it will be rejected/ignored. The Shipment has to go through the 'Submit' process again, obtain the new Fiscal Doc ID in order to be dispatched.

Transfer and Vendor Deliveries — The warehouse and supplier will also need to obtain Fiscal Doc ID before they dispatch the shipment. SIOCS is able to leverage the Fiscal Doc ID from the deliveries sent from a warehouse and also for the deliveries from vendors.

Scan Bar — SIOCS will allow a user to scan the Fiscal Doc ID and retrieve the transaction with it, similar to ASN, Container etc., in the Transaction List screens of Transfer Shipment, RTV Shipment, Customer Order Deliveries, and Transfer Receiving and DSD Receiving.

Configurations

The Store Inventory system provides retailers with great flexibility to handle Fiscal Doc mandate based on the rules and regulations prevailing at the location of the store. The configurations are set at store level and further at the Transaction type level.

Configurations to Enable Obtaining Fiscal Doc

Restrict Shipment Dispatch After Submit

A shipment cannot be dispatched without a Fiscal Doc ID. The system automatically requests for Fiscal Doc ID on Submit when this store parameter is set to 'Yes'. Once the Fiscal Doc ID is available, the user is notified and the shipment can be dispatched. This parameter is available separately for each transaction type (Transfer shipment, RTV Shipment, Customer Order Delivery). This allows the user to set the Fiscal Document mandate only for the transaction for which it is necessary.

Capture Vehicle Details on Submit

The details related to the vehicle and the driver used for the transportation of the items must be sent to the government in order to obtain the Fiscal Doc ID. In SIOCS, this can be achieved by setting the store parameter 'Capture Vehicle Details on Submit.' This configuration can be set at Transaction Type level (Transfer Shipment, RTV Shipment, Customer Order Delivery) and the values for these fields can be captured through the respective 'Edit transaction' screens. The value captured for these fields are not persisted in SIOCS DB due to PII regulations.

The retailers are offered the flexibility to make all or some of these details mandatory to be captured based on the rules and regulations of the store location. The store parameters that enable the retailer to configure this for Transfer Shipment are as follows:

- Vehicle Number Required for Transfer Shipment
- Vehicle Country Required for Transfer Shipment
- Driver Name Required for Transfer Shipment
- Driver License Number Required for Transfer Shipment

Similar list of configurations are also available for RTV Shipment and Customer Order Delivery. This means that the configurations mentioned above can be set at different Transaction Type levels, which offers more flexibility.

View Fiscal Doc Information

The user can view the Fiscal Doc Request ID, Request Status, Reject Reason (if rejected), Fiscal Doc ID and Fiscal Doc Link in the Info screen of the respective transactions.

Search Criteria Screen

Fiscal Doc related fields are also included as part of Search Criteria screens of Transfer Shipment, RTV Shipment, Customer Order Deliveries, Transfer Receiving and DSD Receiving.

To better understand how the Fiscal Doc related fields are accommodated in the screens, please refer to the respective shipping areas in this User Guide.

In Store Replenishment



Overview

The replenishment process attempts to ensure that the shop floor inventory is set at a level best suited for enticing customers to buy a product and to prevent empty shelves. Shelf replenishment functionality within the mobile application is related to the movement of goods from the back room to the shop floor and shop floor to back room. For example, when a certain soda quantity is low, you can initiate a replenishment process so that more of the soda is moved from the back room. Similarly, if there is excess stock on the shop floor, the mobile application supports processes to move inventory to the back room. Some of the processes require capacity setup and some form of plan-o-gram sequenced data, while others do not.

Shelf replenishment-related processing within the mobile application includes the following features:

- The following lists the different replenishment methods:

- Capacity algorithm based on stock level percentages
 - Sales based
 - Gap empty shelf scanning
 - Display stock replenishment
 - Receiving on the shop floor
 - Automatic
 - Print Reports
 - Manage Delivery Bay
- The system can calculate the optimal quantity of inventory on what should be held on the shop floor to prevent empty shelves
 - On demand generation of pick lists with real-time data
 - Store employees are driven to replenish the most urgently needed items first
 - Optional item location guidance when picking items by back room micro sequence
 - Formal or informal picking dialog
 - Ad hoc update shop floor and back room process to balance and correct inventory positions
 - Optional substitution when lacking inventory
 - Within day partial or end of day full replenishment pick lists for user efficiency

Capacity replenishment uses shop floor capacity and back room inventory positions to calculate a pick list optimized to keep shelves on the shop floor well stocked. You must indicate how many cases you want to replenish and which items by selecting the product group. This method is focused on those retailers and items which have a well-defined plan-o-gram.

The capacity-based replenishment method is best used by retailers who have a structured shop floor where it is easy to define capacity, items are fairly static, and multiple units are on the shop floor. This is especially useful for grocery retailers and mass merchandise retailers. The structured shop floor is important to this method since there is an inherent cost involved with the need to understand how much capacity exists on the shop floor. A dynamic environment with continuously changing assortments or single item counts often is too costly to maintain the plan-o-gram shop floor capacity.

Capacity based requires you to define product group components using the product group dialog which will be used to generate the pick list.

Gap scanning is focused on those retail environments who want to have a very simple easy to use shop floor replenishment system. You can scan items on the shop floor which become a back room pick list for someone to pick items on and bring to the shop floor.

Sales-based shelf replenishment is based on a process that records all sales coming into the store. The sold item is added to the pick list based on merchandize hierarchy. Like the ad hoc scanning process, this does not require plan-o-gram information. Sales-based shelf replenishment is especially well suited for fashion retailers who have constantly changing assortments and have many low, or even single instance items like special shoe sizes or undergarments.

Display Stock is a replenishment method specifically geared towards single unit items that are used to sell to customers and are related to each other by style. The process allows a user to scan the items they have on the shop floor. The system will generate a pick list for those styles and differentiator combination not represented on the shop floor.

The Display List type shelf replenishment helps you to scan a list of items available on the shelf and create a list and compare it with the product group and identify the gap and replenish. The product group dialog allows you to select the diff through which the replenishment would be done. The Display list method requires you to define outside of the product group components to also define the differentiator. The combination of differentiator and product group used with a scanned list will provide you with a list of items that were not scanned.

Business Case example: A handbag retailer displays all the colors within a style for purses. Susan finds the perfect burgundy colored purse, picks it up from the shop floor, and goes to a sales counter. The sales associates on the sales floor do not notice that particular color/model is not displayed anymore. Jane looked at a magazine and really wanted to have the featured red colored purse, but when shopping for that specific purse she does not see it on the shop floor and assumes it has sold out or was never carried. She decides to walk out of the store without a purchase and look at a different purse vendor who may have the red colored purse.

This scenario could easily have been resolved by the sales associate scanning periodically the items that are displayed on the shop floor and generating a list of missing items in inventory using the display replenishment methods.

Shop floor receiving will allow the receiving associate to indicate if they are receiving in the back room or directly on the shop floor. This method is most often used with those retailers that have daily deliveries and move delivered quantities directly to the shop floor since most of the delivered quantities are just in time deliveries as is the case in the grocery environment.

The automatic option will refresh the store shop floor quantities based on capacity and available inventory for a specific merchandise selection. This feature can be used by those retailers who have a process where the store is brought back into a refreshed state at the end of the day and do not want to run manual or calculated pick lists. Another possible scenario could be when a large refresh is required due to significant plan-o-gram changes or when initially configuring a store.

Business Cases

Three business case examples are shown below:

Replenishment of Shop Floor

This operation will help a retailer to move goods from the back room to the shop floor. This is done to achieve a better fill rate at the store; the more shelf space is utilized, the better sales. This is possible even if a retailer is not using sequencing.

Moving Items to the Backroom

Moving of Items from Shop floor to the Backroom is possible. It helps a retailer to move extra goods from the shop floor, which could be an outcome of receiving the delivery at the shop floor itself or incorrect movement of goods. For example, if a retailer receives a delivery at the shop floor but there is not enough space to keep the full delivery, then the retailer can use this


functionality to move the goods to the backroom which are not required for that moment on shop floor. Secondly, if due to manual intervention there has been a movement of goods from the backroom to the shop floor and the shop floor cannot accommodate that much quantity, the retailer can push back the excess quantity to the backroom.

Moving Items from Delivery Bay

Moving of items that just got received and lying at store delivery bay area can be moved to shop floor or back room. This helps the retailer to quickly replenish the needed SKUs and sell. Also, this helps the retailer to clear the inventory quickly from delivery bay and not wait for the standard process.



The Replenishment Pick List screen can be accessed from the In Store Replenishment menu. When you access this screen, the system will by default list the New and In Progress pick list.

The Replenishment Pick List screen allows you to create a new pick list by selecting the **Create** button. All types of replenishment lists are displayed with the total quantity to pick. When you select a replenishment list the system takes you to the [Replenishment Pick Items](#) screen. If you create a new replenishment list, you go to the [Create Replenishment Pick](#) screen.

You can filter the list by selecting the pair of glass and providing the filter criteria.

The following fields are shown in the list for you to identify the pick list:

- ID -The unique replenishment id created by the system.
- Total number of quantity in the pick list.
- Status of the pick.
- Pick Type
 - Four types of in store replenishment methods can be defined here: Capacity, Sales, Display and Gap.
- Updated User, Create Date and the Description of the pick.

Figure 10-4 Replenishment List Search Criteria Screen



The Replenishment List Search Criteria screen can be accessed from selecting the eye glasses from the [Replenishment Pick List](#) screen. This helps to limit the search on Replenishment Pick List screen through date, hierarchy, and various additional filters which includes search fields Pick List Id, Pick type, Product Group, Mode, Scan List, Item and so on.

The Create Replenishment Pick screen is used to create a new shelf replenishment pick list based on various criteria specified by you. This screen is accessed by selecting the **Create** button from the [Replenishment Pick List](#) screen. You can create four different types of shelf replenishment lists: Capacity, Sales, Display, and Gap based replenishment lists. Based on the replenishment list type selected, some fields will display while others will not.

Replenishment List Types

Capacity (Algorithm Based on Stock Level Percentages)

Capacity-based replenishment is dependent on the capacity defined for an item in sequencing at the shop floor. A user can choose to replenish within the day or end of the day.

The difference between the capacity quantity and the actual stock on the shop floor becomes the suggested quantity to replenish. If you choose to replenish the stock within the day, you also have an option to enter a quantity to replenish considering the manpower availability. If you choose to replenish at the end of the day, it is assumed that you will have sufficient manpower and be able to replenish the full deficit.

Capacity-based replenishment uses the difference of the shop floor capacity and the shop floor quantity to calculate the gross need of how many units need to move to the shop floor. This need is constrained by several factors, how many units are present in the back room and how many units do you actually have time to pick and move to the shop floor.

Capacity-based replenishment uses a specific algorithm to define the optimal method to replenish the shop floor quantity:

- The total capacity equals the sum of capacity for all shop floor locations.
- The Out of stock % equals the total capacity minus the shop floor quantity divided by the total capacity times 100.

Calculation:

- The Gross Need Units equals the total capacity minus the shop floor quantity.
- The item list is sorted in the order of percentage Out of stock.
- The Net Need calculation uses the total capacity, total max fill percentage, and the mode.
- The total available replenish quantity equals the back room plus the delivery bay stock. This step is only used when checking available stock on hand.
- The fill quantity equals the Net Need or the total available, whichever is smaller.
- The Within day fill will create a list until units replenished meet the within day fill quantity.
- The End of day fill will create a list with all items needing replenishment.

Sales Based

Sales-based replenishment uses a concept in which the shop floor is intact and accurate every morning. As units are sold, new units will take their place. Often if a unit is sold out, because of limited availability, a substitution will be used to replenish. When the substitute is sold, the substitute will be replenished. The advantage of this type of method is sequencing is not required since everything replenished is based on sold units.

A user can choose to replenish within the day or at the end of the day. If you choose to replenish within the day, they have an option to enter the quantity they have time to replenish. This replenishment quantity is restricted by the quantity entered by you and is pro-rated. If you choose to replenish at the end of the day, it assumes sufficient manpower will be able to replenish the suggested quantity.

This method is mostly used by fashion retailers who have no defined capacity and many items that are single size/color/style items. It often is used in conjunction with substitution to allow them to keep the shop floor looking filled by substituting the sold unit with one that is in the back room.

 **Note:**

This method will often be used with the option to ignore available inventory. This allows "out of stock" items on the replenishment list to be substituted.

Gap Scanning (Empty Shelf Scanning)

The Gap scanning method replenishment is the easiest method of all the various types of shelf replenishment. With this method, you scan the goods that need replenishment, and a replenishment list is created from the units scanned.

The system uses this replenishment list to move the goods from the back room to the shop floor based on back room availability. The reason to have a separate process between scanning and generating is that one user can create a list and another user can execute the shelf replenishment allowing for distribution of workload.

Since this process does not have a dependency with either sales or capacity, it gives an advantage to the retailer to move goods without any complex setup.

Display (Sales Floor/ Shop Floor)

The shelf replenishment method of Display stock replenishment is fully based on the idea that if a customer does not see the item on the shop floor, they do not know the item exists.

This method provides a way to reduce the inefficiency of receiving new styles in the back room, and not having full knowledge of what is displayed and what should be moved from the back room to the shop floor.

The generic process is you will scan all display stock items, and then compare them against a product group with all the styles available for that department. You will then identify what is the differentiator needed to be displayed on the floor. Often this is color.

Because this type of method is often used in a fashion setting, it does not require sequencing or capacity at all. Capacity need is always one item per primary differentiator.

A product group is required to set up with all the items on a shelf. The following table is an example which shows six items with various colors and sizes. For the comparison between shop floor display and back room, all of the items need to be set up in the product group.

Next, a shelf adjustment list needs to be created by scanning the items on display. For this example, you only have item 124 on the display shelf.

Item ID	Diff 1	Diff2
123	Black	S
124	Black	M
125	Black	L
234	Red	S
235	Red	M
236	Red	L

While creating the product group, you selected to sort by the color. Since the scanned item is black, the sorting is by color. The system will try to find a different color available in the back


room. After the comparison between the two lists, the system tells you item 236 needs to be replenished.

**Note:**

The suggested red item to be replenished will depend on available back room inventory and the sort of the second differentiator. If Diff 2 had been defined differently, such as L = 10, M = 08, and S = 06, then item 234 would have been recommended instead for replenishment.

Replenishment Pick Items

Figure 10-6 Pick Items




This screen is accessed by selecting a replenishment list from the [Replenishment Pick List](#) screen or when creating a new pick. You need proper permissions to reach this screen. Selecting an item from the pick items will take you to the Item Detail screen.

Clicking on the Search Criteria (eye glasses) takes you to the Search Popup which displays list of pre-defined searches.

You can access the footer menu by selecting the ellipsis button and perform various functions like viewing the Information of the pick, Default the pick quantity with the actual quantity, confirm the pick, edit CFAs, save, cancel, print, and go back and delete the pick.

The Search Criteria popup is accessed by selecting 'Search Criteria (eye glasses)' from the Replenishment Pick Items screen.

This popup provides the user with the list of pre-defined searches that enables the user to quickly find the list of items based on their picked quantity.

The list of pre-defined searches available are:


1. **Items to Pick** - Selecting this option, will list the partially picked or non-picked items (Actual pick qty = zero OR Actual pick qty < Suggested Pick Qty OR Actual pick qty = NULL) in the Replen Pick Items screen.
2. **Fully Picked Items** - Selecting this option, will list the fully picked items (Actual pick qty = Suggested Pick Qty) in the Replen Pick Items screen.
3. **All** - Selecting this option will display all items irrespective of whether they were picked or not.

These searches will also include Substitute Items. The substitute Items will always be grouped together with the original item.

If the search did not return any records, an empty list will be displayed in the Replen Pick List screen.



The Edit CFAs screen displays the list of CFAs (flexible attributes) that have been set up for Replenishment Pick List in the system. This screen allows you to capture values for them. The fields displayed here are based on what is setup for the Replenishment Pick List. The CFAs that are set up as 'Required' must have a value entered for it before confirming the pick. The value can be one of the following: Date, Text, Decimal, Long depending on the 'data type' set up for the CFAs, while creating them in the mobile application. 
The substituted field displays whether an item has substitute item(s) associated with it and if selected it also allows you to navigate to the substitute items screen to add substitute items.

At the bottom of the screen the details of the last scanned barcode will be displayed.

You can access the footer menu by selecting the ellipsis button to reset the item or go to substitute items screen.

The Substitute Items screen is used to find a substitute item when the requested item has no inventory. The Substitute Items screen can be accessed from the [Replenishment Pick Item Detail](#) screen by tapping the Substituted field. Using item substitution helps maintain a better fill rate within different areas of the store. The substitutions can be recommended by corporate, or they can be ad hoc picked depending on system settings. Depending on security permissions, you can be restricted to just the corporate items or be free to select anything you want.

Receive on Shop Floor

The system allows you to indicate whether the inventory is received on the shop floor directly. The edit container screens in DSD Receiving and Transfer Receiving dialogs support to receive inventory on the shop floor. You can mark the check box Receive on shop floor. You can refer the screens in the respective sections for more details.











The Edit CFAs screen displays the list of CFAs (flexible attributes) that have been set up for Shelf Adjustment in the system. This screen allows you to capture values for them. User may also scan the same item or a different item from this screen. The information will be retained for the shelf adjustment you are currently working in, until you leave the shelf adjustment. Select **Save** from the Shelf Adjustment Items screen to permanently save the item information. There is no Save on the Item Detail screen.

Editable fields are displayed at the top with chevrons and non-editable fields are grouped at the bottom of the pane.

Scanning or entering an item on this screen will refresh this screen for the item scanned/entered. At the bottom of the screen the details of the last scanned barcode will be displayed.

The screen will be in edit mode when all the following conditions are met.











The Edit CFAs screen displays the list of CFAs (flexible attributes) that have been set up for Scan List in the system. This screen allows you to capture values for them. The fields displayed here are based on what is setup for the Scan List. The CFAs that are set up as 'Required' must have a value entered for it before confirming the scan list. The value can be one of the following: Date, Text, Decimal, Long depending on the 'data type' set up for the CFAs, while creating them in the mobile application. Appropriate security permission is needed, and the scan list record must be in editable state for entering CFA values.


Overview

A delivery bay in the store is an area where inventory is received at the time the truck arrives in the store. In a normal fast based process, this inventory will be moved to the shopfloor or put away in the backroom and be immediately available for use. However, in some cases, the delivery load is so large, or no people are available, to manage this as part of the on-going process. For such retailers, the delivery bay allows the receiving of inventory in the backroom instead of the shopfloor or backroom.

This dialogue allows a user during the day start moving inventory from the delivery bay area to the shopfloor or backroom and not have to wait until a batch process runs to move that inventory to the backroom or shopfloor.

Manage Delivery Bay Screen

This dialog can be accessed from In Store Replenishment / Manage Delivery Bay. (This functionality is available only if Delivery Bay inventory is enabled in the system)

If there are delivery bay quantities available, the system will remove the inventory from the delivery bay and update the backroom or shop floor quantity.

The system provides a warning if the item entered is on a stock count that is in progress status for the user to decide whether to move the inventory or not.

After entering an item and if a delivery bay quantity is available, the system will navigate to the item detail screen for the user to enter the quantity to move out of the delivery bay.

Upon selecting to apply the change to move inventory out of the delivery bay, the system checks whether the system is configured to move the delivery bay inventory to the shop floor or the backroom.

If the system is configured to move, the system will prompt the **Move to** popup for the user to select whether to move the inventory to the backroom or shop floor.

1. If the user selects 'Shop floor', the system will look for the capacity defined and if de-defined it will move the inventory up to the capacity level and move the rest of the

quantity to the backroom. If delivery bay quantity is less than the defined quantity, the system will move all the quantities to the shopfloor.

2. If the user selects, 'Backroom', the system will move all the inventory to the back room. If the system is not configured to move to shop floor, the system will prompt the user for confirmation and will move the entire delivery bay movement quantity to the backroom if the user confirms.

Manage Delivery Bay - Item Detail

The user is taken to this screen when an item is scanned on the manage delivery bay screen. On this screen, the user can scan the items that are needed to be moved out of delivery bay. As the user scans the items, the system updates the list and displays it on manage delivery bay screen.

The user can enter the quantity to move using the quantity popup.

The user can use the arrow buttons on the bottom to navigate items.

The user can access the footer menu by selecting the ellipsis button on the bottom and **Remove** the item, **Restore** the item if flagged to remove and **Reset** item.

Stock Counts

This chapter covers stock counts. The following topics are covered:

Overview

The desktop application provides the ability to schedule and authorize stock counts whereas the mobile application provides the ability to execute the stock counts.

Portions of the stock count functionality, such as the setup of product groups, schedules, and authorizations, are performed on the desktop application only. Users can configure and execute different types of stock counts such as cycle or annual counts, ad hoc counts, or counts that are based on inventory position or problems like negative stock on hand. Merchandising and individual level counting require setup and scheduling utilizing product groups, with the exception of Ad Hoc counts. The Ad Hoc count will allow you to decide which items you want to count by scanning from the shelf immediately.

Most of these counts can be scheduled to be executed repetitively on certain dates reducing the need for daily or weekly count management.

Because a variance percentage can be set, items within tolerance can, but do not have to be authorized individually.

Business Case

- **Ad Hoc Stock Count**

A customer is looking for a blue tooth speaker in the color black. The customer finds the location on the shelf, but there are only bright pink speakers and asks a sales associate if there are any black speakers in the storage room. The sales associate looks up the inventory and the system shows there are three on hand. The sales associate looks in the backroom and cannot locate any in the store and informs the customer and reports to the store manager. The store manager instructs the sales associate to perform an ad hoc stock count to immediately correct the inventory.

- **Unit Stock Count**

The dairy department of a grocery retailer orders milk on Tuesdays and Fridays. Before they get the order in, they are always running out of stock. The department manager decides to perform a unit count each day to determine when they are running short or if there might be some pilferage occurring.

- **Problem Line Stock Count**

Due to ineffective receiving processes or supply chain issues, items regularly have negative stock on hand. Inventory control schedules a stock count that tracks this

behavior automatically to correct such problems without having to generate manual stock count lists for each store.

- **Unit and Amount Stock Count**

The Store Manager is informed when it is time to financially report their store's current value of inventory. The corporate user will schedule the Unit and Amount stock count to be executed by Department and the store manager will schedule additional staff to count all items in the store. Each Department manager will be required to complete and approve their section of the stock count. When complete, the financial value will be associated with each item counted in the store and sent to the merchandising system to have it in a similar way corrected.

Types of Stock Counts

Each type of stock count can be useful for a retailer and all play an important part in the management of inventory.

Ad Hoc Stock Counts

Unlike the other stock count types, Ad Hoc stock counts are not scheduled, but rather performed at random times when a user decides to correct inventory.

Since this count type is performed randomly, there are no predefined lists and you can scan any item in any order. The scanned items can also be removed from the stock count, if needed.

You can count any inventory item even if the item has been discontinued.

The inventory snapshot is taken as each item is added to the stock count. Snapshot is a process in which the system will capture the current stock on hand quantity. For Ad Hoc counts, discrepancy thresholds are set up differently from other count types by accessing the Ad Hoc Stock Count screen.

Inventory Adjustments will be created and sent to the merchandising system when an inventory change is made in the system.

Unit Stock Counts

The unit stock count must be scheduled. They can be scheduled and executed the same day if you desire. This count type can be setup on a recurring basis: daily, weekly, monthly or yearly.

The items to include in the stock count are identified by setting up a product group. The product groups are a one-time setup and can be reused for future stock counts. Product groups are used for creating the list of items as well as identifying how the stock count is processed. When setting up the stock count, you can define which items to include by selecting by All department, item, supplier, style, item basket, or merchandise hierarchy level. There are various settings used to determine how an item will be identified as being discrepant.

Unit counts are the only stock count type that allows you to select any item status to include in the count. You can also select whether to include items that do not have any stock on hand.

Inventory Adjustments are created and sent to the Merchandising System for any inventory adjustments made.

Problem Line Stock Counts

The problem line stock count is setup once and scheduled to run daily for a period of time. If there are no problem items, a stock count will not be created. Setup of the stock count can be done at the all department, item, supplier, style, item basket, or merchandise hierarchy level. Each day, the system will run the problem batch and find any problem items and populates those items on a stock count. Discrepancy Thresholds are defined the same as the Unit count, but there are additional criteria defined during Product Group Setup. The additional information you can select for the problem line counts includes, Actual Pick Amount less than Suggested Pick Amount and negative available inventory and UIN Discrepancies (Unique Identification Numbers).

Problem line stock counts follow exactly the same workflow as unit counts. The only exception is the product group setup.

Unit and Amount Stock Counts

The Unit and Amount stock counts must be scheduled for a specific date. These stock counts, need to be scheduled at least 1 day ahead of time. When the count is scheduled it is sent to the merchandising system so that it can also create a corresponding stock count.

Item lists are created by merchandise hierarchy or can include all departments. Unit and Amount counts cannot select by item, supplier, style, or item basket, because the merchandising system holds the valuation at the merchandise hierarchy level. Unexpected items can be added during the counting process so long as they are for the same merchandise hierarchy that the stock count was set up for.

The item status and SOH Quantity cannot be selected and are defined by the system. Inventory is updated in the system and a flat file is created with the new SOH quantity, rather than the delta. The file will be sent out externally for other systems such as merchandising.

Summary

The following figure shows a summary of the similarities and differences between the various types of stock counts.

Unit, Problem Line, Unit and Amount stock counts all use predefined items lists and must be scheduled. Ad Hoc stock counts do not use a predefined item list, are not scheduled. The snapshot for Unit, Problem Line and Unit & Amount stock counts is taken for all items on the count at the same time, while the Ad Hoc stock count takes the snapshot as each item is counted. Only the Unit and Problem Line allow the snapshot to be retaken during the recount. Ad Hoc stock counts never use guided counting and as a result files cannot be imported from a Third Party service. Only the Unit stock count can be scheduled on a recurring basis. The Problem Line can only be scheduled daily and Unit and Amount scheduled for a specific date.

Since the Ad Hoc stock count is not defined using product groups, it is the only type of count that does not have a recounting stage.

Counting Methods

The counting process is identical among Unit, Unit and Amount, and Problem Line stock count types. What differs among these three stock count types is either the setup or the items being counted.

SIOCS includes the following types of counting methods for stock counts:

- **Un-guided**

The Unguided count method allows the user to scan any item in any order. When the system parameter 'Unguided Stock Count Allow Multiple Users' is set to 'Yes', an unguided stock count will allow more than one user to scan simultaneously against the same stock count.

- **Guided**

In Guided count method, the items are counted based on locations

- **Third Party**

Here, the stock count will be done by a third party service provider and the result file will be uploaded into the system for further processing

Serialization

Retailers who sell items such as electronics, cell phones, firearms, medications and fresh items, often have to track unique numbers or attributes for a single item or group of items. These identifiers might be serial numbers, unique identification numbers, FCC IDs, International Mobile Equipment Identity (IMEI) numbers, or other kinds of identifiers. Unique identification numbers aid the retailer in tracking expensive or controlled items, or items that may be subject to manufacturer recalls or investigations by legal authorities.

The system provides the capability to track items by unique identification numbers (UIN). If the system is not configured to use UINs, this does not apply. If the UINs are not used, fields and functions related to UINs are not available in the mobile application UI.

If UINs are required for an item, the UINs must be scanned, entered or automatically generated when stock is received. When UINs are generated for tracking items, users can print labels with the generated UINs.

If the store uses UINs, the snapshot captures the status of those items in the store as part of the store's stock on hand, as well as those UINs in missing status.



Figure 11-2 Stock Count Mobile Screen Flow




After logging into the mobile application, the main menu drawer is displayed. You can select Stock Counts from the Inventory Management menu.

Figure 11-3 Stock Count List Screen





The transactions may include Ad hoc stock count, Unit count, Problem Line count, and Unit and Amount count:

- You are required to have the Edit Adhoc Stock Count permission to edit an Adhoc stock count.
- You are required to have the Edit Unit Stock Count permission to edit a Unit stock count.
- You are required to have the Edit Unit Amount Stock Count permission to edit a Unit and Amount stock count.

You can select **Create Ad Hoc** from [Stock Count List](#) and be directed to the **Add Stock Count** popup to add a description for an adhoc stock count. You will need permissions to access this screen. When you enter the screen, the text box for entering description for Ad Hoc stock count is filled with highlighted <user ID> which, once written with text, goes off. After entering the description, the user can add items to the stock count and complete the count.

If needed, the retailers can create an adhoc stock count and yet not give the opportunity for an associate to continue adding items, basically, the stock count will be locked after adding the first set of items. This option of locking a stock count will be enabled when the system parameter **Enable Adhoc Stock Count Locking** is set to **Yes**. If this parameter is set to **Yes**, there will be new flag called **Adhoc Stock Count Lock** which comes into picture. If the user adds items via bulk scan or through an item basket, this flag is set to **Yes** automatically and additional items cannot be added henceforth. It can be edited from the **Edit Stock Count** screen as well, provided the user has appropriate permissions.

Fields

Criteria Applied <x>: The number of criteria applied to the search, where X is the number.

Scheduled Date: The date for which the scheduled stock count is scheduled. Defaults to blank.

Department: List of values containing all of the departments. The value will be defaulted to All. Since a Product Group can consist of more than one merchandise hierarchy, the filter will return all stock counts that are affiliated with the department or where the counting groups contains that hierarchy. When a department is cleared out, the class and sub-class will also be cleared out.

Class: List of values containing all of the classes for the selected department. You must select a department first for the class to be editable. The value will be defaulted to All. Since a Product Group can consist of more than one merchandise hierarchy, the filter will return all stock counts that are affiliated with the class and counting groups that contain that hierarchy. When a class is cleared out, the subclass will also be cleared out.

Sub-Class: List of values containing all of the sub-classes for the selected class. You must select a class first for the class to be editable. The value will be defaulted to All. Since a Product Group can consist of more than one merchandise hierarchy, the filter will return all stock counts affiliated with that subclass and counting groups that contain that hierarchy.

Count Group: List of all product groups that exists in the system. Defaults to All.

Type: List of values. Valid values are Stock Count, Re-Count, Authorize, Active, and All. Default value is Active. Active is a type represents Stock Count and Recount (not Authorize).

Status: valid values are New, In Progress, Processing, Completed, All, and Active. Default value is Active. Active will include New and In Progress stock counts.


 **Note:**

Confirmed is the status of a guided Unit and Amount stock count for all items that are in Authorize Type and have not yet moved to Completed due to not having the results exported. Once exported, the stock count will move to Completed status. If user selects a stock count in confirmed or completed status it will be in view only mode.

Search Limit: Entry field. You can define a search limit for the number of transactions being displayed. It is a Required Field. The value will default through a system admin setting, Search Limit Default for stock count list - Mobile.

Child Count List

You can select **Stock Count** from the [Stock Count List](#) and be directed to the **Child Count List** screen. When you enter the screen, the system will sort the child count by

ID. Closed child count should be at the bottom and Active child counts should be at the top and then this ID sorting should be applied.

Selecting a child count will take you to the [Stock Count Items and Stock Re-Count Items](#) screen. Ad hoc Stock Counts will automatically have a single child count created. (Ad hoc stock counts will have one stock count to one child). The child count will be automatically named the same as the stock count (assigned description by user) with the words (child) after it.

Snapshot: This will take snapshot for all the child counts on the stock count. This will take a snapshot for Problem line and Unit type of stock counts only. If any other type of stock count, this button will not be visible.

The snapshot of a stock count will happen as follows:

- **Unit or Problem Line:** Can be taken from Child count list screen for the whole stock count or from the Stock count item screen if not in re-count mode. For Re-Count, it will be taken automatically.
- **Adhoc:** Takes snapshot as items are added.
- **Unit and Amount:** Snapshot for this type can be taken via the Snapshot batch within the desktop application.
 - For unexpected items that get added during counting:
 - * If the snapshot has already been taken for the count, it will take the snapshot of the unexpected item as it gets added to the count.
 - * If the snapshot has not been taken for the count yet, then the snapshot for the unexpected item will not get taken as the item is added, rather when the snapshot is taken for the stock count.

You can access the Child Count List screen by creating an Adhoc stock count or selecting a stock count from the [Stock Count List](#) screen.


You must have the Edit Adhoc Stock Count permission to open the screen in edit mode when displaying an Adhoc count; otherwise the screen will open as view only.

Similar to a unit count, you must have the Edit Unit Stock Count permission to open the screen in edit mode when displaying a Unit count; otherwise, the screen will open as view only.

You must have the Edit Unit and Amount Stock Count permission to open the screen in edit mode when displaying a Unit and Amount count; otherwise the screen will open as view only.



Figure 11-8 Edit Stock Count



Figure 11-9 Edit CFAs



The value can be one of the following: Date, Text, Decimal, Long depending on the 'data type' set up for the CFAs, while creating them in the desktop application. 



Figure 11-13 Product Group Info Screen



The user can access the **Bulk Scan** screen by:




Figure 11-16 Bulk Items Screen






Figure 11-19 Issue Detail UIN Screen

Class: List of values containing all of the classes for the selected Department. User must select a department first for the class to be editable. The value will be defaulted to All. Since


a Product Group can consist of more than one merchandise hierarchy, the filter will return all stock counts that are affiliated with the class and counting groups that contain that hierarchy. When a class is cleared out, the subclass will also be cleared out.

Sub-Class: List of values containing all of the sub-classes for the selected Class. You must select a Class first for the sub-class to be editable; the value will be defaulted to All. Since a Product Group can consist of more than one merchandise hierarchy, the filter will return all stock counts affiliated with that subclass and counting groups that contain that hierarchy.

Reset: Button will clear the screen of any previous search criteria that was entered by you and set back to the default values. The screen will remain open for you to enter in new search criteria.

Item Detail

The **Item Detail** screen is displayed when selecting an item from the [Stock Count Items and Stock Re-Count Items](#) screen or an item is scanned. The image display will be controlled by the system parameter. This screen will help you to enter quantity for an item in the stock count. If stock count is not completed then the quantity fields will be editable and user can enter value for counting item. The quantity fields will be disabled for UIN items and RFID enabled items. The value for these fields will be based on the number of UINs/RFID tags scanned.

There is a UIN tab that enables the user to view/add/remove the UINs for the item, if the item is a serial number item. If the user scans a serial number item, they will be taken directly to the UIN tab within the Item Detail screen, for that item.

There is an **Extended Attributes** tab that enables the user to view/capture extended attributes for the item. If the item is not configured to capture extended attributes or there are no extended attributes captured, the list will be empty.

This will be a view-only screen if the stock count is completed and no further edits can be made, or the user has no edit permissions. Items are sorted based on a few different criteria:

- If guided and items are sequenced, the order will be based on the sequence with non-sequenced (no location items) falling at the end.
- If unguided, items are always sorted by item description.

 **Note:**

Removal of an item after it has been added is not allowed in Stock Count unless it is an Ad-hoc stock count.

Units/case field: The sum of the quantity of the items scanned until a new item is scanned. This field indicates the number of items a user has in front of them that they have scanned.

Variance: User will be able to view the difference between the 'snapshot' quantity and the 'Total quantity' counted, provided the user has 'View variance' security permission.

- If the snapshot quantity < Total quantity, display '+' symbol before the variance value.
- If the snapshot quantity > Total quantity, display '-' symbol before the variance value.
- If the snapshot quantity = Total quantity, display '0' symbol before the variance value. This field will be displayed only when the user has 'View Variance' security permission.

It will be calculated dynamically after each scan (count) happens and it will only be displayed for 'counted' items.

 **Note:**

If the system is configured to auto save the items for the unguided stock counts depending on the system parameter 'Unguided stock counts Automatic Save', the system will look for the threshold value set in the Auto Save number of items threshold and save the items automatically when it reaches the threshold. The system resets the count and automatically saves the items every time it reaches the threshold. If the user exits before the threshold is met, the system still automatically saves the items and exits.

Last Scan shows the details of the last scanned barcode.

User Quantity is the sum of all quantities for an item since the last time it was saved.

Total Quantity includes the quantities from the database when it was last read, increase with the user quantity.







When a department is cleared out, the class and sub-class will also be cleared out.

Class: List of values containing all of the classes for the selected department. You must select a department first for the class to be editable. The value will be defaulted to All. Since a Product Group can consist of more than one merchandise hierarchy, the filter will return all stock counts that are affiliated with the class and counting groups that contain that hierarchy. When a class is cleared out, the subclass will also be cleared out.

Sub-Class: List of values containing all of the sub-classes for the selected class. You must select a class first for the class to be editable. The value will be defaulted to All. Since a Product Group can consist of more than one merchandise hierarchy, the filter will return all stock counts affiliated with that subclass and counting groups that contain that hierarchy.

Count Group: List of all product groups that exists in the system. Defaults to All.

Phase: Valid values are Active, Authorize, Re-Count and Stock Count. Active will include Stock Counts that are in Stock Count and Re-Count phase.

Status: Valid values are All, New, In Progress, Processing, Active, Canceled and Completed. Default value is Active. Active will include New and In Progress stock counts.


 **Note:**

Confirmed is the status of a guided Unit and Amount stock count for all items that are in Authorise Phase and have not yet moved to completed due to not having the results exported. Once exported, the stock count will move to Completed status. If the user selects a stock count in Confirmed or Completed status, it will be in view only mode.

Search Limit: This is an entry field. You can define a search limit for the number of transactions being displayed. It is a Required Field. The value will default through a system admin setting, Search Limit Default for stock count list - Mobile.

Stock Count - Child Count List

Stock Count (Child Count List) Screen



You are directed to this screen when you select a Stock Count from the [Stock Count \(Stock Count List\)](#) or from the [Open Transactions](#) screen. When you enter the screen, the system will sort the child count by ID. Closed child count should be at the bottom and Active child counts should be at the top and then this ID sorting should be applied.

This screen is skipped in case of Ad-Hoc Stock Counts. You will be directed to the Item Detail directly when you create an Ad-Hoc Stock count or select an existing ad hoc type of stock count.

Selecting a child count will take you to the Item Detail screen and from there you can select to go to the item list.

If you scan an item to search child count by item and if the system finds more than one result, the system prompts you to select the item from the Select Scanned Item screen.

If the system finds one or more child counts for the scanned item, the system prompts to select the child count from the Select Child Count screen.

You can scan the child ID on the scan bar and if found you are directed to the Item Detail (Stock Count) screen.

Snapshot: Selecting this button will take snapshot for all the child counts on the stock count. This will take a snapshot for Problem line and Unit type of stock counts only. If any other type of stock count, this button will not be visible.


The snapshot of a stock count will happen as follows:

- Unit or Problem Line: Can be taken from Child count list screen for the whole stock count or from the Stock count item screen if not in re-count mode. For Re-Count, it will be taken automatically.
- Ad hoc: Takes snapshot as items are added.
- Unit and Amount: Snapshot for this type can be taken via the Snapshot batch within the desktop application. For unexpected items that get added during counting:








Actual Shelf Repl Amount less than Suggested Shelf Repl Amount - Actual Shelf replenishment amount is less than suggested or not is displayed. This field will only be visible if product group is a problem line product group.

Available Negative Inventory - This will display if Negative inventory is available. This field will only be visible if product group is a problem line product group.

UIN Discrepancy - If any UIN discrepancy is there is displayed. This field will only be visible if product group is a problem line product group.

Figure 11-32 Child Count Information Screen





This search criteria popup screen is displayed when you select the magnifying glass from the Item List or Item Detail screen.

On the item list screen, this helps you to filter the items based on the search criteria applied and on the item detail this will help you to navigate through the items based on the search.

The defaults will be:

- Stock Count: Count / Re-Count Qty = 'uncounted'
- Re-Count: Count / Re-Count Qty = 'uncounted', Filter = 'Discrepant'
- The Count / Re-Count Qty will default as the filter on the top of the Stock Count / Stock Re-Count screen.

Fields

Count / Re-Count Qty: Valid values are All, Counted and Uncounted. Filter: Valid values are All Items and Discrepant Items. Displays only when it is a Re-Count.

Filter: Valid values are All Items and Discrepant Items. Displays only when it is a Re-Count.

Department: List of values containing all of the departments pertaining to that stock count. The value will be defaulted to All. Since a Product Group can consist of more than one merchandise hierarchy, the filter will return all stock counts that are affiliated with the dept or where the counting groups contains that hierarchy. When a department is cleared out, the class and sub-class will also be cleared out.

Class: List of values containing all of the classes for the selected Department. User must select a department first for the class to be editable. The value will be defaulted to All.

Since a Product Group can consist of more than one merchandise hierarchy, the filter will return all stock counts that are affiliated with the class and counting groups that contain that hierarchy. When a class is cleared out, the subclass will also be cleared out.

Sub-Class: List of values containing all of the sub-classes for the selected Class. You must select a Class first for the sub-class to be editable; the value will be defaulted to All. Since a

Product Group can consist of more than one merchandise hierarchy, the filter will return all stock counts affiliated with that subclass and counting groups that contain that hierarchy.

Search: Upon selecting this button, the system will filter the records based on the criteria provided.

Reset: Button will clear the screen of any previous search criteria that was entered by you and set back to the default values. The screen will remain open for you to enter in new search criteria.

Cancel- This will discard the selection and go back to the previous screen.

Figure 11-34 Item Detail Screen 1





Figure 11-35 Item detail Screen 2



You are directed to the Item Detail screen in multiple ways:

- When selecting a child count or when scanning a valid child id on the Stock Count (Child Stock Count List).
- After selecting the child stock count from the Select Child Count screen when there are more child count results for the search.
- After selecting or scanning a valid item on the Count Items(Item List).

You can go to the item list by selecting the Item List icon or selecting the option from the footer menu.

This screen will help you to enter count quantity or the total quantity for an item in the stock count. If stock count is not completed, the quantity fields will be editable, and you can enter value for the item counted. Upon selecting the quantity fields, the system displays the Edit Quantity popup to enter the total quantity or the counted quantity depending on what you select. On this screen you will be able to take the snapshot for the child count.

Below is a detailed explanation on how Count Quantity and Total Quantity work:

Count Quantity – Displays the current scan quantity of the item until another item is scanned. Enter the quantity using the Edit Quantity Popup that is triggered when you select the field.

- It will show 1 when the item is scanned in + scan mode
- It will bottom out to 0 when using – scan mode
- Each time the item is saved, or the item is changed to another item, this quantity is set to 0
- This quantity can be edited only if you have permission.

- The entered quantity in this field is added to the total quantity.
- Value has to be 0 or positive, it cannot be negative.
- For UIN Serial Numbers (AGSN and non AGSN), the quantity field is disabled and the selecting the edit quantity will take the user to the Serial Number popup screen
 - The Edit Quantity icon will be a <pen>+, + to show that UINs are needed.
 - Quantity would get updated per UINs being added / removed on the UIN panel
 - The system does not look for the Edit Quantity permission for the UIN items.

Total Quantity - This value represents the total child quantity field when the item is added. Can enter the total quantity using the Edit Quantity Popup that is triggered when you select the field.

- This is the user quantity increased by the current scan quantity or entered quantity
- It will bottom out to 0 when using – scan mode
- This quantity can be edited only if you have permission to do so
- Value must be 0 or positive, it cannot be negative.
- This field will be updated real time to display the current total quantity as items are scanned in user's session

This will be a view only screen if the stock count is completed and no further edits can be made, or the user has no edit permissions. Items are sorted based on different criteria:

- If guided and items are sequenced, the order will be based on the sequence with non-sequenced (no location items) falling at the end
- If unguided, items are always sorted by item description

 **Note:**

Removal of an item after it has been added is not allowed in Stock Count unless it is an Ad-hoc stock count.

Unit Field: The sum of the quantity of the items scanned until a new item is scanned. It indicates the number of items a user has in front of them they have scanned.

Variance: The user will be able to view the difference between the 'snapshot' quantity and the 'Total quantity' counted, provided the user has 'View variance' security permission.

- If the snapshot quantity < Total quantity, display '+' symbol before the variance value.
- If the snapshot quantity > Total quantity, display '-' symbol before the variance value.
- If the snapshot quantity = Total quantity, display '0' symbol before the variance value. This field will be displayed only when the user has 'View Variance' security permission.

It will be calculated dynamically after each scan (count) happens and it will only be displayed for 'counted' items.

 **Note:**

If the system is configured to auto save the items for the unguided stock counts depending on the system parameter 'Unguided stock counts Automatic Save', the system will look for the threshold value set in the Auto Save number of items threshold and save the items automatically when it reaches the threshold. The system resets the count and automatically saves the items every time it reaches the threshold. If the user exits before the threshold is met, the system still automatically saves the items and exits.

Last Scan: Shows the details of the last scanned barcode.

Extended Attributes Sets: The extended attributes option is available only if it is configured in the store parameter and the user has proper permission.

- If the proper permissions do not exist, the screen will be read only.
- It is a link that will take the user to the Extended Attributes screen.
- <x >represents the number of attribute sets assigned; initially it will be zero.



View Full Item List - Upon selecting this menu, you are navigated to the Item List.

Complete Child - This will complete the child count and go to the Stock Count (Child Stock Count List).

Complete Count - This is applicable for Adhoc stock count. Upon selecting this the system will complete the adhoc stock count.

Save and Exit -This will save the child stock count and exit to the child stock count list screen.

Cancel - This will discard changes to stock count / re-count and navigate you to Stock Count (Child Stock Count List).

Quick Count

The Quick Count dialog can be accessed from the drawer/menu on the Jet Mobile application. This dialog enables the store users to do a quick count of inventory in the store across multiple locations on the fly without scheduling a stock count, taking a snapshot or authorizing the count results.

This feature helps the retailer to keep an eye on the inventory and do a quick stock count of any random item(s) like high priced, fast moving, etc and match the inventory with the physical count in the store.

Features:

- Update inventory of Shop Floor, Backroom and Delivery Bay of an item or just the available inventory based on configuration.
- Adjust the quantity of all inventory buckets of an item to zero.
- Add the selected item to the item basket.
- Print Ticket.




Figure 11-38 Quick Count Screen: Item

The Quick Count screen can be accessed from the menu drawer and Quick Actions. On this screen, the user can enter or scan an item to update the inventory.

The user can access this only when the proper permission is assigned.

User can scan or enter an item on the scan bar and the system will display the item if it is valid. On this screen, the user can see the current values of the inventory buckets and enter the actual quantity to be updated on the individual buckets. Scanning the next item is not a confirmation on this screen. User must enter the values using the Edit quantity widget and confirm for the system to update.

Non inventory items are not allowed on this screen.

The shopfloor, backroom and delivery bay are only displayed when they are leveraged in the system. If they are turned off, then only available inventory will be shown to the user.

Confirm Quick Count

Upon selecting the **Confirm** button, the system updates the inventory based on the values entered in Shop floor, Back room and Delivery bay quantities or available bucket if shopfloor/backroom are not managed in SIOCS.

Depending on the inventory buckets tracked in SIOCS, the following rules will apply when the system updates available inventory. Note that this type of stock count does not set SOH to 0 when nothing is counted, so there is no impact on driving the inventory negative when unavailable inventory exists.

- The available bucket = Shop Floor+Backroom+Delivery bay. If not configured for these buckets, available will be update with the counted quantities.
- In case a bucket is not counted, the original value will be applied. With other words a blank value does not equate to a 0 count.
- Update process will create an inventory adjustment in the system using the inventory adjustment reason with appropriate disposition.

Use Cases

1. Assume current inventory bucket values in the system are SOH =100, Available=80, Unavailable=20, Shop floor=20, Backroom=40 and Delivery bay=20.
2. User starts counting an item and scans the item, e.g. 1234.
3. Assume counted quantity in Shop floor=30, Backroom=20 and Delivery bay=10 and user enters the quantity on the respective buckets on this dialog.
4. The system will update the SOH=80, Unavailable=20(not altered), Shop floor=30, Backroom=20 and Delivery bay=10.

The system displays the Shop Floor and Backroom fields only when 'Display Shop floor/ Backroom quantity' system setting is enabled.

The delivery bay is only displayed when the Replenishment - Delivery Bay Inventory parameter is turned on.

Additional informational fields on this screen include:

- **Last Received** - how many were last received on allocation, DSD, transfer.
- **Next Delivery** - the quantity on the next delivery. It is the in transit (In bound qty) for the ASN (Transfer,DSD, allocation)
- **Sold Today** - number of units sold today for item and store in the SUOM.
- **Unavailable** - This field holds the total unavailable stock on hand. Unavailable = Total Stock on Hand – Available SOH
- **Regular Price** - shown if the item is on regular price. Also shown if the item is on Promo. Will not display if item is on clearance.
- **Promo Price** - will display if there is a promo for the item. May also display if the item is on clearance.
- **Clearance Price** - will display if the item is on clearance.

Footer Menu

From the footer menu, the user can access the **Adjust to Zero**, **Add to Item Basket** and **Print Ticket** functions.

Add to Item Basket — User can select this option to add the item to the Investigate Item Basket. Item is added to the latest active investigate type item basket.

Remove from Item Basket — Selecting this option will remove the item from the item basket.

Print Ticket — If the user is having permission to print the tickets, this option can be used to print the tickets.

Printer — This will show the list of printers configured including the blue tooth printers. During the session, the 'default' printer is the one the user selected first.



- Access the delivery dialog for a specific customer order


Figure 12-1 Customer Order Screen Flow



The Cust Order Items screen is used to select a customer order from the [Customer Order List](#) screen. The items are listed for the customer order. The item image for the line items is displayed per configuration.

Line items appear in a list and selecting a line item will navigate to the item details of that item. Scrolling in the list of items on the left will display a filter. The filter can be used to narrow down the list of items. Filtering can occur by item ID or item description.

Scanning or entering an item in the scan bar will navigate to the [Item Detail \(Customer Orders\)](#) screen for that item. The ellipsis in the lower right hand corner will access the Footer menu which will contain all of the functions that can be performed on a customer order.

 **Note:**

If the order has duplicate items, meaning an item exists on the customer order more than once, the items will appear multiple times in the list with the corresponding line numbers listed as well. This applies to all screens that display the item within customer orders, customer order picking, customer order deliveries, and customer order reverse picking.

Footer Menu

The footer menu is accessed from the ellipsis footer menu on the Customer Order Items screen. The menu functions will include the following.

Info: Info will access the Info popup.

Notes: The Notes option accesses the notes common dialog to capture notes. Notes will always be available for viewing and user can create notes regardless of the status of the customer order, provided the user has Create Notes permission.

Edit CFAs: This option takes the user to Edit CFAs screen to enter values for the CFAs that are set up for Customer Orders.

Edit Customer Order: This option takes the user to the Edit Customer Order screen to specify the Hold Location.

Customer: The customer information popup for the customer order will display, view only.

Pick: Pick will generate a pick for the customer order and navigate the user to the Pick Items screen for the new pick. All picking rules apply. If picking by Area is configured for the store, the user will navigate to the Create Pick popup to select an Area first. See [Customer Order Picking](#).

Delivery: Navigates to the Delivery dialog (Delivery List screen) for the current customer order. See [Customer Order Deliveries](#).

All states of customer orders as well as all types (web order, pick up, layaway, and so on).

The user must have 'Access Customer Order Delivery' permission.

Accept: Accept will only be for web order types of customer orders of status 'New' or 'New but in Under Review mode' and after the customer order is accepted at the store, it will go through the required process for it to be shipped.


Reject: Reject will be available for web order types of customer orders in any status except 'Completed' and 'Cancelled'. All item quantities that have not yet been picked will be canceled/rejected. A system generated reverse pick will be created for the rejected items. For more information, see [Customer Order Reverse Picks](#).

Back: Back will return to the Customer Orders List, no changes made to status.

Print: Print will display the common print dialog to print the customer order report.

Figure 12-5 Edit Customer Order






Figure 12-7 Edit CFAs Screen


Figure 12-8 Customer Popup



The user will access the Customer Order Picking Dialog from the Customer Order Mgmt menu in the drawer. The [Pick List](#) screen will display the list of Active picks. The user can go to the [Search Criteria \(Pick List\)](#) screen to search for picks using alternate criteria.


From the Pick List screen, the user can select a pick to go to the Pick Items (detail of pick) for viewing or editing purposes.

Also from the Pick List screen, the user can Create a pick. The pick may be created by bin or customer order. When creating by customer order, the user will need to specify which order is being picked and, once that is done, the system will generate a pick and navigate to the details of that Pick on the Pick Items screen. 



Figure 12-14 Create Pick Popup within Picking



The Create Pick popup is accessed by selecting the **Create** button from the [Pick List](#) screen. The create pick allows for the creation of a customer order pick by either Store customer order ID or by bin. The type will default per the store setting **Default Customer Order Picking Method**. The store must be configured for **Reserve Customer Order Inventory Upon Receiving** set to **No** in order to create or generate a pick by bin or Store Customer Order. This means that inventory is reserved when the customer order arrives into the store and therefore it should be picked from inventory. When set to **Yes**, inventory is reserved based upon receipts and therefore should be picked from the receipt. The user would not want the store to pick from inventory when it should be picked based upon what was received on the delivery.

When selecting Store Customer Order, the user must enter in the Store customer order ID to be picked or use the search function to select one from the list. When creating a pick by Store Customer Order ID, there will only be one Customer Order Fulfillment Order per pick transaction. When creating a pick by bin, the user will define the number of bins to be put on the pick. Initially, the bin quantity will be defaulted based upon the store admin setting **Default Number of Bins**. The user has the potential to override this quantity if the store admin setting **Override Bin Quantity** is set to **Yes**.

Picks created by Bin allows for multiple customer orders to be put on the pick; one store customer order per bin. It will first look to all store customer orders that are the oldest based upon release date. All other rules for creating the pick will be the same as those above for picking by store customer order ID.


In both by Store Customer Order ID and bin a pick can be created by Area. Picking by Area allows a user to create a pick for a customer order that is for a specific Area of the store. This is only possible if the store configuration **Allow Picking by Area** is set to **Yes** and the system admin of **Customer Order Fulfillment Restriction** is set to **Transaction Controlled** (meaning that the entire customer order does not have to be picked in one pick). Areas are set up in the desktop application in the Area dialog. If Area is an option, the system will give a list of **Completed** status Areas, with one of the options being **None** for no area.

Upon selecting **Create**, the user will navigate to the [Pick Items](#) screen for the generated pick.

Customer Orders that will be available for picking will follow these rules:

- Customer order must be a web order type.
- Customer order must still be open.
- There cannot be an existing open pick for the customer order.
 - If Area is being used, open picks are allowed for the customer order, so long as it is not for the same area.
- Customer order must have at least one item on the order with items remaining to be picked.
- If the system admin Customer Order Fulfillment Restriction equals Transaction Controlled, the system will also need to check that there is stock available to be picked for at least one item.
 - If pick is by Area of **None**, all items from the customer order will be put on the pick.
 - If the pick is for a specific area, the system will put the items from the customer order which are in the selected area.
- If Customer Order Fulfillment Restriction equals Restricted, there must be enough available stock for all items on the pick to be fully picked in their entirety.
- If Customer Order Fulfillment Restriction equals Line Controlled, user will not be able to create the pick if there is not enough available stock to pick at least one item fully.
- Items that have substitute equal to Yes on the customer order (meaning they allow for substitutes) will have their stock ignored. This is because they can have items substituted for them.


Figure 12-15 Bin List Screen



The Bin List screen applies to those picks which are by bin. Picks by bin will have bins manually or system generated per the store admin setting. For manually-captured bins, the user will be directed to the Bin List screen immediately upon creating the pick prior to going to the [Pick Items](#) screen. Bins are only editable for manually-captured bins. System and manually captured bins can be viewed from the Bin option within the footer menu of the [Pick Items](#) screen. The bins can be printed through the Print button.

Pick Items

The Pick Items screen is accessed by selecting an existing pick from the [Pick List](#) screen, or by creating a new pick. The Pick Items displays all of the items on the pick including substitute items which will be listed below the original item with an arrow referencing up to the original item. Fields will include the suggested pick quantity, quantity (actual picked quantity) and store customer order ID or bin ID based upon the pick type. Selecting an item will navigate to the Item Detail screen for that item. Scanning an item will also navigate to the Item Detail screen for that item and the quantity may be updated per the quantity scanned. If the pick is by bin, the user will go to the Confirm Bin screen to scan the bin prior to going to the Item Detail screen. The items are listed in order with those items with stock on hand in the backroom being displayed first, followed by items with shopfloor stock on hand, and lastly those that do not have stock on hand in either the backroom or the shopfloor. All items are ordered by macro sequence location. Items will have an icon displayed denoting the pick status of the item. If the item's pick quantity has quantity left to be picked there will be a blue circle with an 'i'. If the item's pick quantity is fully picked, it will be a green circle with a check mark. If the item's pick quantity has exceeded the amount to be picked (because changes to the customer order have been made such as a delivery or cancelation), there will be a red circle with a '!'. Refresh will refresh the customer order pick and pull in any delivered or canceled quantities that have happened for the delivery. The Adjusted Pick Quantity will reflect the new suggested pick quantity.

Footer Menu

The footer menu is accessed from the ellipsis footer menu on the [Pick Items](#) screen. The menu functions will include the following:

Info: Info will access the Info popup.

Notes: The Notes option accesses the notes common dialog to capture notes. Notes can only be added for picks by Store Customer Order ID. The note will be saved on the customer order and not the pick.

Edit CFAs: This option takes the user to Edit CFAs screen to enter values for the CFAs that are set up for Customer Order Picking.

Bins: Accesses the Bin List screen.

Refresh: Perform the same function as the refresh on the Pick Items screen.

Confirm: Confirms the pick and move it to Completed status and, the user returns to the Pick List screen.

Save: Saves the pick as In Progress status and return the user to the Pick List screen.

Delete: Allows for deleting of a New or In Progress status pick and moves it to Canceled status. The user will return to the Pick List screen.

Cancel: Exits to the Pick List screen and no changes will be saved.

Back: Back is only applicable to view only picks and will exit to the Pick List screen.

Print: Print will display the common print dialog to print the customer order pick report.

Quantity Validation

When confirming, if any of the store customer order quantities on the pick transaction have been canceled or delivered since the pick was created, and the total pick quantity for the item is now greater than the remaining pick quantity:

- The Adjusted Pick Qty field will be updated to indicate to the user how much is needed to pick based upon the changes (delivery and cancels) that were made on the customer order.

Upon confirm, the system will check the system admin, Customer Order Fulfillment Restriction:

- If it is set to Restricted, the entire customer order must be picked in its entirety.
- If it is set to Line controlled, any item that is getting picked must be picked in its entirety.
- If it is set to Transaction Controlled, no restrictions as above.

Tolerances


- When the item has a variable unit of measure, it can be difficult to pick the exact amount suggested. For example: picking 2 pounds of bananas might end up truly being 2.2. The quantity picked may exceed the suggested if the defined tolerances are setup to allow for such.

Substitute Items

- Substitute Items are considered in the Total Pick Qty when doing all quantity validations.
- The reserved quantity for the original item is decreased by the rolled up pick quantities.
- The substituted items that have an actual pick quantity greater than zero will have their reserved quantity increased for the amount being substituted.

Item Detail (Picking)

The Item Detail screen contains the details for the specific item on the customer order pick. Entering/scanning an item on this screen will refresh the screen and update item and the pick quantity for the item. If the pick is by bin, first the user will have to Confirm the bin before refreshing the details for the item. Once an item has been fully picked, the system will automatically navigate to the next item on the pick.

The Pick Quantity, represented by the field on the top of the screen with the UOM label is editable by the user and represents how many of this item is being picked. Editing the quantity is controlled by security. If the quantity is edited, the user will be prompted with the Confirm Items popup to confirm the proper item and also the confirm bin (if pick is by bin).

The suggested pick quantity displays the quantity the system suggests to be picked. The adjust pick qty is the suggested pick quantity that is updated by the system upon refresh or

trying to confirm the pick. It reflects any deliveries or cancellations that have occurred on the customer order since the time the pick was generated. Total Picked is the total amount picked for the item along with all of its substitute items. Lastly, if the pick is by Store Customer Order ID, that ID will be displayed. Otherwise, if the pick is by bin, then the bin for the pick will be displayed.

If the item allows for substitute items, there will be a Substituted field that will state Yes if there is one or more items substituted, and No if there are no substitutes. Tapping on this field will navigate to the Substitute Items screen. If the item is being substituted for another item, there will be a Substituted For field and it will display the original item ID that the item is being substituted for.

If **Display Sequence Fields** equals **Yes**, the macro location and area for the item will be displayed. If it set to **No**, this field is not displayed.

If there is stock on hand in the backroom:

- It will display the first available backroom location.
- If no backroom location, it will display Backroom.

If there is no stock in the backroom and stock exists in the shopfloor:

- It will display the first available shopfloor location.
- If there is no shopfloor location, it will display Shopfloor.


If there is no stock on hand in the backroom or the shopfloor:

- It will display the first backroom location.
- If no backroom location, the first shopfloor location is displayed.
- If no shopfloor location, it displays no location.

The screen has arrows on the bottom that will prompt the user to the next item on the pick.

Confirm Item/Confirm Bin

After editing the pick quantity the user will be required to confirm the item in the **Confirm Item** popup. This is to validate the proper item is being picked.

For picks that are by bin, the user also needs to validate that the items are being placed into the proper bin. When entering or scanning an item or editing the pick quantity, the user will be directed to the **Confirm Bin** popup to scan the bin for the item.




Figure 12-19 Substitute Items Screen



The Substitute Items screen is accessed by selecting the Substituted field on the [Item Detail \(Picking\)](#) screen. This screen will list all of the available substitute items for the item being picked (if there are any). If the **Item Substitution - Store Discretion** equals **Yes**, the user does not have to use one of the items in the list, and can also enter/scan an item for substitution. It will be added to the pick as well as to the **Substitute Items** list. If the user does not have store discretion, only items from the list can be selected.


Figure 12-20 Edit CFAs Screen


Customer Order Deliveries

Delivering of a customer order consists of collecting the items that have been picked and then getting them to the customer (shipment or pickup). This might be for a customer pickup or shipping them to the customer.

- Edit an existing customer order delivery (web order)
- Delete a customer order delivery (web order)
- Print a customer order delivery
- Create a customer order delivery (web order)


Figure 12-22 Customer Order Delivery Screen Flow



Customer order deliveries will be accessed from the **Customer Order** dialog on the **Cust Order Items** footer menu. Customer order deliveries can be created and edited for web order types, non web orders can only be viewed and are fulfilled through the POS system. Customer order deliveries will allow for viewing, creating, editing, saving, submitting, dispatching, printing, BOL, and deleting customer order deliveries

Delivery List

The Delivery List screen is accessed by selecting the **Delivery** menu option within the footer menu of a specific customer order. The screen will display all of the customer orders delivery for the specific customer order delivery. The deliveries displayed may

be for web orders that were created within the system, a third-party system such as POS, or they may be for POS on holds and layaways.

Since there will never be a large number of deliveries for a specific customer order, there is no search criteria screen. There is however a filter bar, which allows for filtering by: delivery ID, status, date, and user. Selecting a delivery will navigate to the details for the customer order delivery. The **Create** button will attempt to create the delivery and navigate to the [Delivery Items](#) screen.

Creating a new delivery is also an option. New Deliveries can only be created for web order customer orders that are not in 'New', 'Under Review mode but in New status', 'Completed' or 'Cancelled' status, which means there is remaining quantity yet to be fulfilled.


In case the system is configured to require picking, it will validate there are item quantities on the customer order that have been picked which have not yet been delivered prior to creating the delivery. Next, the system will check the **Allow Partial Delivery** indicator which is on the customer order fulfillment order. If this is set to **No**, it means that the entire order must be delivered together. The system would not allow the creation of the delivery unless the entire order has been picked. If picking is not required, the delivery will be created. The **Allow Partial Delivery** indicator will then be validated upon dispatch of the delivery.

Once the system creates the delivery, the delivery will consist of all of the items that were auto populated from the customer order fulfillment order including substitutes.

This screen gives a quick view of the list of deliveries for the customer order along with the details such as delivery ID, status, status of the Fiscal Doc/E-way bill request(if the system is configured to use Fiscal Doc ID/E-way Bill ID), etc.

Delivery Items

The Delivery Items screen is accessed by selecting an existing Delivery from the [Delivery List](#) screen, or by creating a new delivery. Delivery Items displays all of the items on the delivery including the order and remaining quantities.

Selecting an item will navigate to the [Item Detail \(Customer Order Deliveries\)](#) screen for that item. Scanning an item will also navigate to the **Item Detail** screen for that item and the quantity may be updated per the quantity scanned. If the item scanned is a UIN item, the user will navigate to the UIN tab within the **Item Detail** screen.

The items are listed in ascending order by item ID. A **Default Qty** button will be displayed in the footer which will default in the delivery quantities on the delivery (non UIN items) to what is remaining to be delivered.

If any item in the customer order has **Customer Order Ship Alone** indicator set to **Yes**, then the system will not allow the user to deliver this item along with other items. Those items will need to be shipped alone.

Footer Menu

The footer menu is accessed from the ellipsis footer menu on the [Pick Items](#) screen. The menu functions will include the following:

Info: Info will access the Info popup.

BOL Info: Accesses the BOL Info popup.

Notes: The Notes option accesses the notes common dialog to capture notes. The note will be saved on the customer order and not the pick.

Default Qty: Default Qty will default in the delivery quantity to what is remaining.

Edit CFAs: This option takes the user to Edit CFAs screen to enter values for the CFAs that are set up for Customer Order Delivery.

Edit Delivery: Displays the **Edit Delivery** popup to edit header level information on the delivery.

Refresh: Refreshes the delivery by getting the most current customer order/fulfillment order information. There may be other picks or deliveries that have occurred in the time the delivery was originally created.

Cancel Submit: Sets a submitted status delivery back to **In Progress**.

Dispatch: Dispatch will check if **Allow Partial Indicator** is set to **No**, it will validate that the entire order is being delivered together. If not, the system will restrict the user from dispatching. Those users with certain privileges will be able to override this and it will be a warning. If Allow Partial Indicator is set to Yes, the customer order can be delivered partially. If system parameter 'Customer Order Fulfillment Restriction' is set to 'Line Controlled' and Allow Partial Indicator is set to Yes, if an item is getting delivered then it has to be delivered fully. Partial delivery of an item is not allowed. Also, if the store parameter **Manifest Customer Order Deliveries** is set to **No** and system parameter **Tracking ID Required** is set to **Yes**, the system should check if the Tracking ID has been captured or not, if not captured, an error message will be displayed. Upon dispatch of the delivery the delivery will move to **Completed** status, and user returns to the [Delivery List](#) screen. The stock on hand and customer order reserved quantities will be decremented by the delivered quantities. The customer order fulfillment order will have the delivered and remaining quantity updated. If the entire customer order has been fulfilled, meaning there is no remaining quantity, the customer order will be set to **Completed** status. If the system is enabled to obtain Fiscal Doc ID/E-way bill ID as part of the shipping process, the delivery cannot be dispatched until the Fiscal Doc ID/E-way bill ID is available. The exception is when the user has 'Allow dispatch without Fiscal Document ID' security permission.

Submit: Submit will submit the delivery and set it to **Submitted** status. Submit is only available when store configured for **Dispatch Validate to Ship Submit**. Submitting will set the delivery to a **Submitted** status and not allow for edits, since there are no updates to inventory at this point. The only step possible will be to cancel Submit or Dispatch. When the system is configured for **Ship Direct**, submitting is not possible. Submit will check if Allow Partial Indicator is set to No, it will validate that the entire order is being delivered together. If not, the system will restrict the user from submitting. Those users with certain privileges will be able to override this and it will be a warning. If Allow Partial Indicator is set to Yes, the customer order can be delivered partially. If system parameter 'Customer Order Fulfillment Restriction' is set to 'Line Controlled' and Allow Partial Indicator is set to Yes, if an item is getting delivered then it has to be delivered fully. Partial delivery of an item is not allowed. If the store parameter **Manifest Customer Order Deliveries** is set to **No** and system parameter **Tracking ID Required** is set to **Yes**, the system should check if the Tracking ID has been captured or not, if not captured, an error message will be displayed. If the system is enabled to obtain Fiscal Doc ID/E-way bill ID for the shipment, the process to request the E*waybill starts once the shipment is submitted.

Save: Saves the delivery as **In Progress** status and return to the [Delivery List](#) screen.

Delete: Deletion of an **In Progress** status delivery and move it to **Canceled** status. User will return to the [Delivery List](#) screen.

Back: Back is only applicable to view only deliveries and will exit to the [Delivery List](#) screen.

Cancel: Exits to the [Delivery List](#) screen and no changes will be saved.

External Printing: Displays the external printing dialog to select a printer for pre-shipment or manifesting.

Print: Print will display the common print dialog to print the customer order delivery report.

The Item Detail screen contains the details for the specific item on the customer order delivery. The delivery quantity, represented by the field on the top of the screen with the UOM label is editable by the user and represents how many of this item is being delivered. 
The pack size will be displayed if the UOM is set to cases. The remaining, order, picked, delivered and canceled quantities for the customer order will be displayed. Lastly, if the item is a substitute for another item, the **Substitute For** field will display with the original item listed.

The Item Detail has a UIN tab to take user to the UIN screen to add/remove UINs for UIN items (if system is configured to use UINs and if the item is a UIN item).

There is an **Extended Attributes** tab that enables the user to view/capture Extended Attributes for the item. If the item is not configured to capture extended attributes or there are no extended attributes captured, the list will be empty.





This is the Edit Delivery screen for Customer Order Deliveries. It allows the user to edit details on the Customer Order Delivery or BOL. If the carrier is on the customer order, the carrier type will be defaulted to third party and the carrier will be populated from the customer order. If there is no carrier on the customer order, the type will default to the sender for shipments and receiver for pick-ups.

The Service, example 2 day, next day, and so on, are defaulted from the customer order. They are not required. For additional details on BOL, Manifesting, and pre-shipment, see [Shipping and Receiving Common Components](#).

- The screen also enables the user to specify details such as vehicle number and country, driver name and License number, if the retailer has been using Fiscal Document ID/E-way bill ID in the shipment process.

Customer Order Reverse Picks

Canceling of customer orders can come in from an external system, such as an Order Management System. When this happens, a reverse pick list will be generated. If there are items that physically need to be un-picked, the user will action the reverse pick list which will then take the items that were canceled and move the picked quantities back to the appropriate area in the store. If the items that are being canceled are not picked, then the system generated reverse pick will just be created in a **Completed** status with no action required through the application.

A system-generated reverse pick may get created if the user rejects an open customer order.


A manual reverse pick might also be necessary. This happens when the user discovers that something which was picked has to be unpicked, maybe because it has been damaged. The manual reverse pick will reverse the pick quantities.

Note that reverse picking and canceling is more of an exception process.



Figure 12-30 Customer Order Reverse Picking Screen Flow

The **Reverse Pick List** screen is accessed by selecting the Reverse Pick menu option within the footer menu of a specific customer order. The list will contain all of the Reverse Picks for the specific Customer Order. The screen will list both externally created system-generated reverse picks as well as manually created reverse picks. Reverse Picks are only for web orders. The Reverse Pick List screen lists reverse pick records for all statuses. This list screen does not have a filter as there normally would not be that many reverse picks for a customer order fulfillment order to filter on. The fields will include the Reverse Pick ID, status, last update date, and user for the reverse pick. A user can navigate to the details of a reverse pick by tapping on a reverse pick record. Finally, the user can create a new manually created reverse pick.

Manual Reverse Pick

- New Reverse Picks can only be created for Web Order customer orders that are in any status except 'New', 'Under Review mode but in New status', 'Completed' or 'Cancelled'. The user might want to create a manual reverse pick because something that was picked might have become damaged and therefore it must be un-picked.
- Before creating a new manual reverse pick, the system needs to perform some validations. The system must be configured for manual or auto picking and if so,


then reverse picks can be created. This means that if Reserve on Receiving is set to Yes and Auto Picking is not turned on, then a reverse pick would not be allowed to be created. There must be at least one item on the customer order with a physical picked quantity. By physical picked quantity it means a quantity that is still physically sitting there as picked, and it has not been delivered (which means shipped or picked up by the customer). Once the reverse pick is created, it will consist of all the items auto populated from the customer order fulfillment order including the substitute items. The Suggested Reverse Pick Quantity will be set to zero for manual picks. For manual reverse picks, the quantity cannot exceed the physical picked quantity.

External System-Generated Reverse Pick

- When a system generated reverse pick is created, it will put all items on the reverse pick, including the substitute items. However, only those items that have a suggested quantity will be allowed to be reverse picked. The **Suggested Reverse Pick Quantity** will be populated with what should be reverse picked based upon the cancellation from the external system. For externally system generated reverse picks, the Quantity cannot exceed the remaining quantity or the suggested reverse pick quantity.
- If a cancelation comes into the system that is for more than what is remaining on the order, the cancelation will be rejected and a system-generated reverse pick will not be created.
- When creating the system generated reverse pick, the system will first try and cancel those items that have not been picked. If this quantity is exceeded, it will cancel those items already picked. When all items that are canceled have not been picked, there will not be anything to un-pick and therefore the reverse pick will be auto completed and put into a Completed status and updates will happen to the customer order and inventory as stated below. When some or all items that are canceled are picked, this creates a system-generated reverse pick in New status. This occurs so the user can action it and un-pick the items. Updates will occur upon confirmation of the reverse pick as described below.

Reverse Pick Items

The Reverse Pick Items screen is accessed by selecting an existing Reverse Pick from the [Reverse Pick List](#) screen, or by creating a new Reverse Pick. The Reverse Pick Items display the items in alphanumeric order by item description and the items are determined based upon the following rules:

- Manually created reverse picks will put only the items that:
 - Have a physical pick quantity, meaning they have been physically picked and therefore can be reverse picked.
 - OR, if there is reverse pick qty, meaning one had already been entered by the user on the reverse pick and saved (the PPQ may not exist any longer on the customer order depending on what has happened to the order).
- Externally generated (system) reverse picks will put all items on the reverse pick that have a suggested quantity. Meaning the items that are being canceled by the external system. If the item being canceled has a substitute(s) those will be put on the reverse pick along with the original item.
- All completed and canceled status reverse picks will display all items from the customer order.

Selecting an item will navigate to the Item Detail screen for that item. Scanning an item will also navigate to the Item Detail screen for that item and the quantity may be updated per the quantity scanned.

Footer Menu

The footer menu is accessed from the ellipsis footer menu on the [Reverse Pick Items](#) screen. The menu functions will include the following:

Info: Info will access the Info popup.

Notes: The Notes option accesses the notes common dialog to capture notes. The note will be saved on the customer order.

Default Qty: Default Qty will default in the quantity.

- Manually created reverse picks will default the quantity to the physical pick quantity.
- Externally generated (system) reverse picks will default the quantity to that of the suggested quantity.

Edit CFAs: This option takes the user to Edit CFAs screen to enter values for the CFAs that are set up for Customer Order Reverse Picking.

Confirm: Confirm will complete the Reverse Pick and move it to Completed status.

- For manual reverse picks, the pick quantity on the customer order will be decremented by what was a Reverse picked. The Reserved quantity and the canceled quantity will not get updated as the items are not being canceled on the order, so they need to remain as reserved. They are simply being un-picked.
- For the externally (system) generated reverse picks the pick quantity will be decremented on the customer order. The reserved quantity (if it had been reserved) will be decremented by what was reverse picked and put back to the backroom. The Canceled quantity on the customer order will be incremented by the reverse picked quantity. If all items have been canceled and there have been no deliveries, the status of the customer order will move to Cancelled. If there is no remaining order quantity on the order, and some of the items have been delivered, the customer order will move to Completed status.

Save: Saves the reverse pick as In Progress status and return to the [Reverse Pick List](#) screen.

Delete: Delete will allow for deleting of an In Progress status reverse pick and move it to Canceled status. User will return to the [Reverse Pick List](#) screen.


Back: Back is only applicable to view only reverse picks and will exit to the [Reverse Pick List](#) screen.

Cancel: Exits to the [Reverse Pick List](#) screen and no changes will be saved.

Print: Print will display the common print dialog to print the customer order reverse pick report.

The **Item Detail** screen contains the details for the specific item on the customer order reverse pick. Entering/scanning an item on this screen will refresh the screen and update item and the reverse pick quantity for the item.

The reverse pick quantity, represented by the field on the top of the screen with the UOM label is editable by the user and represents how many of this item is being reverse picked. Editing the quantity is controlled by security. The suggested quantity will populate with the amount to be reversed for system generated reverse picks. Manually created will have the suggested quantity set to zero.

Users will enter in the quantity to be reverse picked.


- For manual reverse picks, the user must enter in a quantity less than or equal to the physical pick quantity for the item.
- For system generated (external) reverse picks the quantity must be less than or equal to the suggested quantity for items which are units. It must be less than or equal to the remaining quantity for variable UOM items (that is, Kg, Lbs, and so on).

The pack size will be displayed if the UOM is set to cases. Other fields include remaining, order, picked, delivered and canceled quantities for the customer order will

be displayed. Lastly, if the item is a substitute for another item, the Substitute For field will display with the original item listed.


Figure 12-34 Edit CFAs Screen




Figure 12-36 Customer Order Quick Flow Screen Flow



Customer Order Quickflow starts by accessing the web order type customer order in open transactions. A customer order can be accepted, if successful will move the customer order to the Customer Order Pick process. In customer order pick the user can pick the order. A physical holding location may be required to put the items for later pickup. Once picking has been complete the user will move to the shipment/pickup/curbside pickup process dependent on the type of delivery. If a reverse pick exists for the customer order, it will need to be acknowledged to continue the process. At any point the customer order can be rejected which will cancel any quantities which have not yet been picked. Note: Customer Order Quick Flow can also be accessed from Recently Edited and navigating to a transaction from Notifications.





The Customer Order Pick Screen is the next step in the process after the Customer Order screen. It is accessed by successfully creating a pick by selecting the Accept or Pick options for the Customer Order. The Customer Order Pick screen is for customer orders that are in 'Pick in Progress' status as well as for customer orders that are in 'Ready to Ship' and 'Ready to Pickup' status where the delivery record has not been generated yet. Customer Order Picks are accessed automatically within the process flow or from Open Transactions. User must have 'Access Customer Order Quick Flow' user permissions.

The header will contain the Store Customer Order ID, Delivery Type, Release Date and Order Status. The Holding Location can be entered via the link on the top or also from within the overflow menu.

The list will have the items on the customer order with item, description, and image (per preferences).

If Display Sequence Fields equals Yes, the macro location and area for the item will be displayed. If it set to No, this field is not displayed. Note: screenshot above is not showing this.

If there is stock on hand in the backroom:

- It will display the first available backroom location.
- If no backroom location, it will display Backroom.

If there is no stock in the backroom and stock exists in the shopfloor:

- It will display the first available shopfloor location.
- If there is no shopfloor location, it will display Shopfloor.

If there is no stock on hand in the backroom or the shopfloor:

- It will display the first backroom location.
- If no backroom location, the first shopfloor location is displayed.
- If no shopfloor location, it displays no location.

Items will be ordered by macro locations that have stock on hand with backroom locations first, followed by shopfloor and no location.

If the quantity needed for the item is the suggested pick quantity generated by the system. When the needed quantity has been satisfied a check mark will be displayed. The user can enter in the quantity to pick (Edit Quantity Customer Order Quick Flow permission) or use the scan bar to scan in the quantity.

- If the delivery type is a 'Customer Pickup' the system will navigate to Open Transactions and the order will be 'Ready for Pickup'. If holding location is required per store configuration and the user has not captured it, the system will prompt for this first.
- If the delivery type is 'Ship to Customer'
 - System will validate store parameter, 'Navigate to Shipment'.
 - If it is set to 'Yes', the system will navigate directly to the Shipment screen and the order will be in 'Delivery in Progress'
 - If it is set to 'No' the system will navigate to the Open Transactions screen and the customer order will be in 'Ready for Shipment' status.

Create Shipment / Pickup: This option will be available for customer orders that are in 'Ready for Pickup' or 'Ready for Shipment' and it will generate the pickup / shipment and navigate to the corresponding screen.

Quantity Validation

Upon confirm, the system will check the system admin, Customer Order Fulfillment Restriction:



Tolerances

When the item has a variable unit of measure, i.e. Lbs, pounds, it can be difficult to pick the exact amount suggested. For example: picking 2 Lbs of bananas might end up truly being 2.2. The quantity picked may exceed the needed if the defined tolerances are setup to allow for such.

Figure 12-40 Holding Location




The Holding Location is accessed by:



Figure 12-43 Shipment Screen




Figure 12-44 Curbside Pickup Screen





Figure 12-45 Pickup Screen



The functionality of these screens is the same. The Shipment screen is for delivery types of 'Shipment' it will be accessed from Open Transactions, or if the store configuration, 'Navigate to Shipment' is set to 'Yes', the system will automatically continue on to this screen after completing the pick. The status of the customer order will be 'Delivery in Progress'. The Pickup and Curbside Pickup screens will be accessed from Open Transactions. The status of the customer order will be 'Delivery in Progress'.

Curbside Pickup will contain information in the header about the pickup. It will include the customer's current wait time and any other information that came in on the curbside pickup notification.

The Holding Location (if it exists) will display in the header. A **Default Quantities** option will default in the delivery quantities on the delivery to what is remaining to be delivered. A **Clear Quantities** option is available to clear out the quantities and set them to blank. The items are listed in descending order by item ID. The list will have the items on the customer order with item, description, and image (per preferences).

User can enter in the delivery quantity (Edit Quantity Customer Order Quick Flow permission). Quantity must be less than the Needed quantity, which is the remaining order quantity. Or, if more was picked than what was needed due to tolerances, the delivery quantity must be less than or equal to the picked quantity.




Figure 12-46 Customer Popup



The Reverse Pick is accessed from Customer Order Pick and Shipment/Pickup/ Curbside. Reverse picking is the action of indicating to the OMS that a previous pick is now being unpicked and inventory is moved back to the shopfloor. It also can indicate a confirmation of the cancel request from the OMS. It will be available when the customer order is in Reverse Pick status, a system generated reverse pick exists.

Items will be listed with ID, description, image (if set in preferences), primary location (if Display Sequence Fields = 'Yes'), and the reverse pick/canceled quantity.


Items will be listed that have been picked and that have a remaining order quantity (meaning they have not been shipped/picked up or canceled). They will be sorted by item description.

The user will be able to select 'cancel' to leave without changes. Or, 'Reverse Pick' which will move the reverse pick to 'completed' status. Customer order picked and reserved quantities are decremented and canceled quantity is incremented.

Figure 12-50 Customer Order Status Flow when Picking is Required





Pick in Progress	A pick is open for an order.
Reverse Pick	A reverse pick is open for an order.
Ready to Ship	If the Picked quantity \geq Remaining quantity and the order is not fully shipped yet and the order is of type 'Ship to Customer'.
Ready for Pickup	If the Picked quantity \geq Remaining quantity and the order is not fully picked up yet and the order is of type 'Customer Pickup'.
Delivery in Progress	If at least one delivery is available which is either saved or submitted but not dispatched yet.
Completed	This is one of the final states of a customer order. When the customer order is fully shipped or picked up, it goes to 'Completed' status.

The following table shows the different statuses that a customer order can take when picking is not required for the customer order:

Table 12-2 Customer Order Status when Picking is Not Required

Status	Meaning
New	The order is created but not been accepted yet at the store.
In Progress	A customer order gets this status when it is being looked at and the order is not fully shipped by the store or picked up by the customer.
Completed	This is one of the final states of a customer order. When the customer order is fully shipped or picked up, it goes to 'Completed' status.
Cancelled	This is also one of the final states of a customer order. When the customer order is rejected or cancelled, it goes to 'Cancelled' status.

Customer Order Status Update Logic

Picking Required for Customer Orders is set to Yes

When the store parameter **Picking Required for Customer Orders** is set to **Yes**, the status of customer orders will need to be checked for update whenever any of the following events occur on the customer order.

1. When the customer order is accepted at the store.
2. When a Reverse pick is saved, completed or cancelled, both internally in the system and externally.
3. When a pick is created, saved, completed or cancelled.

4. When a delivery record is created, cancelled, saved, submitted or partially/fully dispatched.
5. When POS sends a fulfilment record against the customer order, which partially/completely fulfilled the order.
6. When the customer order is rejected by the store or cancelled by the user or at Order management system.



Note:

These events can be a manually created, system generated, internally created or externally created event.

After any of the events mentioned above occur, perform the following:

For the Customer Order, check if there is at least one open reverse pick exists:

If **Yes**, update the status of the customer order to **Reverse Pick**.

If **No**, check if there is a Pick in Progress, that is, Pick's status = **New** or **In progress**.

- If **Yes**, update the status of the customer order to **Pick In Progress**.
- If **No**, check if there is a Delivery In Progress, that is, at least one delivery which is either saved or submitted and not dispatched yet.
 - If **Yes**, update the status of the customer order to **Delivery In Progress**.
 - If **No**, check the Picked Qty of the items on the customer order.
 - * If **Allow Partial Delivery = No**,
If at least one item is not completely picked, update the status to **Picking Required**.
If all items are picked completely, then:
if the order is of type Ship to Customer, update the status of customer order to **Ready to Ship**, or,
if the order is of type Customer Pickup, update the status of customer order to **Ready for Pickup**.
 - * If **Allow Partial Delivery = Yes**,
If no item is picked yet, update the status to **Picking Required**.
If at least one item is picked partially or completely picked, then:
if the order is of type Ship to Customer, update the status of customer order to **Ready to Ship**, or,
if the order is of type Customer Pickup, update the status of customer order to **Ready for Pickup**.

Picking Required for Customer Orders is set to No

When the store parameter **Picking Required for Customer Orders** is set to **No**, the following is true:

If the store has decided to not pick the items before shipping, then if the Customer Order is accepted, the status will show **In Progress**.

If the store has decided to formally pick the items and ship, the status is derived as per the rules that apply when **Picking Required** is set to **Yes**.

Completed and Cancelled

Completed and **Cancelled** are the final states of a customer order, irrespective of whether picking is required or not.

The customer order moves into **Completed** status when:

- a customer order is completely shipped by the store or picked up by the customer
- a customer order is rejected and some items have been delivered already

The customer order moves into **Cancelled** status when:

- a customer order is rejected and none of the items have been delivered
- a customer order is cancelled by the user or at the Order management system

The customer order will become read-only once it reaches either **Completed** or **Cancelled** status.

Under Review Status

When the retailer has chosen to integrate with OBCS (Order Broker Cloud Services) and whenever a customer order goes through payment reauthorization, the Order Broker system informs the Store Inventory system about it and the status of the customer order would move to 'Under Review'. This is to indicate that the customer order is going through payment reauthorization and it is not in the state to be submitted/dispatched. The Store Inventory system would have to wait for the payment reauthorization to be successful in order to submit/dispatch the customer order.

Note:

The status of the customer order is not updated to 'Under_Review' at DB rather the status displayed in the UI alone would show 'Under_Review'.

When the customer order moves to 'Under Review' mode, the user can still perform the same actions on the customer order as if it is in New/In Progress/Picking Required/Delivery In Progress, Ready to Ship/Ready for Pickup/Reverse Pick status. that is, the user will be able to approve/reject, create pick/reverse pick/delivery and so on, A validation will be done on Submit/Dispatch of customer order deliveries to ensure that the customer order is not in 'Under Review' mode.

Whenever OBCS informs Store Inventory system that the payment reauthorization has been successful, the status of the customer order moves back to its previous status or to an appropriate status based on the activities that had happened on the customer order while it was in 'Under Review' mode. The customer order would now be available for submit/dispatch. If the payment reauthorization fails, the customer order would get cancelled.

Item Basket

Item Basket is a way of creating a list of items that can be utilized for other things such as line busting, gift registries, and so on. Item Basket allows a user to capture items and their quantities.



Note:


An item basket that has only items on it is considered 'static' meaning that the number of items does not change. An item basket that has only hierarchies or hierarchies and items is considered 'dynamic' meaning that the items on the basket can change based upon the items associated to the hierarchy. The desktop allows for item baskets that are 'dynamic' or 'static' to be created, viewed and edited. Whereas, on the mobile application only static item baskets (ones with items) can be created, viewed, and edited.

- Create a new item basket
- View or edit and existing item basket
- Delete an In Progress Item Basket
- Copy a Completed Item Basket

Item Basket


Figure 13-1 Item Basket Mobile Screen Flow



Item Basket is accessed through the Item Basket menu within the drawer. Selecting the menu option takes the user to the [Item Basket List](#) screen. On this screen, the option is given to search for Item Basket records which will be presented on the [Item Basket List](#) screen. From here one can edit or view an item basket, in all cases the user is directed to the list of items on the [Item Basket Items](#) screen. The user can select an existing item or scan/enter a new item directing to the [Item Detail](#) screen where functions allow the user to add, view, and edit the details of the items. The user can specify values for CFAs (Custom Flexible Attributes) that have been setup for the item basket within the [Edit CFAs](#) screen. Lastly, additional functions will include Notes, Print, Copy, Delete, Save, and Confirm.

When navigating to **Item Basket**, the **Item Basket List** screen displays the **In Progress** item baskets as the default list. The user can use the search criteria eye glasses to navigate to the [Search Criteria \(Item Basket\)](#) screen to enter search criteria for item baskets. When scanning/entering an item in the scan bar, the system adds the item to the entered search criteria and narrows down the current list of item baskets.

Creating a new item basket navigates to the [Create Item Basket](#) popup to enter in header level information, and then it will navigate to the [Item Basket Items](#) screen with no details (items) to build a new item basket. Selecting an item basket from the list navigates directs the user to the details for that item basket.





The **Create Item Basket** screen is used when creating a new item basket and it is accessed when selecting **Create** from the [Item Basket List](#) screen. All item baskets created on mobile will be static. A user must have create permissions to create a new item basket. The type of item basket is required to be selected from the list. The type is populated from the list of item basket types defined in **Code Info** dialog within the desktop application.

Description is an optional text field to describe the item basket. **Alternate ID** is also an optional field to hold an alternate ID given to the item basket by the user, different from that of the system generated item basket ID. **Expiration date** is a field to hold an optional expiration date used to update item baskets to 'canceled' status when the expiration date has passed. Lastly, the store field is required and the options will include the user's store or 'All Stores'. 'All Stores' is only available to users that have the proper permission, and this option will allow for the creation of item baskets in which all stores would have access to use.

Item Basket Items

The Item Basket Items screen is where a new item basket is created. Initially, this screen will not have any items. The items screen is also displayed when selecting an existing item basket transaction from the [Item Basket List](#). The items are listed for the item basket. The item image for the line items is displayed per configuration.

Line items appear in a list and selecting a line item navigates to the item details of that item. If an item has been changed in the current session, it is indicated by a bar on the left of the item. Scrolling in the list of items displays a filter. The filter can be used to narrow down the list of items. Filtering can occur by item ID and description.

Scanning or entering an item in the scan bar navigates you to the [Item Detail](#) screen for that item. The quantity may be updated depending on the scan mode. If the scan type is 'Bulk Scan' the user will navigate to the [Bulk Scan](#) screen.

The ellipsis in the lower right hand corner accesses the footer menu which contains all of the functions that can be performed on an item basket.

Footer Menu


The footer menu is accessed from the ellipsis footer menu on the Item Basket Items screen. The menu functions include the following:

- **Info:** Accesses the Info popup.

- **Notes:** Accesses the notes dialog to capture notes.
- **Bulk Scan:** Bulk Scan will navigate to the [Bulk Scan](#) screen. User must have proper permissions.
- **Edit Item Basket:** The Edit Item basket option navigates to the [Edit Item Basket](#) screen. User must have proper permissions.
- **Edit CFAs:** Lets the user enter values for the CFAs that are set up for Item Basket.
- **Copy:** The copy function is only available for those item baskets in a 'Completed' status. It takes the current item basket, copies the items and quantities, and creates a new editable item basket with a new ID. It references the copied item basket's ID.
- **Confirm:** Confirms and completes the Item Basket setting it to 'Completed' status.
- **Save:** Saves the item basket in 'In Progress' status to be completed later.
- **Delete:** Marks the item basket to 'Canceled' status.
- **Cancel:** Exits the item basket; changes made in that session are not saved.
- **Print:** Displays the common print dialog to print the item basket report.

Item Detail

The Item Detail screen is used for selecting or scanning an item from the [Item Basket Items](#) screen. Scanning or entering an item on this screen in the scan bar, updates the quantity per the scan mode and refreshes the Item Detail screen for the item and quantity scanned.

The quantity can be edited and updated manually if permissions allow. The item information including the image (which is system configured) displays in the header. The bottom portion of the screen contains fields for quantity with UOM, pack size, and location. The Last Scan will display the contents of the last entered or scanned barcode. It is purely informational.

The footer menu, ellipsis button, contains a reset function as well as remove and restore functions. You can page through existing items on the item basket using the arrows on the bottom.

Figure 13-7 Edit Item Basket Screen



The Edit Item Basket screen is used to edit header level information about the item basket. Edit Item Basket is accessed by selecting **Edit Item Basket** from within the footer menu of [Item Basket Items](#), and a user must have proper permissions. 

The Edit CFAs screen displays the list of CFAs (flexible attributes) that have been set up for Item Baskets in the desktop application and lets the user enter values for them. It is accessed by selecting the **Edit CFAs** menu option within the footer of [Item Basket Items](#) and the user must have proper permissions.

The CFAs that are set up as being required must have a value entered for it before confirming the item basket. The value can be one of the following: Date, Text, Decimal, Long depending on the 'data type' set up for the CFAs defined during setup in the desktop application. Appropriate security permission is needed for entering CFA values.

Info Screen (Item Basket)

The Info screen is an informational popup that contains read-only information about the header level of the item basket. Info is accessed by selecting **Info** from within the footer menu of [Item Basket Items](#). Details include ID, description, alternate ID, reference ID, type, status, create date/user, last update date/user, expiration date, and store and the CFAs that have a value.

Bulk Scanning

Bulk scanning is the ability to be able to enter/scan one or more items on a transaction and apply them to the transaction all at once or in bulk. This enables retailers the ability to use RFID to scan many items to add to a transaction.

From the <transaction> items ([Item Basket Items](#)) screen, if the scan type is **Bulk**, after entering/scanning one or many items the user will be directed to the [Bulk Scan](#) screen. On the [Bulk Scan](#) screen, a counter will tally total, valid, invalid, and expected scans. The [Bulk Scan](#) screen can also be accessed via the **Bulk Scan** menu option from the footer menu on the <transaction> items screen.

Once on the [Bulk Scan](#) screen items can continue to be entered/scanned as well as the option to import an item basket.

Selecting the **Items** option from the footer menu will direct the user to the [Bulk Items](#) screen which will list all items that have been collected. Here the user can remove items from the bulk collection if necessary. Once complete, the user can select **Apply**

and the system will apply the items and navigate back to the <transaction> items screen. Bulk scanning is currently used within Item Basket.

Bulk Scan

The Bulk Scan screen can be accessed via the Bulk Scan footer menu option from the [Item Basket Items](#) screen if the user has proper security permissions. It can also be accessed when scanning/entering an item from the [Item Basket Items](#) screen when the scan type is set to **Bulk**. The [Bulk Scan](#) screen allows a user to enter/scan in multiple items at once (that is, RFID) or one by one. In both scenarios the system will gather the items and create a counter of the "scans" including: total, valid, and invalid as well as the total quantity. The system does not apply any validations when items are entered/scanned. Validation does not take place when scanning/entering an item on this screen. The validation takes place once all of the bulk scanning is complete and the user chooses to apply the items to the transaction.

Footer Menu

The footer menu is accessed from the ellipsis footer menu on the Bulk Scan screen. The menu functions include the following:

- **Items:** Navigates to the Bulk Items screen to view the items that were scanned/entered on the Bulk Scan screen.

- **Import Basket:** Navigates to the [Select Item Basket](#) screen to import an item basket into the Bulk Scan screen. Only 'static' item baskets can be imported.
- **Apply:** Takes all of the items that were scanned/entered, as well as imported item baskets, and executes the item validations and applies the items to the transaction and the user is returned to the [Item Basket Items](#) screen with items in the list.
- **Clear:** Clears out all of the items that were scanned/entered or imported from an item basket. All of the counters on the Bulk Scan screen are re-set to zero.
- **Back:** Navigates back to the [Item Basket Items](#) screen and the items that were scanned/entered or imported via an item basket are saved to the Bulk Scan.


Figure 13-11 Bulk Items Screen



The Bulk Items screen is accessed via the **Bulk Items** menu option within the footer on the [Bulk Scan](#) screen. This screen lists all of the items that have been entered/ scanned or imported from an item basket on the [Bulk Scan](#) screen. There is a filter at the top of the screen to allow for filtering on item ID and item description. The user is able to delete items that are not needed on the transaction. Deleted items can be restored if accidentally deleted. Save will save the deletions made and return to the [Bulk Scan](#) screen.

The Select Item Basket screen is accessed via the **Import Item Basket** footer menu option on [Bulk Scan](#). This screen allows a user to import a 'completed' status item basket that was created for the user's store or All Stores. Upon selecting the item basket the user will be given the option to add only the items without the quantities or add the items with the quantities to the bulk scan. A **Delete Item Basket** check box is available which will set the selected item basket to 'canceled' status upon import. This allows those item baskets that are no longer of use to not show up in the list anymore and it will get picked up in the purge.

Ticketing

Ticket printing on the mobile application is accessible from Inventory Management/Print Item menu. The system supports two types of ticketing that is, Item Ticket and Shelf Label. There are two modes of printing tickets, auto print and manual print.

The user is taken to the Auto Print Mode by default when the dialog is accessed. In auto print mode, the user can print tickets quickly with the pre-defined attributes by just scanning or entering the items. The user can change the ticket attributes or switch to the Manual mode using the [Default Attributes](#) option.

In manual print item mode, the user can pre-set the type, format, override price, quantity and change the attributes if required for every ticket on the fly. The user can select the country of manufacture for the ticket.



Ticketing MAF Mobile

Auto Print Item

This screen is accessed from the Print Item menu under the Inventory Management in the mobile application. Auto Print Item mode is the default mode when the user enters the dialog.

This screen allows the user to scan the items and submit the tickets for printing automatically.

The system by default sets the type to Item Ticket, default format set for the type, Price type based on the **Print Item Events** store parameter and quantity to 1. This helps the user to start scanning the items right from the time entering the screen.

The user can select the **Default Attributes** option to change the attributes. The system starts using the attributes set in this screen from the time the user has changed until the dialog is closed.

Based on the event(s) configured in the **Print Item Events** store parameter or the values set in the default attributes, the system determines what tickets need to be submitted by looking at the item meeting the configured event as described below.

Always Print: This option will always print a ticket regardless if there is a price change.

Clearance: Only print a ticket if on the specific date any clearance event is effective. So, for Clearance say 2, that means today's date + 2 days, if the item on that day has a clearance going on, the system prints the ticket.

Promotion: Only print a ticket if on the specific date any promotion event is effective.

Regular or Clearance: Only print a ticket if on the specific date any Regular or Clearance event is getting effective.

Regular: Only print a ticket if on the specific date any Regular even of getting effective.

Any Price Event: Based on the date selected, if any price event goes into effect (clearance, promotion or regular price) a ticket is generated. If there is no price event goes into effect, the system prints nothing.

The system needs a printer to be set as default, if no printer is set as default the user is shown an error on the first scan and can select the printer using the 'Select Printer' option from the footer menu.

If there are any overlapping events, the system displays a popup with the events and allows the user to select.

On this screen, the system displays the total scanned items, what is the printer assigned and total print quantity.


The user can change the mode to Manual Print on the [Default Attributes](#) screen.

On each row, the system displays the Item Image if configured, Item Id, Description, print status, type, format assigned, price type, effective date, event price, current price, override price if any, quantity and error if any.

The system generates the ticket after a valid scan and submits to the assigned printer.

Manual Print Item

This screen appears when the user changes the mode to Manual using the [Default Attributes](#) screen.

The system displays the values based on the default setting done for the fields on this screen.

The user can scan or enter the item for which the ticket or label must be printed.

On this screen, the user can edit the type, format, country of manufacture, override price if permission allowed and enter the quantities or can use the default values and print the ticket.

The system displays the country of manufacture of the item scanned and allows to edit.

On the first scan after entering on to the manual mode, the system displays an error if the default printer is not set. The user can change the printer using the **Select Printer** option from the footer menu.

The user can access the [Default Attributes](#) screen anytime to change the mode and set the default attributes.

The system displays the Stock on Hand, Available, Event and price along with the item information above the editable fields.

Default Attributes

This screen is used by the user to set the default attribute values for the ticket generation for the Auto and Manual mode of printing.

This screen is accessed when the user selects the **Default Attributes** button on the [Auto Print Item](#) or [Manual Print Item](#) screen.

For the Auto Mode, the user can set the format type, format, event type, days range, number of days for range, override price and quantity.

The **Event** type field consists of following options. Always, Promotion, Clearance, Permanent, Clearance or Permanent and Any Price Event. The default value shown here is set from the **Print Item Events** store parameter.

The **Days Range** option includes, Specific Date, Range, Past and Future. For all the options the range cannot be more than 3 days.

Based on the range selected, the system determines whether the scanned item falls in the selected event and if an event exists, the system generates the ticket and submits to print.


For the Manual mode, the user can set the format type, format, override price and the override quantity.

For the both the modes, the system considers the override price and quantity and sets the value when the ticket is generated.

For the manual mode the override price and quantity are populated and allowed to edit on the [Manual Print Item](#) screen.

Select Printer

This screen is for the user to set the printer for the ticket printing.

On this screen, the user can filter the printers by External or Store by selecting from Printers dropdown.

The Bluetooth printers are indicated with the Bluetooth symbol and prefix 'BT' and these printers cannot be scanned.

On this screen the user can select or scan the barcode of the printer and submit the tickets for printing.

This screen is accessed from the **Select Printer** option on the [Auto Print Item](#), [Manual Print Item](#) screens and Print Tickets popup that appears when printing tickets from the container items screen.

This screen lists all the printers that are available in the system for the item tickets and label type.

The selected printer is displayed on the [Auto Print Item](#) and [Manual Print Item](#) screens for the user to know to which printer the tickets/labels are submitted for printing.





Store Orders

This chapter is divided into the following sections:

Store Orders allows a store to request items to be ordered to the store. The items being requested may come from a supplier or a warehouse. The system allows a user to capture items and their quantities to be ordered as well as define restrictions for the store order. The inventory is sourced to the store based on the corporate replenishment setup. This can be either a delivery from a warehouse or a drop ship from the supplier. The actual sourcing, delivery timings, and final quantities remain a function of the replenishment system. Store Orders may be created manually on the mobile application. They may also come in from an external system via a web service and the user can enter quantities against the external order quantity. Features:


- Create a new store order
- View or edit an existing store order
- Delete an In Progress store order
- Copy a Completed store order
- Print Store Order Report

Business Case

- A retailer has milk and eggs that are setup on semi auto replenishment. Purchase Order gets generated in merchandising for the milk and eggs and it comes to SIOCS. Store manager opens the store order for the milk and eggs within the Store Orders dialog. Manager updates the quantities and approves the store order.
- A retailer has a need to order more cornflakes due to the high demand of a current promotion. A retailer creates a store order for more boxes of cornflakes.
- A retailer has certain items that are needed at different times of the day. Within a store order, a timeslot for the delivery can be specified, so it is possible to order doughnuts in the morning, sandwiches at lunch, and hot meals in the evening.
- A retailer realizes that they are often out of dairy items because of very variable customer purchase habits. The store orders what is needed by scheduling a store order product group for the Dairy Department for each Monday. A system generated store order is created on Monday for the dairy items and the retailer walks through the items on the store order and enters in the needed quantity. The store order is approved and fired off to the merchandising system and three days later the items arrive at the store on a warehouse to store transfer or supplier direct delivery.


Figure 15-1 Store Orders Mobile Screen Flow



Store Orders are accessed within the Inventory Management menu by selecting **Store Orders**. Selecting the Store Orders menu option takes you to the [Store Order List](#) screen. On this screen, you have the option to search for existing store order records. You can create a store order, edit, or view a store order. When creating, editing, or viewing a store order, you are first directed to the list of items on the [Store Order Items](#) screen. You can add, view, and edit the details of the items on the [Item Detail](#) screen. You can specify values for CFAs (Custom Flexible Attributes) set up for store order via the [Edit CFAs](#) screen.

When navigating to Store Orders, the **Store Order List** screen displays the **New** and **In Progress** store orders as the default list and a red '!' icon will be displayed for those store orders that have a requested date before today.

The Store Order List will contain store orders for the following origins:

- **Manual:** Store order was created manually in the system.
- **External:** The store order was created in an external system such as a merchandising or forecasting system.
- **System:** The store order was generated by the system from a scheduled store order product group

You can use the search criteria eye glasses to navigate to the [Search Criteria \(Store Orders\)](#) screen to enter search criteria for store orders. When scanning/entering an item in the scan bar, the system adds the item to the entered search criteria and narrows down the current list of store orders based upon the scanned/entered item.

Creating a new store order directs you to the [Create Store Order](#) popup to build a new store order. Selecting a store order from the list navigates you to the details for that existing store order.



Create Store Order

The **Create Store Order** screen is used when creating a new store order and it is accessed when selecting **Create** from the [Store Order List](#) screen. All store orders created on mobile will have an origin of 'manual'. A user must have create permissions to create a new store order.

Every newly created store order will have a system generated unique store order ID. The user may also choose to give the store order a description. The description is an optional text field to describe the store order. An optional context can be assigned to the store order, the context types are populated at setup within the **Code Info** dialog on the desktop. The last field in the header is the **Requested Date**, when the store order is wanted by. **Requested Date** is required and must be greater than or equal to today. The **Requested Date** may have additional date validations later on in the store order process (when adding items or at time of approval) depending on if the item is a 'Store Order' replenishment item.

Restrictions

The last piece of the create process is the restrictions section which is used to define what items the store order is restricted too, in other words what items are allowed to be added to the store order. Restrictions are not required, if not set up, then items will not be restricted. Restrictions can be defined by one or more of the following:

- Supplier
- Warehouse
- Merchandise hierarchy

- Area
- Store Order replenishment items

More than one restriction can be defined for a store order.

Example: A restriction of Supplier 1212-Soda Supplier and Store Order Items of 'checked' would mean that all added to the store order must be a Store Order item for Supplier 1212-Soda Supplier.

Both Supplier and Warehouse restrictions can be configured at the store to be:

1. Enabled and optional
2. Enabled and required
3. Not displayed if not used

Supplier has one additional store configuration, **DSD Delivery Supplier for Store Order**, to check. If it is set to **No**, no additional validation is needed and the supplier can be added as a restriction. If it is set to **Yes**, when adding the supplier as a restriction, the **DSD Allowed Indicator** on the supplier must be set to **Yes** in order to add the supplier. If the supplier indicator is set to **No** then a store order cannot be created for that supplier.

An Area is setup on the desktop in the Area dialog. Areas can be used as restrictions on store orders if the store is configured to **Yes** for **Enable Area for Store Orders**.

Merchandise Hierarchy and Store Order Replenishment Items are always available to be selected for restrictions.




Note:

Restrictions will already be set for store orders that are system or externally created.

Store Order Items

Initially, if the user is creating a new store order, this items screen will not have any items. When selecting an existing store order from the [Store Order List](#) screen, this screen will be displayed with the items for the store order. Line items appear in a list and selecting a line item navigates to the item details of that item.

Fields will include, item, item description and item image depending on the system configuration. The quantity for the item on the store order will display once a quantity has been added for the item. If the store order is from an 'External' origin there will also be an external quantity representing the suggested quantity to be ordered.

Delivery Timeslot: Will be displayed if store is configured for delivery timeslots.

- The Delivery Timeslot at the header level will be used as a default at the item level for the 'SO' (store order) items. Changing the timeslot at the header will only apply to newly added items on the store order.
- If not Delivery Timeslot is selected at the header, the item level will default to 'None'.
- The Delivery Timeslots list will be populated from the Delivery Timeslot Admin screen on the desktop. The list will have those delivery timeslots that the user has data permissions for.

If an item has been changed in the current session, it is indicated by a bar on the left of the item. Scrolling in the list of items displays a filter. The filter can be used to narrow down the list of items. Filtering can occur by item ID and description.

Items can be removed by swiping. Items added by the user will be flagged for removal. Items that were on the store order from an 'External' origin will have their store order quantity set to zero.

The ellipsis in the lower right hand corner accesses the footer menu which contains all of the functions that can be performed on the store order.

Item Validations

- Scanning or entering an item in the scan bar navigates you to the [Item Detail](#) screen for that item. The quantity may be updated depending on the scan mode.
- Items scanned will be restricted to those restrictions defined on create.
 - **Supplier:** Restricts the store order to items only for that supplier.
 - **Warehouse:** Restricts the store order to items only for that warehouse.
 - **Merchandise hierarchy:** Restricts the store order to items only for that merchandise hierarchy.
 - **Area:** Restricts the store order to items only defined for that area.
 - **Store Order replenishment items:** When this restriction is checked the system restricts the store order to items that are only store order replenishment items.
- **Store Order Allowed:** There is a store re-orderable indicator that is sent on from merchandising (ItemLocVirt). This must be **Yes** for the item to be put on the store order. If it is set to **No**, the user will get an error and the item cannot be store ordered.
- If the item is an 'SO' (store order) replenishment item, and it has a store order reject indicator set to **Yes** the **Request Date** for the store order must be greater than or the **Next Delivery Date** for that item.
 - If it is not then the item cannot be added to the store order.

 **Note:**

The 'SO' replenishment method, store order reject indicator and the next delivery date are defined in the merchandising system for the item and held in EICS on the item/store record.

- UINS or GS1 databar data (extended attributes) are not captured in Store Orders.

Adding Items - System and External Store Orders

If the store order is a system or external store order, unexpected items (those not originally on the external store order), will only be able to be added if the store order has the Add Items indicator checked to **Yes**. If it is set to **No** the user will only be able to enter/scan items and quantities against the items that are originally on the store order.

Quantity Validations

Rounding – see Rounding menu option below

Tolerances define how much the store order quantity can deviate from the external store order quantity.

Tolerances will be validated for items on externally created store orders. Tolerances come into the system from merchandising and are defined on the item/location. They can be set as a percentage or UOM, one will be set, not both. Tolerances will be validated if they exist. A tolerance of 0, means that the store order quantity must match the external order quantity exactly, the quantity field will be defaulted to the external

order quantity and disabled. Tolerance UOM: The system will take the external order quantity and add the Tolerance UOM to it to get the upper range, and subtract the Tolerance UOM to get the lower range. Only for SUOM, not applicable to cases.

Example:

External Order qty = 100 units. Tolerance UOM = 10. Entered User Quantity must be 90-110

For Tolerance %: The system will take the % value x the External Order Quantity to get the tolerance quantity. That tolerance quantity will be added to the external order quantity for the upper range and subtracted from the external order qty to get the lower range.

Example:

External Order qty = 100 units. Tolerance % = 7. Tolerance Qty = 7% x 100 = 7 units Entered User Quantity must be 93-107 units

Footer Menu

The footer menu is accessed from the ellipsis footer menu on the [Store Order Items](#) screen. The menu functions include the following:

Info: Accesses the Info popup.

Notes: Accesses the notes dialog to capture notes.

Refresh Cost: If the user has permission for cost to display in the store order, this button will go out and grab the latest costs for the items to be used in the Total Estimated Cost on the Store Order Info screen.

Default Qty: The Default Qty will update the store order quantities for all line items on the store order that do not have a quantity.

- For manually created store orders the quantity will be set to the last requested quantity from the most recent approved store order.
- For externally created store orders the quantity will be set to the external quantity.

Edit Store Order: takes the user to the Edit Store Order screen to edit header level store order information.

Edit CFAs: Lets the user enter values for the CFAs that are set up for store orders.

Approve: Approves and completes the store order. The store order is set to 'Completed' status..

- User must have Approve Store Order permission.
- If the user has the Submit Store Orders permission set to 'yes', the store order will require a submit first, thus the Approve button will not be available until the store order is in 'submitted' status. (assuming user also has Approve store order permission).
- If the user has the Submit Store Orders permission set to 'no', the Approve button will be available in 'In Progress' status as well as 'Submitted' status (assuming user also has Approve store order permission).
- If the store order has the Case Pack Round indicator set then the store order will require rounding. See Round option below.
- Tolerances on the store order quantity will be validated.
- The store order is published out.

Save: Saves the store order 'In Progress' status to be completed later.

- Saving a store order does not publish anything out; it simply saves it. The **Save** button can be used to implement a Save and Approval process.

Round: will round the item quantities on the store order up to the next multiple of the supplier case size. Example: Pack Size is 12. User enters in a quantity of 20. Round will round up to 24 .

- Available for store orders that are editable.
- System, External and manually created store orders
- Externally created store orders from RMFCS that are for a supplier (Purchase Order) will have the Case Pack Round indicator set to 'Yes', thus requiring the user to round the store order.

Cancel Submit: It will set the store order back to 'In Progress' status.

- Will be available for store orders in 'Submitted' status.
- User must have Cancel Submit Store Orders permission to have this option.

Submit: will set the store order to 'Submitted' status which is still an editable state. Submit will perform all functionality of the approve option with the exception of integration will not take place.

- Available for 'New' and 'In Progress' store orders.
- User must have Submit Store Orders permission for the option to be available.

Delete: Marks the store order to 'Canceled' status.


Cancel: Exits the store order; changes made in that session are not saved.

Print: Displays the common print dialog to print the store order report.

Copy: The copy function is only available for those store orders in a completed state which is 'Approved' or 'Canceled' status. It takes the current store order, copies the items and quantities (not external quantities), and creates a new editable store order with a new ID. It references the copied store order's ID.

Item Detail

The **Item Detail** screen is used for selecting or scanning an item from the [Store Order List](#) screen. Scanning or entering an item on this screen in the scan bar, updates the quantity per the scan mode and refreshes the [Item Detail](#) screen for the item and quantity scanned. The item rules and validations will be the same as that on the [Store Order Items](#) screen.

The item information including the image (which is system configured) displays in the header. The bottom portion of the screen contains various read only fields about the item to assist in creating the store order.

The quantity can be edited and updated manually if permissions allow. For system generated store orders the quantity for all items will be initially blank until the user enters or scans in a quantity for the items.

Additional fields include:

Delivery Timeslot: Will be displayed if store is configured for delivery timeslots.

- If a Delivery Timeslot was selected at the header level of the store order, it will be used as a default at the item level. User will be able to change the timeslot. Changing the timeslot at the header will only apply to newly added items on the store order.
- The Delivery Timeslots list will be populated from the Delivery Timeslot Admin screen on the desktop.
- The list will have those delivery timeslots that the user has data permissions for.

- Delivery Timeslot is only available for those items that are 'SO' (store order) items.
- Delivery Timeslot is not required.
- When the store order is approved and published out, the Delivery Timeslot will only be sent on the message if the publish indicator is **Yes**.

External Order Qty: If the order was from an external origin. This is the quantity that is suggested to order by the external system.

Available: Available stock on hand for the item at the user's store.

Requested Today Qty: Sum of all requested quantities on all 'Approved' store orders for today's date for the item at the user's store.

Last Requested Qty: The store order quantity for the last/most recent 'Approved' store order for the item at the user's store.

Last Requested Date: The approved date for the store order that has the last requested quantity.

Next Delivery Date: The next delivery date for the item at the user's store.

- This field is populated on the item location record from the merchandising system and only for 'SO' (store order) replenishment type items.

Shopfloor: Shopfloor inventory for the item at the user's store. Only displayed if store is configured to display shopfloor/backroom.

Backroom: Backroom inventory for the item at the user's store. Only displayed if store is configured to display shopfloor/backroom.

Capacity: The total summed up capacity for the item. Only displayed if store is configured to display sequence fields.

**Note:**

Capacity is setup / defined via a third party upload.

Ordered: The total remaining ordered quantity for the item at the store. This is for transfers, allocations and purchase orders.

Inbound: The total quantity approved to be sent to the user's store. This is for store to store transfers, warehouse and finisher deliveries and RTV shipments.

Unit Cost: The unit cost for the item. Only displayed if user has proper permission.

**Note:**

Unit cost will not be displayed if the currency of the store is different than that of the supplier (in the case that a supplier restriction is set up).

Price: Current price for the item.

Replenishment Method: The replenishment method for the item at the user's store, such as Store Order, Min Max, and so on.


Last Scan: Displays the details that are from the barcode.

- GS1 - will display the barcode, GTIN, and the contents of the barcode such as price, UIN, and so on.
- Type 2 - will display the barcode and the price.
- All other barcodes - will display the barcode.

The footer menu, ellipsis button, contains a reset function as well as remove and restore functions. The Sales Data screen can also be accessed from this menu.

You can page through existing items on the store order using the arrows on the bottom.

The **Sales Data** screen is used to display sales data for an item and store. It is accessed by selecting Sales Data from within the footer menu of the (Store Order) Item Detail screen. The screen allows a user to view two types of sales data: Sales History and Sales Forecast. A user must have permission to view Sales History as well as to view Sales Forecast. If the user does not have either permission, this screen will not be available.

Sales History: Will display the past 30 days (or less if 30 does not exist) of Sales History for the item at the user's store. Sales History is pulled from sales within the system that are found in Transaction History. This will display in a list with item and quantity.

Sales Forecast: Will display the next 30 days (or less if 30 does not exist) of future sales for the item at the user's store. Sales Forecast is retrieved via a web service from an external system such as merchandising. This will display in a list with item and quantity.

Lastly, the system will display the calculated Days of Supply.

Edit Store Order

Figure 15-8 Edit Store Order Screen




The **Edit Store Order** screen is used to edit header level information about the store order. **Edit Store Order** is accessed by selecting **Edit Store Order** from within the footer menu of [Store Order Items](#), and a user must have proper permissions. The fields are the same as those on the [Create Store Order](#) screen and include: description, context, and request date.

Request Date: If there are no 'SO' (store order) items on the store order, the request date needs to be greater than or equal to today. If there are 'SO' (store order) items that have a **Store Order Reject** indicator of **Yes**, the request date needs to be greater than the latest **Next Delivery Date** of the 'SO' items on the store order. This gets validated also upon approval of the store order.

Edit CFAs

The **Edit CFAs** screen displays the list of CFAs (flexible attributes) that have been set up for Store Orders on the desktop, and lets you enter values for them. The CFAs that are set up as **Required** must have a value entered for it before approving the store order. The value can be one of the following: Date, Text, Decimal, Long depending on the 'data type' set up for the CFAs, while creating them on the desktop. Appropriate security permission is needed for entering CFA values.

The **Info** screen is an informational popup that contains read-only information about the header level of the store order. Fields include:

ID: System generated ID for the store order.

External ID: The ID from the external system for externally created store orders.

Reference ID: ID associated to the store order that was copied.

Description: Description of the store order. For system generated store orders, this will be the description defined on the Product Group.

Status: Status of the store order: New, In Progress, Approved, and Canceled.

Context: The context type associated to the store order.

Origin: Where the store order originated: manual, system, or external.

Requested Date: The requested date for the store order.

Total Quantity: Total quantity of all items on the store order.

Total Estimated Cost: Total cost of all items on the store order. This field is only displayed if user has proper permission.

Add Items: Has a value of Yes or No and defines if items can be added to the store order. For manually created store orders this is defaulted to **Yes**. For store orders that are from an external system, or system generated, this may be set to **Yes** or **No**. **Yes** would mean that items can be added to the external store order, whereas **No** would be that items cannot be added and only the items originally on the store order can be ordered.

Product Group ID: For system generated store orders this will display the Product Group ID that the store order was generated from.

Product Group Description: For system generated store orders this will display the Product Group Description that the store order was generated from.

CFAs: Each CFA attribute and value for the store order.

Restrictions: The restrictions that were defined for the store order.

- Supplier, warehouse, merchandise hierarchy, area, and store order items.



System Generated

System Generated store orders are created on the desktop of the EICS application. See the Product Group & Product Group Schedule section of *Oracle Retail Enterprise Inventory Cloud Service User Guide - Operations* chapter. Those schedules created for today will generate the store order at the time of completing the schedule for stores on the schedule. Other store orders will be generated based upon their schedule in the nightly batch. System generated store orders will have an origin of 'system' and will be created in a status of 'New' with the items that were defined per the product group component without quantities. The request delivery date will be set per the Days before Delivery.

On the mobile the store order will allow the user to modify and save or approve it. Items can be added within the defined restrictions defined on the product group if the 'Add Items' indicator was selected on the product group.



The Quick Order flow is available from the Drawer or Quick Actions menu on Jet Mobile. It will allow a user to find items in their store that are on open store orders. The items are identified by first selecting an area. The system will give a list of items that are on open external store orders for the selected Area. The user can then enter in store order quantities for the items. In this multi purpose dialog the user can also adjust the shop floor or backroom quantities


Store Order Areas

Store Order Areas is accessed by selecting **Quick Order** from the drawer or Quick Actions. This screen lists all Areas in the store that have 'open' store orders that are from external system. There is a filter to filter down the list of Areas.

Items in Store Orders

Once an Area is selected the user will navigate to the Items In Store Orders screen which will list all items that are on 'open' status external store orders that are for the Area selected. The area selected displays at the header. This screen displays items across multiple store orders.

Items will include ID, description, image (user preference), order ID, and the recommended order quantity. Items will be sorted by item description and the user can choose to update the sort. Selecting an item will navigate to the Item Detail for that item. Selecting the search option will navigate to the Search Criteria (for Quick Order).

The user can scan or enter in the scan bar and if the user preference for Scan Navigate is set to 'Yes' the user will go the Item Detail screen and the quantity will not be incremented. If the Scan Navigate is set to 'No' the user will stay on the Items in Store Orders and the quantity will be incremented per the scan.

Quantity Validation

Tolerances come into the system from merchandising and are defined on the item/location. They can be set as a percentage or UOM, one will be sent, not both. Tolerances will be validated if they exist. A tolerance of 0, means that the store order quantity must match the external order quantity exactly, the quantity field will be defaulted to the external order quantity and disabled. Tolerance UOM: The system will take the external order quantity and add the Tolerance UOM to it to get the upper range, and subtract the Tolerance UOM to get the lower range. Only for SUOM, not applicable to cases.

Example: External Order qty = 100 units. Tolerance UOM = 10. Entered User Quantity must be 90-110

The Item Detail screen is accessed by selecting an item from Items on Store Orders or by scanning/entering an item into the scan bar on that screen. The header contains the item ID, description and image (per user preference). The order quantity can be updated. See quantity validation on Items on Store Orders.

Inventory allows for a direct update to the Shop Floor and Backroom inventory buckets if the 'Display Shop floor / Backroom quantity' store parameter is set to 'Yes'. If it is set to 'No', then Available Inventory bucket can be adjusted.

Sales History will display if the user has 'Display Sales History' permission. This data is populated from Transaction History. Sales Forecast will display if the user has 'Display Sales Forecast' permission. The store must also be configured to call the Sales Forecast web-service. For both of these, they will be displayed in graphs with the system trying to display up to four weeks of data, if the data exists. Only full weeks will be displayed.

Additional informational fields on this screen include:

- Last Received - how many were last received on allocation, DSD, transfer.
- Next Delivery - the quantity on the next delivery. It is the in transit (In bound qty) for the ASN (Transfer,DSD, allocation).
- Warehouse – sum of inventory for the item at all warehouse.
- On Order - This field will display the total quantity remaining on the order. (same as Item Lookup)Transfers + Allocations + Purchase Orders.
- Available
- Unavailable
- Total SOH
- Order ID
- Area Description
- Area ID
- Regular Price
- Promotional Price

Footer Menu

Confirm: Store Order is updated to 'In Progress' status. It will get approved via the nightly batch.

- If adjustments were made to the inventory buckets, inventory adjustment will be written with reason codes of Quick Adjustment In and Quick Adjustment Out. The adjustments are published. Transaction history is written.

Print Ticket: Allows the user to print a ticket if the user has Print Ticket security permission.


Add to Item Basket: Adds the item being looked up to an investigate type item basket. If one or more 'in progress' status 'Investigate' type item baskets exist for the user's store, the system will add the item to the newest one. If one does not exist, the system will create one. The item basket will be 'static' and available in the Item Basket dialog of both the desktop and mobile.

Remove from Item Basket: removes from the investigate item basket.

Configure Screen Layout: brings up a popup where the user can configure the Item Detail screen. See section below.

The Configure Layout screen is used to configure the data and layout on Item Detail. It will show a list of the sections to display in the screen, Inventory, Order, Sales History (Display Sales History permission), and Sales Forecast (Display Sales Forecast permission). The order of the sections can be modified by dragging the sections up and down. The switch on each section controls whether or not that section will be displayed.

- The settings made in this screen are applicable for the user until it changes again. Whenever the user comes to this screen, these settings will be applied automatically.
- When the user alters the settings, the changes will be effective immediately and for the future.

Manual and System Created

Those store orders that were created manually on the mobile or via a schedule in the system, will be sent out via RICS once approved. Any items with a zero quantity will not be sent. Non inventory items will be sent based upon a publish non inventory items configuration. If there are no items with quantities on the store order to send, the store order will not be sent. CFAs are also published based upon a publish attribute defined on the setup of the CFA. Delivery Timeslots will be published based upon the delivery timeslot publish attribute. Items will be sent and grouped together as being 'SO' store order items or NON store order items.

Externally Created

RMFCS

Those store orders that were generated externally from RMFCS will be published back out to RMFCS via ICL.

Third Party

Store orders can come from an external system into SIOCS via a web service. These store orders will have an external order quantity to be used as a suggested order quantity. The user will enter/scan a store order quantity for the actual order quantity. The order will also indicate if additional items can be added to the store order by the user.

Those store orders that originated from an external system will be sent out via web service. All items will be sent out those that were originally on the store order from external system as well as those added in addition by the user. Items with a zero quantity will also be sent back to the external system to indicate no quantities are required. The rules for non inventory and CFAs are the same as that above for manually created store orders.

RMFCS Processing for SIOCS Created Orders (Manual And System)

A user is able to use store order functionality to request items regardless of the replenishment type normally used by the merchandising system to replenish the item. All items are sourced from either a warehouse or through a supplier depending on the sourcing parameters for the item specified in the replenishment system. Items specified as using Store Order replenishment (or items that are not set up for auto-replenishment at all) are sourced through the creation of one-off purchase orders or warehouse transfer requests only after the store has requested inventory using the Store Order functionality. There is no correlation between the purchase order/transfer and the item request. Any quantities requested for items that have a replenishment type other than Store Order are added above and beyond the quantity that is normally sourced through the replenishment system on the item's next replenishment review date. However, if the requested delivery date falls prior to the item's next replenishment review date, the request is sourced through the creation of a one-off purchase order or warehouse delivery instead. All inventory requested is sourced to the store at the earliest possible date given the replenishment review date, the supplier or warehouse lead time, and any other factors that may influence the time it takes a delivery to reach the store.

Externally Created Store Orders

Web Services

There are web services for creating, updating and deleting of store orders. Create allows for externally created store orders to come into SIOCS and simulates the SOCS store order create functionality. In addition it also has an external order number, external order quantity, and add items indicator. The add items indicator is used to determine if additional items can be added the store order when editing it within SOCS.

ICL Integration

Store Orders can be integrated into SICOS via ICL from RMFCS.

Integration will occur for:

- Purchase orders (POs) that are in 'submitted' or 'worksheet' status.
- Transfers that are in 'input' or 'submitted' status.
- Only semi-automated replenishment orders – these are flagged for review and if the 'Store User Access' is 'Review' or 'Approved' then they will integrate to SIOCS.
- POs are for a single location.
